# Renormalization Group and Asymptotic Spin-Charge separation for Chiral Luttinger liquids

#### Abstract

The phenomenon of Spin-Charge separation in non-Fermi liquids is well understood only in certain solvable $d=1$ fermionic systems. In this paper we furnish the first example of asymptotic Spin-Charge separation in a $d=1$ non solvable model. This goal is achieved using Renormalization Group approach combined with Ward-Identities and Schwinger-Dyson equations, corrected by the presence of a bandwidth cut-offs. Such methods, contrary to bosonization, could be in principle applied also to lattice or higher dimensional systems.


## 1 Introduction and Main results

In recent years the properties of non-Fermi liquids have been extensively investigated, both from experimental and theoretical point of view. In particular, one of the most spectacular feature appearing in non-Fermi liquids is the phenomenon of Spin-Charge (SC) separation, which is surely relevant for the physics of metals so anisotropic to be considered one dimensional, see for instance [18] or [11]. In addition, it is the key property in the Anderson theory of high- $T_{c}$ superconductors (cuprates described by $\mathrm{d}=2$ fermionic systems), [1].

As it is well known, SC separation is an highly non-perturbative phenomenon, and its occurrence in fermionic models is quite hard to prove. Up to now it has been obtained only for the spinning Luttinger model (or Mattis model), [16], describing two kind of fermions, with spin $1 / 2$ and interacting through a short ranged potential. Its exact solvability is due to the linear dispersion relation (without any form of high energy cutoff) requiring a "Dirac
sea" of fermions with negative energy; such features are quite unrealistic in a model aiming to describe conduction electrons in a metal, but they allow to map the interacting fermionic system into a non-interacting bosonic one, and to write the Hamiltonian as sum of two, decoupled Hamiltonians, respectively for spin and the charge degree of freedom. As a result, the twopoint Schwinger function, in the case of local interaction, factorizes into the product of two functions, with different Fermi velocities, $s_{\rho}, s_{\sigma}$, and different critical indices $\eta_{\rho}, \eta_{\sigma}$, for the density $(\rho)$ and the spin $(\sigma)$ respectively:

Such a factorization appears also in the $n$-point Schwinger functions (see [14] for an explicit formula), and it causes a phenomenology considerably different from the one of Fermi liquids [19].

For certain values of the parameters the spinning Luttinger model reduces to the Chiral Luttinger model; in such a case (11) still hold but $\eta_{\rho}=\eta_{\sigma}=0$, that is in such a model only SC separation and no anomalous dimension is present.

The occurrence of SC separation in more realistic non solvable models, like the Hubbard model, has never been established, as a consequence of the fact that lattice or nonlinear bands prevents the use of bosonization. It is important to understand SC separation in the framework of Renormalization Group (RG), which is actually the only method which can be in principle applied in full generality to the complex models appearing in condensed matter in any dimension. However even in $d=1$, in which RG methods have been extensively applied, - from the fundamental perturbative analysis in [18] to the non-perturbative and rigorous construction of Luttinger liquids in [6], [2], [3], [4, [15] - very few attention has been devoted to the application to SC separation effects (with the exception of the recent paper [9], in which however several approximations are introduced).

In this paper we will show that SC separation can be established in a non exactly solvable model by using RG methods; the model we consider is the Chiral Luttinger liquid model with a bandwidth cut-off, describing spinning fermions interacting through a short range potential. For physical applications, the presence of a finite momentum cut-off is essential as a linear dispersion relation can be a reasonable approximation for a non-relativistic dispersion relation only for momenta close to the Fermi surface; its presence prevents however the possibility of an exact solution through bosonization. This model have received a great deal of attention since the edge excitations in the fractional Quantum Hall effect are believed to be a physical realization of a Chiral Luttinger liquid [20].

### 1.1 Basic definitions

We express the Chiral Luttinger liquid model directly in terms of Grassmann variables. Given the interval $[0, L]$, the inverse temperature $\beta$ and a large integer, $M$, we introduce the lattice $\Lambda_{M}$ made of the points $\mathbf{x}=\left(x_{0}, x_{1}\right)=$ $\left(n_{0} \frac{\beta}{M}, n_{1} \frac{L}{M}\right)$, for $n_{0}, n_{1}=0,1, \ldots M-1$. We also consider the lattice $\mathcal{D}=$ $\mathcal{D}_{L} \times \mathcal{D}_{\beta}$ of points $\mathbf{k}=\left(k_{0}, k_{1}\right)$, with $k_{0}=\frac{2 \pi}{\beta}\left(n_{0}+\frac{1}{2}\right), k_{1}=\frac{2 \pi}{L}\left(n_{1}+\frac{1}{2}\right)$, and $n_{0}, n_{1}=0,1, \ldots M-1$. With each $\mathbf{k} \in \mathcal{D}$, we associate eight Grassmann variables, $\widehat{\psi}(\leq N) \varepsilon$, for $\varepsilon, \omega, \sigma= \pm$; and we consider the Grassman measure $P\left(d \psi^{(\leq N)}\right)$ that is defined in terms of the propagator $\left\langle\psi_{\mathbf{x}, \omega, \sigma}^{-\varepsilon(\leq N)} \psi_{\mathbf{y}, \omega^{\prime}, \sigma^{\prime}}^{\varepsilon^{\prime}(\leq N)}\right\rangle_{0}=$ $\varepsilon \delta_{\varepsilon, \varepsilon^{\prime}} \delta_{\omega, \omega^{\prime}} \delta_{\sigma, \sigma^{\prime}} g_{\omega}^{(\leq N)}(\mathbf{x}-\mathbf{y})$ for

where $\widehat{\chi}_{N}(\mathbf{k})$ is a smooth compact support function $\widehat{\chi}_{N}(\mathbf{k}) \stackrel{\text { def }}{=} \widehat{\chi}\left(\gamma^{-N}|\mathbf{k}|\right)$, where $\gamma>1$ and $\widehat{\chi}(t)$ is a $C_{0}^{\infty}\left(\mathbb{R}_{+}\right)$such that

The Generating Functional of the finite temperature Schwinger functions are obtained from the following Grassman integral

where $\int d \mathbf{x} \stackrel{\text { def }}{=} \frac{\beta L}{M^{2}} \sum_{x_{0}, x_{1} \in \Lambda_{M}}$ and, for $v(\mathbf{x})$ a smooth, rotation invariant, short range potential with $\widehat{v}(0)=1$,

$\left\{J_{\mathbf{x}, \omega}\right\}_{\mathbf{x}, \omega}$ are commuting variables, while $\left\{\varphi_{\mathbf{x}, \omega}^{\sigma}\right\}_{\mathbf{x}, \omega, \sigma}$ are anticommuting. The Schwinger functions are obtained by taking derivatives of $\mathcal{W}(\varphi, J)$; in particular the two-point Schwinger function is defined

The lattice $\Lambda_{M}$ is introduced just for technical reasons in order to avoid an infinite number of Grassmann variables, but our results are trivially uniform in $M$. The size $L$ and the inverse temperature $\beta$ plays the role of infrared cut-offs; one is interested in the physical quantities in the thermodynamic limit $L \rightarrow \infty$ and at low temperatures, that is up to $\beta=\infty$. We will prove the following result.

Theorem 1.1 There exists $\varepsilon_{0}>0$ ( $N$ independent) such that, for $|\lambda| \leq \varepsilon_{0}$, the limit of the two-points Schwinger function for $M, \beta, L \rightarrow \infty$ exists and has the form, for $\mathbf{x} \neq \mathbf{0}$

with $R_{N}(\mathbf{x})$ bounded and such that

The above theorem provides the first example of SC separation in a non solvable model. It is only asymptotic, that is up to terms which which are negligible for large distances.

The proof of (7) is based on Renormalization Group methods combined with Ward Identities and Schwinger-Dyson equations, corrected by terms due to the presence of the momentum cut-offs which breaks the local symmetries. Hopefully the methods presented here could be applied to prove spin-charge separation in the $d=1$ or even the $d=2$ Hubbard model, despite such problems are of course much harder and pose several extra technical problems.

The rest of the paper is organized in the following way. In $\S 2$ and $\S 3$ we perform a Renormalization Group analysis; in the integration of the ultraviolet scales one has to improve the naive dimensional bounds taking advantage from the non-locality of the interaction, while in the infrared scales dramatic cancellations due to global phase symmetries are exploited. In $\S 4$ we bound the difference of the Schwinger functions with and without cut-offs, showing that it has a faster power law decay. Finally in $\S 5$ we implement Ward Identities and Schwinger-Dyson equations in the RG approach, obtaining an explicit expression of the Schwinger functions in the limit of removed cutoff.

## 2 Renormalization Group analysis

We define the effective potential on scale $N$

Let $\widehat{f_{h}}(\mathbf{k}) \stackrel{\text { def }}{=} \hat{\chi}\left(\gamma^{-h}|\mathbf{k}|\right)-\hat{\chi}\left(\gamma^{-(h-1)}|\mathbf{k}|\right)$. The RG analysis is triggered by the decomposition of $\widehat{\chi}_{N}(\mathbf{k})$ as $\sum_{h=-\infty}^{N} \widehat{f}_{h}(\mathbf{k})$, and correspondingly, the decomposition of the propagator, (2), as

Using standard techniques (see for instance [12], appendix A2), for any positive integer $q$, there exists a constant $C_{q}$ such that, for any $h \leq N$

From the basic properties of Grassman integrals it also follows that $\psi_{\mathrm{x}, \omega, \sigma}^{\varepsilon(\leq N)}=$ $\sum_{j=-\infty}^{N} \psi_{\mathbf{x}, \omega, \sigma}^{\varepsilon(j)}$, where $\psi_{\mathbf{x}, \omega, \sigma}^{\varepsilon(j)}$ is randomly independent from $\psi_{\mathbf{x}, \omega, \sigma}^{\varepsilon(i)}$, for $i \neq j$; and has covariance $g_{\omega}^{(j)}(\mathbf{x})$. We then define the effective potential on scale $k$, $\mathcal{V}^{(k)}\left(\psi^{(\leq k)}, \varphi, J\right)$, such that

for $\psi_{\mathbf{x}, \omega, \sigma}^{\varepsilon[k, N]}=\sum_{j=k}^{N} \psi_{\mathbf{x}, \omega, \sigma}^{\varepsilon(j)}$ and $\psi_{\mathbf{x}, \omega, \sigma}^{\varepsilon(\leq k)}=\sum_{j=-\infty}^{N} \psi_{\mathbf{x}, \omega, \sigma}^{\varepsilon(j)} ; \mathcal{E}_{k, N}^{T}$ is the truncated expectation with respect to the propagator $g_{\omega}^{[k, N]}(\mathbf{x})$ :

The effective potential is a polynomial of the fields. For $\varphi=0$, (the case $\varphi \neq 0$ will be discussed in (41) we define the kernels on scale $k, W_{\omega, \bar{\sigma}}^{(n ; 2 m)(k)}$, such that, for $\underline{\mathbf{z}}=\mathbf{z}_{1}, \ldots, \mathbf{z}_{n}, \underline{\mathbf{x}}=\mathbf{x}_{1}, \ldots, \mathbf{x}_{m}, \underline{\mathbf{y}}=\mathbf{y}_{1}, \ldots, \mathbf{y}_{m}$ and $\underline{\sigma}=$ $\sigma_{1}^{\prime}, \ldots \sigma_{n}^{\prime}, \sigma_{1}, \ldots \sigma_{m}$, we have

where $\underline{\chi}_{k}(\underline{\mathbf{x}})=\prod_{j=1}^{n} \chi_{k}\left(\mathbf{x}_{j}\right)$ and $\chi_{k}(\mathbf{x})$ is the Fourier transform of $\sum_{j \leq k} \widehat{f}_{j}(\mathbf{k})$.
We give more details on the truncated expectation of monomials of the fields; then, any polynomial can be computed by multilinearity. To shorten the notations we call

where $P$ is a set of labels. Given the clusters of points $P_{1}, \ldots P_{s}$, the truncated expectation $\mathcal{E}_{k+1, N}^{T}\left[\psi_{P_{1}}|\cdots| \psi_{P_{s}}\right]$ is given by the sum of the values (with the relative sign) of all possible connected Feynman graphs, obtained representing graphically the monomial $\psi_{P}$ as a set of oriented half lines coming out from the clusters of points and contracting them in all possible ways so that all the clusters are connected; to each line is associated a propagator $g_{\omega}^{[k+1, N]}$.

Then the kernels $W_{\omega, \underline{g}}^{(n ; 2 m)(k)}$ can be written as sum over Feynman graphs as well, and the presence of cutoffs make each of them finite. Each connected Feynman graph made of $p$ vertices is bounded by $C^{p}|\lambda|^{p} / p!$; anyway their number is $O\left(p!^{2}\right)$ so that the sum of the graphs giving the truncated expectations are bounded by $C^{p}|\lambda|^{p} p$ !, from which convergence of the series expansion in $\lambda$ does not follow. The combinatorial bound can be improved using the idea in [7]: the anticommutativity of fermions produces dramatic cancellations among Feynman graphs, which are lost if the sum of graphs is simply bounded by the sum of their absolute values.


Figure 1: : An example of Feynman graph corresponding to one possible contribution to the truncated expectation of the clusters $P_{1}, \ldots, P_{4}$. The lines with the arrows are the propagator: not all of them are necessary to connect the four clusters.

In order to exploit such cancellations it is then convenient to use a different representation of the truncated expectations: here we follow the standard technique of [10] and [8] (see also [13] and, for a detailed derivation, [12]).

where:

1) $T$ is a set of lines forming a tree between the clusters of points $P_{1}, \ldots, P_{s}$, i.e. $T$ is a set of lines which becomes a tree if all the points in the same cluster are identified; $n \stackrel{\text { def }}{=} \sum_{j=1}^{s}\left|P_{j}\right|$;
2) $\mathbf{t}=\left\{t_{i, i^{\prime}} \in[0,1], 1 \leq i, i^{\prime} \leq s\right\}$ and $d P_{T}(\mathbf{t})$ is a probability measure with support on a set of $\mathbf{t}$ such that $t_{i, i^{\prime}}=\mathbf{u}_{i} \cdot \mathbf{u}_{i^{\prime}}$ for some family of vectors $\mathbf{u}_{i} \in \mathbb{R}^{s}$ of unit norm;
3) $G_{k+1, N}^{T}(\mathbf{t})$ is a $(n-s+1) \times(n-s+1)$ matrix, whose elements are given by

\left[G_{k+1, N}^{T}(\mathbf{t})\right]_{(j, i),\left(j^{\prime}, i^{\prime}\right)}=t_{j, j^{\prime}} g_{\omega}^{[k+1, N]}\left(\mathbf{x}_{j, i}-\mathbf{x}_{j^{\prime}, i^{\prime}}\right) \tag{18}
\end{equation*}

where $1 \leq j, j^{\prime} \leq s$ and $1 \leq i \leq\left|P_{j}\right|, 1 \leq i^{\prime} \leq\left|P_{j^{\prime}}\right|$, such that the lines $l=\mathbf{x}_{j, i}-\mathbf{x}_{j^{\prime}, i^{\prime}}$ do not belong to $T$.

The kernels $W_{\omega, \sigma}^{(n ; 2 m)(k)}$ can be written as a convergent series in $\lambda$, as it is shown by the following lemma.

Lemma 2.1 There exists $\varepsilon_{k, N}$ such that, for any $\lambda$ such that $|\lambda| \leq \varepsilon_{k, N}$, $W^{(n ; 2 m)(k)}$ are analytic in $\lambda$.

Proof. We bound the determinant $G_{k+1, N}^{T}(\mathbf{t})$ in (17) by using the GramHadamard inequality: if $A_{i}, B_{j}$ are vectors in a Hilbert space with scalar product $\langle\cdot, \cdot \cdot\rangle$, then

where $\mathbf{u}_{i} \in \mathbb{R}^{s}, i=1, \ldots, s$, are the vectors such that $t_{i, i^{\prime}}=\mathbf{u}_{i} \cdot \mathbf{u}_{i^{\prime}}$, and

The number of trees $T$ in (17) is bounded by $C^{\sum_{i}\left|P_{i}\right|} s!$, for a suitable constant $C$; by using (14) and (17), bounding the determinants by (11) and the integrations over coordinates by

and convergence follows for $\lambda$ small enough.
The above lemma says that the kernels $W_{\omega, \sigma}^{(n, 2 m)(k)}$ are analytic in $\lambda$ with an estimated radius of convergence which shrinks to zero when $|N-k| \rightarrow \infty$; we will see in the rest of this section how to improve the above bound to get convergence uniformly in $N-k$, by exploiting suitable cancellations in the series expansion.

It is convenient to introduce the directional derivative

Calling $\widehat{W}_{\omega, \underline{\sigma}}^{(n ; 2 m)(k)}(\underline{\mathbf{p}} ; \underline{\mathbf{k}}, \underline{\mathbf{q}})$ the Fourier transform of $W_{\omega, \underline{\sigma}}^{(n ; 2 m)(k)}(\underline{\mathbf{z}} ; \underline{\mathbf{x}}, \underline{\mathbf{y}})$, we have the following lemma.
Lemma 2.2 For $|\lambda|$ small enough,

Because of lemma 2.1, we can write the kernels as a convergent power series in $\lambda: \widehat{W}_{\omega, \underline{\sigma}}^{(n ; 2 m)(k)}(\underline{\mathbf{p}} ; \underline{\mathbf{k}}, \underline{\mathbf{q}})=\sum_{p \geq 0} \lambda^{p} \widehat{W}_{p ; \omega, \underline{\sigma}}^{(n ; 2 m)(k)}(\underline{\mathbf{p}} ; \underline{\mathbf{k}}, \underline{\mathbf{q}})$. For any integer $p \geq 1$, we define $R_{p} \mathbf{k}$ as the rotation of $\mathbf{k}$ of an angle $\frac{\pi}{2 p}$ :

In the same way $\widehat{W}_{p ; \underline{\sigma}}^{(1 ; 2)(k)}(\underline{\mathbf{k}})$ is sum over Feynman graphs obtained contracting $4 p$ fields (for $p \geq 0$ ); then

\left(\partial_{\omega} \widehat{W}_{p ; \omega, \sigma}^{(0 ; 2)(k)}\right)\left(R_{p} \mathbf{k}\right)=e^{-i \omega \pi}\left(\partial_{\omega} \widehat{W}_{p ; \omega, \sigma}^{(0 ; 2)(k)}\right)(\mathbf{k}), \\
\left(\partial_{-\omega} \widehat{W}_{p ; \omega, \sigma}^{(0 ; 2)(k)}\right)\left(R_{p} \mathbf{k}\right)=e^{-i \omega \pi\left(1-\frac{1}{p}\right)}\left(\partial_{-\omega} \widehat{W}_{p ; \omega, \sigma}^{(0 ; 2)(k)}\right)(\mathbf{k}) . \tag{32}
\end{array}

Since $p \geq 1$, and $\widehat{W}_{1 ; \omega, \sigma}^{(0 ; 2)(k)}(\mathbf{k}) \equiv 0$ by explicit computation, (27) is proved.
We start now the multiscale integration. Using (12), we find

In performing the bounds, it is necessary to pass to the coordinate representation; for $0 \leq k \leq N$, we define $\lambda_{k ; \omega, \underline{\underline{q}}}(\underline{\mathbf{x}}), \nu_{k ; \omega, \sigma}(\underline{\mathbf{x}})$ and $Z_{k ; \omega, \underline{\underline{g}}}(\mathbf{z} ; \underline{\mathbf{x}})$ such that

& +\sum_{\omega, \sigma} \int d \underline{\mathbf{x}} \gamma^{k} \nu_{k ; \omega, \sigma}(\underline{\mathbf{x}}) \psi_{\mathbf{x}_{1}, \omega, \sigma}^{+} \psi_{\mathbf{x}_{2}, \omega, \sigma}^{-} \\
& +\sum_{\omega, \underline{\sigma}} \int d \mathbf{z} d \underline{\mathbf{x}} Z_{k ; \omega, \underline{\sigma}}(\mathbf{z} ; \underline{\mathbf{x}}) J_{\mathbf{z}, \omega, \sigma} \psi_{\mathbf{x}_{1}, \omega, \sigma^{\prime}}^{+} \psi_{\mathbf{x}_{2}, \omega, \sigma^{\prime}}^{-} \tag{38}

while for $k<0$

where $\delta_{3}(\underline{\mathbf{x}}) \stackrel{\text { def }}{=} \delta\left(\mathbf{x}_{1}-\mathbf{x}_{2}\right) \delta\left(\mathbf{x}_{2}-\mathbf{x}_{3}\right) \delta\left(\mathbf{x}_{3}-\mathbf{x}_{4}\right)$ while $\delta_{2}(\mathbf{z}, \underline{\mathbf{x}}) \stackrel{\text { def }}{=} \delta\left(\mathbf{x}_{1}-\mathbf{x}_{2}\right) \delta\left(\mathbf{x}_{2}-\right.$ $\mathbf{z}$ ). To have a uniform notation we will also use the definitions, for $k<0$, $\lambda_{k ; \omega, \underline{g}}(\underline{\mathbf{x}}) \stackrel{\text { def }}{=} \lambda \delta_{\sigma,-\sigma^{\prime}} \delta_{3}(\underline{\mathbf{x}})$ and $Z_{k ; \omega, \underline{\underline{( }}}\left(\mathbf{z} ; \underline{\mathbf{x}} \stackrel{\text { def }}{=} \delta_{\sigma, \sigma^{\prime}} \delta_{2}(\mathbf{z}, \underline{\mathbf{x}})\right.$.

It is well known, see for instance [2], that $V^{(k)}\left(\psi^{(\leq k)}, 0, J\right)$ can be represented as a sum over Gallavotti-Nicolò trees (in the following simply called trees) defined in the following way.


Figure 3: : A example of the Gallavotti-Nicolò tree.

The trees which can be constructed by joining a point $r$, the root, with an ordered set of $n \geq 1$ points, the endpoints of the tree, so that $r$ is not a branching point. $n$ will be called the order of the unlabeled tree and the branching points will be called the non trivial vertices. We associate a label $h \leq N-1$ with the root, $r$ and we introduce a family of vertical lines, labeled by an integer taking values in $[h, N+1]$, and we represent any tree $\tau \in \mathcal{T}_{h, n}$ so that, if $v$ is an endpoint or a non trivial vertex, it is contained in a vertical line with index $h_{v}>h$, to be called the scale of $v$, while the root is on the line with index $h$. The tree will intersect the vertical lines in set of points different from the root and the endpoints; these points will be called trivial vertices. The set of the vertices of $\tau$ will be the union of the endpoints, the trivial vertices and the non trivial vertices. Note that, if $v_{1}$ and $v_{2}$ are two vertices and $v_{1}<v_{2}$, then $h_{v_{1}}<h_{v_{2}}$. Moreover, there is only one vertex immediately following the root, which will be denoted $v_{0}$ and can not be an endpoint; its scale is $h+1$. There is the constraint, for the end-points of scale $h_{v}$, that $h_{v}=h_{v^{\prime}}+1$, if $v^{\prime}$ is the first non trivial vertex immediately preceding $v$. With each normal endpoint of scale $h_{v}$ we associate $\mathcal{L} \mathcal{V}^{h_{v}-1}$ given by (34) if $h_{v} \geq 0$ or (36) if $h_{v}<0$.

We introduce a field label $f$ to distinguish the field variables appearing in the terms $\mathcal{V}$ associated with the endpoints. If $v$ is a vertex of the tree $\tau, P_{v}$ is a set of labels which distinguish the external fields of $v$, that is the field variables of type $\psi$ which belong to one of the endpoints following $v$ and are not yet contracted in the vertex $v$. We will also call $n_{v}^{\psi} \stackrel{\text { def }}{=}\left|P_{v}\right|$ the number of such fields $\psi$, and $n_{v}^{J}$ the number of the field variables of type $J$ which belong to one of the endpoints following $v$. Finally, if $v$ is not an endpoint, $\mathbf{x}_{v}$ is the family of all space-time points associated with one of the endpoints following $v$. It is easy to verify that

With these definitions, we can rewrite $\mathcal{V}^{(k)}\left(\tau, \psi^{(\leq k)}\right)$ as:

& \mathcal{V}^{(k)}(\tau, \mathbf{P})=\int d \mathbf{x}_{v_{0}} \psi_{P_{v_{0}}}^{(\leq k)} K_{\tau, \mathbf{P}}^{(k)}\left(\mathbf{x}_{v_{0}}\right) \tag{42}
\end{align*}
$$

where $K_{\tau, \mathbf{P}}^{(h+1)}\left(\mathbf{x}_{v_{0}}\right)$ is defined inductively by (41).
By lemma 2.1 and calling $\varepsilon_{k}=\max _{\omega, \underline{\sigma}} \max _{k \leq h \leq N}\left\{\left\|\lambda_{h ; \omega, \underline{\sigma}}\right\|_{k},\left\|\nu_{h ; \sigma}\right\|_{k}\right\}$

\left\|K_{\tau, \mathbf{P}}^{(k)}\right\|_{k} \leq\left(c \varepsilon_{k+1}\right)^{n-n_{v_{0}}^{J}} \gamma^{k\left(2-\frac{\left|P_{v_{0}}\right|}{2}-n_{v_{0}}^{J}\right)} \prod_{v \text { not e.p. }} \gamma^{-\left(\frac{\left|P_{v}\right|}{2}-2+z_{v}+n_{v}^{J}\right)} \tag{43}

where, if $h_{v}>0, z_{v} \equiv 0$. If $h_{v} \leq 0, z_{v}=2$ if $\left|P_{v}\right|+2 n_{v}^{J}=2 ; z_{v}=1$ if $\left|P_{v}\right|+2 n_{v}^{J}=4$, and $z_{v}=0$ otherwise. The proof of (43) is an immediate consequence of the analysis in $\S 3$ of [2], based on (17) and teh Gram-Hadamard inequality. The following lemma is an immediate consequence of the above bound.

Lemma 2.3 There exist $C>1$ and $\varepsilon>0$ such that, for $\varepsilon_{k+1} \leq \varepsilon$ and $\max _{h \geq k+1}\left\|Z_{k, \omega, \sigma}\right\|_{k}<2$,

Proof. For $h_{v}>0$ the definition of $\mathcal{R}$ imposes the constraint that there are no $v$ such that $\left(\left|P_{v}\right|, n_{v}^{J}\right)=(4,0),(2,0),(2,1)$; this implies that, for any $v$,

In order to sum over $\tau$ and $\mathbf{P}$ (for more details, see again [2]) we note that the number of unlabeled trees is $\leq 4^{n}$; fixed an unlabeled tree, the number of terms in the sum over the various labels of the tree is bounded by $C^{n}$, except the sums over the scale labels and the sets $\mathbf{P}$. Let $V(\tau)$ the nontrivial vertices of $\tau$. In order to bound the sums over the scale labels and $\mathbf{P}$ we use the inequality

and the first factor in the r.h.s. allow to bound the sums over the scale labels by $C^{n}$, while the the sum over $\mathbf{P}$ can be bounded by using the following combinatorial inequality. Let $\left\{p_{v}, v \in \tau\right\}$ a set of integers such that $p_{v} \leq$ $\sum_{i=1}^{S_{v}} p_{v_{i}}$ for all $v \in \tau$ which are not endpoints; then

## 3 Power counting improvement

The bound (44) is of course not sufficient to prove the boundedness of the kernels $W_{\underline{\sigma}, \underline{\omega}}^{(n ; 2 m)(k)}$, as we need to prove that $\bar{\varepsilon}_{k}$ is small uniformly in $k$. On the other hand $\vec{v}_{h}=\left(\lambda_{h}, \gamma^{h} \nu_{h}, Z_{h}^{(2)}\right)$ verify the equation, for $h \geq 0$

where $\vec{\beta}_{h}$ is expressed by a sum of trees such that the first non trivial vertex has scale $h+1$ (from the property $\mathcal{L R}=0$ ), and $\vec{v}_{N}=\left(\lambda \delta_{-\sigma^{\prime}, \sigma}, 0, \delta_{\sigma, \sigma^{\prime}}\right)$. Iterating the above equation one finds

and there is no reason a priori for which $\vec{v}_{h}$ should remain close to $\vec{v}_{N}$; this property will be established by a careful analysis implying an improvement of the previous bounds. We will prove in fact the following theorem.

Theorem 3.1 For $|\lambda|$ small enough, there exist a constant $C_{1}>1$ such that, for $0 \leq h \leq N$

where (with slight abuse of notation) $v \delta_{2} \equiv \delta(\mathbf{x}-\mathbf{y}) v(\mathbf{x}-\mathbf{u}) \delta(\mathbf{u}-\mathbf{v})$.

An immediate consequence of the above theorem, together with (36), (37), (44), (49) is the boundedness of the kernels $W_{\omega, \boldsymbol{\sigma}}^{(n ; 2 m)(k)}$ for $|\lambda|$ small enough (and since, for $h \geq 0, \gamma^{-h} \leq 1$ )

To shorten the notation, in this proof we call $\eta \stackrel{\text { def }}{=} \psi^{\leq k}$. By definition of the effective interaction, $\mathcal{V}^{(k)}$, we have

By the explicit expression of the function $\mathcal{V}^{(N)}$ we obtain:

+ & +\int d \mathbf{w} v(\mathbf{x}-\mathbf{w})\left[\frac{\partial^{2} \mathcal{V}^{(k)}}{\partial J_{\mathbf{w}, \omega,-\sigma} \partial \varphi_{\mathbf{x}, \sigma}^{+}}+\frac{\partial \mathcal{V}^{(k)}}{\partial J_{\mathbf{w}, \omega,-\sigma}} \frac{\partial \mathcal{V}^{(k)}}{\partial \varphi_{\mathbf{x}, \omega, \sigma}^{+}}\right](\eta, J, 0) . \tag{53}

+ & \int d \mathbf{u} d \mathbf{u}^{\prime} g_{\omega}^{[k+1, N]}(\mathbf{x}-\mathbf{u}) g_{\omega}^{[k+1, N]}\left(\mathbf{x}-\mathbf{u}^{\prime}\right) \\
& \cdot\left[\frac{\partial^{2} \mathcal{V}^{(k)}}{\partial \eta_{\mathbf{u}, \omega, \sigma}^{+} \partial \eta_{\mathbf{u}^{\prime}, \omega, \sigma}^{-}}+\frac{\partial \mathcal{V}^{(k)}}{\partial \eta_{\mathbf{u}, \omega, \sigma}^{+}} \frac{\partial \mathcal{V}^{(k)}}{\partial \eta_{\mathbf{u}^{\prime}, \omega, \sigma}^{-}}\right] \tag{56}

We will use the following straightforward bounds, for $c_{0}, c_{1}, c_{2}>1$ :

We start the improvement of the dimensional bounds by considering $W_{\sigma}^{(0 ; 2)(k)}$. By symmetry we have $W_{-\sigma}^{(1 ; 0)(k)}(\mathbf{w}) \equiv 0$; hence from (53) and (55) we expand the two-points kernel as in Fig. 4

so that, from the bound (44), $\left\|W_{-\sigma ; \sigma}^{(1 ; 2)(k)}\right\|_{k} \leq C$ given by (44), and by the second of (57), we obtain

which proves the first of (50), since $\frac{1-\gamma^{-1}}{c_{1}}<1\left(C_{1}\right.$ is chosen so large to have such a factor because of later usage). Let us consider now $W_{\sigma^{\prime} ; \sigma}^{(1 ; 2)(k)}$, which from (53) can be rewritten as in Fig. 5

In order to obtain an improved bound also for the graphs (b) and (c) of Fig. 55, we need to further expand $W_{\sigma^{\prime} ; \sigma}^{(2 ; 0)(k)}$. Using (56), we find

In order to obtain bound uniform in $N-k$, it is convenient to decompose the three propagators $g_{\omega} g_{\omega} g_{\omega}$ into scales, $\sum_{j, i, i^{\prime}=k}^{N} g_{\omega}^{(j)} g_{\omega}^{(i)} g_{\omega}^{\left(i^{\prime}\right)}$ and then, for any realization of $j, i, i^{\prime}$, to take the $|\cdot|_{1}$ norm on the two propagator on the higher scales, and the $|\cdot|_{\infty}$ norm on the propagator with the lowest one. In this way we obtain:

where, in the last inequality, we have taken $|\lambda|$ small enough, and we have used that $\sum_{j=k}^{N} \gamma^{-j}(j-k) \leq C \sum_{j=k}^{N} \gamma^{-j} \gamma^{(j-k) / 2} \leq C^{\prime} \gamma^{-k}$.

\stackrel{\text { def }}{=} \lambda \delta_{\sigma^{\prime},-\sigma} \delta(\mathbf{x}-\mathbf{y}) \int d \mathbf{w} v(\mathbf{x}-\mathbf{w})\left[g_{-\omega}^{[k+1, N]}(\mathbf{w}-\mathbf{z})\right]^{2} \tag{67}
\end{array}
$$

For $\mathbf{k}^{*}=\left(-k_{0}, k\right)$, it holds $\widehat{g}_{\omega}^{[k+1, N]}(\mathbf{k})=-i \omega \widehat{g}_{\omega}^{[k+1, N]}\left(\mathbf{k}^{*}\right)$ hence

\cdot \sum_{j=0,1} \int_{0}^{1} d \tau \int d \mathbf{w}\left(\partial_{j} v\right)(\mathbf{x}-\mathbf{z}+\tau(\mathbf{z}-\mathbf{w}))\left(z_{j}-w_{j}\right) g_{\omega}^{[k+1, N]}(\mathbf{w}-\mathbf{z})

and the first addend is vanishing because of (68). Hence, using the third of (57),

\leq 4|\lambda| \int d \mathbf{x}\left|\left(\partial_{j} v\right)(\mathbf{x})\right| \sum_{i=k}^{N} \sum_{j=k}^{i}\left|g_{-\omega}^{(j)}\right|_{\infty} . \\
\cdot \int d \mathbf{w}\left|w_{j}\right|\left|g_{\omega}^{(i)}(\mathbf{w})\right| \leq|\lambda| \frac{C_{1}}{20} \gamma^{-k} \tag{70}
\end{array}

5.The expression for (b3) is:

As in the previous cases, it is convenient first to decompose the propagators $g_{\omega}(\mathbf{w}-\mathbf{z}) g_{\omega}\left(\mathbf{w}-\mathbf{w}^{\prime}\right) g_{\omega}\left(\mathbf{w}^{\prime}-\mathbf{u}\right)$ into scales, $\sum_{j, i, i^{\prime}=k}^{N} g_{\omega}^{(j)} g_{\omega}^{(i)} g_{\omega}^{\left(i^{\prime}\right)}$ and then, for any realization of $j, i, i^{\prime}$, to bound with $|\cdot|_{1}$ norm the two propagators on highest scale, and with $|\cdot|_{\infty}$ norm the one on lower scale. Finally, for $|\lambda|$ small enough, we have:

7. Similar arguments can be used to bound also the graph (b5).

Finally, it is also clear that a bound for (c) of Fig. 5 can be found along the same lines discussed for (b) of the same figure. We have so proved, therefore

Finally from (53) we obtain the identity in Fig. 8,

Therefore the bound for the sum of the graphs (a), (b), (d), and (e) is

Indeed, the last inequality follows from the just proved, improved bound $\left\|W_{\sigma ; \sigma^{\prime}}^{(1 ; 2)(k)}-\delta_{\sigma, \sigma^{\prime}} \delta_{2}\right\|_{k} \leq \frac{C_{1}}{C_{2}}|\lambda| \gamma^{-k}$. Finally, the graph (c) is

Using (44), $\left\|W_{-\sigma ; \sigma, \sigma^{\prime}}^{(1 ; 4)}\right\| \leq C|\lambda| \gamma^{-k}$ and

From this the third of (50) follows and the theorem is proved.

## 4 Schwinger functions

The multiscale integration of (4), when $\varphi \neq 0$, is obtained by a slight modification of the one presented in $\S 2$. In particular $\mathcal{V}^{(k)}\left(\psi^{(\leq k)}, \phi, J\right)$ is given by an expression similar to (13), sum of monomials in $\psi^{(\leq k)}, J$ and $\phi$. We define $\mathcal{L}=0$ on the kernels of the monomials containing at least a $\phi$ except when the monomial is $\varphi_{\mathbf{x}, \omega, \sigma}^{+} \psi_{\mathbf{y}, \omega, \sigma}^{-(\leq k+1)}$ or $\psi_{\mathbf{y}, \omega, \sigma}^{+(\leq k+1)} \varphi_{\mathbf{x}, \omega, \sigma}^{-}$; in such a case the kernel is $\widehat{g}_{\omega}(\mathbf{k}) \widehat{W}_{\sigma}^{(0 ; 2)(k)}(\mathbf{k})$ and we define, for $0 \leq k \leq N$,

while, for $k<0, \mathcal{L} \equiv 0$. Correspondingly , for $k>0$ we define

and using (59) we obtain $\left\|\widetilde{\nu}_{k, \omega, \sigma}\right\|_{k} \leq C_{1}|\lambda| \gamma^{-k}$; while for $k<0$ we set $\widetilde{\nu}_{k, \omega, \sigma}(\mathbf{x}, \mathbf{y}) \equiv 0$, because of the fact that $\widehat{W}_{\sigma}^{0 ; 2(k)}(0)=0$ by symmetries, and then there is an automatic dimensional gain:

Let $\widetilde{\varepsilon}_{k}$ be larger than $\varepsilon_{k}$ and $\max _{\omega, \sigma} \max _{h: k \leq h \leq N}\left\|\widetilde{\nu}_{k, \omega, \sigma}\right\|_{k}$. The 2-points Schwinger function is given by

where $\overline{\mathcal{T}}_{h, n}^{n^{\varphi}, n^{J}}$ is the set of trees with $n$ endpoints, $n^{\varphi}$ special endpoints of type $\varphi, n^{J}$ endpoints of type $J$ and first vertex scale $j ; n_{v}^{J}, n_{v}^{\phi}$ are the number of fields of type $J, \phi$ associated to end-points following $v$. If $h$ is the first nontrivial vertex $u$ of $\tau$, and $h_{1}$ and $h_{2}$ are the scale of the two endpoints of type $\varphi$, we have

\frac{\gamma^{2 h}}{1+\left[\gamma^{h}|\mathbf{x}-\mathbf{y}|\right]^{\frac{q}{2}}}
\end{array}
$$

Indeed, (83) is the same of (43), for $\left|P_{v_{0}}\right|=2, n_{v_{0}}^{J}=0$, times some factors more.

1. The presence, with respect to the graphical expansion of the kernels, of two external propagators, $g_{\omega}^{\left(h_{1}\right)}$ and $g_{\omega}^{\left(h_{2}\right)}$, causes the factor $\gamma^{-h_{1}-h_{2}}$.
2. Before performing the bounds as for the kernels, it is possible to extract from the bound on the propagator (11) a factor $b_{h}=(1+$ $\left.\left(\gamma^{h}|\mathbf{x}-\mathbf{y}|\right)^{\frac{g}{2}}\right)^{-1}$ : the product of $b_{h}$ for each of the propagators of the graph that are not involved into the Gram determinant (18) can be bounded with the factor $\left[1+\left[\gamma^{h}|\mathbf{x}-\mathbf{y}|\right]^{\frac{g}{2}}\right]^{-1}$ in (83) at the price of a constant $C^{n}$.
3. The bounds for the kernels can be straightforwardly modified also for obtaining the factor $\gamma^{2 h}$ : it is the effect of the missed integration in the variable $\mathbf{x}-\mathbf{y}$, that causes the replacement of $|\cdot|_{1}$-norm with the $|\cdot|_{\infty}$-norm of a propagator $g_{\omega}$; this occurs in correspondence of $v$, the vertex with highest scale, $h$, in which the two special endpoints of type $\varphi$ are connected.

It is convenient to call $\left|P_{v}\right|=n_{v}^{\psi}+n_{v}^{\varphi}$. We have that $z_{v}$ is the same of (43), with a further case in which it is not zero: if $h_{v}<0$ and $n_{v}^{\psi}=n_{v}^{\varphi}=1$, then $z_{v}=1$. This is because the automatic dimensional gain depicted in (81).

Along the tree $\tau$, we consider three paths: $\mathcal{C}_{1}$ and $C_{2}$, connecting the endpoint of type $\varphi$ on scale $h_{1}$ and the one on scale $h_{2}$ respectively with $v_{0}$; and $\mathcal{C}$ connecting $u$ with $v_{0}$. For $j=1,2$, we find $\gamma^{-h_{j}}=\gamma^{-j} \prod_{v \in \mathcal{C}_{j}} \gamma^{-1}$ and $\gamma^{-j}=\gamma^{-h} \prod_{v \in \mathcal{C}} \gamma$. These identities, replaced in (83), gives:

and $\frac{n_{v}^{\psi}}{2}+\frac{3 n_{v}^{\varphi}}{2}-2+z_{v}>0$, as well as $\frac{n_{v}^{\psi}}{2}>0$ for $v \in \mathcal{C}$ : we can perform the summation on the trees, keeping fixed the scale $h$.

\left|S_{N ; \omega ; \sigma}(\mathbf{x}, \mathbf{y})-g_{\omega}^{(\leq N)}(\mathbf{x}, \mathbf{y})\right| \leq C|\lambda| \sum_{h \leq N} \frac{\gamma^{h}}{1+\left[\gamma^{h}|\mathbf{x}-\mathbf{y}|\right]^{\frac{g}{2}}} \leq C|\lambda| \frac{1}{|\mathbf{x}-\mathbf{y}|} \tag{85}
\end{equation*}
$$

Finally, we want to study the difference $S_{N ; \omega ; \sigma}(\mathbf{x}, \mathbf{y})-S_{\omega ; \sigma}(\mathbf{x}, \mathbf{y})$ for $\mathbf{x}-\mathbf{y} \neq 0$.

+\sum_{n=0}^{\infty} \sum_{j=-\infty}^{+\infty} \sum_{\tau \in \overline{\mathcal{T}}_{j, n}^{2,0}} \sum_{\substack{\mathbf{P} \in \mathcal{P} \\
\left|P_{v_{0}}\right|=2}} D_{\tau}(\mathbf{x}, \mathbf{y}) \tag{86}
\end{array}

In such a tree expansion, $D_{\tau}(\mathbf{x}, \mathbf{y})$ is not zero only in two cases: either $\tau$ has at least one vertex $v^{*}$ on scale $h^{*}>N$; or $\tau$ has vertices scales $\leq N$, but has an endpoint which, in turn, has tree expansion with at least one vertex $v^{*}$ on scale $h^{*}>N$. If $\tau$ is of the former type, fixed $\vartheta$, we have

\gamma^{-\vartheta\left(h^{*}-h\right)}\left(\prod_{v \text { not e.p. }}^{v \notin \mathcal{C}} \gamma^{-\left(\frac{n_{v}^{\psi}}{2}+\frac{3 n_{v}^{\varphi}}{2}-2+z_{v}-\vartheta\right)}\right) \prod_{v \in \mathcal{C}} \gamma^{-\frac{n_{v}^{\psi}}{2}} \tag{87}
\end{array}
$$

It $\tau$ is of the latter type, we still have the above bound, by induction on the subtrees in which the endpoints can be expanded: indeed, in the analysis of the previous section it is clear that if the fermion propagator is constrained to be on scale $>N$, bounds (50) are still true, with a more factor $\gamma^{-\vartheta\left(h^{*}-k\right)}$, which, together to a factor $\gamma^{-\vartheta(k-h)}$ gives the wanted $\gamma^{-\vartheta\left(h^{*}-h\right)}$.

For $\vartheta>0$ and but small enough, we still have $\frac{n_{v}^{\psi}}{2}+\frac{3 n_{v}^{\varphi}}{2}-2+z_{v}-\vartheta>0$. This means that we can perform the summation on the trees, keeping fixed the scale $k$. As $\gamma^{-\vartheta\left(h^{*}-h\right)} \leq \gamma^{-\vartheta(N-h)}$,

& \leq C \frac{1}{\gamma^{\vartheta N}|\mathbf{x}-\mathbf{y}|^{1+\vartheta}} \tag{88}
\end{align*}

## 5 Ward Identities

Let us consider the 2-point Schwinger function with one density insertion:

In the generating functional (4), we perform the phase-chiral transformation

The rest $\Delta_{\omega ; \sigma^{\prime}, \sigma}(\mathbf{p} ; \mathbf{k})$ does not vanish in the limit of removed cutoff, but rather it causes the anomaly of the Ward Identities.

It follows that, given $\tau$, if $h_{-}$and $h_{+}$are the scale indices of the $\psi$ fields belonging to the endpoints associated with $\varphi^{+}$and $\varphi^{-}$, while $h_{J}$ denotes the scale of the endpoint of type $J, \widehat{G}_{\tau}(\mathbf{p} ; \mathbf{k})$ can be different from 0 only if $h_{-}=h_{\mathbf{k}}, h_{\mathbf{k}}+1, h_{+}=$ $h_{\mathbf{k}-\mathbf{p}}, h_{\mathbf{k}-\mathbf{p}}+1$ and $h_{J} \geq h_{\mathbf{p}}-\log _{\gamma} 2$. Moreover, if $\mathcal{T}_{j_{0}, n}^{\mathbf{p}, \mathbf{k}}$ denotes the set of trees satisfying the previous conditions and $\tau \in \mathcal{T}_{j_{0}, n}^{\mathrm{p}, \mathbf{k}},\left|\widehat{G}_{\tau}(\mathbf{p} ; \mathbf{k})\right|$ can be bounded by $\int d \mathbf{z} d \mathbf{x}\left|G_{\tau}(\mathbf{z} ; \mathbf{x}, \mathbf{y})\right|$. Given $\tau \in \mathcal{T}_{j_{0}, n}^{\mathbf{p}, \mathbf{k}}$, let $v_{0}^{*}$ the higher vertex preceding all three special endpoints and $v_{1}^{*} \geq v_{0}^{*}$ the higher vertex preceding either the two endpoints of type $\varphi$ or one endpoint of type $\varphi$ and the endpoint of type $J$. We have $d_{v}>0$, except for a finite number of vertices belonging to the path $\mathcal{C}^{*}$ connecting $v_{1}^{*}$ with $v_{0}^{*}$, where $d_{v}=0$ :
a) the vertices with $\left|P_{v}\right|=4$ and $n_{v}^{J}=0$; since there is a momentum $\mathbf{k}$ flowing inside the corresponding cluster and $\mathbf{k}-\mathbf{p}$ flowing outside, by conservation of the momenta the scale label of both of the other $\psi$ fields - and hence also the scale label of such vertices - cannot be less than $\log _{\gamma}(|\mathbf{p}| / 2) ;$
b) the vertices with $\left|P_{v}\right|=2$ and $n_{v}^{J}=1$; with a momentum $\mathbf{p}$ flowing inside the cluster and either a momentum $\mathbf{k}$ flowing inside or $\mathbf{k}-\mathbf{p}$ flowing outside, the scale label of such vertices cannot be less than $\min \left\{h_{+}, h_{-}\right\}-1$.

Accordingly, the number of the vertices depicted in the above list is not larger than $\min \left\{\left|h_{\mathbf{k}}-h_{\mathbf{p}}\right|,\left|h_{\mathbf{k}-\mathbf{p}}-h_{\mathbf{p}}\right|\right\}+2-\log _{\gamma} 2$. Thus we can replace in (94) the rough bound:

We remark that the presence of the cutoff function $\bar{\chi}_{N}(\mathbf{p}) \stackrel{\text { def }}{=} \sum_{j=-N}^{N} \widehat{f}_{j}(\mathbf{p})$ is immaterial for (98), since $\mathbf{p}$ is finite and nonzero. But it is essential for the multiscale integration, because it simplify the discussion of the tadpoles.

A crucial role in the following analysis is played by the functions

where $n_{v}^{\alpha}$ is the number of endpoints of type $\alpha$ following the vertex $v$ and, by construction, $n_{v_{0}}^{\alpha}=1$. $\frac{\left|P_{v}\right|}{2}-2+z_{v}+n_{v}^{\alpha}>0$; this formula implies immediately (109).

The bound (104) says that, for obtaining the dimensional bound (116), the function $S^{(i, j)}$ is exactly equivalent to the contraction of the operator $J \psi^{+} \psi^{-}$, with one $\psi$ field contracted on scale $i$, and the other contracted on scale $j$. This is coherent with thinking to the external field $D_{\omega}(\mathbf{p}) \widehat{\alpha}_{\mathbf{p}, \omega, \sigma}$ as bearing the same dimension of the $J$ field.

To avoid the $(n!)^{2}$ bounds for the truncated expectation require more care. Indeed, in the contraction of the operator $J \psi^{+} \psi^{-}$one propagator belongs to the anchored tree of formula (17), while the other may belong to the anchored tree, or be inside the Gram determinant. When studying the the contraction of the kernel $T_{0}$ it is convenient to avoid the bound of the Gram determinant with (24) directly. The determinant can be expanded with respect to the entries of one the row and the corresponding minors; in particular, we choose the row (made of $l$ entries) containing the propagator coming out of the operator $T_{0}$, so that, together with the other propagator in the anchored tree, we can reconstruct the function $S^{(i, j)}$ times a monomial in the parameters $\mathbf{t}$ that can be always bounded by 1 ; the corresponding minors are Gram determinants of dimension $l-1$, that can be bounded as in (11). Therefore, the expansion with respect to a row make us loose a factor $l$ with respect to the usual bound, namely a $C^{n}$ factor more in the final bound.

In order to prove (115) we note that

The reason for which in the second line of (117) there is $W_{\omega ; \sigma, \sigma^{\prime}}^{(0 ; 4)(k)}(\mathbf{u}, \mathbf{w}, \mathbf{x}, \mathbf{y})$ and not also non-connected graphs whit four external legs is the following:
a) Defining $\left(1-\chi_{N}(\mathbf{k})\right) f_{i}(\mathbf{k})=\delta_{i, N} u_{N}(\mathbf{k})$, the graphs in which one between the fields $\widehat{\psi}$ in $T_{0}$ is contracted with a kernel $\widehat{W}_{\sigma}^{(0 ; 2)(k)}$ is of the form:

This term is not compatible with the structure of the multiscale expansion of the Schwinger functions, since by support properties we have $|\mathbf{k}+\mathbf{p}|,|\mathbf{k}|>\gamma^{N}$ while, by construction, the fields $\psi_{\mathbf{k}+\mathbf{p}}^{\leq N-1}$ and $\psi_{\mathbf{k}}^{\leq N-1}$, implies the constraint $|\mathbf{k}+\mathbf{p}|,|\mathbf{k}|<\gamma^{N}$.
b) The graphs in which all and two the fields $\widehat{\psi}$ in $T_{0}$ are contracted, each one with its own $\widehat{W}_{\sigma}^{(0 ; 2)(k)}$ have the form

(117) is analyzed in a way similar to the one followed in $\S 3$; by using the decomposition of $W_{\omega, \sigma}^{(0 ; 4)(k)}$ in Fig. 8, so obtaining the decomposition for $W_{\Delta ; \bar{\omega}, \omega, \sigma, \sigma^{\prime}}^{(1 ; 2)(k)}$ depicted in Fig 9,
Fixed the integer $q$ and calling $b_{j}(\mathbf{x}) \stackrel{\text { def }}{=} C_{q} \gamma^{j} /\left(1+\left[\gamma^{j}|\mathbf{x}|\right]^{q}\right)$, we bound the r.h.s. member in the same spirit as in $\S 3$.

Hence a bound can be obtained with the same above argument, with only one important difference: the contribution that in the previous analysis were compensated by (b) now are zero by symmetries. Indeed, calling $\mathbf{k}^{*}$ the rotation of $\mathbf{k}$ of $\pi / 2$ and since $\widehat{S}_{\bar{\omega}, \omega}^{(i, j)}\left(\mathbf{k}^{*}, \mathbf{p}^{*}\right)=-\omega \bar{\omega} \widehat{S}_{\bar{\omega}, \omega}^{(i, j)}(\mathbf{k}, \mathbf{p})$, in place of the bound (127), in this case we have:

We can finally discuss the bound for $R_{\omega ; \sigma^{\prime}, \sigma}^{(1 ; 2)}(\mathbf{p} ; \mathbf{k})$ so finally proving Lemma 5.4. It can be written by a sum of trees essentially identical to the ones for $\widehat{G}_{\omega ; \sigma^{\prime}, \sigma}^{(1 ; 2)}(\mathbf{p} ; \mathbf{k})$, with the only important difference that there are three different special endpoints associated to the field $\alpha$, corresponding to the three different terms in (100); we call these endpoints of type $T_{+}, T_{-}, T_{0}$ respectively.

The sum over the trees such that the endpoint is of type $\nu_{k, \omega, \sigma}^{ \pm}$can be bounded as in (94), the only difference being that, thanks to the bound (115), one has to multiply the r.h.s. by a factor $|\lambda| \gamma^{-\frac{1}{2}(N-k)}$, for $k$ the scale of the endpoint. This factor has to be inserted also in the r.h.s. of the bounds (95), hence, it is easy to see that the contributions of these trees vanishes as $N \rightarrow \infty$.

Let us now consider the trees with an endpoint of type $T_{0}$. The fields of the $T_{0}$ endpoint are contracted at scale $j, N$; this implies that $h_{J}=N$ : since $d_{v}+r_{v}-1 / 4>0$ for all vertices belonging to the path connecting the endpoint to the root, we can replace in the r.h.s. of the bounds (95) $d_{v}+r_{v}$ with $d_{v}+r_{v}-1 / 4$ and add a factor $\gamma^{-\left(N-h_{\mathbf{k}}\right) / 4}$, so that

2. The contraction of $\widehat{\psi}_{\mathbf{q}+\mathbf{p}, \omega,-\varepsilon \sigma}^{+}$with $\widehat{\psi}_{\mathbf{k}+\mathbf{p}, \omega, \sigma}^{-}$(that can take place only for $\varepsilon=-)$, possibly through a kernel $\widehat{W}^{(0 ; 2)(k)}(\mathbf{q}+\mathbf{p})$, and possibly with $\widehat{\psi}_{\mathbf{q}, \omega,-\varepsilon \sigma}^{-}$contracted with a second kernel $\widehat{W}^{(0 ; 2)(k)}(\mathbf{q})$, has the following expression

\begin{array}{r}
\widehat{A}_{-}(\mathbf{p})=\frac{\nu_{N} \widehat{v}^{2}(\mathbf{p}) D_{-\omega}(\mathbf{p})}{D_{\omega}^{2}(\mathbf{p})-\nu_{N}^{2} \widehat{v}^{2}(\mathbf{p}) D_{-\omega}^{2}(\mathbf{p})} \\
=\frac{\nu_{N} \widehat{v}^{2}(\mathbf{p}) D_{-\omega}(\mathbf{p})}{D_{\omega}^{2}(\mathbf{p})} \sum_{p \geq 0}\left(\frac{\nu_{N} \widehat{v}(\mathbf{p}) D_{-\omega}(\mathbf{p})}{D_{\omega}(\mathbf{p})}\right)^{2 p} \stackrel{\text { def }}{=} \sum_{p \geq 0} \widehat{A}_{p,-}(\mathbf{p}) \tag{160}
\end{array}
$$

Under a rotation of an angle $\vartheta$, we have:

$$
\begin{array}{r}
\widehat{A}_{p,-}\left(\mathbf{p}^{*}\right)=e^{-i \omega \vartheta(4 p+3)} \widehat{A}_{p,-}(\mathbf{p}) \\
\widehat{W}_{p^{\prime}, \omega, \sigma}^{(0 ; 2)(k)}\left(\mathbf{p}^{*}\right)=e^{-i \omega \vartheta\left(2 p^{\prime}-1\right)} \widehat{W}_{p^{\prime}, \omega, \sigma}^{(0 ; 2)(k)}(\mathbf{p}) \tag{161}
\end{array}
$$

and therefore, since $\left(4 p+4+2 p^{\prime}\right)>0$, taking $\vartheta: \vartheta\left(4 p+4+2 p^{\prime}\right)<2 \pi$, the integral (159), with $\widehat{A}_{-}(\mathbf{p})$ and $\widehat{W}_{\omega, \sigma}^{(0 ; 2)(k)}(\mathbf{p})$ replaced by $\widehat{A}_{p,-}(\mathbf{p})$ and $\widehat{W}_{p^{\prime}, \omega, \sigma}^{(0 ; 2)(k)}(\mathbf{p})$ respectively, is zero.
3. The contraction of $T_{1}$ with all and three fields contracted with the same kernel $\widehat{W}_{\omega, \underline{q}}^{(0 ; 4)(k)}$; and the contraction of $T_{-}$. They are:

$$
\begin{array}{r}
\widehat{H}_{T,, ;, \omega, \sigma}^{b(1 ; 1)(k)}(\mathbf{k}) \\
=\sum_{\bar{\omega}} \sum_{i, j=k}^{N} \int \frac{d \mathbf{p} d \mathbf{q}}{(2 \pi)^{4}} \bar{\chi}_{N}(\mathbf{p}) \widehat{A}_{\varepsilon}(\mathbf{p}) D_{\bar{\omega}}(\mathbf{p}) \widehat{S}_{\bar{\omega}, \omega}^{(i, j)}(\mathbf{q}+\mathbf{p}, \mathbf{q}) \\
\cdot \widehat{g}_{\omega}(\mathbf{p}+\mathbf{k}) \widehat{W}_{\underline{\sigma}}^{(0 ; 4)(k)}(\mathbf{k}+\mathbf{p}, \mathbf{q}+\mathbf{p}, \mathbf{q}) \\
+\int \frac{d \mathbf{p}}{(2 \pi)^{2}} \bar{\chi}_{N}(\mathbf{p}) \widehat{A}_{\varepsilon}(\mathbf{p}) \widehat{v}(\mathbf{p}) D_{-\omega}(\mathbf{p}) \\
\cdot \widehat{g}_{\omega}(\mathbf{p}+\mathbf{k}) \widehat{W}_{\underline{\sigma}}^{(1 ; 2)(k)}(\mathbf{k}+\mathbf{p}, \mathbf{p}) \tag{162}
\end{array}
$$

It has a bound as (115) times a further factor

|v|_{\infty} \cdot \sum_{j=k}^{N}\left|g_{\omega}^{j}\right|_{1} \leq C \gamma^{-k} \tag{163}
\end{equation*}
$$

For $k<0$, we have $H_{T, \varepsilon ; \omega, \sigma}^{b(1 ; 1)(k)}(0)=0$. This follows using (160), (161) and

$$
\begin{array}{r}
\widehat{A}_{+}(\mathbf{p})=\frac{\widehat{v}(\mathbf{p}) D_{\omega}(\mathbf{p})}{D_{\omega}^{2}(\mathbf{p})-\nu_{N}^{2} \widehat{v}^{2}(\mathbf{p}) D_{-\omega}^{2}(\mathbf{p})} \stackrel{\text { def }}{=} \sum_{p \geq 0} \widehat{A}_{p,+}(\mathbf{p}) \\
\widehat{A}_{p,+}\left(\mathbf{p}^{*}\right)=e^{-i \omega \vartheta(4 p+1)} \widehat{A}_{p,+}(\mathbf{p}) \\
\widehat{W}_{p^{\prime}, \underline{\sigma}}^{(0 ; 4)(k)}\left(\mathbf{p}^{*}\right)=e^{-i \omega \vartheta\left(2 p^{\prime}-2\right)} \widehat{W}_{p^{\prime}, \underline{\sigma}}^{(0 ; 4)(k)}(\mathbf{p}) \\
D_{\bar{\omega}}\left(\mathbf{p}^{*}\right) \widehat{S}_{\bar{\omega}, \omega}^{(i, j)}\left(\mathbf{q}^{*}+\mathbf{p}^{*}, \mathbf{q}^{*}\right)=e^{-i \omega \vartheta} D_{\bar{\omega}}(\mathbf{p}) \widehat{S}_{\widehat{\omega}, \omega}^{(i, j)}(\mathbf{q}+\mathbf{p}, \mathbf{q}) \tag{165}
\end{array}
$$

This completes the proof.

## A Bounds for the $\Delta$ function

Because of the symmetry $\widehat{S}_{\omega, \omega^{\prime}}^{(i, j)}(\mathbf{p}, \mathbf{q})=\widehat{S}_{\omega, \omega^{\prime}}^{(j, i)}(\mathbf{q}, \mathbf{p})$, we will only concern the case $i \geq j$. A bound for $\widehat{S}_{\omega, \omega^{\prime}}^{(i, j)}$ can be obtained by explicit computation, using that

$$
f_{i}(\mathbf{k})\left(1-\chi_{N}^{-1}(\mathbf{k})\right)=-\delta_{i, N}\left(1-f_{N}(\mathbf{k})\right) \stackrel{\text { def }}{=}-\delta_{i, N} u_{N}(\mathbf{k})
$$

1. For $i=j=N$,

$$
\begin{aligned}
& \widehat{U}_{\omega}^{(N, N)}(\mathbf{q}+\mathbf{p}, \mathbf{q})=\left[u_{N}(\mathbf{q}) \frac{f_{N}(\mathbf{q}+\mathbf{p})}{D_{\omega}(\mathbf{q}+\mathbf{p})}-u_{N}(\mathbf{q}+\mathbf{p}) \frac{f_{N}(\mathbf{q})}{D_{\omega}(\mathbf{q})}\right] \bar{\chi}_{N}(\mathbf{p}) \\
&= \frac{u_{N}(\mathbf{q}) f_{N}(\mathbf{q}+\mathbf{p})}{D_{\omega}(\mathbf{q}) D_{\omega}(\mathbf{q}+\mathbf{p})} \bar{\chi}_{N}(\mathbf{p}) D_{\omega}(\mathbf{p}) \\
&+\frac{f_{N}(\mathbf{q})}{D_{\omega}(\mathbf{q})}\left[u_{N}(\mathbf{q})-u_{N}(\mathbf{q}+\mathbf{p})\right] \bar{\chi}_{N}(\mathbf{p}) \\
&\left.+\frac{u_{N}(\mathbf{q})}{D_{\omega}(\mathbf{q})}\left[f_{N}(\mathbf{q}+\mathbf{p})-f_{N}(\mathbf{q})\right] \bar{\chi}_{N}(\mathbf{p}) 166\right)
\end{aligned}
$$

Therefore we obtain:

$$
\begin{array}{r}
\widehat{S}_{\omega, \omega^{\prime}}^{(N, N)}(\mathbf{q}+\mathbf{p}, \mathbf{q}) \stackrel{\text { def }}{=}-\delta_{\omega, \omega^{\prime}} \bar{\chi}_{N}(\mathbf{p}) \frac{u_{N}(\mathbf{q}) f_{N}(\mathbf{q}+\mathbf{p})}{D_{\omega}(\mathbf{q}) D_{\omega}(\mathbf{q}+\mathbf{p})} \\
+\bar{\chi}_{N}(\mathbf{p}) \frac{f_{N}(\mathbf{q})}{D_{\omega}(\mathbf{q})} \int_{0}^{1} d \tau\left(\partial_{\omega^{\prime}} u_{N}\right)(\mathbf{q}+\tau \mathbf{p}) \\
+\bar{\chi}_{N}(\mathbf{p}) \frac{u_{N}(\mathbf{q})}{D_{\omega}(\mathbf{q})} \int_{0}^{1} d \tau\left(\partial_{\omega^{\prime}} f_{N}\right)(\mathbf{q}+\tau \mathbf{p}) \tag{167}
\end{array}
$$

2. For $j<N$, using also that $u_{N}(\mathbf{q}) f_{j}(\mathbf{q}) \equiv 0$ (the support of the two function is disjoint) we have

$$
\begin{array}{r}
\widehat{U}_{\omega}^{(N, j)}(\mathbf{q}+\mathbf{p}, \mathbf{q})=-\bar{\chi}_{N}(\mathbf{p}) u_{N}(\mathbf{q}+\mathbf{p}) \frac{f_{j}(\mathbf{q})}{D_{\omega}(\mathbf{q})} \\
\quad=-\bar{\chi}_{N}(\mathbf{p})\left[u_{N}(\mathbf{q}+\mathbf{p})-u_{N}(\mathbf{q})\right] \frac{f_{j}(\mathbf{q})}{D_{\omega}(\mathbf{q})} . \tag{168}
\end{array}
$$

Hence:

$$
\begin{equation*}
\widehat{S}_{\omega, \omega^{\prime}}^{(N, j)}(\mathbf{q}+\mathbf{p}, \mathbf{q})=\bar{\chi}_{N}(\mathbf{p}) \frac{f_{j}(\mathbf{q})}{D_{\omega}(\mathbf{q})} \int_{0}^{1} d \tau\left(\partial_{\omega^{\prime}} u_{N}\right)(\mathbf{q}+\tau \mathbf{p}) \tag{169}
\end{equation*}
$$

3. For $i, j<N$, we have $\widehat{U}_{\omega}^{(i, j)} \equiv 0$.

By inspection, since $\left|\partial_{\omega} f_{j}\right| \leq C \gamma^{-j}$ as well as $\left|\partial_{\omega} u_{N}\right| \leq C \gamma^{-N}$, we obtain that $\partial_{\mathbf{p}}^{m} \partial_{\mathbf{q}}^{n} \widehat{S}_{\omega, \omega^{\prime}}^{(N, j)}(\mathbf{p}, \mathbf{q})$ is not identically zero if one between $i=N ; \mathbf{q}: f_{j}(\mathbf{q}) \neq 0$ and $\mathbf{p}:|\mathbf{p}| \leq 2 \gamma^{N}$; in this case we obtain

$$
\begin{equation*}
\left|\partial_{\mathbf{p}}^{m} \partial_{\mathbf{q}}^{n} \widehat{S}_{\omega, \omega^{\prime}}^{(N, j)}(\mathbf{p}, \mathbf{q})\right| \leq C_{m, n} \gamma^{-N(1+m)-j(1+n)} \tag{170}
\end{equation*}
$$

The above bounds allow to obtain

$$
\begin{equation*}
\int \frac{d \mathbf{p} d \mathbf{q}}{(2 \pi)^{4}}\left|\partial_{\mathbf{p}}^{m} \partial_{\mathbf{q}}^{n} \widehat{S}_{\omega, \omega^{\prime}}^{(N, j)}(\mathbf{p}, \mathbf{q})\right| \leq C_{m, n}^{\prime} \gamma^{N(1-m)+j(1-n)} \tag{171}
\end{equation*}
$$

from which the former of (104) follows. The analysis for $P_{\bar{\omega}, \omega}^{(N, j)}$ is similar:

$$
\begin{array}{r}
\widehat{Q}_{\omega}^{(N, j)}(\mathbf{q}+\mathbf{p}, \mathbf{q})=\bar{\chi}_{N}(\mathbf{p}) u_{N}(\mathbf{p}+\mathbf{q}) \widehat{\chi}_{j}(\mathbf{q}) \\
=\bar{\chi}_{N}(\mathbf{p})\left[u_{N}(\mathbf{p}+\mathbf{q})-u_{N}(\mathbf{q})\right] \widehat{\chi}_{j}(\mathbf{q}) \tag{172}
\end{array}
$$

from which the latter of (104) follows.

## B Solution of the closed equation

By (135) into (132), in the limit $N \rightarrow \infty$

$$
\begin{equation*}
\partial_{\omega} S_{\omega, \sigma}(\mathbf{x})=\delta(\mathbf{x})+\lambda A_{-}(\mathbf{x}) S_{\omega, \sigma}(\mathbf{x}) \tag{173}
\end{equation*}
$$

whose solution is

$$
\begin{equation*}
S_{\omega, \sigma}(\mathbf{x})=\exp \left\{\lambda \int d \mathbf{z}\left[g_{\omega}(\mathbf{x}-\mathbf{z})-g_{\omega}(\mathbf{z})\right] A_{-}(\mathbf{z})\right\} g_{\omega}(\mathbf{x}) \tag{174}
\end{equation*}
$$

By (136), we first consider

$$
\begin{array}{r}
\int \frac{d \mathbf{p}}{(2 \pi)^{2}} e^{-i \mathbf{x} \cdot \mathbf{p}} \widehat{g}_{\omega}(\mathbf{p}) \widehat{v}(\mathbf{p}) a(\mathbf{p}) \\
=\int \frac{d \mathbf{p}}{(2 \pi)^{2}} F(\mathbf{p}) \frac{e^{-i \mathbf{x} \cdot \mathbf{p}}}{\left(p_{0}+i \omega s(\mathbf{p}) p_{1}\right)\left(p_{0}+i \omega p_{1}\right)} \tag{175}
\end{array}
$$

where

$$
s(\mathbf{p})=\frac{1+\nu \widehat{v}(\mathbf{p})}{1-\nu \widehat{v}(\mathbf{p})}, \quad F(\mathbf{p})=\frac{\widehat{v}(\mathbf{p})}{\nu \widehat{v}(\mathbf{p})-1}
$$

Indeed (175) is well defined for $\mathbf{x}=0$ : we can rewrite it separating the two domains $|\mathbf{p}| \leq 1$ and $|\mathbf{p}|>1$. The integral on the latter is absolutely convergent, since the decay of $F(\mathbf{p})$ is faster than any power. The integral of the former can be written as

$$
\begin{equation*}
F(0) \int_{|\mathbf{p}| \leq 1} \frac{d \mathbf{p}}{(2 \pi)^{2}} \frac{1}{\left(p_{0}+i \omega s p_{1}\right)\left(p_{0}+i \omega p_{1}\right)}+R \tag{176}
\end{equation*}
$$

where $R$ is again an absolutely convergent integral; the first integral can be written as

$$
\begin{array}{r}
\quad \int_{|\mathbf{p}| \leq 1} \frac{d \mathbf{p}}{(2 \pi)^{2}} \frac{1}{\left(p_{0}+i \omega s p_{1}\right)\left(p_{0}+i \omega p_{1}\right)}= \\
=-\int_{|\mathbf{p}| \leq 1} \frac{d \mathbf{p}}{(2 \pi)^{2}} \frac{1}{\left(i \omega p_{1}+s p_{0}\right)\left(i \omega p_{1}+p_{0}\right)} \\
=-  \tag{177}\\
-\int_{p_{0}^{2}+s^{2} p_{1}^{2} \leq 1} \frac{d \mathbf{p}}{(2 \pi)^{2}} \frac{1}{\left(p_{0}+i \omega p_{1}\right)\left(p_{0}+i \omega s p_{1}\right)}
\end{array}
$$

hence, the above integral also equals

$$
\begin{equation*}
\int \frac{d \mathbf{p}}{(2 \pi)^{2}} \frac{\chi\left(p_{0}^{2}+p_{1}^{2} \leq 1\right)-\chi\left(p_{0}^{2}+s^{2} p_{1}^{2} \leq 1\right)}{\left(p_{0}+i \omega s p_{1}\right)\left(p_{0}+i \omega p_{1}\right)} \tag{178}
\end{equation*}
$$

which is absolutely convergent since the support of $\chi\left(p_{0}^{2}+p_{1}^{2} \leq 1\right)-\chi\left(p_{0}^{2}+\right.$ $s^{2} p_{1}^{2} \leq s^{2}$ ) does not contain a neighbourhood of the origin.

Now we discuss (175) for $\mathbf{x} \neq 0$. It can be written as $H_{0}+H_{1}+H_{2}$, for

$$
\begin{array}{r}
H_{0}=F(0) \int \frac{d \mathbf{p}}{(2 \pi)^{2}} \frac{e^{-i \mathbf{x} \cdot \mathbf{p}}}{\left(p_{0}+i \omega s p_{1}\right)\left(p_{0}+i \omega p_{1}\right)} \\
H_{1}=\int \frac{d \mathbf{p}}{(2 \pi)^{2}} \frac{[F(\mathbf{p})-F(0)] e^{-i \mathbf{x} \cdot \mathbf{p}}}{\left(p_{0}+i \omega s p_{1}\right)\left(p_{0}+i \omega p_{1}\right)} \\
H_{2}=\int \frac{d \mathbf{p}}{(2 \pi)^{2}} F(\mathbf{p}) \frac{e^{-i \mathbf{x} \cdot \mathbf{p}}}{\left(p_{0}+i \omega p_{1}\right)}\left[\frac{1}{\left(p_{0}+i \omega p_{1}\right)}-\frac{1}{\left(p_{0}+i \omega s(\mathbf{p}) p_{1}\right)}\right] \tag{179}
\end{array}
$$

By straightforward computation, $H_{0}$ is given by

$$
\begin{array}{r}
\frac{1}{2 \pi(1-\nu)(s-1)} \int_{0}^{+\infty} \frac{d q_{1}}{q_{1}}\left[e^{-\left[\left|x_{0}\right| c+i x_{1} \omega \operatorname{sgn}\left(x_{0}\right)\right] q_{1}}\right. \\
\left.-e^{-\left[\left|x_{0}\right|+i x_{1} \omega \operatorname{sgn}\left(x_{0}\right)\right] q_{1}}\right] \\
=\frac{1}{4 \pi \nu} \ln \frac{x_{0}+i \omega x_{1}}{x_{0} s+i \omega x_{1}}, \tag{180}
\end{array}
$$

while both $H_{1}$ and $H_{2}$ are vanishing as $\mathbf{x} \rightarrow \infty$. Indeed $H_{1}$ can be written as

$$
\begin{align*}
& \int_{|\mathbf{p}| \leq N} \frac{d \mathbf{p}}{(2 \pi)^{2}}[F(\mathbf{p})-F(0)] \frac{e^{-i \mathbf{x} \cdot \mathbf{p}}}{\left(p_{0}+i \omega s p_{1}\right)\left(p_{0}+i \omega p_{1}\right)} \\
&+\int_{|\mathbf{p}| \geq N} \frac{d \mathbf{p}}{(2 \pi)^{2}} F(\mathbf{p}) \frac{e^{-i \mathbf{x} \cdot \mathbf{p}}}{\left(p_{0}+i \omega s p_{1}\right)\left(p_{0}+i \omega p_{1}\right)} \\
& \quad+F(0) \int_{|\mathbf{p}| \geq N} \frac{d \mathbf{p}}{(2 \pi)^{2}} \frac{e^{-i \mathbf{x} \cdot \mathbf{p}}}{\left(p_{0}+i \omega s p_{1}\right)\left(p_{0}+i \omega p_{1}\right)} \tag{181}
\end{align*}
$$

The second and third term are convergent integral, and each of them can be chosen small than $\frac{\varepsilon}{3}$ for $N$ large enough; the first integral is vanishing as $\mathrm{x} \rightarrow \infty$. A similar argument holds for $H_{3}$.
