# ON THE CLASS $\mathcal{R} \mathcal{S I}$ OF RATIONAL SCHUR FUNCTIONS INTERTWINING SOLUTIONS OF LINEAR DIFFERENTIAL EQUATIONS 

DANIEL ALPAY, ANDREY MELNIKOV, AND VICTOR VINNIKOV


#### Abstract

In this paper we extend and solve in the class of functions $\mathcal{R S} \mathcal{I}$ mentioned in the title, a number of problems originally set for the class $\boldsymbol{\mathcal { R }} \boldsymbol{\mathcal { S }}$ of rational functions contractive in the open right-half plane, and unitary on the imaginary line with respect to some preassigned self-adjoint matrix. The problems we consider include the Schur algorithm, the partial realization problem and the Nevanlinna-Pick interpolation problem. The arguments rely on the one-to-one correspondence between elements in a given subclass of $\boldsymbol{\mathcal { R S I }} \boldsymbol{\mathcal { I }}$ and elements in $\boldsymbol{\mathcal { R S }}$. Another important tool in the arguments is a new result pertaining to the classical tangential Schur algorithm.

## 1. Introduction

Functions $S(\lambda)$, which are $\mathbb{C}^{p \times p}$-valued, analytic and contractive in the open right half plane $\mathbb{C}_{+}$, or equivalently, such that the kernel

$$
K(\lambda, w)=\frac{I_{p}-S(w)^{*} S(\lambda)}{\lambda+w^{*}}
$$

is positive in $\mathbb{C}_{+}$, play an important role in system theory, inverse scattering theory, network theory and related topics; see for instance [ $\mathrm{L},[\mathrm{BC}], \mathrm{DD}],[\mathrm{He}, \mathrm{A}]$. Here, positivity of the kernel means that for every $n \in \mathbb{N}$ and every choice of points $w_{1}, \ldots, w_{n} \in \mathbb{C}_{+}$and vectors $\xi_{1}, \ldots, \xi_{n} \in \mathbb{C}^{1 \times p}$ the $n \times n$ Hermitian matrix

$$
\left.\left[\xi_{i} K\left(w_{i}, w_{j}\right) \xi_{j}^{*}\right)\right]_{i, j=1, \ldots n}
$$

is positive (that is, has all its eigenvalues greater or equal to 0 ).
Far reaching generalizations of this class were introduced in [M, MVc, in the study of $2 D$-linear systems (say, with respect to the variables $\left(t_{1}, t_{2}\right)$ ), invariant with respect to the variable $t_{1}$. To introduce the classes defined in these papers we first need a definition.

Definition 1.1. Let $\sigma_{1}, \sigma_{2}, \gamma$ and $\gamma_{*}$ be $\mathbb{C}^{p \times p}$-valued functions, continuous on an interval $\mathrm{I}=[a, b]$. Suppose moreover that $\sigma_{1}$ and $\sigma_{2}$ take self-adjoint values, and that $\sigma_{1}$ is differentiable and invertible on I , and that the following relations hold:

\gamma\left(t_{2}\right)+\gamma\left(t_{2}\right)^{*}=\gamma_{*}\left(t_{2}\right)+\gamma_{*}\left(t_{2}\right)^{*}=-\frac{d}{d t_{2}} \sigma_{1}\left(t_{2}\right), \quad t_{2} \in \mathrm{I}
$$

Then $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$ and the interval I are called vessel parameters.
The class of functions $\mathcal{S} \mathcal{I}$ corresponding to some vessel parameters $\sigma_{1}$, $\sigma_{2}, \gamma, \gamma_{*}$ and I was introduced in M, MVc] (see Definition [2.6 below) and consists of the functions $S\left(\lambda, t_{2}\right)$ of two variables $\lambda, t_{2}$ such that for every $t_{2} \in$ I the function $S\left(\lambda, t_{2}\right)$ is meromorphic in $\mathbb{C}_{+}$and the kernel

$$
\begin{equation*}
\frac{\sigma_{1}\left(t_{2}\right)-S\left(w, t_{2}\right)^{*} \sigma_{1}\left(t_{2}\right) S\left(\lambda, t_{2}\right)}{\lambda+w^{*}} \tag{1.1}
\end{equation*}
$$

is positive for $\lambda$ and $\omega$ in the domain of analyticity of $S\left(\lambda, t_{2}\right)$ in $\mathbb{C}_{+}$. For positive $\sigma_{1}\left(t_{2}\right)$, the positivity of the kernel implies that $S$ is analytic in $\mathbb{C}_{+}$; see [D0, [A]. For general (invertible) $\sigma_{1}\left(t_{2}\right)$, the entries of $S$ are of bounded type and $S$ has only poles in $\mathbb{C}_{+}$; see ADRS. It is also required that $S\left(\lambda, t_{2}\right)$ is analytic at infinity for each $t_{2}$, with value $I_{p}$ there, and that $S\left(\lambda, t_{2}\right)$ maps solutions of the input Linear Differential Equation (LDE) with the spectral parameter $\lambda$

$$
\lambda \sigma_{2}\left(t_{2}\right) u\left(\lambda, t_{2}\right)-\sigma_{1}\left(t_{2}\right) \frac{\partial}{\partial t_{2}} u\left(\lambda, t_{2}\right)+\gamma\left(t_{2}\right) u\left(\lambda, t_{2}\right)=0,
$$

to solutions of the output LDE

$$
\lambda \sigma_{2 *}\left(t_{2}\right) y\left(\lambda, t_{2}\right)-\sigma_{1 *}\left(t_{2}\right) \frac{\partial}{\partial t_{2}} y\left(\lambda, t_{2}\right)+\gamma_{*}\left(t_{2}\right) y\left(\lambda, t_{2}\right)=0 .
$$

It is proved in $M, M V c$ that elements of $\mathcal{S I}$ are the transfer functions of $t_{1}$-invariant conservative $2 D$ systems; see Section 2.

The purpose of this paper is to study various questions in $\mathcal{S I}$ in the case of functions rational in $\lambda$. A key result is the following theorem, which we prove in the sequel; see Section 4 .
Theorem 4.1 Let us fix the parameters $\sigma_{1}, \sigma_{2}$, and $\gamma$, and the interval I. Then for every $t_{2}^{0} \in \mathrm{I}$ there is a one-to-one correspondence between pairs $\left(\gamma_{*}, S\right)$ such that $S \in \mathcal{S I}$ and $\gamma_{*}$ continuous in a neighborhood of $t_{2}^{0}$, and functions $Y(\lambda)$, meromorphic in $\mathbb{C}_{+}$, and with the following properties
(1) $Y(\infty)=I_{p}$,
(2) $Y(\lambda)^{*} \sigma_{1}\left(t_{2}^{0}\right) Y(\lambda) \leq \sigma_{1}\left(t_{2}^{0}\right)$ for $\lambda \in \mathbb{C}_{+}$where $Y$ is analytic, and
(3) $Y(\lambda)^{*} \sigma_{1}\left(t_{2}^{0}\right) Y(\lambda)=\sigma_{1}\left(t_{2}^{0}\right)$ for every $\lambda$ satisfying $\Re \lambda=0$, and in a neighborhood of which $Y$ is analytic.
As mentioned above the $\sigma_{1}\left(t_{2}\right)$-contractivity of $Y$ implies that $Y$ is of bounded type in $\mathbb{C}_{+}$, and thus the asserted non-tangential limits exist almost everywhere. But it is important to note that the theorem does not consider these limits, but only the points $\lambda$ in the domain of analyticity of $Y$.

Definition 1.2. Functions $Y$ with the properties in Theorem 4.1 will be called $\sigma_{1}\left(t_{2}^{0}\right)$-inner functions, and their class will be denoted by $\mathcal{S}\left(t_{2}^{0}\right)$. The subclass of rational functions of $\boldsymbol{\mathcal { S }}\left(t_{2}^{0}\right)$ will be denoted by $\boldsymbol{\mathcal { R }} \boldsymbol{\mathcal { S }}\left(t_{2}^{0}\right)$.

For the sequel, it is important to notice that the general tangential Schur algorithm developped in AD can be applied to functions in $\boldsymbol{\mathcal { S }}\left(t_{2}^{0}\right)$, and in particular in $\boldsymbol{\mathcal { R }} \boldsymbol{\mathcal { S }}$.

Definition 1.3. $\mathcal{R S I}$ will denote the subclass of functions in $\mathcal{S I}$ which are rational in $\lambda$ for every $t_{2} \in \mathrm{I}$.

The paper consists of five sections besides the introduction, and we now describe their content. In Section 2 we review the main results from $[\mathrm{M}]$ and $[\mathrm{MVc}]$ on $t_{1}$-invariant conservative $2 D$-systems, relevant to the present work. In particular the class $\mathcal{S I}$ mentioned above consists of the transfer functions of these systems. In Section 3 we present the reproducing kernel space approach to the tangential Schur algorithm for the class $\boldsymbol{\mathcal { R }} \boldsymbol{\mathcal { S }}$, as developped in AD . We obtain in particular new formulas which allow us to find the main operator in a realization of an element of $\boldsymbol{\mathcal { R } \mathcal { S }}$ after one iteration of the tangential Schur algorithm; see formulas (3.15), (3.17), (3.16) in Theorem 3.5, In Section 4 we develop the tangential Schur algorithm for a function $S\left(\lambda, t_{2}\right) \in \boldsymbol{\mathcal { R S }} \mathcal{I}$. Applying directly the theory of the previous section to $S\left(\lambda, t_{2}\right)$ leads to a new function which need not belong to $\boldsymbol{\mathcal { R S I }}$. Instead, we apply the Schur algorithm to the $\sigma_{1}\left(t_{2}^{0}\right)$-inner function $S\left(\lambda, t_{2}^{0}\right)$ for some preassigned $t_{2}^{0} \in \mathrm{I}$, and obtain a simpler (in terms of McMillan degree) $\sigma_{1}\left(t_{2}^{0}\right)$-inner function $S_{0}\left(\lambda, t_{2}^{0}\right)$. We use Theorem 4.1 to obtain an element in a class $\boldsymbol{\mathcal { R S I }}$ from $S_{0}\left(\lambda, t_{2}^{0}\right)$. We call this procedure the tangential Schur algorithm for the class $\boldsymbol{\mathcal { R S I }}$. We study in Section 5 the coefficients (called the Markov moments) $H_{i}\left(t_{2}\right)$ of the expansion of $S\left(\lambda, t_{2}\right)$ around $\lambda=\infty$

$$
S\left(\lambda, t_{2}\right)=I_{p}-\sum_{i=0}^{\infty} \frac{1}{\lambda^{i+1}} H_{i}\left(t_{2}\right)
$$

It turns out that the first Markov moment $H_{0}\left(t_{2}\right)$ satisfies the Lyapunov equation

$$
\begin{equation*}
\gamma_{*}\left(t_{2}\right)-\gamma\left(t_{2}\right)=\sigma_{2}\left(t_{2}\right) H_{0}\left(t_{2}\right)-\sigma_{1}\left(t_{2}\right) H_{0}\left(t_{2}\right) \sigma_{1}^{-1}\left(t_{2}\right) \sigma_{2}\left(t_{2}\right), \quad t_{2} \in \mathrm{I} \tag{1.2}
\end{equation*}
$$

which means that given the functions $\sigma_{1}, \sigma_{2}, \gamma$ and $H_{0}$ on I, one can uniquely reconstruct $\gamma_{*}$, and, as a result of Theorem 4.1, there will exists a unique function $S\left(\lambda, t_{2}\right)\left(t_{2} \in \mathrm{I}\right)$ with the given Markov parameters. We solve the following problem:

Problem 1.4 (Partial realization). Suppose that we are given the functions $\sigma_{1}, \sigma_{2}$ and the Markov moments $H_{i}, i=0, \ldots, n(n \geq 0)$ defined in I, and satisfying there the (necessary) conditions (5.5)

$$
H_{i+1} \sigma_{1}^{-1}+(-1)^{i+1} \sigma_{1}^{-1} H_{i+1}^{*}=\sum_{j=0}^{i}(-1)^{j+1} H_{i-j} \sigma_{1}^{-1} H_{j}^{*}
$$

and (5.6)

$$
(-1)^{n} H_{2 n} \sigma_{1}^{-1}+\sum_{i=0}^{n-1}(-1)^{i+n} \sigma_{1}^{-1} H_{i}^{*} \sigma_{1} H_{2 n-1-i} \sigma_{1}^{-1}>0
$$

for $i=0, \ldots, n-1$. Fix $t_{2}^{0} \in$ I. Find all functions $\gamma$ for which there exists $S\left(\lambda, t_{2}\right) \in \boldsymbol{\mathcal { R S I }}$ defined in a neighborhood of $t_{2}^{0}$ with the moments $H_{i}\left(t_{2}\right)$ for $\gamma_{*}$ computed from (1.2)).
In Section 6 we study the Nevanlinna Pick interpolation problem in the class $\boldsymbol{\mathcal { R S I }}$. Let us recall that in classical Schur analysis, the solution of Nevanlinna Pick interpolation problem plays a special role; see for instance [FK], Dy, A]. Schur analysis gives a parametrization of all solutions (when they exist) for the given data. In the classical case the interpolation problem may be formulated in the following way:

Problem 1.5. Suppose that we are given $N$ pairs of points $\left\langle w_{j}, s_{j}\right\rangle$, $j=1, \ldots, N$ in $\mathbb{D} \times \mathbb{D}$, where $\mathbb{D}$ denotes the open unit disk. Then:
(1) Give sufficient and necessary conditions, so that there exists a function $s(z)$ analytic and contractive in $\mathbb{D}$, and such that $s\left(w_{j}\right)=s_{j}, j=1, \ldots, N$.
(2) Describe the set of all solutions for this problem.

As is well known, and originates with the work of Pick [P], Problem 1.5 is solvable if and only if the $N \times N$ Hermitian matrix

$$
\mathbb{P}=\left[\frac{1-s_{\ell} s_{j}^{*}}{1-w_{\ell} w_{j}^{*}}\right] \geq 0
$$

Nevanlinna [N] then gave a parametrization of all solutions, i.e., solved the second part of Problem [1.5, in the form $S(\lambda)=T_{\Theta}\left(S_{0}(\lambda)\right)$, where $T_{\Theta}$ denotes a linear fractional transformation uniquely determined from the initial data $\left.<w_{j}, s_{j}\right\rangle$, and where the parameter $S_{0}(\lambda)$ runs through all functions analytic and contractive in the open unit disk (that is, Schur functions). We refer to [BGR], Dy] for more information on this classical topic.

As a generalization of Problem 1.5 in the class $\boldsymbol{\mathcal { R S }} \boldsymbol{\mathcal { I }}$ we consider the following question:

Problem 1.6 (Nevanlinna-Pick interpolation). Let $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$ be vessel parameters and let I be an interval. Let $N \in \mathbb{N}$ and $w_{i}, i=1, \ldots, N$ be complex numbers. Suppose also that $N$ input functions $\xi_{i}\left(t_{2}\right)$ satisfying (2.16) with corresponding spectral parameters $w_{i}$ 's, and $N$ output functions $\eta_{i}\left(t_{2}\right)$ satisfying (2.17) with the given $w_{i}$ 's.
(1) Give sufficient and necessary conditions, so that there exists $S\left(\lambda, t_{2}\right) \in \mathcal{R} \mathcal{S I}$ such that $S\left(w_{j}, t_{2}\right) \xi_{i}\left(t_{2}\right)=\eta_{i}\left(t_{2}\right), j=1, \ldots, N$, on a sub-interval of I.
(2) Describe the set of all solutions for this problem.

One can also consider a harder problem, which can also be considered as a generalization of the classical Nevanlinna-Pick interpolation problem, which uses the fact that we can also specify the data for different values of $t_{2}$ :

Problem 1.7. Given $\mathbb{C}^{p \times p}$-valued functions $\sigma_{1}, \sigma_{2}, \gamma$ defined on I , and given $N$ quadruples $<t_{2}^{j}, w_{j}, \xi_{j}, \eta_{j}>$, where $t_{2}^{j} \in I, w_{j} \in \mathbb{C}_{+}, \xi_{j}, \eta_{j} \in$ $\mathbb{C}^{1 \times p} j=1, \ldots N$, then:
(1) Give sufficient and necessary conditions, so that there exists $\gamma_{*}$ and $S\left(\lambda, t_{2}\right) \in \mathcal{R S} \mathcal{I}$ such that $S\left(w_{j}, t_{2}^{j}\right) \xi_{j}=\eta_{j}, j=1, \ldots, N$, on a sub-interval of I containing all the $t_{2}^{j}$.
(2) Describe the set of all solutions for this problem.

If all the values $t_{2}^{j}=t_{2}^{0}$ are equal, we have to find a function $S\left(\lambda, t_{2}^{0}\right)$ satisfying $S\left(w_{j}, t_{2}^{0}\right) \xi_{j}=\eta_{j}$. Thus, the above problem is a generalization of the classical Nevanlinna-Pick interpolation problem. We also remark that we do not address the question of describing the set of all solutions.

Remarks: The present paper deals with the rational case; the general case will be treated in a forthcoming publication. Some of the results presented here have been announced in AMV.

## 2. $t_{1}$ INVARIANT CONSERVATIVE $2 D$ SYSTEMS.

The material in this section is taken from [M] and [MV1], where proofs and more details can be found. The origin of this theory can be found in the paper [Li].
2.1. Definition. An overdetermined conservative $t_{1}$-invariant $2 D$ system is a linear input-state-output ( $\mathrm{i} / \mathrm{s} / \mathrm{o}$ ) system, which consists of operators depending only on the variable $t_{2}$ and is of the following form:

I \Sigma:\left\{\begin{array}{l}
\frac{\partial}{\partial t_{1}} x\left(t_{1}, t_{2}\right)=A_{1}\left(t_{2}\right) x\left(t_{1}, t_{2}\right)+\widetilde{B}_{1}\left(t_{2}\right) u\left(t_{1}, t_{2}\right)  \tag{2.1}\\
x\left(t_{1}, t_{2}\right)=F\left(t_{2}, t_{2}^{0}\right) x\left(t_{1}, t_{2}^{0}\right)+\int_{t_{2}^{0}}^{t_{2}} F\left(t_{2}, s\right) \widetilde{B}_{2}(s) u\left(t_{1}, s\right) d s \\
y\left(t_{1}, t_{2}\right)=u\left(t_{1}, t_{2}\right)-\widetilde{B}\left(t_{2}\right)^{*} x\left(t_{1}, t_{2}\right)
\end{array}\right.
$$

where the variable $t_{1}$ belongs to $\mathbb{R}$, and the variable $t_{2}$ belongs to some interval I. Furthermore, the input $u\left(t_{1}, t_{2}\right)$ and the output $y\left(t_{1}, t_{2}\right)$ take
values in some Hilbert space $\mathcal{E}$ and the state $x\left(t_{1}, t_{2}\right)$ takes values in Hilbert spaces $\mathcal{H}_{t_{2}}$. We assume that $u\left(t_{1}, t_{2}\right)$ and $y\left(t_{1}, t_{2}\right)$ are continuous functions of each variable when the other variable is fixed. The operators of the system are supposed to satisfy the following:

## Assumptions 2.1.

(1) $A_{1}\left(t_{2}\right): \mathcal{H}_{t_{2}} \rightarrow \mathcal{H}_{t_{2}}$, and $\widetilde{B}\left(t_{2}\right): \mathcal{E} \rightarrow \mathcal{H}_{t_{2}}$ are bounded operators for all $t_{2}$,
(2) The functions $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}: \mathcal{E} \rightarrow \mathcal{E}$, are continuous in the operator norm topology.
(3) $\sigma_{1}\left(t_{2}\right)$ is an invertible operator for every $t_{2} \in \mathrm{I}$.
(4) $F(t, s)$ is an evolution continuous semi-group.

For continuous inputs $u\left(t_{1}, t_{2}\right)$, the inner state is continuously differentiable. Requiring now the invariance of the system transition from $\left(t_{1}^{0}, t_{2}^{0}\right)$ to $\left(t_{1}, t_{2}\right)$ via the points $\left(t_{1}^{0}, t_{2}\right)$ and $\left(t_{1}, t_{2}^{0}\right)$, is equivalent to the equality of second order partial derivatives of $x\left(t_{1}, t_{2}\right)$ :

\begin{equation*}
\frac{\partial^{2}}{\partial t_{1} \partial t_{2}} x\left(t_{1}, t_{2}\right)=\frac{\partial^{2}}{\partial t_{2} \partial t_{1}} x\left(t_{1}, t_{2}\right) \tag{2.2}
\end{equation*}
$$

Substituting in this equality the system equations we obtain that for the free evolution $u\left(t_{1}, t_{2}\right)=0$ the so called Lax equation holds

$$
\begin{equation*}
A_{1}\left(t_{2}\right)=F\left(t_{2}, t_{2}^{0}\right) A_{1}\left(t_{2}^{0}\right) F\left(t_{2}^{0}, t_{2}\right) \tag{2.3}
\end{equation*}
$$

Inserting (2.3) into (2.2) we see that the input $u\left(t_{1}, t_{2}\right)$ has to satisfy the following PDE

$$
\begin{aligned}
& \widetilde{B}\left(t_{2}\right) \sigma_{2}\left(t_{2}\right) \frac{\partial}{\partial t_{1}} u\left(t_{1}, t_{2}\right)-\widetilde{B}\left(t_{2}\right) \sigma_{1}\left(t_{2}\right) \frac{\partial}{\partial t_{2}} u\left(t_{1}, t_{2}\right)- \\
& \left(A_{1}\left(t_{2}\right) \widetilde{B}\left(t_{2}\right) \sigma_{2}\left(t_{2}\right)+F\left(t_{2}, t_{2}^{0}\right) \frac{\partial}{\partial t_{2}}\left[F\left(t_{2}^{0}, t_{2}\right) \widetilde{B}\left(t_{2}\right) \sigma_{1}\left(t_{2}\right)\right]\right) u\left(t_{1}, t_{2}\right)=0 .
\end{aligned}
$$

Assuming the existence of a function $\gamma\left(t_{2}\right)$ satisfying

$$
\begin{equation*}
A_{1}\left(t_{2}\right) \widetilde{B}\left(t_{2}\right) \sigma_{2}\left(t_{2}\right)+F\left(t_{2}, t_{2}^{0}\right) \frac{\partial}{\partial s}\left[F\left(t_{2}^{0}, t_{2}\right) \widetilde{B}\left(t_{2}\right) \sigma_{1}\left(t_{2}\right)\right]=-\widetilde{B}\left(t_{2}\right) \gamma\left(t_{2}\right) \tag{2.4}
\end{equation*}
$$

we obtain that it is enough that $u\left(t_{1}, t_{2}\right)$ satisfies the PDE

$$
\begin{equation*}
\sigma_{2}\left(t_{2}\right) \frac{\partial}{\partial t_{1}} u\left(t_{1}, t_{2}\right)-\sigma_{1}\left(t_{2}\right) \frac{\partial}{\partial t_{2}} u\left(t_{1}, t_{2}\right)+\gamma\left(t_{2}\right) u\left(t_{1}, t_{2}\right)=0 . \tag{2.5}
\end{equation*}
$$

The output $y\left(t_{1}, t_{2}\right)$ should satisfy the output compatibility condition of the same type as for the input compatibility condition (2.5), namely:

Here the sign of $-\Re(\lambda)$ determines the sign of $S\left(\lambda, t_{2}\right)^{*} \sigma_{1}\left(t_{2}\right) S\left(\lambda, t_{2}\right)$ $\sigma_{1}\left(t_{2}\right)$ and thus the third property is obtained. The fourth property follows directly from our construction.

Remark: When $\operatorname{dim} \mathcal{H}<\infty$, we obtain that $S\left(\lambda, t_{2}\right)$ is a rational function of $\lambda$ for every $t_{2}$.

It is an interesting fact that also the converse of Proposition 2.4 holds. It is proved in [M], [MVC, chapter 5].

Theorem 2.5. For any function of two variables $S\left(\lambda, t_{2}\right)$, satisfying the conditions of Proposition 2.4, there is a conservative $t_{1}$-invariant vessel whose transfer function is $S\left(\lambda, t_{2}\right)$.

We define the class of transfer functions mentioned in the introduction as follows:
Definition $2.6([\boxed{M V C}])$. The class $\mathcal{S} \boldsymbol{\mathcal { I }}=\boldsymbol{\mathcal { S }} \boldsymbol{\mathcal { I }}\left(\mathbf{U}\left(\lambda, \frac{\partial}{\partial t_{2}} ; t_{2}\right), \mathbf{U}_{*}\left(\lambda, \frac{\partial}{\partial t_{2}} ; t_{2}\right)\right)$ consists of functions $S\left(\lambda, t_{2}\right)$ of two variables, which are
(1) analytic in a neighborhood of $\lambda=\infty$ for all $t_{2}$ and where it holds $S\left(\infty, t_{2}\right)=I_{p}$,
(2) continuous as functions of $t_{2}$ for all $\lambda$,
(3) satisfy (2.19) and (2.20) in the domain of analyticity of $S$,
(4) map solutions of the input $L D E$ (2.16) with spectral parameter $\lambda$ to the output LDE (2.17) with the same spectral parameter

Recall (see [CoLe]) that to every LDE can be associated an invertible matrix (or operator) function $\Phi\left(t_{2}, t_{2}^{0}\right)$, called the fundamental solution, which takes value $I$ at some preassigned value $t_{2}^{0}$ and such that any other solution $u\left(t_{2}\right)$ of the LDE, with initial condition $u\left(t_{2}^{0}\right)=u_{0}$ is of the form

## 3. Schur analysis for the classical case

One of the approaches to the tangential Schur algorithm for a rational matrix function $S(\lambda) \in \mathbb{C}^{p \times p}$ is based on the theory of reproducing kernel Hilbert spaces of the kind introduced by de Branges and Rovnyak; see [dBR1], dBR2], Dy for information on these spaces. The paper (AD considers the case of column-valued functions. In this section we adapt the results of AD to the case of row-valued functions. We also present a new formula for a realization of a Schur function after implementation of the tangential Schur algorithm.
3.1. Schur functions and Reproducing Kernel Hilbert spaces. In this section $\sigma_{1}$ denotes a fixed self-adjoint and invertible (but not necessarily unitary) matrix in $\mathbb{C}^{p \times p}$. Let $S(\lambda)$ be a rational function, $\sigma_{1}$-inner in the open right half plane, i.e.

is finite dimensional. These well-known facts can be proved using realization theory; see for instance [AG. Furthermore, $\mathcal{H}(S)$ is the reproducing kernel Hilbert space, associated to the kernel $K_{S}(\lambda, w)$. The inner product is defined by

$$
\left\langle c K_{S}(\lambda, \nu), d K_{S}(\lambda, w)\right\rangle_{\mathcal{H}_{S}}=\left\langle c K_{S}(w, \nu)\right\rangle_{C^{1 \times p}}=c K_{S}(w, \nu) d^{*} .
$$

For an arbitrary $f(\lambda) \in \mathcal{H}(S)$ we have the reproducing kernel property

$$
\langle f(\lambda), \xi K(\lambda, w)\rangle_{\mathcal{H}_{S}}=f(w) \xi^{*} .
$$

More generally, let now $\mathcal{M}$ be a finite dimensional Hilbert space of $\mathbb{C}^{1 \times p}$-valued functions defined in some set $\Omega$, and let $\left\{f_{1}(\lambda), \ldots, f_{N}(\lambda)\right\}$ be a basis of $\mathcal{M}$. Let $\mathbb{X} \in \mathbb{C}^{p \times p}$ denote the Gram matrix with $\ell, j$ entry given by

It is easily seen that the space $\mathcal{M}$ is a reproducing kernel Hilbert space with kernel given by the formula

Assume now that $\mathcal{M}$ consists of rational functions, defined on a set $\Omega(\mathcal{M})$. For $\alpha \in \Omega(\mathcal{M})$ the backward-shift operator $R_{\alpha}$ is defined by

R_{\alpha}(f(\lambda))=\frac{f(\lambda)-f(\alpha)}{\lambda-\alpha} .

Suppose that:
(1) The space $\mathcal{M}$ is invariant under the action of $R_{\alpha}$,
(2) The functions $f_{i}(\lambda)$ has the property that $f_{i}(\infty)=0$, i.e., $F(\infty)=0$,
then the function $F$ given by (3.4) can be written as

for suitably chosen matrices $A, B$. In this special case, formula (3.3) takes the form

As mentioned at the beginning of this section we are interested in kernels of the form (3.1) for some $\sigma_{1}$-inner rational function $S$. We now recall the characterization of these spaces, and first note the following: equation (3.1) leads to

Theorem 3.1. Let $\mathcal{M}$ be a finite dimensional Hilbert space of $\mathbb{C}^{1 \times p_{-}}$ valued rational functions, which are zero at infinity. Suppose that $R_{\alpha} \mathcal{M} \subset \mathcal{M}$ for $\alpha \in \Omega(\mathcal{M})$ and let $\mathbb{X}$ be its Gram matrix with respect to $F(\lambda)$. Then $\mathcal{M}=\mathcal{H}(S)$ for $S$ defined by (3.7) if and only if the Lyapunov equation

holds.
When the spectrum of the operator $A$ is in the open left half plane $\Re \lambda<0$, one has

\mathcal{H}(S)=\mathbf{H}_{2, \sigma_{1}} \ominus \mathbf{H}_{2, \sigma_{1}} S
$$

where $\mathbf{H}_{2, \sigma_{1}}$ is the Hardy space $\mathbf{H}_{2}^{p}$ with the inner product

[f, g]_{\mathbf{H}_{2, \sigma_{1}}}=\left\langle f, g \sigma_{1}^{-1}\right\rangle_{\mathbf{H}_{2}^{p}} .
$$

We set $J=\left[\begin{array}{cc}-\sigma_{1} & 0 \\ 0 & \sigma_{1}\end{array}\right]$. Note that $J$ is both invertible and selfadjoint, and one can define $J$-inner rational functions. Let $\Theta=\left[\begin{array}{cc}\Theta_{11} & \Theta_{12} \\ \Theta_{21} & \Theta_{22}\end{array}\right]$ be a $J$-inner rational function; we introduce the linear fractional transformation

T_{\Theta}(W)=\left(\Theta_{11}+W \Theta_{21}\right)^{-1}\left(\Theta_{12}+W \Theta_{22}\right)
$$

Theorem 3.2. Let $S$ and $\Theta$ be respectively $\sigma_{1}$-inner $J$-inner rational functions. Then there exists a $\sigma_{1}$-inner rational function $W$ such that $S=T_{\Theta}(W)$ if and only if the map

is a contraction from $\mathcal{H}(\Theta)$ to $\mathcal{H}(S)$.
This theorem originates with the work of de Branges and Rovnyak (see dBR1, Theorem 13 p. 305]), where it is proved in a more general setting, and is one of the key ingredients to the reproducing kernel approach to the Schur algorithm. The proof is the same as for columnvalued functions, and is omitted.

As a special case of the previous theorem we have:
Corollary 3.3. Given $S \in \mathcal{R} \mathcal{S}, w_{1}, \ldots, w_{n} \in \mathbb{C}_{+}$, and row vectors $\xi_{1}, \ldots, \xi_{n} \in \mathbb{C}^{1 \times p}$, define

Then there exists $S_{0} \in \boldsymbol{\mathcal { R }} \boldsymbol{\mathcal { S }}$ such that $S=T_{\Theta}\left(S_{0}\right)$.
Proof: Let us denote by $t$ the map (3.9). For an arbitrary element $f(\lambda)=\eta F(\lambda)$, we shall obtain that

& =\sum_{i} \xi_{i} \eta_{i} K_{S}\left(\lambda, w_{i}\right)
\end{aligned}

and consequently,

\langle t f, t f\rangle & =\left\langle\sum_{i} \xi_{i} \eta_{i} K_{S}\left(\lambda, w_{i}\right), \sum_{j} \xi_{j} \eta_{i} K_{S}\left(\lambda, w_{j}\right)\right\rangle= \\
& =\sum_{i j} \eta_{i} \xi_{i} K_{S}\left(w_{j}, w_{i}\right) \eta_{j}^{*} \xi_{j}^{*}=\eta \mathbb{X} \eta^{*}= \\

Thus $t$ is an isometry and Theorem 3.2 allows to conclude.
The following result shows that the assumption $\mathbb{X}>0$ in the statement of Corollary 3.3 can always be achieved for $n=1$.

Lemma 3.4. Given $S \in \mathcal{R} \mathcal{S}$ which is not the function identically equal to $I_{p}$. Then there exist a pair $(\xi, w) \in \mathbb{C}^{1 \times p} \times \mathbb{C}_{+}$such that the corresponding $\mathbb{X}>0$.

Proof: We proceed by contradiction. Assume that for each $w \in \mathbb{C}_{+}$ and for each vector $\xi$, it holds that

3.2. Analysis of the tangential Schur algorithm. For $n=1$, the matrix function in (3.11) becomes

-\frac{\xi^{*} \eta \sigma_{1}}{\mathbb{X}\left(\lambda+w^{*}\right)} & I_{p}-\frac{\xi^{*} \xi \sigma_{1}}{\mathbb{X}\left(\lambda+w^{*}\right)}
\end{array}\right]=\left[\begin{array}{cc}
\Theta_{11} & \Theta_{12} \\
\Theta_{21} & \Theta_{22}
\end{array}\right],

To the best of our knowledge, Theorem 3.5 below is new. It will be of much use in the following sections.

& \times\left[\begin{array}{cc}
\lambda I-A_{0} & -\frac{B_{0} \sigma_{1} \xi^{*}}{\mathbb{X}} \\
\eta \sigma_{1} B_{0}^{*} \mathbb{X}_{0}^{-1} & \lambda+w^{*}+\frac{\eta \sigma_{1}\left(\eta^{*}-\xi^{*}\right)}{\mathbb{X}}
\end{array}\right]^{-1}\left[\begin{array}{c}
B_{0} \\
\eta-\xi
\end{array}\right] \sigma_{1} .
\end{aligned}
$$

Thus we have obtained the realization (3.15) -(3.17). Furthermore, the Lyapunov equation (3.10) holds since

\mathbb{X}_{0} & 0 \\
0 & \mathbb{X}
\end{array}\right]+ \\
& \\
& +\left[\begin{array}{cc}
\mathbb{X}_{0} & 0 \\
0 & \mathbb{X}
\end{array}\right]\left[\begin{array}{cc}
A_{0}^{*} & -\mathbb{X}_{0}^{-1} B_{0} \sigma_{1} \eta^{*} \\
\frac{\xi \sigma_{1} B_{0}^{*}}{\mathbb{X}} & -w-\frac{\left(\eta^{*}-\xi^{*}\right) \sigma_{1} \eta^{*}}{\mathbb{X}}

The last equality follows easily from the Lyapunov equation for the given realization of $S_{0}$ and the formula (3.13).

## 4. The tangential Schur algorithm in the class $\boldsymbol{\mathcal { R } \mathcal { S }} \boldsymbol{\mathcal { I }}$

Our strategy to the tangential Schur algorithm in the class $\boldsymbol{\mathcal { R S I }}$ relies on the following theorem. This theorem shows in particular that one cannot use the naive approach of applying the classical tangential Schur algorithm for each $t_{2}$ (that is, looking at $t_{2}$ as a mere parameter). The theorem itself is stated and proved for the non-rational case.

Theorem 4.1. Let us fix the parameters $\sigma_{1}, \sigma_{2}$, and $\gamma$, and the interval I. Then for every $t_{2}^{0} \in \mathrm{I}$ there is a one-to-one correspondence between pairs $\left(\gamma_{*}, S\right)$ such that $S \in \mathcal{S} \mathcal{I}$ and $\gamma_{*}$ continuous in a neighborhood of $t_{2}^{0}$, and functions $Y(\lambda) \in \mathcal{S}\left(t_{2}^{0}\right)$.

Proof: Let $\phi$ be the map which to a pair $\left(\gamma_{*}, S\right)$ associates the function $S\left(\lambda, t_{2}^{0}\right) \in \mathcal{S}\left(t_{2}^{0}\right)$. The converse map $\psi: Y(\lambda) \rightarrow Y\left(\lambda, t_{2}\right)$ was introduced in (M], MV1, chapter 7] in a more general setting, and is defined as follows. Suppose that we have realized the transfer function $Y(\lambda)$ in the form

Then we construct $B\left(t_{2}\right)$ from the differential equation with the spectral matrix parameter $A_{1}$ :

In fact, the function $B\left(t_{2}\right)$ is given by the formula

Next we construct $\mathbb{X}\left(t_{2}\right)$ on the maximal interval $\mathcal{I}$, where it is invertible (2.14) via the formula

Finally, we define

& -\sigma_{1}\left(t_{2}\right) B\left(t_{2}\right)^{*} \mathbb{X}^{-1}\left(t_{2}\right) B\left(t_{2}\right) \sigma_{2}\left(t_{2}\right) .
\end{aligned}
$$

Then easy computations show that the function

S\left(\lambda, t_{2}\right)=I_{p}-B\left(t_{2}\right)^{*} \mathbb{X}^{-1}\left(t_{2}\right)\left(\lambda I-A_{1}\right)^{-1} B\left(t_{2}\right) \sigma_{1}\left(t_{2}\right) \tag{4.4}
\end{equation*}
$$

is in the class $\mathcal{C} \mathcal{I}$ corresponding to the parameters $\sigma_{1}\left(t_{2}\right), \sigma_{2}\left(t_{2}\right), \gamma\left(t_{2}\right)$, and $\gamma_{*}\left(t_{2}\right)$ for $t_{2} \in \mathrm{I}$. Moreover, the Lyapunov equation (3.8) holds for
every $t_{2} \in \mathrm{I}$, and thus the realization (4.4) is minimal for every $t_{2} \in \mathrm{I}$.
Note that the composition $\phi \circ \psi=i d$, since starting from a function $Y \in \mathcal{S}\left(t_{2}^{0}\right)$, constructing $Y\left(\lambda, t_{2}\right)$ and taking its value at $t_{2}^{0}$, we shall obtain again $Y$ from the initial conditions of the differential equations (4.1) and (4.3) defining $B\left(t_{2}\right), \mathbb{X}\left(t_{2}\right)$.

In order to show that $\psi \circ \phi=i d$, we start from a function $S\left(\lambda, t_{2}\right) \in \boldsymbol{\mathcal { S }}$ and take its value $S\left(\lambda, t_{2}^{0}\right) \in \mathcal{S}\left(t_{2}^{0}\right)$. Using the construction above, we shall obtain a function $Y\left(\lambda, t_{2}\right)$. Note that the two functions $S\left(\lambda, t_{2}\right)$ and $Y\left(\lambda, t_{2}\right)$ have the same value at $t_{2}^{0}$ and maps solutions of the same input LDE to (possibly different) output LDEs, i.e. :

& Y\left(\lambda, t_{2}\right)=\Phi_{*}^{\prime}\left(\lambda, t_{2}, t_{2}^{0}\right) S\left(\lambda, t_{2}^{0}\right) \Phi^{-1}\left(\lambda, t_{2}, t_{2}^{0}\right)
\end{aligned}
$$

Then the function $S^{-1}\left(\lambda, t_{2}\right) Y\left(\lambda, t_{2}\right)$ is equal to $I_{p}$ at infinity and is entire. By Liouville's theorem it is a constant function and is equal to $I_{p}$. Thus

from where we obtain that

Differentiating both sides of this last equation we get to

\end{aligned}
$$

Since the matrices $\Phi_{*}\left(\lambda, t_{2}, t_{2}^{0}\right), \Phi_{*}^{\prime}\left(\lambda, t_{2}, t_{2}^{0}\right), \sigma_{1}\left(t_{2}\right)$ are invertible we obtain that $\gamma\left(t_{2}\right)=\gamma^{\prime}\left(t_{2}\right)$.

Remark: Last theorems claims that the correspondence is between "initial" values $S\left(\lambda, t_{2}^{0}\right)$ and pairs $\left(S\left(\lambda, t_{2}\right), \gamma_{*}\left(t_{2}\right)\right)$. Notice that it is possible to obtain functions with the same $\gamma_{*}\left(t_{2}\right)$ with different initial conditions:

Proposition 4.2. Suppose that there exists a function $Y \in \mathcal{S}\left(t_{2}^{0}\right)$, which commutes with $\Phi\left(\lambda, t_{2}, t_{2}^{0}\right)$ and suppose that a function $S \in \boldsymbol{\mathcal { S }}$ corresponds to certain vessel parameters $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$. Then the function $S Y$ belongs to the class $\boldsymbol{\mathcal { S }}$ and corresponds to the same vessel parameters $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$.

Proof: Using formula 2.21 we obtain that

intertwines solutions of the input (2.16) and the output (2.17) ODEs with the spectral parameter $\lambda$, and is identity at infinity, because $S$ and $Y$ and their product are such. Thus by the definition the function $S Y \in \mathcal{S I}$ and corresponds to the same spectral parameters as $S$. For example (to be studied in subsection [5.2), taking

\end{array}\right] V
$$

where

V=\left[\begin{array}{cc}
-\frac{\sqrt{2} k}{\lambda} & 1 \\
\frac{\sqrt{2} k}{\lambda} & 1
\end{array}\right], \quad k=\frac{(1+i) \sqrt{\lambda}}{2} .
$$

Taking $Y$, which commutes with $\sigma_{1}^{-1}\left(\sigma_{2} \lambda+\gamma\right)=\left[\begin{array}{ll}0 & i \\ \lambda & 0\end{array}\right]$, i.e. of the form

Y(\lambda)=I_{2}-\left[\begin{array}{cc}
a(\lambda) & \frac{i c(\lambda)}{\lambda} \\
c(\lambda) & a(\lambda)
\end{array}\right]
$$

we shall obtain that for any $S \in \mathcal{S} \mathcal{I}$, the function $S Y \in \mathcal{S I}$ and corresponds to the same vessel parameters.
A stronger condition on $\gamma_{*}\left(t_{2}\right)$ will be presented in section 5, after we shall study Markov moments of the transfer functions.
We now focus on the rational case. We first note that starting from different realizations at $t_{2}^{0}$ we shall obtain the same $\gamma_{*}\left(t_{2}\right)$. More precisely we have the following theorem:
Theorem 4.3. Suppose that there are two minimal realizations of the function $S\left(\lambda, t_{2}^{0}\right) \in \mathcal{R S}$ :

$$
S\left(\lambda, t_{2}^{0}\right)=I_{p}-B_{\ell}^{*} \mathbb{X}_{\ell}^{-1}\left(\lambda I-A_{1}\right)^{-1} B_{\ell} \sigma_{1}\left(t_{2}^{0}\right), \quad \ell=1,2
$$

with associated similarity matrix $V$. Then the functions

$$
S_{\ell}\left(\lambda, t_{2}\right)=I_{p}-B_{\ell}\left(t_{2}\right)^{*} \mathbb{X}_{\ell}^{-1}\left(t_{2}\right)\left(\lambda I-A_{\ell}\right)^{-1} B_{\ell}\left(t_{2}\right) \sigma_{1}\left(t_{2}\right), \quad \ell=1,2
$$

obtained from these realizations via the construction in Theorem 4.1 are the same, and this holds if and only if:

B_{2}\left(t_{2}\right)=V B_{1}\left(t_{2}\right), \tag{4.5}
\end{equation*}
$$

where $t_{2}$ varies in a neighborhood of $t_{2}^{0}$. Moreover, in this case the following formula holds

$$

Proof: Equality of the two realizations means that there exists an invertible matrix $V$ such that

A_{2}=V A_{1} V^{-1}, B_{2} \sigma_{1}\left(t_{2}^{0}\right)=V B_{1} \sigma_{1}\left(t_{2}^{0}\right), B_{1}^{*} \mathbb{X}_{1}^{-1} V=B_{2}^{*} \mathbb{X}_{2}^{-1}
$$

from which follows (see [AG, Lemma 2.1 p. 184] for instance) that

By the construction described in Theorem4.1, the function $B_{1}\left(t_{2}\right)$ will satisfy (4.1)

\frac{d}{d t_{2}}\left[B_{1}\left(t_{2}\right) \sigma_{1}\left(t_{2}\right)\right]+A_{1} B_{1}\left(t_{2}\right) \sigma_{2}\left(t_{2}\right)+B_{1}\left(t_{2}\right) \gamma\left(t_{2}\right)=0, \quad B_{1}\left(t_{2}^{0}\right)=B_{1}
$$

and the function $B_{2}\left(t_{2}\right)$ will satisfy the same equation with $A_{2}$ instead of $A_{1}$ :

\frac{d}{d t_{2}}\left[B_{2}\left(t_{2}\right) \sigma_{1}\left(t_{2}\right)\right]+A_{2} B_{2}\left(t_{2}\right) \sigma_{2}\left(t_{2}\right)+B_{2}\left(t_{2}\right) \gamma\left(t_{2}\right)=0, \quad B_{2}\left(t_{2}^{0}\right)=B_{2}
$$

Using the equalities $A_{2}=V A_{1} V^{-1}, B_{2}=V B_{1}$ we obtain that the function $V^{-1} B_{2}\left(t_{2}\right)$ satisfies

& \frac{d}{d t_{2}}\left[V^{-1} B_{2}\left(t_{2}\right) \sigma_{1}\left(t_{2}\right)\right]+A_{1} V^{-1} B_{2}\left(t_{2}\right) \sigma_{2}\left(t_{2}\right)+V^{-1} B_{2}\left(t_{2}\right) \gamma\left(t_{2}\right)=0, \\
& V^{-1} B_{2}\left(t_{2}^{0}\right)=B_{1}
\end{aligned}
$$

which is the same differential equation as for $B_{1}\left(t_{2}\right)$. Thus $B_{2}\left(t_{2}\right)=$ $V B_{1}\left(t_{2}\right)$. Similarly, considering the differential equations

we obtain that

$$

Consequently,

B_{2}^{*}\left(t_{2}\right) \mathbb{X}_{2}^{-1}\left(t_{2}\right) B\left(t_{2}\right) & =B_{1}^{*}\left(t_{2}\right) V^{*} V^{-1 *} \mathbb{X}_{1}^{-1}\left(t_{2}\right) V^{-1} V B_{1}\left(t_{2}\right) \\
& =B_{1}^{*}\left(t_{2}\right) \mathbb{X}_{1}^{-1}\left(t_{2}\right) B_{1}\left(t_{2}\right),
\end{aligned}
$$

from where we conclude that the same function $\gamma_{*}$ is associated to $S_{1}\left(\lambda, t_{2}\right)$ and $S_{2}\left(\lambda, t_{2}\right)$. Since these functions coincide for $t_{2}=t_{2}^{0}$ and map the same input ODE, we obtain that they are equal in a neighborhood of $t_{2}^{0}$.

The following notion has been introduced and studied in M2].

Definition 4.4. Let $S \in \mathcal{R} \mathcal{S} \mathcal{I}$ with a realization (4.4). The function

\tau\left(t_{2}\right)=\operatorname{det} \mathbb{X}\left(t_{2}\right)
$$

is called the $\tau$-function associated to $S$.
It follows from Theorem 4.3 that the $\tau$ function is well defined up to a multiplicative strictly positive constant. Indeed using the notation of the theorem,

We now introduce the counterpart of the tangential Schur algorithm in the class $\mathcal{R S I}$. Let $S \in \boldsymbol{\mathcal { R S I }} \boldsymbol{\mathcal { I }}$ and fix $t_{2}^{0} \in \mathrm{I}$. The function $S\left(\lambda, t_{2}^{0}\right) \in \mathcal{R} \mathcal{S}$. Consider now a space $\mathcal{M}$ with $\mathbb{X}>0$ and corresponding function $\Theta$ as in Corollary 3.3. This is always possible in view of Lemma 3.4. It follows from Theorem 3.2 that there exists $S_{0} \in \mathcal{R} \mathcal{S}$ such that

\end{equation*}

Applying Theorem 4.1 to $S_{0}$, we obtain a uniquely defined function $S_{0}\left(\lambda, t_{2}\right) \in \boldsymbol{\mathcal { R S I }}$, such that at $t_{2}^{0}$ the relation (4.6) holds.

Definition 4.5. The map $T_{\Theta, t_{2}^{0}}$

S\left(\lambda, t_{2}\right) \mapsto S_{0}\left(\lambda, t_{2}\right)
$$

is the time-varying counterpart of the linear fractional transformation (4.6). We will call it a generalized linear fractional transformation.

If $S\left(\lambda, t_{2}\right) \in \mathcal{S} \mathcal{I}$ corresponds to the vessel parameters $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$, then $S_{0}\left(\lambda, t_{2}^{0}\right) \in \mathcal{S I}$ corresponds to the vessel parameters $\sigma_{1}, \sigma_{2}, \gamma$, $\gamma_{0, *}$ for a uniquely defined function $\gamma_{0, *}\left(t_{2}\right)$. Moreover, for $t_{2}=t_{2}^{0}$ we have the usual linear fractional transformation (4.6).

As a consequence of Theorem 4.1 the following lemma holds.
Lemma 4.6. For a given $J$-inner function $\Theta$ and a given point $t_{2}^{0}$, the map $T_{\Theta, t_{2}^{0}}$ is one-to-one from $\boldsymbol{\mathcal { R S }}$ into $\mathcal{R S I}$.
Proof: Notice that for a given $t_{2}^{0}$ the map $T_{\Theta}$ is injective. Furthermore, using Theorem 4.1, every $S \in \mathcal{R S \mathcal { I }}$ is uniquely defined by the function $S\left(\lambda, t_{2}^{0}\right) \in \boldsymbol{\mathcal { R S }}$. The result follows.

Suppose now that we start from $S_{0}(\lambda) \equiv I_{p}$ and apply $n$ linear fractional transformations for a fixed $t_{2}^{0}$, using the data $\left\langle w_{i}, \xi_{i}, \eta_{i}\right\rangle$ $(i=1, \ldots n)$ to construct the corresponding $J$-inner functions. We obtain a function

S_{n}(\lambda)=T_{\Theta}(I)=I-B_{n}^{*} X_{n}^{-1}\left(\lambda I-A_{n}\right)^{-1} B_{n} \sigma_{1} \in \mathcal{R} \mathcal{S} .
$$

Using iteratively formulas (3.15), (3.16), (3.17) we obtain that

## 5. Markov moments and partial realization problem in THE CLASS $\boldsymbol{\mathcal { R S }} \boldsymbol{\mathcal { I }}$

Let $S \in \boldsymbol{\mathcal { R }} \boldsymbol{\mathcal { S }}$, and consider the Laurent expansion at infinity

in terms of a given minimal realization. The matrices $H_{i}=B^{*} \mathbb{X}^{-1} A^{i} B \sigma_{1}$ are called the Markov moments of $S$. The Partial Realization Problem (or moment problem at infinity) in $\boldsymbol{\mathcal { R }} \boldsymbol{\mathcal { S }}$ is defined as follows: Given the first $n+1$ Markov moments $H_{0}, \ldots, H_{n}$, find all functions (if any) $S \in \mathcal{R S}$ with these first $n+1$ moments. See GKL] for a general study of the partial realization problem. Similarly, one can define the Markov moments for an element $S \in \boldsymbol{\mathcal { R S }} \boldsymbol{\mathcal { I }}$. We now give necessary conditions which the moments of a function $S \in \boldsymbol{\mathcal { R S }} \boldsymbol{\mathcal { I }}$ have to satisfy. Then we consider the partial realization Problem 1.4, that is, given $n+1 \mathbb{C}^{p \times p_{-}}$ valued functions $H_{0}\left(t_{2}\right), \ldots, H_{n}\left(t_{2}\right)$, for a fixed choice of $\sigma_{1}, \sigma_{2}$, find all $S \in \boldsymbol{\mathcal { R S }} \boldsymbol{\mathcal { I }}$ with these first $n+1$ moments.

It is important to notice the following: fixing $t_{2}=t_{2}^{0}$ and solving the corresponding classical moment problem will not lead to a solution of the problem in the class $\boldsymbol{\mathcal { R S I }}$ because we cannot obtain the function $\gamma$ (and hence $\gamma_{*}$ ) from this solution.

### 5.1. Restrictions on Markov moments for functions in $\mathcal{R S I}$.

 We study the Markov moments of a function $S \in \boldsymbol{\mathcal { R } \mathcal { I }}$, which maps solutions of the input ODE (2.16) to the output ODE (2.17) using a minimal realization (4.4) of $S$. First we develop an analogue of the formula $\qquad$ for $2 D$ vessels with constant coefficients.Theorem 5.1. For fixed $\sigma_{1}, \sigma_{2}, \gamma$, a necessary condition on $\gamma_{*}$ so that there exists a vessel with the vessel parameters $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$ is

Since it happens for all points outside the spectrum of $A_{1}$ and the functions $\operatorname{det} \Phi_{*}\left(\lambda, t_{2}, t_{2}^{0}\right)$, $\operatorname{det} \Phi\left(\lambda, t_{2}, t_{2}^{0}\right)$ are entire they are equal for all $\lambda$.
Since $A_{1}$ is a constant matrix, at some stage the elements $I, A_{1}, \ldots, A_{1}^{n}$ will be linearly dependent and we obtain:

Lemma 5.2. Given $S \in \mathcal{R S} \mathcal{I}$, with Markov moments $H_{i}\left(t_{2}\right)$, $i=$ $0,1, \ldots$. Then exists $N$ and constants $\mu_{j}, j=1, \ldots, N$ such that

This condition means that the function $S\left(\lambda, t_{2}\right)$ is $\sigma_{1}\left(t_{2}\right)$ contractive, and, for example, the first moment $H_{0}\left(t_{2}\right)$ satisfies $H_{0}\left(t_{2}\right) \sigma_{1}^{-1}\left(t_{2}\right)>0$. Using the minimality property, we have

Theorem 5.3. Suppose that we are given moments $H_{i}\left(t_{2}\right)$, defined in a neighborhood of the point $t_{2}^{0} \in \mathrm{I}$. Then there exists $n_{0} \leq p^{2}$ such that each element $H_{i+1}$ is uniquely determined from $H_{0}, \ldots, H_{i}$ using the algebraic formulas (5.5), and $n_{0}$ LDEs with arbitrary initial conditions, obtained from (5.4).

Remarks: 1. This theorem is of local nature. The number " $n_{0}$ " appearing in the theorem may vary with the point $t_{2}^{0}$, but is unchanged in a small neighborhood of $t_{2}^{0}$ by continuity.
2. We emphasize that in order to generate moments one needs produce $n_{0}$ initial conditions for each moment $H_{i}$. In other words, one need $2 n_{0}$ complex numbers to determine $H_{0}, H_{1}$, etc.
3. The proof of the theorem allows to produce an algorithm to determine explicitly, up to $n_{0}$ initial conditions, the Markov moments. The arguments in the proof of the theorem are illustrated on an example in the following subsection. This example exhibits all the difficulties present in the general case.

Proof of 5.3: From formula (5.5) we obtain that the real or imaginary part of $H_{i+1}\left(t_{2}\right)$ is uniquely determined from all the previous moments. Suppose that $\Re H_{i+1}\left(t_{2}\right)$ is known (that is, $i$ is even); then using formula (5.4) in which we insert the formula for $\Re H_{i+1}\left(t_{2}\right)$ we shall obtain an algebraic equation which gives $p^{2}-n_{0}$ relations on the elements of $\Im H_{i+1}\left(t_{2}\right)$, where $n_{0}$ is the dimension of the kernel of the linear operator defined by the left handside of (5.4). Let us demonstrate it more explicitly, let us rewrite the equation (5.4) as a system of $p^{2}$ linear equations in $p^{2}$ variables $\Im H_{i+1}^{k l}, k, l=1, \ldots, p^{2}$ :

Here $\alpha_{k l}^{i j}, \beta_{k l}^{i j}, \delta_{k l}^{i j}$ are functions of $t_{2}$ derived from the vessel parameters. Using basic algebra manipulations, it is enough to find a maximally independent subset of equations in the left side of (5.7), and to obtain
a system of $p^{2}-n_{0}$ independent equations

Consequently, from (5.8) we express $p^{2}-n_{0}$ elements of $\Im H_{i+1}$ as functions of other $n_{0}$ elements of $H_{i+1}$ and of $H_{i}$. On the other hand, using the same formula (5.4) with $i+1$ plugged instead of $i$, we shall obtain $n_{0}$ differential equations for elements of $\Im H_{i+1}$, which can be considered as restrictions on $n_{0}$ unknown elements:

Notice that there are at least $n_{0}$ unknown elements between these equations, because of the appearance of $\frac{d}{d t_{2}} \Im H_{i+1}\left(t_{2}\right)$ at the functions $g_{j}$. Since we obtain algebraic (5.8) and differential (5.9) equations, they are all independent. So, if all elements of $\Im H_{i+1}$ appear at these equations we shall obtain that one can uniquely solve them up to $n_{0}$ initial conditions.
If this is not the case, some of the elements, say $p_{0} \leq n_{0}$ will not appear in the equations (5.8) and (5.9). We sum up these consideration with the following description: we have obtained that $p^{2}-p_{0}$ elements of $\Im H_{i+1}$ are determined from $p_{0}$ unknown elements of $\Im H_{i+1}$ and from $H_{i}$ via $p^{2}$ equations (5.8) and (5.9).
By induction the same will hold for $H_{i+2}$. In other words, $p^{2}-p_{0}$ elements of $H_{i+2}$ are determined from $p_{0}$ unknown elements of $H_{i+2}$ and from $H_{i+1}$ via $p^{2}$ equations (5.8) and (5.9). This means that $p_{0}$
relations are obtained for the elements of $H_{i+2}$, which are actually equations on the elements of $H_{i+1}$. This produce differential equations on $p_{0}$ unknown elements of $H_{i+1}$. Notice that the unknown elements will appear only with one differentiation, since their derivatives did not appear at the previous stage. Thus $H_{i+1}$ is uniquely determined up to $n_{0}$ initial conditions for some of its elements.
Next theorem put some light on the connection between equations, which determine the transfer function $S\left(\lambda, t_{2}\right)$ and its moments. This theorem is similar to the property of a solution of a Riccati equation [Ze, theorem 2.1]

Theorem 5.4. Suppose that $S\left(\lambda, t_{2}\right)$ is a continuous function of $t_{2}$ for each $\lambda$, meromorphic in $\lambda$ for each $t_{2}$ and satisfies $S\left(\infty, t_{2}\right)=I$. Suppose also that $S\left(\lambda, t_{2}\right)$ is an intertwining function of LDEs (2.16) and (2.17). Then if the equality

Consequently, using properties of $\gamma_{*}, \gamma$ appearing in definition 1.1 we obtain that the function $\sigma_{1}^{-1}\left(t_{2}\right) S^{-1 *}\left(-\bar{\lambda}, t_{2}\right) \sigma_{1}\left(t_{2}\right)$ satisfies the same differential equation. If these two functions are equal at $t_{2}^{0}$, from the uniqueness of solution for a differential equation with continuous coefficients, they are also equal for all $t_{2}$.

Corollary 5.5. Suppose that $S\left(\lambda, t_{2}\right)$ satisfies conditions of theorem 5.4, then the moments the equation for the moments (5.5) is excessive.

Proof: From theorem 5.4 it follows that

Theorem 5.6. Let $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$ be vessel parameters, and $\mathfrak{V}$ a finite dimensional vessel corresponding to the $m$ parameters. Then the entreis of the function $\gamma_{*}$ satisfies a polynomial differential equation of
finite order with coefficients in the differential ring $\boldsymbol{\mathcal { R }}$, generated by (the entries of) $\sigma_{1}, \sigma_{1}^{-1}, \sigma_{2}, \gamma$.

Proof: Suppose that the transfer function of the vessel $\mathfrak{V}$, defined in (2.11) is

for linear in moments functions $f_{00}, f_{01}$ with coefficients depending on $\mathcal{R}$ and $\gamma_{*}$. Similarly, differentiating this expression and using formula (5.4) for $\frac{d}{d t_{2}} H_{0}\left(t_{2}\right)$ and $\frac{d}{d t_{2}} H_{1}\left(t_{2}\right)$, we shall obtain that the second derivative is

\frac{d^{N}}{d t_{2}^{N}}\left(\sigma_{1}^{-1}\left(t_{2}\right) \gamma_{*}\left(t_{2}\right)\right)=\frac{d^{N}}{d t_{2}^{N}}\left(\sigma_{1}^{-1}\left(t_{2}\right) \gamma\left(t_{2}\right)\right)+\sum_{j=0}^{N} f_{N j}\left(H_{j}\right) \\

Suppose that that the dimension of the inner state is $n$ (i.e. $\operatorname{dim} \mathcal{H}=$ $n$ ), then we get that each of the matrices $H_{j}$ has $n^{2}$ entries and there is the total number of $n^{2}(N+1)$ entries for the moments $H_{0}, \ldots, H_{N}$. So, taking "enough" derivatives of $\gamma_{*}\left(t_{2}\right)$ (i.e., taking $K$ so that $K \operatorname{dim}(\mathcal{E})^{2}>$ $\left.n^{2}(N+1)\right)$ and eliminating all the entries of the moments, we shall obtain a finite number of polynomial differential equation for the entries of $\gamma_{*}\left(t_{2}\right)$.
Remark: From this theorem is follows that $\gamma_{*}$ satisfies an equation of the form

5.2. Sturm Liouville vessel parameters. The following example was extensively studied in [M2]. It deals with the Sturm Liouville differential equation

For $q\left(t_{2}\right)=0$ this problem is easily solved by exponents and in this case we shall call this equation trivial. In [M2] one connects solutions of the more general problem with non trivial $q\left(t_{2}\right)$ to the trivial one.

Definition 5.7. the Sturm Liouville vessel parameters are given by

From the second equation one finds that $u_{2}\left(\lambda, t_{2}\right)=-i \frac{\partial}{\partial t_{2}} u_{1}\left(\lambda, t_{2}\right)$ and plugging it back to the first equation, we shall obtain the trivial Sturm Liouville differential equation with the spectral parameter $i \lambda$ for $u_{1}\left(\lambda, t_{2}\right)$ :

The first equation (1.2) considered for $H_{0}=\left[\begin{array}{cc}H_{0}^{11} & H_{0}^{12} \\ H_{0}^{21} & H_{0}^{22}\end{array}\right]$ becomes

So, the question which arises here is whether every function $\gamma$, which solves (5.22) produces a solution of the partial realization problem 1.4. We connect the solution of the partial realization problem 1.4 to the classical one.

Assume that we are given functions $\sigma_{1}, \sigma_{2}$ and Markov moments $H_{i}\left(t_{2}\right), i=0, \ldots, n(n \geq 0)$ defined in a neighborhood of a point $t_{2}^{0} \in \mathrm{I}$, satisfying the necessary conditions (5.5) and (5.6). Assume also that the following necessary conditions are also satisfied:
(1) The classical partial realization problem for the moments $H_{i}\left(t_{2}^{0}\right)$ $i=1, \ldots, n$ has a solution, which we denote by $S \in \mathcal{R} \mathcal{S}$ with a minimal realization

S\left(\lambda, t_{2}\right)=I-B\left(t_{2}\right) \mathbb{X}\left(t_{2}\right)^{-1}\left(\lambda I-A_{0}\right)^{-1} B\left(t_{2}\right) \sigma_{1}\left(t_{2}\right)
$$

is a solution of the partial realization problem 1.4, with $\gamma_{*}\left(t_{2}\right)$ given by the equation (1.2).

Proof: Using simple calculation and the definitions of $B\left(t_{2}\right), \mathbb{X}\left(t_{2}\right)$ it follows that the function $S\left(\lambda, t_{2}\right)$ intertwines solutions of the input and output LDEs, with $\gamma_{*}$ defined as in the theorem, is equal to $I_{p}$ at $\infty$, and is continuous for each $\lambda$. Since the Lyapunov equation holds, the function $S\left(\lambda, t_{2}\right) \in \boldsymbol{\mathcal { R S I }}$. It remains to show that it has the given Markov moments. By construction the first moment of $S\left(\lambda, t_{2}\right)$ is $H_{0}\left(t_{2}\right)$. By Theorem 5.3 the second moment of $S\left(\lambda, t_{2}\right)$ satisfies (5.4) with $i=0$, and differential equations with $n_{0}$ initial conditions. But these initial conditions are obtained from the realization $S\left(\lambda, t_{2}^{0}\right)$. This way we obtain the first moment of $S\left(\lambda, t_{2}\right)$. The other moments are obtained by iteration.

Remarks: 1. If there is a linear combination $H\left(t_{2}\right)=\sum_{i=0}^{n-1} \alpha_{i} H_{i}\left(t_{2}\right)$ which has its spectrum disjoint from $-H\left(t_{2}\right)$ then $\gamma$ is uniquely determined from

& =-\frac{d}{d t_{2}} \sum_{i=0}^{n-1} \alpha_{i} H_{i}-\sigma_{1}\left[H_{0}, \sigma_{1}^{-1} \sigma_{2}\right] \sum_{i=0}^{n-1} \alpha_{i} H_{i}-\left[\sum_{i=0}^{n-1} \alpha_{i} H_{i+1}, \sigma_{1}^{-1} \sigma_{2}\right]
\end{aligned}
$$

2. Case $\sigma_{1}\left(t_{2}\right)>0$ : The equation (5.22) is then uniquely solvable for $\gamma$ if the spectrum because the first Markov moment $H_{0}\left(t_{2}\right)$ is self adjoint and strictly positive, and thus the spectra of $H_{0}$ and $-H_{0}$ are disjoint.

## 6. Nevanlinna-Pick interpolation problem

Nevanlinna-Pick (NP) interpolation problem 1.6 is similar to non commutative, Riemann surface cases and involves specifying the exact class of input-output mappings, and a finite number of inputs that are to be mapped to the corresponding outputs. In our case this yields fixing
both $\mathbf{U}\left(\lambda, \frac{\partial}{\partial t_{2}} ; t_{2}\right)$ and $\mathbf{U}_{*}\left(\lambda, \frac{\partial}{\partial t_{2}} ; t_{2}\right)$, a set of values $w_{i}, i=1, \ldots, N$ for the spectral parameter, and corresponding solutions $\xi_{i}\left(t_{2}\right)$ and $\eta_{i}\left(t_{2}\right)$ of the input and the output LDEs, respectively, as it is defined in the problem 1.6.
Since everything is determined by the initial conditions, this reduces to the NP problem at some fixed $t_{2}^{0} \in \mathrm{I}$, except that now $\gamma_{*}$ is fixed, yielding a constraint on the solution parameter $S_{0}$. According to remark, following the theorem 5.6 $\gamma_{*}$ satisfies an equation of the form

$$
P\left(x, x^{\prime}, x^{\prime \prime}, \ldots, x^{(K)}\right)=0
$$

for a non-commutative polynomial with coefficients in $\boldsymbol{\mathcal { R }}$. Since the derivatives of $\gamma_{*}$ may be represented using the moments $H_{i}\left(t_{2}\right)$ differentiating the linkage condition (2.8) and using (5.4), we shall obtain that the moments have to satisfy an equation of the form

$$
P^{\prime}\left(H_{0}, H_{1}, \ldots, H_{n}\right)=0
$$

for a non-commutative polynomial $P^{\prime}$ with coefficients in $\boldsymbol{\mathcal { R }}$. On the other hand, they must be linearly dependent, which is a necessary condition and the formula (5.1) must hold. Consequently, there must be a minimal (with respect to the index $N$ - the biggest moment appearing) linear combination

$$
\sum_{i=1}^{N} \mu_{i} H_{i}\left(t_{2}\right)
$$

of the moments such that it divides from the left and from the right the polynomial $P^{\prime}\left(H_{0}, H_{1}, \ldots, H_{n}\right)$. In this way we shall be obtain the coefficients $\mu_{i}$, which are also coefficients of the minimal polynomial for the final operator $A_{1}$.
Next we shall look for functions $S_{0} \in \mathcal{R} \mathcal{S}$, which has $A_{1}$ with the prescribed minimal polynomial. Notice that this also means that the Jordan block structure of the class of $A_{1}$ is defined in this manner. It is remained to choose values for $B_{0}, \mathbb{X}_{0}$ so that the system of equations (5.10) will be satisfied at the point $t_{2}^{0}$. This follows from the fact that $\gamma_{*, 0}$ corresponding to the function $S_{0}$ will have the same initial values as the given $\gamma_{*}$ and, moreover, there will be obtained the same differential equations for the $\gamma_{*}$ and $\gamma_{*, 0}$. We now present the exact statement

Theorem 6.1. Suppose that there is a realization of $S_{0} \in \mathcal{R} \mathcal{S}$

$$
S_{0}\left(\lambda, t_{2}\right)=I-B_{0}^{*} \mathbb{X}^{-1}\left(\lambda I-A_{1}\right)^{-1} B_{0} \sigma_{1}\left(t_{2}^{0}\right),
$$

then $S_{0}$ is a solution of the Nevanlinna-Pick interpolation problem 1.6. if the minimal polynomial of $A_{1}$ is equal to the minimal polynomial
defined from $\gamma_{*}$ and if the moments $H_{i}$ of the functions $S_{0}$ satisfy the system of equations (5.10) at $t_{2}^{0}$.

Proof: We construct first a polynomial $P\left(x, x^{\prime}, x^{\prime \prime}, \ldots, x^{(K)}\right)$ from $\gamma_{*}$ as it is explained in the text preceding the theorem. Then we find a minimal polynomial for $A_{1}$, obtained from $P^{\prime}\left(H_{0}, H_{1}, \ldots, H_{n}\right)$ by substituting $H_{i}$ with $x^{i}$. Then the moments of the function $S_{0}\left(\lambda, t_{2}\right) \mathcal{R S I}$ constructed from $S_{0} \in \mathcal{R} \mathcal{S}$ will satisfy the same differential equations appearing in theorem (5.10). As a result the output $\gamma_{*, 0}$ of the function $S_{0}\left(\lambda, t_{2}\right)$ will satisfy the same polynomial differential equation as the given $\gamma_{*}$ and will have the same initial conditions, which means that $\gamma_{*, 0}=\gamma_{*}$, which finishes the proof.
We now solve Problem 1.7.
Theorem 6.2. Given $\mathbb{C}^{p \times p}$-valued functions $\sigma_{1}, \sigma_{2}, \gamma$, an interval I and $N$ quadruples $<t_{2}^{j}, w_{j}, \xi_{j}, \eta_{j}>$ where $t_{2}^{j} \in \mathrm{I}$, $w_{j} \in \mathbb{C}_{+}, \xi_{j}, \eta_{j} \in \mathbb{C}^{1 \times p}$ $j=1, \ldots N$, and assume that the corresponding matrices $\widetilde{\mathbb{X}}_{i}>0$. Then there exists a solution of the Nevanlinna-Pick problem 1.7, i.e. there exists a function $S \in \mathcal{R} \mathcal{S} \mathcal{I}$ satisfying $S\left(w_{i}, t_{2}^{i}\right) \xi_{i}=\eta_{i}$ if and only if there exists $n \in \mathbb{N}$, matrices $A_{0}^{i}, \mathbb{X}_{0}^{i}, \in \mathbb{C}^{(n-1) \times(n-1)}$ with $\mathbb{X}_{0}^{i}>0$, $B_{0}^{i} \in \mathbb{C}^{p \times(n-1)}, V_{i j} \in \mathbb{C}^{n \times n}$ such that for $A_{i}, B_{i}, \mathbb{X}_{i}$ defined by

(2) $\oint\left(\lambda I-A_{i}\right)^{-1} B_{i} \sigma_{1}^{-1}\left(t_{2}^{j}\right) \Phi^{-1}\left(\lambda, t_{2}^{j}, t_{2}^{i}\right) d \lambda=V_{i j} B_{j}$.
and the matrix $X\left(t_{2}\right)$,

\mathbb{X}\left(t_{2}\right)=\mathbb{X}_{i}+\int_{t_{2}^{i}}^{t_{2}} B_{i}(y) \sigma_{2}(y)\left(B_{i}(y)\right)^{*} d y
$$

is invertible on the interval I.
Proof: For each $t_{2}^{i}$ all the functions which satisfy $S\left(w_{i}, t_{2}^{i}\right) \xi_{i}=\eta_{i}$ are of the form $T_{\Theta_{i}}\left(S_{0}^{i}\left(\lambda, t_{2}\right)\right)$, provided $\widetilde{\mathbb{X}}_{i}=\frac{\xi_{i} \sigma_{1}\left(t_{2}^{i}\right) \xi_{i}^{*}-\eta_{i} \sigma_{1}\left(t_{2}^{i}\right) \eta_{i}^{*}}{w_{i}^{*}+w_{i}}>0$.

Here

and $S_{0}^{i} \in \boldsymbol{\mathcal { R }}$. Given a minimal realization

$$
S_{0}^{i}(\lambda)=I-\left(B_{0}^{i}\right)^{*}\left(\mathbb{X}_{0}^{i}\right)^{-1}\left(\lambda I-A_{0}^{i}\right)^{-1} B_{0}^{i} \sigma_{1}\left(t_{2}^{i}\right)
$$

of $S_{0}^{i}$, we shall obtain from formulas (3.15), (3.16), (3.17) the formulas (6.1), (6.2), (6.3) in the theorem. In view of Theorem 4.7, a necessary and sufficient condition to obtain the same function $S\left(\lambda, t_{2}\right)$ for every $i$ is that there exist invertible constant matrices $V_{i j}$ such that the operators $A_{i}$ are similar. In other words there must exist $V_{i j}$ such that $A_{i}=V_{i j} A_{j} V_{i j}^{-1}$. Moreover, the second part of theorem 4.7 tells that additionally the equality

$$
\oint\left(\lambda I-A_{i}\right)^{-1} B_{i} \sigma_{1}^{-1}\left(t_{2}^{j}\right) \Phi^{-1}\left(\lambda, t_{2}^{j}, t_{2}^{i}\right) d \lambda=V_{i j} B_{j}
$$

must hold.

# ON THE CLASS $\mathcal{S I}$ OF $J$-CONTRACTIVE FUNCTIONS INTERTWINING SOLUTIONS OF LINEAR DIFFERENTIAL EQUATIONS

#### Abstract

In the PhD thesis of the second author under the supervision of the third author was defined the class $\boldsymbol{\mathcal { S I }}$ of $J$ contractive functions, depending on a parameter and arising as transfer functions of overdetermined conservative $2 D$ systems invariant in one direction. In this paper we extend and solve in the class $\mathcal{S} \mathcal{I}$, a number of problems originally set for the class $\mathcal{S}$ of functions contractive in the open right-half plane, and unitary on the imaginary line with respect to some preassigned signature matrix $J$. The problems we consider include the Schur algorithm, the partial realization problem and the Nevanlinna-Pick interpolation problem. The arguments rely on a correspondence between elements in a given subclass of $\boldsymbol{\mathcal { S }}$ and elements in $\mathcal{S}$. Another important tool in the arguments is a new result pertaining to the classical tangential Schur algorithm.

## 1. Introduction

Functions $S(\lambda)$, which are $\mathbb{C}^{p \times p}$-valued, analytic and contractive in the open right half plane $\mathbb{C}_{+}$, or equivalently, such that the kernel

$$
K(\lambda, w)=\frac{I_{p}-S(w)^{*} S(\lambda)}{\lambda+w^{*}}
$$

is positive ${ }^{1}$ in $\mathbb{C}_{+}$, play an important role in system theory, inverse scattering theory, network theory and related topics; see for instance $[\mathrm{L}],[\mathrm{BC}],[\mathrm{DD}],[\mathrm{He},[\mathrm{A}]$. Here, positivity of the kernel means that for every $n \in \mathbb{N}$ and every choice of points $w_{1}, \ldots, w_{n} \in \mathbb{C}_{+}$and vectors $\xi_{1}, \ldots, \xi_{n} \in \mathbb{C}^{1 \times p}$ the $n \times n$ Hermitian matrix

$$
\left.\left[\xi_{i} K\left(w_{i}, w_{j}\right) \xi_{j}^{*}\right)\right]_{i, j=1, \ldots n}
$$

is positive (that is, has all its eigenvalues greater or equal to 0 ).
Far reaching generalizations of this class were introduced in M, MV1, MVc , in the study of $2 D$-linear systems (say, with respect to the variables $\left.\left(t_{1}, t_{2}\right)\right)$, invariant with respect to the variable $t_{1}$. To introduce the classes defined in these papers we first need a definition.

Definition 1.1. Let $\sigma_{1}, \sigma_{2}, \gamma$ and $\gamma_{*}$ be $\mathbb{C}^{p \times p}$-valued functions, continuous on an interval $\mathrm{I}=[a, b]$. Suppose moreover that $\sigma_{1}$ and $\sigma_{2}$ take self-adjoint values, and that $\sigma_{1}$ is differentiable and invertible on I , and that the following relations hold:

$$
\gamma\left(t_{2}\right)+\gamma\left(t_{2}\right)^{*}=\gamma_{*}\left(t_{2}\right)+\gamma_{*}\left(t_{2}\right)^{*}=-\frac{d}{d t_{2}} \sigma_{1}\left(t_{2}\right), \quad t_{2} \in \mathrm{I}
$$

[^2]Then $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$ and the interval I are called vessel parameters.
The class of functions $\mathcal{S} \mathcal{I}$ corresponding to thr vessel parameters $\sigma_{1}$, $\sigma_{2}, \gamma, \gamma_{*}$ and the interval I was introduced in [M, MVc] (see Definition 2.7 below) and consists of the functions $S\left(\lambda, t_{2}\right)$ of two variables $\lambda, t_{2}$ such that for every $t_{2} \in \mathrm{I}$ the function $S\left(\lambda, t_{2}\right)$ is meromorphic in $\mathbb{C}_{+}$ and the kernel

$$
\begin{equation*}
\frac{\sigma_{1}\left(t_{2}\right)-S\left(w, t_{2}\right)^{*} \sigma_{1}\left(t_{2}\right) S\left(\lambda, t_{2}\right)}{\lambda+w^{*}} \tag{1.1}
\end{equation*}
$$

is positive for $\lambda$ and $\omega$ in the domain of analyticity of $S\left(\lambda, t_{2}\right)$ in $\mathbb{C}_{+}$. For positive $\sigma_{1}\left(t_{2}\right)$, the positivity of the kernel implies that $S$ is analytic in $\mathbb{C}_{+}$; see [D0], A]. For general (invertible) $\sigma_{1}\left(t_{2}\right)$, the entries of $S$ are of bounded type and $S$ has at most poles in $\mathbb{C}_{+}$; see ADRS. It is also required that $S\left(\lambda, t_{2}\right)$ is analytic at infinity for each $t_{2}$, with value $I_{p}$ there, and that $S\left(\lambda, t_{2}\right)$ maps solutions of the input Linear Differential Equation (LDE) with the spectral parameter $\lambda$

$$

It is proved in $\bar{M}, ~ M V c$ that elements of $\mathcal{S I}$ are the transfer functions of $t_{1}$-invariant conservative $2 D$ systems; see Section 2.

The purpose of this paper is to study various questions in the class $\mathcal{S I}$ such as Nevanlinna-Pick interpolation, property of moments, etc. A key result is the following theorem, which we prove in the sequel; see Section 4.
Theorem 4.1 Let us fix the parameters $\sigma_{1}, \sigma_{2}$, and $\gamma$, and the interval I. Then for every $t_{2}^{0} \in \mathrm{I}$ there is a one-to-one correspondence between pairs $\left(\gamma_{*}, S\right)$ such that $S \in \mathcal{S I}$ and $\gamma_{*}$ continuous in a neighborhood of $t_{2}^{0}$, and functions $Y(\lambda)$, meromorphic in $\mathbb{C}_{+}$, and with the following properties
(1) $Y(\infty)=I_{p}$,
(2) $Y(\lambda)^{*} \sigma_{1}\left(t_{2}^{0}\right) Y(\lambda) \leq \sigma_{1}\left(t_{2}^{0}\right)$ for $\lambda \in \mathbb{C}_{+}$where $Y$ is analytic, and
(3) $Y(\lambda)^{*} \sigma_{1}\left(t_{2}^{0}\right) Y(\lambda)=\sigma_{1}\left(t_{2}^{0}\right)$ for almost $\lambda$ satisfying $\Re \lambda=0$ and where $Y(\lambda)$ is the non-tangential limit.
As mentioned above the $\sigma_{1}\left(t_{2}\right)$-contractivity of $Y$ implies that $Y$ is of bounded type in $\mathbb{C}_{+}$, and thus the asserted non-tangential limits exist almost everywhere.

Definition 1.2. The class of functions $Y$ with the properties in Theorem 4.1 will be will be denoted by $\boldsymbol{\mathcal { S }}\left(t_{2}^{0}\right)$ and the functions will be called $\sigma_{1}\left(t_{2}^{0}\right)$-inner. The subclass of rational functions of $\boldsymbol{\mathcal { S }}\left(t_{2}^{0}\right)$ will be denoted by $\boldsymbol{\mathcal { R } \mathcal { S }}\left(t_{2}^{0}\right)$.

For the sequel, it is important to notice that the general tangential Schur algorithm developped in AD can be applied to functions in $\boldsymbol{\mathcal { S }}\left(t_{2}^{0}\right)$, and in particular in $\boldsymbol{\mathcal { R }} \boldsymbol{\mathcal { S }}\left(t_{2}^{0}\right)$.

Definition 1.3. $\mathcal{R S I}$ will denote the subclass of functions in $\mathcal{S I}$ which are rational in $\lambda$ for every $t_{2} \in \mathrm{I}$.

The paper consists of six sections besides the introduction, and we now describe their content. In Section 2 we review the main results from [M] (see details in [MV1] and MVc]) on $t_{1}$-invariant conservative $2 D$-systems, relevant to the present work. In particular the class $\mathcal{S} \boldsymbol{\mathcal { I }}$ mentioned above consists of the transfer functions of these systems. In Section 3 we present the reproducing kernel space approach to the tangential Schur algorithm for the class $\mathcal{S}$, as developed in AD]. We obtain in particular new formulas which allow us to find the main operator in a realization of an element of $\mathcal{S}$ after one iteration of the tangential Schur algorithm; see formulas (3.15), (3.17), (3.16) in Theorem 3.5. In Section 4 we develop the tangential Schur algorithm for a function $S\left(\lambda, t_{2}\right) \in \mathcal{S I}$. Applying directly the theory of the previous section to $S\left(\lambda, t_{2}\right)$ leads to a new function which need not belong to $\boldsymbol{\mathcal { S I }}$. Instead, we apply the Schur algorithm to the $\sigma_{1}\left(t_{2}^{0}\right)$-inner function $S\left(\lambda, t_{2}^{0}\right)$ for some preassigned $t_{2}^{0} \in \mathrm{I}$, and obtain a simpler (in terms of McMillan degree) $\sigma_{1}\left(t_{2}^{0}\right)$-inner function $S_{0}\left(\lambda, t_{2}^{0}\right)$. We use Theorem 4.1 to obtain an element in a class $\mathcal{S} \mathcal{I}$ from $S_{0}\left(\lambda, t_{2}^{0}\right)$. We call this procedure the tangential Schur algorithm for the class $\mathcal{S I}$. We study in Section 5 the coefficients (called the Markov moments) $H_{i}\left(t_{2}\right)$ of the expansion of $S\left(\lambda, t_{2}\right)$ around $\lambda=\infty$

It turns out that the first Markov moment $H_{0}\left(t_{2}\right)$ satisfies the Lyapunov equation

which means that given the functions $\sigma_{1}, \sigma_{2}, \gamma$ and $H_{0}$ on I, one can uniquely reconstruct $\gamma_{*}$, and, as a result of Theorem 4.1, there will
exists a unique function $S\left(\lambda, t_{2}\right)\left(t_{2} \in \mathrm{I}\right)$ with the given Markov parameters. We prove the following theorem 5.5 on the structure of Markov moments:
Theorem Suppose that we are given moments $H_{i}\left(t_{2}\right)$, defined in a neighborhood of the point $t_{2}^{0} \in \mathrm{I}$. Then there exists $n_{0} \leq p^{2}$ such that each element $H_{i+1}$ is uniquely determined from $H_{0}, \ldots, H_{i}$ using the algebraic formulas (5.5), and $n_{0}$ LDEs with arbitrary initial conditions, obtained from (5.4). Moreover, $n_{0}$ equations must be satisfied by the elements of $\gamma_{*}\left(t_{2}\right)$.
Starting from the Markov coefficients at infinity, constructed under conditions of Theorem 5.5 we recover in Section 6 the transfer function $S\left(\lambda, t_{2}\right)$. In the arguments we make use of a Krein-space realization theorem of Dijksma-Langer-de Snoo for analytic functions at infinity [DLdeS, Theorem 3]. By a counterexample, we show that it is not always possible to reconstruct the function using Hilbert space realizations.
In Section 7 we study two generalizations of Nevanlinna Pick interpolation problem in the class $\boldsymbol{\mathcal { S I }}$. Let us recall that in the classical Nevanlinna Pick interpolation problem [N, P] Schur analysis plays a special role; see for instance [FK, Dy, [A]. Schur analysis gives a parametrization of all solutions (when they exist) for the given data. The first problem 1.4 is similar to the non commutative and Riemann surface cases and involves specifying the exact class of input-output mappings, and a finite number of inputs that are to be mapped to the corresponding outputs. In our case this yields fixing vessels parameters and a set of values $w_{i}, i=1, \ldots, N$ and corresponding solutions $\xi_{i}\left(t_{2}\right)$ and $\eta_{i}\left(t_{2}\right)$ of the input and the output LDEs, respectively:

Problem 1.4 (Nevanlinna-Pick interpolation). Let $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$ be vessel parameters and let I be an interval. Let $N \in \mathbb{N}$ and $w_{i}, i=1, \ldots, N$ be complex numbers. Suppose also that $N$ input functions $\xi_{i}\left(t_{2}\right)$ satisfying (2.16) with corresponding spectral parameters $w_{i}$ 's, and $N$ output functions $\eta_{i}\left(t_{2}\right)$ satisfying (2.17) with the given $w_{i}$ 's.
(1) Give sufficient and necessary conditions, so that there exists $S\left(\lambda, t_{2}\right) \in \mathcal{S} \mathcal{I}$ such that $S\left(w_{j}, t_{2}\right) \xi_{i}\left(t_{2}\right)=\eta_{i}\left(t_{2}\right), j=1, \ldots, N$, on a sub-interval of I.
(2) Describe the set of all solutions for this problem.

The second problem uses the fact that we can also specify the data for different values of $t_{2}$ and is more similar to the classical one:

Problem 1.5. Given $\mathbb{C}^{p \times p}$-valued functions $\sigma_{1}, \sigma_{2}, \gamma$ defined on I , and given $N$ quadruples $<t_{2}^{j}, w_{j}, \xi_{j}, \eta_{j}>$, where $t_{2}^{j} \in I, w_{j} \in \mathbb{C}_{+}, \xi_{j}, \eta_{j} \in$ $\mathbb{C}^{1 \times p} j=1, \ldots N$, then:
(1) Give sufficient and necessary conditions, so that there exists $\gamma_{*}$ and $S\left(\lambda, t_{2}\right) \in \mathcal{S I}$ such that $S\left(w_{j}, t_{2}^{j}\right) \xi_{j}=\eta_{j}, j=1, \ldots, N$, on a sub-interval of I containing all the $t_{2}^{j}$.
(2) Describe the set of all solutions for this problem.

If all the values $t_{2}^{j}=t_{2}^{0}$ are equal, we have to find a function $S\left(\lambda, t_{2}^{0}\right)$ satisfying $S\left(w_{j}, t_{2}^{0}\right) \xi_{j}=\eta_{j}$. Thus, the above problem is a generalization of the classical Nevanlinna-Pick interpolation problem. We also remark that we do not address the question of describing the set of all solutions. Remarks: Some of the results presented here have been announced in AMV.

## 2. $t_{1}$ INVARIANT CONSERVATIVE $2 D$ SYSTEMS.

The material in this section is taken from [M, MV1, MVc], where proofs and more details can be found. The origin of this theory can be found in the paper [Li].
2.1. Definition. An overdetermined conservative $t_{1}$-invariant $2 D$ system is a linear input-state-output ( $\mathrm{i} / \mathrm{s} / \mathrm{o}$ ) system, which consists of operators depending only on the variable $t_{2}$ and is of the following form:

where the variable $t_{1}$ belongs to $\mathbb{R}$, and the variable $t_{2}$ belongs to some interval I. Furthermore, the input $u\left(t_{1}, t_{2}\right)$ and the output $y\left(t_{1}, t_{2}\right)$ take values in some Hilbert space $\mathcal{E}$ and the state $x\left(t_{1}, t_{2}\right)$ takes values in the Hilbert space $\mathcal{H}_{t_{2}}$. We assume that $u\left(t_{1}, t_{2}\right)$ and $y\left(t_{1}, t_{2}\right)$ are continuous functions of each variable when the other variable is fixed. The operators of the system are supposed to satisfy the following:

## Assumptions 2.1.

(1) $A_{1}\left(t_{2}\right): \mathcal{H}_{t_{2}} \rightarrow \mathcal{H}_{t_{2}}$, and $\widetilde{B}\left(t_{2}\right): \mathcal{E} \rightarrow \mathcal{H}_{t_{2}}$ are bounded operators for all $t_{2}$,
(2) The functions $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}: \mathcal{E} \rightarrow \mathcal{E}$, are continuous in the operator norm topology.
(3) $\sigma_{1}\left(t_{2}\right)$ is an invertible operator for every $t_{2} \in \mathrm{I}$.
(4) $F(t, s)$ is an evolution continuous semi-group.

For continuous inputs $u\left(t_{1}, t_{2}\right)$, the inner state is continuously differentiable. Requiring now the invariance of the system transition from $\left(t_{1}^{0}, t_{2}^{0}\right)$ to $\left(t_{1}, t_{2}\right)$ via the points $\left(t_{1}^{0}, t_{2}\right)$ and $\left(t_{1}, t_{2}^{0}\right)$ respectively, is equivalent to the equality of second order partial derivatives of $x\left(t_{1}, t_{2}\right)$ :

\frac{\partial}{\partial t_{1}} x\left(t_{1}, t_{2}\right)=A_{1}\left(t_{2}\right) x\left(t_{1}, t_{2}\right)+\widetilde{B}\left(t_{2}\right) \sigma_{1}\left(t_{2}\right) u\left(t_{1}, t_{2}\right) \\
x\left(t_{1}, t_{2}\right)=F\left(t_{2}, t_{2}^{0}\right) x\left(t_{1}, t_{2}^{0}\right)+\int_{t_{2}^{0}}^{t_{2}} F\left(t_{2}, s\right) \widetilde{B}(s) \sigma_{2}(s) u\left(t_{1}, s\right) d s \\
y\left(t_{1}, t_{2}\right)=u\left(t_{1}, t_{2}\right)-\widetilde{B}\left(t_{2}\right)^{*} x\left(t_{1}, t_{2}\right) .
\end{array}\right.
$$

with inputs and outputs satisfying the compatibility conditions (2.5) and (2.6), i.e. satisfy:

\mathbf{U}\left(\frac{\partial}{\partial t_{1}}, \frac{\partial}{\partial t_{2}} ; t_{2}\right) u\left(t_{1}, t_{2}\right)=0, \quad \mathbf{U}_{*}\left(\frac{\partial}{\partial t_{1}}, \frac{\partial}{\partial t_{2}} ; t_{2}\right) y\left(t_{1}, t_{2}\right)=0
$$

The theory of such vessels, developed in [M, MV1] enables to find a more convenient form of the vessel. Denoting $\mathcal{H}=\mathcal{H}_{t_{2}^{0}}, A_{1}=A_{1}\left(t_{2}^{0}\right)$, $F^{*}\left(t_{2}, t_{2}^{0}\right) F\left(t_{2}, t_{2}^{0}\right)=\mathbb{X}^{-1}\left(t_{2}\right)$ and $B\left(t_{2}\right)=F\left(t_{2}^{0}, t_{2}\right) \widetilde{B}\left(t_{2}\right)$, we shall obtain the following notion, first introduced in [M2].
Definition 2.3. A (differential) conservative vessel associated to the vessel parameters is a collection of operators and spaces

\mathfrak{V}=\left(A_{1}, B\left(t_{2}\right), \mathbb{X}\left(t_{2}\right) ; \sigma_{1}\left(t_{2}\right), \sigma_{2}\left(t_{2}\right), \gamma\left(t_{2}\right), \gamma_{*}\left(t_{2}\right) ; \mathcal{H}, \mathcal{E}\right) \tag{2.11}
\end{equation*}
$$

where the operators satisfy the following vessel conditions:

0=\frac{d}{d t_{2}}\left(B\left(t_{2}\right) \sigma_{1}\left(t_{2}\right)\right)+A_{1} B\left(t_{2}\right) \sigma_{2}\left(t_{2}\right)+B\left(t_{2}\right) \gamma\left(t_{2}\right), \\
A_{1} \mathbb{X}\left(t_{2}\right)+\mathbb{X}\left(t_{2}\right) A_{1}^{*}=B\left(t_{2}\right) \sigma_{1}\left(t_{2}\right) B\left(t_{2}\right)^{*}, \\
\frac{d}{d t_{2}} \mathbb{X}\left(t_{2}\right)=B\left(t_{2}\right) \sigma_{2}\left(t_{2}\right) B\left(t_{2}\right)^{*}, \\
\gamma_{*}\left(t_{2}\right)=\gamma\left(t_{2}\right)+\sigma_{2}\left(t_{2}\right) B\left(t_{2}\right)^{*} \mathbb{X}^{-1}\left(t_{2}\right) B\left(t_{2}\right) \sigma_{1}\left(t_{2}\right)-  \tag{2.15}\\
-\sigma_{1}\left(t_{2}\right) B\left(t_{2}\right)^{*} \mathbb{X}^{-1}\left(t_{2}\right) B\left(t_{2}\right) \sigma_{2}\left(t_{2}\right)
\end{array}

It turns out that Lyapunov equation (2.13) is partially redundant.
Lemma 2.4. Suppose that $B\left(t_{2}\right)$ satisfies (2.12) and $\mathbb{X}\left(t_{2}\right)$ satisfies (2.14), then if the Lyapunov equation (2.13)

A_{1} \mathbb{X}\left(t_{2}\right)+\mathbb{X}\left(t_{2}\right) A_{1}^{*}+B\left(t_{2}\right) \sigma_{1}\left(t_{2}\right) B\left(t_{2}\right)^{*}=0

holds for a fixed $t_{2}^{0}$, then it holds for all $t_{2}$. If $\mathbb{X}\left(t_{2}^{0}\right)=\mathbb{X}^{*}\left(t_{2}^{0}\right)$, then $\mathbb{X}\left(t_{2}\right)=\mathbb{X}\left(t_{2}\right)^{*}$ for all $t_{2}$.
Proof: By differentiating the left hand side of (2.13), we will obtain that it is zero. The derivative of $\mathbb{X}\left(t_{2}\right)$ is selfadjoint.
This representation of a vessel is the most convenient when one focuses on the notion of transfer function, as we do in the next subsection.
2.2. Transfer function. Performing a separation of variables as follows

we arrive at the notion of a transfer function. Note that $u\left(t_{1}, t_{2}\right)$ and $y\left(t_{1}, t_{2}\right)$ satisfy PDEs, but $u_{\lambda}\left(t_{2}\right)$ and $y_{\lambda}\left(t_{2}\right)$ are solutions of LDEs with spectral parameter $\lambda$,

The corresponding $\mathrm{i} / \mathrm{s} / \mathrm{o}$ system becomes

y_{\lambda}\left(t_{2}\right)=u_{\lambda}\left(t_{2}\right)-\widetilde{B}\left(t_{2}\right)^{*} x_{\lambda}\left(t_{2}\right)
\end{array}\right.

The output $y_{\lambda}\left(t_{2}\right)=u_{\lambda}\left(t_{2}\right)-\widetilde{B}\left(t_{2}\right)^{*} x_{\lambda}\left(t_{2}\right)$ may be found from the first i/s/o equation:

& =I-\widetilde{B}\left(t_{2}\right)^{*} F\left(t_{2}, t_{2}^{0}\right)\left(\lambda I-A_{1}\left(t_{2}^{0}\right)\right)^{-1} F\left(t_{2}^{0}, t_{2}\right) \widetilde{B}\left(t_{2}\right) \sigma_{1}\left(t_{2}\right) \\
& =I-\widetilde{B}\left(t_{2}\right)^{*} F^{*}\left(t_{2}^{0}, t_{2}\right) F^{*}\left(t_{2}, t_{2}^{0}\right) F\left(t_{2}, t_{2}^{0}\right)\left(\lambda I-A_{1}\right)^{-1} B\left(t_{2}\right) \sigma_{1}\left(t_{2}\right) \\
& =I-B\left(t_{2}\right)^{*} \mathbb{X}^{-1}\left(t_{2}\right)\left(\lambda I-A_{1}\right)^{-1} B\left(t_{2}\right) \sigma_{1}\left(t_{2}\right)
\end{aligned}
$$

and we obtain that

S\left(\lambda, t_{2}\right)=I-B\left(t_{2}\right)^{*} \mathbb{X}^{-1}\left(t_{2}\right)\left(\lambda I-A_{1}\right)^{-1} B\left(t_{2}\right) \sigma_{1}\left(t_{2}\right) \tag{2.18}
\end{equation*}
$$

Proposition 2.5. The transfer function $S\left(\lambda, t_{2}\right)$ defined by (2.18) has the following properties:
(1) For all $t_{2}, S\left(\lambda, t_{2}\right)$ is an analytic function of $\lambda$ in the neighborhood of $\infty$, where it satisfies:

(2) For all $\lambda, S\left(\lambda, t_{2}\right)$ is a continuous function of $t_{2}$.
(3) For $\lambda$ in the domain of analyticity of $S\left(\lambda, t_{2}\right)$ :

(4) Maps solutions of the input LDE (2.16) with spectral parameter $\lambda$ to the output LDE (2.17) with the same spectral parameter.

Proof: These properties are easily checked, and follow from the definition of $S\left(\lambda, t_{2}\right)$ :

The function $S\left(\lambda, t_{2}\right)$ is analytic for $\lambda>\left\|A_{1}\left(t_{2}\right)\right\|$ and since all the operators are bounded, we have $S\left(\infty, t_{2}\right)=I_{p}$. The second property follows from the regularity assumptions 2.1. The third property follows from straightforward calculations:

\end{aligned}
$$

Here the sign of $-\Re(\lambda)$ determines the sign of $S\left(\lambda, t_{2}\right)^{*} \sigma_{1}\left(t_{2}\right) S\left(\lambda, t_{2}\right)$ $\sigma_{1}\left(t_{2}\right)$ and thus the third property is obtained. The fourth property follows directly from our construction.

Remark: When $\operatorname{dim} \mathcal{H}<\infty$, we obtain that $S\left(\lambda, t_{2}\right)$ is a rational function of $\lambda$ for every $t_{2}$.

It is an interesting fact that also the converse of Proposition 2.5 holds; see [M], MVc, chapter 5].

Theorem 2.6. For any function of two variables $S\left(\lambda, t_{2}\right)$, satisfying the conditions of Proposition 2.5, there is a conservative $t_{1}$-invariant vessel whose transfer function is $S\left(\lambda, t_{2}\right)$.

We define the class of transfer functions mentioned in the introduction as follows:
Definition 2.7 ([MVC]). The class $\mathcal{S} \boldsymbol{\mathcal { I }}=\boldsymbol{\mathcal { S } \mathcal { I }}\left(\mathbf{U}\left(\lambda, \frac{\partial}{\partial t_{2}} ; t_{2}\right), \mathbf{U}_{*}\left(\lambda, \frac{\partial}{\partial t_{2}} ; t_{2}\right)\right)$ consists of functions $S\left(\lambda, t_{2}\right)$ of two variables, which
(1) are analytic in a neighborhood of $\lambda=\infty$ for all $t_{2}$ and where it holds $S\left(\infty, t_{2}\right)=I_{p}$,
(2) are continuous as functions of $t_{2}$ for all $\lambda$,
(3) satisfy (2.19) and (2.20) in the domain of analyticity of $S$,
(4) map solutions of the input $L D E$ (2.16) with spectral parameter $\lambda$ to the output LDE (2.17) with the same spectral parameter

Recall (see CoLe]) that to every LDE can be associated an invertible matrix (or operator) function $\Phi\left(t_{2}, t_{2}^{0}\right)$, called the fundamental solution, which takes value $I$ at some preassigned value $t_{2}^{0}$ and such that any other solution $u\left(t_{2}\right)$ of the LDE, with initial condition $u\left(t_{2}^{0}\right)=u_{0}$ is of the form

Let $\Phi\left(\lambda, t_{2}, t_{2}^{0}\right)$ and $\Phi_{*}\left(\lambda, t_{2}, t_{2}^{0}\right)$ be the fundamental solutions of the input LDE (2.16) and the output LDE (2.17) respectively, where we have added in the notation the dependence in $\lambda$. Then,

and consequently $S\left(\lambda, t_{2}\right)$ satisfies the following LDE

\frac{\partial}{\partial t_{2}} S\left(\lambda, t_{2}\right)=\sigma_{1}^{-1}\left(t_{2}\right)\left(\sigma_{2}\left(t_{2}\right) \lambda+\gamma_{*}\left(t_{2}\right)\right) S\left(\lambda, t_{2}\right)-  \tag{2.22}\\
-S\left(\lambda, t_{2}\right) \sigma_{1}^{-1}\left(t_{2}\right)\left(\sigma_{2}\left(t_{2}\right) \lambda+\gamma\left(t_{2}\right)\right) .
\end{gather*}
$$

The symmetry conditions (2.19) and (2.20), which are a result of Lyapunov equation (3.8) gives us

## 3. Schur analysis for the classical case

One of the approaches to the tangential Schur algorithm for a rational matrix function $S(\lambda) \in \mathbb{C}^{p \times p}$ is based on the theory of reproducing kernel Hilbert spaces of the kind introduced by de Branges and Rovnyak; see dBR1], dBR2, Dy for information on these spaces. The paper [AD] considers the case of column-valued functions. In this section we adapt the results of $[\mathrm{AD}]$ to the case of row-valued functions. We also present a new formula for a realization of a Schur function after implementation of the tangential Schur algorithm.
3.1. Schur functions and Reproducing Kernel Hilbert spaces. In this section $\sigma_{1}$ denotes a fixed self-adjoint and invertible (but not necessarily unitary) matrix in $\mathbb{C}^{p \times p}$. Let $S(\lambda)$ be a rational function, $\sigma_{1}$-inner in the open right half plane, i.e.

$$
S(\lambda)^{*} \sigma_{1} S(\lambda)-\sigma_{1} \leq 0
$$

at all points in the domain of analyticity $\Omega(S)$ of $S$ in $\mathbb{C}_{+}$, and

$$
S(\lambda)^{*} \sigma_{1} S(\lambda)-\sigma_{1}=0
$$

at all points on the imaginary axis where $S$ is defined. Then, the kernel

$$
\begin{equation*}
K_{S}(\lambda, w)=\frac{\sigma_{1}-S(w)^{*} \sigma_{1} S(\lambda)}{\bar{w}+\lambda} \tag{3.1}
\end{equation*}
$$

is positive for $\lambda, w \in \Omega(S)$, and the space of rational $\mathbb{C}^{1 \times p}$-valued functions

$$
\mathcal{H}(S)=\left\{\sum_{i=1}^{n} \alpha_{i} c_{i} K_{S}\left(\lambda, w_{i}\right) \mid \alpha_{1} \in \mathbb{C}, w_{i} \in \Omega, c_{i} \in \mathbb{C}^{1 \times p}\right\}
$$

is finite dimensional. These well-known facts can be proved using realization theory; see for instance [AG]. Furthermore, $\mathcal{H}(S)$ is the reproducing kernel Hilbert space, associated to the kernel $K_{S}(\lambda, w)$. The inner product is defined by

$$
\left\langle c K_{S}(\lambda, \nu), d K_{S}(\lambda, w)\right\rangle_{\mathcal{H}_{S}}=\left\langle c K_{S}(w, \nu)\right\rangle_{C^{1 \times p}}=c K_{S}(w, \nu) d^{*} .
$$

For an arbitrary $f(\lambda) \in \mathcal{H}(S)$ we have the reproducing kernel property

\langle f(\lambda), \xi K(\lambda, w)\rangle_{\mathcal{H}_{S}}=f(w) \xi^{*}
$$

More generally, let now $\mathcal{M}$ be a finite dimensional Hilbert space of $\mathbb{C}^{1 \times p}$-valued functions defined in some set $\Omega$, and let $\left\{f_{1}(\lambda), \ldots, f_{N}(\lambda)\right\}$ be a basis of $\mathcal{M}$. Let $\mathbb{X} \in \mathbb{C}^{p \times p}$ denote the Gram matrix with $\ell, j$ entry given by

\mathbb{X}_{\ell, j}=\left\langle f_{j}(\lambda), f_{\ell}(\lambda)\right\rangle_{\mathcal{M}}, \quad \ell, j=1, \ldots, p \tag{3.2}
\end{equation*}
$$

It is easily seen that the space $\mathcal{M}$ is a reproducing kernel Hilbert space with kernel given by the formula

\end{array}\right] \mathbb{X}^{-1}\left[\begin{array}{c}
f_{1}(\lambda)  \tag{3.3}\\

f_{N}(\lambda)
\end{array}\right]
$$

We set

$$
F(\lambda)=\left[\begin{array}{c}
f_{1}(\lambda)  \tag{3.4}\\
\vdots \\
f_{p}(\lambda)
\end{array}\right]
$$

Assume now that $\mathcal{M}$ consists of rational functions, defined on a set $\Omega(\mathcal{M})$. For $\alpha \in \Omega(\mathcal{M})$ the backward-shift operator $R_{\alpha}$ is defined by

R_{\alpha}(f(\lambda))=\frac{f(\lambda)-f(\alpha)}{\lambda-\alpha} .

Suppose that:
(1) The space $\mathcal{M}$ is invariant under the action of $R_{\alpha}$,
(2) The functions $f_{i}(\lambda)$ has the property that $f_{i}(\infty)=0$, i.e., $F(\infty)=0$,
then the function $F$ given by (3.4) can be written as

F(\lambda)=(\lambda I-A)^{-1} B \sigma_{1},
$$

for suitably chosen matrices $A, B$. In this special case, formula (3.3) takes the form

As mentioned at the beginning of this section we are interested in kernels of the form (3.1) for some $\sigma_{1}$-inner rational function $S$. We now recall the characterization of these spaces, and first note the following: equation (3.1) leads to

If $S$ is analytic at infinity and satisfies there $S(\infty)=I_{p}$, and letting $w \rightarrow \infty$ in this equation, we obtain the formula

Theorem 3.1. Let $\mathcal{M}$ be a finite dimensional Hilbert space of $\mathbb{C}^{1 \times p_{-}}$ valued rational functions, which are zero at infinity. Suppose that $R_{\alpha} \mathcal{M} \subset \mathcal{M}$ for $\alpha \in \Omega(\mathcal{M})$ and let $\mathbb{X}$ be its Gram matrix with respect to $F(\lambda)$. Then $\mathcal{M}=\mathcal{H}(S)$ for $S$ defined by (3.7) if and only if the Lyapunov equation

$$

A \mathbb{X}+\mathbb{X} A^{*}+B \sigma_{1} B^{*}=0 \tag{3.8}
\end{equation*}
$$

holds.
When the spectrum of the operator $A$ is in the open left half plane $\Re \lambda<0$, one has

\mathcal{H}(S)=\mathbf{H}_{2, \sigma_{1}} \ominus \mathbf{H}_{2, \sigma_{1}} S,
$$

where $\mathbf{H}_{2, \sigma_{1}}$ is the Hardy space $\mathbf{H}_{2}^{p}$ with the inner product

[f, g]_{\mathbf{H}_{2, \sigma_{1}}}=\left\langle f, g \sigma_{1}^{-1}\right\rangle_{\mathbf{H}_{2}^{p}} .
$$

We set $J=\left[\begin{array}{cc}-\sigma_{1} & 0 \\ 0 & \sigma_{1}\end{array}\right]$. Note that $J$ is both invertible and selfadjoint, and one can define $J$-inner rational functions. Let $\Theta=\left[\begin{array}{cc}\Theta_{11} & \Theta_{12} \\ \Theta_{21} & \Theta_{22}\end{array}\right]$
be a $J$-inner rational function; we introduce the linear fractional transformation

T_{\Theta}(W)=\left(\Theta_{11}+W \Theta_{21}\right)^{-1}\left(\Theta_{12}+W \Theta_{22}\right)
$$

Theorem 3.2. Let $S$ and $\Theta$ be respectively $\sigma_{1}$-inner J-inner rational functions. Then there exists a $\sigma_{1}$-inner rational function $W$ such that $S=T_{\Theta}(W)$ if and only if the map

$$

is a contraction from $\mathcal{H}(\Theta)$ to $\mathcal{H}(S)$.
This theorem originates with the work of de Branges and Rovnyak (see [dBR1, Theorem 13 p. 305]), where it is proved in a more general setting, and is one of the key ingredients to the reproducing kernel approach to the Schur algorithm. The proof is the same as for columnvalued functions, and is omitted.

As a special case of the previous theorem we have:
Corollary 3.3. Given $S \in \mathcal{R} \mathcal{S}, w_{1}, \ldots, w_{n} \in \mathbb{C}_{+}$, and row vectors $\xi_{1}, \ldots, \xi_{n} \in \mathbb{C}^{1 \times p}$, define

## 4. The tangential Schur algorithm in the class $\boldsymbol{\mathcal { S }} \boldsymbol{\mathcal { I }}$

Our strategy to the tangential Schur algorithm in the class $\mathcal{S I}$ relies on the following theorem. This theorem shows in particular that one cannot use the naive approach of applying the classical tangential Schur algorithm for each $t_{2}$ (that is, looking at $t_{2}$ as a mere parameter).

Theorem 4.1. Let us fix the parameters $\sigma_{1}, \sigma_{2}$, and $\gamma$, and the interval I. Then for every $t_{2}^{0} \in I$ there is a one-to-one correspondence between pairs $\left(\gamma_{*}, S\right)$ such that $S \in \mathcal{S} \mathcal{I}$ and $\gamma_{*}$ continuous in a neighborhood of $t_{2}^{0}$, and functions $Y(\lambda) \in \mathcal{S}\left(t_{2}^{0}\right)$.

Proof: Let $\phi$ be the map which to a pair $\left(\gamma_{*}, S\right)$ associates the function $S\left(\lambda, t_{2}^{0}\right) \in \mathcal{S}\left(t_{2}^{0}\right)$. The converse map $\psi: Y(\lambda) \rightarrow Y\left(\lambda, t_{2}\right)$ was introduced in [M, MV1, chapter 7] in a more general setting, and is defined as follows. Suppose that we have realized the transfer function $Y(\lambda)$ in the form

\frac{d}{d t_{2}} \mathbb{X}\left(t_{2}\right)=B\left(t_{2}\right) \sigma_{2}\left(t_{2}\right) B\left(t_{2}\right)^{*}, \quad \mathbb{X}\left(t_{2}^{0}\right)=\mathbb{X}_{0} \tag{4.3}
\end{equation*}
$$

Finally, we define

$$
\begin{aligned}
\gamma_{*}\left(t_{2}\right)= & \gamma\left(t_{2}\right)+\sigma_{2}\left(t_{2}\right) B\left(t_{2}\right)^{*} \mathbb{X}^{-1}\left(t_{2}\right) B\left(t_{2}\right) \sigma_{1}\left(t_{2}\right)- \\
& -\sigma_{1}\left(t_{2}\right) B\left(t_{2}\right)^{*} \mathbb{X}^{-1}\left(t_{2}\right) B\left(t_{2}\right) \sigma_{2}\left(t_{2}\right) .
\end{aligned}
$$

Then easy computations show that the function

$$
\begin{equation*}
S\left(\lambda, t_{2}\right)=I_{p}-B\left(t_{2}\right)^{*} \mathbb{X}^{-1}\left(t_{2}\right)\left(\lambda I-A_{1}\right)^{-1} B\left(t_{2}\right) \sigma_{1}\left(t_{2}\right) \tag{4.4}
\end{equation*}
$$

is in the class $\mathcal{C} \mathcal{I}$ corresponding to the parameters $\sigma_{1}\left(t_{2}\right), \sigma_{2}\left(t_{2}\right), \gamma\left(t_{2}\right)$, and $\gamma_{*}\left(t_{2}\right)$ for $t_{2} \in \mathrm{I}$. ?????????????????? Moreover, the Lyapunov equation (3.8) holds for every $t_{2} \in \mathrm{I}$, and thus the realization (4.4) is minimal for every $t_{2} \in I$.

Note that the composition $\phi \circ \psi=i d$, since starting from a function $Y \in \mathcal{S}\left(t_{2}^{0}\right)$, constructing $Y\left(\lambda, t_{2}\right)$ and taking its value at $t_{2}^{0}$, we shall obtain again $Y$ from the initial conditions of the differential equations (4.1) and (4.3) defining $B\left(t_{2}\right), \mathbb{X}\left(t_{2}\right)$.

In order to show that $\psi \circ \phi=i d$, we start from a function $S\left(\lambda, t_{2}\right) \in \boldsymbol{\mathcal { S }}$ and take its value $S\left(\lambda, t_{2}^{0}\right) \in \mathcal{S}\left(t_{2}^{0}\right)$. Using the construction above, we shall obtain a function $Y\left(\lambda, t_{2}\right)$. Note that the two functions $S\left(\lambda, t_{2}\right)$ and $Y\left(\lambda, t_{2}\right)$ have the same value at $t_{2}^{0}$ and maps solutions of the same input LDE to (possibly different) output LDEs, i.e. :

& Y\left(\lambda, t_{2}\right)=\Phi_{*}^{\prime}\left(\lambda, t_{2}, t_{2}^{0}\right) S\left(\lambda, t_{2}^{0}\right) \Phi^{-1}\left(\lambda, t_{2}, t_{2}^{0}\right) .
\end{aligned}
$$

Then the function $S^{-1}\left(\lambda, t_{2}\right) Y\left(\lambda, t_{2}\right)$ is equal to $I_{p}$ at infinity and is entire. By Liouville's theorem it is a constant function and is equal to $I_{p}$. Thus

\Phi_{*}\left(\lambda, t_{2}, t_{2}^{0}\right)=\Phi_{*}^{\prime}\left(\lambda, t_{2}, t_{2}^{0}\right),
$$

from where we obtain that

\Phi_{*}^{-1}\left(\lambda, t_{2}, t_{2}^{0}\right) \Phi_{*}^{\prime}\left(\lambda, t_{2}, t_{2}^{0}\right)=I_{p} .
$$

Differentiating both sides of this last equation we get to

0 & =\frac{\partial}{\partial t_{2}}\left[\Phi_{*}^{-1}\left(\lambda, t_{2}, t_{2}^{0}\right) \Phi_{*}^{\prime}\left(\lambda, t_{2}, t_{2}^{0}\right)\right]= \\
& =\Phi_{*}^{-1}\left(\lambda, t_{2}, t_{2}^{0}\right) \sigma_{1}^{-1}\left(t_{2}\right)\left(-\gamma\left(t_{2}\right)+\gamma^{\prime}\left(t_{2}\right)\right) \Phi_{*}^{\prime}\left(\lambda, t_{2}, t_{2}^{0}\right)
\end{aligned}
$$

Since the matrices $\Phi_{*}\left(\lambda, t_{2}, t_{2}^{0}\right), \Phi_{*}^{\prime}\left(\lambda, t_{2}, t_{2}^{0}\right), \sigma_{1}\left(t_{2}\right)$ are invertible we obtain that $\gamma\left(t_{2}\right)=\gamma^{\prime}\left(t_{2}\right)$.

Remark: Last theorems claims that the correspondence is between "initial" values $S\left(\lambda, t_{2}^{0}\right)$ and pairs $\left(S\left(\lambda, t_{2}\right), \gamma_{*}\left(t_{2}\right)\right)$. Notice that it is possible to obtain functions with the same $\gamma_{*}\left(t_{2}\right)$ with different initial conditions:

Proposition 4.2. Suppose that there exists a function $Y \in \mathcal{S}\left(t_{2}^{0}\right)$, which commutes with $\Phi\left(\lambda, t_{2}, t_{2}^{0}\right)$ and suppose that a function $S \in \boldsymbol{\mathcal { S }}$ corresponds to certain vessel parameters $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$. Then the function $S Y$ belongs to the class $\boldsymbol{\mathcal { S }}$ and corresponds to the same vessel parameters $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$.

Proof: Using formula 2.21 we obtain that

$$

intertwines solutions of the input (2.16) and the output (2.17) ODEs with the spectral parameter $\lambda$, and is identity at infinity, because $S$ and $Y$ and their product are such. Thus by the definition the function $S Y \in \mathcal{S I}$ and corresponds to the same spectral parameters as $S$.
For example (to be studied in subsection 5.5), taking Sturm-Liouville (SL) vessel parameters

e^{-k\left(t_{2}-t_{2}^{0}\right)} & 0 \\
0 & e^{k\left(t_{2}-t_{2}^{0}\right)}
\end{array}\right] V^{-1}
$$

where

$$
V=\left[\begin{array}{cc}
-\sqrt{\frac{i}{\lambda}} & \sqrt{\frac{i}{\lambda}} \\
1 & 1
\end{array}\right], \quad k=\sqrt{i \lambda}
$$

Taking $Y$, which commutes with $\sigma_{1}^{-1}\left(\sigma_{2} \lambda+\gamma\right)=\left[\begin{array}{cc}0 & i \\ \lambda & 0\end{array}\right]$, i.e. of the form

$$
Y(\lambda)=I_{2}-\left[\begin{array}{cc}
a(\lambda) & \frac{i c(\lambda)}{\lambda}  \tag{4.5}\\
c(\lambda) & a(\lambda)
\end{array}\right]
$$

for functions $a(\lambda), c(\lambda)$, which are zero at infinity, we shall obtain that for any $S \in \mathcal{S I}$, the function $S Y \in \mathcal{S I}$ and corresponds to the same vessel parameters. But in this case (which can be also generalized) it turns to be a necessary condition as the following theorem states:
Lemma 4.3. Given $S L$ vessel parameters $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}(x)$, there exists a unique initial value $S(0, \lambda)$ up to a scalar $t_{2}$-independent symmetric and identity at infinity function.

Proof: For this it is enough to prove that if a function $Y\left(\lambda, t_{2}\right) \in$ $\mathcal{S I}$ intertwines solutions of the input LDE (2.16) with itself, then $Y\left(\lambda, t_{2}\right)=Y\left(\lambda, t_{2}^{0}\right)$, i.e is a constant function, which moreover commutes with $\Phi_{I}\left(\lambda, t_{2}, t_{2}^{0}\right)$. Indeed, if we are given two functions $S_{1}\left(\lambda, t_{2}\right)$, $S_{2}\left(\lambda, t_{2}\right)$, then the function $S_{1}^{-1}\left(\lambda, t_{2}\right) S_{2}\left(\lambda, t_{2}\right)$ will intertwine solutions of the input LDE with itself and as a result is constant $Y(\lambda) \in \mathcal{S}$, which is moreover commutes with $\Phi_{I}\left(\lambda, t_{2}\right)$. Following the paragraph preceding the theorem, $Y(\lambda)=I$ and this means that $S_{1}\left(\lambda, t_{1}^{0}\right)=S_{2}\left(\lambda, t_{2}^{0}\right)$.

Let us show first that if $S\left(\lambda, t_{2}\right)$ intertwines solutions of the input LDE (2.16) with itself and is identity at $\lambda=\infty$, then it is a constant matrix, which commutes with $\Phi\left(\lambda, t_{2}, t_{2}^{0}\right)$. Performing simple calculations, we can find that
$\sigma_{1}^{-1}\left(\sigma_{2} \lambda+\gamma\right)=\left[\begin{array}{cc}0 & i \\ \lambda & 0\end{array}\right], \quad \Phi\left(\lambda, t_{2}, t_{2}^{0}\right)=V\left[\begin{array}{cc}e^{-k\left(t_{2}-t_{2}^{0}\right)} & 0 \\ 0 & e^{k\left(t_{2}-t_{2}^{0}\right)}\end{array}\right] V^{-1}$,
where

$$
V=\left[\begin{array}{cc}
-\sqrt{\frac{i}{\lambda}} & \sqrt{\frac{i}{\lambda}} \\
1 & 1
\end{array}\right], \quad k=\sqrt{i \lambda} .
$$

Consequently, for the expression $S\left(\lambda, t_{2}\right)=\Phi\left(\lambda, t_{2}, t_{2}^{0}\right) S_{0}(\lambda) \Phi^{-1}\left(\lambda, t_{2}, t_{2}^{0}\right)$ to be identity for $\lambda=\infty$, it is necessary to "cancel" the essential singularity arising from two entire functions $\Phi\left(\lambda, t_{2}, t_{2}^{0}\right)$ and $\Phi^{-1}\left(\lambda, t_{2}, t_{2}^{0}\right)$ (or more precisely, let them cancel each other).
Using the formula for $\Phi\left(\lambda, t_{2}, t_{2}^{0}\right)$
$V\left[\begin{array}{cc}e^{-k\left(t_{2}-t_{2}^{0}\right)} & 0 \\ 0 & e^{k\left(t_{2}-t_{2}^{0}\right)}\end{array}\right] V^{-1} S\left(\lambda, t_{2}^{0}\right) V^{-1}\left[\begin{array}{cc}e^{k\left(t_{2}-t_{2}^{0}\right)} & 0 \\ 0 & e^{-k\left(t_{2}-t_{2}^{0}\right)}\end{array}\right] V^{-1}=I$
and considering coefficients of the exponents, we may conclude that in order to cancel the exponents it is necessary to demand

b(\lambda) & 0 \\
0 & d(\lambda)
\end{array}\right] .
$$

for some analytic in $\sqrt{\lambda}$ at infinity functions $b(\lambda), d(\lambda)$ which are 1 there. From here it follows that

S\left(\lambda, t_{2}^{0}\right)=\left[\begin{array}{cc}
-\sqrt{\frac{i}{\lambda}}(b(\lambda)+d(\lambda)) & \frac{i}{\lambda}(d(\lambda)-b(\lambda)) \\
d(\lambda)-b(\lambda) & -\sqrt{\frac{i}{\lambda}}(b(\lambda)+d(\lambda))
\end{array}\right] .
$$

denoting here $1-a(\lambda)=-\sqrt{\frac{i}{\lambda}}(b(\lambda)+d(\lambda))$ and $-c(\lambda)=d(\lambda)-b(\lambda)$, we shall obtain that $S_{0}(\lambda)$ is of the form (4.5), i.e. commutes with the fundamental matrix $\Phi\left(\lambda, t_{2}, t_{2}^{0}\right)$.
Finally, let us consider a function of this form and will require the symmetry condition for it:

Plugging here the expression (4.5) for $S\left(\lambda, t_{2}^{0}\right)$

we shall obtain that on the one imaginary axis, where $\lambda=-\bar{\lambda}$, the following system of equations must hold

\left(1-a^{*}(-\bar{\lambda})\right) c(\lambda)+c^{*}(-\bar{\lambda})(1-a(\lambda))=0 \\
\left(1-a^{*}(-\bar{\lambda})\right)(1-a(\lambda))+\frac{1}{\lambda} c^{*}(-\bar{\lambda}) c(\lambda)=1 \\
\left(1-a^{*}(-\bar{\lambda})\right)(1-a(\lambda))+\frac{1}{\bar{\lambda}} c^{*}(-\bar{\lambda}) c(\lambda)=1 \\
\frac{i c^{*}(-\bar{\lambda})(1-a(\lambda))}{\lambda}+\frac{i c(\lambda)\left(1-a^{*}(-\bar{\lambda})\right)}{\lambda}=0
\end{array}\right.
$$

Subtracting the second and the third equation we obtain that (remember that $\lambda=-\bar{\lambda}$ )

c^{*}(-\bar{\lambda}) c(\lambda)\left(\frac{1}{\lambda}-\frac{1}{\bar{\lambda}}\right)=c^{*}(-\bar{\lambda}) c(\lambda) \frac{2}{\lambda}=0 .

from where it follows that on the imaginary axis at the points of analyticity of $c(\lambda)$ it holds that $c(\lambda)=0$. Since it is analytic there, it will be globally zero. Notice that the last system of equations for the trivial $c(\lambda)$ gives

We now focus on the rational case. We first note that starting from different realizations at $t_{2}^{0}$ we shall obtain the same $\gamma_{*}\left(t_{2}\right)$. More precisely we have the following theorem:

Theorem 4.4. Suppose that there are two minimal realizations of the function $S\left(\lambda, t_{2}^{0}\right) \in \mathcal{R} \mathcal{S}$ :

with associated similarity matrix $V$. Then the functions

S_{\ell}\left(\lambda, t_{2}\right)=I_{p}-B_{\ell}\left(t_{2}\right)^{*} \mathbb{X}_{\ell}^{-1}\left(t_{2}\right)\left(\lambda I-A_{\ell}\right)^{-1} B_{\ell}\left(t_{2}\right) \sigma_{1}\left(t_{2}\right), \quad \ell=1,2,
$$

obtained from these realizations via the construction in Theorem 4.1 are the same, and this holds if and only if:

where $t_{2}$ varies in a neighborhood of $t_{2}^{0}$. Moreover, in this case the following formula holds

Proof: Equality of the two realizations means that there exists an invertible matrix $V$ such that

from which follows (see [AG, Lemma 2.1 p .184$]$ for instance) that

By the construction described in Theorem 4.1, the function $B_{1}\left(t_{2}\right)$ will satisfy (4.1)

$$

and the function $B_{2}\left(t_{2}\right)$ will satisfy the same equation with $A_{2}$ instead of $A_{1}$ :

\frac{d}{d t_{2}}\left[B_{2}\left(t_{2}\right) \sigma_{1}\left(t_{2}\right)\right]+A_{2} B_{2}\left(t_{2}\right) \sigma_{2}\left(t_{2}\right)+B_{2}\left(t_{2}\right) \gamma\left(t_{2}\right)=0, \quad B_{2}\left(t_{2}^{0}\right)=B_{2}
$$

Using the equalities $A_{2}=V A_{1} V^{-1}, B_{2}=V B_{1}$ we obtain that the function $V^{-1} B_{2}\left(t_{2}\right)$ satisfies

\begin{aligned}
& \frac{d}{d t_{2}}\left[V^{-1} B_{2}\left(t_{2}\right) \sigma_{1}\left(t_{2}\right)\right]+A_{1} V^{-1} B_{2}\left(t_{2}\right) \sigma_{2}\left(t_{2}\right)+V^{-1} B_{2}\left(t_{2}\right) \gamma\left(t_{2}\right)=0, \\
& V^{-1} B_{2}\left(t_{2}^{0}\right)=B_{1}
\end{aligned}
$$

which is the same differential equation as for $B_{1}\left(t_{2}\right)$. Thus $B_{2}\left(t_{2}\right)=$ $V B_{1}\left(t_{2}\right)$. Similarly, considering the differential equations

\frac{d}{d t_{2}} \mathbb{X}_{i}\left(t_{2}\right)=B_{i}\left(t_{2}\right) \sigma_{1} B_{i}\left(t_{2}\right)^{*}, \quad \mathbb{X}_{i}\left(t_{2}^{0}\right)=\mathbb{X}_{i}, \quad i=1,2
$$

we obtain that

$$
\mathbb{X}_{2}\left(t_{2}\right)=V \mathbb{X}_{1}\left(t_{2}\right) V^{*}
$$

Consequently,

$$
\begin{aligned}
B_{2}^{*}\left(t_{2}\right) \mathbb{X}_{2}^{-1}\left(t_{2}\right) B\left(t_{2}\right) & =B_{1}^{*}\left(t_{2}\right) V^{*} V^{-1 *} \mathbb{X}_{1}^{-1}\left(t_{2}\right) V^{-1} V B_{1}\left(t_{2}\right) \\
& =B_{1}^{*}\left(t_{2}\right) \mathbb{X}_{1}^{-1}\left(t_{2}\right) B_{1}\left(t_{2}\right),
\end{aligned}
$$

from where we conclude that the same function $\gamma_{*}$ is associated to $S_{1}\left(\lambda, t_{2}\right)$ and $S_{2}\left(\lambda, t_{2}\right)$. Since these functions coincide for $t_{2}=t_{2}^{0}$ and map the same input ODE, we obtain that they are equal in a neighborhood of $t_{2}^{0}$.

The following notion has been introduced and studied in M2].
Definition 4.5. Let $S \in \boldsymbol{\mathcal { R S I }}$ with a realization (4.4). The function

$$
\tau\left(t_{2}\right)=\operatorname{det} \mathbb{X}\left(t_{2}\right)
$$

is called the $\tau$-function associated to $S$.

It follows from Theorem 4.4 that the $\tau$ function is well defined up to a multiplicative strictly positive constant. Indeed using the notation of the theorem,

We now introduce the counterpart of the tangential Schur algorithm in the class $\mathcal{R S I}$. Let $S \in \mathcal{R} \mathcal{S} \mathcal{I}$ and fix $t_{2}^{0} \in \mathrm{I}$. The function $S\left(\lambda, t_{2}^{0}\right) \in \mathcal{R} \mathcal{S}$. Consider now a space $\mathcal{M}$ with $\mathbb{X}>0$ and corresponding function $\Theta$ as in Corollary 3.3. This is always possible in view of Lemma 3.4. It follows from Theorem 3.2 that there exists $S_{0} \in \mathcal{R} \mathcal{S}$ such that

Applying Theorem 4.1 to $S_{0}$, we obtain a uniquely defined function $S_{0}\left(\lambda, t_{2}\right) \in \boldsymbol{\mathcal { R S I }}$, such that at $t_{2}^{0}$ the relation (4.7) holds.

Definition 4.6. The map $T_{\Theta, t_{2}^{0}}$

$$

is the time-varying counterpart of the linear fractional transformation (4.7). We will call it a generalized linear fractional transformation.

If $S\left(\lambda, t_{2}\right) \in \mathcal{S I}$ corresponds to the vessel parameters $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$, then $S_{0}\left(\lambda, t_{2}^{0}\right) \in \mathcal{S} \mathcal{I}$ corresponds to the vessel parameters $\sigma_{1}, \sigma_{2}, \gamma$, $\gamma_{0, *}$ for a uniquely defined function $\gamma_{0, *}\left(t_{2}\right)$. Moreover, for $t_{2}=t_{2}^{0}$ we have the usual linear fractional transformation (4.7).

As a consequence of Theorem 4.1 the following lemma holds.
Lemma 4.7. For a given $J$-inner function $\Theta$ and a given point $t_{2}^{0}$, the map $T_{\Theta, t_{2}^{0}}$ is one-to-one from $\mathcal{R S}$ into $\boldsymbol{\mathcal { R S I }}$.

Proof: Notice that for a given $t_{2}^{0}$ the map $T_{\Theta}$ is injective. Furthermore, using Theorem 4.1, every $S \in \boldsymbol{\mathcal { R S I }}$ is uniquely defined by the function $S\left(\lambda, t_{2}^{0}\right) \in \boldsymbol{\mathcal { R S }}$. The result follows.

Suppose now that we start from $S_{0}(\lambda) \equiv I_{p}$ and apply $n$ linear fractional transformations for a fixed $t_{2}^{0}$, using the data $\left\langle w_{i}, \xi_{i}, \eta_{i}\right\rangle$ $(i=1, \ldots n)$ to construct the corresponding $J$-inner functions. We obtain a function

Assume now that, starting from the identity matrix we apply this procedure for two different sets of data (with the same $n$ ) at two different points $t_{2}^{1}$ and $t_{2}^{2}$. The following theorem answers the question as when we obtain the same function, that is, when do we have:

Theorem 4.8. Suppose that there are given two sets of $n$ triples $<w_{i}^{1}, \xi_{i}^{1}, \eta_{i}^{1}>$ and $<w_{i}^{2}, \xi_{i}^{2}, \eta_{i}^{2}>$, with corresponding $\Theta_{\ell}, \ell=1,2$. Then necessary and sufficient conditions for equality of the two functions

$$

are:
(1) The corresponding matrices $A_{n}^{1}$ and $A_{n}^{2}$ defined by (4.8) are similar, i.e. there exists an invertible matrix $V$ such that $A_{n}^{1}=$ $V A_{n}^{2} V^{-1}$,
(2) $\oint\left(\lambda I-A_{n}^{1}\right)^{-1} B_{n}^{1} \sigma_{1}^{-1} \Phi^{-1}\left(\lambda, t_{2}^{2}, t_{2}^{1}\right) d \lambda=V B_{n}^{2}$.

Proof: From Theorem 4.1, a necessary and sufficient condition for the functions to be equal is that

A more general construction in this setting is obtained if one supposes that at each step different values of $t_{2}$ are chosen. In this case the construction of the function $S_{n}\left(\lambda, t_{2}\right)$ is more complicated, and can be computed recursively. The formulas are very involved in this case and we can see no real advantage to develop them at this point.

## 5. Markov moments and partial realization problem in THE CLASS $\boldsymbol{\mathcal { S }} \boldsymbol{\mathcal { I }}$

Let $S \in \boldsymbol{\mathcal { S }}$, and consider the Laurent expansion at infinity

in terms of a given minimal realization. The matrices $H_{i}=B^{*} \mathbb{X}^{-1} A^{i} B \sigma_{1}$ are called the Markov moments of $S$. The Partial Realization Problem (or moment problem at infinity) in $\mathcal{S}$ is defined as follows: Given the first $n+1$ Markov moments $H_{0}, \ldots, H_{n}$, find all functions (if any) $S \in \mathcal{S}$ with these first $n+1$ moments. See GKL] for a general study of the partial realization problem. Similarly, one can define the Markov moments for an element $S \in \mathcal{S I}$. We now give necessary conditions which the moments of a function $S \in \mathcal{S I}$ have to satisfy.
It is important to notice the following: fixing $t_{2}=t_{2}^{0}$ and solving the corresponding classical moment problem will not lead to a solution of the problem in the class $\boldsymbol{\mathcal { S }} \boldsymbol{\mathcal { I }}$ because we cannot obtain the function $\gamma$ (and hence $\gamma_{*}$ ) from this solution.
5.1. Fundamental properties of $S\left(\lambda, t_{2}\right)$. Before we consider moments of the function $S\left(\lambda, t_{2}\right)$ we present some of its fundamental properties which shed more light on the deriving of the moment equations.

Theorem 5.1. For fixed $\sigma_{1}, \sigma_{2}, \gamma$, a necessary condition on $\gamma_{*}$ so that there exists a vessel with the vessel parameters $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$ is

Proof: Let $S \in \mathcal{S I}$ be a function corresponding to the parameters $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$. Then using a realization (4.4)

& =\operatorname{det}\left(I-B\left(t_{2}\right) \sigma_{1}\left(t_{2}\right) B\left(t_{2}\right)^{*} \mathbb{X}^{-1}\left(t_{2}\right)\left(\lambda I-A_{1}\right)^{-1}\right) \\
& =\operatorname{det}\left(I+\left(A_{1} \mathbb{X}\left(t_{2}\right)+\mathbb{X}\left(t_{2}\right) A_{1}^{*}\right) \mathbb{X}^{-1}\left(t_{2}\right)\left(\lambda I-A_{1}\right)^{-1}\right) \\
& =\operatorname{det}\left(I+A_{1}\left(\lambda I-A_{1}\right)^{-1}+\mathbb{X}\left(t_{2}\right) A_{1}^{*} \mathbb{X}^{-1}\left(t_{2}\right)\left(\lambda I-A_{1}\right)^{-1}\right) \\
& =\operatorname{det}\left(\left(\lambda I+\mathbb{X}\left(t_{2}\right) A_{1}^{*} \mathbb{X}^{-1}\left(t_{2}\right)\right)\left(\lambda I-A_{1}\right)^{-1}\right) \\
& =\operatorname{det}\left(\lambda I+A_{1}^{*}\right) \operatorname{det}\left(\lambda I-A_{1}\right)^{-1} \\
& =\operatorname{det} S\left(\lambda, t_{2}^{0}\right) .
\end{aligned}
$$

Consequently, taking determinant of the formula (2.21)

we shall obtain that $\operatorname{det} \Phi_{*}\left(\lambda, t_{2}, t_{2}^{0}\right)=\operatorname{det} \Phi\left(\lambda, t_{2}, t_{2}^{0}\right)$ for all points $\lambda$, where $\operatorname{det} S\left(\lambda, t_{2}^{0}\right)$ exists and is different from zero. Since it happens for all points outside the spectrum of $A_{1}$ and the functions $\operatorname{det} \Phi_{*}\left(\lambda, t_{2}, t_{2}^{0}\right)$, $\operatorname{det} \Phi\left(\lambda, t_{2}, t_{2}^{0}\right)$ are entire they are equal for all $\lambda$.
Next theorem put some light on the connection between equations, which determine the transfer function $S\left(\lambda, t_{2}\right)$ and its moments. This theorem is similar to the property of a solution of a Riccati equation [Ze, theorem 2.1]

Theorem 5.2. Suppose that $S\left(\lambda, t_{2}\right)$ is a continuous function of $t_{2}$ for each $\lambda$, meromorphic in $\lambda$ for each $t_{2}$ and satisfies $S\left(\infty, t_{2}\right)=I$. Suppose also that $S\left(\lambda, t_{2}\right)$ is an intertwining function of LDEs (2.16) and (2.17). Then if the symmetry condition (2.23)

Proof: Since $S\left(\lambda, t_{2}\right)$ intertwines solutions of (2.16) and (2.17), then it satisfies the differential equation (2.22)

Consequently, using properties of $\gamma_{*}, \gamma$ appearing in definition 1.1 we obtain that the function $\sigma_{1}^{-1}\left(t_{2}\right) S^{-1 *}\left(-\bar{\lambda}, t_{2}\right) \sigma_{1}\left(t_{2}\right)$ satisfies the same differential equation. If these two functions are equal at $t_{2}^{0}$, from the uniqueness of solution for a differential equation with continuous coefficients, they are also equal for all $t_{2}$.
5.2. Restrictions on Markov moments for functions in $\mathcal{S I}$. We study the Markov moments of a function $S \in \boldsymbol{\mathcal { S I }}$, which maps solutions of the input ODE (2.16) to the output ODE (2.17) using a minimal realization (4.4) of $S$.
If $A_{1}$ is a constant matrix, at some stage the elements $I, A_{1}, \ldots, A_{1}^{n}$ will be linearly dependent and we obtain:

Lemma 5.3. Given $S \in \mathcal{R} \mathcal{S} \mathcal{I}$, with Markov moments $H_{i}\left(t_{2}\right), i=$ $0,1, \ldots$.. Then exists $N$ and constants $\mu_{j}, j=1, \ldots, N$ such that

Next we present formulas, which hold for the moments of a function in $\boldsymbol{\mathcal { S I }}$. They can be easily derived from theorem 5.2. We notice that the first moment $H_{0}\left(t_{2}\right)$ satisfies the linkage condition (1.3):

\end{align*}

see M, MV1]. Thus, differentiating $H_{0}\left(t_{2}\right)$, we obtain

& +\sigma_{1}^{-1}\left(t_{2}\right) \gamma_{*}\left(t_{2}\right) H_{0}\left(t_{2}\right)-H_{0}\left(t_{2}\right) \sigma_{1}^{-1}\left(t_{2}\right) \gamma\left(t_{2}\right) .
\end{aligned}
$$

In other words the second moment $H_{1}\left(t_{2}\right)=C\left(t_{2}\right) A_{1} B\left(t_{2}\right) \sigma_{1}\left(t_{2}\right)$ satisfies the following differential equation

& =\frac{d}{d t_{2}} H_{0}\left(t_{2}\right)-\sigma_{1}^{-1} \gamma_{*} H_{0}\left(t_{2}\right)+H_{0}\left(t_{2}\right) \sigma_{1}^{-1}\left(t_{2}\right) \gamma\left(t_{2}\right) .
\end{aligned}

In the same manner the moments $H_{i}\left(t_{2}\right)$ and $H_{i+1}\left(t_{2}\right)$ are connected by the following differential equation

Remark: One can obtain the same equations (5.4) and (5.5) by taking the expansion of $S\left(\lambda, t_{2}\right)$ into Taylor series around $\lambda=\infty$ and equating the coefficients of each $\frac{1}{\lambda^{i}}$. More precisely, the algebraic condition (5.4) is a consequence of the symmetry condition (2.23) and the condition (5.5) is a result of the differential equation (2.22).

Finally, we show how the third condition in Proposition 2.5 is reflected in the moments $H_{i}\left(t_{2}\right)$. This condition means that the function $S\left(\lambda, t_{2}\right)$ is $\sigma_{1}\left(t_{2}\right)$ contractive, and, for example, the first moment $H_{0}\left(t_{2}\right)$ satisfies $H_{0}\left(t_{2}\right) \sigma_{1}^{-1}\left(t_{2}\right)>0$. Using the minimality property, we have

Next theorem shows that moments of a transfer function in $\mathcal{S}$ satisfy recursive equations, involving algebraic and differential equations: The positivity of the matrix $\mathbb{P}$, in that case does not necessarily hold.

Theorem 5.5. Suppose that we are given moments $H_{i}\left(t_{2}\right)$, defined in a neighborhood of the point $t_{2}^{0} \in \mathrm{I}$. Then there exists $n_{0} \leq p^{2}$ such that each element $H_{i+1}$ is uniquely determined from $H_{0}, \ldots, H_{i}$ using the algebraic formulas (5.5), and $n_{0}$ LDEs with arbitrary initial conditions, obtained from (5.4). Moreover, $n_{0}$ equations must be satisfied by the elements of $\gamma_{*}\left(t_{2}\right)$.
Remarks: 1. This theorem is of local nature. The number " $n_{0}$ " appearing in the theorem may vary with the point $t_{2}^{0}$, but is unchanged in a small neighborhood of $t_{2}^{0}$ by continuity.
2. The proof of the theorem allows to produce an algorithm to determine explicitly, up to $n_{0}$ initial conditions, the Markov moments. The arguments in the proof of the theorem are illustrated on an example in the following subsection. This example exhibits all the difficulties present in the general case.

Proof of 5.5: We have seen in lemma 5.4, that the real part of $H_{2 n+1}=$ $R+i M$, defined by equation (5.4) satisfies (5.7). Let as concentrate on the equation (5.8) in order to solve for $M$. For example, if

Remark: This theorem means that the equations (5.4) and (5.5) are compatible, i.e. one can always solve them, once $n_{0}$ equations are satisfied for $\gamma_{*}\left(t_{2}\right)$. But if we consider the differential equation (5.4) only and ignore (5.5), then one obtain the following

So, this last equation means that the remaining $p_{0}$ elements are found from

Theorem 5.7. Let $\sigma_{1}, \sigma_{2}, \gamma, \gamma_{*}$ be vessel parameters, and $\mathfrak{V}$ a finite dimensional vessel corresponding to the $m$ parameters. Then the entries of the function $\gamma_{*}$ satisfies a polynomial differential equation of finite order with coefficients in the differential ring $\boldsymbol{\mathcal { R }}$, generated by (the entries of) $\sigma_{1}, \sigma_{1}^{-1}, \sigma_{2}, \gamma$.

Proof: Suppose that the transfer function of the vessel $\mathfrak{V}$, defined in (2.11) is

Suppose that that the dimension of the inner state is $n$ (i.e. $\operatorname{dim} \mathcal{H}=$ $n$ ), then we get that each of the matrices $H_{j}$ has $n^{2}$ entries and there is the total number of $n^{2}(N+1)$ entries for the moments $H_{0}, \ldots, H_{N}$. So, taking "enough" derivatives of $\gamma_{*}\left(t_{2}\right)$ (i.e., taking $K$ so that $K \operatorname{dim}(\mathcal{E})^{2}>$ $n^{2}(N+1)$ ) and eliminating all the entries of the moments, we shall obtain a finite number of polynomial differential equation for the entries of $\gamma_{*}\left(t_{2}\right)$.
Remark: From this theorem is follows that $\gamma_{*}$ satisfies an equation of the form

It is also possible that these differential equations will not determine the first row of $H_{0}$, in this case we shall obtain additional differential restrictions on the elements of $\sigma_{1}^{-1}\left(\gamma_{*}\left(t_{2}\right)-\gamma\left(t_{2}\right)\right)$ (see (5.24) below). In this case, the elements of the first row of $H_{0}$ will be determined from differential equations on the next level, involving $H_{1}\left(t_{2}\right)$ (see (5.32) below).
5.5. Sturm Liouville vessel parameters. The following example was extensively studied in [M2]. It deals with the Sturm Liouville differential equation

with the spectral parameter $\lambda$. The parameter $q\left(t_{2}\right)$ is usually called the potential. For $q\left(t_{2}\right)=0$ this problem is easily solved by exponents and in this case we shall call this equation trivial. In [M2] one connects solutions of the more general problem with non trivial $q\left(t_{2}\right)$ to the trivial one.

Definition 5.9. the Sturm Liouville vessel parameters are given by

for real valued continuous functions $\pi_{11}\left(t_{2}\right), \beta\left(t_{2}\right)$.
Notice that these parameters correspond to the Jordan block form of $\sigma_{1}^{-1} \sigma_{2}=\left[\begin{array}{ll}0 & 0 \\ 1 & 0\end{array}\right]$.
The input compatibility differential equation (2.16) is equivalent to

where we denote $u_{\lambda}\left(t_{2}\right)=\left[\begin{array}{l}u_{1}\left(\lambda, t_{2}\right) \\ u_{2}\left(\lambda, t_{2}\right)\end{array}\right]$. From the second equation one finds that $u_{2}\left(\lambda, t_{2}\right)=-i \frac{\partial}{\partial t_{2}} u_{1}\left(\lambda, t_{2}\right)$ and plugging it back to the
first equation, we shall obtain the trivial Sturm Liouville differential equation with the spectral parameter $i \lambda$ for $u_{1}\left(\lambda, t_{2}\right)$ :

from which we immediately obtain that $y_{2}\left(\lambda, t_{2}\right)=i\left(\beta\left(t_{2}\right)-\frac{\partial}{\partial t_{2}}\right) y_{1}\left(\lambda, t_{2}\right)$ and plugging it into the first equation

which means that $y_{1}\left(\lambda, t_{2}\right)$ satisfies the Sturm Liouville differential equation with the spectral parameter $i \lambda$ and the potential $q\left(t_{2}\right)=$ $\left(\pi_{11}\left(t_{2}\right)+\beta^{\prime}\left(t_{2}\right)+\beta^{2}\left(t_{2}\right)\right)$.

The first equation (1.3) considered for $H_{0}=\left[\begin{array}{cc}H_{0}^{11} & H_{0}^{12} \\ H_{0}^{21} & H_{0}^{22}\end{array}\right]$ becomes

Let us consider the differential equation (5.4), where we use the notation $H_{1}=\left[\begin{array}{cc}H_{1}^{11} & H_{1}^{12} \\ H_{1}^{21} & H_{1}^{22}\end{array}\right]$. Substituting the expressions for the vessel parameters, we shall obtain

The last equation (5.32) ${ }^{\prime}$ is obtained from (5.32) by substituting the index 0 at $H_{0}^{i j}$ by the index 1: $H_{1}^{i j}$.
Finally, we obtain that in the general case $H_{i+1}$ is derived from $H_{i}$ using a system of similar equations.

from where we see that Markov moments are defined up to initial conditions for $n_{0}=2$ elements. Notice that $p_{0}=1$ in this case.
Let us also demonstrate theorem 5.7 for the Sturm Liouville parameters from definition 5.9. We will take the simplest case $n=1$ and as a result the transfer function is

Since the vessel parameters are constant the differential ring $\mathcal{R}=\mathbb{C}$ is trivial. Using the formulas developed in [M2] we shall obtain that $\tau=\exp \int \beta$ satisfies

Definition 5.10. Non-Linear Shrödinger equation parameters are given by

Then the output and output compatibility conditions take the form of the classical non linear Schrödinger equation with the spectral parameter $i \lambda$

Using formula (1.2) and denoting n-th moment by $H_{n}\left(t_{2}\right)=\left[\begin{array}{cc}H_{n}^{11} & H_{n}^{12} \\ H_{n}^{21} & H_{n}^{22}\end{array}\right]$ we shall find that the moments has to satisfy the following relations

## 6. Inverse problem at infinity for given vessel PARAMETERS

In order to discuss the reconstruction of the transfer function from its moments, we will show first that for almost arbitrary vessel parameters one can solve the $n_{0}$ moment equations, appearing in Theorem 5.5, Once a symmetric, equal to identity at infinity, function is constructed, we will use a Krein space realization for it. Finally, by a counterexample, we will show that not all vessels parameters admit Hilbert space (with positive $\mathbb{X}$ ) realizations.

We have seen that there is a differential equation (5.17), which connects the moments, and means that the next moments is roughly speaking a second derivative of the previous one. If we start to estimate its growth, we will end with factorial growth for the moments, because consecutive applying of derivative produces many terms due to Leibniz rule. Instead, we will assume that there is a "big" function $M\left(t_{2}\right)$ which majorizes all the moments. Of course such an assumption narrows the class of function, to which the realization theorem 6.1 is applicable. On the other hand, the algebraic equations (5.5) connects the real/ imaginary parts of the moments with all the previous ones. Again, we found assumptions, which will enable us to handle the growth of such elements.
From theorem 5.2 it follows that we have to demand the symmetry condition (5.5) only at $t_{2}^{0}$. Examining the equation (5.5) and supposing that $\left\|H_{n}\left(t_{2}^{0}\right)\right\| \leq f_{n} C^{n+1}$, we will obtain that

\end{aligned}

So, if the series $\left\{f_{n}\right\}$ has the property

Let us search for a constant in $t_{2}$ matrix $S(\lambda, 0)=\left[\begin{array}{cc}a(\lambda) & b(\lambda) \\ c(\lambda) & d(\lambda)\end{array}\right]$ such that the constructed $S\left(\lambda, t_{2}\right)=\Phi_{*}\left(\lambda, t_{2}\right) S(\lambda, 0) \Phi^{-1}\left(\lambda, t_{2}\right)$ satisfies
conditions of the proposition 2.5. Considering the identity at infinity requirement, we come to the conclusion that

where the square root at the Right Half Plane (RHP) is taken so that at the infinity its argument coincides with the argument of $\frac{\lambda}{2}$. In this case the expression $\Gamma+\frac{\lambda}{2}$ is analytic in the whole $\mathbb{C}$, except for a cut from $-\sqrt{2}|\beta|$ to $\sqrt{2}|\beta|$. In other words this can not be defined as an analytic function at the right half plane. On the other hand, if it were possible to realize this function with $A_{1}$, satisfying Lyapunov equation (3.8) with positive $\mathbb{X}$, this would mean that the spectrum of $A_{1}$ is at the left hand side, since $\sigma_{1}=I$ and is a positive matrix:

As a result $S(\lambda, 0)$ would have spectrum only at the left hand side of the complex plane, contradicting the previous argument.
Finally, we present in this section a lemma, which says that one can always define moments so that the corresponding Pick matrices are positive, but as the example above shows they will not always define an analytic function (the radius of convergence may be zero)

Lemma 6.3. Suppose that equations (5.5), (5.4) hold so that the eigenvalues of the Pick matrix $\mathbb{P}_{n}$ are strictly positive on a finite interval I. Suppose that initial values are chosen for $H_{2 n+1}$, then there exists an initial values for $H_{2 n+2}$ such that all eigenvalues of $P_{n+1}$ are positive on arbitrary finite interval around $t_{2}^{0}$.

Proof: Let us use Sylvester criterion for positive definiteness of a matrix. Denote the entries of the matrix $(-1)^{n} H_{2 n} \sigma_{1}^{-1}$ as follows

## 7. Generalized Nevanlinna-Pick interpolation problem

We address the two kinds of Nevanlinna-Pick interpolation problems 1.4 and 1.5, defined in the introduction. The first one is solved using the notion of positive pairs and for the second one we present a criterion in terms of the of the initial data.
7.1. Linear Fractional Transformations in terms of intertwining positive pairs. Suppose that we are given a data of the NP interpolation problem 1.4. Following the notations of corollary 3.3 let us write

7.2. Nevanlinna-Pick interpolation problem 1.5. Using the previous results, we present a criterion for solvability of the Problem 1.5.

and $S_{0}^{i} \in \mathcal{R} \mathcal{S}$. Given a minimal realization

$$
S_{0}^{i}(\lambda)=I-\left(B_{0}^{i}\right)^{*}\left(\mathbb{X}_{0}^{i}\right)^{-1}\left(\lambda I-A_{0}^{i}\right)^{-1} B_{0}^{i} \sigma_{1}\left(t_{2}^{i}\right)
$$

of $S_{0}^{i}$, we shall obtain from formulas (3.15), (3.16), (3.17) the formulas (7.1), (7.2), (7.3) in the theorem. In view of Theorem 4.8, a necessary and sufficient condition to obtain the same function $S\left(\lambda, t_{2}\right)$ for every $i$ is that there exist invertible constant matrices $V_{i j}$ such that the operators $A_{i}$ are similar. In other words there must exist $V_{i j}$ such that $A_{i}=V_{i j} A_{j} V_{i j}^{-1}$. Moreover, the second part of theorem 4.8 tells that
additionally the equality

$$
\oint\left(\lambda I-A_{i}\right)^{-1} B_{i} \sigma_{1}^{-1}\left(t_{2}^{j}\right) \Phi^{-1}\left(\lambda, t_{2}^{j}, t_{2}^{i}\right) d \lambda=V_{i j} B_{j}
$$

must hold.
