# THERE IS NO UPPER BOUND FOR THE DIAMETER OF THE COMMUTING GRAPH OF A FINITE GROUP

#### Abstract

We construct a family of finite special 2-groups which have commuting graph of increasing diameter.


## 1. Introduction

For a group $G$, the commuting graph $\Gamma(G)$ of $G$ is the graph which has vertices the non-central elements of $G$ and two distinct vertices of $\Gamma(G)$ are adjacent if and only if they commute in $G$. In [3], Iranmanesh and Jafarzadeh conjecture that the commuting graph of a finite group is either disconnected or has diameter bounded above by a constant independent of the group $G$. They support this conjecture by proving that the commuting graph of $\operatorname{Sym}(n)$ and $\operatorname{Alt}(n)$ is either disconnected or has diameter at most 5. The conjecture is verified by the second author for the special case of soluble groups with trivial centre in [4] where it is shown that the appropriate constant for such groups is 8. This followed earlier work of Woodcock [7] and Giudici and Pope [1]. Further support for the conjecture is provided by the work of Segev and Seitz which demonstrates that the commuting graph of a classical simple group defined over a field of order greater than 5 is either disconnected or has diameter at most 10 and at least 4 [5, Corollary (pg. 127), Theorem 8]. In addition they show the commuting graph of the exceptional Lie type groups other than $\mathrm{E}_{7}(q)$ and the sporadic simple groups are disconnected [5, Theorem 6]. In [2] Hegarty and Zhelezov suggest a construction of a class of 2 -groups motivated by probabilistic methods aimed at providing a counter example to the Iranmanesh and Jafarzadeh conjecture. Though as yet unsuccessful, their putative examples motivated the examples presented in this article. Their supporting calculations yielded a group with commuting graph having diameter 10, the largest known diameter in the literature. Our theorem is as follows.

Theorem 1.1. For all positive integers d, there exists a finite special 2-group $G$ such that the commuting graph of $G$ has diameter greater than $d$.

Theorem 1.1 proves that the Iranmanesh and Jafarzadeh conjecture is false. However, we believe that it is most probably true that the commuting graph of a finite group with trivial centre is either disconnected or has diameter bound above by a constant. We are confident enough in this judgment to formulate it as a formal conjecture:

Conjecture 1.1. There is an absolute constant $d$ such that if $G$ is a finite group with trivial centre, then the commuting graph of $G$ is either disconnected or has diameter at most d.

We remark, that if the definition of the commuting graph of a group is revised so that the vertices of the graph are all the non-trivial elements of $G$, then our conjecture is that the modified commuting graph of a finite group $G$ is either disconnected or has diameter bounded above by a constant independent of $G$.

## 2. The construction

Suppose that $m$ is an integer with $m \geq 3$ and $V_{m}$ and $W_{m}$ are vector spaces defined over $\mathrm{GF}(2)$ which have dimension $m$ and $m-2$ respectively. Assume $x_{1}, \ldots, x_{m}$ is an ordered basis for $V_{m}$ and $y_{1}, \ldots, y_{m-2}$ is an ordered basis for $W_{m}$. Let $f_{m}: V_{m} \times V_{m} \rightarrow W_{m}$ be the bilinear map defined by the bilinear extension of the following map

$$
f_{m}\left(x_{i}, x_{j}\right)= \begin{cases}0 & j \in\{i, i+1\} \\ y_{j-i-1} & i+2 \leq j \leq m \\ 0 & i>j\end{cases}
$$

Because $f_{m}$ is bilinear it is immediate that it is a 2-cocycle. Therefore we can define the group $H_{m}$ which has underlying set $V_{m} \times W_{m}$ and multiplication defined as follows: for $(a, b),(c, d) \in H_{m}$,

$$
(a, b) \cdot(c, d)=\left(a+c, f_{m}(a, c)+b+d\right)
$$

Then $H_{m}$ is a central extension of $V_{m}$ by $W_{m}$. Furthermore, as $f_{m}$ is non-zero, $H_{m}$ is a nilpotent group of class 2 . Note that the identity of $H_{m}$ is $(0,0)$.

We calculate $\left(x_{i}, 0\right)\left(x_{i}, 0\right)=\left(0, f_{m}\left(x_{i}, x_{i}\right)\right)=(0,0)$ so that $\left(x_{1}, 0\right), \ldots,\left(x_{m}, 0\right)$ are involutions and

$$
\begin{aligned}
{\left[\left(x_{i}, 0\right),\left(x_{j}, 0\right)\right] } & =\left(x_{i}, 0\right)\left(x_{j}, 0\right)\left(x_{i}, 0\right)\left(x_{j}, 0\right) \\
& = \begin{cases}\left(0, f_{m}\left(x_{i}, x_{j}\right)\right)=\left(0, y_{j-i-1}\right) & i+1<j \\
\left(0, f_{m}\left(x_{i}, x_{j}\right)\right)=\left(0, y_{i-j-1}\right) & i>j+1 \\
(0,0) & \text { otherwise }\end{cases}
\end{aligned}
$$

The following lemma is elementary to prove.
Lemma 2.1. Assume that $m \geq 4$. Then the following hold:
(i) We have $C_{H_{m}}\left(\left(x_{1}, 0\right)\right)=\left\langle\left(x_{1}, 0\right),\left(x_{2}, 0\right),(0, w) \mid w \in W_{m}\right\rangle$ and $C_{H_{m}}\left(\left(x_{m}, 0\right)\right)=$ $\left\langle\left(x_{m}, 0\right),\left(x_{m-1}, 0\right),(0, w) \mid w \in W_{m}\right\rangle$.
(ii) $\left[H_{m}, H_{m}\right]=Z\left(H_{m}\right)=\left\{(0, w) \in H_{m} \mid w \in W_{m}\right\}$ has order $2^{m-2}$.
(iii) $X=\left\{(v, 0) \in H_{m} \mid v \in V_{m}\right\}$ is a transversal to $Z\left(H_{m}\right)$ in $H_{m}$.
(iv) $\left\langle\left(x_{1}, 0\right), \ldots,\left(x_{m-1}, 0\right)\right\rangle \cong H_{m-1}$.

Proof. To see (i), first note that $C_{H_{m}}\left(\left(x_{1}, 0\right)\right) \geq\left\langle(0, w) \mid w \in W_{m}\right\rangle$. Suppose that $(v, 0) \in$ $C_{H_{m}}\left(\left(x_{1}, 0\right)\right)$ with $v \in V_{m} \backslash\{0\}$. Write $v=x_{i_{1}}+\cdots+x_{i_{r}}$ with $1 \leq i_{1} \leq \cdots \leq i_{r}$. If $i_{r} \geq 3$, then $\left[\left(x_{1}, 0\right),(v, 0)\right]=\left(0, y_{i_{1}-2}+\cdots+y_{i_{r}-2}\right) \neq(0,0)$. Thus $i_{r} \leq 2$ and this proves the first part of (i). The proof of the second part is similar.

Clearly

$$
\left[H_{m}, H_{m}\right]=\left\langle\left(0, y_{j-i-1}\right) \mid 1 \leq i<j \leq m\right\rangle=\left\{(0, w) \mid w \in W_{m}\right\} \leq Z\left(H_{m}\right)
$$

On the other hand, by (i), as $m \geq 4$,

$$
Z\left(H_{m}\right) \leq C_{H_{m}}\left(\left(x_{1}, 0\right)\right) \cap C_{H_{m}}\left(\left(x_{m}, 0\right)\right)=\left\{(0, w) \mid w \in W_{m}\right\} .
$$

So (ii) holds.
Parts (iii) and (iv) are obvious.
We now commence with the investigation of the commuting graph $\Gamma_{m}=\Gamma\left(H_{m}\right)$ of $H_{m}$. We define a subgraph $\Gamma_{m}^{*}$ of $\Gamma_{m}$. The vertices of $\Gamma_{m}^{*}$ are the non-trivial elements of the transversal $X=\left\{(v, 0) \in H_{m} \mid v \in V_{m}\right\}$ to $Z\left(H_{m}\right)$ and two elements of $X \backslash\{(0,0)\}$ are joined if and only if they commute. Then $\Gamma_{m}$ is the lexicographic product of $\Gamma_{m}^{*}$ and the complete graph on $\left|Z\left(H_{m}\right)\right|$ vertices [6]. Thus the diameter of $\Gamma_{m}$ is equal to the diameter of $\Gamma_{m}^{*}$. In particular, to prove Theorem [1.1, it suffices to prove that for every natural number $d$, there exists $m$ such that $\Gamma_{m}^{*}$ has diameter greater than $d$. This is now our objective. To make the notation less unwieldy we abbreviate the elements $\left(x_{i}, 0\right), 1 \leq i \leq m$, by $x_{i}$ and $\left(0, y_{i}\right), 1 \leq i \leq m-2$, by $y_{i}$ expecting that no significant confusion will occur. We also set $Z_{m}=Z\left(H_{m}\right)$.

We know that $\Gamma_{4}^{*}$ has 15 vertices and elementary calculations yield that it has a graphical representation as follows:


The graph $\Gamma_{4}^{*}$.
Therefore $\Gamma_{4}^{*}$ is connected and has diameter 3 .
The proof that $\Gamma_{m}$ is connected only uses the fact that $\operatorname{dim} V_{m}-\operatorname{dim} W_{m} \geq 2$ and the connectivity of smaller graphs.

Lemma 2.2. For all $m \geq 4, \Gamma_{m}$ is connected.
Proof. We have already seen that $\Gamma_{4}^{*}$ is connected. Hence $\Gamma_{4}$ is connected. Assume $m>4$ and that $\Gamma_{m-1}$ is connected.

Let $J=\left\langle x_{1}, \ldots, x_{m-1}\right\rangle Z_{m}$. Then $J$ has index 2 in $H_{m}, \Gamma(J)$ is a subgraph of $\Gamma_{m}$ and $\Gamma(J) \cong \Gamma_{m-1}$ is connected. Let $a \in H_{m} \backslash J$. It suffices to show $C_{H_{m}}(a) \cap J \not 又 Z_{m}$. This means we should show $\left|C_{H_{m}}(a) / Z_{m}\right| \geq 4$. The commutator map $\phi: H_{m} / Z_{m} \rightarrow H_{m}^{\prime}$ given
by $b Z \mapsto[a, b]$ is a homomorphism from $H_{m} / Z_{m} \cong V_{m}$ of order $2^{m}$ to $H_{m}^{\prime} \cong W_{m}$ which has order $2^{m-2}$ and so, indeed, $\left|C_{H_{m}}(a) / Z_{m}\right| \geq 4$ and therefore $\Gamma_{m}$ is connected.
Lemma 2.3. Suppose that $d$ is an integer such that $m>2^{d-1}$. Assume that $w \in V\left(\Gamma_{m}^{*}\right)$ and $\mathrm{d}\left(x_{1}, w\right)=d$. If $x_{n}$ appears in the minimal expression for $w$, then $n \leq 2^{d-1}+1$.

Proof. We have $C_{H_{m}}\left(x_{1}\right)=\left\langle x_{1}, x_{2}\right\rangle Z_{m}$ from Lemma 2.1 (i). Hence $\left|C_{H_{m}}\left(x_{1}\right) / Z_{m}\right|=4$ and the vertices incident to $x_{1}$ in $\Gamma_{m}^{*}$ are $x_{1}+x_{2}$ and $x_{2}$. Thus the highest subscript involved in vertices at distance 1 from $x_{1}$ is $2=2^{1-1}+1$. So the result is true for vertices at distance 1 from $x_{1}$. Assume that the result is true for vertices at distance $k$ from $x_{1}$. Let $w \in V\left(\Gamma_{m}^{*}\right)$ be such that $d\left(x_{1}, w\right)=k+1$ and $u \in V\left(\Gamma_{m}^{*}\right)$ be incident to $w$ and have distance $k$ from $x_{1}$. Write $w=x_{\beta_{1}}+\cdots+x_{\beta_{s}}$ and $u=x_{\alpha_{1}}+\cdots+x_{\alpha_{r}}$ where $\alpha_{1} \leq \cdots \leq \alpha_{r}$ and $\beta_{1} \leq \cdots \leq \beta_{s}$. Since $\mathrm{d}\left(x_{1}, u\right)=k, \alpha_{r} \leq 2^{k-1}+1$. Because $[u, w]=(0,0)$, we have

$$
\sum_{\substack{1 \leq i \leq r \\ 1 \leq j \leq s}}\left[x_{\alpha_{i}}, x_{\beta_{j}}\right]=\sum_{\substack{1 \leq i \leq r \\ 1 \leq j \leq s}} y_{\left|\alpha_{i}-\beta_{j}\right|-1}=(0,0)
$$

where we assume $y_{\ell}$ with $\ell \leq 0$ is $(0,0)$. If $\beta_{s} \leq \alpha_{r}+1 \leq 2^{k-1}+2$, then there is nothing to prove. Hence we may assume that $\beta_{s} \geq \alpha_{r}+2 \geq \alpha_{1}+2$. As $\sum_{\substack{1 \leq i \leq r \\ 1 \leq j \leq s}} y_{\left|\alpha_{i}-\beta_{j}\right|-1}=(0,0)$, there exists $\alpha_{1} \leq \alpha_{t} \leq \alpha_{r}$ and $\beta_{1} \leq \beta_{u} \leq \beta_{s}$ such that

$$
y_{\beta_{s}-\alpha_{1}-1}= \begin{cases}y_{\alpha_{t}-\beta_{u}-1} & \alpha_{t}>\beta_{u} \\ y_{\beta_{u}-\alpha_{t}-1} & \alpha_{t}<\beta_{u}\end{cases}
$$

Since $\beta_{s} \geq \beta_{u}$ and $\alpha_{1} \leq \alpha_{t}$, the latter possibility is impossible. Thus $\beta_{s}-\alpha_{1}-1=$ $\alpha_{t}-\beta_{u}-1$ which means

$$
\beta_{s}<\beta_{s}+\beta_{u}=\alpha_{1}+\alpha_{t} \leq 2 \alpha_{r} \leq 2\left(2^{k-1}+1\right)
$$

Therefore $\beta_{s} \leq 2^{k}+1$ and the result follows by induction.
Proof of Theorem 1.1. Lemmas 2.2 and 2.3 show that for any given integer $d$, there exists a positive integer $m$ such that $\Gamma_{m}$ is connected of diameter greater than $d$.

One final remark: computations show that for $4 \leq m \leq 16$ the diameter of $\Gamma_{m}$ is $m-1$.
