# Input-to-State Stability of Periodic Orbits of Systems with Impulse Effects via Poincaré Analysis

*Abstract*—In this paper we investigate the relation between robustness of periodic orbits exhibited by systems with impulse effects and robustness of their corresponding Poincaré maps. In particular, we prove that input-to-state stability (ISS) of a periodic orbit under external excitation in both continuous and discrete time is equivalent to ISS of the corresponding 0-input fixed point of the associated *forced* Poincaré map. This result extends the classical Poincaré analysis for asymptotic stability of periodic solutions to establish orbital input-to-state stability of such solutions under external excitation. In our proof, we define the forced Poincaré map, and use it to construct ISS estimates for the periodic orbit in terms of ISS estimates of this map under mild assumptions on the input signals. As a consequence of the availability of these estimates, the equivalence between exponential stability (ES) of the fixed point of the 0 input (unforced) Poincaré map and ES of the corresponding orbit is recovered. The results can be applied naturally to study the robustness of periodic orbits of continuous-time systems as well. Although our motivation for extending classical Poincaré analysis to address ISS stems from the need to design robust controllers for limit-cycle walking and running robots, the results are applicable to a much broader class of systems that exhibit periodic solutions.

*Index Terms*—Poincaré map, systems with impulse effects, limit cycles, input-to-state stability, robustness.

# I. INTRODUCTION

SIFEMS with impulse effects (SIEs) are characterized<br>by a set of ordinary differential equations (ODEs) and a<br>discussed are that printiplied the ODEs when the converged by a set of ordinary differential equations (ODEs) and a discrete map that reinitializes the ODEs when the corresponding solution reaches a switching surface, possibly resulting in discontinuous evolution. These systems arise in a broad range of fields; a non-exhaustive list of examples includes impact mechanics [\[1\]](#page-14-0), modeling of population dynamics [\[2\]](#page-14-1), communication [\[3\]](#page-14-2), and legged robotics [\[4\]](#page-14-3); a collection of methods for analyzing SIEs can be found in [\[5\]](#page-14-4).

In this paper, we study the stability properties of limit cycles exhibited by SIEs under external excitation. Our interest in this specific class of systems arises from dynamically-stable legged robots, where periodic walking gaits are modeled as limit cycles of SIEs. This approach has been successful in generating asymptotically stable periodic gaits for bipedal robots through a variety of methods, including hybrid zero dynamics [\[6\]](#page-14-5), [\[7\]](#page-14-6), geometric control [\[8\]](#page-15-0), virtual holonomic constraints [\[9\]](#page-15-1), to name a few. Recent extensions of these methods resulted in generating continuums of limit-cycle gaits for bipedal walkers [\[10\]](#page-15-2), [\[11\]](#page-15-3), and switching among them [\[12\]](#page-15-4)–[\[14\]](#page-15-5), to enlarge the behavioral repertoire of these robots in order to accomplish tasks that require adaptability to typical human-centric environments [\[15\]](#page-15-6), and human (or robot) collaborators [\[16\]](#page-15-7). Practical use of these robots demands robustness to external disturbances, which has led many researchers—including the authors of the present paper—to analyze [\[17\]](#page-15-8)–[\[19\]](#page-15-9) and design [\[14\]](#page-15-5), [\[20\]](#page-15-10), [\[21\]](#page-15-11) controllers that enhance the robustness of limit-cycle walking gaits. With this being our motivation, we develop in this paper a framework for rigorously analyzing the robustness of limit cycles, by relating orbital input-to-state stability (ISS) for hybrid limit cycles of SIEs with the corresponding Poincaré map.

The notion of ISS has been widely used to study robustness of equilibrium points in continuous [\[22\]](#page-15-12), discrete [\[23\]](#page-15-13), and hybrid [\[24\]](#page-15-14) systems. Intuitively, the solutions emanating in a neighborhood of an ISS equilibrium point remain bounded when the external inputs are bounded. In addition, when the inputs vanish, these solutions converge back to the equilibrium. Beyond equilibrium points, ISS can be naturally applied to study robustness of zero-invariant sets by considering the point-to-set distance [\[22\]](#page-15-12), [\[25\]](#page-15-15). Establishing ISS in this context poses a considerable challenge, which, in the case of SIEs, is exacerbated by the hybrid nature of the system. However, for periodic orbits—such as those of interest in this paper—we show here that the problem can be reduced to studying ISS of an unforced (0-input) fixed point of a discrete dynamical system, thus avoiding direct analysis of hybrid solutions. This discrete system arises through the Poincaré map construction suitably extended to incorporate external inputs, thereby resulting in the definition of a *forced Poincare map. ´*

Numerous results exist that analyze forced Poincaré maps of systems evolving under the influence of external inputs; in the context of SIEs, examples include [\[18\]](#page-15-16), [\[19\]](#page-15-9), [\[26\]](#page-15-17), in which the input signals are not necessarily periodic. However, the exact relation of conclusions deduced on the basis of the Poincaré map to properties of the underlying periodic orbit has *not* been explicitly discussed in the relevant literature. Indeed, rigorous results that relate the stability properties of the Poincaré map with those of the corresponding periodic orbit are restricted to systems *without* inputs; e.g., [\[27,](#page-15-18) Theorem 6.4] addresses local asymptotic stability (LAS) of periodic orbits in continuous systems, while [\[28,](#page-15-19) Theorem 1], [\[5,](#page-14-4) Theorem 13.1] address LAS and [\[29,](#page-15-20) Theorem 1] local exponential stability (LES) of such orbits in SIEs. The relation between the behavior of periodic orbits of SIEs *under external inputs* and the corresponding *forced* Poincaré map is at the core of this paper.

Specifically, the main contribution of this work (Theorem [1\)](#page-4-0) is that ISS of a limit cycle exhibited by a SIE is equivalent

to ISS of a 0-input fixed point of the corresponding forced Poincaré map. This result significantly simplifies analysis, as it replaces the problem of establishing ISS of a hybrid limit cycle with the simpler problem of checking asymptotic stability of a 0-input fixed point of a discrete dynamical system defined by the corresponding Poincaré map (Theorem [2\)](#page-4-1). To ensure the level of generality required by practical applications, we consider inputs affecting both the continuous and the discrete dynamics of the system. The continuous-time inputs belong in the (Banach) space of continuous bounded functions under the supremum norm. The resulting forced Poincaré map is a nonlinear *functional* defined over an infinite-dimensional function space, thus significantly extending prior work that considers finite dimensional disturbances; see [\[18\]](#page-15-16), [\[19\]](#page-15-9), [\[30\]](#page-15-21) for example. Finally, the proof of the main result provides an explicit connection between ISS estimates of the forced Poincaré map and those of the hybrid orbit.

The results presented in this paper generalize previous contributions such as [\[29,](#page-15-20) Theorem 1], which is widely used to establish exponential stability (ES) of a hybrid limit cycle when the fixed point of the corresponding Poincaré map is ES. Indeed, [\[29,](#page-15-20) Theorem 1] can be obtained as a consequence of Theorem [1](#page-4-0) of Section [III](#page-4-2) below. Furthermore, Proposition [1](#page-4-3) of Section [III](#page-4-2) and Lemma [9](#page-8-0) of Section [V](#page-7-0) complete crucial arguments that were omitted in the proof of [\[29,](#page-15-20) Theorem 1]. Moreover, our results can offer useful tools for the design of robust controllers for limit cycles of SIEs. For example, the methods in [\[31\]](#page-15-22) that are based on Poincaré map analysis can be supported using Theorem [1.](#page-4-0) As a final note, the results of this paper can naturally be applied to study ISS of limit cycles of continuous-time nonlinear systems under external excitation. Hence, their relevance extends to other bioinspired robots including aerial robots with flapping wings [\[32\]](#page-15-23) and robot snakes [\[33\]](#page-15-24)—which, like legged robots, realize locomotion through periodic forceful interactions with their environment.

# II. BACKGROUND

This section introduces the class of systems with impulse effects pertinent to this paper, and develops a forced Poincaré map suitable for studying periodic orbits of such systems under the influence of continuous and discrete exogenous inputs; such inputs could be command or disturbance signals. We begin with a few notes on the notation used in the paper.

## <span id="page-1-0"></span>*A. Notation*

Let  $\mathbb R$  and  $\mathbb Z$  denote the sets of real and integer numbers, and  $\mathbb{R}_+$  and  $\mathbb{Z}_+$  the corresponding subsets that include the non-negative reals and integers, respectively. For any  $x \in \mathbb{R}^n$ , the Euclidean norm is represented as  $||x||$ . An open ball of radius  $\delta > 0$  centered at x is denoted by  $B_{\delta}(x)$ . The pointto-set distance of x from  $A \subseteq \mathbb{R}^n$  is defined as  $dist(x, \overline{A}) :=$ inf<sub>u∈A</sub>  $||x - y||$ . We use  $\mathcal{P}(\mathcal{A})$  to represent the power set of A, and  $A^c$  to denote the complement of A with respect to  $\mathbb{R}^n$ .

For any interval  $E \subseteq \mathbb{R}$  let  $u : E \to \mathbb{R}^p$  be a function that represents the continuous-time inputs. The norm of  $u$  is defined as  $||u||_{\infty} := \sup_{t \in E} ||u(t)||$ . The set of continuoustime inputs we work with belongs to  $\mathcal{U} := \{u : E \rightarrow$ 

 $\mathbb{R}^p \mid u$  is continuous,  $||u||_{\infty} \in \mathbb{R}_+$ . Discrete-time inputs  $\bar{v}$  :  $\mathbb{Z}_{+} \rightarrow \mathbb{R}^{q}$  correspond to sequences  $\bar{v} = \{v_{k}\}_{k=0}^{\infty}$ with  $v_k \in \mathbb{R}^q$  for  $k \in \mathbb{Z}_+$ . The norm of  $\bar{v}$  is defined as  $\|\bar{v}\|_{\infty} := \sup_{k \in \mathbb{Z}_+} \|v_k\|$ . The discrete inputs belong to  $\mathcal{V} := \{\bar{v}: \mathbb{Z}_+ \to \mathbb{R}^q \mid \|\bar{v}\|_{\infty} \in \mathbb{R}_+\}.$  With an abuse of notation we use  $\|\cdot\|_{\infty}$  to denote the norm for both U and V. No ambiguity arises because the meaning of  $\|\cdot\|_{\infty}$  depends on whether the argument is continuous or discrete.

A function  $\alpha : \mathbb{R}_+ \to \mathbb{R}_+$  belongs to class K if it is continuous, strictly increasing, and  $\alpha(0) = 0$ . A function  $\beta : \mathbb{R}_+ \times \mathbb{R}_+ \to \mathbb{R}_+$  belongs to class  $\mathcal{KL}$  if it is continuous,  $\beta(\cdot, t)$  belongs to K for any fixed  $t \geq 0$ ,  $\beta(s, \cdot)$  is strictly decreasing, and  $\lim_{t\to\infty} \beta(s,t) = 0$ , for any fixed  $s \geq 0$ .

# <span id="page-1-6"></span>*B. Forced Systems With Impulse Effects*

We are interested in studying the stability of periodic orbits exhibited by systems with impulse effects under externally applied inputs. These systems are characterized by alternating continuous and discrete phases. The evolution of the state  $x \in$  $\mathbb{R}^n$  during the continuous phase is governed by an ODE

where the input  $u : \mathbb{R}_+ \to \mathbb{R}^p$  is an element of U defined in Section [II-A](#page-1-0) and  $u(t) \in \mathbb{R}^p$  is its value. The vector field f in the right-hand side of [\(1\)](#page-1-1) satisfies the following assumption: A.[1](#page-1-2))  $f: \mathbb{R}^n \times \mathbb{R}^p \to \mathbb{R}^n$  is twice continuously differentiable<sup>1</sup>.

<span id="page-1-3"></span>Local existence and uniqueness of solutions of [\(1\)](#page-1-1) for a fixed  $u$  follows from [\[34,](#page-15-25) Theorem 3.1] based on assumption A[.1](#page-1-3) and the continuity of  $u$  as a function of  $t$ . We denote the flow of [\(1\)](#page-1-1) starting from the initial state  $x(0)$  and evolving under the influence of the input u by  $\varphi(t, x(0), u)$ .

The continuous phase terminates when the flow of [\(1\)](#page-1-1) reaches a set  $\mathcal{S} \subset \mathbb{R}^n$  defined as

where it is assumed that

<span id="page-1-8"></span>A.2)  $S \neq \emptyset$ ,  $H : \mathbb{R}^n \to \mathbb{R}$  is twice continuously differentiable, and for all  $\hat{x} \in S$ ,  $\frac{\partial H}{\partial x}\Big|_{\hat{x}} \neq 0$ , i.e., S is a co-dimension 1 embedded submanifold in  $\mathbb{R}^n$ ; see [\[35,](#page-15-26) p. 431].

For future use we define the sets  $\mathcal{S}^+ := \{x \in \mathbb{R}^n \mid H(x) > 0\}$ and  $S^- := \{x \in \mathbb{R}^n \mid H(x) < 0\}.$ 

The intersection of the flow of  $(1)$  with S initiates the discrete phase, which is governed by the mapping

where  $x^{-}$ ,  $x^{+}$  are the states right before and after impacting S, respectively, and  $v \in \mathbb{R}^q$  is a member of the discrete input  $\bar{v}$  that belongs in V defined in Section [II-A.](#page-1-0) It is assumed that A.3)  $\Delta : \mathbb{R}^n \times \mathbb{R}^q \to \mathbb{R}^n$  is continuously differentiable.

<span id="page-1-9"></span>Putting together the continuous and discrete phases [\(1\)](#page-1-1) and [\(3\)](#page-1-4), the *forced system with impulse effects* takes the form

where  $x^-(t) := \lim_{\tau \nearrow t} x(\tau)$  and  $x^+(t) := \lim_{\tau \searrow t} x(\tau)$ .

At any time instant for which it exists, the solution of [\(4\)](#page-1-5) evolves according to either [\(1\)](#page-1-1) or [\(3\)](#page-1-4). This allows us to represent the hybrid flow of [\(4\)](#page-1-5) as the solution of [\(1\)](#page-1-1) which, on approaching  $S$ , is interrupted by the discrete map [\(3\)](#page-1-4). Let  $\psi(t, x(0), u, \overline{v})$  denote the flow of [\(4\)](#page-1-5) for some initial state  $x(0)$ , continuous input u, and discrete input  $\bar{v}$ . Adapting the definition in [\[28,](#page-15-19) Section III-A],  $\psi(t, x(0), u, \bar{v})$ as a function of time  $t \in [0, t_f)$ ,  $t_f \in \mathbb{R}_+ \cup \{\infty\}$ , satisfies the following: (i) it is right continuous<sup>[2](#page-2-0)</sup> on [0,  $t_f$ ]; (ii) left limits exist at each point in  $(0, t_f)$ ; and (iii) there exists a discrete subset  $\mathcal{T} \subset [0, t_{\rm f})$  such that (a) for every  $t \notin \mathcal{T}$ ,  $\psi(t, x(0), u, \overline{v})$  satisfies [\(1\)](#page-1-1) for the input u considered, and (b) for  $t \in \mathcal{T}$ ,  $x^-(t) = \lim_{\tau \nearrow t} \psi(\tau, x(0), u, \bar{v}) \in \mathcal{S}$  and  $x^+(t) = \lim_{\tau \searrow t} \psi(\tau, x(0), u, \overline{v}) = \Delta(x^-(t), v)$  where v is a member of the sequence  $\bar{v}$ . Note that right continuity implies that at time  $t \in \mathcal{T}$  the solution attains the value  $x^+(t)$  and not  $x^-(t)$ ; that is,  $x(t) = \psi(t, x(0), u, \bar{v}) = x^+(t)$ . Moreover, Proposition [2](#page-4-4) in Section [III](#page-4-2) below ensures that in the neighborhood of distinct locally input-to-state stable periodic orbits—such as those of interest in this work—the solutions of [\(4\)](#page-1-5) exist for arbitrary  $t_f > 0$ , they do not possess consecutive discrete jumps (beating) and do not exhibit Zeno behavior; see [\[5\]](#page-14-4), [\[36\]](#page-15-27) for definitions. the results of the square is not discussed in the results of the results that we have a state for the results of the

It follows from our assumptions that  $\mathcal O$  is a bounded unforced  $(u \equiv 0, \bar{v} \equiv 0)$  hybrid periodic orbit of  $\Sigma$  that exhibits only one impact with S at  $x^*$  and has period  $T^*$ . Moreover, O is not a closed curve; see Fig. [1](#page-2-3) for a geometric illustration.

# <span id="page-2-11"></span>*C. Forced Poincare Map ´*

The Poincaré map is a common tool used for analyzing systems with periodic orbits. Given a Poincaré section—which is an embedded submanifold transversal to the orbit—the Poincaré map returns consecutive intersections of the system's flow with the Poincaré section. Here, we study the map which returns the intersection of the solution of  $(4)$  with S under the influence of the external inputs u and  $\bar{v}$ . Consequently, it is natural to call this map the *forced* Poincaré map.

As was mentioned in Section [II-B,](#page-1-6) when the input  $u$ affecting [\(1\)](#page-1-1) is a *fixed* signal from  $U$ , existence and uniqueness of the solution emanating from<sup>[3](#page-2-4)</sup>  $x(0) \in \mathbb{R}^n$  can be established over an interval  $J \subseteq \mathbb{R}_+$  with  $0 \in J$ , by [\[34,](#page-15-25) Theorem 3.1] applied on the time-varying vector field  $\hat{f}(t, x) := f(x, u(t)).$ To develop the forced Poincaré map, however, we need to compare solutions with different initial conditions *and* different inputs. To do this, it is important to be able to consider the forced solution  $\varphi(t, x(0), u)$  of [\(1\)](#page-1-1) as a mapping from  $J \times \mathbb{R}^n \times \mathcal{U}$  to  $\mathbb{R}^n$ , interpreting u as an infinite-dimensional "parameter" residing in the Banach space  $(\mathcal{U}, \|\cdot\|_{\infty})$ . We can then analyze variations of  $\varphi(t, x(0), u)$  with respect to its arguments, including  $u$ . The following lemma shows that, over its maximal interval of existence, the solution  $\varphi(t, x(0), u)$ of [\(1\)](#page-1-1) is continuously differentiable in its arguments, with differentiability understood in the Fréchet sense [\[37,](#page-15-28) p. 333].

<span id="page-2-6"></span>**Lemma 1.** Let  $f : \mathbb{R}^n \times \mathbb{R}^p \to \mathbb{R}^n$  in [\(1\)](#page-1-1) be continuously *differentiable, and let*  $u \in U$  *with*  $U$  *as in Section [II-A.](#page-1-0) Then, the solution*  $\varphi : J \times \mathbb{R}^n \times U \to \mathbb{R}^n$  *is continuously differentiable in its arguments in the Frechet sense. ´*

The proof makes use of Banach calculus [\[37\]](#page-15-28) and is presented in Appendix [A.](#page-11-0) We only note here that, for notational convenience, we use the same symbol  $u$  to denote both the finite-dimensional values of the input function at given instants and the infinite-dimensional input signal as a function in the Banach space  $(U, \|\cdot\|_{\infty})$ ; the distinction will always be clear through the domain of definition of the corresponding map.

Let  $T_1: S \times U \times \mathbb{R}^q \to \mathbb{R}_+ \cup \{\infty\}$  be the time-to-impact map defined as

Lemma [2](#page-2-5) below establishes that the time-to-impact function  $T<sub>I</sub>$ is well defined and continuously differentiable in  $x$ ,  $u$  and  $v$ . Note that the dependence of  $T_1$  on u is to be understood with u interpreted as a function in  $(\mathcal{U}, \|\cdot\|_{\infty})$ . The proof is based on the implicit mapping theorem [\[37,](#page-15-28) Chapter XIV, Theorem 2.1] and on Lemma [1](#page-2-6) above, and is presented in Appendix [A.](#page-11-0)

Suppose that* [\(4\)](#page-1-5) *satisfies assump-tions A[.1-](#page-1-3)A[.7.](#page-2-8) Then, there exists a*  $\delta > 0$  *such that*  $T_1$  *is continuously differentiable for any*  $x \in B_\delta(x^*) \cap S$ ,  $u \in \mathcal{U}$ *with*  $||u||_{\infty} < \delta$ *, and*  $v \in B_{\delta}(0)$ *.*

We are now ready to define the forced Poincaré map  $P$  :  $S \times U \times \mathbb{R}^q \to S$  as

From Lemmas [1](#page-2-6) and [2](#page-2-5) it follows that  $P$  is well defined and continuously differentiable for any  $x \in B_\delta(x^*) \cap \mathcal{S}, u \in \mathcal{U}$ with  $||u||_{\infty} < \delta$ , and  $v \in B_{\delta}(0)$ .

Let  $\psi(t, x(0), u, \overline{v})$  be a solution of [\(4\)](#page-1-5) and  $x(t)$  =  $\psi(t, x(0), u, \bar{v})$  be the value of the state at time t. For  $k \in \mathbb{Z}_+$ , let  $t_k$  be the instant at which the  $(k + 1)$ -th "intersection" of  $x(t)$  with S occurs. Define  $u_k(t) := u(t)$  for  $t_k \le t < t_{k+1}$ , and let  $v_k$  be the k-th element of the sequence  $\bar{v}$ . Then, the forced Poincaré map gives rise to the forced discrete system

$$
x_{k+1} = P(x_k, u_k, v_k) \t{,} \t(7)
$$

where  $x_k := \lim_{t \nearrow t_k} x(t)$ . The discrete system [\(7\)](#page-3-0) captures the evolution of the system from *just before* an impact with S to *just before* the next impact, assuming that the next impact occurs. It should be emphasized that the state  $x(t)$  does *not* attain<sup>[4](#page-3-1)</sup> the value  $x_k$  at  $t_k$  because  $\psi$  has been assumed right continuous in t; in fact,  $x(t_k) = \Delta(x_k, v_k) = \lim_{t \searrow t_k} x(t) \neq$  $\lim_{t \nearrow t_k} x(t) = x_k$ . Let  $x^*$  be as in assumption A[.6,](#page-2-9) then  $x^*$ is the 0-input fixed point of [\(7\)](#page-3-0), i.e.,  $x^* = P(x^*, 0, 0)$ .

For future use, we also define  $\hat{T}_I : \mathcal{S}^+ \times \mathcal{U} \to \mathbb{R}_+ \cup \{\infty\}$  as the time-to-impact function for solutions of [\(1\)](#page-1-1) starting from states in  $S^+$  as

$$
\hat{T}_1(x, u) :=
$$
\n
$$
\begin{cases}\n\inf\{t \ge 0 \mid \varphi(t, x, u) \in \mathcal{S}\}, & \text{if } \exists t : \varphi(t, x, u) \in \mathcal{S} \\
\infty, & \text{otherwise}\n\end{cases}
$$
\n(8)

It is noted that for any point  $w \in \mathcal{O}$  there exists a  $\delta > 0$ such that  $\hat{T}_I$  is continuously differentiable for any  $x \in B_\delta(w)$ and any  $u \in \mathcal{U}$  with  $||u||_{\infty} < \delta$ . The proof similar to that of Lemma [2,](#page-2-5) and it is not presented for brevity.

Finally, Remark [1](#page-3-2) clarifies the relation between  $\psi$ ,  $\varphi$  and the sequence  ${x_k}_{k=0}^{\infty}$  and Remark [2](#page-3-3) indicates that the results are valid even when the input  $u$  is a piecewise continuous signal, as long as the points of discontinuity are at  $t_k$ .

<span id="page-3-2"></span>**Remark 1.** Let  $\psi(t, x(0), u, \bar{v})$  be a solution of [\(4\)](#page-1-5) that exists *for all*  $t \geq 0$  *and*  $x(t) = \psi(t, x(0), u, \overline{v})$  *be the value of the state at time t. Then, if*  $t_0 := \hat{T}_I(x(0), u)$  *is the time instant of the first crossing of* S *we have*

$$
x(t) = \varphi(t, x(0), u_{[0, t_0)}), \text{ for } 0 \le t < t_0.
$$

*Moreover, if the sequence*  ${x_k}_{k=0}^{\infty}$  *is the solution of* [\(7\)](#page-3-0) *for the initial state*  $x_0 := \lim_{t \nearrow t_0} x(t)$  *and the sequence of input functions*  $\{u_k\}_{k=0}^{\infty}$  *are as defined above, then for all*  $k \in \mathbb{Z}_+$ 

$$
x(t) = \varphi(t, \Delta(x_k, v_k), u_k), \text{ for } t_k \le t < t_{k+1} ,
$$

*where*  $v_k$  *is the k-th element of*  $\bar{v}$  *and* 

<span id="page-3-5"></span>
$$
t_{k+1} = t_k + T_1(x_k, u_k, v_k) = t_0 + \sum_{j=0}^k T_1(x_j, u_j, v_j) .
$$

<span id="page-3-1"></span><sup>4</sup>Right continuity of  $\psi$  in t implies that, in general, there is no t for which  $x(t) \in S$ ; see related comments in Section [II-B](#page-1-6) and in [\[4,](#page-14-3) Section 4.1.2 ].

<span id="page-3-3"></span>Remark 2. *The results of the paper hold when* u *is discontinuous, as long as each* u<sup>k</sup> *is a continuous function in* U *that agrees with u over the interval*  $[t_k, t_{k+1})$ *.* 

## *D. Pertinent Stability Definitions*

Notions of orbital stability that will be studied in this paper are introduced here. We begin with local input-to-state stability (LISS) of the periodic orbit.

<span id="page-3-4"></span>Definition 1. *The periodic orbit* O *of* [\(4\)](#page-1-5) *is orbitally LISS if there exists a*  $\delta > 0$ ,  $\alpha_1, \alpha_2 \in \mathcal{K}$ , and  $\beta \in \mathcal{KL}$  *such that*  $x(t) =$  $\psi(t, x(0), u, \bar{v})$  *satisfies for all*  $t \in [0, t_f)$ *,*  $t_f \in \mathbb{R}_+ \cup \{\infty\}$ *,* 

$$
dist(x(t), \mathcal{O}) \leq \beta dist(x(0), \mathcal{O}), t) + \alpha_1(||u||_{\infty})
$$
  
+  $\alpha_2(||\bar{v}||_{\infty})$ , (9)

*for any*  $x(0) \in S^+$  *with* dist $(x(0), \mathcal{O}) < \delta$ ,  $u \in \mathcal{U}$  *with*  $\|u\|_{\infty} < \delta$ , and  $\bar{v} \in V$  with  $\|\bar{v}\|_{\infty} < \delta$ .

Proposition [2](#page-4-4) in Section [III](#page-4-2) below asserts that shrinking  $\delta > 0$ in Definition [1](#page-3-4) guarantees that all ensuing hybrid solutions exist for all time; that is,  $t_f > 0$  in Definition [1](#page-3-4) can be chosen arbitrarily large. Since we focus on local properties of distinct periodic orbits  $\mathcal O$  of [\(4\)](#page-1-5), we work with solutions in a small enough neighborhood of  $O$  that satisfy [\(9\)](#page-3-5) for all  $t > 0$ .

<span id="page-3-9"></span>Besides LISS, we will briefly consider local exponential stability (LES) of  $\mathcal O$ . As above, Proposition [2](#page-4-4) of Section [III](#page-4-2) below ensures that in a small enough neighborhood of  $O$ solutions of [\(4\)](#page-1-5) exist over arbitrarily long intervals. Hence, the definition below assumes existence of solutions for all  $t \geq 0$ .

<span id="page-3-7"></span>Definition 2. *The periodic orbit* O *of* [\(4\)](#page-1-5) *is LES if there exists a*  $\delta > 0$ *,*  $N > 0$ *, and*  $\omega > 0$  *such that*  $x(t) = \psi(t, x(0), 0, 0)$ *satisfies for all*  $t > 0$ ,

<span id="page-3-10"></span>
$$
dist(x(t), \mathcal{O}) \leq N e^{-\omega t} dist(x(0), \mathcal{O}) ,
$$

*for any*  $x(0) \in S^+$  *with* dist $(x(0), \mathcal{O}) < \delta$ .

In addition to orbital stability, we also present notions of stability for the discrete system [\(7\)](#page-3-0).

<span id="page-3-6"></span>**Definition 3.** *The system* [\(7\)](#page-3-0) *is LISS if there exists a*  $\delta > 0$ *,*  $\alpha_1, \alpha_2 \in \mathcal{K}$ *, and*  $\beta \in \mathcal{KL}$ *, such that for all*  $k \in \mathbb{Z}_+$ *,* 

$$
||x_k - x^*|| \le \beta(||x_0 - x^*||, k) + \alpha_1(||u||_{\infty}) + \alpha_2(||\bar{v}||_{\infty}),
$$
\n(10)

*is satisfied for any*  $x_0 \in S$  *with*  $||x_0 - x^*|| < \delta$ ,  $u \in U$  *with*  $||u||_{\infty} < \delta$ , and  $\bar{v} \in V$  with  $||\bar{v}||_{\infty} < \delta$ .

Finally, the 0-input fixed point  $x^*$  of [\(7\)](#page-3-0) satisfies  $x^* =$  $P(x^*,0,0)$ , and it is locally asymptotically stable (LAS) or LES if it satisfies the following definition.

<span id="page-3-8"></span>Definition 4. *The 0-input fixed point* x <sup>∗</sup> *of* [\(7\)](#page-3-0) *is LAS if there exists a*  $\delta > 0$  *and*  $\beta \in \mathcal{KL}$  *such that for all*  $k \in \mathbb{Z}^+$ *,* 

$$
||x_k - x^*|| \le \beta(||x_0 - x^*||, k) ,
$$

*is satisfied for any*  $x_0 \in S$  *with*  $||x_0 - x^*|| < \delta$ . Furthermore, *if there exists a*  $N > 0$ *, and*  $0 < \rho < 1$  *such that* 

$$
\beta(\|x_0 - x^*\|, k) \le N \rho^k \|x_0 - x^*\|,
$$

*then* x ∗ *is a LES 0-input fixed point of* [\(7\)](#page-3-0)*.*

# III. MAIN RESULTS

<span id="page-4-2"></span>In this section we present the main results of this paper. First, we introduce an important proposition on the geometric relation between  $\mathcal O$  and  $\mathcal S$ . This proposition allows us to express bounds on the orbital distance of any  $x \in S$  from  $\mathcal{O}$ equivalently based on the Euclidean distance of  $x$  from  $x^*$ , and vice-versa. The importance of this proposition becomes clear by observing the distance metrics used in Definition [1](#page-3-4) and Definition [3.](#page-3-6) Hence, it serves as an important bridge between the orbital notions of stability and the Poincaré map's stability.

<span id="page-4-3"></span>Proposition 1. *Let* S *be defined as in* [\(2\)](#page-1-7) *and satisfy assumption A[.2.](#page-1-8) Let* O *be defined as in* [\(5\)](#page-2-10) *and satisfy assumptions A[.4-](#page-2-1)A[.7.](#page-2-8) Then, there exists a*  $0 < \lambda < 1$  *such that* 

<span id="page-4-6"></span>
$$
\lambda \|x - x^*\| \le \text{dist}(x, \mathcal{O}) \le \|x - x^*\| \quad , \tag{11}
$$

*for all*  $x \in S$ *.* 

The proof of Proposition [1](#page-4-3) is detailed in Section [IV](#page-4-5) below.

Proposition [1](#page-4-3) can be used to show that solutions in a small enough neighborhood of a LISS periodic orbit  $O$  and for sufficiently small continuous and discrete input signals do not exhibit beating and Zeno behavior, and exist indefinitely. This statement is made precise by the following proposition, a proof of which can be found in Appendix [A.](#page-11-0)

<span id="page-4-4"></span>Proposition 2. *Consider the system* [\(4\)](#page-1-5) *which satisfies assumptions A[.1-](#page-1-3)A[.7.](#page-2-8) Suppose that the solutions of* [\(4\)](#page-1-5)*, denoted by*  $x(t) = \psi(t, x(0), u, \overline{v})$  *and defined in Section [II-B,](#page-1-6) satisfy Definition [1.](#page-3-4) Then, there exists a*  $\delta > 0$  *such that for all*  $x(0) \in S^+$  *with* dist $(x(0), \mathcal{O}) < \delta$ ,  $u \in \mathcal{U}$  *with*  $||u||_{\infty} < \delta$ , *and*  $\bar{v} \in V$  *with*  $\|\bar{v}\|_{\infty} < \delta$  *the following holds:* 

- (i) x(t) *has no consecutive discrete jumps,*
- (ii) x(t) *does not exhibit Zeno behavior, and*
- (iii)  $x(t)$  *exists for all*  $t \geq 0$ *.*

Now we are ready to present the main result of the paper.

<span id="page-4-0"></span>Theorem 1. *Consider the system* [\(4\)](#page-1-5) *which satisfies assumptions A[.1-](#page-1-3)A[.3](#page-1-9) and possesses a periodic orbit* O *that is defined as in* [\(5\)](#page-2-10) *and satisfies assumptions A[.4-](#page-2-1)A[.7.](#page-2-8) Then, the following are equivalent.*

- (i)  $\circ$  *is an LISS orbit of* [\(4\)](#page-1-5);
- (ii)  $x^*$  is an LISS fixed point of  $(7)$ *.*

It is straightforward to note that in the absence of inputs  $(u \equiv 0, \bar{v} \equiv 0)$ , Theorem [1](#page-4-0) reduces to the Poincaré result for asymptotic stability of periodic orbits of systems with impulse effects, providing an alternative proof to [\[28,](#page-15-19) Theorem 1]. Note though that the proof detailed in the following sections explicitly constructs the class- $KL$  functions involved in the definitions, thereby providing useful insight on the rates of convergence. The following result can be stated as an immediate corollary of Theorem [1.](#page-4-0)

<span id="page-4-7"></span>Corollary 1. *Under the assumptions of Theorem [1,](#page-4-0) the following are equivalent*

- (i)  $\circ$  *is an LES 0-input orbit of* [\(4\)](#page-1-5);
- (ii)  $x^*$  is an LES 0-input fixed point of  $(7)$ *.*

The following remarks are in order.

Remark 3. *The equivalence between ES of a periodic orbit and ES of the corresponding fixed point of the associated Poincare map has been discussed in [\[29,](#page-15-20) Theorem 1], which ´ has been subsequently used in a number of relevant publications, e.g., [\[7\]](#page-14-6), [\[38\]](#page-15-29)–[\[40\]](#page-15-30), and many more. However, [\[29,](#page-15-20) Theorem 1] is proved only for initial states in the Poincaré section, as noted above [\[29,](#page-15-20) Equation (6)], rather than for initial states in a neighborhood of the* entire *orbit, as Definition [2](#page-3-7) requires. Furthermore, Proposition [1,](#page-4-3) which is crucial for commuting between Definition [2](#page-3-7) and Definition [4](#page-3-8) is omitted in the proof of [\[29,](#page-15-20) Theorem 1], resulting in the estimate in [\[29,](#page-15-20) Equation (6)] being incomplete; the final estimate should have been expressed in terms of*  $dist(x, 0)$ *, which requires the use of Proposition [1.](#page-4-3)*

Remark 4. *It should be emphasized that the results of this paper can be used to study limit-cycle solutions of continuoustime forced systems like* [\(1\)](#page-1-1) *by replacing the discrete update map* ∆ *with the identity map for the* x *component and the zero map for the* v *component.*

Theorem [1](#page-4-0) can be used to establish LISS of a periodic orbit of [\(4\)](#page-1-5) on the basis of LISS of a fixed point of the associated Poincaré map [\(7\)](#page-3-0). However, in many applications—see Section [VI](#page-10-0) for an example—the lack of analytical expressions for the forced Poincaré map makes it challenging to establish LISS for a fixed point of it. To alleviate this issue, the following theorem provides a tool for establishing that a 0-input fixed point  $x^*$  of the forced Poincaré map [\(7\)](#page-3-0) is LISS by showing that  $x^*$  is a LAS fixed point of the unforced Poincaré map. Hence, one can simply linearize the unforced Poincaré map and compute the eigenvalues of the associated linearization. If all the eigenvalues lie within the unit disc, the corresponding fixed point is a LAS fixed point of the unforced Poincaré map. Then, Theorem [2](#page-4-1) ensures that  $x^*$  is a LISS fixed point of the forced Poincaré map and Theorem [1](#page-4-0) establishes LISS of the associated periodic orbit. A result similar to Theorem [2](#page-4-1) can be found in [\[22\]](#page-15-12) for continuous-time systems; however, to the best of our knowledge, we have not seen such a result for discrete systems and we provide it below.

<span id="page-4-1"></span>Theorem 2. *Consider the discrete dynamical system* [\(7\)](#page-3-0)*. Let*  $\delta > 0$  *such that* P *is continuously differentiable in the Fréchet sense for*  $x \in B_\delta(x^*) \cap \mathcal{S}$ ,  $u \in \mathcal{U}$  *with*  $||u||_{\infty} < \delta$ , and  $v \in B_\delta(0)$ *. Then, the following are equivalent.* 

- (i)  $x^*$  is an LISS fixed point of [\(7\)](#page-3-0);
- (ii) x ∗ *is an LAS 0-input fixed point of* [\(7\)](#page-3-0)*.*

A proof for Theorem [2](#page-4-1) is presented in Section [V.](#page-7-0)

# IV. PROOF OF PROPOSITION [1](#page-4-3)

<span id="page-4-5"></span>The proof of Proposition [1](#page-4-3) is organized in a sequence of lemmas. We begin with a lemma which establishes that for  $O$ , the point-to-set distance is equal to the minimum Euclidean distance over the closure of the orbit. As the minimum will be attained by some point in  $\overline{O}$ , Lemma [3](#page-5-0) allows us to work with the Euclidean distance from that point instead of dealing with inf<sub>y∈ $\emptyset$ </sub>  $||x - y||$ .

<span id="page-5-0"></span>Lemma 3. *Let* O *be defined as in* [\(5\)](#page-2-10) *and satisfy assumptions A[.4-](#page-2-1)A[.7,](#page-2-8) then for all*  $x \in \mathbb{R}^n$ *, we have* 

<span id="page-5-1"></span>
$$
dist(x, O) := \inf_{y \in O} ||x - y|| = \min_{y \in \overline{O}} ||x - y||.
$$

*Proof.* Let  $x \in \mathbb{R}^n$ . The fact that  $\overline{\mathcal{O}} = \mathcal{O} \cup \{x^*\}$  implies

$$
\min_{y \in \overline{\mathcal{O}}} \|x - y\| = \min\{\|x - x^*\|, \inf_{y \in \mathcal{O}} \|x - y\|\} . \tag{12}
$$

On the other hand,

$$
\inf_{y \in \mathcal{O}} \|x - y\| \le \inf_{y \in \mathcal{O}} (\|x - x^*\| + \|x^* - y\|) = \|x - x^*\| \quad (13)
$$

because  $\inf_{y \in \mathcal{O}} ||x^* - y|| = 0$  due to  $x^* \in \overline{\mathcal{O}}$ . The result follows from [\(12\)](#page-5-1) in view of [\(13\)](#page-5-2).  $\Box$ 

To simplify notation in the proofs that follow, the closure of the orbit  $\overline{O}$  is parameterized as a function  $y(\tau)$  in "time" like coordinates  $\tau$  taking values in a closed interval [0, T]. In more detail, let  $\varphi^-(t, x^*, 0)$  be the solution of the 0-input continuous system [\(1\)](#page-1-1) backwards in time from the initial state x<sup>\*</sup>. The flow is chosen to be backwards so that  $x^*$  is at  $\tau = 0$ . This is primarily for convenience of notation; the flow can be chosen forwards in time starting from  $\Delta(x^*,0)$  as well. Then, let  $\tau := t/s$ , where  $s > 0$  is a scaling constant, and define the function  $y : [0, T] \rightarrow \overline{\mathcal{O}}$  by

$$
y(\tau) := \varphi^-(s\tau, x^*, 0)
$$
 (14)

where

<span id="page-5-6"></span>
$$
T := T^*/s \tag{15}
$$

The scaling is performed to ensure that in the Taylor expansion of  $y(\tau)$  about  $\tau = 0$ , the first derivative is a vector of unit magnitude. This is done only to simplify notation in the future. Note that  $y(\tau)$  should be viewed as a parameterization of the set  $\overline{\mathcal{O}}$  and *not* as a solution of the system  $\Sigma$  in [\(4\)](#page-1-5). In fact, this section only deals with geometric properties of  $\mathcal O$  and  $\mathcal S$  and does not study the dynamical system as such. The following lemma provides some useful properties of  $y(\tau)$ .

<span id="page-5-3"></span>**Lemma 4.** *The map*  $\tau \mapsto y(\tau)$  *is bijective and three-times continuously differentiable in τ.* 

The proof of Lemma [4](#page-5-3) can be found in Appendix [B.](#page-12-0)

Let<sup>[5](#page-5-4)</sup>  $\tau_m : \mathbb{R}^n \to \mathcal{P}(\overline{\mathcal{O}})$  be a set-valued map defined as

<span id="page-5-7"></span>
$$
\tau_{\mathbf{m}}(x) := \arg \min_{\tau \in [0,T]} \|x - y(\tau)\| \quad , \tag{16}
$$

where  $x \in \mathbb{R}^n$  and  $y(\tau)$ , T as defined in [\(14\)](#page-5-5) and [\(15\)](#page-5-6), respectively. Intuitively, the map  $x \mapsto \tau_m(x)$  returns the *set*  $\tau_{\text{m}}(x)$  of "times"  $\tau$  that "realize" the points  $y(\tau)$  on  $\overline{\mathcal{O}}$  that are nearest to x. Hence, for any  $\tau_{\min} \in \tau_{\min}(x)$ , we have

<span id="page-5-9"></span>
$$
||x - y(\tau_{\min})|| \le ||x - y(\tau)|| \text{ for all } \tau \in [0, T]. \tag{17}
$$

The next lemma shows that by selecting  $x$  sufficiently close to  $x^*$ , the points on  $\overline{\mathcal{O}}$  nearest to x also remain close to  $x^*$ .

<span id="page-5-10"></span>**Lemma 5.** Let  $\tau_m$  be defined as in [\(16\)](#page-5-7). Then, for every  $\epsilon > 0$ *there exists*  $\delta > 0$  *such that*  $||x - x^*|| < \delta$  *implies*  $\tau_{\min} < \epsilon$ *for all*  $\tau_{\min} \in \tau_{\min}(x)$ *.* 

<span id="page-5-4"></span><sup>5</sup>Recall from Section [II-A](#page-1-0) that  $\mathcal{P}(\cdot)$  is the power set of its argument.

*Proof.* Let  $0 < \epsilon < T$ . The map  $y(\tau)$  is continuous, so  $y([\epsilon, T])$  is compact (and thus closed) in  $\mathbb{R}^n$ . Hence, its complement  $y([\epsilon, T])^c$  in  $\mathbb{R}^n$  is open and contains  $y(0) = x^*$ using the injectivity of  $y(\tau)$  from Lemma [4.](#page-5-3) As a result, there exists a  $\delta > 0$  such that  $B_{2\delta}(x^*) \subset y([\epsilon, T])^c$ .

<span id="page-5-2"></span>It can be seen that for any  $x \in B_\delta(x^*)$ , the points on  $\overline{\mathcal{O}}$  closest to x will be within  $B_{2\delta}(x^*)$ . This follows by a contradiction argument. Indeed, take any  $x \in B_\delta(x^*)$  and let  $\tau_{\min}$  be any element of the set<sup>[6](#page-5-8)</sup>  $\tau_{\text{m}}(x)$  defined in [\(16\)](#page-5-7). Assume  $y(\tau_{\min})$  is outside  $B_{2\delta}(x^*)$  so that  $||x - y(\tau_{\min})|| \ge \delta$  by the reverse triangle inequality. But, since  $y(0) = x^* \in \overline{\mathcal{O}}$ , by [\(17\)](#page-5-9) we have  $||x - y(\tau_{\min})|| \le ||x - x^*|| < \delta$ , thus resulting in a contradiction. It follows that for any  $\tau_{\min} \in \tau_{\min}(x)$ ,  $y(\tau_{\min}) \in B_{2\delta}(x^*) \subset y([\epsilon,T])^c$ , and thus  $\tau_{\min} < \epsilon$  as a consequence of the injectivity of  $y(\tau)$  by Lemma [4.](#page-5-3) As this holds for any  $0 < \epsilon < T$ , the result trivially holds  $\forall \epsilon > 0$ .  $\Box$ 

Next, we present a lemma which shows that the lower bound of Proposition [1](#page-4-3) holds locally around  $x^*$ .

<span id="page-5-13"></span>Lemma 6. *Let* S *be defined as in* [\(2\)](#page-1-7) *and satisfy assumption A[.2.](#page-1-8) Let* O *be as in* [\(5\)](#page-2-10) *and satisfy assumptions A[.4-](#page-2-1)A[.7.](#page-2-8) Then, there exists*  $\delta > 0$  *and*  $0 < \lambda < 1$  *such that* 

<span id="page-5-12"></span>
$$
dist(x, O) \ge \bar{\lambda} \|x - x^*\| ,
$$

<span id="page-5-5"></span>*for all*  $x \in B_\delta(x^*) \cap S$ *.* 

*Proof.* This proof is structured as follows. We begin by establishing the desired inequality for states restricted to the vector spaces  $T_{x^*}$  $\mathcal O$  (tangent line to  $\mathcal O$  at  $x^*$ ) and  $T_{x^*}$  $\mathcal S$  (tangent plane to  $S$  at  $x^*$ ) and subsequently introduce non-linearities one-byone. First, we extend the result to  $\mathcal{O}$  and  $T_{x*}S$ , and finally, we extend the result to  $\mathcal O$  and  $\mathcal S$ . A geometric illustration of the setup can be seen in Fig. [2.](#page-6-0)

Performing Taylor's expansion [\[37,](#page-15-28) p. 349] of  $y(\tau)$  about  $\tau = 0$ , we get

$$
y(\tau) = x^* + \tau \nu + \tau^2 r(\tau) \tag{18}
$$

where  $\nu$  is a unit vector and  $\tau^2 r(\tau)$  is the remainder. The scaling factor s in the definition of  $\tau$  above [\(14\)](#page-5-5) is chosen to ensure that  $\nu$  has unit length. Let  $y'(\tau)$ ,  $r'(\tau)$  be shorthand for  $dy/d\tau$  and  $dr/d\tau$ , respectively. As  $y(\tau)$  is three-times continuously differentiable by Lemma [4,](#page-5-3)  $r(\tau)$  and  $r'(\tau)$  are continuous on  $\tau \in [0, T]$ , hence there exists  $M_r \geq 0$  such that  $||r(\tau)|| \leq M_r$  and  $||r'(\tau)|| \leq M_r$  for all  $\tau \in [0, T]$ . *(i)*  $T_x * \mathcal{O}$  *and*  $T_x * \mathcal{S}$ 

The tangent line of  $\mathcal O$  at  $x^*$  is  $T_{x^*}\mathcal O := \{x^* + \tau \nu \mid \tau \in$ R} as illustrated in Fig. [2.](#page-6-0) Given any  $z \text{ ∈ } T_{x*}S$ , we have  $dist(z, T_{x^*}\mathcal{O}) = inf_{\tau \in \mathbb{R}} ||z - (x^* + \tau \nu)||$  and the point on  $T_{x*}\mathcal{O}$  closest to z can be obtained by projecting the vector  $z - x^*$  along the unit vector  $\nu$ . Specifically, the point on  $T_{x^*}\mathcal{O}$ closest to z is given by  $x^* + \hat{\tau}_{\text{min}}(z)\nu$  with

$$
\hat{\tau}_{\min}(z) = \langle z - x^*, \nu \rangle \quad , \tag{19}
$$

where  $\langle \cdot, \cdot \rangle$  represents the inner product in  $\mathbb{R}^n$ . Consider now the right triangle with vertices at  $x^*$ , z, and  $x^* + \hat{\tau}_{\min}(z)\nu$ . Then,  $||z - (x^* + \hat{\tau}_{\min}(z)\nu)|| = ||z - x^*|| \cdot |\sin(\theta(z))|$ , where

 $\theta(z)$  is the angle between  $z - x^*$  and  $\nu$ . By transversality of O and S at  $x^*$  given by assumption A[.7,](#page-2-8)  $\theta(z)$  will never be 0 or  $\pi$ , so  $\min_{\|z-x^*\|=1} |\sin(\theta(z))| =: \mu$  satisfies  $0 < \mu \leq 1$ . Thus, for all  $z \in T_{x} \mathcal{S}$ , we have

$$
dist(z, T_{x^*}\mathcal{O}) = \inf_{\tau \in \mathbb{R}} ||z - (x^* + \tau \nu)|| = ||z - (x^* + \hat{\tau}_{\min}(z)\nu)||
$$

$$
= ||z - x^*|| \cdot |\sin(\theta(z))| \ge \mu ||z - x^*|| . (20)
$$

*(ii)*  $\mathcal{O}$  *and*  $T_{x^*} \mathcal{S}$ 

Now we extend the result to  $\mathcal O$  and  $T_{x^*} \mathcal S$ . Choose  $\delta > 0$  such that  $z \in B_\delta(x^*) \cap T_{x^*} \mathcal{S}$  implies  $\tau_{\min} < T$  with T as in [\(15\)](#page-5-6) for all  $\tau_{\min} \in \tau_{\min}(z)$ ; Lemma [5](#page-5-10) guarantees that such a  $\delta$  exists. Next, split the set  $B_\delta(x^*) \cap T_{x^*}S$  into two subsets:

(a)  $E_1 := \{ z \in B_\delta(x^*) \cap T_{x^*} \mathcal{S} \mid \exists \tau_{\min} \in \tau_{\min}(z) : \tau_{\min} = 0 \}$ (b)  $E_2 := \{ z \in B_\delta(x^*) \cap T_{x^*} \mathcal{S} \mid \forall \tau_{\min} \in \tau_{\min}(z), \tau_{\min} \neq 0 \}.$ Clearly,  $E_1$  and  $E_2$  are disjoint and  $E_1 \cup E_2 = B_\delta(x^*) \cap T_{x^*} \mathcal{S}.$ If  $z \in E_1$ , then  $0 \in \tau_m(z)$  and thus

<span id="page-6-12"></span>dist(z, O) = 
$$
\inf_{y \in O} ||z - y|| = ||z - y(\tau_{\min})|| = ||z - x^*||
$$
. (21)

For convenience, from here on when we use  $\tau_{\text{min}}$ , it is understood that  $\tau_{\min}$  can be any element of  $\tau_{\min}(z)$ . Also, we will drop the functional dependence of  $\hat{\tau}_{\text{min}}$  on z; see [\(19\)](#page-5-11).

If  $z \in E_2$  then  $\tau_{\min} > 0$  and the vector from z to the nearest point on  $O$  must be orthogonal to the orbit. Hence, we have  $\langle z - y(\tau_{\min}), y'(\tau_{\min}) \rangle = 0$ , which, on using [\(18\)](#page-5-12), gives

$$
\langle z - x^* - \tau_{\min} \nu - \tau_{\min}^2 r(\tau_{\min}),
$$
  

$$
\nu + 2\tau_{\min} r(\tau_{\min}) + \tau_{\min}^2 r'(\tau_{\min}) = 0.
$$
 (22)

Next, we use [\(22\)](#page-6-1) to derive the following important estimate,

$$
\tau_{\min} = \langle z - x^*, \nu \rangle + 2\tau_{\min} \langle r(\tau_{\min}), z - x^* \rangle + \tau_{\min}^2 a(\tau_{\min}, z)
$$
\n(23)  
\nwhere  $a(\tau, z) := \langle r'(\tau), z - x^* \rangle - \langle 3\nu, r(\tau) \rangle - \tau \langle \langle \nu, r'(\tau) \rangle +$   
\n $\langle 2r(\tau), r(\tau) \rangle$ ) -  $\tau^2 \langle r(\tau), r'(\tau) \rangle$ . Since  $r(\tau)$  and  $r'(\tau)$  are  
\nbounded as discussed below (18),  $z \in B_\delta(x^*) \cap T_{x^*} \mathcal{S}$ , and  
\n $\tau_{\min} < T$ , we have, for some constant  $c > 0$ , that

$$
\tau_{\min} \le ||z - x^*|| + c\tau_{\min}(||z - x^*|| + \tau_{\min}). \tag{24}
$$

Using  $\epsilon = 1/(4c)$  in Lemma [5](#page-5-10) there exists a  $\delta < 1/(4c)$ (shrink  $\delta$  if necessary) such that for  $||z - x^*|| < \delta$ , we have  $\tau_{\min}$  < 1/(4*c*). Then from [\(24\)](#page-6-2) we have

<span id="page-6-4"></span>
$$
\tau_{\min} \le 2||z - x^*||. \tag{25}
$$

Next, noting  $\hat{\tau}_{\min} = \langle z - x^*, v \rangle$  by [\(19\)](#page-5-11), from [\(23\)](#page-6-3) we obtain

$$
|\hat{\tau}_{\min} - \tau_{\min}| \le |2\tau_{\min}\langle r(\tau_{\min}), z - x^* \rangle + \tau_{\min}^2 a(\tau_{\min}, z)|
$$
  

$$
\le c(\tau_{\min} || z - x^* || + \tau_{\min}^2)
$$

where the last inequality follows by using bounds similar to those that led to [\(24\)](#page-6-2). Using [\(25\)](#page-6-4) in the above inequality and updating the constant<sup>[7](#page-6-5)</sup>  $c > 0$  accordingly, we have

<span id="page-6-11"></span><span id="page-6-9"></span><span id="page-6-8"></span><span id="page-6-7"></span><span id="page-6-6"></span>
$$
|\hat{\tau}_{\min} - \tau_{\min}| \le c \|z - x^*\|^2 \quad , \tag{26}
$$

provided  $||z - x^*|| < \delta$ .

Turning our attention to  $dist(z, 0)$  and using Lemma [3,](#page-5-0)

$$
\inf_{y \in \mathcal{O}} ||z - y|| = ||z - y(\tau_{\min})||
$$
  
=  $||z - x^* - \tau_{\min} \nu - \tau_{\min}^2 r(\tau_{\min})||$  (27)

$$
= ||z - x^* - \hat{\tau}_{\min} \nu + (\hat{\tau}_{\min} - \tau_{\min})\nu - \tau_{\min}^2 r(\tau_{\min})|| \quad (28)
$$

$$
\geq ||z - x^* - \hat{\tau}_{\min} \nu|| - |\hat{\tau}_{\min} - \tau_{\min}| - \tau_{\min}^2 ||r(\tau_{\min})|| \tag{29}
$$
  
>  $||z - x^*|| - c||z - x^*||^2$  (30)

$$
\geq \mu \|z - x^*\| - c\|z - x^*\|^2 \tag{30}
$$

<span id="page-6-10"></span>where  $(27)$  is obtained by using  $(18)$ ;  $(28)$  is obtained by adding and subtracting  $\hat{\tau}_{\min} \nu$ ; [\(29\)](#page-6-8) is obtained by using the reverse triangle inequality; and [\(30\)](#page-6-9) is obtained by the boundedness of  $r(\tau)$ , [\(20\)](#page-6-10), [\(26\)](#page-6-11), and [\(25\)](#page-6-4). Again we update the constant  $c > 0$  accordingly. Further we can write [\(30\)](#page-6-9) as

$$
\inf_{y \in \mathcal{O}} ||z - y|| \ge (\mu/2) ||z - x^*|| + ||z - x^*|| (\mu/2 - c||z - x^*||).
$$

Choosing  $||z-x^*|| \leq \mu/(2c)$  (shrink  $\delta > 0$  if necessary) gives

<span id="page-6-13"></span>dist(z, O) := 
$$
\inf_{y \in O} ||z - y|| \ge (\mu/2) ||z - x^*||
$$
, (31)

for all  $z \in E_2$ .

Putting together [\(21\)](#page-6-12) and [\(31\)](#page-6-13) for the sets  $E_1$  and  $E_2$ , respectively, and noting that  $\min\{1, \mu/2\} = \mu/2$  as  $\mu/2 \leq$  $1/2 < 1$  (see below [\(19\)](#page-5-11) to recall the meaning of  $\mu$ ) gives

<span id="page-6-15"></span>dist(z, O) := 
$$
\inf_{y \in O} ||z - y|| \ge (\mu/2) ||z - x^*||
$$
, (32)

for all  $z \in B_\delta(x^*) \cap T_{x^*} \mathcal{S}.$ *(iii)*  $O$  *and*  $S$ 

Here, we extend the result to  $x \in B_\delta(x^*) \cap S$ . First, note that if  $x \in S$  is a point in the neighborhood of  $x^*$  and  $z \in T_{x^*}S$ is the projection of x on  $T_{x*}S$ , then Appendix [C](#page-12-1) shows that there exists a constant  $c > 0$  such that

<span id="page-6-14"></span>
$$
||x - z|| \le c||x - x^*||^2 \tag{33}
$$

<span id="page-6-1"></span>Since  $||z - x^*|| = ||z - x + x - x^*|| \le ||x - x^*|| + c||x - x^*||^2$ by the triangle inequality and [\(33\)](#page-6-14), choosing  $x \in S$  so that  $||x - x^*|| < \delta$  for a sufficiently small  $\delta > 0$  ensures that the corresponding  $z$  satisfies [\(32\)](#page-6-15). Then,

<span id="page-6-2"></span>
$$
\inf_{y \in \mathcal{O}} ||x - y|| = \inf_{y \in \mathcal{O}} ||x - z + z - y||
$$
\n
$$
\geq \inf_{y \in \mathcal{O}} ||z - y|| - ||x - z||
$$
\n
$$
\geq (\mu/2) ||z - x^*|| - ||x - z|| \tag{34}
$$
\n
$$
\geq (\mu/2) ||x - x^*|| - (1 + \mu/2) ||x - z|| \tag{35}
$$

<span id="page-6-18"></span><span id="page-6-17"></span><span id="page-6-16"></span>
$$
\geq (\mu/2) \|x - x^*\| - c \|x - x^*\|^2 \quad . \tag{36}
$$

where [\(34\)](#page-6-16) follows from [\(32\)](#page-6-15); [\(35\)](#page-6-17) from the reverse triangle inequality on  $||z - x^*|| = ||z - x + x - x^*||$ ; and [\(36\)](#page-6-18) follows from [\(33\)](#page-6-14) with  $c > 0$  updated accordingly. Write [\(36\)](#page-6-18) as

<span id="page-6-19"></span>
$$
\inf_{y \in \mathcal{O}} ||x - y|| \ge (\mu/4) ||x - x^*|| + ||x - x^*||(\mu/4 - c||x - x^*||),
$$

<span id="page-6-5"></span><sup>7</sup>Intermediate constants of no particular importance are used as  $c$  while updating the meaning of  $c$  as we proceed with the proof.

and choose  $||x - x^*|| \leq \mu/(4c)$ , shrinking  $\delta$  if necessary. The result follows by letting  $\overline{\lambda} = \mu/4 < 1$ .  $\Box$ 

Now we present the proof of Proposition [1,](#page-4-3) which essen-tially extends Lemma [6](#page-5-13) to the entire  $S$ .

*Proof of Proposition [1.](#page-4-3)* The upper bound on  $dist(x, 0)$  in Proposition [1](#page-4-3) follows, for all  $x \in S$ , directly from [\(13\)](#page-5-2).

For the lower bound, we begin by applying Lemma [6](#page-5-13) to establish the existence of  $\delta > 0$  and  $0 < \bar{\lambda} < 1$  such that

$$
dist(x, \mathcal{O}) \ge \bar{\lambda} \|x - x^*\| \quad , \tag{37}
$$

for all  $x \in S$  with  $\|x - x^*\| < \delta$ . To obtain a lower bound that holds for all  $x \in S$ , we first consider the case where S is unbounded; then, the case where  $S$  is bounded follows easily.

Let  $S$  be unbounded and distinguish the following regions. (*i*)  $\mathcal{R}_{\mathrm{I}} := \{x \in \mathcal{S} \mid ||x - x^*|| > \delta' \}$  for  $\delta' > \delta$ We will show that a  $\delta' > \delta$  exists so that for all  $x \in \mathcal{R}_{\mathrm{I}}$  a lower bound for  $dist(x, 0)$  similar to [\(37\)](#page-6-19) can be found. First note that, by the definition [\(2\)](#page-1-7), the surface  $S$  is closed. Furthermore, by assumption A[.6](#page-2-9) we have  $\overline{\mathcal{O}} \cap \mathcal{S} = \{x^*\}$ , and thus the only limit point that  $\mathcal O$  and  $\mathcal S$  share is  $x^*$ . Hence,  $dist(x, \mathcal O) > 0$ for all  $x \in S \setminus \{x^*\}$ , as these points are in the complement of the closure of  $\hat{O}$  in  $\mathbb{R}^n$ , and  $dist(x, \hat{O})/||x - x^*|| > 0$  is well defined for all  $x \in S \setminus \{x^*\}$ . We claim that

<span id="page-7-1"></span>
$$
\lim_{\|x\| \to \infty, \ x \in \mathcal{S} \setminus \{x^*\}} \text{dist}(x, \mathcal{O}) / \|x - x^*\| = 1 \tag{38}
$$

from which it follows easily that there exists  $\delta' > 0$  (expand  $\delta'$  if necessary to ensure  $\delta' > \delta$ ) such that

<span id="page-7-4"></span>
$$
dist(x, O) \ge (1/2) \|x - x^*\| , \qquad (39)
$$

for all  $x \in \mathcal{R}_I$ . To show the claim [\(38\)](#page-7-1), take any  $x \in \mathcal{S} \backslash \{x^*\},$ let  $\tau_{\min} \in \tau_{\min}(x)$  and define  $M_{\mathcal{O}} := \max_{y_1, y_2 \in \overline{\mathcal{O}}} ||y_1 - y_2||$ so that  $||x^* - y(\tau_{\min})|| \leq M_{\mathcal{O}}$ . Then,  $dist(x, \mathcal{O}) := ||x - y||$  $y(\tau_{\min}) \| \geq \|x - x^*\| - \|x^* - y(\tau_{\min})\|$  implies

<span id="page-7-2"></span>
$$
\frac{\text{dist}(x, \mathcal{O})}{\|x - x^*\|} \ge 1 - \frac{\|x^* - y(\tau_{\min})\|}{\|x - x^*\|} \ge 1 - \frac{M_{\mathcal{O}}}{\|x - x^*\|} \quad (40)
$$

and dist(x,  $\mathcal{O}$ ) =  $||x - y(\tau_{\min})|| \le ||x - x^*|| + ||x^* - y(\tau_{\min})||$ implies

<span id="page-7-3"></span>
$$
\frac{\text{dist}(x, \mathcal{O})}{\|x - x^*\|} \le 1 + \frac{\|x^* - y(\tau_{\min})\|}{\|x - x^*\|} \le 1 + \frac{M_{\mathcal{O}}}{\|x - x^*\|} \tag{41}
$$

As a result, for any sequence of points  $x_n \in S \setminus \{x^*\}$  such that  $||x_n - x^*|| \to \infty$ , it follows from [\(40\)](#page-7-2) and [\(41\)](#page-7-3) that

$$
1 \leq \liminf_{n \to \infty} \frac{\text{dist}(x_n, \mathcal{O})}{\|x_n - x^*\|} \leq \limsup_{n \to \infty} \frac{\text{dist}(x_n, \mathcal{O})}{\|x_n - x^*\|} \leq 1,
$$

implying  $\lim_{n\to\infty} \text{dist}(x_n, \mathcal{O})/||x_n - x^*|| = 1$ , which by [\[41,](#page-15-31) Theorem 4.2] proves the claim [\(38\)](#page-7-1).

(*ii*)  $\mathcal{R}_{\text{II}} := \{x \in \mathcal{S} \mid \delta \leq ||x - x^*|| \leq \delta'\}$ 

With  $\delta > 0$  provided by Lemma [6](#page-5-13) and  $\delta' > \delta$  selected as in case *(i)*, let  $\hat{\lambda} := \min_{x \in \mathcal{R}_{\text{II}}} (\text{dist}(x, \mathcal{O}) / ||x - x^*||) > 0$ , which is well defined since  $dist(x, 0) / ||x - x^*|| > 0$  is continuous over the compact set  $\mathcal{R}_{II}$ . Hence,

<span id="page-7-5"></span>
$$
dist(x, \mathcal{O}) \ge \hat{\lambda} \|x - x^*\| \quad , \tag{42}
$$

for all  $x \in \mathcal{R}_{II}$ .

Finally, combining [\(37\)](#page-6-19), [\(39\)](#page-7-4), and [\(42\)](#page-7-5) by choosing  $\lambda =$  $\min\{\overline{\lambda}, 1/2, \overline{\lambda}\}\$ gives

$$
dist(x, \mathcal{O}) := \inf_{y \in \mathcal{O}} ||x - y|| \ge \lambda ||x - x^*||,
$$

for all  $x \in S$ , completing the proof when S is unbounded.

For the case where S is bounded, we can choose  $\delta' > 0$ sufficiently large to ensure that  $S \subset B_{\delta'}(x^*)$ . Then, an argument analogous to that used in *(ii)* above establishes the desired lower bound for this case, thereby completing the proof of Proposition [1.](#page-4-3)  $\Box$ 

# V. PROOF OF THEOREM [1](#page-4-0) AND THEOREM [2](#page-4-1)

<span id="page-7-0"></span>In the proof of Theorem [1,](#page-4-0) we will compare different solutions based on their initial states and inputs. With this in mind, we present the following lemma, which is a straightforward adaptation of [\[34,](#page-15-25) Theorem 3.5] and its proof will be omitted.

<span id="page-7-8"></span>**Lemma 7.** *Suppose* f in [\(1\)](#page-1-1) *satisfies assumption A[.1.](#page-1-3)* Let  $u_1 \in$ U and  $x_1(t)$  be the solution of

$$
\dot{x}(t) = f(x(t), u_1(t)), \quad x_1(0) = a_1 ,
$$

*which exists for all*  $t \in [0, T]$ *. Then, there exists*  $L > 0$  *and*  $\delta > 0$  such that if  $||a_2 - a_1|| < \delta$  and  $||u_2 - u_1||_{\infty} < \delta$ ,

<span id="page-7-9"></span> $\dot{x}(t) = f(x(t), u_2(t)), x_2(0) = a_2$ 

*has a unique solution*  $x_2(t)$  *for all*  $t \in [0, \hat{T}]$ *. Further,* 

$$
||x_1(t) - x_2(t)|| \le e^{L\hat{T}} ||a_1 - a_2|| + (e^{L\hat{T}} - 1)||u_1 - u_2||_{\infty}, \tag{43}
$$

*for all*  $t \in [0, \hat{T}]$ *.* 

The following remark extends the unperturbed (zero-input) solution  $\varphi(t, \Delta(x^*, 0), 0)$  of [\(1\)](#page-1-1) that starts from  $\Delta(x^*, 0)$ .

<span id="page-7-7"></span>**Remark 5.** *By assumption A[.5,](#page-2-2) the solution*  $\varphi(t, \Delta(x^*, 0), 0)$ *of* [\(1\)](#page-1-1) *exists for all*  $t \in [0, T^*]$ *, where*  $T^* = T_1(x^*, 0, 0)$  *is the period of* O*. Hence, by [\[34,](#page-15-25) Theorem 3.1], there exists*  $\overline{T} \in (T^*, \infty)$  so that  $\varphi(t, \Delta(x^*, 0), 0)$  can be extended over *the interval*  $[T^*, \overline{T}]$ . As  $L_f H(\varphi(T^*, \Delta(x^*, 0), 0), 0) < 0$  from  $a$ *ssumption* A[.7](#page-2-8) while  $L_f H(\varphi(t, \Delta(x^*, 0), 0), 0)$  *is continuous in time, it follows that for a sufficiently small*  $\overline{T} > T^*$ *, we can*  $\textit{ensure~L}_f H(\varphi(t,\Delta(x^*,0),0),0) < 0 \textit{ for all } T^* \leq t \leq \overline{T}, \textit{ so }$  $\varphi(t, \Delta(x^*, 0), 0) \in S^-$  over the interval  $(T^*, \overline{T}]$ .

Lemma [8](#page-7-6) below shows that the perturbed solution  $\varphi(t, \Delta(x, v), u)$  of [\(1\)](#page-1-1) is locally well defined over the interval [0,  $\overline{T}$ ] where the unperturbed solution  $\varphi(t, \Delta(x^*, 0), 0)$  can be extended. Moreover, the lemma provides a *linear* upper bound on the distance of  $\varphi(t, \Delta(x, v), u)$  from  $\mathcal O$  that will be used in proving Theorem [1.](#page-4-0) The proof of Lemma [8](#page-7-6) is in Appendix [D.](#page-12-2)

<span id="page-7-6"></span>Lemma 8. *Under the assumptions of Theorem [1,](#page-4-0) there exist*  $\delta > 0$ , and  $\underline{T} > 0$ ,  $\overline{T} > T^*$  with  $T^* = T_1(x^*, 0, 0)$  being the *period of*  $\emptyset$ *, such that for all*  $x \in B_\delta(x^*) \cap \mathcal{S}$ *, u*  $\in \mathcal{U}$  *with*  $\|u\|_{∞} < δ$ , and  $\bar{v} \in V$  with  $\|\bar{v}\|_{∞} < δ$  the following hold

- *(i) The perturbed solution*  $\varphi(t, \Delta(x, v), u)$  *of* [\(1\)](#page-1-1)*, where v is an element of*  $\bar{v}$ *, exists and is unique for*  $t \in [0, \overline{T}]$ *.*
- *(ii) The solution*  $\varphi(t, \Delta(x, v), u)$  *crosses* S *in finite time*  $T_1(x, u, v)$  *given by* [\(6\)](#page-2-7)*, and*  $0 < \underline{T} < T_1(x, u, v) < \overline{T}$ *,*

*where*  $T < T^* < \overline{T}$ *. Moreover, it does so transversally to* S with  $L_f H(\varphi(T_1(x, u, v), \Delta(x, v), u), u) < 0$ . *(iii) There exists a*  $c > 0$  *such that* 

$$
\sup_{0 \le t < T_1} \text{dist}(\varphi(t, \Delta(x, v), u), \mathcal{O}) \le c \|x - x^*\| + c \|u\|_{\infty} + c \|\bar{v}\|_{\infty}.
$$
\n(44)

In proving Theorem [1,](#page-4-0) we will also need Lemma [9](#page-8-0) which is an "orbital" analogue of Lemma [8.](#page-7-6) Lemma [9](#page-8-0) does not require x to be confined on S so that any  $x \in S^+$  can be used, as long as it is sufficiently close to  $\mathcal{O}$ .

<span id="page-8-0"></span>Lemma 9. *Under the assumptions of Theorem [1,](#page-4-0) there exist*  $\delta > 0$  and  $\overline{T} > T^*$  with  $T^* = T_1(x^*, 0, 0)$  being the period of  $O$ , such that for all  $x \in S^+$  with  $dist(x, O) < \delta$  and  $u \in U$ *with*  $||u||_{\infty} < \delta$ , the following hold

- *(i) The perturbed solution*  $\varphi(t, x, u)$  *of* [\(1\)](#page-1-1) *exists and is unique for*  $t \in [0, \overline{T} - \xi]$  *where*  $\xi \in [0, T^*]$ *.*
- (*ii*) The solution  $\varphi(t, x, u)$  *crosses* S in finite time  $\hat{T}_I(x, u)$ given by [\(8\)](#page-3-9), and  $0 < \hat{T}_I(x, u) < \overline{T}$ . Moreover, it does so *transversally to* S *with*  $\hat{L}_f H(\varphi(\hat{T}_I(x,u),x,u),u) < 0$ .
- *(iii) There exists a*  $c > 0$  *such that*

$$
\sup_{0 \le t < \hat{T}_1} \text{dist}(\varphi(t, x, u), \mathcal{O}) \le c \, \text{dist}(x, \mathcal{O}) + c \|u\|_{\infty}.\tag{45}
$$

The proof of Lemma [9](#page-8-0) is similar to the proof of Lemma [8,](#page-7-6) albeit more technical as it requires the construction of a suitable open cover for  $\overline{O}$ ; thus, it is relegated to Appendix [D.](#page-12-2)

Now we are ready to provide the proof of Theorem [1.](#page-4-0)

*Proof of Theorem [1.](#page-4-0)* We first show (i)  $\implies$  (ii) and then (ii)  $\implies$  (i) by explicitly constructing class- $\mathcal{KL}$  and class- $\mathcal{KL}$ functions to satisfy Definitions [1](#page-3-4) and [3.](#page-3-6) To avoid ambiguity in notation, we use  $x(0) \in \mathbb{R}^n$  as the initial condition for the system with impulse effects [\(4\)](#page-1-5) and  $x_0 \in S$  as the initial condition for the discrete system [\(7\)](#page-3-0).

 $(i) \implies (ii)$ 

Assume that  $\mathcal O$  is a LISS orbit of [\(4\)](#page-1-5), and let  $x(t)$  =  $\psi(t, x(0), u, \bar{v})$  be a solution of [\(4\)](#page-1-5) that satisfies Definition [1](#page-3-4) for some  $\delta_{\Sigma} > 0$  and for suitable functions  $\alpha_1, \alpha_2 \in \mathcal{K}$ ,  $\beta \in \mathcal{KL}$ . Choose  $\delta_{\Sigma}$  sufficiently small to further ensure that Lemma [9](#page-8-0) is satisfied. Then,  $t_0 := \hat{T}_I(x(0), u)$  is finite, and  $x_0 := \lim_{t \nearrow t_0} x(t)$  is well-defined. On arriving at S, the solution jumps to  $x(t_0) = \Delta(x_0, v_0)$  where  $v_0$  is the first element of the sequence  $\bar{v}$ . However, to establish the estimate [\(10\)](#page-3-10) in Definition [3](#page-3-6) we need  $x_0$  to appear in the RHS instead of  $x(t_0)$ . To do this we will use the fact that, by assumption A[.3,](#page-1-9) the map  $\Delta$  is continuously differentiable and thus locally Lipschitz. Hence, there exists a  $\delta_{\Delta} > 0$  for which the Lipschitz condition holds uniformly for all  $x \in B_{\delta_{\Delta}}(x^*) \cap S$  and  $\|\bar{v}\|_{\infty} < \delta_{\Delta}$  for some constant  $L_{\Delta} > 0$ , so that

$$
dist(\Delta(x_0, v_0), \mathcal{O}) = dist(\Delta(x_0, v_0), \mathcal{O}) - dist(\Delta(x^*, 0), \mathcal{O})
$$
  
\n
$$
\leq \|\Delta(x_0, v_0) - \Delta(x^*, 0)\|
$$
  
\n
$$
\leq L_{\Delta}(\|x_0 - x^*\| + \|\bar{v}\|_{\infty}),
$$
\n(46)

where we used  $dist(\Delta(x^*,0), \mathcal{O}) = 0$  and the fact that  $dist(\cdot, \mathcal{O})$  is Lipschitz continuous with constant equal to 1. Finally, to guarantee that the time to impact is well defined for subsequent intersections of  $x(t)$  with S, choose  $\delta_T > 0$  so that Lemma [8](#page-7-6) is satisfied for  $\underline{T} > 0$  and  $\overline{T} > T^*$ .

<span id="page-8-2"></span>Now we refine the selection of  $\delta$  so that the aforementioned properties hold uniformly along the entire orbit. Pick  $0 < \delta <$  $\min\{\delta_{\Sigma}, \delta_{T}, \delta_{\Delta}\}\$  sufficiently small to also ensure that  $\beta(\delta, 0)$ +  $\alpha_1(\delta) + \alpha_2(\delta) < \min{\{\delta_{\Sigma}, \lambda \delta_{T}, \lambda \delta_{\Delta}\}}$ ; here, by Proposition [1,](#page-4-3)  $\lambda \in (0,1)$  is a constant such that [\(11\)](#page-4-6) holds for all  $x \in S$ . Then, for  $dist(x(0), \mathcal{O}) < \delta$ ,  $||u||_{\infty} < \delta$ , and  $||\bar{v}||_{\infty} < \delta$ ,

$$
dist(x(t), \mathcal{O}) \leq \beta dist(x(0), \mathcal{O}), t) + \alpha_1(||u||_{\infty}) + \alpha_2(||\bar{v}||_{\infty})
$$
  
\n
$$
\leq \beta(\delta, 0) + \alpha_1(\delta) + \alpha_2(\delta)
$$
  
\n
$$
< \min{\delta_{\Sigma}, \lambda \delta_{T}, \lambda \delta_{\Delta}}
$$

for all  $t \geq 0$ . Now, by continuity of the distance function,  $\lim_{t \nearrow t_k} \text{dist}(x(t), \mathcal{O}) = \text{dist}(x_k, \mathcal{O})$ , and this choice of  $\delta > 0$ ensures that  $dist(x_k, O) < \lambda \delta_{\Delta}$ . Hence, by Proposition [1,](#page-4-3) we get  $||x_k - x^*|| < \delta_\Delta$  for all  $k \in \mathbb{Z}_+$  and, since this  $\delta$  also guarantees  $\|\bar{v}\|_{\infty} < \delta_{\Delta}$ , the bound [\(46\)](#page-8-1) holds for all  $k \in$  $\mathbb{Z}_+$ . Similarly, this choice of  $\delta$  ensures  $||x_k - x^*|| < \delta_T$  for all  $k \in \mathbb{Z}_+$ , ensuring that  $\underline{T} < T_1(x_k, u_k, v_k) < \overline{T}$  uniformly for all  $k \in \mathbb{Z}_+$ . Finally, this  $\delta$  guarantees that  $dist(x_0, \mathcal{O}) < \delta_{\Sigma}$ , allowing the use of [\(9\)](#page-3-5) with the same  $\beta$ ,  $\alpha_1$ ,  $\alpha_2$  as above. Putting all these together, for all  $k \in \mathbb{Z}_+$  we can write

$$
||x_k - x^*||
$$
  
\n
$$
\leq \lambda^{-1} \text{dist}(x_k, \mathcal{O})
$$
  
\n
$$
\leq \lambda^{-1} (\beta(\text{dist}(\Delta(x_0, v_0), \mathcal{O}), t_k - t_0) + \alpha_1(||u||_{\infty})
$$
  
\n
$$
+ \alpha_2(||\bar{v}||_{\infty}))
$$
  
\n
$$
\leq \lambda^{-1} (\beta(L_{\Delta}(|x_0 - x^*|| + ||\bar{v}||_{\infty}), t_k - t_0) + \alpha_1(||u||_{\infty})
$$
  
\n
$$
+ \alpha_2(||\bar{v}||_{\infty}))
$$
  
\n
$$
\leq \lambda^{-1} (\beta(2L_{\Delta}||x_0 - x^*||, t_k - t_0) + \alpha_1(||u||_{\infty})
$$
  
\n
$$
+ \alpha_2(||\bar{v}||_{\infty}))
$$
  
\n
$$
\leq \lambda^{-1} (\beta(2L_{\Delta}||x_0 - x^*||, k\underline{T}) + \alpha_1(||u||_{\infty}) + \alpha_2(||\bar{v}||_{\infty}))
$$
,

where the first inequality follows from Proposition [1;](#page-4-3) the second from [\(9\)](#page-3-5) with the solution starting from  $\Delta(x_0, v_0)$ ; the third from [\(46\)](#page-8-1); the fourth follows by [\[42,](#page-15-32) Lemma 14] on  $\beta(L_{\Delta}(\Vert x_0 - x^* \Vert + \Vert \bar{v} \Vert_{\infty}), t_k - t_0)$  followed by absorbing the  $\|\bar{v}\|_{\infty}$  term in  $\alpha_2$ ; and the last inequality follows from the fact that  $\beta$  is monotonically decreasing in time and  $t_{k+1} - t_k = T_1(x_k, u_k, v_k) \geq T$  for all  $k \in \mathbb{Z}_+$ . Noting that  $(1/\lambda)\beta \in \mathcal{KL}$ ,  $(1/\lambda)\alpha_1 \in \mathcal{K}$  and  $(1/\lambda)\alpha_2 \in \mathcal{K}$ , and comparing the last inequality with [\(10\)](#page-3-10), we get that the solution of [\(7\)](#page-3-0) satisfies Definition [3,](#page-3-6) thus completing the proof.  $(ii) \Longrightarrow (i)$ 

Assume that  $x^*$  is a LISS fixed point of [\(7\)](#page-3-0), and let  $\{x_k\}_{k \in \mathbb{Z}_+}$ with  $x_k \in S$  for all  $k \in \mathbb{Z}_+$  be a solution of [\(7\)](#page-3-0) that satisfies Definition [3](#page-3-6) for some  $\delta_1 > 0$ . Then, for  $x_0 \in B_{\delta_1}(x^*) \cap S$ ,  $\|u\|_{\infty} < \delta_1$ , and  $\|\bar{v}\|_{\infty} < \delta_1$ , there exist suitable functions  $\alpha_1, \alpha_2 \in \mathcal{K}, \beta \in \mathcal{KL}$  such that [\(10\)](#page-3-10) is satisfied. This implies  $||x_k - x^*|| \leq \beta(\delta_1, 0) + \alpha_1(\delta_1) + \alpha_2(\delta_1)$  for all  $k \in \mathbb{Z}_+,$ and thus  $\delta_1$  can be chosen (shrinking it if necessary) so that Lemma [8](#page-7-6) is satisfied for  $\varphi(t, \Delta(x_k, v_k), u_k)$  *for all* integers  $k \geq 0$ . Then, there exist  $\overline{T}_1 > T^*$  (obtained as in Remark [5\)](#page-7-7) so that  $T_1(x_k, u_k, v_k) < T_1$  for all  $k \in \mathbb{Z}_+$ .

<span id="page-8-1"></span>The setting above provides a uniform (over  $k$ ) upper bound  $\overline{T}_1$  to the impact times  $T_1(x_k, u_k, v_k)$  defining the intervals  $[t_k, t_{k+1})$ , where  $t_{k+1} = t_k + T_1(x_k, u_k, v_k)$  for  $k \in \mathbb{Z}_+$ . However, to establish a relation between the discrete-time solution of [\(7\)](#page-3-0) and the continuous-time solution [\(4\)](#page-1-5), we also need to address the interval  $[0, t_0)$ . By Lemma [9,](#page-8-0) there exists  $\delta > 0$  such that, if  $x(0) \in S^+$  satisfies  $dist(x(0), \mathcal{O}) < \delta$  and  $u \in \mathcal{U}$  satisfies  $||u||_{\infty} < \delta$ , the solution crosses S in finite time  $t_0 := \hat{T}_1(x(0), u)$ , and there exists a bound  $\overline{T}_2 > T^*$  so that  $t_0 < T_2$ . We need to make sure that  $\delta$  can be selected in a way that  $x_0$  satisfies  $||x_0 - x^*|| < \delta_1$  so that Lemma [8](#page-7-6) continues to hold. As before, let  $x(t) = \psi(t, x(0), u, \bar{v})$ ; see Remark [1](#page-3-2) for the form of  $x(t)$  over the intervals  $[t_k, t_{k+1})$ . From Lemma [9](#page-8-0)*(iii)* we have

$$
\sup_{0 \le t < t_0} \text{dist}(x(t), \mathcal{O}) \le c_1 \text{dist}(x(0), \mathcal{O}) + c_1 \|u\|_{\infty} \quad (47)
$$

for some  $c_1 > 0$ , which since  $x_0 := \lim_{t \nearrow t_0} x(t)$  and the function  $dist(x, 0)$  is continuous in x, implies that

<span id="page-9-0"></span>
$$
dist(x_0, \mathcal{O}) \le c_1 dist(x(0), \mathcal{O}) + c_1 \|u\|_{\infty} . \qquad (48)
$$

Since  $x_0 \in S$ , Proposition [1](#page-4-3) implies  $\lambda ||x_0 - x^*|| \leq \text{dist}(x_0, \mathcal{O})$ for  $\lambda \in (0,1)$ , and by [\(48\)](#page-9-0) we have  $\lambda \|x_0 - x^*\| \leq$  $c_1$ dist $(x(0), \mathcal{O}) + c_1 \|u\|_{\infty} < 2c_1\delta$ . Hence, by the inequality above, choosing  $\delta < \min{\{\delta_1, \lambda \delta_1/(2c_1)\}}$  in Lemma [9](#page-8-0) ensures that Lemma [8](#page-7-6) continues to hold. Furthermore, in what follows, we define  $\overline{T} := \max{\{\overline{T}_1, \overline{T}_2\}}$ .

The analysis above shows that, under the assumption of  $x^*$ being a LISS fixed point of [\(7\)](#page-3-0), there exist a  $\delta > 0$  such that, for  $x(0) \in S^+$  with  $dist(x(0), \mathcal{O}) < \delta$  and for  $u \in \mathcal{U}$  with  $||u||_{\infty} < \delta$ , Lemma [9](#page-8-0) implies  $t_0 < \overline{T}$  where  $t_0 := \hat{T}_I(x(0), u)$ , and that the solution satisfies the bound [\(47\)](#page-9-1). If, in addition,  $\bar{v} \in \mathcal{V}$  with  $\|\bar{v}\|_{\infty} < \delta$ , Lemma [8](#page-7-6) implies  $t_{k+1} - t_k < \overline{T}$  with  $t_{k+1} = t_k + T_1(x_k, u_k, v_k)$  for all  $k \in \mathbb{Z}_+$ . In this case, the solution satisfies the bound

$$
\sup_{t_k \le t < t_{k+1}} \text{dist}(x(t), \mathcal{O}) \le c_2 \|x_k - x^*\| + c_2 \|u\|_{\infty} + c_2 \|\bar{v}\|_{\infty},\tag{49}
$$

for some  $c_2 > 0$  and for all  $k \in \mathbb{Z}_+$ . Substituting [\(10\)](#page-3-10) in [\(49\)](#page-9-2), and (for compactness of notation) defining  $\alpha(u, \bar{v}) :=$  $\hat{\alpha}_1(\|u\|_{\infty}) + \hat{\alpha}_2(\|\bar{v}\|_{\infty})$  with  $\hat{\alpha}_1(\|u\|_{\infty}) := c_2\alpha_1(\|u\|_{\infty}) +$  $c_2||u||_{\infty}$  and  $\hat{\alpha}_2(||\bar{v}||_{\infty}) := c_2\alpha_2(||\bar{v}||_{\infty}) + c_2||\bar{v}||_{\infty}$ , results in

$$
dist(x(t), \mathcal{O}) \le c_2 \beta(\|x_0 - x^*\|, k) + \alpha(u, \bar{v})
$$
  
 
$$
\le c_2 \beta(\text{dist}(x_0, \mathcal{O})/\lambda, k) + \alpha(u, \bar{v})
$$
 (50)

for all  $t_k \le t < t_{k+1}$  and  $k \in \mathbb{Z}_+$ . Note that [\(50\)](#page-9-3) was obtained by using Proposition [1](#page-4-3) for  $\lambda \in (0, 1)$ .

With this information, we now construct suitable class- $K$ and class- $KL$  functions to prove that the orbit  $O$  is LISS in the system [\(4\)](#page-1-5). We distinguish the following cases.

*Case (a):*  $t \in [t_k, t_{k+1})$  for any  $k \geq 1$ .

By Remark [1](#page-3-2) we have that  $t_{k+1} \leq (k+2)\overline{T}$ . Pick  $c_3 > 0$ such that for all  $k \geq 1$ ,  $c_3(k+2)\overline{T} \leq k$ . This can be ensured by selecting  $c_3 \leq 1/(3T)$ . Using this in [\(50\)](#page-9-3) implies

$$
dist(x(t), \mathcal{O}) \le c_2 \beta \left(\text{dist}(x_0, \mathcal{O})/\lambda, c_3(k+2)T\right) + \alpha(u, \bar{v})
$$
  

$$
\le c_2 \beta \left(\text{dist}(x_0, \mathcal{O})/\lambda, c_3 t\right) + \alpha(u, \bar{v}) , \qquad (51)
$$

which is obtained by using the fact  $t < t_{k+1} \leq (k+2)\overline{T}$ . The estimate [\(51\)](#page-9-4) holds for all  $k \in \mathbb{Z}_+$  with  $k \geq 1$ , and thus it holds for all  $t \geq t_1$ .

*Case (b):*  $t \in [t_k, t_{k+1})$  for  $k = 0$ . Choose  $\gamma := \ln(2)/(2\overline{T})$  so that  $c_2\beta(\text{dist}(x_0,\mathcal{O})/\lambda, 0) \leq$  $2c_2\beta(\text{dist}(x_0,\mathcal{O})/\lambda,0)e^{-\gamma t}$  over the interval  $[t_0, t_0 + \overline{T}) \subset$ [0, 2T]. Then, since  $t_1 < t_0 + \overline{T}$ , the estimate [\(50\)](#page-9-3) implies that, for all  $t \in [t_0, t_1)$ ,

dist
$$
(x(t), \mathcal{O}) \leq c_2 \beta(\text{dist}(x_0, \mathcal{O})/\lambda, 0) + \alpha(u, \bar{v})
$$
  
 $\leq 2c_2 \beta(\text{dist}(x_0, \mathcal{O})/\lambda, 0) e^{-\gamma t} + \alpha(u, \bar{v})$ . (52)

Now we can combine the estimates [\(51\)](#page-9-4) and [\(52\)](#page-9-5) to obtain a bound for all  $t > t_0$  of the distance from  $\mathcal O$  of a solution starting from  $x_0$  at time  $t_0$ . Note that the function

<span id="page-9-5"></span>
$$
\hat{\beta}(\text{dist}(x_0, \mathcal{O}), t) := c_2 \max\{2\beta(\text{dist}(x_0, \mathcal{O})/\lambda, 0)e^{-\gamma t}, \beta(\text{dist}(x_0, \mathcal{O})/\lambda, c_3 t)\},
$$

is continuous, monotonically increasing in  $dist(x_0, O)$ , and monotonically decreasing in  $t$  because the individual functions in the max have the same properties; hence,  $\beta \in \mathcal{KL}$ . Upper bounding [\(51\)](#page-9-4) and [\(52\)](#page-9-5) with  $\hat{\beta}$  and remembering that  $\alpha(u, \bar{v}) := \hat{\alpha}_1(||u||_{\infty}) + \hat{\alpha}_2(||\bar{v}||_{\infty})$  results in

$$
dist(x(t), \mathcal{O}) \leq \hat{\beta}(\text{dist}(x_0, \mathcal{O}), t) + \hat{\alpha}_1(\|u\|_{\infty}) + \hat{\alpha}_2(\|\bar{v}\|_{\infty}),
$$
\n(53)

which holds for all  $t \geq t_0$ .

To complete the proof of this case, we need an estimate in which the class- $\mathcal{KL}$  function in the RHS of [\(53\)](#page-9-6) depends on dist(x(0), O) and not dist(x<sub>0</sub>, O); recall that x(0) is the initial state of the solution of [\(4\)](#page-1-5), i.e.,  $\psi(t, x(0), u, \bar{v})$ , while  $x_0$  is the first intersection of  $\psi$  with S. To remedy this, use [\(48\)](#page-9-0) noting that  $\hat{\beta}$ (dist(x<sub>0</sub>, O), t) in [\(53\)](#page-9-6) is a class-K function for any fixed  $t$ , followed by [\[42,](#page-15-32) Lemma 14] to get

$$
\hat{\beta}(\text{dist}(x_0, \mathcal{O}), t) \leq \hat{\beta}(c_1 \text{dist}(x(0), \mathcal{O}) + c_1 \|u\|_{\infty}, t)
$$
  
\n
$$
\leq \hat{\beta}(2c_1 \text{dist}(x(0), \mathcal{O}), t) + \hat{\beta}(2c_1 \|u\|_{\infty}, t)
$$
  
\n
$$
\leq \hat{\beta}(2c_1 \text{dist}(x(0), \mathcal{O}), t) + \hat{\beta}(2c_1 \|u\|_{\infty}, 0).
$$

Use this inequality in [\(53\)](#page-9-6) and with an abuse of notation absorb the second term of the above inequality in  $\hat{\alpha}_1(\|u\|_{\infty})$  to obtain

$$
(x(t), \mathcal{O}) \leq \hat{\beta}(2c_1 \text{dist}(x(0), \mathcal{O}), t)
$$
  
  $+ \hat{\alpha}_1(||u||_{\infty}) + \hat{\alpha}_2(||\bar{v}||_{\infty})$ . (54)

<span id="page-9-3"></span>However, [\(54\)](#page-9-7) merely holds for  $t \ge t_0$  and not for all  $t \ge 0$ . To address this issue we consider the following case.

*Case* (*c*):  $t \in [0, t_0)$ .

We use the bound [\(47\)](#page-9-1), which is a consequence of Lemma [9.](#page-8-0) Employing a trick similar to the one used for constructing the class KL function in *Case (b)*, let<sup>[8](#page-9-8)</sup>  $\gamma := \ln(2)/(2\overline{T})$ . Then,  $c_1\mathrm{dist}(x(0),\mathcal{O}) \leq 2c_1\mathrm{dist}(x(0),\mathcal{O})e^{-\gamma t}$  over the interval  $[0, \overline{T}]$ . Then, since  $t_0 \leq \overline{T}$ , [\(47\)](#page-9-1) gives for  $t \in [0, t_0)$ ,

dist(x(t), \mathcal{O}) \le 2c_1 dist(x(0), \mathcal{O})e^{-\gamma t} + c_1 \|u\|_{\infty} . \quad (55)
$$

We now combine the bound [\(54\)](#page-9-7) for  $t \geq t_0$  with the bound [\(55\)](#page-9-9) for  $t \in [0, t_0)$  to construct class- $\mathcal{KL}$  and class- $\mathcal K$  functions that satisfy Definition [1.](#page-3-4) Indeed, defining

$$
\tilde{\beta}(\text{dist}(x(0),\mathcal{O}),t) := \max\{2c_1\text{dist}(x(0),\mathcal{O})e^{-\gamma t},\
$$

$$
\hat{\beta}(2c_1\text{dist}(x(0),\mathcal{O}),t)\},
$$

and  $\tilde{\alpha}_1(\|u\|_{\infty}) := \hat{\alpha}_1(\|u\|_{\infty}) + c_1\|u\|_{\infty}$  and  $\tilde{\alpha}_2(\|\bar{v}\|_{\infty}) :=$  $\hat{\alpha}_2(\|\bar{v}\|_{\infty})$  implies that the solution  $x(t)$  satisfies Definition [1](#page-3-4) for all  $t \geq 0$ , thereby completing the proof of Theorem [1.](#page-4-0)  $\Box$ 

Next, we present a proof of Corollary [1.](#page-4-7)

*Proof of Corollary [1.](#page-4-7)* The proof is identical to that of Theo-rem [1](#page-4-0) with  $u \equiv 0$ ,  $\bar{v} \equiv 0$ . Ony note that in proving (ii)  $\Longrightarrow$  (i) we choose  $\omega > 0$  such that  $\rho = e^{-\omega T}$  as in Definition [4.](#page-3-8)

Finally, we present the proof of Theorem [2.](#page-4-1)

*Proof of Theorem [2.](#page-4-1)* The proof of  $(i) \implies (ii)$  trivially follows by substituting  $u = 0$  and  $v = 0$  in Definition [3](#page-3-6) to recover Definition [4](#page-3-8) that establishes LAS. For  $(ii) \implies (i)$ , we assume that  $x^*$  is a LAS fixed point of the 0-input system. By [\[43,](#page-15-33) Theorem  $1(1)$ ], there exists a smooth (discrete) Lyapunov function  $V : \mathbb{R}^n \to \mathbb{R}_+$  so that for all  $x \in B_\delta(x^*) \cap \mathcal{S}$ ,

V(P(x,0,0)) - V(x) \le -\alpha(||x - x^*||) , \qquad (56)
$$

with  $\alpha \in \mathcal{K}$ . Since V is smooth and P is continuously differentiable,  $V \circ P : \mathcal{S} \times \mathcal{U} \times \mathbb{R}^q \to \mathbb{R}_+$  is locally Lipschitz, and  $\delta > 0$  can be chosen (shrink if necessary) so that the Lipschitz condition holds uniformly for some  $L_{PV} > 0$  for all  $x \in B_\delta(x^*) \cap \mathcal{S}$ ,  $u \in \mathcal{U}$ ,  $||u||_{\infty} < \delta$ , and  $v \in B_\delta(0)$ . Then,

$$
V(P(x, u, v)) - V(x) = V(P(x, 0, 0)) - V(x)
$$
  
+ 
$$
V(P(x, u, v)) - V(P(x, 0, 0))
$$
  
\$\leq -\alpha(||x - x^\*||) + L\_{PV}||u||\_{\infty} + L\_{PV}||\overline{v}||\_{\infty} , \quad (57)\$

where the inequality follows from [\(56\)](#page-10-1) and the Lipschitz continuity of  $V \circ P$ . Hence, V is a LISS Lyapunov function as required by [\[23,](#page-15-13) Definition 3.2] and from [\[43,](#page-15-33) Lemma 3.5] it follows that the system is LISS.  $\Box$ 

#### VI. EXAMPLE: LISS OF A BIPEDAL WALKER

<span id="page-10-0"></span>This section presents an example of applying Theorems [1](#page-4-0) and [2](#page-4-1) to establish ISS for a periodic walking gait for the biped of Fig. [3.](#page-10-2) The model is underactuated, having five degrees of freedom (DOF) and four actuators; two actuators are placed at the knees and two at the hip. Ground contact is modeled as a passive pivot. More details about the model along with the mechanical properties used here can be found in [\[4,](#page-14-3) Table 6.3].

As shown in Fig. [3,](#page-10-2) we choose  $q := (q_1, q_2, q_3, q_4, q_5)$ as coordinates for the configuration space Q. Let Γ be the actuator inputs and  $F_e \in \mathcal{F} := \{F_e : \mathbb{R}_+ \to \mathbb{R}^2 \mid ||F_e||_{\infty} <$  $\infty$ ,  $F_e$  is continuous} be an external force acting at the torso as shown in Fig. [3.](#page-10-2) Further, let  $x \in \mathcal{TQ} := \{(q, \dot{q}) \mid q \in$  $Q, \, \dot{q} \in \mathbb{R}^5$  be the state. The swing phase dynamics is

$$
\dot{x} = f(x) + g(x)\Gamma + g_{e}(x)F_{e} . \qquad (58)
$$

This phase terminates when the swing foot makes contact with the ground. This occurs when  $x \in S := \{(q, \dot{q}) \in$

 $\mathcal{TQ} \mid p_{v}(q) = 0$ , where  $p_{v}(q)$  is the height of the swing foot from the ground. The ensuing impact map  $\Delta$  takes the states  $x^-$  just before to the states  $x^+$  just after impact, under the influence of an impulsive disturbance  $F_I \in \mathbb{R}^2$  applied at the same point as  $F_e$ . The resulting system takes the form

in which  $\Delta$  is smooth. Note that  $F_e$  and  $F_I$  are viewed as continuous and discrete disturbances, respectively. There is a variety of methods available for designing control laws  $\Gamma(x)$ that result in asymptotically stable limit-cycle gaits in the absence of the disturbances; here, we use the method in [\[17\]](#page-15-8).

Let  $\bar{F}_I := \{F_{I,k}\}_{k=0}^{\infty}$  be the sequence of impulsive disturbances and  ${F_{e,k}}_{k=0}^{\infty}$  be the sequence of continuous inputs as in Section [II-C.](#page-2-11) Then, [\(59\)](#page-10-3) in closed loop with  $\Gamma(x)$ , gives rise to the forced Poincaré map  $P : \mathcal{S} \times \mathcal{F} \times \mathbb{R}^2 \to \mathcal{S}$

x_{k+1} = P(x_k, F_{e,k}, F_{I,k}) \t{60}
$$

which captures the dynamics of  $(59)$  as it goes through S. A simple calculation shows that all the eigenvalues of the linearization of the Poincaré map about a 0-input fixed point  $x^*$  are within the unit disk so that  $x^*$  is LAS. Then, Theorem [2](#page-4-1) implies that  $x^*$  is a LISS fixed point of the forced Poincaré map [\(60\)](#page-10-4) and Theorem [1](#page-4-0) ensures that the corresponding periodic orbit  $\mathcal O$  is LISS in the presence of disturbances.

Figure [4](#page-11-1) shows the behavior of the model when  $F_e$  is a horizontal sinusoidal force and  $\bar{F}_I$  consists of horizontal impulses  $\bar{F}_{I,k}$  uniformly sampled from the interval  $[-\|\bar{F}_{I}\|_{\infty},\|\bar{F}_{I}\|_{\infty}]$ for a predetermined  $\|\bar{F}_{I}\|_{\infty} < \infty$ . It can be seen that the solution  ${x_k}_{k=0}^{\infty}$  of [\(60\)](#page-10-4) in Fig. [4\(a\)](#page-11-2) as well as the solution  $x(t) = \psi(t, x(0), F_e, \bar{F}_1)$  of [\(59\)](#page-10-3) in Fig. [4\(b\),](#page-11-3) asymptotically converge to 0 in the absence of disturbances (blue); are ultimately bounded when  $||F_e||_{\infty} = 5$  N,  $||\overline{F}_I||_{\infty} = 0.1$  N.s (gray) and  $||F_e||_{\infty} = 10$  N,  $||\overline{F}_I||_{\infty} = 0.2$  N.s (red), with the ultimate bound for the former being smaller than that of the latter, indicating LISS behavior.

## VII. CONCLUSION

This paper presents a method for analyzing robustness of limit cycles exhibited by systems with impulse effects. It is

shown that ISS of the limit cycle is equivalent to that of the forced Poincaré map. This result allows us to analyze the robustness of *hybrid* limit cycles by merely analyzing a discrete dynamical system. The proof of this result, provides ISS estimates that could be used to quantify the robustness. Furthermore, exploiting the availability of these estimates, we establish an equivalence between ES of the limit cycle and the 0-input Poincaré map. The overarching goal of this work is to develop a framework within which the robustness of periodic orbits can be rigorously analyzed.

## <span id="page-11-0"></span>APPENDIX A

This appendix provides proofs to Lemmas [1](#page-2-6) and [2](#page-2-5) and to Proposition [2,](#page-4-4) clarifying properties of the forced solution  $\varphi(t, x(0), u)$  of [\(1\)](#page-1-1) and  $\psi(t, x(0), u, \overline{v})$  of [\(4\)](#page-1-5).

*Proof of Lemma [1.](#page-2-6)* The proof relies on [\[37,](#page-15-28) Theorem 5.2, p. 377]. To apply this result, define  $F: \mathbb{R}_+ \times \mathbb{R}^n \times \mathcal{U} \to \mathbb{R}^n$  as  $F(t, x, u) := f(x, G(t, u))$ , where  $G$  :  $\mathbb{R}_+ \times U \rightarrow \mathbb{R}^p$  is  $G(t, u) = u(t)$ . Then, [\[37,](#page-15-28) Theorem 5.2, p. 377] states that  $\varphi$  is continuously differentiable in  $x$  and  $u$  if  $F$  is so. Note that, in view of the procedure in [\[37,](#page-15-28) p. 369] for treating time-dependent vector fields, the statement of [\[37,](#page-15-28) Theorem 5.2, p. 377] would require  $F$  to be continuously differentiable in  $t$ . However, the proof of [\[37,](#page-15-28) Theorem 5.2, p. 377] *only* uses continuity of  $F$  in  $t$ . Hence, below we show that  $F$  is continuously differentiable in  $x$  and  $u$ , but only continuous in  $t$ .

We begin by showing that  $G$  is continuous in  $t$  and continuously differentiable in  $u$ . Continuity of  $G$  in  $t$  is clear. Continuity of G in  $u \in \mathcal{U}$  follows from the fact that  $\hat{G} : \mathcal{U} \to \mathbb{R}^p$ defined by  $G(u) := G(t, u) = u(t)$  is bounded and linear for each *fixed* time  $t \in \mathbb{R}_+$ ; by [\[44,](#page-15-34) p. 257, Theorem 1] this implies that  $\tilde{G}$  is continuous in u, thus G is also continuous in u. Indeed, linearity is immediate by the definition of  $\tilde{G}$ , while boundedness follows from  $\|\tilde{G}(u)\| = \|u(t)\| < \|u\|_{\infty}$ , implying that the operator norm is upper bounded by 1 for any  $t \in \mathbb{R}_+$ . As a result,  $G(t, u)$  is continuous in both arguments. Furthermore,  $G$  is linear with respect to  $u$ , and using  $[37, p. 339, Theorem 3.1]$  $[37, p. 339, Theorem 3.1]$ , we have that the Fréchet (partial) derivative of  $G$  with respect to  $u$  is continuous, for it <span id="page-11-3"></span>is G itself. Thus,  $G(t, u)$  is continuous in t and continuously differentiable in  $u$ . Using this fact with the assumption that  $f$ is continuously differentiable, it follows that  $F$  is continuous in t and continuously differentiable in  $(x, u)$ . The result then follows from [\[37,](#page-15-28) Theorem 5.2, p. 377].  $\Box$ 

*Proof of Lemma [2.](#page-2-5)* Before proceeding with the proof, note that even though the domain of  $T_1$  is restricted to  $S \times U \times \mathbb{R}^q$ ,  $T_I$  is well-defined on  $\mathbb{R}^n \times \mathcal{U} \times \mathbb{R}^q$  since  $\Delta$  and  $\varphi$  are welldefined maps for any  $x \in \mathbb{R}^n$ . Hence, we will consider this extended domain of  $T<sub>I</sub>$  in the proof, which follows from the implicit mapping theorem [\[37,](#page-15-28) Chapter XIV, Theorem 2.1].

Let  $\tilde{H}(t, x, u, v) := H \circ \varphi(t, \Delta(x, v), u)$  where  $x \in \mathbb{R}^n$ ,  $u \in \mathcal{U}$ , and  $v \in \mathbb{R}^q$ . From Lemma [1](#page-2-6) in Appendix [A,](#page-11-0) we have that the solution  $\varphi$  is continuously differentiable in all its arguments in the Fréchet sense. Using this with assumption A[.2](#page-1-8) we have that  $\hat{H}$  is continuously differentiable. From assumption A[.5](#page-2-2) it follows that  $\tilde{H}(T^*, x^*, 0, 0) = 0$ . Further, from assumption A[.7](#page-2-8) we have  $\partial \tilde{H}/\partial t|_{(T^*,x^*,0,0)} \neq 0$ . Next, noting that  $(\mathbb{R}^n \times \mathbb{R}^q, \| \cdot \|)$  and  $(\mathcal{U}, \| \cdot \|_{\infty})$  are Banach spaces, we can use [\[37,](#page-15-28) Chapter XIV, Theorem 2.1] to establish the existence of a unique map  $T_1(x, u, v)$  which satisfies  $H(T_1(x, u, v), x, u, v) = 0$  for a sufficiently small  $\delta > 0$  such that  $x \in B_\delta(x^*)$ ,  $u \in \mathcal{U}$  with  $||u||_{\infty} < \delta$ , and  $v \in B_\delta(0)$ . Additionally, since  $H(t, x, u, v)$  is continuously differentiable with respect to its arguments, so is  $T_1(x, u, v)$ . As this holds for any  $x \in B_\delta(x^*)$ , it also holds for any  $x \in B_\delta(x^*) \cap S$ .

*Proof of Proposition [2.](#page-4-4)* We restrict attention to initial conditions  $x(0)$  that result in solutions that hit S; otherwise the solution is continuous and it can be extended indefinitely, trivially excluding the occurrence of Zeno and beating phenomena.

We first show parts *(i)* and *(ii)* simultaneously. Let  $x(t) =$  $\psi(t, x(0), u, \bar{v})$  be a solution of [\(4\)](#page-1-5) that is defined over some interval  $[0, t_f)$  and satisfies Definition [1.](#page-3-4) As in Remark [1,](#page-3-2) let  $t_k$ and  $t_{k+1}$  denote two subsequent impact times so that  $t_{k+1}$  –  $t_k = T_1(x_k, u_k, v_k)$ , where  $x_k := \lim_{t \to t_k} x(t) \in S$ ,  $u_k(t) =$  $u(t)$  for  $t \in [t_k, t_{k+1})$ , and  $v_k$  is the k-th element of the sequence  $\bar{v}$ . We will show that there exists  $T > 0$  such that  $t_{k+1} - t_k > \underline{T}$  for all  $k \in \mathbb{Z}_+$  with  $[t_k, t_{k+1}) \subset [0, t_f)$ . By Definition [1,](#page-3-4) there exists  $\delta > 0$  so that  $dist(x(0), \mathcal{O}) < \delta$ ,  $u \in \mathcal{U}$  with  $||u||_{\infty} < \delta$ , and  $\bar{v} \in \mathcal{V}$  with  $||\bar{v}||_{\infty} < \delta$  imply

$$
dist(x(t), \mathcal{O}) \le \beta(\delta, 0) + \alpha_1(\delta) + \alpha_2(\delta) , \qquad (61)
$$

for all  $t \in [0, t<sub>f</sub>)$ . Furthermore, by continuity of the distance function, we have  $\lim_{t \to t_k} \text{dist}(x(t), \mathcal{O}) = \text{dist}(x_k, \mathcal{O})$ , and [\(61\)](#page-12-3) in view of Proposition [1](#page-4-3) implies that, for some  $\lambda \in (0,1)$ ,

$$
||x_k - x^*|| \le \frac{1}{\lambda} \left(\beta(\delta, 0) + \alpha_1(\delta) + \alpha_2(\delta)\right) ,\qquad(62)
$$

for all  $k \in \mathbb{Z}_+$  with  $[t_k, t_{k+1}) \subset [0, t_f)$ . The result now follows from continuity of the time-to-impact function by Lemma [2.](#page-2-5) Indeed, as in the proof of part *(ii)* of Lemma [5,](#page-7-7) continuity of  $T_1$  implies that, for some  $T > 0$ , there exists a  $\delta_T >$ 0 such that  $x \in B_{\delta_T}(x^*) \cap S$ ,  $u \in \mathcal{U}$  with  $||u||_{\infty} < \delta_T$ , and  $v \in B_{\delta_T}(0)$  imply  $\underline{T} < T_1(x, u, v)$ . Choosing  $\delta$  in [\(62\)](#page-12-4) so that  $\frac{1}{\lambda}(\beta(\delta, 0) + \alpha_1(\delta) + \alpha_2(\delta)) < \delta_T$  ensures that  $x_k \in$  $B_{\delta_T}(x^*) \cap S$  for all  $k \in \mathbb{Z}_+$  with  $[t_k, t_{k+1}) \subset [0, t_f)$ . Such choice of  $\delta$  is always possible since the upper bound in [\(62\)](#page-12-4) is a class-K function of δ. Shrinking δ further (if necessary) to ensure that  $\delta < \delta_T$  guarantees that for  $x_k \in B_\delta(x^*) \cap \mathcal{S}, u \in \mathcal{U}$ with  $||u||_{\infty} < \delta$ , and  $v \in B_{\delta}(0)$  we have that  $T_1(x_k, u_k, v_k) >$  $\underline{T}$  for all discrete events k of the solution. As a result,  $t_{k+1}$  –  $t_k > \underline{T}$  for all  $k \in \mathbb{Z}_+$  with  $[t_k, t_{k+1}) \subset [0, t_f)$ . This ensures that any two discrete events are punctuated by a time gap of  $\underline{T}$ , thereby precluding solutions that are purely discrete or eventually discrete, or exhibit Zeno behavior, completing the proof of *(i)* and *(ii)*.

To prove part *(iii)*, from [\(61\)](#page-12-3) it is clear that  $x(t)$  is trapped in a compact set. Neglecting – as was mentioned at the beginning of the proof – the trivial case where the continuous solution never approaches  $S$ , using arguments similar to the proof of [\[34,](#page-15-25) Theorem 3.3] the solution can be extended until it reaches S. At this point, a well-defined discrete jump occurs that ensures the post-discrete-event state is still trapped within the same compact set and lies outside  $S$  because of part  $(i)$ ; hence, the solution must flow again according to the continuous dynamics until it reaches S. Additionally *(ii)* ensures the absence of Zeno behavior. Hence, we can propagate this argument forward for all time to obtain *(iii)*.  $\Box$ 

#### <span id="page-12-0"></span>APPENDIX B

*Proof of Lemma [4.](#page-5-3)* By assumption A[.1,](#page-1-3)  $f(x, 0)$  is twice continuously differentiable; thus, its backward flow  $\varphi^-(s\tau, x^*, 0) = y(\tau)$  is three-times continuously differentiable. Surjectivity of  $y(\tau)$  is obvious from the definition of  $y(\tau)$  in [\(14\)](#page-5-5). Injectivity follows from a contradiction argument. Assume  $y(\tau)$  is not injective, then there exist  $\tau_1 < \tau_2$  in  $[0, T]$  with  $y(\tau_1) = y(\tau_2)$ . Let  $f^-(x,0) := -f(x,0)$  be the vector field for the backwards flow. If  $f^-(y(\tau_1),0) \neq f^-(y(\tau_2),0)$  then f would not be well defined. If  $f^-(y(\tau_1), 0) = f^-(y(\tau_2), 0)$ , we have: *Case* (*i*):  $0 < \tau_1 < \tau_2$ 

Since  $y(\tau_1) = y(\tau_2)$ , we return to the same state after an interval  $\tau_2 - \tau_1 > 0$ . Hence,  $E := \{y(\tau) \mid \tau_1 \leq \tau \leq \tau_2\} \subset \mathcal{O}$ is a periodic orbit of the backwards-flow continuous system and we have the following sub-cases:

- <span id="page-12-3"></span>*(a)*  $y(\tau) \in E$  for all  $\tau \in [\tau_1, T]$ : The orbit E would also exist in the forward flow. As the periodic orbit is an invariant set under the 0-input continuous dynamics [\(1\)](#page-1-1), the forward flow starting from  $y(T) = \Delta(x^*, 0)$ will be trapped in  $E$  and never reach  $S$ , contradicting assumption A[.5,](#page-2-2) according to which the solution must reach S in finite time  $T^*$ .
- *(b)* There exists  $\hat{\tau} \in [\tau_1, T]$  such that  $y(\hat{\tau}) \notin E$ : This contradicts uniqueness of the backwards solution, as starting from  $y(\tau_1) \in E$ , one solution flows to  $y(\hat{\tau}) \notin E$ while the other gets trapped in E.

*Case (ii):*  $0 = \tau_1 < \tau_2$ 

Note that  $H(y(\tau))$  and  $L_{f}-H(y(\tau,0))$  are continuous in  $\tau$ . Additionally, from assumption A[.6-](#page-2-9)A[.7,](#page-2-8)  $H(y(0)) = H(x^*) =$ 0 and  $L_f$ −  $H(y(0), 0) > 0$  (flipped sign from assumption A[.7](#page-2-8) due to the flow being backwards in time), thus there exists a  $\delta > 0$  such that  $L_{f^-} H(y(\tau), 0) > 0$  for all  $\tau \in [0, \delta)$ . Hence for the interval  $(0, \delta)$  we have  $H(y(\tau)) > 0$ , i.e.,  $\{y(\tau) \mid \tau \in (0,\delta)\}\subset \mathcal{S}^+$ . Again using continuity of  $H(y(\tau))$ and  $L_f$ -  $H(y(\tau), 0)$  at  $\tau_2$  we have that  $H(y(\tau))$  is strictly increasing in the interval  $(\tau_2 - \delta, \tau_2 + \delta)$  (shrink  $\delta > 0$  if necessary to ensure  $\delta < \tau_2 - \delta$ ) but  $H(y(\tau_2)) = 0$ , hence,  $H(y(\tau)) < 0$  for all  $\tau \in (\tau_2 - \delta, \tau_2)$ , i.e.,  $\{y(\tau) | \tau \in$  $(\tau_2-\delta, \tau_2)\}\subset \mathcal{S}^-$ . Thus, for some  $\bar{\tau}$  such that  $\delta < \bar{\tau} < \tau_2-\delta$ , the solution must cross over from  $S^+$  to  $S^-$  at a point other than  $x^*$ , resulting in a contradiction to assumption A[.6.](#page-2-9)  $\Box$

First note that  $S$  is a twice continuously differentiable embedded submanifold in  $\mathbb{R}^n$  defined by  $H(x) = 0$ . Clearly,  $H(x^*) = 0$ , and, without loss of generality, assume that for the *n*-th coordinate  $\frac{\partial H}{\partial x_n}\Big|_{x^*} \neq 0$ , which follows from assumption A[.2.](#page-1-8) Hence, using the implicit function theorem we can write  $x_n = h(\bar{x})$  where  $\bar{x} := (x_1, ..., x_{n-1})$  for  $\bar{x} \in B_{\delta}(\bar{x}^*)$  where  $x^* = (\bar{x}^*, h(\bar{x}^*))$ . As a result, the local coordinates of states  $x \in S$  in a neighborhood of  $x^*$  are  $x = (\bar{x}, h(\bar{x}))$ . The Taylor expansion of  $h(\bar{x})$  at  $\bar{x}^*$  gives

$$
h(\bar{x}) = h(\bar{x}^*) + A(\bar{x} - \bar{x}^*) + O(||\bar{x} - \bar{x}^*||^2) , \qquad (63)
$$

where  $A = \frac{\partial h}{\partial \bar{x}}|_{\bar{x}^*}$ . Let  $z \in T_{x^*}S$  be the projection of x on  $T_{x^*}$ S along  $(x_1, x_2, ..., x_{n-1})$ , then its coordinates are  $z =$  $(\bar{x}, h(\bar{x}^*) + A(\bar{x} - \bar{x}^*))$ . Hence, for  $x \in B_\delta(x^*) \cap S$  and  $z \in T_{x} \mathcal{S}$ , there exists a  $c > 0$  such that,

$$
||x - z|| = ||(\bar{x}, h(\bar{x})) - (\bar{x}, h(\bar{x}^*) + A(\bar{x} - \bar{x}^*))||
$$
  
=  $|O(||\bar{x} - \bar{x}^*||^2)| \le c ||\bar{x} - \bar{x}^*||^2 \le c ||x - x^*||^2.$ 

# <span id="page-12-2"></span>APPENDIX D

*Proof of Lemma [8.](#page-7-6)* We begin with part *(i)*. By Remark [5,](#page-7-7)  $\varphi(t, \Delta(x^*, 0), 0)$  exists and is unique over  $[0, \overline{T}]$  with  $\overline{T} > T^*$ . Lemma [7](#page-7-8) establishes the existence of  $\delta_1 > 0$  for which, when  $x \in S$  and  $v \in \mathbb{R}^q$  are such that  $\|\Delta(x, v) - \Delta(x^*, 0)\| < \delta_1$ , and when  $||u||_{\infty} < \delta_1$ , the perturbed solution  $\varphi(t, \Delta(x, v), u)$ exists and is unique over the same interval  $[0, T]$ . By the continuity of  $\Delta$  following from assumption A[.3,](#page-1-9) there exists a  $\delta_2 > 0$  for which  $||x - x^*|| < \delta_2$  and  $||v|| < \delta_2$  guarantee  $\|\Delta(x, v) - \Delta(x^*, 0)\| < \delta_1$ . Hence, choosing  $\delta = \min\{\delta_1, \delta_2\}$ 

we have that, for  $x \in B_\delta(x^*) \cap \mathcal{S}, u \in \mathcal{U}$  with  $||u||_{\infty} < \delta$  and  $\bar{v} \in V$  with  $\|\bar{v}\|_{\infty} < \delta$ , the perturbed solution  $\varphi(t, \Delta(x, v), u)$ of [\(1\)](#page-1-1) exists and is unique over  $[0, T]$ , thus proving part *(i)*.

To prove part *(ii)*, let  $\epsilon_T := \overline{T} - T^* > 0$ . By continuity of  $T_1$  there exists a  $\delta_T > 0$  such that for  $x \in$  $B_{\delta_T}(x^*) \cap \mathcal{S}, u \in \mathcal{U}$  with  $||u||_{\infty} < \delta_T$ , and  $v \in B_{\delta_T}(0)$ , we have that  $|T_1(x, u, v) - T_1(x^*, 0, 0)| < \epsilon_T$ , which implies that  $T \leq T_1(x, u, v) \leq \overline{T}$  where  $T := T^*$  –  $\epsilon_T = 2T^* - \overline{T} > 0$  (shrink  $\overline{T}$  if necessary to ensure that  $\overline{T}$  < 2T\*). To show transversality, define  $\ell(x, u, v)$  :=  $\frac{\partial H}{\partial x}\big|_{\varphi(T_1(x,u,v),\Delta(x,v),u)} f(\varphi(T_1(x,u,v),\Delta(x,v),u),u)$  so that  $\ell^* := \ell(x^*, 0, 0) < 0$  by assumption A[.7,](#page-2-8) and let  $\epsilon_\ell \in (0, -\ell^*).$ By continuity of  $\ell$ , there is a  $\delta_{\ell} > 0$  such that for  $x \in$  $B_{\delta_{\ell}}(x^*) \cap \mathcal{S}, u \in \mathcal{U}$  with  $||u||_{\infty} < \delta_{\ell}$ , and  $v \in B_{\delta_{\ell}}(0)$ , we have that  $|\ell(x, u, v) - \ell(x^*, 0, 0)| < \epsilon_\ell$ , implying  $\ell(x, u, v)$  $\epsilon_{\ell} + \ell^* < 0$ . Choosing  $\delta = \min{\{\delta_1, \delta_2, \delta_T, \delta_\ell\}}$  with  $\delta_1, \delta_2 > 0$ as in the proof of part *(i)* completes the proof of part *(ii)*.

Finally, for part *(iii)*, we begin by setting up the region within which we work. Let  $w(t) = \varphi(t, \Delta(x^*, 0), 0)$  be the unperturbed (zero-input) solution of [\(1\)](#page-1-1), which by Remark [5](#page-7-7) is well-defined over the interval  $[0, \overline{T}]$  with  $\overline{T} > T^*$ . Let  $\delta > 0$ be as in the proof of part *(ii)* so that, for  $x \in B_\delta(x^*) \cap$ S,  $u \in \mathcal{U}$  with  $||u||_{\infty} < \delta$  and  $v \in B_{\delta}(0)$ , the perturbed solution  $\varphi(t, \Delta(x, v), u)$  exists and is unique over  $[0, \overline{T}]$  and  $T_1(x, u, v) < \overline{T}$ . Furthermore, for this choice of  $\delta$ , Lemma [7](#page-7-8) guarantees the existence of  $L > 0$  such that

$$
\|\varphi(t, \Delta(x, v), u) - w(t)\| \le e^{L\overline{T}} \|\Delta(x, v) - \Delta(x^*, 0)\|
$$
  
+  $(e^{L\overline{T}} - 1) \|u\|_{\infty},$ 

for all  $t \in [0, \overline{T}]$ . Since  $\Delta$  is continuously differentiable from assumption A[.3,](#page-1-9) it is locally Lipschitz. Hence, shrinking  $\delta$  (if necessary) ensures that the Lipschitz condition can be satisfied uniformly over  $B_\delta(x^*) \cap \mathcal{S}$  and  $\|\bar{v}\|_{\infty} < \delta$  for some constant  $L_{\Delta} > 0$ , thereby resulting in the following estimate

$$
\sup_{0 \le t \le T} \|\varphi(t, \Delta(x, v), u) - w(t)\|
$$
  

$$
\le e^{L\overline{T}} L_{\Delta}(\|x - x^*\| + \|\overline{v}\|_{\infty}) + (e^{L\overline{T}} - 1) \|u\|_{\infty}.
$$
 (64)

In addition, since by Lemma [2](#page-2-5) the map  $T_1$  is continuously differentiable and thus locally Lipschitz. Shrinking  $\delta$  further (if necessary) ensures that there exists a  $L<sub>T</sub> > 0$  such that

|T_1(x, u, v) - T_1(x^*, 0, 0)| \le L_T(||x - x^*|| + ||u||_{\infty} + ||\bar{v}||_{\infty})

\n(65)

for all  $x \in B_\delta(x^*) \cap \mathcal{S}$ ,  $u \in \mathcal{U}$  with  $||u||_{\infty} < \delta$  and  $\overline{v} \in \mathcal{V}$  with  $\|\bar{v}\|_{\infty} < \delta$ . In what follows, we work in such region so that the perturbed solution  $\varphi(t, \Delta(x, v), u)$  and the corresponding time to impact  $T_1(x, u, v)$  satisfy [\(64\)](#page-13-0) and [\(65\)](#page-13-1), respectively.

Now, let us consider the distance of the perturbed solution  $\varphi(t, \Delta(x, v), u)$  from  $\mathcal{O}$ . For any  $t \in [0, T]$  we have

$$
dist(\varphi(t, \Delta(x, v), u), \mathcal{O})
$$
  
:= 
$$
inf_{y \in \mathcal{O}} ||\varphi(t, \Delta(x, v), u) - w(t) + w(t) - y||
$$
  

$$
\leq ||\varphi(t, \Delta(x, v), u) - w(t)|| + dist(w(t), \mathcal{O}) ,
$$
 (66)

where [\(66\)](#page-13-2) is obtained by the triangle inequality. Regarding the term  $dist(w(t), \mathcal{O})$  in [\(66\)](#page-13-2), note that when  $t \in [0, T^*)$  we have  $dist(w(t), \mathcal{O}) = 0$ , while for  $t \in [T^*, \overline{T}]$  we have

dist(w(t), \mathcal{O}) := \inf_{y \in \mathcal{O}} ||w(t) - x^* + x^* - y||

= ||w(t) - x^*|| , \qquad (67)
$$

since  $\inf_{y \in \mathcal{O}} ||x^* - y|| = 0$ . We distinguish the following cases. *Case (a)*: Assume that  $T_1(x, v, u) < T^*$ . Then, for all  $t \in$  $[0, T_1(x, v, u)]$ , we have  $dist(w(t), \mathcal{O}) = 0$  and application of  $\sup_{0 \leq t < T_1}$  on [\(66\)](#page-13-2) results in the bound

$$
\sup_{0 \le t < T_1} \text{dist}(\varphi(t, \Delta(x, v), u), \mathcal{O})
$$
\n
$$
\le \sup_{0 \le t < T_1} \|\varphi(t, \Delta(x, v), u) - w(t)\| \tag{68}
$$

Since  $T^* < \overline{T}$ , for this case we have  $[0, T_1(x, u, v)) \subset [0, \overline{T}],$ and the bound [\(64\)](#page-13-0) implies

$$
\sup_{0 \le t < T_1} \text{dist}(\varphi(t, \Delta(x, v), u), \mathcal{O})
$$
  

$$
\le e^{L\overline{T}} L_{\Delta}(\Vert x - x^* \Vert + \Vert \overline{v} \Vert_{\infty}) + (e^{L\overline{T}} - 1) \Vert u \Vert_{\infty}.
$$

*Case (b)*: Assume that  $T_1(x, v, u) \geq T^*$ . Then, [\(67\)](#page-13-3) implies

$$
\sup_{0 \le t < T_1} \text{dist}(w(t), \mathcal{O}) \le \sup_{T^* \le t < T_1} \|w(t) - x^*\| \quad . \tag{69}
$$

Applying  $\sup_{0 \le t < T_1}$  on [\(66\)](#page-13-2) followed by [\(69\)](#page-13-4) results in

\leq \sup_{0 \leq t < T_1} \|\varphi(t, \Delta(x, v), u) - w(t)\|
$$
\n
$$
+ \sup_{T^* \leq t < T_1} \|w(t) - x^*\| . \tag{70}
$$

Regarding the first term in the RHS of [\(70\)](#page-13-5), the upper bound [\(64\)](#page-13-0) can be used since  $[0, T_1) \subset [0, \overline{T}]$ . Next, we look at the second term. Let  $K := \max_{T^* \le t \le T} ||f(w(t), 0)||$ . As mentioned in Remark [5,](#page-7-7) we have  $L_f^- \overline{H}(w(t), 0) < 0$  for all  $T^* \leq t \leq \overline{T}$  which implies that  $f(w(t), 0) \neq 0$  for all  $t \in [T^*, \overline{T}]$ , hence  $K > 0$ . Use K in the following,

\le KL_T(\|x - x^*\| + \|u\|_{\infty} + \|\bar{v}\|_{\infty}), \qquad (71)
$$

where [\(65\)](#page-13-1) was used. The desired estimate in Case *(b)* is then found by combining [\(64\)](#page-13-0) and [\(71\)](#page-13-6) according to [\(70\)](#page-13-5).

Finally, Case *(a)* and *(b)* can be combined for an appropriate  $c > 0$  to obtain [\(44\)](#page-8-2), thereby completing the proof.  $\Box$ 

<span id="page-13-2"></span>*Proof of Lemma [9.](#page-8-0)* We first prove Lemma [9](#page-8-0)*(i), (ii)* simultaneously. We begin by using Lemma [7](#page-7-8) to show that, for any point of  $\mathcal{O}$ , there exists an open ball of initial conditions and inputs for which a unique (forced) solution exists over a time interval that is sufficiently long to cross  $S$  transversally in finite time. Then, compactness of  $\overline{O}$  is used to extract a finite open subcover of  $\overline{O}$ , based on which an upper bound on the time to cross  $S$  is established uniformly in a tube around  $O$ .

Let  $w(t) = \varphi(t, \Delta(x^*, 0), 0)$  be the unperturbed (zero-input) solution of [\(1\)](#page-1-1) starting from  $\Delta(x^*,0)$ . By Remark [5,](#page-7-7)  $w(t)$  is well-defined over an interval  $[0, \overline{T}]$  with  $\overline{T} > T^*$ . Then define  $w_e := w(\overline{T})$  which is in the open set  $S^-$ . Hence, there exists a  $\delta_e > 0$  such that  $B_{\delta_e}(w_e) \subset S^-$ . Given an arbitrary time  $\xi \in [0, T^*]$  and the corresponding point  $w(\xi) \in \overline{\mathcal{O}}$ , Lemma [7](#page-7-8) ensures that there exists a  $\delta_{\xi} > 0$  such that, for any  $x \in B_{\delta_{\xi}}(w(\xi))$  and  $u \in \mathcal{U}$  with  $||u||_{\infty} < \delta_{\xi}$ , the (perturbed) solution  $\varphi(t, x, u)$  exists and is unique over the interval  $t \in [0, T-\xi]$ . Furthermore, for some  $L > 0$ , [\(43\)](#page-7-9) of Lemma [7](#page-7-8) gives  $\|\varphi(t, x, u) - w(\xi + t)\| \leq (2e^{L(\overline{T}-\xi)} - 1)\delta_{\xi}$  for all  $t \in [0, \overline{T} - \xi]$ , which implies that  $\delta_{\xi}$  can be chosen sufficiently small to ensure that  $\sup_{0 \le t \le \overline{T}-\xi} ||\varphi(t, x, u) - w(t+\xi)|| < \delta_e$ . As a result,  $\varphi(T - \xi, x, u) \in B_{\delta_e}(w_e)$ , from which it follows that the perturbed solution has crossed  $S$  during the interval  $[0, \overline{T}_x]$  with  $\overline{T}_x := \overline{T} - \xi$ ; clearly,  $\overline{T}_x$  depends on the choice of  $w(\xi)$ . Finally, the fact that the solution crosses S transversally can be shown similarly to the proof of part *(ii)* of Lemma [8.](#page-7-6)

Now, to extend these results over the entire orbit, construct an open cover of  $\overline{\mathcal{O}}$  by using the open balls  $B_{\delta_{\xi}}(w(\xi))$  for each  $\xi \in [0, T^*]$ . As  $\overline{\mathcal{O}}$  is compact, there exists  $\xi_1, \xi_2, ..., \xi_N \in$  $[0, T^*]$ , and  $\delta_i := \delta_{\xi_i}$ ,  $w_i := w(\xi_i)$  such that  $\cup_{i=1}^N B_{\delta_i}(w_i) \supset$  $\overline{O}$  is a finite sub-cover. Choose  $0 < \delta < \min_{1 \le i \le N} \delta_i$  such that  $\{x \in \mathbb{R}^n \mid \text{dist}(x, \mathcal{O}) < \delta\} \subset \cup_{i=1}^N B_{\delta_i}(\overline{w_i})$ . Choosing such  $\delta > 0$  is always possible. Indeed, since  $\cup_{i=1}^{N} B_{\delta_i}(w_i)$  is bounded, its boundary  $\mathcal{B} := \partial(\cup_{i=1}^N B_{\delta_i}(w_i))$  is compact. Let  $0 < \delta < \min_{x \in \mathcal{B}} \text{dist}(x, \mathcal{O})/2$  (shrink if necessary to ensure  $\delta$  < min<sub>1</sub><*i*<*N*  $\delta_i$ ) where the min is well-defined because  $dist(x, 0)$  is continuous. Note that  $\{x \in \mathbb{R}^n \mid dist(x, 0) < \delta\}$ is connected because  $\mathcal O$  is connected; hence, this choice of  $\delta$ ensures that  $\{x \in \mathbb{R}^n \mid \text{dist}(x, \mathcal{O}) < \delta\} \subset \cup_{i=1}^N B_{\delta_i}(w_i)$ . With this choice of  $\delta$ , any solution  $\varphi(t, x, u)$  such that  $x \in S^+$  with  $dist(x, 0) < \delta$  and  $u \in \mathcal{U}$  with  $||u||_{\infty} < \delta$  exists and is unique for  $t \in [0, \overline{T} - \xi_i]$ , where  $\xi_i$  corresponds to the ball  $B_{\delta_i}(w_i)$ that includes  $x$  (note that  $x$  may belong to multiple such balls; picking any one would suffice). Moreover, the solution will cross S transversally and in time within  $\max_{1 \leq i \leq N} (\overline{T} - \xi_i) \leq$  $\overline{T}$ . This completes the proof of Lemma  $9(i)$ , *(ii)*.

The proof of Lemma [9](#page-8-0)*(iii)* closely follows the proof of Lemma [8](#page-7-6)*(iii)*, with the difference that, instead of comparing the solution  $\varphi(t, x, u)$  with  $\varphi(t, \Delta(x^*, 0), 0)$  as was the case in Lemma [8](#page-7-6)*(iii)*, now we compare  $\varphi(t, x, u)$  with  $\varphi(t, w(\xi_{\min}), 0) = w(t + \xi_{\min})$ , where  $\xi_{\min} \in [0, T^*]$  is such that<sup>[9](#page-14-7)</sup> dist(x,  $\mathcal{O}$ ) =  $||x - w(\xi_{\text{min}})||$ . To do this comparison, we use  $T^* - \xi_{\min}$  and  $\overline{T} - \xi_{\min}$  instead of  $T^*$  and  $\overline{T}$ , and we use Claim 1 and Claim 2 below to generalize estimates related to  $\hat{T}_I$  and Lemma [7,](#page-7-8) respectively, from an open-ball around a point in  $\mathbb{R}^n$  to an entire open neighborhood of  $\mathcal O$  in  $\mathcal S^+$ . In the end, we replace  $||x - w(\xi_{\min})||$  with dist $(x, 0)$ 

*Claim 1:* Let  $\hat{T}_I$  be as in [\(8\)](#page-3-9). There exist  $L_{\hat{T}} > 0$  and  $\delta > 0$ such that for  $x \in S^+$  with  $dist(x, 0) < \delta$  and  $u \in U$  with  $||u||_{\infty} < \delta$ , the following is satisfied

$$
|\hat{T}_I(x, u) - \hat{T}_I(w(\xi_{\min}), 0)| \le L_{\hat{T}}(||x - w(\xi_{\min})|| + ||u||_{\infty}).
$$

<span id="page-14-7"></span><sup>9</sup>Such  $\xi_{\text{min}}$  exists by Lemma [3](#page-5-0) and depends on x since  $\xi_{\text{min}} \in$  $\arg \min_{\xi \in [0,T]} ||x - w(\xi)||$ ; we do not display this dependence here.

*Claim 2:* There exist  $L > 0$  and  $\delta > 0$  such that for any  $x \in S^+$  with  $dist(x, \mathcal{O}) < \delta$  and  $u \in \mathcal{U}$  with  $||u||_{\infty} < \delta$ , the following is satisfied for  $0 \le t \le \overline{T} - \xi_{\min}$ ,

$$
\|\varphi(t, x, u) - w(t + \xi_{\min})\| \le e^{L\overline{T}} \|x - w(\xi_{\min})\| + (e^{L\overline{T}} - 1)\|u\|_{\infty}.
$$

Finally, we present proofs of Claim 1 and 2.

*Proof of Claim 1.* For any  $\xi \in [0, T^*]$ , there exists a  $\delta_{\xi} > 0$ such that  $\hat{T}_I$  is continuously differentiable, and thus locally Lipschitz for  $x \in B_{\delta_{\xi}}(w(\xi))$  and  $u \in \mathcal{U}$  with  $||u||_{\infty} < \delta_{\xi}$ . Shrink (if necessary)  $\delta_{\xi}$  to ensure that the Lipschitz condition is satisfied uniformly for some  $L_{\hat{T},\xi} > 0$ . Construct an opencover for  $\overline{\mathcal{O}}$  and extract a finite subcover  $\cup_{i=1}^{N} B_{\delta_i/2}(w_i)$  as above, but now use  $\delta_i/2$ . Let  $x \in B_{\delta_i/2}(w_i)$  for some i, then  $w(\xi_{\min}) \in B_{\delta_i}(w_i)$  for the same *i*. This holds because  $||x - w(\xi_{\min})|| \le ||x - w_i|| < \delta_i/2$ , hence using the triangle inequality  $||w(\xi_{\min}) - w_i|| \le ||x - w(\xi_{\min})|| + ||w_i - x|| < \delta_i$ . Therefore, for any  $x \in \bigcup_{i=1}^{N} B_{\delta_i/2}(w_i)$ , we can write the Lipschitz condition with the constant  $L_{\hat{T},\xi_i}$  replaced by  $L_{\hat{T}} =$  $\max_{1 \leq i \leq N} L_{\hat{T}, \xi_i}$ . Choosing  $0 < \delta < \min_{1 \leq i \leq N} \delta_i/2$  such that  $\{x \in S^+ \mid \text{dist}(x, \mathcal{O}) < \delta\} \subset \bigcup_{i=1}^N B_{\delta_i/2}(w_i)$  and  $u \in \mathcal{U}$ with  $||u||_{\infty} < \delta$  completes the proof.  $\Box$ 

*Proof of Claim 2.* The proof is similar to [\[34,](#page-15-25) Theorem 3.5]; hence, we only provide a sketch. Note that  $L$  is the Lipschitz constant of f on the compact set  $\{(x, \hat{u}) \in \mathbb{R}^n \times \mathbb{R}^p \mid ||x - \hat{u}||\}$  $w(t)$   $\leq \epsilon, \forall t \in [0, T^*],$  and  $\|\hat{u}\| \leq \epsilon$  where  $\hat{u}$  denotes the *value* of  $u \in U$  at a certain time instant and should not be confused with the function itself. The proof follows by the Gronwall-Bellman inequality [\[34,](#page-15-25) Lemma A.1], which gives

$$
\|\varphi(t, x, u) - w(t + \xi_{\min})\|
$$
\n
$$
\leq e^{L(\overline{T} - \xi_{\min})} \|x - w(\xi_{\min})\| + (e^{L(\overline{T} - \xi_{\min})} - 1) \|u\|_{\infty},
$$
\n
$$
\leq e^{L\overline{T}} \|x - w(\xi_{\min})\| + (e^{L\overline{T}} - 1) \|u\|_{\infty}.
$$
\n(72)

for  $t \in [0, \overline{T} - \xi_{\min}]$ . Choosing  $\delta = \epsilon/(2e^{LT})$  such that  $dist(x, 0) = ||x - w(\xi_{\min})|| < \delta$  and  $||u||_{\infty} < \delta$  ensures the solution remains trapped in the compact  $\epsilon$ -neighborhood of  $\overline{\mathcal{O}}$  for  $t \in [0, T^* - \xi_{\text{min}}]$  and hence the inequality holds.  $\Box$
