# The mean-field limit of a network of Hopfield neurons with correlated synaptic weights

#### Abstract

We study the asymptotic behaviour for asymmetric neuronal dynamics in a network of Hopfield neurons. The randomness in the network is modelled by random couplings which are centered Gaussian correlated random variables. We prove that the annealed law of the empirical measure satisfies a large deviation principle without any condition on time. We prove that the good rate function of this large deviation principle achieves its minimum value at a unique Gaussian measure which is not Markovian. This implies almost sure convergence of the empirical measure under the quenched law. We prove that the limit equations are expressed as an infinite countable set of linear non Markovian SDEs.

## 1 Introduction

We revisit the problem of characterizing the large-size limit of a network of Hopfield neurons. Hopfield [14] defined a broad class of neuronal networks and characterized some of their computational properties [15, 16], i.e. their ability to perform computations. Inspired by his work Sompolinsky and co-workers studied the thermodynamic limit of these networks when the interaction term is linear [6] using the dynamic mean-field theory developed in [22] for symmetric spin glasses. The method they use is a functional integral formalism used in particle physics and produces the self-consistent mean-field equations of the network. This was later extended to the case of a nonlinear interaction term, the nonlinearity being an odd

[^0]sigmoidal function [21]. A recent revisit of this work can be found in [7]. Using the same formalism the authors established the self-consistent mean-field equations of the network and the dynamics of its solutions which featured a chaotic behaviour for some values of the network parameters. A little later the problem was picked up again by mathematicians. Ben Arous and Guionnet applied large deviation techniques to study the thermodynamic limit of a network of spins interacting linearly with i.i.d. centered Gaussian weights. The intrinsic spin dynamics (without interactions) is a stochastic differential equation where the drift is the gradient of a potential. They prove that the annealed (averaged) law of the empirical measure satisfies a large deviation principle and that the good rate function of this large deviation principle achieves its minimum value at a unique measure which is not Markovian $[12,1,13]$. They also prove averaged propagation of chaos results. Moynot and Samuelides [18] adapt their work to the case of a network of Hopfield neurons with a nonlinear interaction term, the nonlinearity being a sigmoidal function, and prove similar results in the case of discrete time. The intrinsic neural dynamics is the gradient of a quadratic potential.

We extend this paradigm by including correlations in the random distribution of network connections. There is an excellent motivation for this, because it is commonly thought that neural networks have a small-world architecture, such that the connections are not completely random, but display a degree of clustering [23]. It is thought that this clustering could be a reason behind the correlations that have been observed in neural spike trains [5].

We propose a different method to obtain the annealed LDP to previous work by Ben Arous and Guionnet [1, 13], Faugeras and MacLaurin [10]. The analysis of these papers centres on the Radon-Nikodym derivative between the coupled state and the uncoupled state, demonstrating that this converges as the network size asymptotes to infinity. By contrast, our analysis centres on the SDE governing the finite-dimensional annealed system. It bears some similarities to the coupling method developed by Sznitman [24] for interacting particle systems, insofar as we demonstrate that the finite-dimensional SDE converges to the limiting system superexponentially quickly.

Our method is more along the lines of recent work that uses methods from stochastic control theory to determine the Large Deviations of interacting particle systems [4]. It is centered on the idea of constructing an exponentially good approximation of the annealed law of the empirical measure under the averaged law of the finite size system.

## 2 Outline of model and main result

Let $I_{n}=[-n \cdots n], n \geq 0$ be the set of $2 n+1$ integers between $-n$ and $n, N:=2 n+1$.
For any positive integer $n$, let $J_{n}=\left(J_{n}^{i j}\right)_{i, j \in I_{n}} \in \mathbb{R}^{N \times N}$, and consider the system $\mathcal{S}^{N}\left(J_{n}\right)$ of $N$ stochastic differential equations

where $\left(B^{i}\right)_{i \in I_{n}}$ is an $N$-dimensional vector of independent Brownian motions. We assume for simplicity that $V_{0}^{i}=0, i \in I_{n} . \sigma$ is a positive number. The function $f: \mathbb{R} \rightarrow \mathbb{R}^{+}$is bounded
and Lipschitz continuous. We may assume without loss of generality that $f(\mathbb{R}) \subset[0,1]$ and that its Lipschitz constant is equal to 1. A typical example is

The weights $J_{n}:=\left(J_{n}^{j k}\right)_{j, k \in I_{n}}$ are, under the probability $\gamma$ on $(\Omega, \mathcal{A})$, centered correlated Gaussian random variables with a shift invariant covariance function given by

Remark 2.1. Expectations w.r.t. $\gamma$ are noted $\mathbb{E}^{\gamma}$ throughout the paper.
Remark 2.2. Model (1) is a slightly simplified version of the full Hopfield model which includes a linear term and a general initial condition:

$\alpha$ is a positive constant and $\mu_{0}$ is a probability measure on $\mathbb{R}$ with finite variance.
Adding the extra linear term and a more general initial condition does not change the nature of the mathematical problems we address but complicates the notations.

Here $R_{\mathcal{J}}$ is independent of $n$ and such that

where the two positive sequences $\left(a_{k}\right)$ and $\left(b_{l}\right)$ are such that

We note $a$ and $b$ the sums of the two series $\left(a_{k}\right)_{k \in \mathbb{Z}}$ and $\left(b_{k}\right)_{k \in \mathbb{Z}}$,

2. There exists a centered Gaussian stationary process $\left(J^{i j}\right)_{i, j \in \mathbb{Z}}$ with autocorrelation $R_{\mathcal{J}}$. Because of (5) this process has a spectral density noted $R_{\mathcal{J}}$ given by

with $i=\sqrt{-1}$. We assume that this spectral density is strictly positive:

for all $\varphi_{1}, \varphi_{2} \in[-\pi, \pi[$.

Remark 2.3. The hypotheses (6) guarantee that the Fourier transform

is three times continuously differentiable on $[-\pi, \pi]$. We provide a short proof.
Proof. Define $Q_{\mathcal{J}}(k):=\sum_{l \in \mathbb{Z}} R_{\mathcal{J}}(k, l)$. This is well defined since the series in the right hand side is absolutely convergent. Because $\left|Q_{\mathcal{J}}(k)\right| \leq b a_{k}, Q_{\mathcal{J}}(k)$ is $\mathcal{O}\left(1 /|k|^{3}\right)$ and hence its Fourier transform $\tilde{R}_{\mathcal{J}}(\varphi, 0)$ (see (8)) is three times continuously differentiable.

We have the following Proposition.
Proposition 2.4. For each $J_{n} \in \mathbb{R}^{N \times N}, \mathcal{S}^{N}\left(J_{n}\right)$ has a unique weak solution.
Proof. For each $J_{n}$, we have a standard system of stochastic differential equations with smooth coefficient (Lipschitz continuous). Existence and uniqueness of the solution is well known.

The solution $V_{n}:=\left(V^{j}\right)_{j \in I_{n}}$ to the above system defines a $\mathcal{T}^{N}$-valued random variable, where $\mathcal{T}=\mathcal{C}([0, T], \mathbb{R})$.

Given a metric space $\mathfrak{X}$, in what follows $\mathfrak{X}=\mathcal{T}, \mathcal{T}^{N}$, or $\mathcal{T}^{\mathbb{Z}}$, and the corresponding distance $d$ we consider the measurable space $\left(\mathfrak{X}, \mathcal{B}_{d}\right)$, where $\mathcal{B}_{d}$ is the Borelian $\sigma$-algebra induced by the topology defined by $d$, and note $\mathcal{P}(\mathfrak{X})$ the set of probability measures on $\left(\mathfrak{X}, \mathcal{B}_{d}\right)$.

We note $P \in \mathcal{P}(\mathcal{T})$, the law of each scaled Brownian motion $\sigma B^{i}, P^{\otimes N} \in \mathcal{P}\left(\mathcal{T}^{N}\right)$ the law of $N$ independent scaled Brownian motions $\sigma B^{j}, j \in I_{n}$, and $P^{\otimes \mathbb{Z}} \in \mathcal{P}\left(\mathcal{T}^{\mathbb{Z}}\right)$ the law of $\left(\sigma B_{t}^{j}\right)_{j \in \mathbb{Z}}$. We also note $P^{N}\left(J_{n}\right) \in \mathcal{P}\left(\mathcal{T}^{N}\right)$ the law of the solution to $\mathcal{S}^{N}\left(J_{n}\right)$.

We note $u=\left(u^{i}\right)_{i \in \mathbb{Z}}$ an element of $\mathcal{T}^{\mathbb{Z}}$ and $u_{n}=\left(u^{i}\right)_{i \in I_{n}}$ its projection on $\mathcal{T}^{N}$.
Given $\mu \in \mathcal{P}\left(\mathcal{T}^{\mathbb{Z}}\right)$ we note $\mu^{I_{n}} \in \mathcal{P}\left(\mathcal{T}^{N}\right)$ its marginal over the set of coordinates of $u_{n}$.
Because of the shift invariance of the covariance $R_{\mathcal{J}}$ we are naturally led to consider stationary probability measures on $\mathcal{T}^{\mathbb{Z}}$. For this, let $S^{i}$ be the shift operator acting on $\mathcal{T}^{\mathbb{Z}}$ by

and let $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ be the space of all probability measures that are invariant under $S$. This property obviously implies the invariance under $S^{i}$, for all integers $i$. The periodic empirical measure $\hat{\mu}_{n}: \mathcal{T}^{N} \rightarrow \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ is defined to be

where $u_{n, p} \in \mathcal{T}^{\mathbb{Z}}$ is the periodic interpolant of $u_{n}$, i.e. such that $u_{n, p}^{j}:=u_{n}^{j} \bmod I_{n}$. Let $\Pi^{n}\left(J_{n}\right)=P^{N}\left(J_{n}\right) \circ \hat{\mu}_{n}^{-1} \in \mathcal{P}\left(\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)\right)$ be the (quenched) law of $\hat{\mu}_{n}\left(V_{n}\right)$ under $P^{N}\left(J_{n}\right)$, and $\Pi^{n}:=\mathbb{E}^{\gamma}\left[\Pi^{n}\left(J_{n}\right)\right]=\mathbb{E}^{\gamma}\left[P^{N}\left(J_{n}\right)\right] \circ \hat{\mu}_{n}^{-1} \in \mathcal{P}\left(\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)\right)$ be the annealed (averaged) law of
$\hat{\mu}_{n}\left(V_{n}\right)$ under the averaged law $Q^{n}:=\mathbb{E}^{\gamma}\left[P^{N}\left(J_{n}\right)\right]$. Finally let $\Pi_{0}^{n}=P^{\otimes N} \circ \hat{\mu}_{n}^{-1}$ be the law of $\hat{\mu}_{n}\left(\sigma B_{n}\right)$, i.e. the law of the empirical measure under $P^{\otimes N}$.

We metrize the weak topology on $\mathcal{T}^{\mathbb{Z}}$ with the following distance

where $\left\|f\left(u^{i}\right)-f\left(v^{i}\right)\right\|_{T}=\sup _{t \in[0, T]}\left|f\left(u_{t}^{i}\right)-f\left(v_{t}^{i}\right)\right|$ and the positive sequence $b_{i}$ is defined by (5).

We use the Wasserstein- 1 distance to metrize the weak topology on $\mathcal{P}\left(\mathcal{T}^{\mathbb{Z}}\right)$ :
given $\mu, \nu \in \mathcal{P}\left(\mathcal{T}^{\mathbb{Z}}\right)$ we define

where $C(\mu, \nu)$ denotes the set of probability measures on $\mathcal{T}^{\mathbb{Z}} \times \mathcal{T}^{\mathbb{Z}}$ with marginals $\mu$ and $\nu$ on the first and second factors (couplings).

The following is our main result.

## Theorem 2.5.

(i) The sequence of laws $\left(\Pi^{n}\right)_{n \in \mathbb{Z}^{+}}$satisfies a Large Deviation Principle with respect to the weak topology on $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$, with good rate function $H(\mu): \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right) \rightarrow \mathbb{R}$.
(ii) The rate function $H$ has the following structure. If it is not the case that $\mu^{I_{n}} \ll P^{\otimes N}$ for all $n$, then $H(\mu)=\infty$, otherwise

where the measurable function $\Psi: \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right) \rightarrow \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ is defined in Section 3.2. and $I^{(3)}$ in Theorem 2.6.
(iii) $H$ has a unique zero $\mu_{*}=\Psi\left(P^{\otimes \mathbb{Z}}\right)$.
(iv) $\mu_{*}$ is the law of the unique weak solution $Z$ of the following system of McKean-Vlasovtype equations,

The sequence of processes $\left(\sigma W^{j}\right)_{j \in \mathbb{Z}}$ is distributed as $P^{\otimes \mathbb{Z}}$, and $L_{\mu_{*}}$ is defined in Remark 3.3 and Appendix C.1. Furthermore $\mu_{*}$ is Gaussian.

The proof of this theorem uses the following, classical, theorem [3] and [8, Section 6]. Recall that $\Pi_{0}^{n}$ is the law of the empirical measure under $P^{\otimes N}$.

Theorem 2.6. The sequence of laws $\left(\Pi_{0}^{n}\right)_{n \in \mathbb{Z}^{+}}$satisfies a large deviation principle with good rate function $I^{(3)}$ on $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$. The specific relative entropy is

where, for measures $\nu$ and $\rho$ on $\mathbb{R}^{N}$, the relative entropy $I^{(2)}$ is defined by

see e.g. [9].
The unique zero of $I^{(3)}$ is $P^{\otimes \mathbb{Z}}$.
A standard argument yields that the averaged LDP of the previous theorem implies almost sure convergence of the empirical measure under the quenched law [1]. This is stated in the following corollary.

Corollary 2.7. For almost every realization of the weights and Brownian motions,

\hat{\mu}_{n}\left(V_{n}\right) \rightarrow \mu_{*} \quad \text { as } N \rightarrow \infty .
$$

Proof. The proof is standard. It follows from an application of Borel-Cantelli's Lemma to Proposition 2.9.

Remark 2.8. Note that this implies that for all $f \in C_{b}\left(\mathcal{T}^{\mathbb{Z}}\right)$ and for almost all $\omega \in \Omega$.

Proposition 2.9. For any closed set $F$ of $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ and for almost all $J_{n}$,

\limsup _{N \rightarrow \infty} \frac{1}{N} \log \left[P^{N}\left(J_{n}\right)\left(\hat{\mu}_{n} \in F\right)\right] \leq-\inf _{\mu \in F} H(\mu)
$$

Proof. The proof, found in [1, Th. 2.7], follows from an application of Borel-Cantelli's Lemma.

Remark 2.10. Note that in the case we assume the synaptic weights to be uncorrelated, equations (14) reduce to

which is exactly the one found in [1, Th. 5.14].

## 3 Proof of Theorem 2.5

Our strategy is partially inspired from the one in [1, 13]. We apply Girsanov's Theorem to $\mathcal{S}^{N}\left(J_{n}\right)$ to obtain the Radon-Nikodym derivative of the measure $P^{N}\left(J_{n}\right)$ with respect to the measure $P^{\otimes N}$ of the system of $N$ uncoupled neurons. We then show that the average $Q^{n}$ of $P^{N}\left(J_{n}\right)$ w.r.t. to the weights is absolutely continuous w.r.t. $P^{\otimes N}$ and compute the corresponding Radon-Nikodym derivative which characterizes the averaged (annealed) process. As in the work of Ben Arous and Guionnet [1], the idea is to deduce our LDP from the one satisfied by the sequence $\left(\Pi_{0}^{n}\right)_{n \in \mathbb{N}}$. We differ from the work of Ben Arous and Guionnet in that in order to obtain the Large Deviation Principle that governs this process we approximate the averaged system of SDEs with a system with piecewise constant in time coefficients by discretizing the time interval $[0, T]$ into $m$ subintervals of size $T / m$, for $m$ an integer. This system allows us to construct a sequence of continuous maps $\Psi^{m}$ : $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right) \rightarrow \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ and a measurable map $\Psi: \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right) \rightarrow \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ such that the sequence $\Psi^{m}$ converges uniformly toward $\Psi$ on the level sets of the good rate function of the LDP satisfied by $\Pi_{0}^{n}$. We then show that for a specific choice $m(n)$ of $m$ as a function of $n$ the sequence $\Pi_{0}^{n} \circ\left(\Psi^{m(n)}\right)^{-1}$ is an exponentially good approximation of the sequence $\Pi^{n}$. The LDP for $\Pi^{n}$ and the corresponding good rate function then follow from a Theorem by Dembo and Zeitouni, [8, Th. 4.2.23].

In more details, we use Girsanov's Theorem to establish in Section 3.1 the SDEs whose solution's law is the averaged law $Q^{n}$. In Section 3.2 we construct an approximation of these equations by a) discretizing the time interval $[0, T]$ with $m$ subintervals and b) cutting off the spatial correlation of the weights so that it extends over $\left[-q_{m}, q_{m}\right]$ rather than over $[-n, n]$, $q_{m} \leq n$. We then use this approximation to construct the family $\left(\Psi^{m}\right)_{m \in \mathbb{N}}$ of continuous maps. Section 3.3 contains the proof of our main Theorem 2.5. This proof contains two main ingredients, the exponential tightness of $\left(\Pi^{n}\right)_{n \in \mathbb{Z}^{+}}$proved in Section 3.4, and the existence of an exponential approximation of the family of measures $\left(\Pi^{n}\right)_{n \in \mathbb{Z}^{+}}$by the family of measures $\left(\Pi^{m, n}\right)_{m, n \in \mathbb{Z}^{+}}=\Pi_{0}^{n} \circ\left(\Psi^{m}\right)^{-1}$ constructed from the law of the solutions to the approximate equations. The existence of this exponential approximation and the possible choices for $m$ and $q_{m}$ as functions of $n$ are proved in Section 3.5. The unique minimum of the rate function is characterized in Section 3.6.

### 3.1 The SDEs governing the Finite-Size Annealed Process

For every $J_{n} \in \mathbb{R}^{N \times N}, P^{N}\left(J_{n}\right)$ is a probability measure on $\mathcal{T}^{N}$ and as a consequence of Girsanov's theorem

In Proposition 3.4 below, we demonstrate that the Radon-Nikodym derivative of $Q^{n}$ w.r.t. $P^{\otimes N}$ exists and is a function of the empirical measure. To facilitate this, we must introduce intermediate centered Gaussian Processes $\left(G_{t}^{i}\right)_{i \in I_{n}, t \in[0, T]}$, for which it turns out that their probability law is entirely determined by the empirical measure, i.e.

Remark 3.1. Note that we have shown that under $\gamma$, the sequence $G^{i}, i \in I_{n}$, is centered, stationary with covariance $K_{\hat{\mu}_{n}\left(X_{n}\right)}$. To make this dependency explicit we write $\gamma^{\hat{\mu}_{n}\left(X_{n}\right)}$ the law under which the Gaussian process $\left(G_{t}^{i}\right)_{i \in I_{n}, t \in[0, T]}$ has mean 0 and covariance $K_{\hat{\mu}_{n}\left(X_{n}\right)}$.

Before we prove the following proposition which is key to the whole approach we need to introduce a few more notations. We note

Remark 3.2. More generally given a measure $\mu$ in $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ we note $\gamma^{\mu}$ the law under which the Gaussian process $\left(G_{t}^{i}\right)_{i \in I_{n}, t \in[0, T]}$ has mean 0 and covariance $K_{\mu}$ such that

The properties of $K_{\mu}$ are proved in Appendix C. Note that we do not make explicit the dependency of $\Lambda$ on $\mu$ since it is always clear from the context, see next remark.

Remark 3.3. To each covariance $K_{\mu}$ defined in Remark 3.2 we associate a new covariance $L_{\mu}^{t}$ such that

Proposition 3.4. The measures $Q^{n}$ and $P^{\otimes N}$ are equivalent, with Radon-Nikodym derivative over the time interval $[0, t]$ equal to

Applying the Fubini-Tonelli theorem to the positive measurable function $\frac{d P^{N}\left(J_{n}\right)}{d P^{\otimes N}}$ we find that $Q^{n} \ll P^{\otimes N}$ and

Moreover, under $\gamma,\left\{\sum_{j \in I_{n}} J_{n}^{i j} f\left(X_{t}^{j}\right), i \in I_{n}, t \leq T\right\}$ is a centered Gaussian process with covariance $K_{\hat{\mu}_{n}\left(X_{n}\right)}$, thanks to (19) and (20). Therefore we have:

The above expression demonstrates that $Q_{\mid \mathcal{F}_{t}}^{n}$ is equivalent to $P_{\mid \mathcal{F}_{t}}^{\otimes N}$ for all $t \in[0, T]$, since the above exponential cannot be zero on any set $A \in \mathcal{B}\left(\mathcal{T}^{N}\right)$ such that $P^{\otimes N}(A) \neq 0$. Thus by Girsanov's Theorem [19],

the second bracket only contains a finite variation process, so its bracket with $B^{j}$ is 0 . Furthermore the probability measure $\gamma^{\hat{\mu}_{n}\left(X_{n}\right)} \in \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ does not change with time, hence we may commute the bracket and expectation as follows,

since $\Lambda_{t}$ is time-differentiable, and we have used Ito's Lemma. To be sure, we have carefully double checked (using multiple applications of Ito's Formula) that the time-differentiable terms in (27) are of the correct form. We thus have proved the Proposition, using (22) again.
Remark 3.5. By writing $G^{j}, G^{i}$ and $\Lambda_{t}(G)$ as functions of the synaptic weights in (28) and using their stationarity, $\theta_{t}^{j}$ can be rewritten as

with indexes taken modulo $I_{n}$.
Since $Q^{n}$ and $P^{\otimes N}$ are equivalent, by Girsanov's Theorem we obtain the following immediate corollary of Proposition 3.4. Part (ii) of the corollary is immediate from the definitions.

(i) Let $V_{n} \in \mathcal{T}^{N}$ have law $Q^{n}$. There exist processes $W_{t}^{j}$ that are independent Brownian motion under $Q^{n}$ and such that $V_{n}$ is the unique weak solution to the following equations

### 3.2 Approximation of the Finite-Size Annealed Process and construction of the sequence of maps $\Psi^{m}$

It is well known that Large Deviations Principles are preserved under continuous transformations. However we cannot in general find a continuous mapping $\Gamma^{n}$ on $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ such that $\Gamma^{n}\left(\hat{\mu}_{n}\left(\sigma W_{n}\right)\right)=\hat{\mu}_{n}\left(V_{n}\right)$, where $V_{n}$ is defined in Corollary 3.6. Therefore to prove the LDP, we will use 'exponentially equivalent approximations'. This technique approximates the mapping $\hat{\mu}_{n}\left(\sigma W_{n}\right) \rightarrow \hat{\mu}_{n}\left(V_{n}\right)$ by a sequence of continuous approximations. Our next step therefore is to define the continuous map $\Psi^{m}: \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right) \rightarrow \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ (for positive integers $m$ ), which will be such that for any $\delta>0$, the probability that $D_{T}\left(\Psi^{m}\left(\hat{\mu}_{n}\left(\sigma W_{n}\right)\right), \hat{\mu}_{n}\left(V_{n}\right)\right)>\delta$ is superexponentially small. These approximations will converge to the map $\Psi$ that is defined in the proof of Theorem 2.5. This is done in two steps: First approximate the system (29)(30) by discretizing the time and cutting off the correlation between the synaptic weights and, second, by using this approximation to construct the map $\Psi^{m}$ from $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ to itself.

### 3.2.1 Approximation of the system of equations (29)-(30)

To this aim, we use an Euler scheme type approximation: the integrand of $V_{t}^{j}$ is replaced by a piecewise constant in time version. Let $\Delta_{m}, m$ a strictly positive integer, be a partition of $[0, T]$ with steps $\eta_{m}:=\frac{T}{m}$ into the $(m+1)$ points $p \eta_{m}$, for $p=0$ to $m$, and for any $t \in[0, T]$, write $t^{(m)}:=p \eta_{m}$ such that $t \in\left[p \eta_{m},(p+1) \eta_{m}\right)$.

To obtain the Large Deviation Principle, we need to approximate the expression for $V_{n}$ in Corollary 3.6 by a continuous map. The approximate system has finite-range spatial interactions. The spatial interactions have range $Q_{m}=2 q_{m}+1$ (with $0<q_{m}<n$ ). The parameters $m$ and $q_{m}$ are specified as functions of $n$ in Remark D. 2 in the proof of Lemma 3.21.

More precisely, following (29), the approximate system is of the form, for $j \in I_{n}$

The $W_{t}^{j}$ s are Brownian motions and (remember (21))

It is important for the upcoming definition of the map $\Psi^{m}$ that the covariance between the Gaussian variables $\left(G_{t}^{m, i}\right)$ can be written as a function of the empirical measure $\hat{\mu}_{n}\left(V_{n}^{m}\right)$ which we now demonstrate. One verifies easily that

### 3.2.2 Construction of the sequence of maps $\Psi^{m}$

In order to construct the map $\Psi^{m}$ we rewrite (36) in terms of the increment of $V_{t}^{m}-V_{t^{(m)}}^{m}$ of the process $V^{m}$ :

We can now generalize (38) by considering a general measure $\nu$ in $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ and simply replacing $\bar{\gamma}_{s}^{\hat{\mu}_{n}\left(V_{n}^{m}\right)}$ by $\bar{\gamma}_{s}^{\nu}$ in this equation. This is the basic idea but we have to be slightly more careful.

In detail, following Remark 3.1, given $\nu=\left(\nu_{1}, \nu_{2}\right) \in \mathcal{P}_{S}\left(\left(\mathcal{T}^{\mathbb{Z}}\right)^{2}\right)$ we define the $I_{q_{m}}$ periodic centered stationary Gaussian process $\left(G_{t}^{m, i}\right)_{i \in I_{q_{m}}, t \in[0, T]}$, i.e. its covariance function, by (patterning after (35))

(a) if $X_{t}^{j}$ and $Y_{t}^{j}$ are $N$-periodic, so is $Z_{t}^{j}$.
(b) the expected value $\mathbb{E}^{\bar{\gamma}_{u \eta_{m}}^{\nu_{1}}}$ in (40) acts only on the Gaussian random variables $G^{m}$ and not on the Ys.

The continuity of $\psi_{u}^{m}$ follows from the facts that this equation is linear in $X, Y$ and $Z$, and the mapping $\nu \rightarrow L_{\nu_{1}}$ is continuous, see Proposition C.10. The continuity of $\Psi_{u}^{m}$ follows from (42) and that of $\Psi^{m}$ from (43) and the continuity of $\Psi^{0}$ defined by (44) and (45).

(ii) Let $X_{n, 2}=\left(X_{n}^{1}, X_{n}^{2}\right)$ be an element of $\left(\mathcal{T}^{N}\right)^{2}$, and $\hat{\mu}_{n}\left(X_{n, 2}\right)=\frac{1}{N} \sum_{i \in I_{n}} \delta_{\left(S^{i} X_{n, p}^{1}, S^{i} X_{n, p}^{2}\right)}$ (remember (10)) the corresponding empirical measure in $\mathcal{P}_{S}\left(\left(\mathcal{T}^{\mathbb{Z}}\right)^{2}\right)$. Let $\varphi:\left(\mathcal{T}^{\mathbb{Z}}\right)^{2} \rightarrow$ $\left(\mathcal{T}^{\mathbb{Z}}\right)^{2}$, be a measurable function. Then it is true that

where ${ }^{0} V^{m}$ is equal to the solution of (36) on the time interval $\left[0, \eta_{m}\right]$. According to Remark 3.7, ${ }^{0} V_{t}^{m, j}$ is $N$-periodic in the variable $j$ for $t \in\left[0, \eta_{m}\right]$.

Next we have

& =\hat{\mu}_{n}\left(\psi_{1}^{m}\left(\hat{\mu}_{n}\left({ }^{0} V^{m}, \sigma W_{n}\right),{ }^{0} V^{m}, \sigma W_{n}\right)\right)=\hat{\mu}_{n}\left({ }^{1} V^{m}, \sigma W_{n}\right),

where ${ }^{1} V^{m}$ is equal to the solution of (36) on the time interval $\left[0,2 \eta_{m}\right]$, and again $N$-periodic.

(i) For any Borelian of $\left(\mathcal{T}^{\mathbb{Z}}\right)^{2}$ we have $\hat{\mu}_{n}\left(X_{n}\right) \circ \iota(A)=\hat{\mu}_{n}\left(X_{n}\right)\left(\iota^{-1}(A)\right)=\hat{\mu}_{n}\left(X_{n}\right)((A \cap\{0 \times$ $\left.\left.\mathcal{T}^{\mathbb{Z}}\right\}\right)_{2}$ ), where $\left(A \cap\left\{0 \times \mathcal{T}^{\mathbb{Z}}\right\}\right)_{2}$ is the second coordinate $y$ of the elements of $A$ of the form $(0, y)$. This means that $\hat{\mu}_{n}\left(X_{n}\right) \circ \iota=\hat{\mu}_{n}\left(0_{n}, X_{n}\right)$.
(ii) Let $A$ be a Borelian of $\left(\mathcal{T}^{\mathbb{Z}}\right)^{2}$. We have

### 3.3 Proof of Theorem 2.5.(i)-(iii)

It turns out to be convenient, in order to prove the Theorem, to use the $L^{2}$ distance on $\mathcal{T}^{\mathbb{Z}}$ given by

The reason for this is that we are then able to use the tools of Fourier analysis since the measures we consider are shift invariant, i.e. invariant to spatial translations.

Let $D_{T, L^{2}}$ be the corresponding Wasserstein- 1 metric on $\mathcal{P}\left(\mathcal{T}^{\mathbb{Z}}\right)$ induced by $d_{L^{2}}(u, v)$.
Remark 3.10. The topology induced by $D_{T, L^{2}}$ on $\mathcal{P}\left(\mathcal{T}^{\mathbb{Z}}\right)$ is coarser than the one induced by $D_{T}$. Hence it will suffice for us to prove the LDP with respect to the topology on $\mathcal{P}\left(\mathcal{T}^{\mathbb{Z}}\right)$ induced by the metric $D_{T, L^{2}}$. This is because we prove in Lemma 3.15 that the sequence $\Pi^{n}$ is exponentially tight for the topology induced by $D_{T}$ on $\mathcal{P}\left(\mathcal{T}^{\mathbb{Z}}\right)$. We can then use [8, Corollary 4.2.6] which states that if $\Pi^{n}$ satisfies an LDP for a coarser topology, then it does satisfy the same LDP for a finer topology. Lemma 3.15 is proved in Section 3.4.

We use [8, Th. 4.2.23] to prove the LDP for $\hat{\mu}_{n}\left(V_{n}\right)$ on $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ induced by the metric $D_{T, L^{2}}$. The common probability space in which we perform the exponentially equivalent approximations is $\left(\mathcal{T}^{N}, Q^{n}\right)$ which contains the random variable $\left(V_{t}^{j}\right)$, as well as (as explained in Corollary 3.6) the random variables $\left(\sigma W_{t}^{j}\right)$ which are distributed as $P^{\otimes N}$. We approximate $\hat{\mu}_{n}\left(V_{n}\right)$ by $\Psi^{m}\left(\hat{\mu}_{n}\left(\sigma W_{n}\right)\right)$. It is noted in Lemma 3.8 that the approximations $\Psi^{m}$ are continuous with respect to the topology induced by $D_{T}$, so that they must also be continuous with respect to the topology induced by $D_{T, L^{2}}$.

The proof is based on Lemma 3.16. According to this Lemma for any $j \in \mathbb{N}^{*}$, we have

By construction, the sequence $\left(m_{j}\right)_{j \geq 1}$ is strictly increasing and hence $\lim _{j \rightarrow \infty} m_{j}=\infty$.
Next define the sets

The following Lemma shows that $\mathfrak{A}$ is not empty.

Lemma 3.11. If $I^{(3)}(\mu)<\infty$, then $\mu \in \mathfrak{A}$.
Proof. We prove that if $I^{(3)}(\mu)<j$, then $\mu \in \mathfrak{A}_{j}$ and so we also have $\mu \in \bigcap_{k \geq j} \mathfrak{A}_{k}$. By Theorem 2.6, we know that

We deduce by Corollary 3.6 that

\leq & Q^{n}\left(D_{T, L^{2}}\left(\Psi^{m_{j}}\left(\hat{\mu}_{n}\left(\sigma W_{n}\right)\right), \hat{\mu}_{n}\left(V_{n}\right)\right)>2^{-(j+1)}\right) \\
& +Q^{n}\left(D_{T, L^{2}}\left(\Psi^{m_{j+1}}\left(\hat{\mu}_{n}\left(\sigma W_{n}\right)\right), \hat{\mu}_{n}\left(V_{n}\right)\right)>2^{-(j+1)}\right) \\
\leq & Q^{n}\left(D_{T, L^{2}}\left(\Psi^{m_{j}}\left(\hat{\mu}_{n}\left(\sigma W_{n}\right)\right), \hat{\mu}_{n}\left(V_{n}\right)\right)>2^{-(j+1)}\right) \\
& +Q^{n}\left(D_{T, L^{2}}\left(\Psi^{m_{j+1}}\left(\hat{\mu}_{n}\left(\sigma W_{n}\right)\right), \hat{\mu}_{n}\left(V_{n}\right)\right)>2^{-(j+2)}\right)
\end{aligned}
$$

In addition, using $\log (a+b) \leq \log (2 \max (a, b))=\log (2)+\max (\log (a), \log (b))$ and (47), we obtain

& \left.\varlimsup_{n \rightarrow \infty} \frac{1}{N} \log Q^{n}\left(D_{T, L^{2}}\left(\Psi^{m_{j+1}}\left(\hat{\mu}_{n}\left(\sigma W_{n}\right)\right), \hat{\mu}_{n}\left(V_{n}\right)\right)>2^{-(j+2)}\right)\right\} \leq \\
& \max \{-j,-(j+1)\}=-j .
\end{aligned}
$$

Then, by (50) we conclude that $\forall \mu \in \mathfrak{A}_{j}^{c}$ we have $I^{(3)}(\mu) \geq j$. It ends the proof.
We define $\Psi: \mathfrak{A} \rightarrow \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ as follows

it is true that $\lim _{j, k \rightarrow \infty} D_{T, L^{2}}\left(\Psi^{m_{j}}(\mu), \Psi^{m_{j+k}}(\mu)\right)=0$.
In the notation of [8, Th. 4.2.23], $\epsilon=N^{-1}, \tilde{\mu}_{\epsilon}=\Pi^{n}, f:=\Psi, \mu_{\epsilon}=\Pi_{0}^{n}$ and $f^{j}:=\Psi^{m_{j}}$.
Step 1: Exponential equivalence
The 'exponentially equivalent' property requires that for any $\delta>0$, and recalling the definition of $V_{n}$ in Corollary 3.6 and the fact that the law of $\hat{\mu}_{n}\left(V_{n}\right)$ is $\Pi^{n}$ (also in Corollary 3.6 ),

Step 2: Uniform Convergence on Level Sets of $I^{(3)}$
The second property required for [8, Th. 4.2.23] is the uniform convergence on level sets, $\mathcal{L}_{I^{(3)}}(\alpha):=\left\{\mu: I^{(3)}(\mu) \leq \alpha\right\}$, of $I^{(3)}$, that is we must prove that for any $\alpha>0$,

for all $\mu \in \mathcal{L}_{I^{(3)}}(\alpha)$.
Step 3: Rate Function We have thus established the LDP. It remains for us to prove that the rate function is of the form noted in the theorem, and its unique minimum is given by $\mu_{*}$. According to [8, Th. 4.2.23] ,

where $H(\mu):=\infty$ if there does not exist $\zeta \in \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ such that $\Psi(\zeta)=\mu$. Since the unique zero of $I^{(3)}$ is $P^{\otimes \mathbb{Z}}$, we can immediately infer that the unique zero of $H$ is $\Psi\left(P^{\otimes \mathbb{Z}}\right)$, which is $\mu_{*}$. In Section 3.6 we prove that this satisfies the McKean-Vlasov stochastic differential equation stated in the Theorem.

Remark 3.12. Theorem 4.2.23 of [8] requires $\Psi$ to be defined and measurable in $\mathcal{P}\left(\mathcal{T}^{\mathbb{Z}}\right)$, not only in $\mathfrak{A}$. Since $\mathfrak{A}$ is non empty thanks to Lemma 3.11, measurable as a countable union of closed sets, we can extend $\Psi$ to a measurable function in $\mathcal{P}\left(\mathcal{T}^{\mathbb{Z}}\right)$ by simply setting it to an arbitrary measure, say $P^{\otimes \mathbb{Z}}$, in $\mathfrak{A}^{c}$.

### 3.4 Exponential Tightness of $\left(\Pi^{n}\right)_{n \in \mathbb{Z}^{+}}$on $\left(\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right), D_{T}\right)$

In this section we prove in Lemma 3.15 the exponential tightness of $\left(\Pi^{n}\right)_{n \in \mathbb{Z}^{+}}$for the topology induced by $D_{T}$ on $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$. As pointed out in Remark 3.10 it is necessary to prove Theorem 2.5.

Lemma 3.13 is crucial for comparing the system with correlations with the uncorrelated system via Girsanov's Theorem. It is used in the proof of the exponential tightness of $\left(\Pi^{n}\right)_{n \in \mathbb{Z}^{+}}$in Lemma 3.15 and is used, as well as Lemma 3.14, several times in the sequel.

Just as for several of the Lemmas below it makes good use of the Discrete Fourier Transform (DFT) of the relevant variables. The corresponding material and notations are presented in Appendix B. As a general notation, given an $I_{n}$-periodic sequence $\left(\beta^{j}\right)_{j \in I_{n}}$, we note $\left(\tilde{\beta}^{p}\right)_{p \in I_{n}}$ its length $N$ DFT defined by

Proof. The proof is rather typical of many of the proofs in this paper. It uses some definitions and results that are given in Appendix B. It follows three steps.

## Step 1: Go to the Fourier domain

By Parseval's Theorem,

& =\frac{1}{N} \sigma^{-2} \sum_{q \in I_{n}} \mathbb{E}^{\gamma^{\hat{\mu}_{n}\left(V_{n}\right)}}\left[\Lambda_{s}(G) \tilde{G}_{s}^{q} \int_{0}^{s} \tilde{G}_{r}^{-p} d \tilde{V}_{r}^{p}\right]
\end{aligned}
$$

According to Corollary B. 12 and its proof

& =\mathbb{E}^{\hat{\mu}^{\hat{\mu}_{n}\left(V_{n}\right)}}\left[\tilde{\Lambda}_{s}^{|p|}(\tilde{G}) \tilde{G}_{s}^{p} \int_{0}^{s} \tilde{G}_{r}^{-p} d \tilde{V}_{r}^{p}\right] .
\end{aligned}
$$

This allows us to rewrite (60) as

## Step 2: Find an upper bound for the Fourier transformed quantities:

By Lemma B.14,

$$

and

\begin{aligned}
\left|\mathbb{E}^{\gamma^{\mu_{n}\left(V_{n}\right)}}\left[\tilde{\Lambda}_{t}^{|p|}(\tilde{G}) \tilde{G}_{t}^{p} \int_{0}^{t} \tilde{G}_{s}^{-p} d \tilde{W}_{s}^{p}\right]\right|^{2} & \leq\left(C_{\mathcal{J}}\right)^{2} \sum_{j \in I_{n}} f\left(V_{t}^{j}\right)^{2} \sum_{k \in I_{n}}\left|\int_{0}^{t} f\left(V_{s}^{k}\right) d \tilde{W}_{s}^{p}\right|^{2} \\
& \leq N\left(C_{\mathcal{J}}\right)^{2} \sum_{k \in I_{n}}\left|\int_{0}^{t} f\left(V_{s}^{k}\right) d \tilde{W}_{s}^{p}\right|^{2}
\end{aligned}
$$

Applying Parseval's Theorem to the right hand side of the previous inequality,

$$

We thus find through Gronwall's Inequality that

## Step 3: Apply Doob's submartingale inequality:

Now $\sum_{j, k \in I_{n}}\left(\int_{0}^{t} f\left(V_{s}^{k}\right) d W_{s}^{j}\right)^{2}$ is a submartingale, hence, for any $\kappa>0$,

Q^{n}\left(\sup _{t \in[0, T]} \frac{1}{N^{2}} \sum_{p \in I_{n}}\left|\tilde{\theta}_{t}^{p}\right|^{2} \geq K\right) & =Q^{n}\left(\sup _{t \in[0, T]} \exp \left(\frac{\kappa}{N} \sum_{p \in I_{n}}\left|\tilde{\theta}_{t}^{p}\right|^{2}\right) \geq \exp (\kappa N K)\right) \\
& \leq Q^{n}\left(\sup _{t \in[0, T]} \zeta_{t} \geq \exp (\kappa N K)\right) \\
& \leq \exp (-\kappa N K) \mathbb{E}\left[\zeta_{T}\right] .
\end{aligned}
$$

Now for $\kappa$ small enough, by Lemma A. 1 and the boundedness of $f$ there exists a constant $C$ such that $\mathbb{E}\left[\zeta_{T}\right] \leq \exp (N C)$ for all $N \in \mathbb{Z}^{+}$. We thus find that

& \leq \exp (N(C-\kappa K)),
\end{aligned}

from which we can conclude the Lemma by taking $K$ to be sufficiently large.

We have a similar result for $\theta^{m, j}$ defined in (37).
Lemma 3.14. For any $M>0$, there exists $C_{M}>0$ such that

Note that the DFT $\tilde{V}^{m, p}$ of the approximation $V^{m, j}$ satisfies the following system of SDEs, analog to (59):

The family of measures $\left(\Pi^{n}\right)_{n \in \mathbb{Z}^{+}}$is exponentially tight with respect to the topology on $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ induced by $D_{T}$. That is, for any $M>0$, there exists a compact set $K_{M} \subset \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ such that

Proof. Consider the event $\mathfrak{K}_{n, M}$ defined by

For any compact set $K_{M}$ of $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$, we have $\Pi^{n}\left(K_{M}^{c}\right)=Q^{n}\left(\hat{\mu}_{n}^{-1}\left(K_{M}^{c}\right)\right)$ so that, by (66)

\varlimsup_{n \rightarrow \infty} \frac{1}{N} \log \Pi^{n}\left(K_{M}^{c}\right) & \leq \max \left\{\varlimsup_{n \rightarrow \infty} \frac{1}{N} \log Q^{n}\left(\hat{\mu}_{n}^{-1}\left(K_{M}^{c}\right) \cap \mathfrak{K}_{n, M}^{c}\right), \varlimsup_{n \rightarrow \infty} \frac{1}{N} \log Q^{n}\left(\mathfrak{K}_{n, M}\right)\right\} \\
& \leq \max \left\{\varlimsup_{n \rightarrow \infty} \frac{1}{N} \log Q^{n}\left(\hat{\mu}_{n}^{-1}\left(K_{M}^{c}\right) \cap \mathfrak{K}_{n, M}^{c}\right),-M\right\},
\end{aligned}
$$

so that it suffices for us to prove that

By Proposition 3.4, and using the Cauchy-Schwarz Inequality,

& Q^{n}\left(\hat{\mu}_{n}^{-1}\left(K_{M}^{c}\right) \cap \mathfrak{K}_{n, M}^{c}\right)=\int_{\hat{\mu}_{n}^{-1}\left(K_{M}^{c}\right) \cap \mathfrak{K}_{n, M}^{c}} \exp \left(\sum_{j \in I_{n}} \int_{0}^{T} \theta_{s}^{j} d B_{s}^{j}-\frac{1}{2} \sum_{j \in I_{n}} \int_{0}^{T}\left(\theta_{s}^{j}\right)^{2} d s\right) d P^{\otimes N}(B) \\
& \leq\left\{\int_{\hat{\mu}_{n}^{-1}\left(K_{M}^{c}\right) \cap \mathfrak{K}_{n, M}^{c}} \exp \left(2 \sum_{j \in I_{n}} \int_{0}^{T} \theta_{s}^{j} d B_{s}^{j}-2 \sum_{j \in I_{n}} \int_{0}^{T}\left(\theta_{s}^{j}\right)^{2} d s\right) d P^{\otimes N}(B)\right\}^{\frac{1}{2}} \\
& \times\left\{\int_{\hat{\mu}_{n}^{-1}\left(K_{M}^{c}\right) \cap \mathfrak{K}_{n, M}^{c}} \exp \left(\sum_{j \in I_{n}} \int_{0}^{T}\left(\theta_{s}^{j}\right)^{2} d s\right) d P^{\otimes N}(B)\right\}^{\frac{1}{2}}
\end{aligned}
$$

Now using the properties of a supermartingale,

$$
\begin{aligned}
\int_{\hat{\mu}_{n}^{-1}\left(K_{M}^{c}\right) \cap \mathfrak{K}_{n, M}^{c}} \exp \left(2 \sum_{j \in I_{n}}\right. & \left.\int_{0}^{T} \theta_{s}^{j} d B_{s}^{j}-2 \sum_{j \in I_{n}} \int_{0}^{T}\left(\theta_{s}^{j}\right)^{2} d s\right) d P^{\otimes N}(B) \\
& \leq \int_{\mathcal{T}^{N}} \exp \left(2 \sum_{j \in I_{n}} \int_{0}^{T} \theta_{s}^{j} d B_{s}^{j}-2 \sum_{j \in I_{n}} \int_{0}^{T}\left(\theta_{s}^{j}\right)^{2} d s\right) d P^{\otimes N}(B) \leq 1
\end{aligned}
$$

Using the definition of $\mathfrak{K}_{n, M}$ in (65), and since $\Pi_{0}^{n}=P^{\otimes N} \circ \hat{\mu}_{n}^{-1}$

$$
\begin{aligned}
\int_{\hat{\mu}_{n}^{-1}\left(K_{M}^{c}\right) \cap \mathfrak{K}_{n, M}^{c}} \exp \left(\sum_{j \in I_{n}} \int_{0}^{T}\left(\theta_{s}^{j}\right)^{2} d s\right) d P^{\otimes N}(B) \leq \exp \left(N T C_{M}\right) & P^{\otimes N}\left(\hat{\mu}_{n}^{-1}\left(K_{M}^{c}\right)\right) \\
& =\exp \left(N T C_{M}\right) \Pi_{0}^{n}\left(K_{M}^{c}\right)
\end{aligned}
$$

Now $\left(\Pi_{0}^{n}\right)_{n \in \mathbb{Z}^{+}}$is exponentially tight (a direct consequence of Theorem 2.6), which means that we can choose $K_{M}$ to be such that

so that we can conclude (67) as required.

### 3.5 Exponentially Equivalent Approximations using $\Psi^{m}$

The following Lemma, which is central in the proof of Theorem 2.5, is the main result of this section. Its proof is long and technical and uses four auxiliary Lemmas, Lemmas 3.20-3.23 whose proofs are found in Appendix D.

Lemma 3.16. For any $\delta>0$,

Proof. The proof uses the following ideas.
By Lemma 3.8, $\Psi^{m}\left(\hat{\mu}_{n}\left(\sigma W_{n}\right)\right)=\hat{\mu}_{n}\left(V_{n}^{m}\right)$. By Lemma 3.17, we can find an upperbound of $D_{T, L^{2}}\left(\hat{\mu}_{n}\left(V_{n}^{m}\right), \hat{\mu}_{n}\left(V_{n}\right)\right)$ using the $L^{2}$ distance between $V_{n}^{m}$ and $V_{n}$, so that the proof boils down to comparing the solution $V_{n}$ to the system of equations (29) and (30) to the solution $V_{n}^{m}$ to the approximating system of equations (37) constructed in Section 3.2.1 by an $L^{2}$ distance. By equations (37) and (29) this is equivalent to comparing the $L^{2}$ distance between $\theta^{m}$ and $\theta$. As already mentioned, it is technically easier to work in the Fourier domain with the $L^{2}$ distance between $\tilde{\theta}^{m, p}$ and $\tilde{\theta}^{p}, p \in I_{n}$, the Fourier transforms of $\left(\theta^{m, j}\right)_{j \in I_{n}}$ and $\left(\theta^{j}\right)_{j \in I_{n}}$. This distance naturally brings in the operators $\bar{L}_{\hat{\mu}_{n}\left(V_{n}\right)}^{t}$ and $\bar{L}_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{t}$ defined in Appendix C, in effect their Fourier transforms.

The following Lemma (proved page 32) relates the Wasserstein distance $D_{T, L^{2}}$ between two empirical measures associated with two elements of $\mathcal{T}^{N}$ to the $L^{2}$ distance between these elements.
Lemma 3.17. For all $X_{n}, Y_{n} \in \mathcal{T}^{N}$ we have

where $b$ is defined by (7).

We now follow our plan for the proof of Lemma 3.16.
By Lemmas 3.8 and 3.17 we write

$$

In order to prove (68) it therefore suffices for us to prove that for any arbitrary $M, \delta>0$, which are now fixed throughout the rest of this proof,

\end{equation*}

Using the expression in (59), it follows from the Cauchy-Schwarz inequality that for any $t \in[0, T]$,

\end{equation*}
$$

In order to continue our plan we introduce the discrete time approximation ${ }^{m} \tilde{\theta}_{s^{(m)}}^{p}$ of $\tilde{\theta}_{s}^{p}$

{ }^{m} \tilde{\theta}_{s^{(m)}}^{p}=\frac{1}{N \sigma^{2}} \mathbb{E}^{\gamma^{\hat{\mu}_{n}\left(V_{n}\right)}}\left[\tilde{\Lambda}_{s(m)}^{|p|}(\tilde{G}) \tilde{G}_{s^{(m)}}^{p} \int_{0}^{s^{(m)}} \tilde{G}_{r^{(m)}}^{-p} d \tilde{V}_{r}^{p}\right] \tag{71}
\end{equation*}

We obtain in the following Lemma a characterization of ${ }^{m} \tilde{\theta}_{s^{(m)}}^{p}$
Lemma 3.18. Assume $s^{(m)}=v \eta_{m}, v=0, \cdots, m$. We have

\tilde{L}_{\hat{\mu}_{n}\left(V_{n}\right)}^{p}\left(v \eta_{m}, w \eta_{m}\right)=N^{-1} \mathbb{E}^{\gamma^{\hat{\mu}_{n}\left(V_{n}\right)}}\left[\tilde{\Lambda}_{v \eta_{m}}^{|p|}(\tilde{G}) \tilde{G}_{v \eta_{m}}^{p} \tilde{G}_{w \eta_{m}}^{-p}\right]

and $\delta \tilde{V}^{p}$ is the $v+1$-dimensional vector

& =\sigma^{-2} \sum_{w=0}^{v-1} N^{-1} \mathbb{E}^{\gamma^{\hat{\mu}_{n}\left(V_{n}\right)}}\left[\tilde{\Lambda}_{v \eta_{m}}^{|p|}(\tilde{G}) \tilde{G}_{v \eta_{m}}^{p} \tilde{G}_{w \eta_{m}}^{-p}\right]\left(\tilde{V}_{(w+1) \eta_{m}}^{p}-\tilde{V}_{w \eta_{m}}^{p}\right) \\
& =\sigma^{-2} \sum_{w=0}^{v-1} \tilde{L}_{\hat{\mu}_{n}\left(V_{n}\right)}^{p}\left(v \eta_{m}, w \eta_{m}\right)\left(\tilde{V}_{(w+1) \eta_{m}}^{p}-\tilde{V}_{w \eta_{m}}^{p}\right) \\
& =\sigma^{-2}\left(\tilde{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}\right)}^{p} \delta \tilde{V}^{p}\right)\left(v \eta_{m}\right),
\end{aligned}

where $\overline{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}\right)}^{p}$ is the $(v+1) \times(v+1)$ matrix $\left(\tilde{L}_{\hat{\mu}_{n}\left(V_{n}\right)}^{p}\left(w \eta_{m}, u \eta_{m}\right)\right)_{w, u=0, \cdots, v}$ defined in Remark 3.3 and Appendix C.2.

The autocorrelation function $L_{\hat{\mu}_{n}\left(V_{n}\right)}$ (resp. $\left.L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}\right)$ involved in the sequence $\left(V^{j}\right)_{j \in I_{n}}$ (resp. $\left.\left(V^{m, j}\right)_{j \in I_{n}}\right)$ and hence in the sequence $\left(\theta^{j}\right)_{j \in I_{n}}$ (resp. $\left.\left(\theta^{m, j}\right)_{j \in I_{n}}\right)$ arises from the values of the autocorrelation function $R_{\mathcal{J}}$, defined in (3), on a grid $I_{n} \times I_{n}\left(\operatorname{resp} . I_{q_{m}} \times I_{n}\right)$. Since we are working in the discrete Fourier domain, it is natural, as explained in Appendix C.2, and in fact necessary, to consider the following four operators (in the discrete time setting, matrixes) in order to compare $\tilde{\theta}^{p}$ and $\tilde{\theta}^{m, p}$. In detail, $\overline{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}\right)}^{p}$, (resp. $\left.\overline{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{p}\right)$, $p \in I_{n}$ is obtained by taking the length $N$ DFT of the length $N$ sequence $\left(L_{\hat{\mu}_{n}\left(V_{n}\right)}^{i}\right)_{i \in I_{n}}$ (resp. $\left.\left(L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{i}\right)_{i \in I_{n}}\right)$. Similarly, $\overline{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}\right)}^{q_{m}, p}$, (resp. $\left.\overline{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{q_{m}, p}\right), p \in I_{n}$ is obtained by taking the length $N$ DFT of the length $Q_{m}$ sequence $\left(L_{\hat{\mu}_{n}\left(V_{n}\right)}^{i}\right)_{i \in I_{q_{m}}}\left(\right.$ resp. $\left.\left(L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{i}\right)_{i \in I_{q_{m}}}\right)$ padded with $N-Q_{m}$ zeros.

We then use the following decomposition

\sigma^{-2}\left|\left(\left(\tilde{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}\right)}^{q_{m}, p}-\tilde{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{p}\right) \delta \tilde{V}^{p}\right)\left(v \eta_{m}\right)\right|+\sigma^{-2}\left|\left(\tilde{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{p}\left(\delta \tilde{V}^{p}-\delta \tilde{V}^{m, p}\right)\right)\left(v \eta_{m}\right)\right|+ \\
\left|\sigma^{-2}\left(\tilde{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{p} \delta \tilde{V}^{m, p}\right)\left(v \eta_{m}\right)-\tilde{\theta}_{s}^{m, p}\right|,
\end{array}

Each term on the right hand side performs a specific comparison:
First term: Allows to compare $\tilde{\theta}_{s}^{p}$ and its time discretized version ${ }^{m} \tilde{\theta}_{s^{(m)}}^{p}$ which is equal, thanks to Lemma 3.18, to $\sigma^{-2}\left(\overline{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}\right)}^{p} \delta \tilde{V}^{p}\right)\left(v \eta_{m}\right)$.

Second term: Allows to compare the operator $\overline{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}\right)}^{p}$ with its space/correlation truncated and Fourier interpolated version $\overline{\tilde{L}}_{\tilde{\mu}_{n}\left(V_{n}\right)}^{q_{m}, p}$.

Third term: Allows to compare the operator $\overline{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}\right)}^{q_{m}, p}$ with the operator $\overline{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{p}$ corresponding to the approximated solution.

Fourth term: Allows to compare the time discretized versions of the $\tilde{V}_{n}$ and $\tilde{V}_{n}^{m}$ processes.
Fifth term Allows to compare the space/correlation truncated and Fourier interpolated opertor $\overline{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{q_{m, p}}$ with its Fourier interpolation $\tilde{\theta}^{m, p}$.

By slightly changing the order of the terms we write, remember that $s^{(m)}=v \eta_{m}$,

& +\frac{5}{N^{2}} \sum_{p \in I_{n}}\left|\sigma^{-2}\left(\overline{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{p} \delta \tilde{V}^{m, p}\right)\left(v \eta_{m}\right)-\tilde{\theta}_{s}^{m, p}\right|^{2} & \} \alpha_{v \eta_{m}}^{3} \\
& +\frac{5}{N^{2} \sigma^{4}} \sum_{p \in I_{n}}\left|\left(\left(\overline{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}\right)}^{q_{m}, p}-\overline{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{p}\right) \delta \tilde{V}^{p}\right)\left(v \eta_{m}\right)\right|^{2} & \} \alpha_{v \eta_{m}}^{4} \\
& +\frac{5}{N^{2} \sigma^{4}} \sum_{p \in I_{n}}\left|\left(\overline{\tilde{L}}_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{p}\left(\delta \tilde{V}^{p}-\delta \tilde{V}^{m, p}\right)\right)\left(v \eta_{m}\right)\right|^{2} & \} \alpha_{v \eta_{m}}^{5} . \tag{73}

Our first action is to remove the term $\alpha^{5}$ through the use of Gronwall's Lemma.

The crucial idea of the proof is to upper bound the left hand side of (69) by

If $X_{n}=\left(X^{-n}, \cdots, X^{n}\right)$, we note $s\left(X_{n}\right)$ the element $\left(X^{s(-n)}, \cdots, X^{s(n)}\right)$. The knowledge of $\hat{\mu}_{n}\left(X_{n}\right)$ does not imply that of $X_{n}$, in effect it implies the knowledge of all $s\left(X_{n}\right) \mathrm{s}$ without knowing which permutation is the correct one. Choose one such element, say $s_{0}\left(X_{n}\right)$. Similarly choose $s_{1}\left(Y_{n}\right)$. There exists a family of couplings ${ }^{1} \xi^{s}$ such that

\int\left\|u^{0}-v^{0}\right\|_{L^{2}}^{2} d \xi^{s}(u, v)=\frac{1}{N} \sum_{k \in I_{n}}\left\|X^{s_{0}(k)}-Y^{s\left(s_{1}(k)\right)}\right\|_{L^{2}}^{2}
$$

from which we obtain, for $s=s_{0} s_{1}^{-1}$

$$
D_{T, L^{2}}\left(\hat{\mu}_{n}\left(X_{n}\right), \hat{\mu}_{n}\left(Y_{n}\right)\right)^{2} \leq \frac{b^{2}}{N} \sum_{k \in I_{n}}\left\|X^{k}-Y^{k}\right\|_{L^{2}}^{2}
$$

which is the announced result.
The proofs of Lemma 3.20-3.23 are found in Appendix D.

### 3.6 Characterization of the Limiting Process

We prove in this Section that the limit equations are given by (14), i.e. Theorem 2.5.iv. This is achieved by first showing that the solution to (14), without the condition that $\mu_{*}$ is the law of $Z$, is unique and has a closed form expression as a function of the Brownian motions $W^{j}$. This is the content of the following Lemma whose proof can be found in Appendix E. This proof is based on an adaptation of the theory of Volterra equations of the second type [26] to our, stochastic, framework.

[^1]Lemma 3.24. Let $\mu \in \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$. The system of equations (14)

\end{aligned}

has a unique solution given by

& V_{t}^{j}=\sigma W_{t}^{j}+\sum_{i \in \mathbb{Z}} \int_{0}^{t}\left(\int_{0}^{s} L_{\mu}^{i}(s, u) d W_{u}^{i+j}\right) d s+ \\
& \sigma^{-1} \sum_{i, \ell \in \mathbb{Z}} \int_{0}^{t}\left(\int_{0}^{s} M_{\mu}^{i}(s, u)\left(\int_{0}^{u} L_{\mu}^{\ell-i}(u, v) d W_{v}^{\ell+j}\right) d u\right) d s \tag{88}
\end{align*}
$$

where $M_{\mu}^{k}$ is defined in the proof and satisfies

\sup _{s, u \in[0, t]} \sum_{k}\left|M_{\mu}^{k}(s, u)\right|<\infty
$$

Note $Q^{m, n}$ the law of the solution to (31). Lemma 3.16 indicates that $\Pi^{m, n}=Q^{m, n} \circ$ $\hat{\mu}_{n}\left(V_{n}^{m}\right)$ satisfies an LDP with the same good rate function $H$ as $\Pi^{n}$.

Lemma 3.25. The limit law of $Q^{m, n}$ when $m, n \rightarrow \infty$ is $\mu_{*}$, the unique zero of the rate function $H$. Moreover, for all $k \in I_{n}, t, s \in[0, T]$

\lim _{m, n \rightarrow \infty} \int_{\mathcal{T}^{N}} L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{k}(t, s) d Q^{m, n}\left(V_{n}^{m}\right)=L_{\mu_{*}}^{k}(t, s)
$$

Proof. We know that $H$ has a unique zero, noted $\mu_{*}$. This implies that $\Pi^{m, n}$ converges weakly to $\delta_{\mu_{*}}$ and therefore, for all $F \in C_{b}\left(\mathcal{P}\left(\mathcal{T}^{\mathbb{Z}}\right)\right)$,

From the relation $\Pi^{m, n}=Q^{m, n} \circ \hat{\mu}_{n}\left(V_{n}^{m}\right)^{-1}$ we infer that

Let us choose a function $f \in C_{b}\left(\mathcal{T}^{\mathbb{Z}}\right)$ and define $F: \mathcal{P}\left(\mathcal{T}^{\mathbb{Z}}\right) \rightarrow \mathbb{R}$ by

so that we have

& \lim _{m, n \rightarrow \infty} \int_{\mathcal{T}^{N}} \int_{\mathcal{T}_{\mathbb{Z}}} f(V) d \hat{\mu}_{n}\left(V_{n}^{m}\right)(V) d Q^{m, n}\left(V_{n}^{m}\right)= \\
& \quad \lim _{m, n \rightarrow \infty} \frac{1}{N} \sum_{i \in I_{n}} \int_{\mathcal{T}^{N}} f\left(S^{i} V_{n}^{m}\right) d Q^{m, n}\left(V_{n}^{m}\right)=\int_{\mathcal{T}_{\mathbb{Z}}} f(V) d \mu_{*}(V)
\end{aligned}
$$

We note that $Q^{m, n}$ is invariant under a uniform shift of the indexes, i.e. satisfies

for all $i \in I_{n}$, so that

\frac{1}{N} \sum_{i \in I_{n}} \int_{\mathcal{T}^{N}} f\left(S^{i} V_{n}^{m}\right) d Q^{m, n}\left(V_{n}^{m}\right)=\int_{\mathcal{T}^{N}} f\left(V_{n}^{m}\right) d Q^{m, n}\left(V_{n}^{m}\right)
$$

and therefore

\lim _{m, n \rightarrow \infty} \int_{\mathcal{T}^{N}} f\left(V_{n}^{m}\right) d Q^{m, n}\left(V_{n}^{m}\right)=\int_{\mathcal{T}_{\mathbb{Z}}} f(V) d \mu_{*}(V)

Since this is true for all $f \in C_{b}\left(\mathcal{T}^{\mathbb{Z}}\right)$ we have proved that the limiting law of $Q^{m, n}$ is $\mu_{*}$.
Next consider the function $F: \mathcal{P}\left(\mathcal{T}^{\mathbb{Z}}\right) \rightarrow \mathbb{R}$

We now prove Theorem 2.5.iii
Theorem 3.26. The equations describing the unique 0, $\mu_{*}$, of the rate function $H$ are (14).
Proof. We prove that for all $n \geq 0$

\theta_{t}^{m, j} & =\sigma^{-2} \sum_{i \in I_{q_{m}}} \mathbb{E}^{\hat{\gamma}_{t}^{\hat{\mu}_{n}\left(V_{n}^{m}\right)}}\left[G_{t^{(m)}}^{m, 0} \int_{0}^{t^{(m)}} G_{s}^{m, i} d V_{s}^{m, i+j}\right] \\
& =\sigma^{-2} \sum_{i \in I_{q_{m}}} \int_{0}^{t^{(m)}} L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{i}\left(t^{(m)}, s^{(m)}\right) d V_{s}^{m, i+j}
\end{aligned}
$$

We also have, for $j \in \mathbb{Z}$.

\theta_{t}^{j}=\sigma^{-2} \sum_{i \in \mathbb{Z}} \int_{0}^{t} L_{\mu_{*}}^{i}(t, s) d V_{s}^{i+j}
$$

Write

\theta_{t}^{j}-\theta_{t}^{m, j}= & \sigma^{-2} \sum_{i \in I_{q_{m}}} \int_{0}^{t}\left(L_{\mu_{*}}^{i}(t, s)-L_{\mu_{*}}^{i}\left(t^{(m)}, s^{(m)}\right)\right) d V_{s}^{i+j} & & \} \alpha_{t}^{j, 1} \\
& +\sigma^{-2} \sum_{i \in I_{q_{m}}} \int_{t^{(m)}}^{t} L_{\mu_{*}}^{i}\left(t^{(m)}, s^{(m)}\right) d V_{s}^{i+j} & & \} \alpha_{t}^{j, 2} \\
& +\sigma^{-2} \sum_{i \in I_{q_{m}}} \int_{0}^{t^{(m)}}\left(L_{\mu_{*}}^{i}\left(t^{(m)}, s^{(m)}\right)-L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{i}\left(t^{(m)}, s^{(m)}\right)\right) d V_{s}^{i+j} & \} \alpha_{t}^{j, 3} \\
& +\sigma^{-2} \sum_{i \in \mathbb{Z} / I_{q_{m}}} \int_{0}^{t} L_{\mu_{*}}^{i}(t, s) d V_{s}^{i+j} & \} \alpha_{t}^{j, 4} \\
& +\sigma^{-2} \sum_{i \in I_{q_{m}}} \int_{0}^{t^{(m)}} L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{i}\left(t^{(m)}, s^{(m)}\right)\left(\theta_{s}^{i+j}-\theta_{s}^{m, i+j}\right) d s, &
\end{array}
$$

so that we have

\theta_{t}^{j}-\theta_{t}^{m, j}=\sum_{k=1}^{4} \alpha_{t}^{j, k}+\sigma^{-2} \sum_{i \in I_{q_{m}}} \int_{0}^{t^{(m)}} L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{i}\left(t^{(m)}, s^{(m)}\right)\left(\theta_{s}^{i+j}-\theta_{s}^{m, i+j}\right) d s
$$

To simplify notations further we write $L_{n}^{i}\left(t^{(m)}, s^{(m)}\right)$ for $L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{i}\left(t^{(m)}, s^{(m)}\right)$ since there is no ambiguity, and define

The previous equation writes

This is a Volterra equation of the second type [26]. We solve it for $\Phi$ as a function of the $\alpha$ s and use the following Lemma whose proof can be found in Appendix F.

Lemma 3.27. For all $\varepsilon>0$, there exists $m_{0}(\varepsilon)$ in N such that for all $m \geq m_{0}$

We use standard results on Volterra equations [26] to write

\end{equation*}

where we have noted $\lambda=\sigma^{-2}$, the "resolvent kernel" $\tilde{H}(\varphi)(t, s, \lambda)$ is given by the series of iterated kernels

and

\tilde{L}_{n, \ell+1}^{*}(\varphi)\left(t^{(m)}, s^{(m)}\right)=\int_{0}^{t^{(m)}} \tilde{L}_{n}^{*}(\varphi)\left(t^{(m)}, u^{(m)}\right) \tilde{L}_{n, \ell}^{*}(\varphi)\left(u^{(m)}, s^{(m)}\right) d u
$$

The convergence of the series (91) is guaranteed by the fact that the two functions

$$
A_{n}(\varphi, t)^{2}=\int_{0}^{T}\left|\tilde{L}_{n}(\varphi)(t, s)\right|^{2} d s \text { and } B_{n}(\varphi, s)^{2}=\int_{0}^{T}\left|\tilde{L}_{n}(\varphi)(t, s)\right|^{2} d t
$$

are upperbounded by $T^{2} a^{2} b^{2}$ independently of $n$, thanks to Proposition C.8. The theory of Volterra equations then guarantees that

$$

for some positive constant $C$ independent of $n, m$.
Equation (90) then implies that

\left|\tilde{\Phi}_{t}(\varphi)\right|^{2} \leq 2\left|\tilde{\alpha}_{t}(\varphi)\right|^{2}+2 \lambda^{2} C^{2} \int_{0}^{t}\left|\tilde{\alpha}_{s}(\varphi)\right|^{2} d s
$$

By Parseval's Theorem

\sum_{j \in I_{n}}\left|\Phi_{t}^{j}\right|^{2} \leq 2 \sum_{j \in I_{n}}\left|\alpha_{t}^{j}\right|^{2}+2 \lambda^{2} C^{2} \int_{0}^{t} \sum_{j \in I_{n}}\left|\alpha_{s}^{j}\right|^{2} d s
$$

Taking the expected value of both sides and using the spatial stationarity of $\left(\Phi_{t}^{j}\right)_{j \in I_{n}}$ and $\left(\alpha_{t}^{j}\right)_{j \in I_{n}}$ we have for any $j \in I_{n}$

\mathbb{E}\left[\left|\Phi_{t}^{j}\right|^{2}\right] \leq 2 \mathbb{E}\left[\left|\alpha_{t}^{j}\right|^{2}\right]+2 \lambda^{2} C^{2} \int_{0}^{t} \mathbb{E}\left[\left|\alpha_{s}^{j}\right|^{2}\right] d s
$$

Since by Lemma 3.27

$$
\mathbb{E}\left[\max _{k=1,2,3,4} \sup _{s \in[0, t]}\left|\alpha_{s}^{j, k}\right|^{2}\right] \rightarrow 0
$$

we conclude that

$$
\lim _{m, n \rightarrow \infty} \mathbb{E}\left[\sup _{s \in[0, t]}\left|\theta_{s}^{j}-\theta_{s}^{m, j}\right|^{2}\right]=0
$$

and therefore

$$
\sup _{s \in[0, t]}\left|V_{s}^{j}-V_{s}^{m, j}\right| \leq \int_{0}^{t} \sup _{\rho \in[0, s]}\left|\theta_{\rho}^{j}-\theta_{\rho}^{m, j}\right| d s \leq \sqrt{t}\left(\int_{0}^{t} \sup _{\rho \in[0, s]}\left(\theta_{\rho}^{j}-\theta_{\rho}^{m, j}\right)^{2} d s\right)^{1 / 2}
$$

and by Cauchy-Schwarz again

$$
\begin{aligned}
\mathbb{E}\left[\sup _{s \in[0, t]}\left|V_{s}^{j}-V_{s}^{m, j}\right|\right] \leq & \sqrt{t}\left(\mathbb{E}\left[\int_{0}^{t} \sup _{\rho \in[0, s]}\left(\theta_{\rho}^{j}-\theta_{\rho}^{m, j}\right)^{2} d s\right]\right)^{1 / 2} \\
& =\sqrt{t}\left(\int_{0}^{t} \mathbb{E}\left[\sup _{\rho \in[0, s]}\left(\theta_{\rho}^{j}-\theta_{\rho}^{m, j}\right)^{2}\right] d s\right)^{1 / 2}
\end{aligned}
$$

We conclude that

$$
\lim _{m, n \rightarrow \infty} \mathbb{E}\left[\sup _{s \in[0, t]}\left|V_{s}^{j}-V_{s}^{m, j}\right|\right]=0
$$

for all $j \in \mathbb{Z}$ and $t \in[0, T]$.

## A A martingale Expectation Inequality

We recall the result used in [1]:
Lemma A.1. Consider $B^{-n}, \cdots, B^{n} N$ independent Brownian motions and $h^{-n}, \cdots, h^{n} N$ previsible processes such that $N^{-1} \sum_{j \in I_{n}}\left(h_{t}^{j}\right)^{2} \leq 1$. Then, for all $\varepsilon<1 /(2 \sqrt{T})$, we have

Proof. Define $\alpha:=\frac{\varepsilon^{2}}{2 N}, X_{t}^{i j}=\int_{0}^{t} h_{s}^{i} d B_{s}^{j}, S_{t}:=\sum_{i \in I_{n}}\left(h_{t}^{i}\right)^{2}$, and $Y_{t}:=\sum_{i, j \in I_{n}}\left(X_{t}^{i j}\right)^{2}$. Using Itô's rule we obtain

Y_{t}=2 \sum_{i, j \in I_{n}} \int_{0}^{t} h_{s}^{i}\left(\int_{0}^{s} h_{u}^{i} d B_{u}^{j}\right) d B_{s}^{j}+N \int_{0}^{t} S_{u} d u
$$

Define the martingale

$$
Z_{t}:=\sum_{i, j \in I_{n}} \int_{0}^{t} h_{s}^{i}\left(\int_{0}^{s} h_{u}^{i} d B_{u}^{j}\right) d B_{s}^{j}
$$

Using the fact that $\left\langle B^{j}, B^{l}\right\rangle_{t}=\delta_{j l} t$, we have

$$
\langle Z, Z\rangle_{t}=\sum_{i, j, k \in I_{n}} \int_{0}^{t} h_{s}^{i} h_{s}^{k}\left(\int_{0}^{s} h_{u}^{i} d B_{u}^{j}\right)\left(\int_{0}^{s} h_{u}^{k} d B_{u}^{j}\right) d s
$$

Apply Cauchy-Schwarz to obtain

$$
\sum_{i \in I_{n}}\left|h_{s}^{i}\left(\int_{0}^{s} h_{u}^{i} d B_{u}^{j}\right)\right| \leq\left(\sum_{i \in I_{n}}\left(h_{s}^{i}\right)^{2}\right)^{1 / 2}\left(\sum_{i \in I_{n}}\left(\int_{0}^{s} h_{u}^{i} d B_{u}^{j}\right)^{2}\right)^{1 / 2}
$$

from which it follows that

\langle Z, Z\rangle_{t}=\left|\langle Z, Z\rangle_{t}\right| \leq \int_{0}^{t} S_{u} Y_{u} d u
$$

Now we have

e^{\alpha Y_{t}}=e^{2 \alpha Z_{t}+\alpha N \int_{0}^{t} S_{s} d s}=e^{2 \alpha Z_{t}-4 \alpha^{2}\langle Z, Z\rangle_{t}} \times e^{4 \alpha^{2}\langle Z, Z\rangle_{t}+\alpha N \int_{0}^{t} S_{u} d u} .
$$

Apply Cauchy-Schwarz again to obtain

$$
\mathbb{E}\left[e^{\alpha Y_{t}}\right]^{2} \leq \mathbb{E}\left[e^{4 \alpha Z_{t}-8 \alpha^{2}\langle Z, Z\rangle_{t}}\right] \times \mathbb{E}\left[e^{8 \alpha^{2} \int_{0}^{t} S_{u} Y_{u} d u+2 \alpha N \int_{0}^{t} S_{u} d u}\right]
$$

By supermartingale properties, the first expected value in the right hand side of the previous inequality is bounded by 1 , hence

$$
\mathbb{E}\left[e^{\alpha Y_{t}}\right]^{2} \leq \mathbb{E}\left[e^{8 \alpha^{2} \int_{0}^{t} S_{u} Y_{u} d u+2 \alpha N \int_{0}^{t} S_{u} d u}\right]
$$

Now use the fact that $S_{u} \leq N$ uniformly in $u$ to conclude

$$
\mathbb{E}\left[e^{\alpha Y_{t}}\right]^{2} \leq e^{2 \alpha N^{2} t} \mathbb{E}\left[e^{8 \alpha^{2} N \int_{0}^{t} Y_{u} d u}\right]=e^{\varepsilon^{2} N t} \mathbb{E}\left[e^{4 \varepsilon^{2} \alpha \int_{0}^{t} Y_{u} d u}\right],
$$

then use Jensen's inequality to obtain

$$
\mathbb{E}\left[e^{\alpha Y_{t}}\right]^{2} \leq e^{\varepsilon^{2} N t} \frac{1}{t} \int_{0}^{t} \mathbb{E}\left[e^{4 \varepsilon^{2} t \alpha Y_{u}}\right] d u

If $4 \varepsilon^{2} t<1$ we can use again Jensen's inequality

Define $g(t):=\mathbb{E}\left[e^{\alpha Y_{t}}\right]^{2}$, the above inequality reads

Since $4 \varepsilon^{2} t<1$ implies $2 \varepsilon^{2} t<1$ we can apply Bihari's Lemma [17, Chap. 1, Th. 8.2] to obtain

and, since $1-4 \varepsilon^{2} t<1-2 \varepsilon^{2} t$,

\mathbb{E}\left[e^{\alpha Y_{t}}\right] \leq e^{\frac{\varepsilon^{2} t}{\left(1-4 \varepsilon^{2} t\right)} N}=e^{\frac{4 \varepsilon^{2} t}{\left(1-4 \varepsilon^{2} t\right)} N / 4},
$$

and, since $-\frac{x}{1-x}>\log (1-x), 0<x<1$

\begin{aligned}
\mathbb{E}\left[e^{\alpha Y_{t}}\right] & \leq e^{\left.-\frac{N}{4} \log \left(1-4 \varepsilon^{2} t\right)\right)} \\
\mathbb{E}\left[e^{\alpha Y_{T}}\right] & \leq\left(1-4 \varepsilon^{2} T\right)^{-N / 4}
\end{aligned}
$$

## B Discrete Fourier Transforms (DFT) of Gaussian processes

Define $F_{N}:=e^{\frac{2 \pi i}{N}}$. Let $a:=\left(a^{j}\right)_{j \in I_{n}}$ be an $N$-periodic complex sequence. Its DFT $\tilde{a}:=$ $\left(\tilde{a}^{p}\right)_{p \in I_{n}}$ is defined by

\tilde{a}^{p}=\sum_{j \in I_{n}} a^{j} F_{N}^{-j p}
$$

from which the original sequence can be recovered by the inverse DFT (IDFT)

$$
a^{j}=\frac{1}{N} \sum_{p \in I_{n}} \tilde{a}^{p} F_{N}^{j p}
$$

We need two Lemmas about the DFT of $N$-periodic sequences defined on $I_{n}$. The first one is about the DFT of a translated sequence.

Lemma B.1. The DFT of the sequence $a_{k}:=\left(a^{j+k}\right)_{j \in I_{n}}, k \in \mathbb{Z}$ is given by

\operatorname{DFT}\left(a_{k}\right)^{p}=F_{N}^{k p} \tilde{a}^{p}
$$

Proof. The proof is left to the reader.
The second Lemma is about the DFT of the convolution of two sequences. Let $\left(a^{j}\right)_{j \in I_{n}}$ and $\left(b^{j}\right)_{j \in I_{n}}$. We define their (circular or periodic) convolution as

where indexes are taken modulo $I_{n}$. We have the Lemma.

Proof. The proof is left to the reader.
We derive some properties of the Fourier transforms of the synaptic weights $\left(J_{n}^{i j}\right)_{i, j \in I_{n}}$ and the Gaussian processes $G_{t}^{j}$. We define $\left(\tilde{R}_{\mathcal{J}}(p, l)\right)_{p, l \in I_{n}}$ to be the length $N$ DFT w.r.t to the first index of the sequence $\left(R_{\mathcal{J}}(k, l)_{k, l \in I_{n}}\right)$, that ${ }^{2}$

\tilde{R}_{\mathcal{J}}(p, l)=\sum_{k \in I_{n}} R_{\mathcal{J}}(k, l) W_{N}^{-k p}
$$

We first characterize the joint laws of the synaptic weights under $\gamma$.

[^2]Lemma B.3. Define

to be the DFT of the synaptic weights $J^{j k}$ w.r.t the first index. Their covariance is

\mathbb{E}^{\gamma}\left[\tilde{J}_{n}^{p k} \tilde{J}_{n}^{q l}\right]=\sum_{j, h \in I_{n}} \mathbb{E}^{\gamma}\left[J_{n}^{j k} J_{n}^{h l}\right] F_{N}^{-j p} F_{N}^{-h q}=\frac{1}{N} \sum_{j, h \in I_{n}} & R_{\mathcal{J}}(h-j, l-k) F_{N}^{-j p} F_{N}^{-h q}= \\
& \frac{1}{N} \sum_{j, h \in I_{n}} R_{\mathcal{J}}(j-h, k-l) F_{N}^{-j p} F_{N}^{-h q} .
\end{aligned}
$$

By Lemma B. 1 we have

0 & \text { otherwise }
\end{array}\right.
$$

Remark B.4. In the terminology of complex Gaussian vectors to be found, e.g. in [11], Lemma B. 3 states the following. Consider the $N$ centered complex $N$-dimensional Gaussian vectors $\tilde{J}_{n}^{p}=\left(\tilde{J}_{n}^{p k}\right)_{k \in I_{n}}, p \in I_{n}$. Note that the complex conjugate $\tilde{J}_{n}^{p *}$ of $\tilde{J}_{n}^{p}$ is $\tilde{J}_{n}^{-p}, p \in I_{n}$. If $p \neq 0 \tilde{J}_{n}^{p}$ is such that its pseudo-covariance matrix $\mathbb{E}^{\gamma}\left[\tilde{J}_{n}^{p} t \tilde{J}_{n}^{p}\right]=0$ and its covariance matrix $\mathbb{E}^{\gamma}\left[\tilde{J}_{n}^{p t} \tilde{J}_{n}^{-p}\right]$ is equal to the circulant matrix $C_{n}^{p}:=\left(R_{\mathcal{J}}(p, k-l)\right)_{k, l \in I_{n}}$. If $p=0 \tilde{J}_{n}^{0}$ is in effect real and its covariance and pseudo-covariance matrixes are both equal to $C^{0}$.

Remark B.5. Note that the covariance matrices $C_{n}^{p}=\mathbb{E}^{\gamma}\left[\tilde{J}_{n}^{p} t \tilde{J}_{n}^{-p}\right]$, $p \in I_{n}$, are circulant Hermitian, i.e. $C_{n}^{p}={ }^{t} C_{n}^{p *}$, because $R_{\mathcal{J}}$ is even. They are positive definite because, being circulant, their eigenvalues are the values of the length $N$ DFT of the sequence $\left(\tilde{R}_{\mathcal{J}}(p, k)\right)_{k \in I_{n}}$ which are positive because $R_{\mathcal{J}}$ is an autocorrelation function hence has a positive spectrum. Hypothesis (9) guarantees that for $N$ large enough these eigenvalues are strictly positive, hence $C_{n}^{p}$ is invertible.

Remark B.6. Complex Gaussian calculus indicates that the probability density function under $\gamma$ of $\tilde{J}_{n}^{p}, p \neq 0$ is

\tilde{J}_{n}^{-p}
\end{array}\right]\right\},
$$

and, since $C_{n}^{p}$ is invertible (see Remark B.5),

\end{array}\right]\left[\begin{array}{cc}
\left(C_{n}^{p}\right)^{-1} & 0  \tag{92}\\

\end{array}\right]\left[\begin{array}{c}
\tilde{J}_{n}^{p} \\
\tilde{J}_{n}^{-p}
\end{array}\right]\right\}
$$

Remark B.7. Note that Lemma B.3 implies that the complex centered Gaussian vectors $\tilde{J}_{n}^{p}$ and $\tilde{J}_{n}^{q}$ are independent under $\gamma$ if $p+q \neq 0$. Indeed, complex Gaussian calculus indicate that the four jointly Gaussian $N$-dimensional centered real vectors $\operatorname{Re}\left(\tilde{J}_{n}^{p}\right), \operatorname{Im}\left(\tilde{J}_{n}^{p}\right), \operatorname{Re}\left(\tilde{J}_{n}^{q}\right), \operatorname{Im}\left(\tilde{J}_{n}^{q}\right)$ are independent if $p+q \neq 0$.

Given a Hermitian matrix $A$ of size $N$, we note $\lambda_{1}(A) \geq \cdots \geq \lambda_{N}(A)$ its eigenvalues. As a consequence of Lemma B. 3 we obtain a useful upper bound.
Corollary B.8. For all $n \in \mathbb{Z}^{+}$, all $p \in I_{n}$ and all vectors $\zeta=\left(\zeta^{j}\right)_{j \in I_{n}}$ and $\xi=\left(\xi^{j}\right)_{j \in I_{n}}$ of $\mathbb{R}^{N}$,

$$

$a$ and $b$ are defined in (7).
Proof. According to Remark B. 5 we have

\left|\sum_{j, k \in I_{n}} \mathbb{E}^{\gamma}\left[\tilde{J}_{n}^{p j} \tilde{J}_{n}^{-p k}\right] \zeta^{j} \xi^{k}\right|=\left|{ }^{t} \zeta C_{n}^{p} \xi\right| \leq\left\|C_{n}^{p}\right\|_{2}\|\zeta\|_{2}\|\xi\|_{2}
$$

Next we have $\left\|C_{n}^{p}\right\|_{2}=\lambda_{1}\left(C_{n}^{p}\right)$, where $\lambda_{1}(A)$ is the largest eigenvalue of the Hermitian matrix $A$. By Remark B. 5 the eigenvalues of the circulant matrix $C_{n}^{p}$ are the values of the DFT of the sequence $\left(\tilde{R}_{\mathcal{J}}(p, k)\right)_{k \in I_{n}}$. According to (5) and (7) they are all upperbounded in magnitude by $a b$, and so is $\left\|C_{n}^{p}\right\|_{2}$.

Let $\left(Z_{t}^{j}\right), j \in I_{n}$ be an element of $\mathcal{T}^{N}$. We recall the definition of the centered Gaussian field $\left(G_{t}^{J}\right)$ :

Taking the length $N$ DFT of the $I_{n}$-periodic sequence $\left(G_{t}^{j}\right)_{j \in I_{n}}$, we introduce the following $I_{n}$-periodic stationary sequence of centered complex Gaussian processes $\left(\tilde{G}^{p}\right)_{p \in I_{n}}$

\tilde{G}_{t}^{p}=\sum_{l \in I_{n}} \tilde{J}_{n}^{p l} f\left(Z_{t}^{l}\right) \tag{93}
\end{equation*}
$$

We have the following independence result.

Lemma B.9. If $p+q \neq 0$, under $\gamma^{\hat{\mu}_{n}\left(Z_{n}\right)}$, the centered complex Gaussian processes $\left(\tilde{G}^{p}\right)_{t}$ and $\left(\tilde{G}^{q}\right)_{s}$ are independent on $[0, T]$ and

\mathbb{E}^{\hat{\mu}^{\hat{\mu}_{n}\left(Z_{n}\right)}}\left[\tilde{G}_{t}^{p} \tilde{G}_{s}^{q}\right]=\left\{\begin{array}{lc}
\sum_{l, k \in I_{n}} \tilde{R}_{\mathcal{J}}(p, l-k) f\left(Z_{t}^{l}\right) f\left(Z_{s}^{k}\right) & \text { if } \quad p+q=0 \\
0 & \text { otherwise }
\end{array}\right.
$$

Proof. We write

\tilde{G}_{t}^{p}=\sum_{l \in I_{n}} \tilde{J}_{n}^{p l} f\left(Z_{t}^{l}\right), \quad \tilde{G}_{s}^{q}=\sum_{k \in I_{n}} \tilde{J}_{n}^{q k} f\left(Z_{s}^{k}\right)
$$

The independence under $\gamma^{\hat{\mu}_{n}\left(Z_{n}\right)}$ follows from the independence under $\gamma$ of $\tilde{J}_{n}^{p}$ and $\tilde{J}_{n}^{q}$ if $p+q \neq 0$ proved in Remark B.7. Moreover

The result follows from Lemma B.3.

\end{equation*}

where $\alpha_{0}=\frac{1}{2 \sigma^{2} N}, \alpha_{p}=\frac{1}{\sigma^{2} N}, p \neq 0$.
Define also $U_{t}^{n}$ to be the $N \times N$ symmetric positive semi-definite matrix with elements $U_{t}^{n, j k}=\int_{0}^{t} f\left(Z_{s}^{j}\right) f\left(Z_{s}^{k}\right) d s, j, k \in I_{n}$.
Lemma B.10. The $\tilde{\Lambda}_{t}^{p}(\tilde{G}), p \in I_{n}, p \geq 0$, are independent under $\gamma^{\hat{\mu}_{n}\left(Z_{n}\right)}$ and we have

Because of the independence under $\gamma$, proved in Remark B.7, of $\tilde{J}_{n}^{p}$ and $\tilde{J}_{n}^{q}$ if $p+q \neq 0$, we have

=\prod_{p=0}^{n} \mathbb{E}^{\gamma^{\hat{\mu}_{n}\left(Z_{n}\right)}}\left[\exp \left\{-\frac{1}{N \sigma^{2}} \int_{0}^{t}\left|\tilde{G}_{s}^{p}\right|^{2} d s\right\}\right]
\end{array}
$$

and (95) follows.
The independence under $\gamma^{\hat{\mu}_{n}\left(Z_{n}\right)}$ of the $\tilde{\Lambda}_{t}^{p}(\tilde{G}), p=0, \cdots, n$, follows from the independence under $\gamma$, proved in Remark B.7, of $\tilde{J}_{n}^{p}$ and $\tilde{J}_{n}^{q}$ if $p+q \neq 0$. This concludes the proof of the Lemma.

We next characterize the law of $\left(\tilde{J}_{n}^{p}, p \in I_{n}\right)$ under the law $\bar{\gamma}_{t}^{\hat{\mu}_{n}\left(Z_{n}\right)}=\Lambda_{t}(G) \cdot \gamma^{\hat{\mu}_{n}\left(Z_{n}\right)}$.

The covariance of $\widetilde{J}_{n}^{p}$ under $\bar{\gamma}_{t}^{\hat{\mu}_{n}\left(Z_{n}\right)}$ is given by

which shows that, under $\bar{\gamma}_{t}^{\hat{\mu}_{n}\left(Z_{n}\right)}, \tilde{J}_{n}^{p}$ is centered complex Gaussian with covariance $\left(\left(C_{n}^{p}\right)^{-1}+\right.$ $\left.\alpha_{p} U_{t}^{n}\right)^{-1}$

Corollary B.12. The centered processes $\tilde{G}_{t}^{p}$ and $\tilde{G}_{s}^{q}, p, q \in I_{n}$ are still Gaussian and independent under $\bar{\gamma}_{t}^{\hat{\mu}_{n}\left(Z_{n}\right)}$ for all $s \leq t$ except for $p+q=0$. Moreover

Proof. By Lemma C. 9 the process $\left(G_{t}^{k}\right)_{k \in I_{n}, t \in[0, T]}$ is Gaussian centered under $\bar{\gamma}_{t}^{\hat{\mu}_{n}\left(Z_{n}\right)}$ and therefore so is the process $\left(\tilde{G}_{t}^{p}\right)_{p \in I_{n}, t \in[0, T]}$. By Lemma B. 10

The sum $\left(C_{n}^{p}\right)^{-1}+\alpha_{p} U_{t}^{n}$ is therefore Hermitian positive. The dual Weyl inequality [25] commands that

Since $\lambda_{j}\left(\alpha_{p} U_{t}^{n}\right) \geq 0$ for $j=1, \cdots, N$ and $\lambda_{i}\left(\left(C_{n}^{p}\right)^{-1}\right) \geq$ $\lambda_{N}\left(\left(C_{n}^{p}\right)^{-1}\right)=\lambda_{1}\left(C_{n}^{p}\right)^{-1}>0$ for all $i=1, \cdots, N$ we conclude that

## C Covariance functions

## C. 1 Time continuous setting

One of the basic constructions in this paper is the following. Given a measure $\mu \in \mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$, an integer $n$ (possibly infinite), and a time $t \in[0, T]$, define the following sequence of functions $K_{\mu}^{k}:[0, t]^{2} \rightarrow \mathbb{R}$

for $s, u \in[0, t]$. The summation w.r.t $l$ in the right hand side is either over the set $I_{n}$ for finite $n$ or over $\mathbb{Z}$. The index $k$ in the left hand side has the same range as $l$. In case of $n$ infinite, the right hand side is well defined because of the absolute summability of the sequences $\left(R_{\mathcal{J}}(k, l)\right)_{l \in \mathbb{Z}}$ for all $k \in \mathbb{Z}$ and the fact that $0 \leq f \leq 1$. In the case of $n$ finite, the sequence $\left(K_{\mu}^{k}\right)_{k \in I_{n}}$, noted $K_{\mu}^{n, k}$, is $N$-periodic.

It is easy to check that the sequence $\left(K_{\mu}^{k}(s, u)\right)_{k}$ of functions is the covariance of a centered stationary Gaussian process noted $G_{s}^{j}$, with $s \in[0, t]$ and $j$ is in $I_{n}$ for finite $n$ or in $\mathbb{Z}$ otherwise. There are several possible representations of this process. In the case of finite $n$ we use

and noted $\gamma^{\mu^{I_{n}}}$ the law under which it has covariance $K_{\mu}^{n}$, i.e.

see the proof of Lemma C. 2 below. A second representation is provided by the consideration of the operator defined by the sequence $K_{\mu}^{k}$. This operator is defined on the Hilbert
space $L^{2}(\mathbb{Z} \times[0, t]):=\bigoplus_{i \in \mathbb{Z}} L^{2}([0, t])\left(\right.$ or $\left.L^{2}\left(I_{n} \times[0, t]\right)\right)$ of infinite (or finite) sequences of measurable square integrable complex functions $g_{s}^{k}$ on $[0, t]$ such that

where, as usual, the summation w.r.t. $k$ is over $I_{n}$ for $n$ finite or over $\mathbb{Z}$ otherwise. In the sequel we treat only the case of infinite $n$, i.e. $I_{n}=\mathbb{Z}$, the case of $n$ finite being easily deduced from this one.

We prove in Lemma C. 1 that the operator $\bar{K}_{\mu}$ acting on $L^{2}(\mathbb{Z} \times[0, t])$ by

Note that by Fourier transform the space $L^{2}(\mathbb{Z} \times[0, t])$ is isomorphic to the space $L^{2}([-\pi, \pi] \times[0, t])$. Each element $g$ of $L^{2}(\mathbb{Z} \times[0, t])$ features a Fourier transform $\tilde{g}$ such that

By the convolution theorem, the operator $\bar{K}_{\mu}$ on $L^{2}(\mathbb{Z} \times[0, t])$ induces an operator $\overline{\tilde{K}}_{\mu}$ on $L^{2}([-\pi, \pi] \times[0, t])$ acting on such functions by

Lemma C.1. The linear operator $\bar{K}_{\mu}$ defined by (99) maps $L^{2}(\mathbb{Z} \times[0, t])$ to itself and is continuous, self-adjoint, and compact. Its norm is upperbounded by abt.

1) Well-defined and continuous:

We prove that $\bar{K}_{\mu}$ maps $L^{2}(\mathbb{Z} \times[0, t])$ onto itself. In effect, by Cauchy-Schwarz

and therefore $\bar{K}_{\mu}$ is well-defined as a linear mapping from $L^{2}(\mathbb{Z} \times[0, t])$ to itself , bounded and therefore continuous with $\left\|\bar{K}_{\mu}\right\|_{L^{2}(\mathbb{Z} \times[0, t])} \leq a b t$.
2) Self-adjoint:

This follows directly from the identity $K_{\mu}^{k}(u, s)=K_{\mu}^{-k}(s, u)$.
3) Compactness:

We sketch the proof. We use the Kolmogorov-Riesz-Fréchet Theorem [2, Th. 4.26] for the compactness of bounded set of $L^{p}\left(\mathbb{R}^{n}\right)$, the analog of the Ascoli-Arzelà Theorem for continuous functions.

Let $\tilde{g} \in L^{2}([-\pi, \pi] \times[0, t])$. Let $h=\left(h_{1}, h_{2}\right) \in \mathbb{R}^{2}$. We define the operator $\tau_{h}$ : $L^{2}([-\pi, \pi] \times[0, t]) \rightarrow L^{2}([-\pi, \pi] \times[0, t])$ by

According to the Kolmogorov-Riesz-Fréchet Theorem, it is sufficient to prove that

& =\sum_{l \in \mathbb{Z}}\left(\tilde{R}_{\mathcal{J}}\left(\varphi+h_{1}, l\right)-\tilde{R}_{\mathcal{J}}(\varphi, l)\right) \int_{\mathcal{T}} f\left(v_{s+h_{2}}^{0}\right) f\left(v_{u}^{l}\right) d \mu(v) \\
& \quad+\sum_{l \in \mathbb{Z}} \tilde{R}_{\mathcal{J}}(\varphi, l) \int_{\mathcal{T}}\left(f\left(v_{s+h_{2}}^{0}\right)-f\left(v_{s}^{0}\right)\right) f\left(v_{u}^{l}\right) d \mu(v), \tag{103}
\end{align*}
$$

where we have noted

$$
\tilde{R}_{\mathcal{J}}(\varphi, l)=\sum_{k} R_{\mathcal{J}}(k, l) e^{-i k \varphi}
$$

We first upperbound the magnitude of the first term in the right hand side of (103). By the mean value theorem and (6)

$$
\left|\tilde{R}_{\mathcal{J}}\left(\varphi+h_{1}, l\right)-\tilde{R}_{\mathcal{J}}(\varphi, l)\right| \leq\left|h_{1}\right| \sum_{k}|k|\left|R_{\mathcal{J}}(k, l)\right| \leq\left|h_{1}\right| b_{l} \sum_{k}|k| a_{k}
$$

Because of $0 \leq f \leq 1$ and (6) again, we have

$$
\begin{equation*}
\left|\sum_{l \in \mathbb{Z}}\left(\tilde{R}_{\mathcal{J}}\left(\varphi+h_{1}, l\right)-\tilde{R}_{\mathcal{J}}(\varphi, l)\right) \int_{\mathcal{T}_{\mathbb{Z}}} f\left(v_{s+h_{2}}^{0}\right) f\left(v_{u}^{l}\right) d \mu(v)\right| \leq C_{1}\left|h_{1}\right|, \tag{104}
\end{equation*}
$$

for some positive constant $C_{1}$.
We next upperbound the magnitude of the second term in the right hand side of (103). First, thanks to the Dominated Convergence Theorem, the function $s \rightarrow \int_{\mathcal{T}} f\left(v_{s}^{0}\right) d \mu(v)$ is continuous on $[0, t] 0 \leq t \leq T$, and hence uniformly continuous,

\forall \varepsilon>0 \exists \delta(\varepsilon) \geq 0,\left|h_{2}\right| \leq \delta \Rightarrow\left|\int_{\mathcal{T}_{\mathbb{Z}}}\left(f\left(v_{s+h_{2}}^{0}\right)-f\left(v_{s}^{0}\right)\right) d \mu(v)\right| \leq \varepsilon \tag{105}
\end{equation*}
$$

Second, $\left|\tilde{R}_{\mathcal{J}}(\varphi, l)\right| \leq a b_{l}$.
Combining (102)-(105) with the fact that $\left(\tilde{g}^{k}\right)_{k}$ is bounded and Cauchy-Schwarz implies (101).

We now prove that $\bar{K}_{\mu}$ is non negative.
Lemma C.2. The linear operator $\bar{K}_{\mu}$ defined by (99) is non negative.
Proof. Consider

This implies, because of (3) and the stationarity of $\mu$, that

\mathbb{E}^{\mu^{\mu_{n}}}\left[G_{s}^{i} G_{u}^{k}\right] & =\mathbb{E}^{\gamma^{\mu^{I_{n}}}}\left[\sum_{j, l \in I_{n}} J_{n}^{i j} J_{n}^{k l} f\left(v_{s}^{j}\right) f\left(v_{u}^{l}\right)\right]=\frac{1}{N} \sum_{j, l \in I_{n}} R_{\mathcal{J}}(k-i, l-j) \mathbb{E}^{\mu^{I_{n}}}\left[f\left(v_{s}^{j}\right) f\left(v_{u}^{l}\right)\right] \\
& =\frac{1}{N} \sum_{j, l \in I_{n}} R_{\mathcal{J}}(k-i, l-j) \mathbb{E}^{\mu^{I_{n}}}\left[f\left(v_{s}^{0}\right) f\left(v_{u}^{l-j}\right)\right] \\
& =\sum_{l \in I_{n}} R_{\mathcal{J}}(k-i, l) \mathbb{E}^{\mu^{I_{n}}}\left[f\left(v_{s}^{0}\right) f\left(v_{u}^{l}\right)\right]=K_{\mu}^{n, k-i}(s, u)
\end{aligned}
$$

from which it follows that

$$
\begin{aligned}
\left\langle\bar{K}_{\mu}^{n} g, g\right\rangle_{L^{2}\left(I_{n} \times[0, t]\right)} & =\sum_{k, l \in I_{n}} \int_{0}^{t}\left(\int_{0}^{t} K_{\mu}^{n, k-l}(s, u) g_{u}^{l} d u\right)\left(g_{s}^{k}\right)^{*} d s \\
& =\sum_{k, l \in I_{n}} \int_{0}^{t} \int_{0}^{t} \mathbb{E}^{\gamma^{I^{I_{n}}}}\left[G_{s}^{k} G_{u}^{l}\right] g_{u}^{l}\left(g_{s}^{k}\right)^{*} d u d s \\
& =\mathbb{E}^{\gamma^{\mu_{n}}}\left[\left|\sum_{k \in I_{n}} \int_{0}^{t} G_{s}^{k} g_{s}^{k} d s\right|^{2}\right] \geq 0 .
\end{aligned}
$$

We conclude that $\bar{K}_{\mu}^{n}$ is positive as an operator on $L^{2}\left(I_{n} \times[0, t]\right)$ and hence, taking the limit $n \rightarrow \infty$ that $\bar{K}_{\mu}$ is a positive operator on $L^{2}(\mathbb{Z} \times[0, t])$.

We have the following Lemma related to the Fourier representation of the sequence $\left(K_{\mu}^{k}(s, u)\right)_{k \in \mathbb{Z}}$.
Lemma C.3. The sequence $\left(K_{\mu}^{k}(s, u)\right)_{k \in \mathbb{Z}}$ is the Fourier series of a three times continuously differentiable periodic function $\left[-\pi, \pi\left[\rightarrow \mathbb{R}, \varphi \rightarrow \tilde{K}_{\mu}(\varphi)(s, u)\right.\right.$ which is continuous w.r.t. $(s, u)$. This implies that the $K_{\mu}^{k}(s, u)$ are $\mathcal{O}\left(1 /|k|^{3}\right)$. Furthermore this convergence is uniform in $s, u, \mu$.

Proof. It follows from Lemma C. 1 that for all $s, u \in[0, t]$ that the sequence $\left(K_{\mu}^{k}(s, u)\right)_{k \in \mathbb{Z}}$ is the Fourier series of a continuous periodic function $\left[-\pi, \pi\left[\rightarrow \mathbb{R}, \varphi \rightarrow \tilde{K}_{\mu}(\varphi)(s, u)\right.\right.$ which is continuous w.r.t. $(s, u)$. By definition

\tilde{K}_{\mu}(\varphi)(s, u)=\sum_{k} K_{\mu}^{k}(s, u) e^{-i k \varphi}
$$

where the series in the right hand side is absolutely convergent. By (97) we have

\tilde{K}_{\mu}(\varphi)(s, u)=\sum_{l} \tilde{R}_{\mathcal{J}}(\varphi, l) \int_{\mathcal{T}^{\mathbb{Z}}} f\left(v_{s}^{0}\right) f\left(v_{u}^{l}\right) d \mu(v)
$$

and the order three differentiability of $\tilde{K}_{\mu}(\varphi)(s, u)$ follows from Remark 2.3 as well as the uniform convergence of $K_{\mu}^{k}(s, u)$.

We have the following useful result.
Lemma C.4. We have

\left|\tilde{K}_{\mu}(\varphi)(s, u)\right| \leq a b \quad \forall s, u \in[0, t], \varphi \in[-\pi, \pi[
$$

Proof. By (97)

\left|\tilde{K}_{\mu}(\varphi)(s, u)\right| \leq \sum_{l \in \mathbb{Z}}\left|\tilde{R}_{\mathcal{J}}(\varphi, l)\right|
$$

where

\tilde{R}_{\mathcal{J}}(\varphi, l)=\sum_{k \in \mathbb{Z}} R_{\mathcal{J}}(k, l) e^{-i k \varphi}
$$

This implies that

\left|\tilde{K}_{\mu}(\varphi)(s, u)\right|^{2} \leq\left(\sum_{l \in \mathbb{Z}}\left|\tilde{R}_{\mathcal{J}}(\varphi, l)\right|\right)^{2}
$$

and, since by (5), (6)

\left|\tilde{R}_{\mathcal{J}}(\varphi, l)\right| \leq \sum_{k \in \mathbb{Z}}\left|R_{\mathcal{J}}(k, l)\right| \leq b_{l} \sum_{k \in \mathbb{Z}} a_{k}=a b_{l}
$$

We conclude that

$$
\left|\tilde{K}_{\mu}(\varphi)(s, u)\right|^{2} \leq a^{2} b^{2}
$$

By Lemmas C. 1 and C. 2 it follows that the spectrum of $\bar{K}_{\mu}$ is discrete and composed of non negative eigenvalues noted $\lambda_{m}^{\mu}, m \in \mathbb{N}$. Let $\left(h_{m}^{\mu}\right)$ be a corresponding orthonormal basis of eigenvectors i.e. such as

\bar{K}_{\mu} h_{m}^{\mu}=\lambda_{m}^{\mu} h_{m}^{\mu}, \quad\left\langle h_{m}^{\mu}, h_{m^{\prime}}^{\mu}\right\rangle=\delta_{m m^{\prime}} \quad \forall m, m^{\prime} \in \mathbb{N}
$$

Next define $g_{m}^{\mu}=\sqrt{\lambda_{m}^{\mu}} h_{m}^{\mu}, m \in \mathbb{N}$. One has the following "SVD" decomposition of the operator $\bar{K}_{\mu}$.

K_{\mu}^{k}(s, u)=\sum_{m \in \mathbb{N}} \sum_{l} g_{m}^{\mu}(l, s) g_{m}^{\mu}(l+k, u)
$$

Given a covariance $\left(K_{\mu}^{k}\right)_{k \in \mathbb{Z}}$ we know that there exists a centered Gaussian process $\left(\Omega, \mathcal{A}, \gamma,\left(G_{t}^{k}\right)_{k \in \mathbb{Z}}\right)$ with covariance $\left(K_{\mu}^{k}\right)_{k \in \mathbb{Z}}$. For any such process, if $H_{\mu}$ denotes the Gaussian space associated (the closed linear span of $\left(G_{t}^{k}\right)_{k \in \mathbb{Z}}$ in $L^{2}(\Omega, \mathcal{A}, \gamma)$ ), then $H_{\mu}$ is isomorphic to the autoreproducing Hilbert space $\mathcal{H}_{\mu}$ associated to $\left(K_{\mu}^{k}\right)_{k \in \mathbb{Z}}$ by

$$
\begin{aligned}
\phi: H_{\mu} & \rightarrow \mathcal{H}_{\mu} \\
Z & \rightarrow \mathbb{E}^{\gamma}[Z G:] .
\end{aligned}
$$

The space $\mathcal{H}_{\mu} \subset L^{2}(\mathbb{Z},[0, T])$ admits $\left(g_{m}^{\mu}\right)_{m \geq 0}$ as an orthonormal basis. If $\xi_{m}^{\mu}=\phi^{-1}\left(g_{m}^{\mu}\right)$, then $\left(\xi_{m}^{\mu}\right)_{m \geq 0}$ is a sequence of i.i.d. $\mathcal{N}(0,1)$ random variables in $H_{\mu}$ and we have the following representation for the Gaussian process $G_{s}^{i}$ :

$$
G_{s}^{i}=\sum_{m \geq 0} g_{m}^{\mu}(i, s) \xi_{m}^{\mu}
$$

where the convergence is in $L^{2}(\Omega, \mathcal{A}, \gamma)$. We note $\gamma^{\mu}$ the law on $(\Omega, \mathcal{A})$ under which the sequence $\left(G_{s}^{i}\right), i \in \mathbb{Z}, s \in[0, t]$ has covariance $K_{\mu}^{k}$.

Remark C.5. Note that given two measures $\mu_{1}$ and $\mu_{2}$ in $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$ and the corresponding operators $\bar{K}_{\mu_{1}}$ and $\bar{K}_{\mu_{2}}$, the operator $\bar{K}:=\bar{K}_{\mu_{1}} \circ \bar{K}_{\mu_{2}}$ has the following kernel

$$
K^{k}(s, u)=\sum_{l} \int_{0}^{t} K_{\mu_{1}}^{k-l}(s, v) K_{\mu_{2}}^{l}(v, u) d v
$$

or, in the (continuous) Fourier domain

$$
\tilde{K}(\varphi)(s, u)=\int_{0}^{t} \tilde{K}_{\mu_{1}}(\varphi)(s, v) \tilde{K}_{\mu_{2}}(\varphi)(v, u) d v
$$

and in the discrete case

$$
\tilde{K}^{p}(s, u)=\int_{0}^{t} \tilde{K}_{\mu_{1}}^{p}(s, v) \tilde{K}_{\mu_{2}}^{p}(v, u) d v, p \in I_{n} .
$$

Consider the new self-adjoint positive compact operator $\bar{L}_{\mu}$ on $L^{2}(\mathbb{Z} \times[0, t])$ defined by

$$
\begin{equation*}
\bar{L}_{\mu}=\left(\operatorname{Id}+\sigma^{-2} \bar{K}_{\mu}\right)^{-1} \bar{K}_{\mu}, \tag{106}
\end{equation*}
$$

and let $L_{\mu}$ be its kernel:

L_{\mu}^{k}(s, u)=\sum_{m \geq 0} \frac{1}{1+\frac{\lambda_{m}^{\mu}}{\sigma^{2}}} \sum_{l} g_{m}^{\mu}(l, s) g_{m}^{\mu}(l+k, u)
$$

Remark C.6. Note that $\left(\operatorname{Id}+\sigma^{-2} \bar{K}_{\mu}\right)^{-1}$ and $\bar{K}_{\mu}$ commute, i.e.,

\bar{L}_{\mu}=\left(\operatorname{Id}+\sigma^{-2} \bar{K}_{\mu}\right)^{-1} \bar{K}_{\mu}=\bar{K}_{\mu}\left(\operatorname{Id}+\sigma^{-2} \bar{K}_{\mu}\right)^{-1}
$$

as can be readily seen by noticing that both sides of the previous equality are equal to $\sigma^{2}\left(\operatorname{Id}-\left(\operatorname{Id}+\sigma^{-2} \bar{K}_{\mu}\right)^{-1}\right)$, so that we also have

Remark C.7. Just as for the operator $\bar{K}_{\mu}$ we also use the finite size version $\bar{L}_{\mu}^{n}$ of $\bar{L}_{\mu}$ whose kernel is written $L_{\mu}^{n, k}, k \in I_{n}$.

We have the analog of Lemma C. 3 for the Fourier transform $\tilde{L}_{\mu}(\varphi)$ of $L_{\mu}^{k}$.
Proposition C.8. The sequence $\left(L_{\mu}^{k}(s, u)\right)_{k \in \mathbb{Z}}$ is the Fourier series of a three times continuously differentiable periodic function $\varphi \rightarrow \tilde{L}_{\mu}(\varphi)(s, u)$ which is continuous w.r.t. $(s, u)$. The Fourier coefficients of $\tilde{L}_{\mu}(\varphi)(s, u)$, i.e. the kernel $\left(L_{\mu}^{k}(s, u)\right)_{k \in \mathbb{Z}}$ of the operator $\bar{L}_{\mu}$, is $\mathcal{O}\left(1 /|k|^{3}\right)$, uniformly in $s$, $u$ in $[0, t]$ and $\mu$. Therefore there exist constants $C$ and $D$ independent of $\mu$ such that $\forall s, u \in[0, t], \forall \varphi \in[-\pi, \pi)$,

$$
\begin{array}{r}
\sum_{k \in \mathbb{Z}}\left|L_{\mu}^{k}(s, u)\right| \leq C \\
\sum_{k \in \mathbb{Z}}\left(L_{\mu}^{k}(s, u)\right)^{2} \leq D \\
\left|\tilde{L}_{\mu}(\varphi)(s, u)\right| \leq \sqrt{D} .
\end{array}
$$

Proof. It follows from (106) and Remark C. 6 that

$$
\begin{equation*}
\overline{\tilde{L}}_{\mu}(\varphi)=\left(\operatorname{Id}+\sigma^{-2} \overline{\tilde{K}}_{\mu}(\varphi)\right)^{-1} \overline{\tilde{K}}_{\mu}(\varphi)=\overline{\tilde{K}}_{\mu}(\varphi)\left(\operatorname{Id}+\sigma^{-2} \overline{\tilde{K}}_{\mu}(\varphi)\right)^{-1} \tag{108}
\end{equation*}
$$

The order three continuous differentiability of $\tilde{L}_{\mu}(\varphi)(s, u)$ w.r.t. $\varphi$ follows from that of $\tilde{K}_{\mu}(\varphi)(s, u)$ proved in Lemma C.3. We also obtain the fact that the $L_{\mu}^{k}(s, u)$ are $\mathcal{O}\left(1 /|k|^{3}\right)$ uniformly in $s, u$ in $[0, t]$ and $\mu$.

We have the following important Lemma which establishes that the kernels $L_{\mu}^{k}(s, u)$ are the covariance of the centered Gaussian field defined by (98) under another probability law than $\gamma^{\mu}$.
Lemma C.9. For all $t \in[0, T]$ and all $s, u \in[0, t]$, under the new law $\Lambda_{t}(G) \cdot \gamma^{\mu}$, the family of processes $\left(G_{s}^{i}\right)$ is still centered and Gaussian with covariance $L_{\mu}$ given by

\mathbb{E}^{\gamma^{\mu}}\left[\Lambda_{t}(G) G_{s}^{0} G_{u}^{k}\right]=L_{\mu}^{t, k}(s, u) \tag{109}
\end{equation*}
$$

where

$$
\Lambda_{t}(G)=\frac{\exp \left\{-\frac{1}{2 \sigma^{2}} \sum_{j} \int_{0}^{t}\left(G_{u}^{j}\right)^{2} d u\right\}}{\mathbb{E}^{\gamma^{\mu}}\left[\exp \left\{-\frac{1}{2 \sigma^{2}} \sum_{j} \int_{0}^{t}\left(G_{u}^{j}\right)^{2} d u\right\}\right]}
$$

In the above, the summation w.r.t. $j$ is over $I_{n}$ for finite $n$ or over $\mathbb{Z}$ otherwise.
In agreement with (22) and Remark 3.2 we note $\bar{\gamma}_{t}^{\mu}$ the corresponding probability law on $(\Omega, \mathcal{A})$
Proof. Let $\delta$ be a real number and $G_{t}^{M, k}=\sum_{m=0}^{M} g_{m}^{\mu}(k, t) \xi_{m}^{\mu}$. Using the properties of the basis $\left(g_{m}^{\mu}\right)_{m \geq 0}$ we have

$$
\begin{aligned}
\mathbb{E}^{\gamma^{\mu}} & {\left[\exp \left\{\delta G_{t}^{M, k}-\frac{1}{2 \sigma^{2}} \sum_{j} \int_{0}^{t}\left(G_{s}^{M, j}\right)^{2} d s\right\}\right] } \\
& =\mathbb{E}^{\gamma^{\mu}}\left[\exp \left\{\delta \sum_{m=0}^{M} g_{m}^{\mu}(k, t) \xi_{m}^{\mu}-\frac{1}{2 \sigma^{2}} \sum_{m=0}^{M} \lambda_{m}^{\mu}\left(\xi_{m}^{\mu}\right)^{2}\right\}\right]
\end{aligned}
$$

Because of the independence of the $\xi_{n}^{\mu}$, this is equal to

$$
\prod_{m=0}^{M} \mathbb{E}^{\gamma^{\mu}}\left[\exp \left\{\delta g_{m}^{\mu}(k, t) \xi_{n}^{\mu}-\frac{1}{2 \sigma^{2}} \lambda_{m}^{\mu}\left(\xi_{m}^{\mu}\right)^{2}\right\}\right]
$$

and, using standard Gaussian calculus, we obtain

$$
\begin{aligned}
& \mathbb{E}^{\gamma^{\mu}}\left[\exp \left\{\delta G_{t}^{M, k}-\frac{1}{2 \sigma^{2}} \sum_{j} \int_{0}^{t}\left(G_{s}^{M, j}\right)^{2} d s\right\}\right] \\
&=\prod_{m=0}^{M}\left(1+\frac{\lambda_{m}^{\mu}}{\sigma^{2}}\right)^{-1 / 2} \exp \left(\frac{\delta^{2}}{2} \sum_{m=0}^{M} \frac{1}{1+\frac{\lambda_{m}^{\mu}}{\sigma^{2}}}\left(g_{m}^{\mu}(k, t)\right)^{2}\right)
\end{aligned}
$$

In particular

$$
\begin{align*}
& \mathbb{E}^{\gamma^{\mu}}\left[\exp \left\{-\frac{1}{2 \sigma^{2}} \sum_{j} \int_{0}^{t}\left(G_{s}^{M, j}\right)^{2} d s\right\}\right]=\left(\prod_{m=0}^{M}\left(1+\frac{\lambda_{m}^{\mu}}{\sigma^{2}}\right)\right)^{-1 / 2}  \tag{110}\\
& \frac{\mathbb{E}^{\gamma^{\mu}}\left[\exp \left\{\delta G_{t}^{M, k}-\frac{1}{2 \sigma^{2}} \sum_{j} \int_{0}^{t}\left(G_{s}^{M, j}\right)^{2} d s\right\}\right]}{\mathbb{E}^{\gamma^{\mu}}\left[\exp \left\{-\frac{1}{2 \sigma^{2}} \sum_{j} \int_{0}^{t}\left(G_{s}^{M, j}\right)^{2} d s\right\}\right]}=\exp \frac{\delta^{2}}{2}\left\{\sum_{m=0}^{M} \frac{1}{1+\frac{\lambda_{m}^{\mu}}{\sigma^{2}}}\left(g_{m}^{\mu}(k, t)\right)^{2}\right\} .
\end{align*}
$$

The same formula shows that the sequence $\exp \left\{\delta G_{t}^{M, k}-\frac{1}{2 \sigma^{2}} \sum_{j} \int_{0}^{t}\left(G_{s}^{M, j}\right)^{2} d s\right\}$ is bounded in $L^{1+\rho}(\Omega, \mathcal{A}, \gamma)$ for any positive real $\rho$ so that this sequence is uniformly integrable. It converges in probability to $\exp \left\{\delta G_{t}^{k}-\frac{1}{2 \sigma^{2}} \sum_{j} \int_{0}^{t}\left(G_{s}^{j}\right)^{2} d s\right\}$. We conclude that

$$
\begin{align*}
& \mathbb{E}^{\gamma^{\mu}}\left[\exp \left\{-\frac{1}{2 \sigma^{2}} \sum_{j} \int_{0}^{t}\left(G_{s}^{j}\right)^{2} d s\right\}\right] \tag{111}
\end{align*}=\prod_{m \in \mathbb{N}}\left(1+\frac{\lambda_{m}^{\mu}}{\sigma^{2}}\right)^{-1 / 2} .
$$

We have computed the moment generating function of $G_{s}^{i}$ under the new law $\Lambda_{t}(G) \cdot \gamma^{\mu}$. It is still Gaussian centered with covariance obtained by deriving (112) twice at $\delta=0$ to obtain:

## C. 2 Discrete time setting

In several parts of the paper we use time-discretized versions of these operators. Two cases occur. The first is that of a general measure in $\mathcal{P}_{S}\left(\mathcal{T}^{\mathbb{Z}}\right)$, typically the limit measure $\mu_{*}$. The second is that of an empirical measure $\hat{\mu}_{n}\left(V_{n}\right)$ or $\hat{\mu}_{n}\left(V_{n}^{m}\right)$. Given a partition of $[0, T]$ into the $(m+1)$ points $v \eta_{m}=v \frac{T}{m}$, with $\eta_{m}:=T / m$, for $v=0$ to $m$ we deal with the operators $\bar{K}_{\mu}$ and $\bar{L}_{\mu}$. It will be clear from the context whether these operators are defined by a finite, e.g. $\left(\bar{K}_{\mu}^{i}\right)_{i \in I_{n}}$, or infinite, e.g. $\left(\bar{K}_{\mu}^{i}\right)_{i \in \mathbb{Z}}$, sequence. In the finite case these operators are $N v \times N v$ matrixes which are block Toeplitz for $\bar{K}_{\mu}$ and $\bar{L}_{\mu}$.

We also consider several Fourier transforms of these operators. The continuous one noted $\overline{\tilde{K}}_{\mu}(\varphi), \varphi \in[-\pi, \pi[$ in both the infinite and finite cases, and the discrete one. In the continuous case we have

We consider their length $N$ Discrete Fourier Transform (DFT), i.e. the sequence of $N v \times v$ matrixes $\tilde{K}_{\mu}^{p}, p \in I_{n}$ with

We also consider the sequence of $Q_{m} v \times v$ matrixes, noted $K_{\mu}^{q_{m}, j}, j \in I_{q_{m}}$, pad it with $N-Q_{m}$ nul matrixes, and consider its length $N$ Discrete Fourier Transform (DFT), i.e. the sequence of $N v \times v$ matrixes noted $\tilde{K}_{\mu}^{q_{m}, p}, p \in I_{n}$ with

\frac{u_{p}}{N \sigma^{2}} \int_{0}^{s} \mathbb{E}\left[\left|\tilde{G}_{u}^{p}\right|^{2}\right] d u \leq \frac{u_{p} a b T}{\sigma^{2}} \leq \frac{a b T}{\sigma^{2}}
$$

and (120) is proved with $D=e^{-\frac{a b T}{\sigma^{2}}}$. Going back to (119) and since $u_{p} \leq 1$, we have

Step 2: upper bound for $\alpha_{s}^{1,1, p}$ :
From the definition of $\alpha_{s}^{1,1, p}$ in (117) and (121), we have

& \left.+\mathbb{E}^{\gamma^{\hat{\mu}_{n}\left(V_{n}\right)}}\left[\int_{s^{(m)}}^{s}\left|\tilde{G}_{u}^{p}\right|^{2} d u\right]^{2} \mathbb{E}^{\gamma^{\hat{\mu}_{n}\left(V_{n}\right)}}\left[\tilde{\Lambda}_{s^{(m)}}^{p}(\tilde{G})\left|\tilde{G}_{s^{(m)}}^{p}\right|\left|\int_{0}^{s^{(m)}} \tilde{G}_{r^{(m)}}^{-p} d \tilde{V}_{r}^{p}\right|\right]^{2} .\right)

\left.+\mathbb{E}^{\gamma^{\hat{\mu}_{n}\left(V_{n}\right)}}\left[\tilde{\Lambda}_{s^{(m)}}^{p}(\tilde{G})\left|\tilde{G}_{s^{(m)}}^{p}\right|^{2}\right] \mathbb{E}^{\gamma^{\hat{\mu}_{n}\left(V_{n}\right)}}\left[\tilde{\Lambda}_{s^{(m)}}^{p}(\tilde{G})\left|\int_{0}^{s^{(m)}} \tilde{G}_{r^{(m)}}^{-p} d \tilde{V}_{r}^{p}\right|^{2}\right]\right) .

& \times\left(\mathbb{E}^{\gamma^{\hat{\mu}_{n}\left(V_{n}\right)}}\left[\left|\tilde{G}_{s^{(m)}}^{p}\right|^{2}\left|\int_{0}^{s^{(m)}} \tilde{G}_{r^{(m)}}^{-p} d \tilde{V}_{r}^{p}\right|^{2}\right]+\right. \\

For the second factor of the first term we use again (123) with $X_{1}=\tilde{G}_{s^{(m)}}^{p}, X_{2}=X_{1}^{*}=\tilde{G}_{s^{(m)}}^{-p}$, $X_{3}=\int_{0}^{s^{(m)}} \tilde{G}_{r^{(m)}}^{-p} d \tilde{V}_{r}^{p}$ and $X_{4}=X_{3}^{*}=\int_{0}^{s^{(m)}} \tilde{G}_{r^{(m)}}^{p} d \tilde{V}_{r}^{-p}$. By Lemma B. 9 again we have

We can conclude with Lemmas A. 1 and 3.13.

\end{aligned}
$$

where we have included the constant $\sigma^{2}$ into $D$.
Since, if $\tau(\epsilon, \mathfrak{c}) \geq u \eta_{m}$, by (76) we have

for all $s \leq u \eta_{m}$, we conclude that

\varlimsup_{n \rightarrow \infty} \frac{1}{N} \log Q^{n}\left(\frac{15}{N^{4} \sigma^{4}} \sum_{p \in I_{n}} \alpha_{v \eta_{m}}^{4,1, p} \geq \frac{\epsilon \mathfrak{c}}{3 T C \sigma^{2}} \exp \left(v \eta_{m} \mathfrak{c}\right) \text { and } \tau(\epsilon, \mathfrak{c}) \geq u \eta_{m}\right)
$$

is upperbounded by twice the larger of the two terms

& \varlimsup_{n \rightarrow \infty} \frac{1}{N} \log Q^{n}\left(\frac{D}{N^{2}} \int_{0}^{v \eta_{m}} e^{s \mathfrak{c}} d s \times \sum_{k \in I_{n}} \sum_{l \in I_{n}}\left(\int_{0}^{v \eta_{m}} f\left(V_{r(m)}^{k}\right) d W_{r}^{l}\right)^{2} \geq \frac{\mathfrak{c} \exp \left(v \eta_{m} \mathfrak{c}\right)}{6 T C \sigma^{2}}\right)  \tag{144}\\
& \varlimsup_{n \rightarrow \infty} \frac{1}{N} \log Q^{n}\left(\frac{D}{N^{2}} \int_{0}^{v \eta_{m}} e^{s \mathfrak{c}} d s \times \sum_{k \in I_{n}} \sum_{l \in I_{n}}\left(\int_{0}^{v \eta_{m}} f\left(V_{r(m)}^{k}\right) \theta_{r}^{l} d r\right)^{2} \geq \frac{\mathfrak{c} \exp \left(v \eta_{m} \mathfrak{c}\right)}{6 T C \sigma^{2}}\right) . \tag{145}
\end{align*}

Step 6: conclude by the use of Lemmas A. 1 and 3.13

& \quad \exp \left(-\frac{N \mathfrak{c}}{12 T C D \sigma^{2}}\right) \mathbb{E}^{Q^{n}}\left[\exp \left(\frac{1 / \mathfrak{c}}{2 N} \sum_{k \in I_{n}} \sum_{l \in I_{n}}\left(\int_{0}^{v \eta_{m}} f\left(V_{r^{(m)}}^{k}\right) d W_{r}^{l}\right)^{2}\right)\right] .
\end{aligned}
$$

In order to apply Lemma A. 1 to the above expectation we require

Therefore we have

& -\mathfrak{c} \frac{1}{12 T C D \sigma^{2}}-\frac{1}{4} \log \left(1-4 \frac{T}{\mathfrak{c}}\right)
\end{aligned}
$$

We conclude that for $\mathfrak{c}$ large enough, for all positive $M \mathrm{~s}$ and for all $v=0, \cdots, u(144)$ is less than $-M$.

Along similar lines, we can upperbound (145) by

$$

Since $0 \leq f \leq 1$ and $0 \leq v \eta_{m} \leq T$, this is also upperbounded by
$\varlimsup_{n \rightarrow \infty} \frac{1}{N} \log Q^{n}\left(\frac{1}{N} \sum_{l \in I_{n}} \int_{0}^{T}\left(\theta_{r}^{l}\right)^{2} d r \geq \frac{\mathfrak{c}^{2}}{6 T^{2} C D \sigma^{2}}\right) \leq \varlimsup_{n \rightarrow \infty} \frac{1}{N} \log Q^{n}\left(\frac{1}{N} \sup _{r \in[0, T]} \sum_{l \in I_{n}}\left(\theta_{r}^{l}\right)^{2} \geq \frac{\mathfrak{c}^{2}}{6 T^{3} C D \sigma^{2}}\right)$,
and Lemma 3.13 allows us to conclude.

Equation (14) resembles a Volterra equation of the second kind. As previously, we ignore for the sake of simplicity the upper time index in $L_{\mu}$ and $K_{\mu}$.
Step 1: Construction of the sequence of processes $\left(\Phi_{t}^{i, n}\right)_{i \in \mathbb{Z}, n \in \mathbb{N}_{*}}$
We proceed as in the case of the deterministic Volterra equations by constructing the following sequence of processes

& =\sigma W_{t}^{j}+\int_{0}^{t}\left(\sum_{i \in \mathbb{Z}} \int_{0}^{s} L_{\mu}^{i}(s, u) d W_{u}^{i+j}\right) d s
\end{aligned}
\end{aligned}
$$

where the infinite sum is the $L^{2}$ limit of the finite sums. The existence of this limit is guaranteed by Proposition C.8. We then compute the following difference

\text { and } \quad \sum_{k=1}^{p} \psi_{t}^{j, k} & =V_{t}^{j, p}-V_{t}^{j, 0}=V_{t}^{j, p}-\sigma W_{t}^{j}=\sum_{k=1}^{p} \int_{0}^{t} \Phi_{s}^{j, k} d s . \tag{149}
\end{align*}
$$

Step 2: Analysis of the sequence $\left(\Phi_{t}^{j, k}\right)_{j \in \mathbb{Z}, k \in \mathbb{N}_{*}}$
We now analyze the sequence $\left(\Phi_{t}^{j, k}\right)_{k \geq 1}$. First we note that

\end{aligned}

## Step 4: Proof of the convergence of (156)

We prove the convergence of the right hand side of (156). Note that (153) is a convolution with respect to the spatial index:

Applying this for $p=1$ we obtain, according to (154)

& \quad \leq\left(\int_{0}^{T}\left(\sum_{l \in \mathbb{Z}}\left|L_{\mu}^{l}(t, u)\right|\right)^{2} d u\right)^{1 / 2}\left(\int_{0}^{T}\left(\sum_{l \in \mathbb{Z}}\left|L_{\mu}^{l}(u, s)\right|\right)^{2} d u\right)^{1 / 2}=: A(t) B(s) . \tag{159}
\end{align*}
$$

Both $A(t)$ and $B(s)$ are finite by Proposition C.8. Applying (158) for $p=2$ we obtain, using (159)

& \leq A^{2}(t) B^{2}(s) \int_{s}^{t} A^{2}(u) d u \tag{160}
\end{align*}

Applying (158) for $p=3$ we obtain, using (160)

& \leq A^{2}(t) B^{2}(s) \int_{s}^{t} A^{2}(u) \int_{s}^{u} A^{2}(v) d v d u \tag{161}
\end{align*}

In general we can write

F_{k}(t, s) & =\int_{s}^{t} A^{2}(u) F_{k-1}(u, s) d u \tag{164}
\end{align*}

We claim that

\end{aligned}

\sigma^{-(k+1)}\left|L_{\mu, k+2}^{i}(t, s)\right| \leq \sigma^{-1} \frac{\left(\sigma^{-1} C\right)^{k}}{\sqrt{k!}} A(t) B(s) \tag{167}
\end{equation*}
$$

for all $i \in \mathbb{Z}$. and, since the series $z^{k} / \sqrt{k!}$ is absolutely convergent for all complex $z$, (167) shows that the right hand side of (156) is absolutely and uniformly convergent so that $M_{\mu}^{i}(t, s)$ is well-defined for all $i \in \mathbb{Z}$, continuous and uniformly bounded w.r.t. to $i$, and (166) shows that the series $M_{\mu}^{i}(t, s)$ is absolutely convergent, so that we have obtained (88).

## Step 5: Existence and uniqueness of the solution

We then prove that (88) is a solution to (14) and that it is unique. Indeed, (88) implies

Uniqueness is obtained by noting that if two solutions $V_{1, t}$ and $V_{2, t}$ exist, there difference $V_{t}=V_{1, t}-V_{2, t}$ must satisfy the deterministic homogeneous Volterra equation of the second type

& \sigma^{-1} \underbrace{\sum_{t^{(m)}} L_{\mu_{*}}^{i}\left(t^{(m)}, s^{(m)}\right)\left(\int_{0}^{s} M_{\mu_{*}}^{k}(s, u)\left(\int_{0}^{v} L_{\mu_{*}}^{L-k}(u, v) d W_{v}^{L+i+j}\right) d u\right) d s .}_{i, k, L \in I_{q_{m}}} \tag{174}
\end{align*}
$$

Lemma F. 2 then follows from the following two Lemmas.
Lemma F.8. For all $\varepsilon>0$, there exists $m_{0}(\varepsilon)$ in $\mathbb{N}$ such that for all $m \geq m_{0}$

$$
\mathbb{E}\left[\sup _{s \in[0, t]}\left|\alpha_{s}^{j, 2,1}\right|\right] \leq C \varepsilon
$$

for some positive constant $C$ independent of $j$.
Lemma F.9. For all $\varepsilon>0$, there exists $m_{0}(\varepsilon)$ in $\mathbb{N}$ such that for all $m \geq m_{0}$

$$
\mathbb{E}\left[\sup _{s \in[0, t]}\left|\alpha_{s}^{j, 2,2}\right|\right] \leq C \varepsilon
$$

for some positive constant $C$ independent of $j$.

Proof of Lemma F.8. The proof is very similar to that of Lemma F.5. As in this Lemma it is based upon recognizing that

$$
S_{t}^{j}:=\sum_{i \in I_{q_{m}}} \int_{t^{(m)}}^{t} L_{\mu_{*}}^{i}(t, s) d W_{s}^{i+j}
$$

is a continuous martingale with quadratic variation

$$
\left\langle S_{\cdot}^{j}\right\rangle_{t}=\sum_{i \in I_{q_{m}}} \int_{t^{(m)}}^{t}\left(L_{\mu_{*}}^{i}(t, s)\right)^{2} d s
$$

because of the independence of the Brownian motions.
We have

$$
\mathbb{E}\left[\sup _{s \in[0, t]}\left|\alpha_{s}^{j, 2,1}\right|\right]=\sigma \mathbb{E}\left[\sup _{s \in[0, t]}\left|S_{s}^{j}\right|\right],
$$

and, by Burkholder-Davis-Gundy's inequality

$$
\begin{aligned}
& \mathbb{E}\left[\sup _{s \in[0, t]}\left|\alpha_{s}^{j, 2,1}\right|\right] \leq C_{1} \sigma\left(\sum_{i \in I_{q_{m}}} \int_{t^{(m)}}^{t}\left(L_{\mu_{*}}^{i}(t, u)\right)^{2} d u\right)^{1 / 2} \leq \\
& C_{1} \sigma\left(\int_{t^{(m)}}^{t} \sum_{i \in \mathbb{Z}}\left(L_{\mu_{*}}^{i}(t, u)\right)^{2} d u\right)^{1 / 2}=\frac{C_{1} \sigma}{\sqrt{2 \pi}}\left(\int_{t^{(m)}}^{t} \int_{-\pi}^{\pi}\left|\tilde{L}_{\mu_{*}}(\varphi)(t, u)\right|^{2} d \varphi d u\right)^{1 / 2} .
\end{aligned}
$$

The fact that $\int_{-\pi}^{\pi}\left|\tilde{L}_{\mu_{*}}(\varphi)(t, w)\right|^{2} d \varphi \leq C$ for some positive constant $C$ uniformly in $t, w$, follows from Proposition C. 8 and ends the proof.

Remark F.10. The proof of Lemma F. 9 is very similar and left to the reader.
Next we write

$$
\begin{align*}
& \alpha_{t}^{j, 3}=\sigma \underbrace{\sum_{i \in I_{q_{m}}} \int_{0}^{t}\left(L_{\mu_{*}}^{i}\left(t^{(m)}, s^{(m)}\right)-L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{q_{m}, i}\left(t^{(m)}, s^{(m)}\right)\right) d W_{s}^{i+j}}_{\alpha_{t}^{j, 3,1}}+ \\
& \sigma^{-1} \sum_{i, k, L \in I_{q_{m}}} \int_{0}^{t}\left(L_{\mu_{*}}^{i}\left(t^{(m)}, s^{(m)}\right)-L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{q_{m}, i}\left(t^{(m)}, s^{(m)}\right)\right) \\
&\left(\int_{0}^{s} M_{\mu_{*}}^{k}(s, u)\left(\int_{0}^{u} L_{\mu_{*}}^{L-k}(u, v) d W_{v}^{L+i+j}\right) d u\right) d s \tag{175}
\end{align*}
$$

and define

$$
\begin{aligned}
& \alpha_{t}^{j, 3,2}:= \sum_{i, k, L \in I_{q_{m}}} \int_{0}^{t}\left(L_{\mu_{*}}^{i}\left(t^{(m)}, s^{(m)}\right)-\right. \\
&\left.L_{\hat{\mu}_{n}\left(V_{n}^{m)}\right.}^{q_{m}, i}\left(t^{(m)}, s^{(m)}\right)\right) \\
&\left(\int_{0}^{s} M_{\mu_{*}}^{k}(s, u)\left(\int_{0}^{u} L_{\mu_{*}}^{L-k}(u, v) d W_{v}^{L+i+j}\right) d u\right) d s .
\end{aligned}
$$

Lemma F. 3 then follows from the next two Lemmas.
Lemma F.11. For all $\varepsilon>0$,

$$
\mathbb{E}\left[\sup _{s \in[0, t]}\left|\alpha_{s}^{j, 3,1}\right|\right] \leq C \varepsilon
$$

for some positive constant $C$ independent of $j$, for all $m, n$ large enough.
Similarly we have
Lemma F.12. For all $\varepsilon>0$,

$$
\mathbb{E}\left[\sup _{s \in[0, t]}\left|\alpha_{s}^{j, 3,2}\right|\right] \leq C \varepsilon
$$

for some positive constant $C$ independent of $j$, for all $m, n$ large enough.
Sketch of a proof of Lemma F.11.
We note that $S_{t}^{j, m}:=\sum_{i \in I_{q_{m}}} \int_{0}^{t}\left(L_{\mu_{*}}^{i}\left(t^{(m)}, s^{(m)}\right)-L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{q_{m}, i}\left(t^{(m)}, s^{(m)}\right)\right) d W_{s}^{i+j}$ is a martingale. Hence, by the Bürkholder-Davis-Gundy inequality,

$$
\mathbb{E}\left[\sup _{s \in[0, t]}\left|S_{s}^{j, m}\right|\right] \leq C_{1} \mathbb{E}\left[\left\langle S^{j, m}\right\rangle_{t}^{1 / 2}\right] \leq C_{1} \mathbb{E}\left[\left\langle S^{j, m}\right\rangle_{t}\right]^{1 / 2}
$$

By the independence of the Brownian motions

$$
\left\langle S^{j, m}\right\rangle_{t}=\sum_{i \in I_{q_{m}}} \int_{0}^{t}\left(L_{\mu_{*}}^{i}\left(t^{(m)}, u^{(m)}\right)-L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{q_{m}, i}\left(t^{(m)}, u^{(m)}\right)\right)^{2} d u,
$$

and therefore, by Cauchy-Schwarz

$$
\mathbb{E}\left[\sup _{s \in[0, t]}\left|S_{s}^{j, m}\right|\right] \leq C_{1}\left(\int_{0}^{t} \sum_{i \in I_{q_{m}}} \mathbb{E}\left[\left(L_{\mu_{*}}^{i}\left(t^{(m)}, u^{(m)}\right)-L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{q_{m}, i}\left(t^{(m)}, u^{(m)}\right)\right)^{2}\right] d u\right)^{1 / 2}
$$

By Proposition C. $10\left|L_{\mu_{*}}^{i}\left(t^{(m)}, u^{(m)}\right)-L_{\hat{\mu}_{n}\left(V_{n}^{m}\right)}^{q_{m}, i}\left(t^{(m)}, u^{(m)}\right)\right| \leq D_{t}\left(\mu_{*}, \hat{\mu}_{n}\left(V_{n}^{m}\right)\right) \mathcal{O}\left(1 /|i|^{3}\right)$, where $D_{t}$ is the Wasserstein distance between the two measures $\mu_{*}$ and $\hat{\mu}_{n}\left(V_{n}^{m}\right)$, we conclude that

$$
\mathbb{E}\left[\sup _{s \in[0, t]}\left|S_{s}^{j, n, m}\right|\right] \leq C_{1} T^{1 / 2} \mathbb{E}\left[D_{t}\left(\mu_{*}, \hat{\mu}_{n}\left(V_{n}^{m}\right)\right)\right] \sum_{i \in I_{q_{m}}} \mathcal{O}\left(1 /|i|^{3}\right) \leq C \mathbb{E}\left[D_{t}\left(\mu_{*}, \hat{\mu}_{n}\left(V_{n}^{m}\right)\right)\right]
$$

for a constant $C>0$. This concludes the proof of the Lemma since Lemma 3.25 implies that $\lim _{m, n \rightarrow \infty} \mathbb{E}\left[D_{t}\left(\mu_{*}, \hat{\mu}_{n}\left(V_{n}^{m}\right)\right)\right]=0$.

The proof of Lemma F. 12 is very similar and left to the reader. So is the proof of Lemma F.4.
