# ON SOME COUNTERPARTS OF RICKART *-ALGEBRAS

#### Abstract

In the present paper, we introduce and study counterparts of Rickart involutive algebras, i.e., almost inner Rickart algebras. We prove that a nilpotent associative algebra, which has no nilpotent elements with nonzero square roots, is an almost inner Rickart algebra. A nilpotent associative algebra, which has no nilpotent elements with a square root $b$ such that $b^{3} \neq \mathbf{0}$, is not an almost inner Rickart algebra if there exists a nonzero element $a$ such that $a^{2} \neq \mathbf{0}$.

As a main result of the paper, we describe a finite-dimensional almost inner Rickart algebra $\mathcal{A}$ over a field $\mathbb{F}$, isomorphic to $\mathbb{F}^{n} \dot{+} \mathcal{N}, n=1,2$, with a nilradical $\mathcal{N}$. Also, we classify finite-dimensional almost inner Rickart algebras over the real or complex numbers with a nonzero nilradical $\mathcal{N}$.


## 1. Introduction

In the present paper, we introduce and study counterparts of Rickart *-algebras, that is almost inner Rickart algebras. We define an almost inner Rickart algebra as an associative algebra which is a Jordan algebra with respect to the Jordan multiplication $a \cdot b=\frac{1}{2}(a b+b a)$ close to inner RJ-algebras. Inner RJ-algebras are introduced and studied in the papers [1], [2], [3].

The chosen notions were built around an (inner) quadratic annihilator. For each nonempty subset $\mathcal{B}$ of an associative algebra $\mathcal{A}$, the (inner) quadratic annihilator of $\mathcal{B}$ is defined by

$$
{ }^{\perp_{q}} \mathcal{B}:=\{a \in \mathcal{A}: s a s=\mathbf{0}, \forall s \in \mathcal{B}\} .
$$

Thus, following [5], an associative algebra $\mathcal{A}$ which is equal to the direct sum $\mathcal{S} \dot{+} \mathcal{N}$ of vector spaces $\mathcal{S}$ and $\mathcal{N}$, where $\mathcal{S}$ is a semisimple algebra and $\mathcal{N}$ is a nilpotent radical of $\mathcal{A}$ (including the case $\mathcal{N} \equiv\{\mathbf{0}\}$ ), is called an almost inner Rickart algebra if, for each element $x \in \mathcal{A}$, there exists an idempotent $e \in \mathcal{A}$ such that ${ }^{\perp_{q}}\{x\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$, where $\mathcal{S}^{2}:=\left\{a^{2}: a \in \mathcal{S}\right\}$, $\mathcal{N}^{2}:=\left\{a^{2}: a \in \mathcal{N}\right\}$. There exist examples of almost inner Rickart algebras without unit element (cf. [2, p. 32]). Note that, there exist pairwise nonisomorphic (associative) almost inner Rickart algebras, the Jordan algebras of which are isomorphic (see Examples in item 4) below). This is a motivation to introduce the notion of an almost inner Rickart algebra.

[^0]In the present paper, we prove that a nilpotent associative algebra $\mathcal{A}$ such that $a^{2}=\mathbf{0}$ for every element $a \in \mathcal{A}$ is an almost inner Rickart algebra. We explain that a nilpotent associative algebra that has no nilpotent elements with a square root $b$ such that $b^{3} \neq 0$ is not an almost inner Rickart algebra if there exists a nonzero element $a$ such that $a^{2} \neq \mathbf{0}$.

As a main result of the paper we describe a finite-dimensional almost inner Rickart algebra $\mathcal{A}$ over a field $\mathbb{F}$, isomorphic to $\mathbb{F}^{n} \dot{+} \mathcal{N}, n=1,2$, with a nilradical $\mathcal{N}$ (Theorems 2.5 and 2.11). Also, we classify finite-dimensional almost inner Rickart algebras over the real or complex numbers with a nonzero nilradical $\mathcal{N}$ (Theorem 2.10).

## 2. Description of finite-dimensional almost inner Rickart ALGEBRAS

Throughout the paper let $\mathcal{A}$ be an associative algebra which is decomposed (as a linear space) into a direct sum $\mathcal{S} \dot{+} \mathcal{N}$ of a semisimple algebra $\mathcal{S}$ and a nilpotent radical $\mathcal{N}$ of $\mathcal{A}$. For an associative algebra $\mathcal{A}$, we consider the following condition:
(A) for every element $x \in \mathcal{A}$, there exists an idempotent $e \in \mathcal{A}$ such that

$$
{ }^{\perp_{q}}\{x\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right) .
$$

Definition. An associative algebra satisfying condition (A) is called an almost inner Rickart algebra, and condition (A) itself is called an almost inner Rickart condition.

Examples. 1) It is obvious that every associative algebra which is an inner RJ-algebra with respect to the multiplication $a \cdot b=\frac{1}{2}(a b+b a)$ is an almost inner Rickart algebra.
2) Let $M_{n}(\mathbb{R})$ be the associative algebra of $n \times n$ matrices over the field $\mathbb{R}$ of real numbers, where $\mathbf{1}$ is the unit of the algebra $M_{n}(\mathbb{R}),\left\{e_{i, j}\right\}_{i, j=1}^{n}$ is the system of matrix units of the algebra $M_{n}(\mathbb{R}), n=2 k$.
a) Consider the associative algebra

$$
\mathcal{A}=\mathbb{R} \mathbf{1}+\sum_{i=1}^{k} \mathbb{R} e_{2 i-1,2 i}
$$

This algebra is an almost inner Rickart algebra which is not involutive [2, p. 30].
b) Similarly, the associative algebra

$$
\mathcal{A}=\mathbb{R} \mathbf{1}+\sum_{i=1}^{k} \mathbb{R} e_{2 i, 2 i-1}
$$

is an almost inner Rickart algebra.
c) Consider the associative algebra

$$
\mathcal{A}=\sum_{i=1}^{k} \mathbb{R} e_{2 i-1,2 i}
$$

This algebra is an almost inner Rickart algebra without a unit element [2, Page 30, Example 3]. Indeed, since $\mathcal{S}^{2} \cup \mathcal{N}^{2}=\{\mathbf{0}\}$, then

$$
{ }^{\perp_{q}}\{0\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=\mathbf{0}(\mathcal{A}) \mathbf{0} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)
$$

Moreover, $\left\{e_{2 i-1,2 i}\right\}^{\perp_{q}} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=\mathbf{0}(\mathcal{A}) \mathbf{0} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$ for any $i$ from $\{1,2, \ldots, k\}$.
d) Similar to Example c) the associative algebra

$$
\mathcal{A}=\sum_{i=1}^{k} \mathbb{R} e_{2 i, 2 i-1}
$$

is also an almost inner Rickart algebra without a unit element.
3) A vector space $\mathcal{A}$ of dimension $n+1$ with a basis $\left\{e, e_{1}, e_{2}, \ldots, e_{n}\right\}$ such that

$$
e e=e, e e_{i}=e_{i} e=e_{i}, e_{i}^{2}=\mathbf{0}, e_{i} e_{j}=\mathbf{0}, i, j=1,2, \ldots, n
$$

is a commutative associative algebra and, by Theorem 2.5, an almost inner Rickart algebra.
4) Let $\mathcal{A}$ be an associative algebra and $(\mathcal{A}, \cdot)$ be the Jordan algebra with respect to the multiplication $a \cdot b=\frac{1}{2}(a b+b a)$. Then, the algebras $\mathcal{A}_{2}^{2}, \mathcal{A}_{2}^{3}, \mathcal{A}_{3}^{4}, \mathcal{A}_{3}^{6}, \mathcal{A}_{4}^{8}, \mathcal{A}_{4}^{9}$, $\mathcal{A}_{4}^{19}, \mathcal{A}_{4}^{20}$ are almost inner Rickart algebras (see Tables 1 and 2) and the Jordan algebras $\left(\mathcal{A}_{2}^{2}, \cdot\right) \cong\left(\mathcal{A}_{2}^{3}, \cdot\right),\left(\mathcal{A}_{3}^{4}, \cdot\right) \cong\left(\mathcal{A}_{3}^{6}, \cdot\right),\left(\mathcal{A}_{4}^{8}, \cdot\right) \cong\left(\mathcal{A}_{4}^{9}, \cdot\right),\left(\mathcal{A}_{4}^{19}, \cdot\right) \cong\left(\mathcal{A}_{4}^{20}, \cdot\right)$. Thus, two mutually non-isomorphic almost inner Rickart algebras give the same Jordan algebra. The examples above are a motivation to introduce the notion of an almost inner Rickart algebra.

Lemma 2.1. Let $\mathcal{A}=\mathcal{S}+\mathcal{N}$ be an almost inner Rickart algebra. Then the algebra $\mathcal{A}$ has an element e such that ear $a^{2} a^{2} e=a^{2}$ for every $a \in \mathcal{S} \cup \mathcal{N}$.

Proof. Take $x=\mathbf{0}$. We have ${ }^{\perp_{q}}\{x\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$ for some idempotent $e$ in $\mathcal{A}$. But ${ }^{\perp_{q}}\{x\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=\mathcal{A} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=\mathcal{S}^{2} \cup \mathcal{N}^{2}$. Hence $e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=\mathcal{S}^{2} \cup \mathcal{N}^{2}$. Then $e a=e(e b e)=e b e=a$ and $a e=(e b e) e=$ ebe $=a$ for all $a \in \mathcal{S}^{2} \cup \mathcal{N}^{2}$.

Theorem 2.2. A nilpotent associative algebra that has no nilpotent elements with a nonzero square root is an almost inner Rickart algebra.

Proof. Let $\mathcal{A}$ be a nilpotent associative algebra that has no nilpotent elements with a nonzero square root. Let $a$ be a nonzero element from the algebra $\mathcal{A}$. Since $\mathcal{A}$ is nilpotent, then $a^{m}=\mathbf{0}$ for some element $m$. Then $a^{2}=\mathbf{0}$. Otherwise, the algebra $\mathcal{A}$ contains an element $b$, which is a nilpotent element with a nonzero square root. So, $a^{2}=\mathbf{0}$ for every non-zero element $a$ from $\mathcal{A}$. Therefore, for any $a, b$ from $\mathcal{A}$,

$$
a b+b a=(a+b)^{2}-a^{2}-b^{2}=\mathbf{0}, \quad a b a+b a a=a b a=\mathbf{0}
$$

The algebra $\mathcal{A}$ is an almost inner Rickart algebra. Indeed, the algebra $\mathcal{A}$ does not contain a nonzero idempotent. In particular, there is no non-zero idempotent $e$ such that

$$
{ }^{\perp_{q}}\{\mathbf{0}\}=e \mathcal{A} e .
$$

However, since $\mathcal{S}^{2} \cup \mathcal{N}^{2}=\{0\}$, we have

$$
{ }^{\perp_{q}}\{0\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=\mathbf{0} \mathbf{A} 0 \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)
$$

Here ${ }^{\perp_{q}}\{\mathbf{0}\}=\mathcal{A}$. Similarly, for any element $a$ from $\mathcal{A}$, we have

$$
{ }^{\perp_{q}}\{a\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=\{0\}=\mathbf{0} \mathcal{A} 0 \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)
$$

The proof is complete.
Theorem 2.3. Let $\mathcal{A}$ be a nilpotent associative algebra. Then $\mathcal{A}$ is an almost inner Rickart algebra if and only if, for any element a in $\mathcal{A}, a^{2}=\mathbf{0}$.

Proof. Suppose that $\mathcal{A}$ is an almost inner Rickart algebra. Let $a$ be an arbitrary nonzero element from the algebra $\mathcal{A}$ such that $a^{2} \neq 0$. Since the algebra $\mathcal{A}$ is nilpotent, $a$ is a nilpotent element. Then $a^{k} \neq \mathbf{0}, a^{k+1}=\mathbf{0}$ for some natural number $k \geq 2$. Then $\left(a^{\left[\frac{k}{2}\right]}\right)^{2} \neq \mathbf{0}$ and

$$
\left(a^{\left[\frac{k}{2}\right]}\right)^{2} \in^{\perp_{q}}\{a\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right) .
$$

Hence, ${ }^{\perp_{q}}\{a\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right) \neq\{\mathbf{0}\}$. So, there is a nonzero idempotent $e$ such that

$$
{ }^{\perp_{q}}\{a\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right) .
$$

But there is no nonzero idempotent in the algebra $A$ since the algebra $\mathcal{A}$ is nilpotent. Therefore, $\mathcal{A}$ is not an almost inner Rickart associative algebra. This is a contradiction. So, $a^{2}=\mathbf{0}$.

Now, suppose that for any element $a$ in $\mathcal{A}, a^{2}=\mathbf{0}$. Then, by Theorem $2.2 \mathcal{A}$ is an almost inner Rickart algebra. This ends the proof.

Lemma 2.4. Let $\mathcal{A}$ be a finite-dimensional almost inner Rickart algebra over a field $\mathbb{F}$ of characteristic $\neq 2$ and $\neq 3$ with a one-dimensional simple subalgebra $\mathcal{S}$ and an n-dimensional commutative nilpotent radical $\mathcal{N}$ such that $\mathcal{A}=\mathcal{S}+\mathcal{N}$, $\mathcal{N}^{2} \neq\{\mathbf{0}\}$ and $\mathcal{N}^{3}=\left\{a^{3}: a \in \mathcal{N}\right\}=\{\mathbf{0}\}$. Then, for any idempotent $e \in \mathcal{A}$ such that ${ }^{\perp_{q}}\{x\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$, $e \in \mathcal{S}$, and, for any elements $a, b, c$ from $\mathcal{N}$,

$$
\begin{equation*}
a b c=0 . \tag{1.0}
\end{equation*}
$$

Proof. By the condition, the associative algebra $\mathcal{N}$ has no nilpotent elements $a$ such that $a^{3} \neq \mathbf{0}$. So, for any nonzero element $a$ from the nilradical $\mathcal{N}$ we have $a^{3}=\mathbf{0}$. Therefore, for any $a, b$ from $\mathcal{N}$,

$$
\begin{gathered}
\mathbf{0}=(a+b)^{3}-a^{3}-b^{3}=\left(a^{2}+a b+b a+b^{2}\right)(a+b)-a^{3}-b^{3}, \\
=a^{3}+a^{2} b+a b a+a b^{2}+b a^{2}+b a b+b^{2} a+b^{3}-a^{3}-b^{3}=3 a^{2} b+3 b^{2} a, \\
\mathbf{0}=(a-b)^{3}-a^{3}+b^{3}=\left(a^{2}-a b-b a+b^{2}\right)(a-b)-a^{3}+b^{3}, \\
=a^{3}-a^{2} b-a b a+a b^{2}-b a^{2}+b a b+b^{2} a-b^{3}-a^{3}-b^{3}=-3 a^{2} b+3 b^{2} a .
\end{gathered}
$$

Hence,

$$
a^{2} b=\mathbf{0}, b^{2} a=\mathbf{0}
$$

As well as,

$$
a b c=a \frac{1}{2}\left((b+c)^{2}-b^{2}-c^{2}\right)=\frac{1}{2}\left(a(b+c)^{2}-a b^{2}-a c^{2}\right)=\mathbf{0} .
$$

So, for any elements $a, b, c$ from $\mathcal{N}$, equality (1.0) is valid.

Let $a$ be an arbitrary nonzero element from the radical $\mathcal{N}$. Then there exists a nonzero idempotent $e \in \mathcal{A}$ such that

$$
{ }^{\perp_{q}}\{a\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right) .
$$

Due to (1.0) we have $\mathcal{N}^{2} \subseteq^{\perp_{q}}\{a\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$. Hence,

$$
\mathcal{N}^{2} \subseteq e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)
$$

Since $\mathcal{S}$ is a one-dimensional simple algebra, there exists an idempotent $p$ in $\mathcal{S}$ such that $\mathcal{S}=\mathbb{F} p$. There exist $b \in \mathcal{N}$ and nonzero $x \in \mathcal{S}$ such that $e=x+b$. We have

$$
e=e^{2}=(x+b)^{2}=x^{2}+x b+b x+b^{2}, x=x^{2}, b=x b+b x+b^{2}
$$

So, $x=p$.
If there exists $y \in \mathcal{S}^{2}$ such that $y \in{ }^{\perp_{q}}\{a\}$, then $p \in{ }^{\perp_{q}}\{a\}$, i.e., apa $=\mathbf{0}$. Hence, $p \in e\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right) e$, i.e., $e p=p e=p$. So, $(p+b) p=p(p+b)=p$. But $p(p+b)=(p+b) p=p+b p=p+p b$ and $p b, b p \in \mathcal{N}$. Hence, $b p=p b=\mathbf{0}$. Therefore, $b=p b+b p+b^{2}=b^{2}$. The fact that $b^{2} \neq \mathbf{0}$ contradicts $b \in \mathcal{N}$ and that $\mathcal{N}$ is nilpotent. So, $b^{2}=\mathbf{0}$ and, hence, $b=\mathbf{0}$. From $b=\mathbf{0}$ it follows that $e=p$, i.e., $e \in \mathcal{S}$.

Suppose that $\mathcal{S}^{2} \cap{ }^{\perp_{q}}\{a\}=\{\mathbf{0}\}$. Then

$$
\perp_{q}\{a\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=e \mathcal{A} e \cap \mathcal{N}^{2}=\mathcal{N}^{2}
$$

But, for any $a \in \mathcal{N}$, we have $e a^{2} e=e a^{2}=a^{2}$, i.e., $(p+b) a^{2}=p a^{2}+b a^{2}=p a^{2}=a^{2}$ by (1.0). Similarly, $a^{2} p=a^{2}$. Hence,

$$
e \mathcal{A} e \cap \mathcal{N}^{2}=\mathcal{N}^{2}=p \mathcal{N}^{2} p=p \mathcal{A} p \cap \mathcal{N}^{2}
$$

Therefore, in this case we have

$$
{ }^{\perp_{q}}\{a\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=p \mathcal{A} p \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)
$$

and instead of $e$ we can take $p$. The proof is complete.
Theorem 2.5. Let $\mathcal{A}$ be a finite-dimensional almost inner Rickart algebra over a field $\mathbb{F}$ of characteristic $\neq 2$ and $\neq 3$ with a one-dimensional simple subalgebra $\mathcal{S}$ and an n-dimensional commutative nilpotent radical $\mathcal{N}$ such that $\mathcal{A}=\mathcal{S}+\mathcal{N}$, $\mathcal{N}^{2} \neq\{\mathbf{0}\}$ and $\mathcal{N}^{3}=\{\mathbf{0}\}$. Then there is a nonzero idempotent $e \in \mathcal{A}$ such that $\mathcal{A}=\mathbb{F} e \dot{+} \mathcal{N}$ and for any basis $\left\{e_{1}, e_{2}, \ldots, e_{n}\right\}$ of $\mathcal{N}$ the following conditions are valid

$$
\begin{gather*}
e_{i} e_{j} e_{k}=\mathbf{0}, i, j, k=1,2, \ldots, n,  \tag{1.1}\\
e\left(e_{i} e_{j}\right)=\left(e_{i} e_{j}\right) e=e_{i} e_{j}, i, j=1,2, \ldots, n,  \tag{1.2}\\
e_{i} e e_{j}+e_{j} e e_{i}=\mathbf{0}, i, j=1,2, \ldots, n,  \tag{1.3}\\
e e_{i} \in \mathcal{N}, e_{i} e \in \mathcal{N} . \tag{1.4}
\end{gather*}
$$

Conversely, any associative algebra $\mathcal{A}$ over a field $\mathbb{F}$ of characteristic $\neq 2$ and $\neq 3$ with a one-dimensional simple subalgebra $\mathcal{S}=\mathbb{F e}$, where $e$ is an idempotent element, and an n-dimensional commutative nilpotent radical $\mathcal{N}$ with a basis
$\left\{e_{1}, e_{2}, \ldots, e_{n}\right\}$ such that $\mathcal{A}=\mathcal{S} \dot{+} \mathcal{N}$, is an almost inner Rickart algebra if the conditions (1.1)-(1.4) are valid.

Proof. Since $\mathcal{N}^{3}=\{\mathbf{0}\}$, we have, by Lemma 2.4, for any elements $a, b, c$ from $\mathcal{N}$,

$$
\begin{equation*}
a b c=0 . \tag{1.5}
\end{equation*}
$$

Since $\mathcal{N}^{2} \neq\{\mathbf{0}\}$, there exists $x \in \mathcal{N}$ such that $x^{2} \neq \mathbf{0}$. Let $a$ be an arbitrary nonzero element from the radical $\mathcal{N}$. Then, by Lemma 2.4 and (1.5), there exists a nonzero idempotent $e \in \mathcal{S}$ such that

$$
x^{2} \in^{\perp_{q}}\{a\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)
$$

We also have $e \in e \mathcal{A} e$. Since $e$ is idempotent, we have $e \in \mathcal{S}^{2}$. Hence, $e \in$ $e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$, i.e., $e \in^{\perp_{q}}\{a\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$. From this it follows that aea $=\mathbf{0}$.

Due to (1.5) we have $\mathcal{N}^{2} \subseteq{ }^{\perp_{q}}\{a\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$. Hence,

$$
\mathcal{N}^{2} \subseteq e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)
$$

Let $b$ be another nonzero element from the nilradical $\mathcal{N}$. Then there exists a nonzero idempotent $f \in \mathcal{S}$ such that

Since codimension of $\mathcal{N}$ equals 1 we have $e=f$. If we take $a+b$ then

Now let us prove that the associative algebra $\mathcal{A}$ with a basis $\left\{e, e_{1}, e_{2}, \ldots, e_{n}\right\}$, satisfying the properties (1.1)-(1.4), is an almost inner Rickart algebra. We have

Now we take an element of the form $\lambda e+a, \lambda \neq 0$. Since $\mathcal{N}$ is an ideal, by (1.2), we have

for every $b \in \mathcal{N}$ such that $b^{2} \neq \mathbf{0}$. We also have

and $c \in \mathcal{N}$ since $\mathcal{N}$ is an ideal. Therefore $(\lambda e+a)(\mu e)^{2}(\lambda e+a) \neq \mathbf{0}$. Hence,

So, $\mathcal{A}$ is an almost inner Rickart algebra. The proof is complete.
It should be noted that Theorem 2.4 in [3], which is a Jordan analog of Theorem 2.5 , is incorrect. A correct version of this theorem is proved in [4]. Note that Theorem 2.4 in the paper [3] is valid for a so-called almost inner RJ-algebra, defined following way:
Definition 2.6. A Jordan algebra $\mathcal{J}$ with a semisimple subalgebra $\mathcal{S}$ and a nilpotent radical $\mathcal{N}$ such that $\mathcal{J}=\mathcal{S} \dot{+} \mathcal{N}$ is called an almost inner RJ-algebra if, for any element $a \in \mathcal{J}$, there exists an idempotent $e \in \mathcal{S}$ such that

{ }^{\perp_{q}}\{a\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=U_{e}(\mathcal{J}) \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right) .

It should be noted that this and all other statements of the paper [3] are valid for almost inner RJ-algebras. In [4] corrected versions for inner RJ-algebras of the statements in [3] are given.

Remark 2.7. Note that the associative algebra, indicated in theorem 2.5 is a direct sum of an indecomposable non-nilpotent algebra and a nilpotent algebra. If, for example, the nilradical $\mathcal{N}$ of an almost inner Rickart algebra $\mathcal{A}$ is of codimension 2 , then the quantity of non-nilpotent indecomposable algebras in the direct sum of $\mathcal{A}$ may be one or two. For example, the almost inner Rickart algebra

where $\left\{e_{1}, e_{2}, n_{1}, n_{2}\right\}$ is a basis of the algebra $\mathcal{A}_{1}$ and the omitted products vanish, is decomposable. The subalgebras

\mathcal{B}_{1}: e_{1}^{2}=e_{1}, e_{1} n_{1}=n_{1}, \mathcal{B}_{2}: e_{2}^{2}=e_{2}, e_{2} n_{2}=n_{2}
$$

are almost inner Rickart algebras satisfying the conditions of theorem 2.5 and $\mathcal{A}_{1}=\mathcal{B}_{1} \oplus \mathcal{B}_{2}$. The associative algebra

([6, Table 2.3, algebra $\left.A s_{4}^{19}\right]$ ), where $\left\{e_{1}, e_{2}, n_{1}, n_{2}\right\}$ is a basis of the algebra $\mathcal{A}_{2}$ and the omitted products vanish, is indecomposable. The nilradical $\mathcal{N}=<n_{1}, n_{2}>$ is an almost inner Rickart algebra by Theorem 2.3. Then $\mathcal{A}_{2}$ is also an almost inner Rickart algebra by Theorem 2.11. The subalgebras

of the algebra $\mathcal{A}_{2}$ are almost inner Rickart algebras satisfying the conditions of Theorem 2.5.

Let $\mathcal{A}$ be a finite-dimensional almost inner Rickart algebra which is decomposed (as a linear space) into a direct sum $\mathcal{S} \dot{+} \mathcal{N}$ of a semisimple algebra $\mathcal{S}$ and a nilpotent radical $\mathcal{N}$ of $\mathcal{A}$. For $\mathcal{A}$, we consider the following condition:
(B) for any idempotent $e \in \mathcal{A}$ such that ${ }^{\perp_{q}}\{x\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$, $e \in \mathcal{S}$.

Lemma 2.8. Let $\mathcal{A}$ be a finite-dimensional associative algebra over the real or complex numbers which is decomposed (as a linear space) into a direct sum $\mathcal{S} \dot{+} \mathcal{N}$ of a semisimple algebra $\mathcal{S}$ and a nilpotent radical $\mathcal{N}$ of $\mathcal{A}$. Then, if $\mathcal{A}$ is an almost inner Rickart algebra satisfying Condition (B), then $\mathcal{S}$ is also an almost inner Rickart algebra.
Proof. Let $a$ be an arbitrary nonzero element from $\mathcal{S}$. Then there exists a nonzero idempotent $e \in \mathcal{S}$ such that

{ }^{\perp_{q}}\{a\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right) .

This ends the proof.
Lemma 2.9. Let $\mathcal{A}=\mathcal{S}+\mathcal{N}$ be an almost inner Rickart algebra satisfying Condition (B). Then the algebra $\mathcal{A}$ has no a nilpotent element $a$ in $\mathcal{S} \cup \mathcal{N}$ such that $a^{3} \neq 0$.
Proof. Take an element $a \in \mathcal{S} \cup \mathcal{N}$. Suppose that $a^{4}=\mathbf{0}$. Then $a^{2} \in{ }^{\perp_{q}}\{a\} \cap$ $\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$. Since $\mathcal{A}$ is an almost inner Rickart algebra, there exists a nonzero idempotent $e \in \mathcal{A}$ such that ${ }^{\perp_{q}}\{a\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$. Therefore aea $=\mathbf{0}$ and $e a^{2}=a^{2}$ since $e \in e \mathcal{A} e \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$. Hence, $a^{3}=a a^{2}=a e a^{2}=$ $($ aea $) a=\mathbf{0}$.

Further, we shall apply the induction. The induction assumption is $\left(a^{2}\right)^{k}=\mathbf{0}$, $1 \leq k \leq n$, implies that $a^{3}=\mathbf{0}$, where the induction step is $n$. If $n=1,2$ then the induction assumption is valid by the previous paragraph.

Suppose that $\left(a^{2}\right)^{n+1}=0$. Then, if $n=2 k$, then $\left(a^{2}\right)^{n+1} a^{2}=\left(a^{2}\right)^{2 k+2}=$ $\left(a^{4}\right)^{k+1}=\mathbf{0}$ and $1 \leq k+1<n$. By the inductive assumption $a^{6}=\mathbf{0}$. So, $\left(a^{2}\right) a^{2}\left(a^{2}\right)=\mathbf{0}$ and $a^{2} \in{ }^{\perp_{q}}\left\{a^{2}\right\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$. Since $\mathcal{A}$ is an almost inner Rickart algebra, there exists an idempotent $f \in \mathcal{A}$ such that ${ }^{\perp_{q}}\left\{a^{2}\right\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=$ $f \mathcal{A} f \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$. Therefore $f f f=f \in f \mathcal{A} f \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right), a^{2} f a^{2}=0$ and $f a^{2}=a^{2}$. Hence, $a^{4}=a^{2} f a^{2}=\mathbf{0}$. By the previous paragraph $a^{3}=\mathbf{0}$.

If $n=2 k+1$, then $\left(a^{2}\right)^{n+1}=\left(a^{2}\right)^{2 k+2}=\left(a^{4}\right)^{k+1}=\mathbf{0}$ and $1 \leq k+1<n$. Again, by the inductive assumption $a^{6}=\mathbf{0}$. Hence, by the previous paragraph $a^{3}=\mathbf{0}$.

Thus, by the induction, we obtain that for $a \in \mathcal{S} \cup \mathcal{N}$, if $a^{n}=\mathbf{0}$ for some natural number $n \geq 4$, then $a^{3}=\mathbf{0}$. The proof is complete.

Theorem 2.10. Let $\mathcal{A}$ be a finite-dimensional almost inner Rickart algebra over the real or complex numbers satisfying Condition (B), with a nilpotent radical $\mathcal{N} \operatorname{il}(\mathcal{A})$. Then there exist pairwise orthogonal idempotents $e_{1}, e_{2}, \ldots, e_{m}$ in $\mathcal{A}$ such that

\mathcal{A}=\left(e_{1} \mathbb{F} \oplus e_{2} \mathbb{F} \oplus \cdots \oplus e_{m} \mathbb{F}\right) \dot{+} \mathcal{N} i l(\mathcal{A}),
$$

where $\mathbb{F}=\mathbb{R}, \mathbb{C}, \mathbb{H}$.
Proof. By the Wedderburn-Malcev and Cartan-Frobenius-Molien theorems, every finite-dimensional associative algebra $\mathcal{A}$ over the real or complex numbers can be represented as $\mathcal{A}=\mathcal{S}+\mathcal{N}$, where $\mathcal{N}$ is a nil-radical and $\mathcal{S}$ is a semi-simple algebra. In its turn $\mathcal{S}$ can be represented as

\mathcal{S}=\mathcal{C}_{1} \oplus \mathcal{C}_{2} \oplus \ldots \mathcal{C}_{n}
$$

where $\mathcal{C}_{i}, i=1,2, \ldots n$, are simple algebras and $\mathcal{C}_{i} \cong M_{n_{i}}\left(\mathcal{N}_{i}\right)$, where $M_{n_{i}}\left(\mathcal{N}_{i}\right)$ is the algebra of $n_{i} \times n_{i}$ matrices with entries from a division algebra $\mathcal{N}_{i}$. Also, by Lemma 2.9 $\mathcal{N} \operatorname{il}(\mathcal{A})^{3}=\{\mathbf{0}\}$. Therefore, by the examples in item 2) of Remark 1.6 in [3], every finite-dimensional almost inner Rickart algebra $\mathcal{A}$ has the following form

where $\mathcal{N} i l(\mathcal{A})$ is the nilpotent radical of $\mathcal{A}$ and $\mathcal{S}$ is a semisimple subalgebra every simple subalgebra of which is isomorphic to only one of the following algebras: an abelian algebra, the algebra of $2 \times 2$-matrices over a division algebra, the algebra of $3 \times 3$-matrices over a division algebra.

By Lemma $2.8 \mathcal{S}$ is also an almost inner Rickart algebra. Moreover, every direct summand $\mathcal{C}_{i}$ is also an almost inner Rickart algebra. Indeed, let $e_{i}$ be a unit element and $x$ is an element of $\mathcal{C}_{i}$. Then, there exists an idempotent $e$ in $\mathcal{S}$ such that ${ }^{\perp_{q}}\{x\} \cap \mathcal{S}^{2}=e \mathcal{S} e \cap \mathcal{S}^{2}$. Hence, $\left({ }^{\perp_{q}}\{x\} \cap \mathcal{S}^{2}\right) \cap \mathcal{C}_{i}=e_{i} \mathcal{S e}_{i} \cap \mathcal{C}_{i}{ }^{2}=e_{i} \mathcal{C}_{i} e_{i} \cap \mathcal{C}_{i}^{2}$.

By the examples on page 35 of [2] and on page 8 of [3] the algebras $M_{2}(\mathbb{F})$, $M_{3}(\mathbb{F})$, where $\mathbb{F}=\mathbb{R}, \mathbb{C}, \mathbb{H}$, are not inner RJ-algebras. But for a simple associative algebra the definition of an almost inner Rickart algebra coincides with the definition of an inner RJ-algebra. So, the algebras $M_{2}(\mathbb{F}), M_{3}(\mathbb{F})$, where $\mathbb{F}=\mathbb{R}, \mathbb{C}, \mathbb{H}$, are not almost inner Rickart algebras. Therefore, there exist pairwise orthogonal idempotents $e_{1}, e_{2}, \ldots, e_{m}$ in $\mathcal{A}$ such that

\mathcal{S}=e_{1} \mathbb{F} \oplus e_{2} \mathbb{F} \oplus \cdots \oplus e_{m} \mathbb{F}
$$

The proof is complete.
Theorem 2.11. Let $\mathcal{A}$ be an indecomposible finite-dimensional almost inner Rickart algebra over the real or complex numbers $\mathbb{F}$ satisfying Condition (B) with a two-dimensional semisimple subalgebra $\mathcal{S}$ and an n-dimensional commutative nilpotent radical $\mathcal{N}$ such that $\mathcal{A}=\mathcal{S}+\mathcal{N}, \mathcal{N}^{2} \neq\{\mathbf{0}\}$. Then there exist two mutually orthogonal nonzero idempotents $p_{1}, p_{2} \in \mathcal{A}$ such that $\mathcal{A}=\left(\mathbb{F} p_{1} \oplus \mathbb{F} p_{2}\right) \dot{+} \mathcal{N}$ and for any basis $\left\{e_{1}, e_{2}, \ldots, e_{n}\right\}$ of $\mathcal{N}$ one of the following two cases is valid

Conversely, any associative algebra $\mathcal{A}$ over a field $\mathbb{F}$ of characteristic $\neq 2$ and $\neq 3$ with a two-dimensional semisimple subalgebra $\mathcal{S}=\mathbb{F} p_{1} \oplus \mathbb{F} p_{2}$, where $p_{1}, p_{2}$ are mutually orthogonal idempotents, and an n-dimensional commutative nilpotent radical $\mathcal{N}$ with a basis $\left\{e_{1}, e_{2}, \ldots, e_{n}\right\}$ such that $\mathcal{A}=\mathcal{S} \dot{+} \mathcal{N}$, is an almost inner Rickart algebra if conditions (1.1)-(1.5) or conditions (2.1)-(2.5) are valid.

Proof. By Theorem 2.10, there exist pairwise orthogonal idempotents $p_{1}, p_{2}$ in $\mathcal{A}$ such that

We take the annihilator ${ }^{\perp_{q}}\left\{p_{1}\right\}$. It is clear that $p_{2} \in^{\perp_{q}}\left\{p_{1}\right\}$. We prove that

Clearly, $p_{2} \mathcal{A} p_{2} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right) \subseteq{ }^{\perp_{q}}\left\{p_{1}\right\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$ and ${ }^{\perp_{q}}\left\{p_{1}\right\} \cap \mathcal{S}^{2} \subseteq p_{2} \mathcal{A} p_{2} \cap \mathcal{S}^{2}$. It is sufficient to prove ${ }^{\perp_{q}}\left\{p_{1}\right\} \cap \mathcal{N}^{2} \subseteq p_{2} \mathcal{A} p_{2} \cap \mathcal{N}^{2}$. We take $x^{2} \in^{\perp_{q}}\left\{p_{1}\right\} \cap \mathcal{N}^{2}$. Then $p_{1} x^{2} p_{1}=0$ and $p_{1} x^{2} p_{2}+p_{2} x^{2} p_{1}=0$ by (2.5). Hence, $x^{2}=p_{2} x^{2} p_{2}$ and $x^{2} \in p_{2} \mathcal{A} p_{2} \cap \mathcal{N}^{2}$. So, ${ }^{\perp_{q}}\left\{p_{1}\right\} \cap \mathcal{N}^{2} \subseteq p_{2} \mathcal{A} p_{2} \cap \mathcal{N}^{2}$. Therefore, ${ }^{\perp_{q}}\left\{p_{1}\right\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=$ $p_{2} \mathcal{A} p_{2} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$.

Similarly, we have

$$
{ }^{\perp_{q}}\left\{p_{2}\right\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=p_{1} \mathcal{A} p_{1} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)
$$

Now we take an element of the form $\lambda p_{1}+\mu p_{2}+a, \lambda \neq 0$ or $\mu \neq 0$, and $b \in \mathcal{N}$ such that $b^{2} \neq 0$. Since $\mathcal{N}$ is an ideal, by the properties of the Peirce decomposition, we have

$$
\begin{gathered}
\left(\lambda p_{1}+\mu p_{2}+a\right) b^{2}\left(\lambda p_{1}+\mu p_{2}+a\right) \\
=\left(\lambda p_{1}+\mu p_{2}\right) b^{2}\left(\lambda p_{1}+\mu p_{2}\right)+\left(\lambda p_{1}+\mu p_{2}\right) b^{2} a+a b^{2}\left(\lambda p_{1}+\mu p_{2}\right)+a b^{2} a \\
=\left(\lambda p_{1}+\mu p_{2}\right) b^{2}\left(\lambda p_{1}+\mu p_{2}\right) \neq \mathbf{0}
\end{gathered}
$$

since $b^{2} \in\left(p_{1}+p_{2}\right) \mathcal{A}\left(p_{1}+p_{2}\right)$. We also have

$$
\begin{gathered}
\left(\lambda p_{1}+\mu p_{2}+a\right)\left(\nu p_{1}+\rho p_{2}\right)^{2}\left(\lambda p_{1}+\mu p_{2}+a\right)= \\
\left(\lambda p_{1}+\mu p_{2}+a\right)\left(\nu^{2} p_{1}+\rho^{2} p_{2}\right)\left(\lambda p_{1}+\mu p_{2}+a\right) \\
=\lambda^{2} \nu^{2} p_{1}+\mu^{2} \rho^{2} p_{2}+c
\end{gathered}
$$

where $c \in \mathcal{N}$ since $\mathcal{N}$ is an ideal. Therefore

$$
\left(\lambda p_{1}+\mu p_{2}+a\right)\left(\nu p_{1}+\rho p_{2}\right)^{2}\left(\lambda p_{1}+\mu p_{2}+a\right) \neq \mathbf{0}
$$

if $\nu \neq 0$ or $\rho \neq 0$. Hence,

$$
\perp_{q}\left\{\lambda p_{1}+\mu p_{2}+a\right\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=\{\mathbf{0}\}=\mathbf{0} \mathcal{A} \mathbf{0} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right) .
$$

So, $\mathcal{A}$ is an almost inner Rickart algebra. This ends the proof.
Remark 2.12. Note that, in the case $e=p_{1}$ of the proof of Theorem 2.11, since $A$ is an almost inner Rickart algebra and $p_{2} \in{ }^{\perp_{q}}\left\{p_{1}\right\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=f \mathcal{A} f \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)$ for some idempotent $f \neq \mathbf{0}$ in $\mathcal{A}$ we have $f \in \mathcal{S}^{2}$ and $p_{1} f p_{1}=\mathbf{0}$. Hence, $p_{1} f=\mathbf{0}$ since $\mathcal{S}$ is commutative. So, $f=p_{2}$ and

$$
{ }^{\perp_{q}}\left\{p_{1}\right\} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right)=p_{2} \mathcal{A} p_{2} \cap\left(\mathcal{S}^{2} \cup \mathcal{N}^{2}\right) .
$$

The following proposition follows from the Jordan form of a $3 \times 3$ complex matrix.

Proposition 2.13. The associative algebra $M_{3}(\mathbb{C})$ does not have nilpotent elements $a \in M_{3}(\mathbb{C})$ such that $a^{3} \neq \mathbf{0}$.

Remark 2.14. If a finite-dimensional semisimple associative algebra is an almost inner Rickart algebra, then this algebra is an inner RJ-algebra with respect to the Jordan multiplication. By Proposition 2.13 and the example on page 8 of [3] the condition of Lemma 2.9 is not sufficient for an associative algebra $\mathcal{A}$ to be an almost inner Rickart algebra.

In the following tables associative algebras of dimension two and three are listed. It is indicated that, wether an associative algebras is an almost inner Rickart algebra or not for every associative algebra of the tables.

The fourth column of the tables indicates whether the appropriate associative algebra is an almost inner Rickart algebra or not, i.e., if yes, then sign " + " is put in the appropriate place of the column, if not, then sign "-" is put in this place. All notations of the tables 1 and 2 are taken from [6].
