# FROM TWO SIMPLE PROBLEMS TO THE CONNECTION OF SPECIAL POINTS

#### Abstract

Both the USA TST 2008 [1] and the ELMO Shortlist 2013 [2] suggested two issues that are connected to fixed points. These problems provide a strong linkage between the various attributes of specific points in a triangle. In this article, we will first investigate various theorems concerning the fixed points that have been presented, and then we will demonstrate how those points are connected to a few triangle centers.


## 1. Introduction

The fixed-point problems have been seen in a great number of international mathematical olympiad competitions [4]. The generalization of these problems in this area, as well as the features of these problems, leave behind a plethora of notable results [10]. In this work, we talk about some of those problems and show the relationship to a few of different kinds of unique triangle centers.

In USA Team Selection Test 2008 [1], there is a fixed-point problem as following:

Problem 1. Given triangle $A B C$, centroid $G$. Let $P$ be a variable point on segment $B C$. Let $Q, R$ be points on $A C, A B$ such that $P Q\|A B, P R\| A C$. Prove that $(A Q R)$ passes through a fixed point $X$ such that $(A B, A G)=$ $(A X, A C)$.

Proof. Let $\omega_{1}$ be the circle which passes $A, B$ and tangents to $A C$. Let $\omega_{2}$ be the circle which passes $A, C$ and tangents to $A B$. Let $X$ be intersection of $\omega_{1}$ and $\omega_{2}$, so $X$ is fixed. Since two triangle $A B X$ and $A X C$ are homothetic, hence $\frac{A X}{B X}=\frac{A C}{A B}$. On the other hand, $\frac{A C}{A B}=\frac{P R}{B R}=\frac{A Q}{B R}$ so $\frac{A X}{B X}=\frac{A Q}{B R}$, also $(B R, B X)=(A X, A X)$ hence two triangle $B R X$ and $A Q X$ are homothetic, therefore $(R B, R X)=(Q A, Q X)$, following that $A, Q, X, R$ are cyclic. Moreover, we have

$$
\frac{\sin (A B, A X)}{\sin (C A, C X)}=\frac{\sin (A B, A X)}{\sin (B A, B X)}=\frac{B X}{A X}=\frac{A B}{A C}
$$

so $A X$ is the symmedian line of triangle $A B C$, which means $(A B, A G)=$ $(A X, A C)$. The problem has been solved.

With this configuration, ELMO Shortlist 2013 [2] provide the following problem using the antiparallel lines instead of parallel ones:

Problem 2. Given triangle $A B C$ and a centroid $G$. Let $P$ be a variable point on segment $B C$. Let $Q, R$ respectively be points on $A C, A B$ such that $P Q, P R$ are antiparallel lines of $A B, A C$. Prove that $(A Q R)$ passes through a fixed point.

Proof. Let $\gamma_{1}$ be the circles passes $A, B$ and tangents to $B C$. Let $\gamma_{2}$ be the circle passes $A, C$ and tangents to $B C$. Let $Y$ be intersection of $\gamma_{1}$ and $\gamma_{2}$,
so $Y$ is fixed. Let $K$ be intersection of $B Q$ and $C R$. We hav

$$
(R K, R A)=(P C, P A)=(P B, P A)=(Q K, Q A)(\bmod \pi)
$$

Hence four points $A, R, K, Q$ are cyclic. Therefore:

$$
\begin{aligned}
(K B, K C)=(K R, K Q)=(A R, A Q) & =(A R, A Y)+(A Y, A Q) \\
& =(B Y, B C)+(C B, C Y) \\
& =(Y B, Y C)(\bmod \pi)
\end{aligned}
$$

So four points $B, K, Y, C$ are cyclic. We have

$$
(K R, K Y)=(K Y, K C)=(B Y, B C)=(A R, A Y)(\bmod \pi)
$$

Hence $Y$ is on $(A R K) \equiv(A Q R)$. Moreover, by using the power of point's properties, we have the radical axis of $\gamma_{1}$ and $\gamma_{2}$ passes their common tangents, following that $A Y$ passes $B C$ at its midpoint or $A Y$ is the median line of triangle $A B C$.

The subsequent sections will go into the various qualities associated with the aforementioned pair of fixed points, which are closely linked to several notable triangle centers.

## 2. Properties related to the first problem

Two above problems appeared in many contests [1, 2] and journals [4] in the world, but it seems like there are just few properties about. This article will put forward some results about two fixed points mentioned above. We denotes $A_{X}, A_{Y}$ be that two points in the previous problems.

Theorem 2.1. $A_{X}$ is projection point of the circumcenter of triangle $A B C$ on the $A$-symmedian line of that triangle.

Proof. Let $A_{S}$ be the second intersection of $A A_{X}$ and $(A B C)$. From Problem 1, we have two triangle $A B A_{X}$ and $A A_{X} C$ are homothetic hence $A_{X} A^{2}=A_{X} B \cdot A_{X} C$. Moreover, we have

$$
\begin{aligned}
\left(A_{X} B, A_{X} A_{S}\right)=\left(A_{X} B, A A_{X}\right) & =\left(A A_{X}, A_{X} C\right)=\left(A_{X} A_{S}, A_{X} C\right) \\
\left(A_{S} B, A_{S} A_{X}\right)=(C B, C A) & =\left(C B, C A_{X}\right)+\left(C A_{X}, C A\right) \\
& =\left(C B, C A_{X}\right)+\left(A A_{S}, A B\right) \\
& =\left(C B, C A_{X}\right)+\left(C A_{S}, C B\right) \\
& =\left(C A_{S}, C A_{X}\right)
\end{aligned}
$$

So two triangle $A_{X} B A_{S}$ and $A_{X} A_{S} C$ are homothetic. Therefore $A_{X} A_{S}^{2}=$ $A_{X} B \cdot A_{X} C$. Hence $A_{X} A=A_{X} A_{S}$ or $A_{X}$ is midpoint of $A A_{S}$, following that $A_{X}$ is projection point of the circumcenter of triangle $A B C$ on the $A$-symmedian line of that triangle.

Theorem 2.2. Brocard circle [14] is the circle which passes two Brocard points $Z_{1}, Z_{2}[12,13]$, Lemoine point $L[16]$ and circumcenter $O$ of triangle $A B C$. Let $A_{X}$ be the fixed point mentioned in Problem 1. The construction of $B_{X}$ and $C_{X}$ is performed in a similar manner, but with the utilization of vertices $B$ and $C$. Then $A_{X}, B_{X}$ and $C_{X}$ lie on Brocard circle [14] of triangle $A B C$.

Remark 2.1. $A_{X} B_{X} C_{X}$ is the second Brocard triangle of triangle $A B C$.
Lemma 2.1. (Mannheim's theorem) Given triangle $A B C$ and three points $L, M, N$ respectively be on $B C, C A, A B$. Let $A^{\prime}, B^{\prime}, C^{\prime}$ respectively be three points that lie on $(A M N),(B N L),(C L M)$ such that $A A^{\prime}$, $B B^{\prime}, C C^{\prime}$ are concurrent at $K$. Prove that four points $A^{\prime}, B^{\prime}, C^{\prime}, K$ are cyclic.

Proof. Let $P$ be Miquel point of triangle $L M N$ with respect to triangle $A B C$. Let $Q$ be intersection of $P B^{\prime}$ and $(A M N)$. Applying Reim's theorem to $(A M N)$ and $(B N L)$ we have $A Q \| B B^{\prime}$. Through angle chasing:

$$
\left(K A, K B^{\prime}\right)=\left(A A^{\prime}, A Q\right)=\left(P A^{\prime}, P B^{\prime}\right)(\bmod \pi)
$$

Therefore $A^{\prime}, P, B^{\prime}, K$ are cyclic. Similarly, $B^{\prime}, P, C^{\prime}, K$ are cyclic. Hence four points $A^{\prime}, B^{\prime}, C^{\prime}, K$ are cyclic.

Lemma 2.2. Given triangle $A B C$ inscribed in $(O)$ and a point $P$ is not this triangle's vertex. Lines $A P, B P, C P$ respectively cut $(A B C)$ at $S, T$, $U$. Let $X, Y, Z$ be midpoints of segments $A S, B T, C U$, respectively. Prove that $X, Y, Z$ lie on $(O P)$ (a circle with center $O$ and radius $O P$ ).

Proof. We have $X, Y, Z$ respectively be projection of $O$ on $A S, B T, C U$. Through angle chasing:

$$
(X P, X O)=(Y P, Y O)=(Z P, Z O)=\frac{\pi}{2}
$$

Therefore $X, Y, Z$ lie on $(O P)$. The lemma has been proved.
Back to Theorem 2.2,

Proof. Applying Lemma 2.1, to triangle $A B C$ with $A A_{X}, B B_{X}, C C_{X}$ are concurrent at $L$ and $Z_{1}$ is intersection of $\left(A B B_{X}\right),\left(B C C_{X}\right),\left(C A A_{X}\right)$ we have $L, Z_{1}$ lie on $\left(A_{X} B_{X} C_{X}\right)$. Similarly, $Z_{2}$ lies on $\left(A_{X} B_{X} C_{X}\right)$. From Lemma 2.2, we have $A_{X}, B_{X}, C_{X}$ lie on $O L$. The theorem has been proved.

Theorem 2.3. Ray $A A_{Y}$ cuts $(A B C)$ at $A_{M}$. Prove that $B A_{Y} C A_{M}$ is parallelogram.

Proof. Using the properties of $A_{Y}$ at Problem 2, we have

$$
\left(B A_{Y}, B C\right)=\left(A B, A A_{M}\right)=\left(C B, C A_{M}\right) .
$$

Therefore $A_{Y} B \| A_{M} C$. Similarly, $A_{Y} C \| A_{M} C$ so $B A_{Y} C A_{M}$ is a parallelogram. The problem has been solved.
Corollary 2.1. $A_{Y}$ is symmetric with $A_{S}$ through BC.
Theorem 2.4. $A_{X}$ is the isogonal conjugate of $A_{Y}$ with respect to triangle $A B C$.

Proof. Because $A A_{X}$ and $A A_{Y}$ respectively be symmedian line and median line at vertex $A$ are two isogonal conjugate lines so we have to prove that $B A_{X}$ and $B A_{Y}$ are two isogonal conjugate ones. Through angle chasing,

$$
\left(B A_{X}, B A\right)=\left(A A_{X}, A C\right)=\left(A B, A A_{Y}\right)=\left(B C, B A_{Y}\right),
$$

we have $B A_{X}$ and $B A_{Y}$ are isogonal conjugate, therefore $A_{X}$ is the isogonal conjugate of $A_{Y}$ with respect to triangle $A B C$.

Theorem 2.5. Given triangle $A B C$, centroid $G$. Let $M_{A B}, M_{B C}, M_{C A}$ respectively be midpoints of $B C, C A, A B$. Let $A_{G}$ be midpoint of $A A_{Y}$. Prove that $A_{G}$ lies on $\left(M_{A B} M_{B C} M_{C A}\right)$.

Proof. Because $M_{A B} A_{G}$ is the midline of triangle $A B A_{Y}$ so we have:

$$
\left(M_{A B} A, M_{A B} A_{G}\right)=\left(B A, B A_{Y}\right)
$$

Draw altitude $C H_{C}$ of triangle $A B C$. Through angle chasing,

$$
\begin{aligned}
\left(M_{B C} H_{C}, M_{B C} A\right) & =\left(M_{B C} H_{C}, B A\right)+(B A, C B) \\
& +(C B, C A)+\left(C A, M_{B C} A\right) \\
& =2(B A, C B)+(C B, C A)+\left(C A, M_{B C} A\right) \\
& =(B A, C B)+\left(A B, A M_{B C}\right) \\
& =\left(B A, B A_{Y}\right)+\left(B A_{Y}, C B\right)+\left(C B, C A_{M}\right) \\
& =\left(B A, B A_{Y}\right) \\
& =\left(M_{A B} A, M_{A B} A_{G}\right) .
\end{aligned}
$$

Hence $A_{G}$ lies on $\left(M_{A B} H_{C} M_{B C}\right) \equiv\left(M_{A B} M_{B C} M_{C A}\right)$. We have done.
Theorem 2.6. Draw parallelogram $M_{A B} A_{G} M_{C A} A_{G Y}$. Then $A_{G Y}$ is midpoint of $A A_{M}$.

Proof. Let $A_{N}$ be midpoint of $M_{A B} M_{C A}$. Because $M_{A B} A_{G} M_{C A} A_{G Y}$ and $A M_{A B} M_{B C} M_{C A}$ are parallelogram, we can easily see that $A_{N}$ is midpoint of both $A_{G} A_{G Y}$ and $A M_{B C}$. We have

$$
\begin{aligned}
\overline{A A_{G Y}} & =\overline{{A A_{N}}+\overline{A_{N} A_{G Y}}=\overline{A_{N} M_{B C}}+\overline{A_{G} A_{N}}} \\
& =\overline{A_{G} M_{B C}}=\overline{A_{G} A_{Y}}+\overline{A_{Y} M_{B C}} \\
& =\frac{1}{2}\left(\overline{A A_{Y}}+\overline{A_{Y} A_{M}}\right)=\frac{1}{2} \overline{A_{M}} .
\end{aligned}
$$

Therefore $A_{G Y}$ is midpoint of $A A_{M}$.
Corollary 2.2. $A_{X} A_{G Y} \| B C$.
Corollary 2.3. $A_{X}$ is symmetric with $A_{G}$ through $M_{A B} M_{C A}$.
Theorem 2.7. $A_{Y}$ is the Anticomplement point of $A_{G Y}$ with respect to triangle $A B C$.

Proof. From these above properties, we have:

$$
\begin{aligned}
\overline{G A_{G Y}} & =\overline{G M_{B C}}-\overline{A_{G Y} M_{B C}}=2 \overline{A_{N} G}-\overline{A_{G} A_{Y}} \\
& =\overline{2 A_{N} G}-\overline{A_{G} A_{N}}-\overline{A_{N} A_{Y}}=\overline{A_{N} A_{Y}}+2 \overline{A_{Y} G}-\overline{A_{N} A_{G Y}} \\
& =\overline{A_{G Y} A_{Y}}+2 \overline{A_{Y} G}=\overline{A_{G Y} G}+\overline{A_{Y} G} .
\end{aligned}
$$

Hence $\overline{A_{Y} G}=2 \overline{G A_{G Y}}$ therefore $A_{Y}$ is the Anticomplement point of $A_{G Y}$ with respect to triangle $A B C$.

Theorem 2.8. The first Brocard triangle is a triangle which has three vertices respectively be intersection points of lines $A Z_{1}, B Z_{1}, C Z_{1}, A Z_{2}, B Z_{2}$, $C Z_{2}$. Let $Z_{A}, Z_{B}, Z_{C}$ be three vertices of this triangle. Prove that $Z_{A} Z_{B} Z_{C}$ is inscribed in $\left(A_{X} B_{X} C_{X}\right)$.

Proof. Let $\left(A Z_{1}, A B\right)=\left(A C, A Z_{2}\right)=\alpha$. Through angle chasing,

$$
\begin{aligned}
\left(A_{X} Z_{1}, A_{X} Z_{2}\right) & =\left(A_{X} Z_{1}, A_{X} C\right)+\left(A_{X} C, A_{X} A\right)+\left(A_{X} A, A_{X} Z_{2}\right) \\
& =\left(A Z_{1}, A C\right)+\left(A_{X} A, A_{X} B\right)+\left(A_{X} A, Z_{2} A\right)+\left(Z_{2} A, A_{X} Z_{2}\right) \\
& =\left(A Z_{1}, A C\right)+\left(A_{X} A, A_{X} B\right)+\left(A_{X} A, Z_{2} A\right)+\left(B A, B A_{X}\right) \\
& =\left(A Z_{1}, A C\right)+\left(A_{X} A, A_{X} B\right)+\left(A_{X} A, Z_{2} A\right)+\left(A C, A A_{X}\right) \\
& =\left(A Z_{1}, A B\right)+\left(A B, A A_{X}\right)+\left(A_{X} A, A_{X} B\right)+\left(A_{X} A, Z_{2} A\right) \\
& =\left(A Z_{1}, A B\right)+\left(B A, A_{X} B\right)+\left(A_{X} A, Z_{2} A\right) \\
& =\left(A Z_{1}, A B\right)+\left(A C, A A_{X}\right)+\left(A A_{X}, A Z_{2}\right) \\
& =\left(A Z_{1}, A B\right)+\left(A C, A Z_{2}\right) \\
& =2 \alpha(\bmod \pi) .
\end{aligned}
$$

On the other hand, we have

$$
\left(Z_{A} Z_{1}, Z_{A} Z_{2}\right)=\left(Z_{A} Z_{1}, C B\right)+\left(C B, Z_{A} Z_{2}\right)=\alpha+\alpha=2 \alpha .
$$

Therefore $Z_{A}$ lies on $\left(Z_{1} A_{X} Z_{2}\right) \equiv\left(A_{X} B_{X} C_{X}\right)$. Similarly, $Z_{B}, Z_{C}$ lie on $\left(A_{X} B_{X} C_{X}\right)$. WE have done.

Corollary 2.4. $Z_{1}$ is symmetric with $Z_{2}$ through $O L$ and $\left(O Z_{1}, O Z_{2}\right)=2 \alpha$.
Theorem 2.9. $O A_{X}, C Z_{2}$ cut $\omega_{1}$ at $O_{W}, C_{W}$. Then $O_{W} C_{W} \| O Z_{A}$.
Lemma 2.3. Let $B Z_{1}$ cut $\omega_{2}$ at $B_{W}$. Prove that $B_{W} C_{W} \| B C$.
Proof. We have $\left(B B_{W}, B C\right)=\left(C A, C Z_{1}\right)=\left(B_{W} A, B_{W} Z_{1}\right)$ so $A B_{W} \|$ $B C$. Similarly, $A C_{W} \| B C$ so $B_{W} C_{W} \| B C$. We have done.

Back to Theorem 2.9,

Proof. By Lemma 2.3 and $\left(B C, B Z_{A}\right)=\left(C Z_{A}, C B\right)$, we have $B C B_{W} C_{W}$ is an isosceles trapezoid or $O Z_{A}$ is perpendicular to $B_{W} C_{W}$. On the other

hand, by Theorem 2.2, we have $\left(A_{X} A, A_{X} O_{W}\right)=\left(C_{W} A, C_{W} O_{W}\right)=\frac{\pi}{2}$. Therefore $O_{W} C_{W}$ is perpendicular to $B_{W} C_{W}$. So $O_{W} C_{W} \| O Z_{A}$.

Theorem 2.10. $A_{X} Z_{A}, B_{X} Z_{B}, C_{X} Z_{C}$ are concurrent at $G$.
Lemma 2.4. Given triangle $A B C$. On the plane containing this triangle, choose $A^{\prime}, B^{\prime}, C^{\prime}$ such that the triangles $A^{\prime} C B, B^{\prime} A C, C^{\prime} B A$ are homothetic. We construct the parallelogram $B A^{\prime} C D$. Prove that $A^{\prime} C D B$ is also a parallelogram.

Proof. We have

$$
\frac{C^{\prime} B}{C^{\prime} D}=\frac{C^{\prime} B}{A B^{\prime}}=\frac{C^{\prime} A}{B^{\prime} C}=\frac{B^{\prime} D}{B^{\prime} C}
$$

and

$$
\begin{aligned}
\left(C^{\prime} B, C^{\prime} D\right) & =\left(C^{\prime} B, C^{\prime} A\right)+\left(C^{\prime} A, C^{\prime} D\right) \\
& =\left(B^{\prime} A, B^{\prime} C\right)+\left(B^{\prime} D, B^{\prime} A\right)=\left(B^{\prime} D, B^{\prime} C\right)
\end{aligned}
$$

Therefore triangle $C^{\prime} B D$ and triangle $B^{\prime} D C$ are homothetic. Hence

$$
\frac{B D}{C D}=\frac{C^{\prime} B}{B^{\prime} D}=\frac{C^{\prime} B}{C^{\prime} A}=\frac{A^{\prime} B}{A^{\prime} C}
$$

On the other hand,

$$
\begin{aligned}
(D B, D C) & =\left(D B, D C^{\prime}\right)+\left(D C^{\prime}, D B^{\prime}\right)+\left(D B^{\prime}, D C\right) \\
& =\left(D C, B^{\prime} C\right)+\left(B^{\prime} A, D B^{\prime}\right)+\left(D B^{\prime}, D C\right) \\
& =\left(B^{\prime} A, B^{\prime} C\right) \\
& =\left(A^{\prime} C, A B\right) .
\end{aligned}
$$

So triangle $D B C$ and triangle $A^{\prime} C B$ are homothetic. Therefore, $B D \| A^{\prime} C$ and $C D \| A^{\prime} B$. We conclude that $A^{\prime} C D B$ is a parallelogram.

Lemma 2.5. $G$ is the centroid of triangle $Z_{A} Z_{B} Z_{C}$.

Proof. Let $Z_{A}^{\prime}$ be symmetric point with $Z_{A}$ through $B C$. Since triangle $B Z_{A} C$ is a isosceles triangle at $Z_{A}, B Z_{A} C Z_{A}^{\prime}$ is a parallelogram. Applying Lemma 2.4 for triangle $A B C$, we have $A Z_{C} Z_{A}^{\prime} Z_{B}$ is a parallelogram so $A Z_{A}^{\prime}$ passes midpoint $N_{B C}$ of $Z_{B} Z_{C}$. In triangle $A Z_{A} Z_{A}^{\prime}$, the two median lines $A M_{B C}$ and $Z_{A} N_{B C}$ intersect with each other at this triangle's centroid so that this point is also the centroid $G$ of triangle $A B C$ and triangle $Z_{A} Z_{B} Z_{C}$.

Lemma 2.6. Given triangle $A B C$ and two disjoint arbitrary points $P, Q$. Let $X, Y, Z$ respectively be projection of $P$ on the lines which passes $Q$ and is perpendicular to $B C, C A, A B$. Let $X^{\prime}, Y^{\prime}, Z^{\prime}$ respectively be projection of $Q$ on $A P, B P, C P$. Prove that $X X^{\prime}, Y Y^{\prime}$ and $Z Z^{\prime}$ are concurrent.

Proof. Noted that $X, Y, Z, X^{\prime}, Y^{\prime}, Z^{\prime}$ lie on a circle with diameter $P Q$ and $A B\|P Z, A C\| P Y$ so we have

$$
(A B, A C)=(Z P, P Y)=(X Y, X Z)
$$

Similarly, $(B C, B A)=(Y Z, Y X)$ and $(C A, C B)=(Z X, Z Y)$ so two triangles $X Y Z$ and $A B C$ are homothetic. Let $P^{\prime}$ be the image of $P$ through the homothety transformation which turns triangle $A B C$ into triangle $X Y Z$. Let $P^{*}$ be the isogonal conjugate point of $P$ in triangle $X Y Z$. We have

$$
\left(X X^{\prime}, X Z\right)=\left(P X^{\prime}, P Z\right)=(A P, A B)=\left(X P^{*}, X Z\right)
$$

Therefore $X X^{\prime}$ passes $P^{*}$. Similarly, $Y Y^{\prime}$ and $Z Z^{\prime}$ passes $P^{*}$, which solves the lemma.

Back to Theorem 2.10,
Proof. By applying Lemmas 2.5 and 2.6 for triangle $Z_{A} Z_{B} Z_{C}$, we solves the problem.

By Corollary 2.3, the Brocard circle is definitely the Hagge circle [5] of $G$ in triangle $M_{B C} M_{C A} M_{A B}$. We will discuss some properties related to this issue and use these ones to prove Theorem 2.10.

Lemma 2.7 (Hagge circle). Given triangle $A B C$, orthocenter $H$ and $a$ point $P$ lies inside $(A B C)$. Rays $A P, B P, C P$ cuts $(A B C)$ at the second points $A_{1}, B_{1}, C_{1}$. Let $A_{2}, B_{2}, C_{2}$ respectively be the symmetry points of $A_{1}, B_{1}, C_{1}$ through $A, B, C$. Prove that $A_{2}, B_{2}, C_{2}$ and $H$ are cyclic.
Remark 2.2. The circle mentioned above called Hagge circle $\mathcal{H}_{P}$ of point $P$ with respect to triangle $A B C$.

Proof. Let $P^{\prime}$ be the isogonal conjugate of $P$ in triangle $A B C$. $A P^{\prime}, B P^{\prime}$, $C P^{\prime}$ cut $(A B C)$ respectively at $A_{1}^{\prime}, B_{1}^{\prime}, C_{1}^{\prime}$. Let $B_{2}^{\prime}, C_{2}^{\prime}$ respectively be symmetry points of $B_{2}, C_{2}$ through midpoint of $B C$. Set $O$ is the center of $(A B C)$ with diameter $A A^{\prime}$. It is easy to see that $A_{2}, B_{2}, C_{2}$ are symmetry points of $A_{1}^{\prime}, B_{2}^{\prime}, C_{2}^{\prime}$ through midpoint of $B C$. We have $C B_{2} A B_{1}^{\prime}$ and $C B_{2} B B_{2}^{\prime}$ are parallelograms so the quadrilateral $A B B_{2}^{\prime} B_{1}^{\prime}$ is also a parallelogram. We conclude that midpoint $M_{1}$ of $A B_{2}^{\prime}$ is the projection of $O$ on $B P^{\prime}$. Similarly, midpoint $M_{2}$ of $A C_{2}^{\prime}$ is the projection of $O$ on $C P^{\prime}$. Let $M_{3}$ be midpoint of $A A_{1}^{\prime}$. Then triangle $M_{1} M_{2} M_{3}$ is inscribed in a circle with diameter $O P^{\prime}$. We use two geometric transformations respectively with the first one (1) is the homothety transformation $\mathbf{H}_{A}^{2}$ with center $A$ and ratio 2 ; and the later (2) is the symmetric one $\mathbf{S}_{M_{B C}}$ through midpoint $M_{B C}$ of $B C$, to points $M_{3}, M_{1}, M_{2}, O$ such that

$$
\mathbf{S}_{M_{B C}} \circ \mathbf{H}_{A}^{2}: M_{3}, M_{1}, M_{2}, O \mapsto A_{2}, B_{2}, C_{2}, H
$$

Since $M_{1}, M_{2}, M_{3}, O$ lie on a same circle so $A_{2}, B_{2}, C_{2}, H$ are also cyclic.
Lemma 2.8. Given triangle $A B C$ and two points $S$ and $S^{\prime \prime}$ are isogonal conjugate. Let $X, X^{\prime}$ respectively be intersection of $A S, A S^{\prime}$ with ( $A B C$ ). Let $V$ be intersection of $A S^{\prime}$ and $B C$. Prove that

$$
\frac{\overline{A S}}{\overline{S X}}=\frac{\overline{S^{\prime} V}}{\overline{V X^{\prime}}} .
$$

Proof. We have

$$
\begin{gathered}
\left(C V, C X^{\prime}\right)=\left(A B, A X^{\prime}\right)=(A X, A C), \\
\left(X^{\prime} V, X^{\prime} C\right)=(X A, X C)
\end{gathered}
$$

So two triangles $V C X^{\prime}$ and $C A X$ are homothetic. On the other hand,

$$
\begin{aligned}
\left(S^{\prime} X^{\prime}, S^{\prime} C\right) & =\left(A S^{\prime}, A C\right)+\left(C A, C S^{\prime}\right) \\
& =(A B, A S)+(C S, C B) \\
& =(C B, C X)+(C S, C B) \\
& =(C S, C X), \\
\left(X^{\prime} S^{\prime},\right. & \left.X^{\prime} C\right)=(X S, X C) .
\end{aligned}
$$

Therefore two triangles $C X^{\prime} S^{\prime}$ and $S X C$ are homothetic. So,

$$
\overline{X^{\prime} V} \cdot \overline{X A}=\overline{X^{\prime} C} \cdot \overline{X C}=\overline{X^{\prime} S^{\prime}} \cdot \overline{X S} .
$$

Hence, $\frac{\overline{X A}}{\overline{X S}}=\frac{\overline{X^{\prime} S^{\prime}}}{\frac{X^{\prime} V}{}}$ or $\frac{\overline{A S}}{S X}=\frac{\overline{S^{\prime} V}}{V X^{\prime}}$.
Lemma 2.9. Let $A_{3}, B_{3}, C_{3}$ respectively be intersection of $\mathcal{H}_{P}$ and $A H$, $B H, C H$. Prove that $A_{2} A_{3}, B_{2} B_{3}, C_{2} C_{3}$ are concurrent at $P$.

Proof. We construct diameter $H H^{\prime}$ of $\mathcal{H}_{P}$. From Lemma 2.7, we have

$$
\mathbf{S}_{M_{B C}} \circ \mathbf{H}_{A}^{2}: O, P^{\prime} \mapsto H, H^{\prime}
$$

Therefore $O P^{\prime} \| H H^{\prime}$ and $\overline{H^{\prime} H}=2 \overline{O P^{\prime}}$ so $H^{\prime}$ is the Anticomplement point of $P^{\prime}$ in triangle $A B C$. On the other hand, $A_{3} H^{\prime} \| B C$ and $B C \perp A H$ hence $A A^{\prime}=2 \mathrm{~d}\left(P^{\prime}, B C\right)$. Using Lemma 2.8, we have

$$
\frac{\overline{A P}}{\overline{P A_{1}}}=\frac{\mathrm{d}\left(P^{\prime}, B C\right)}{\mathrm{d}\left(A_{1}^{\prime}, B C\right)}=\frac{\mathrm{d}\left(P^{\prime}, B C\right)}{\mathrm{d}\left(A_{1}, B C\right)}=\frac{\overline{A A_{3}}}{\overline{A_{2} A_{1}}} .
$$

This means $A_{2} A_{3}$ passes $P$. Similarly, $B_{2} B_{3}, C_{2} C_{3}$ passes $P$. We have solved the lemma.

Back to Theorem 2.10,

Proof. By Corollary 2.3, the Brocard cirlce is the Hagge circle of $G$ with respect to triangle $M_{B C} M_{C A} M_{A B}$. By applying Lemma 2.7 and 2.9 for triangle $M_{B C} M_{C A} M_{A B}$, we have the result.

## 3. Properties Related to the second problem

Theorem 3.1. $A_{Y}$ is the projection of orthocenter $H$ on the $A$-median line of triangle $A B C$.

Proof. Let $A A_{O}$ be diameter of $(A B C)$. Since $B H C A_{O}$ is a parallelogram, $M_{B C}$ is the midpoint of $A_{O} H$. On the other hand, $M_{B C}$ is also the mid point of $A_{Y} A_{M}$. By Theorem 2.3, $H A_{Y} A_{O} A_{M}$ is a parallelogram therefore $A_{Y} H \| A_{O} A_{M}$. Moreover, $A_{O} A_{M} \perp A A_{M}$ hence $A_{Y}$ is the projection of $H$ on the $A$-median line.

Corollary 3.1. Let $B_{Y}$ and $C_{Y}$ be constructed in a similar manner as $A_{Y}$, but with respect to $B$ and $C$ respectively. Let $H_{A} H_{B} H_{C}$ be the Orthocentroidal triangle with $H_{A}, H_{B}, H_{C}$ repsectively be projection of $G$ on $A H$, $B H, C H$. Then two triangles $A_{Y} B_{Y} C_{Y}$ and $H_{A} H_{B} H_{C}$ are inscribed in the circle with diameter $G H$ which called Orthocentroidal circle.

Corollary 3.2. The Hagge circle of the Lemoine point $L$ in triangle $A B C$ is the Orthocentroidal circle of this triangle.

Theorem 3.2. The radical line of $\left(A_{X} B_{X} C_{X}\right)$ and $\left(A_{Y} B_{Y} C_{Y}\right)$ passes midpoint $X$ (39) of two Brocard points.

We can see the proof of this property here [9] using Barycentric coordinate.
Theorem 3.3. $A_{Y} H_{A}, B_{Y} H_{B}, C_{Y} H_{C}$ are concurrent at $L$.

Lemma 3.1. $L$ is also the Lemoine point of triangle $H_{A} H_{B} H_{C}$.
Proof. By Corollary 3.2, the Orthocentroidal circle of triangle $A B C$ is the Hagge circle of $L$ with respect to this triangle. Moreover, by Corollary 2.1, triangle $A_{Y} B_{Y} C_{Y}$ is the Hagge triangle of $L$, which means $A_{Y}, B_{Y}, C_{Y}$ are constructed in the same way of $A_{2}, B_{2}, C_{2}$ in Lemma 2.7, but with respect to $L$. We then apply Lemma 2.9 to completely solve this result.

Back to Theorem 3.3,
Proof. By applying Lemma 2.7, 2.9 and 3.1 for triangle $A B C$ with Lemoine point $L$ and the Orthocentroidal circle, we can prove the theorem.

Theorem 3.4. The perpendicular bisector of $A X A_{G Y}$ cuts $A L$ at $L_{N}$. Then $A X A_{Y} \| L_{N} M_{B C}$.

Proof. By Corollary 2.2, $L_{N}$ also lies on the perpendicular bisector of $M_{A B} M_{C A}$ containing $A_{N}$ so $A_{N} L_{N} \| A_{Y} A_{S}$. Therefore

$$
\overline{A L_{N}} \cdot \overline{A A_{Y}}=\overline{A A_{N}} \cdot \overline{A A_{S}}=\overline{A M_{B C}} \cdot \overline{A A_{X}}
$$

so $\frac{\overline{A A_{X}}}{\frac{A L_{N}}{}}=\frac{\overline{A A_{Y}}}{\overline{A M_{B C}}}$. Hence, $A_{X} A_{Y} \| L_{N} M_{B C}$.
Theorem 3.5. $\left(A_{X} A_{G Y} L_{N}\right)$ is tangent to (BOC).

Proof. By Theorem 2.1, $A_{X}$ lies on (BOC). Let $A d$ be a ray which belongs to tangent line at $A$ of $\left(A_{X} A_{G Y} L_{N}\right)$ such that $A d$ and $B$ are on the same side of the plane separated by $A L$. By Theorem 2.1, $A_{X} A_{S}$ is the $A_{X}$-bisector of triangle $A_{X} B C$. We have

$$
\begin{aligned}
\left(A_{X} d, A_{X} B\right) & =\left(A_{X} d, A_{X} A_{S}\right)+\left(A_{X} A_{S}, A_{X} B\right) \\
& =\left(A_{X} A_{S}, A_{X} A_{G Y}\right)+\left(A_{X} C, A_{X} A_{S}\right) \\
& =\left(A_{X} C, A_{X} A_{G Y}\right) \\
& =\left(C B, C A_{X}\right) .
\end{aligned}
$$

So $A d$ is the tangent line of $\left(A_{X} B C\right) \equiv(B O C)$. We have done.
Theorem 3.6. Let $A_{L X}$ be projection of $H$ on $A L$. Then $M_{B C} A_{Y}=$ $M_{B C} A_{L X}$.

Proof. Draw altitudes $B H_{C A}$ and $C H_{A B}$ of triangle $A B C$. It can be seen that $A, H, H_{C A}, H_{A B}, A_{Y}, A_{L X}$ lie on the circle with diameter $A H$. Since $M_{B C}$ is the intersection of two tangent lines at $H_{C A}$ and $H_{A B}$ of $(A H)$ so $A H_{A B} A_{Y} H_{B C}$ is a harmonic quadrilateral. Since $A L$ is a median line of triangle $A H_{C A} H_{A B}$ hence $H_{C A} H_{A B} \| A_{Y} A_{L X}$. Moreover, as $M$ lies on the perpendicular bisector of $H_{C A} H_{A B}$, which is also the perpendicular bisector of $A_{Y} A_{L X}$, so that $M_{B C} A_{Y}=M_{B C} A_{L X}$.

Corollary 3.3. $\left(A_{Y} M_{B C} A_{L X}\right)$ is tangent to the Euler circle of triangle $A B C$.

Theorem 3.7. Let $L_{B C}$ be intersection of $A L$ and $B C$. Then $A_{Y} L_{B C}$ is a symmedian line of triangle $A_{Y} B C$.

Proof. Since $A L_{B C}$ is a symmedian line of triangle $A B C$ so

$$
\frac{\overline{L_{B C} B}}{\overline{L_{B C} C}}=-\left(\frac{A B}{A C}\right)^{2} .
$$

On the other hand,

$$
\left(\frac{A B}{A C}\right)^{2}=\left(\frac{A B}{M_{B C} B} \cdot \frac{M_{B C} C}{A C}\right)^{2}=\left(\frac{A_{M} C}{A_{M} M_{B C}} \cdot \frac{A_{M} M_{B C}}{A_{M} B}\right)^{2}=\left(\frac{A_{Y} B}{A_{Y} C}\right)^{2}
$$

So

$$
\frac{\overline{L_{B C} B}}{\overline{L_{B C} C}}=-\left(\frac{A_{Y} B}{A_{Y} C}\right)^{2} .
$$

We conclude that $A_{Y} L_{B C}$ is a symmedian line of triangle $A_{Y} B C$.
Theorem 3.8. $\left(A_{Y} M_{B C} A_{L X}\right)$ is tangent to (BHC).

Lemma 3.2. Given triangle $A B C$. On segment $B C$, we choose $D, E$ such that $A D, A E$ are isogonal conjugate of each other in this triangle. Prove that $(A B C)$ is tangent to $(A D E)$.

Proof. The tangent line at $A$ of $(A B C)$ cuts line $B C$ at $F$. Then

$$
(A F, A D)=(A F, A B)+(A B, A D)=(C A, C B)+(E A, C A)=(E A, C B)
$$

so $A F$ is tangent to $(A D E)$. Thus, $(A B C)$ is tangent to $(A D E)$.
Back to Theorem 3.8,


Figure 29. Proof of Theorem 3.8

Proof. Draw the altitude $A H_{B C}$ of triangle $A B C$. We have that $H_{B C}$ and $A_{L X}$ lie on the circle with diameter $H L_{B C}$. Therefore,

$$
\left(L_{B C} A_{L X}, L_{B C} M_{B C}\right)=\left(H A_{L X}, H H_{B C}\right)=\left(A_{Y} A_{L X}, A_{Y} A\right)
$$

So $A_{Y}, A_{L X}, L_{B C}, M_{B C}$ are cyclic. Using Theorem 3.7, $A_{Y} L_{B C}$ is a symmedian line of triangle $A_{Y} B C$. We use Lemma 3.2 to conclude that $\left(A_{Y} M_{B C} A_{L X}\right)$ touches (BHC).

Theorem 3.9. The rays $B A_{Y}, C A_{Y}$ cuts $(A B C)$ at $A_{B Y}, A_{C Y}$. Let $A_{B Y}^{\prime}, A_{C Y}^{\prime}$ be symmetry points of $A_{B Y}, A_{C Y}$ through $C A, A B$ respectively. Then $A_{B Y}^{\prime}$ and $A_{C Y}^{\prime}$ lie on $A L$.

Proof. We have

$$
\begin{aligned}
\left(A A_{B Y}^{\prime}, A C\right) & =\left(A C, A A_{B Y}\right)=\left(B C, B A_{B Y}\right) \\
& =\left(C B, C A_{M}\right)=\left(A B, A A_{M}\right) \\
& =(A L, A C)
\end{aligned}
$$

Thus $A L$ passes $A_{B Y}^{\prime}$. Similarly, $A L$ passes $A_{C Y}^{\prime}$.
Theorem 3.10. $A_{L X}$ is midpoint of $A_{B Y}^{\prime} A_{C Y}^{\prime}$.
Proof. Rays $B H$ and $C H$ cut $(A B C)$ respectively at $H_{B}$ and $H_{C}$. We have

$$
\left(H_{B} A_{C Y}, H_{B} B\right)=\left(C A_{C Y}, C B\right)=\left(H A_{Y}, H H_{B}\right)
$$

so $H_{B} A_{C Y} \| H A_{Y}$, where $H A_{Y} \perp A G$. Simiarly $H_{C} A_{B Y} \| H A_{Y}$, where $H A_{Y} \perp A G$ hence $H_{B} A_{C Y} H_{C} A_{B Y}$ is a isosceles trapezoid. We conclude that $H_{C} A_{C Y}=H_{B} A_{B Y}$. Using symmetry transformation through $A B$ and $A C$, we have $\mathbf{S}_{A B}: H, A_{C Y} \mapsto H_{C}, A_{C Y}^{\prime}$ and $\mathbf{S}_{A C}: H, A_{B Y} \mapsto H_{B}, A_{B Y}^{\prime}$. Therefore $H A_{B Y}^{\prime}=H_{B} A_{B Y}=H_{C} A_{C Y}=H A_{C Y}^{\prime}$, which means triangle $H A_{B Y}^{\prime} A_{C Y}^{\prime}$ is isosceles at $H$. Moreover, $A_{L X}$ is the projection of $H$ on $A_{B Y}^{\prime} A_{C Y}^{\prime}$ so $A_{L X}$ is midpoint of $A_{B Y}^{\prime} A_{C Y}^{\prime}$.

## 4. Conclusion

This article is a discussion on the properties associated with a pair of distinct triangle centers. Further investigations can be conducted in this domain to delve deeper into the subject matter and uncover additional distinctive characteristics pertaining to triangles.
