# An improvement and generalization of Rotfel'd type inequalities for sectorial matrices

#### Abstract

By using equivalence conditions for sectorial matrices obtained by Alakhrass and Sababheh in 2020, we improve a Rotfel'd type inequality for sectorial matrices derived by P. Zhang in 2015 and generalize a result derived by Y. Mao et al. in 2024.


Keywords: Polar decomposition, Rotfel'd theorem, sectorial matrix.

## 1. Introduction

Let $\mathbb{M}_{n}$ be the set of all $n \times n$ complex matrices. The set of $n \times n$ positive semidefinite matrices is denoted by $\mathbb{M}_{n}^{+}$. A norm $\|\cdot\|$ on $\mathbb{M}_{n}$ is unitarily invariant if $\|U A V\|=\|A\|$ for any $A \in \mathbb{M}_{n}$ and unitary matrices $U, V \in \mathbb{M}_{n}$. For $A \in \mathbb{M}_{n}$, we denote by $A^{*}$ and $|A|=\left(A^{*} A\right)^{\frac{1}{2}}$ the conjugate transpose and the modulus of $A$, respectively. We denote the $j$-th largest singular value of $A$ by $\sigma_{j}(A)$. If $A$ is Hermitian, then its eigenvalues of $A$ are real and its $j$-th largest eigenvalue is written as $\lambda_{j}(A)$. Note that $\sigma_{j}(A)=\lambda_{j}(|A|), j=1, \cdots, n$. For two Hermitian matrices $A, B \in \mathbb{M}_{n}$, we write $A \leq B$ to mean $B-A \in \mathbb{M}_{n}^{+}$.

For $A \in \mathbb{M}_{n}$, we can write

$$
A=\Re A+i \Im A
$$

$$
\Re A=\frac{1}{2}\left(A+A^{*}\right), \quad \Im A=\frac{1}{2 i}\left(A-A^{*}\right) .
$$

This is called the Cartesian decomposition of $A$.
The numerical range of $A \in \mathbb{M}_{n}$ is defined by

$$
W(A)=\left\{x^{*} A x \mid x \in \mathbb{C}^{n}, x^{*} x=1\right\} .
$$

Sectorial matrices were defined in [3] as an extension of the definition of the positive matrices. For $\alpha \in[0, \pi / 2)$, we define a sector on the complex plane

$$
S_{\alpha}=\left\{z \in \mathbb{C}^{n}|\Re z \geq 0,|\Im z| \leq(\Re z) \tan \alpha\}\right.
$$

A matrix $A \in \mathbb{M}_{n}$ whose numerical range is a subset of a sector $S_{\alpha}$, for some $\alpha \in[0, \pi / 2)$, is called a sectorial matrix. Relevant studies of sectorial matrices can be found in Drury and Lin [5], Zhang [12] and references therein. Note that if $\alpha=0$, then a sectorial matrix $A$ is a positive matrix. It is obvious, from the definition of sectorial matrices that if $W(A) \subseteq S_{\alpha}$ for some $\alpha$, then $\Re A \in \mathbb{M}_{n}^{+}$.

Consider a partitioned matrix $A \in \mathbb{M}_{n}$ in the form

$$
A=\left[\begin{array}{ll}
A_{11} & A_{12}  \tag{1}\\
A_{21} & A_{22}
\end{array}\right], \quad \text { where diagonal blocks } A_{11} \text { and } A_{22} \text { are square. }
$$

Let $A, B$ be positive semidefinite matrices and let $f(x)$ be a non-negative concave function on $[0, \infty)$. In [10], Rotfel'd proved a subadditivity result for concave functions of sums of singular values of operators. In [8], Lee proved the following result which is considered as an extension of the classic Rotfel'd theorem.

Theorem 1.1. Let $A \in \mathbb{M}_{n}$ be positive semidefinite and be partitioned as in (1), and let $f:[0, \infty) \rightarrow[0, \infty)$ be a concave function. Then for any unitarily invariant norm $\|\cdot\|$ it holds

$$
\|f(A)\| \leq\left\|f\left(A_{11}\right)\right\|+\left\|f\left(A_{22}\right)\right\| .
$$

In 13], Zhang considered sectorial matrices and obtained the following extension of Lee's result.

Theorem 1.2. [13, Theorem 3.4] Let $f:[0, \infty) \rightarrow[0, \infty)$ be a concave function and let $A$ with $W(A) \subseteq S_{\alpha}$ for $\alpha \in[0, \pi / 2)$ be partitioned as in (1). Then

$$
\|f(|A|)\| \leq\left\|f\left(\left|A_{11}\right|\right)\right\|+\left\|f\left(\left|A_{22}\right|\right)\right\|+2\left(\left\|f\left(\tan (\alpha)\left|A_{11}\right|\right)\right\|+\left\|f\left(\tan (\alpha)\left|A_{22}\right|\right)\right\|\right)
$$

Zhang also obtained the following result:
Theorem 1.3. [13, Corollary 3.3] Let $f:[0, \infty) \rightarrow[0, \infty)$ be a concave function and let $A$ with $W(A) \subseteq S_{\pi / 4}$ be partitioned as in (1). Then

$$
\|f(|A|)\| \leq 2\left(\left\|f\left(\frac{\sqrt{2}}{2}\left|A_{11}\right|\right)\right\|+\left\|f\left(\frac{\sqrt{2}}{2}\left|A_{22}\right|\right)\right\|\right)
$$

Zhang [13] asked whether the coefficient 2 in Theorem 1.3 can be replaced by 1. Several authors have considered this problem and given solutions under certain conditions. In [7], Hou and Zhang gave an answer to the problem when $\Im A \in \mathbb{M}_{n}^{+}$. In [14], when $A$ is normal, Zhao and Ni affirmed this problem. They proved that

Theorem 1.4. [14, Theorem 3.4] Let $A$ be partitioned as in (1). Suppose $f:[0, \infty) \rightarrow[0, \infty)$ is a concave function and let $A$ with $W(A) \subseteq S_{\alpha}$ for $\alpha \in[0, \pi / 2)$ and $A$ is normal. and Then

$$
\|f(|A|)\| \leq\left\|f\left(\left|A_{11}\right|\right)\right\|+\left\|f\left(\left|A_{22}\right|\right)\right\|+\left\|f\left(\tan (\alpha)\left|A_{11}\right|\right)\right\|+\left\|f\left(\tan (\alpha)\left|A_{22}\right|\right)\right\|
$$

Recently, Yang, Lu and Chen [11] improved Theorem ??. They proved
Theorem 1.5. [11, Theorem 3.1] Let $f:[0, \infty) \rightarrow[0, \infty)$ be a concave function and let $A$ with $W(A) \subseteq S_{\alpha}$ for $\alpha \in[0, \pi / 2)$ and assume $A$ is normal, and let $A$ be partitioned as in (1). Then

$$
\|f(|A|)\| \leq\left\|f\left(\sec \alpha\left|A_{11}\right|\right)\right\|+\left\|f\left(\sec \alpha\left|A_{22}\right|\right)\right\|
$$

Fu and Liu [6] also obtained the following generalization of Theorem 1.1.
Theorem 1.6. [6, Theorem 3] Let $f:[0, \infty) \rightarrow[0, \infty)$ be a concave function and let $A$ with $W(A) \subseteq S_{\alpha}$ for $\alpha \in[0, \pi / 2)$ be partitioned as in (1). Then

$$
\begin{equation*}
\|f(|A|)\| \leq\left\|f\left(\sec ^{2} \alpha\left|A_{11}\right|\right)\right\|+\left\|f\left(\sec ^{2} \alpha\left|A_{22}\right|\right)\right\| \tag{2}
\end{equation*}
$$

In 9], the authors gave a generalization of Theorem 1.3 to a general angle $\alpha \in[0, \pi / 2)$.

Theorem 1.7. [g, Theorem 2.7] Let $f:[0, \infty) \rightarrow[0, \infty)$ be a concave function and let $A$ with $W(A) \subseteq S_{\alpha}$ for $\alpha \in[0, \pi / 2)$ be partitioned as in (1). Then for any unitarily invariant norm $\|\cdot\|$ it holds

$$
\|f(|A|)\| \leq 2\left(\left\|f\left(\frac{\sec \alpha}{2}\left|A_{11}\right|\right)\right\|+\left\|f\left(\frac{\sec \alpha}{2}\left|A_{22}\right|\right)\right\|\right)
$$

In this paper, we improve Theorem 1.2 and give a generalization of Theorem 1.7

## 2. Improvements of Rotfel'd theorem for sectorial matrices

In this section, we first list a few lemmas that are useful to derive our main results.
Lemma 2.1. Let $\left[\begin{array}{cc}A & X \\ X^{*} & B\end{array}\right]$ partitioned into four blocks in $\mathbb{M}_{n}$ be positive semidefinite. Then exists some unitary matrix $U$, for every $s>0$,

$$
|X| \leq \frac{s}{2} U^{*} A U+\frac{1}{2 s} B
$$

and exists some unitary matrix $V$, for every $s>0$,

$$
\left|X^{*}\right| \leq \frac{s}{2} A+\frac{1}{2 s} V^{*} B V
$$

Proof. Let the polar decomposition of $X^{*}$ be $X^{*}=U\left|X^{*}\right|$ and $s>0$. Notice that

$$
\begin{aligned}
{\left[\begin{array}{ll}
s I & -U^{*}
\end{array}\right]\left[\begin{array}{cc}
A & X \\
X^{*} & B
\end{array}\right]\left[\begin{array}{c}
s I \\
-U
\end{array}\right] } & =s^{2} A-s U^{*} X^{*}-s X U+U^{*} B U \\
& =s^{2} A-2 s\left|X^{*}\right|+U^{*} B U \geq 0
\end{aligned}
$$

That is,

$$
\begin{equation*}
\left|X^{*}\right| \leq \frac{s}{2} A+\frac{1}{2 s} U^{*} B U \tag{3}
\end{equation*}
$$

Note that

$$
\left[\begin{array}{cc}
B & X^{*} \\
X & A
\end{array}\right]=\left[\begin{array}{ll}
0 & I \\
I & 0
\end{array}\right]\left[\begin{array}{cc}
A & X \\
X^{*} & B
\end{array}\right]\left[\begin{array}{ll}
0 & I \\
I & 0
\end{array}\right] \geq 0
$$

Applying (3) to $\left[\begin{array}{cc}B & X^{*} \\ X & A\end{array}\right]$ and replacing $s$ by $1 / s$ yield the desired result.
Lemma 2.2. [2, Theorem 2.2] Let $A \in \mathbb{M}_{n}$ and $\alpha \in[0, \pi / 2)$. Then the following relations are equivalent:
(1) $W(A) \subseteq S_{\alpha}$.
(2) $\left[\begin{array}{cc}\sec (\alpha) \Re A & A^{*} \\ A & \sec (\alpha) \Re A\end{array}\right] \geq 0$.
(3) $\left[\begin{array}{cc}\tan (\alpha) \Re A & \Im A \\ \Im A & \tan (\alpha) \Re A\end{array}\right] \geq 0$.

Lemma 2.3. [4, Theorem III.5.6] Let $A, B \in \mathbb{M}_{n}$. Then there exist two unitary matrices $U, V$ such that

$$
|A+B| \leq U|A| U^{*}+V|B| V^{*}
$$

Lemma 2.4. [1, Theorem 2.1] Let $f:[0, \infty) \rightarrow[0, \infty)$ be a concave function and $A, B \in \mathbb{M}_{n}^{+}$. Then there exist two unitary matrices $U, V \in \mathbb{M}_{n}$ such that

$$
f(A+B) \leq U^{*} f(A) U+V^{*} f(B) V
$$

A celebrated result due to Fan and Hoffman (see, e.g.[4, p.73]) is as follows.
Lemma 2.5. Let $A \in \mathbb{M}_{n}$. Then

$$
\lambda_{j}(\Re A) \leq \sigma_{j}(A), \quad j=1, \cdots, n
$$

Equivalently,

$$
\Re A \leq U|A| U^{*}
$$

for some unitary matrix $U \in \mathbb{M}_{n}$.
Lemma 2.6. Let $A \geq B \geq 0$ and $f:[0, \infty) \rightarrow[0, \infty)$ be a concave function.
Then

$$
\|f(A)\| \geq\|f(B)\|
$$

Proof. Note that $f:[0, \infty) \rightarrow[0, \infty)$ is a concave function implies $f$ is nondecreasing. By using Weyl Monotonicity Theorem [4, p. 63], we have $\lambda_{j}(f(A))=$ $f\left(\lambda_{j}(A)\right) \geq f\left(\lambda_{j}(B)\right)=\lambda_{j} f((B)), 1 \leq j \leq n$. Thus, $\|f(A)\| \geq\|f(B)\|$.

It immediately follows from 2.5 that
Corollary 2.7. Let $A$ be a sectorial matrix and $f:[0, \infty) \rightarrow[0, \infty)$ be a concave function. Then

$$
\|f(\Re A)\| \leq\|f(|A|)\|
$$

Next, we present our main results.

Theorem 2.8. Let $f:[0, \infty) \rightarrow[0, \infty)$ be a concave function and let $A$ with $W(A) \subseteq S_{\alpha}$ for $\alpha \in[0, \pi / 2)$ be partitioned as in (1). Then for every $s>0$,

$$
\|f(|A|)\| \leq \sum_{i=1}^{2}\left(\left\|f\left(\left|A_{i i}\right|\right)\right\|+\left\|f\left(\frac{s \tan \alpha}{2}\left|A_{i i}\right|\right)\right\|+\| f\left(\frac{\tan \alpha}{2 s}\left|A_{i i}\right| \|\right)\right.
$$

Proof. Let the Cartesian decomposition of $A$ be $A=\Re A+i \Im A$ and $s>0$. Then from Lemma [2.2, we know that $\left[\begin{array}{cc}\tan (\alpha) \Re A & \Im A \\ \Im A & \tan (\alpha) \Re A\end{array}\right] \geq 0$. So by Theorem 2.1. we have

$$
\begin{equation*}
|\Im A| \leq \frac{s \tan \alpha}{2} \Re A+\frac{\tan \alpha}{2 s} U^{*} \Re A U \tag{4}
\end{equation*}
$$

for some unitary matrix $U \in \mathbb{M}_{n}$. Thus,

$$
\begin{align*}
|A| & =|\Re A+i \Im A| \\
& \leq U_{1} \Re A U_{1}^{*}+V_{1}|\Im A| V_{1}^{*}(\text { By Lemma 2.3) } \\
& \leq U_{1} \Re A U_{1}^{*}+\frac{\tan \alpha}{2} V_{1}\left(s \Re A+s^{-1} U^{*} \Re A U\right) V_{1}^{*}(\mathrm{By} \text { (44) }) \tag{5}
\end{align*}
$$

for two unitary matrices $U_{1}, V_{1} \in \mathbb{M}_{n}$.
By Lemma 2.4 there exists three unitary matrices $U_{2}, V_{2}, V \in \mathbb{M}_{n}$ such that

$$
\begin{align*}
f\left(U_{1} \Re A U_{1}^{*}+\frac{\tan \alpha}{2} V_{1}\left(s \Re A+s^{-1} U^{*} \Re A U\right) V_{1}^{*}\right) & \leq U_{2} f(\Re A) U_{2}^{*}+V_{2} f\left(\frac{s \tan \alpha}{2} \Re A\right) V_{2}^{*} \\
& +V f\left(\frac{\tan \alpha}{2 s} \Re A\right) V^{*} . \tag{6}
\end{align*}
$$

Since $f:[0, \infty) \rightarrow[0, \infty)$ is concave, then $f$ is non-decreasing. Therefore,

$$
\begin{aligned}
\|f(|A|)\| \leq & \left\|f\left(U_{1} \Re A U_{1}^{*}+\frac{\tan \alpha}{2} V_{1}\left(s \Re A+s^{-1} U^{*} \Re A U\right) V_{1}^{*}\right)\right\|(\text { By (5) and Lemma 2.6) } \\
\leq & \left\|U_{2} f(\Re A) U_{2}^{*}+V_{2} f\left(\frac{s \tan \alpha}{2} \Re A\right) V_{2}^{*}+V f\left(\frac{\tan \alpha}{2 s} \Re A\right) V^{*}\right\|(\text { By (6) and Lemma 2.6) }) \\
\leq & \|f(\Re A)\|+\left\|f\left(\frac{s \tan \alpha}{2} \Re A\right)\right\|+\left\|f\left(\frac{\tan \alpha}{2 s} \Re A\right)\right\| \\
\leq & \sum_{i=1}^{2}\left(\left\|f\left(\Re A_{i i}\right)\right\|+\left\|f\left(\frac{s \tan \alpha}{2} \Re A_{i i}\right)\right\|+\left\|f\left(\frac{\tan \alpha}{2 s} \Re A_{i i}\right)\right\|\right) \\
& \left(\text { Since } \Re A=\left[\begin{array}{cc}
\Re A_{11} & \left.\frac{A_{12}+A_{21}^{*}}{2}\right] \geq 0, \text { then by Theorem (1.1) } \\
\frac{A_{12}^{*}+A_{21}}{2} & \Re A_{22}
\end{array}\right]\right. \\
\leq & \sum_{i=1}^{2}\left(\left\|f\left(\left|A_{i i}\right|\right)\right\|+\left\|f\left(\frac{s \tan \alpha}{2}\left|A_{i i}\right|\right)\right\|+\left\|\left.f\left(\left.\frac{\tan \alpha}{2 s} \right\rvert\, A_{i i}\right) \right\rvert\,\right\|\right) \text { (By Corollary (2.7) }
\end{aligned}
$$

Remark 2.9. When $s \in[1,2]$, Theorem 2.8 is stronger than Theorem 1.2, For instance, under same assumptions of Theorem 1.2, in Theorem 2.8. for $s=1$, we have

$$
\|f(|A|)\| \leq\left\|f\left(\left|A_{11}\right|\right)\right\|+\left\|f\left(\left|A_{22}\right|\right)\right\|+2\left(\left\|f\left(\frac{\tan \alpha}{2}\left|A_{11}\right|\right)\right\|+\left\|f\left(\frac{\tan \alpha}{2}\left|A_{22}\right|\right)\right\|\right)
$$

for $s=2$, we have

$$
\begin{aligned}
\|f(|A|)\| \leq & \left\|f\left(\left|A_{11}\right|\right)\right\|+\left\|f\left(\left|A_{11}\right|\right)\right\|+\left\|f\left(\tan \alpha\left|A_{11}\right|\right)\right\|+\left\|f\left(\tan \alpha\left|A_{22}\right|\right)\right\| \\
& +\left\|f\left(\frac{\tan \alpha}{4}\left|A_{11}\right|\right)\right\|+\left\|f\left(\frac{\tan \alpha}{4}\left|A_{22}\right|\right)\right\| .
\end{aligned}
$$

Corollary 2.10. Let $f(t)=t^{p}, 0<p \leq 1$. For $s=1$ and let $A$ with $W(A) \subseteq S_{\alpha}$ for $\alpha \in[0, \pi / 2)$ be partitioned as in (1). Then we have

$$
\left\||A|^{p}\right\| \leq\left(1+2^{1-p}(\tan \alpha)^{p}\right)\left(\left\|\left|A_{11}\right|^{p}\right\|+\left\|\left|A_{22}\right|^{p}\right\|\right)
$$

Similarly, we can also get a generalization of Theorem 1.7 along a different path from Y. Mao in 9].

Theorem 2.11. Let $f:[0, \infty) \rightarrow[0, \infty)$ be a concave function and let $A$ with $W(A) \subseteq S_{\alpha}$ for $\alpha \in[0, \pi / 2)$ be partitioned as in (1). Then for any $s>0$,

$$
\|f(|A|)\| \leq \sum_{i=1}^{2}\left(\left\|f\left(\frac{s \sec \alpha}{2}\left|A_{i i}\right|\right)\right\|+\left\|f\left(\frac{\sec \alpha}{2 s}\left|A_{i i}\right|\right)\right\|\right)
$$

Proof. By Lemma 2.2, we know

$$
\left[\begin{array}{cc}
\sec (\alpha) \Re A & A^{*} \\
A & \sec (\alpha) \Re A
\end{array}\right] \geq 0
$$

By using Lemma 2.1, it implies that

$$
\begin{equation*}
|A| \leq \frac{\sec \alpha}{2}\left(s \Re A+s^{-1} U^{*} \Re A U\right), \text { for any } s>0 \tag{7}
\end{equation*}
$$

So by Lemma 2.4 there exists two unitary matrices $U_{1}, V_{1} \in \mathbb{M}_{n}$ such that

$$
\begin{equation*}
f\left(\frac{\sec \alpha}{2}\left(s \Re A+s^{-1} U^{*} \Re A U\right)\right) \leq U_{1} f\left(\frac{s \sec \alpha}{2} \Re A\right) U_{1}^{*}+V_{1} f\left(\frac{\sec \alpha}{2 s} \Re A\right) V_{1}^{*} \tag{8}
\end{equation*}
$$

Since $f:[0, \infty) \rightarrow[0, \infty)$ is concave, then $f$ is non-decreasing. Therefore,

$$
\begin{aligned}
\|f(|A|)\| \leq & \left\|f\left(\frac{\sec \alpha}{2}\left(s \Re A+s^{-1} U^{*} \Re A U\right)\right)\right\|(\text { By (7) }) \text { and Lemma 2.6) } \\
\leq & \left\|U_{1} f\left(\frac{s \sec \alpha}{2} \Re A\right) U_{1}^{*}+V_{1} f\left(\frac{\sec \alpha}{2 s} \Re A\right) V_{1}^{*}\right\|(\text { By (8) }) \text { and Lemma 2.6) } \\
\leq & \left\|f\left(\frac{s \sec \alpha}{2} \Re A\right)\right\|+\left\|f\left(\frac{\sec \alpha}{2 s} \Re A\right)\right\| \\
\leq & \sum_{i=1}^{2}\left(\left\|f\left(\frac{s \sec \alpha}{2} \Re A_{i i}\right)\right\|+\left\|f\left(\frac{\sec \alpha}{2 s} \Re A_{i i}\right)\right\|\right) \\
& \left(\text { Since } \Re A=\left[\begin{array}{cc}
\Re A_{11} & \frac{A_{12}+A_{21}^{*}}{2} \\
\frac{A_{12}^{*}+A_{21}}{2} & \Re A_{22}
\end{array}\right] \geq 0,\right. \text { then by Theorem 1.1) } \\
\leq & \sum_{i=1}^{2}\left(\left\|f\left(\frac{s \sec \alpha}{2}\left|A_{i i}\right|\right)\right\|+\left\|f\left(\frac{\sec \alpha}{2 s}\left|A_{i i}\right|\right)\right\|\right) \quad(\text { By Corollary [2.7) }
\end{aligned}
$$

Remark 2.12. For $s=1$ in Theorem [2.11, we obtain the result in 1.7 .
