# ALGEBRAIC COMPLETE INTEGRABILITY OF THE $a_{4}^{(2)}$ TODA LATTICE

#### Abstract

The aim of this work is focused on the investigation of the algebraic complete integrability (a.c.i) of the Toda lattice associated with the twisted affine Lie algebra $a_{4}^{(2)}$. First, we prove that the generic fiber of the momentum map for this system is an affine part of an abelian surface. Second, we show that the flows of integrable vector fields on this surface are linear. Finally, using the formal Laurent solutions of the system, we provide a detailed geometric description of these abelian surfaces and the divisor at infinity.


## 1. Introduction

The study of integrable Hamiltonian systems has been motivated by several factors, including the development of powerful and beautiful mathematical theories and the application of integration concepts to various physical, biological, and chemical systems. However, it remains challenging to describe or recognize integrable Hamiltonian systems with ease, as they are exceptional cases. The Korteweg-de Vries equation has generated numerous new ideas in the field of completely integrable Hamiltonian systems, leading to unexpected connections between mechanics, spectral theory, Lie algebra theory, algebraic geometry, and even differential geometry. Some interesting integrable systems also appear as coverings of algebraic complete integrable systems. These systems are called algebraic complete integrable.

The concept of algebraic complete integrability systems is a more general concept than complete integrability. An algebraic complete integrable system can be linearized on a complex torus, and its invariant functions (often called first integrals or constants) are polynomial maps and their restrictions to an invariant complex variety are meromorphic functions on a complex abelian variety. The fluxes generated by the constants of motion are straight lines in this complex abelian variety.

The Toda lattice, introduced by Morikazu Toda in 1967, is a simple model for a onedimensional crystal in solid-state physics. It is famous because it is one of the first examples of a completely integrable nonlinear system. It is described by a chain of particles with nearest-neighbor interaction, and its dynamics are governed by the Hamiltonian

[^0]where $q(n, t)$ is the displacement of the $n$-th particle from its equilibrium position, and $p(n, t)$ is its momentum (with mass $m=1$ ), and the Toda potential is given by $V(r)=$ $e^{-r}+r-1$. The classical Toda lattice is a system of particles with unit mass, connected by exponential springs. Its equations of motion derived from the Hamiltonian.

where $q_{j}$ is the position of the $j$-th particle and $p_{j}$ is its amount of movement. This type of Hamiltonian was considered first by Morikazu Toda [9. The equation (1.1) is known as the finite classic no periodic Toda lattice to distinguish other versions of various forms of the system. The periodic version of (1.1) is given by

where the equations of motion are given by

The integrability of the periodic Toda lattice was established by Henon [8] and Flaschka [7] using the Lax pairs method. In 1976, Bogoyavlensky [4] introduced a generalization of the classical Toda periodic lattice to arbitrary Lie algebras.

Vanhaecke, Adler and Moerbeke in [3] give the explicit Hamiltonians for the periodic Toda lattices that involve precisely three (connected) particles. There are precisely six cases of them, going with the extended root systems $a_{2}^{(1)}, a_{4}^{(2)}, c_{2}^{(1)}, d_{3}^{(2)}, g_{2}^{(1)}$ and $d_{4}^{(3)}$. Them prove that the case $a_{2}^{(1)}$ is algebraic completely integrable (a.c.i). In his case, Dehainsala prove in [5] that the two cases $c_{2}^{(1)}$ and $d_{3}^{(2)}$ are (a.c.i).

In this work, we prove that the $a_{4}^{(2)}$ is a two-dimensional integrable system. This system satisfies the linearization criterion [[2], theorem 6.41]. We prove that this system is an algebraic completely integrable in the Adler-van Moerbeke sense.

To prove this, with respect to the complex Liouville theorem, firstly, by the indicial locus and the Kowaleski matrix, we have show that our system has three distinct families of homogeneous Laurent solutions with weights depending on four free parameters and find the Zariski open set $\Omega$ and the fiber $\mathbb{F}_{c}, c \in \Omega$. Secondly, with these Laurent solutions, we determined the Painlevé divisor and their arithmetic genus. We have obtain three divisors, for $c \in \Omega$, the Painlevé divisor $\Gamma_{c}^{(0)}$ is a smooth three genus hyperelliptic curve, the Painlevé divisor $\Gamma_{c}^{(1)}$ is a smooth four genus elliptic curve and the Painlevé divisor $\Gamma_{c}^{(2)}$ is a smooth two genus hyperelliptic curve. Thirdly, to compactify the fiber, we determined the projective space to embedding the divisor at infinity to fine the singularities an the intersection between the differents curves. We have obtain twenty-five (25) functions which forms the basis of the projective space and determined the intersections points. To end our prove, we show that the vetor field $\left(\varphi_{c}\right)_{*} \mathcal{V}_{1}$ extends to an holomorphic vector fields on $\mathbb{P}^{24}$. To show that the vector field $\left(\varphi_{c}\right)_{*} \mathcal{V}_{1}$ is holomorphic on two chart of $\mathbb{P}^{24}$, we have establish that this vector field can be written as a quadratic vector field in the chart $Z_{0} \neq 0$ and $Z_{1} \neq 0$.

This paper is organized as follows. In section 2, preliminaries of this work, we give the basic notions of algebraic integrability in sense of Adler-Van Moerbeke. In section 3, main part of the paper, we verify that the $a_{4}^{(2)}$ Toda lattice is Liouville integrable, we do the

Painlevé analysis of the system. This analysis shows that our integrable system admits three principal balances i.e. three families of Laurent solutions depending on the maximal number of free parameters,four in our case. Thus, by confining each family of Laurent solutions to the invariant manifolds we calculate the Painlevé divisors associated to these principal balances and, for $c \in \Omega$, we give an explicit embedding of the invariant manifold $\mathbb{F}_{c}$ in the projective space $\mathbb{P}^{24}$. Finally, in the section 4 , we determine the holomorphic differentials forms on the abelian surface.

## 2. Preliminaries

Let $v=\left(v_{1}, \cdots, v_{n}\right)$ be a collection of positive integers without a common divisor. Such a $v$ is called a weight vector.

Definition 2.1. [2] A polynomial $f \in \mathcal{F}\left(\mathbb{C}^{n}\right):=\mathbb{C}\left[x_{1}, \cdots, x_{n}\right]$ is a weight homogeneous polynomial of weight $k$ (with respect to $v$ ) if $f\left(t^{v_{1}} x_{1}, \cdots, t^{v_{n}} x_{n}\right)=t^{k} f\left(x_{1}, \cdots, x_{n}\right)$, $\forall\left(x_{1}, \cdots, x_{n}\right) \in \mathbb{C}^{n}$ and $t \in \mathbb{C}$.

When the weight of $f$ is $k \in \mathbb{N}$, we denote

Definition 2.2. [2] A polynomial vector field on $\mathbb{C}^{n}$,

is called a weight homogeneous vector field of weight $k$ (with respect to $v$ ) if each of the polynomials $f_{1}, \cdots, f_{n}$ is weight homogeneous (with respect to $v$ ) and if $\varpi\left(f_{i}\right)=v_{i}+k=$ $\varpi\left(x_{i}\right)+k$ for $i=1, \cdots, n$.

According to [[2], proposition 7.6], if (2.1) is a weight homogeneous vector field then a Laurent solution to (2.1) have the form

is called weight homogeneous Laurent solution. We will say that a formal Laurent solution is a principal balance if it depends on $n-1$ free parameters; otherwise, it will be called the lower balance.

The positive integers $v_{i}$ being the weights of the phase variables, then the leading coefficients $x_{i}^{(0)}$ satisfy the nonlinear algebraic equations

while the other coefficients $x_{i}^{(k)},(k \geq 1)$ satisfy

where $x^{(k)}=\left(x_{1}^{(k)}, x_{2}^{(k)}, \cdots, x_{n}^{(k)}\right)^{\top}, P^{(k)}=\left(P_{1}^{(k)}, P_{2}^{(k)}, \cdots, P_{n}^{(k)}\right)^{\top}$ and each $P_{i}^{(k)}$ is a polynomial which depends only on the variables $x_{1}^{(l)}, x_{2}^{(l)}, \cdots, x_{n}^{(l)}$ with $0 \leq l \leq k$.

The matrix $\mathcal{K}$ of order $n$ is defined by $\mathcal{K}_{i j}=\frac{\partial f_{i}}{\partial x_{j}}+v_{i} \delta_{i j}$ is called the Kowalevski matrix. All the set of equations (2.2) of $\mathcal{V}$. Its solution set $\mathcal{I}$ is called the indicial equation.

The number of non-negative integers eigenvalues of the matrix $\mathcal{K}$ is precisely the number of free parameters of the family of Laurent solutions whose first term is given in [1] by $\left(x_{1}^{(0)}, x_{2}^{(0)}, \cdots, x_{n}^{(0)}\right)$. For any element $m$ of $\mathcal{I}$, the Kowalevski matrix $\mathcal{K}(m)$ always admits -1 as an eigenvalue.

Theorem 2.3. [2] $\mathcal{V}$ is a homogeneous polynomial vector field with weights over $\mathbb{C}^{n}$. If $x(t)$ is a weight homogeneous formal Laurent solution of $\mathcal{V}$ then $x(t)$ is convergent (for small $|t|$ or zero)

Consider a weight homogeneous vector field $\mathcal{V}$ on $\mathbb{C}^{n}$. Suppose that for any irreducible component $\mathcal{I}^{\prime}$ of the indicial locus $\mathcal{I}$ of $\mathcal{V}$ the characteristic polynomial $\left(k I d_{n}-\mathcal{K}(m)\right)$ is independent of $m \in \mathcal{I}^{\prime}$. Then the set of all weight homogeneous Laurent solutions of $\mathcal{V}$ is parametrized by a finite number of affine varieties $\Gamma_{i=0,1,2}^{(i)}$. For any one of these affine varieties $\Gamma^{(i)}$ the coefficients that appear in the corresponding weight homogeneous balance are regular functions on $\Gamma^{(i)}$.

If $x(t ; \Gamma)$ is a principal balance then $\Gamma$ is an affine variety; hence has a decent topological structure, and all other balances also have this property. The compact subset $\Gamma_{0}$ can then be taken with respect to the complex topology. If $\Gamma$ does not have a nice structure, just give it the discrete topology.

Definition 2.4. 2] Let $\mathcal{V}$ be a weight homogeneous vector field on $\mathbb{C}^{n}$ and write, as before, $\dot{F}$ for $\mathcal{V}[F]$, where $F \in \mathcal{F}\left(\mathbb{C}^{n}\right)=\mathbb{C}\left[x_{1}, \cdots, x_{n}\right]$, and $\dot{x}_{i}=f_{i}(x)$, where $i=1, \cdots, n$. Define

In view of the Leibniz rule, $\mathcal{H}$ is a subalgebra of $\mathcal{F}\left(\mathbb{C}^{n}\right)$, which we call the algebra of constants of motion or the algebra of first integrals of $\mathcal{V}$.

Let $\Lambda$ be a discrete subgroup of rank $k$ of $\mathbb{C}^{n}$. The quotient group $\mathbb{C}^{n} / \Lambda$ has a smooth complex manifold structure induced by the projection $\pi: \mathbb{C}^{n} \longrightarrow \mathbb{C}^{n} / \Lambda$. This complex manifold is compact if and only if $k=2 n$. In this case, $\mathbb{T}^{n}=\mathbb{C}^{n} / \Lambda$ is a complex torus. If such a complex torus is also an algebraic variety, i.e admits a projective embedding, we then say that it is an abelian variety. If $k=2 n=4$, we say that it is an abelian surface.

The following theorem gives the conditions on the network $\Lambda$ for which $\mathbb{T}^{n}$ is an algebraic variety.

Theorem 2.5. (Riemann Condition) [2]
A complex torus $\mathbb{T}^{n}=\mathbb{C}^{n} / \Lambda$ is an abelian variety if and only if there exists a complex basis $\left(e_{1}, \cdots, e_{n}\right)$ of $\mathbb{C}^{n}$ and an integer basis $\left(\lambda_{1}, \cdots, \lambda_{2 n}\right)$ of $\Lambda$, the $n \times 2 n$ matrix as a $\mathbb{Z}$ - module such that the last base can be expressed in terms of the first as

takes the form $\Lambda=\left(\Delta_{\delta} Z\right)$ with all $\delta_{i}$ (are called the elementary divisors of the polarization) are positive integers such that $\delta_{i} \mid \delta_{i+1}(1 \leq i<n)$ and $Z$ is a symmetric matrix whose imaginary part is positive definite.

Notice that before show the algebraic complete integrability of a system, we first show his complete integrability. For us, we use the Liouville integrability. In order word we
determine the vector fields or the first integrals which commute pairwise. For this we use some notions like Poisson bracket, first integrable, involution, integrable or completely integrable system.

Definition 2.6. Let $M$ be a manifold. A Poisson bracket or Poisson structure on $M$ is a Lie algebra structure $\{\cdot, \cdot\}$ on $\mathcal{F}(M)$, which is a biderivation on $\mathcal{F}(M)$, i.e., for any $H \in \mathcal{F}(M)$ the linear map

is a derivation on $\mathcal{F}(M)$, i.e., a vector field. The pair $(M,\{\cdot, \cdot\})$ is called a Poisson manifold.
Definition 2.7. Let $(M,\{\cdot, \cdot\})$ a Poisson manifold and let $H \in \mathcal{F}(M)$. The vector field $\mathcal{X}_{H}:=\{\cdot, H\}$ is called the Hamiltonian vector field associated to the Hamiltonian $H$.

Definition 2.8. Let $(\mathbf{M},\{\cdot, \cdot\})$ be a Poisson manifold and let $\mathbf{F}, \mathbf{G} \in \mathcal{F}(\mathbf{M})$. We say that $\mathbf{F}$ and $\mathbf{G}$ are in involution if $\{\mathbf{F}, \mathbf{G}\}=0$. For a subset $\mathcal{F}$ of $\mathcal{F}(\mathbf{M})$ we say that $\mathcal{F}$ is involutive if any two elements of $\mathcal{F}$ are in involution

If $\mathbf{F}=\left(\mathbf{F}_{\mathbf{1}}, \cdots, \mathbf{F}_{\mathbf{s}}\right)$ is an $s$-tuple, elements of $\mathbf{F}_{\mathbf{i}} \in \mathcal{F}(M)$ then $\mathbf{F}$ defines a map from $\mathbf{M}$ to $\mathbb{R}^{s}$ or $\mathbb{C}^{s}$.

Definition 2.9. Let $(M,\{\cdot, \cdot\})$ a Poisson manifold and suppose that $\mathbf{F}=\left(\mathbf{F}_{\mathbf{1}}, \cdots, \mathbf{F}_{\mathbf{s}}\right)$, where $\mathbf{F}_{\mathbf{i}} \in \mathcal{F}(M)$ for $1 \leq i \leq s$. We say that $\mathbf{F}$ is independent when the open subset on which the differentials $d \mathbf{F}_{1}, \cdots, d \mathbf{F}_{s}$ are independent is dense in $M$.

Thus $\mathbf{F}=\left(\mathbf{F}_{\mathbf{1}}, \cdots, \mathbf{F}_{\mathbf{s}}\right)$ is independent if and only if the set

is a dense open subset of $M$. In local coordinates $\left(x_{1}, \cdots, x_{n}\right)$ on a neighborhood of $m \in M$, we have $m \in \mathcal{U}_{\mathbf{F}}$ if and only if

Definition 2.10. [2] Let $(M,\{\cdot, \cdot\})$ a Poisson manifold of $n$ dimension and the rank $2 r, \mathbf{F}=\left(\mathbf{F}_{\mathbf{1}}, \cdots, \mathbf{F}_{\mathbf{s}}\right)$ an involutive family and independent functions on $M$, such that $s=n-r . \mathbf{F}$ is completely integrable and the system $(M,\{\cdot, \cdot\}, \mathbf{F})$ is an integrable system or a completely integrable system in the sense of Liouville. The map $F$ is call momentum map and the vectors fields $\mathcal{X}_{\mathbf{F}_{i}}$ are integrable vectors fields. The integer $r$ is the number of degrees of freedom of the integrable system and $2 r$ is it rank.

Notice that $2 r$ is the dimension of the symplectic leaves of maximal dimension (typically the generic leaf) and $r$ is the number of independent commuting Hamiltonian vector fields on such a leaf.

According to [2], many integrable systems from classical mechanics admit a complexification, where phase space and time are complexified, and the geometry of the (complex) momentum map is the best possible complex analogue of the geometry that appears in the Liouville Theorem. Namely, in many relevant examples the generic complexified fiber is an affine part of an Abelian variety (a compact algebraic torus) and the integrable vector fields are translation invariant, when restricted to any of these tori. Hence to define an algebraic complete integrable system, we need the following definitions.

## Definition 2.11. [2]

A fiber of $\mathbf{F}$ is a common level set of the functions $\mathbf{F}_{\mathbf{i}}$. The fiber of $\mathbf{F}$ that passes through $m \in M$ will be denoted by

For $c \in \mathbb{R}^{s}\left(\operatorname{resp} \mathbb{C}^{s}\right)$, we will note the fiber $\mathbf{F}^{-1}(c)$ above $c$ by $\mathbf{F}_{c}$. So we have

The set of regular values of $\mathbf{F}$ is a residual subset (hence a dense subset) of $\mathbb{R}^{s}\left(\operatorname{resp} \mathbb{C}^{s}\right)$. By the inverse function theorem, the fiber $\mathbf{F}_{c}$ over each regular value $c$ that lies in the image of $\mathbf{F}$ is non-singular. Hence when $\mathbf{F}=\left(\mathbf{F}_{\mathbf{1}}, \cdots, \mathbf{F}_{\mathbf{s}}\right)$ is involutive, the Hamiltonian vector fields $\mathcal{X}_{\mathbf{F}_{i}}(1 \leq i \leq s)$ commute and for any point $m$ they are tangent to the non-singular affine part of $\mathbf{F}(m)$.

Definition 2.12. An abelian variety is a complex torus $\mathbb{C}^{r} / \Lambda\left(\Lambda\right.$ a lattice in $\left.\mathbb{C}^{r}\right)$ which is projective, which means that it admits a embedding in a project space $\mathbb{P}^{N}$.

An abelian variety $\mathbb{T}^{r}$ will be called an irreducible abelian variety, when $\mathbb{T}^{r}$ does not contain any abelian subvariety, otherwise it will be called a reducible abelian variety.

Definition 2.13. Let $(M,\{\cdot, \cdot\}, \mathbf{F})$ be a complex integrable system, where $M$ is a nonsingular affine variety and where $\mathbf{F}=\left(\mathbf{F}_{\mathbf{1}}, \cdots, \mathbf{F}_{\mathbf{s}}\right)$. We say that $(M,\{\cdot, \cdot\}, \mathbf{F})$ is an algebraic completely integrable system or an a.c.i. system if for generic $c \in \mathbb{C}^{s}$ the fiber $\mathbf{F}_{c}$ is an affine part of an Abelian variety and if the Hamiltonian vector fields $\mathcal{X}_{\mathbf{F}_{i}}$ are translation invariant, when restricted to these fibers. In the particular case in which $M$ is an affine space $\mathbb{C}^{n}$ we will call $\left(\mathbb{C}^{n},\{\cdot, \cdot\}, \mathbf{F}\right)$ a polynomial a. c. i. system. When the generic Abelian variety of the a.c.i. system is irreducible we speak of an irreducible a.c.i. system.

An integrable system is said to be algebraic completely integrable if the fibers of the moment map are affine parts of abelian varieties and the integrable fields are linear.

The following theorem gives a necessary condition for the algebraic integrability of an integrable system. It is inspired by the Kowalevski work, and is based on the fact that the phase space of an a.c.i. system admits a partial compactification on which the integrable vector fields extend into complete vector fields. This means that each of the integrable vector fields of an irreducible a.c.i. system on $\mathbb{C}^{n}$ admits one or several families of Laurent solutions (called balances), which will lead to a necessary condition for algebraic complete integrability, which we call the Kowalevski-Painleve Criterion.

Theorem 2.14. (Kowalevski-Painleve criterion) [2]
Let $\left(\mathbb{C}^{n},\{\cdot, \cdot\}, \mathbf{F}\right)$ be an irreducible, polynomial a.c.i. system, where $\mathbf{F}=\left(\mathbf{F}_{\mathbf{1}}, \cdots, \mathbf{F}_{\mathbf{s}}\right)$ is a family of polynomials and $\left(x_{1}, \cdots, x_{n}\right)$ be a system of linear coordinates on $\mathbb{C}^{n}$. Let $\mathcal{V}$ be any one of the integrable vector fields $\mathcal{X}_{F_{1}}, \cdots, \mathcal{X}_{F_{s}}$. For each $1 \leq i \leq n$ such that $x_{i}$ is not constant along the integral curve of $\mathcal{V}$, i.e $\dot{x}_{i}:=\mathcal{V}\left[x_{i}\right] \neq 0$, there exists a principal balance $x(t)=\left(x_{1}(t), \cdots, x_{n}(t)\right)$, depending on $n-1$ free parameters for which $x_{i}(t)$ has a pole.

Let $\mathcal{A}$ an affine variety, $\varphi: \mathcal{A} \longrightarrow \mathbb{P}^{N}$ a regular map, let $\overline{\varphi(\mathcal{A})}$ be the closure of the image of $\mathcal{A}$ in $\mathbb{P}^{N}$.

The following theorem gives the sufficient conditions to be satisfied by the fibers of the momentum map of an integrable system to be a.c.i

Theorem 2.15. (Complex Liouville Theorem) [2]
Let $\mathcal{A} \in \mathbb{C}^{s}$ be a non-singular affine variety of dimension $r$ which supports $r$ holomorphic vector fields $\mathcal{V}_{1}, \cdots, \mathcal{V}_{r}$ and let $\varphi: \mathcal{A} \longrightarrow \mathbb{C}^{N} \subset \mathbb{P}^{N}$ be a regular map; here $\mathbb{C}^{N} \subset \mathbb{P}^{N}$ is the usual inclusion of $\mathbb{C}^{N}$ as the complement of a hyperplane $\mathbf{H}$ in $\mathbb{P}^{N}$. We define $\Delta:=\overline{\varphi(\mathcal{A})} \backslash \varphi(\mathcal{A})$ and we decompose the analytic subset $\Delta$ as $\Delta=\Delta^{\prime} \cup \Delta^{\prime \prime}$ where $\Delta^{\prime}$ is the union of the irreducible components of $\Delta$ of dimension $r-1$ and $\Delta^{\prime \prime}$ is the union of the other irreducible components of $\Delta$. The following conditions are assumed to be verified:
(1) $\varphi: \mathcal{A} \longrightarrow \mathbb{C}^{N}$ is an isomorphic embedding;
(2) The vector fields commute pairwise, $\left[\mathcal{V}_{i}, \mathcal{V}_{j}\right]=0$ for $1 \leq i, j \leq r$;
(3) At every point $m \in \mathcal{A}$, the vector fields $\mathcal{V}_{1}, \cdots, \mathcal{V}_{r}$ are independent;
(4) The vector field $\varphi * \mathcal{V}_{1}$ extends to a vector field $\overline{\mathcal{V}}_{1}$ which is holomorphic on a neighborhood of $\Delta^{\prime}$ in $\mathbb{P}^{N}$;
(5) The integral curves of $\overline{\mathcal{V}}_{1}$ that start at points $m \in \Delta^{\prime}$ go immediately into $\varphi(\mathcal{A})$.

Then $\overline{\varphi(\mathcal{A})}$ is a abelian variety of dimension $r$ and $\Delta^{\prime \prime}=\emptyset$, so that $\overline{\varphi(\mathcal{A})}=\varphi(\mathcal{A}) \cup \Delta^{\prime}$. Morever, the vector fields $\varphi * \mathcal{V}_{1}, \cdots, \varphi * \mathcal{V}_{r}$ extends to holomorphic vector fields on $\overline{\varphi(\mathcal{A})}$.

## 3. Algebraic integrability of the Toda lattice $a_{4}^{(2)}$.

The aims of this section is to prove the algebraic complete integrability of the Toda lattice $a_{4}^{(2)}$.
3.1. Liouville integrability of the Toda lattice $a_{4}^{(2)}$. The differential equations of the periodic Toda lattice $a_{4}^{(2)}$ are given on the five dimensions hyperplane $\mathcal{H}=\left\{\left(x_{0}, x_{1}, x_{2}, y_{0}, y_{1}, y_{2}\right) \in \mathbb{C}^{6} \mid y_{0}+2 y_{1}+2 y_{2}=0\right\}$ of $\mathbb{C}^{6}$ by

where $x=\left(x_{0}, x_{1}, x_{2}\right)^{\top}, y=\left(y_{0}, y_{1}, y_{2}\right)^{\top}$ and $A$ is the Cartan matrix of the twisted affine Lie algebra $a_{4}^{(2)}$ given in [2] by

and $\varepsilon=(1,2,2)^{\top}$ is the normalized null vector of $A^{\top}$. The equations of motion of the Toda lattice $a_{4}^{(2)}$ are given in [2] by :

We denote by $\mathcal{V}_{1}$ the vector field defined by the above differential equations (3.1). Then $\mathcal{V}_{1}$ is the Hamiltonian vector field, with Hamiltonian function $F_{2}=y_{0}^{2}+4 y_{2}^{2}-4 x_{0}-8 x_{1}-16 x_{2}$ with respect to the Poisson structure $\{\cdot, \cdot\}$ defined by the following skew-symmetric matrix

This Poisson structure is given on $\mathbb{C}^{6}$; the function $F_{0}=y_{0}+2 y_{1}+2 y_{2}$ is a Casimir, so that the hyperplane $\mathcal{H}$ is a Poisson subvariety. The rank of this Poisson structure $\{\cdot, \cdot\}$ is 0 on the three-dimensional subspace $\left\{x_{0}=x_{1}=x_{2}=0\right\}$; the rank is 2 on the three four-dimensional subspaces: $\left\{x_{0}=x_{1}=0\right\},\left\{x_{0}=x_{2}=0\right\}$ and $\left\{x_{1}=x_{2}=0\right\}$. Thus, for all points of $\mathcal{H}$ except the four subspaces above the rank is 4 . The vector field $\mathcal{V}_{1}$ admits also the following two constants of motion:

$F_{1}$ is a Casimir for $\{\cdot, \cdot\}$, and the function $F_{3}$ generates a second Hamiltonian vector field $\mathcal{V}_{2}$, which commutes with $\mathcal{V}_{1}$, given by the differential equations

Hence the system (3.1) is completely integrable in the Livouille sense. It can be written as a Hamiltonian vector fields

where $\frac{\partial H}{\partial z}=\left(\frac{\partial H}{\partial x_{0}}, \frac{\partial H}{\partial x_{1}}, \frac{\partial H}{\partial x_{2}}, \frac{\partial H}{\partial y_{0}}, \frac{\partial H}{\partial y_{1}}, \frac{\partial H}{\partial y_{2}}\right)^{\top}$ and $J$ is an antisymmetric matrix.
The vector field $\mathcal{V}_{2}$ admits the same constants of motion (3.3) and is in involution with $\mathcal{V}_{1}$ therefore $\left\{F_{2}, F_{3}\right\}=0$. The involution $\sigma$ defined on $\mathbb{C}^{6}$ by

preserves the constants of motion $F_{1}, F_{2}$ and $F_{3}$, hence leave the fibers of the momentum map $F$ invariant. This involution can be restricts to the hyperplane $\mathcal{H}$.

Let $\mathbf{F}=\left(\mathbf{F}_{\mathbf{1}}, \mathbf{F}_{\mathbf{2}}, \mathbf{F}_{\mathbf{3}}\right): \mathcal{H} \rightarrow \mathbb{C}^{\mathbf{3}}$ be the momentum map; functions $\mathbf{F}_{\mathbf{i}}$ being two by two in involution, $\mathbf{F}$ is involutive. The Jacobian matrix of $\mathbf{F}$ is given by:

with $a=-4 y_{0} y_{2}+16 x_{2}+8 x_{1}, b=2 y_{0}\left(y_{2}^{2}-4 x_{2}\right)-4 x_{1} y_{2}, c=2 y_{2}\left(y_{0}^{2}-4 x_{0}\right)-4 x_{1} y_{0}$. Let $p_{0}\left(1,1,1,1, \frac{-3}{2}, 1\right)$ be a point of $\mathcal{H}$. The Jacobian matrix of $\mathbf{F}$ at $p_{0}$ is given by

The rank of matrix $\operatorname{Jac}\left(p_{0}\right)$ is 3 , so the the differentials $d \mathbf{F}_{i},(i=1,2,3)$ are independent at $p_{0}$ according to (definition (2.9)) and since the functions $\mathbf{F}_{i}$ are polynomials, $\mathbf{F}$ is independent on a dense open subset $\mathcal{U}_{\mathbf{F}}$ of $\mathcal{H}$. We can deduce that $(\mathcal{H},\{.,\},. \mathbf{F})$ is an integrable system in the sense of Liouville.

Let $\mathcal{S}$ be the set of points in $\mathcal{H}$ where the determinants of all $3 \times 3$ minors of the matrix Jac cancel. By direct computation, we prove that $S$ is the union of following subvarieties:

\mathcal{S}_{5}:=\left\{x_{0}=\frac{1}{4} \beta, x_{2}=\frac{1}{2} \frac{y_{2}\left(4 x_{1} y_{2}-2 x_{1} y_{0}-2 y_{0} y_{2}^{2}+y_{0}^{2} y_{2}\right)}{y_{0}\left(-4 y_{2}+y_{0}\right)}\right\} .
\end{gathered}

with

The images under $\mathbf{F}$ of $S_{1}$ and $S_{2}$ are contained in the subset $\mathbf{F}_{\mathbf{1}}=\mathbf{c}_{\mathbf{1}}=\mathbf{0}$. By substituting $x_{1}=\frac{1}{8} y_{0}^{2}, x_{2}=\frac{1}{4} x_{0}$ and $y_{0}=4 y_{2}$ in the three constants of motion $\mathbf{F}_{\mathbf{i}}=\mathbf{c}_{\mathbf{i}},(i=1,2,3)$, by direct compulation with Maple, we obtain:

At a generic point $c=\left(c_{1}, c_{2}, c_{3}\right) \in \mathbb{C}^{3}$, the fiber on $c \in \Omega$ of $\mathbf{F}$ is therefore:

Hence we have the following result which prove that Toda lattice $a_{4}^{(2)}$ is a completely integrable system in the Liouville sense.

Proposition 3.1. For $c \in \Omega$, the fiber $\mathbb{F}_{c}$ over $c$ of the momentum $F$ is a smooth affine variety of dimension 2 and the rank of the Poisson structure (3.2) is maximal and equal to 4 at each point of $\mathbb{F}_{c}$; moreover the vector fields $\mathcal{V}_{1}$ and $\mathcal{V}_{2}$ are independent at each point of the fiber $\mathbb{F}_{c}$.

Proposition 3.2. $(\mathcal{H},\{\cdot, \cdot\}, \mathbf{F})$ is a completely integrable system describing the Toda lattice $a_{4}^{(2)}$ where $\mathbf{F}=\left(\mathbf{F}_{1}, \mathbf{F}_{2}, \mathbf{F}_{3}\right)$ and $\{\cdot, \cdot\}$ are given respectively by (3.3) and (3.2) with commuting vector fields (3.1) and (3.4).
3.2. Algebraic integrability of $a_{4}^{(2)}$ Toda lattice. To show that the Toda lattice $a_{4}^{(2)}$ is algebraically completely integrable (a.c.i), we show that for all $c=\left(c_{1}, c_{2}, c_{3}\right) \in \Omega$, the fiber $\mathbf{F}_{\mathbf{c}}$ is the affine part of an abelian surface on which the two vector fields $\mathcal{V}_{1}$ and $\mathcal{V}_{2}$ are linear [5]. For that it is necessary to verify that $\mathbf{F}_{\mathbf{c}}$ satisfies the conditions of the Liouville complex theorem (theorem 2.15).
Observe that the vector field $\mathcal{V}_{1}$ is homogeneous with respect to the following weights :

We can also verify that the constants of motion $\mathbf{F}_{\mathbf{i}}$ are weight homogeneous and they have the following weights:

3.2.1. Laurent solutions. According to [2], the vector fields of an a.c.i system have good properties at infinity; after all, a linear vector field on a complex torus is the same along the divisor, which will happen to be absent in phase space, as on the rest of the torus. In fact, since every holomorphic function on a complex torus can be written as a quotient of theta functions, the integral curves (solutions) to any of the vector fields of an a.c.i system can be written as a quotient of holomorphic functions. Intuitively speaking this means that we can consider not only Taylor solutions to the differential equations that describe these vector fields but also Laurent solutions, which will correspond to initial conditions at infinity ( precisely: on the divisor that needs to be adjoined to the fibers of the momentum map to complete them into Abelian varieties). Moreover, these Laurent solutions must depend on $\operatorname{dim} \mathcal{H}-1$ free parameters, which corresponds to the freedom of choice of the initial condition at infinity.

Let us look for weights homogeneous Laurent solutions associated to the vector field $\mathcal{V}_{1}$. The solution form of vector field $\mathcal{V}_{1}$ is

that is to say that $\varpi\left(x_{i}\right)=2 \varpi\left(y_{i}\right)=2$ for $i=0,1,2$. By substituting these solutions into the differential equations (3.1) associated with the vector field $\mathcal{V}_{1}$, the indicial locus is the subset of $\mathcal{H}$ given, according to (2.2), by:

These equations are easily solved and they yield the following (non-zero) solutions:

Lemma 3.3. The system of differential equation (3.1) of the vector field $\mathcal{V}_{1}$ has three distincts families of homogeneous Laurent solutions with weights depending on four (dim $\mathcal{H}-1)$ free parameters.

Proof. The characteristic polynomial of the Kowalevski matrix at $m_{0}$ is given by:

It admits 4 non-negative eigenvalues which leads to a Laurent solution depending on four free parameters, whose the five leading terms (going with steps $1,2,2,3$ respectively, are denoted by $a, c, d$ and $e$ ). The first four terms of this balance which we note $x\left(t, m_{0}\right)$ :

Proposition 3.4. For the Laurent solution $x\left(t ; m_{0}\right)$ restricted to the invariant surface, for $c \in \Omega$, the Painlevé divisor $\Gamma_{c}^{(0)}$ is a smooth three genus hyperelliptic curve. It is given by:

which shows that above from the points $t_{1}$ and $t_{2}$, the map $\bar{\psi}$ is not ramified. We then conclude that the application $\bar{\psi}: \overline{\Gamma_{c}^{(2)}} \longrightarrow \overline{\varepsilon_{c}^{(2)}}$ is a double covering of $\mathbb{P}^{1}$ branched into 5 points. We deduce that the genus of $\overline{\Gamma_{c}^{(2)}}$ is equal to 2 according to the Riemann-Hurwitz formula.
3.3. Abelian surface. According to [6], in order to embed the three Riemann surfaces $\overline{\Gamma_{c}^{(0)}}, \overline{\Gamma_{c}^{(1)}}$ and $\overline{\Gamma_{c}^{(2)}}$ into some projective space, one of the key underlying principles used the Kodaira embedding theorem, which states that a smooth complex manifold can be smoothly embedded into projective space $\mathbb{P}^{N}(\mathbb{C})$ with the set of functions having a pole of order $k$ along positive divisor on the manifold, provided $k$ is large enough; fortunately, for Abelian surfaces, $k$ need not be larger than three according to Lefschetz theorem. These functions are easily constructed from the three Laurent solutions by looking for polynomials in the phase variables which in the expansions have at most a $k$-fold pole. The nature of the expansions and some algebraic properties of Abelian varieties provide a recipe for when to terminate our search for such functions, thus making the procedure implementable. Precisely, we wish to find a set of polynomial functions $\left\{z_{0}, \cdots, z_{N}\right\}$, of increasing degree in the original variables $x_{0}, \cdots, y_{2}$ having the property that the embedding $\mathcal{D}$ of $\overline{\Gamma_{c}^{(i)}}{ }_{i=0,1,2}$ into $\mathbb{P}^{N}(\mathbb{C})$ via those functions satisfies the relation: $g(\mathcal{D})=N+2$ where $g(\mathcal{D})$ is the geometric genus of $\mathcal{D}$. If the $a_{4}^{(2)}$ Toda lattice is an irreducible a.c.i. system, then as we have seen above a divisor $\mathcal{D}$ can be added to a Zariski open subset of $\mathcal{H}$, having the effect of compactifying all fibers $\mathbb{F}_{c}$, where $c \in \Omega$. The divisor that is added to $\mathbb{F}_{c}$ will be denoted by $\mathcal{D}_{c}$ and the resulting torus by $\mathbb{T}_{c}^{2}$. The vector fields $\mathcal{V}_{1}$ and $\mathcal{V}_{2}$ extend to linear (hence holomorphic) vector fields on this partial compactification of $\mathcal{H}$, hence we may consider the integral curves of $\mathcal{V}_{1}$, starting from any component $\mathcal{D}_{c}^{(i)}$. Since the third power of an ample divisor on an Abelian variety is very ample, we look for all polynomials which have a simple pole at most when any of the three principal balances are substituted in them. Precisely, we look for a maximal independent set of functions which are independent when
restricted to $\mathbb{F}_{c}$. By direct computation, one finds the twenty-five (25) weight homogeneous polynomials of weight at most 13. These twenty-five (25) functions are defined by

The points $Q_{\epsilon_{1} \epsilon_{2}}, T$ are all distinct. We then deduce that $\varphi_{c}^{(2)}$ extends into an embedding of $\overline{\varphi_{c}^{(2)}}$. The curve $\mathcal{D}_{c}^{(2)}$ is therefore not singular. The singularities of the curves can be seen from the figure:

3.3.2. The quadratic differential equations and holomorphic. Now we want to show that the vector field $\left(\varphi_{c}\right)_{*} \mathcal{V}_{1}$ extends into a holomorphic vectors field on $\mathbb{P}^{24}$. This is done by exhibiting the quadratic differential equations in two of the charts. We will use the following

Lemma 3.7. [2 Let $\mathcal{X}$ be a vector field on $\mathbb{P}^{N}$ holomorphic in two different maps $\left(Z_{i} \neq 0\right)$ and $\left(Z_{j} \neq 0\right)$. Then $\mathcal{X}$ is holomorphic over $\mathbb{P}^{N}$. That is to say on any map $\left(Z_{j} \neq 0\right)$.

Proposition 3.8. The vector field $\left(\varphi_{c}\right)_{*} \mathcal{V}_{1}$ extends into a holomorphic vectors field on $\mathbb{P}^{24}$.

Proof. It suffices to show that the vector field $\left(\varphi_{c}\right)_{*} \mathcal{V}_{1}$ is holomorphic on two chart of $\mathbb{P}^{24}$. To do this, let us establish that this vector field can be written as a quadratic vector field in the chart $Z_{0} \neq 0$ and $Z_{1} \neq 0$. In the chart $Z_{0} \neq 0$, we obtain the following result

This shows that the vector field $\left(\varphi_{c}\right)_{*} \mathcal{V}_{1}$ extends into a linear vector field $\overline{\mathcal{V}}_{1}$ on $\mathbb{P}^{24}$.
Thus the item four of the complex Liouville theorem (theorem (2.15)) is satisfied. We now show that the integral curves of $\overline{\mathcal{V}}_{1}$ that start at the three singular points go into the affine immediately
Proposition 3.9. The flow $\Phi_{t}$ of the vector field $\overline{\mathcal{V}}_{1}$ on $\mathbb{P}^{24}$ coming from the points of $\mathcal{D}_{c}$ is sent into the affine part $\varphi_{c}\left(\mathbb{F}_{c}\right)$.

Proof. Note that this is automatic for the points of $\varphi_{c}\left(\boldsymbol{\Gamma}_{c}^{(0)}\right), \varphi_{c}\left(\boldsymbol{\Gamma}_{c}^{(1)}\right)$ and $\varphi_{c}\left(\boldsymbol{\Gamma}_{c}^{(2)}\right)$. We then just need to check for the singular points $Q_{\varepsilon_{1} \varepsilon_{2}}, P_{\varepsilon}$ and $T$ in $\mathbb{P}^{24}$.
Consider the 4 points $Q_{\varepsilon_{1} \varepsilon_{2}}$ intersections of $\mathcal{D}_{c}^{(0)}$ and $\mathcal{D}_{c}^{(2)}$. From (3.9) and (3.19) that the leading coefficient of $z_{4}\left(t ; \boldsymbol{\Gamma}_{c}^{(0)}\right)$ has a pole for $\varsigma=0$, that is maximal with the leading coefficient of $z_{9}\left(t ; \boldsymbol{\Gamma}_{c}^{(0)}\right)$ and thus the function $z_{4}$ defines a map at these points. Let us show then that $\lim _{p \rightarrow \infty_{\epsilon_{1} \epsilon_{2}}} \frac{1}{z_{4}} \varphi_{c}^{(0)} \neq 0$.

For the point $P_{\epsilon}$, intersection points of $\mathcal{D}_{c}^{(0)}$ and $\mathcal{D}_{c}^{(1)}$, the residue having the largest pole among the residues of $z_{0}\left(t ; \boldsymbol{\Gamma}_{c}^{(1)}\right), \cdots, z_{24}\left(t ; \boldsymbol{\Gamma}_{c}^{(1)}\right)$ is $z_{9}\left(t ; \boldsymbol{\Gamma}_{c}^{(1)}\right)$, the function $z_{15}$ defines a local chart around this point. Consider the balances $x\left(t ; m_{1}\right) 3.6$ and rewriting $a, b, c, d$ of $\frac{1}{z_{9}\left(t ; \boldsymbol{\Gamma}_{c}^{(1)}\right)}$ depending on the local parameter $\varsigma$ around $\infty_{\epsilon}$ using $c=\frac{1}{12} a^{2}-\frac{1}{24} c_{2}, e=\frac{c_{1}}{d^{2}}$ and (3.11) we obtain

For the point $T$, intersection point of $\mathcal{D}_{c}^{(2)}$ and $\mathcal{D}_{c}^{(1)}$, the only non-zero coordinate corresponds to the function $z_{17}\left(t ; \boldsymbol{\Gamma}_{c}^{(1)}\right)$, the function $z_{17}$ defines a local map around this point. Consider the
balances $x\left(t ; m_{1}\right)$ (3.61) and $x\left(t ; m_{2}\right)$ (3.7) by writing $a, c, d, e$ of $\frac{1}{z_{17}\left(t ; \Gamma_{c}^{(1)}\right)}$ depending on the local parameter $\varsigma$ around $\infty_{\epsilon}$ and using $c=\frac{1}{12} a^{2}-\frac{1}{24} c_{2}, e=\frac{c_{1}}{d^{2}}$ and (3.11) we get

Thus the different limits found are different from zero, which also shows that the integral curve of $\overline{\mathcal{V}}_{1}$ which starts from the points $T$ are immediately sent in the affine part $\varphi_{c}\left(\mathbb{F}_{c}\right)$.
Thus the flow of the vector field $\overline{\mathcal{V}}_{1}$ starting from each of the points of $\mathcal{D}_{c}^{(0)} \cup \mathcal{D}_{c}^{(1)} \cup \mathcal{D}_{c}^{(2)}$ goes into the affine part of $\varphi_{c}\left(\mathbb{F}_{c}\right)$.
In order to complete the proof of algebraic integrability, it is necessary to show that there exist no other divisors passing through the points $Q_{\epsilon_{1} \epsilon_{2}}, P_{\epsilon}$ and $T$.
For the four intersections points $Q_{\epsilon_{1} \epsilon_{2}}$ of $\mathcal{D}_{c}^{(0)}$ and $\mathcal{D}_{c}^{(2)}$, by rewriting the coefficients of the right hand side of (3.23) with respect to the local parameter $\varsigma$ in the neighborhood of the points $\infty_{\epsilon_{1} \epsilon_{2}} \in \bar{\Gamma}^{(0)} c$, we find:

For the points $P_{\epsilon}$ and $T$ of the divisor $\mathcal{D}_{c}$, obtained from the points at infinity $\infty_{\epsilon}, \infty_{1}$ and $\infty_{2}$, let's check that the degree of $\mathcal{D}_{c}$ which is 3 is indeed equal to the degree of $\overline{\varphi_{c}\left(\mathbb{F}_{c}\right)} \backslash \varphi_{c}\left(\mathbb{F}_{c}\right)$ at these points. As the vector field $\overline{\mathcal{V}}_{1}$ is only tangent to one of the branches (transverse to the other) of $\mathcal{D}_{c}^{1}$ passing through these two points, we do the expansion along the non-tangent branch. As the function $z_{17}$ defines a map at point $T$, we just need to substitute (3.11) into its inverse series:

For points $P_{\epsilon}$, we do this by calculating the first terms of the series $\frac{1}{z_{8}\left(t ; \Gamma_{c}^{(0)}\right)}$ using Laurent's solution $x\left(t ; m_{0}\right)$ then we express the free parameters according to the local parameter $\varsigma$ in a neighborhood of (3.8). The resulting series in $\varsigma$ and $t$ should start with monomials of degree 3 because the point $P_{\epsilon}$ has multiplicity 2 and 1 on the divisors $\mathcal{D}_{c}^{(0)}$ and $\mathcal{D}_{c}^{(1)}$ respectively and the function $z_{8}$ has a simple pole on each of these divisors. We have:

So there are no other divisors in $\overline{\varphi_{c}\left(\mathbb{F}_{c}\right)} \backslash \varphi_{c}\left(\mathbb{F}_{c}\right)$ besides the divisors $\mathcal{D}_{c}^{(0)}, \mathcal{D}_{c}^{(1))}$ and $\mathcal{D}_{c}^{(2)}$ already found.

The Liouville Complex theorem conditions being satisfied, it follows that for $c \in \Omega$, the projective variety $\overline{\varphi_{c}\left(\mathbb{F}_{c}\right)}=\varphi_{c}\left(\mathbb{F}_{c}\right) \cup \mathcal{D}_{c}$ is an abelian surface and the restrictions of vector fields $\overline{\mathcal{V}}_{1}$ and $\overline{\mathcal{V}}_{2}$ to these these Abelian surfaces are linear. Since $\overline{\varphi_{c}\left(\mathbb{F}_{c}\right)}$ contains a smooth curve of genus 2, it is the Jacobian of this curve. We have therefore proved the following theorem.
Theorem 3.10. Let $(\mathcal{H},\{\cdot, \cdot\}, \mathbf{F})$ be an integrable system describing the Toda lattice $a_{4}^{(2)}$ where $\mathbf{F}=\left(\mathbf{F}_{1}, \mathbf{F}_{2}, \mathbf{F}_{3}\right)$ and $\{\cdot, \cdot\}$ are given respectively by (3.3) and (3.2) with commuting vector fields (3.11).
i) $(\mathcal{H},\{\cdot, \cdot\}, \mathbf{F})$ is a weight homogeneous algebraical completely integrable system.
ii) For $c \in \Omega$, the fiber $\mathbb{F}_{c}$ of its momentum map is completed in an abelian surface $\mathbb{T}_{c}^{2}$ ( the Jacobian of the hyperelliptic curve (of genus two) $\overline{\Gamma_{c}^{(2)}}$ ) by the addition of a singular divisor $\mathcal{D}_{c}$ composed of three irreducible components: $\mathcal{D}_{c}^{(0)}$ defined by:

$$
\begin{aligned}
\Gamma_{c}^{(0)}: & 16 d^{2} a^{8}-\left(256 d^{3}+8 d^{2} c_{2}\right) a^{6}+\left(1536 d^{2}+96 d c_{2}+8 c_{3}+c_{2}^{2}\right) d^{2} a^{4} \\
& -\left(\left(8\left(8 c_{3}+48 d c_{2}+c_{2}^{2}+512 d^{2}\right) d+2 c_{2} c_{3}\right) d^{2}+64 c_{1}\right) a^{2} \\
& +\left(8 d\left(c_{2} c_{3}+16 d c_{3}+64 d^{2} c_{2}+512 d^{3}+2 d c_{2}^{2}\right)+c_{3}^{2}\right) d^{2}=0
\end{aligned}
$$

and $\mathcal{D}_{c}^{(1)}$ defined by:

$$
\Gamma_{c}^{(1)}: 256 a d^{3}-\left(\left(4 a^{2}-c_{2}\right)^{2}-16 c_{3}\right) d^{2}-+64 c_{1}=0
$$

two singular curves of respective genus 3 and 4 and one smooth curve and $\mathcal{D}_{c}^{(2)}$ defined by

$$
\Gamma_{c}^{(2)}: e^{4} a^{4}-\left(8 c_{1}+c_{2} e^{2}\right) a^{2} e^{2}-64 e^{5}+4 e^{2} c_{1} c_{2}+4 c_{3} e^{4}+16 c_{1}^{2}=0 .
$$

of genus 2 and isomorphic to $\overline{\Gamma_{c}^{(2)}}$. The curves intercept each other as indicated in figure 1.

## 4. Geometry of the $a_{4}^{(2)}$ Toda lattice: Holomorphic differentials forms.

Let us calculate the holomorphic differential forms $\omega_{1}$ and $\omega_{2}$ on the divisor $\mathcal{D}_{c}$ which come from the differentials $d t_{1}$ and $d t_{2}$ on the abelian surface $\mathbf{T}_{c}^{2}$.
Let $y_{0}:=z_{1}$ and $y:=z_{4}$ be restricted to $\mathcal{D}_{c}^{(0)}$, the first coefficients of their Laurent series are given by

$$
\begin{array}{ll}
y_{0}^{(0)}=-2 & y_{0}^{(1)}=2 c \\
y^{(0)}=2 a & y^{(1)}=-4 d
\end{array}
$$

and using (3.5) and (3.4), we have

$$
\mathcal{V}_{2}\left[\frac{1}{z_{1}}\right]_{\mid \mathcal{D}_{c}^{(0)}}=-2 a^{2}+8 d, \mathcal{V}_{2}\left[\frac{z_{4}}{z_{1}}\right]_{\mathcal{D}_{c}^{(0)}}=-4 e a-24 c d
$$

It then follows that

$$
\begin{aligned}
\delta & =\frac{1}{\left(y_{0}^{(0)}\right)^{2}}\left|\begin{array}{cc}
y_{0}^{(0)} & \mathcal{V}_{2}\left[\frac{1}{y_{0}}\right]_{\mid \mathcal{D}_{c}^{(0)}} \\
y_{0}^{(0)} y^{(1)}-y^{(0)} y_{0}^{(1)} & \mathcal{V}_{2}\left[\frac{z_{4}}{y_{0}}\right]_{\mid \mathcal{D}_{c}^{(0)}}
\end{array}\right| \\
& =\frac{1}{4}\left|\begin{array}{cc}
-2 & -2 a^{2}+8 d \\
8 d-4 a c & -4 e a-24 c d
\end{array}\right| \\
& =2 e a+12 c d+4 a^{2} d-2 a^{3} c-16 d^{2}+8 c a d
\end{aligned}
$$

The holomorphic differential forms $d t_{1}$ and $d t_{2}$ restricted to $\mathcal{D}_{c}^{(0)}$ are given by:

$$
\omega_{1}=\frac{1}{\delta y_{0}^{(0)}} d\left(\frac{y^{(0)}}{y_{0}^{(0)}}\right)=-\frac{d a}{\delta} \quad \text { and } \quad \omega_{2}=-\frac{1}{\delta} \mathcal{V}_{2}\left[\frac{1}{y_{0}}\right]_{\mid \mathcal{D}_{c}^{(0)}} d\left(\frac{y^{(0)}}{y_{0}^{(0)}}\right)=-\frac{2 a^{2}-8 d}{\delta} d a .
$$

To determing differential forms on the divisor $\mathcal{D}_{c}^{(1)}$, consider the functions $y_{0}:=z_{1}$ and $y:=z_{3}$, restricted to $\mathcal{D}_{c}^{(1)}$, the first coefficients of their Laurent series are given by

$$
\begin{array}{ll}
y_{0}^{(0)}=2 & y_{0}^{(1)}=a \\
y^{(0)}=-a & y^{(1)}=-3 c+\frac{a^{2}}{4}
\end{array}
$$

and using (3.6) and (3.4), we have
$\mathcal{V}_{2}\left[\frac{1}{z_{1}}\right]_{\mid \mathcal{D}_{c}^{(1)}}=-6 c-\frac{a^{2}}{2}, \mathcal{V}_{2}\left[\frac{z_{3}}{z_{1}}\right]_{\mid \mathcal{D}_{c}^{(1)}}=-2 e+4 a d+18 c^{2}-3 a^{2} c-\frac{3 a^{4}}{8}$.
then

$$
\begin{aligned}
\delta & =\frac{1}{\left(y_{0}^{(1)}\right)^{2}}\left|\begin{array}{cc}
y_{0}^{(0)} & \mathcal{V}_{2}\left[\frac{1}{y_{0}}\right]_{\mid \mathcal{D}_{c}^{(1)}} \\
y_{0}^{(0)} y^{(1)}-y^{(0)} y_{0}^{(1)} & \mathcal{V}_{2}\left[\frac{z_{3}}{y_{0}}\right]_{\mid \mathcal{D}_{c}^{(1)}}
\end{array}\right| \\
& =\frac{1}{4}\left|\begin{array}{cc}
2 & -6 c-\frac{a^{2}}{2} \\
-6 c+\frac{3 a^{2}}{2} & -2 e+4 a d+18 c^{2}-3 a^{2} c-\frac{3 a^{4}}{8}
\end{array}\right| \\
& =2 a d-e
\end{aligned}
$$

The holomorphic differential forms $d t_{1}$ and $d t_{2}$ restricted to $\mathcal{D}_{c}^{(1)}$ are given by:

$$
\omega_{1}=\frac{1}{\delta y_{0}^{(0)}} d\left(\frac{y^{(0)}}{y_{0}^{(0)}}\right)=-\frac{d a}{4 \delta} \quad \text { and } \quad \omega_{2}=-\frac{1}{\delta} \mathcal{V}_{2}\left[\frac{1}{y_{0}}\right]_{\mathcal{D}_{c}^{(1)}} d\left(\frac{y^{(0)}}{y_{0}^{(0)}}\right)=-\frac{a^{2}+12 c}{4 \delta} d a .
$$

For calculating differential forms on the divisor $\mathcal{D}_{c}^{(2)}$, consider the functions $y_{0}:=z_{2}$ and $y:=z_{4}$ restricted to $\mathcal{D}_{c}^{(2)}$, the first coefficients of their Laurent series are given by

$$
\begin{array}{ll}
y_{0}^{(0)}=-2 & y_{0}^{(1)}=2 d \\
y^{(0)}=-2 a & y^{(1)}=-4 c
\end{array}
$$

and using (3.7) and (3.4), we have

$$
\mathcal{V}_{2}\left[\frac{1}{z_{2}}\right]_{\mid \mathcal{D}_{c}^{(2)}}=2 c-\frac{a^{2}}{2}, \mathcal{V}_{2}\left[\frac{z_{4}}{z_{2}}\right]_{\mid \mathcal{D}_{c}^{(2)}}=16 e-96 c d .
$$

It then follows that

$$
\begin{aligned}
\delta & =\frac{1}{\left(y_{0}^{(1)}\right)^{2}}\left|\begin{array}{cc}
y_{0}^{(0)} & \mathcal{V}_{2}\left[\frac{1}{y_{0}}\right]_{\mid \mathcal{D}_{c}^{(2)}} \\
y_{0}^{(0)} y^{(1)}-y^{(0)} y_{0}^{(1)} & \mathcal{V}_{2}\left[\frac{z_{3}}{y_{0}}\right]_{\mid \mathcal{D}_{c}^{(2)}}
\end{array}\right| \\
& =\frac{1}{4}\left|\begin{array}{cc}
-2 & 2 c-\frac{a^{2}}{2} \\
8 c+4 a d & 16 e-96 c d
\end{array}\right| \\
& =48 c d-8 e+c a^{2}+\frac{a^{3} d}{2}-4 c^{2}-2 a c d
\end{aligned}
$$

The holomorphic differential forms $d t_{1}$ and $d t_{2}$ restricted to $\mathcal{D}_{c}^{(2)}$ are given by:

$$
\omega_{1}=\frac{1}{\delta y_{0}^{(0)}} d\left(\frac{y^{(0)}}{y_{0}^{(0)}}\right)=-\frac{d a}{2 \delta} \quad \text { et } \quad \omega_{2}=-\frac{1}{\delta} \mathcal{V}_{2}\left[\frac{1}{y_{0}}\right]_{\mathcal{D}_{c}^{(2)}} d\left(\frac{y^{(0)}}{y_{0}^{(0)}}\right)=-\frac{4 c-a^{2}}{2 \delta} d a
$$

The zero of differentials forms $\omega_{1}$ and $\omega_{2}$ gives the tangency points of fields vector $\mathcal{V}_{1}$ and $\mathcal{V}_{2}$ respectively.
