# HOPF ALGEBRAS, STEINBERG MODULES, AND THE UNSTABLE COHOMOLOGY OF $\mathrm{SL}_{n}(\mathbb{Z})$ AND $\mathrm{GL}_{n}(\mathbb{Z})$

#### Abstract

We prove that the direct sum of all homology groups of the integral general linear groups with Steinberg module coefficients form a commutative Hopf algebra, in particular a free graded commutative algebra. We use this to construct new infinite families of unstable cohomology classes of $\mathrm{SL}_{n}(\mathbb{Z})$.


## 1. Introduction

The goal of this paper is to prove a new structural result on the rational cohomology of general and special linear groups over the integers. Let $\mathrm{St}_{n} \mathbb{Q}$ denote the $n$th Steinberg module of the rationals (top degree reduced homology of the poset of subspaces of $\mathbb{Q}^{n}$ ) and det denote the determinant representation (unless stated otherwise, all homology will be taken with coefficients in a field of characteristic zero). By work of Borel-Serre [BS73] (see also Putman-Studenmund [PS22]), the twisted homology groups

H_{*}\left(\mathrm{GL}_{n} \mathbb{Z} ; \mathrm{St}_{n} \mathbb{Q}\right) \text { and } H_{*}\left(\mathrm{GL}_{n} \mathbb{Z} ; \mathrm{St}_{n} \mathbb{Q} \otimes \operatorname{det}\right)
$$

determine the cohomology of $\mathrm{SL}_{n}(\mathbb{Z})$ and $\mathrm{GL}_{n}(\mathbb{Z})$ :

$$
\begin{aligned}
& \cdot H^{\binom{n}{2}-k}\left(\mathrm{SL}_{n} \mathbb{Z}\right) \cong H_{k}\left(\mathrm{GL}_{n} \mathbb{Z} ; \mathrm{St}_{n} \mathbb{Q}\right) \oplus H_{k}\left(\mathrm{GL}_{n} \mathbb{Z} ; \mathrm{St}_{n} \mathbb{Q} \otimes \operatorname{det}\right) \text { for } n>0 \\
& \cdot H^{\binom{n}{2}-k}\left(\mathrm{GL}_{n} \mathbb{Z}\right) \cong H_{k}\left(\mathrm{GL}_{n} \mathbb{Z} ; \mathrm{St}_{n} \mathbb{Q}\right) \text { for } n \text { odd, } \\
& \cdot H^{\binom{n}{2}-k}\left(\mathrm{GL}_{n} \mathbb{Z}\right) \cong H_{k}\left(\mathrm{GL}_{n} \mathbb{Z} ; \mathrm{St}_{n} \mathbb{Q} \otimes \text { det }\right) \text { for } n \text { even. }
\end{aligned}
$$

There is a well-known equivariant product structure on the Steinberg modules (see e.g. [MNP20] and [MPW]). In particular, there is a $\mathrm{GL}_{n} \mathbb{Z} \times \mathrm{GL}_{m} \mathbb{Z}$-equivariant map

$$
\begin{equation*}
\mathrm{St}_{n} \mathbb{Q} \otimes \mathrm{St}_{m} \mathbb{Q} \longrightarrow \mathrm{St}_{n+m} \mathbb{Q} \tag{1}
\end{equation*}
$$

which induces ring structures on

$$
H:=\bigoplus_{k, n \geq 0} H_{k}\left(\mathrm{GL}_{n} \mathbb{Z} ; \mathrm{St}_{n} \mathbb{Q}\right) \quad \text { and } \quad H^{\mathrm{det}}:=\bigoplus_{k, n \geq 0} H_{k}\left(\mathrm{GL}_{n} \mathbb{Z} ; \mathrm{St}_{n} \mathbb{Q} \otimes \operatorname{det}\right)
$$

We define coproduct structures on these rings which make them into Hopf algebras.
Theorem A. $H$ and $H^{\text {det }}$ have the structure of graded commutative Hopf algebras.
Using a theorem of Leray, we deduce the following.
Corollary 1.1. $H$ and $H^{\text {det }}$ are free graded commutative algebras.
Our freeness result lets us easily produce new nonzero classes in the cohomology of $\mathrm{SL}_{n} \mathbb{Z}$ and $\mathrm{GL}_{n} \mathbb{Z}$ simply by multiplying classes that were previously known to be nonzero. Moreover, using elementary results on Hopf algebras, one can check algebraic independence of cohomology classes using the coproduct. We apply our theory to the so-called wheel classes. Brown-Schnetz [BS, Theorem 4(i)] showed that there are nonzero classes

w_{n} \in H_{n}\left(\mathrm{GL}_{n} \mathbb{Z} ; \mathrm{St}_{n} \mathbb{Q}\right) \cong H^{\binom{n}{2}-n}\left(\mathrm{GL}_{n} \mathbb{Z}\right) \subset H^{\binom{n}{2}-n}\left(\mathrm{SL}_{n} \mathbb{Z}\right)
$$

for every odd $n \geq 3$. For odd $n \geq 1$, let

$$
t_{n} \in H_{\binom{n}{2}}\left(\mathrm{GL}_{n} \mathbb{Z} ; \mathrm{St}_{n} \mathbb{Q}\right) \cong H^{0}\left(\mathrm{GL}_{n} \mathbb{Z}\right)
$$

be a generator of the one-dimensional vector space. (It turns out that $t_{3}$ and $w_{3}$ both generate the one-dimensional vector space $H_{3}\left(\mathrm{GL}_{3} \mathbb{Z} ; \mathrm{St}_{3} \mathbb{Q}\right)$.) And let, for even $n \geq 2$,

$$
t_{n} \in H_{\binom{n}{2}}\left(\mathrm{GL}_{n} \mathbb{Z} ; \mathrm{St}_{n} \mathbb{Q} \otimes \operatorname{det}\right) \cong H^{0}\left(\mathrm{GL}_{n} \mathbb{Z}\right)
$$

be a generator of the one-dimensional vector space.
Theorem B. The free graded commutative algebra

$$
\bigwedge\left[t_{1}, t_{5}, t_{9}, \ldots\right] \otimes \operatorname{Sym}\left[t_{7}, t_{11}, \ldots\right] \otimes \operatorname{Sym}\left[w_{3}, w_{5}, \ldots\right]
$$

embeds as an algebra into $H$ and the free graded commutative algebra

$$
\bigwedge\left[t_{2}, t_{6}, t_{10}, \ldots\right] \otimes \operatorname{Sym}\left[t_{4}, t_{8}, \ldots\right]
$$

embeds as an algebra into $H^{\text {det }}$.
The cohomology $H^{*}\left(\mathrm{SL}_{n}(\mathbb{Z})\right)$ has been completely computed for $n \leq 7$ (see [Sou10, Hor14, EVGS13]). Using Theorem B, we describe bases of the vector spaces $\overline{H^{k}}\left(\operatorname{SL}_{n}(\mathbb{Z})\right)$ for $n \leq 7$ in terms of the wheel classes, trivial classes, and the Borel classes $\sigma_{5} \in H^{5}\left(\mathrm{SL}_{6} \mathbb{Z}\right), \sigma_{5} \in H^{5}\left(\mathrm{SL}_{7} \mathbb{Z}\right)$, and $\sigma_{9} \in H^{9}\left(\mathrm{SL}_{7} \mathbb{Z}\right)$, which are known to be nonzero (see [Bor74, Fra08, GKT21, Bro]):

Remark 1.2. Ash [Ash] recently proved that $t_{1}$ and $w_{3}$ generates a free graded commutative algebra inside of $H$. His paper inspired this collaboration and our coproducts on $H$ and $H^{\text {det }}$ come from his product on cosharblies.
Remark 1.3. After a draft of this paper had been circulated, we learned of a forthcoming paper by F. Brown, M. Chan, S. Galatius, and S. Payne where they independently constructed a commutative Hopf algebra structure on $H$ and use it to deduce many properties of the cohomology of $\mathrm{SL}_{n}(\mathbb{Z})$.
Remark 1.4. The bialgebra structure on $H$ is the shadow of a bialgebra structure on the Steinberg modules themselves. Steinberg modules assemble to form a representation of the groupoid $\bigsqcup_{n} \mathrm{GL}_{n}(\mathbb{Z})$. This category of representations carries two monoidal structures, one often called the Day convolution product considered for example in [MNP20] and one based on parabolic induction considered for example by Nagpal [Nag19]. These monoidal structures are compatible in the sense that they form a duoidal category. The Steinberg modules form an algebra with respect to the first product, a coalgebra with respect to the second product, and bialgebra in a duoidal sense. For the definitions of a duoidal category and a bialgebra therein, see Böhm-Chen-Zhang [BCZ13]. To keep this paper less abstract, we will only work with classical Hopf algebras. However, we plan to revisit these ideas to study the unstable cohomology of congruence subgroups.
Remark 1.5. Free rings are determined by their indecomposables so it is natural to ask for a description of the indecomposables of $H$. It follows from [MPW, Remark 1.6] that these indecomposables are isomorphic to the reduced equivariant homology of Rognes' common basis complex [Rog92].

## 2. A differential graded bialgebra that computes Steinberg homology

Let $R$ be a PID and let $F$ be its field of fractions. Further, let $K$ be our coefficient ring, a field of characteristic zero.

The Tits building of $F^{n}$ denoted by $\mathcal{T}_{n}(F)$ is the simplicial complex whose vertices are nonzero proper subspaces $0 \subsetneq V \subsetneq F^{n}$ and $\left\{V_{0}, \ldots, V_{p}\right\}$ is a simplex if

$$
V_{0} \subset \cdots \subset V_{p}
$$

The Solomon-Tits Theorem [Sol69] implies that $\mathcal{T}_{n}(F)$ is a wedge of $(n-2)$-dimensional spheres and its only nonzero reduced homology group is called the Steinberg module

$$
\operatorname{St}_{n}(F):=\tilde{H}_{n-2}\left(\mathcal{T}_{n}(F) ; K\right)
$$

By convention, we define $\mathrm{St}_{0}(F)$ to be $K$.
Lee-Szczarba [LS76] gave a flat $K \mathrm{GL}_{n}(R)$-resolution of $\mathrm{St}_{n}(F)$. We use a slight variant of it here, which can be established with the same proof. See also Ash-Gunnells-McConnell [AGM12]. Let $V_{n}$ be the set of all nonzero vectors in $R^{n} \subset F^{n}$ and $V_{n}^{ \pm}$be the quotient of $V_{n}$ identifying negatives. By abuse of notation, we denote an element of $V_{n}^{ \pm}$simply by its representative $v \in R^{n}$. Let $X_{n}$ be the simplicial complex whose vertices are the elements of $V_{n}^{ \pm}$and all (finite) sets of vertices are simplices. Let $L_{n}$ the subcomplex of all simplices $\left\{v_{0}, \ldots, v_{p}\right\}$ such that the $F$-span of $v_{0}, \ldots, v_{p}$ is not all of $F^{n}$. Clearly, $X_{n}$ is contractible and using Lee-Szczarba's argument it follows that $L_{n}$ is homotopy equivalent to $\mathcal{T}_{n}(F)$, which implies that

$$
H_{i}\left(X_{n}, L_{n} ; K\right) \cong \tilde{H}_{i-1}\left(L_{n} ; K\right) \cong \begin{cases}\mathrm{St}_{n}(F) & i=n-1 \\ 0 & i \neq n-1\end{cases}
$$

Because $C_{i}\left(X_{n}, L_{n} ; K\right)=0$ for $i<n-1$, we get an exact sequence

$$
\cdots \longrightarrow C_{n}\left(X_{n}, L_{n} ; K\right) \longrightarrow C_{n-1}\left(X_{n}, L_{n} ; K\right) \longrightarrow \operatorname{St}_{n}(F) \longrightarrow 0
$$

[CP17, Lemma 3.2] implies that $C_{i}\left(X_{n}, L_{n} ; K\right)$ is a flat $K \mathrm{GL}_{n}(R)$-module.

We will use the notation

$$
\mathrm{Sh}_{n, k}=C_{n+k-1}\left(X_{n}, L_{n} ; K\right)
$$

and refer to $\mathrm{Sh}_{n, *} \rightarrow \mathrm{St}_{n}(F)$ as the Sharbly resolution of $\mathrm{St}_{n}(F)$. Given nonzero vectors $v_{1}, \ldots, v_{n+k} \in R^{n}$, we get a canonical element

$$
\left[v_{1}, \ldots, v_{n+k}\right] \in \mathrm{Sh}_{n, k}
$$

given by the corresponding simplex $\left\{v_{1}, \ldots, v_{n+k}\right\}$ in $X_{n}$. These elements are nonzero if and only if the $F$-span of $v_{1}, \ldots, v_{n+k}$ is $F^{n}$. We call such an element then a basic sharbly.

Let $\chi: R^{\times} \rightarrow K^{\times}$be a character (i.e. a group homomorphism), which we will view as a onedimensional $K \mathrm{GL}_{n}(R)$-module that factors through the determinant. We will use the notation

$$
\left[v_{1}, \ldots, v_{n+k}\right]^{\chi}:=\left[v_{1}, \ldots, v_{n+k}\right] \otimes 1 \in \operatorname{Sh}_{n, k}^{\chi}:=\operatorname{Sh}_{n, k} \otimes_{K} \chi
$$

We will further consider the $\mathrm{GL}_{n}(R)$-coinvariants of $\mathrm{Sh}_{n, k}^{\chi}$ and call its elements coinvariant sharblies. In particular, we will denote the image of a basic sharbly $\left[v_{1}, \ldots, v_{n+k}\right]^{\chi} \in \mathrm{Sh}_{n, k}^{\chi}$ by

$$
\left[v_{1}, \ldots, v_{n+k}\right]_{\mathrm{GL}_{n}(R)}^{\chi} \in\left(\mathrm{Sh}_{n, k}^{\chi}\right)_{\mathrm{GL}_{n}(R)}
$$

and call it a basic coinvariant sharbly. Because $\mathrm{GL}_{n}(R)$ acts on the set of all basic sharblies, which up to signs ${ }^{1}$ form a basis of $\mathrm{Sh}_{n, k}^{\chi}$, the set of nonzero basic coinvariant sharblies form a basis up to signs.

Let us denote by

$$
B_{n, k}^{\chi}:=\left(\mathrm{Sh}_{n, k}^{\chi}\right)_{\mathrm{GL}_{n}(R)} \quad \text { and } \quad B_{m}^{\chi}:=\bigoplus_{n+k=m} B_{n, k}^{\chi}
$$

the coinvariants of the sharblies and by

$$
B^{\chi}:=\bigoplus_{m \geq 0} B_{m}^{\chi}=\bigoplus_{n, k \geq 0} B_{n, k}^{\chi}
$$

the (bi-)graded vector space of all coinvariant sharblies. It comes with a differential

$$
\begin{aligned}
\partial: B_{n, k}^{\chi}=\left(\operatorname{Sh}_{n, k}^{\chi}\right)_{\mathrm{GL}_{n}(R)} & \longrightarrow\left(\operatorname{Sh}_{n, k-1}^{\chi}\right)_{\mathrm{GL}_{n}(R)}=B_{n, k-1}^{\chi} \\
\quad\left[v_{1}, \ldots, v_{n+k}\right]_{\mathrm{GL}_{n}(R)}^{\chi} & \longmapsto \sum_{i=1}^{n+k}(-1)^{i}\left[v_{1}, \ldots, \hat{v}_{i}, \ldots, v_{n+k}\right]_{\mathrm{GL}_{n}(R)}^{\chi}
\end{aligned}
$$

of degree -1 , such that its homology is

$$
H\left(B^{\chi}\right)_{n, k} \cong H_{k}\left(\operatorname{GL}_{n}(R) ; \operatorname{St}_{n}(F) \otimes_{K} \chi\right)
$$

Definition 2.1. We define

$$
\nabla: B_{n, k}^{\chi} \otimes B_{m, l}^{\chi} \longrightarrow B_{n+m, k+l}^{\chi}
$$

by sending a tensor product of basic coinvariant sharblies $x=\left[v_{1}, \ldots, v_{n+k}\right]_{\mathrm{GL}_{n}(R)}^{\chi}$ and $y=$ $\left[w_{1}, \ldots, w_{m+l}\right]_{\mathrm{GL}_{m}(R)}^{\chi}$ to

$$
\nabla(x \otimes y)=x y=\left[\phi_{n, n+m}\left(v_{1}\right), \ldots, \phi_{n, n+m}\left(v_{n+k}\right), \psi_{m, n+m}\left(w_{1}\right), \ldots, \psi_{m, n+m}\left(w_{m+l}\right)\right]_{\mathrm{GL}_{n+m}(R)}^{\chi},
$$

where $\phi_{n, n+m}: R^{n} \rightarrow R^{n+m}$ sends the standard basis vector $e_{i} \in R^{n}$ to $e_{i} \in R^{n+m}$ and $\psi_{m, n+m}: R^{m} \rightarrow R^{n+m}$ sends $e_{i} \in R^{m}$ to $e_{n+i} \in R^{n+m}$.

The following lemma is easy to check.
Lemma 2.2. $\nabla: B^{\chi} \otimes B^{\chi} \rightarrow B^{\chi}$ defines a (bi-)graded algebra.
We call $\chi: R^{\times} \rightarrow K^{\times}$odd if $\chi(-1)=-1$ and even if $\chi(-1)=1$.
Lemma 2.3. If $\chi$ is odd and $n$ is odd, then $B_{n, k}^{\chi}=0$.
Proof. Let $x=\left[v_{1}, \ldots, v_{n+k}\right]^{\chi}$ be a basic sharbly in $\operatorname{Sh}_{n, k}^{\chi}$. Then

$$
(-\mathrm{id}) \cdot x=\chi(-1)^{n} \cdot\left[-v_{1}, \ldots,-v_{n+k}\right]^{\chi}=-\left[v_{1}, \ldots, v_{n+k}\right]^{\chi}=-x
$$

and thus vanishes in the coinvariants $B_{n, k}^{\chi}$.

[^0]Lemma 2.4. $B^{\chi}$ is graded commutative, i.e. for $x \in B_{n, k}^{\chi}$ and $y \in B_{m, l}^{\chi}$, we get

$$
x y=(-1)^{(n+k)(m+l)} y x .
$$

Proof. Let $x=\left[v_{1}, \ldots, v_{n+k}\right]_{\mathrm{GL}_{n}(R)}^{\chi}$ and $y=\left[w_{1}, \ldots, w_{m+l}\right]_{\mathrm{GL}_{m}(R)}^{\chi}$ be basic coinvariant sharblies. We observe that

$$
\begin{aligned}
& x y=\left[\phi_{n, n+m}\left(v_{1}\right), \ldots, \phi_{n, n+m}\left(v_{n+k}\right), \psi_{m, n+m}\left(w_{1}\right), \ldots, \psi_{m, n+m}\left(w_{m+l}\right)\right]_{\mathrm{GL}_{n+m}(R)}^{\chi} \\
= & (-1)^{(n+k)(m+l)}\left[\psi_{m, n+m}\left(w_{1}\right), \ldots, \psi_{m, n+m}\left(w_{m+l}\right), \phi_{n, n+m}\left(v_{1}\right), \ldots, \phi_{n, n+m}\left(v_{n+k}\right)\right]_{\mathrm{GL}_{n+m}(R)}^{\chi}
\end{aligned}
$$

Let $T_{n, m}$ be the permutation matrix sending $e_{i}$ to $e_{m+i}$ if $i \leq n$ and to $e_{i-n}$ if $i>n$. We can use $T_{n, m} \in \mathrm{GL}_{n+m}(R)$ to swap $\phi$ and $\psi$ in the sense that

$$
T_{n, m} \phi_{n, n+m}=\psi_{n, n+m} \quad \text { and } \quad T_{n, m} \psi_{m, n+m}=\phi_{m, n+m}
$$

The determinant of $T_{n, m}$ is $(-1)^{n m}$, so in particular 1 if $n$ or $m$ are even. We then get that

$$
\begin{aligned}
& {\left[\psi_{m, n+m}\left(w_{1}\right), \ldots, \psi_{m, n+m}\left(w_{m+l}\right), \phi_{n, n+m}\left(v_{1}\right), \ldots, \phi_{n, n+m}\left(v_{n+k}\right)\right]_{\mathrm{GL}_{n+m}(R)}^{\chi}} \\
& =T_{n, m} \chi(-1)^{n m}\left[\phi_{m, n+m}\left(w_{1}\right), \ldots, \phi_{m, n+m}\left(w_{m+l}\right), \psi_{n, n+m}\left(v_{1}\right), \ldots, \psi_{n, n+m}\left(v_{n+k}\right)\right]_{\mathrm{GL}_{n+m}(R)}^{\chi} \\
& =T_{n, m} \chi(-1)^{n m} y x .
\end{aligned}
$$

Therefore

$$
x y=(-1)^{(n+k)(m+l)} \cdot \chi(-1)^{n m} \cdot y x
$$

in the coinvariants $B_{n+m, k+l}^{\chi}$. The factor $\chi(-1)^{n m}$ is of course 1 if $\chi(-1)=1$, and it is also 1 if $\chi(-1)=-1$ because then $n m$ is even or $x y=y x=0$.

Lemma 2.5. $B^{\chi}$ together with the differential $\partial$ is a differential graded algebra.
Proof. Given basic coinvariant sharblies $x=\left[v_{1}, \ldots, v_{n+k}\right]_{\mathrm{GL}_{n}(R)}^{\chi}$ and $y=\left[w_{1}, \ldots, w_{m+l}\right]_{\mathrm{GL}_{m}(R)}^{\chi}$, we need to prove that

$$
\partial(x y)=(\partial x) y+(-1)^{n+k} x(\partial y)
$$

This follows as

$$
\begin{aligned}
& \partial(x y) \\
&= \sum_{i=1}^{n+k}(-1)^{i}\left[\phi_{n, n+m}\left(v_{1}\right), \ldots, \phi_{n, n+m}\left(v_{i}\right), \ldots, \phi_{n, n+m}\left(v_{n+k}\right), \psi_{m, n+m}\left(w_{1}\right), \ldots, \psi_{m, n+m}\left(w_{m+l}\right)\right]_{\mathrm{GL}_{n+m}(R)}^{\chi} \\
&+(-1)^{n+k} \sum_{i=1}^{m+l}(-1)^{i}\left[\phi_{n, n+m}\left(v_{1}\right), \ldots, \phi_{n, n+m}\left(v_{n+k}\right), \psi_{m, n+m}\left(w_{1}\right), \ldots, \psi_{m, n+m}\left(w_{i}\right), \ldots, \psi_{m, n+m}\left(w_{m+l}\right)\right]_{\mathrm{GL}_{n+m}(R)}^{\chi} \\
&=(\partial x) y+(-1)^{n+k} x(\partial y) .
\end{aligned}
$$

We now want to describe the coalgebra structure on $B^{\chi}$. We will actually first describe it before taking coinvariants.

Definition 2.6. Let $U$ be an $a$-dimensional subspace of $F^{n}$. Let $X(U)$ be the simplicial complex whose vertices are

$$
V^{ \pm}(U):=\left\{v \in V_{n}^{ \pm} \mid v \in U\right\}
$$

and every finite subset forms a face. Let $L(U)$ the subcomplex of $X(U)$ of all simplices $\left\{v_{0}, \ldots, v_{p}\right\}$ such that the $F$-span of $v_{0}, \ldots, v_{p}$ is not all of $U$. We define

$$
\operatorname{Sh}_{s}^{\chi}(U):=C_{a+s-1}(X(U), L(U) ; K) .
$$

Note that a basis of the free $R$-module $U \cap R^{n}$ gives an isomorphism $\operatorname{Sh}_{*}^{\chi}(U) \cong \operatorname{Sh}_{a, *}^{\chi}$ of chain complexes.

Further, let $W$ be a $b$-dimensional subspace of $U$. We define $\operatorname{Sh}_{s}^{\chi}(U / W)$ as the quotient of $\operatorname{Sh}_{s-b}^{\chi}(U)$ by identifying basic sharblies $\left[v_{1}, \ldots, v_{a+(s-b)}\right]^{\chi}$ and $\left[w_{1}, \ldots, w_{a+(s-b)}\right]^{\chi}$ in $\operatorname{Sh}_{s-b}^{\chi}(U)$ if $v_{i}-w_{i} \in W$ for all $i$. We also identify a basic sharbly $\left[v_{1}, \ldots, v_{a+(s-b)}\right]^{\chi}$ with zero if $v_{i} \in W$ for some $i$ or if $v_{i}-v_{j} \in W$ for some $i \neq j$. Note that a basis of the free $R$-module $\left(U \cap R^{n}\right) /\left(W \cap R^{n}\right)$ gives an isomorphism $\operatorname{Sh}_{*}^{\chi}(U / W) \cong \operatorname{Sh}_{a-b, *}^{\chi}$ of chain complexes.

Definition 2.7. Let $W \subseteq U \subseteq F^{n}$ be subspaces of $F^{n}$. We define a map

$$
\Delta: \operatorname{Sh}_{k}^{\chi}(U / W) \longrightarrow \bigoplus_{\substack{W \subseteq V \subseteq U \\ p+q=k}} \operatorname{Sh}_{p}^{\chi}(V / W) \otimes \operatorname{Sh}_{q}^{\chi}(U / V)
$$

in the following way.
Let $x=\left[v_{1}, \ldots, v_{\operatorname{dim} U-\operatorname{dim} W+k}\right]^{\chi} \in \operatorname{Sh}_{k}^{\chi}(U / W)$ be a basic sharbly. We define $\mathcal{U}_{x}$ to be the set of subspaces $V \subseteq U$ that are spanned by $W$ and a subset of $\left\{v_{1}, \ldots, v_{\operatorname{dim} U-\operatorname{dim} W+k}\right\}$. ( $W$ and $U$ are necessarily included in $\mathcal{U}_{x}$.) Let $[m]$ denote the set $\{1, \ldots, m\}$. For $V \in \mathcal{U}_{x}$, let

$$
S(V)=\left\{i \in[\operatorname{dim} U-\operatorname{dim} W+k] \mid v_{i} \in V\right\} .
$$

Let $s_{1}<\cdots<s_{\operatorname{dim} V-\operatorname{dim} W+p}$ be the elements of $S(V)$ and $t_{1}<\cdots<t_{\operatorname{dim} U-\operatorname{dim} V+q}$ the elements of $[a+k] \backslash S(V)$.

We set

$$
x_{V}^{\prime}=\left[v_{s_{1}}, \ldots, v_{s_{\operatorname{dim} V-\operatorname{dim} W+p}}\right]^{\chi} \in \operatorname{Sh}_{p}^{\chi}(V / W)
$$

and

$$
x_{V}^{\prime \prime}=\left[v_{t_{1}}, \ldots, v_{t_{\operatorname{dim} U-\operatorname{dim} V+q}}\right]^{\chi} \in \operatorname{Sh}_{q}^{\chi}(U / V) .
$$

We define

$$
\Delta(x)=\sum_{V \in \mathcal{U}_{x}}(-1)^{\pi_{V / W \subset U / W}} x_{V}^{\prime} \otimes x_{V}^{\prime \prime}
$$

where $\pi_{V / W \subset U / W}$ is the shuffle permutation sending $i$ to $s_{i}$ if $i \leq \operatorname{dim} V-\operatorname{dim} W+p$ and to $t_{i-\operatorname{dim} W-p}$ if $i>\operatorname{dim} V-\operatorname{dim} W+p$. If $U=F^{n}$ and $W=0$, we will sometimes simply write $\pi_{V}$ for $\pi_{V / W \subset F^{n} / W}$.
Lemma 2.8. The map

$$
\Delta: \operatorname{Sh}_{n, k}^{\chi} \longrightarrow \bigoplus_{\substack{U \subset F^{n} \\ p+q=k}} \operatorname{Sh}_{p}^{\chi}(U) \otimes \operatorname{Sh}_{q}^{\chi}\left(F^{n} / U\right)
$$

is $\mathrm{GL}_{n}(R)$-equivariant and the $\mathrm{GL}_{n}(R)$-coinvariants of it give a map

$$
\Delta: B_{n, k}^{\chi} \longrightarrow \bigoplus_{\substack{a+b=n \\ p+q=k}} B_{a, p}^{\chi} \otimes B_{b, q}^{\chi}
$$

Proof. For the equivariance it is important to note that $\mathrm{GL}_{n}(R)$ permutes the summands by acting on the set of subspaces $U \subset F^{n}$.

The coinvariants on the left are $B_{n, k}^{\chi}$ by definition. On the right, we first note that $\mathrm{GL}_{n}(R)$ acts transitively on the set of $a$-dimensional $U \subset F^{n}$. (Here we use that $R$ is a PID.) Let $P_{a, b}$ denote the stabilizer of $F^{a} \subset F^{n}$ in $\mathrm{GL}_{n}(R)$, where $b=n-a$.

There is a canonical isomorphism of $\operatorname{Sh}_{p}^{\chi}\left(F^{a}\right) \rightarrow \operatorname{Sh}_{a, p}^{\chi}$. There is also a canonical isomorphism of $\operatorname{Sh}_{q}^{\chi}\left(F^{n} / F^{a}\right) \rightarrow \operatorname{Sh}_{b, q}^{\chi}$ by only recording the last $q$ coordinates of the representatives of vectors. $P_{a, b}$ acts on

$$
\operatorname{Sh}_{p}^{\chi}\left(F^{a}\right) \otimes \operatorname{Sh}_{q}^{\chi}\left(F^{n} / F^{a}\right) \cong \operatorname{Sh}_{a, p}^{\chi} \otimes \operatorname{Sh}_{b, q}^{\chi}
$$

via the projection onto its Levi factor: $P_{a, b} \rightarrow \mathrm{GL}_{a}(R) \times \mathrm{GL}_{b}(R)$. And that means that the coinvariants on the right-hand-side are isomorphic to

$$
\bigoplus_{\substack{a+b=n \\ p+q=k}} B_{a, p}^{\chi} \otimes B_{b, q}^{\chi} .
$$

We get that $B^{\chi}$ is a coalgebra by the following lemma.
Lemma 2.9. $\Delta: B^{\chi} \rightarrow B^{\chi} \otimes B^{\chi}$ defines a (bi-)graded coalgebra.
Proof. We will only check coassociativity here and leave all other properties to the reader. In fact, we check coassociativity before taking coinvariants.

Let $x=\left[v_{1}, \ldots, v_{n+k}\right]^{\chi} \in \mathrm{Sh}_{n, k}^{\chi}$ a basic sharbly. We compute that

$$
(\Delta \otimes \mathrm{id}) \circ \Delta(x)=\sum_{\substack{W, U \in \mathcal{U}_{x} \\ W \subseteq U}}(-1)^{\pi_{U \subset F^{n}}}\left((-1)^{\pi_{W \subset U}}\left(x_{U}^{\prime}\right)_{W}^{\prime} \otimes\left(x_{U}^{\prime}\right)_{W}^{\prime \prime}\right) \otimes x_{U}^{\prime \prime}
$$

where $\left(x_{U}^{\prime}\right)_{W}^{\prime} \in \operatorname{Sh}_{a}^{\chi}(W),\left(x_{U}^{\prime}\right)_{W}^{\prime \prime} \in \operatorname{Sh}_{b}^{\chi}(U / W)$, and $x_{U}^{\prime \prime} \in \operatorname{Sh}_{c}^{\chi}\left(F^{n} / U\right)$ for corresponding $a+b+$ $c=k$.

We also compute that

$$
(\operatorname{id} \otimes \Delta) \circ \Delta(x)=\sum_{\substack{W, U \in \mathcal{U}_{x} \\ W \subseteq U}}(-1)^{\pi_{W \subset F^{n}}} x_{W}^{\prime} \otimes\left((-1)^{\pi_{U / W \subset F^{n} / W}}\left(x_{W}^{\prime \prime}\right)_{U / W}^{\prime} \otimes\left(x_{W}^{\prime \prime}\right)_{U / W}^{\prime \prime}\right)
$$

where $x_{W}^{\prime} \in \operatorname{Sh}_{a}^{\chi}(W),\left(x_{W}^{\prime \prime}\right)_{U}^{\prime} \in \operatorname{Sh}_{b}^{\chi}(U / W)$, and $\left(x_{W}^{\prime \prime}\right)_{U}^{\prime \prime} \in \operatorname{Sh}_{c}^{\chi}\left(F^{n} / U\right)$ for corresponding $a+b+$ $c=k$.

It is now easy to see that

$$
\left(x_{U}^{\prime}\right)_{W}^{\prime}=x_{W}^{\prime}, \quad\left(x_{U}^{\prime}\right)_{W}^{\prime \prime}=\left(x_{W}^{\prime \prime}\right)_{U}^{\prime}, \quad x_{U}^{\prime \prime}=\left(x_{W}^{\prime \prime}\right)_{U}^{\prime \prime}, \text { and } \quad \pi_{W \subset U} \circ \pi_{U \subset F^{n}}=\pi_{U / W \subset F^{n} / W} \circ \pi_{W \subset F^{n}}
$$

Let us check that it behaves well with the differential.
Lemma 2.10. $B^{\chi}$ together with the differential $\partial$ is a differential graded coalgebra.
Proof. Given a basic sharbly $x=\left[v_{1}, \ldots, v_{n+k}\right]^{\chi} \in \mathrm{Sh}_{n, k}^{\chi}$, we need to check that

$$
\Delta(\partial x)=\sum_{U \in \mathcal{U}_{x}}(-1)^{\pi_{U}}\left(\partial x_{U}^{\prime} \otimes x_{U}^{\prime \prime}+(-1)^{|S(U)|} x_{U}^{\prime} \otimes \partial x_{U}^{\prime \prime}\right)
$$

We want to show that both sides of this equation are equal to the sum

$$
\sum_{\substack{U \in \mathcal{U}_{x} \\ i \in[n+k]}}(-1)^{\pi_{U}} \cdot(-1)^{\pi_{U}^{-1}(i)} d_{i}\left(x_{U}^{\prime} \otimes x_{U}^{\prime \prime}\right)
$$

where $d_{i}$ omits the vector $v_{i}$ from $x_{U}^{\prime}$ if $v_{i} \in U$ and from $x_{U}^{\prime \prime}$ if $v_{i} \notin U$.
On the right-hand-side, we can index the summands by $U \in \mathcal{U}_{x}$ and the $v_{i}$ that is being omitted. As for the sign, note that $\pi_{U}^{-1}(i)$ is the position of $v_{i}$ in $x_{U}^{\prime}$ if $v_{i} \in U$ and the position of $v_{i}$ in $x_{U}^{\prime \prime}$ plus $|S(U)|$ if $v_{i} \notin U$.

For the left-hand-side, let us compute $\Delta\left(x_{i}\right)$ for every

$$
x_{i}=\left[v_{1}, \ldots, \hat{v}_{i}, \ldots, v_{n+k}\right]^{\chi}
$$

This is

$$
\Delta\left(x_{i}\right)=\sum_{U \in \mathcal{U}_{x_{i}}}(-1)^{\pi_{U, i}}\left(x_{i}^{\prime}\right)_{U} \otimes\left(x_{i}^{\prime \prime}\right)_{U}
$$

where $\pi_{U, i}$ is the shuffle permutation obtained from $\pi_{U}$ by removing the strand that comes from $i$. That means we get a summand $d_{i}\left(x_{U}^{\prime} \otimes x_{U}^{\prime \prime}\right)$ for every pair $(U, i)$ such that $U \in \mathcal{U}_{x_{i}}$. For these summands, the sign of $\pi_{U, i}$ is equal to $(-1)^{\left|i-\pi_{U}^{-1}(i)\right|}$.

We finish the proof by observing that if $U \in \mathcal{U}_{x} \backslash \mathcal{U}_{x_{i}}$, then $d_{i}\left(x_{U}^{\prime} \otimes x_{U}^{\prime \prime}\right)=0$. This follows because then $v_{i} \in U$ and the vectors $v_{s}$ with $s \in S(U) \backslash\{i\}$ do not span $U$ without $v_{i}$.

We conclude this section by proving that the product and the coproduct are compatible.
Lemma 2.11. The diagram

$$
\begin{gathered}
B^{\chi} \otimes B^{\chi} \xrightarrow{\nabla} B^{\chi} \xrightarrow{\Delta} B^{\chi} \otimes B^{\chi} \\
\Delta \otimes \Delta \downarrow \\
B^{\chi} \otimes B^{\chi} \otimes B^{\chi} \otimes B^{\chi} \xrightarrow{\text { id } \otimes \tau \otimes \mathrm{id}} \longrightarrow B^{\chi} \otimes B^{\chi} \otimes B^{\chi} \otimes B^{\chi}
\end{gathered}
$$

commutes. Here $\tau: B_{n}^{\chi} \otimes B_{m}^{\chi} \rightarrow B_{m}^{\chi} \otimes B_{n}^{\chi}$ is given by

$$
\tau(x \otimes y)=(-1)^{n m}(y \otimes x)
$$

Proof. We evaluate both paths on $x \otimes y$ for basic sharblies $x=\left[v_{1}, \ldots, v_{n+k}\right]^{\chi} \in \operatorname{Sh}_{n, k}^{\chi}$ and $y=\left[w_{1}, \ldots, w_{m+l}\right]^{\chi} \in \operatorname{Sh}_{m, l}^{\chi}$.

For the lower path we get that $x \otimes y$ is sent to

$$
\sum_{\substack{U \in \mathcal{U}_{x} \\ V \in \mathcal{U}_{y}}}(-1)^{p q}(-1)^{\pi_{U}}(-1)^{\pi_{V}} x_{U}^{\prime} y_{V}^{\prime} \otimes x_{U}^{\prime \prime} y_{V}^{\prime \prime}
$$

where $p$ is the number of vectors in $x_{U}^{\prime \prime}$ and $q$ the number of vectors in $y_{V}^{\prime}$. We note that we consider the product $x_{U}^{\prime} y_{V}^{\prime}$ to be in

$$
\operatorname{Sh}_{a+c}^{\chi}(\phi(U) \oplus \psi(V)) \subset \operatorname{Sh}_{n+m, a+c}^{\chi}
$$

where $a=|S(U)|-\operatorname{dim} U$ and $c=|S(V)|-\operatorname{dim} V$. And we consider the product $x_{U}^{\prime \prime} y_{V}^{\prime \prime}$ to be in the quotient

$$
\operatorname{Sh}_{b+d}^{\chi}\left(F^{n+m} /(\phi(U) \oplus \psi(V))\right)
$$

of $\mathrm{Sh}_{n+m, b+d}^{\chi}$, where $b=k-a$ and $d=l-c$.
For the upper path, we get that $x \otimes y$ is sent to

$$
\sum_{W \in \mathcal{U}_{x y}}(-1)^{\pi_{W}}(x y)_{W}^{\prime} \otimes(x y)_{W}^{\prime \prime}
$$

To see that these two sums are the same, we first observe that every $W \in \mathcal{U}_{x y}$ uniquely decomposes into a direct sum $\phi(U) \oplus \psi(V)=W$ for pairs $(U, V) \in \mathcal{U}_{x} \times \mathcal{U}_{y}$.

It remains to show that the corresponding summands agree. For this note that

$$
(x y)_{W}^{\prime}=\left[\phi\left(v_{s_{1}}\right), \ldots, \phi\left(v_{s_{\operatorname{dim} U+a}}\right), \psi\left(w_{\eta_{1}}\right), \ldots, \psi\left(w_{\eta_{\operatorname{dim} V+c}}\right)\right] \in \operatorname{Sh}_{a+c}^{\chi}(W)
$$

where $S(U)=\left\{s_{1}<\cdots<s_{\operatorname{dim} U+a}\right\}$ and $S(V)=\left\{\eta_{1}<\cdots<\eta_{\operatorname{dim} V+b}\right\}$ which is the same as

$$
x_{U}^{\prime} y_{V}^{\prime}=\left[\phi\left(v_{s_{1}}\right), \ldots, \phi\left(v_{s_{\operatorname{dim} U+a}}\right), \psi\left(w_{\eta_{1}}\right), \ldots, \psi\left(w_{\eta_{\operatorname{dim} V+c}}\right)\right] \in \operatorname{Sh}_{a+c}^{\chi}(\phi(U) \oplus \psi(V)) .
$$

And

$$
(x y)_{W}^{\prime \prime}=\left[\phi\left(v_{t_{1}}\right), \ldots, \phi\left(v_{t_{n-\operatorname{dim} U+b}}\right), \psi\left(w_{\theta_{1}}\right), \ldots, \psi\left(w_{\theta_{m-\operatorname{dim} V+b}}\right)\right] \in \operatorname{Sh}_{b+d}^{\chi}\left(F^{n+m} / W\right)
$$

where $[n+k] \backslash S(U)=\left\{t_{1}<\cdots<t_{n-\operatorname{dim} U+b}\right\}$ and $[m+l] \backslash S(V)=\left\{\theta_{1}<\cdots<\theta_{m-\operatorname{dim} V+b}\right\}$, which is the same as
$x_{U}^{\prime \prime} y_{V}^{\prime \prime}=\left[\phi\left(v_{t_{1}}\right), \ldots, \phi\left(v_{t_{n-\operatorname{dim} U+b}}\right), \psi\left(w_{\theta_{1}}\right), \ldots, \psi\left(w_{\theta_{m-\operatorname{dim} V+b}}\right)\right] \in \operatorname{Sh}_{b+d}^{\chi}\left(\phi\left(F^{n} / U\right) \oplus \psi\left(F^{m} / V\right)\right)$.
Finally, we need to compare the signs. Let us consider the two permutations $\pi_{U}$ and $\pi_{V}$ as one permutation $\pi_{U, V}$ on $n+k+m+l$ letters. We note that $\pi_{W}$ is $\pi_{U, V}$ postcomposing with the permutation that swaps the number of vectors in $x_{U}^{\prime \prime}$, which we denoted by $p$, and the number of vectors in $y_{V}^{\prime}$, which we denoted by $q$, with each other. Thus

$$
(-1)^{\pi_{W}}=(-1)^{p q}(-1)^{\pi_{U}}(-1)^{\pi_{V}}
$$

The result of this section is summarized in the following theorem.
Theorem 2.12. For every PID $R$ and every character $\chi: R^{\times} \rightarrow \mathbb{C}^{\times}$,

$$
B^{\chi}=\bigoplus_{n, k \geq 0}\left(\operatorname{Sh}_{n, k}^{\chi} \otimes_{K} \chi\right)_{\mathrm{GL}_{n}(R)}
$$

is a differential graded commutative bialgebra.
We get the following corollary as an immediate consequence.
Corollary 2.13. For every PID $R$ and every character $\chi: R^{\times} \rightarrow \mathbb{C}^{\times}$,

$$
H\left(B^{\chi}\right) \cong \bigoplus_{n, k \geq 0} H_{k}\left(\operatorname{GL}_{n}(R) ; \operatorname{St}_{n}(F) \otimes_{K} \chi\right)
$$

is a graded commutative bialgebra.
Remark 2.14. Let $R$ be a PID with a finite group of units $R^{\times}$, for example $R=\mathbb{Z}$ or $R$ a complex quadratic number ring which is a PID. And let $K$ be a field of characteristic zero over which the $R^{\times}$-representations split into one-dimensional irreducibles, for example $\mathbb{C}$. Then for $n \geq 1$,

$$
H_{k}\left(\operatorname{SL}_{n}(R) ; \operatorname{St}_{n}(F)\right) \cong H_{k}\left(\operatorname{GL}_{n}(R) ; \operatorname{St}_{n}(F) \otimes \chi_{1}\right) \oplus \cdots \oplus H_{k}\left(\operatorname{GL}_{n}(R) ; \operatorname{St}_{n}(F) \otimes \chi_{r}\right)
$$

where the regular representation $K R^{\times} \cong \chi_{1} \oplus \cdots \oplus \chi_{r}$.
In fact, Equation (1) induces an algebra structure on

$$
\bigoplus_{n, k \geq 0} H_{k}\left(\operatorname{SL}_{n}(R) ; \operatorname{St}_{n}(F)\right),
$$

but products between elements of summands corresponding to different characters are zero.

## 3. Hopf algebras

In this section, we recall several definitions and facts about Hopf algebras and then prove a generalization of Theorem A.

A graded bialgebra $B=\bigoplus_{n>0} B_{n}$ is called connected if $B_{0}=K$.
Usually, a Hopf algebra is defined to be a bialgebra that has an antipode. We will mainly cite Milnor-Moore [MM65] in this section, who do not require an antipode, i.e. their "Hopf algebras" are simply bialgebras. But it turns out that every connected bialgebra is automatically a Hopf algebra which follows from [MM65, Proposition 8.2]. Together with Corollary 2.13, this implies the following generalization of Theorem A.
Theorem 3.1. For every PID $R$ and every character $\chi: R^{\times} \rightarrow \mathbb{C}^{\times}$,

$$
H\left(B^{\chi}\right) \cong \bigoplus_{n, k \geq 0} H_{k}\left(\mathrm{GL}_{n}(R) ; \operatorname{St}_{n}(F) \otimes_{K} \chi\right)
$$

is a graded commutative Hopf algebra.
The primitives of a bialgebra $B$ are given by

$$
P(B)=\{x \in B \mid \Delta(x)=x \otimes 1+1 \otimes x\} .
$$

For a connected bialgebra $B$, let $B_{+}$denote the augmentation ideal $\bigoplus_{n \geq 1} B_{n}$. The indecomposables of $B$ are

$$
Q(B)=B_{+} /\left(B_{+}\right)^{2} .
$$

Because $P(B) \subset B_{+}$, there is a canonical map $P(B) \rightarrow Q(B)$.
Proposition 3.2 (Milnor-Moore [MM65, Proposition 4.17]). A connected Hopf algebra H over a characteristic zero field is commutative if and only if $P(H) \rightarrow Q(H)$ is injective.

Theorem 3.3 (Leray [MM65, Theorem 7.5]). A connected graded commutative Hopf algebra $H$ over a characteristic zero field is isomorphic to the free graded commutative algebra generated by $Q(H)$.

Therefore we get the following generalization of Corollary 1.1.
Corollary 3.4. For every PID $R$ and every character $\chi: R^{\times} \rightarrow \mathbb{C}^{\times}$,

$$
H\left(B^{\chi}\right) \cong \bigoplus_{n, k \geq 0} H_{k}\left(\operatorname{GL}_{n}(R) ; \operatorname{St}_{n}(F) \otimes_{K} \chi\right)
$$

is a free graded commutative algebra.

## 4. New CLasses

In this section, we take $R=\mathbb{Z}, F=\mathbb{Q}$, and $K=\mathbb{Q}$. Let $n \geq 3$. We call the basic coinvariant sharbly

$$
w_{n}=\left[e_{1}, \ldots, e_{n}, e_{1}-e_{2}, \ldots, e_{n-1}-e_{n}, e_{n}-e_{1}\right]_{\mathrm{GL}_{n}(\mathbb{Z})} \in\left(\mathrm{Sh}_{n, n}\right)_{\mathrm{GL}_{n}(\mathbb{Z})}
$$

a wheel sharbly. It is easy to check that $w_{n}=0$ if $n$ is even and that $\partial w_{n}=0$ if $n$ is odd. Recently, Brown-Schnetz [BS, Theorem 4(i)] proved ${ }^{2}$ that for odd $n \geq 3, w_{n}$ gives rise to a nonzero element in homology

$$
H(B)_{n, n} \cong H_{n}\left(\mathrm{GL}_{n}(\mathbb{Z}) ; \operatorname{St}_{n}(\mathbb{Q})\right)
$$

We want to prove the following two proposition about them and the trivial classes $t_{n} \in$ $H^{0}\left(\mathrm{GL}_{n}(\mathbb{Z})\right)$.
Proposition 4.1. $w_{n}$ is primitive in $B$.
Proposition 4.2. $t_{n}$ is primitive in $H$ or $H^{\text {det }}$, depending on the parity.

[^1]Because we know that $w_{n}$ is nonzero in $H(B)$, it follows that it is a nonzero primitive in $H(B)$. Using Proposition 3.2 and Theorem 3.3, Theorem B follows as an immediate corollary.

Proof of Proposition 4.1. For notational convenience, set $x=w_{n}$. Recall that we defined the coproduct using the formula

$$
\Delta(x)=\sum_{U \in \mathcal{U}_{x}}(-1)^{\pi_{U}} x_{U}^{\prime} \otimes x_{U}^{\prime \prime}
$$

We want to prove that if $U \in \mathcal{U}_{x}$ is a nonzero proper subspace of $F^{n}$, then $x_{U}^{\prime \prime}=0$. Let $\beta$ denote reduction modulo $U$.

First assume that none of the $e_{1}, \ldots, e_{n}$ are in $U$. Because $U$ is nonzero, without loss of generality it contains $e_{1}-e_{2}$. But that means that $\beta\left(e_{1}\right)=\beta\left(e_{2}\right)$ because $e_{1}-e_{2}$ is in the kernel of $\beta$ and thus $x_{U}^{\prime \prime}=0$.

We can therefore assume without loss of generality that $e_{1} \in U$. Let $k \geq 1$ be so that $e_{1}, \ldots, e_{k} \in U$ and $e_{k+1} \notin U$. This implies that $e_{k}-e_{k+1} \notin U$, because $e_{k} \in U$. But $\beta\left(e_{k}-\right.$ $\left.e_{k+1}\right)=-\beta\left(e_{k+1}\right)$ because $e_{k}$ is in the kernel of $\beta$. Therefore $x_{U}^{\prime \prime}=0$.

This implies that $x_{U}^{\prime \prime}$ is only nonzero if $U=0$ or $U=F^{n}$ and we get that

$$
\Delta(x)=1 \otimes x+x \otimes 1
$$

Proof of Proposition 4.2. By Borel-Serre [BS73],

$$
H_{k}\left(\operatorname{SL}_{n}(\mathbb{Z}) ; \operatorname{St}_{n}(\mathbb{Q})\right) \cong H_{k}\left(\mathrm{GL}_{n}(\mathbb{Z}) ; \operatorname{St}_{n}(\mathbb{Q})\right) \otimes H_{k}\left(\mathrm{GL}_{n}(\mathbb{Z}) ; \operatorname{St}_{n}(\mathbb{Q}) \otimes \operatorname{det}\right) \cong 0
$$

for $k>\binom{n}{2}$. And

$$
\binom{a}{2}+\binom{b}{2} \leq\binom{ a+b}{2}
$$

with equality only if $a$ or $b$ is zero. This means that the coproduct $\Delta\left(t_{n}\right)$ of $t_{n} \in H_{\binom{n}{2}}\left(\mathrm{GL}_{n}(\mathbb{Z}) ; \operatorname{St}_{n}(\mathbb{Q}) \otimes\right.$ $\chi$ ), where $\chi$ is trivial if $n$ is odd and the determinant representation if $n$ is even, can only be $1 \otimes t_{n}+t_{n} \otimes 1$ for degree reasons.
