# ON GORENSTEINESS OF ASSOCIATED GRADED RINGS OF FILTRATIONS

#### Abstract

Let $(A, \mathfrak{m})$ be a Gorenstein local ring, and $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration. In this paper, we give a criterion for Gorensteinness of the associated graded ring of $\mathcal{F}$ in terms of the Hilbert coefficients of $\mathcal{F}$ in some cases. As a consequence we recover and extend a result proved in [19]. Further, we present ring-theoretic properties of the normal tangent cone of the maximal ideal of $A=S /(f)$ where $S=K \llbracket x_{0}, x_{1}, \ldots, x_{m} \rrbracket$ is a formal power series ring over an algebraically closed field $K$, and $f=x_{0}^{a}-g\left(x_{1}, \ldots, x_{m}\right)$, where $g$ is a polynomial with $g \in\left(x_{1}, \ldots, x_{m}\right)^{b} \backslash\left(x_{1}, \ldots, x_{m}\right)^{b+1}$, and $a, b, m$ are integers. We show that the normal tangent cone $\bar{G}(\mathfrak{m})$ is Cohen-Macaulay if $A$ is normal and $a \leq b$. Moreover, we give a criterion of the Gorensteinness of $\bar{G}(\mathfrak{m})$.


## 1. Introduction

Let $(A, \mathfrak{m})$ be a Noetherian local ring of dimension $d$ with an infinite residue field. An $F_{1}$-good filtration, $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ is a descending chain $A=F_{0} \supseteq F_{1} \supseteq \cdots$ of ideals satisfying $F_{i} F_{j} \subseteq F_{i+j}$ for all $i, j \in \mathbb{Z}$, $F_{n}=A$ for all $n \leq 0$, and $F_{n+1}=F_{1} F_{n}$ for all $n \gg 0$. In addition, if $F_{1}$ is an $\mathfrak{m}$-primary ideal, then $\mathcal{F}$ is called a Hilbert filtration (c.f. [1]). We write $G(\mathcal{F}):=\bigoplus_{n \geq 0} F_{n} / F_{n+1}$ for the associated graded ring of $\mathcal{F}$. Studying the homological properties of $G(\mathcal{F})$, in particular, the Cohen-Macaulay property, has been an active topic of research since long time, see for instance [4, 8, 13].

In this paper we study the Gorenstein property of $G(\mathcal{F})$ with particular attention to the filtration $\left\{\overline{I^{n}}\right\}_{n \in \mathbb{Z}}$ where $\bar{J}$ denotes the integral closure of $J$. The Gorenstein property of $G(\mathcal{F})$ when $\mathcal{F}=\left\{I^{n}\right\}_{n \in \mathbb{Z}}$ has been studied extensively (eg. [20, 10, 3, 12, 24, 22, 23|).

Let $\mathcal{F}$ be a Hilbert filtration. It is well known that the Hilbert function of $\mathcal{F}, H_{\mathcal{F}}(n):=\ell\left(A / F_{n}\right)$ coincides with a polynomial of degree $d$ for large $n$ (see [15]). We denote this polynomial by $P_{\mathcal{F}}(n)$ and write it as

$$
P_{\mathcal{F}}(n)=e_{0}(\mathcal{F})\binom{n+d-1}{d}-e_{1}(\mathcal{F})\binom{n+d-2}{d-1}+\cdots+(-1)^{d} e_{d}(\mathcal{F})
$$

Here $e_{i}(\mathcal{F})$ are integers called the Hilbert coefficients of $\mathcal{F}$. Recall that $Q$ is said to be a reduction of $\mathcal{F}$ if $Q \subseteq F_{1}$ and $F_{n+1}=Q F_{n}$ for $n \gg 0$. A reduction $Q$ of $I$ is said to be a minimal reduction of $\mathcal{F}$, if $Q$ is a

[^0]reduction of $\mathcal{F}$ and is minimal with respect to the inclusion. The reduction number of $\mathcal{F}$ with respect to a minimal reduction $Q$ of $\mathcal{F}$,
$$
r_{Q}(\mathcal{F}):=\min \left\{r \mid F_{n+1}=Q F_{n} \text { for all } n \geq r\right\}
$$
and the reduction number of $\mathcal{F}$ is
$$
r(\mathcal{F}):=\min \left\{r_{Q}(\mathcal{F}) \mid Q \text { is a minimal reduction of } \mathcal{F}\right\}
$$

It is easy to observe that if $I$ is an $\mathfrak{m}$-primary ideal in $A$, then $\mathcal{F}=\left\{I^{n}\right\}_{n \in \mathbb{Z}}$ is a Hilbert filtration. In this case we write $G(I)$ for $G(\mathcal{F}), e_{i}(I)$ for $e_{i}(\mathcal{F}), r_{Q}(I)$ for $r_{Q}(\mathcal{F})$ and $r(I)$ for $r(\mathcal{F})$.

There is another interesting example of a filtration that appears in the study of resolution of singularities, namely $\mathcal{F}=\left\{\overline{I^{n}}\right\}_{n \in \mathbb{Z}}$.

In [21] Rees showed that if $A$ is an analytically unramified local ring and $I$ is an m-primary ideal in $A$, then $\mathcal{F}=\left\{\overline{I^{n}}\right\}_{n \in \mathbb{Z}}$ is a Hilbert filtration. In this case we write $\bar{G}(I)$ for $G(\mathcal{F})$. We denote $\bar{e}_{i}(I)$ for $e_{i}(\mathcal{F})$, $\bar{r}_{Q}(I)$ for $r_{Q}(\mathcal{F})$, and $\bar{r}(I)$ for $r(\mathcal{F})$ and call them as the normal Hilbert coefficients, normal reduction number with respect to a minimal reduction $Q$ of $\left\{\overline{I^{n}}\right\}_{n \in \mathbb{Z}}$ and normal reduction number, respectively.

It has been observed that $G(I)$ and $\bar{G}(I)$ are rarely Cohen-Macaualy even if $A$ is Cohen-Macaualy. A large attention in the literature is devoted to obtaining criteria for $G(\mathcal{F})$ to be Cohen-Macaualy in terms of Hilbert coefficients and/or reduction number with particular attention to the filtration $\left\{I^{n}\right\}_{n \in \mathbb{Z}}$ and $\left\{\overline{I^{n}}\right\}_{n \in \mathbb{Z}}$. For instance, it is well-known that if $r(\mathcal{F}) \leq 1$ in a Cohen-Macaualy local ring, then $G(\mathcal{F})$ is Cohen-Macaualy (c.f. [15]). Also, it is known that if $e_{1}(\mathcal{F})=0$ in a Cohen-Macaualy local ring, then $G(\mathcal{F})$ is Cohen-Macaualy (c.f. [15]). For these reasons, a huge research is devoted to obtaining a sharp bound on the Hilbert coefficients and reduction number, and studying the behavior of $G(\mathcal{F})$ when these bounds are extremal. This was also a theme studied by several mathematicians, for example, Huneke, Goto, Lipman, Sally among others.

In this paper, we are interested in obtaining the Gorenstein property of $G(\mathcal{F})$ in terms of the Hilbert coefficients. As mentioned before this has also a rich history. Now, we focus on the content of this paper.

In [5] Heinzer, Kim, and Ulrich established a criterion for Gorensteinness of $G(I)$ when $A$ is an Artinian Gorenstein local ring. This has been extended for Hilbert filtrations in [6].

They proved that $G(\mathcal{F})$ is Gorenstein if and only if the $h$-vector of $G(\mathcal{F})$ is symmetric. In this paper we extend this result for any $d$-dimensional Gorenstein local ring (Theorem 3.1). We use this result to characterize the Gorensteiness of $G(\mathcal{F})$ in terms of the Hilbert coefficients.

A first result in this direction is obtained when $r(\mathcal{F}) \leq 2$ (Theorems 3.4 and 4.2). We make an additional assumption when $r(\mathcal{F})=2$, namely: there exists a minimal reduction $Q$ of $\mathcal{F}$ such that $r_{Q}(\mathcal{F})=2$ and $F_{2} \cap Q=Q F_{1}$. This condition ensures that $G(\mathcal{F})$ is Cohen-Macaualy (Lemma 3.2), and helps to compute the Hilbert series of $G(\mathcal{F})$. Notice that this condition is not restrictive. For instance, the filtration $\mathcal{F}=$ $\left\{\overline{I^{n}}\right\}_{n \in \mathbb{Z}}$ and $\mathcal{F}=\left\{\mathfrak{m}^{n}\right\}_{n \in \mathbb{Z}}$ satisfies this criterion. As a consequence of our result, we obtain a criterion for Gorensteiness of $\bar{G}(I)$ (Corollary 4.3). This recovers and extends a recent result by Okuma, Watanabe, and Yoshida in [19].

We next investigate the case $r(\mathcal{F})>2$. A difficulty in this case is the computation of the Hilbert series of $G(\mathcal{F})$. In order to compute this we assume that the relative reduction number is maximal. We define this term below.

In section 2, we introduce the relative reduction number $\operatorname{nr}(\mathcal{F})$ for Hilbert filtration $\mathcal{F}$. This is inspired by the definition of relative reduction number for normal filtrations defined in [18] in dimension two. The
relative reduction number of $\mathcal{F}$ with respect to a minimal reduction $Q$ of $\mathcal{F}$ is defined as

$$
\operatorname{nr}_{Q}(\mathcal{F}):=\min \left\{r \in \mathbb{Z}_{+} \mid F_{r+1}=Q F_{r}\right\}
$$

The relative reduction number of $\mathcal{F}$ is defined as

$$
\operatorname{nr}(\mathcal{F}):=\min \left\{\operatorname{nr}_{Q}(\mathcal{F}) \mid Q \text { is a minimal reduction of } \mathcal{F}\right\} .
$$

Observe that $\operatorname{nr}(\mathcal{F}) \leq r(\mathcal{F})$ and the inequality can be strict in general (see [16, Example 2.8]). If $\mathcal{F}=$ $\left\{I^{n}\right\}_{n \in \mathbb{Z}}$, then $\operatorname{nr}_{Q}(\mathcal{F})=r_{Q}(\mathcal{F})$ for any minimal reduction $Q$ of $I$ and hence $\operatorname{nr}(F)=r(\mathcal{F})$. For $\mathcal{F}=$ $\left\{\overline{I^{n}}\right\}_{n \in \mathbb{Z}}$, we denote $\mathrm{nr}_{Q}(\mathcal{F})$ by $\mathrm{nr}_{Q}(I)$ and $\operatorname{nr}(\mathcal{F})$ by $\mathrm{nr}(I)$ and the latter is called the relative normal reduction number. Note that $\operatorname{nr}(I)$ does not refer to the relative reduction number of the filtration $\mathcal{F}=\left\{I^{n}\right\}_{n \in \mathbb{Z}}$.

In Theorem 2.3 we derive an upper bound for $\operatorname{nr}(\mathcal{F})$ in a $d$-dimensional Cohen-Macaualy local ring when depth $G(\mathcal{F}) \geq d-1$. We prove that

$$
\begin{equation*}
\operatorname{nr}(\mathcal{F}) \leq e_{1}(\mathcal{F})-e_{0}(\mathcal{F})+\ell\left(A / F_{1}\right)+1 \tag{1.1}
\end{equation*}
$$

In [16] the inequality (1.1) was proved for $\mathcal{F}=\left\{\overline{I^{n}}\right\}_{n \in \mathbb{Z}}$ in a two-dimensional normal excellent local domain. We also examine the conditions under which $\operatorname{nr}(\mathcal{F})$ achieves the upper bound, which serves as a crucial technical assumption for the computation of the Hilbert series of $G(\mathcal{F})$. We say $\mathcal{F}$ has maximal relative reduction number if $\operatorname{nr}(\mathcal{F})=e_{1}(\mathcal{F})-e_{0}(\mathcal{F})+\ell\left(A / F_{1}\right)+1$.

We are able to compute the Hilbert series of $G(\mathcal{F})$ when $r(\mathcal{F})>2$ and the relative reduction number is maximal in dimensions one and two. Since these computations are slightly different, we separate these cases. We consider the dimension one case in Section 3 and the dimension two case in Section 5 As a consequence we obtain criteria for $G(\mathcal{F})$ to be Gorenstein when $r(\mathcal{F})>2$ and $\operatorname{nr}(\mathcal{F})$ is maximal in dimensions one and two in Theorems 3.4 and 5.4 respectively. These criteria stated above enable us to understand the Gorenstein property of $\bar{G}(I)$ even without having the information on the explicit expression of $\overline{I^{n}}$.

We include some interesting examples of semigroup rings in dimension one in Section 3 and use our criteria to detect Gorensteinness of $\bar{G}(\mathfrak{m})$.

In Section 6 and Section 7 we study Gorensteiness of $\bar{G}(\mathfrak{m})$ in hypersurface rings $A=K \llbracket x_{0}, x_{1}, \ldots, x_{m} \rrbracket /(f)$. The standard graded ring defined by

$$
G(\mathfrak{m})=\bigoplus_{n \geq 0} \mathfrak{m}^{n} / \mathfrak{m}^{n+1}
$$

is called the tangent cone of $\mathfrak{m}$. It is well-known that for a local ring $A, G(\mathfrak{m})$ is a hypersurface (and thus Gorenstein) with the multiplicity of $G(\mathfrak{m})$ is equal to $\operatorname{ord}(f)=r_{Q}(\mathfrak{m})+1$.

A criterion for Gorensteinness of $\bar{G}(I)$ in terms of $\overline{\mathrm{r}}_{Q}(I)$ and the other geometric properties is given in [19, 17]. In [16, Example 2.8] an explicit example of an $\mathfrak{m}$-primary integrally closed ideal $I \subset A$ is given such that $\overline{\mathrm{r}}_{Q}(I)>\mathrm{nr}_{Q}(I)$. Such an ideal $I$ gives an example for which $\bar{G}(I)$ is not Cohen-Macaulay. However, the ring $A$ is not Gorenstein in this example. So it is natural to ask the following:

Question. Let $A$ be a reduced hypersurface. Then
(1) Is $\bar{G}(\mathfrak{m})$ a hypersurface?
(2) Is $\bar{G}(\mathfrak{m})$ Gorenstein?
(3) Is $\bar{G}(\mathfrak{m})$ Cohen-Macaulay?

This question (2) has a negative answer. Surprisingly, there exist many examples of Brieskorn hypersurfaces for which $\bar{G}(\mathfrak{m})$ is NOT Gorenstein (see [19]). However, we have no negative answers to Question (3). So the main aim of Sections 6 and 7 is to prove the Cohen-Macaulayness of $\bar{G}(\mathfrak{m})$ for certain hypersurfaces, and to give a criterion for Gorensteinness for such $\bar{G}(\mathfrak{m})$. Furthermore, we compute $\bar{r}_{Q}(\mathfrak{m})$ in this case.

Let $K$ be an algebraically closed field, and let $m \geq 1,2 \leq a \leq b$ be integers, and put $S=K \llbracket x_{0}, x_{1}, \ldots, x_{m} \rrbracket$ be a formal power series ring with $(m+1)$-variables over $K$. Put $x=x_{0}$ and $\underline{x}=x_{1}, \ldots, x_{m}$. Let $g$, $f$ be polynomials such that

$$
\begin{aligned}
& g=g(\underline{x}) \in(\underline{x})^{b} \backslash(\underline{x})^{b+1} \\
& f=f(x, \underline{x})=x^{a}-g(\underline{x})
\end{aligned}
$$

Then a hypersurface $A=S /(f)$ is called "Zariski-type hypersurface" if $a \neq 0$ in $K$.
The main result of these sections is the following:
Theorem 1.1. Let $m \geq 1,2 \leq a \leq b$ be integers. Let $A=S /\left(x^{a}-g(\underline{x})\right)$ be a normal Zariski-type hypersurface as above, and $\mathfrak{m}$ be its unique maximal ideal. Then
(a) $\overline{\mathrm{r}}_{Q}(\mathfrak{m})=\left\lfloor\frac{(a-1) b}{a}\right\rfloor$.
(b) $\bar{G}:=\bar{G}(\mathfrak{m})$ is Cohen-Macaulay with $\operatorname{dim} \bar{G}=m$ and $e_{0}(\bar{G})=a$.
(c) $\bar{G}$ is Gorenstein if and only if $b \equiv 0$ or $d(\bmod a)$, where $d=\operatorname{gcd}(a, b)$.
(d) $\bar{G}$ has maximal embedding dimension if and only if either $(i) a=2$ or $(i i) b \equiv a-1(\bmod a)$.

We refer [2] for undefined terms.

## 2. A Bound on relative reduction number

In this section, we obtain an upper bound for the relative reduction number $\operatorname{nr}(\mathcal{F})$ of $\mathcal{F}$ when the depth of $G(\mathcal{F})$ is almost maximal. In general for an arbitrary filtration $\mathcal{F}$, we have $\mathrm{nr}_{Q}(\mathcal{F}) \leq r_{Q}(\mathcal{F})$, and hence $\operatorname{nr}(\mathcal{F}) \leq r(\mathcal{F})$. In [16, Example 2.8] the authors gave an example for which the inequality is strict for the filtration $\mathcal{F}=\left\{\overline{I^{n}}\right\}_{n \in \mathbb{Z}}$. In the following proposition we show that if $G(\mathcal{F})$ is Cohen-Macaualy, then $\operatorname{nr}(\mathcal{F})=r(\mathcal{F})$ for any Hilbert filtration $\mathcal{F}$.

Proposition 2.1. Let $(A, \mathfrak{m})$ be a Cohen-Macaulay local ring of dimension d. Let $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ be a Hilbert filtration. If $G(\mathcal{F})$ is Cohen-Macaulay, then $\operatorname{nr}_{Q}(\mathcal{F})=r_{Q}(\mathcal{F})$ for any minimal reduction $Q$ of $\mathcal{F}$. In particular, $\operatorname{nr}(\mathcal{F})=r(\mathcal{F})$.

Proof. We always have $\operatorname{nr}_{Q}(\mathcal{F}) \leq r_{Q}(\mathcal{F})$. Let $Q$ be a minimal reduction of $F_{1}$ such that $\mu(Q)=d$. Since $G(\mathcal{F})$ is Cohen-Macaulay, by [7, Proposition 3.5] $Q \cap F_{n}=Q F_{n-1}$ for all $n \geq 1$. Let $m=\operatorname{nr}_{Q}(\mathcal{F})$. Then $F_{m+1}=Q F_{m}$. Hence $F_{m+2} \subseteq F_{m+1} \subseteq Q$. Therefore

$$
F_{m+2}=F_{m+2} \cap Q=Q F_{m+1} .
$$

Continuing this successively we get $F_{k+1}=Q F_{k}$ for all $k \geq m$. This implies that $r_{Q}(\mathcal{F}) \leq m=\operatorname{nr}_{Q}(\mathcal{F})$. Thus $r_{Q}(\mathcal{F})=\mathrm{nr}_{Q}(\mathcal{F})$.

In general, the reduction number $r_{Q}(\mathcal{F})$ of $\mathcal{F}$ and the relative reduction number $\mathrm{nr}_{Q}(\mathcal{F})$ of $\mathcal{F}$ are dependent on the minimal reduction $Q$. It is well-known that if depth $G(\mathcal{F}) \geq d-1$, then $r_{Q}(\mathcal{F})$ is independent of the minimal reduction $Q$. In the following proposition we show that $\mathrm{nr}_{Q}(\mathcal{F})$ is also independent of $Q$ if
depth $G(\mathcal{F}) \geq d-1$. Recall that if $f: \mathbb{Z} \rightarrow \mathbb{N}$ is a numerical function, then $\Delta(f): \mathbb{Z} \rightarrow \mathbb{N}$ is a numerical function defined by

$$
\Delta(f)(n):=f(n)-f(n-1) .
$$

Proposition 2.2. Let $(A, m)$ be a d-dimensional Cohen-Macaulay local ring, and $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration. If depth $G(\mathcal{F}) \geq d-1$, then $\mathrm{nr}_{Q}(\mathcal{F})$ is independent of any minimal reduction $Q$.

Proof. Using [15, Theorem 3.6] for all $n \in \mathbb{Z}$, we have

$$
\Delta^{d}\left(P_{\mathcal{F}}(n)-H_{\mathcal{F}}(n)\right)=\ell\left(F_{n} / Q F_{n-1}\right) .
$$

Since the expression on the left-hand side is independent of $Q$, we get $\ell\left(F_{n} / Q F_{n-1}\right)$ is independent of $Q$. Hence it is easy to verify that $\mathrm{nr}_{Q}(\mathcal{F})$ is independent of $Q$.

If $(A, \mathfrak{m})$ is a Cohen-Macaualy local ring of dimension two and $\mathcal{F}=\left\{\bar{I}^{n}\right\}_{n \in \mathbb{Z}}$, then depth $G(\mathcal{F}) \geq 1$ by [15, Proposition 3.25]. Hence by Proposition 2.2] $\mathrm{nr}_{Q}(I)$ is independent of $Q$ and thus $\mathrm{nr}(I)=\mathrm{nr}_{Q}(I)$. This is a reason that the authors use the notation $n r(I)$ (without suffix) for the relative normal reduction number in [16].

In the next theorem we extend a result by Okuma, Rossi, Watanabe, and Yoshida. In [16. Theorem 2.7] they showed that if $(A, \mathfrak{m})$ is an excellent two-dimensional normal local domain containing an algebraically closed field $A / \mathfrak{m}$, then for an $\mathfrak{m}$-primary ideal $I$

$$
\operatorname{nr}(I) \leq \bar{e}_{1}(I)-\bar{e}_{0}(I)+\ell(A / \bar{I})+1
$$

They also provided a criterion for the equality to hold. In the following theorem we prove an analogue bound for any Hilbert filtration in a $d$-dimensional Cohen-Macaualy local ring, provided $G(\mathcal{F})$ has almost maximal depth.

Theorem 2.3. Let $(A, \mathfrak{m})$ be a d-dimensional Cohen-Macaulay local ring, and $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration. If depth $G(\mathcal{F}) \geq d-1$, then

$$
\operatorname{nr}(\mathcal{F}) \leq e_{1}(\mathcal{F})-e_{0}(\mathcal{F})+\ell\left(A / F_{1}\right)+1
$$

Moreover, the equality holds if and only if $\ell\left(F_{n} / Q F_{n-1}\right)=1$ for all $2 \leq n \leq \operatorname{nr}(\mathcal{F})$ for any minimal reduction $Q$ of $\mathcal{F}$ and $\operatorname{nr}(\mathcal{F})=r(\mathcal{F})$. Also, $e_{i}(\mathcal{F})=\binom{\operatorname{nr}(\mathcal{F})}{i}$ for $2 \leq i \leq d$.
Proof. Using Proposition [7. Proposition 4.6], for any minimal reduction $Q$ of $\mathcal{F}$ we have,

$$
\begin{align*}
e_{1}(\mathcal{F}) & =\sum_{n \geq 1}^{r(\mathcal{F})} \ell\left(F_{n} / Q F_{n-1}\right) \\
& =\ell\left(F_{1} / Q\right)+\sum_{n \geq 2}^{r(\mathcal{F})} \ell\left(F_{n} / Q F_{n-1}\right) \\
& =e_{0}(\mathcal{F})-\ell\left(A / F_{1}\right)+\sum_{n \geq 2}^{r(\mathcal{F})} \ell\left(F_{n} / Q F_{n-1}\right) \quad\left(\text { as } e_{0}(\mathcal{F})=\ell(A / Q)\right) \tag{2.1}
\end{align*}
$$

We observe that $\ell\left(F_{n} / Q F_{n-1}\right) \geq 1$ for $2 \leq n \leq \operatorname{nr}(\mathcal{F})$. Therefore by (2.1)

$$
\begin{equation*}
\operatorname{nr}(\mathcal{F})-1 \leq \sum_{n \geq 2}^{r(\mathcal{F})} \ell\left(F_{n} / Q F_{n-1}\right)=e_{1}(\mathcal{F})-e_{0}(\mathcal{F})+\ell\left(A / F_{1}\right), \tag{2.2}
\end{equation*}
$$

and hence $\operatorname{nr}(\mathcal{F}) \leq e_{1}(\mathcal{F})-e_{0}(\mathcal{F})+\ell\left(A / F_{1}\right)+1$.
Suppose $\operatorname{nr}(\mathcal{F})=e_{1}(\mathcal{F})-e_{0}(\mathcal{F})+\ell\left(A / F_{1}\right)+1$. Then by (2.2) $\ell\left(F_{n} / Q F_{n-1}\right)=0$ for $n \geq \operatorname{nr}_{Q}(\mathcal{F})+1$ and $\ell\left(F_{n} / Q F_{n-1}\right)=1$ for $2 \leq n \leq \operatorname{nr}_{Q}(\mathcal{F})$. Therefore $\operatorname{nr}_{Q}(\mathcal{F})=r_{Q}(\mathcal{F})$, which yields $n r(\mathcal{F})=r(\mathcal{F})$. Again using [7] Proposition 4.6] we have, for $i \geq 2$,

$$
e_{i}(\mathcal{F})=\sum_{n \geq i}^{\operatorname{nr}(\mathcal{F})}\binom{n-1}{i-1}=\binom{\operatorname{nr}(\mathcal{F})}{i} .
$$

Using Theorem 2.3 for the filtration $\mathcal{F}=\left\{\overline{I^{n}}\right\}_{n \in \mathbb{Z}}$ in dimension two, we recover and extend the result [16, Theorem 2.7] by Okuma, Rossi, Watanabe and Yoshida.

Corollary 2.4 ((cf. [16. Theorem 2.7])). Let ( $A, \mathfrak{m}$ ) be a two-dimensional Cohen-Macaulay analytically unramified local ring, and I an $\mathfrak{m}$-primary ideal. Let $Q$ a minimal reduction of I. Then

$$
\operatorname{nr}(I) \leq \bar{e}_{1}(I)-e_{0}(I)+\ell(A / \bar{I})+1 .
$$

Moreover, the equality holds if and only if $\ell\left(\overline{I^{n}} / Q \overline{I^{n-1}}\right)=1$ for all $2 \leq n \leq \operatorname{nr}(I)$ and $\operatorname{nr}(I)=\bar{r}(I)$. Also, $\bar{e}_{2}(I)=\binom{\mathrm{nr}(I)}{2}$.

Proof. Since depth $\bar{G}(I) \geq 1$ by [15, Proposition 3.25], the result follows from Theorem 2.3]

## 3. Gorensteinness of $G(\mathcal{F})$ in dimension one

In this section, we discuss the Gorenstein property of $G(\mathcal{F})$ of a Hilbert filtration $\mathcal{F}$ in a one-dimensional Cohen-Macaulay local ring.

In [6] Heinzer, Kim and Ulrich gave criteria for $G(\mathcal{F})$ to be Gorenstein for an Artinian Gorenstein local ring. In the following theorem, we extend this result for any $d$-dimensional Gorenstein local ring. This plays a very important role in determining the Gorenstein property of the associated graded ring in terms of the Hilbert coefficients of $\mathcal{F}$.

Theorem 3.1. Let $(A, \mathfrak{m})$ be a d-dimensional Gorenstein local ring, $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}} a$ Hilbert filtration. Let

$$
H S_{G(\mathcal{F})}(z)=\frac{h_{0}+h_{1} t+\cdots+h_{s} t^{s}}{(1-t)^{d}},
$$

where $h_{s} \neq 0$ be the Hilbert series of $G(\mathcal{F})$. Suppose $G(\mathcal{F})$ is Cohen-Macaulay. Then $G(\mathcal{F})$ is Gorenstein if and only if $h_{s-i}=h_{i}$ for all $i=0,1, \ldots, s$.

Proof. Let $Q$ be a minimal reduction of $\mathcal{F}$. By [9, Theorem 8.6.3] there exists a generating set $a_{1}, \ldots, a_{d}$ of $Q$ such that $a_{1}, \ldots, a_{d}$ is a superficial sequence. Since $G(\mathcal{F})$ is Cohen-Macaualy, $a_{1}^{*}, \ldots a_{d}^{*}$ is a $G(\mathcal{F})$-regular sequence by [7. Lemma 2.1], where $a_{i}^{*}=a_{i}+F_{2}$ for $i=1,2, \ldots, d$. Therefore $G(\mathcal{F}) /\left(a_{1}^{*}, \ldots, a_{d}^{*}\right) \cong G(\mathcal{F} / Q)$. Since $a_{1}^{*}, \ldots, a_{d}^{*}$ is a regular sequence in $G(\mathcal{F})$,

$$
H S_{G(\mathcal{F}) /\left(a_{1}^{*}, \ldots, a_{d}^{*}\right)}(t)=h_{0}+h_{1} t+\cdots+h_{s} t^{s} .
$$

Hence

$$
H S_{G(\mathcal{F} / Q)}(t)=h_{0}+h_{1} t+\cdots+h_{s} t^{s} .
$$

Therefore by [6. Theorem 4.2] $G(\mathcal{F} / Q)$ is Gorenstein if and only if $h_{s-i}=h_{i}$ for $i=0,1, \ldots, s$. Now the result follows because $a_{1}^{*}, \ldots, a_{d}^{*}$ is a regular sequence in $G(\mathcal{F})$ and $G(\mathcal{F}) /\left(a_{1}^{*}, \ldots, a_{d}^{*}\right) \cong G(\mathcal{F} / Q)$.

Our goal is to use Theorem 3.1 to obtain criteria for $G(\mathcal{F})$ to be Gorenstein in terms of the Hilbert coefficients. For this, first of all we should know whether $G(\mathcal{F})$ is Cohen-Macaualy. There is a huge research in the literature on obtaining criteria for $G(\mathcal{F})$ to be Cohen-Macaualy in terms of numerical invariants such as Hilbert coefficients and reduction number. Below we present a well-known criteria for $G(\mathcal{F})$ to be CohenMacaualy in terms of reduction number. We remark that the condition in $(b)$ is not restrictive. For instance, the filtration $\mathcal{F}=\left\{\overline{I^{n}}\right\}_{n \in \mathbb{Z}}$ and $\mathcal{F}=\left\{\mathfrak{m}^{n}\right\}_{n \in \mathbb{Z}}$ satisfies this criterion.

Lemma 3.2. Let $(A, \mathfrak{m})$ be a $d$-dimensional Cohen-Macaulay local ring and $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration. Then $G(\mathcal{F})$ is Cohen-Macaulay in each of the following cases:
(a) $r(\mathcal{F})=1$;
(b) there exists a minimal reduction $Q$ of $\mathcal{F}$ such that $r_{Q}(\mathcal{F})=2$ and $F_{2} \cap Q=Q F_{1}$.

Proof. The proof follows by [7, Proposition 3.5].
Now in order to provide conditions for $G(\mathcal{F})$ to be Gorenstein, we need to compute the Hilbert series of $G(\mathcal{F})$. This computation is slightly different for the one-dimensional case. In this section, we compute the Hilbert series of $G(\mathcal{F})$ in dimension one, and using this, we obtain criteria for $G(\mathcal{F})$ to be Gorenstein in terms of Hilbert coefficients of $\mathcal{F}$. We consider $d \geq 2$ in the next section.

The computation of the Hilbert series of $G(\mathcal{F})$ is not an easy task in general. In the following proposition we compute the Hilbert series of $G(\mathcal{F})$ in the case $\mathcal{F}$ satisfies the conditions (a), (b) of Lemma 3.2, and under certain additional assumptions when $r(\mathcal{F}) \geq 3$. For this, we recall the following definition: For a Hilbert filtration $\mathcal{F}$, the postulation number of $\mathcal{F}$ is given by

$$
n(\mathcal{F}):=\sup \left\{n \in \mathbb{Z} \mid H_{\mathcal{F}}(n) \neq P_{\mathcal{F}}(n)\right\} .
$$

If $\mathcal{F}=\left\{\overline{I^{n}}\right\}_{n \in \mathbb{Z}}$, then $n(\mathcal{F})$ is denoted by $\bar{n}(I)$. We also recall the result [15, corollary 3.8] that will be used frequently in the remainder of the paper. Let $(A, \mathfrak{m})$ be a $d$-dimensional Cohen-Macaulay local ring with infinite residue field and $\mathcal{F}=\left\{F_{n}\right\}_{n \mathbb{Z}}$ a Hilbert filtration of ideals. Suppose depth $G(\mathcal{F}) \geq d-1$. Then

$$
\begin{equation*}
r(\mathcal{F})=n(\mathcal{F})+d \tag{3.1}
\end{equation*}
$$

Proposition 3.3. Let $(A, \mathfrak{m})$ be a one-dimensional Cohen-Macaulay local ring and $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration.
(a) $\operatorname{Ifr}(\mathcal{F})=1$, then $H S_{G(\mathcal{F})}(t)=\frac{\left(e_{0}(\mathcal{F})-e_{1}(\mathcal{F})\right)+e_{1}(\mathcal{F}) t}{(1-t)}$.
(b) Suppose there exists a minimal reduction $Q$ of $\mathcal{F}$ such that $r_{Q}(\mathcal{F})=2$ and $F_{2} \cap Q=Q F_{1}$. Then

$$
H S_{G(\mathcal{F})}(t)=\frac{1}{(1-t)}\left(\ell\left(A / F_{1}\right)+\left(\left(\ell\left(F_{1} / F_{2}\right)-\ell\left(A / F_{1}\right)\right)\right) t+\left(e_{1}(\mathcal{F})-e_{0}(\mathcal{F})+\ell\left(A / F_{1}\right)\right) t^{2}\right) .
$$

(c) Suppose $r(\mathcal{F}) \geq 3$ and $\operatorname{nr}(\mathcal{F})$ is maximal. Then

$$
H S_{G(\mathcal{F})}(t)=\frac{1}{(1-t)}\left(\ell\left(A / F_{1}\right)-t\left(e_{0}(\mathcal{F})-\ell\left(A / F_{1}\right)-1\right)+t^{r(\mathcal{F})}\right) .
$$

Proof. (a) By Lemma3.2 $G(\mathcal{F})$ is Cohen-Macaulay. Hence using Equation (3.1) we get $n(\mathcal{F})=1-1=0$. Hence for all $n \geq 1, P_{\mathcal{F}}(n)=H_{\mathcal{F}}(n)$. Taking $n=1$, we obtain

$$
\begin{equation*}
\ell\left(A / F_{1}\right)=e_{0}(\mathcal{F})-e_{1}(\mathcal{F}) . \tag{3.2}
\end{equation*}
$$

Also,

$$
\begin{equation*}
\ell\left(F_{n} / F_{n+1}\right)=\ell\left(A / F_{n+1}\right)-\ell\left(A / F_{n}\right)=e_{0}(F) \text { for all } n \geq 1 \tag{3.3}
\end{equation*}
$$

Therefore

$$
\begin{array}{rlr}
H S_{G(\mathcal{F})}(t) & =\sum_{n \in \mathbb{Z}} \ell\left(F_{n} / F_{n+1}\right) t^{n} \\
& =\ell\left(A / F_{1}\right)+\sum_{n \geq 1} \ell\left(F_{n} / F_{n+1}\right) t^{n} \\
& =\ell\left(A / F_{1}\right)-e_{0}(\mathcal{F})+\sum_{n \geq 0} e_{0}(\mathcal{F}) t^{n} & \text { (by Equation (3.3)) } \\
& =-e_{1}(\mathcal{F})+\frac{e_{0}(\mathcal{F})}{(1-t)} \\
& =\frac{\left(e_{0}(\mathcal{F})-e_{1}(\mathcal{F})\right)+e_{1}(\mathcal{F}) t}{(1-t)} . &
\end{array}
$$

(b) By Lemma 3.2 $G(\mathcal{F})$ is Cohen-Macaualy. Hence using Equation 3.1) $n(\mathcal{F})=2-1=1$. Hence for all $n \geq 2, P_{\mathcal{F}}(n)=H_{\mathcal{F}}(n)$. Taking $n=2$, we obtain

$$
\begin{equation*}
\ell\left(A / F_{2}\right)=2 e_{0}(\mathcal{F})-e_{1}(\mathcal{F}) \tag{3.4}
\end{equation*}
$$

The Hilbert series of $G(\mathcal{F})$ is given by

$$
\begin{aligned}
H S_{G(\mathcal{F})}(t) & =\sum_{n \in \mathbb{Z}} \ell\left(F_{n} / F_{n+1}\right) t^{n} \\
& =\ell\left(A / F_{1}\right)+\ell\left(F_{1} / F_{2}\right) t+\sum_{n \geq 2} \ell\left(F_{n} / F_{n+1}\right) t^{n} \\
& =\ell\left(A / F_{1}\right)-e_{0}(\mathcal{F})+\left(\ell\left(F_{1} / F_{2}\right)-e_{0}(\mathcal{F})\right) t+\sum_{n \geq 0} e_{0}(\mathcal{F}) t^{n} \\
& =\frac{1}{(1-t)}\left(\left(\ell\left(A / F_{1}\right)-e_{0}(\mathcal{F})\right)(1-t)+\left(\ell\left(F_{1} / F_{2}\right)-e_{0}(\mathcal{F})\right) t(1-t)+e_{0}(\mathcal{F})\right) \\
& =\frac{1}{(1-t)}\left(\ell\left(A / F_{1}\right)+\left(\ell\left(F_{1} / F_{2}\right)-\ell\left(A / F_{1}\right)\right) t+\left(e_{0}(\mathcal{F})-\ell\left(F_{1} / F_{2}\right)\right) t^{2}\right) \\
& =\frac{1}{(1-t)}\left(\ell\left(A / F_{1}\right)+\left(\ell\left(F_{1} / F_{2}\right)-\ell\left(A / F_{1}\right)\right) t+\left(e_{0}(\mathcal{F})-\ell\left(A / F_{2}\right)+\ell\left(A / F_{1}\right)\right) t^{2}\right) \\
& =\frac{1}{(1-t)}\left(\ell\left(A / F_{1}\right)+\left(\ell\left(F_{1} / F_{2}\right)-\ell\left(A / F_{1}\right)\right) t+\left(e_{1}(\mathcal{F})-e_{0}(\mathcal{F})+\ell\left(A / F_{1}\right)\right) t^{2}\right)
\end{aligned}
$$

where the last equality follows from Equation (3.4).
(c) Let $Q=(x)$ a minimal reduction of $\mathcal{F}$. By Theorem 2.3 we have $r(\mathcal{F})=\operatorname{nr}(\mathcal{F})$ and $\ell\left(F_{n} / Q F_{n-1}\right)=1$ for all $2 \leq n \leq r(\mathcal{F})$. Let $r=r(\mathcal{F})$. Observe that for $1 \leq n \leq r-1$,

$$
\begin{array}{rlr}
\ell\left(F_{n} / F_{n+1}\right) & =\ell\left(A / F_{n+1}\right)-\ell\left(A / F_{n}\right) \\
& =\ell\left(A / x F_{n}\right)-\ell\left(F_{n+1} / x F_{n}\right)-\ell\left(A / F_{n}\right) \\
& =\ell(A /(x))+\ell\left((x) / x F_{n}\right)-\ell\left(F_{n+1} / x F_{n}\right)-\ell\left(A / F_{n}\right) \\
& =\ell(A /(x))+\ell\left(A / F_{n}\right)-\ell\left(F_{n+1} / x F_{n}\right)-\ell\left(A / F_{n}\right) & \left(\operatorname{as}(x) / x F_{n} \cong A / F_{n}\right) \\
& =e_{0}(\mathcal{F})-1 & \left.\quad \text { (since } e_{0}(\mathcal{F})=A /(x)\right) .
\end{array}
$$

Therefore

$$
\begin{aligned}
H S_{G(\mathcal{F})}(t) & =\ell\left(A / F_{1}\right)+\sum_{n=1}^{r-1} \ell\left(F_{n} / F_{n+1}\right) t^{n}+\sum_{n \geq r} e_{0}(\mathcal{F}) t^{n} \\
& =\ell\left(A / F_{1}\right)-e_{0}(\mathcal{F})+\sum_{n=1}^{r-1}\left(\ell\left(F_{n} / F_{n+1}\right)-e_{0}(\mathcal{F})\right) t^{n}+\frac{e_{0}(\mathcal{F})}{(1-t)} \\
& =\frac{1}{(1-t)}\left(\ell\left(A / F_{1}\right)-t\left(\ell\left(A / F_{1}\right)-e_{0}(\mathcal{F})\right)-(1-t) \sum_{n=1}^{r-1} t^{n}\right) \quad(\text { by equation (3.5) }) \\
& =\frac{1}{(1-t)}\left(\ell\left(A / F_{1}\right)+t\left(e_{0}(\mathcal{F})-\ell\left(A / F_{1}\right)\right)-t\left(1-t^{r-1}\right)\right) \\
& =\frac{1}{(1-t)}\left(\ell\left(A / F_{1}\right)+t\left(e_{0}(\mathcal{F})-\ell\left(A / F_{1}\right)-1\right)+t^{r}\right) .
\end{aligned}
$$

Using Proposition 3.3 we provide criteria for $G(\mathcal{F})$ to be Gorenstein in terms of the Hilbert coefficients.
Theorem 3.4. Let $(A, \mathfrak{m})$ be a one-dimensional Gorenstein local ring and $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration.
(a) $\operatorname{Let} r(\mathcal{F})=1$. Then $G(\mathcal{F})$ is Gorenstein if and only if $e_{0}(\mathcal{F})=2 e_{1}(\mathcal{F})$.
(b) Suppose there exists a minimal reduction $Q$ of $\mathcal{F}$ such that $r_{Q}(\mathcal{F})=2$ and $F_{2} \cap Q=Q F_{1}$. Then $G(\mathcal{F})$ is Gorenstein if and only if $e_{0}(\mathcal{F})=e_{1}(\mathcal{F})$.
(c) Suppose $r(\mathcal{F}) \geq 3, \operatorname{nr}(\mathcal{F})$ is maximal, and $G(\mathcal{F})$ is Cohen-Macaulay. Then $G(\mathcal{F})$ is Gorenstein if and only if $F_{1}=\mathfrak{m}$ and $e_{0}(\mathcal{F})=2$.

Proof. (a) By Lemma3.2 $G(\mathcal{F})$ is Cohen-Macaualy. By Proposition 3.3, we have

$$
H S_{G(\mathcal{F})}(t)=\frac{e_{0}(\mathcal{F})-e_{1}(\mathcal{F})+e_{1}(\mathcal{F}) t}{(1-t)}
$$

Note that $e_{1}(\mathcal{F}) \neq 0$. Using Theorem 3.1, we obtain $G(\mathcal{F})$ is Gorenstein if and only if $e_{0}(\mathcal{F})=2 e_{1}(\mathcal{F})$.
(b) By Lemma3.2 $G(\mathcal{F})$ is Cohen-Macaualy. Using Proposition 3.3, we have

$$
H S_{G(\mathcal{F})}(t)=\frac{1}{(1-t)}\left(\ell\left(A / F_{1}\right)+\left(\ell\left(F_{1} / F_{2}\right)-\ell\left(A / F_{1}\right)\right) t+\left(e_{1}(\mathcal{F})-e_{0}(\mathcal{F})+\ell\left(A / F_{1}\right)\right) t^{2}\right)
$$

By Theorem 3.1, we obtain $G(\mathcal{F})$ is Gorenstein if and only if $e_{0}(\mathcal{F})=e_{1}(\mathcal{F})$.
(c) By Proposition 3.3(c),

$$
H S_{G(\mathcal{F})}(t)=\frac{\ell\left(A / F_{1}\right)+\left(e_{0}(\mathcal{F})-\ell\left(A / F_{1}\right)-1\right) t+t^{r(\mathcal{F})}}{1-t}
$$

Using Theorem 3.1 we get $G(\mathcal{F})$ is Gorenstein if and only if $F_{1}=\mathfrak{m}$ and $e_{0}(\mathcal{F})=2$.
Following is an easy consequence of Theorem 3.4
Corollary 3.5. Let $(A, \mathfrak{m})$ be a one-dimensional analytically unramified Gorenstein local ring, I an $\mathfrak{m}$-primary ideal in $A$.
(a) Let $\bar{r}(I)=1$. Then $\bar{G}(I)$ is Gorenstein if and only if $e_{0}(I)=2 \bar{e}_{1}(I)$.
(b) Let $\bar{r}(I)=2$. Then $\bar{G}(I)$ is Gorenstein if and only if $e_{0}(I)=\bar{e}_{1}(I)$.
(c) Suppose $\bar{r}(I)=r \geq 3$ and $\operatorname{nr}(I)$ is maximal. Then $\bar{G}(I)$ is Gorenstein if and only if $\bar{I}=\mathfrak{m}$ and $e_{0}(I)=2$.

Note that if $(A, \mathfrak{m})$ is a positive dimensional Cohen-Macaulay local ring and $I$ is an $\mathfrak{m}$-primary ideal, then depth $\bar{G}(I) \geq 1$ by [15, Proposition 3.25]. In particular, if $\operatorname{dim} A=1$, then $\bar{G}(I)$ is Cohen-Macaulay.

Next, we give examples of one-dimensional semigroup rings and apply our results.
Definition 3.6. Let $m_{1}<m_{2}<\cdots<m_{n}$ be positive integers with $\operatorname{gcd}\left(m_{1}, m_{2}, \ldots, m_{n}\right)=1$, and $S$ be the semigroup generated by $m_{1}, m_{2}, \ldots, m_{n}$. Then the Fröbenius number $F(S)$ of $S$ is defined as the smallest integer $k$ such that $n \in S$ for all $n>k$.

Lemma 3.7. Let $A=K \llbracket t^{m_{1}}, t^{m_{2}}, \ldots, t^{m_{n}} \rrbracket$ be a semigroup ring of the semigroup generated by $m_{1}<m_{2}<\cdots<m_{n}$ with $\operatorname{gcd}\left(m_{1}, m_{2}, \ldots, m_{n}\right)=1$. Then $\bar{r}(\mathfrak{m})=\left\lceil\frac{F(S)}{m_{1}}\right\rceil$.
Proof. We note that $Q=\left(t^{m_{1}}\right)$ is a minimal reduction of $\mathfrak{m}=\left(t^{m_{1}}, t^{m_{2}}, \ldots, t^{m_{n}}\right)$, the maximal ideal of $A$. By [6. Example 7.3] we have $\overline{\mathfrak{m}^{i}}=\left\{\alpha \in A \mid \operatorname{ord}(\alpha) \geq m_{1} i\right\}$ where ord $(\alpha)$ is the degree of the initial form of $\alpha$. Indeed, the natural inclusion map $A \rightarrow K \llbracket t \rrbracket$ is an integral extension. We have $\bar{I}=\overline{I K \llbracket t \rrbracket} \cap A$ for any ideal $I$ in $A$. Since $K \llbracket t \rrbracket$ is a PID, $\left(t^{m_{1}}\right) K \llbracket t \rrbracket$ is integrally closed. As $Q=\left(t^{m_{1}}\right)$ is a minimal reduction of $\mathfrak{m}, \overline{Q^{i}}=\overline{\mathfrak{m}^{i}}$. Let $k$ be the smallest integer such that $m_{1} k>F(S)$.

Consider $\overline{\mathfrak{m}^{k}}=\left(t^{m_{1} k}, t^{m_{1} k+1}, \cdots\right)$. Hence

$$
\overline{Q \mathfrak{m}^{k}}=\left(t^{m_{1}(k+1)}, t^{m_{1}(k+1)+1} \ldots\right)=\overline{\mathfrak{m}^{k+1}}
$$

Therefore $\bar{r}(\mathfrak{m}) \leq k$.
By the definition of the Fröbenius number $m_{1}(k-1) \neq F(S)$. Hence, $m_{1}(k-1)<F(S)$. Hence $F(S)+$ $m_{1}>m_{1} k$. Therefore $t^{F(S)+m_{1}} \in \overline{\mathfrak{m}^{k}}$. Suppose $t^{F(S)+m_{1}} \in Q_{\mathfrak{m}^{k-1}}$. Then $t^{F(S)+m_{1}}=t^{m_{1}} b$ where $b \in A$. Since $t^{m_{1}}$ is a regular element in $k \llbracket t \rrbracket$, we obtain $t^{F(S)}=b \in A$. This is a contradiction. Hence $t^{F(S)+m_{1}} \in$ $\overline{m^{k}} \backslash Q \overline{\mathfrak{m}^{k-1}}$. Therefore $\bar{r}(\mathfrak{m})=k$.

Example 3.8. Let $A=K \llbracket t^{3}, t^{4} \rrbracket$ be a semigroup ring generated by $t^{3}$ and $t^{4}$. The Fröbenius number $F(S)$ of the semigroup $S=\mathbb{N} 3+\mathbb{N} 4$ is 5 . Since $S$ is symmetric, $A$ is Gorenstein. Also, $\overline{\mathfrak{m}^{i}}=\{\alpha \in A \mid \operatorname{ord}(\alpha) \geq 3 i\}$. Note that $Q=\left(t^{3}\right)$ is a minimal reduction of $\mathfrak{m}$. Hence by Lemma $3.7 \bar{r}(\mathfrak{m})=2$. Since depth $\bar{G}(m) \geq 1$, $\bar{G}(\mathfrak{m})$ is Cohen-Macaulay. Using equation 3.1, $\bar{n}(\mathfrak{m})=2-1=1$. Hence $\bar{P}_{\mathfrak{m}}(n)=\bar{H}_{\mathfrak{m}}(n)$ for all $n \geq 2$. Therefore to calculate $e_{0}(\mathfrak{m})$ and $\overline{e_{1}}(m)$ we solve the following two equations:

$$
\begin{aligned}
2 e_{0}(\mathfrak{m})-\overline{e_{1}}(\mathfrak{m}) & =\ell\left(A / \overline{\mathfrak{m}^{2}}\right) \\
3 e_{0}(\mathfrak{m})-\overline{e_{1}}(\mathfrak{m}) & =\ell\left(A / \overline{\mathfrak{m}^{3}}\right)
\end{aligned}
$$

Since $\ell\left(A / \overline{\mathfrak{m}^{2}}\right)=3, \ell\left(A / \overline{\mathfrak{m}^{3}}\right)=6$, we obtain $e_{0}(\mathfrak{m})=3$ and $\overline{e_{1}}(\mathfrak{m})=3$. Since $e_{0}(\mathfrak{m})=\overline{e_{1}}(\mathfrak{m})$, by Theorem 3.4 $\bar{G}(\mathfrak{m})$ is Gorenstein.

Example 3.9. Let $A=K \llbracket t^{2}, t^{m} \rrbracket$ be a semigroup ring generated by $t^{2}$ and $t^{m}$ where $m$ is an odd integer $\geq 3$. The Fröbenius number $F(S)$ of the semigroup $S=\mathbb{N} 2+\mathbb{N} m$ is $m-2$. Since $S$ is symmetric, $A$ is Gorenstein. Also, $\overline{\mathfrak{m}^{i}}=\{\alpha \in A \mid \operatorname{ord}(\alpha) \geq 2 i\}$. Note that $Q=\left(t^{2}\right)$ is a minimal reduction of $\mathfrak{m}$. Hence by Lemma $3.7 \bar{r}(\mathfrak{m})=(m-1) / 2$. Therefore $\bar{P}_{\mathfrak{m}}(n)=\bar{H}_{\mathfrak{m}}(n)$ for all $n \geq(m-1) / 2$.
Also,

$$
\begin{aligned}
& \ell\left(A / \overline{\mathfrak{m}^{(m-1) / 2}}\right)=(m-3) / 2+1=(m-1) / 2 \\
& \ell\left(A / \overline{\mathfrak{m}^{(m+1) / 2}}\right)=(m-3) / 2+3=(m+3) / 2
\end{aligned}
$$

Hence

$$
\begin{aligned}
& e_{0}(\mathfrak{m})((m-1) / 2)-\overline{e_{1}}(\mathfrak{m})=(m-1) / 2, \\
& e_{0}(\mathfrak{m})((m+1) / 2)-\overline{e_{1}}(\mathfrak{m})=(m+3) / 2 .
\end{aligned}
$$

Therefore $e_{0}(\mathfrak{m})=2$ and $\overline{e_{1}}(\mathfrak{m})=(m-1) / 2$. Hence $\bar{r}(\mathfrak{m})=\overline{e_{1}}(\mathfrak{m})-e_{0}(\mathfrak{m})+\ell(A / \bar{m})+1$. Therefore by Corollary $3.5 \bar{G}(\mathfrak{m})$ is Gorenstein.

Example 3.10. Let $A=K \llbracket t^{4}, t^{5}, t^{6} \rrbracket$ be a semigroup ring generated by 4,5 and 6 . The Fröbenius number of the semigroup $F(S)=7$. Since $S$ is symmetric, $A$ is Gorenstein. Let $Q=\left(t^{4}\right)$. Then $Q$ is a minimal reduction of $\mathfrak{m}$. By Lemma 3.7we get $\bar{r}(\mathfrak{m})=2$. Using similar arguments as above we obtain $e_{0}(\mathfrak{m})=4$ and $\overline{\rho_{1}}(\mathfrak{m})=4$. Hence by Corollary $3.5 \bar{G}(\mathfrak{m})$ is Gorenstein.

The following example is from [6, Example 7.3]. They prove that $\bar{G}(\mathfrak{m})$ is not Gorenstein. We also prove the same by using our techniques.

Example 3.11. Let $A=K \llbracket t^{4}, t^{6}, t^{7} \rrbracket$ be a semigroup ring generated by 4,6 and 7 . The Fröbenius number of the semigroup $F(S)=9$ and the semigroup is symmetric. Hence $A$ is a one-dimensional Gorenstein local ring. Let $\mathfrak{m}=\left(t^{4}, t^{6}, t^{7}\right)$. Then $\overline{\mathfrak{m}^{i}}=\{\alpha \in A \mid \operatorname{ord}(\alpha) \geq 4 i\}$, and $Q=\left(t^{4}\right)$ is a minimal reduction of $\mathfrak{m}$ with reduction number $\bar{r}(\mathfrak{m})=3$ by Lemma 3.7 Since the depth $\bar{G}(\mathfrak{m}) \geq 1, \bar{G}(\mathfrak{m})$ is Cohen-Macaulay. By equation 3.1 $\bar{n}(\mathfrak{m})=3-1=2$. Hence $\bar{P}_{\mathfrak{m}}(n)=\bar{H}_{\mathfrak{m}}(n)$ for all $n \geq 3$. Therefore to calculate $e_{0}(\mathfrak{m})$ and $\bar{e}_{1}(m)$ we solve the following two equations:

$$
\begin{aligned}
3 e_{0}(\mathfrak{m})-\overline{e_{1}}(\mathfrak{m}) & =\ell\left(A / \overline{\mathfrak{m}^{3}}\right) \\
4 e_{0}(\mathfrak{m})-\overline{e_{1}}(\mathfrak{m}) & =\ell\left(A / \overline{\mathfrak{m}^{4}}\right) .
\end{aligned}
$$

Since $\ell\left(A / \overline{\mathfrak{m}^{3}}\right)=7$ and $\ell\left(A / \overline{\mathfrak{m}^{4}}\right)=11$, we get $e_{0}(\mathfrak{m})=4$ and $\overline{\rho_{1}}(\mathfrak{m})=5$. Since $\bar{G}(\mathfrak{m})$ is Cohen-Macaulay, by Theorem 2.3] $n \mathbf{r}(\mathfrak{m})=\bar{r}(\mathfrak{m})$. We have

$$
\overline{e_{1}}(\mathfrak{m})-e_{0}(\mathfrak{m})+\ell(A / \mathfrak{m})+1=5-4+1+1=3=\operatorname{nr}(\mathfrak{m}) .
$$

Since $e_{0}(\mathfrak{m})=4$, by Theorem $3.5 \bar{G}(\mathfrak{m})$ is not Gorenstein.

## 4. Gorensteinness of $G(\mathcal{F})$ IN Dimension $d \geq 2$ And $r(\mathcal{F}) \leq 2$

Let $(A, \mathfrak{m})$ be a $d$-dimensional Gorenstein local ring where $d \geq 2$ and $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration. In this section, we determine criteria for $G(\mathcal{F})$ to be Gorenstein in terms of the Hilbert coefficients in arbitrary dimension $d \geq 2$ when $r(\mathcal{F}) \leq 2$. A reason for the assumption $r(\mathcal{F}) \leq 2$ is that we are able to compute the Hilbert series of $G(\mathcal{F})$ in this case, and hence use Theorem 3.1. As a consequence we recover the criterion proved in [19, Theorem 2.1].

Proposition 4.1. Let $(A, \mathfrak{m})$ be a d-dimensional Cohen-Macaulay local ring where $d \geq 2$ and $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration.
(a) $\operatorname{If} r(\mathcal{F})=1$, then $H S_{G(\mathcal{F})}(t)=\frac{\left(e_{0}(\mathcal{F})-e_{1}(\mathcal{F})\right)+e_{1}(\mathcal{F}) t}{(1-t)}$.
(b) Suppose there exists a minimal reduction $Q$ of $\mathcal{F}$ such that $r_{Q}(\mathcal{F})=2$ and $F_{2} \cap Q=Q F_{1}$. Then

$$
H S_{G(\mathcal{F})}(t)=\frac{1}{(1-t)^{d}}\left(\left[e_{0}(\mathcal{F})-e_{1}(\mathcal{F})+e_{2}(\mathcal{F})\right]+\left(e_{1}(\mathcal{F})-2 e_{2}(\mathcal{F})\right) t+e_{2}(\mathcal{F}) t^{2}\right) .
$$

Proof. (a) By Lemma $3.2 G(\mathcal{F})$ is Cohen-Macaualy. Hence using Equation (3.1) we obtain that $n(\mathcal{F})=$ $1-d \leq-1$. Therefore $P_{\mathcal{F}}(n)=H_{\mathcal{F}}(n)$ for all $n \geq 0$. Since $G(\mathcal{F})$ is Cohen-Macaulay and $r(\mathcal{F})=1$, by [7, Proposition 4.6] $e_{i}(\mathcal{F})=0$ for all $i \geq 2$. Therefore for all $n \geq 0$

$$
\begin{equation*}
\ell\left(F_{n} / F_{n+1}\right)=\ell\left(A / F_{n+1}\right)-\ell\left(A / F_{n}\right)=e_{0}(\mathcal{F})\binom{n+d-1}{d-1}-e_{1}(\mathcal{F})\binom{n+d-2}{d-2} \tag{4.1}
\end{equation*}
$$

Hence

$$
\begin{aligned}
H S_{G(\mathcal{F})}(t) & =\sum_{n \in \mathbb{Z}} \ell\left(F_{n} / F_{n+1}\right) t^{n} \\
& =\sum_{n \geq 0}\left[e_{0}(\mathcal{F})\binom{n+d-1}{d-1}-e_{1}(\mathcal{F})\binom{n+d-2}{d-2}\right] t^{n} \quad \text { (by Equation (4.1)) } \\
& =\frac{e_{0}(\mathcal{F})}{(1-t)^{d}}-\frac{e_{1}(\mathcal{F})}{(1-t)^{d-1}} \\
& =\frac{\left[e_{0}(\mathcal{F})-e_{1}(\mathcal{F})\right]+e_{1}(\mathcal{F}) t}{(1-t)^{d}}
\end{aligned}
$$

(b) By Lemma $3.2 G(\mathcal{F})$ is Cohen-Macaualy.

Case 1: $d=2$. Then $n(\mathcal{F})=0$. Therefore $P_{\mathcal{F}}(n)=H_{\mathcal{F}}(n)$ for all $n \geq 1$. In particular, when $n=1$ we have

$$
\begin{equation*}
\ell\left(A / F_{1}\right)=e_{0}(\mathcal{F})-e_{1}(\mathcal{F})+e_{2}(\mathcal{F}) \tag{4.2}
\end{equation*}
$$

The Hilbert series of $G(\mathcal{F})$ is given by

$$
\begin{aligned}
H S_{G(\mathcal{F})}(t) & =\sum_{n \in \mathbb{Z}} \ell\left(F_{n} / F_{n+1}\right) t^{n} \\
& =\ell\left(A / F_{1}\right)-e_{0}(\mathcal{F})+e_{1}(\mathcal{F})+\sum_{n \geq 0}\left(e_{0}(\mathcal{F})(n+1)-e_{1}(\mathcal{F})\right) t^{n} \\
& =e_{2}(\mathcal{F})+\frac{e_{0}(\mathcal{F})}{(1-t)^{2}}-\frac{e_{1}(\mathcal{F})}{(1-t)} \\
& =\frac{1}{(1-t)^{2}}\left(e_{2}(\mathcal{F})(1-t)^{2}+\left(e_{0}(\mathcal{F})-e_{1}(\mathcal{F})\right)+e_{1}(\mathcal{F}) t\right) \\
& =\frac{1}{(1-t)^{2}}\left(\left(e_{0}(\mathcal{F})-e_{1}(\mathcal{F})+e_{2}(\mathcal{F})\right)+\left(e_{1}(\mathcal{F})-2 e_{2}(\mathcal{F})\right) t+e_{2}(\mathcal{F}) t^{2}\right)
\end{aligned}
$$

Case 2: $d \geq$ 3. Then $n(\mathcal{F}) \leq-1$. Hence $P_{\mathcal{F}}(n)=H_{\mathcal{F}}(n)$ for all $n \geq 0$, and

$$
P_{\mathcal{F}}(n)=e_{0}(\mathcal{F})\binom{n+d-1}{d}-e_{1}(\mathcal{F})\binom{n+d-2}{d-1}+e_{2}(\mathcal{F})\binom{n+d-3}{d-2}
$$

The Hilbert series of $G(\mathcal{F})$ is given by

$$
\begin{aligned}
H S_{G(\mathcal{F})}(t) & =\sum_{n \in \mathbb{Z}} \ell\left(F_{n} / F_{n+1}\right) t^{n} \\
& =\sum_{n \geq 0}\left[e_{0}(\mathcal{F})\binom{n+d-1}{d-1}-e_{1}(\mathcal{F})\binom{n+d-2}{d-2}+e_{2}(\mathcal{F})\binom{n+d-3}{d-3}\right] t^{n} \\
& =\frac{e_{0}(\mathcal{F})}{(1-t)^{d}}-\frac{e_{1}(\mathcal{F})}{(1-t)^{d-1}}+\frac{e_{2}(\mathcal{F})}{(1-t)^{d-2}} \\
& =\frac{1}{(1-t)^{d}}\left(e_{0}(\mathcal{F})-e_{1}(\mathcal{F})(1-t)+e_{2}(\mathcal{F})(1-t)^{2}\right) \\
& =\frac{1}{(1-t)^{d}}\left(\left(e_{0}(\mathcal{F})-e_{1}(\mathcal{F})+e_{2}(\mathcal{F})\right)+\left(e_{1}(\mathcal{F})-2 e_{2}(\mathcal{F})\right) t+e_{2}(\mathcal{F}) t^{2}\right)
\end{aligned}
$$

Theorem 4.2. Let $(A, \mathfrak{m})$ be a d-dimensional Gorenstein local ring of dimension $d \geq 2$. Let $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration.
(a) $\operatorname{Let} r(\mathcal{F})=1$. Then $G(\mathcal{F})$ is Gorenstein if and only if $e_{0}(\mathcal{F})=2 e_{1}(\mathcal{F})$.
(b) Suppose there exists a minimal reduction $Q$ of $\mathcal{F}$ such that $r_{Q}(\mathcal{F})=2$ and $F_{2} \cap Q=Q F_{1}$. Then $G(\mathcal{F})$ is Gorenstein if and only if $e_{0}(\mathcal{F})=e_{1}(\mathcal{F})$.

Proof. In both the cases, by Lemma $3.2 G(\mathcal{F})$ is Cohen-Macaulay.
(a) By Proposition 4.1,

$$
H S_{G(\mathcal{F})}(t)=\frac{\left[e_{0}(\mathcal{F})-e_{1}(\mathcal{F})\right]+e_{1}(\mathcal{F}) t}{(1-t)^{d}}
$$

By Theorem 3.1, $G(\mathcal{F})$ is Gorenstein if and only if $e_{0}(\mathcal{F})-e_{1}(\mathcal{F})=e_{1}(\mathcal{F})$. Hence the result follows.
(b) Using Proposition 4.1.

$$
H S_{G(\mathcal{F})}(t)=\frac{1}{(1-t)^{d}}\left(e_{0}(\mathcal{F})-e_{1}(\mathcal{F})+e_{2}(\mathcal{F})+\left(e_{1}(\mathcal{F})-2 e_{2}(\mathcal{F})\right) t+e_{2}(\mathcal{F}) t^{2}\right)
$$

By Theorem 3.1, $G(\mathcal{F})$ is Gorenstein if and only if $e_{0}(\mathcal{F})-e_{1}(\mathcal{F})+e_{2}(\mathcal{F})=e_{2}(\mathcal{F})$. Hence the result follows.

Now we recover the result in [19, Theorem 2.1]. Moreover, we extend it for any $d$-dimensional analytically unramified Gorenstein local ring.

Corollary 4.3. Let $(A, \mathfrak{m})$ be a d-dimensional analytically unramified Gorenstein local ring of dimension $d \geq 2$, and I an $\mathfrak{m}$-primary ideal in $A$.
(a) If $\bar{r}(I)=1$, then $\bar{G}(I)$ is Gorenstein if and only if $e_{0}(I)=2 \bar{e}_{1}(I)$.
(b) If $\bar{r}(I)=2$, then $\bar{G}(I)$ is Gorenstein if and only if $e_{0}(I)=\bar{e}_{1}(I)$.

Proof. (a) If $\bar{r}(I)=1$, then the result follows by Theorem4.2.
(b) Let $\bar{r}(I)=2$. By [11, Theorem 1], we obtain $Q \cap \overline{I^{2}}=Q \bar{I}$. By Theorem4.2, the result follows.

Below we provide criteria for $G(\mathcal{F})$ to be Gorenstein under the additional assumption that $\operatorname{nr}(\mathcal{F})$ is maximal.

Corollary 4.4. Let $(A, \mathfrak{m})$ be a d-dimensional Gorenstein local ring of dimension $d \geq 2$, and $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration. Suppose $\operatorname{nr}(\mathcal{F})$ is maximal.
(a) If $r(\mathcal{F})=1$, then $G(\mathcal{F})$ is Gorenstein if and only if $e_{0}(\mathcal{F})=2 \ell\left(A / F_{1}\right)$.
(b) Suppose there exists a minimal reduction $Q$ of $\mathcal{F}$ such that $r_{Q}(\mathcal{F})=2$ and $F_{2} \cap Q=Q F_{1}$. Then $G(\mathcal{F})$ is Gorenstein if and only if $F_{1}=\mathfrak{m}$.

Proof. (a) By Lemma $3.2 G(\mathcal{F})$ is Cohen-Macaulay. Hence by Theorem 2.3, $\operatorname{nr}(\mathcal{F})=r(\mathcal{F})$. Therefore by assumption

$$
\begin{equation*}
e_{1}(\mathcal{F})=e_{0}(\mathcal{F})-\ell\left(A / F_{1}\right) \tag{4.3}
\end{equation*}
$$

By Theorem 4.2, $G(\mathcal{F})$ is Gorenstein if and only if $e_{0}(\mathcal{F})=2 e_{1}(\mathcal{F})$. Substituting $e_{1}(\mathcal{F})$ from equation 4.3, we obtain the result.
(b) By Lemma $3.2 G(\mathcal{F})$ is Cohen-Macaulay. Hence by Theorem 2.3, $\operatorname{nr}(\mathcal{F})=r(\mathcal{F})$. Therefore by assumption

$$
\begin{equation*}
e_{1}(\mathcal{F})-e_{0}(\mathcal{F})+\ell\left(A / F_{1}\right)=1 \tag{4.4}
\end{equation*}
$$

By Theorem 4.2, $G(\mathcal{F})$ is Gorenstein if and only if $e_{0}(\mathcal{F})=e_{1}(\mathcal{F})$. Hence by equation 4.4, we obtain the result.

Applying the above result for the filtration $\left\{\overline{I^{n}}\right\}_{n \in \mathbb{Z}}$ we obtain the following result:
Corollary 4.5. Let $(A, \mathfrak{m})$ be a d-dimensional analytically unramified Gorenstein local ring, and I an $\mathfrak{m}$-primary ideal in $A$. Suppose $\operatorname{nr}(I)$ is maximal.
(a) If $\bar{r}(I)=1$, then $\bar{G}(I)$ is Gorenstein if and only if $\bar{e}_{0}(I)=2 \ell(A / \bar{I})$.
(a) If $\bar{r}(I)=2$, then $\bar{G}(I)$ is Gorenstein if and only if $\bar{I}=\mathfrak{m}$.

Proof. Follows from Corollary 4.4

## 5. Gorensteinness of $G(\mathcal{F})$ In dimension two

In this section we present results on Gorensteinness of $G(\mathcal{F})$ in two-dimensional Gorenstein local rings. If $r(\mathcal{F}) \leq 2$, the Gorensteinness of $G(\mathcal{F})$ is characterized in Section 4 In this section we consider the case $r(\mathcal{F}) \geq 3$. In order to use Theorem 3.1 we need to compute the Hilbert series of $G(\mathcal{F})$. This is not easy when $r(\mathcal{F}) \geq 3$ even in dimension two. In this section we compute the Hilbert series of $G(\mathcal{F})$ in dimension two under the assumption that the relative reduction number is maximal. As a consequence we characterize the Gorensteinness of $G(\mathcal{F})$ in terms of the Hilbert coefficients of $\mathcal{F}$.

Let $(A, \mathfrak{m})$ be a two-dimensional Cohen-Macaulay local ring, and $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration. Let depth $G(\mathcal{F}) \geq 1$. Then we can find $a, b \in F_{1} \backslash \mathfrak{m} F_{1}$ such that $Q=(a, b)$ a minimal reduction of $F_{1}$ where $a^{*}$ is regular in $G(\mathcal{F})$ (see [15, Proposition A.2.4] and [7, Lemma 2.1]).

We need the following lemmas in order to compute the Hilbert series of $G(\mathcal{F})$.
Lemma 5.1. Let $(A, \mathfrak{m})$ be a two-dimensional Cohen-Macaulay local ring, and $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration. Let depth $G(\mathcal{F}) \geq 1$, and $Q=(a, b)$ a minimal reduction of $F_{1}$ where $a^{*}$ is regular in $G(\mathcal{F})$. Then for all $n \geq 1$,

$$
\ell\left(Q / Q F_{n}\right)=2 \ell\left(A / F_{n}\right)-\ell\left(A / F_{n-1}\right)
$$

Proof. Consider the $A$-module homomorphism

$$
f: A / F_{n} \oplus A / F_{n} \rightarrow Q / Q F_{n}
$$

defined by $f(\bar{x}, \bar{y})=\overline{a x+b y}$ for $x, y \in A$ where $\bar{x}, \bar{y}$ denote the image of $x, y \in A / F_{n}$ and $\overline{a x+b y}$ is the image of $a x+b y \in Q / Q F_{n}$. Then $\operatorname{ker}(f)=\left\{(\bar{r}, \bar{s}) \mid r a+s b \in Q F_{n}\right\}$. Let $(\bar{r}, \bar{s}) \in \operatorname{ker}(f)$, then $r a+s b=$ $a p+b q$ for some $p, q \in F_{n}$. Hence

$$
\begin{equation*}
a(r-p)+b(s-q)=0 \tag{5.1}
\end{equation*}
$$

Since $a, b$ is a regular sequence in $A$, we get $r-p=b t$ for some $t \in A$. Substituting in equation (5.1) we obtain $s-q=-a t$, hence $(\bar{r}, \bar{s})=t(\bar{b},-\bar{a})$. Therefore $\operatorname{ker}(f)=(\bar{b},-\bar{a}) A$.

Consider $\varphi: A \rightarrow(\bar{b},-\bar{a}) A$ an $A$-module homomorphism given by

$$
\varphi(r)=(r \bar{b},-r \bar{a})
$$

Then $\varphi$ is surjective and $\operatorname{ker}(\varphi)=\left(F_{n}: a\right) \cap\left(F_{n}: b\right)$. Note that $F_{n-1}=\left(F_{n}: a\right)$, since $a^{*}$ is a nonzerodivisor in $G(\mathcal{F})$. Indeed, if $x \in\left(F_{n}: a\right)$, then $x a \in F_{n} \cap(a)=a F_{n-1}$ by [7, Proposition 3.5]. Moreover, since $a$ is a nonzerodivisor in $A, x \in F_{n-1}$. Clearly $F_{n-1} \subseteq\left(F_{n}: b\right)$. Thus $\operatorname{ker}(\varphi)=F_{n-1}$. Hence we have $(\bar{b},-\bar{a}) A \cong A / F_{n-1}$. Therefore

$$
0 \longrightarrow A / F_{n-1} \longrightarrow A / F_{n} \oplus A / F_{n} \longrightarrow Q / Q F_{n} \longrightarrow 0
$$

is an exact sequence and the result follows.
Lemma 5.2. Let $(A, \mathfrak{m})$ be a two-dimensional Cohen-Macaulay local ring, and $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration. Let depth $G(\mathcal{F}) \geq 1$. Suppose $\operatorname{nr}(\mathcal{F})$ is maximal. Then for all $1 \leq n \leq \operatorname{nr}(\mathcal{F})-1$,

$$
f(n):=\ell\left(F_{n} / F_{n+1}\right)=n\left(e_{0}(\mathcal{F})-1\right)+\ell\left(A / F_{1}\right)
$$

Proof. We first claim that $\ell\left(F_{n} / F_{n+1}\right)=e_{0}(\mathcal{F})-1+\ell\left(F_{n-1} / F_{n}\right)$ for all $1 \leq n \leq \operatorname{nr}(\mathcal{F})-1$. Let $Q=(a, b)$ be a minimal reduction of $\mathcal{F}$ such that $a^{*}$ is a nonzerodivisor on $G(\mathcal{F})$. Since

$$
Q F_{n} \subseteq F_{n+1} \subseteq F_{n} \subseteq A \quad \text { and } \quad Q F_{n} \subseteq Q \subseteq A
$$

we have

$$
\begin{aligned}
\ell\left(F_{n} / F_{n+1}\right) & =\ell\left(A / Q F_{n}\right)-\ell\left(A / F_{n}\right)-\ell\left(F_{n+1} / Q F_{n}\right) \\
& =e_{0}(\mathcal{F})+\ell\left(Q / Q F_{n}\right)-\ell\left(A / F_{n}\right)-\ell\left(F_{n+1} / Q F_{n}\right) \\
& =e_{0}(\mathcal{F})+2 \ell\left(A / F_{n}\right)-\ell\left(A / F_{n-1}\right)-\ell\left(A / F_{n}\right)-\ell\left(F_{n+1} / Q F_{n}\right) \\
& =e_{0}(\mathcal{F})+\ell\left(A / F_{n}\right)-\ell\left(A / F_{n-1}\right)-\ell\left(F_{n+1} / Q F_{n}\right) \\
& =e_{0}(\mathcal{F})+\ell\left(F_{n-1} / F_{n}\right)-\ell\left(F_{n+1} / Q F_{n}\right)
\end{aligned}
$$

Using Theorem 2.3 we have $\ell\left(F_{n+1} / Q F_{n}\right)=1$ for all $1 \leq n \leq \operatorname{nr}(\mathcal{F})-1$. Hence the claim follows. Therefore, for $1 \leq n \leq \operatorname{nr}(\mathcal{F})-1$, we have

$$
\begin{aligned}
f(n) & =e_{0}(\mathcal{F})-1+f(n-1) \\
f(n-1) & =e_{0}(\mathcal{F})-1+f(n-2) \\
& \vdots \\
f(1) & =e_{0}(\mathcal{F})-1+\ell\left(A / F_{1}\right)
\end{aligned}
$$

Adding all the equalities above, we obtain $f(n)=n\left(e_{0}(\mathcal{F})-1\right)+\ell\left(A / F_{1}\right)$.
Now we compute the Hilbert series of $G(\mathcal{F})$ when $\operatorname{nr}(\mathcal{F})$ is maximal.

Proposition 5.3. Let $(A, \mathfrak{m})$ be a two-dimensional Cohen-Macaulay local ring, and $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration. Let depth $G(\mathcal{F}) \geq 1$, and $\operatorname{nr}(\mathcal{F})=r \geq 3$. Suppose $\operatorname{nr}(\mathcal{F})$ is maximal. Then

$$
H S_{G(\mathcal{F})}(t)=\frac{\ell\left(A / F_{1}\right)+\left(e_{1}(\mathcal{F})-r\right) t+t^{r}}{(1-t)^{2}}
$$

Proof. Since $\operatorname{nr}(\mathcal{F})=e_{1}(\mathcal{F})-e_{0}(\mathcal{F})+\ell\left(A / F_{1}\right)+1$, by Theorem 2.3 we get, $\operatorname{nr}(\mathcal{F})=r(\mathcal{F})$. Let $r(\mathcal{F})=r$. By equation 3.1, $n(\mathcal{F})=r-2, P_{\mathcal{F}}(n)=H_{\mathcal{F}}(n)$ for all $n \geq r-1$. Therefore, for all $n \geq r-1$,

$$
\ell\left(F_{n} / F_{n+1}\right)=P_{\mathcal{F}}(n+1)-P_{\mathcal{F}}(n)
$$

Therefore

$$
\begin{aligned}
H S_{G(\mathcal{F})}(t)= & \sum_{n \in \mathbb{Z}} \ell\left(F_{n} / F_{n+1}\right) t^{n} \\
= & \sum_{n=0}^{r-2} \ell\left(F_{n} / F_{n+1}\right) t^{n}+\sum_{n \geq r-1} \ell\left(F_{n} / F_{n+1}\right) t^{n} \\
= & \sum_{n=0}^{r-2}\left(n\left(e_{0}(\mathcal{F})-1\right)+\ell\left(A / F_{1}\right)-e_{0}(\mathcal{F})(n+1)+e_{1}(\mathcal{F})\right) t^{n} \\
& +\sum_{n \geq 0}\left(e_{0}(\mathcal{F})(n+1)-e_{1}(\mathcal{F})\right) t^{n} \quad[\text { by Lemma[5.2] } \\
= & \sum_{n=0}^{r-2}\left(-n+\ell\left(A / F_{1}\right)-e_{0}(\mathcal{F})+e_{1}(\mathcal{F})\right) t^{n}+\frac{e_{0}(\mathcal{F})}{(1-t)^{2}}-\frac{e_{1}(\mathcal{F})}{(1-t)} \\
= & \frac{1}{(1-t)^{2}}\left(\sum_{n=1}^{r-2}\left(-n t^{n}\right)(1-t)^{2}+\sum_{n=0}^{r-2}\left(\ell\left(A / F_{1}\right)-e_{0}(\mathcal{F})+e_{1}(\mathcal{F})\right) t^{n}(1-t)^{2}\right) \\
& +\frac{1}{(1-t)^{2}}\left(e_{0}(\mathcal{F})-e_{1}(\mathcal{F})(1-t)\right) \\
= & \frac{1}{(1-t)^{2}}\left(\sum_{n=1}^{r-2}\left(-n t^{n}\right)(1-t)^{2}+\left(\ell\left(A / F_{1}\right)-e_{0}(\mathcal{F})+e_{1}(\mathcal{F})\right)\left(1-t^{r-1}\right)(1-t)\right) \\
& +\frac{1}{(1-t)^{2}}\left(-e_{1}(\mathcal{F})(1-t)+e_{0}(\mathcal{F})\right) \\
= & \frac{1}{(1-t)^{2}}\left(\sum_{n=1}^{r-2}\left(-n t^{n}\right)(1-t)^{2}+(r-1)\left(1-t^{r-1}\right)(1-t)-e_{1}(\mathcal{F})(1-t)+e_{0}(\mathcal{F})\right)
\end{aligned}
$$

Now for further simplification consider the $h$-vector,

$$
\begin{aligned}
h(t)= & \sum_{n=1}^{r-2}\left(-n t^{n}\right)(1-t)^{2}+(r-1)\left(1-t^{r-1}\right)(1-t)+e_{0}(\mathcal{F})-e_{1}(\mathcal{F})(1-t) \\
= & \sum_{n=1}^{r-2}\left(-n t^{n}\right)+2 \sum_{n=1}^{r-2} n t^{n+1}-\sum_{n=1}^{r-2} n t^{n+2}+(r-1)\left(1-t^{r-1}\right)(1-t)+e_{0}(\mathcal{F})-e_{1}(\mathcal{F})(1-t) \\
= & -t+\sum_{n=2}^{r-2}-n t^{n}+2 \sum_{n=2}^{r-2}(n-1) t^{n}+2(r-2) t^{r-1}+\sum_{n=2}^{r-2}-(n-2) t^{n}-(r-3) t^{r-1}-(r-2) t^{r} \\
& \quad+(r-1)\left(1-t^{r-1}-t+t^{r}\right)+e_{0}(\mathcal{F})-e_{1}(\mathcal{F})(1-t) \\
= & \left(e_{0}(\mathcal{F})-e_{1}(\mathcal{F})+r-1\right)+\left(-1-r+1+e_{1}(\mathcal{F})\right) t+(2 r-4-r+3-r+1) t^{r-1} \\
& \quad+(-r+2+r-1) t^{r} \\
= & \ell\left(A / F_{1}\right)+\left(e_{1}(\mathcal{F})-r\right) t+t^{r} .
\end{aligned}
$$

As a consequence, we obtain:
Theorem 5.4. Let $(A, \mathfrak{m})$ be a two-dimensional Gorenstein local ring, $\mathcal{F}=\left\{F_{n}\right\}_{n \in \mathbb{Z}}$ a Hilbert filtration. Let $G(\mathcal{F})$ be Cohen-Macaulay, and $\operatorname{nr}(\mathcal{F})=r \geq 3$. Suppose $\operatorname{nr}(\mathcal{F})$ is maximal. Then $G(\mathcal{F})$ is Gorenstein if and only if $F_{1}=\mathfrak{m}$ and $e_{0}(\mathfrak{m})=2$.

Proof. Since $\operatorname{nr}(\mathcal{F})=e_{1}(\mathcal{F})-e_{0}(\mathcal{F})+\ell\left(A / F_{1}\right)+1$, by Theorem 2.3 $\operatorname{nr}(\mathcal{F})=r(\mathcal{F})$. By Theorem 3.1 and Theorem5.3, we get $G(\mathcal{F})$ is Gorenstein if and only if $\ell\left(A / F_{1}\right)=1$ and $e_{1}(\mathcal{F})=r(\mathcal{F})$ if and only if $F_{1}=\mathfrak{m}$ and $e_{0}(\mathcal{F})=2$.

Applying Theorem 5.4 for the filtration $\left\{\overline{I^{n}}\right\}_{n \in \mathbb{Z}}$ we get the following result.
Corollary 5.5. Let $(A, \mathfrak{m})$ be a two-dimensional analytically unramified Gorenstein local ring, and I an $\mathfrak{m}$-primary ideal in $A$. Let $\operatorname{nr}(I) \geq 3$. Suppose $\operatorname{nr}(I)$ is maximal, and $\bar{G}(I)$ is Cohen-Macaulay. Then $\bar{G}(I)$ is Gorenstein if and only if $\bar{I}=\mathfrak{m}$ and $e_{0}(\mathfrak{m})=2$.

Proof. Follows from Theorem 5.4

## 6. GORENSTEINESS OF $\bar{G}(\mathfrak{m})$ IN ZARISKI-TYPE HYPERSURFACE RINGS

Consider the following setup in the rest of the paper. Let $K$ be an algebraically closed field, and let $m \geq 1$, $2 \leq a \leq b$ be integers, and put $S=K\left[\left[x_{0}, x_{1}, \ldots, x_{m}\right]\right]$ be a formal power series ring with $(m+1)$-variables over $K$. Then $S$ is a complete regular local ring with the unique maximal ideal $\mathfrak{m}_{S}=\left(x_{0}, x_{1}, \ldots, x_{m}\right)$. Put $x=x_{0}$ and $\underline{x}=x_{1}, \ldots, x_{m}$. Let $g, f$ be polynomials such that

$$
\begin{aligned}
& g=g(\underline{x}) \in(\underline{x})^{b} \backslash(\underline{x})^{b+1} \\
& f=f(x, \underline{x})=x^{a}-g(\underline{x})
\end{aligned}
$$

Then a hypersurface $A=S /(f)$ is called "Zariski-type hypersurface" if $a \neq 0$ in $K$. Let $Q=(\underline{x}) A$. Note that $Q$ is a minimal reduction of $\mathfrak{m}=\mathfrak{m}_{S} A$. Indeed, $\mathfrak{m}^{a}=Q \mathfrak{m}^{a-1}$. In this section, we compute $\overline{\mathbf{r}}(\mathfrak{m})$ and
prove the Cohen-Macaulayness of $\bar{G}(\mathfrak{m})$. The proof is a slight generalization of the proof in [18]. We fix the following notation for the rest of the paper:

$$
d=\operatorname{gcd}(a, b), \quad a^{\prime}=\frac{a}{d^{\prime}} \quad b^{\prime}=\frac{b}{d} \quad \text { and } \quad n_{k}=\left\lfloor\frac{k b}{a}\right\rfloor \quad \text { for } k=1,2, \ldots, a-1 .
$$

For all $n \geq 1$, we define the following two ideals:

$$
\begin{aligned}
J_{n} & :=Q^{n}+x Q^{n-n_{1}}+x^{2} Q^{n-n_{2}}+\cdots+x^{a-1} Q^{n-n_{a-1}}, \\
I_{n} & :=\left(x^{k} x_{1}^{i_{1}} \cdots x_{m}^{i_{m}} \mid k b^{\prime}+\left(i_{1}+\cdots+i_{m}\right) a^{\prime} \geq n, k, i_{1}, \ldots, i_{m} \in \mathbb{Z}_{\geq 0}\right) A .
\end{aligned}
$$

Proposition 6.1. $J_{n}=I_{n a^{\prime}}$ for every $n \geq 1$.
Proof. First we prove $J_{n} \subset I_{n a^{\prime}}$. It is enough to show $x^{k} Q^{n-n_{k}} \subset I_{n a^{\prime}}$ for every $k=1,2, \ldots, a-1$. For each $k$ with $1 \leq k \leq a-1$, if $i_{1}+\cdots+i_{m} \geq n-n_{k}$, then

$$
k b^{\prime}+\left(i_{1}+\cdots+i_{m}\right) a^{\prime} \geq k b^{\prime}+\left(n-n_{k}\right) a^{\prime} \geq k b^{\prime}+\left(n-\frac{k b^{\prime}}{a^{\prime}}\right) a^{\prime}=n a^{\prime},
$$

as required. Next we prove the converse. If $x^{k} x_{1}^{i_{1}} \cdots x_{m}^{i_{m}} \in I_{n a^{\prime}}$, then $k b^{\prime}+\left(i_{1}+\cdots+i_{m}\right) a^{\prime} \geq n a^{\prime}$. Thus

$$
n_{k}=\left\lfloor\frac{k b^{\prime}}{a^{\prime}}\right\rfloor \geq n-\left(i_{1}+\cdots+i_{m}\right), \text { that is, } i_{1}+\cdots+i_{m} \geq n-n_{k} .
$$

Hence $x^{k} x_{1}^{i_{1}} \cdots x_{m}^{i_{m}} \in x^{k} Q^{n-n_{k}}$. This yields $I_{n a^{\prime}} \subset J_{n}$.
Proposition 6.2. Under the notation above,
(a) For every $k, n \geq 1, x^{k} \in \overline{Q^{n}}$ if and only if $n \leq n_{k}$.
(b) $Q^{n} \subset J_{n} \subset \overline{Q^{n}}$, that is, $\overline{J_{n}}=\overline{Q^{n}}$ for each $n \geq 1$.

Proof. (a) We first show that if $n \leq n_{k}$ then $x^{k} \in \overline{Q^{n}}$. By definition of $n_{k}$, we get

$$
\left(x^{k}\right)^{a}=x^{k a} \in\left(Q^{b}\right)^{k}=Q^{k b} \subset Q^{a n_{k}}=\left(Q^{n_{k}}\right)^{a} .
$$

Hence $x^{k} \in \overline{Q^{n_{k}}} \subset \overline{Q^{n}}$.
Suppose $x^{k} \in \overline{Q^{n}}$. We will show $n \leq n_{k}$. By assumption, there exists a nonzero divisor $c \in A$ such that $c\left(x^{k}\right)^{\ell} \subset Q^{n \ell}$ for sufficiently large $\ell$. By Artin-Rees' lemma, we can take an integer $\ell_{0} \geq 1$ such that if $\ell \gg 0$, then $Q^{\ell} \cap c A=c\left(Q^{\ell}: c\right) \subset c Q^{\ell-\ell_{0}}$. Thus $Q^{\ell}: c \subset Q^{\ell-\ell_{0}}$ because $c$ is a nonzero divisor.

Now suppose that $n \geq n_{k}+1$. By the choice of $n_{k}$, we have

$$
\frac{k b}{a}+\frac{1}{a} \leq n_{k}+1 \leq n .
$$

Then $k b+1 \leq a\left(n_{k}+1\right) \leq a n$. If $\ell \geq \ell_{0}+1$, then

$$
g^{k \ell}=x^{a k \ell} \in Q^{a n \ell}: c \subset Q^{a n \ell-\ell_{0}} \subset Q^{(k b+1) \ell-\ell_{0}} \subset Q^{k b \ell+1} .
$$

Moreover, since $g \in Q^{b} \backslash Q^{b+1}$, if necessary, by replacing $\underline{x}=x_{1}, x_{2}, \ldots, x_{m}$ with $\underline{y}=y_{1}, \ldots, y_{m}$, the other minimal generators of $Q$, we may assume that $g \equiv x_{1}^{b}\left(\bmod \left(x_{2}, \ldots, x_{m}\right) A\right)$. Hence $\bar{x}_{1}^{b k \ell} \in\left(x_{1}^{k b \ell+1}, x_{2}, \ldots, x_{n}\right)$. This contradicts the fact that $x_{1}, x_{2}, \ldots, x_{m}$ forms a regular sequence on $A$.
(b) It is enough to show $x^{k} x_{1}^{i_{1}} \cdots x_{m}^{i_{m}} \in \overline{Q^{n}}$ if and only if $i_{1}+\cdots+i_{m} \geq n-n_{k}$. Since depth $\bar{G}(Q) \geq 1$, we have $\overline{Q^{n}}$ : $x_{j}=\overline{Q^{n-1}}$ for every $n, j$. So one can easily see that

$$
x^{k} x_{1}^{i_{1}} \cdots x_{m}^{i_{m}} \in \overline{Q^{n}} \Longleftrightarrow x^{k} \in \overline{Q^{n-\left(i_{1}+\cdots+i_{m}\right)}} .
$$

By (1), the last condition means that $i_{1}+\cdots+i_{m} \geq n-n_{k}$. Hence we get the required inclusions.

Set $\mathcal{I}=\left\{I_{n}\right\}_{n \in \mathbb{Z}}$, which is a filtration of ideals in $A$ introduced above and, $I_{n}=A$ for every integer $n \leq 0$. We put

$$
\mathcal{R}^{\prime}(\mathcal{I})=\bigoplus_{n \in \mathbb{Z}} I_{n} t^{n} \subset A\left[t, t^{-1}\right], \quad G(\mathcal{I})=\bigoplus_{n \geq 0} I_{n} / I_{n+1} \cong \mathcal{R}^{\prime}(\mathcal{I}) / t^{-1} \mathcal{R}^{\prime}(\mathcal{I})
$$

In the following, we set $\underline{x} t^{k}=x_{1} t^{k}, \ldots, x_{m} t^{k}$ and $\underline{Y}=Y_{1}, \ldots, Y_{m}$.
Lemma 6.3. Write $g=g_{b}+g_{b+1}+\cdots+g_{c}$, where $g_{i}$ denotes a homogeneous polynomial of degree $i=b, b+$ $1, \ldots, c$. Then $\mathcal{R}^{\prime}(\mathcal{I}) \cong A\left[x t^{b^{\prime}}, \underline{x} t^{a^{\prime}}, t^{-1}\right]$ and $G(\mathcal{I}) \cong K[X, \underline{Y}] /\left(X^{a}-g_{b}(\underline{Y})\right)$.

Proof. We have

$$
\begin{aligned}
\mathcal{R}^{\prime}(\mathcal{I}) & =\bigoplus_{n \in \mathbb{Z}} I_{n} t^{n} \\
& =\sum_{k, i_{1}, \ldots, i_{m} \in \mathbb{Z}_{\geq 0}} x^{k} x_{1}^{i_{1}} \cdots x_{m}^{i_{m}} t^{k b^{\prime}+\left(i_{1}+\cdots+i_{m}\right) a^{\prime}}+\sum_{n \geq 0} A t^{-n} \\
& =\sum_{k, i_{1}, \ldots, i_{m} \in \mathbb{Z}_{\geq 0}}\left(x t^{b^{\prime}}\right)^{k}\left(x_{1} t^{a^{\prime}}\right)^{i_{1}} \cdots\left(x_{m} t^{a^{\prime}}\right)^{i_{m}}+\sum_{n \geq 0} A t^{-n} \\
& =A\left[x t^{b^{\prime}}, x_{1} t^{a^{\prime}}, \ldots, x_{m} t^{a^{\prime}}, t^{-1}\right] .
\end{aligned}
$$

Put $X=x t^{b^{\prime}}, Y_{i}=x t^{t^{\prime}}$ for $i=1,2, \ldots, m$ and $U=t^{-1}$. Then

$$
\begin{aligned}
X^{a} & =x^{a} t^{a b^{\prime}}=x^{a} t^{a^{\prime} b} \\
& =g_{b}\left(x_{1}, \ldots, x_{m}\right) t^{a^{\prime} b}+g_{b+1}\left(x_{1}, \ldots, x_{m}\right) t^{a^{\prime} b}+\cdots+g_{c}\left(x_{1}, \ldots, x_{m}\right) t^{a^{\prime} b} \\
& =g_{b}\left(Y_{1}, Y_{2}, \ldots, Y_{m}\right)+g_{b+1}\left(Y_{1}, \Upsilon_{2}, \ldots, Y_{m}\right) t^{-a^{\prime}}+\cdots+g_{c}\left(Y_{1}, Y_{2}, \ldots, Y_{m}\right) t^{-(c-b) a^{\prime}} \\
& =g_{b}\left(Y_{1}, Y_{2}, \ldots, Y_{m}\right)+g_{b+1}\left(Y_{1}, \Upsilon_{2}, \ldots, Y_{m}\right) U^{a^{\prime}}+\cdots+g_{c}\left(Y_{1}, Y_{2}, \ldots, Y_{m}\right) U^{(c-b) a^{\prime}} .
\end{aligned}
$$

Hence

$$
\begin{aligned}
G(\mathcal{I}) & =\mathcal{R}^{\prime}(\mathcal{I}) / t^{-1} \mathcal{R}^{\prime}(\mathcal{I}) \\
& =K\left[X, Y_{1}, Y_{2}, \ldots, Y_{m}\right] /\left(X^{a}-g_{b}\left(Y_{1}, \ldots, Y_{m}\right)\right)
\end{aligned}
$$

The normality of $A$ is needed in the following proposition.
Proposition 6.4. Suppose that $A$ is a Zariski-type normal hypersurface. Under the notation as above,
(a) $G(\mathcal{I})$ is reduced.
(b) $\overline{I_{n}}=I_{n}$ for every $n \geq 1$.
(c) $\overline{J_{n}}=J_{n}$ for every $n \geq 1$.

Proof. (a) By Lemma 6.3, since $G(\mathcal{I}) \cong K[X, \underline{Y}] /\left(X^{a}-g_{b}(\underline{Y})\right)$ is a hypersurface, it satisfies the Serre condition $\left(S_{1}\right)$.

Put $f=X^{a}-g_{b}(\underline{Y})$. Then

$$
\operatorname{ht}\left(\frac{\partial f}{\partial X}, \frac{\partial f}{\partial Y_{1}}, \ldots, \frac{\partial f}{\partial Y_{m}}, f\right) \geq \operatorname{ht}\left(X, g_{b}(\underline{Y})\right) \geq 1
$$

Hence $G(\mathcal{I})$ satisfies $\left(R_{0}\right)$ and it is reduced.
(b) It follows from [14, Lemma 3.1].
(c) Since $J_{n}=I_{n \alpha^{\prime}}$ for every $n \geq 1$ by Proposition 6.1, $J_{n}$ is also integrally closed by (b).

The following theorem generalizes [18, Theorem 3.1].
Theorem 6.5. Under the notation as above,
(a) $\overline{\mathfrak{m}^{n}}=\overline{Q^{n}}=Q^{n}+x Q^{n-n_{1}}+x^{2} Q^{n-n_{2}}+\cdots+x^{a-1} Q^{n-n_{a-1}}$.
(b) $\overline{\mathrm{r}}_{Q}(\mathfrak{m})=\operatorname{nr}_{Q}(\mathfrak{m})=n_{a-1}=\left\lfloor\frac{(a-1) b}{a}\right\rfloor$.
(c) $\bar{G}(\mathfrak{m})$ is Cohen-Macaulay.

Proof. (a) It follows from Proposition6.2(b) and Proposition 6.4(c).
(b) It immediately follows from (a).
(c) By Proposition 6.4 $G(\mathcal{I})$ is a hypersurface. Therefore it is Cohen-Macaulay. Hence $\mathcal{R}^{\prime}(\mathcal{I})$ is CohenMacaulay.

On the other hand, $\overline{\mathcal{R}^{\prime}}(\mathfrak{m})=\mathcal{R}^{\prime}\left(\left\{J_{n}\right\}\right)=\mathcal{R}^{\prime}\left(\left\{I_{n a^{\prime}}\right\}\right)$ by Propositions 6.1 and 6.4(c). Then $\overline{\mathcal{R}^{\prime}}(\mathfrak{m})$ is also Cohen-Macaulay since $\overline{\mathcal{R}^{\prime}}(\mathfrak{m})$ is isomorphic to a direct summand of $\mathcal{R}^{\prime}(\mathcal{I})$. Therefore $\bar{G}(\mathfrak{m})$ is CohenMacaulay.

Next, we give a criterion for $\bar{G}(\mathfrak{m})$ to be Gorenstein in the case $A$ is a Zariski-type hypersurface. First, we need the following criterion from [17]. We put $L_{n}=Q+\overline{\mathfrak{m}^{n}}$ and $\ell_{n}=\ell_{A}\left(A / L_{n}\right)$ for every $n \geq 1$.

Lemma 6.6. Put $r=\overline{\mathrm{r}}_{Q}(\mathfrak{m})$. Then the following conditions are equivalent:
(a) $\bar{G}(\mathfrak{m})$ is Gorenstein.
(b) $Q: L_{n}=L_{r+1-n}$ for every $n=1,2, \ldots, r$.
(c) $\ell_{n}+\ell_{r+1-n}=$ a for every $n=1,2, \ldots,\left\lceil\frac{r}{2}\right\rceil$.

As an application of Proposition 6.4, we obtain the following proposition.
Proposition 6.7. Under the same notation as above, we have

$$
\ell_{n}=\min \left\{k \in \mathbb{Z}_{+} \mid n \leq n_{k}\right\} .
$$

Proof. Suppose $n>n_{k-1}$ and $n \leq n_{k}$. Then

$$
\begin{aligned}
L_{n} & =Q+\overline{\mathfrak{m}^{n}} \\
& =Q+\left(Q^{n}+x Q^{n-n_{1}}+\cdots+x^{k-1} Q^{n-n_{k-1}}+x^{k} Q^{n-n_{k}}+\cdots\right) \\
& =Q+\left(x^{k}\right)
\end{aligned}
$$

Hence $\ell_{n}=\ell_{A}\left(K[x] /\left(x^{k}\right)\right)=k$.

The following theorem is a main result in this section. Recall $d=\operatorname{gcd}(a, b)$.
Theorem 6.8. $\bar{G}(\mathfrak{m})$ is Gorenstein if and only if $b \equiv 0, d(\bmod a)$. Moreover,
(a) If $b \equiv 0(\bmod a)$, then $\bar{G}(\mathfrak{m})$ is a reduced, hypersurface.
(b) If $b \equiv 1(\bmod a)$, then $\bar{G}(\mathfrak{m})$ is a non-reduced, hypersurface.
(c) If $b \equiv d(\bmod a)$ and $d>1$, then $\bar{G}(\mathfrak{m})$ is a complete intersection but not a hypersurface.

In what follows, we prove the above theorem in several steps.

Proposition 6.9. If a divides $b$, then $\bar{G}(\mathfrak{m})$ is a reduced hypersurface, and thus Gorenstein. In fact,

$$
\bar{G}(\mathfrak{m}) \cong K[X, \underline{Y}] /\left(X^{a}-g_{b}(\underline{Y})\right) .
$$

Proof. One can easily see that

$$
\begin{aligned}
\overline{\mathcal{R}}^{\prime}(\mathfrak{m}) & =K\left[x t, \underline{x} t,\left\{x^{k} t^{n_{k}}\right\}_{1 \leq k \leq a-1}, t^{-1}\right] \\
& =K\left[x t^{n_{1}}, \underline{x} t, t^{-1}\right] \\
& \cong K[X, \underline{Y}, U] /\left(X^{a}-g_{b}(\underline{Y})-\cdots-g_{c}(\underline{Y}) U^{c-b}\right),
\end{aligned}
$$

where $X=x t^{n_{1}}, Y_{i}=x_{i} t(i=1,2, \ldots, m)$, and $U=t^{-1}$.
Moreover, it immediately follows from the fact that $\overline{\mathcal{G}}(\mathfrak{m}) \cong \overline{\mathcal{R}^{\prime}}(\mathfrak{m}) / t^{-1} \overline{\mathcal{R}^{\prime}}(\mathfrak{m})$.
The case $1 \leq d<a$. First, we consider the case of $d=1$ and $b \equiv 1(\bmod a)$.
Proposition 6.10. If $d=1$ and $b=n_{1} a+1$, then $\bar{G}(\mathfrak{m})$ is a non-reduced hypersurface, and thus Gorenstein. In fact,

$$
\bar{G}(\mathfrak{m}) \cong K[X, \underline{Y}] /\left(X^{a}\right) \cong G(\mathfrak{m}) .
$$

Proof. For every $k$ with $1 \leq k \leq a-1$, we have

$$
n_{k}=\left\lfloor\frac{k b}{a}\right\rfloor=\left\lfloor\frac{k\left(n_{1} a+1\right)}{a}\right\rfloor=k n_{1}+\left\lfloor\frac{k}{a}\right\rfloor=k n_{1} .
$$

Hence

$$
\begin{aligned}
\overline{\mathcal{R}^{\prime}}(\mathfrak{m}) & =K\left[x t, \underline{x} t,\left\{x^{k} t^{n_{k}}\right\}_{1 \leq k \leq a-1}, t^{-1}\right] \\
& =K\left[x t, \underline{x} t, x t^{n_{1}}, t^{-1}\right] \\
& \cong K[X, \underline{Y}, U] /\left(X^{a}-g_{b}(\underline{Y}) U-\cdots-g_{c}(\underline{Y}) U^{c-b+1}\right) .
\end{aligned}
$$

Indeed, put $X=x t^{n_{1}}, Y_{i}=x_{i} t$ for $i=1,2, \ldots, m$ and $U=t^{-1}$. Then $x t=\left(x t^{n_{1}}\right)\left(t^{-1}\right)^{n_{1}-1}$ and

$$
\begin{aligned}
X^{a}=\left(x t^{n_{1}}\right)^{a} & =\left(g_{b}+g_{b+1}+\cdots+g_{c}\right) t^{a n_{1}} \\
& =\left(g_{b}+g_{b+1}+\cdots+g_{c}\right) t^{b-1} \\
& =\left(g_{b} t^{b}\right) U+g_{b+1} t^{b+1} U^{2}+\cdots+g_{c} t^{c} U^{c-b+1} \\
& =g_{b}(\underline{Y}) U+\cdots+g_{c}(\underline{Y}) U^{c-b+1} .
\end{aligned}
$$

The other assertion follows from this.
Next, we consider the case $1<d<a^{\prime}, b^{\prime} \equiv 1\left(\bmod a^{\prime}\right)$.
Proposition 6.11. If $1<d<a^{\prime}$ and $b^{\prime}=n_{1} a^{\prime}+1$, then $\bar{G}(\mathfrak{m})$ is a complete intersection, and thus Gorenstein. In fact,

$$
\bar{G}(m) \cong K[X, \underline{Y}, Z] /\left(X^{a^{\prime}}, Z^{d}-g_{b}(\underline{Y})\right) .
$$

Proof. Note that $b^{\prime} \equiv 1\left(\bmod a^{\prime}\right)$. One can easily see that $n_{k}=k n_{1}$ for $1 \leq k \leq a^{\prime}-1$, and $n_{a^{\prime}}=b^{\prime}$. For any integer $p(1 \leq p \leq d-1)$, if $p a^{\prime}+1 \leq k \leq p a^{\prime}+a^{\prime}-1$, then

$$
n_{k}=\left\lfloor\frac{k\left(n_{1} a^{\prime}+1\right)}{a^{\prime}}\right\rfloor=k n_{1}+\left\lfloor\frac{k}{a^{\prime}}\right\rfloor=k n_{1}+p=p b^{\prime}+\left(k-p a^{\prime}\right) n_{1} .
$$

Hence $\left(k, n_{k}\right)=p\left(a^{\prime}, b^{\prime}\right)+\left(k-p a^{\prime}\right)\left(1, n_{1}\right)$. Similarly, if $k=p a^{\prime}(2 \leq p \leq d-1)$, then $\left(k, n_{k}\right)=p\left(a^{\prime}, b^{\prime}\right)$. Therefore

$$
\begin{aligned}
\overline{\mathcal{R}^{\prime}}(\mathfrak{m}) & =K\left[x t, x_{1} t, \ldots, x_{m} t, x t^{n_{1}}, x^{a^{\prime}} t^{b^{\prime}}, t^{-1}\right] \\
& \cong K[X, \underline{Y}, Z, U] /\left(X^{a^{\prime}}-Z U, Z^{d}-g_{b}(\underline{Y})-\cdots-g_{c}(\underline{Y}) U^{c-b}\right),
\end{aligned}
$$

where $X=x t^{n_{1}}, Y_{i}=x_{i} t, Z=x^{a^{\prime}} t^{b^{\prime}}$, and $U=t^{-1}$. Indeed,

$$
X^{a^{\prime}}=x^{a^{\prime}} t^{n_{1} a^{\prime}}=\left(x^{a^{\prime}} t^{b^{\prime}}\right)\left(t^{-1}\right)^{b^{\prime}-n_{1} a^{\prime}}=\left(x^{a^{\prime}} t^{b^{\prime}}\right)\left(t^{-1}\right)=Z U
$$

and

$$
\begin{aligned}
Z^{d} & =\left(x^{a^{\prime}} t^{b^{\prime}}\right)^{d} \\
& =x^{a} t^{b} \\
& =g_{b}\left(x_{1}, \ldots, x_{m}\right) t^{b}+\cdots+g_{c}\left(x_{1}, \ldots, x_{m}\right) t^{c} \cdot t^{b-c} \\
& =g_{b}(\underline{Y})+\cdots+g_{c}(\underline{Y}) U^{c-b}
\end{aligned}
$$

The other assertion follows from this.

In the rest of this section, we consider the case of $1<d<a$ and $b^{\prime} \equiv \delta\left(\bmod a^{\prime}\right)$ for some $\delta(2 \leq \delta \leq$ $a^{\prime}-1$ ). Note that

$$
\overline{\mathrm{r}}(\mathfrak{m})=n_{a-1}=\left\lfloor\frac{(a-1) b^{\prime}}{a^{\prime}}\right\rfloor=(a-1) n_{1}+d \delta-1
$$

In order to prove Theorem6.8, it suffices to prove the following proposition.
Proposition 6.12. In the above notation, if we put $k_{1}=\left\lceil\frac{a^{\prime}}{\delta}\right\rceil$ and $t_{1}=\left(k_{1}-1\right) n_{1}+1$, then

$$
\ell_{t_{1}}+\ell_{r+1-t_{1}}=a+1(\neq a)
$$

In particular, $\bar{G}(\mathfrak{m})$ is not Gorenstein.
Proof. We first prove the following claim.
Claim 1. $\left\lfloor\frac{k \delta}{a^{\prime}}\right\rfloor=0,\left\lceil\frac{k \delta}{a^{\prime}}\right\rceil=1$ for each $k\left(1 \leq k \leq k_{1}-1\right)$.
By definition, $k \leq k_{1}-1<\frac{a^{\prime}}{\delta}$. Thus $0<\frac{k \delta}{a^{\prime}}<1$. Hence $\left\lfloor\frac{k \delta}{a^{\prime}}\right\rfloor=0$ and $\left\lceil\frac{k \delta}{a^{\prime}}\right\rceil=1$.
Claim 2. $\left\lfloor\frac{k_{1} \delta}{a^{\prime}}\right\rfloor=1,\left\lceil\frac{k_{1} \delta}{a^{\prime}}\right\rceil=2$.
By definition, $k_{1}-1<\frac{a^{\prime}}{\delta} \leq k_{1}$. Since $\left(a^{\prime}, \delta\right)=1, \frac{a^{\prime}}{\delta}$ is not an integer. Hence $\frac{a^{\prime}}{\delta}<k_{1}$, that is, $\frac{k_{1} \delta}{a^{\prime}}>1$. If $\frac{k_{1} \delta}{a^{\prime}} \geq 2$, then one has

$$
\frac{2 a^{\prime}}{\delta}-1 \leq k_{1}-1<\frac{a^{\prime}}{\delta}
$$

This yields $a^{\prime}<\delta$, which is a contradiction. Hence $1<\frac{k_{1} \delta}{a^{\prime}}<2$. The claim follows from here.
Claim 3. $n_{k}=k n_{1}$ for every $k\left(1 \leq k \leq k_{1}-1\right)$ and $n_{k_{1}}=k_{1} n_{1}+1$.

Indeed, for every $k\left(1 \leq k \leq k_{1}-1\right)$, Claim 1 implies

$$
n_{k}=\left\lfloor\frac{k b^{\prime}}{a^{\prime}}\right\rfloor=\left\lfloor\frac{k\left(n_{1} a^{\prime}+\delta\right)}{a^{\prime}}\right\rfloor=k n_{1}+\left\lfloor\frac{k \delta}{a^{\prime}}\right\rfloor=k n_{1}
$$

On the other hand, Claim 2 implies

$$
n_{k_{1}}=\left\lfloor\frac{k_{1} b^{\prime}}{a^{\prime}}\right\rfloor=\left\lfloor\frac{k_{1}\left(n_{1} a^{\prime}+\delta\right)}{a^{\prime}}\right\rfloor=k_{1} n_{1}+\left\lfloor\frac{k_{1} \delta}{a^{\prime}}\right\rfloor=k_{1} n_{1}+1
$$

Claim 4. $n_{a-k}=(a-k) n_{1}+d \delta-1$ for each $k\left(1 \leq k \leq k_{1}-1\right)$ and $n_{a-k_{1}}=\left(a-k_{1}\right) n_{1}+d \delta-2$.
For every $k\left(1 \leq k \leq k_{1}-1\right)$, Claim 1 implies

$$
n_{a-k}==\left\lfloor\frac{(a-k)\left(n_{1} a^{\prime}+\delta\right)}{a^{\prime}}\right\rfloor=(a-k) n_{1}+d \delta-\left\lceil\frac{k \delta}{a^{\prime}}\right\rceil=(a-k) n_{1}+d \delta-1
$$

On the other hand, Claim 2 implies

$$
n_{a-k_{1}}=\left\lfloor\left\lfloor\frac{\left(a-k_{1}\right)\left(n_{1} a^{\prime}+\delta\right)}{a^{\prime}}\right\rfloor=\left(a-k_{1}\right) n_{1}+d \delta-\left\lceil\frac{k_{1} \delta}{a^{\prime}}\right\rceil=\left(a-k_{1}\right) n_{1}+d \delta-2\right.
$$

Claim 5. $\ell_{t_{1}}+\ell_{r+1-t_{1}}=a+1$.
By Claim 3, $n_{k_{1}-1}+1=t_{1} \leq n_{k_{1}}$. Hence $\ell_{t_{1}}=k_{1}$ by Proposition 6.7. By Claim 4, we have

$$
\begin{aligned}
n_{a-k_{1}}+1 & =\left(a-k_{1}\right) n_{1}+d \delta-1=r+1-t_{1} \\
n_{a-k_{1}+1} & =\left(a-k_{1}+1\right) n_{1}+d \delta-1>r+1-t_{1}
\end{aligned}
$$

Hence $\ell_{r+1-t_{1}}=a-k_{1}+1$ and thus $\ell_{t_{1}}+\ell_{r+1-t_{1}}=\left(a-k_{1}+1\right)+k_{1}=a+1$.
Example 6.13. Let $m \geq 1$ be an integer, and let $A=\mathbb{C}\left[x_{0}, x_{1}, \ldots, x_{m}\right] /\left(x_{0}^{3}+x_{1}^{5}+\cdots+x_{m}^{5}\right)$. Put $\mathfrak{m}=$ $\left(x_{0}, x_{1}, \ldots, x_{m}\right)$ and $x_{0}=x$. Then
(a) $A$ is a rational singularity if and only if $m \geq 4$.
(b) $\overline{\mathfrak{m}^{2}}=\mathfrak{m}^{2}, \overline{\mathfrak{m}^{3}}=\mathfrak{m}^{3}+\left(x^{2}\right)$, and $\overline{\mathfrak{m}^{4}}=\left(x_{1}, x_{2}, \ldots, x_{m}\right) \overline{\mathfrak{m}^{3}}$.
(c) $\overline{\mathcal{R}^{\prime}}(\mathfrak{m})=K\left[x t, x_{1} t, x_{2} t, \ldots, x_{m} t, x^{2} t^{3}, t^{-1}\right]$.
(d) $\bar{G}(\mathfrak{m})$ is a Cohen-Macaulay ring of $e_{0}(\bar{G})=3$ and CM type 2 .

If we put $X=x t, Y_{i}=x_{i} t(i=1,2, \ldots m)$ and $Z=x^{2} t^{3}$, and $U=t^{-1}$, then

$$
\overline{\mathcal{R}^{\prime}}(\mathfrak{m}) \cong K[X, \underline{Y}, Z, U] /\left(X^{2}-Z U, X Z+\underline{Y^{5}} U, Z^{2}+X \underline{Y^{5}}\right)
$$

In particular,

$$
\bar{G}(\mathfrak{m}) \cong \overline{\mathcal{R}^{\prime}}(\mathfrak{m}) / t^{-1} \overline{\mathcal{R}^{\prime}}(\mathfrak{m}) \cong K[X, \underline{Y}, Z] /\left(X^{2}, X Z, Z^{2}+X \underline{Y^{5}}\right)
$$

where $\underline{Y^{5}}=Y_{1}^{5}+\cdots+Y_{m}^{5}$.
Example 6.14. Let $A=K \llbracket t^{a}, t^{b} \rrbracket$ be a semigroup ring generated by the positive integers $a \leq b$ such that $\operatorname{gcd}(a, b)=1$. We know that $A \cong k \llbracket x, y \rrbracket /\left(x^{a}-y^{b}\right)$ is a hypersurace. By Theorem 6.5 $\bar{r}_{Q}(\mathfrak{m})=\left\lfloor\frac{(a-1) b}{a}\right\rfloor$. By Theorem $6.8 \bar{G}(\mathfrak{m})$ is Gorenstein if and only if $b \equiv 1(\bmod a)$.

The examples 3.8 and 3.9 can also be verified using Theorem 6.8 .

## 7. Normal Tangent cones of maximal embedding dimension

Let $\mathfrak{M}_{\bar{G}}$ denote the unique graded maximal ideal of $\bar{G}=\bar{G}(\mathfrak{m})$. Then $\operatorname{embdim}(\bar{G})$, the embedding dimension of $\bar{G}$, is the number of minimal system of generators of $\mathfrak{M}_{\bar{G}}$. Since $\bar{G}$ is Cohen-Macaulay,

$$
\begin{equation*}
\operatorname{embdim}(\bar{G}) \leq e_{0}(\bar{G})+\operatorname{dim} \bar{G}-1=a+m-1 \tag{7.1}
\end{equation*}
$$

If equality holds in Eq.(7.1), then $\bar{G}$ is said to have maximal embedding dimension (in the sense of Sally). Note that $\mathfrak{M}_{\bar{G}}$ is generated by $\left\{x^{k} t^{n_{k}}\right\}_{k=1,2, \ldots, a-1}$, and $x_{1} t, x_{2} t, \ldots, x_{m} t$.

We can characterize those $\bar{G}$ in terms of $a$ and $b$.
Proposition 7.1. Let $A=S /\left(x^{a}-g(\underline{x})\right)$ be a Zariski-type hypersurface with $b=\operatorname{ord}(g) \geq a$. Then $\bar{G}(\mathfrak{m})$ has maximal embedding dimension if and only if one of the following cases occurs:
(a) $a=2$.
(b) $a \geq 3, \operatorname{gcd}(a, b)=1$ and $b \equiv a-1(\bmod a)$.

When this is the case, $\bar{G}(\mathfrak{m})$ is Gorenstein if and only if $a=2$.
Proof. In the case of $a=2$, since $\bar{G}$ is a hypersurface of $e_{0}(\bar{G})=2$, it is a Gorenstein ring having maximal embedding dimension. So we may assume that $a \geq 3$.

If part: We may compute $n_{k}$ as follows:

$$
n_{k}=\left\lfloor\frac{k\left(n_{1} a+a-1\right)}{a}\right\rfloor=k n_{1}+k+\left\lfloor\frac{-k}{a}\right\rfloor=k n_{1}+k-\left\lceil\frac{k}{a}\right\rceil=k n_{1}+k-1
$$

for every $k=1,2, \ldots, a-1$. Then a sequence

$$
x t^{n_{1}}, x^{2} t^{2 n_{1}+1}, x^{3} t^{3 n_{1}+2}, \ldots, x^{a-1} t^{(a-1) n_{1}+a-2}, x_{1} t, \ldots, x_{m} t
$$

forms a minimal system of generators of $\mathfrak{M}_{\bar{G}}$, we have

$$
\operatorname{embdim}(\bar{G})=a+m-1=e_{0}(\bar{G})+\operatorname{dim} \bar{G}-1
$$

Only if part: In order to complete the proof, we prove the following two lemmata.
Lemma 7.2. If $d>1$ and $a \geq 3$, then $\bar{G}$ does not have maximal embedding dimension.
Proof. We note that $\mathfrak{M}_{\bar{G}}=\left(\left\{x^{k} t^{n_{k}}\right\}_{k=1,2, \ldots, a-1}, x_{1} t, \ldots, x_{m} t\right)$. For every $s(1 \leq s \leq d), \delta\left(1 \leq \delta \leq a^{\prime}-1\right)$, we have

$$
n_{s a^{\prime}+\delta}=\left\lfloor\frac{\left(s a^{\prime}+\delta\right) b}{a}\right\rfloor=\left\lfloor\frac{\left(s a^{\prime}+\delta\right) b^{\prime}}{a^{\prime}}\right\rfloor=s b^{\prime}+\left\lfloor\frac{\delta b^{\prime}}{a^{\prime}}\right\rfloor=s n_{a^{\prime}}+n_{\delta}
$$

and hence

$$
x^{s a^{\prime}+\delta} t^{n_{s a^{\prime}+\delta}}=x^{s a^{\prime}+\delta} t^{s n_{a^{\prime}}+n_{\delta}}=\left(x^{a^{\prime}} t^{n_{a^{\prime}}}\right)^{s} \cdot\left(x^{\delta} t^{n_{\delta}}\right) \in \mathfrak{M}_{\bar{G}}^{2} .
$$

Moreover, if $s \geq 2$, then

$$
x^{s a^{\prime}} t^{n_{s a^{\prime}}}=x^{s a^{\prime}} t^{s n_{a^{\prime}}}=\left(x^{a^{\prime}} t^{n_{a^{\prime}}}\right)^{s} \in \mathfrak{M}_{\bar{G}}^{2} .
$$

Hence $\mathfrak{M}_{\overline{\mathrm{G}}}=\left(\left\{x^{k} t^{n_{k}}\right\}_{k=1,2, \ldots, a^{\prime}}, x_{1} t, \ldots, x_{m} t\right)$. Since $a \geq 3$ and $d \geq 2$, we obtain that

$$
\operatorname{embdim}(\bar{G}) \leq a^{\prime}+m \leq \frac{a}{2}+m<(a-1)+m=a+m-1
$$

as required.
Lemma 7.3. If $d=1$ and $b \equiv \delta(\bmod a)$ with $1 \leq \delta \leq a-2$, then $\bar{G}$ does not have maximal embedding dimension.

Proof. For each $k(1 \leq k \leq a-1)$, if we put $m_{k}=n_{k}-k n_{1}$, we have

$$
m_{k}=n_{k}-k n_{1}=\left\lfloor\frac{k b}{a}\right\rfloor-k n_{1}=\left\lfloor\frac{k\left(n_{1} a+\delta\right)}{a}\right\rfloor-k n_{1}=\left\lfloor\frac{k \delta}{a}\right\rfloor
$$

Since $1 \leq \delta \leq a-2$ and $a \geq 3$, we get

$$
m_{a-1}=\left\lfloor\frac{(a-1) \delta}{a}\right\rfloor \leq\left\lfloor\frac{(a-1)(a-2)}{a}\right\rfloor=a-3+\left\lfloor\frac{2}{a}\right\rfloor=a-3 .
$$

Then since $0 \leq m_{1} \leq m_{2} \leq \cdots \leq m_{a-1} \leq a-3$, there exists an integer $i$ with $2 \leq i \leq a-1$ such that $m_{i-1}=m_{i}$ by Pigeonhole principle. Since $n_{1}+n_{i-1}=n_{1}+\left\{(i-1) n_{1}+m_{i-1}\right\}=i n_{1}+m_{i}=n_{i}$, we get

$$
x^{i} t^{n_{i}}=x^{i} t^{n_{1}+n_{i-1}}=\left(x t^{n_{1}}\right)\left(x^{i-1} t^{n_{i-1}}\right) \in \mathfrak{M}_{\bar{G}}^{2}
$$

This implies embdim $(\bar{G}) \leq a+m-2<e_{0}(\bar{G})+\operatorname{dim} \bar{G}-1$, that is, $\bar{G}$ does not have maximal embedding dimension.

By the lemmata as above, we complete the proof of Proposition 7.1
