# FORMAL STRUCTURE OF SCALAR CURVATURE IN GENERALIZED KÄHLER GEOMETRY

ABSTRACT. Building on works of Boulanger [8] and Goto [20, 19], we show that Goto's scalar curvature is the moment map for an action of generalized Hamiltonian automorphisms of the associated Courant algebroid, constrained by the choice of an adapted volume form. We derive an explicit formula for Goto's scalar curvature, and show that it is constant for generalized Kähler-Ricci solitons. Restricting to the generically symplectic type case, we realize the generalized Kähler class as the complexified orbit of the Hamiltonian action above. This leads to a natural extension of Mabuchi's metric and K-energy, implying a conditional uniqueness result. Finally, in this setting we derive a Calabi-Matsushima-Lichnerowicz obstruction and a Futaki invariant.

#### 1. INTRODUCTION

In [9] Calabi initiated an expansive program of finding canonical representatives of Kähler metrics in a fixed deRham class. He proposed extremal Kähler metrics, i.e. metrics whose scalar curvature defines a holomorphic Hamiltonian vector field, as the candidates for such canonical metrics. This problem combines the well-known existence problems for constant scalar curvature and Kähler-Einstein metrics, and is guided by the central Yau-Tian-Donaldson (YTD) conjecture, which asserts that the obstruction for existence of an extremal Kähler metric is expressed using an algebraic notion of stability for the Kähler class. In recent years the subject of generalized Kähler geometry [16, 22, 24, 25] has emerged as a deeply structured extension of Kähler geometry, which captures further natural interactions between complex, Poisson, and symplectic geometry. Building on seminal work of Goto [20, 19], in [3] the authors gave an extension of analytic aspects of Calabi's program to the setting of generalized Kähler structures. This general setup can be applied to underlying complex Poisson manifolds which do not admit symplectic structures at all, such as Hopf surfaces.

1.1. Scalar curvature as moment map. We recall briefly that generalized Kähler structures admit two descriptions on the background of  $(M, H_0)$ , a smooth manifold M endowed with a closed three-form  $H_0$ . The first is described in terms of bihermitian geometry: a generalized Kähler structure is a quadruple (g, I, J, b) of a Riemannian metric g, a two-form b and two integrable almost complex structures I, J such that g is compatible with I and J and further satisfy

$$-d_I^c \omega_I = H_0 + db = d_J^c \omega_J,$$

where  $\omega_I = gI, \omega_J = gJ$  and  $d_I^c = \sqrt{-1}(\overline{\partial}_I - \partial_I), d_J^c = \sqrt{-1}(\overline{\partial}_J - \partial_J)$ . The second description is in terms of generalized complex geometry: a generalized Kähler structure is a pair of commuting generalized complex structures  $\mathbb{I}, \mathbb{J}$  on the exact Courant algebroid  $(TM \oplus T^*M, H_0)$  further satisfying  $\langle -\mathbb{I}J, \rangle > 0$ , where  $\langle, \rangle$  is the canonical neutral inner product. These two descriptions are equivalent by the work of Gualtieri [22] (cf. Theorem 2.18 below). There are several natural Poisson tensors associated to a generalized Kähler structure. First, as observed by Hitchin [26], the tensor

(1.1) 
$$\pi \coloneqq \frac{1}{2} [I, J] g^{-1}$$

defines a real Poisson structure. Furthermore, for any generalized complex structure  $\mathbb{J}$  one has a canonically associated real Poisson tensor  $\pi_{\mathbb{J}}(\xi,\eta) \coloneqq \langle \mathbb{J}\xi,\eta \rangle$ . Thus, a generalized Kähler structure comes equipped with three (generally distinct) real Poisson tensors:  $\pi$  as above, together with

$$\pi_{\mathbb{I}} = \frac{1}{2}(I-J)g^{-1}, \qquad \pi_{\mathbb{J}} = \frac{1}{2}(I+J)g^{-1}.$$

In the special case when the generalized Kähler structure is of symplectic type, the endomorphism I + J is invertible,  $F = -2g(I + J)^{-1}$  is a symplectic form, and  $\pi_{\mathbb{J}} = F^{-1}$ . With this in mind the results to follow are all generalizations of our prior work [3] in the symplectic type case.

Viewed from the bihermitian description, one notes that in general there is no single connection which preserves all of the data, and thus it is not clear at the outset what the relevant curvature quantities are. In view of this, works of Boulanger [8] and Goto [19, 20] sought to define a relevant scalar curvature by generalizing the Fujiki-Donaldson work in Kähler geometry realizing the scalar curvature as the moment map for a natural action of the group of Hamiltonian diffeomorphisms for a fixed symplectic form. This culminated in [19], where Goto identified a natural Lie algebra of infinitesimal automorphisms of  $(TM \oplus T^*M, H_0)$  generated by elements  $\mathbb{J}du$ , where u is a smooth function on M preserved by the divergence of  $\mathbb{J}$  relative to a fixed, *arbitrary* volume form (cf. §2.2). These act on the space of 'almost generalized Kähler' structures compatible with  $\mathbb{J}$ , a space which inherits a natural Kähler structure. Furthermore, Goto defines a scalar curvature quantity associated to a generalized Kähler structure ( $\mathbb{I},\mathbb{J}$ ) and a volume form, and relates the variation of this scalar curvature to deformations by generalized Hamiltonians described above. Given this variational formula, certain 'modified Hamiltonians' are introduced and it is claimed that the scalar curvature is the moment map for the action by these.

This delicate and surprising work suggests many further questions. First, it appears that the 'modified Hamiltonians' described in [19] do not form a Lie algebra. For this reason we present in §3 a slight modification of the setup in [19], which places a further restriction on the generalized Kähler structures. As described above, there is a canonical infinitesimal symmetry of  $(TM \oplus T^*M, H_0)$  associated to  $\mathbb{J}$  and a choice of volume form vol on M, denoted  $\operatorname{div}_{\operatorname{vol}}(\mathbb{J})$ . Inspired by recent work of Inoue [27] in the Kähler case, we ask for a volume form vol such that  $\operatorname{div}_{\operatorname{vol}}(\mathbb{J})$  (which always preserves  $\mathbb{J}$ ) preserves  $\mathbb{I}$ . In this case, we call the volume form *adapted*. In terms of the bihermitian description (g, I, J, b), expressing  $\operatorname{vol} = e^{-f} dV_g$ , if vol is adapted then the vector field

$$X = \frac{1}{2} \left( d_g^* (\omega_I + \omega_J) + (I + J) \nabla^g f \right)$$

is Killing for (g, I, J). A subtle issue is that the condition that X preserves the bihermitian data does not seem to imply that the volume form is adapted, although we show that this is true in the generically symplectic type case (cf. Lemma 3.20). We let T be the torus of isometries generated by the Killing vector field X. In the Kähler case, when we have I = J and using T-invariant potentials, we recover the formal moment map setting considered by Inoue in [27], leading to the so-called  $\mu$ -scalar curvature Kähler metrics and extending the notion of Kähler-Ricci solitons on Fano manifolds [40] to arbitrary Kähler classes.

Considering the space  $\mathcal{AGK}(\mathbb{J}, \mathrm{vol})$  of all  $\mathbb{I}$ -compatible and  $\operatorname{div}_{\mathrm{vol}}(\mathbb{J})$ -invariant almost generalized Kähler structures  $(\mathbb{I}, \mathbb{J})$  on M, Goto's original variational formulas lead directly to the claim that the generalized scalar curvature is the moment map for the infinitesimal action of  $\mathbb{T}$ -invariant Hamiltonians  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$  on the space  $\mathcal{AGK}(\mathbb{J}, \mathrm{vol})$ : (cf. §3 for precise notation)

**Theorem 1.1.** [19] (Theorem 3.13) The natural action of  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$  on  $\mathcal{AGK}(\mathbb{J}, \mathrm{vol})$  is Hamiltonian with moment map given by the generalized scalar curvature. More concretely,

$$\mathbf{\Omega}\left(L_{\mathbb{J}du}^{H_0}\mathbb{I}, \left.\frac{\partial}{\partial t}\right|_{t=0}\mathbb{I}_t\right) = \int_M \left(\frac{\partial}{\partial t} \operatorname{Gscal}(\mathbb{I}_t, \mathbb{J}, \operatorname{vol})\right) u \operatorname{vol}$$

for any one-parameter family  $\mathbb{I}_t \in \mathcal{AGK}(\mathbb{J}, \mathrm{vol})$ .

1.2. Scalar curvature and generalized Kähler-Ricci solitons. Goto's scalar curvature is defined using the local spinorial description of generalized Kähler structures, and thus it is not clear what this quantity really is in terms of the classical bihermitian description. By now formulas in some special cases have appeared [8, 20, 19, 3, 1] which hint at the general form of the answer. Here, by exploiting the nondegenerate perturbation method introduced in [1], we obtain the general answer:

**Theorem 1.2.** (Theorem 4.3) Let (M, g, I, J, b) be a generalized Kähler manifold determined by generalized complex structures  $(\mathbb{I}, \mathbb{J})$  on  $(M, H_0)$ . Then for all  $f \in C^{\infty}(M)$  one has

$$\operatorname{Gscal}(\mathbb{I}, \mathbb{J}, e^{-f} dV_g) = \frac{1}{4} \left( R - \frac{1}{12} |H|^2 + 2\Delta f - |df|^2 \right),$$

where  $H \coloneqq -d_I^c \omega_I = d_J^c \omega_J = H_0 + db$ .

This quantity has already appeared in several distinct contexts, including as the integrand of the string effective action [32], in Bismut's work on the index theorem in complex geometry [7], and as the natural notion of scalar curvature in generalized geometry [10, 13] and generalized Ricci flow [15, 34], making Goto's derivation from the spin geometry of generalized Kähler structures quite surprising.

Theorem 1.2 shows that the moment map framework above captures a number of interesting examples. Generalized Kähler-Ricci solitons are self-similar solutions of generalized Kähler-Ricci flow [37] and serve as the canonical geometries behind extensions of the Calabi-Yau theorem to generalized Kähler geometry (cf. [1, 2]). By a Bianchi identity (Proposition 4.4) we show that all generalized Kähler-Ricci solitons have constant scalar curvature relative to the weighted volume. We furthermore show that the vector field X above is automatically Killing for a soliton, thus showing that generically symplectic type solitons fit into the GIT framework above. In a series of works [35, 38, 5] the authors constructed and classified all generalized Kähler-Ricci solitons on compact complex surfaces, with non-Kähler generically symplectic type examples occurring on all type 1 Hopf surfaces. In higher dimensions there are the examples of canonical generalized Kähler structures on semisimple Lie groups. These were shown to have constant Goto scalar curvature of these examples follows immediately from Theorem 1.2, and in the case the group has no abelian factors we construct the relevant adapted volume form and again give the realization of these geometries as zeroes of the moment map.

1.3. Complexified orbit and Calabi problem. A further fundamental aspect of the Fujiki-Donaldson moment map framework is the fact that on a given complex manifold, the space of Kähler metrics in a fixed deRham class admits a natural interpretation as the complexified orbit of the action of the group of Hamiltonian symplectomorphisms. This point follows by Moser's lemma, and in [3] we extended this to the symplectic type generalized Kähler case. In [23] a notion of generalized Kähler class of structures is introduced via certain infinitesimal deformations of the bihermitian data. We show in Lemma 5.7 that these deformations correspond formally to the complexified orbit for the natural complex structure on  $\mathcal{AGK}(\mathbb{J})$  in the moment map setup we present, after pullback by an appropriately chosen family of Courant automorphisms. However, ensuring that the complexified orbit remains adapted to the volume form is a subtle point. In general one can construct a family of volume forms associated to a path in the generalized Kähler class by pullback of the fixed adapted volume by the automorphisms constructed above. In general, this volume form will be adapted to the bihermitian data, and in case the initial GK structure is generically symplectic type, it will be adapted to  $(\mathbb{I}, \mathbb{J})$ . Furthermore we show in this case that the volume form, which is constructed pathwise in the nonlinear space of generalized Kähler structures, does not depend on the chosen path.

Continuing in the generically symplectic type case, using the canonically associated adapted volume form constructed above, we define a generalization of the Mabuchi metric [31] (cf. [33, 11]), further extending the construction from [3]. This is a formal Riemannian metric on the generalized Kähler class. We derive the Levi-Civita connection and geodesic equation, and we show in Proposition 5.16 that it is formally a symmetric space with nonpositive sectional curvature. With these tools in place we can define an extension of the Calabi problem. In particular we define the Calabi energy as the  $L^2$  norm of the Goto scalar curvature, and show in Proposition 6.2 that critical points are precisely the extremal GK structures. Furthermore by integrating the Goto scalar curvature against an invariant Hamiltonian potential we obtain a generalization of the Mabuchi one-form. We show in Proposition 6.4 that this form is closed, and thus there is at least a locally defined functional whose differential is this one-form. The existence of such a functional which is well-defined on the whole generalized Kähler class is a nontrivial open problem. We furthermore show in Proposition 6.5 that the Mabuchi one-form is monotone along Mabuchi geodesics, which leads in Corollary 6.6 to the claim that any two critical points connected by a smooth geodesic are in fact isometric.

1.4. **Obstruction theory.** In the final Section 7, we extend in Theorem 7.3 the Calabi-Lichnerowicz-Matsushima theorem to general extremal GK structures. Similarly to the work of Goto [21] in the symplectic-type case, the general version of this result relates the stabilizers respectively in  $\mathfrak{ham}^{\mathbb{T}}$  and in its complexification  $\mathfrak{ham}^{\mathbb{T}} \otimes \mathbb{C}$  of an extremal GK structure. This relationship follows from purely formal arguments, using the the moment map interpretation of the Goto scalar curvature (see Appendix A). In order to obtain further ramifications, expressed as the reductiveness of a certain Lie algebra of real holomorphic vector fields, we assume generically symplectic type and obtain in Theorem 7.11 a partial generalization of our previous results [4] which were obtained in the symplectic type case. We finally derive in Theorem 7.15, as a byproduct of our definition of Mabuchi 1-form, a version of the Futaki invariant associated to a GK class.

#### 2. Background

2.1. Generalized geometry. Consider a smooth manifold M of real dimension 2n endowed with a closed 3-form  $H_0$ . The pair  $(M, H_0)$  gives rise to an exact Courant algebroid  $E = TM \oplus T^*M$ with neutral inner product and  $H_0$ -twisted Dorfman bracket defined on sections of E by

$$\langle X + \xi, Y + \eta \rangle = \frac{1}{2} \left( \eta(X) + \xi(Y) \right)$$
$$[X + \xi, Y + \eta]_{H_0} = [X, Y] + L_X \eta - i_Y d\xi + i_Y i_X H_0.$$

We have a natural spinorial action of elements of E on  $\wedge^*(M)$  by:

$$(X+\xi)\cdot\alpha=i_X\alpha+\xi\wedge\alpha.$$

It is straightforward to see that this action extends to an action of the Clifford algebra of  $E = TM \oplus T^*M$  on  $\Lambda^*(T^*)$ , i.e. satisfies:

$$(X+\xi)\cdot((X+\xi)\cdot\alpha)=\xi(X)\alpha=\langle X+\xi,X+\xi\rangle\alpha.$$

Thus,  $\wedge^*(M)$  is a Clifford module. All of the above can be complexified to define a Clifford action of  $(TM \oplus T^*M) \otimes \mathbb{C}$  on

$$\wedge^*(M)_{\mathbb{C}} \coloneqq \wedge^*(M) \otimes \mathbb{C}.$$

This algebra is equipped with a twisted de Rham differential

$$d_{H_0}\alpha \coloneqq d\alpha - H_0 \wedge \alpha.$$

Furthermore, there is a  $\wedge^{2n}(M)_{\mathbb{C}}$ -valued Spin-invariant Mukai pairing  $(\cdot, \cdot): \wedge^*(M)_{\mathbb{C}} \otimes \wedge^*(M)_{\mathbb{C}} \to \wedge^{2n}(M)_{\mathbb{C}}$  defined by

$$(\alpha,\beta)_M \coloneqq [\alpha \land \sigma(\beta)]_{\mathrm{top}},$$

where  $\alpha, \beta \in \wedge^*(M)_{\mathbb{C}}$ ;  $\sigma: \wedge^*(M) \to \wedge^*(M)$  is the Clifford involution defined on the decomposable forms as  $\sigma(dx^{i_1} \wedge \cdots \wedge dx^{i_k}) \coloneqq dx^{i_k} \wedge \cdots \wedge dx^{i_1}$ ; and  $[\alpha]_{\text{top}}$  denotes the top degree component of  $\alpha \in \wedge^*(M)_{\mathbb{C}}$ .

**Remark 2.1.** With our convention for the normalization of the Mukai pairing, if  $\omega \in \wedge^2(M)$  and  $\varphi := e^{\sqrt{-1}\omega} \in \wedge^{\text{even}}(M)_{\mathbb{C}}$ , we have

$$(\varphi,\overline{\varphi})_M = (2\sqrt{-1})^n \frac{\omega^n}{n!}.$$

Given a diffeomorphism  $\Phi \in \text{Diff}(M)$  we lift it to  $E = T \oplus T^*$  as

$$\begin{pmatrix} \Phi_* & 0\\ 0 & (\Phi^*)^{-1} \end{pmatrix}$$

and, by a standard abuse of notation, denote the corresponding action by  $\Phi$ :

$$\Phi \cdot (X + \xi) \coloneqq \Phi_*(X) + (\Phi^*)^{-1}(\xi).$$

Furthermore for  $b \in \wedge^2(M)$  we define a  $\langle \cdot, \cdot \rangle$ -orthogonal endomorphism  $e^b \in \operatorname{End}(TM \oplus T^*M)$  by

$$e^{b}(X+\xi) \coloneqq X+\xi+b(X,\cdot).$$

Combining the two actions, we obtain the extended diffeomorphism group action  $TM \oplus T^*M$ :

$$\{\Phi \circ e^b \mid \Phi \in \operatorname{Diff}(M), \ b \in \wedge^2(M), \}$$

with product given by

$$(f_1 \circ e^{b_1}) \circ (f_2 \circ e^{b_2}) = f_1 \circ f_2 \circ e^{b_2 + f_2^* b_1}$$

The corresponding Lie algebra is  $C^{\infty}(M, TM \oplus \wedge^2(M))$  with Lie bracket

$$[X_1 + b_1, X_2 + b_2]_{\text{aut}} = [X_1, X_2] + L_{X_1}b_2 - L_{X_2}b_1$$

The extended diffeomorphism group leads to a Lie derivative of sections of  $TM \oplus T^*M$ , extending the usual Lie derivative with respect to a vector field. The extended Lie derivative is explicitly given by

(2.1) 
$$L_{X+b}(Y+\eta) = [X,Y] + L_X\eta - \imath_Y b.$$

An extended diffeomorphism  $f \circ e^b$  preserves the  $H_0$ -twisted Dorfman bracket if and only if db = 0. In general, it transforms the  $H_0$ -twisted Dorfman bracket into the  $(H_0-db)$ -twisted Dorfman bracket (cf. [15] Proposition 2.14):

(2.2) 
$$[e^b(X+\xi), e^b(Y+\eta)]_{H_0-db} = e^b[X+\xi, Y+\eta]_{H_0}.$$

We shall refer to  $e^b$  as a *b*-field transformation of *E*.

**Definition 2.2** ([15, Prop. 2.21]). The group of automorphisms of  $(TM \oplus T^*M, [\cdot, \cdot]_{H_0})$  is

$$\operatorname{Aut}(M, TM \oplus T^*M, [\cdot, \cdot]_{H_0}) = \{ \Phi \circ e^b \mid \Phi \in \operatorname{Diff}(M), \ b \in \wedge^2(M), \ \Phi^*H_0 = H_0 - db \}$$

For simplicity, we will often denote this group  $\operatorname{Aut}(M, H_0)$ .

The group  $Aut(M, H_0)$  fits into an exact sequence

$$1 \to C^{\infty}(M, \wedge^2_{\mathrm{cl}}(M)) \to \mathrm{Aut}(M, H_0) \to \mathrm{Diff}(M) \to 1,$$

where  $\wedge^2_{\rm cl}(M)$  is the sheaf of closed 2-forms. Its Lie algebra is

$$\mathfrak{aut}(M, H_0) = \{X + b \mid d(i_X H_0 + b) = 0\}, \qquad X \in C^{\infty}(M, TM), b \in C^{\infty}(M, \wedge^2(M)),$$

with the Lie bracket  $[\cdot, \cdot]_{aut}$  introduced above. This Lie algebra fits into an exact sequence

(2.3) 
$$0 \to C^{\infty}(M, \bigwedge_{\mathrm{cl}}^{1}(M)) \to C^{\infty}(E) \xrightarrow{\Psi} \mathfrak{aut}(M, H_{0}) \to 0$$
$$\Psi(X + \xi) = X + d\xi - i_{X}H_{0}.$$

and

 $L_{\Psi(X+\xi)}(Y+\eta) = [X+\xi, Y+\eta]_{H_0},$ 

(which follows readily from (2.1) and the definition of  $\Psi$  above).

**Definition 2.3.** For sections  $X + \xi$  and  $Y + \eta$  of *E*, we let

$$L_{X+\xi}^{H_0}(Y+\eta) \coloneqq [X+\xi, Y+\eta]_{H_0}.$$

Thus,  $L_{\Psi(X+\xi)}(Y+\eta) = L_{X+\xi}^{H_0}(Y+\eta).$ 

**Remark 2.4.** The notation  $e^b$  will also be used for the formal exponential of b as a differential form

$$e^{b} = 1 + b + \frac{1}{2}b \wedge b + \dots,$$

which in turn acts on  $\wedge^*(M)$  via the wedge product:

$$\alpha \to e^b \wedge \alpha, \qquad \alpha \in \wedge^*(M).$$

This gives rise to an action of 2-forms on the spin bundle  $\wedge^*(M)$  compatible with the Clifford multiplication and  $d_{H_0}$  in the following sense:

(2.4) 
$$e^{b}(X+\xi) \cdot (e^{-b} \wedge \alpha) = e^{-b} \wedge ((X+\xi) \cdot \alpha), \qquad d_{H_0}\alpha = e^{b} \wedge d_{H_0-db}(e^{-b} \wedge \alpha).$$

Consequently, the action of Aut $(M, H_0)$  naturally extends to the action on the spin bundle  $\wedge^*(M)$ , and this action commutes with  $d_{H_0}$ .

2.2. Divergence of generalized complex structures. In this subsection we define a notion of divergence associated to a volume form vol and a generalized complex structure J. We first review basic points on generalized complex structures.

**Definition 2.5.** Let  $(M, H_0)$  be a smooth manifold with a closed 3-form. A generalized complex structure on  $(M, H_0)$  is a  $\langle,\rangle$ -orthogonal almost complex structure on E whose  $\sqrt{-1}$ -eigenbundle is integrable with respect to the  $H_0$ -twisted Dorfman bracket. Let  $K_{\mathbb{J}}$  denote the canonical line bundle of  $\mathbb{J}$ , i.e. the complex line bundle locally spanned by pure spinors  $\psi \in \wedge^*(M) \otimes \mathbb{C}$  satisfying

$$\operatorname{Ker}(\psi) = L^{1,0}_{\mathbb{J}},$$

where  $L^{1,0}_{\mathbb{J}} \subset E \otimes \mathbb{C}$  is the  $\sqrt{-1}$ -eigenspace of  $\mathbb{J}$ . The integrability of  $\mathbb{J}$  is equivalent to the condition that for every local defining spinor  $\psi$  one has

$$d_{H_0}\psi = e \cdot \psi$$

for some  $e \in E \otimes \mathbb{C}$ . Note that for a choice of defining spinor  $\psi$ , there exists a unique element  $e \in E$ , referred to as the *real potential*, such that

(2.5) 
$$d_{H_0}\psi = \frac{\sqrt{-1}}{2}e \cdot \psi$$

Furthermore, given vol a choice of volume form on M, we say that a defining spinor is normalized if

(2.6) 
$$(\psi, \overline{\psi}) = (2\sqrt{-1})^n \text{vol.}$$

**Lemma 2.6.** Given  $(M, H_0)$ , let  $\mathbb{J}$  be a generalized complex structure and vol a volume form on M. Choose  $\psi$  a normalized local defining spinor and let  $e = X + \xi$  be the real potential of  $\psi$ . Then X and  $\Psi(e) = X + d\xi - i_X H_0 \in \mathfrak{aut}(M, H_0)$  are globally defined. Moreover, with respect to the generalized complex structure  $\tilde{J} = e^b J e^{-b}$  on  $(M, H_0 - db)$  and volume form vol, the corresponding real potential  $\tilde{e}$  satisfies  $\Psi(\tilde{e}) = X + d\xi - \imath_X H_0 + L_X b$ .

*Proof.* The normalization condition (2.6) determines  $\psi$  up to a multiplication with  $e^{\sqrt{-1}u}$ , where u is a local real function. If  $\psi_u = e^{\sqrt{-1}u}\psi$  is another normalized local section of  $K_{\mathbb{J}}$ , then

$$d_{H_0}\psi_u = \frac{\sqrt{-1}}{2}(e+2du)\cdot\psi_u.$$

Clearly  $\Psi(e + 2du) = \Psi(e)$  and  $\pi_T(e + 2du) = \pi_T e$ , as claimed. For the second claim, first note that  $L_{\widetilde{1}}^{1,0} = e^b L_{\mathbb{J}}^{1,0}$ , and then the integrability with respect to  $H_0 - db$  follows from (2.2). Also, if  $\psi$  is a defining spinor  $\mathbb{J}$  then  $e^{-b} \wedge \psi$  is a defining spinor for  $\widetilde{\mathbb{J}}$  by (2.4). Furthermore note that it follows from the definition of the Mukai pairing that it is invariant under the b-field action, thus  $e^{-b} \wedge \psi$  is vol-normalized if  $\psi$  is. We also note from (2.4) that

$$d_{H_0-db}(e^{-b} \wedge \psi) = e^{-b} \wedge d_{H_0}\psi = e^{-b} \wedge (\sqrt{-1}e \cdot \psi)$$
$$= \left(\sqrt{-1}e^b(X+\xi)\right) \cdot e^{-b} \wedge \psi = \left(\sqrt{-1}(X+i_Xb+\xi)\right) \cdot e^{-b} \wedge \psi.$$

Thus  $\tilde{e} = X + i_X b + \xi$ , and using the map  $\Psi$  from (2.3) associated to  $H_0 - db$  we obtain

$$\Psi(\tilde{e}) = X + d(i_X b + \xi) - i_X (H_0 - db) = X + d\xi - i_X H_0 + L_X b.$$

**Definition 2.7.** Let  $\mathbb{J} \in \text{End}(E)$  be a generalized complex structure on  $(M, H_0)$ . For a fixed volume form vol  $\in \wedge^{2n}(M)$  we define the divergence of  $\mathbb{J}$  relative to vol, denoted

$$\operatorname{div}_{\operatorname{vol}}(\mathbb{J}) \in \mathfrak{aut}(M, H_0)$$

as the unique element of  $\mathfrak{aut}(M, H_0)$  guaranteed by Lemma 2.6.

**Remark 2.8.** The notion of a 'divergence operator' (cf. [13]) plays an important role in the theory of connections in generalized geometry. While apparently related, this notion is distinct from the concept defined above, though there should be some relation. Note that the divergences used here are key to the definition of Goto's scalar curvature (cf. §3 below), which in turn by Theorem 1.2 is equal to the more general notion of scalar curvature in terms of a generalized metric and divergence operator [13].

**Remark 2.9.** Whenever a generalized complex structure  $\mathbb{J}$  is determined by a *closed* pure spinor  $\psi$ , we can define the corresponding spinorial volume form

$$dV_{\psi} \coloneqq (2\sqrt{-1})^{-n}(\psi,\overline{\psi}).$$

Clearly, in this case the divergence of  $\mathbb{J}$  vanishes:  $\operatorname{div}_{dV_{ab}}(\mathbb{J}) = 0$ .

**Remark 2.10.** One can identify  $\operatorname{div}_{\operatorname{vol}}(\mathbb{J})$  with the unique  $\mathbb{J}$ -holomorphic unitary generalized connection  $D: C^{\infty}(L) \to C^{\infty}(E \otimes L)$  on the line bundle  $L = K_{\mathbb{J}}$  equipped with the Hermitian structure:

$$|s|_{\operatorname{vol}}^{2} \coloneqq \frac{(2\sqrt{-1})^{-n}(s,\overline{s})}{\operatorname{vol}} \in C^{\infty}(M,\mathbb{R}).$$

**Lemma 2.11.** For any volume form vol the element  $\operatorname{div}_{\operatorname{vol}}(\mathbb{J}) \in \mathfrak{aut}(M, H_0)$  generates an infinitesimal symmetry of  $\mathbb{J}$ .

Proof. Let  $\psi$  be a local spinor defining  $\mathbb{J}$  as in the definition of the divergence operator, and choose the unique  $e \in E$  such that  $d_{H_0}\psi = \sqrt{-1}e \cdot \psi$ . It suffices to prove that the well-defined infinitesimal action of e on  $\wedge^*(M) \otimes \mathbb{C}$  preserves the subbundle  $K_{\mathbb{J}}$ . Indeed, computing its action on  $\psi$  we find

$$L_e^{H_0}\psi = (e \cdot d_{H_0}\psi + d_{H_0}(e \cdot \psi)) = \sqrt{-1}e \cdot e \cdot \psi - \sqrt{-1}d_{H_0}^2\psi = \sqrt{-1}\langle e, e \rangle \psi.$$

Since  $L_e^{H_0}$  preserves the  $\mathbb{C}$ -span of  $\psi$ , the underlying generalized complex structure is also preserved.

A key point in the sequel is the relationship of this divergence to the canonical Poisson structure associated to a generalized complex structure.

**Definition 2.12.** Given  $\mathbb{J}$  a generalized complex structure, define the bivector  $\pi_{\mathbb{J}} \in \wedge^2 TM$  by

$$\pi_{\mathbb{J}}(\alpha,\beta) \coloneqq \langle \mathbb{J}\alpha,\beta \rangle$$

It is shown in [22] that  $\pi_{\mathbb{J}}$  is a real Poisson tensor. Furthermore,  $\pi_{\mathbb{J}}$  is invariant under the conjugation  $e^b \mathbb{J} e^{-b}$  of  $\mathbb{J}$  by a 2-form  $b \in \wedge^2(M)$ .

First observe that for a Poisson tensor and a fixed volume form there is a natural notion of divergence:

**Definition 2.13.** Given  $(M, \pi)$  a Poisson manifold and a volume form vol on M, we define the *divergence* 

$$X = \operatorname{div}_{\operatorname{vol}}(\pi)$$

to be the unique vector field X such that

$$d(i_{\pi} \operatorname{vol}) = i_X \operatorname{vol}.$$

It follows directly from Cartan's formula, and its extension for the Schouten bracket, that

(2.7) 
$$L_X \pi = 0, \quad L_X \text{vol} = 0.$$

It turns out that the two notions of divergence are compatible in the following sense:

**Lemma 2.14.** Let  $\mathbb{J}$  be a generalized complex structure on  $(M, H_0)$ . Given a volume form vol, one has

$$\pi_T \operatorname{div}_{\operatorname{vol}}(\mathbb{J}) = \operatorname{div}_{\operatorname{vol}}(\pi_{\mathbb{J}}).$$

Proof. Observe by Lemma 2.6 that  $\pi_T \operatorname{div}_{\operatorname{vol}}(\mathbb{J})$  is invariant under the *b*-field action, and also  $\pi_{\mathbb{J}}$  is invariant by definition. Furthermore, as the regular points of a generalized complex structure are dense in M, in suffices to prove the result at regular points. Using the Darboux theorem for generalized complex structures ([22] Theorem 4.35), in an open neighborhood of any regular point there exists a diffeomorphism and *b*-field transformation such that in this neighborhood  $\mathbb{J}$  is a product of a standard complex space  $\mathbb{C}^k$  and standard symplectic space  $(\mathbb{R}^{2n-2k}, \omega)$ . In particular it is defined by the closed pure spinor

$$\psi = e^{\sqrt{-1}\omega} \wedge \Theta,$$

where  $\Theta$  is a holomorphic volume form on  $\mathbb{C}^k$ . It follows that  $\pi_{\mathbb{J}} = \omega^{-1}$ , where the inverse is defined leaf-wise. It then follows easily, expressing vol =  $e^{-f}\Theta \wedge \overline{\Theta} \wedge \omega^k$ , that the relevant normalized spinor is  $e^{-f/2}e^{\sqrt{-1}\omega} \wedge \Theta$ , and thus  $\pi_T \operatorname{div}_{\operatorname{vol}}(\mathbb{J}) = -\frac{1}{2}\omega^{-1}df = \frac{1}{2}\operatorname{div}_{\operatorname{vol}}(\pi_{\mathbb{J}})$ .

**Lemma 2.15.** Suppose  $\mathbb{J}$  is a generalized complex structure on  $(M, H_0)$  and vol a volume form. Suppose, furthermore, that  $\pi_{\mathbb{J}}$  is non-degenerate over an open dense subset of M. Then  $\operatorname{div}_{\operatorname{vol}}(\mathbb{J}) = \operatorname{div}_{\operatorname{vol}}(\pi_{\mathbb{J}})$  if and only if  $L_{\operatorname{div}_{\operatorname{vol}}(\pi_{\mathbb{J}})} \mathbb{J} = 0$ . *Proof.* Let  $X = \operatorname{div}_{\operatorname{vol}}(\pi_{\mathbb{J}})$  and  $\operatorname{div}_{\operatorname{vol}}\mathbb{J} = X + B$ , where B is a 2-form, see Lemma 2.14. In one direction, if B=0 then  $L_X\mathbb{J}=0$  by Lemma 2.11. In the other direction, Lemma 2.11 and the assumption  $L_X\mathbb{J}=0$ , yield

$$0 = L_{X+B}\mathbb{J} = L_B\mathbb{J}.$$

As the infinitesimal action of *b*-fields on generalized complex structures has no stabilizer in the locus where  $\pi_{\mathbb{J}}$  is nondegenerate, we know B = 0 on that locus, and hence everywhere by the assumption that this tensor is nondegenerate on a dense set.

**Remark 2.16.** The nondegeneracy condition on  $\pi_{\mathbb{J}}$  in Lemma 2.15 is essential. For instance, consider the case when  $\mathbb{J}$  is a generalized complex structure corresponding to a complex structure J on TM, i.e

$$\mathbb{J} = \begin{pmatrix} -J & 0\\ 0 & J^* \end{pmatrix}.$$

In this case  $\pi_{\mathbb{J}} = 0$  and, therefore,  $\operatorname{div}_{\operatorname{vol}} \pi_{\mathbb{J}} = 0$  for any volume form vol. On the other hand, we have a local spinor  $\Theta$  for  $\mathbb{J}$  which is a holomorphic volume form. Now fix any volume form vol and note that this defines a function f such that the spinor  $\psi = e^{-f/2}\Theta$  is vol-normalized. An elementary computation using that  $df - \sqrt{-1}\mathbb{J}df \in \operatorname{Ker}(\psi)$  yields

$$d\psi = \sqrt{-1}(-\mathbb{J}\frac{1}{2}df) \cdot \psi = \sqrt{-1}(-\frac{1}{2}J^*df) \cdot \psi.$$

In particular, for generic f,  $0 = \operatorname{div}_{\operatorname{vol}}(\pi_{\mathbb{J}}) \neq \operatorname{div}_{\operatorname{vol}}(\mathbb{J}) = -\frac{1}{2}dJ^*df$ . Note though, using that  $dJ^*df$  is of type (1, 1), it follows still that  $L_{\operatorname{div}_{\operatorname{vol}}\mathbb{J}}\mathbb{J} = 0$  in accordance with Lemma 2.11. Note furthermore that if J is compatible with a Kähler metric  $\omega$ , and the data is interpreted as a generalized Kähler structure  $(\mathbb{J}_{\omega}, \mathbb{J})$ , then for f nonconstant  $L_{\operatorname{div}_{\operatorname{vol}}\mathbb{J}}\mathbb{J}_{\omega} \neq 0$ .

#### 2.3. Generalized Kähler structures.

**Definition 2.17.** Let  $(M, H_0)$  be a smooth manifold with a closed 3-form. A generalized Kähler structure on  $(M, H_0)$  is a pair of commuting generalized complex structures  $(\mathbb{I}, \mathbb{J})$  such that the bilinear form

 $\langle -\mathbb{IJ}\cdot,\cdot \rangle$ 

on  $TM \oplus T^*M$  is positive definite. We denote the operator  $-\mathbb{IJ}$  by  $\mathbb{G}$ , which is a generalized metric.

A fundamental result of Gualtieri states that a generalized Kähler structure  $(\mathbb{I}, \mathbb{J})$  on  $(M, H_0)$  can be equivalently described by bihermitian data on  $(M, H_0)$ .

**Theorem 2.18** ([22] Ch. 6). Let  $(\mathbb{I},\mathbb{J})$  be a generalized Kähler structure on  $(M, H_0)$ . Then there exist unique Riemannian metric g, real 2-form b and orthogonal integrable complex structures I and J, such that

(2.8) 
$$\mathbb{I} = \frac{1}{2} e^b \begin{pmatrix} I + J & -(\omega_I^{-1} - \omega_J^{-1}) \\ \omega_I - \omega_J & -(I^* + J^*) \end{pmatrix} e^{-b}, \quad \mathbb{J} = \frac{1}{2} e^b \begin{pmatrix} I - J & -(\omega_I^{-1} + \omega_J^{-1}) \\ \omega_I + \omega_J & -(I^* - J^*) \end{pmatrix} e^{-b},$$

where the fundamental 2-forms  $\omega_I = gI$  and  $\omega_J = gJ$  satisfy

$$-d_I^c \omega_I = H_0 + db = d_J^c \omega_J.$$

Conversely, if the data (g, b, I, J) satisfies (2.9), then (2.8) determines a generalized Kähler structure on  $(M, H_0)$ .

**Remark 2.19.** By the theorem above we can refer equivalently to generalized Kähler structures by the data  $(\mathbb{I}, \mathbb{J})$  or the bihermitian data (g, I, J, b). At times we will refer simply to a generalized Kähler structure via (g, I, J), where implicitly we mean to choose  $H_0 = -d_I^c \omega_I = d_J^c \omega_J$  and b = 0. **Definition 2.20.** A generalized complex structure is called *symplectic type* if the associated Poisson tensor  $\pi_{\mathbb{J}}$  is everywhere nondegenerate. A generalized Kähler structure  $(\mathbb{I}, \mathbb{J})$  on  $(M, H_0)$  is called *symplectic type* if  $\mathbb{J}$  is symplectic type. It is called *nondegenerate* if  $\mathbb{I}$  and  $\mathbb{J}$  are both symplectic type.

If the data (g, I, J) satisfies that  $\det(I + J) \neq 0$  on M, we can set  $b \coloneqq g(I + J)^{-1}(I - J)$  and  $F \coloneqq -2g(I + J)^{-1}$ . The data (g, I, J, b) is then generalized Kähler with  $H_0 = 0$ , and furthermore  $\mathbb{J} = \begin{pmatrix} 0 & -F^{-1} \\ F & 0 \end{pmatrix}$ . This implies that showing that F is a symplectic form and  $\mathbb{J}$  is a symplectic type generalized complex structure.

For a nondegenerate structure  $(\mathbb{I}, \mathbb{J})$  the corresponding transformations  $I \pm J \in \text{End}(TM)$  are invertible, and there are canonically associated symplectic forms

$$F_{\pm} = -2g(I \pm J)^{-1}.$$

If I and J are given by (2.8), then setting  $b' = b - g(I + J)^{-1}(I - J)$  we observe that

$$\mathbb{I} = e^{b'-4\Omega} \begin{pmatrix} 0 & -F_{-}^{-1} \\ F_{-} & 0 \end{pmatrix} e^{-b'+4\Omega}, \quad \mathbb{J} = e^{b'} \begin{pmatrix} 0 & -F_{+}^{-1} \\ F_{+} & 0 \end{pmatrix} e^{-b'}$$

where  $\Omega = g(I+J)^{-1}(I-J)^{-1}$  is a closed 2-form, see [2, §3.1]. The underlying  $d_{H_0}$ -closed spinors are  $e^{4\Omega - b' + \sqrt{-1}F_-}$  and  $e^{-b' + \sqrt{-1}F_+}$ .

#### 3. Scalar curvature as moment map

3.1. **Definition and basic properties.** In this subsection we recall the definition of Goto's scalar curvature following [19]. Let  $(\mathbb{I}, \mathbb{J})$  be a generalized Kähler structure on  $(M, H_0)$ . This data determines a Riemannian metric g on M. Let  $dV_g$  be the corresponding volume form, and pick an arbitrary volume form  $\mu_f := e^{-f} dV_g$ . Associated to the data  $(\mathbb{I}, \mathbb{J}, \mu_f)$ , Goto assigns a scalar quantity  $S(\mathbb{I}, \mathbb{J}, \mu_f) \in C^{\infty}(M, \mathbb{R})$  generalizing the notion of the scalar curvature in Kähler geometry, determined purely by the underlying spinors and the measure  $\mu_f$ .

**Definition 3.1.** ([19]) Let  $(\mathbb{I}, \mathbb{J})$  be a generalized Kähler manifold on  $(M, H_0)$ , with a fixed volume form  $\mu_f = e^{-f} dV_g$ . Let  $\psi_1$  and  $\psi_2$  be pure spinors defining  $\mathbb{I}$  and  $\mathbb{J}$  respectively, normalized relative to  $\mu_f$  according to (2.6), with real potentials  $\eta_i \in TM \oplus T^*M$  satisfying (2.5). Then *Goto's scalar curvature* Gscal( $\mathbb{I}, \mathbb{J}, \mu_f$ ) is the real function defined by the identity

(3.1) 
$$\operatorname{Gscal}(\mathbb{I}, \mathbb{J}, \mu_f) \mu_f \coloneqq \operatorname{Re}\left( (2\sqrt{-1})^{-n} (\psi_1, d_{H_0}(\eta_2 \cdot \overline{\psi}_1)) + (2\sqrt{-1})^{-n} (\psi_2, d_{H_0}(\eta_1 \cdot \overline{\psi}_2)) \right).$$

**Proposition 3.2.** (19) Propositions 3.2, 3.5, 3.6) The following hold:

- (1) Gscal( $\mathbb{I}, \mathbb{J}, \mu_f$ ) does not depend on the choice of the local spinors  $\psi_i$  and determines a welldefined real-valued function on M.
- (2) If b is a 2-form, then  $\operatorname{Gscal}(\mathbb{I},\mathbb{J},\mu_f) = \operatorname{Gscal}(e^b \mathbb{I} e^{-b}, e^b \mathbb{J} e^{-b}, \mu_f)$ .
- (3)  $\operatorname{Gscal}(\mathbb{I}, \mathbb{J}, \mu_f) = \operatorname{Gscal}(\mathbb{J}, \mathbb{I}, \mu_f).$

**Remark 3.3.** Item (2) essentially follows from [19] Proposition 3.5, although as stated there it requires that b is closed. The general claim follows easily from the b-field transformation laws from §2, noting that the conjugated structure is generalized Kähler on the background  $(M, H_0 - db)$ .

3.2. A formal moment map setup. In [20, 19] (see also the preceding work by Boulanger [8]), Goto interprets  $\operatorname{Gscal}(\mathbb{I}, \mathbb{J}, \mu_f)$  as the moment map for a certain formal infinitesimal group action. In particular, he defines a Lie algebra of Hamiltonian automorphisms using scalar potentials which are invariant under the divergence of  $\pi_{\mathbb{J}}$  with respect to an *arbitrary* volume form  $\mu_f$  (cf. Definition 3.10). Then, a general variational formula for the scalar curvature is computed, and it is claimed that this determines the scalar curvature as the moment map for a class of 'modified Hamiltonians' (cf. [19] Definition 4.2). We were not able to verify that these modified Hamiltonians form a Lie algebra, and instead take a different approach here. Inspired by recent works of E. Inoue [27] of A. Lahdili [28], we ask that the volume vol =  $\mu_f$  is such that the divergence of  $\pi_{\mathbb{J}}$  with respect to vol, which always preserves  $\mathbb{J}$ , also preserves  $\mathbb{I}$ . This is a nontrivial further constraint (see Lemma 3.6 below) which in the Kähler case (M, g, J, J) boils down for asking that  $\log\left(\frac{\text{vol}}{dV_g}\right)$  is a Killing potential, which is precisely the set-up in [27]. In general, it is not always clear that such a volume form will exist, but with this further constraint in place Goto's variational formulas lead directly to the claim that the scalar curvature is the moment map for this infinitesimal group action.

**Definition 3.4.** Given a generalized Kähler structure  $(\mathbb{I}, \mathbb{J})$ , we say that a volume form vol is *adapted to*  $(\mathbb{I}, \mathbb{J})$  if

$$L_{\operatorname{div}_{\operatorname{vol}}}\mathbb{J}\mathbb{I}=0$$

For simplicity at times we will refer to a triple  $(\mathbb{I}, \mathbb{J}, \text{vol})$  as *adapted*.

**Lemma 3.5.** Suppose  $(\mathbb{I},\mathbb{J})$  is a generalized Kähler structure defined on  $(M, H_0)$ , with corresponding bihermitian data (g, I, J, b). Then

$$\pi_T \mathfrak{aut}(M, H_0, \mathbb{I}, \mathbb{J}) < \mathfrak{aut}(M, g, I, J)$$

Proof. Elements of  $\mathfrak{aut}(M, H_0)$  are canonically identified with sections X + B of  $TM \oplus \wedge^2(T^*M)$ . The induced infinitesimal action of a section X + B on the upper right block of an endomorphism of  $E = TM \oplus T^*M$  is purely via Lie derivative by the vector field component X. Thus if such an infinitesimal automorphism preserves  $\mathbb{I}$  and  $\mathbb{J}$ , then it also preserves the generalized metric  $\mathbb{G} = -\mathbb{IJ}$ , and then by inspecting the form of  $\mathbb{I}$  and  $\mathbb{J}$  in Theorem 2.18, it follows that X preserves g, I, and J, as claimed.

**Lemma 3.6.** Suppose  $(\mathbb{I}, \mathbb{J}, \text{vol})$  is an adapted generalized Kähler structure on  $(M, H_0)$ . Let (g, I, J, b) be the corresponding bihermitian data and f the smooth function determined by  $\text{vol} = \mu_f$ . Then the vector field

$$X = \operatorname{div}_{\operatorname{vol}} \pi_{\mathbb{J}} = \frac{1}{2} \left( I \theta_I^{\sharp} + J \theta_J^{\sharp} - (I+J) df^{\sharp} \right)$$

satisfies

$$L_X g = 0, \qquad L_X I = L_X J = 0.$$

In particular, X generates a compact torus  $\mathbb{T} \subset \text{Isom}(g)$ .

*Proof.* Since  $\operatorname{div}_{vol}(\mathbb{J})$  preserves  $\mathbb{I}$  by hypothesis, and preserves  $\mathbb{J}$  by Lemma 2.11, Lemma 3.5 yields that

$$X \coloneqq \pi_T(\operatorname{div}_{\operatorname{vol}}(\mathbb{J}))$$

preserves (g, I, J). We thus only need to compute X in terms of (g, I, J, vol). By Lemma 2.14,

$$X = \operatorname{div}_{\operatorname{vol}} \pi_{\mathbb{J}}$$

whereas by Theorem 2.18,

$$\pi_{\mathbb{J}} = \frac{1}{2}(I+J)g^{-1}.$$

Using the definition of f and the bihermitian property,

vol = 
$$e^{-f} dV_g = e^{-f} \omega_I^{[n]} = \omega_J^{[n]},$$

thus

$$i_{\pi_{\mathbb{J}}} \operatorname{vol} = \frac{e^{-f}}{2} \left( \omega_{I}^{[n-1]} + \omega_{J}^{[n-1]} \right)$$

It follows that

$$d(\imath_{\pi_{\mathbb{J}}} \mathrm{vol}) = \frac{e^{-f}}{2} \left( (\theta_I - df) \wedge \omega_I^{[n-1]} + (\theta_J - df) \wedge \omega_J^{[n-1]} \right),$$

where  $\theta_I \coloneqq Id^*\omega_I$  and  $\theta_J \coloneqq Jd^*\omega_J$  are the Lee forms of (g, I) and (g, J), respectively, and we have used the basic identity  $d\omega_I^{[n-1]} = \theta_I \wedge \omega^{[n-1]}$  and similarly for  $\omega_J$ . It thus follows that

$$X = \operatorname{div}_{\operatorname{vol}} \pi_{\mathbb{J}} = \frac{1}{2} \left( I \theta_I^{\sharp} + J \theta_J^{\sharp} \right) - \pi_{\mathbb{J}} df,$$

as claimed.

**Remark 3.7.** The existence of a Killing vector field X for (g, I, J) of the above form is thus a necessary condition for (g, I, J) to come from a vol-adapted GK pair  $(\mathbb{I}, \mathbb{J})$ . In the case when  $\pi_{\mathbb{J}}$  is non-degenerate on an open dense subset, this condition is also sufficient, see Lemma 2.15.

**Definition 3.8.** Given a generalized Kähler structure (g, I, J), we say that the volume form vol is (g, I, J)-adapted if the vector field X defined in Lemma 3.6 preserves (g, I, J).

**Remark 3.9.** Remark 2.16 makes clear that a volume form being (g, I, J)-adapated is strictly weaker than being adapted to  $(\mathbb{I}, \mathbb{J})$ .

In what follows, we denote by  $\mathbb{T}$  the torus generated by the infinitesimal isometry X of the bihermitian structure (g, I, J) corresponding to  $(\mathbb{I}, \mathbb{J}, \text{vol})$ .

**Definition 3.10.** [Normalized potentials & Hamiltonian automorphisms] Given  $(\mathbb{I}, \mathbb{J})$  a generalized Kähler structure with adapted volume form vol and corresponding torus  $\mathbb{T}$ , we define the space of *normalized potentials* by

$$C_0^{\infty}(M,\mathbb{R})^{\mathbb{T}} = \{ u \in C^{\infty}(M,\mathbb{R}) \mid du(X) = 0, \ \int_M u \text{vol} = 0 \}.$$

Furthermore, define the space of *Hamiltonian automorphisms* by

$$\mathfrak{ham}^{\mathbb{T}}(\mathbb{J}) = \{ \Psi(\mathbb{J}du) \mid u \in C_0^{\infty}(M, \mathbb{R})^{\mathbb{T}} \},\$$

**Lemma 3.11.** (cf. [21] Proposition 3.1) Given the setup above,  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$  is a Lie subalgebra of  $\mathfrak{aut}(M, H_0)$ , isomorphic to  $(C_0^{\infty}(M, \mathbb{R}), \mathrm{vol})$  with the Lie bracket given by the Poisson bracket with respect to  $\pi_{\mathbb{J}}$ :

$$[\mathbb{J}du,\mathbb{J}dv]_{H_0}=\mathbb{J}d\{u,v\}_{\pi_{\mathbb{J}}}$$

Furthermore,  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$  preserves  $\mathbb{J}$ , vol, and  $\operatorname{div}_{\operatorname{vol}}(\mathbb{J})$ , i.e.

$$L_{\mathbb{J}du}^{H_0} \mathbb{J} = 0, \qquad L_{\pi_{\mathbb{J}}du} \operatorname{vol} = 0, \qquad [\Psi(\mathbb{J}du), \operatorname{div}_{\operatorname{vol}}(\mathbb{J})]_{\operatorname{aut}} = 0.$$

for all  $u \in C_0^{\infty}(M, \mathbb{R})^{\mathbb{T}}$ .

*Proof.* Notice first that the map

$$(C_0^{\infty}(M,\mathbb{R}), \mathrm{vol}) \ni u \to \Psi(\mathbb{J}du) \in \mathfrak{aut}(M, H_0)$$

is injective. Indeed, if  $\Psi(\mathbb{J}du) = 0$ , then by Theorem 2.18 we find  $\pi_T(\Psi(\mathbb{J}du)) = \pi_{\mathbb{J}}(du) = \frac{1}{2}(I + J)du^{\sharp} = 0$  and d(I - J)du = 0. It then follows that  $dd_I^c u = dd_J^c u = 0$ , so u = 0 by the maximum principle and the normalization.

Using integrability of J and the definition of Dorfman bracket we have

$$\begin{split} [\mathbb{J}du, \mathbb{J}dv]_{H_0} &= [du, dv]_{H_0} + \mathbb{J}[\mathbb{J}du, dv]_{H_0} + \mathbb{J}[du, \mathbb{J}dv]_{H_0} \\ &= \mathbb{J}[\mathbb{J}du, dv]_{H_0} \\ &= \mathbb{J}L_{\pi_{\mathbb{J}}du}dv \\ &= \mathbb{J}d\{u, v\}_{\pi_{\mathbb{J}}}. \end{split}$$

If X preserves u, v, and  $\pi_{\mathbb{J}}$ , then it also preserves  $\{u, v\}_{\pi_{\mathbb{J}}}$ , showing  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$  is a subalgebra. Using the integrability of  $\mathbb{J}$  and the fact that the automorphisms induced by closed 1-forms are trivial, it follows that

$$L_{\mathbb{J}du}^{H_0}\mathbb{J} = \mathbb{J}L_{du}^{H_0}\mathbb{J} = 0$$

as claimed. Finally, we have

(3.2)

) 
$$L_{\pi_{\mathbb{J}}du} \operatorname{vol} = di_{\pi_{\mathbb{J}}du} \operatorname{vol} = d(du \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol}) = -du \wedge (di_{\pi_{\mathbb{J}}} \operatorname{vol}) = (L_X u) \operatorname{vol} = 0$$

The last property follows from the first two.

The lemma above shows that  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$  acts infinitesimally on the space of generalized Kähler structures  $(\mathbb{I}, \mathbb{J})$  adapted to  $(\mathbb{J}, \text{vol})$ . The use of this space represents the key conceptual difference between our approach and that of [19], where the 'modified Hamiltonians' are used. For technical purposes it is more natural to drop the integrability condition on  $\mathbb{I}$  and consider the action of  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$  on a larger space:

**Definition 3.12.** Given a generalized complex structure  $\mathbb{J}$  on  $(M, H_0)$  and a volume form vol, the space of  $(\mathbb{J}, \text{vol})$ -adapted almost generalized Kähler structures is the space of all generalized almost complex structures  $\mathbb{I}$  compatible with  $\mathbb{J}$  and invariant under the action of  $\text{div}_{\text{vol}}(\mathbb{J})$ :

$$\mathcal{AGK}(\mathbb{J}, \mathrm{vol}) = \left\{ \mathbb{I} \in \mathrm{End}(E) \mid \mathbb{I}^2 = -\mathrm{Id}, \ \langle \mathbb{I} \cdot, \mathbb{I} \cdot \rangle = \langle \cdot, \cdot \rangle, \ -\mathbb{IJ} = -\mathbb{JI} > 0, \ L_{\mathrm{div}_{\mathrm{vol}}}(\mathbb{J})\mathbb{I} = 0 \right\}.$$

There is a natural Kähler structure ([19] Proposition 5.2, cf. also [8]) determined at  $\mathbb{I} \in \mathcal{AGK}(\mathbb{J}, \text{vol})$  by the symplectic form and Riemannian metric

$$\boldsymbol{\Omega}_{\mathbb{I}}(\dot{\mathbb{I}}_1,\dot{\mathbb{I}}_2) = \frac{1}{4} \int_M \operatorname{tr}\left(\mathbb{I}\dot{\mathbb{I}}_1\dot{\mathbb{I}}_2\right) \operatorname{vol}, \qquad \boldsymbol{g}(\dot{\mathbb{I}}_1,\dot{\mathbb{I}}_2) = \frac{1}{4} \int_M \operatorname{tr}\left(\dot{\mathbb{I}}_1\dot{\mathbb{I}}_2\right) \operatorname{vol}.$$

The corresponding formal integrable almost complex structure acts by

$$(3.3) J_{\mathbb{I}}(\dot{\mathbb{I}}) \coloneqq \ddot{\mathbb{I}}.$$

It follows from Lemma 3.11 that  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$  acts on  $\mathcal{AGK}(\mathbb{J}, \mathrm{vol})$  via infinitesimal symmetry. It follows immediately from the work of Goto that this action is Hamiltonian, with moment map given by the scalar curvature.

**Theorem 3.13.** [19] (Theorem 1.1) The natural action of  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$  on  $\mathcal{AGK}(\mathbb{J}, \mathrm{vol})$  is Hamiltonian with moment map given by the scalar curvature  $\mathrm{Gscal}(\mathbb{I}, \mathbb{J}, \mathrm{vol})$  associated to  $(\mathbb{I}, \mathbb{J}, \mathrm{vol})$  via (3.1). In particular,

$$\Omega\left(L_{\mathbb{J}du}^{H_0}\mathbb{I}, \left.\frac{\partial}{\partial t}\right|_{t=0}\mathbb{I}_t\right) = \int_M \left(\frac{\partial}{\partial t} \operatorname{Gscal}(\mathbb{I}_t, \mathbb{J}, \operatorname{vol})\right) u \operatorname{vol}$$

for any one-parameter family  $\mathbb{I}_t \in \mathcal{AGK}(\mathbb{J}, \mathrm{vol})$ .

Proof. In [19] Goto proved a more general variation formula

$$(3.4) \qquad \mathbf{\Omega}\left(L_{\mathbb{J}du}^{H_0}\mathbb{I}, \frac{\partial}{\partial t}\Big|_{t=0}\mathbb{I}_t\right) = \int_M \left(\frac{\partial}{\partial t}\Big|_{t=0}\operatorname{Gscal}(\mathbb{I}_t, \mathbb{J}, \operatorname{vol})\right) u \operatorname{vol} + 2\mathbf{\Omega}\left(uL_{\operatorname{div}_{\operatorname{vol}}(\mathbb{J})}\mathbb{I}, \frac{\partial}{\partial t}\Big|_{t=0}\mathbb{I}_t\right),$$

which holds for any  $\mathbb{T}$ -invariant smooth function u on M. In our setting  $\operatorname{div}_{\operatorname{vol}}(\mathbb{J})$  preserves also  $\mathbb{I}$ , thus the second term on the right hand side vanishes.  $\Box$ 

**Remark 3.14.** In the above statement, we have identified the Lie algebra  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$  with

$$(C_0^{\infty}(M,\mathbb{R})^{\mathbb{T}}, \mathrm{vol}, \{\cdot,\cdot\}_{\pi_{\mathbb{J}}})$$

via Lemma 3.11. Notice that  $\operatorname{Gscal}(\mathbb{I},\mathbb{J},\operatorname{vol})$  is a  $\mathbb{T}$ -invariant function by Lemma 3.5 and Theorem 4.3. The  $L_2$  global product on M with respect to vol defines an ad-invariant inner product on  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$  (see (3.2)), which we use to see  $\operatorname{Gscal}(\mathbb{I},\mathbb{J},\operatorname{vol})$  as an element of  $(\mathfrak{ham}^{\mathbb{T}}(\mathbb{J}))^*$ .

**Definition 3.15.** Given  $(\mathbb{I}, \mathbb{J}, \text{vol})$  an adapted generalized Kähler structure on  $(M, H_0)$ , we say that

- (1) (I, J, vol) is constant scalar curvature (cscGK) if Gscal(I, J, vol) =  $\overline{\mu}$  is constant.
- (2) (I, J, vol) is extremal if  $\chi \coloneqq \Psi(JdGscal(I, J, vol))$  is a Hamiltonian isometry, i.e.  $L_{\chi}I = 0$ .

**Corollary 3.16.** Given  $(\mathbb{I}, \mathbb{J}, \text{vol})$  an adapted generalized Kähler structure on  $(M, H_0)$ ,

- (1) (I, J, vol) is cscGK if and only if I is a zero of the moment map  $\mu$  of  $\mathcal{AGK}(J, vol)$ .
- (2) (I, J, vol) is extremal if and only if I is a critical point of the functional  $\mathbb{I} \to ||\boldsymbol{\mu}(\mathbb{I})||_{vol}^2$  on  $\mathcal{AGK}(\mathbb{J}, \mathrm{vol}).$

*Proof.* The first claim is immediate from Theorem 3.13. For the second claim we can compute the variation and use Theorem 3.13 to obtain

$$\frac{d}{dt}\Big|_{t=0} \|\boldsymbol{\mu}(\mathbb{I}_t)\|_{\text{vol}}^2 = \int_M \left(\frac{\partial}{\partial t}\Big|_{t=0} \operatorname{Gscal}(\mathbb{I}_t, \mathbb{J}, \text{vol})\right) \operatorname{Gscal}(\mathbb{I}, \mathbb{J}, \text{vol}) \operatorname{vol} = \mathbf{\Omega}\left(L_{\chi}\mathbb{I}, \frac{\partial}{\partial t}\Big|_{t=0}\mathbb{I}_t\right).$$
he symplectic form  $\mathbf{\Omega}$  is nondegenerate, the second claim follows.

Since the symplectic form  $\Omega$  is nondegenerate, the second claim follows.

**Remark 3.17.** By Theorem 4.3,  $Gscal(\mathbb{I}, \mathbb{J}, vol)$  and hence also the corresponding notion of cscGK, depends only on the data (g, I, J, vol). In other words, one can arbitrarily choose the 2-form b and set  $H_0 \coloneqq -d_I^c \omega_I - db$  (see (2.9)) in the momentum map setup, subject to the condition  $L_{\operatorname{div}_{\operatorname{vol}}(\mathbb{J})}\mathbb{I} = 0$ . In the symplectic type case considered in [4], the data (g, I, J, vol) is induced by a symplectic 2-form F on M taming the complex structure J, with  $\text{vol} \coloneqq \frac{F^n}{n!}$  being the corresponding symplectic volume. In this case, letting  $(H_0, b) = (0, +(FJ)^{\text{skew}})$  allows one to recast the setup in [4] in terms of the one presented here and in [20].

In view of the above remark and Lemma 3.5, we also give the following:

**Definition 3.18.** Given a generalized Kähler structure (g, I, J) and a (g, I, J)-adapted volume form vol, we say that

- (1) (g, I, J, vol) is cscGK if Gscal is constant;
- (2) (g, I, J, vol) is extremal if the vector field  $\frac{1}{2}(I+J)(d\text{Gscal})^{\sharp}$  preserves (g, I, J).

## 3.3. The generically symplectic case.

**Definition 3.19.** We say that a generalized complex structure  $\mathbb{J}$  on  $(M, H_0)$  is generically symplectic type if the real Poisson tensor  $\pi_{\mathbb{J}}$  is non-degenerate over an open dense subset of M. A generalized Kähler structure  $(\mathbb{I},\mathbb{J})$  is called *generically symplectic type* if  $\mathbb{J}$  is generically symplectic type. A bihermitian data (g, I, J) is called generically symplectic type if  $\frac{1}{2}(I+J)g^{-1}$  is non-degenerate over an open dense subset.

We note that a generalized Kähler structure for which the Poisson tensor defined by (1.1) is non-degenerate over an open dense subset of M are generically symplectic type. In particular, the generalized Kähler structures of even type on the compact complex surfaces with first Betti number 1 constructed in [29, 12] and [38] are generically symplectic type. Generalized Kähler structures of generically symplectic type will allow us to extend the theory we developed in the symplectic type case in [4]. This extension hinges on the following observation.

**Lemma 3.20.** Let (M, g, I, J, b) be a generalized Kähler structure with adapted volume form vol in the sense of Definition 3.8, and with corresponding generalized complex structures  $(\mathbb{I},\mathbb{J})$ . Let  $\mathbb{T}$  the compact torus generated by  $X = \operatorname{div}_{\operatorname{vol}}(\pi_{\mathbb{J}})$ . Suppose that  $(\mathbb{J},\mathbb{J})$  is generically symplectic type, and that b is  $\mathbb{T}$ -invariant. Then  $(\mathbb{I}, \mathbb{J}, \mathrm{vol})$  is adapted in the sense of Definition 3.4.

*Proof.* By Theorem 2.8, we have that  $L_X \mathbb{J} = L_X \mathbb{I} = 0$ . Thus, by Lemma 2.15,  $\operatorname{div}_{\operatorname{vol}}(\mathbb{J}) = X$  and, therefore,

$$L_{\operatorname{div}_{\operatorname{vol}}(\mathbb{J})}\mathbb{I} = L_X\mathbb{I} = 0.$$

**Remark 3.21.** Using Lemma 3.20, we can start with a generically symplectic type bihermitian data (g, I, J) on M, and an adapted volume form vol generating a torus  $\mathbb{T}$ . We then choose a  $\mathbb{T}$ -invariant 2-form b (note b = 0 will suffice) and define  $H_0 \coloneqq -d_I^c \omega_I - db$ . Then, by Lemma 3.20, the corresponding generalized Kähler structure  $(\mathbb{I}, \mathbb{J})$  on  $(M, H_0)$  belongs to  $\mathcal{AGK}(\mathbb{J}, \text{vol})$ . Furthermore, by virtue of Lemma 2.15, in this case we have  $\operatorname{div}_{\operatorname{vol}}(\mathbb{J}) = X$  and therefore

$$\mathcal{AGK}(\mathbb{J}, \mathrm{vol}) = \mathcal{AGK}^{\mathbb{T}}(\mathbb{J}),$$

where  $\mathcal{AGK}^{\mathbb{T}}(\mathbb{J})$  is the space of all  $\mathbb{J}$ -compatible  $\mathbb{T}$ -invariant almost generalized Kähler pairs  $(\mathbb{I}, \mathbb{J})$  for the natural action of  $\mathbb{T}$  on  $E = TM \oplus T^*M$  by diffeomorphisms.

### 4. GENERALIZED KÄHLER-RICCI SOLITONS AS CSCGK STRUCTURES

In this section we show that generalized Kähler-Ricci solitons are automatically Goto constant scalar curvature, and fit them into the GIT framework constructed above. The first step is to obtain an explicit formula for this curvature in terms of the bihermitian data. Given this, we derive a Bianchi identity for the weighted Bismut Ricci curvature which gives the claim that solitons have constant scalar curvature. We next derive an a priori symmetry which holds for solitons which identifies the relevant adapted volume form, giving the GIT interpretation for generically symplectic type solitons.

4.1. An explicit formula. In this subsection we derive an explicit formula for  $\operatorname{Gscal}(\mathbb{I}, \mathbb{J}, \mu_f)$  in terms of the underlying bihermitian data (M, g, I, J, b). To this end, we first establish the formula under the further key hypothesis that the structure is *nondegenerate*, see Definition 2.20. The reason for this hypothesis is that in this setting the pure spinors underlying the generalized Kähler structure can be made completely explicit in terms of the bihermitian data. In the general case, these underlying pure spinors would involve the choice of partial holomorphic volume forms with respect to both I and J, and it is unclear how to work directly with the mixed I-holomorphic and J-holomorphic coordinates. Given the formula in this special case, the general case follows using the nondegenerate perturbation technique introduced in [1]. As this has been used already throughout [1] and [3], we omit the details.

We begin with a preliminary computational lemma. In the statements below different Laplacians appear. In particular we let  $\Delta$  denote the Riemannian Laplacian, while  $\Delta^{C,I}$  will denote the Laplacian of the Chern connection of the Hermitian structure (g, I), and analogously  $\Delta^{C,J}$ . Recall that for  $f \in C^{\infty}(M, \mathbb{R})$ 

$$\Delta^{C,I} f = \Delta f - \langle df, \theta_I \rangle,$$

where  $\theta_I = Id^*\omega_I$ .

**Lemma 4.1.** Let (M, g, I, J) be a generalized Kähler structure with I + J invertible, and define  $F_+ = -2g(I + J)^{-1}$ . Denote by  $d_{F_+} := F_+g^{-1}d$  the twisted differential. Then, for any smooth function f,

$$\frac{(dd_{F_+}f)\wedge F_+^{n-1}}{F_+^n} = \Delta f - \frac{1}{2} \langle df, d\log \det(I+J) \rangle.$$

Similarly, whenever (I - J) is invertible, we define  $F_{-} = -2g(I - J)^{-1}$  and have

$$\frac{(dd_{F_-}f)\wedge F_-^{n-1}}{F_-^n} = \Delta f - \frac{1}{2} \langle df, d\log \det(I-J) \rangle.$$

*Proof.* In the computation below, the upper-script  $\sharp$  denotes  $g^{-1}$ , and we use that  $F_+ = -2g(I+J)^{-1}$ ,  $b = g(J+I)^{-1}(I-J)$ ,  $\theta_I = I\delta^g I$ ,  $\theta_J = J\delta^g J$ .

$$\frac{(dd_{F_+}f) \wedge F_+^{n-1}}{F_+^n} = \sum_{i=1}^{2m} \left\langle (I+J) \left( \nabla_{e_i} (I+J)^{-1} df^{\sharp} \right), e_i \right\rangle$$
$$= \Delta f - \sum_{i=1}^{2n} \left\langle \left( \nabla_{e_i} (I+J) \right) \left( (I+J)^{-1} (df^{\sharp}) \right), e_i \right\rangle$$
$$= \Delta f - \left\langle (I+J)^{-1} (df^{\sharp}), \delta^g (I+J) \right\rangle$$
$$= \Delta f - \left\langle df^{\sharp}, (I+J)^{-1} (I\theta_I^{\sharp} + J\theta_J^{\sharp}) \right\rangle$$
$$= \Delta f + \frac{1}{2} \left\langle df, b(\theta_J^{\sharp} - \theta_I^{\sharp}) - \theta_I - \theta_J \right\rangle.$$

Our claim then follows from the identity

$$\frac{1}{2}d\log\det(I+J) = \theta_J - \imath_{\theta_J^{\sharp}}b - \delta^g b = \theta_I + \imath_{\theta_I^{\sharp}}b + \delta^g b,$$

which is established in [2, Lemmas 2.10 & 2.13].

**Lemma 4.2.** Let (M, g, I, J) be a nondegenerate generalized Kähler manifold. Then for  $f \in C^{\infty}(M)$  one has

(4.1) 
$$\operatorname{Gscal}(\mathbb{I}, \mathbb{J}, \mu_f) = \frac{1}{4} \left( R - \frac{1}{12} |H|^2 + 2\Delta f - |df|^2 \right),$$

where  $H = H_0 + db = -d_I^c \omega_I = d_J^c \omega_J$ .

*Proof.* Since (M, g, I, J) is nondegenerate, both I + J and I - J are globally invertible. We define  $b = g(I + J)^{-1}(I - J)$ , and apply this *b*-field transform to  $(\mathbb{I}, \mathbb{J})$ . By Theorem 2.18 the corresponding generalized Kähler structure, still denoted  $(\mathbb{I}, \mathbb{J})$ , is given by

(4.2) 
$$\mathbb{I} = e^{-4\Omega} \begin{pmatrix} 0 & -F_{-}^{-1} \\ F_{-} & 0 \end{pmatrix} e^{4\Omega}, \quad \mathbb{J} = \begin{pmatrix} 0 & -F_{+}^{-1} \\ F_{+} & 0 \end{pmatrix},$$

where  $F_{\pm} = -2g(I \pm J)^{-1}$  are the underlying symplectic forms, and  $\Omega = g(I + J)^{-1}(I - J)^{-1}$  is the common real part of *I*- and *J*-holomorphic symplectic forms. Since  $\text{Gscal}(\mathbb{I}, \mathbb{J}, \mu_f)$  is invariant under *b*-field transformation, we can calculate it for the GK structure given by (4.2). It is easy to see that the  $\sqrt{-1}$ -eigenspaces for  $\mathbb{I}$  and  $\mathbb{J}$  are

$$L_{\mathbb{I}}^{1,0} = \{ v - 4\Omega(v) - \sqrt{-1}F_{-}(v) \mid v \in TM \}, \quad L_{\mathbb{J}}^{1,0} = \{ v - \sqrt{-1}F_{+}(v) \mid v \in TM \}.$$

These generalized complex structures have underlying closed pure spinors

$$\varphi_1 = \exp(4\Omega + \sqrt{-1}F_-), \quad \varphi_2 = \exp(\sqrt{-1}F_+)$$

with Mukai norms

$$(\varphi_1, \overline{\varphi_1}) = \frac{F_-^n}{n!} = \det(I - J)^{-1/2} dV_g = e^{-\Psi_-} dV_g,$$
  
$$(\varphi_2, \overline{\varphi_2}) = \frac{F_+^n}{n!} = \det(I + J)^{-1/2} dV_g = e^{-\Psi_+} dV_g,$$

where by definition

$$\Psi_{\pm} \coloneqq \frac{1}{2} \log \det(I \pm J).$$

In the definition of the scalar curvature, we need to use normalized spinors, thus we introduce

$$f_1 = -f/2 + \log \det(I - J)/4, \qquad f_2 = -f/2 + \log \det(I + J)/4,$$

so that  $\psi_i \coloneqq e^{f_i} \varphi_i$  satisfies

$$(\psi_i, \overline{\psi_i}) = \mu_f = e^{-f} dV_g$$

Since  $\varphi_i$  are closed and  $df_i - \sqrt{-1} \mathbb{J}_i df_i \in \operatorname{Ker} \psi_i$ , we have

$$d\psi_i = df_i \wedge \psi_i = df_i \wedge \psi_i - (df_i - \sqrt{-1}\mathbb{J}_i df_i) \cdot \psi_i = \sqrt{-1}(\mathbb{J}_i df_i) \cdot \psi_i.$$

Using the explicit forms of  $\mathbb{J}_i$ , we find that the real potentials  $\eta_i = \mathbb{J}_i df_i$  are

$$\eta_1 = F_-^{-1}(df_1) - 4\Omega F_-^{-1}(df_1) = -\frac{1}{2}(I-J)g^{-1}df_1 + 2g(I+J)^{-1}g^{-1}df_1,$$
  
$$\eta_2 = F_+^{-1}(df_2) = -\frac{1}{2}(I+J)g^{-1}df_2.$$

We also observe the basic fact that the Clifford involution  $\sigma$  in the definition of the Mukai pairing satisfies

$$\sigma\overline{\psi_1} = \sigma(e^{f_1}\overline{e^{4\Omega+\sqrt{-1}F_-}}) = e^{f_1}\sigma(e^{4\Omega-\sqrt{-1}F_-}) = e^{f_1}e^{-4\Omega+\sqrt{-1}F_-}$$

With these formulas we now can compute the necessary terms from (3.1). We start with the first one, the second being analogous. Using Lemma 4.1 we have

$$\begin{aligned} \operatorname{Re}(\psi_{1}, d(\sqrt{-1}\eta_{2} \cdot \overline{\psi}_{1})) &= \operatorname{Re}\left[ (2\sqrt{-1})^{-n} e^{f_{1}} e^{4\Omega + \sqrt{-1}F_{-}} \wedge d(e^{f_{1}} \imath_{\sqrt{-1}\eta_{2}} (-4\Omega + \sqrt{-1}F_{-})) \wedge e^{-4\Omega + \sqrt{-1}F_{-}} \right]_{\operatorname{top}} \\ &= -\frac{1}{2} e^{2f_{1}} F_{-}^{n-1} \wedge \left( df_{1} \wedge F_{-} (g^{-1} df_{2}) + dd_{F_{-}} f_{2} \right) \\ &= -\frac{1}{2} \left( df_{1} \wedge F_{-} (g^{-1} df_{2}) + dd_{F_{-}} f_{2} \right) \wedge F_{-}^{n-1} \\ &= -\frac{1}{2} \left( \langle df_{1}, df_{2} \rangle + \Delta f_{2} - \frac{1}{2} \langle df_{2}, d\log \det(I - J) \rangle \right) \mu_{f} \\ &= \frac{1}{8} \left( 2\Delta (f - \Psi_{+}) - |df|^{2} + \langle d\Psi_{+}, d\Psi_{-} \rangle + \langle df, d\Psi_{-} - d\Psi_{+} \rangle \right) \mu_{f}, \end{aligned}$$

where the last line follows using the definitions of  $\Psi_{\pm}$ . We can compute the second summand  $\operatorname{Re}(\psi_2, d(\eta_1 \cdot \overline{\psi}_2))$  of Definition 3.1 analogously, or just observe that it is invariant under the action of *b*-field transform, and the conjugation by  $e^{4\Omega}$  transforms it into an identical expression, modulo exchanging  $\Psi_{\pm}$ . This yields

$$\operatorname{Re}(\psi_2, d(\sqrt{-1}\eta_1 \cdot \overline{\psi}_2)) = \frac{1}{8} \left( 2\Delta (f - \Psi_-) - |df|^2 + \langle d\Psi_+, d\Psi_- \rangle + \langle df, d\Psi_+ - d\Psi_- \rangle \right) \mu_f.$$

Finally, there is the further identity ([1] Lemma 4.5)

$$R - \frac{1}{12} |H|^2 = -\Delta(\Psi_+ + \Psi_-) + \langle d\Psi_+, d\Psi_- \rangle.$$

Collecting the above calculations gives the result.

**Theorem 4.3.** (Theorem 1.2) Let (M, g, I, J) be a generalized Kähler manifold determined by generalized complex structures  $(\mathbb{I}, \mathbb{J})$ . Then for all  $f \in C^{\infty}(M)$  one has

$$\operatorname{Gscal}(\mathbb{I},\mathbb{J},\mu_f) = \frac{1}{4} \left( R - \frac{1}{12} |H|^2 + 2\Delta f - |df|^2 \right).$$

*Proof.* This follows from the perturbation method described above, and we omit the details (cf. for instance [1] Proposition 4.3).  $\Box$ 

4.2. Generalized Ricci solitons. Given a smooth manifold M, a triple (g, H, f) of a Riemannian metric, closed three-form, and function defines a generalized Ricci soliton (cf. [15]) if

$$\operatorname{Rc} -\frac{1}{4}H^{2} + \nabla^{2}f = 0$$
$$d_{a}^{*}H + i_{\nabla f}H = 0.$$

These equations are naturally expressed using the associated Bismut connection,

$$\nabla^H \coloneqq \nabla + \frac{1}{2}g^{-1}H.$$

In particular, if we let  $\operatorname{Rc}^{H}$  denote the Ricci curvature of this connection, we define

$$\begin{aligned} &\operatorname{Rc}^{H,f} \coloneqq \ \operatorname{Rc}^{H} + \nabla^{H} \nabla^{H} f = \operatorname{Rc} - \frac{1}{4} H^{2} + \nabla^{2} f - \frac{1}{2} (d_{g}^{*} H + i_{\nabla f} H), \\ & R^{H,f} = R - \frac{1}{12} |H|^{2} + 2\Delta f - |\nabla f|^{2}. \end{aligned}$$

and we observe that the generalized Ricci soliton system is equivalent to the vanishing of  $\operatorname{Rc}^{H,f} \equiv 0$ . The relevant identity uses the weighted divergence operator associated to H and f, i.e. for a covariant tensor T we define

$$\operatorname{div}^{H,f}T = e^f \operatorname{tr} \nabla^H \left( e^{-f}T \right)$$

With this background we can prove a Bianchi identity for these curvatures, which is a special case of ([36] Proposition 6.8):

**Proposition 4.4.** Let  $(M^n, g, H, f)$  be a Riemannian manifold with closed three-form and function f. Then

$$\operatorname{div}^{H,f} \operatorname{Rc}^{H,f} = \frac{1}{2} \nabla R^{H,f}$$

*Proof.* We first observe that for a two-tensor K,

$$\nabla_i^H K_{ij} = \nabla_i K_{ij} + \frac{1}{2} H_{ipj} K_{ip}.$$

Next observe using the classical Bianchi identity and the Bochner identity that

$$\nabla_i^f \operatorname{Rc}_{ij}^f = \nabla_i \left( \operatorname{Rc}_{ij} + \nabla_i \nabla_j f \right) - \operatorname{Rc}_{ij}^f \nabla_i f$$
  
=  $\frac{1}{2} \nabla_j R + \nabla_i \nabla_j \nabla_i f - \operatorname{Rc}_{ij} \nabla_i f - \nabla_i \nabla_j f \nabla_i f$   
=  $\frac{1}{2} \nabla_j \left( R + 2\Delta f - |\nabla f|^2 \right).$ 

Also using ([15] Lemma 3.19) we obtain

$$\nabla_i \left( -\frac{1}{4} H^2 - \frac{1}{2} d^* H \right)_{ij} + \frac{1}{2} H_{ipj} \left( -\frac{1}{2} d^* H \right)_{ip} = -\frac{1}{24} \nabla_j |H|^2.$$

Lastly, observe

$$-\frac{1}{2}\nabla_i(i_{\nabla f}H)_{ij} = -\frac{1}{2}\nabla_i\left(\nabla_k f H_{kij}\right) = -\frac{1}{2}\nabla_k f \nabla_i H_{kij} = -\frac{1}{2}\nabla_k f(d^*H)_{kj}.$$

Combining these, using  $d^*d^*H = 0$  and observing a further elementary cancellation we conclude

$$\begin{split} \nabla_i^{H,f} \operatorname{Rc}_{ij}^{H,f} &= \nabla_i^H \operatorname{Rc}_{ij}^{H,f} - \operatorname{Rc}_{ij}^{H,f} \nabla_i f \\ &= \nabla_i \operatorname{Rc}_{ij}^{H,f} + \frac{1}{2} H_{ipj} \operatorname{Rc}_{ip}^{H,f} - \operatorname{Rc}_{ij}^{H,f} \nabla_i f \\ &= \nabla_i \left( \operatorname{Rc} - \frac{1}{4} H^2 + \nabla^2 f - \frac{1}{2} \left( d_g^* H + i_{\nabla f} H \right) \right)_{ij} + \frac{1}{2} H_{ipj} \left( -\frac{1}{2} \left( d^* H + i_{\nabla f} H \right) \right)_{ip} \\ &- \left( \operatorname{Rc} - \frac{1}{4} H^2 + \nabla^2 f - \frac{1}{2} \left( d_g^* H + i_{\nabla f} H \right) \right)_{ij} \nabla_i f \\ &= \frac{1}{2} \nabla_j R^{H,f}. \end{split}$$

Proposition 4.4 has the immediate consequence that generalized Ricci solitons have constant twisted scalar curvature  $R^{H,f}$ . We note that this result is also implicit by the scalar curvature monotonicity result for generalized Ricci flow [34], and also follows from ([15] Proposition 4.33).

**Corollary 4.5.** Given (g, H, f) a generalized Ricci soliton, then

$$R^{H,f} \equiv \lambda,$$
$$\frac{1}{6} |H|^2 + \Delta f - |\nabla f|^2 \equiv \lambda.$$

Furthermore, if M is compact, then  $\lambda \ge 0$  with equality if and only if  $H \equiv 0, \nabla f \equiv 0$ .

*Proof.* The claim that  $R^{H,f}$  is constant is immediate from Proposition 4.4. Calling this constant  $\lambda$ , we then obtain

$$\lambda = R^{H,f} - \operatorname{tr}_{g} \operatorname{Rc}^{H,f} = \frac{1}{6} |H|^{2} + \Delta f - |\nabla f|^{2}.$$

If M is compact, we integrate this final equation against  $e^{-f}dV_q$  to obtain

$$\lambda \int_M e^{-f} dV_g = \frac{1}{6} \int_M |H|^2 e^{-f} dV_g$$

It follows that  $\lambda \ge 0$  with equality if and only if  $H \equiv 0$ . In this case (g, f) is a compact steady soliton, and then it is known that also  $\nabla f \equiv 0$ .

### 4.3. Generalized Kähler-Ricci solitons.

**Definition 4.6** (Generalized Kähler-Ricci solitons). A generalized Kähler structure (g, I, J) is called a *generalized Kähler-Ricci soliton* if there exists a smooth function f such that the data (g, H, f) defines a generalized Ricci soliton.

Note that Corollary 4.5 and Theorem 4.3 yield that any generalized Kähler-Ricci soliton has constant Goto scalar curvature  $\text{Gscal}(\mathbb{I}, \mathbb{J}, \mu_f)$ . We are next show that the volume form  $\text{vol} = \mu_f$  is adapted, i.e.  $(g, I, J, e^{-f} dV_g)$  is a cscGK structure in the sense of Definition 3.18. It is shown in ([39] Prop 4.1) that for any generalized Kähler-Ricci soliton, the vector fields

$$X_I \coloneqq \frac{1}{2}I\left(\theta_I^{\sharp} - \nabla f\right), \quad X_J \coloneqq \frac{1}{2}J\left(\theta_J^{\sharp} - \nabla f\right)$$

satisfy

(4.3) 
$$L_{X_I}g = L_{X_I}g = 0, \qquad L_{X_I}I = L_{X_I}J = 0.$$

We upgrade this to

**Lemma 4.7.** Let  $(M^{2n}, g, I, J, f)$  be a generalized Kähler-Ricci soliton and let  $X = X_I + X_J$ . Then

$$L_X I = L_X J = 0, \ L_X g = 0, \qquad [X_I, X_J] = 0$$

*Proof.* It is shown in ([5], Proposition 4.6) that one has the identities (recall  $\pi$  here is given by 1.1)

$$L_{IX_I}\pi = L_{JX_J}\pi = L_{X_I}\pi = L_{X_J}\pi = 0.$$

As  $X = \frac{1}{2}(I\theta_I^{\sharp} + J\theta_J^{\sharp}) - \pi_{\mathbb{J}}(df) = \operatorname{div}_{e^{-f}dV_g}\pi_{\mathbb{J}}$  (see Lemma 3.6), we have  $L_X\pi_{\mathbb{J}} = 0$  (see (2.7)). Using this and (4.3), we obtain

$$L_{X_I}J + L_{X_J}I = 0$$

It then follows that

$$0 = L_{X_I}(2\pi g) = [L_{X_J}I, J] = [J, L_{X_I}J] = 2JL_{X_I}J$$

Thus  $L_{X_I}J \equiv 0$  and similarly  $L_{X_J}I \equiv 0$ . Note it follows then immediately that  $L_{X_I}\theta_I = L_{X_I}\theta_J = L_{X_J}\theta_I = L_{X_J}\theta_J = 0$ , and also  $L_{X_I}H = L_{X_J}H = 0$ . Then we can compute

$$L_{X_I}(-JX_J) = \frac{1}{2} \left[ \theta_J^{\sharp} - \nabla f, X_I \right] = \left[ X_I, IX_I \right] + \frac{1}{2} \left[ \theta_j^{\sharp} - \theta_I^{\sharp}, X_I \right] = 0,$$

hence  $0 = L_{X_I}(JX_J) = J[X_I, X_J]$ , finishing the proof.

**Corollary 4.8.** Let  $(M^{2n}, g, I, J, f)$  be a generalized Kähler-Ricci soliton. Then the volume form vol =  $\mu_f$  is (g, I, J)-adapted and  $(g, I, J, \mu_f)$  is a cscGK structure.

*Proof.* This is an immediate corollary of Corollary 4.5 and Lemmas 3.6 and 4.7.  $\Box$ 

**Corollary 4.9.** Let  $(M^{2n}, g, I, J, f)$  be a generalized Kähler-Ricci soliton of generically symplectic type. Denote by  $\mathbb{T}$  the torus generated by the adapted volume form vol =  $\mu_f$  and let b be any  $\mathbb{T}$ -invariant 2-form. Then the generalized Kähler structure  $(\mathbb{I}, \mathbb{J})$  on  $(M, H_0 = -d_I^c \omega_I - db)$  corresponding to (g, I, J, b) is cscGK in  $\mathcal{AGK}(\mathbb{J}, \text{vol}) = \mathcal{AGK}^{\mathbb{T}}(\mathbb{J})$ .

*Proof.* The hypothesis that the structure is generically symplectic implies, by Lemma 2.15, that the triple  $(\mathbb{I}, \mathbb{J}, \text{vol})$  is adapted.

**Example 4.10.** As an immediate consequence of Theorem 4.3, we recover the result of Goto [19] that the canonical generalized Kähler structures on semisimple Lie groups have constant scalar curvature. In particular, as described in [22], given a compact semisimple Lie group K with biinvariant metric g, H the Cartan three-form and  $J_L$  and  $J_R$  left- and right-invariant complex structures compatible with g, then  $(g, H, J_L, J_R)$  is generalized Kähler. By the invariance it follows easily that  $\operatorname{Gscal}(\mathbb{I}, \mathbb{J}, dV_g) = R - \frac{1}{12}|H|^2 = \frac{1}{6}|H|^2$  is a positive constant. Furthermore, in case K has no abelian factors, the generalized Kähler structure is generically symplectic type. In this case  $dV_g$  is adapted to  $(\mathbb{I}, \mathbb{J})$  by Corollary 4.9, and thus the data is cscGK in  $\mathcal{AGK}(\mathbb{J}, dV_g)$ .

**Example 4.11.** In a series of works [35, 38, 5] the authors constructed and classified all generalized Kähler-Ricci solitons on compact complex surfaces, with the non-Kähler examples occurring on Hopf surfaces. Furthermore, in [39] the authors gave an exhaustive construction complete generalized Kähler-Ricci solitons on surfaces with minimal symmetry group via an extension of the Gibbons-Hawking ansatz. These metrics are thus all cscGK, while none of these examples are symplectic type (the case covered by our earlier work [3]), they are all generically symplectic type. Thus by Corollary 4.9 they admit adapted volume forms vol =  $\mu_f$  and are cscGK in  $\mathcal{AGK}(\mathbb{J}, vol)$ .

# 5. Generalized Kähler class as complexified orbit in the generically symplectic case

5.1. Generalized Kähler class. Let  $(\mathbb{I},\mathbb{J})$  be a GK structure corresponding to the bihermitian data (g, I, J, b). We are going to introduce a notion of a generalized Kähler class  $\mathcal{GK}_{\pi,J}$  fixing J and  $\pi = \frac{1}{2}g^{-1}[I, J]$  and varying I, g and b. Our discussion builds on the fundamental works [6, 23].

**Definition 5.1.** [Generalized Kähler class] Consider a GK structure  $m_0 = (g_0, I_0, J, b_0)$ . Define the generalized Kähler class based at  $m_0$  as

(5.1) 
$$\mathcal{GK}_{m_0}(\pi, J) = \{ \text{exact } A \in \wedge^2(M) \mid AI_0 + I_0^*A - A\pi A = 0 \}.$$

As was observed by Gualtieri [23] any such A gives rise to a GK structure  $(g_1, I_1, J, b_1)$  with

 $I_1 = I_0 - \pi A,$   $(g_1 - b_1) = (g_0 - b_0) - AJ$ 

When there is no confusion, we will suppress the basepoint  $m_0$  and identify the point  $A \in \mathcal{GK}(\pi, J)$  with the underlying GK structures (g, I, J, b).

**Remark 5.2.** Following [23], one way to construct a 2-form A solving (5.1) is to fix a 1-parameter family of functions  $u_t$ , generate a flow of  $\pi$ -Hamiltonian diffeomorphisms  $\Phi_s$  by  $X_{u_t} := -\pi(du_t)$ . Then setting

$$I_t = \Phi_t \cdot I_0, \quad A_t = \int_0^t dd_{I_s}^c u_s ds$$

we obtain a one-parameter family of exact forms  $A_t$  which solve (5.1).

**Lemma 5.3.** The tangent space space to  $\mathcal{GK}(\pi, J)$  at a point corresponding to a GK structure m = (g, I, J, b) is

$$T_m \mathcal{GK}(\pi, J) \simeq \{ \text{exact } A \in \wedge^2(M) \text{ of } I \text{-type } (1,1) \}.$$

In particular there is a natural distribution  $\mathcal{D} \subset T_m \mathcal{GK}(\pi, J)$  given by  $dd_I^c$ -exact 2-forms

$$\mathcal{D} = \{ dd_I^c u \mid u \in C^\infty(M, \mathbb{R}) \}$$

This distribution is integrable with

$$[\mathbf{X}_u, \mathbf{X}_v] = -\mathbf{X}_{\pi(du, dv)},$$

where  $\mathbf{X}_u$  is a vector field  $dd_I^c u$  on  $\mathcal{GK}(\pi, J)$  defined by  $u \in C^{\infty}(M, \mathbb{R})$ .

Proof. The proof is similar to the one of [4], Lemma 2.15, by working with  $A_t$  instead of  $F_t$ . **Lemma 5.4.** Under the variation of (g, I, J, b) induced by  $dd_I^c u \in \mathcal{D} \subset T_m \mathcal{GK}(\pi, J)$  we have

$$\begin{split} \frac{\partial}{\partial t}g &= -(dIdu)_J^{(1,1)}J, \qquad \frac{\partial}{\partial t}I = -\pi(dIdu), \qquad \frac{\partial}{\partial t}b = (dIdu)_J^{(2,0)+(0,2)}J, \\ &\qquad \frac{\partial}{\partial t}\mathbb{I} = L_{\mathbb{I}Idu}^{H_0}\mathbb{I}, \qquad \frac{\partial}{\partial t}\mathbb{J} = -L_{\mathbb{J}Idu}^{H_0}\mathbb{J}. \end{split}$$

*Proof.* This computation of the variation of  $(g_t, I_t, b_t)$  follows from Definition 5.1. From the variational formulae for (g, I, b) we get

$$\frac{d}{dt}\omega_J = (dIdu)_J^{(1,1)}, \qquad \frac{d}{dt}(bJ) = -(dIdu)_J^{(2,0)+(0,2)},$$

which yields

$$\frac{d}{dt}\left(d_{J}^{c}\omega_{J}-db\right)=-Jd(dIdu)=0,$$

showing that  $H_0 := d_J^c \omega_J - db$  is constant. The variation of the GK data  $(\mathbb{I}_t, \mathbb{J}_t)$  is analogous to the work of [18], up to the interchanging the roles of I and J.

**Remark 5.5.** All of the above can be repeated verbatim whenever there is a compact Lie group  $G \subset \text{Diff}(M)$  and we are only considering *G*-invariant GK structures (g, I, J, b) on  $(M, H_0)$ . Notice that by (2.9),  $H_0$  is then also *G*-invariant. In this case, we get a notion of *G*-invariant generalized Kähler class which we will denote  $\mathcal{GK}^G(\pi, J)$ . The corresponding distribution is  $\mathcal{D}^G = \{ dd_I^c u \mid u \in C^{\infty}(M, \mathbb{R})^G \}.$ 

5.2. Complexified orbits. We now consider an adapted GK structure  $(\mathbb{I}_0, \mathbb{J}_0) \in \mathcal{AGK}(\mathbb{J}_0, \mathrm{vol}_0)$ . Let  $\mathbb{T} \subset \mathrm{Diff}(M)$  be the torus generated by  $X_0 = \mathrm{div}_{\mathrm{vol}_0} \pi_{\mathbb{J}_0}$ . As in Remark 3.21, we also assume that the corresponding bihermitian structure  $m_0 = (g_0, I_0, J, b_0)$  is  $\mathbb{T}$ -invariant. We denote by  $\mathcal{F}^{\mathbb{T}} \subset \mathcal{GK}_{m_0}^{\mathbb{T}}(\pi, J)$  a leaf of the  $\mathbb{T}$ -invariant distribution  $\mathcal{D}^{\mathbb{T}}$ .

We first establish the relation between  $\mathcal{F}^{\mathbb{T}}$  and the moment map picture on  $\mathcal{AGK}(\mathbb{J}, \text{vol})$  above. We use that the formal complex structure **J** on  $\mathcal{AGK}(\mathbb{J}, \text{vol})$  (see (3.3)) is integrable and  $\mathfrak{ham}(\mathbb{J})$  preserves **J** in order to "complexify" the infinitesimal action of  $\mathfrak{ham}(\mathbb{J})$  as follows:

(5.2) 
$$\mathfrak{ham}^{\mathbb{T}}(\mathbb{J}) \otimes \mathbb{C} \ni \Psi(\mathbb{J}(du)) + \sqrt{-1}\Psi(\mathbb{J}(dv)) \to L_{\Psi}(\mathbb{J}du)\mathbb{I} + \mathbb{I}L_{\Psi}(\mathbb{J}dv)\mathbb{I},$$

where the RHS is viewed as a vector field on  $\mathcal{AGK}(\mathbb{J}, \mathrm{vol})$ . Of course, it is not clear in the formal infinite dimensional setting that such a vector field admits a flow.

Definition 5.6 (Complexified orbit). The vector fields on  $\mathcal{AGK}(\mathbb{J}, \mathrm{vol})$  of the form

$$\left\{L_{\mathbb{J}du}^{H_0}\mathbb{I} + \mathbb{I}L_{\mathbb{J}dv}^{H_0}\mathbb{I}, \ u, v \in C_0^{\infty}(M, \mathbb{R})^{\mathbb{T}}\right\}$$

define a foliation on  $\mathcal{AGK}(\mathbb{J}, \mathrm{vol})$ . A (formal) leaf of this foliation will be referred to as a complexified orbit of  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$ . Thus, we say that a smooth path  $\mathbb{I}_t \in \mathcal{AGK}(\mathbb{J}, \mathrm{vol})$  belongs to the complexified orbit of  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$  if  $\frac{\partial}{\partial t}\mathbb{I}_t = L_{\mathbb{J}du_t}^{H_0}\mathbb{I}_t + \mathbb{I}_t L_{\mathbb{J}dv_t}^{H_0}\mathbb{I}_t$  for some  $\mathbb{T}$ -invariant smooth functions  $u_t, v_t$ .

We now show that a variation within the leaf  $\mathcal{F}^{\mathbb{T}}$  corresponds naturally to a path in the complexified orbit of the infinitesimal action of  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J}_0)$  on  $\mathcal{AGK}(\mathbb{J}_0, \mathrm{vol}_0)$ . In the Kähler setting, this is achieved by fixing the Kähler form via Moser's Lemma, whereas here we use a one-parameter family of Courant automorphisms which fixes both  $\mathbb{J}$  and vol.

**Lemma 5.7.** Let  $m_0 = (g_0, I_0, J, b_0)$  be a bihermitan structure on M corresponding to a GK structure  $(\mathbb{I}_0, \mathbb{J}_0)$ . Suppose that vol is adapted to  $(g_0, I_0, J)$ , generating a torus  $\mathbb{T}$ . Let  $m_t = (g_t, I_t, J, b_t)$  be a path in  $\mathcal{F}^{\mathbb{T}}$  starting at  $m_0$ , corresponding to a family of functions  $u_t \in C_0^{\infty}(M, \mathbb{R})^{\mathbb{T}}$ . Denote by  $(\mathbb{I}_t, \mathbb{J}_t)$  the corresponding generalized complex structures and by vol<sub>t</sub> the volume forms obtained as solution to

$$\frac{\partial}{\partial t} \operatorname{vol}_t = -L_{\pi_{\mathbb{J}_t}(I_t du_t)} \operatorname{vol}_t, \qquad (\operatorname{vol}_t)_{|_{t=0}} = \operatorname{vol}_0.$$

along  $m_t$ . Let  $\Phi_t \in \operatorname{Aut}(M, H_0)$ ,  $\Phi_0 = \operatorname{Id}$  be the isotopy corresponding to the time-dependent infinitesimal generator  $-\mathbb{J}_t(I_t du_t)$ , and by  $\phi_t \in \operatorname{Diff}(M)$  the induced isotopy of diffeomorphisms, corresponding to the vector field  $\pi_T(-\mathbb{J}_t(I_t du_t)) = -\pi_{\mathbb{J}_t}(I_t du_t)$ . Then

$$\Phi_t(\mathbb{J}_t) = \mathbb{J}_0, \quad (\phi_t^{-1})^*(\operatorname{vol}_t) = \operatorname{vol}_0.$$

In particular, vol<sub>t</sub> is  $(g_t, I_t, J)$ -adapted. Furthermore, the pullback data  $\widetilde{u}_t = (\phi_t^{-1})^* u_t$ ,  $\widetilde{\mathbb{I}}_t = \Phi_t(\mathbb{I}_t)$ and  $\widetilde{J}_t := \phi_t \cdot J$  satisfy

$$\frac{\partial}{\partial t}\widetilde{\mathbb{I}}_t = \widetilde{\mathbb{I}}_t L_{\mathbb{J}_0 d\widetilde{u}_t}^{H_0} \widetilde{\mathbb{I}}_t, \qquad \frac{\partial}{\partial t} \widetilde{J}_t = \widetilde{J}_t L_{\pi_{\mathbb{J}_0} d\widetilde{u}_t} \widetilde{J}_t.$$

Furthermore, if  $(\mathbb{I}_0, \mathbb{J}_0)$  is generically symplectic type, so is  $(\mathbb{I}_t, \mathbb{J}_t)$  and  $\tilde{\mathbb{I}}_t \in \mathcal{AGK}(\mathbb{J}_0, \mathrm{vol}_0)$  belongs to the complexified orbit of  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J}_0)$ .

*Proof.* First note that the existence of  $\Phi_t$  and  $\phi_t$  follow from standard ODE methods. In particular, the existence of  $\phi_t$  is standard, and given this the putative  $\Phi_t$  will satisfy

$$\frac{\partial}{\partial t}(\phi_t^{-1} \circ \Phi_t) = (\mathrm{Id} - \pi_T) \left( \Psi(-\mathbb{J}_t I_t du_t) \right),$$

where  $\phi_t^{-1}$  acts on  $T \oplus T^*$  as usual. In other words, after pulling back by  $\phi_t^{-1}$  we now solve for a one-parameter family of Courant automorphisms covering the identity automorphism, in particular the family driven by the two-form component of  $\Psi(-\mathbb{J}_t I_t du_t)$ . Alternatively one can construct  $\Phi_t$  directly using the interpretation of infinitesimal automorphisms as vector fields on E (cf. [36] Proposition 2.7).

The claims  $\Phi_t(\mathbb{J}_t) = \mathbb{J}_0$  and  $(\phi_t^{-1})^*(\operatorname{vol}_t) = \operatorname{vol}_0$  are immediate from the construction. We also notice that  $\Phi_t$  and  $\phi_t$  are  $\mathbb{T}$ -equivariant. To obtain the evolution equation for  $\widetilde{\mathbb{I}}$ , it suffices to compute its derivative at t = 0. Note that using the Gualtieri map (2.8), it follows that

$$(5.3) (I + J)Idu = IJdu - du.$$

Using the above relation, the integrability of  $\tilde{\mathbb{I}}$ , and the fact that the Lie derivative by an exact 1-form vanishes, we obtain

$$\frac{\partial}{\partial t}\widetilde{\mathbb{I}}_t\Big|_{t=0} = L_{\mathbb{I}_0 I_0 du}^{H_0} \mathbb{I}_0 + L_{\mathbb{J}_0 I_0 du}^{H_0} \mathbb{I}_0 = L_{\mathbb{I}_0 \mathbb{J}_0 du - du}^{H_0} \mathbb{I}_0 = \mathbb{I}_0 L_{\mathbb{J}_0 du}^{H_0} \mathbb{I}_0,$$

as claimed. To obtain the evolution equation for J we first note as an elementary consequence of (2.8) we have  $\pi_{\mathbb{J}}I = J\pi_{\mathbb{J}}$  (cf. Lemma 5.12 below). Using this we have

$$\frac{\partial}{\partial t} \left. \widetilde{J}_t \right|_{t=0} = L_{\pi_{\mathbb{J}} I du} J = L_{J \pi_{\mathbb{J}} du} J = J L_{\pi_{\mathbb{J}} du} J$$

Finally, in the case  $(\mathbb{I}_0, \mathbb{J}_0)$  is generically symplectic type,  $\tilde{\mathbb{I}}_t \in \mathcal{AGK}(\mathbb{J}_0, \operatorname{vol}_0) = \mathcal{AGK}^{\mathbb{T}}(\mathbb{J})$  as  $(\tilde{\mathbb{I}}_t, \mathbb{J}_0)$  is  $\mathbb{T}$ -invariant, see Remark 3.21.

**Lemma 5.8.** Suppose  $m_0 = (g_0, I_0, J, b_0)$ , vol<sub>0</sub> and  $\mathbb{T} \subset \text{Diff}(M)$  are as in Lemma 5.7. Suppose that  $m_0$  is generically symplectic type. Let  $m_t = (g_t, I_t, J, b_t)$  be a path in  $\mathcal{F}^{\mathbb{T}}$  generated by a family of functions  $u_t \in C_0^{\infty}(M, \mathbb{R})^{\mathbb{T}}$ . Let vol<sub>t</sub> be the family of volume forms along  $m_t$  introduced in Lemma 5.7. Then vol<sub>t</sub> depends only on the endpoint  $m_t$ , and does not depend on the specific path between  $m_0$  and  $m_t$ .

*Proof.* Let  $m_t, t \in [0,1]$  be a closed loop in  $\mathcal{F}^{\mathbb{T}}$ . We need to prove that  $\text{vol}_0 = \text{vol}_1$ . By Lemmas 5.7 and 2.15, we know that along the path  $m_t$ ,

$$X_t = \operatorname{div}_{\operatorname{vol}_t} \mathbb{J}_t = \phi_t^{-1} \cdot X_0 = X_0,$$

(as  $\phi_t$  preserves  $\mathbb{T}$ ). Thus,

$$\frac{\partial}{\partial t} \operatorname{div}_{\operatorname{vol}}(\mathbb{J}) = 0.$$

If  $f = \log \frac{\text{vol}_1}{\text{vol}_0}$ , we use the definition of divergence and the fact that  $df - \sqrt{-1} \mathbb{J}_0 df \in \text{Ker}(\psi)$ , where  $\psi$  is a defining spinor for  $\mathbb{J}_0$ , to obtain

$$0 = (\operatorname{div}_{\operatorname{vol}_1}(\mathbb{J}_0) - \operatorname{div}_{\operatorname{vol}_0}(\mathbb{J}_0)) = -\frac{1}{2}\mathbb{J}_0(df),$$

which implies that f is constant. On the other hand the total volume  $\int_M \text{vol}_t$  is fixed along  $m_t$ , proving that f = 1 and  $\text{vol}_0 = \text{vol}_1$ .

**Remark 5.9.** The above lemma proves that we can endow every point  $m \in \mathcal{F}^{\mathbb{T}}$  with a volume form  $vol_m$ . When there is no confusion, we will suppress the subscript m and simply denote this volume form by vol keeping in mind that it depends on a point in  $\mathcal{F}^{\mathbb{T}}$ .

5.3. The Mabuchi metric. Mabuchi [31] (cf. [33, 11]) introduced a formal Riemannian structure on Kähler classes whose geometry captures fundamental features of the existence and uniqueness of cscK metrics. In [3] we extended this construction to generalized Kähler classes for structures of symplectic type. Here we extend this to generalized Kähler structures which are generically symplectic type, using the framework above. Throughout the reminder of this section, we make the following

Assumption 5.10.  $m_0 = (g_0, I_0, J, b_0)$  is a generically symplectic type bihermitian structure on M which admits an adapted volume form  $\operatorname{vol}_0$  generating a torus  $\mathbb{T}$  of symmetries of  $m_0$ . We denote by  $\mathcal{F}^{\mathbb{T}} = \mathcal{F}_{m_0}^{\mathbb{T}}$  the corresponding generalized Kähler class of  $\mathbb{T}$ -invariant bihermitian structures. By Lemma 5.7, any  $m \in \mathcal{F}_{m_0}^{\mathbb{T}}$  is generically symplectic type and, by Lemma 5.8, there is a well defined adapted volume form  $\operatorname{vol}_m$  associated to m. We shall identify the tangent space at  $m \in \mathcal{F}^{\mathbb{T}}$  (which is  $C^{\infty}(M, \mathbb{R})^{\mathbb{T}}/\mathbb{R}$ ) with the space of  $\operatorname{vol}_m$ -normalized  $\mathbb{T}$ -invariant smooth functions

$$T_m \mathcal{F}^{\mathbb{T}} = C_0^{\infty}(M, \operatorname{vol}_m) = \left\{ u \in C^{\infty}(M, \mathbb{R})^{\mathbb{T}} \mid \int_M u \operatorname{vol}_m = 0 \right\}.$$

**Definition 5.11.** The Mabuchi Riemannian metric is defined for  $m \in \mathcal{F}^{\mathbb{T}}$  and  $u, v \in T_m \mathcal{F}^{\mathbb{T}}$  via

$$\langle\!\langle u, v \rangle\!\rangle_m = \int_M u v \mathrm{vol}_m,$$

where  $vol_m$  is the volume form guaranteed by Lemma 5.8.

The computations to follow on the geometry of this metric exploit a number of delicate identities for generalized Kähler structures, which we collect here: Lemma 5.12. The following identities hold:

$$\pi_{\mathbb{J}}(\alpha \wedge J\beta) = -\pi_{\mathbb{J}}(I\alpha \wedge \beta)$$
$$\langle \pi, \alpha \wedge \beta \rangle = \pi_{\mathbb{J}}((J-I)\alpha \wedge \beta)$$
$$\operatorname{tr}(\pi_{\mathbb{J}}(\beta \wedge I\beta) \circ \pi_{\mathbb{J}}(\alpha \wedge J\alpha)) = \frac{1}{2}(\langle (I+J)\alpha, \beta \rangle_{g}^{2} + \langle (I+J)\alpha, I\beta \rangle_{g}^{2})$$
$$\int_{M} ud(Idv \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol}) = \int_{M} vd(Jdu \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol}).$$

*Proof.* The first is an easy consequence of the identity I(I + J) = (I + J)J. The second follows directly from the definitions. The third is a lengthty computation identical to [3, (2.11)]. For the third we integrate by parts and apply the first identity to yield

$$\int_{M} ud(Idv \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol}) = -\int_{M} du \wedge Idv \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol}$$
$$= \int_{M} Jdu \wedge dv \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol}$$
$$= \int_{M} vd(Jdu \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol}),$$

as claimed.

5.4. The Levi-Civita connection.

**Lemma 5.13.** The Riemannian structure  $\langle\!\langle \cdot, \cdot \rangle\!\rangle$  admits a unique Levi-Civita connection  $\mathcal{D}$ , defined by

$$(\mathcal{D}_u\boldsymbol{\xi})_m = \dot{\boldsymbol{\xi}}_m(u) - \pi_{\mathbb{J}}(du \wedge Jd\boldsymbol{\xi}_m),$$

where  $\dot{\boldsymbol{\xi}}_m(u) \coloneqq \frac{\partial}{\partial t}\Big|_{t=0} \boldsymbol{\xi}_{m_t}$ , where  $m_t$  is the canonical deformation of m defined by u.

*Proof.* We first compute the Levi-Civita connection for canonical vector fields. In our formal setting, the Levi-Civita connection is still determined by the Koszul formula:

$$2\langle\!\langle \mathcal{D}_{\mathbf{X}_{u_1}}\mathbf{X}_{u_2}, \mathbf{X}_{u_3}\rangle\!\rangle = \mathbf{X}_{u_1}\langle\!\langle \mathbf{X}_{u_2}, \mathbf{X}_{u_3}\rangle\!\rangle + \mathbf{X}_{u_2}\langle\!\langle \mathbf{X}_{u_1}, \mathbf{X}_{u_3}\rangle\!\rangle - \mathbf{X}_{u_3}\langle\!\langle \mathbf{X}_{u_1}, \mathbf{X}_{u_2}\rangle\!\rangle - \langle\!\langle \mathbf{X}_{\{u_1, u_2\}_{\pi}}, \mathbf{X}_{u_3}\rangle\!\rangle + \langle\!\langle \mathbf{X}_{\{u_2, u_3\}_{\pi}}, \mathbf{X}_{u_1}\rangle\!\rangle + \langle\!\langle \mathbf{X}_{\{u_1, u_3\}_{\pi}}, \mathbf{X}_{u_2}\rangle\!\rangle.$$

Next we observe using Lemma 5.12:

$$\begin{aligned} \mathbf{X}_{u_1} \langle\!\langle \mathbf{X}_{u_2}, \mathbf{X}_{u_3} \rangle\!\rangle &= \int_M u_2 u_3 (-L_{\mathbb{J}Idu_1}^{H_0} \operatorname{vol}) = \int_M u_2 u_3 (-L_{\pi_{\mathbb{J}}Idu_1} \operatorname{vol}) = \int_M u_2 u_3 d \left( Idu_1 \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol} \right) \\ \mathbf{X}_{u_2} \langle\!\langle \mathbf{X}_{u_1}, \mathbf{X}_{u_3} \rangle\!\rangle &= \int_M u_1 u_3 d \left( Idu_2 \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol} \right) \\ \mathbf{X}_{u_3} \langle\!\langle \mathbf{X}_{u_1}, \mathbf{X}_{u_2} \rangle\!\rangle &= \int_M u_1 u_2 d \left( Idu_3 \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol} \right) = \int_M u_3 d (Jd(u_1 u_2) i_{\pi_{\mathbb{J}}} \operatorname{vol}) \\ &= \int_M u_3 u_1 d (Jdu_2 \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol}) + u_3 u_2 d (Jdu_1 \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol}) \\ &+ u_3 \left( du_1 \wedge Jdu_2 + du_2 \wedge Jdu_1 \right) \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol}. \end{aligned}$$

Next we observe

$$i_{\pi\alpha}$$
vol =  $i_{\pi_{\mathbb{J}}(J-I)\alpha}$ vol =  $(J-I)\alpha \wedge i_{\pi_{\mathbb{J}}}$ vol.

Using this we compute

$$\begin{split} \langle \langle \mathbf{X}_{\{u_1,u_2\}_{\pi}}, \mathbf{X}_{u_3} \rangle &= \int_M u_3 \left( (J-I) du_1 \wedge du_2 \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol} \right) \\ \langle \langle \mathbf{X}_{\{u_2,u_3\}_{\pi}}, \mathbf{X}_{u_1} \rangle \rangle &= \int_M u_1 \left( (J-I) du_2 \wedge du_3 \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol} \right) \\ &= \int_M u_3 \left( du_1 \wedge (J-I) du_2 \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol} \right) + u_1 u_3 d \left( (J-I) du_2 \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol} \right) \\ \langle \langle \mathbf{X}_{\{u_1,u_3\}_{\pi}}, \mathbf{X}_{u_2} \rangle \rangle &= \int_M u_3 \left( du_2 \wedge (J-I) du_1 \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol} \right) + u_2 u_3 d \left( (J-I) du_1 \right) \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol} \right). \end{split}$$

Using these computations and Lemma 5.12 gives

$$\left(\mathcal{D}_{\mathbf{X}_{u_1}}\mathbf{X}_{u_2}\right)_m = -\pi_{\mathbb{J}}(du_1 \wedge J du_2) - \int_M u_2 d(I du_1 \wedge i_{\pi_{\mathbb{J}}} \mathrm{vol}).$$

Now for a general vector field  $m \to \xi_m$  we compute

$$\begin{aligned} \langle\!\langle \mathcal{D}_{u}\xi, \mathbf{X}_{v}\rangle\!\rangle &= \mathbf{X}_{u}\langle\!\langle \xi, \mathbf{X}_{v}\rangle\!\rangle - \langle\!\langle \xi, \mathcal{D}_{u}\mathbf{X}_{v}\rangle\!\rangle \\ &= \frac{\partial}{\partial t}\Big|_{t=0} \int_{M} \xi v \operatorname{vol} + \int_{M} \xi (du \wedge J dv \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol}) \\ &= \int_{M} \dot{\xi}(u) v \operatorname{vol} + \int_{M} \xi v d(I du \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol}) + \int_{M} \xi (du \wedge J dv \wedge i_{\pi_{\mathbb{J}}} \operatorname{vol}) \\ &= \int_{M} \left(\dot{\xi}(u) - \pi_{\mathbb{J}}(du \wedge J d\xi)\right) v \operatorname{vol}, \end{aligned}$$

as claimed.

**Definition 5.14.** Let  $m_t$  be a smooth path in  $\mathcal{F}^{\mathbb{T}}$  corresponding to a Hamiltonian deformation with respect to a smooth path of functions  $u_t \in C_0^{\infty}(M, \operatorname{vol}_t)$ . We say that  $m_t$  is a *geodesic* if

$$0 = \mathcal{D}_u u = \dot{u} - \pi_{\mathbb{J}} (du \wedge J du).$$

**Proposition 5.15.** Given the setup above, suppose Y is a Hamiltonian vector field with respect to  $\pi_{\mathbb{J}}$  which preserves J. Then the flow  $\Phi_t = \exp(-JY)$  of -JY defines a geodesic in  $\mathcal{F}^{\mathbb{T}}$ .

*Proof.* By the Hamiltonian assumption, there exists a smooth function  $u_0$  such that

$$Y = -\pi_{\mathbb{J}} du_0, \qquad \int_M u_0 \operatorname{vol} = 0.$$

By Lemma 7.9 below, the flow of Y generates a path  $m_t$  in  $\mathcal{F}^{\mathbb{T}}$ .

We let  $u_t := \Phi_t^*(u_0)$ . Since  $\Phi_t \cdot Y = Y$ , it follows that  $Y = -\pi_{\mathbb{J}_t} du_t$ . Thus we compute

$$\frac{\partial}{\partial t}u_t = -L_{JY}u_t = du_t(-JY) = \pi_{\mathbb{J}}(du_t \wedge Jdu_t),$$

as required.

5.5. Curvature.

**Proposition 5.16.** At any given  $m \in \mathcal{F}^{\mathbb{T}}$ , the curvature tensor of the Mabuchi metric satisfies

$$\left(\mathcal{R}(\mathbf{X}_{u_1},\mathbf{X}_{u_2})\mathbf{X}_{u_3}\right)_m = -\left\{\left\{u_1,u_2\right\}_{\pi_{\mathbb{J}}},u_3\right\}_{\pi_{\mathbb{J}}}$$

In particular

$$\langle\!\langle \mathcal{R}(\mathbf{X}_{u_1}, \mathbf{X}_{u_2}) \mathbf{X}_{u_1}, \mathbf{X}_{u_2} \rangle\!\rangle_m = - \langle\!\langle \{u_1, u_2\}_{\pi_{\mathbb{J}}}, \{u_1, u_2\}_{\pi_{\mathbb{J}}} \rangle\!\rangle,$$

so that the sectional curvature is everywhere nonpositive.

*Proof.* We note that the second formula follows from the first using ad-invariance of the metric (3.2). We will drop the basepoint from the computations to follow, and also ignore the additive normalizing constants of the underlying smooth functions, as these do not affect the answer. Thus in particular we express

$$\mathcal{D}_u \mathbf{X}_v = -\operatorname{tr}_{\pi_{\mathbb{T}}} (du \wedge J dv).$$

Thus we first compute using Lemma 5.13,

(5.4) 
$$\mathcal{D}_{u_1}\left(\mathcal{D}_{u_2}\mathbf{X}_{u_3}\right) = \frac{1}{2}\operatorname{tr}\left(\pi_{\mathbb{J}}dd_I^c u_1\pi_{\mathbb{J}}(du_2 \wedge Jdu_3)\right) + \operatorname{tr}_{\pi_{\mathbb{J}}}(du_1 \wedge Jd\operatorname{tr}_{\pi_{\mathbb{J}}}(du_2 \wedge Jdu_3)) \\ = \frac{1}{2}\operatorname{tr}\left(\pi_{\mathbb{J}}dd_I^c u_1\pi_{\mathbb{J}}(du_2 \wedge Jdu_3)\right) + \operatorname{tr}_{\pi_{\mathbb{J}}}(d\operatorname{tr}_{\pi_{\mathbb{J}}}(du_2 \wedge Jdu_3) \wedge Idu_1).$$

Now we observe using Schur's Lemma that for 2-forms  $\alpha, \beta$  one has

(5.5) 
$$\alpha \wedge \beta \wedge i_{\pi_{\mathbb{J}}} i_{\pi_{\mathbb{J}}} \operatorname{vol} = -\frac{1}{2} \operatorname{tr}(\pi_{\mathbb{J}} \alpha \pi_{\mathbb{J}} \beta) \operatorname{vol} + (\operatorname{tr}_{\pi_{\mathbb{J}}} \alpha) (\operatorname{tr}_{\pi_{\mathbb{J}}} \beta) \operatorname{vol}.$$

Using this we obtain from (5.4) and integration by parts

Also we compute

$$\begin{split} & \langle \mathcal{D}_{\{u_1, u_2\}_{\pi}} \mathbf{X}_{u_1}, \mathbf{X}_{u_2} \rangle = -\int_M u_2 \left( d\{u_1, u_2\}_{\pi} \wedge J du_1 \right) \wedge i_{\pi_{\mathbb{J}}} \mathrm{vol} \\ & = \int_M \{u_1, u_2\}_{\pi} du_2 \wedge J du_1 \wedge i_{\pi_{\mathbb{J}}} \mathrm{vol} + \int_M u_2 \{u_1, u_2\}_{\pi} dd_J^c u_1 \wedge i_{\pi_{\mathbb{J}}} \mathrm{vol} - \int_M u_2 \{u_1, u_2\} J du_1 \wedge di_{\pi_{\mathbb{J}}} \mathrm{vol} \\ & = -\int_M \mathrm{tr}_{\pi_{\mathbb{J}}} (du_1 \wedge (I - J) du_2) \mathrm{tr}_{\pi_{\mathbb{J}}} (du_2 \wedge J du_1) \mathrm{vol} - \int_M u_2 \mathrm{tr}_{\pi_{\mathbb{J}}} (du_1 \wedge (I - J) du_2) \mathrm{tr}_{\pi_{\mathbb{J}}} dd_J^c u_1 \mathrm{vol} \\ & + \int_M u_2 \mathrm{tr}_{\pi_{\mathbb{J}}} (du_1 \wedge (I - J) du_2) J du_1 \wedge di_{\pi_{\mathbb{J}}} \mathrm{vol} \\ & = -\int_M \left( \mathrm{tr}_{\pi_{\mathbb{J}}} (du_2 \wedge J du_1) - \mathrm{tr}_{\pi_{\mathbb{J}}} (du_2 \wedge I du_1) \right) \mathrm{tr}_{\pi_{\mathbb{J}}} (du_2 \wedge J du_1) \mathrm{vol} \\ & - \int_M u_2 \left( \mathrm{tr}_{\pi_{\mathbb{J}}} (du_1 \wedge I du_2) + \mathrm{tr}_{\pi_{\mathbb{J}}} (I du_1 \wedge du_2) \right) \mathrm{tr}_{\pi_{\mathbb{J}}} dd_J^c u_1 \mathrm{vol} \\ & + \int_M u_2 \mathrm{tr}_{\pi_{\mathbb{J}}} (du_1 \wedge (I - J) du_2) J du_1 \wedge di_{\pi_{\mathbb{J}}} \mathrm{vol}. \end{split}$$

We divide the terms in the expression for curvature into those which do not involve a derivative of the volume form  $(T_1)$  and those which do  $(T_2)$ . Using the computations above the former comprise:

$$T_{1} = \int_{M} (\operatorname{tr}_{\pi_{\mathbb{J}}}(du_{2} \wedge Jdu_{1})^{2} \operatorname{vol} + \int_{M} (du_{2} \wedge Idu_{2} \wedge du_{1} \wedge Jdu_{1}) \wedge i_{\pi_{\mathbb{J}}}i_{\pi_{\mathbb{J}}} \operatorname{vol} - \int_{M} (\operatorname{tr}_{\pi_{\mathbb{J}}}(du_{1} \wedge Jdu_{1})(\operatorname{tr}_{\pi_{\mathbb{J}}}(du_{2} \wedge Idu_{2})) \operatorname{vol} - \int_{M} u_{2}(du_{1} \wedge Idu_{2} \wedge dd_{J}^{c}u_{1}) \wedge i_{\pi_{\mathbb{J}}}i_{\pi_{\mathbb{J}}} \operatorname{vol} + \int_{M} u_{2}(\operatorname{tr}_{\pi_{\mathbb{J}}}(du_{1} \wedge Idu_{2}) \operatorname{tr}_{\pi_{\mathbb{J}}}(dd_{J}^{c}u_{1})) \operatorname{vol} - \int_{M} u_{2}(Idu_{1} \wedge du_{2} \wedge dd_{J}^{c}u_{1}) \wedge i_{\pi_{\mathbb{J}}}i_{\pi_{\mathbb{J}}} \operatorname{vol} + \int_{M} u_{2}(\operatorname{tr}_{\pi_{\mathbb{J}}}(Idu_{1} \wedge du_{2}) \operatorname{tr}_{\pi_{\mathbb{J}}}(dd_{J}^{c}u_{1})) \operatorname{vol}$$

Using (5.5) and Lemma 5.12 we simplify the final four terms as:

$$\frac{1}{2} \int_{M} \left[ \operatorname{tr} \left( \pi_{\mathbb{J}} (du_{1} \wedge I du_{2}) \pi_{\mathbb{J}} dd_{J}^{c} u_{1} \right) + \operatorname{tr} \left( \pi_{\mathbb{J}} (I du_{1} \wedge du_{2}) \pi_{\mathbb{J}} dd_{J}^{c} u_{1} \right) \right] \operatorname{vol} \\ = \frac{1}{2} \int_{M} \left[ \operatorname{tr} \left( \pi_{\mathbb{J}} (du_{1} \wedge I du_{2}) \pi_{\mathbb{J}} dd_{J}^{c} u_{1} \right) + \operatorname{tr} \left( \pi_{\mathbb{J}} (I du_{1} \wedge du_{2}) \pi_{\mathbb{J}} J dd_{J}^{c} u_{1} J \right) \right] \operatorname{vol} \\ = \frac{1}{2} \int_{M} \left[ \operatorname{tr} \left( \pi_{\mathbb{J}} (du_{1} \wedge I du_{2}) \pi_{\mathbb{J}} dd_{J}^{c} u_{1} \right) + \operatorname{tr} \left( \pi_{\mathbb{J}} (I I du_{1} \wedge I du_{2}) \pi_{\mathbb{J}} dd_{J}^{c} u_{1} \right) \right] \operatorname{vol} \\ = 0.$$

With similar simplifications we finally yield

$$T_{1} = \int_{M} (\operatorname{tr}_{\pi_{\mathbb{J}}}(du_{2} \wedge Jdu_{1})^{2} \operatorname{vol} + \int_{M} (du_{2} \wedge Idu_{2} \wedge du_{1} \wedge Jdu_{1}) \wedge i_{\pi_{\mathbb{J}}}i_{\pi_{\mathbb{J}}} \operatorname{vol} - \int_{M} (\operatorname{tr}_{\pi_{\mathbb{J}}}(du_{1} \wedge Jdu_{1})(\operatorname{tr}_{\pi_{\mathbb{J}}}(du_{2} \wedge Idu_{2})) \operatorname{vol} = \int_{M} (\operatorname{tr}_{\pi_{\mathbb{J}}}(du_{2} \wedge Jdu_{1})^{2} \operatorname{vol} - \frac{1}{2} \int_{M} \operatorname{tr}(\pi_{\mathbb{J}}(du_{2} \wedge Idu_{2})\pi_{\mathbb{J}}(du_{1} \wedge Jdu_{1})) \operatorname{vol} = \int_{M} (\operatorname{tr}_{\pi_{\mathbb{J}}}(du_{2} \wedge Jdu_{1})^{2} \operatorname{vol} - \int_{M} (\operatorname{tr}_{\pi_{\mathbb{J}}}(du_{1} \wedge du_{2}))^{2} \operatorname{vol} - \int_{M} (\operatorname{tr}_{\pi_{\mathbb{J}}}(du_{1} \wedge Idu_{2}))^{2} \operatorname{vol} = - \int_{M} (\operatorname{tr}_{\pi_{\mathbb{J}}}(du_{1} \wedge du_{2}))^{2} \operatorname{vol}.$$

It remains to simplify the terms involving the exterior derivative of the volume form. To that end we first note that

$$di_{\pi_{\mathbb{J}}}i_{\pi_{\mathbb{J}}}$$
vol =  $i_{\pi_{\mathbb{J}}}i_X$ vol.

Using this we see

$$T_{2} = \int_{M} \left( Idu_{1} \wedge du_{2} \wedge Jdu_{1} - Idu_{2} \wedge du_{1} \wedge Jdu_{1} \right) \wedge (i_{\pi_{\mathbb{J}}}i_{X} \operatorname{vol}) \\ + \left( \operatorname{tr}_{\pi_{\mathbb{J}}}(du_{1} \wedge Jdu_{1})Idu_{2} - \operatorname{tr}_{\pi_{\mathbb{J}}}(du_{2} \wedge Jdu_{1})Idu_{1} - \operatorname{tr}_{\pi_{\mathbb{J}}}(du_{1} \wedge (I - J)du_{2})Jdu_{1} \right) \wedge i_{X} \operatorname{vol}.$$

Next we claim the identity:

$$\alpha_1 \wedge \alpha_2 \wedge \alpha_3 \wedge i_{\pi_{\mathbb{J}}} i_X \operatorname{vol} = \left( \operatorname{tr}_{\pi_{\mathbb{J}}} (\alpha_1 \wedge \alpha_2) \alpha_3 - \operatorname{tr}_{\pi_{\mathbb{J}}} (\alpha_1 \wedge \alpha_3) \alpha_2 + \operatorname{tr}_{\pi_{\mathbb{J}}} (\alpha_2 \wedge \alpha_3) \alpha_1 \right) \wedge i_X \operatorname{vol}.$$

Furthermore we note by the X invariance of  $u_i$  it follows that  $du_i \wedge i_X \text{vol} = Xu_i \text{vol} = 0$ . Using these points we observe

$$T_{2} = \int_{M} \left( (\operatorname{tr}_{\pi_{\mathbb{J}}}(du_{2} \wedge Jdu_{1}) - \operatorname{tr}_{\pi_{\mathbb{J}}}(du_{2} \wedge Jdu_{1}))Idu_{1} + (\operatorname{tr}_{\pi_{\mathbb{J}}}(du_{1} \wedge Jdu_{1}) - \operatorname{tr}_{\pi_{\mathbb{J}}}(du_{1} \wedge Jdu_{1}) - \operatorname{tr}_{\pi_{\mathbb{J}}}(du_{1} \wedge (I - J)du_{2}))Jdu_{1} \right) \wedge i_{X} \operatorname{vol} = 0.$$

## 6. The generalized Kähler Calabi problem.

In this section, we combine the moment map setup with the Mabuchi geometry of  $\mathcal{F}^{\mathbb{T}}$  developed in Section 3 in order to obtain results about the existence of extremal bihermitian structures  $m \in \mathcal{F}^{\mathbb{T}}$ , see Definition 3.18. We still assume throughout this section that Assumption 5.10 holds true.

#### 6.1. Calabi Energy.

**Definition 6.1.** Given a generalized Kähler class  $\mathcal{F}^{\mathbb{T}}$ , we define the *Calabi functional* as

$$\mathbf{Ca}: \mathcal{GK}(\pi, J)^{\mathbb{T}} \to \mathbb{R}$$
$$\mathbf{Ca}(\mathbb{I}, \mathbb{J}, \mathrm{vol}) = \int_{M} \mathrm{Gscal}(\mathbb{I}, \mathbb{J}, \mathrm{vol})^{2} \mathrm{vol}.$$

**Proposition 6.2.**  $(\mathbb{I}, \mathbb{J}, \text{vol}) \in \mathcal{GK}(\pi, J)^{\mathbb{T}}$  is a critical point of **Ca** if and only if  $(\mathbb{I}, \mathbb{J}, \text{vol})$  is extremal.

*Proof.* Using the Moser isotopy  $\Phi_t$  from Lemma 5.7 we can compute for an arbitrary variation in  $\mathcal{F}^{\mathbb{T}}$  as in Corollary 3.16

$$\frac{d}{dt}\Big|_{t=0} \mathbf{Ca}(\mathbb{I}_t, \mathbb{J}_t, \operatorname{vol}_t) = \frac{d}{dt}\Big|_{t=0} \Phi_t^* \mathbf{Ca}(\mathbb{I}_t, \mathbb{J}_t, \operatorname{vol}_t)$$
$$= \frac{d}{dt}\Big|_{t=0} \int_M \operatorname{Gscal}^2(\mathbb{I}_t, \mathbb{J}, \operatorname{vol}) \operatorname{vol}$$
$$= \mathbf{\Omega}\left(L_{\chi}\mathbb{I}, \mathbb{I}L_{\Psi}(\mathbb{J}du_0)\mathbb{I}\right).$$

Specializing to the case  $u_0 = \text{Gscal}(\mathbb{I}, \mathbb{J}, \text{vol})$  it follows that  $|L_{\chi}\mathbb{I}|_{\boldsymbol{g}}^2 = 0$ , giving the claim.

### 6.2. Mabuchi 1-form.

**Definition 6.3.** The Mabuchi 1-form  $\boldsymbol{\tau}$  on  $\mathcal{F}^{\mathbb{T}}$  is defined through its values on the fundamental vector fields  $\mathbf{X}_u, u \in C_0^{\infty}(M, m)^{\mathbb{T}}$ :

$$\tau(\mathbf{X}_u) \coloneqq -\int_M u \operatorname{Gscal}_{\operatorname{vol}}(\mathbb{I}, \mathbb{J}) \operatorname{vol}.$$

**Proposition 6.4.** The Mabuchi 1-form  $\tau$  is closed.

*Proof.* We will verify that

$$\mathbf{X}_{u} \cdot \boldsymbol{\tau}(\mathbf{X}_{v}) - \mathbf{X}_{v} \cdot \boldsymbol{\tau}(\mathbf{X}_{u}) + \boldsymbol{\tau}(\mathbf{X}_{\pi(du,dv)}) = 0,$$

where we used the identity for  $[\mathbf{X}_u, \mathbf{X}_v]$  from Lemma 5.3. Let us start with calculating the first term. We denote by  $\frac{\partial}{\partial t}\Big|_{t=0}$  the infinitesimal action of  $\mathbf{X}_u$ 

(6.1) 
$$\mathbf{X}_{u} \cdot \boldsymbol{\tau}(\mathbf{X}_{v}) = -\frac{d}{dt} \Big|_{t=0} \int_{M} v \operatorname{Gscal}(\mathbb{I}_{t}, \mathbb{J}_{t}, \operatorname{vol}_{t}) \operatorname{vol}_{t}$$

Pulling back by a generalized automorphism generated by  $\mathbb{J}(Idu)$ , and denoting by  $\tilde{\mathbb{I}}_t$  the regauged one-parameter family of generalized complex structures with

$$\frac{\partial}{\partial t}\Big|_{t=0}\widetilde{\mathbb{I}}_t = \mathbb{I}L_{\mathbb{J}du}^{H_0}\mathbb{I},$$

we can rewrite the last expression as

$$\begin{split} \mathbf{X}_{u} \cdot \boldsymbol{\tau}(\mathbf{X}_{v}) &= -\int_{M} v \left. \frac{\partial}{\partial t} \right|_{t=0} \operatorname{Gscal}(\widetilde{\mathbb{I}}_{t}, \mathbb{J}, \operatorname{vol}) \operatorname{vol} - \int_{M} \langle dv, \mathbb{J}Idu \rangle \operatorname{Gscal}(\mathbb{I}, \mathbb{J}, \operatorname{vol}) \operatorname{vol} \\ &= \mathbf{\Omega}(\mathbb{I}L_{\mathbb{J}du}^{H_{0}}\mathbb{I}, L_{\mathbb{J}dv}^{H_{0}}\mathbb{I}) + \frac{1}{2} \int_{M} \langle dv, g^{-1}(I+J)Idu \rangle \operatorname{Gscal}(\mathbb{I}, \mathbb{J}, \operatorname{vol}) \operatorname{vol}. \end{split}$$

The first term of the last expression is symmetric in u and v since  $\Omega$  is an I-invariant 2-form. The anti-symmetrization of the last expression is exactly

$$\int_{M} \pi(du, dv) \operatorname{Gscal}_{\operatorname{vol}}(\mathbb{I}, \mathbb{J}) \operatorname{vol} = -\boldsymbol{\tau}(\mathbf{X}_{\pi(du, dv)}),$$

proving that  $\boldsymbol{\tau}$  is closed.

**Proposition 6.5.** Let  $m_t$  be a smooth geodesic in  $\mathcal{F}^{\mathbb{T}}$ , corresponding to  $u_t$ . Then

$$\frac{d}{dt}\boldsymbol{\tau}(\mathbf{X}_{u_t}) \ge 0,$$

with equality if and only if  $u_t$  is induced by a  $\pi_{\mathbb{J}}$ -Hamiltonian vector field as in Proposition 5.15.

*Proof.* We let  $u_t$  denote a geodesic, and observe that it suffices to compute

$$-\frac{d}{dt}\int_{M}u_{t}\mathrm{Gscal}_{\mathrm{vol}_{t}}(\mathbb{I}_{t},\mathbb{J}_{t})\mathrm{vol}_{t}$$

at t = 0. We construct the Moser isotopy  $\Phi_t$  from Lemma 5.7. We first observe that for a geodesic, the pullback potentials  $\tilde{u}_t = \Phi_t^* u_t$  are constant:

$$\frac{d}{dt}\widetilde{u}_t = \Phi_t^* \left( L_{Z_t} u_t + \dot{u}_t \right)$$
$$= \Phi_t^* \left( \pi_{\mathbb{J}_t} (I_t du_t, du_t) + \dot{u}_t \right)$$
$$= \Phi_t^* \left( -\pi_{\mathbb{J}_t} (du_t, J du_t) + \dot{u}_t \right)$$
$$= 0.$$

Using this, Theorem 3.13 and Lemma 5.7 we have

$$\begin{aligned} -\frac{d}{dt}\Big|_{t=0} \int_{M} u_{t} \operatorname{Gscal}_{\operatorname{vol}_{t}}(\mathbb{I}_{t}, \mathbb{J}_{t}) \operatorname{vol}_{t} &= -\frac{d}{dt}\Big|_{t=0} \int_{M} \Phi_{t}^{*}\left(u_{t} \operatorname{Gscal}_{\operatorname{vol}_{t}}(\mathbb{I}_{t}, \mathbb{J}_{t}) \operatorname{vol}_{t}\right) \\ &= -\frac{d}{dt}\Big|_{t=0} \int_{M} u_{0} \operatorname{Gscal}_{\operatorname{vol}}(\mathbb{I}_{t}, \mathbb{J}) \operatorname{vol} \\ &= -\Omega(L_{\mathbb{J}du_{0}}^{H_{0}} \mathbb{I}, \mathbb{I}) \\ &= \Omega(L_{\mathbb{J}du_{0}}^{H_{0}} \mathbb{I}, \mathbb{I}L_{\mathbb{J}du_{0}}^{H_{0}} \mathbb{I}) \\ &= \Big| \left| L_{\mathbb{J}du_{0}}^{H_{0}} \mathbb{I} \right|_{g}. \end{aligned}$$

This proves the claimed monotonicity. In the case of equality it follows that, along the original geodesic, the section  $e_t := \mathbb{J}_t du_t$  preserves  $\mathbb{I}_t$  for all t. Since it also preserves  $\mathbb{J}_t$  in general, it follows that  $Y_t := \pi_T(e_t) = \pi_{\mathbb{J}_t}(du_t)$  preserves the bihermitian data  $(g_t, I_t, J)$  as well. We finally claim that  $Y_t$  is in fact constant in time. To this end we compute, using the geodesic equation expressed as  $\dot{u} = i_Y I du$ 

$$\frac{\partial}{\partial t}Y_t = \frac{\partial}{\partial t}\pi_{\mathbb{J}_t}du_t = \pi_{\mathbb{J}_t} \left(i_Y dd_I^c u + d\dot{u}\right)$$
$$= \pi_{\mathbb{J}}(i_Y dd_I^c u + di_Y d_I^c u)$$
$$= \pi_{\mathbb{J}}L_Y (Idu)$$
$$= \pi_{\mathbb{J}}IdL_Y u$$
$$= 0.$$

Thus,  $u_t$  is given by Proposition 5.15.

As a consequence of the above proposition we obtain uniqueness of constant scalar curvature GK structures, predicated upon the existence of a smooth geodesic connecting and two cscGK structures.

**Corollary 6.6.** Suppose  $m_0, m_1 \in \mathcal{F}^{\mathbb{T}}$  are cscGK structures which can be joined by a smooth geodesic  $m_t$ . Then  $m_1$  and  $m_2$  are isometric.

#### 7. The Calabi-Licherowicz-Matsushima obstruction and the Futaki invariant

## 7.1. The formal statement.

**Definition 7.1.** We say that an element  $\mathbb{J}du \in \mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$  is a Hamiltonian isometry of a  $(\mathbb{J}, \mathrm{vol})$ adapted generalized Kähler structure  $(\mathbb{I}, \mathbb{J})$  if  $L_{\mathbb{I}du}^{H_0}\mathbb{I} = 0$ . We denote by

$$\mathfrak{g}^{\mathbb{T}}(\mathbb{I},\mathbb{J}) < \mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$$

the sub-algebra of Hamiltonian isometries of  $(\mathbb{I}, \mathbb{J})$ . If m = (g, I, J, b) is the corresponding biHermitian structure, we also consider the Lie algebra of vector fields

$$\mathfrak{g}^{\mathbb{T}}(m) = \{ V = \pi_{\mathbb{J}}(du), \, u \in C_0^{\infty}(M, \mathbb{R})^{\mathbb{T}} \, | \, L_V g = 0, \, L_V I = L_V J = 0 \}.$$

**Definition 7.2.** If I is a generalized Kähler structure in  $\mathcal{AGK}(J, vol)$ , we denote by

$$\mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J}) \coloneqq \left\{ \Psi(\mathbb{J}du) + \sqrt{-1}\Psi(\mathbb{J}dv) \in \mathfrak{ham}^{\mathbb{T}}(\mathbb{J}) \otimes \mathbb{C} \mid L^{H_0}_{\mathbb{J}du}\mathbb{I} + \mathbb{I}L^{H_0}_{\mathbb{J}dv}\mathbb{I} = 0 \right\} \subset \mathfrak{ham}^{\mathbb{T}}(\mathbb{J}) \otimes \mathbb{C}.$$

Using the integrability of  $\mathbb{I}$ , we identify

$$\mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J}) = \left\{ \Psi(\mathbb{J}du) + \sqrt{-1}\Psi(\mathbb{J}dv) \in \mathfrak{ham}^{\mathbb{T}}(\mathbb{J}) \otimes \mathbb{C} \mid L^{H_0}_{\mathbb{J}du + \mathbb{I}\mathbb{J}dv}\mathbb{I} = 0 \right\},\$$

which shows that  $\mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J}) < \mathfrak{ham}^{\mathbb{T}}(\mathbb{J}) \otimes \mathbb{C}$  is then the subalgebra identified with the stabilizer of  $\mathbb{I}$  inside  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J}) \otimes \mathbb{C}$ . We shall refer to  $\mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J})$  as the Lie algebra of *reduced infinitesimal generalized* complex automorphisms of  $(\mathbb{I},\mathbb{J})$ . If  $\chi \in \mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J})$ , we denote by  $(\mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J}))^{\chi} < \mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J})$  the commutator of  $\chi$  inside  $\mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J})$ .

By the definitions of  $\mathfrak{g}(\mathbb{I},\mathbb{J})$  and  $\mathfrak{h}(\mathbb{I},\mathbb{J})$ , we have the inclusion

$$\mathfrak{g}^{\mathbb{T}}(\mathbb{I},\mathbb{J})\otimes\mathbb{C}<\mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J}).$$

Using the formal moment map picture from the previous section, we deduce (similarly to [20]) the following generalized Calabi-Lichnerowicz-Matsushima theorem.

**Theorem 7.3.** [21]/Calabi-Lichnerowicz-Matsushima] Suppose ( $\mathbb{I}, \mathbb{J}, \text{vol}$ ) is a  $\mathbb{T}$ -invariant extremal GK data on  $(M, H_0)$  with extremal Hamiltonian isometry  $\chi = \Psi(\mathbb{J}d\text{Gscal}(\mathbb{I}, \mathbb{J}, \text{vol}))$ . Then

$$(\mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J}))^{\chi} = \mathfrak{g}^{\mathbb{T}}(\mathbb{I},\mathbb{J}) \otimes \mathbb{C}.$$

*Proof.* This follows from the general statement in [30], see also Theorem A.5 for a short proof.  $\Box$ 

7.2. Reductive Lie algebras. We would like to use Theorem 7.3 in order to deduce computable obstructions for the existence of extremal GK structures in terms of automorphisms group. To this end, we are going to recast the Lie algebras  $\mathfrak{g}^{\mathbb{T}}(\mathbb{I},\mathbb{J})$  and  $\mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J})$  in terms of the corresponding bihermitian data.

**Definition 7.4.** Let m = (g, I, J, b) be the bihermitian structure corresponding to  $(\mathbb{I}, \mathbb{J})$ . Define the Lie algebra of vector fields

$$\mathfrak{g}^{\mathbb{T}}(m) = \{ V = \pi_{\mathbb{J}}(du), \, u \in C_0^{\infty}(M, \mathbb{R})^{\mathbb{T}} \, | \, L_V g = 0, \, L_V I = L_V J = 0 \}.$$

**Lemma 7.5.** The vector field  $V := \pi_T(\mathbb{J}du) = \pi_{\mathbb{J}}(du)$  associated to a Hamiltonian isometry  $\mathbb{J}(du)$  of  $(\mathbb{I},\mathbb{J})$  preserves the corresponding bihermitian structure (g,I,J) and volume form vol. In particular,

$$\pi_T(\mathfrak{g}^{\mathbb{T}}(\mathbb{I},\mathbb{J})) < \mathfrak{g}^{\mathbb{T}}(m)$$

is a compact sub-algebra of vector fields.

*Proof.* This follows from Lemma 3.11.

In the generically symplectic type case the elements of  $\mathfrak{g}^{\mathbb{T}}(m)$  canonically lift to elements of  $\mathfrak{g}^{\mathbb{T}}(\mathbb{I},\mathbb{J})$ :

**Lemma 7.6.** Let m = (g, I, J, b) be a generalized Kähler structure of generically symplectic type. Suppose vol is a (g, I, J) adapted volume form, generating a torus  $\mathbb{T}$ , and suppose b is  $\mathbb{T}$ -invariant. Let  $V \in \mathfrak{g}^{\mathbb{T}}(m)$  with potential  $u \in C_0^{\infty}(M, \mathbb{R})^{\mathbb{T}}$ . Then  $L_{\mathbb{J}du}^{H_0} \mathbb{J} = L_{\mathbb{J}du}^{H_0} \mathbb{I} = 0$ , i.e.  $\Psi(\mathbb{J}du) \in \mathfrak{g}^{\mathbb{T}}(\mathbb{I}, \mathbb{J})$ .

*Proof.* By Theorem 2.18 we have

$$L_V \mathbb{I} = L_V \mathbb{J} = 0, \qquad \mathbb{J} du = V + I du - J du + b(V, \cdot)$$

Writing  $\Psi(\mathbb{J}du) = V + B$  with  $B = dd_I^c u - dd_J^c u + d(i_V b)$ , we know by Lemma 3.11 and the V-invariance of the bihermitian data

$$0 = L_{\mathbb{J}du}^{H_0} \mathbb{J} = L_{V+B} \mathbb{J} = L_B \mathbb{J}.$$

As  $\pi_{\mathbb{J}}$  is non-degenerate almost everywhere, we have B = 0. It then follows that

$$L_{\mathbb{J}du}^{H_0}\mathbb{I} = L_V\mathbb{I} = 0.$$

**Definition 7.7.** Given a T-invariant generalized Kähler structure m = (g, I, J, b) on a compact manifold M, with associated Poisson tensor  $\pi_{\mathbb{J}} := \frac{1}{2}(I+J)g^{-1}$  we let

$$\mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m) \coloneqq \left\{ V = \pi_{\mathbb{J}}(du) + J\pi_{\mathbb{J}}(dv), \, u, v \in C^{\infty}(M, \mathbb{R})^{\mathbb{T}} \mid L_{V}J = 0 \right\}$$

Notice that

$$\mathfrak{g}^{\mathbb{T}}(m) + J\mathfrak{g}^{\mathbb{T}}(m) < \mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m)$$

**Lemma 7.8.**  $\mathfrak{h}_{red}^{\mathbb{T}}(m)$  is a complex Lie sub-algebra of the Lie algebra  $\mathfrak{aut}^{\mathbb{T}}(M,\pi,J)$  of real holomorphic vector fields on (M,J) which are  $\mathbb{T}$ -invariant and preserve the holomorphic Poisson tensor  $\pi - \sqrt{-1}J\pi$ . The complex structure of  $\mathfrak{aut}^{\mathbb{T}}(M,\pi,J)$  is induced by the action of J on real holomorphic vector fields.

Proof. The vector space  $\mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m)$  is clearly *J*-invariant. We check that  $\mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m)$  is a Lie algebra. Let  $V_1 = \pi_{\mathbb{J}}(du_1) + J\pi_{\mathbb{J}}(dv_1), \qquad V_2 = \pi_{\mathbb{J}}(du_2) + J\pi_{\mathbb{J}}(dv_2)$ 

be two elements of  $\mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m)$ . In the computation below, we use that  $L_{V_i}J = 0$ , the Poisson property  $[\pi_{\mathbb{J}}(du), \pi_{\mathbb{J}}(dv)] = \pi_{\mathbb{J}}(d\{u, v\}_{\pi_{\mathbb{J}}})$ , and the integrability condition  $J(L_V J) = -L_{JV} J$ :

$$\begin{split} [V_1, V_2] &= \pi_{\mathbb{J}}(d\{u_1, u_2\}_{\pi_{\mathbb{J}}}) + J\pi_{\mathbb{J}}(d\{u_1, v_2\}_{\pi_{\mathbb{J}}}) - [\pi_{\mathbb{J}}(du_2), J\pi_{\mathbb{J}}(dv_1)] - J[\pi_{\mathbb{J}}(dv_2), J\pi_{\mathbb{J}}(dv_1)] \\ &= \pi_{\mathbb{J}}\left(d[\{u_1, u_2\}_{\pi_{\mathbb{J}}} - \{v_1, v_2\}_{\pi_{\mathbb{J}}}]\right) + J\pi_{\mathbb{J}}\left(d[\{u_1, v_2\}_{\pi_{\mathbb{J}}} + \{v_1, u_2\}_{\pi_{\mathbb{J}}}]\right) - (L_{V_2}J)(\pi_{\mathbb{J}}(dv_1)) \\ &= \pi_{\mathbb{J}}\left(d[\{u_1, u_2\}_{\pi_{\mathbb{J}}} - \{v_1, v_2\}_{\pi_{\mathbb{J}}}]\right) + J\pi_{\mathbb{J}}\left(d[\{u_1, v_2\}_{\pi_{\mathbb{J}}} + \{v_1, u_2\}_{\pi_{\mathbb{J}}}]\right). \end{split}$$

We now show that the elements of  $\mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m)$  preserve  $\pi$ . By the Poisson version of Cartan's formula, we have

(7.1) 
$$L_V \pi_{\mathbb{J}} = \pi_{\mathbb{J}} (dIdv) \pi_{\mathbb{J}}.$$

From the expression of  $\pi_{\mathbb{J}}$  and the definition (1.1) of  $\pi$ , we have

(7.2) 
$$J\pi_{\mathbb{J}} + \pi_{\mathbb{J}}J^* = (J-I)\pi_{\mathbb{J}} = -\pi.$$

Using  $L_V J = 0$  (which holds by assumption) and (7.1), the above equality gives

(7.3)  

$$L_V \pi = -J \pi_{\mathbb{J}} (dIdv) \pi_{\mathbb{J}} - \pi_{\mathbb{J}} (dIdv) \pi_{\mathbb{J}} J$$

$$= \pi_{\mathbb{J}} (I^* (dIdv) + (dIdv)I) \pi_{\mathbb{J}}$$

$$= 0,$$

where we have used that  $\pi_{\mathbb{J}}J^* = -I\pi_{\mathbb{J}}, J\pi_{\mathbb{J}} = -\pi_{\mathbb{J}}I^*$  to obtain the second line and  $I^*(dIdv) + (dIdv)I = 0$  (by type considerations with respect to I) to get the third line. This proves the inclusion  $\mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m) < \mathfrak{aut}^{\mathbb{T}}(M, \pi, J)$ .

**Lemma 7.9.** Let  $m_0 = (g_0, J, I_0, b_0)$  be a generically symplectic type bihermitian structure and  $\mathbb{T}$  be a compact torus of isometries of  $m_0$ . Then, for any  $V \in \mathfrak{h}_{red}^{\mathbb{T}}(m_0)$ , the flow  $\phi_t$  of V defines tensors  $g_t = (\phi_t^{-1})^* g_0, J = (\phi_t^{-1})_* J(\phi_t)_* = J, I_t = (\phi_t^{-1})_* I_0(\phi_t)_*$  which give rise to a path  $m_t = (g_t, J, I_t, b_t) \in \mathcal{F}_{m_0}^{\mathbb{T}}$  for a suitable choice of  $\mathbb{T}$ -invariant 2-forms  $b_t$ .

*Proof.* Denote by  $\phi_t$  the flow of V and let  $m_t \coloneqq \phi_t \cdot m$  be the variation of the bihermitian data under this flow. Clearly,  $J_t = J$  as the flow of V preserves J, and the corresponding Poisson tensor is  $\pi_t = (\phi_t)_*(\pi) = \pi$  because of (7.3). As  $(\phi_t)_* \pi_{\mathbb{J}} = \pi_{\mathbb{J}_t}$ , we have

$$V = \pi_{\mathbb{J}_t}(du_t) + J\pi_{\mathbb{J}_t}(dv_t)$$

with  $u_t = \phi_t^*(u)$  and  $v_t := \phi_t^*(v)$ . From (7.1), (7.2) and  $L_V J = 0$  we get

$$0 = L_V \pi = L_V \left( (I - J) \pi_{\mathbb{J}} \right) = (L_V I) \pi_{\mathbb{J}} + (I - J) \pi_{\mathbb{J}} (dI dv) \pi_{\mathbb{J}} = \left( (L_V I) + \pi (dI dv) \right) \pi_{\mathbb{J}}.$$

The fact that  $\pi_{\mathbb{J}}$  is invertible on an open dense subset yields that

$$(7.4) L_V I = -\pi (dI dv)$$

on this subset, and hence, by continuity, everywhere on M. Similarly, using (7.1) and  $L_V J = 0$ , we compute

$$\begin{split} L_V I &= L_V (I+J) = 2L_V (\pi_{\mathbb{J}}g) = 2\pi_{\mathbb{J}} (dIdv) \pi_{\mathbb{J}}g + 2\pi_{\mathbb{J}} (L_V g) \\ &= \pi_{\mathbb{J}} (dIdv) (I+J) + 2\pi_{\mathbb{J}} (L_V g) \\ &= -\pi_{\mathbb{J}} I^* (dIdv) + \pi_{\mathbb{J}} (dIdv) J + 2\pi_{\mathbb{J}} (L_V g) \\ &= J\pi_{\mathbb{J}} (dJdv) + \pi_{\mathbb{J}} (dIdv) J + 2\pi_{\mathbb{J}} (L_V g) \\ &= -\pi (dIdv) + I\pi_{\mathbb{J}} (dIdv) + \pi_{\mathbb{J}} (dIdv) J + 2\pi_{\mathbb{J}} (L_V g) \\ &= -\pi (dIdv) + \pi_{\mathbb{J}} (-J^* (dIdv) + (dIdv) J + 2L_V g) \,. \end{split}$$

From (7.4), we thus get

$$\pi_{\mathbb{J}}(L_V g) = -\pi_{\mathbb{J}}\left((dIdv)J\right)^{\text{sym}},$$

and hence

(7.5) 
$$L_V g = -\left(\left(dIdv\right)J\right)^{\text{sym}}.$$

Therefore, by (7.4) and (7.5), we compute

$$\frac{d}{dt}I = -L_V I = \pi (dIdv) \qquad \frac{d}{dt}g = -L_V g = ((dIdv)J)^{\text{sym}}.$$

Finally, we define a path of 2-forms  $b_t$  by

$$\frac{d}{dt}b = -((dIdv)J)^{\text{skew}}.$$

This shows that  $\tilde{m}_t := (g_t, J, I_t, b_t)$  is a smooth path in  $\mathcal{F}_m^{\mathbb{T}}$ , generated by the smooth function  $v_t = -(\phi_t^{-1})^* v$ , see Lemma 5.4.

**Remark 7.10.** If we assume in Lemma 7.9 that the torus  $\mathbb{T}$  is generated by the divergence  $\operatorname{div}_{\operatorname{vol}_0} \pi_{\mathbb{J}_0}$  of a volume form  $\operatorname{vol}_0$  on M, then letting

$$\operatorname{vol}_t \coloneqq (\phi_t^{-1})^* (\operatorname{vol}_0)$$

we obtain the solution of the evolution equation for  $\operatorname{vol}_t$  in Lemma 5.7. Thus, in this case, all the data  $(g_t, J_t = J, I_t, \operatorname{vol}_t)$  in Lemma 5.7 are induced by the flow  $\phi_t$  of V.

**Theorem 7.11.** Let m = (g, I, J, 0) be a generically symplectic type generalized Kähler structure on M and vol an adapted volume form which generates a torus  $\mathbb{T}$  of isometries of m. Denote by  $(\mathbb{I}, \mathbb{J})$  the corresponding  $(\mathbb{J}, \text{vol})$ -adapted GK structure on  $(M, H_0 := -d_I^c \omega_J)$ , see Remark 3.21. Then

(1)  $\mathfrak{g}^{\mathbb{T}}(m) \cong \mathfrak{g}^{\mathbb{T}}(\mathbb{I},\mathbb{J})$  is a compact Lie algebra and  $\mathfrak{g}^{\mathbb{T}}(m) \cap J\mathfrak{g}^{\mathbb{T}}(m) = 0$ .

(2) There exists an injective complex Lie algebra homomorphism

$$j:\mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m)\to\mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J}),\qquad j(\pi_{\mathbb{J}}(du)+J\pi_{\mathbb{J}}(dv)):=\Psi(\mathbb{J}du+\mathbb{I}\mathbb{J}dv).$$

(3) Suppose (I, J, vol) is extremal and X<sub>ext</sub> := π<sub>J</sub>(dGscal(I, J, vol)) = π<sub>T</sub>(χ) ∈ g<sup>T</sup>(m) is the corresponding extremal vector field. Denote by Î the torus extension of T generated by X<sub>ext</sub> and let h<sup>T</sup><sub>red</sub>(m) < h<sup>T</sup><sub>red</sub>(m) be the sub-algebra of X<sub>ext</sub>-invariant elements. Then h<sup>T</sup><sub>red</sub>(m) = g<sup>T</sup>(m) ⊕ Jg<sup>T</sup>(m) is reductive and j: h<sup>T</sup><sub>red</sub>(m) ≅ (h<sup>T</sup>(I,J))<sup>χ</sup> = g<sup>T</sup>(I,J) ⊗ C.

*Proof.* (1) By Lemma 7.6,  $\mathfrak{g}^{\mathbb{T}}(m)$  consists of all Killing vector fields of (g, I, J) of the form  $V = \pi_{\mathbb{J}}(du)$ ,  $u \in C_0^{\infty}(M, \mathbb{R})^{\mathbb{T}}$  and the Lie algebra homomorphism  $\pi_T : \mathfrak{g}^{\mathbb{T}}(\mathbb{I}, \mathbb{J}) \to \mathfrak{g}^{\mathbb{T}}(m)$  is surjective. The kernel of  $\pi_T$  consists of 2-forms B such that  $L_B^{\text{aut}}\mathbb{J} = L_B^{\text{aut}}\mathbb{I} = 0$ . Note that B must be zero at the points where  $\pi_{\mathbb{J}}$  is non-degenerate, hence, by continuity, everywhere.

Next let  $V = \mathfrak{g}^{\mathbb{T}}(m) \cap J\mathfrak{g}^{\mathbb{T}}(m)$ . Then

$$V = \pi_{\mathbb{J}}(du) = J\pi_{\mathbb{J}}(dv) = \pi_{\mathbb{J}}(Idv)$$

By the non-degeneracy assumption for  $\pi_{\mathbb{J}}$  we will have du = Idv everywhere. The latter and the maximum principle yield that v and u are constant, i.e. V = 0.

(2) We first notice that if  $V = \pi_{\mathbb{J}}(du) + J\pi_{\mathbb{J}}(dv) \in \mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m)$ , then the potential functions are uniquely defined up to additive constants. Indeed, if  $\pi_{\mathbb{J}}(du) + J\pi_{\mathbb{J}}(dv) = 0$ , then using  $J\pi_{\mathbb{J}} = \pi_{\mathbb{J}}I$ and the non-degeneration of  $\pi_{\mathbb{J}}$ , we conclude that du+Jdv = 0. The claim follows from the maximum principle. This shows that  $j:\mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m) \to \mathfrak{aut}(M, H_0)$  is well-defined.

Let  $V = \pi_{\mathbb{J}}(du) + J\pi_{\mathbb{J}}(dv) \in \mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m)$ , and consider the path  $\tilde{m}_t = (g_t, I, I_t, b_t) \in \mathcal{F}_m^{\mathbb{T}}$  generated by the flow of V as in Lemma 7.9. We thus have (see the proof of Lemma 7.9)

$$\frac{\partial}{\partial t}\Big|_{t=0}I = -L_V I, \quad \frac{\partial}{\partial t}\Big|_{t=0}J = -L_V J = 0, \quad \frac{\partial}{\partial t}\Big|_{t=0}g = -L_V g, \quad \frac{\partial}{\partial t}\Big|_{t=0}b = -(dIdv)_J^{(2,0)+(0,2)}J =: B.$$

Using Theorem 2.18 and  $b_0 = 0$ , we compute the derivatives at t = 0 of I and J to be

$$\frac{\partial}{\partial t}\Big|_{t=0} \mathbb{I} = -L_V \mathbb{I} + L_B \mathbb{I}, \qquad \frac{\partial}{\partial t}\Big|_{t=0} \mathbb{J} = -L_V \mathbb{J} + L_B \mathbb{J}$$

On the other hand, by Lemma 5.4, we have

$$\frac{\partial}{\partial t}\Big|_{t=0}\mathbb{I} = L^{H_0}_{\mathbb{I}Idv}\mathbb{I} = L_{\Psi(\mathbb{I}Idv)}\mathbb{I}, \qquad \frac{\partial}{\partial t}\Big|_{t=0}\mathbb{J} = -L^{H_0}_{\mathbb{J}Idv}\mathbb{J} = -L_{\Psi(\mathbb{J}Idv)}\mathbb{J},$$

We thus derive the identities

(7.6) 
$$L_{V+\Psi(\mathbb{I}Idv)-B}\mathbb{I}=0, \qquad L_{V-\Psi(\mathbb{J}Idv)-B}\mathbb{J}=0.$$

Using (2.8), we have

$$V - \mathbb{J}Idv = \frac{1}{2}\left((I+J)du^{\sharp} + dv + JIdv\right), \qquad \mathbb{J}du = \frac{1}{2}\left((I+J)du^{\sharp} + (I-J)du\right)$$

As  $L_{\Psi(\mathbb{J}du)}^{H_0}\mathbb{J} = 0$  (see Lemma 3.11) we have

$$0 = L_{\Psi(V-\mathbb{J}du+\mathbb{J}Idu)-B}^{H_0} \mathbb{J} = \frac{1}{2} L_{\Psi(dv+JIdv-(I-J)du)-2B}^{H_0} \mathbb{J}$$

By the non-degeneracy condition for  $\pi_{\mathbb{J}}$ , we deduce

$$\frac{1}{2}\Psi(dv+JIdv-(I-J)du)=\frac{1}{2}\Psi(JIdv-(I-J)du)=B.$$

By (2.8) again, we compute

(7.7) 
$$\mathbb{J}du + \mathbb{I}\mathbb{J}dv = \frac{1}{2}\left(-2dv^{\sharp} + (I+J)du^{\sharp} + (I-J)du\right)$$

$$V + \mathbb{I}Idv = \frac{1}{2} \left( -2dv^{\sharp} + (I+J)du^{\sharp} - dv + JIdv \right).$$

It follows that

$$\Psi(V + \mathbb{I}Idv) - \Psi(\mathbb{J}du + \mathbb{I}Jdv) = \frac{1}{2}\Psi(-dv + JIdv - (I - J)du) = \frac{1}{2}\Psi(JIdv - (I - J)du) = B.$$

Substituting back in (7.6), we get

 $L_{\Psi(\mathbb{J}du+\mathbb{I}\mathbb{J}dv)}\mathbb{I}=0.$ 

This shows that  $j: \mathfrak{h}_{red}^{\mathbb{T}}(m) \to \mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J})$  is a complex-linear map; it is a Lie algebra homomorphism by Lemma 3.11 (and the fact that  $\mathfrak{ham}^{\mathbb{T}}(\mathbb{J})$  acts holomorphically on  $\mathcal{AGK}(\mathbb{J}, vol)$ ) and the formula for the Lie bracket on  $\mathfrak{h}_{red}^{\mathbb{T}}(m)$  in the proof of Lemma 7.8. The injectivity of j follows from (7.7) and the maximum principle.

(3) First, by the arguments in the proof of Lemma 7.6, we have that

$$\Psi(\mathbb{J}d\mathrm{Gscal}(\mathbb{I},\mathbb{J},\mathrm{vol})) = X_{\mathrm{ext}},$$

showing that

$$\left(\mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J})\right)^{\chi} = \{\Psi(\mathbb{J}du) + \sqrt{-1}\Psi(\mathbb{J}dv) \in \mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J}) \mid L_{X_{\mathrm{ext}}}u = L_{X_{\mathrm{ext}}}v = 0\}.$$

It thus follows that

$$j:\mathfrak{h}_{\mathrm{red}}^{\hat{\mathbb{T}}}(m)\to (\mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J}))^{\chi}.$$

Also, as  $\text{Gscal}(\mathbb{I}, \mathbb{J}, \text{vol})$  is a smooth function depending only on (g, I, J, vol) (see Theorem 4.3 below),  $\text{Gscal}(\mathbb{I}, \mathbb{J}, \text{vol})$  is invariant by any element  $V \in \mathfrak{g}^{\mathbb{T}}(m)$  (recall V preserves vol by Lemma 3.11 and (g, I, J) by definition). In particular,

$$\mathfrak{g}^{\mathbb{T}}(m) \oplus J\mathfrak{g}^{\mathbb{T}}(m) < \mathfrak{h}_{\mathrm{red}}^{\hat{\mathbb{T}}}(m)$$

By Lemma 7.6,  $j: \mathfrak{g}^{\mathbb{T}}(m) \cong \mathfrak{g}^{\mathbb{T}}(\mathbb{I}, \mathbb{J})$ , hence also (examining the definition of j)

$$j:\mathfrak{g}^{\mathbb{T}}(m)\oplus J\mathfrak{g}^{\mathbb{T}}(m)\cong\mathfrak{g}^{\mathbb{T}}(\mathbb{I},\mathbb{J})\otimes\mathbb{C}.$$

By Theorem 7.3, we know that

$$\mathfrak{g}^{\mathbb{T}}(\mathbb{I},\mathbb{J})\otimes\mathbb{C}=ig(\mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J})ig)^{\chi}$$

By the injectivity of j we conclude  $\mathfrak{g}^{\mathbb{T}}(m) \oplus J\mathfrak{g}^{\mathbb{T}}(m) = \mathfrak{h}_{\mathrm{red}}^{\hat{\mathbb{T}}}(m) \stackrel{j}{\cong} (\mathfrak{h}^{\mathbb{T}}(\mathbb{I},\mathbb{J}))^{\chi}$ .

**Remark 7.12.** (1) Presumably,  $\mathfrak{h}_{\mathrm{red}}^{\hat{\mathbb{T}}}(m)$  should be independent of the choice of  $m \in \mathcal{F}^{\mathbb{T}}$  (this is established in the symplectic type case in [4]) and is thus a Lie algebra that can be computed *a priori*. Theorem 7.11 therefore can be used to determine the infinitesimal symmetries of an extremal bihermitian data  $(g, I, J, \mathrm{vol})$  in  $\mathcal{F}^{\mathbb{T}}$ . (2) In the Kähler case,  $\mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m)$  is the Lie algebra of holomorphic vector fields on (M, J) with

(2) In the Kähler case,  $\mathfrak{h}_{red}^{\mathbb{T}}(m)$  is the Lie algebra of holomorphic vector fields on (M, J) with non-empty zero set (see e.g. [17]). Similarly, in the symplectic type GK case, the Lie algebra  $\mathfrak{h}_{red}^{\mathbb{T}}(m)$ is identified in [4] with the sub-algebra of  $\mathfrak{aut}(M, \pi, J)$  of holomorphic vector fields preserving the holomorphic Poisson tensor  $\pi - \sqrt{-1}J\pi$  on (M, J), which vanish somewhere on M.

(3) There is a natural complex Lie algebra isomorphism  $q : \mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m) \to \mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(\overline{m})$ , where  $\overline{m} = (g, J, I, b)$  denotes the bi-Hermitian data with I and J exchanged. Specifically,

$$q(\pi_{\mathbb{J}}(du) + J\pi_{\mathbb{J}}(dv)) \coloneqq \pi_{\mathbb{J}}(du) + I\pi_{\mathbb{J}}(dv).$$

The fact that q(V) preserves I follows by the expression  $q(V) = V + \pi(dv)$ , the formula  $L_V I = -\pi(dd_I^c v)$  established in the proof of Lemma 7.8, and the general fact  $L_{\pi(dv)}I = \pi(dd_I^c u)$  (which holds for any smooth function v by using that  $\pi - \sqrt{-1}I\pi$  is a holomorphic Poisson tensor on (M, I)).

**Example 7.13** (Diagonal Hopf surfaces). Let  $(M, J) = (\mathbb{C}^2 \setminus \{0\})/\langle A \rangle$  be a diagonal Hopf complex surface, where  $A = \operatorname{diag}(\alpha, \beta), 0 < |\alpha| < 1, 0 < |\beta| < 1$  is a contraction of  $\mathbb{C}^2$ . It is known [39, 5] that (M, J) admits a generalized Kähler Ricci soliton m = (g, J, I, f) such that  $\pi - \sqrt{-1}J\pi$  is a holomorphic section of the anti-canonical bundle vanishing along two disjoint smooth elliptic curves  $E_1 \cup E_2$ . In particular,  $\pi_{\mathbb{J}}$  is non-degenerate on the open dense subset  $M \setminus (E_1 \cup E_2)$ . By Corollary 4.8, this is an instance of a cscGK structure with respect to the volume form vol =  $e^{-f} dV_g$ , where f is the soliton potential. The connected Lie group  $\operatorname{Aut}_0(M, \pi, J)$  is (see [5, Prop.6.3]) ( $\mathbb{C}^* \times \mathbb{C}^*$ )/ $\langle A \rangle$ , showing that  $\operatorname{aut}(M, \pi, J) = \mathbb{C}^2$ . We also notice that  $\operatorname{Aut}_0(M, \pi, J)$  admits a 3-dimensional maximal compact torus K, generated by the A-invariant vector fields

$$\left\{\operatorname{Im}(z_1\frac{\partial}{\partial z_1}), \operatorname{Im}(z_2\frac{\partial}{\partial z_2}), \log |\alpha| \operatorname{Re}(z_1\frac{\partial}{\partial z_1}) + \log |\beta| \operatorname{Re}(z_2\frac{\partial}{\partial z_2})\right\}.$$

By Lemma 4.7 the divergence  $\operatorname{div}_{\operatorname{vol}} \pi_{\mathbb{J}}$  is  $X = X_I + X_J$ , which is identified in the proof of Theorem 6.6 in [5] with a real multiple of  $\operatorname{Im}(z_2 \frac{\partial}{\partial z_2})$ . It thus follows that in this case  $\mathbb{T} = S^1$  corresponds to rotation in the  $z_2$ -axis of  $\mathbb{C}^2$ . This proof also shows that the commuting Killing fields  $(X_I, X_J)$  define a 2-dimensional torus in  $\operatorname{Aut}_0(M, \pi, J)$ , generated by  $\{\operatorname{Im}(z_1 \frac{\partial}{\partial z_1}), \operatorname{Im}(z_2 \frac{\partial}{\partial z_2})\}$ . By Lemma 6.8 in [5],

$$\mathfrak{h}_{\mathrm{red}}^{K}(m) = \{0\}.$$

As  $\mathfrak{aut}(M,\pi,J)$  is abelian, we have for any torus  $\mathbb{T} \subset \operatorname{Aut}_0(M,\pi,J)$ 

$$\mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m) = \mathfrak{h}_{\mathrm{red}}^{K}(m) = \{0\}.$$

7.3. Futaki invariant. Here we introduce a generalized Kähler analogue of the Futaki character, extending the definition in the symplectic-type case given in [3]. We are in the setup of Assumption 5.10.

**Definition 7.14.** Denote by  $\mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(J)$  the Lie algebra of all  $\mathbb{T}$ -invariant real holomorphic vector fields V on (M, J), such that for each  $m \in \mathcal{F}^{\mathbb{T}}$ , there exist (unique by the generically symplectic type assumption) smooth functions  $u_m, v_m \in C_0^{\infty}(M, \mathrm{vol}_m)^{\mathbb{T}}$  with

(7.8) 
$$V = \pi_{\mathbb{J}_m}(du_m) + J\pi_{\mathbb{J}_m}(dv_m).$$

Observe that by the results in Section 7.2 and Lemma 5.7, we have

$$\mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(J) = \bigcap_{m \in \mathcal{F}^{\mathbb{T}}} \mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(m),$$

showing that  $\mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(J)$  is a complex sub-algebra of  $\mathfrak{aut}(M, \pi, J)$ .

**Theorem 7.15** (Futaki character). Let  $m \in \mathcal{F}^{\mathbb{T}}$  be a generalized Kähler structure. Define a homomorphism  $\mathbf{F}_m: \mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(J) \to \mathbb{R}$  by

(7.9) 
$$\mathbf{F}_m(V) \coloneqq \int_M v_m \operatorname{Gscal}(m, \operatorname{vol}_m) \operatorname{vol}_m = -\boldsymbol{\tau}(\mathbf{X}_{v_m}).$$

Then  $\mathbf{F}_m$  is independent of  $m \in \mathcal{F}^{\mathbb{T}}$  and vanishes on the commutator  $[\mathfrak{h}_{red}^{\mathbb{T}}(J), \mathfrak{h}_{red}^{\mathbb{T}}(J)]$ . In particular,  $\mathbf{F} = \mathbf{F}_m$  is a character of  $\mathfrak{h}_{red}^{\mathbb{T}}(J)$  which is identically zero if  $\mathcal{F}^{\mathbb{T}}$  admits a cscGK metric.

*Proof.* The infinitesimal action of the vector field  $V \in \mathfrak{h}_{red}^{\mathbb{T}}(J)$  on  $m \in \mathcal{F}^{\mathbb{T}}$  induces a vector field **X** on  $\mathcal{F}^{\mathbb{T}}$  by Lemma 7.9, which at a point  $m \in \mathcal{F}^{\mathbb{T}}$  is given by

$$\mathbf{X}_m = \mathbf{X}_{v_m},$$

where  $v_m$  is the unique normalized potential for V associated to  $m \in \mathcal{F}^{\mathbb{T}}$  via (7.8). Now, the 1-form  $\tau$  on  $\mathcal{F}^{\mathbb{T}}$  is invariant under the vector field  $\mathbf{X}$ , since it is induced by an action of Diff(M) on the entire structure (g, I, J, vol) as explained in Lemma 7.9. Thus by Cartan's formula we have

$$0 = d(\boldsymbol{\tau}(\mathbf{X})) + d\boldsymbol{\tau}(\mathbf{X}, \cdot).$$

Since  $\boldsymbol{\tau}$  is closed, it follows that  $\boldsymbol{\tau}(\mathbf{X})$  is constant on  $\mathcal{F}^{\mathbb{T}}$  which is equivalent to the statement of the constancy of  $\mathbf{F}_m(V)$  on  $\mathcal{F}^{\mathbb{T}}$ .

Furthermore, if  $W \in \mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(J)$  is another holomorphic vector field inducing a vector field **Y** on  $\mathcal{GK}_{0}^{\mathbb{T}}$ , then

$$\mathbf{F}_m([V,W]) = -\boldsymbol{\tau}([\mathbf{X},\mathbf{Y}]) = d\boldsymbol{\tau}(\mathbf{X},\mathbf{Y}) + \mathbf{Y} \cdot \boldsymbol{\tau}(\mathbf{X}) - \mathbf{X} \cdot \boldsymbol{\tau}(\mathbf{Y}) = 0,$$

as claimed, so that  $\mathbf{F}_m$  is a character of  $\mathfrak{h}_{\mathrm{red}}^{\mathbb{T}}(J)$ .

**Remark 7.16.** A conceptually distinct notion of Futaki invariant appeared recently in the context of generalized geometry [14], yielding obstructions to the existence of solutions of the Hull-Strominger system.

#### Appendix A. The general Calabi-Lichnerowiz-Matsushima theorem

In this appendix we show a general Calabi-Lichnerowicz-Matsuhima result which follows easily from the arguments of [30], but is not stated exactly in the form below.

#### A.1. The formal GIT setup. The formal setup is as follows:

•  $(\mathbf{M}, \mathbf{J}, \mathbf{\Omega}, \mathbf{g})$  is a formal (possibly infinite dimensional) Fréchet Kähler manifold, with tangent space  $\mathbf{T}_m \mathbf{M}$ . We denote by  $\mathfrak{X}(\mathbf{M})$  the space of (formal) vector fields on  $\mathbf{M}$ . We assume that each tangent vector  $\mathbf{X}(m) \in \mathbf{T}_m \mathbf{M}$  can be obtained as the value at m of a vector field  $\mathbf{X} \in \mathfrak{X}(\mathbf{M})$  which admits a flow  $\Phi_t : \mathbf{M} \to \mathbf{M}$ , i.e.

$$\Phi_0 = \mathrm{id}, \qquad \Phi_{t+s} = \Phi_t \circ \Phi_s, \qquad \frac{d}{dt} \Phi_t(m) = \mathbf{X}(\Phi_t(m)).$$

- $\mathfrak{Aut}$  is a (possibly infinite dimensional) Lie group with Lie algebra  $\mathfrak{aut}$  admitting exponential map  $\exp : \mathfrak{aut} \to \mathfrak{Aut}$ . We assume that  $\mathfrak{Aut}$  acts differentiably (on the left) on  $\mathbf{M}$ ; this gives rise to fundamental vector fields  $\mathbf{X}_u, u \in \mathfrak{aut}$  which admit flows.
- ham < aut is a (possibly infinite dimensional) Lie sub-algebra endowed with an ad-invariant inner product ⟨⟨·, ·⟩⟩, such that:
  - (a) The representation  $\mathfrak{ham} \ni u \mapsto \mathbf{X}_u \in \mathfrak{X}(\mathbf{M})$  coming from the  $\mathfrak{Aut}$ -action is (formally) hamiltonian in the sense that there exists a differentiable map  $\mu : \mathbf{M} \to \mathfrak{ham}^*$  such that for any  $u \in \mathfrak{ham}$ , the corresponding fundamental vector field  $\mathbf{X}_u$  on  $\mathbf{M}$  satisfies

$$\mathbf{\Omega}(\mathbf{X}_u,\cdot) = -d\langle u,\boldsymbol{\mu}\rangle,$$

and for any  $u, v \in \mathbf{h}$ ,

$$\Omega(\mathbf{X}_u, \mathbf{X}_v) = -\langle [u, v], \boldsymbol{\mu} \rangle.$$

(b)  $\boldsymbol{\mu}$  admits a differentiable  $\langle\!\langle \cdot, \cdot \rangle\!\rangle$ -dual map  $\boldsymbol{\mu}^{\sharp} : \mathbf{M} \to \mathbf{h}$  such that  $\forall m \in \mathbf{M}$ ,

$$\boldsymbol{\mu}(m) = \langle\!\langle \boldsymbol{\mu}^{\sharp}(m), \cdot \rangle\!\rangle.$$

(c) The action of  $\mathfrak{ham}$  is formally **J**-holomorphic, meaning that for any  $u \in \mathfrak{ham}$  and any  $\mathbf{X} \in \mathfrak{X}(\mathbf{M})$ 

$$[\mathbf{X}_u, \mathbf{J}\mathbf{X}] = \mathbf{J}[\mathbf{X}_u, \mathbf{X}],$$

where the Lie brackets are defined via the flow of  $\mathbf{X}_{u}$ .

The example of interest in this paper is when  $\mathbf{M} = \mathcal{AGK}(\mathbb{J}, \text{vol})$  and  $\mathfrak{Aut} = \operatorname{Aut}(M, H_0, \mathbb{J}, \operatorname{div}_{\operatorname{vol}}(\mathbb{J}))$ is the group of  $\mathbb{T}$ -invariant generalized automorphisms of  $(E = TM \oplus T^*M, H_0)$  preserving  $\mathbb{J}$  and  $\operatorname{div}_{\operatorname{vol}}(\mathbb{J})$ . The Lie algebra  $\mathfrak{aut}$  is then  $\mathfrak{aut}(M, H_0, \mathbb{J}, \operatorname{div}_{\operatorname{vol}}(\mathbb{J}))$  with exponential map coming from the flow of vector fields composed with the *B*-field action. Furthermore, in our case  $\mathfrak{ham} = \mathfrak{ham}^{\mathbb{T}}(\mathbb{J}) =$  $\{\Psi(\mathbb{J}du), u \in C_0^{\infty}(M, \mathbb{R})^{\mathbb{T}}\}$  and the ad-invariant inner product  $\langle\!\langle \cdot, \cdot \rangle\!\rangle$  correspond to the global  $L^2$ product on  $C_0^{\infty}(M, \mathbb{R})^{\mathbb{T}}$  with respect to vol. We then have  $\mu^{\sharp}(m) = \operatorname{Gscal}(\mathbb{I}, \mathbb{J}, \operatorname{vol})$  is the normalized Goto scalar curvature in  $C_0^{\infty}(M, \operatorname{vol})$ .

#### A.2. Extremal points.

**Definition A.1.** An *extremal point*  $m \in \mathbf{M}$  is a critical point of the square-norm function

$$m \to \|\boldsymbol{\mu}^{\sharp}(m)\|^2.$$

For any given point  $m \in \mathbf{M}$ , we denote in the sequel by  $\mathfrak{g}(m) < \mathfrak{ham}$  the Lie algebra of the "stabilizer" of m, i.e.

$$\mathfrak{g}(m) \coloneqq \{ u \in \mathfrak{ham} \, | \, \mathbf{X}_u(m) = 0 \}$$

The fact that  $\mathfrak{g}(m)$  is a sub-algebra of  $\mathfrak{ham}$  follows by the assumption that  $\mathfrak{ham}$  admits an exponential map exp:  $\mathfrak{ham} \to \mathfrak{Aut}$  and  $\mathfrak{Aut}$  acts differentiably on M.

**Lemma A.2.**  $m \in \mathbf{M}$  is extremal if and only if

$$\chi \coloneqq \boldsymbol{\mu}^{\sharp}(m) \in \mathfrak{g}(m).$$

Furthermore, in this case,  $\chi$  is in the center of  $\mathfrak{g}(m)$ .

*Proof.* We denote by  $m_t$  a smooth curve through m with velocity  $\mathbf{X}(m) \in \mathbf{T}_m \mathbf{M}$ . We thus have (using the condition (a) for  $\mathfrak{ham}$ ):

$$\frac{\partial}{\partial t}\Big|_{t=0} \|\boldsymbol{\mu}^{\sharp}(m_t)\|^2 = 2\langle\!\langle \boldsymbol{\chi}, \frac{\partial}{\partial t}\Big|_{t=0} \boldsymbol{\mu}^{\sharp}(m_t)\rangle\!\rangle = d\langle \boldsymbol{u}, \boldsymbol{\mu}\rangle(\mathbf{X}(m)) = -\boldsymbol{\Omega}_m(\mathbf{X}_{\boldsymbol{\chi}}(m), \mathbf{X}(m)).$$

The first claim follows as  $\Omega$  is non-degenerate. To show that  $\chi$  is in the center, we use condition (b), i.e. for any  $u, v \in \mathfrak{g}(m)$ ,

$$0 = \mathbf{\Omega}_m(\mathbf{X}_u(m), \mathbf{X}_v(m)) = -\langle [u, v], \boldsymbol{\mu}(m) \rangle = -\langle [u, v], \boldsymbol{\chi} \rangle$$

Then the claim follows by the ad-invariance of  $\langle\!\langle \cdot, \cdot \rangle\!\rangle$ .

A.3. The reduced autmorphism group and the Calabi–Licherwowicz-Matsushima theorem. We define a map

$$\mathfrak{ham} \otimes \mathbb{C} \ni u + \sqrt{-1}v \to \mathbf{X}_u + \mathbf{J}\mathbf{X}_v \in \mathfrak{X}(\mathbf{M}).$$

The fact that the RHS forms a **J**-invariant distribution on **M** follows from the formal integrability of **J** and the condition (c) for  $\mathfrak{ham}$ . Thus, the above gives rise to a  $\mathbb{C}$ -linear representation of the complex Lie algebra  $\mathfrak{ham} \otimes \mathbb{C}$  into  $\mathfrak{X}(\mathbf{M})$ . This is sometimes referred to as *complexified infinitesimal action* of  $\mathfrak{ham} \otimes \mathbb{C}$  on **M**, although we emphasize here that we do not assume that the formal vector fields  $\mathbf{X}_u + \mathbf{J}\mathbf{X}_v$  on **M** admit flows.

We next fix an extremal point  $m \in \mathbf{M}$  and consider the complex vector sub-space

$$\mathfrak{h}(m) \coloneqq \{u + \sqrt{-1}v \in \mathfrak{ham} \otimes \mathbb{C} \,|\, \mathbf{X}_u(m) + \mathbf{J}\mathbf{X}_v(m) = 0\} \subset \mathfrak{ham} \otimes \mathbb{C}$$

and impose the following assumption

Assumption A.3. We assume that any element  $\mathbf{X}_u + \mathbf{J}\mathbf{X}_v \in \mathfrak{h}(m)$  admits a flow.

Clearly, the above assumption implies that  $\mathfrak{h}(m) < \mathfrak{ham} \otimes \mathbb{C}$ .

**Definition A.4.** If the assumption above is satisfied, we shall refer to  $\mathfrak{h}(m)$  as the Lie algebra of reduced infinitesimal automorphisms of m.

Clearly, we have an inclusion

$$\mathfrak{g}(m)\otimes\mathbb{C}<\mathfrak{h}(m)$$

which forces  $\mathfrak{g}(m)$  to be finite dimensional Lie algebra too. Thus we have:

**Theorem A.5** (Calabi-Lichnerowicz-Matsushima). In the setup above, the centralizer  $(\mathfrak{h}(m))^{\chi}$  of  $\chi$  in  $\mathfrak{h}(m)$  equals  $\mathfrak{g} \otimes \mathbb{C}$ .

*Proof.* We know by Lemma A.2 that  $\mathfrak{g}(m) \otimes \mathbb{C} < (\mathfrak{h}(m))^{\chi}$ . We want to show equality. Let  $u + \sqrt{-1}v$  be an element in  $(\mathfrak{h}(m))^{\chi}$ , i.e.

$$\mathrm{ad}_{\chi} u = 0, \qquad \mathrm{ad}_{\chi} v = 0$$

It then follows by (b), the ad-invariance of  $\langle\!\langle \cdot, \cdot \rangle\!\rangle$  and using the definition of  $\mathfrak{m}(g)$ 

$$0 = \langle \langle \operatorname{ad}_{\chi} u, v \rangle \rangle = -\langle \langle [u, \chi], v \rangle \rangle = \langle \langle \chi, [u, v] \rangle \rangle$$
$$= \langle \mu(m), [u, v] \rangle = -\Omega_m(\mathbf{X}_u(m), \mathbf{X}_v(m))$$
$$= \Omega_m(\mathbf{J}\mathbf{X}_v(m), \mathbf{X}_v(m)) = -\mathbf{g}(\mathbf{X}_v(m), \mathbf{X}_v(m)).$$

It thus follows that  $\mathbf{X}_v(m) = \mathbf{X}_u(m) = 0$ , i.e.  $u + \sqrt{-1}v \in \mathfrak{g}(m) \otimes \mathbb{C}$ .
