# Dihedral-product groups of nonabelian simple groups

#### Abstract

Given a finite group $G$, a group $X$ is called a dihedral-product group of $G$ if $X=G D$ where $D$ is a finite dihedral group. In particular, it is called a dihedralskew product group of $G$ if $G \cap D=1$ and $D$ has a trivial core in $X$. In this paper, dihedral-skew product groups of all nonabelian simple groups are classified and dihedral-product groups of all nonabelian simple groups are characterized.


## 1 Introduction

Throughout the paper all groups are finite. Given a finite group $G$, a group $X$ is called a dihedral-product group of $G$ if $X=G D$ where $D$ is a finite dihedral group. In particular, a dihedral-product group $X=G D$ of $G$ is called a dihedral-skew product group of $G$ if $G \cap D=1$ and $D$ has a trivial core in $X$. The investigation of dihedral-skew product groups is at least related to the following three topics.
(1) Factorizations of groups: A group $X$ is said to be properly factorizable if $X=$ $G H$ for two proper subgroups $G$ and $H$ of $X$, while the expression $X=G H$ is called a factorization of $X$. Furthermore, if $G \cap H=1$, then we say that $X$ has an exact factorization. Hence, a dihedral-skew product group $X$ of a group $G$ means that $X$ has a factorization $X=G D$ such that $D$ is a dihedral group, and a dihedral-skew product group $X$ of a group $G$ means that $X$ has an exact factorization $X=G D$ such that $D$ is a dihedral group with a trivial core in $X$. Similarly, for any given group $G$, a group $X$ is called a skew product group of $G$ if $X=G C$ where $G \cap C=1$ and $C$ is a cyclic group with a trivial core in $X$.

Factorizations of groups naturally arise from the well-known Frattini's argument, including its version in permutation groups. One of the most famous results about factorized groups might be one of theorems of Itô, saying that any group is metabelian whenever it is the product of two abelian subgroups (see [8]). Later, Wielandt and Kegel showed that the product of two nilpotent subgroups must be soluble (see [22] and [10]). Douglas showed that the product of two cyclic groups must be super-solvable (see [6]). The factorizations of the finite almost simple groups were determined in [16] and the factorizations

[^0]of almost simple groups with a solvable factor were determined in [15]. There are many other papers related to factorizations, for instance, finite products of soluble groups, factorizations with one nilpotent factor and so on. Here we are not able to list all references and the readers may refer to a survey paper [1].
(2) Permutation groups: For a factorization $X=G H$, let $\Omega=[X: G]$ be the set of right cosets of $G$ in $X$. If $G$ is core free, then $X$ acts faithfully on $\Omega$. Hence, $X$ is a permutation group with degree $|\Omega|$ and contains a transitive subgroup $H$. Clearly, a dihedral-skew product group $X=G D$ of $G$ is a permutation group acting on $[X: D]$ and containing a regular subgroup $G$. The study of a permutation group containing a transitive subgroup played an important role in the history of permutation group theory. A transitive permutation group $X$ is called primitive if $\Omega$ has no nontrivial $X$-invariant partition. Burnside and Schur proved that primitive permutation group containing a regualr cyclic group of order $p^{m}$ and composite order is 2 -transitive (see [3, 19]). In 1949, Wielandt showed that such group containing a regualr dihedral group is 2-transitive [23], and in 1957, Scott proved that such group containing a regualr generalized quaternion group is 2 -transitive [20]. A permutation group is called quasiprimitive if each of its non-trivial normal subgroups is transitive. Recently, Li, Pan and Xia characterized quasiprimitive permutation group containing a regualr metacyclic group [14].
(3) Cayley maps: A map $\mathcal{M}$ is said to be orientable regular or regular if its automorphism group $\operatorname{Aut}(\mathcal{M})$ is regular on arcs or flags, see [12] for the definitions. Richter et al. show that a $\operatorname{map} \mathcal{M}$ is a Cayley map of a group $G$ if and only if the group $\operatorname{Aut}(\mathcal{M})$ contains a regular subgroup that is isomorphic to $G$ (see [18]). Jajcay and Siráň showed that for a rotary Cayley map CM of $G$, the automorphism group Aut (CM) is a skew product group of $G$ (see [9]). Orientable regular Cayley maps of cyclic groups, dihedral groups and elementary abelian $p$-groups are classified in [5, 11, 7], separately. And orientable regular Cayley maps of finite nonabelian characteristically simple groups are characterized in [4]. Recently, Kwak and Kwon showed that for an unoriented regular Cayley map CM of $G$, the automorphism group Aut (CM) is a dihedral-skew product group of $G$ (see [12]). Thus the problem of determining all regular Cayley maps of $G$ is suffice to determine all dihedral-skew product groups of $G$. Since orientable regular Cayley maps of nonabelian simple groups are characterized in [4], we shall consider their unoriented regular Cayley maps. Hence, we need to determine dihedral-skew product groups of all nonabelian simple groups.

Theorem 1.1 Let $X=G D$ be a dihedral-skew product group of a nonabelian simple group $G$. Then either $G \triangleleft X$ or the triple $(X, G, D)$ is given in Table $\mathbb{1}$.

Recall that a permutation group is called quasiprimitive if each of its non-trivial normal subgroups is transitive. Then a permutation group is called non-quasiprimitive if there exists a non-trivial normal subgroup that is non-transitive. In other words, a nonquasiprimitive permutation group means that there exists a non-trivial normal subgroup

which induces proper blocks. In fact, a permutation group is either quasiprimitive or non-quasiprimitive.

Remark: $X$ acts quasiprimitively on $[X: G]$ in Rows 1-4 of Table 1 and non-quasiprimitively in Rows 5-8.

Next, dihedral-skew product groups of nonabelian simple groups are characterized. For two groups $G$ and $H$, let $G . H$ denote an extension of $G$ by $H$.

Theorem 1.2 Let $Y=G D$ be a dihedral-product group of a nonabelian simple group $G$ and set $D_{Y}=\cap_{y \in Y} D^{y}$, the core of $D$ in $Y$. Then either $G \triangleleft Y$ or one of the following holds:
(1) $G \cap D=1$, and one of the following holds:
(1.1) $D_{Y}=1$ and $Y$ is a dihedral-skew product group of $G$;
(1.2) $D_{Y} \neq 1$ is cyclic and $Y=D_{Y} \cdot X=D_{Y} \rtimes X$, where $X$ is Rows 5 and 6 in Table 1; or
(1.3) $D_{Y} \cong \mathbb{Z}_{2}$ and $Y=D_{Y} \cdot X$, where $X$ is one of Table $\mathbb{1}$.
(2) $G \cap D=2$, and $(Y, G, D)=\left(A_{m+1}, A_{m}, D_{2(m+1)}\right)$ or $\left(A_{m+1} \times \mathbb{Z}_{2}, A_{m}, D_{4(m+1)}\right)$, with $\frac{m}{2} \geq 3$ even.

## 2 Preliminaries

Notation and terminologies used in the paper are standard and can be found in [17]. In particular, $H_{G}=\cap_{g \in G} H^{g}$, the core of the subgroup $H$ in $G$.

Proposition 2.1 [13, Theorem 1.5] Let $X$ be a quasiprimitive permutation group of degree $n$. Then, $X$ contains a dihedral regular subgroup $G$ if and only if $X$ is 2-transitive, and one of the following holds, where $\omega \in \Omega$ :
(i) $(X, G)=\left(A_{4}, D_{4}\right),\left(S_{4}, D_{4}\right),\left(\operatorname{AGL}(3,2), D_{8}\right),\left(\operatorname{AGL}(4,2), D_{16}\right),\left(\mathbb{Z}_{2}^{4} \rtimes A_{6}, D_{16}\right)$, or $\left(\mathbb{Z}_{2}^{4} \rtimes\right.$ $A_{7}, D_{16}$ );
(ii) $\left(X, G, X_{\omega}\right)=\left(M_{12}, D_{12}, M_{11}\right),\left(M_{22} \cdot 2, D_{22}, \operatorname{PSL}(3,4) .2\right)$, or $\left(M_{24}, D_{24}, M_{23}\right)$;
(iii) $\left(X, G, X_{\omega}\right)=\left(S_{2 m}, D_{2 m}, S_{2 m-1}\right)$ or $\left(A_{4 m}, D_{4 m}, A_{4 m-1}\right)$;
(iv) $X=\operatorname{PSL}\left(2, p^{e}\right) . O, G=D_{p^{e}+1}$, and $X_{\omega} \unrhd \mathbb{Z}_{p}^{e} \rtimes \mathbb{Z}_{\frac{p^{e}-1}{2}} . O$, where $p^{e} \equiv 3(\bmod 4)$, and $O \leq \operatorname{Out}\left(\operatorname{PSL}\left(2, p^{e}\right)\right) \cong \mathbb{Z}_{2} \times \mathbb{Z}_{e} ;$
(v) $X=\operatorname{PGL}\left(2, p^{e}\right) \mathbb{Z}_{f}, G=D_{p^{e}+1}$, and $X_{\omega}=\mathbb{Z}_{p}^{e} \rtimes \mathbb{Z}_{p^{e}-1}$, where $p^{e} \equiv 1(\bmod 4)$, and $f \mid e$.

Picking up all point stabilizers which are simple groups in Proposition 2.1 and using Magma [2], we immediately get the following corollary.

Corollary 2.2 Let $X=G D$ be a dihedral-skew product group of a nonabelian simple group $G$. Suppose that $X$ acts faithfully and quasiprimitively on $[X: G]$. Then $(X, G, D)=\left(\operatorname{AGL}(3,2), G L(3,2), D_{8}\right),\left(M_{12}, M_{11}, D_{12}\right),\left(M_{24}, M_{23}, D_{24}\right)$, or $\left(A_{4 m}, A_{4 m-1}\right.$, $D_{4 m}$ ) with $m \geq 2$.

Proposition 2.3 [4, Theorem 1.1] Let $X=G C$ be a skew group of a nonabelian simple group $G$. Then one of following holds:
(1) $X=G \rtimes C$ and $C \leq \operatorname{Aut}(G)$; or
(2) $(X, G)=\left(\mathrm{PSL}(2,11), A_{5}\right),\left(M_{23}, M_{22}\right)$, or $\left(A_{m+1}, A_{m}\right)$ with $m \geq 6$ even.

For a group $H$, consider an extension of $K$ by $H$, that is $G=K . H$. In particular, $G$ is a proper central extension of $K$ by $H$ if $K \leq Z(G) \cap G^{\prime}$ [21]. Then a central extension $G$ is either a proper central extension or $K \times H$.

Proposition 2.4 [4, Proposition 2.3] For the simple groups PSL(2,11), $M_{23}$ and $A_{n}$ for $5 \leqslant n \neq 6$, we have the following results:
(1) there exists no nontrivial proper central extension of $\operatorname{PSL}(2,11)\left(A_{n}\right)$ containing a subgroup $A_{5}\left(A_{n-1}\right)$, separately; and
(2) there exists no nontrivial proper central extension of $M_{23}$.

Using Magma [2], we get the following facts.
Lemma 2.5 (1) If $\operatorname{PSL}(2,11) \rtimes \mathbb{Z}_{2}$ contains a subgroup $D_{22}$, then $\operatorname{PSL}(2,11) \rtimes \mathbb{Z}_{2}=$ $\operatorname{PGL}(2,11)=A_{5} D_{22} ;$
(2) if $M_{12} \rtimes \mathbb{Z}_{2}$ contains a subgroup $D_{24}$, then $M_{12} \rtimes \mathbb{Z}_{2}=\operatorname{Aut}\left(M_{12}\right)=M_{11} D_{24}$;
(3) there exists no $M_{23} \rtimes \mathbb{Z}_{2}\left(M_{24} \rtimes \mathbb{Z}_{2}\right)$ containing a subgroup $D_{46}\left(D_{48}\right)$, separately; and
(4) there exists no $\operatorname{AGL}(3,2) \rtimes \mathbb{Z}_{2}$ containing a subgroup $D_{16}$.

## 3 Proof of Theorem 1.1

Throughout this section, let $G$ be a nonabelian simple group and $X=G D$ a dihedralskew product group of $G$, where $D=\langle a\rangle \rtimes\langle b\rangle$.

Since $G_{X} \unlhd G$ and $G$ is a nonabelian simple group, we get that $G_{X}$ is either $G$ or 1 . Suppose that $G_{X}=G$. Then $G \triangleleft X$, that is the former of Theorem 1.1. Since $X=G \rtimes D$ and $G$ is a nonabelian simple group, we know $G$ char $X$. So in what follows, we assume that $G_{X}=1$.

Lemma 3.1 Suppose that $G_{X}=1$ and there exists a maximal subgroup $H$ of $X$ such that $G<H$ and $H \cap D \leq\langle a\rangle$. Then $X=(G\langle a\rangle) \rtimes\langle b\rangle$ and $(X, G, D)$ is either $\left(\operatorname{PGL}(2,11), A_{5}, D_{22}\right)$ or $\left(A_{m+1} \rtimes \mathbb{Z}_{2}, A_{m}, D_{2(m+1)}\right)$ with $m \geq 6$ even. Moreover, $G\langle a\rangle \operatorname{char} X$.

Proof Set $H \cap D=\left\langle a_{1}\right\rangle \neq 1$, that is $H=G\left\langle a_{1}\right\rangle$. Then we shall show $\left\langle a_{1}\right\rangle=\langle a\rangle$, that is $H=G\langle a\rangle$. Since

$$
\begin{equation*}
a_{1} \in \cap_{a^{i} b \in D} H^{a^{i} b}=\cap_{g a^{i} b \in X} H^{g a^{i} b}=\cap_{x \in X} H^{x}=H_{X} \tag{1}
\end{equation*}
$$

we get $\left\langle a_{1}\right\rangle \leq H_{X}$ which implies $H_{X}=\left(H_{X} \cap G\right)\left\langle a_{1}\right\rangle$. Noting that $G$ is a nonabelian simple group and $H_{X} \cap G \unlhd G$, we know that $H_{X} \cap G$ is either 1 or $G$. For the contrary, assume that $H_{X} \cap G=1$, that is $H_{X}=\left\langle a_{1}\right\rangle$. Then one can get $H_{X}=\left\langle a_{1}\right\rangle \leq D_{X}=1$, a contradiction. Therefore, $H_{X} \cap G=G$, that is $H_{X}=G\left\langle a_{1}\right\rangle=H$. Noting that $X / H=\bar{D}$ act regularly and primitively on $[X: H]$, by the definition of $H$, we get $\left\langle a_{1}\right\rangle=\langle a\rangle$, that is

$$
H=G\langle a\rangle \quad \text { and } \quad X=H \rtimes\langle b\rangle .
$$

Then $\langle b\rangle_{X} \leq D_{X}=1$. Moreover, we get

$$
\langle a\rangle_{H}=\cap_{a^{i} g \in H}\langle a\rangle^{a^{i} g}=\cap_{b j} a^{i} g \in X\langle a\rangle^{b^{j} a^{i} g}=\langle a\rangle_{X} \leq D_{X}=1 .
$$

Noting that $G \cap\langle a\rangle=1$, we know that $H$ is a skew product group of $G$. Then by Proposition [2.3, we get that either $H=G \rtimes\langle a\rangle$, or $(H, G)=\left(\operatorname{PSL}(2,11), A_{5}\right)$, $\left(M_{23}, M_{22}\right)$ or $\left(A_{m+1}, A_{m}\right)$ with $m \geq 6$ even. For the contrary, assume $H=G \rtimes\langle a\rangle$. Then we get $G$ char $H \triangleleft X$, which implies $G \triangleleft X$, a contradiction. Hence, $(H, G)=$ $\left(\mathrm{PSL}(2,11), A_{5}\right),\left(M_{23}, M_{22}\right)$, or $\left(A_{m+1}, A_{m}\right)$.

By $X=H \rtimes\langle b\rangle$, we get that $(X, G, D)$ can only be in the following three cases:

$$
\left(\operatorname{PSL}(2,11) \rtimes \mathbb{Z}_{2}, A_{5}, D_{22}\right),\left(M_{23} \rtimes \mathbb{Z}_{2}, M_{22}, D_{46}\right) \text { or }\left(A_{m+1} \rtimes \mathbb{Z}_{2}, A_{m}, D_{2(m+1)}\right) .
$$

By Lemma 2.5, we get

$$
(X, G, D) \in\left\{\left(\operatorname{PGL}(2,11), A_{5}, D_{22}\right),\left(A_{m+1} \rtimes \mathbb{Z}_{2}, A_{m}, D_{2(m+1)}\right)\right\} .
$$

Next, we shall structure the dihedral-skew product group $A_{m+1} \rtimes \mathbb{Z}_{2}$ of $A_{m}$. Let $D_{2(m+1)}=$ $\langle a, b\rangle \leq S_{m+3}$, where $a=(12 \cdots m+1) \in A_{m+1}$ and $b=(1 m+1)(2 m) \cdots\left(\frac{m}{2} \frac{m}{2}+1\right)(m+$ $2 m+3)$. Then $A_{m+1} \rtimes\langle b\rangle \cong A_{m+1} \rtimes \mathbb{Z}_{2}=A_{m} D_{2(m+1)}$. Since $A_{m+1}$ is a simple group, we know $D_{2(m+1) A_{m+1}}=1$, which implies that $A_{m+1} \rtimes \mathbb{Z}_{2}$ is a dihedral-skew product groups of $A_{m}$.

Hence, $(X, G, D)=\left(\mathrm{PGL}(2,11), A_{5}, D_{22}\right)$ or $\left(A_{m+1} \rtimes \mathbb{Z}_{2}, A_{m}, D_{2(m+1)}\right)$ with $m \geq 6$ even. Moreover, one can get $G\langle a\rangle=H$ char $X$, as desired.

Lemma 3.2 Suppose that $G_{X}=1$. Then $(X, G, D)$ is given in Table $\mathbb{1}$, that is the later of Theorem 1.1.

Proof Let $\Omega=[X: G]$ be the set of right cosets of $G$ in $X$. Since $G_{X}=1, X$ acts faithfully on $\Omega$ by right multiplication. Suppose that $X$ is quasiprimitive. Then by Corollary 2.2., we get $(X, G, D)=\left(\operatorname{AGL}(3,2), G L(3,2), D_{8}\right),\left(M_{12}, M_{11}, D_{12}\right),\left(M_{24}, M_{23}, D_{24}\right)$ or $\left(A_{4 m}, A_{4 m-1}, D_{4 m}\right)$ with $m \geq 2$, that is Rows 1-4 of Table 1,

In what follows, we assume that $X$ is non-quasiprimitive, that is there exists a nontransitive normal subgroup $N$ of $X$ that induces proper blocks, which implies $G N<X$. Let $H$ be a maximal subgroup of $X$ containing $G N$. Clearly, we know $N \leq H_{X} \neq 1$. By $G<H$, we get $H=G(H \cap D)$ where $H \cap D \neq 1$. If $H \cap D \leq\langle a\rangle$, then noting that $G_{X}=1$, by Lemma 3.1, we get

$$
(X, G, D)=\left(\operatorname{PGL}(2,11), A_{5}, D_{22}\right),\left(A_{2 m+3} \rtimes \mathbb{Z}_{2}, A_{2 m+2}, D_{2(2 m+3)}\right), \text { with } m \geq 2
$$

that is Rows 5 and 6 of Table 1 . So in what follows, we assume that $H \cap D \not \leq\langle a\rangle$. In fact, we can make a more rigorous assumption $\mathfrak{A}$ : for any maximal subgroup $L$ of $X$ containing $G$, if $L_{X} \neq 1$, then $L \cap D \nsubseteq\langle a\rangle$.

Set $H \cap D=\left\langle a_{1}, b\right\rangle$ for some $\left\langle a_{1}\right\rangle<\langle a\rangle$ and $b \in D \backslash\langle a\rangle$. Then $H=G\left\langle a_{1}, b\right\rangle$. With the same as (11), we get that $\left\langle a_{1}\right\rangle \leq H_{X}$ and $H_{X} \cap G$ is either 1 or $G$. Depending on $H_{X} \cap G$, we can divide it into the following two cases.

Case 1: $H_{X} \cap G=1$.
We claim that there exists the only element $g b \in H_{X} \backslash\left\langle a_{1}\right\rangle$ with $1 \neq g \in G$. Suppose that there exists no element $g b \in H_{X} \backslash\left\langle a_{1}\right\rangle$ with $g \in G$. Then $H_{X}=\left\langle a_{1}\right\rangle \leq D_{X}=1$, contradicting to $H_{X} \neq 1$. Hence, there exists an element $g b \in H_{X} \backslash\left\langle a_{1}\right\rangle$ with $g \in G$. If $g=1$, then $\left\langle a_{1}, b\right\rangle \leq H_{X}$. Since $H_{X} \cap G=1$, we know $H_{X}=\left\langle a_{1}, b\right\rangle \leq D_{X}=1$,
a contradiction. Hence, $g \neq 1$. If there exists an other element $g_{1} b \in H_{X} \backslash\left\langle a_{1}\right\rangle$ with $g \neq g_{1} \in G$, then we get $g_{1} g^{-1} \in H_{X} \cap G=1$, a contradiction again. Therefore, there exists the only element $g b \in H_{X} \backslash\left\langle a_{1}\right\rangle$ with $1 \neq g \in G$.

For the contrary, assume that $(g b)^{2} \notin\left\langle a_{1}\right\rangle$. Set $(g b)^{2}=g_{1} a_{1}^{i} b^{j}$ for $g_{1} \in G, i \in \mathbb{Z}$ and $j \in\{0,1\}$. If $j=0$, then $g_{1} \in H_{X}$ as $\left\langle a_{1}\right\rangle \leq H_{X}$, which implies $g_{1}=1$, and so $(g b)^{2}=a_{1}^{i}$, a contradiction. If $j=1$, that is $(g b)^{2}=g_{1} a_{1}^{i} b=g_{1} b a_{1}^{-i}$, then $g_{1} b \in H_{X}$, which implies $g_{1}=g$, and so $g b=a_{1}^{-i} \in\left\langle a_{1}\right\rangle$, a contradiction again. Therefore, $(g b)^{2} \in\left\langle a_{1}\right\rangle$ and so $H_{X}=\left\langle a_{1}\right\rangle .\langle g b\rangle$.

Noting $(g b)^{2} \in\left\langle a_{1}\right\rangle$, we get $\left\langle a_{1}^{2}\right\rangle$ char $H_{X} \triangleleft X$, which implies $\left\langle a_{1}^{2}\right\rangle \triangleleft X$. By $D_{X}=1$, we know $a_{1}^{2}=1$. For the contrary, suppose that $a_{1}$ is a involution. Then $H_{X} \cong D_{4}$ or $\mathbb{Z}_{4}$, and $H / C_{H}\left(H_{X}\right)=\bar{G} \leq \operatorname{Aut}\left(H_{X}\right)$ as $H=G H_{X}$ and $H_{X} \leq C_{H}\left(H_{X}\right)$. By the definition of $H$, we know $C_{H}\left(H_{X}\right)=H$, which implies $H_{X} \leq Z(H)$. Hence, $\left\langle a_{1}\right\rangle \leq$ $D_{X}=1$, a contradiction. Therefore, we know $a_{1}=1$, that is $H_{X}=\langle g b\rangle \cong \mathbb{Z}_{2}$ and $H=G\langle b\rangle$. Then $g b \in Z(X)$. If $H \triangleleft X$, then $G$ char $H \triangleleft X$, which implies $G \triangleleft X$, a contradiction. Consider $\bar{X}:=X / H_{X}=\bar{G}\langle\bar{a}\rangle$ and then $\bar{G} \nexists \bar{X}$, which implies $\bar{G}_{\bar{X}}=1$. Set $\left\langle\bar{a}_{2}\right\rangle=\langle\bar{a}\rangle_{X / H_{X}}$. Since $H \leq G\left\langle a_{2}, b\right\rangle<X$, by the maximality of $H$, we get $a_{2}=1$, which implies $\langle\bar{a}\rangle_{X / H_{X}}=1$. Hence, $\langle\bar{a}\rangle$ is core-free in $X / H_{X}$. By Proposition 2.3, we know $(\bar{X}, \bar{G})=\left(\operatorname{PSL}(2,11), A_{5}\right),\left(M_{23}, M_{22}\right)$, or $\left(A_{2 m+3}, A_{2 m+2}\right)$ with $m \geq 2$. Hence,

$$
(X, G)=\left(\mathbb{Z}_{2} \cdot \operatorname{PSL}(2,11), A_{5}\right),\left(\mathbb{Z}_{2} \cdot M_{23}, M_{22}\right), \text { or }\left(\mathbb{Z}_{2} \cdot A_{2 m+3}, A_{2 m+2}\right) .
$$

Since $\mathbb{Z}_{2} . L$ is either a proper central extension or $L \times \mathbb{Z}_{2}$, where $L \in\left\{\operatorname{PSL}(2,11), M_{23}, A_{2 m+3}\right\}$, by Lemma 2.5 and Proposition 2.4, we know that there exists no $\mathbb{Z}_{2} \cdot \operatorname{PSL}(2,11)\left(\mathbb{Z}_{2} \cdot M_{23}\right)$ such that $\mathbb{Z}_{2} \cdot \operatorname{PSL}(2,11)=A_{5} D_{22}\left(\mathbb{Z}_{2} \cdot M_{23}=M_{22} D_{46}\right)$, separately, and if $\mathbb{Z}_{2} \cdot A_{2 m+3}=$ $A_{2 m+2} D_{2(2 m+3)}$, then $\mathbb{Z}_{2} . A_{2 m+3}=A_{2 m+3} \times \mathbb{Z}_{2}$. Hence,

$$
(X, G, D)=\left(A_{2 m+3} \times \mathbb{Z}_{2}, A_{2 m+2}, D_{2(2 m+3)}\right) .
$$

But $G\langle a\rangle=A_{2 m+3}$ is a maximal subgroup of $X$ and $G\langle a\rangle \triangleleft X$, contradicting to $\mathfrak{A}$.
Case 2: $H_{X} \cap G=G$.
In this case, $H_{X}$ is either $G\left\langle a_{1}\right\rangle$ or $G\left\langle a_{1}, b\right\rangle=H$ as $\left\langle a_{1}\right\rangle \leq H_{X}$. If $H_{X}=G\left\langle a_{1}\right\rangle$, then $G\langle a\rangle$ is a maximal subgroup of $X$ and $G\langle a\rangle \triangleleft X$, contradicting to $\mathfrak{A}$ again. Hence, $H_{X}=G\left\langle a_{1}, b\right\rangle=H$. By $H_{X} \triangleleft X$, we know that $H=G\left\langle a^{2}, b\right\rangle$ and $X=H \rtimes\langle a b\rangle$, which implies $4\left||D|\right.$. If $G \triangleleft H$, then $H=G \rtimes\left\langle a^{2}, b\right\rangle$ as $G \cap\left\langle a^{2}, b\right\rangle=1$, and so $G$ char $H \triangleleft X$ as $G$ is a nonabelian simple group, which implies $G \triangleleft X$, contradicting with $G_{X}=1$. Therefore, $G \nrightarrow H$, which implies $a^{2} \neq 1$ and $G_{H}=1$. Noting that $\left\langle a^{2}, b\right\rangle_{H}=1, G \cap\left\langle a^{2}, b\right\rangle=1$ and $\left\langle a^{2}, b\right\rangle$ is a dihedral group in $H=G\left\langle a^{2}, b\right\rangle$, we know that $H$ is also a dihedral-skew product group of $G$. By $G_{H}=1$, we know that $H$ acts faithfully on $[H: G]$.

Suppose that $H$ is a quasiprimitive group. By Corollary [2.2, we get $(H, G, D)=$ $\left(\operatorname{AGL}(3,2), G L(3,2), D_{8}\right),\left(M_{12}, M_{11}, D_{12}\right),\left(M_{24}, M_{23}, D_{24}\right),\left(A_{4 m}, A_{4 m-1}, D_{4 m}\right)$, with $m \geq$

2, which implies $(X, G, D)=\left(\operatorname{AGL}(3,2) \rtimes \mathbb{Z}_{2}, G L(3,2), D_{16}\right),\left(M_{12} \rtimes \mathbb{Z}_{2}, M_{11}, D_{24}\right),\left(M_{24} \rtimes\right.$ $\left.\mathbb{Z}_{2}, M_{23}, D_{48}\right),\left(A_{4 m} \rtimes \mathbb{Z}_{2}, A_{4 m-1}, D_{8 m}\right)$. By Lemma [2.5, we get

$$
(X, G, D) \in\left\{\left(\operatorname{Aut}\left(M_{12}\right), M_{11}, D_{24}\right),\left(A_{4 m} \rtimes \mathbb{Z}_{2}, A_{4 m-1}, D_{8 m}\right)\right\} .
$$

Next, we shall structure the dihedral-skew product group $A_{4 m} \rtimes \mathbb{Z}_{2}$ of $A_{4 m-1}$. Let $D_{8 m}=$ $\langle a, b\rangle \leq S_{4 m+2}$, where $a=(12 \cdots 4 m)(4 m+14 m+2)$ and $b=(14 m)(24 m-1) \cdots(2 n 2 m+$ 1) $\in A_{4 m}$. Then

$$
A_{4 m} \rtimes\langle a b\rangle=A_{4 m} \times\langle(4 m+14 m+2)\rangle \cong A_{4 m} \times \mathbb{Z}_{2}=A_{4 m-1} D_{8 m}
$$

Since $A_{4 m}$ is a simple group, we know $D_{8 m A_{4 m}}=1$, which implies that $A_{4 m} \rtimes \mathbb{Z}_{2}$ is a dihedral-skew product group of $A_{m}$. Hence,

$$
(X, G, D)=\left(\operatorname{Aut}\left(M_{12}\right), M_{11}, D_{24}\right) \text { or }\left(A_{4 m} \rtimes \mathbb{Z}_{2}, A_{4 m-1}, D_{8 m}\right),
$$

that is Rows 7 and 8 in Table 1 .
In what follows, we shall show that $H$ may not be a non-quasiprimitive. For the contrary, assume that $H$ is a non-quasiprimitive. Then there exists a maximal subgroup $K=G\left\langle a_{1}, b^{j}\right\rangle$ of $H$ such that $K_{X} \neq 1$, where $a_{1} \in\left\langle a^{2}\right\rangle$ and $j \in\{0,1\}$. Suppose that $j=0$, that is $K=G\left\langle a_{1}\right\rangle$. Then using Lemma 3.1 for $H$, we get $K=G\left\langle a^{2}\right\rangle$ char $H \triangleleft X$, which implies $K \triangleleft X$. Hence, $G\langle a\rangle \leq X$, contradicting to $\mathfrak{A}$. Therefore, $j=1$, that is $K=G\left\langle a_{1}, b\right\rangle$, and furthermore, by the above argument, we know that $G\left\langle a^{2}\right\rangle$ can not be a subgroup of $H$. Clearly, $K_{H} \cap G$ is either 1 or $G$. If $K_{H} \cap G=1$, then with the same argument as Case 1, we know $G\left\langle a^{2}\right\rangle$ char $H$, a contradiction. Thus, $K_{H} \cap G=G$ and so $K_{H}$ is either $G\left\langle a_{1}\right\rangle$ or $K$. For the former, that is $K_{H}=G\left\langle a_{1}\right\rangle$, we get $G\left\langle a^{2}\right\rangle \leq H$, a contradiction. For the later, that is $K_{H}=K$, we get $\left\langle a_{1}\right\rangle=\left\langle a^{4}\right\rangle$ and $4 \mid o(a)$, which implies $K=K_{H}=G\left\langle a^{4}, b\right\rangle$. Clearly, $\left\langle a^{4}\right\rangle \leq K_{X}$ and $b \notin K_{X}$. Since $|X: K|=4$ and $X / K_{X} \leq S_{4}$, we know $G \leq K_{X}$, which implies $K_{X}=G\left\langle a^{4}\right\rangle$. Then we also get $G\left\langle a^{2}\right\rangle \leq H$, a contradiction again.

## 4 Proof of Theorem 1.2

Let $G$ be a nonabelian simple group and $Y=G D$ a dihedral-product group of $G$, where $D=\langle a\rangle \rtimes\langle b\rangle$. Set $D_{Y}=\cap_{y \in Y} D^{y}$, the core of $D$ in $Y$.

Since $G_{Y} \unlhd G$ and $G$ is a nonabelian simple group, we get that $G_{Y}$ is either $G$ or 1 . Suppose that $G_{Y}=G$. Then $G \triangleleft Y$, that is the part (i) of Theorem 1.2, So in what follows, we assume that $G_{Y}=1$.

Generally, for a dihedral-product group $Y=G D$ of any group $G$ (maybe not a nonabelian simple group) with a trivial core in $Y$, we have the following result.

Lemma 4.1 Let $H$ be a group and $Y=H D$ a dihedral-product group of $H$. Set $D=$ $\langle a\rangle \rtimes\langle b\rangle$. Suppose that $H$ is core-free. Then $H \cap D$ is either 1 or $\left\langle b_{1}\right\rangle$ with $b_{1} \in D \backslash\langle a\rangle$.

Proof Since $H$ is core-free, $Y$ acts faithfully on $\Omega:=[Y: H]$. Set $H \cap\langle a\rangle=\left\langle a_{1}\right\rangle$. Then

$$
\left\langle a_{1}\right\rangle \leq \cap_{a^{i} b^{j} \in D} H^{a^{i} b^{j}}=\cap_{h \in H, a^{i} b^{j} \in D} H^{h a^{i} b^{j}}=\cap_{y \in Y} H^{y}=H_{Y}=1,
$$

which implies $H \cap\langle a\rangle=1$. Hence, $H \cap D$ is either 1 or $\left\langle b_{1}\right\rangle$ with $b_{1} \in D \backslash\langle a\rangle$, as desired.

By Lemma 4.1, we get $|G \cap D| \leq 2$ for $Y=G D$. Depending on $|G \cap D|$, we get Lemmas 4.2 and 4.3 .

Lemma 4.2 Let $G$ be a nonabelian simple group and $Y=G D$ a dihedral-product group of $G$. Set $D=\langle a\rangle \rtimes\langle b\rangle$. Suppose that $G \cap D=1$ and $G$ is core fore. Then $D_{Y}<\langle a\rangle$ the following holds:
(i) $\left|D_{Y}\right| \leq 2$ and $Y=D_{Y} \cdot X$, where $X$ is one of Table 1; or
(ii) $D_{Y} \neq 1$ and $Y=D_{Y} \cdot X=D_{Y} \rtimes X$, where $X$ is Rows 5 and 6 in Table 1 .

Proof Let $G$ be a nonabelian simple group and $Y=G D$ a dihedral-product group of $G$ such that $G \cap D=1$ and $G$ is core free. Set $D=\langle a\rangle \rtimes\langle b\rangle$ and $D_{Y}=\cap_{y \in Y} D^{y}$, the core of $D$ in $Y$.

For the contrary, assume that $D_{Y} \nexists\langle a\rangle$. Then by $D_{Y} \unlhd D$, we get $D_{Y}$ is either $D$ or $\left\langle a^{2}, b_{1}\right\rangle$ with $b_{1} \in D \backslash\langle a\rangle$. If $D_{Y}=D$, then $Y=D \rtimes G$. Since $Y / C_{Y}(D) \leq \operatorname{Aut}(D)$, $\operatorname{Aut}(D)$ is a solvable group and $G$ is an nonabelian group, we get $G \leq C_{Y}(D)$, which implies $G \triangleleft Y$, a contradiction. If $D_{Y}=\left\langle a^{2}, b_{1}\right\rangle$ with $b_{1} \in D \backslash\langle a\rangle$, then $Y=\left(D_{Y} \rtimes G\right) \rtimes\langle a b\rangle$. With the same argument as the case $D_{Y}=D$, we get $Y=\left(G \times\left\langle a^{2}, b_{1}\right\rangle\right) \rtimes\langle a b\rangle$. Consider $H=G \times\left\langle a^{2}, b_{1}\right\rangle$. We shall show $G$ char $H$. If not, then there exists a subgroup $K$ in $H$ such that $K \neq G, K \cong G$ and $K \triangleleft H$. Since $G \cap K \triangleleft G$ and $G$ is an nonabelian group, we get $G \cap K=1$ and so $G \times K \leq H$. Then $\left\langle K, a^{2}, b_{1}\right\rangle \leq C_{H}(G)=\left\langle a^{2}, b_{1}\right\rangle$, which implies $K \leq\left\langle a^{2}, b_{1}\right\rangle$, a contradiction. Hence, $G$ char $H$. By $G \operatorname{char} G \times\left\langle a^{2}, b_{1}\right\rangle \triangleleft Y$, we know $G \triangleleft Y$, a contradiction again. Therefore, $D_{Y} \leq\langle a\rangle$.

Set $D_{Y}=\left\langle a_{1}\right\rangle$. Then $Y / C_{Y}\left(\left\langle a_{1}\right\rangle\right) \leq \operatorname{Aut}\left(\left\langle a_{1}\right\rangle\right)$ is abelian, which implies that $G C_{Y}\left(\left\langle a_{1}\right\rangle\right) / C_{Y}\left(\left\langle a_{1}\right\rangle\right)$ is abelian. Since $\langle a\rangle \leq C_{Y}\left(\left\langle a_{1}\right\rangle\right)$ and $C_{Y}\left(\left\langle a_{1}\right\rangle\right) \cap G \unlhd G$, we get that $C_{Y}\left(\left\langle a_{1}\right\rangle\right)$ is either $Y$ or $G\langle a\rangle$. Hence, $\left\langle D_{Y}, G\right\rangle=D_{Y} \times G$. If $D_{Y} \times G \triangleleft Y$, then $G$ char $D_{Y} \times G \triangleleft Y$, which implies $G \triangleleft Y$, a contradiction. Therefore,

$$
Y=\left(D_{Y} \times G\right) D, \text { where } D_{Y} \times G \nexists Y \text {. }
$$

Note that the quotient group $\bar{Y}:=Y / D_{Y}=\overline{G D}$ is a dihedral-skew product group of $G$ as $\bar{G} \cong G$, and $\bar{G}$ is core free.

Suppose that $C_{Y}\left(\left\langle a_{1}\right\rangle\right)=Y$. Then by the definition of $D$, we get o $\left(a_{1}\right) \leq 2$. If o $\left(a_{1}\right)=1$, then $D$ is core free and so $Y$ is a dihedral-skew product group of $G$ with $G_{Y}=1$, which implies that $(Y, G, D)$ is given in Table 1. If $\mathrm{o}\left(a_{1}\right)=2$, then by Theorem 1.1, we know that $Y$ is a central extension of $\mathbb{Z}_{2}$ by $X$, where $X$ is given in Table noting $\bar{G} \cong G$
in $\bar{Y}$. Hence, $Y=D_{Y} \cdot X$, where $X$ is given in Table 1, that is the former part of this lemma.

Suppose that $C_{Y}\left(\left\langle a_{1}\right\rangle\right)=G\langle a\rangle$. Then $a_{1} \neq 1$ and $\bar{Y}=(\bar{G}\langle\bar{a}\rangle) \rtimes\langle\bar{b}\rangle$. Noting that $\bar{G}_{\bar{Y}}=$ 1, by Lemma 3.1, we get $(\bar{Y}, \bar{G}\langle\bar{a}\rangle, \bar{G}, \bar{D})$ is either $\left(\operatorname{PGL}(2,11), \operatorname{PSL}(2,11), A_{5}, D_{22}\right)$ or $\left(A_{m+1} \rtimes \mathbb{Z}_{2}, A_{m+1}, A_{m}, D_{2(m+1)}\right)$ with $m \geq 6$ even. Since the pre-image $\bar{G}\langle\bar{a}\rangle$ is $\left\langle a_{1}\right\rangle .(\bar{G}\langle\bar{a}\rangle)$, the central extension of $\left\langle a_{1}\right\rangle$ by $G\langle a\rangle$, by Proposition [2.4, we get $G\langle a\rangle=\left\langle a_{1}\right\rangle \times\left(G\left\langle a_{2}\right\rangle\right)$, where $\langle a\rangle=\left\langle a_{1}\right\rangle \times\left\langle a_{2}\right\rangle$ and $G\left\langle a_{2}\right\rangle$ is either $\operatorname{PSL}(2,11)$ or $A_{m+1}$. By $G\left\langle a_{2}\right\rangle \operatorname{char} G\langle a\rangle \triangleleft Y$, we know $G\left\langle a_{2}\right\rangle \triangleleft Y$. Then

$$
Y=\left(\left\langle a_{1}\right\rangle \times\left(G\left\langle a_{2}\right\rangle\right)\right) \rtimes\langle b\rangle=\left\langle a_{1}\right\rangle \rtimes X,
$$

where $X=\left(G\left\langle a_{2}\right\rangle\right) \rtimes\langle b\rangle$ is either $\operatorname{PGL}(2,11)$ or $A_{m+1} \rtimes \mathbb{Z}_{2}$ with $m \geq 6$ even, that is the later part of this lemma.

Lemma 4.3 Let $G$ be a nonabelian simple group and $Y=G D$ a dihedral-product group of $G$. Suppose that $|G \cap D|=2$ and $G$ is core fore. Then $(Y, G, D)=\left(A_{m+1}, A_{m}, D_{2(m+1)}\right)$ or $\left(A_{m+1} \times \mathbb{Z}_{2}, A_{m}, D_{4(m+1)}\right)$, with $\frac{m}{2} \geq 3$ even.

Proof Let $G$ be a nonabelian simple group and $Y=G D$ a dihedral-product group of $G$ such that $|G \cap D|=2$ and $G$ is core free. By Lemma 4.1, set $C=\langle a\rangle$ and $\langle b\rangle \cong \mathbb{Z}_{2}$ such that $D=C \rtimes\langle b\rangle, G \cap D=\langle b\rangle$. Then $Y=G C$ where $G \cap C=1$. With the same argument as Lemma 4.2, consider $C_{Y}$, the core of $C$ in $Y$.

Suppose that $C_{Y}=1$. Then $Y$ is a skew product group of $G$ with $G_{Y}=1$. By Proposition 2.3, we get that $(Y, G, C)=\left(\operatorname{PSL}(2,11), A_{5}, \mathbb{Z}_{11}\right),\left(M_{23}, M_{22}, \mathbb{Z}_{23}\right)$, or $\left(A_{m+1}, A_{m}, \mathbb{Z}_{m+1}\right)$ with $m \geq 6$ even. By the definition of $Y$, we know that there exists an involution $b \in G$ such that $\langle C, b\rangle$ is dihedral. But by Magma [2], we know that there no exists $D_{22}\left(D_{46}\right)$ in $\operatorname{PSL}(2,11)\left(M_{23}\right)$, separately. Next, consider $(Y, G, C)=\left(A_{m+1}, A_{m}, \mathbb{Z}_{m+1}\right)$. We get

$$
a=(12 \cdots m m+1) \text { and } C=\langle a\rangle \cong \mathbb{Z}_{m+1}
$$

Clearly, there exists an involution $b=(1 m+1)(2 m) \cdots\left(\frac{m}{2} \frac{m}{2}+2\right) \in S_{m+1}$ such that $\langle a, b\rangle=D_{2(m+1)}$. Moreover, $b \in A_{m+1}$ if $\frac{m}{2}$ is even. Then we get

$$
(Y, G, D)=\left(A_{m+1}, A_{m}, D_{2(m+1)}\right), \text { with } \frac{m}{2} \geq 3 \text { even }
$$

that is the former part of the lemma. So in what follows, we assume that $\left|C_{Y}\right| \neq 1$.
Set $C_{Y}=\left\langle a_{1}\right\rangle$ with $a_{1} \in\langle a\rangle$. By $\left|C_{Y}\right| \neq 1$, we know $a_{1} \neq 1$. Then $Y / C_{Y}\left(\left\langle a_{1}\right\rangle\right) \leq$ Aut $\left(\left\langle a_{1}\right\rangle\right)$ is abelian, which implies that $G C_{Y}\left(\left\langle a_{1}\right\rangle\right) / C_{Y}\left(\left\langle a_{1}\right\rangle\right)$ is abelian. Since $\langle a\rangle \leq$ $C_{Y}\left(\left\langle a_{1}\right\rangle\right)$ and $C_{Y}\left(\left\langle a_{1}\right\rangle\right) \cap G \unlhd G$, we get that $C_{Y}\left(\left\langle a_{1}\right\rangle\right)=G\langle a\rangle=Y$. By the definition of $Y$ and $a_{1} \neq 1$, we get $\mathrm{o}\left(a_{1}\right)=2$. Consider $\bar{Y}=Y /\left\langle a_{1}\right\rangle=\overline{G D}=\overline{G C}$. Since $\bar{G} \cong G$ and $\bar{C}_{\bar{Y}}=1$, we know that $\bar{Y}$ is a dihedral-skew product group of $G$ with $\bar{G} \cap \bar{D}=2$ and $\bar{C}_{\bar{Y}}=1$. Then with the same as the above, we know $\bar{Y}=A_{m+1}$, with $\frac{m}{2} \geq 3$ even.

Hence, $Y$ is a central extension of $\left\langle a_{1}\right\rangle$ by $X$, where $X$ is $A_{m+1}$, with $\frac{m}{2} \geq 3$ even. Then $(Y, G, D)=\left(\mathbb{Z}_{2} . A_{m+1}, A_{m}, D_{2(m+1)}\right)$ with $\frac{m}{2} \geq 3$ even. By Proposition 2.4, we know

$$
(Y, G, D)=\left(\mathbb{Z}_{2} \cdot A_{m+1}, A_{m}, D_{4(m+1)}\right), \text { with } \frac{m}{2} \geq 3 \text { even }
$$

that is the later part of the lemma.

## 5 Further research

In this paper, we classify dihedral-skew product groups of all nonabelian simple groups. Since all nonabelian simple groups are finite nonabelian characteristically simple groups and orientable regular Cayley maps of finite nonabelian characteristically simple groups are characterized in [4], we propose the following problem for further research.

Question 1 Determine dihedral-skew product groups of all finite nonabelian characteristically simple groups and classify regular Cayley maps of unoriented finite nonabelian characteristically simple groups.

Since dihedral-product groups of all nonabelian simple groups are characterized in Theorem 1.2, we also want to classify them.

Question 2 Determine dihedral-product groups of all nonabelian simple groups.
