# The asymptotic spectrum distance, graph limits, and the Shannon capacity

#### Abstract

Determining the Shannon capacity of graphs is a long-standing open problem in information theory, graph theory and combinatorial optimization. Over decades, a wide range of upper and lower bound methods (of combinatorial, algebraic, analytic, and computational nature) have been developed to analyze this problem. However, despite tremendous effort, even small instances of the problem have remained open (e.g., the Shannon capacity of any odd cycle of length at least seven), and central computational and structural questions unanswered.

In recent years, a new dual characterization of the Shannon capacity of graphs, asymptotic spectrum duality, has unified and extended known upper bound methods and structural theorems. This duality originated from the work of Strassen in algebraic complexity theory.

In this paper, building on asymptotic spectrum duality, we develop a new theory of graph distance, that we call asymptotic spectrum distance, and corresponding limits (reminiscent of, but different from, the celebrated theory of cut-norm, graphons and flag algebras). We propose a graph limit approach to the Shannon capacity problem: to determine the Shannon capacity of a graph, construct a sequence of easier to analyse graphs converging to it. (1) We give a very general construction of non-trivial converging sequences of graphs (in a family of circulant graphs). As a consequence, we prove new continuity properties of the Shannon capacity, the Lovász theta function and other graph parameters, answering questions of Schrijver and Polak. (2) We construct Cauchy sequences of finite graphs that do not converge to any finite graph, but do converge to an infinite graph. We establish strong connections between convergence questions of finite graphs and the asymptotic properties of Borsuk-like infinite graphs on the circle, and use ideas from the theory of dynamical systems to study these infinite graphs. (3) We observe that all best-known lower bound constructions for Shannon capacity of small odd cycles can be obtained from a "finite" version of the graph limit approach, in which we approximate the target graph by another graph with a large independent set that is an "orbit" under a natural group action. We develop computational and theoretical aspects of this approach and use these to obtain a new Shannon capacity lower bound for the fifteen-cycle.

The graph limit point-of-view brings many of the constructions that have appeared over time in a unified picture, makes new connections to ideas in topology and dynamical systems, and offers new paths forward. The theory of asymptotic spectrum distance applies not only to Shannon capacity of graphs, but indeed we will develop it for a general class of mathematical objects and their asymptotic properties.

## 1 Introduction

Posed by Shannon in 1956 [Sha56], determining the amount of information that can be transmitted perfectly over a noisy communication channel, the Shannon zero-error capacity, is a longstanding and central open problem in information theory, graph theory and combinatorial optimization [KO98, Alo02, Sch03]. Mathematically, this problem asks for determining the rate of growth of the independence number of powers of graphs.

Over decades, a wide range of upper and lower bound methods (of combinatorial, algebraic, analytic, and computational nature) have been developed to analyze this problem, by Shannon [Sha56], Lovász [Lov79], Haemers [Hae79, Hae81], Alon [Alo98], Alon-Lubetzky [AL06], Polak-Schrijver [PS19, Pol19b], Google DeepMind [RPBN+ ${ }^{+}$24] and many others [Ros67, $\mathrm{BMR}^{+} 71$, Hal73, $\mathrm{CFG}^{+} 93$, BH03, BM13, Bla13b, MOr17, GRW18, BC19, ABG+20, Fri21, GR21, Sch23, Zhu24]. However, despite tremendous effort, even small instances of the problem have remained open (in particular, determining the Shannon capacity of any odd cycle of length at least seven), and central computational and structural questions unanswered.

In recent years, a new dual characterization of the Shannon capacity of graphs, called asymptotic spectrum duality [Zui19], has unified and extended known upper bound methods and structural theorems [Vra21, Sim21, Fri21, Sch23]. This duality originates from Strassen's work in algebraic complexity theory on fast matrix multiplication algorithms and tensors [Str87, Str88, Str91, CVZ23] (and goes back to the real representation theorems of Stone and Kadison-Dubois [BS83]) and applies much more generally to asymptotic problems in various fields [JV20, RZ21, Fri23]; see the survey of Wigderson-Zuiddam [WZ23].

In this paper, building on asymptotic spectrum duality, we develop a new theory of graph distance and limits-reminiscent of, but different from, the celebrated theory of cut-norm, graphons and flag algebras in the study of homomorphism densities [LS06, Raz07, BCL ${ }^{+} 08$, Lov12]. The crucial property of this asymptotic spectrum distance is that converging graphs have converging Shannon capacity,

$$
G_{i} \rightarrow H \Rightarrow \Theta\left(G_{i}\right) \rightarrow \Theta(H),
$$

thus suggesting a graph limit approach to the Shannon capacity problem: to determine (or, say, lower bound) the Shannon capacity of a "hard" graph, construct a sequence of easier to analyse (e.g., highly structured) graphs converging to it.

Central results of this paper are (1) how to construct converging sequences of graphs and (2) where to look for graphs that are "easier to analyse". Indeed, a special case of our results is that for any odd cycle graph we can construct many non-trivial converging sequences of very structured graphs converging to it (as illustrated in Figure 1). Using a "finite" version of this idea we will obtain a new lower bound on the Shannon capacity of the fifteen-cycle.


Figure 1: Beginning of non-trivial sequence converging to the seven-cycle (Theorem 1.1).

As we will see, the graph limit point-of-view opens the door to analyzing the Shannon capacity problem from many new angles, including: via infinite graphs, topological and analytical methods, and the theory of dynamical systems. It brings many of the best-known Shannon capacity constructions in a unified picture, and offers new paths forward.

We briefly summarize here our main results and we will expand on these in the rest of the introduction:

- Convergence and continuity. We develop asymptotic spectrum distance, including methods for bounding it. These lead to a very general construction of non-trivial converging sequences of graphs (in a family of circulant graphs that we call fraction graphs, and are also called circular graphs). As a consequence, we prove new continuity properties of the Shannon capacity, the Lovász theta function and other graph parameters. (Section 1.2)
- Infinite graphs as limit points. We construct Cauchy sequences of finite graphs that do not converge to any finite graph, but do converge to an infinite graph. More generally we establish strong connections between convergence questions of (finite) graphs and the asymptotic properties of (Borsuk-like) infinite graphs on the circle, and use ideas from the theory of dynamical systems to study these infinite graphs. (Section 1.3)
- Graph limit approach and orbit constructions. We observe that all bestknown lower bound constructions for Shannon capacity of small odd cycles can be obtained from a "finite" version of the graph limit approach, in which we approximate the target graph by another graph with a large independent set that is an "orbit" under a natural group action. ${ }^{1}$ We develop computational and theoretical aspects of this approach and use it to obtain a new Shannon capacity lower bound for the fifteen-cycle. (Section 1.4)

The asymptotic spectrum distance theory applies not only to graphs and the Shannon capacity problem, but indeed is much more general and applies to other kinds of mathematical objects and their asymptotic (under large powers) properties. We will thus develop parts of the theory in the generality of preordered semirings. Remarkably, comparing asymptotic spectrum distance for the semiring of graphs and the semiring of tensors (which has a very long history and rich theory [Str87, Str88, Str91, WZ23, CVZ23]), we see a striking difference: while for graphs we have non-trivial converging sequences and non-converging Cauchy sequences, it follows from recent works [BDR22, $\left.\mathrm{BCL}^{+} 24\right]$ that tensors show much more discrete behaviour, and in particular that for tensors over finite fields no such sequences exist. (Section 1.5)

In the rest of the introduction we discuss basic notions and main results in more detail.

### 1.1 Shannon capacity and asymptotic spectrum distance

We discuss some basic notions (a full discussion is in Section 2) and then elaborate on our results. The Shannon capacity of a graph $G$ is defined as the rate of growth of the

[^0]independence number under taking large powers of the graph (under the "strong product"), that is, $\Theta(G)=\lim _{n \rightarrow \infty} \alpha\left(G^{\boxtimes n}\right)^{1 / n}$ [Sha56]. By Fekete's lemma this equals the supremum $\sup _{n} \alpha\left(G^{\boxtimes n}\right)^{1 / n}$, so that we may think of Shannon capacity as a maximisation problem.

Asymptotic spectrum duality [Zui19] characterizes the Shannon capacity as the minimization $\Theta(G)=\min _{F \in \mathcal{X}} F(G)$, where $\mathcal{X}$, called the asymptotic spectrum of graphs, is a natural family of real-valued functions on graphs (namely, multiplicative, additive, cohomomorphism-monotone, normalized functions, which we discuss in detail later, Section 2.2). The asymptotic spectrum $\mathcal{X}$ contains the Lovász theta function, fractional Haemers bound, fractional clique covering number, and other well-known upper bounds on Shannon capacity. While we do not have an explicit description of all elements of $\mathcal{X}$, several structural properties are known [Vra21].

We define the asymptotic spectrum distance by $d(G, H)=\sup _{F \in \mathcal{X}}|F(G)-F(H)|$ for any two graphs $G, H .{ }^{2}$ From asymptotic spectrum duality it can be seen that converging graphs have converging Shannon capacity (Lemma 2.7). As we will see (Lemma 2.8), asymptotic spectrum distance can be phrased in an operational form using asymptotic spectrum duality. Namely, $d(G, H)$ is small if and only if a "polynomial blow up" of $G$ can be mapped (cohomomorphicaly) to a slightly larger polynomial blow up of $H$, and similarly for $G$ and $H$ reversed. ${ }^{3}$

### 1.2 Converging sequences

We construct (non-trivial) converging sequences of graphs in the asymptotic spectrum distance. For this we use a natural family of vertex-transitive graphs which we call fraction graphs. ${ }^{4}$ For any $p, q \in \mathbb{N}$ with $p / q \geq 2$ we let $E_{p / q}$ be the graph with vertex set $V=\{0, \ldots, p-1\}$ and with distinct $u, v \in V$ forming an edge if $u-v$ or $v-u$ is strictly less than $q$ modulo $p .{ }^{5}$ For example, $E_{8 / 3}$ is the following graph:


The graphs $E_{p / q}$, which we call fraction graphs, have many nice properties. We write $G \leq H$ if there is a cohomomorphism $G \rightarrow H$ (a map $V(G) \rightarrow V(H)$ that maps non-edges to non-edges). Then: $p / q \leq s / t$ (in $\mathbb{Q}$ ) if and only if $E_{p / q} \leq E_{s / t}$ in the cohomomorphism preorder. That is, fraction graphs are ordered as the rational numbers,

[^1]and in particular inherit their denseness. (We note that $E_{p / q}$ and $E_{n p / n q}$, for $n \in \mathbb{N}$, are not isomorphic graphs, but they are equivalent under cohomomorphism.) The fraction graphs contain all cycle graphs as $C_{n}=E_{n / 2}$, and the edgeless graphs as $E_{m}=E_{m / 1}=\bar{K}_{m}$.

We develop techniques to bound the asymptotic spectrum distance of vertextransitive graphs and their induced subgraphs (Section 2.5), and a vertex removal strategy for fraction graphs (Section 3.1). Using these we obtain a general construction of converging sequences:

Theorem 1.1 (Theorem 3.7). For any $a / b \geq 2$, if $p_{n} / q_{n}$ converges to $a / b$ from above, then $E_{p_{n} / q_{n}}$ converges to $E_{a / b} .{ }^{6}$

Theorem 1.1 solves a problem and extends the work of Schrijver and Polak [Pol19a, Chapter 9]. They constructed (by means of an independent set construction) for every integer $m \in \mathbb{N}$ a sequence of fraction graphs $E_{p_{n} / q_{n}}$ that converges to $E_{m}=E_{m / 1}$ from below, which implies that for any sequence $p_{n} / q_{n}$ converging to $m$ from below we have that $E_{p_{n} / q_{n}}$ converges to $E_{m}$.

We leave it as an open problem whether $p_{n} / q_{n} \rightarrow a / b$ from below also implies $E_{p_{n} / q_{n}} \rightarrow E_{a / b}$. In the next section we discuss how this problem is closely related to properties of infinite graphs.

Theorem 1.1 can alternatively be phrased in terms of continuity of the graph parameters in the asymptotic spectrum, $F \in \mathcal{X}$. Namely, it says that $p / q \mapsto F\left(E_{p / q}\right)$ is right-continuous (and the same for $F=\Theta$ ).

With similar methods we get:
Theorem 1.2 (Theorem 3.14). For any irrational $r \in \mathbb{R}_{\geq 2}$, if $p_{n} / q_{n}$ converges to $r$, then $E_{p_{n} / q_{n}}$ is Cauchy.

It follows from Theorem 1.2 with a simple argument (Corollary 3.16) that there are Cauchy sequences that do not converge to any finite graph. Indeed, the fractional clique cover number of any sequence in Theorem 1.2 converges to the irrational number $r$, which cannot be the fractional clique cover number of a finite graph. This answers a question raised in [Pol19a, Chapter 9].

There is a natural (albeit abstract) way to complete the space of finite graphs with the asymptotic spectrum distance, by identifying every graph $G$ with its evaluation function $\widehat{G}: \mathcal{X} \rightarrow \mathbb{R}: F \mapsto F(G)$. The coarsest topology on $\mathcal{X}$ that makes the $\widehat{G}$ continuous is compact, and thus we can think of graphs as living in the space $C(\mathcal{X})$ of continuous functions on $\mathcal{X}$ endowed with the sup-norm, which is complete.

The above (keeping in mind the analogous theory of cut-norm and graphons) raises the question whether there are concrete, graph-like models for limit points; indeed we prove that infinite graphs provide such models.

### 1.3 Infinite graphs as limit points

We prove that certain infinite graphs (on the circle) are limit points for non-converging Cauchy sequences of finite graphs, and investigate the properties of these graphs, and strong connections to the Shannon capacity of finite graphs.

[^2]We define two kinds of infinite graphs on the circle (that may be thought of as infinite versions of the fraction graphs). Let $C \subseteq \mathbb{R}^{2}$ denote a circle with unit circumference. For $r \in \mathbb{R}_{\geq 2}$ we define $E_{r}^{o}$ to be the infinite graph with vertex set $C$ for which two vertices are adjacent if and only if they have distance strictly less than $1 / r$ on $C$. We define $E_{r}^{o}$ to be the infinite graph with vertex set $C$ for which two vertices are adjacent if and only if they have distance strictly at most $1 / r$ on $C$. The subtle difference between the "open" and "closed" version of these circle graphs will play an important role.

We naturally extend asymptotic spectrum duality and distance to infinite graphs, and are then able to establish the circle graphs as limit points:

Theorem 1.3 (Theorem 4.11). For any irrational $r \in \mathbb{R}_{\geq 2}$, if $p_{n} / q_{n}$ converge to $r$, then $E_{p_{n} / q_{n}}$ converges to $E_{r}^{o}$.

For any two graphs $G, H$ we write $G \lesssim H$ if $G^{\boxtimes n} \leq H^{\boxtimes(n+o(n))}$. We say $G$ and $H$ are asymptotically equivalent, if $G \lesssim H$ and $H \lesssim G$. It follows from our proof of Theorem 1.3 that $E_{r}^{c}$ is asymptotically equivalent to $E_{r}^{o}$ for irrational $r$. For rational $r$ we find:

Theorem 1.4 (Theorem 4.12). Let $r=p / q \in \mathbb{Q}_{\geq 2}$. The following are equivalent:
(i) $E_{r}^{c}$ and $E_{r}^{\mathrm{o}}$ are asymptotically equivalent.
(ii) If $a_{n} / b_{n} \rightarrow p / q$ from below, then $E_{a_{n} / b_{n}} \rightarrow E_{p / q}$.

Graphs $G$ and $H$ are called equivalent if $G \leq H$ and $H \leq G$. Equivalent graphs are asymptotically equivalent (but asymptotically equivalent graphs may not be equivalent). As a step towards understanding $E_{r}^{\mathrm{c}}$ and $E_{r}^{\mathrm{o}}$ better, we prove that they are not equivalent:

Theorem 1.5 (Theorem 5.8). Let $r \in \mathbb{R}_{>2}$. Then $E_{r}^{c}$ and $E_{r}^{o}$ are not equivalent.
The proof of this result is based on a complete characterization of the self-cohomomorphisms of the circle graphs $E_{r}^{c}$ and $E_{r}^{o}$ (Theorem 5.6), for which we use ideas from the theory of dynamical systems.

### 1.4 Independent sets from orbit constructions and reductions

Having delved into asymptotic spectrum distance and how to construct converging sequences, we focus in this part on the construction of explicit independent sets, their structure and ways of transforming them between graphs (reductions).

Over time, several structured and concise constructions of independent sets in powers of graphs (say, odd cycles) have been found and investigated, starting with the famous independent set $\left\{t \cdot(1,2): t \in \mathbb{Z}_{5}\right\}$ in $C_{5}^{\boxtimes 2}$ [Sha56], and later [BMR ${ }^{+} 71$, GR21, PS19], among others. In the recent remarkable work by Google DeepMind [RPBN+ ${ }^{+}$24], a large language model (LLM) not only recovered the best-known lower bounds for the Shannon capacity of small odd cycles, but moreover did so in a concise manner (in the sense of Kolmogorov-complexity). ${ }^{7}$

We propose a simple, general framework in which essentially all best-known lower bounds on Shannon capacity of odd cycles fit-offering an explanation for the aforementioned structure and conciseness. This framework, which can be thought of as

[^3]a finite version of the graph limit approach, consists of (1) relating the target graph $G=C_{n}=E_{n / 2}$ to another fraction graph $H=E_{p / q}$ (and "intermediate" or "auxilary" graph), and then (2) constructing a large independent set in a power of $H$ using an "orbit" construction. The aforementioned constructions of Shannon [Sha56] and PolakSchrijver [PS19] are indeed of this form; other bounds (e.g., by Baumert, McEliece, Rodemich, Rumsey, Stanley and Taylor [ $\left.\mathrm{BMR}^{+} 71\right]$ ) can be recovered in this way. We discuss this in Section 6.1 (and in particular Table 1).

The framework described above is remarkably similar to the state-of-the-art methods used for constructing fast matrix multiplication algorithms. Indeed, the (asymptotically) fastest matrix multiplication algorithms are obtained by a reduction of the matrix multiplication tensor" to an "intermediate tensor" for which the relevant properties are easier to analyse [CW87, Blä13a, AFG15, CVZ21, Alm21, WXXZ23, WZ23].

In Section 6.2 we develop methods for reducing a target graph $G$ to an auxiliary graph and in particular introduce a new "nondeterministic rounding" technique. Using this technique applied to an orbit construction in (a power of) of a fraction graph close to the fifteen-cycle, we find a new Shannon capacity lower bound:
Theorem 1.6 (Theorem 6.2). $\Theta\left(C_{15}\right) \geq \alpha\left(C_{15}^{\boxtimes 4}\right)^{1 / 4} \geq 2842^{1 / 4} \approx 7.30139$.
Our bound improves the previous bound $\Theta\left(C_{15}\right) \geq 7.25584$ which was obtained by Codenotti, Gerace and Resta [CGR03] and independently by Polak and Schrijver (personal communication).

In Section 6.3 we investigate independent sets in products of fraction graphs further. We focus on describing, for fixed $k$, the function $p / q \mapsto \alpha\left(E_{p / q}^{\boxtimes k}\right)$, and more generally the multivariate version of this function, $\left(p_{1} / q_{1}, \ldots, p_{k} / q_{k}\right) \mapsto \alpha\left(E_{p_{1} / q_{1}} \boxtimes \cdots \boxtimes E_{p_{k} / q_{k}}\right)$. For $k=1$, a simple argument gives $\alpha\left(E_{p / q}\right)=\lfloor p / q\rfloor$. For $k=2$, Hales [Hal73] and Badalyan and Markosyan [BM13] proved

$$
\alpha\left(E_{p_{1} / q_{1}} \boxtimes E_{p_{2} / q_{2}}\right)=\min \left\{\left\lfloor\left\lfloor p_{1} / q_{1}\right\rfloor p_{2} / q_{2}\right\rfloor,\left\lfloor\left\lfloor p_{2} / q_{2}\right\rfloor p_{1} / q_{1}\right\rfloor\right\} .
$$

We give a simple proof of this result using orbits (Theorem 6.5). As our main result, we consider $k=3$ and determine $\alpha_{3}\left(p_{1} / q_{1}, p_{2} / q_{2}, p_{3} / q_{3}\right):=\alpha\left(E_{p_{1} / q_{1}} \boxtimes E_{p_{2} / q_{2}} \boxtimes E_{p_{3} / q_{3}}\right)$ for all $p_{i} / q_{i} \in[2,3]$. Since $\alpha_{3}$ is monotone in every coordinate, it suffices to determine the discontinuities to describe the function:

Theorem 1.7 (Theorem 6.9, Figure 4). The discontinuities of $\alpha_{3}$ restricted to the set $(\mathbb{Q} \cap[2,3])^{3}$ are, up to permutation, at

### 1.5 Asymptotic spectrum distance of tensors, matrix multiplication

Let us take a step back and note again that the theory of asymptotic spectrum distance applies much more broadly than just to graphs. Namely, it applies to any semiring with
a preorder for which the asymptotic spectrum duality holds; the exact conditions for this we discuss in Appendix A.

An interesting and much studied setting where asymptotic spectrum duality exists (and thus asymptotic spectrum distance) is the semiring of tensors (under direct sum and tensor product) with the "restriction preorder" (Appendix A). This was in fact the original application of asymptotic spectrum duality in the seminal work [Str87, Str88, Str91], motivated by the problem of constructing fast matrix multiplication algorithms.

Remarkably, recent works of Draisma, Blatter and Rupniewski [BDR22] and Briët, Christandl, Leigh, Shpilka and Zuiddam $\left[\mathrm{BCL}^{+} 24\right]$ show that (contrary to the graph setting) many asymptotic tensor parameters are discrete. In particular, it can be shown that over any finite field, with the asymptotic spectrum distance, any Cauchy sequence of tensors must be eventually constant, and thus the space of tensors with asymptotic spectrum distance is complete.

The discreteness in the tensor setting is in stark contrast to what we see in the graph setting of this paper: as we have discussed (Section 1.2), in the space of graphs with the asymptotic spectrum distance we can construct non-trivial converging sequences of graphs, and also non-converging Cauchy sequences. It is this surprisingly "continuous" behaviour of graphs that we aim to capitalize on in this work.

### 1.6 Paper overview

In Section 2 we review the basic notation and background around Shannon capacity, including asymptotic spectrum duality, and we prove the basic properties and characterizations of asymptotic spectrum distance. (This section deals only with finite graphs for simplicity. The straightforward extension to infinite graph we discuss in Section 4.2.) In Section 3 we use fraction graphs to construct non-trivial converging sequences. In Section 4 we work with infinite graphs and in particular with graphs on the circle in the real plane. We prove that they are limit points for certain sequences of fraction graphs. We prove a strong relation between convergence questions for fraction graphs and asymptotic equivalence of "open" and "closed" circle graphs. In Section 5 we study self-cohomomorphisms of fraction graphs and cicrcle graphs and use these to prove non-equivalence of the "open" and "closed" version of circle graphs. In Section 6 we discuss the structure and computation of independent sets in products of fraction graphs, and prove a new lower bound on the Shannon capacity of the fifteen-cycle. Section 7 is a discussion of future directions and problems.

## 2 Shannon capacity and asymptotic spectrum distance

The goal of this section is to define a distance function on graphs that is geared towards attacking the Shannon capacity problem-and indeed arises naturally from it-and to discuss its basic properties.

We begin with a brief discussion of Shannon capacity and related basic notions. We then discuss asymptotic spectrum duality, which provides a dual description for the Shannon capacity. Asymptotic spectrum duality naturally leads to a distance on graphs, the asymptotic spectrum distance. Finally, we discuss a method for constructing pairs of graphs that have small distance in the asymptotic spectrum distance.

In this section we only work with finite graphs, for simplicity and since this suffices for Section 3. Most ideas, in particular asymptotic spectrum duality and distance, extend directly to infinite graphs. Later, in Section 4 and Section 5, we will indeed use infinite graphs, and we will discuss the needed material for infinite graphs there (Section 4.2). In fact, most material in this section holds much more generally, which we discuss in Appendix A (and see the general survey [WZ23]).

### 2.1 Shannon capacity and basic notions

Let $G$ and $H$ be (finite, simple) graphs. We denote by $G \boxtimes H$ the strong product of $G$ and $H .{ }^{8}$ We denote by $\alpha(G)$ the independence number of $G$ (which is defined as the size of the largest independent set in $G$ ) and by $\Theta(G)=\lim _{n \rightarrow \infty} \alpha\left(G^{\boxtimes n}\right)^{1 / n}$ the Shannon capacity of $G$ [Sha56]. It is known by Fekete's lemma that the limit exists and can be replaced by a supremum. Determining the Shannon capacity of a graph is a hard problem, even for small graphs. Various techniques are known to upper bound the Shannon capacity, including the (fractional) clique covering number [Sha56], (fractional) orthogonal rank (projective rank) [Pee96, HPRS17], Lovász theta function [Lov79], and (fractional) Haemers bound [Hae79, Bla13b, BC19].

We use the following basic terminology throughout the paper. We denote by $G \sqcup H$ the disjoint union of $G$ and $H$. We denote by $\bar{G}$ the complement graph of $G$. We denote the complete graph on $n$ vertices by $K_{n}$, and its complement by $E_{n}=\bar{K}_{n}$, so that $E_{n}$ is the graph with $n$ vertices and no edges. With the addition $\sqcup$ and multiplication $\boxtimes$ the set of (isomorphism classes of) graphs becomes a commutative semiring. In this semiring, the graphs $E_{0}$ and $E_{1}$ are the additive and multiplicative unit, respectively.

We say that a map $f: V(G) \rightarrow V(H)$ is a cohomomorphism $G \rightarrow H$ if for every distinct $u, v \in V(G)$ if $(u, v) \notin E(G)$, then $(f(u), f(v)) \notin E(H)$. We write $G \leq H$ if there is a cohomomorphism $G \rightarrow H$. We call $\leq$ the cohomomorphism preorder. Cohomomorphisms are precisely the maps that preserve independent sets, and in particular $G \leq H$ implies $\alpha(G) \leq \alpha(H)$. We say that $G$ and $H$ are equivalent if $G \leq H$ and $H \leq G$.

The independence number can be written in terms of cohomomorphisms and the graphs $E_{n}$ by $\alpha(G)=\max \left\{n \in \mathbb{N}: E_{n} \leq G\right\}$. The "opposite" graph parameter $\bar{\chi}(G)=\min \left\{n \in \mathbb{N}: G \leq E_{n}\right\}$ is known as the clique covering number, and equals the smallest number of cliques in the graph $G$ that are needed to cover all its vertices. ${ }^{9}$

### 2.2 Asymptotic spectrum duality

Understanding the Shannon capacity naturally asks for understanding how graphs behave when taking large powers (under the strong product $\boxtimes$ ). For this we will use ideas developed in the theory of asymptotic spectrum duality [Str88, Zui18, Zui19, Fri23, WZ23], which (for convenience of the reader) we will explain here in the setting of graphs, following [Zui19].

[^4]For any graphs $G, H$, we write $G \lesssim H$ if there is a function $f: \mathbb{N} \rightarrow \mathbb{N}$ with $f(n)=o(n)$ such that for all $n \in \mathbb{N}$ we have $G^{\boxtimes n} \leq H^{\boxtimes(n+f(n))}$. We call $\lesssim$ the asymptotic preorder. We say that $G$ and $H$ are asymptotically equivalent if $G \lesssim H$ and $H \lesssim G$. Note that in particular, Shannon capacity is monotone under $\lesssim$.

The asymptotic spectrum of graphs $\mathcal{X}$ is defined as the set of all maps $F$ from graphs to non-negative reals, such that for any graphs $G, H$ we have: $F(G \sqcup H)=F(G)+F(H)$ (additivity), $F(G \boxtimes H)=F(G) F(H)$ (multiplicativity), $F\left(E_{n}\right)=n$ for every $n \in \mathbb{N}$ (normalisation), and if $G \leq H$, then $F(G) \leq F(H)$ (monotonicity).

It is an open problem to fully determine $\mathcal{X}$. Known elements in $\mathcal{X}$ are the Lovász theta function $\vartheta$ [Lov79], the fractional Haemers bound (over different fields) [BC19], the fractional orthogonal rank (projective rank), and the fractional clique covering number $\bar{\chi}_{f}$ (see [Zui19]). Continuously many elements in $\mathcal{X}$ can be constructed using the interpolation method of Vrana [Vra21]. All of these are upper bounds on Shannon capacity, and it is not hard to prove that indeed every element of $\mathcal{X}$ is an upper bound on Shannon capacity.

The asymptotic spectrum duality theorem says, in particular, that the upper bounds in $\mathcal{X}$ are sufficiently strong to determine the Shannon capacity. In fact, it says that the functions in $\mathcal{X}$ are strong enough to completely characterize the asymptotic preorder $\lesssim$.

Theorem 2.1 (Asymptotic spectrum duality). Let $G, H$ be graphs.
(a) $\Theta(G)=\min _{F \in \mathcal{X}} F(G)$.
(b) $\bar{\chi}_{f}(G)=\max _{F \in \mathcal{X}} F(G)$.
(c) $G \lesssim H$ if and only if for every $F \in \mathcal{X}, F(G) \leq F(H)$.

Remark 2.2. The Shannon capacity $\Theta$ itself is not in $\mathcal{X}$, which follows from results of Haemers [Hae79] and Alon [Alo98]. Thus, in Theorem 2.1, the element $F$ minimizing $\min _{F \in \mathcal{X}} F(G)$ depends on $G$. On the other hand, the fractional clique covering number $\bar{\chi}_{f}$ is in $\mathcal{X}$, and it is the pointwise largest function in there. This is closely related to the nontrivial fact that $\bar{\chi}_{f}(G)=\lim _{n \rightarrow \infty} \bar{\chi}\left(G^{\boxtimes n}\right)^{1 / n}$ [Sch03, Theorem 67.17].

Remark 2.3. Theorem 2.1 characterizes $\Theta$ as a minimization, rather than an infimum. This is a consequence of compactness of $\mathcal{X}$, which intuitively follows from the fact that the defining conditions of $\mathcal{X}$ are closed conditions and the fact that for every graph $G$, the values that any $F \in X$ can take on $G$ are bounded (by $\alpha(G)$ and $\bar{\chi}(G)$, say). We discuss compactness further in Section 2.4.

### 2.3 Distance and convergence

The functions in the asymptotic spectrum $\mathcal{X}$ provide, in the precise sense of Theorem 2.1, all asymptotic information of a graph. They also naturally allow us to measure distance between graphs in a way that is appropriate in the context of Shannon capacity. We discuss this distance and basic properties.

Definition 2.4. For any graphs $G, H$, we define the asymptotic spectrum distance by

$$
d(G, H)=\sup _{F \in \mathcal{X}}|F(G)-F(H)| .
$$

Remark 2.5. The asymptotic spectrum distance is not quite a distance on graphs, because for distinct graphs $G, H$ we may have $d(G, H)=0$. However, if we let $\mathcal{G}$ denote the set of all graphs in which we identify graphs that are asymptotically equivalent (recall that $G, H$ are asymptotically equivalent if $G \lesssim H$ and $H \lesssim G$, Section 2.2), then the asymptotic spectrum distance is indeed a distance on $\mathcal{G}$ (this follows from Theorem 2.1) and the set $\mathcal{G}$ is a metric space.

Remark 2.6. The supremum in Definition 2.4 is in fact attained. This follows from compactness of $\mathcal{X}$, as we will discuss in Section 2.4.

Lemma 2.7. If a sequence of graphs $\left(G_{i}\right)_{i \in \mathbb{N}}$ converges to a graph $H$ in the asymptotic spectrum distance, then $\left(\Theta\left(G_{i}\right)\right)_{i \in \mathbb{N}}$ converges to $\Theta(H)$.

Proof. Let $\varepsilon>0$. There is an $N$ such that for every $i>N$ and every $F \in \mathcal{X}$ we have $\left|F\left(G_{i}\right)-F(H)\right|<\varepsilon$. Let $F_{G_{i}}, F_{H} \in \mathcal{X}$ such that $F_{G_{i}}\left(G_{i}\right)=\mathrm{Q}\left(G_{i}\right)$ and $F_{H}(H)=\underset{\sim}{\mathrm{Q}}(H)$ (Theorem 2.1). Then we have $\left.\mathrm{Q}(H)=F_{H}(H)>F_{H}\left(\widetilde{G_{i}}\right)-\varepsilon \geq \underset{\mathrm{Q}}{( } G_{i}\right)-\varepsilon$ and $\underset{\sim}{\mathrm{Q}}\left(G_{i}\right)=F_{G_{i}}\left(G_{i}\right)>F_{G_{i}}(H)-\varepsilon \geq \underset{\sim}{\mathrm{Q}}(H)-\varepsilon$. Thus $\left|\underset{\sim}{\mathrm{Q}}\left(G_{i}\right)-\underset{\sim}{\mathrm{Q}}(H)\right|<\widetilde{\varepsilon}$.
Lemma 2.8. Let $G, H$ be graphs and $a, b \in \mathbb{N}, b \geq 1$. The following are equivalent.
(i) $d(G, H) \leq a / b$
(ii) $E_{b} \boxtimes G \lesssim\left(E_{b} \boxtimes H\right) \sqcup E_{a}$ and $E_{b} \boxtimes H \lesssim\left(E_{b} \boxtimes G\right) \sqcup E_{a}$
(iii) $\left(E_{b} \boxtimes G\right)^{\boxtimes n} \leq\left(\left(E_{b} \boxtimes H\right) \sqcup E_{a}\right)^{\boxtimes(n+o(n))}$ and $\left(E_{b} \boxtimes H\right)^{\boxtimes n} \leq\left(\left(E_{b} \boxtimes G\right) \sqcup E_{a}\right)^{\boxtimes(n+o(n))}$

Proof. We give the proof (which is a simple application of Theorem 2.1) in a more general setting in Lemma A.4.

### 2.4 Graphs as continuous functions on a compact space

So far we have treated the asymptotic spectrum $\mathcal{X}$ simply as a set of functions on the semiring of graphs, and we made the semiring of (asymptotic equivalence classes of) graphs into a metric space using the distance induced by these functions. We will now take a different perspective that will allow us to apply ideas from analysis and that will in particular provide a natural (albeit abstract) embedding into a complete space.

In this different perspective we will turn $\mathcal{X}$ into a topological space and we will turn graphs into continuous functions on this space. This works as follows. We associate to every graph $G$ its evaluation function

$$
\widehat{G}: \mathcal{X} \rightarrow \mathbb{R}: F \mapsto F(G)
$$

We may think of $\widehat{G}$ as the (infinitely long) vector of evaluations of the elements in the asymptotic spectrum on $G .{ }^{10}$ The basic properties of these objects are:

Lemma 2.9. Let $G$ and $H$ be graphs.
(i) $\widehat{G \boxtimes H}=\widehat{G} \widehat{H}$
(ii) $\widehat{G \sqcup H}=\widehat{G}+\widehat{H}$

[^5](iii) $G \lesssim H$ if and only if $\widehat{G} \leq \widehat{H}$ pointwise
(iv) $\min \widehat{G}=\Theta(G)$
(v) $\max \widehat{G}=\bar{\chi}_{f}(G)$

Proof. These follow directly from Theorem 2.1 and the definition of $\mathcal{X}$.
We claim that $\mathcal{X}$ can be given a topology that is compact, Hausdorff and such that every function $\widehat{G}$ is continuous on $\mathcal{X}$. Indeed, we get this by giving $\mathcal{X}$ the topology generated by the functions $\widehat{G}$, that is, the coarsest (i.e., weakest) topology for which every $\widehat{G}$ is continuous. ${ }^{11}$ Then $\mathcal{X}$ is easily seen to be Hausdorff (but we will not use this). Importantly, it is compact:

Lemma 2.10. The set $\mathcal{X}$ is compact in the coarsest topology such that for every graph $G$ the function $\widehat{G}$ is continuous.

Proof. This is a "standard" fact [BS83, Str88, WZ23], but we give here a proof for the conve of the reader. Note that for every graph $G$, the set of values $\{F(G): F \in \mathcal{X}\}$ is a subset of $[0, \bar{\chi}(G)]$ where $\bar{\chi}$ denotes the clique covering number. We consider $\mathcal{X}$ as a subset of $\prod_{G \in \mathcal{G}} \mathbb{R}$ with inclusion map $i: F \mapsto(F(G))_{G \in \mathcal{G}}$. Endowing $\prod_{G \in \mathcal{G}} \mathbb{R}$ with the product topology, the map $i$ is continuous if and only if all evaluation functions $\widehat{G}$ are continuous [Mun00, Theorem 19.6]. The coarsest topology on $\mathcal{X}$ that makes $i$ continuous is by definition the subspace topology. For every graph $G$, the set of values $\{F(G): F \in \mathcal{X}\}$ is a subset of $[0, \bar{\chi}(G)]$, where $\bar{\chi}$ denotes the clique covering number. Thus $\mathcal{X}$ is a subset of $\prod_{G \in \mathcal{G}}[0, \bar{\chi}(G)]$. Since $\prod_{G \in \mathcal{G}}[0, \bar{\chi}(G)]$ is compact by Tychonoff's theorem [Mun00, Theorem 37.3], it is now sufficient to show that $\mathcal{X}$ is closed.

For every graph $H$, denote by $\pi_{H}: \prod_{G \in \mathcal{G}} \mathbb{R} \rightarrow \mathbb{R}$ the projection on the coordinate indexed by $H$. These are continuous by definition of the product topology and so is any polynomial combination of them. We can write $\mathcal{X}=Z_{\text {add }} \cap Z_{\text {mul }} \cap Z_{\text {norm }} \cap Z_{\text {mon }}$, where

$$
\begin{aligned}
& Z_{\mathrm{add}}=\bigcap_{G, H \in \mathcal{G}}\left(\pi_{G \sqcup H}-\left(\pi_{G}+\pi_{H}\right)\right)^{-1}(\{0\}), \\
& Z_{\mathrm{mul}}=\bigcap_{G, H \in \mathcal{G}}\left(\pi_{G \boxtimes H}-\pi_{G} \pi_{H}\right)^{-1}(\{0\}), \\
& Z_{\text {norm }}=\bigcap_{n \in \mathbb{N}} \pi_{E_{n}}^{-1}(\{n\}), Z_{\text {mon }}=\bigcap_{\substack{G, H \in \mathcal{G} \\
G \leq H}}\left(\pi_{H}-\pi_{G}\right)^{-1}([0, \infty))
\end{aligned}
$$

All sets are written as the intersections of pre-images of closed sets under continuous maps and are thus closed. We conclude that $\mathcal{X}$ is closed.

Remark 2.11. Since the image of a compact space under a continuous map is compact, we see that $\{F(G): F \in \mathcal{X}\}=\widehat{G}(\mathcal{X})$ is a compact subset of the reals, that is, closed and bounded. In particular, infimum and supremum over this set are attained (cf. Theorem 2.1 (ii) and (iii), and Lemma 2.9 (iv) and (v)).

Denote by $C(\mathcal{X})$ the set of continuous functions $\mathcal{X} \rightarrow \mathbb{R}$. Equip $C(\mathcal{X})$ with the supremum-norm, which is given by $\|f\|_{\infty}=\sup _{F \in \mathcal{X}}|f(F)|$ for $f \in C(\mathcal{X})$. The distance of any $f, g \in C(\mathcal{X})$ is given by $\|f-g\|_{\infty}$. Then $C(\mathcal{X})$ is complete [Rud76, Theorem 7.15].

[^6]The set of continuous functions $C(\mathcal{X})$ is a semiring (and in fact ring) under pointwise addition and pointwise multiplication. The map $G \mapsto \widehat{G}$ is a semiring homomorphism from the semiring of graphs to $C(\mathcal{X})$.
Lemma 2.12. For any graphs $G, H$, we have $d(G, H)=\|\widehat{G}-\widehat{H}\|_{\infty}$.
Proof. $\|\widehat{G}-\widehat{H}\|_{\infty}=\sup _{F \in \mathcal{X}}|\widehat{G}(F)-\widehat{H}(F)|=\sup _{F \in \mathcal{X}}|F(G)-F(H)|=d(G, H)$.
Through the above construction, graphs correspond to elements of $C(\mathcal{X})$. Since $C(\mathcal{X})$ is complete, any Cauchy sequence of graphs will indeed have a limit point in $C(\mathcal{X})$, but as we will see (Corollary 3.16), this limit point may not correspond to a graph! (This answers a question from [Pol19a, Section 9.3].)

To finish this part, we mention that the continuous function point of view naturally lets us use Dini's theorem from analysis to prove the following sufficient condition for convergence of graphs.

Lemma 2.13. Let $\left(G_{i}\right)_{i \in \mathbb{N}}$ be a sequence of graphs and let $H$ be a graph. If for every $F \in \mathcal{X}$ we have that $\left(F\left(G_{i}\right)\right)_{i \in \mathbb{N}}$ is monotone in $i \in \mathbb{N}$ and converges to $F(H)$, then $G_{i}$ converges to $H$.

Proof. The sequence of continuous functions $\widehat{G}_{i} \in C(\mathcal{X})$ converges pointwise to the continuous function $\widehat{H} \in C(\mathcal{X})$. Moreover, $\widehat{G}_{i}(F)$ is monotone in $i$ for every $F \in \mathcal{X}$. Thus $\widehat{G}_{i}$ converges uniformly to $\widehat{H}$ by Dini's theorem [Rud76, Theorem 7.13].

### 2.5 Distance of induced subgraphs of vertex-transitive graphs

We give a general method for constructing pairs of graphs that are close in the asymptotic spectrum metric (which we defined in Section 2.3). This method makes use of induced subgraphs of vertex-transitive graphs.

Let $G$ be a graph, let $S \subseteq V(G)$, and let $G[S]$ denote the induced subgraph of $G$ to $S$. Then we have the inequality $G[S] \leq G$ in the cohomomorphism preorder. In this section we will quantify how close $G[S]$ is to $G$.

As a starting point, we state a basic relation between the independence numbers $\alpha(G[S])$ and $\alpha(G)$, which follows from the well-known No-Homomorphism Lemma of Albertson and Collins [AC85, Theorem 2] (see also [HN04, Corollary 1.23]).

Lemma 2.14. Let $G$ be a vertex-transitive graph and $S \subseteq V(G)$. Then

$$
\alpha(G[S]) \leq \alpha(G) \leq \frac{|V(G)|}{|S|} \alpha(G[S])
$$

We will now extend Lemma 2.14 to elements in the asymptotic spectrum $\mathcal{X}$, that is, we will replace the independence number $\alpha$ by any function $F \in \mathcal{X} .{ }^{12}$ The proof is based on an inequality for vertex-transitive graphs $G$ of [Vra21], which says $G \leq E_{N} \boxtimes G[S]$ for $N=\left\lceil|V(G)||S|^{-1} \ln |V(G)|\right\rceil$. (Recall that $E_{N}=\bar{K}_{N}$ denotes the graph with $N$ vertices and no edges.)

Lemma 2.15. Let $G$ be a vertex-transitive graph and $S \subseteq V(G)$. Let $F \in \mathcal{X}$. Then

$$
F(G[S]) \leq F(G) \leq \frac{|V(G)|}{|S|} F(G[S])
$$

[^7]Proof. The first inequality follows directly from $F$ being monotone under cohomomorphism. For any vertex-transitive graph $G$ and $S \subseteq V(G)$ we have $G \leq E_{N} \boxtimes G[S]$ for $N=\left\lceil|V(G)||S|^{-1} \ln |V(G)|\right\rceil$. Let $m \in \mathbb{N}$. Then $G[S]^{\boxtimes m}$ is an induced subgraph of $G^{\boxtimes m}$. Note that $G^{\boxtimes m}$ is vertex-transitive. Then $G^{\boxtimes m} \leq E_{N_{m}} \boxtimes G[S]^{\boxtimes m}$ with $N_{m}=\left\lceil|V(G)|^{m}|S|^{-m} m \ln |V(G)|\right\rceil$. Apply $F$ to both sides of the inequality, take the $m$-th root on both sides, and let $m$ go to infinity to get the claim.

Finally, we mention that, from either of Lemma 2.14 or Lemma 2.15 follows the analogous inequality for the Shannon capacity: ${ }^{13}$ Let $G$ be a vertex-transitive graph and $S \subseteq V(G)$. Then $\Theta(G[S]) \leq \Theta(G) \leq|V(G)| \cdot|S|^{-1} \cdot \Theta(G[S])$. Indeed, this follows from Lemma 2.14 applied to powers of $G$. Alternatively, there is an $F \in \mathcal{X}$ such that $\Theta(G[S])=F(G[S])$ by Theorem 2.1, and then applying Lemma 2.15 gives the result. For ease of reference, we combine the results of this section into the following lemma.

Lemma 2.16. Let $G$ be a vertex-transitive graph and $S \subseteq V(G)$. Let $F \in \mathcal{X} \cup\{\alpha, \Theta\}$. Then

$$
F(G[S]) \leq F(G) \leq \frac{|V(G)|}{|S|} F(G[S])
$$

Lemma 2.15 lets us construct graphs $G$ and $G[S]$ that are close to each other in the asymptotic spectrum distance, as long as we have a handle on the ratio $|V(G)| /|S|$. The next goal will be to obtain Cauchy sequences using this method. For this we need to do more, as we will discuss in the next sections.

## 3 Converging sequences of finite graphs

In Section 2 we have defined the asymptotic spectrum distance on graphs, and discussed its basic properties, including characterizations of convergence and the motivating connection to the Shannon capacity. A central question is how to construct (non-trivial) converging sequences, or even just Cauchy sequences.

In this section we will give several kinds of constructions of non-trivial converging sequences of graphs. For this we will use a natural family of vertex-transitive graphs which we call fraction graphs (and which are also called circular graphs).

First we will discuss the definition and basic properties of fraction graphs. An important component is a vertex removal strategy for constructing fraction graphs that are close in the asymptotic spectrum distance.

Next we use the vertex removal strategy to construct non-trivial converging sequences of graphs. In particular, for any fraction graph we construct a non-trivial sequence of fraction graphs that converges to it. As a consequence of these constructions, we obtain a right-continuity property of all elements in the asymptotic spectrum (e.g., the Lovász theta function) on fraction graphs.

Finally, we construct Cauchy sequences of fraction graphs that have no limit in the set of finite graphs. Thus the set of finite graphs is not complete in the asymptotic spectrum distance. In Section 4 we will study infinite graphs on the circle as the missing limit points.

### 3.1 Fraction graph definition and basic properties

Fraction graphs have been studied since the work of Vince [Vin88], who used them to study variations on the chromatic number. These graphs have been studied under many names, including circular graphs [Pol19a, PS19], cycle-powers [BM13], and (the complement of) rational complete graphs [HN04] and circular complete graphs [Zhu06].

Definition 3.1. For any $p, q \in \mathbb{N}$ with $p / q \geq 2$ we let $E_{p / q}$ be the graph with vertex set $V=\{0, \ldots, p-1\}$ and with distinct $u, v \in V$ forming an edge if $u-v(\bmod p)<q$ or $v-u(\bmod p)<q$, that is, if their distance modulo $p$ is strictly less than $q$. The graphs $E_{p / q}$ we call fraction graphs. It will sometimes be convenient to allow also $p, q \in \mathbb{N}$ with $p / q<2$, in which case we will use the (natural) convention that $E_{p / q}$ is the complete graph on $p$ vertices. Also, it will sometimes be convenient to identify the vertex set $V=\{0, \ldots, p-1\}$ with $\mathbb{Z}_{p}=\mathbb{Z} / p \mathbb{Z}$, the integers modulo $p .^{14}$

For example, $E_{n / 1}=E_{n}$ and $E_{n / 2}=C_{n}$, where $E_{n}=\bar{K}_{n}$ denotes the "empty graph" on $n$ vertices and $C_{n}$ denotes the cycle-graph on $n$ vertices. For illustration, we draw the fraction graphs $E_{3 / 1}, E_{5 / 2}$ and $E_{8 / 3}$ in Figure 2.


Figure 2: From left to right, these are the fraction graphs $E_{3 / 1}, E_{5 / 2}$ and $E_{8 / 3}$.
A fundamental property of the fraction graphs is that they are ordered under cohomomorphism as the rational numbers.

Lemma 3.2 ([HN04, Theorem 6.3]). For $p, q, p^{\prime}, q^{\prime} \in \mathbb{N}$ with $p / q, p^{\prime} / q^{\prime} \geq 2$, we have $p / q \leq p^{\prime} / q^{\prime}$ if and only if $E_{p / q} \leq E_{p^{\prime} / q^{\prime}}$.

In fact, a cohomomorphism $E_{p / q} \rightarrow E_{p^{\prime} / q^{\prime}}$ is simply $x \mapsto\left\lfloor x p^{\prime} / p\right\rfloor$ (assuming that $\left.p / q \leq p^{\prime} / q^{\prime}\right)$.

In particular, it follows from Lemma 3.2 that if $p / q=p^{\prime} / q^{\prime}$, then $E_{p / q}$ and $E_{p^{\prime} / q^{\prime}}$ are equivalent under cohomomorphism, that is, $E_{p / q} \geq E_{p^{\prime} / q^{\prime}}$ and $E_{p / q} \leq E_{p^{\prime} / q^{\prime}}$. Also, we see that for any two inequivalent fraction graphs, there exists a fraction graph that is strictly in between them in the cohomomorphism order, making the fraction graphs a natural family for constructing interesting converging sequences of graphs.

The "label" of a fraction graph can be computed using the fractional clique covering number $\bar{\chi}_{f}$.
Lemma 3.3 ([HN04, Cor. 6.20, 6.24]). For $p, q \in \mathbb{N}, p / q \geq 2$, we have $\bar{\chi}_{f}\left(E_{p / q}\right)=p / q$.
Since $\bar{\chi}_{f}$ is an element of the asymptotic spectrum $\mathcal{X}$, it follows from Lemma 3.3 that in fact $E_{p / q} \leq E_{p^{\prime} / q^{\prime}}$ if and only if $E_{p / q} \lesssim E_{p^{\prime} / q^{\prime}}$, that is, cohomomorphism and asymptotic cohomomorphism coincide on fraction graphs.

[^9]Remark 3.4. We warn the reader that, while the fraction graphs are ordered (under cohomomorphism) as the rational numbers (Lemma 3.2), in many other ways they do not behave as the rational numbers, in particular when it comes to how they behave under the strong product or the disjoint union (the arithmetic operations of our semiring). Indeed, it is not true in general that $E_{p / q} \boxtimes E_{s / t}$ is equivalent to $E_{(p s) /(q t)}$. For example, suppose $E_{5 / 2}^{\boxtimes 2}$ is equivalent to $E_{p / q}$, then $p / q=\bar{\chi}_{f}\left(E_{p / q}\right)=\bar{\chi}_{f}\left(E_{5 / 2}\right)^{2}=25 / 4 \geq 6$, so $E_{5 / 2}^{\boxtimes 2} \geq E_{6}$. However, this contradicts the well-known fact that $\alpha\left(E_{5 / 2}^{\boxtimes 2}\right)=5<6$, which follows, for instance, from $\vartheta\left(E_{5 / 2}^{\boxtimes 2}\right)=5$ [Lov79], where $\vartheta$ is the Lovász theta function.

An important property of the fraction graphs (which we will use many times in our constructions) is that removing any vertex results in a graph that is again equivalent to a fraction graph, and moreover, there is a simple formula to determine which fraction graph.

Lemma 3.5 ([HN04, Lemma 6.6]). Let $p, q \in \mathbb{N}$ be relatively prime and $p / q \geq 2$. Let $p^{\prime}$ and $q^{\prime}$ be the unique integers such that $0<p^{\prime}<p, 0<q^{\prime}<q$ and $p q^{\prime}-q p^{\prime}=1$. Then the graph obtained by removing any vertex from $E_{p / q}$ is equivalent to $E_{p^{\prime} / q^{\prime}}$.

For example, Lemma 3.5 says that the induced subgraph of $E_{8 / 3}$ obtained by removing any vertex is equivalent to $E_{5 / 2}$ (which we recall is $C_{5}$ ), since $8 \cdot 2-3 \cdot 5=1$.

We note that Lemma 3.5 generalizes considerably: every induced subgraph of a fraction graph is equivalent to a fraction graph [Zhu05, Theorem 3.1], [BJH02, Corollary 3.1], [Zhu06, Page 518]. ${ }^{15}$ A more general version of this will play a role later in the paper (Lemma 5.3).

We now use Lemma 2.16 and Lemma 3.5 to get our vertex removal strategy.
Theorem 3.6. Let $F \in \mathcal{X} \cup\{\alpha, \Theta\}$. Let $0<p^{\prime}<p$ and $0<q^{\prime}<q$ be integers such that $p / q, p^{\prime} / q^{\prime} \geq 2$ and $p q^{\prime}-q p^{\prime}=1$. Then

$$
F\left(E_{p^{\prime} / q^{\prime}}\right) \leq F\left(E_{p / q}\right) \leq \frac{p}{p-1} F\left(E_{p^{\prime} / q^{\prime}}\right)
$$

Proof. Let $G=E_{p / q}$. Let $S$ be $V\left(E_{p / q}\right)$ minus any vertex, so that $|V(G)|=p$ and $|S|=p-1$. The numbers $p, q, p^{\prime}, q^{\prime}$ are chosen such that $G[S]$ is equivalent to $E_{p^{\prime} / q^{\prime}}$ by Lemma 3.5. By Lemma 2.16 we have $F(G[S]) \leq F(G) \leq|V(G)| \cdot|S|^{-1} \cdot F(G[S])$, which gives the claim.

Theorem 3.6 lets us construct pairs of graphs with an upper bound on their asymptotic spectrum distance. For example, using $8 \cdot 2-3 \cdot 5=1$ as before, we can prove that $d\left(E_{8 / 3}, E_{5 / 2}\right) \leq \frac{5}{14}$. Indeed, for any $F \in \mathcal{X}$ we have that

$$
0 \leq F\left(E_{8 / 3}\right)-F\left(E_{5 / 2}\right) \leq \frac{8}{7} F\left(E_{5 / 2}\right)-F\left(E_{5 / 2}\right)=\frac{1}{7} F\left(E_{5 / 2}\right)
$$

by Theorem 3.6, and $F\left(E_{5 / 2}\right) \leq \bar{\chi}_{f}\left(E_{5 / 2}\right)=5 / 2$ by Theorem 2.1 and Lemma 3.3. Therefore we find that $d\left(E_{8 / 3}, E_{5 / 2}\right)=\sup _{F \in \mathcal{X}}\left|F\left(E_{8 / 3}\right)-F\left(E_{5 / 2}\right)\right| \leq \frac{1}{7} \cdot \frac{5}{2}=\frac{5}{14}$.

Our next goal is to not just construct pairs of graphs with an upper bound on their distance, but to construct an infinite sequence of graphs that converges, which we will do in the next section.

### 3.2 Convergence to any fraction graph from above

In this section we will use the vertex removal strategy of Section 3.1 to construct non-trivial converging sequences of fraction graphs. More precisely, for any fraction graph $E_{a / b}$ we will construct a non-trivial sequence of fraction graphs $E_{p_{n} / q_{n}}$ converging to $E_{a / b}$. The convergence will be "from above" in the sense that the numbers $p_{n} / q_{n}$ will satisfy $a / b \leq p_{n} / q_{n}$ and will be decreasing in $n$, and thus $E_{p_{n} / q_{n}}$ approaches $E_{a / b}$ from above in the cohomomorphism order. It will naturally follow that for any sequence $p_{n} / q_{n}$ converging to $a / b$ from above, we have that $E_{p_{n} / q_{n}}$ converges to $E_{a / b}$.

In terms of the asymptotic spectrum $\mathcal{X}$, our result says that for any $F \in \mathcal{X}$ (and in fact for any $F \in \mathcal{X} \cup\{\alpha, \Theta\})$, the function $\mathbb{Q} \geq 2 \rightarrow \mathbb{R}: p / q \mapsto F\left(E_{p / q}\right)$ is right-continuous. So for instance, the Lovász theta function is right-continuous on fraction graphs.

Our result solves a problem of Schrijver and Polak [Pol19a, Chapter 9]. They constructed for every integer $m \in \mathbb{N}$ a sequence of fraction graphs $E_{p_{n} / q_{n}}$ that converges to $E_{m}$ from below, which implies that for any sequence $p_{n} / q_{n}$ converging to $m$ from below we have that $E_{p_{n} / q_{n}}$ converges to $E_{m}$. In terms of the asymptotic spectrum $\mathcal{X}$, their result says that for any $F \in \mathcal{X}$ the function $p / q \mapsto F\left(E_{p / q}\right)$ is left-continuous at every integer.

## Theorem 3.7.

(a) Let $F \in \mathcal{X} \cup\{\alpha, \Theta\}$. The function $\mathbb{Q}_{\geq 2} \rightarrow \mathbb{R}: p / q \mapsto F\left(E_{p / q}\right)$ is right-continuous.
(b) The right-continuity in (a) is uniform over all $F \in \mathcal{X}$ in the following sense. For any $\varepsilon>0$, there is a $\delta>0$, such that for all $p^{\prime} / q^{\prime} \leq p / q \in \mathbb{Q} \geq 2$ if $p / q-p^{\prime} / q^{\prime}<\delta$, then $F\left(E_{p / q}\right)-F\left(E_{p^{\prime} / q^{\prime}}\right)<\varepsilon$ for every $F \in \mathcal{X}$.
(c) If $p_{n} / q_{n}$ converges to $a / b$ from above, then $E_{p_{n} / q_{n}}$ converges to $E_{a / b}$.

Proof. (a) Choose a fixed coprime pair $p^{\prime}, q^{\prime}$, we will show that $F$ is right-continuous at $p^{\prime} / q^{\prime}$. The function $p / q \rightarrow F\left(E_{p / q}\right)$ is monotone and thus it is enough to find an explicit sequence $\left(p_{n} / q_{n}\right)_{n \geq 1}$ approaching $p^{\prime} / q^{\prime}$ from above for which $F\left(E_{p_{n} / q_{n}}\right)$ converges to $F\left(E_{p^{\prime} / q^{\prime}}\right)$.

Because $p^{\prime}$ and $q^{\prime}$ are coprime, there exist positive integers $a, b$ such that $a q^{\prime}-b p^{\prime}=1$. Define the sequences $p_{n}=a+p^{\prime} \cdot n$ and $q_{n}=b+q^{\prime} \cdot n$. For every $n \geq 1$ we find that $0<p^{\prime}<p_{n}, 0<q^{\prime}<q_{n}$ and $p_{n} q^{\prime}-q_{n} p^{\prime}=1$, therefore we can apply Lemma 2.16 to obtain

$$
F\left(E_{p^{\prime} / q^{\prime}}\right) \leq F\left(E_{p_{n} / q_{n}}\right) \leq \frac{p_{n}}{p_{n}-1} F\left(E_{p^{\prime} / q^{\prime}}\right) .
$$

Since $p_{n} /\left(p_{n}-1\right)$ converges to 1 when $n$ goes to infinity, we find that $F\left(E_{p_{n} / q_{n}}\right)$ converges to $F\left(E_{p^{\prime} / q^{\prime}}\right)$.
(b) The uniform right-continuity follows from applying Dini's theorem, Lemma 2.13. We give a direct proof for convenience. Let $\varepsilon>0$. Choose an $n$ such that $\frac{p^{\prime}}{p_{n}-1}<\varepsilon$. Now let $\delta=p_{n} / q_{n}-p^{\prime} / q^{\prime}$. If $0 \leq p / q-p^{\prime} / q^{\prime}<\delta$, then $p^{\prime} / q^{\prime} \leq p / q \leq p_{n} / q_{n}$, and thus $F\left(E_{p / q}\right)-F\left(E_{p^{\prime} / q^{\prime}}\right) \leq \frac{1}{p_{n}-1} F\left(E_{p^{\prime} / q^{\prime}}\right) \leq \frac{1}{p_{n}-1} \bar{\chi}\left(E_{p^{\prime} / q^{\prime}}\right)=\frac{p^{\prime}}{p_{n}-1}<\varepsilon$.
(c) This follows directly from (b).

Remark 3.8. A straightforward modification of the proof of Theorem 3.7 gives the following generalization: Let $F \in \mathcal{X} \cup\{\alpha, \Theta\}$. Let $G$ be any vertex-transitive graph. Then the function $\mathbb{Q} \geq 2 \rightarrow \mathbb{R}: p / q \mapsto F\left(E_{p / q} \boxtimes G\right)$ is right-continuous. For every choice of $G$ this right-continuity is uniform over all $F \in \mathcal{X}$.

Remark 3.9. Theorem 3.7 in particular implies that $p / q \mapsto F\left(E_{p / q}\right)$ is right-continuous at integral $p / q$, and accordingly that if $p_{n} / q_{n}$ converges from above to an integer $m$, then $E_{p_{n} / q_{n}}$ converges to $E_{m}$. This special case has a much simpler proof. Indeed, if $p_{n} / q_{n}$ converges to $m$ from above, then $\max _{F \in \mathcal{X}} F\left(E_{p_{n} / q_{n}}\right) \leq \bar{\chi}_{f}\left(E_{p_{n} / q_{n}}\right)=p_{n} / q_{n} \rightarrow m$. On the other hand, for every $F \in \mathcal{X}$ we have $F\left(E_{m}\right)=m$. Thus $d\left(E_{p_{n} / q_{n}}, E_{m}\right) \rightarrow 0$.

Remark 3.10. In the context of Theorem 3.7, we note that if $p_{n} / q_{n}$ is a strictly decreasing sequence converging to $a / b$, then $E_{p_{n} / q_{n}}$ will also be strictly decreasing in the cohomomorphism order, and in fact in the asymptotic cohomomorphism order, since the asymptotic clique covering number is strictly decreasing. However, we do not know whether every $F \in \mathcal{X}$ (or the Shannon capacity $\Theta$ ) is strictly decreasing on the $\left(E_{p_{n} / q_{n}}\right)_{n \in \mathbb{N}}$. By a result of Bohman and Holzman [BH03] (recently improved by Zhu [Zhu24]), we do know that if $a / b=2$, then there is a sequence $p_{n} / q_{n}$ converging to $a / b$ from above for which $\Theta\left(E_{p_{n} / q_{n}}\right)$ is strictly decreasing.
Remark 3.11. Theorem 3.7 leaves open whether $\mathbb{Q}_{\geq 2} \rightarrow \mathbb{R}: p / q \mapsto F\left(E_{p / q}\right)$ is leftcontinuous at the non-integer points of $\mathbb{Q} \geq 2$ (left-continuity at integer points being proven in [Pol19a, Chapter 9], as mentioned earlier). In other words, if $p_{n} / q_{n}$ converges to a non-integer $a / b$ from below, then we do not know whether $E_{p_{n} / q_{n}}$ converges to $E_{a / b}$ (and we even do not know convergence for concrete elements in the asymptotic spectrum like the Lovász theta function). This question is turns out ot be equivalent to a question about infinite graphs on the circle, which we will discuss in Section 4.

### 3.3 Intermezzo: Continued fraction expansion of irrational numbers

To prepare for our next construction of converging sequences of fraction graphs in Section 3.4, and for the convenience of the reader, we recall here basic facts about the continued fraction expansion of irrational numbers. We will use these facts again later in Section 5.

Given an irrational number $r$ define the sequence $\left(r_{n}\right)_{n \geq 0}$ recursively by $r_{0}=r$ and $r_{n+1}=\left(r_{n}-\left\lfloor r_{n}\right\rfloor\right)^{-1}$. The sequence $\left(a_{n}\right)_{n \geq 0}$ defined by $a_{n}=\left\lfloor r_{n}\right\rfloor$ describes the coefficients of the continued fraction expansion of $r$. The sequence of convergents $\left(p_{n} / q_{n}\right)_{n \geq 0}$ is defined by $\left(p_{0}, q_{0}\right)=\left(a_{0}, 1\right),\left(p_{1}, q_{1}\right)=\left(a_{0} a_{1}+1, a_{1}\right)$, and

$$
\left(p_{n}, q_{n}\right)=\left(a_{n} p_{n-1}+p_{n-2}, a_{n} q_{n-1}+q_{n-2}\right)
$$

for $n \geq 2$. We call $p_{n} / q_{n}$ the $n t h$-order convergent of $r$. We recall the following facts concerning convergents.

Lemma 3.12. Let $r \in \mathbb{R}$ be irrational and let $\left(p_{n} / q_{n}\right)_{n \geq 0}$ be its sequence of convergents.
(a) We have

$$
\lim _{n \rightarrow \infty} \frac{p_{n}}{q_{n}}=r
$$

(b) For all $n \geq 1$,

$$
q_{n} p_{n-1}-p_{n} q_{n-1}=(-1)^{n}
$$

(c) The even-order convergents form an increasing sequence, while the odd-order convergents form a decreasing sequence, that is,

$$
\frac{p_{0}}{q_{0}}<\frac{p_{2}}{q_{2}}<\frac{p_{4}}{q_{4}}<\cdots<r<\cdots<\frac{p_{5}}{q_{5}}<\frac{p_{3}}{q_{3}}<\frac{p_{1}}{q_{1}} .
$$

(d) The convergents are best possible approximations to $r$ in the following sense: for every $n \geq 0$ and integers $a, b$ with $|a| \leq\left|p_{n}\right|$,

$$
\left|r-\frac{p_{n}}{q_{n}}\right| \leq\left|r-\frac{a}{b}\right|
$$

Proof. Proofs for these statements can be found in any elementary text on continued fractions. For example, these four items are respectively proved in Section 5, Theorem 2, Theorem 4, and Theorem 17 of [Khi64].

Corollary 3.13. Let $r \in \mathbb{R}_{>1}$ be irrational and let $\left(p_{n} / q_{n}\right)_{n \geq 0}$ be its sequence of convergents. Then for all $n \geq 0$ we have $\left\lceil p_{2 n} / r\right\rceil=q_{2 n}$ and $\left\lfloor p_{2 n+1} / r\right\rfloor=q_{2 n+1}$.

Proof. Because $r>1$ we have that $p_{m}$ and $q_{m}$ are strictly positive for all $m$. Because $p_{2 n} / q_{2 n}$ is the best approximation to $r$ among fractions with equal or smaller numerator we see that $q_{2 n}$ is the unique positive integer $q$ for which $(q-1) \cdot p_{2 n}<r<q \cdot p_{2 n}$. This equation is satisfied for $q=\left\lceil p_{2 n} / r\right\rceil$ and thus $\left\lceil p_{2 n} / r\right\rceil=q_{2 n}$. The proof of the other equality goes analogously.

### 3.4 Cauchy sequences with no finite limit graph

In Section 3.2 we used the vertex-removal strategy to prove that if $p_{n} / q_{n}$ converges to $a / b$ from above, then $E_{p_{n} / q_{n}}$ converges to $E_{a / b}$. In this section we give another construction of interesting converging sequences, or rather of Cauchy sequences.

We will prove that if $p_{n} / q_{n}$ converges to any irrational number $r \in \mathbb{R}_{\geq 2}$ (without requiring this convergence to be "from above" or "from below"), then $E_{p_{n} / q_{n}}$ is a Cauchy sequence. For this result we will make use of similar ideas as in Section 3.2 and of the continued fraction expansion of $r$ (Section 3.3). It will follow from a simple argument (rationality of the fractional clique covering number of finite graphs) that this sequence cannot have a finite graph as a limit point. Thus we find that the set of finite graphs is not complete. In Section 4 we will discuss how the limit points of these Cauchy sequences of fraction graphs can be described by infinite graphs on the circle.

In terms of the asymptotic spectrum $\mathcal{X}$, our result says that for any element $F \in \mathcal{X}$ (and in fact any $F \in \mathcal{X} \cup\{\alpha, \Theta\}$ ), the map $p / q \mapsto F\left(E_{p / q}\right)$ has an extension to $\mathbb{R}_{\geq 2}$ that is continuous at every irrational number.

Theorem 3.14. Let $r \in \mathbb{R}_{\geq 2}$ be irrational.
(a) For every $F \in \mathcal{X} \cup\{\alpha, \Theta\}$,

$$
\begin{equation*}
\sup _{a / b<r} F\left(E_{a / b}\right)=\inf _{a / b>r} F\left(E_{a / b}\right) \tag{1}
\end{equation*}
$$

In particular, $\mathbb{Q}_{\geq 2} \rightarrow \mathbb{R}: p / q \mapsto F\left(E_{p / q}\right)$ has an extension $\tilde{F}$ to $\mathbb{R}_{\geq 2}$ that is continuous at every irrational number, namely by letting $\tilde{F}(r)=\sup _{a / b<r} F\left(E_{a / b}\right)$.
(b) The continuity in (a) is uniform over all $F \in \mathcal{X}$ in the following sense. Given any $\varepsilon>0$, there is a $\delta>0$ such that if $|r-p / q|<\delta$, then $\left|\sup _{a / b<r} F\left(E_{a / b}\right)-F\left(E_{p / q}\right)\right|<$ $\varepsilon$ for every $F \in \mathcal{X}$.
(c) If $a_{n} / b_{n}$ converges to $r$, then $E_{a_{n} / b_{n}}$ is Cauchy.

Proof. (a) Let $\left(p_{n} / q_{n}\right)_{n \geq 1}$ and $\left(p_{n}^{\prime} / q_{n}^{\prime}\right)_{n \geq 1}$ be the odd-order and even-order convergents of $r$ respectively. It follows from Lemma 3.12 that (i) $p_{n} / q_{n}$ and $p_{n}^{\prime} / q_{n}^{\prime}$ converge to $r$ from above and below, respectively, (ii) for all $n$ we have $p_{n} q_{n}^{\prime}-p_{n}^{\prime} q_{n}=1$, and (iii) $p_{n} \rightarrow \infty$ as $n \rightarrow \infty$. By Lemma 2.16 and the fact that $a / b \mapsto F\left(E_{a / b}\right)$ is nondecreasing we have

$$
F\left(E_{p_{n}^{\prime} / q_{n}^{\prime}}\right) \leq \sup _{a / b<r} F\left(E_{a / b}\right) \leq \inf _{a / b>r} F\left(E_{a / b}\right) \leq F\left(E_{p_{n} / q_{n}}\right) \leq \frac{p_{n}}{p_{n}-1} F\left(E_{p_{n}^{\prime} / q_{n}^{\prime}}\right)
$$

Thus both the left-hand side and the right-hand side of (1) are contained in an interval of length $\frac{1}{p_{n}-1} F\left(E_{p_{n}^{\prime} / q_{n}^{\prime}}\right)$ which is upper bounded by $\frac{1}{p_{n}-1} \bar{\chi}_{f}\left(E_{p_{n}^{\prime} / q_{n}^{\prime}}\right)<\frac{r}{p_{n}-1}$. This bound does not depend on $F$ and goes to 0 as $n$ goes to infinity. This proves Equation 1 and thus $\tilde{F}$ as defined in (a) is continuous at $r$.
(b) To prove uniform continuity, let $\varepsilon>0$. Choose an $n$ such that $\frac{r}{p_{n}-1}<\varepsilon$. Now take any $\delta>0$ such that

$$
\delta<\min \left\{p_{n} / q_{n}-r, r-p_{n}^{\prime} / q_{n}^{\prime}\right\}
$$

Then if $|r-x|<\delta$ we have $x \in\left[p_{n}^{\prime} / q_{n}^{\prime}, p_{n} / q_{n}\right]$ and thus $|\tilde{F}(r)-\tilde{F}(x)| \leq \frac{r}{p_{n}-1}<\varepsilon$.
(c) Let $a_{n} / b_{n}$ be a sequence of rational numbers converging to $r$. Then we have

$$
\begin{aligned}
d\left(E_{a_{n} / b_{n}}, E_{a_{m} / b_{m}}\right) & =\sup _{F \in \mathcal{X}}\left|F\left(E_{a_{n} / b_{n}}\right)-F\left(E_{a_{m} / b_{m}}\right)\right| \\
& \leq \sup _{F \in \mathcal{X}}\left|\tilde{F}\left(a_{n} / b_{n}\right)-\tilde{F}(r)\right|+\sup _{F \in \mathcal{X}}\left|\tilde{F}\left(a_{m} / b_{m}\right)-\tilde{F}(r)\right|
\end{aligned}
$$

where $\tilde{F}$ is defined as above. Since both summands converge to 0 we see that $E_{a_{n} / b_{n}}$ is indeed Cauchy.

Remark 3.15. Unlike for Theorem 3.7 (b), the uniform continuity of Theorem 3.14 (b) does not directly follow using Dini's theorem (Lemma 2.13). However, if we first extend the semiring of graphs to infinite graphs (as we will do in the next section), then there is such a natural proof.

As a consequence of Theorem 3.14 we find that the set of finite graphs with the asymptotic spectrum distance is not complete.

Corollary 3.16. There is a Cauchy sequence of fraction graphs $E_{a_{n} / b_{n}}$ that does not converge to any finite graph.

Proof. Let $r>2$ be an irrational number and let $a_{n} / b_{n}$ be a sequence of rational numbers converging to $r$. Then $E_{a_{n} / b_{n}}$ is a Cauchy sequence (Theorem 3.14 (c)). Note that the fractional clique covering number of $E_{a_{n} / b_{n}}$ is given by $\bar{\chi}_{f}\left(E_{a_{n} / b_{n}}\right)=a_{n} / b_{n}$. Thus any limit graph $G$ of the sequence $E_{a_{n} / b_{n}}$ should satisfy $\bar{\chi}_{f}(G)=r$. This contradicts the fact that $\bar{\chi}_{f}(G)$ is rational for any finite graph $G$.

## 4 Infinite graphs as limit points

In Section 3 we constructed Cauchy sequences of finite graphs in two ways: non-trivial converging sequences of fraction graphs to any fraction graph, and Cauchy sequences of fraction graphs with no finite graph as limit point. What are these limit points? In an abstract sense we know that we can describe them as elements of the space $C(\mathcal{X})$
of continuous functions on the asymptotic spectrum $\mathcal{X}$, since this space is complete (Section 2.3). In this section we will see how infinite graphs give a concrete model for these limit points.

The protagonists of this section are a family of infinite graphs on the circle, which we may think of as "infinite versions" of the fraction graphs of Section 3. These infinite graphs are labeled by real numbers $r \in \mathbb{R}_{\geq 2}$ instead of rational numbers $p / q \in \mathbb{Q} \geq 2$. We present two versions of these graphs: an "open" version and a "closed" version, depending on whether a strict or non-strict inequality is used in their definition (which we will state in a moment). Understanding this seemingly minor difference will turn out to play an important role in the theory (in this section, and in Section 5).

We will first define the two versions of circle graphs and prove their basic properties. Next, we prove that for any irrational number $r \in \mathbb{R}_{\geq 2}$, if $p_{n} / q_{n}$ converges to $r$, then the Cauchy sequence $E_{p_{n} / q_{n}}$ converges to a circle graph. Finally, we prove that the problem of convergence of fraction graphs "from below", or left-continuity of the asymptotic spectrum, is equivalent to the asymptotic equivalence of open and closed circle graphs.

In Section 5 we will study the circle graphs further to prove that the open and closed version are not equivalent under cohomomorphism, characterizing their selfcohomomorphisms in the process.

### 4.1 Circle graph definition and basic properties

Circle graphs are a natural family of infinite graphs. They have been studied in the context of circular colorings by Zhu [Zhu92] (implicitly) and Bauslaugh-Zhu [BZ98]. See also, e.g., [Koz08, Section 17.2.3]. They are related to Borsuk graphs [EH67, Lov78]. The definition and notation we use is as follows.

Definition 4.1. Let $C \subseteq \mathbb{R}^{2}$ denote a circle with unit circumference. Let $r \in \mathbb{R}_{\geq 2}$. Let $E_{r}^{o}$ be the infinite graph with vertex set $C$ for which two vertices are adjacent if and only if they have distance strictly less than $1 / r$ on $C$. Let $E_{r}^{c}$ be the infinite graph with vertex set $C$ for which two vertices are adjacent if and only if they have distance at most $1 / r$ on $C$.

For illustration, we draw in Figure 3 the neighbourhood of a vertex in the circle graphs $E_{3}^{\mathrm{o}}, E_{3}^{\mathrm{c}}$ and $E_{5 / 2}^{\mathrm{c}}$. The neighbourhood in $E_{3}^{\mathrm{o}}$ is open, while the neighbourhood in $E_{3}^{\mathrm{c}}$ and $E_{5 / 2}^{\mathrm{c}}$ is closed.


Figure 3: The neighbourhood of a vertex (in red) in the circle graphs $E_{3}^{\mathrm{o}}, E_{3}^{\mathrm{c}}$ and $E_{5 / 2}^{\mathrm{c}}$ (from left to right). We take the circles to have unit circumference.

It is not hard to see that, just like the fraction graphs, the graphs $E_{r}^{o}$ are cohomomor-phism-monotone with respect to $r$, and the same for the $E_{r}^{c}$. Moreover, for every fixed $r$ the closed version $E_{r}^{\mathrm{c}}$ is always at most the open version $E_{r}^{\mathrm{o}}$. Conversely, if $r<s$, then
the open version $E_{r}^{\mathrm{o}}$ is at most the closed version $E_{s}^{\mathrm{c}}$. We summarize these properties in the following lemma.

Lemma 4.2. If $r, s \in \mathbb{R}_{\geq 2}$ with $r<s$ we have $E_{r}^{c} \leq E_{r}^{o} \leq E_{s}^{c} \leq E_{s}^{o}$.
Proof. Each graph in this sequence of inequalities is a spanning subgraph of the previous graph and thus the identity map $f: C \rightarrow C$ is a cohomomorphism.

The next basic property, which we will use several times, is about finite induced subgraphs of the closed circle graphs. It is a priori clear that for any subset $S \subseteq V\left(E_{r}^{c}\right)$ we have $E_{r}^{\mathrm{c}}[S] \leq E_{r}^{\mathrm{c}}$. For finite $S$, the following lemma bounds $E_{r}^{\mathrm{c}}[S]$ further away from $E_{r}^{\mathrm{c}}$ by means of an open circle graph that is strictly below $E_{r}^{\mathrm{c}}$.

Lemma 4.3. Let $r \in \mathbb{R}_{\geq 2}$ and let $S \subseteq V\left(E_{r}^{c}\right)$ be finite. Then there is an $a / b<r$ such that $E_{r}^{\mathrm{c}}[S] \leq E_{a / b}^{\mathrm{o}}$.

Proof. There is an $s \in \mathbb{R}_{\geq 2}$ such that the smallest distance over all distinct and nonadjacent $\alpha, \beta \in S$ equals $1 / s$. Then $E_{r}^{\mathrm{c}}[S] \leq E_{s}^{\mathrm{o}}$. Since $s<r$, any $a / b$ such that $s<a / b<r$ satisfies the claim by Lemma 4.2.

We call two (possibly infinite) graphs $G$ and $H$ equivalent if $G \leq H$ and $H \leq G$.
Lemma 4.4. Let $p / q \in \mathbb{Q}_{\geq 2}$. Then $E_{p / q}^{\circ}$ and $E_{p / q}$ are equivalent.
Proof. To prove $E_{p / q} \leq E_{p / q}^{o}$, consider $C$ as $[0,1]$ where 0 and 1 are identified, and let $f:[p] \rightarrow C$ be defined by $v \mapsto v / p$. If $v, w \in[p]$ are not adjacent, then they have distance at least $q$ modulo $p$. Then $v / p$ and $w / p$ have distance at least $q / p$ on $C$. Thus $f$ is a cohomomorphism $E_{p / q} \rightarrow E_{p / q}^{\circ}$.

To prove $E_{p / q}^{o} \leq E_{p / q}$, let $f: C \rightarrow[p]$ be defined by $\alpha \mapsto\lfloor p \alpha\rfloor$. One verifies that if $\alpha$ and $\beta$ have distance at least $q / p$ on $C$, then $\lfloor p \alpha\rfloor$ and $\lfloor p \beta\rfloor$ have distance at least $q$ modulo $p$. Thus $f$ is a cohomomorphism $E_{p / q}^{\circ} \rightarrow E_{p / q}$.

We will see a generalization of Lemma 4.4 in Lemma 5.4.

### 4.2 Asymptotic spectrum distance of infinite graphs

In Section 2 we discussed asymptotic spectrum duality and distance for finite graphs. The theory extends naturally to infinite graphs, as was first noted by Fritz [Fri21]), and which we will need in this section. We discuss the extension to infinite graphs briefly here, and refer to the appendix for a more detailed discussion of the general theory of which finite and infinite graphs are a special case (Appendix A).

Let $\mathcal{G}_{\infty}$ be the set of all (possibly) infinite graphs with finite clique covering number. ${ }^{16}$ Strong product $\boxtimes$, Shannon capacity $\Theta$, disjoint union $\sqcup$, cohomomorphism $\rightarrow$, cohomomorphism preorder $\leq$, asymptotic preorder $\lesssim$, and asymptotic spectrum are defined for infinite graphs in the same way as for finite graphs. We will denote the asymptotic spectrum of infinite graphs by $\mathcal{X}_{\infty}$ and keep using $\mathcal{X}$ for the asymptotic spectrum of finite graphs. (This will allow us to compare the two, in a moment.) In $\mathcal{G}_{\infty}$ we identify any two graphs that are asymptotically equivalent.

The asymptotic spectrum duality for infinite graphs is as follows:

[^11]Theorem 4.5 (Asymptotic spectrum duality). Let $G, H \in \mathcal{G}_{\infty}$.
(a) $G \lesssim H$ if and only if for every $F \in \mathcal{X}_{\infty}, F(G) \leq F(H)$.
(b) $\Theta(G)=\min _{F \in \mathcal{X}}^{\infty}$ $F(G)$.
(c) $\mathcal{X}_{\infty}$ is compact in the topology induced by the evaluation maps $\widehat{G}: F \mapsto F(G)$.

Remark 4.6. Note that, unlike for finite graphs (Theorem 2.1), for infinite graphs we do not know whether $\max _{F \in \mathcal{X}_{\infty}} F(G)$ is an element of $\mathcal{X}_{\infty}$. One can prove, with general arguments (see Theorem A.1), that this maximization equals the asymptotic clique covering number $\lim _{n \rightarrow \infty} \bar{\chi}\left(G^{\boxtimes n}\right)^{1 / n}$.

The other theory we discussed for finite graphs remains true for infinite graphs as well. We define asymptotic spectrum distance on $\mathcal{G}_{\infty}$ by $d(G, H)=\sup _{F \in \mathcal{X}_{\infty}}|F(G)-F(H)|$, and the supremum is attained. We may equivalently think of elements of $\mathcal{G}_{\infty}$ as elements $\widehat{G}$ of $C\left(\mathcal{X}_{\infty}\right)$, real-valued continuous functions on $\mathcal{X}_{\infty}$, equipped with the sup-norm. Shannon capacity is continuous. And finally, Dini's theorem implies that if $\left(G_{n}\right)_{n \in \mathbb{N}}$ is a sequence in $\mathcal{G}_{\infty}$ and $H \in \mathcal{G}_{\infty}$, and if for every $F \in \mathcal{X}_{\infty}$ we have that $\left(F\left(G_{n}\right)\right)_{n \in \mathbb{N}}$ is monotone in $i \in \mathbb{N}$ and converges to $F(H)$, then $G_{n}$ converges to $H$. (See Appendix A.)

It is natural to ask how $\mathcal{X}$ and $\mathcal{X}_{\infty}$ are related. Indeed, there is a strong connection; to prove it we use the following basic lemma.

Lemma 4.7. For any two finite graphs $G, H$, we have $G \leq H$ in the cohomomorphism preorder on finite graphs if and only if $G \leq H$ in the cohomomorphism preorder on infinite graphs.

Proof. This follows directly from the definition of a cohomomorphism $G \rightarrow H$ (of graphs or infinite graphs) as a map from $V(G)$ to $V(H)$ that maps any pair of distinct non-adjacent vertices of $G$ to distinct non-adjacent vertices of $H$.

Thus, Lemma 4.7 says that the natural embedding from finite graphs to infinite graphs, $i: \mathcal{G} \rightarrow \mathcal{G}_{\infty}$ is, first of all, well-defined (under cohomomorphism equivalence), and second, is an order-embedding: for every $G, H \in \mathcal{G}$ we have $G \leq H$ if and only if $i(G) \leq i(H)$. In other words, infinite graphs do not introduce any new inequalities between finite graphs in the cohomomorphism preorder. This simple observation implies (as a special case of a general result, Theorem A.2) the following relation between the asymptotic spectra $\mathcal{X}$ and $\mathcal{X}_{\infty}$. We consider the restriction map $i^{*}: \mathcal{X}_{\infty} \rightarrow \mathcal{X}: F \mapsto F \circ i$, which simply restricts the domain of any element $F \in \mathcal{X}_{\infty}$ to finite graphs.

Theorem 4.8. The restriction map $i^{*}: \mathcal{X}_{\infty} \rightarrow \mathcal{X}$ is surjective.
Remark 4.9. In other words, Theorem 4.8 says that any element $F \in \mathcal{X}$ can be extended to an element in $\mathcal{X}_{\infty}$. So, for instance, the Lovász theta function (on finite graphs) can be extended to infinite graphs (perhaps in multiple ways) in such a way that it remains $\boxtimes$-multiplicative, $\sqcup$-additive, $\leq$-monotone and $E_{n}$-normalised.

Remark 4.10. As a consequence of Theorem 4.8, $\sup _{F \in \mathcal{X}_{\infty}}|F(G)-F(H)|$ and $\sup _{F \in \mathcal{X}}|F(G)-F(H)|$ coincide on any finite graphs $G, H$.

Theorem 4.8 will play an important role in several arguments that involve both infinite and finite graphs.

### 4.3 Circle graphs as limit points of fraction graphs

In Section 3.4 we proved that if $p_{n} / q_{n}$ converges to an irrational $r \in \mathbb{R}_{\geq 2}$, then $E_{p_{n} / q_{n}}$ is Cauchy. We noted that no finite graph can be the limit point of these Cauchy sequences (Corollary 3.16). We will prove here that the limit points are circle graphs.

Theorem 4.11. Let $r \in \mathbb{R}_{\geq 2}$ be irrational.
(a) For every $F \in \mathcal{X}_{\infty}$,

$$
F\left(E_{r}^{\mathrm{c}}\right)=F\left(E_{r}^{\mathrm{O}}\right)=\sup _{a / b<r} F\left(E_{a / b}\right)=\inf _{r<c / d} F\left(E_{c / d}\right)
$$

In particular, $E_{r}^{\mathrm{c}}$ and $E_{r}^{\mathrm{o}}$ are asymptotically equivalent.
(b) If $p_{n} / q_{n}$ converges to $r$, then $E_{p_{n} / q_{n}}$ converges to $E_{r}^{o}$.

Proof. For any $a / b, c / d \in \mathbb{Q}_{\geq 2}$ with $a / b<r<c / d$ we have

$$
\begin{equation*}
E_{a / b} \leq E_{r}^{\mathrm{c}} \leq E_{r}^{\mathrm{O}} \leq E_{c / d} \tag{2}
\end{equation*}
$$

From Theorem 3.14 we know that for every $F \in \mathcal{X}, \sup _{a / b<r} F\left(E_{a / b}\right)=\inf _{r<c / d} F\left(E_{c / d}\right)$. Thus applying any $F \in \mathcal{X}_{\infty}$ to Equation 2, and taking the supremum over $a / b<r$ and the infimum over $c / d<r$, gives $F\left(E_{r}^{\mathrm{c}}\right)=F\left(E_{r}^{\mathrm{o}}\right)$. Thus $E_{r}^{\mathrm{c}}$ and $E_{r}^{\mathrm{o}}$ are asymptotically equivalent.

### 4.4 Characterizing convergence to fraction graphs from below

In Section 3.2 we proved that if $p_{n} / q_{n}$ converges to $a / b$ from above, then $E_{p_{n} / q_{n}}$ converges to $E_{a / b}$. We left open whether the same is true if $p_{n} / q_{n}$ converges to $a / b$ from below. Here we will prove that this question is equivalent to the question whether the "closed" and "open" version of the circle graphs are asymptotically equivalent.

Theorem 4.12. Let $r=p / q \in \mathbb{Q} \geq 2$ be rational. The following are equivalent:
(i) $E_{r}^{c}$ and $E_{r}^{o}$ are asymptotically equivalent
(ii) There is a sequence $m_{n}=n+o(n)$ such that for every $n \in \mathbb{N}$ there is a rational number $a_{n} / b_{n}<p / q$ such that $E_{p / q}^{\boxtimes n} \leq E_{a_{n} / b_{n}}^{\boxtimes m_{n}}$
(iii) For every $\varepsilon>0$, there is a $\delta>0$, such that for any $a / b \in \mathbb{Q} \geq 2$, if $0<p / q-a / b<\delta$, then for every $F \in \mathcal{X}, F\left(E_{p / q}\right)-F\left(E_{a / b}\right)<\varepsilon$
(iv) If $a_{n} / b_{n} \rightarrow p / q$ from below, then $E_{a_{n} / b_{n}} \rightarrow E_{p / q}$
(v) For every $F \in \mathcal{X}, \sup _{a / b<p / q} F\left(E_{a / b}\right)=F\left(E_{p / q}\right)$

Proof. (i) $\Rightarrow$ (ii). Suppose $E_{r}^{c}$ and $E_{r}^{\mathrm{o}}$ are asymptotically equivalent. Then there is a sequence $m_{n}=n+o(n)$ such that $\left(E_{r}^{0}\right)^{\boxtimes n} \leq\left(E_{r}^{\mathrm{c}}\right)^{\boxtimes m_{n}}$. Then we have

$$
E_{p / q}^{\boxtimes n} \leq\left(E_{r}^{\mathrm{o}}\right)^{\boxtimes n} \leq\left(E_{r}^{\mathrm{c}}\right)^{\boxtimes m_{n}}
$$

Let $f$ be any cohomomorphism from $E_{p / q}^{\boxtimes n}$ to $\left(E_{r}^{c}\right)^{\boxtimes m_{n}}$. Then $f\left(E_{p / q}^{\boxtimes n}\right)$ is a finite subgraph of $\left(E_{r}^{c}\right)^{\boxtimes m_{n}}$, so by Lemma 4.3 (applied to every factor) there are some $a_{n} / b_{n}<r$ such that $E_{p / q}^{\boxtimes n} \leq E_{a_{n} / b_{n}}^{\boxtimes m_{n}}$.
(ii) $\Rightarrow$ (iii). Write $m_{n}$ as $m_{n}=n(1+f(n))$ with $f(n) \in o(1)$. Applying any $F \in \mathcal{X}$ and taking $n$th roots we find that

$$
F\left(E_{a_{n} / b_{n}}\right) \leq F\left(E_{p / q}\right) \leq F\left(E_{a_{n} / b_{n}}\right)^{1+f(n)}
$$

Letting $L_{n}=F\left(E_{a_{n} / b_{n}}\right)$ and $R_{n}=F\left(E_{a_{n} / b_{n}}\right)^{1+f(n)}$ we have

$$
\begin{aligned}
\left|L_{n}-R_{n}\right| & \leq F\left(E_{a_{n} / b_{n}}\right)^{1+f(n)}-F\left(E_{a_{n} / b_{n}}\right) \\
& =F\left(E_{a_{n} / b_{n}}\right)\left(F\left(E_{a_{n} / b_{n}}\right)^{f(n)}-1\right) \\
& \leq\left(a_{n} / b_{n}\right)\left(\left(a_{n} / b_{n}\right)^{f(n)}-1\right) \\
& \leq r\left(r^{f(n)}-1\right)
\end{aligned}
$$

Let $\varepsilon>0$. Let $n$ be large enough such that $r\left(r^{f(n)}-1\right)<\varepsilon$. Then if $a_{n} / b_{n}<a / b<r$, then for every $F \in \mathcal{X}, F\left(E_{p / q}\right)-F\left(E_{a / b}\right)<\varepsilon$.
(iii) $\Rightarrow$ (iv). These two statements are equivalent by definition.
(iv) $\Rightarrow(\mathrm{v})$. This is an immediate consequence.
$(\mathrm{v}) \Rightarrow(\mathrm{i})$. Suppose that $\sup _{a / b<r} F\left(E_{a / b}\right)=F\left(E_{p / q}\right)$. For any $a / b<r$ we have by Lemma 4.2 that

$$
E_{a / b}^{\mathrm{o}} \leq E_{r}^{\mathrm{c}} \leq E_{r}^{\mathrm{o}}
$$

Applying any $F \in \mathcal{X}_{\infty}$ and taking the supremum over $a / b<r$, we find

$$
F\left(E_{r}^{\mathrm{c}}\right)=F\left(E_{r}^{\mathrm{o}}\right)
$$

This implies by the duality theorem that $E_{r}^{c}$ and $E_{r}^{o}$ are asymptotically equivalent.
Remark 4.13. In particular, it follows from Theorem 4.12 and the left-continuity of every $F \in \mathcal{X}$ on fraction graphs $E_{p / q}$ for integral $p / q \geq 3$ [Pol19a], that for every integral $r \in \mathbb{Z}_{\geq 3}$ the graphs $E_{r}^{c}$ and $E_{r}^{o}$ are asymptotically equivalent.

Remark 4.14. Note that Theorem 4.12 in particular says that convergence of $F\left(E_{a / b}\right)$ to $F\left(E_{p / q}\right)$ for all $F \in \mathcal{X}$ when $a / b \rightarrow p / q$ from below, implies uniform convergence over all $F \in \mathcal{X}$. This should not come as a surprise as this is implied by Dini's theorem (Lemma 2.13).

It is natural to conjecture that the set of "open" circle graphs $\left\{E_{r}^{\circ}: r \in \mathbb{R}_{\geq 2}\right\}$ is the closure (and thus the completion) of the set of fraction graphs $\left\{E_{p / q}: p / q \in \mathbb{Q} \geq 2\right\}$. We cannot quite prove this, but we do know the following partial results from the previous sections.

- Theorem 3.7 implies that if $r_{i} \in \mathbb{R}_{\geq 2}$ converges to $p / q$ from above, then $E_{r_{i}}^{o}$ converges to $E_{p / q}$.
- Theorem 4.11 implies that if $r_{i} \in \mathbb{R}_{\geq 2}$ converges to an irrational number $r \in \mathbb{R}_{\geq 2}$, then $E_{r_{i}}^{\mathrm{o}}$ converges to $E_{r}^{\mathrm{o}}$ (which is asymptoticaly equivalent to $E_{r}^{\mathrm{c}}$ ).
- Theorem 4.12 implies that, assuming $E_{p / q}^{\mathrm{o}}$ and $E_{p / q}^{\mathrm{c}}$ are asymptotically equivalent, if $r_{i} \in \mathbb{R}_{\geq 2}$ converges to $p / q$ from below, then $E_{r_{i}}^{o}$ converges to $E_{p / q}$.

Combining these statements, we obtain the following implication.

Theorem 4.15. Suppose that for every $r \in \mathbb{Q}_{>2}$ the graphs $E_{r}^{c}$ and $E_{r}^{o}$ are asymptotically equivalent. Then $\left\{E_{r}^{\circ}: r \in \mathbb{R}_{\geq 2}\right\}$ is the closure of $\left\{E_{p / q}: p / q \in \mathbb{Q} \geq 2\right\}$.

Proof. Let $E_{r_{i}}^{o}$ be a converging sequence. Then in particular, letting $F \in \mathcal{X}_{\infty}$ be any extension of the fractional clique covering number, we have that $F\left(E_{r_{i}}^{\mathrm{o}}\right)=r_{i}$ converges. Let $r \in \mathbb{R}_{\geq 2}$ denote the limit. We claim that $E_{r_{i}}^{\circ}$ converges to $E_{r}^{o}$.

Suppose $r$ is irrational. Then the claim follows from Theorem 4.11. Suppose $r$ is rational. We may assume that the sequence $\left(r_{i}\right)_{i}$ is monotone. Suppose our sequence is converging from above. Then the claim follows from Theorem 3.7. Suppose our sequence is converging from below. Then the claim follows from Theorem 4.12.

## 5 Non-equivalence of open and closed circle graphs

In Section 4 we proved that for irrational $r$ the circle graphs $E_{r}^{\mathrm{o}}$ and $E_{r}^{\mathrm{c}}$ are asymptotically equivalent (Theorem 4.11). We also proved that for rational $r$ the circle graphs $E_{r}^{\mathrm{o}}$ and $E_{r}^{\mathrm{c}}$ are asymptotically equivalent if and only if the fraction graphs are "left-continuous" at $r$ (Theorem 4.12). Whether $E_{r}^{\mathrm{o}}$ and $E_{r}^{\mathrm{c}}$ are indeed asymptotically equivalent for irrational $r$ remains an open problem.

The above raises the natural question whether the open and closed circle graphs are equivalent. Equivalence, in particular, would imply asymptotic equivalence. We will prove that the circle graphs $E_{r}^{o}$ and $E_{r}^{c}$ are not equivalent for any $r$ (rational or irrational). Thus, any resolution of the asymptotic equivalence problem of rational open and closed circle graphs must be asymptotic in nature (or at least make use of powers of the graphs).

Our proof of non-equivalence relies on characterizing all cohomomorphisms $E_{r}^{c} \rightarrow E_{r}^{c}$ and $E_{r}^{\circ} \rightarrow E_{r}^{\circ}$. We prove that these self-cohomomorphisms are precisely rotations composed with reflections. Before we develop these ideas for the circle graphs, we first prove the analogous statement for the (finite) fraction graphs $E_{p / q}$, which we will then use as a proof ingredient to deal with the circle graphs.

### 5.1 Self-cohomomorphisms of fraction graphs

We call any cohomomorphism $G \rightarrow G$ a self-cohomomorphism. We will prove that for the fraction graphs, these are precisely rotations composed with reflections. We begin by showing that the self-cohomomorphisms of fraction graphs, for reduced fractions, are isomorphisms. (In the language of "cores" [HN04, Section 1.6], this says that the complement of a fraction graph, for reduced fractions, is a core.)

Lemma 5.1 ([BJH02, Lemma 2.5]). Let $p, q \in \mathbb{N}, p / q \geq 2$ such that $\operatorname{gcd}(p, q)=1$. Then any cohomomorphism from $E_{p / q}$ to itself is an isomorphism.

Proof. We give a brief proof for the convenience of the reader. This is obvious when $p / q=2$. Suppose $p / q>2$. Then there are (unique) integers $1 \leq p^{\prime} \leq p, 1 \leq q^{\prime} \leq q$ with $p^{\prime} / q^{\prime} \geq 2$ satisfying $p q^{\prime}-q p^{\prime}=1$. A cohomomorphism from $E_{p / q}$ to a proper induced subgraph would induce a cohomomorphism from $E_{p / q}$ to $E_{p^{\prime} / q^{\prime}}$ by Lemma 3.5 which is precluded by comparing $\bar{\chi}_{f}$ (Lemma 3.2, Lemma 3.3). Alternatively, the result can be proven using the No-Homomorphism Lemma; see [BJH02, Lemma 2.5].

Having Lemma 5.1, it remains to show that these isomorphisms are rotations composed with reflections.

Lemma 5.2. Let $p / q \in \mathbb{Q} \geq 2, q \geq 2$ such that $\operatorname{gcd}(p, q)=1$. Let $f: \mathbb{Z}_{p} \rightarrow \mathbb{Z}_{p}$ be a cohomomorphism from $E_{p / q}$ to itself. Then $f$ is an isomorphism of the form $f(x)=a-x$ or $f(x)=a+x$ for some $a \in \mathbb{Z}_{p}$.

Proof. By Lemma 5.1, $f$ is an isomorphism. The maximum cliques of $E_{p / q}$ are of the form $C_{x}=\{x, x+1, \ldots, x+(q-1)\}$ for $x \in \mathbb{Z}_{p}$ and thus there is a bijection $g: \mathbb{Z}_{p} \rightarrow \mathbb{Z}_{p}$ satisfying $f\left(C_{x}\right)=C_{g(x)}$ for all $x$. The map $g$ must be an automorphism of the auxiliary graph $H$ on vertex set $\mathbb{Z}_{p}$ connecting $x$ and $y$ if and only if the symmetric difference of $C_{x}$ and $C_{y}$ has size two. Observe that the fact that $q \geq 2$ implies that the graph $H$ is isomorphic to a $p$-cycle. It follows that $g(x+1)-g(x) \in\{ \pm 1\}$ for all $x$. Moreover, because $g$ is a bijection, $g(x+1)-g(x)$ must actually constantly be either 1 or -1 . In the first case $g(x)=g(0)+x$ for all $x$ and in the latter case $g(x)=g(0)-x$ for all $x$. These cases correspond to $f(x)=g(0)+x$ and $f(x)=g(0)+q-1-x$ respectively.

### 5.2 Self-cohomomorphisms of circle graphs

In this section we characterise the self-cohomomorphisms of irrational circle graphs. As an ingredient we use the following basic property about finite induced subgraphs of circle graphs.

Lemma 5.3. Let $r \in \mathbb{R}_{\geq 2}$. Every finite induced subgraph of either $E_{r}^{\mathrm{c}}$ or $E_{r}^{\mathrm{o}}$ is equivalent to a fraction graph.
Proof. In [BJH02, Theorem 3.1] it it shown that convex-round graphs are homomorphically equivalent to the complement of a fraction graph. A convex-round graph on $n$ vertices is a graph with vertex set $\mathbb{Z}_{n}$, where the neighborhood of any vertex is an interval, i.e. of the form $\left\{u, u+1, \ldots, u_{d_{v}-1}\right\}$. Every finite induced subgraph of either $E_{r}^{\mathrm{c}}$ or $E_{r}^{\mathrm{o}}$ is the complement of a convex-round graph and thus cohomomorphically equivalent to a fraction graph.

When the finite set of vertices that we induce to is equidistant on the circle $C$ (the vertex set of the circle graphs), we can say more. Namely, we can say precisely which fraction graph we are equivalent to, and the equivalence becomes an isomorphism. Moreover, we describe how the natural "rounding map" on a circle graph to finitely many equidistant points gives a cohomomorphism to a fraction graph.

Lemma 5.4. Let $r \in \mathbb{R}_{\geq 2}, N \in \mathbb{Z}_{\geq 2}$, and let $S$ be a set of $N$ equidistant points on $C$.
(a) The induced subgraphs $E_{r}^{\mathrm{o}}[S]$ and $E_{r}^{\mathrm{c}}[S]$ are isomorphic to $E_{N /\lceil N / r\rceil}$ and $E_{N /(\lfloor N / r\rfloor+1)}$, respectively.
(b) Identify $S$ with $\mathbb{Z}_{N}$ (in an order-preserving way) and define the map $f: C \rightarrow \mathbb{Z}_{N}$ by rounding any $x \in C$ to the clockwise next element of $S$. Then $f$ is a cohomomorphism from both $E_{r}^{\mathrm{o}}$ and $E_{r}^{\mathrm{c}}$ to $E_{N /\lfloor N / r\rfloor}$.
Proof. (a) Both $E_{r}^{\mathrm{o}}[S]$ and $E_{r}^{\mathrm{c}}[S]$ are vertex-transitive. Let $q_{\mathrm{o}}$ be the unique positive integer for which $\left(q_{\mathrm{o}}-1\right) / N<1 / r \leq q_{\mathrm{o}} / N$, that is, $q_{\mathrm{o}}=\lceil N / r\rceil$ and let $q_{\mathrm{c}}$ be the unique positive integer for which $\left(q_{\mathrm{c}}-1\right) / N \leq 1 / r<q_{\mathrm{c}} / N$, that is, $q_{\mathrm{c}}=\lfloor N / r\rfloor+1$. We will prove that $E_{r}^{\mathrm{o}}[S]$ is isomorphic to $E_{N / q_{o}}$. The fact that $E^{\mathrm{c}}[S]$ is isomorphic to $E_{N / q_{\mathrm{c}}}$ can be proved completely analogously.

Any vertex in $E_{r}^{\mathrm{o}}[S]$ is adjacent to its $q_{\mathrm{o}}-1$ nearest clockwise $C$-neighbors and $q_{\mathrm{o}}-1$ nearest anti-clockwise $C$-neighbors. If this describes all vertices in $S$ then $E_{r}^{\mathrm{o}}[S]$ is a
complete graph on $N$ vertices where $N \leq 2\left(q_{\mathrm{o}}-1\right)-1=2 q_{\mathrm{o}}-1$. In this case $N / q_{\mathrm{o}}<2$ and thus $E_{r}^{\circ}[S]$ is indeed isomorphic to $E_{N / q_{\mathrm{o}}}$ because by definition $E_{p / q}$ denotes a complete graph on $p$ vertices whenever $p / q<2$. Otherwise we observe that in both the clockwise and anti-clockwise direction any vertex in $E_{r}^{o}$ is adjacent to its $q_{o}-1$ nearest $C$-neighbors but not to its $q_{o}$ nearest $C$-neighbor, that is, $E_{r}^{\circ}[S]$ is isomorphic to $E_{N / q_{o}}$.
(b) Take distinct $x, y \in C$ and suppose that $f(x)$ is adjacent or equal to $f(y)$. We may assume that $f(y)=f(x)+m$ for some $0 \leq m<\lfloor N / r\rfloor$. Let $d_{x}$ and $d_{y}$ denote the distance from $x$ and $y$ to the nearest clockwise element of $S$ respectively. If $f(x)=f(y)$ we assume that $d_{x} \geq d_{y}$. The clockwise distance from $x$ to $y$ is

$$
m / N+d_{x}-d_{y}<(m+1) / N \leq\lfloor N / r\rfloor / N \leq 1 / r .
$$

Therefore, $x$ and $y$ are adjacent in both $E_{r}^{\mathrm{o}}$ and $E_{r}^{\mathrm{c}}$ and thus $f$ is indeed a cohomomorphism.

For context, recall that for $p / q \in \mathbb{Q} \geq 2$ the open circle graph $E_{p / q}^{0}$ and the fraction graph $E_{p / q}$ are equivalent (Lemma 4.4). We note that this is a special case of the above Lemma 5.4. Indeed, let $S$ be a set of $p$ equidistant points on $C$. By Lemma 5.4 (a) the induced subgraph $E_{p / q}^{\mathrm{o}}[S]$ is isomorphic to $E_{p / q}$ and thus $E_{p / q} \leq E_{p / q}^{\circ}$. Moreover, rounding to $S$, as described in Lemma 5.4 (b), is a cohomomorphism from $E_{p / q}^{o}$ to $E_{p / q}$.

Now we will work towards the characterization of self-cohomomorphisms of irrational circle graphs. We first show that these are continuous.

Lemma 5.5. Let $r \in \mathbb{R}_{\geq 2}$ be irrational and let $f$ be a cohomomorphism from either $E_{r}^{\circ}$ or $E_{r}^{\mathrm{c}}$ to itself. Then $f$ is continuous.

Proof. Let $\left(p_{n} / q_{n}\right)_{n \geq 0}$ be the sequence of convergents of the continued fraction representation of $r$. It follows from Corollary 3.13 and the fact that $r$ is irrational, that for every $n \geq 0$ we have

$$
\left\lceil p_{2 n} / r\right\rceil=\left\lfloor p_{2 n} / r\right\rfloor+1=q_{2 n} \quad \text { and } \quad\left\lfloor p_{2 n+1} / r\right\rfloor=q_{2 n+1} .
$$

We will show that $f$ is continuous at an arbitrary $x \in C$. Let $n \in \mathbb{Z}_{\geq 1}$ and let $S$ be the set of $p_{2 n}$ equidistant points on $C$ containing $x$. Label the elements of $S$ as $\left(x, s_{1}, \ldots, s_{p_{2 n}-1}\right)$ ordered (say clockwise) around $C$. By Lemma $5.4 S$ induces $E_{p_{2 n} / q_{2 n}}$ in both $E_{r}^{\mathrm{o}}$ and $E_{r}^{\mathrm{c}}$. In fact, because $r$ is irrational, there is some $\delta_{n}$ such that if $|x-y|<\delta_{n}$ then the set $S_{y}:=\left\{y, s_{1}, \ldots, s_{p_{2 n}-1}\right\}$ still induces $E_{p_{2 n} / q_{2 n}}$ (this also implies that the sequence $\left(y, s_{1}, \ldots, s_{p_{2 n}-1}\right)$ is still ordered around $C$ ).

It follows from Lemma 5.3 that $f\left(S_{y}\right)$ induces a graph equivalent to $E_{a / b}$ with $a / b \leq r$, where we may assume that $a / b$ is reduced. Because of this assumption $\overline{E_{a / b}}$ is a core (see Lemma 5.1) which implies $a \leq\left|f\left(S_{y}\right)\right| \leq p_{2 n}$. Because $f\left(S_{y}\right)$ is the image of a subgraph isomorphic to $E_{p_{2 n} / q_{2 n}}$ and $f$ is a cohomomorphism, it follows that $p_{2 n} / q_{2 n} \leq a / b$. It thus follows from Lemma 3.12 (d) that $p_{2 n} / q_{2 n}=a / b$. Therefore, by Lemma 5.1, $f\left(S_{y}\right)$ induces a graph isomorphic to $E_{p_{2 n} / q_{2 n}}$. Lemma 5.2 also states that any automorphism of $E_{p_{2 n} / q_{2 n}}$ must be a rotation possibly composed with a reflection and thus the points $\left(f(y), f\left(s_{1}\right), \ldots, f\left(s_{p_{2 n}-1}\right)\right)$ are still cyclically ordered (possibly anti-clockwise) around $C$.

We claim that the distance between any subsequent (on $C$ ) points in $f\left(S_{y}\right)$ is at most $1 / p_{2 n-1}$. Indeed, suppose that there is a pair of $C$-adjacent points whose distance is strictly more. Then there is a set $T$ of $p_{2 n-1}$ equidistant points such that there are
two points in $T$ for which the closed arc between the two points does not contain an element of $f\left(S_{y}\right)$. By rounding to $T$ as described in Lemma 5.4 (b) we obtain a nonsurjective cohomomorphism from $E_{p_{2 n} / q_{2 n}}$ to $E_{p_{2 n-1} / q_{2 n-1}}$. However, by Theorem 3.5 and Lemma 3.12 (b), we find that $E_{p_{2 n-1} / q_{2 n-1}}$ with a vertex removed is equivalent to $E_{p_{2(n-1)} / q_{2(n-1)}}$. This is a contradiction because $p_{2(n-1)} / q_{2(n-1)}<p_{2 n} / q_{2 n}$.

We can thus conclude that for all $y$ with $|x-y|<\delta_{n}$ the point $f(y)$ lies on the arc between $f\left(s_{1}\right)$ and $f\left(s_{p_{2 n}-1}\right)$ and has distance at most $1 / p_{2 n-1}$ from both endpoints. It follows that the arc described by the points at most distance $\delta_{n}$ from $x$ is mapped into an arc of length at most $1 / p_{2 n-1}$ by $f$. This proves that $f$ is continuous.

Theorem 5.6. Let $r \in \mathbb{R}_{\geq 2}$ irrational and let $f$ be a cohomomorphism from either $E_{r}^{o}$ or $E_{r}^{c}$ to itself. Then $f$ is a rotation possibly composed with a reflection.

Proof. From Lemma 5.5 we know that $f$ is continuous. By identifying $C$ with $\mathbb{R} / \mathbb{Z}$ the map $f$ can be lifted to a continuous map $g: \mathbb{R} \rightarrow \mathbb{R}$ under the canonical projection $\pi: \mathbb{R} \rightarrow C$, that is, $\pi \circ g=f \circ \pi$. The lift $g$ is unique up to an additive integer. There is an integer $d$, called the degree of $f$, such that $g(x+1)=g(x)+d$ for all $x$. (See, e.g., [HK03, Proposition 4.3.1] or [Mun00].) By possibly composing with a reflection we may assume that $d$ is nonnegative.

Because $f$ is a cohomomorphism we find that for every $(x, y) \in \mathbb{R} \times(1 / r, 1-1 / r)$ there is an integer $m_{x, y}$ such that $g(x+y)-g(x) \in\left[m_{x, y}+1 / r, m_{x, y}+1-1 / r\right]$. Because $\mathbb{R} \times(1 / r, 1-1 / r)$ is connected and $g$ is continuous, $m_{x, y}$ does not depend on $x$ or $y$, so we can write $m_{x, y}=m$. Furthermore, the inclusion extends to the boundary, that is, $g(x+y)-g(x) \in[m+1 / r, m+1-1 / r]$ for $y \in[1 / r, 1-1 / r]$. It follows that the value of the following integral must be contained in the interval $m+1 / r, m+1-1 / r]$ for all $y \in[1 / r, 1-1 / r]$,

$$
\int_{0}^{1} g(x+y)-g(x) d x=\int_{y}^{1} g(x) d x+\int_{0}^{y} g(x+1) d x-\int_{0}^{1} g(x) d x=d \cdot y
$$

using $g(x+1)=g(x)+d$. It follows that $m=0$ and $d=1$. Because $g(x+1 / r)-g(x) \geq$ $1 / r$ and integrates to exactly $1 / r$ on the interval $[0,1]$ we have that $g(x+1 / r)-g(x)=1 / r$ for all $x \in[0,1]$ and thus for all $x \in \mathbb{R}$. It follows that the function $h(x)=g(x)-x$ has period 1 and period $1 / r$. Because $1 / r$ is irrational, $h$ is constant and thus $g(x)=g(0)+x$. We conclude that $f$ is a rotation.

### 5.3 Non-equivalence of open and closed circle graphs

We will now prove the non-equivalence of open and closed circle graphs. We will first give the proof for the rational case, which is simpler, and then prove the irrational case using the self-cohomorphism characterization of Theorem 5.6.

Theorem 5.7. Let $p / q \in \mathbb{Q}_{\geq 2}$ be rational. Then $E_{p / q}^{c}$ and $E_{p / q}^{o}$ are not equivalent.
Proof. Suppose $E_{p / q}^{\mathrm{o}} \leq E_{p / q}^{\mathrm{c}}$. We know that $E_{p / q}$ is equivalent to $E_{p / q}^{\mathrm{o}}$. Thus there is a cohomomorphism $f: E_{p / q} \rightarrow E_{p / q}^{\mathrm{c}}$. The image of $f$ is a finite induced subgraph of $E_{p / q}^{c}$. Then by Lemma 4.3, there is an $a / b<p / q$ such that $E_{p / q} \leq E_{a / b}$. This is a contradiction.

Theorem 5.8. Let $r \in \mathbb{R}_{>2}$ be irrational. Then $E_{r}^{c}$ and $E_{r}^{o}$ are not equivalent.

Proof. Any supposed cohomomorphism from $E_{r}^{o}$ to $E_{r}^{c}$ is also a cohomomorphism from $E_{r}^{o}$ to itself because the identity is a cohomomorphism from $E_{r}^{c}$ to $E_{r}^{o}$. Therefore, by Theorem 5.6, $f$ is a rotation possibly composed with a reflection. However, such a map is distance preserving and in particular sends pairs of vertices with distance exactly $1 / r$ to pairs with distance exactly $1 / r$, which contradicts $f$ being a cohomomorphism from $E_{r}^{o}$ to $E_{r}^{\mathrm{c}}$.

Remark 5.9. Theorem 4.11 and Theorem 5.8 together give a family of examples of pairs of infinite graphs that are asymptotically equivalent but not equivalent (namely, the circle graphs $E_{r}^{o}$ and $E_{r}^{c}$ for irrational $r$ ). Such examples also exist for finite graphs. For instance, let $G=\left(C_{5} \sqcup C_{5}\right)+E_{5}$, where + is the join, so $G=\overline{\overline{C_{5} \sqcup C_{5}} \sqcup E_{5}}$. Then $\alpha(G)=\Theta(G)=\bar{\chi}_{f}(G)=5$ and $\bar{\chi}(G)=6$ [Ros67, Hal73]. Thus $G$ is asymptotically equivalent to $E_{5}$, but not equivalent to $E_{5} \cdot{ }^{17}$

## 6 Independent sets in products of fraction graphs

In the previous sections we developed-ultimately motivated by the Shannon capacity problem - a theory of convergence of graphs in the asymptotic spectrum distance.

In this section we return to the Shannon capacity problem, and use ideas from the previous sections (e.g., approximation by fraction graphs, and vertex removal, Lemma 3.5) to obtain explicit independent sets and new bounds.

First, we will give a brief overview of the best-known lower bounds on the Shannon capacity of small odd-cycle graphs, and observe that a simple, high-level framework encompasses all of these bounds. Then, in the context of this framework, we introduce a "nondeterministic rounding" technique, which we use to find a new lower bound on the Shannon capacity of the fifteen-cycle, $C_{15}$. Finally, we determine the independence number of products of fraction graphs, in several regimes.

### 6.1 Shannon capacity of odd cycles via orbits and reductions

We observe (and explicitly describe in Table 1) that the best-known lower bounds for the Shannon capacity of small odd cycle graphs can be obtained via a remarkably simple and uniform strategy (which may be thought of as a "finite" version of the graph limit approach). Namely, they can be obtained by (1) relating the target graph $G=C_{n}=E_{n / 2}$ to another fraction graph $H=E_{p / q}$ (which we may call an "intermediate" or "auxiliary" graph), and then (2) constructing a large independent set in a power of $H$ using an "orbit" construction. We explain this approach using three examples, with increasing complexity in the reduction step to the intermediate graph $H$.
(1) The simplest example is, famously, the five-cycle $G=C_{5}$. Here we simply take the intermediate graph to be $H=G$. The Shannon capacity $\Theta\left(C_{5}\right)=\sqrt{5}$ is attained by the independent set $\left\{t \cdot(1,2): t \in \mathbb{Z}_{5}\right\} \subseteq G^{\boxtimes 2}$ [Sha56, Lov79], which has a clear orbit structure (under the action of $\mathbb{Z}_{5}$ ).

[^12](2) A more involved example is for $G=C_{11}$. Here the best-known lower bound on the Shannon capacity $\Theta\left(C_{11}\right)$ can be obtained by taking $H=E_{148 / 27}$, which satisfies $H \leq G$ (since $148 / 27 \leq 11 / 2)$, and verifying that $\left\{t \cdot\left(1,11,11^{2}\right): t \in \mathbb{Z}_{148}\right\}$ is an independent set in $H^{\boxtimes 3}$ of size 148. Since $H \leq G$ implies $\alpha\left(H^{\boxtimes k}\right) \leq \alpha\left(G^{\boxtimes k}\right)$, we directly find $\Theta\left(C_{11}\right) \geq 148^{1 / 3} \approx 5.29$. This bound was obtained in [BMR ${ }^{+} 71$ ]; the construction given there, however, is different.
(3) Another type of reduction from $G$ to an intermediate $H$ is used for $G=C_{7}$ in [PS19] (and for a new bound that we obtain for $G=C_{15}$ in Section 6.2). Namely, here $H$ is taken to be $H=E_{382 / 108}$ which satisfies $G \leq H$ (since $15 / 2 \leq 382 / 108$ ). The set $\left\{t \cdot\left(1,7,7^{2}, 7^{3}, 7^{4}\right): t \in \mathbb{Z}_{382}\right\}$ can be verified to be an independent set in $H^{\boxtimes 5}$ of size 382 . Now $H$ sits above $G$, so $\alpha\left(G^{\boxtimes k}\right) \leq \alpha\left(H^{\boxtimes k}\right)$, which is the wrong direction for getting a lower bound on $\Theta(G)$. However, intuitively, since $H$ sits just above $G$, we may expect that the independent set in $H^{\boxtimes k}$ can be "mapped down" to $G^{\boxtimes k}$ with only a small loss in size. Indeed, using an ad hoc shifted rounding map and an integer programming optimization it is shown in [PS19] that this is the case, resulting in an independent set of size 367 in $G^{\boxtimes 5}$, and thus $\Theta\left(C_{7}\right) \geq 3.25$.

We will develop reduction type (3) (the " $G \leq H$ " type of reduction) further in Section 6.2 using vertex removal and a new "nondeterministic rounding" technique that we introduce. With this we obtain a new lower bound on the Shannon capacity of $C_{15}$.

In Table 1 we list the best-known lower bounds on the Shannon capacity of small odd cycles, how they arise from an orbit construction in a power of an intermediate graph $H$, and the relation between $G$ and $H$ (as one of three types: " $G=H$ ", " $H \leq G$ " or " $G \leq H$ "). We note that the constructions for $E_{11 / 2}$ and $E_{13 / 2}$ that we give in Table 1 do not appear in this form in the literature.

Independent sets of the form $\left\{t \cdot\left(g_{1}, g_{2}, \ldots, g_{k}\right): t \in \mathbb{Z}_{m}\right\}$ (or a more general form with more generators) have played an important role in many constructions of independent sets in the literature [Sha56, $\left.\mathrm{BMR}^{+} 71, \mathrm{PS} 19\right]$. A useful property of these is that verifying that they are an independent set can be done very efficiently, by verifying that $t \cdot\left(g_{1}, g_{2}, \ldots, g_{k}\right)$ is non-adjacent to $(0,0, \ldots, 0)$ for every $t \in \mathbb{Z}_{m}$. Orbit constructions are remarkably effective for finding independent sets. However, we do not know whether orbit constructions (or natural generalisations) are strong enough to achieve the Shannon capacity of odd cycles or fraction graphs in general. Calderbank, Frankl, Graham, Li and Shepp [CFG ${ }^{+} 93$ ] and Guruswami and Riazanov [GR21] have shown that orbits in complements of fraction graphs do not achieve Shannon capacity. We will use orbits again in Section 6.3 to obtain discontinuities of the independence number on products of fraction graphs.

The strategy of determining the Shannon capacity of a graph by reduction to an intermediate graph is reminiscent of the methods used for constructing fast matrix multiplication algorithms. Indeed, the (asymptotically) fastest matrix multiplication algorithms are obtained by a reduction of the "matrix multiplication tensor" to an "intermediate tensor" (e.g., the Coppersmith-Winograd tensors) for which the relevant properties (in this case the asymptotic tensor rank) are easier to analyse [CW87, Blä13a, AFG15, CVZ21, Alm21, WXXZ23, WZ23].

Table 1: Overview of the best-known lower bounds on the Shannon capacity of odd cycle graphs $G=C_{n}=E_{n / 2}$, and how they arise from orbits in the $k$ th power of an intermediate graph $H=E_{p / q}$ for some $k$. The "reduction" column describes the cohomomorphism relation between the intermediate graph $H$ and the target graph $G$. The reduction type " $G \leq H$ " requires special techniques, which we discuss in Section 6.2. The lower bound on $E_{15 / 2}$, which is new, is also discussed there. The constructions given here for $E_{11 / 2}$ and $E_{13 / 2}$ are different from previously published constructions, which were not obtained as orbits in powers of fraction graphs.

### 6.2 New lower bound on the Shannon capacity of the fifteen-cycle

In this section we prove a new lower bound on the Shannon capacity of the cycle graph on fifteen vertices, $C_{15}$.

## Independent set in the third power via vertex removal

We begin by reproving a known lower bound for the purpose of illustrating some of our methods. Mathew and Östergård [MOr17] proved that $\alpha\left(C_{15}^{\boxtimes 3}\right) \geq 381$. The following slightly better bound had previously been observed by Codenotti, Gerace and Resta [CGR03] and later independently by Polak and Schrijver (personal communication):

Theorem 6.1. $\alpha\left(C_{15}^{\boxtimes 3}\right) \geq 382$.
We give a short proof of Theorem 6.1 using an orbit construction in a product of fraction graphs and vertex removal (Lemma 3.5).

Proof. One can verify directly that the set

$$
S=\left\{t \cdot\left(1,75,75^{2}\right): t \in \mathbb{Z}_{383}\right\}
$$

is an independent set in $E_{383 / 51}^{\boxtimes 3}$ of size 383. The number 383 is prime and thus $(0,0,0)$ is the only vertex in $S$ containing 0 as an entry. Therefore $S \backslash\{(0,0,0)\}$ is an independent set of size 382 in $\left(E_{383 / 51}-\{0\}\right)^{\boxtimes 3}$. Since $383 \cdot 2-51 \cdot 15=1$, it follows from Lemma 3.5 that this graph is equivalent to $E_{15 / 2}^{\boxtimes 3}=C_{15}^{\boxtimes 3}$.

## Independent set in the fourth power via nondeterministic rounding

Theorem 6.1 gives $\Theta\left(C_{15}\right) \geq \alpha\left(C_{15}^{\boxtimes 3}\right)^{1 / 3} \geq 7.25584$. We will now improve this bound by constructing a large independent set in the fourth power. For this we will introduce a new nondeterministic rounding technique, which we will apply to an orbit construction in a product of fraction graphs.
Theorem 6.2. $\alpha\left(C_{15}^{\boxtimes 4}\right) \geq 2842$.
Theorem 6.2 gives $\Theta\left(C_{15}\right) \geq \alpha\left(C_{15}^{\boxtimes 4}\right)^{1 / 4} \geq 7.30139$. The best-known upper bound is $\Theta\left(C_{15}\right) \leq \vartheta\left(C_{15}\right)=7.4171482$, where $\vartheta$ is the Lovász theta function. We provide an explicit independent set in Appendix B.

The method we use to obtain Theorem 6.2 is inspired by the method used by Polak and Schrijver [PS19] to give a lower bound for $\alpha\left(C_{7}^{\boxtimes 5}\right)$. They considered the following independent set in the graph $E_{382 / 108}^{\boxtimes 5}$

$$
S=\left\{t \cdot\left(1,7,7^{2}, 7^{3}, 7^{4}\right): t \in \mathbb{Z}_{382}\right\}
$$

Because $382 / 108 \approx 3.537>7 / 2$ this does not immediately give an independent set in $C_{7}^{\boxtimes 5}$. However, roughly described, they use a rounded down image of $S$ into $C_{7}^{\boxtimes 5}$ as a starting point to optimize for an independent set of size 367 .

Our construction also starts with similarly shaped independent set $S$, that is, the orbit of a single generator in a product fraction graphs slightly above $C_{15}^{\boxtimes 4}$. Subsequently we use a different method of rounding down $S$ that is based on the following heuristic. Whenever $p / q \leq 15 / 2$, the map $x \mapsto\lfloor 15 x / p\rfloor$ is a cohomomorphism from $E_{p / q}$ to $E_{15 / 2}$. This is not the case when $p / q>15 / 2$ but heuristically the map is still close to a cohomomorphism whenever $p / q$ is close to $15 / 2$. Therefore we still use this map, however if a vertex is close to being mapped to a different element, that is, when $15 x / p$ is close to an integer, we add both choices to the image $S$. The following contains an exact description of our construction.

Proof of Theorem 6.2. We describe the construction here and give the explicit independent set in Appendix B. We start with the set

$$
S=\left\{t \cdot(1,15,1073,1125): t \in \mathbb{Z}_{2873}\right\}
$$

This is an independent set in $E_{2873 / 383} \boxtimes E_{2873 / 382} \boxtimes E_{2873 / 381} \boxtimes E_{2873 / 381}$ of size 2873. For any $x \in\{0,1, \ldots, 2872\}$ we let $r(x)=15 x / 2873$. For any $\varepsilon \in[0,1 / 2)$ we define the set $F_{\varepsilon}(x) \subseteq \mathbb{Z}_{15}$ by

$$
F_{\varepsilon}(x)= \begin{cases}\{\lfloor r(x)\rfloor,\lfloor r(x)\rfloor+1\} & \text { if } r(x)-\lfloor r(x)\rfloor>1-\varepsilon \\ \{\lfloor r(x)\rfloor,\lfloor r(x)\rfloor-1\} & \text { if } r(x)-\lfloor r(x)\rfloor<\varepsilon \\ \{\lfloor r(x)\rfloor\} & \text { otherwise. }\end{cases}
$$

For any tuple $\vec{\varepsilon}=\left(\varepsilon_{1}, \varepsilon_{2}, \varepsilon_{3}, \varepsilon_{4}\right)$, we define the set

$$
T_{\vec{\varepsilon}}=\bigcup_{\left(v_{1}, \ldots, v_{4}\right) \in S} F_{\varepsilon_{1}}\left(v_{1}\right) \times \cdots \times F_{\varepsilon_{4}}\left(v_{4}\right)
$$

Then $T_{\vec{\varepsilon}}$ is a subset of $V\left(C_{15}^{\boxtimes 4}\right)$. For small $\vec{\varepsilon}$ the set $T_{\vec{\varepsilon}}$ is sufficiently small for optimization software (in our case Gurobi [Gur23]) to quickly calculate close to optimal lower bounds for $\alpha\left(C_{15}^{\boxtimes 4}\left[T_{\vec{\varepsilon}}\right]\right)$. For $\vec{\varepsilon}=(0.12,0.22,0.32,0.32)$, we have $\left|T_{\vec{\varepsilon}}\right|=13718$, and we find $\alpha\left(C_{15}^{\boxtimes 4}\left[T_{\vec{\varepsilon}}\right]\right) \geq 2842$.

Remark 6.3. The lower bound $\alpha\left(C_{7}^{\boxtimes 5}\right) \geq 367$ of [PS19] can similarly be obtained using nondeterministic rounding (with $\varepsilon=0.125$ ) applied to the orbit independent set $S=\left\{t \cdot\left(1,7,7^{2}, 7^{3}, 7^{4}\right): t \in \mathbb{Z}_{382}\right\}$.

### 6.3 Characterization of discontinuities of the independence number

In this subsection we determine the independence number of products of fraction graphs in certain regimes. We will do this by determining where (and by how much) this value "jumps" (i.e., the discontinuity points) when we vary the fraction graphs.

## Nested floor bound

We start with a well-known upper bound on the independence number $\alpha$ of the product of any two graphs. Recall that $\bar{\chi}_{f}$ denotes the fractional clique covering number. Hales [Hal73], using ideas of Rosenfeld [Ros67] (see also [Sch03, Equation 67.101]), proved for any two graphs $G, H$ that

$$
\begin{equation*}
\alpha(G \boxtimes H) \leq\left\lfloor\bar{\chi}_{f}(G) \alpha(H)\right\rfloor \tag{3}
\end{equation*}
$$

As a direct consequence we have the following "nested floor bound" on the independence number of any product of fraction graphs.

Theorem 6.4. Let $p_{1} / q_{1}, \ldots, p_{k} / q_{k} \in \mathbb{Q} \geq 2$. Then

$$
\begin{equation*}
\alpha\left(E_{p_{1} / q_{1}} \boxtimes E_{p_{2} / q_{2}} \boxtimes \cdots \boxtimes E_{p_{k} / q_{k}}\right) \leq\left\lfloor\cdots\left\lfloor\left\lfloor\frac{p_{1}}{q_{1}}\right\rfloor \frac{p_{2}}{q_{2}}\right\rfloor \cdots \frac{p_{k}}{q_{k}}\right\rfloor . \tag{4}
\end{equation*}
$$

Proof. This follows from $\bar{\chi}_{f}\left(E_{p / q}\right)=p / q$ and repeated application of Equation 3.
We note that the left-hand side of Equation 4 is invariant under permuting the numbers $p_{i} / q_{i}$, while the right-hand side is not. Thus when applying Theorem 6.4 we may minimize over these permutations to get the best bound. Moreover, we note that the minimizing permutation is not obtained by simply sorting the $p_{i} / q_{i}$. For instance, note that $\lfloor\lfloor\lfloor 5 / 2\rfloor 2\rfloor 3\rfloor=\lfloor\lfloor\lfloor 5 / 2\rfloor 3\rfloor 2\rfloor=12$ while all other permutations of $5 / 2,2$ and 3 lead to a larger value.

## Discontinuities for one or two fraction graphs

For a single factor, the bound of Theorem 6.4 is easily seen to be optimal, that is,

$$
\alpha\left(E_{p / q}\right)=\left\lfloor\frac{p}{q}\right\rfloor .
$$

Hales [Hal73, Theorem 7.1] proved that the bound of Theorem 6.4 is optimal for the product of any two odd cycles. Badalyan and Markosyan [BM13] proved that the bound of Theorem 6.4 is optimal for the product of any two fraction graphs, that is:

Theorem 6.5. Let $p_{1} / q_{1}, p_{2} / q_{2} \in \mathbb{Q} \geq 2$. Then

$$
\alpha\left(E_{p_{1} / q_{1}} \boxtimes E_{p_{2} / q_{2}}\right)=\min \left\{\left\lfloor\left\lfloor\frac{p_{1}}{q_{1}}\right\rfloor \frac{p_{2}}{q_{2}}\right\rfloor,\left\lfloor\left\lfloor\frac{p_{2}}{q_{2}}\right\rfloor \frac{p_{1}}{q_{1}}\right\rfloor\right\} .
$$

We give a short proof of Theorem 6.5. For this we use the following construction of an independent set in certain products of fraction graphs, which extends the well-known construction of an independent set of size five in $C_{5}^{\boxtimes 2}$.

Lemma 6.6. Let $p / q \in \mathbb{Q} \geq 2$. Then $\alpha\left(E_{p / q} \boxtimes E_{p /\lfloor p / q\rfloor}\right)=p$.
Proof. The upper bound follows from Theorem 6.4. For the lower bound, define the set $S=\left\{t \cdot(1,\lfloor p / q\rfloor): t \in \mathbb{Z}_{p}\right\}$. One verifies that $S$ is an independent set in $E_{p / q} \boxtimes E_{p /\lfloor p / q\rfloor}$.
Proof of Theorem 6.5. Let $n_{i}=\left\lfloor p_{i} / q_{i}\right\rfloor$. We can write $p_{1} / q_{1}=n_{1}+\left(m_{1}+\ell_{1}\right) / n_{2}$ and $p_{2} / q_{2}=n_{2}+\left(m_{2}+\ell_{2}\right) / n_{1}$ for some $m_{i} \in \mathbb{N}$ and $\ell_{i} \in \mathbb{R}$ such that $0 \leq m_{1}<n_{2}$, $0 \leq m_{2}<n_{1}$ and $0 \leq \ell_{i}<1$. Then

$$
\left\lfloor\left\lfloor\frac{p_{1}}{q_{1}}\right\rfloor \frac{p_{2}}{q_{2}}\right\rfloor=n_{1} n_{2}+m_{2}
$$

and

$$
\left\lfloor\left\lfloor\frac{p_{2}}{q_{2}}\right\rfloor \frac{p_{1}}{q_{1}}\right\rfloor=n_{1} n_{2}+m_{1}
$$

We may assume that $m_{1} \leq m_{2}$. Apply Lemma 6.6 with $p=n_{1} n_{2}+m_{1}$ and $q=n_{2}$ to get

$$
\alpha\left(E_{\left(n_{1} n_{2}+m_{1}\right) / n_{2}} \boxtimes E_{\left(n_{1} n_{2}+m_{1}\right) / n_{1}}\right)=n_{1} n_{2}+m_{1} .
$$

Because $\left(n_{1} n_{2}+m_{1}\right) / n_{2} \leq p_{1} / q_{1}$ and $\left(n_{1} n_{2}+m_{1}\right) / n_{1} \leq p_{2} / q_{2}$ we find that $\alpha\left(E_{p_{1} / q_{1}} \boxtimes\right.$ $\left.E_{p_{2} / q_{2}}\right) \geq \alpha\left(E_{\left(n_{1} n_{2}+m_{1}\right) / n_{2}} \boxtimes E_{\left(n_{1} n_{2}+m_{1}\right) / n_{1}}\right)=n_{1} n_{2}+m_{1}$.

## Discontinuities for three (or more) fraction graphs

Theorem 6.5 says that Theorem 6.4 is tight for two factors. For three factors, however, the bound in Theorem 6.4 is no longer always optimal and the independence number $\alpha\left(E_{p_{1} / q_{1}} \boxtimes E_{p_{2} / q_{2}} \boxtimes E_{p_{3} / q_{3}}\right)$ shows more intricate behaviour. We fully determine this behaviour for all triples of fractions in the interval [2,3]. Since the function $\alpha\left(E_{p_{1} / q_{1}} \boxtimes\right.$ $\left.E_{p_{2} / q_{2}} \boxtimes E_{p_{3} / q_{3}}\right)$ is monotone in each $p_{i} / q_{i}$ and integral-valued, it has only finitely many discontinuities, and to determine the function it suffices to determine the value at every discontinuity.

To discuss the discontinuities of the independence number of products of fraction graphs, we define for any $k \in \mathbb{N}$ the function

$$
\alpha_{k}: \mathbb{Q}_{\geq 2}^{k} \rightarrow \mathbb{N}:\left(p_{1} / q_{1}, \ldots, p_{k} / q_{k}\right) \mapsto \alpha\left(E_{p_{1} / q_{1}} \boxtimes \cdots \boxtimes E_{p_{k} / q_{k}}\right) .
$$

For $u, v \in \mathbb{Q}_{\geq 2}^{k}$ we write $u \leq v$ if there is a permutation of $u$ that is pointwise at most $v$. Then $u \leq v$ implies $\alpha_{k}(u) \leq \alpha_{k}(v)$. We write $u<v$ if $u \leq v$ and $u \neq v$. We call $v \in \mathbb{Q}_{\geq 2}^{k}$ an (extremal) discontinuity of $\alpha_{k}$ if for every $u \in \mathbb{Q}_{\geq 2}^{k}$ if $u<v$ then $\alpha_{k}(u)<\alpha_{k}(v)$.

Lemma 6.7. For every $n, k \in \mathbb{N},\left(n, p_{1} / q_{1}, \ldots, p_{k} / q_{k}\right)$ is a discontinuity of $\alpha_{k+1}$ if and only if $\left(p_{1} / q_{1}, \ldots, p_{k} / q_{k}\right)$ is a discontinuity of $\alpha_{k}$.

Proof. We use the fact that the independence number is additive under disjoint union, so that $\alpha\left(E_{n} \boxtimes G\right)=n \alpha(G)$ for any graph $G$ and any $n \in \mathbb{N}$.

Suppose ( $n, p_{1} / q_{1}, \ldots, p_{k} / q_{k}$ ) is a discontinuity. Let $r / s<p_{1} / q_{1}$, say. Then

$$
\begin{aligned}
\alpha\left(E_{r / s} \boxtimes E_{p_{2} / q_{2}} \boxtimes \cdots\right) & =\frac{1}{n} \alpha\left(E_{n} \boxtimes E_{r / s} \boxtimes E_{p_{2} / q_{2}} \boxtimes \cdots\right) \\
& <\frac{1}{n} \alpha\left(E_{n} \boxtimes E_{p_{1} / q_{1}} \boxtimes E_{p_{2} / q_{2}} \boxtimes \cdots\right) \\
& =\alpha\left(E_{p_{1} / q_{1}} \boxtimes E_{p_{2} / q_{2}} \boxtimes \cdots\right),
\end{aligned}
$$

so ( $p_{1} / q_{1}, \ldots, p_{k} / q_{k}$ ) is a discontinuity.
Suppose ( $p_{1} / q_{1}, \ldots, p_{k} / q_{k}$ ) is a discontinuity. Suppose $r / s<p_{1} / q_{1}$, say. Then

$$
\begin{aligned}
\alpha\left(E_{n} \boxtimes E_{r / s} \boxtimes E_{p_{2} / q_{2}} \boxtimes \cdots\right) & =n \alpha\left(E_{r / s} \boxtimes E_{p_{2} / q_{2}} \boxtimes \cdots\right) \\
& <n \alpha\left(E_{p_{1} / q_{1}} \boxtimes E_{p_{2} / q_{2}} \boxtimes \cdots\right) \\
& =\alpha\left(E_{n} \boxtimes E_{p_{1} / q_{1}} \boxtimes E_{p_{2} / q_{2}} \boxtimes \cdots\right) .
\end{aligned}
$$

Suppose $r / s<n$. Then Theorem 6.4 gives $\alpha\left(E_{r / s} \boxtimes E_{p_{1} / q_{1}} \boxtimes \cdots\right)<\alpha\left(E_{n} \boxtimes E_{p_{1} / q_{1}} \boxtimes \cdots\right)$. We conclude that ( $n, p_{1} / q_{1}, \ldots, p_{k} / q_{k}$ ) is a discontinuity.

Example 6.8. The discontinuities of $\alpha_{1}$ are at the natural numbers $\mathbb{N}_{\geq 2}$, and we have $\alpha_{1}(n)=n$ for every $\mathbb{N}_{\geq 2}$.

The discontinuities of $\alpha_{2}$ can be computed using Theorem 6.5. Concretely, restricted to $(\mathbb{Q} \cap[2,3])^{2}$, we see from Lemma 6.7 that $(2,2),(2,3)$ and $(3,3)$ are discontinuities. Taking $2<p_{1} / q_{1}, p_{2} / q_{2}<3$ we see from Theorem 6.5 that $\alpha_{2}\left(p_{1} / q_{1}, p_{2} / q_{2}\right)$ equals $\min \left\{\left\lfloor 2 p_{1} / q_{1}\right\rfloor,\left\lfloor 2 p_{2} / q_{2}\right\rfloor\right\}$, which equals 5 if and only if both $p_{1} / q_{1}$ and $p_{2} / q_{2}$ are at least $5 / 2$. Thus, the discontinuities of $\alpha_{2}$ on $(\mathbb{Q} \cap[2,3])^{2}$ are, up to permutation, at

$$
\alpha_{2}(2,2)=4, \alpha_{2}(5 / 2,5 / 2)=5, \alpha_{2}(2,3)=6, \alpha_{2}(3,3)=9 .
$$

Theorem 6.9. The discontinuities of $\alpha_{3}$ restricted to $(\mathbb{Q} \cap[2,3])^{3}$ are, up to permutation, at

$$
\begin{aligned}
\alpha_{3}(2,2,2) & =8 \\
\alpha_{3}(2,2,3) & =12 \\
\alpha_{3}(2,3,3) & =18 \\
\alpha_{3}(2,5 / 2,5 / 2) & =10 \\
\alpha_{3}(5 / 2,5 / 2,3) & =15 \\
\alpha_{3}(9 / 4,7 / 3,5 / 2) & =9
\end{aligned}
$$

$$
\begin{aligned}
\alpha_{3}(5 / 2,5 / 2,8 / 3) & =11 \\
\alpha_{3}(8 / 3,8 / 3,8 / 3) & =12 \\
\alpha_{3}(11 / 5,11 / 4,11 / 4) & =11 \\
\alpha_{3}(11 / 4,11 / 4,11 / 4) & =13 \\
\alpha_{3}(14 / 5,14 / 5,14 / 5) & =14 \\
\alpha_{3}(3,3,3) & =27 .
\end{aligned}
$$

In order to use Theorem 6.9 to determine the value of $\alpha_{3}$ at an arbitrary point $v=\left(p_{1} / q_{1}, p_{2} / q_{2}, p_{3} / q_{3}\right) \in \mathbb{Q} \cap[2,3]$ we simply search for the largest $u$ from the listed discontinuity points such that $u \leq v$. Then $\alpha_{3}(v)=\alpha_{3}(u)$. As an aid for such a search we provide in Figure 4 the Hasse diagram of the partial ordering on the discontinuity points, in which $u \rightarrow v$ means $u \leq v$.


Figure 4: Hasse diagram of the poset of discontinuity points of Theorem 6.9. Here $u \rightarrow v$ means $u \leq v$, and by definition we have $u \leq v$ if there is a permutation of $u$ that is pointwise at most $v$.

Remark 6.10. We note that for all discontinuity points in Theorem 6.9 the nested floor bound Theorem 6.4 is tight, except for the points $(5 / 2,5 / 2,8 / 3)$ and $(8 / 3,8 / 3,8 / 3)$, where it gives 12 and 13, respectively.

Remark 6.11. In the recent work of Zhu [Zhu24] on the Shannon capacity of the complement of odd cycles, the graphs $E_{9 / 4} \boxtimes E_{7 / 3} \boxtimes E_{5 / 2}, E_{2} \boxtimes E_{5 / 2} \boxtimes E_{5 / 2}$ and $E_{2} \boxtimes E_{2} \boxtimes E_{3}$ appear (in a slightly different language). Our Theorem 6.9 says that these graphs are discontinuity points (and notably they are the "smallest" discontinuity points above $(2,2,2))$.

Remark 6.12. We have seen in the proof of Theorem 6.5 that all discontinuity points of $\alpha_{2}$ can be obtained using independent sets that are orbits in a product of fraction graphs. This is not true for every discontinuity point of $\alpha_{3}$. Indeed, we claim that the discontinuity point $\alpha_{3}(8 / 3,8 / 3,8 / 3)=12$ cannot be realized by a subgroup in a very general sense.

Let $H_{1}, H_{2}, H_{3}$ be finite groups with symmetric subsets $S_{i}$ and let $G_{i}=\operatorname{Cayley}\left(H_{i}, S_{i}\right)$ be the corresponding Cayley graphs. Suppose that $G_{i} \leq E_{8 / 3}$ and suppose that there is a subgroup $I \subseteq H_{1} \times H_{2} \times H_{3}$ of size 12 that is an independent set in $G_{1} \boxtimes G_{2} \boxtimes G_{3}$. We will show that this gives a contradiction. Consider the auxiliary graphs $L_{i}$ with vertex set $I$ where $x \nsim y$ if and only if $x_{i} \nsim y_{i}$ in $G_{i}$. Now $L_{i} \leq G_{i} \leq E_{8 / 3}$ and thus $\bar{\chi}_{f}\left(L_{i}\right) \leq 8 / 3$. Moreover, $L_{i}$ is vertex-transitive so $\bar{\chi}_{f}\left(L_{i}\right)=\left|L_{i}\right| / \omega\left(L_{i}\right)=12 / \omega\left(L_{i}\right)$, where $\omega$ denotes the clique number. Because $\omega\left(L_{i}\right)$ is an integer we can conclude that $\bar{\chi}_{f}\left(L_{i}\right) \leq 12 / 5$. Observe that $\{(x, x, x): x \in I\}$ is an independent set in $L_{1} \boxtimes L_{2} \boxtimes L_{3}$ implying $\alpha\left(L_{1} \boxtimes L_{2} \boxtimes L_{3}\right) \geq 12$. However, using the nested floor bound (Theorem 6.4), we observe that

$$
\alpha\left(L_{1} \boxtimes L_{2} \boxtimes L_{3}\right) \leq\left\lfloor\bar{\chi}_{f}\left(L_{1}\right)\left\lfloor\bar{\chi}_{f}\left(L_{2}\right)\left\lfloor\bar{\chi}_{f}\left(L_{3}\right)\right\rfloor\right\rfloor\right\rfloor \leq\left\lfloor\frac{12}{5}\left\lfloor\frac{12}{5}\left\lfloor\frac{12}{5}\right\rfloor\right\rfloor\right\rfloor=9,
$$

which gives a contradiction.

The proof of Theorem 6.9 consists of a computer-assisted component together with several reductions to the problem, for which we use Lemma 6.7 and the following lemma. (We note that all the ideas we present here work also outside the interval [2, 3]. However, the computer-assisted component becomes more costly.)
Lemma 6.13. If $\left(p_{1} / q_{1}, \ldots, p_{k} / q_{k}\right)$ is a discontinuity of $\alpha_{k}$, then

$$
\max \left\{p_{1}, \ldots, p_{k}\right\} \leq \alpha_{k}\left(p_{1} / q_{1}, \ldots, p_{k} / q_{k}\right)
$$

Proof. Let $m=\alpha_{k}\left(p_{1} / q_{1}, \ldots, p_{k} / q_{k}\right)$. Suppose $\max _{i} p_{i}>m$. Let $S$ be any independent set of $E_{p_{1} / q_{1}} \boxtimes \cdots \boxtimes E_{p_{k} / q_{k}}$ of size $m$. Then there is an $i \in[k]$ and a vertex $v$ of $E_{p_{i} / q_{i}}$ such that for every $s \in S, s_{i} \neq v$. Then $S \subseteq E_{p_{1} / q_{1}} \boxtimes \cdots \boxtimes\left(E_{p_{i} / q_{i}}-\{v\}\right) \boxtimes \cdots \boxtimes E_{p_{k} / q_{k}}$. We know that $E_{p_{i} / q_{i}}-\{v\}$ is equivalent to a fraction graph $E_{a / b}$ for some $a / b \in \mathbb{Q} \geq 2$ that is strictly smaller than $p_{i} / q_{i}$ (Lemma 3.5). Then $\alpha_{k}\left(p_{1} / q_{1}, \ldots, a / b, \ldots, p_{k} / q_{k}\right)=m$, so $\left(p_{1} / q_{1}, \ldots, p_{k} / q_{k}\right)$ is not a discontinuity.

Proof of Theorem 6.9. We will make a set of candidate discontinuities that is small enough so that we can compute the independence number of them with optimization software (Gurobi [Gur23]).

Suppose $\left(p_{1} / q_{1}, p_{2} / q_{2}, p_{3} / q_{3}\right) \in(\mathbb{Q} \cap[2,3])^{3}$ is a discontinuity. We have

$$
\alpha_{3}\left(p_{1} / q_{1}, p_{2} / q_{2}, p_{3} / q_{3}\right) \leq \alpha_{3}(3,3,3)=27
$$

Then from Lemma 6.13 we know that

$$
\begin{equation*}
\max _{i \in[k]} p_{i} \leq 27 \tag{5}
\end{equation*}
$$

Moreover, again from Lemma 6.13, and using the theta number and the nested floor bound (Theorem 6.4), we know that

$$
\begin{equation*}
\max _{i \in[k]} p_{i} \leq \vartheta\left(E_{p_{1} / q_{1}} \boxtimes \cdots \boxtimes E_{p_{k} / q_{k}}\right) \tag{6}
\end{equation*}
$$

and

$$
\begin{equation*}
\max _{i \in[k]} p_{i} \leq \min _{\pi \in S_{k}}\left\lfloor\cdots\left\lfloor\left\lfloor\frac{p_{\pi(1)}}{q_{\pi(1)}}\right\rfloor \frac{p_{\pi(2)}}{q_{\pi(2)}}\right\rfloor \cdots \frac{p_{\pi(k)}}{q_{\pi(k)}}\right\rfloor . \tag{7}
\end{equation*}
$$

Our set of candidate discontinuities consists of all $\left(p_{1} / q_{1}, p_{2} / q_{2}, p_{3} / q_{3}\right) \in(\mathbb{Q} \cap[2,3])^{3}$ such that Equation 5, Equation 6 and Equation 7 hold. Note that Equation 5 already implies that this set is finite. On these elements we run optimization software to compute the independence numbers, resulting in the claim.

Theorem 6.9 describes the discontinuities of $\alpha_{3}\left(p_{1} / q_{1}, p_{2} / q_{2}, p_{3} / q_{3}\right)$ as a function of three inputs. We now consider the symmetric restriction $\alpha_{3}(p / q, p / q, p / q)=\alpha\left(E_{p / q}^{\boxtimes 3}\right)$. Indeed, Theorem 6.9 directly implies the complete description of the discontinuities of this function, and thus the complete description of the function, for $p / q \in \mathbb{Q} \cap[2,3]$.
Theorem 6.14. For $p / q \in \mathbb{Q} \cap[2,3]$ we have

$$
\alpha\left(E_{p / q}^{\boxtimes 3}\right)= \begin{cases}8 & p / q \in[2,5 / 2) \\ 10 & p / q \in[5 / 2,8 / 3) \\ 12 & p / q \in[8 / 3,11 / 4) \\ 13 & p / q \in[11 / 4,14 / 5) \\ 14 & p / q \in[14 / 5,3) \\ 27 & p / q=3\end{cases}
$$

Proof. This follows from Theorem 6.9 by restricting to symmetric triples.
The values of $\alpha\left(E_{p / q}^{\boxtimes 3}\right)$ at the discontinuity points listed in Theorem 6.14 match the previously known values given in [JKT14, Table 1] and [Jur14, Table 8.1].

We visualize the right-continuous step function described in Theorem 6.14 as a graph in Figure 5. (In this graph we omit the point $(3,27)$ to save space.)


Figure 5: Graph of the right-continuous step function $\alpha\left(E_{p / q}^{\boxtimes 3}\right)$ for $p / q \in \mathbb{Q} \cap[2,3)$ with discontinuity points as described in Theorem 6.14.

Remark 6.15. Besides the discontinuity points described in Example 6.8 and Theorem 6.9, some more known discontinuity points are the following:
(1) For any $n \in \mathbb{N}$, the function $\alpha_{2 n}$ has a discontinuity at $(5 / 2, \ldots, 5 / 2)$. This follows from [BPT13, Theorem 4.2], which states that $\vartheta\left(E_{p / q}\right)=\vartheta\left(E_{p^{\prime} / q^{\prime}}\right)$ implies that $p / q=p^{\prime} / q^{\prime}$, where $\vartheta$ denotes the Lovász theta function. Indeed, let $p / q<5 / 2$. Then $\vartheta\left(E_{p / q}\right)<\vartheta\left(E_{5 / 2}\right)=\sqrt{5}$ and thus

$$
\alpha\left(E_{p / q} \boxtimes E_{5 / 2}^{\boxtimes(2 n-1)}\right) \leq \vartheta\left(E_{p / q}\right) \vartheta\left(E_{5 / 2}\right)^{2 n-1}<5^{n}=\alpha\left(E_{5 / 2}^{\boxtimes 2 n}\right) .
$$

(2) Let $r \in \mathbb{Z}_{\geq 3}$ and define the sequence $q_{n}$ by $q_{0}=1$ and $q_{n+1}=r \cdot q_{n}-1$. In [Pol19a, Theorem 9.3.3] it is shown that for all $n \geq 1, \alpha\left(E_{q_{n} / q_{n-1}}^{\boxtimes n}\right) \geq q_{n}$. It is not hard to verify inductively that for $1 \leq m \leq n$ the following equality holds

$$
\underbrace{\left\lfloor\cdots\left\lfloor\left\lfloor\frac{q_{n}}{q_{n-1}}\right\rfloor \frac{q_{n}}{q_{n-1}}\right\rfloor \cdots \frac{q_{n}}{q_{n-1}}\right\rfloor}_{m \text { copies }}=q_{m} .
$$

It thus follows from Theorem 6.4 that for $a / b<q_{n} / q_{n-1}$,

$$
\alpha\left(E_{q_{n} / q_{n-1}}^{\boxtimes(n-1)} \boxtimes E_{a / b}\right) \leq\left\lfloor\left\lfloor\cdots\left\lfloor\left\lfloor\frac{q_{n}}{q_{n-1}}\right\rfloor \frac{q_{n}}{q_{n-1}}\right\rfloor \cdots \frac{q_{n}}{q_{n-1}}\right\rfloor \frac{a}{b}\right\rfloor=\left\lfloor q_{n-1} \cdot \frac{a}{b}\right\rfloor<q_{n}
$$

which shows that $\left(q_{n} / q_{n-1}, \ldots, q_{n} / q_{n-1}\right)$ is a discontinuity point for $\alpha_{n}$. The discontinuity point $(14 / 5,14 / 5,14 / 5)$ for $\alpha_{3}$ recorded in Theorem 6.9 is of this form (obtained
by setting $r=3$ and $n=3$ ). These independent sets were used in [Pol19a] to prove that the functions $p / q \mapsto F\left(E_{p / q}\right)$ are left-continuous at integers $r \geq 3$, where $F$ may either represent the Shannon capacity $\Theta$ or any element of the spectrum $\mathcal{X}$. This follows from the facts that $q_{n} / q_{n-1}$ approaches $r$ from below and that $\lim _{n \rightarrow \infty} q_{n}^{1 / n}=r$ and thus

$$
r \geq \lim _{n \rightarrow \infty} F\left(E_{q_{n} / q_{n-1}}\right) \geq \lim _{n \rightarrow \infty} \Theta\left(E_{q_{n} / q_{n-1}}\right) \geq \lim _{n \rightarrow \infty} \alpha\left(E_{q_{n} / q_{n-1}}^{\boxtimes n}\right)^{\frac{1}{n}} \geq \lim _{n \rightarrow \infty} q_{n}^{\frac{1}{n}}=r .
$$

## 7 Discussion and open problems

Motivated by the Shannon capacity problem, and with the approach in mind of determining the Shannon capacity of "hard" graphs (e.g., the prototypical odd cycles) by approximating them with "easier" graphs (e.g., very structured graphs), we have developed the theory of the asymptotic spectrum distance on graphs and the corresponding notion of convergence. In particular, in Section 3 we have developed several methods for understanding convergence of fraction graphs, including effective distance bounds and topological incompleteness results.

A central problem that we leave open regarding convergence is left-continuity on fraction graphs:

Problem 7.1. Does $p_{n} / q_{n} \rightarrow a / b$ from below, imply that $E_{p_{n} / q_{n}} \rightarrow E_{a / b}$ ?
In Theorem 4.12 we proved that Problem 7.1 is equivalent to determining whether the (infinite) open and closed circle graphs $E_{a / b}^{\mathrm{o}}$ and $E_{a / b}^{\mathrm{c}}$ are asymptotically equivalent.

Generally, we feel that the study of natural infinite graphs like the circle graphs of Section 4 will shed new light on the theory of Shannon capacity. This angle and the use of asymptotic spectrum distance in general hint at the further potential of analytic methods for this otherwise combinatorial and algebraic problem. A central open problem regarding infinite graphs is about their completeness:
Problem 7.2. Are the infinite graphs $\mathcal{G}_{\infty}$ complete? ${ }^{19}$
Another open problem is about density of the finite graphs in the infinite graphs:
Problem 7.3. Are the finite graphs $\mathcal{G}$ dense in the infinite graphs $\mathcal{G}_{\infty}$ ?
In fact, the following is also open:
Problem 7.4. Is there, for every finite graph $G$, a non-trivial sequence of finite graphs $H_{i}$ converging to it, $H_{i} \rightarrow G$ ?

Specifically, Problem 7.4 is open for graphs that are not of the form $G=E_{p / q} \boxtimes G^{\prime}$ with $p / q \in \mathbb{Q} \geq 2$, since those are covered by Theorem 3.7.

In Section 6 we took a computational approach and used some of the developed methods to determine precisely several relevant independence numbers. In particular, we obtained a new lower bound on the Shannon capacity of $C_{15}$, using what could be considered a "finite" version of the converging sequence approach (following PolakSchrijver [PS19]), by using a fraction graph that sits "just above" it. We expect the development and further integration of these ideas to lead to deeper, structural understanding of the Shannon capacity.

## A General theory of asymptotic spectrum distance

In this section we discuss the general theory of asymptotic spectrum distance on preordered semirings (with the appropriate conditions), which has the theory for graphs and for infinite graphs (as discussed in Section 2) as special cases. The goal of this section is to put our ideas in a broader perspective and to clarify which parts of the theory discussed in the previous sections are general. We begin by reviewing the theory of asymptotic spectrum duality, as can be found in [Str88, Zui18, Zui19, WZ23, Fri23] (this is closely related to the real representation theorem of Kadison and Dubois [BS83, PD01, Mar08, Pow21]), and some examples. Then we discuss the general notion of asymptotic spectrum distance and basic properties.

## Semiring and order

Let $\mathcal{R}$ be a commutative semiring with additive unit 0 and multiplicative unit 1. For every $n \in \mathbb{N}$, let $n \in \mathcal{R}$ denote the sum of $n$ copies of the element 1 . Let $\leq$ be a partial order on $\mathcal{R}$ that satisfies the following properties:
(i) For every $a, b, c \in \mathcal{R}$, if $a \leq b$, then $a+c \leq b+c$ and $a c \leq b c$.
(ii) For every $n, m \in \mathbb{N}$ we have $n \leq m$ in $\mathbb{N}$ if and only if $n \leq m$ in $\mathcal{R}$.
(iii) For every nonzero element $a \in \mathcal{R}$ there is an element $n \in \mathbb{N}$ such that $1 \leq a \leq n$.

Let $\lesssim$ be the preorder defined on $\mathcal{R}$ by $a \lesssim b$ if and only if $a^{n} \leq b^{n} 2^{o(n)}$. (In all the examples that we consider we will have that for every $a, b \in \mathcal{R}, a^{n} \leq b^{n} 2^{o(n)}$ if and only if $a^{n} \leq b^{n+o(n)}$.) We may without loss of generality assume that $\lesssim$ is a partial order, by identifying any two elements $a, b \in \mathcal{R}$ for which $a \lesssim b$ and $b \lesssim a$. For every $a \in \mathcal{R}$, let $\mathrm{R}(a)=\min \{n \in \mathbb{N}: a \leq n\}$ and $\mathrm{Q}(a)=\max \{n \in \mathbb{N}: n \leq a\}$. These functions are called rank and subrank, respectively. Let $\mathrm{R}(a)=\lim _{n \rightarrow \infty} \mathrm{R}\left(a^{n}\right)^{1 / n}=\inf _{n} \mathrm{R}\left(a^{n}\right)^{1 / n}$ and $\mathrm{Q}(a)=\lim _{n \rightarrow \infty} \mathrm{Q}\left(a^{n}\right)^{1 / n}=\sup _{n} \mathrm{Q}\left(a^{n}\right)^{1 / n}$. These functions are called asymptotic rank and asymptotic subrank, respectively.

## Asymptotic spectrum duality

Let $\mathcal{X}$ be the set of $\leq$-monotone semiring-homomorphisms $\mathcal{R} \rightarrow \mathbb{R}_{\geq 0}$. We call $\mathcal{X}$ the asymptotic spectrum. For every $a \in \mathcal{R}$, let $\widehat{a}: \mathcal{X} \rightarrow \mathbb{R}_{\geq 0}: F \mapsto F(a)$. We equip $\mathcal{X}$ with the coarsest topology such that for every $a \in \mathcal{R}$ the map $\widehat{a}$ is continuous.

We call an element $a \in \mathcal{R}$ gapped if there is an element $k \in \mathbb{N}$ such that $a^{k} \geq 2$ or there is an element $\phi \in \mathcal{X}$ such that $\phi(a) \leq 1$.
Theorem A. 1 (e.g., [WZ23, Section 3]).
(i) $\mathcal{X}$ is a non-empty compact Hausdorff space.
(ii) Let $a, b \in \mathcal{R}$. Then $a \lesssim b$ if and only if for every $F \in \mathcal{X}, F(a) \leq F(b)$.
(iii) Let $a \in \mathcal{R}$. Then $\underset{\sim}{\mathrm{R}}(a)=\max _{F \in \mathcal{X}} F(a)$.
(iv) Let $a \in \mathcal{R}$ be gapped. Then $\underset{\sim}{\mathrm{Q}}(a)=\min _{F \in \mathcal{X}} F(a)$.

Theorem A. 2 (e.g., [WZ23, Section 4.3]). Let $\left(\mathcal{R}_{1}, \leq_{1}\right)$ and $\left(\mathcal{R}_{2}, \leq_{2}\right)$ be a pair of semirings and preorders as above. Let $i: \mathcal{R}_{1} \rightarrow \mathcal{R}_{2}$ be a semiring homomorphism such that for every $a, b \in \mathcal{R}_{1}$ we have $a \leq_{1} b$ if and only if $i(a) \leq_{2} i(b)$. Let $i^{*}: \mathcal{X}_{2} \rightarrow \mathcal{X}_{1}$ : $F \rightarrow F \circ i$. Then $i^{*}$ is surjective.

## Examples

We discuss some examples that fit in the above framework. We refer to [WZ23] for a more detailed discussion of examples.

Finite graphs. This is the setting of Section 2. Let $\mathcal{R}$ be the set of graphs with addition given by disjoint union, multiplication by strong product, the graph with no vertices as 0 and the graph with one vertex as 1 . Let $\leq$ be the cohomomorphism preorder on $\mathcal{R}$ defined by $G \leq H$ if there is a cohomomorphism $G \rightarrow H$. We identify graphs that are equivalent under cohomomorphism. Then $\mathcal{R}$ is a commutative semiring, and $\mathcal{R}$ and $\leq$ satisfy the properties outlined above. In Section 2 we discussed known elements of $\mathcal{X}$.

Infinite graphs. This is the setting of Section 4.2. The above structure for finite graphs is readily extended to infinite graphs with finite clique covering number. Let $\mathcal{R}$ be the set of infinite graphs with finite clique covering number. (Technically, for this to be a set we restrict ourselves to infinite graphs with bounded cardinality. For us, the cardinality of the reals will suffice, so we will tacitly assume our infinite graphs to have at most this cardinality.) We endow $\mathcal{R}$ with the same operations and preorder as above, and identify graphs that are equivalent under cohomomorphism. Then $\mathcal{R}$ is a commutative semiring, and $\mathcal{R}$ and $\leq$ satisfy the properties outlined above. As discussed in Section 4.2, Theorem A. 2 can be used to prove that the restriction map from the asymptotic spectrum of finite graphs $\mathcal{X}$ to the asymptotic spectrum of infinite graphs $\mathcal{X}_{\infty}$ is surjective. Thus every element of $\mathcal{X}$ can be extended to an element of $\mathcal{X}_{\infty}$ (possibly in multiple ways).

Tensors. The study of tensors (and in particular the matrix multiplication tensors) was the motivating application for Strassen to develop the theory of asymptotic spectra [Str88]. While this setting is not the focus of this paper, we briefly discuss it here for the sake of comparison. Let $\mathcal{R}$ be the set of tensors (over some fixed field, of order three, and with arbitrary dimensions) with addition given by direct sum, multiplication by tensor product, the $1 \times 1 \times 1$ tensor with coefficient 1 as 1 and the $1 \times 1 \times 1$ tensor with coefficient 0 as 0 . Let $\leq$ be the "restriction" preorder on $\mathcal{R}$ defined by $S \leq T$ if there are linear maps $A_{1}, A_{2}, A_{3}$ such that $S=\left(A_{1} \otimes A_{2} \otimes A_{3}\right) T$. We identify tensors that are equivalent under restriction. Then $\mathcal{R}$ is a commutative semiring, and $\mathcal{R}$ and $\leq$ satisfy the properties outlined above. A known family of elements in the asymptotic spectrum are the quantum functionals [CVZ23]. It is not known whether this is all of $\mathcal{X}$, and this question is related to several hard questions in the field.

More examples can be found in [JV20, LZ21, CLT24].

## Asymptotic spectrum distance

Leading up to the introduction of the asymptotic spectrum distance, a first natural step is to rephrase Theorem A. 1 in terms of the elements $\widehat{a}$ for $a \in \mathcal{R}$. By construction of the topology on $\mathcal{X}$ each $\widehat{a}$ is a continuous map $\mathcal{X} \rightarrow \mathbb{R}$. Let $C(\mathcal{X})$ denote the ring of all continuous functions $\mathcal{X} \rightarrow \mathbb{R}$ under pointwise addition and multiplication, and for $\phi, \psi \in C(\mathcal{X})$ write $\phi \leq \psi$ if $\phi$ is at most $\psi$ pointwise on $\mathcal{X}$. Let $\max \phi$ denote the maximum of $\phi$ on $\mathcal{X}$, and let $\min \phi$ denote the minimum of $\phi$ on $\mathcal{X}$. The minimum and maximum are indeed attained since $\mathcal{X}$ is compact. Theorem A. 1 (ii), (iii) and (iv) can be rephrased as saying that $a \lesssim b$ if and only if $\widehat{a} \leq \widehat{b} ; \underset{\sim}{\mathrm{R}}(a)=\max \widehat{a}$; and $\underset{\sim}{\mathrm{Q}}(a)=\min \widehat{a}$.

We equip $C(\mathcal{X})$ with the supremum-norm $\|\phi\|=\sup _{x \in \mathcal{X}}|\phi(x)|$ for $\phi \in C(\mathcal{X})$ and the corresponding distance function $d(\phi, \psi)=\|\phi-\psi\|$ for $\phi, \psi \in C(\mathcal{X})$. Then $C(\mathcal{X})$ is complete [Rud76, Theorem 7.15]. The map $\Phi: \mathcal{R} \rightarrow C(\mathcal{X}): a \mapsto \widehat{a}$ induces a distance on $\mathcal{R}$ as follows.

Definition A.3. For every $a, b \in \mathcal{R}$, we define $d(a, b):=d(\widehat{a}, \widehat{b})$. We call $d$ the asymptotic spectrum distance.

It follows directly from the definitions that $d(a, b)=\|\widehat{a}-\widehat{b}\|=\sup _{x \in \mathcal{X}}|\widehat{a}(x)-\widehat{b}(x)|=$ $\sup _{F \in \mathcal{X}}|F(a)-F(b)|$. Identifying in $\mathcal{R}$ any two elements $a, b$ for which $a \lesssim b$ and $b \lesssim a$, the set $\mathcal{R}$ with the asymptotic spectrum distance becomes a metric space.

From the asymptotic spectrum duality (Theorem A. 1 (ii)), it follows directly that the asymptotic spectrum distance can be rephrased in terms of the cohomomorphism preorder as follows.

Lemma A.4. Let $a, b \in \mathcal{R}$ and $n, m \in \mathbb{N}, m \geq 1$. The following are equivalent.
(i) $d(a, b) \leq n / m$
(ii) For every $F \in \mathcal{X}$ we have $|F(a)-F(b)| \leq n / m$
(iii) $m a \lesssim m b+n$ and $m b \lesssim m a+n$
(iv) $(m a)^{k} \leq(m b+n)^{k} 2^{o(k)}$ and $(m b)^{k} \leq(m a+n)^{k} 2^{o(k)}$

Proof. (i) $\Leftrightarrow$ (ii) is by definition of asymptotic spectrum distance.
(ii) $\Rightarrow$ (iii). For every $F \in \mathcal{X}$ we have $m F(a) \leq m F(b)+n$ and $m F(b) \leq m F(a)+n$, and so $F(m a) \leq F(m b+n)$ and $F(m b) \leq F(m a+n)$. Now apply Theorem A. 1 (ii).
(iii) $\Rightarrow$ (ii). Apply $F \in \mathcal{X}$ to both sides of the two inequalities.
(iii) $\Leftrightarrow$ (iv) is by definition of the asymptotic preorder.

## Convergence

We have the standard notions of Cauchy and convergence in $\mathcal{R}$ : A sequence $a_{1}, a_{2}, \ldots$ in $\mathcal{R}$ is Cauchy if for every $n / m>0(n, m \in \mathbb{N})$ there is an $N \in \mathbb{N}$ such that for every $i, j>N$, we have $d\left(a_{i}, a_{j}\right) \leq n / m$. The sequence $a_{1}, a_{2}, \ldots$ in $\mathcal{R}$ converges to $b \in \mathcal{R}$ if for every $n / m>0(n, m \in \mathbb{N})$ there is an $N \in \mathbb{N}$ such that for every $i>N$, we have $d\left(a_{i}, b\right) \leq n / m$.

Lemma A.5. If the sequence $a_{1}, a_{2}, \ldots$ in $\mathcal{R}$ converges to $b \in \mathcal{R}$, then $\underset{\sim}{\mathrm{Q}}\left(a_{i}\right)$ converges to $\underset{\sim}{\mathrm{Q}}(b)$, and $\underset{\sim}{\mathrm{R}}\left(a_{i}\right)$ converges to $\underset{\sim}{\mathrm{R}}(b)$.

Proof. This follows from the general fact that if a sequence of functions $f_{1}, f_{2}, \ldots$ on a compact space converges uniformly to $f$, then the sequence $\min f_{1}, \min f_{2}, \ldots$ converges to $\min f$, and the same for the maximum. See also the proof of Lemma 2.7 which directly generalizes to this setting.

Lemma A.6. Let $a_{1}, a_{2}, \ldots$ be a sequence in $\mathcal{R}$ and let $a \in \mathcal{R}$. If for every $F \in \mathcal{X}$ we have that $F\left(a_{1}\right), F\left(a_{2}\right), \ldots$ is monotone (i.e., non-increasing or non-decreasing) and converges to $F(a)$, then $a_{1}, a_{2}, \ldots$ converges to $a$.

Proof. This follows from Dini's theorem [Rud76, Theorem 7.13], which says that for any sequence of continuous functions $f_{1}, f_{2}, \ldots$ on a compact space $\mathcal{X}$, if the sequence $f_{1}, f_{2}, \ldots$ converges pointwise to a continuous function, and for every $x \in \mathcal{X}$ we have that $i \mapsto f_{i}(x)$ is monotone in $i$, then the sequence $f_{1}, f_{2}, \ldots$ converges uniformly to $f$. Apply this theorem to the sequence of continuous functions $\widehat{a}_{1}, \widehat{a}_{2}, \ldots$ to get the claim.

## B Explicit independent set

We give an independent set in $C_{15}^{\boxtimes 4}$ of size 2842. This was obtained as described in the proof of Theorem 6.2. We have encoded the vertices as 4-tuples of elements in $\{0,1, \ldots, 14\}$ where we use $A=10, B=11, \ldots, E=14$.

Then for any $a, b \in \mathbb{N}$ we have $d(G, H) \leq a / b$ if and only if $\left(E_{b} \boxtimes G\right)^{\boxtimes n} \leq$ $\left(\left(E_{b} \boxtimes H\right) \sqcup E_{a}\right)^{\boxtimes(n+o(n))}$ and $\left(E_{b} \boxtimes H\right)^{\boxtimes n} \leq\left(\left(E_{b} \boxtimes G\right) \sqcup E_{a}\right)^{\boxtimes(n+o(n))}$ (Lemma 2.8), where $E_{n}:=\bar{K}_{n}$ denotes the graph with $n$ vertices and no edges.

This product is also called the AND product. It can alternatively be described in terms of adjacency matrices: Let $A(G)$ be the adjacency matrix of $G$ in which we put ones on the main diagonal. Then $A(G \boxtimes H)=A(G) \otimes A(G)$, where $\otimes$ is the Kronecker product of matrices.
    ${ }^{9}$ The (standard) notation $\bar{\chi}$ for the clique covering number originates from the relation of this parameter to the chromatic number, which is denoted by $\chi$. Namely, $\bar{\chi}(G)=\chi(\bar{G})$.
