# A NOTE ON THE ORDER OF THE TATE-SHAFAREVICH GROUP MODULO SQUARES

#### Abstract

We investigate the order of the Tate-Shafarevich group of abelian varieties modulo rational squares. Our main result shows that every square-free natural number appears as the non square-free part of the Tate-Shafarevich group of some abelian variety, thereby validating a conjecture of W. Stein.

## 1. Introduction

In the following note, we study the order of the Tate-Shafarevich group $Ш(A / K)$ of an abelian variety $A$ defined over a number field $K$. Its non-zero elements correspond to principal homogeneous spaces for $A / K$ with a rational point over all completions of $K$ though lacking a point in $K$ itself. Despite its central role in the study of rational points, several foundational questions regarding $\amalg(A / K)$ remain open. These include the Tate-Shafarevich conjecture which stipulates its finiteness. In addition, a conjecture of Stein focuses on the possible values that the order of the Tate-Shafarevich group can take (if finite) modulo rational squares. In the following note, we validate Stein's conjecture, which can be phrased as follows.

Theorem 1.1 (=Corollary 3.6). For every positive square-free integer n, there exists an abelian variety $A / \mathbb{Q}$ with finite Tate-Shafarevich group of order $n m^{2}$ for some integer $m \geq 1$.
1.1. Previous work. In the case of principally polarised abelian varieties, the Cassels-Tate pairing,

\langle,\rangle: Ш(A / K) \times Ш(A / K) \rightarrow \mathbb{Q} / \mathbb{Z},

[^0]lays down significant constraints on the structure of the Tate-Shafarevich group. In particular, for elliptic curves, this is known to be alternating, and therefore the order of the Tate-Shafarevich group of an elliptic curve must be a square, if finite.

The work of Flach [4] establishes the (slightly weaker) skew symmetric condition $\langle x, y\rangle=-\langle y, x\rangle$ for principally polarised abelian varieties. From this, one can only deduce that the Tate-Shafarevich group is either a square or twice a square. Building upon this, Poonen and Stoll present a criterion for deducing if the Tate-Shafarevich group (provided it's finite) is of square order purely based on the vanishing of $\langle c, c\rangle$ for an element $c \in \amalg(A / K)[2]$ canonically associated to $A$. They then use this criterion to present the first example of an abelian variety for which the order of its Tate-Shafarevich group is twice a square.

Subsequently, Stein [13] presents the first examples of abelian varieties defined over $\mathbb{Q}$ in which the order of their Tate-Shafarevich groups satisfy $|\amalg(A / \mathbb{Q})|=p m^{2}$ for $p<25000$ an odd prime. His construction relies on the existence of an abelian variety defined over $\mathbb{Q}$ which becomes isomorphic to a product $E^{p-1}$ of elliptic curves over a cyclic extension. Following this, Keil's work [6] presents examples of abelian surfaces, given as quotients of a product of two elliptic curves, for which $|\Psi|=p m^{2}$ for $p \leq 13$ an odd prime.

## 2. Expression for $\amalg$ mod squares

Our proof relies on breaking down the Weil restriction of scalars of an abelian variety up to isogeny followed by an application of a formula of Cassels-Tate. This allows us to express the size of the Tate-Shafarevich group modulo squares in terms of Birch-Swinnerton-Dyer constants.
2.1. Cassels-Tate formula. In the following subsection, we briefly recall a result of Cassels and Tate which proves invariance of the Birch-SwinnertonDyer conjecture under isogeny. We first fix some notation.

Notation 2.1. We let $K$ be a number field. Given a $K$-rational isogeny $\phi: A_{1} \rightarrow A_{2}$, we write

\begin{aligned}
Q(\phi) & =\left|\operatorname{coker}\left(\phi: A_{1}(K) / A_{1}(K)_{\text {tors }} \rightarrow A_{2}(K) / A_{2}(K)_{\text {tors }}\right)\right| \\
& \times\left|\operatorname{ker}\left(\phi: Ш\left(A_{1} / K\right)_{\operatorname{div}} \rightarrow Ш\left(A_{2} / K\right)_{\mathrm{div}}\right)\right|,
\end{aligned}
$$

where $Ш_{\text {div }}$ denotes the divisible part of $Ш$.

For an abelian variety $A / K$ with a fixed non-zero global exterior form $\omega$, we denote the Birch-Swinnerton-Dyer periods by

$$
\Omega_{\mathbb{C}}(A, \omega)=2^{\operatorname{dim} A} \int_{A(\mathbb{C})}|\omega \wedge \bar{\omega}|, \quad \Omega_{\mathbb{R}}(A, \omega)=\int_{A(\mathbb{R})}|\omega| .
$$

We write $\Omega(A / K, \omega)=\prod_{v \mid \infty} \Omega_{K_{v}}(A, \omega)$ where $K_{v}=\mathbb{R}$ (resp. $\mathbb{C}$ ) if $v$ is real (resp. complex). In addition, for a non-archimedean place $v$, we write $w_{A, v}^{\min }$ for a Néron minimal exterior form on $A, c_{v}(A / K)$ for its Tamagawa number and $C(A / K, \omega)=\prod_{v \nmid \infty} c_{v}(A / K)\left|\omega / \omega_{A, v}^{\min }\right|_{v}$. We write $Ш_{0}=Ш^{2} / Ш_{\text {div }}$ and $\square$ to denote the square of a rational number.

The following theorem is a version of the Cassels-Tate formula as found in [3, Theorem 4.3].

Theorem 2.2 (Cassels-Tate). Let $\phi: A_{1} \rightarrow A_{2}$ be a $K$-rational isogeny. Then, for any non-zero global exterior forms $\omega_{1}$ and $\omega_{2}$ on $A_{1}$ and $A_{2}$,

$$
\frac{Q\left(\phi^{\vee}\right)}{Q(\phi)}=\frac{\mid A_{2}(K)_{\text {tors }}}{\left|A_{1}(K)_{\text {tors }}\right|} \left\lvert\, \frac{\mid A_{2}^{\vee}(K)_{\text {tors }}}{\left|A_{1}^{(1}(K)_{\text {tors }}\right|} \frac{C\left(A_{1} / K, \omega_{1}\right)}{C\left(A_{2} / K, \omega_{2}\right)} \frac{\Omega\left(A_{1} / K, \omega_{1}\right)}{\Omega\left(A_{2} / K, \omega_{2}\right)} \prod_{p \mid \text { deg }(\phi)} \frac{\left|Ш_{0}\left(A_{1} / K\right)\left[p^{\infty}\right]\right|}{\left|Ш_{0}\left(A_{2} / K\right)\left[p^{\infty}\right]\right|} .\right.
$$

Given a field extension $L / K$, we write $\phi_{L}$ for the base change of $\phi$ to $L$. The following proposition shows that for carefully chosen $L$ and working modulo squares, the Cassels-Tate formula simplifies.

Lemma 2.3. Let $L / K$ be a quadratic extension such that all bad primes of $A_{1} / K$ and $A_{2} / K$ and all places $v \mid \operatorname{deg}(\phi)$ split in L. In addition, suppose that $\operatorname{deg}(\phi)$ is a square. Then,

$$
\frac{Q\left(\phi_{L}^{\vee}\right)}{Q\left(\phi_{L}\right)}=\frac{\left|A_{2}(L)_{\text {tors }}\right|}{\left|A_{1}(L)_{\text {tors }}\right|} \frac{\left|A_{2}^{\vee}(L)_{\text {tors }}\right|}{\left|A_{1}^{\vee}(L)_{\text {tors }}\right|} \prod_{p \mid \operatorname{deg}(\phi)} \frac{\left|Ш_{0}\left(A_{1} / K\right)\left[p^{\infty}\right]\right|}{\left|Ш_{0}\left(A_{2} / K\right)\left[p^{\infty}\right]\right|} \bmod \square .
$$

Proof. We note that $C\left(A_{1} / L, \omega_{1}\right) \Omega\left(A_{1} / L, \omega_{1}\right)$ is independent of $\omega_{1}$. By our assumptions on $L / K$, the only terms in this product we have to consider are complex places of $L$ which lie above real places of $K$ and non-archimedean places $w \nmid \operatorname{deg}(\phi)$. As in the proof of [9, Theorem 7.3], when $w$ is complex, we have $\Omega_{\mathbb{C}}\left(A_{1}, \phi^{*} \omega_{2}\right) / \Omega_{\mathbb{C}}\left(A_{2}, \omega_{2}\right)=\operatorname{deg}(\phi)=\square$. For a non-archimedean place $w \nmid \operatorname{deg}(\phi),\left|\left(\phi^{*} \omega_{2} / \omega_{A_{1}, w}^{\min }\right) /\left(\omega_{2} / \omega_{A_{2}, w}^{\min }\right)\right|_{w}=1$ (see [12, pp. 12]). To conclude, $\frac{C\left(A_{1} / L, \omega_{1}\right)}{C\left(A_{2} / L, \omega_{2}\right)} \frac{\Omega\left(A_{1} / L, \omega_{1}\right)}{\Omega\left(A_{2} / L, \omega_{2}\right)}=\square$ giving the required result.
2.2. A decomposition for the Weil-restriction of scalars. In what follows, we let $A / K$ be a principally polarised abelian variety defined over a number field $K$. We let $p$ be an odd prime, $F / K$ a cyclic extension of degree $p$ and $\operatorname{Res}_{K}^{F} A$ the restriction of scalars from $F$ to $K$. For brevity, we write $B=\operatorname{Res}_{K}^{F} A$. This is an $F / K$-twist of $A^{p}$, and the product polarisation on $A^{p}$ descends to a principal polarisation on $B / K$. Then, there are $K$-morphisms

$$
i: A \rightarrow B, \quad \operatorname{Tr}: B \rightarrow A
$$

These are the inclusion and the trace map respectively.

After identifying the base change $B_{F}=A^{p}$ as principally polarised abelian varieties, the base changed morphisms $i_{F}$ and $\operatorname{Tr}_{F}$ coincide with the diagonal inclusion and the summation map respectively. In addition, writing $i^{\vee}: B \rightarrow$ $A$ for the dual of $i$ (having suppressed the canonical principal polarisations on both sides), we have $i^{\vee}=\operatorname{Tr}$. Finally, we write $R$ to denote the kernel of the trace map. This is an abelian variety defined over $K$ and is an $F / K$-twist of $A^{p-1}$ (see [13, Proposition 2.4]).
Lemma 2.4. Let $\phi: R \times A \rightarrow B$ be given by $(x, y) \mapsto x+i(y)$. Then, $\phi$ is a $K$-rational isogeny with $\operatorname{ker}(\phi) \cong A[p]$.
Proof. It suffices to show $\operatorname{ker}(\phi) \cong A[p]$. After base change to $\bar{K}$, we identify $R_{\bar{K}}=A^{p-1}$ and $B_{\bar{K}}=A^{p}$. Then, on $\bar{K}$-points $\phi$ is given by $\left(x_{1}, \ldots, x_{p-1}, y\right) \mapsto\left(y+x_{1}, \ldots, y+x_{p-1}, y-\sum_{i=1}^{p-1} x_{i}\right)$. Thus, restricting the projection $R \times A \rightarrow A$ to $\operatorname{ker}(\phi)$ allows us to deduce that $\operatorname{ker}(\phi) \cong A[p]$.
2.3. An expression for $\amalg(R / L)$ modulo squares. In this subsection, we relate $\left|\amalg(R / L)\left[p^{\infty}\right]\right| \bmod \square$ to the torsion subgroup of $R$ and the rank of $A / L$.

Lemma 2.5. Let $L / K$ be a number field extension such that $L \otimes_{K} F$ is a field. Then, the following hold.
(1) For all odd primes $q \neq p,\left|Ш_{0}(R / L)\left[q^{\infty}\right]\right|=\square$
(2) If, in addition, $A$ is an elliptic curve, $\left|Ш_{0}(R / L)\left[2^{\infty}\right]\right|=\square$.

Proof. By Lemma 2.4, $\operatorname{deg}(\phi)=p^{2 \operatorname{dim}(A)}$. When $q \neq p$, this isogeny induces an isomorphism $Ш_{0}(A / L)\left[q^{\infty}\right] \times Ш_{0}(R / L)\left[q^{\infty}\right] \xrightarrow{\sim} Ш_{0}(B / L)\left[q^{\infty}\right]$. Since $A$ and $B$ are principally polarised, [10, Theorem 8] asserts that $\amalg_{0}(A / L)\left[q^{\infty}\right]$ and $Ш_{0}(B / L)\left[q^{\infty}\right]$ are both of square order for all odd $q$. This proves (1). Further, by [2, Proposition A.5.2], $B_{L} \cong \operatorname{Res}_{L}^{L \otimes_{K} F} A$, and by combining [8, pp. 178(a)] with Shapiro's Lemma, $Ш_{0}(B / L)\left[2^{\infty}\right] \cong Ш_{0}\left(A / L \otimes_{K} F\right)\left[2^{\infty}\right]$. Therefore, if $A$ is an elliptic curve, both $\amalg_{0}(A / L)\left[2^{\infty}\right]$ and $Ш_{0}(B / L)\left[2^{\infty}\right]$ are of square order by [10, Theorem 8, Corollary 12]. Claim (2) follows.

In what follows, we write $\mathrm{rk}_{p}(A / K)$ for the $\mathbb{Z}_{p}$-corank of the $p^{\infty}$-Selmer $\operatorname{group} \operatorname{Sel}_{p^{\infty}}(A / K):=\underset{\rightarrow}{\lim _{n \geq 1}} \operatorname{Sel}_{p^{n}}(A / K)$. This coincides with the MordellWeil rank of $A$ plus the multiplicity of $\mathbb{Q}_{p} / \mathbb{Z}_{p}$ in its Tate-Shafarevich group.
Proposition 2.6. Let $L / K$ be a quadratic extension such that all bad primes of $A / K$ and all primes dividing either $\operatorname{deg}(\phi)$ or the relative discriminant $\Delta(F / K)$ split in $L$. Then, the following hold.
(1) Up to rational squares,

$$
\left|Ш_{0}(R / L)\left[p^{\infty}\right]\right| \equiv \frac{Q\left(\phi_{L}\right)}{Q\left(\phi_{L}^{\vee}\right)} \frac{\left|R(L)\left[p^{\infty}\right]\right|}{\left|R^{\vee}(L)\left[p^{\infty}\right]\right|} \bmod \square .
$$

(2) If, in addition, $\operatorname{rk}_{p}(A / L)=\operatorname{rk}_{p}\left(A / L \otimes_{K} F\right)$, then

$$
\left|Ш_{0}(R / L)\left[p^{\infty}\right]\right| \equiv p^{\mathrm{rk}}(A / L) \frac{\left|R(L)\left[p^{\infty}\right]\right|}{\left|R^{\vee}(L)\left[p^{\infty}\right]\right|} \bmod \square .
$$

Proof. Let $v$ be a place of bad reduction for $B / K$. By [8, Proposition 1], this can only happen when $A / K$ has bad reduction at $v$ or when $v \mid$ $\Delta(F / K)$. This shows that all bad primes of $B / K$ split in $L$. Since $A / K$ is principally polarised, $\left|A(L)\left[p^{\infty}\right]\right|=\left|A^{\vee}(L)\left[p^{\infty}\right]\right|$ and $\left|Ш_{0}(A / L)\left[p^{\infty}\right]\right|=$ $\left|Ш_{0}\left(A^{\vee} / L\right)\left[p^{\infty}\right]\right|$. The same holds for $B$. Part (1) follows by combining Lemma 2.3 and Lemma 2.4. For the second claim, it suffices to show that if $\mathrm{rk}_{p}(A / L)=\mathrm{rk}_{p}\left(A / L \otimes_{K} F\right)$, then $Q\left(\phi_{L}\right) / Q\left(\phi_{L}^{\vee}\right)=p^{\mathrm{rk}}(A / L)$. After suppressing the principal polarisations $A=A^{\vee}, B=B^{\vee}$, we view $\phi^{\vee}$ as a morphism $B \rightarrow A \times R^{\vee}$. Therefore, $\frac{Q\left(\phi_{L}\right)}{Q\left(\phi_{L}^{\vee}\right)} \equiv Q\left(\phi_{L}^{\vee} \circ \phi_{L}: A \times R \rightarrow A \times R^{\vee}\right) \bmod \square$. Since the degree of $\phi^{\vee} \circ \phi$ is a power of $p$, it induces an isomorphism $\amalg(A \times R / L)_{\operatorname{div}}\left[q^{\infty}\right] \xrightarrow[\rightarrow]{\sim} \amalg\left(A \times R^{\vee} / L\right)_{\text {div }}\left[q^{\infty}\right]$ for $q \neq p$. From this, we deduce $\operatorname{ker}\left(\phi_{L}^{\vee} \circ \phi_{L} \mid Ш_{\text {div }}\right)=\operatorname{ker}\left(\phi_{L}^{\vee} \circ \phi_{L} \mid Ш_{\text {div }}\left[p^{\infty}\right]\right)$. Since $B_{L} \cong \operatorname{Res}_{L}^{L \otimes_{K} F} A$ (see [2, Proposition A.5.2]), then by combining [8, pp. 178(a)] with Shapiro's Lemma gives $\operatorname{Sel}_{p \infty}(B / L) \cong \operatorname{Sel}_{p \infty}\left(A / L \otimes_{K} F\right)$. By assumption, $\operatorname{rk}_{p}(A / L)=$ $\operatorname{rk}_{p}\left(A / L \otimes_{K} F\right)$, from which we deduce $\operatorname{rk}_{p}(R / L)=\operatorname{rk}_{p}\left(R^{\vee} / L\right)=0$. As a result, $Q\left(\phi_{L}^{\vee} \circ \phi_{L}\right)$ coincides with $Q\left(i_{L}^{\vee} \circ i_{L}\right)$, where we view $i_{L}^{\vee} \circ i_{L}$ as an endomorphism of $A_{L}$. Using the description of $i$ and $i^{\vee}$ from $\S 2.2, i^{\vee} \circ i=[p]_{A}$. This gives the required result.

## 3. Ш of non-Square order

We retain all the notation from §2. In this section, we restrict to the case when $A=E$ is an elliptic curve, and so $R$ is an abelian variety of dimension $p-1$. In addition, we fix the following notation.

Notation 3.1. We write $K_{\infty}$ to denote the cyclotomic $\mathbb{Z}_{p}$-extension of $\mathbb{Q}$, and $K_{n}=\mathbb{Q}\left(\zeta_{p^{n}}+\zeta_{p^{n}}^{-1}\right)$ for the $n^{\text {th }}$ layer of this extension. For $d$ a positive, square-free integer, we let $L_{n}=K_{n} \cdot \mathbb{Q}(\sqrt{-d})$.

We first show that for $n$ sufficiently large, $\amalg\left(R / L_{n}\right)$ is finite for any choice of $d$. Further, having carefully selected $d$, we show that $\left|Ш\left(R / L_{n}\right)\right| \equiv$ $p \bmod \square$. We begin by proving a lemma involving torsion on $R$ and $R^{\vee}$.

Lemma 3.2. Let $E$ be an elliptic curve defined over $\mathbb{Q}$. Then, for any $n \geq 0$ and any prime $p \geq 11$ both $R\left(L_{n}\right)\left[p^{\infty}\right]$ and $R^{\vee}\left(L_{n}\right)\left[p^{\infty}\right]$ are trivial.

Proof. As abelian varieties over $L_{n+1}$, both $R$ and $R^{\vee}$ are isomorphic to $E^{p-1}$. It therefore suffices to show that $E\left(L_{n+1}\right)\left[p^{\infty}\right]$ is trivial for $p \geq 11$. Let $E_{-d}$ be the quadratic twist of $E$ by $-d$. Then, there exists a map $E\left(L_{n+1}\right) \rightarrow E\left(K_{n+1}\right) \times E_{-d}\left(K_{n+1}\right)$ whose kernel and cokernel are 2-groups. Then, for any odd prime $p$, this induces an isomorphism

$$
E\left(L_{n+1}\right)\left[p^{\infty}\right] \xrightarrow{\sim} E\left(K_{n+1}\right)\left[p^{\infty}\right] \times E_{-d}\left(K_{n+1}\right)\left[p^{\infty}\right] .
$$

By [1, Theorem 1.1], $E\left(K_{\infty}\right)\left[p^{\infty}\right]=E(\mathbb{Q})\left[p^{\infty}\right]$ (similarly for $E_{-d}$ ) for any $p \geq 5$. If $p \geq 11$, Mazur's theorem [7, Theorem 2] asserts that $E(\mathbb{Q})\left[p^{\infty}\right]$ and $E_{-d}(\mathbb{Q})\left[p^{\infty}\right]$ are both trivial. Therefore, $E\left(L_{n+1}\right)\left[p^{\infty}\right]$ is trivial.

The following result is a formal consequence of a theorem by Kato and Rohrlich.

Theorem 3.3. Let $E$ be an elliptic curve defined over $\mathbb{Q}$. Then, there exists a positive integer $n$ such that
(1) $\operatorname{ord}_{s=1} L\left(E / L_{n}, s\right)=\operatorname{ord}_{s=1} L\left(E / L_{n+1}, s\right)$,
(2) $\amalg\left(R / L_{n}\right)$ is finite,
(3) $\operatorname{rk}_{p}\left(E / L_{n+1}\right)=\operatorname{rk}_{p}\left(E / L_{n}\right)$.

Proof. As $E$ is defined over $\mathbb{Q}, \operatorname{Res}_{K_{n}}^{L_{n}} E$ is isogenous to $E \times E_{-d}$ giving an equality of $L$-functions

$$
L\left(E / L_{n}, s\right)=L\left(E / K_{n}, s\right) L\left(E_{-d} / K_{n}, s\right)
$$

By Rohrlich [11, pp. 409], the sequence $\left\{\operatorname{ord}_{s=1} L\left(E / K_{n}, s\right)\right\}_{n \geq 1}$ stabilises (similarly for $E_{-d}$ ), and so $\operatorname{ord}_{s=1} L\left(E / L_{n}, s\right)=\operatorname{ord}_{s=1} L\left(E / L_{n+1}, s\right)$ for $n$ sufficiently large. This proves (1). Part (2) is a consequence of a result by Kato [5]. Following the notation introduced there, for $G$ an abelian group, $\tau \in \widehat{G}$, and a $G$-module $M$, we let $M^{(\tau)}:=\left\{x \in M: I_{\tau} \cdot x=0\right\}$ where $I_{\tau} \subseteq \mathbb{Z}[G]$ denotes the kernel of the map $\mathbb{Z}[G] \rightarrow \mathbb{C}^{\times}$induced by $\tau$. We apply this to $G=\operatorname{Gal}\left(L_{n+1} / \mathbb{Q}\right) \cong \mathbb{Z} / 2 p^{n+1} \mathbb{Z}$. For brevity, we write $H=\operatorname{Gal}\left(L_{n+1} / L_{n}\right) \cong \mathbb{Z} / p \mathbb{Z}$. Further, the composition $i \circ \operatorname{Tr}$ from $\S 2.2$ is equal to $N_{H}:=\sum_{h \in H} h$ viewed as a $K$-endomorphism of $B$. It follows that the composition $R \hookrightarrow B \xrightarrow{N_{H}} B$ is the zero map, which in turn gives a homomorphism $\amalg\left(R / L_{n}\right) \rightarrow \operatorname{ker}\left(N_{H} \mid \amalg\left(E / L_{n+1}\right)\right)$. We claim this has finite kernel. To see this, we look at the short exact sequence of abelian varieties

$$
0 \rightarrow R \rightarrow B \xrightarrow{\operatorname{Tr}} E \rightarrow 0 .
$$

Taking Galois cohomology gives an exact sequence

$$
0 \rightarrow E\left(L_{n}\right) / \operatorname{Norm}_{L_{n}}^{L_{n+1}} E\left(L_{n+1}\right) \rightarrow H^{1}\left(L_{n}, R\right) \rightarrow H^{1}\left(L_{n}, B\right)
$$

By the Mordell-Weil theorem $E\left(L_{n}\right) / p E\left(L_{n}\right)$ is finite, from which we deduce that $E\left(L_{n}\right) / \operatorname{Norm}_{L_{n}}^{L_{n+1}} E\left(L_{n+1}\right)$ must be finite. Therefore, the induced map $\amalg\left(R / L_{n}\right) \rightarrow \operatorname{ker}\left(N_{H} \mid \amalg\left(E / L_{n+1}\right)\right)$ has finite kernel. For a primitive character $\tau \in \widehat{G}$, we have $N_{H} \in I_{\tau}$. Therefore, for such $\tau, \operatorname{ker}\left(N_{H} \mid \amalg\left(E / L_{n+1}\right)\right) \subseteq$ $\amalg\left(E / L_{n+1}\right)^{(\tau)}$. By Artin formalism,

$$
L\left(E / L_{n+1}, s\right)=L\left(E / L_{n}, s\right) \prod_{\substack{\chi \in \widehat{H} \\ \chi \neq \mathrm{id}}} L\left(E / L_{n}, \chi, s\right)
$$

We let $n$ be as in part (1) and $\chi$ a non-trivial character of $H$. Then, $L\left(E / L_{n}, \chi, s\right)=L\left(E / \mathbb{Q}, \operatorname{Ind}_{H}^{G} \chi, 1\right) \neq 0$. Therefore, $L(E / \mathbb{Q}, \tau, 1) \neq 0$ for all primitive characters $\tau \in \widehat{G}$. Then, by [5, Corollary 14.3], the $\tau$-part $\left(\amalg_{n+1}\right)^{(\tau)}$ is finite for all primitive $\tau \in \widehat{G}$. This completes the proof of (2). For (3), it suffices to show that $R\left(L_{n}\right)$ is finite. This follows in the same way as (2).

Theorem 3.4. Let $p \geq 11$ be a prime. Then, there exists an abelian extension $L / \mathbb{Q}$ and an abelian variety $R / L$ such that $|\amalg(R / L)|=p \cdot \square$.

Proof. We let $E / \mathbb{Q}$ be an elliptic curve defined over $\mathbb{Q}$ and $d$ a positive integer such that $p$ and all bad primes of $E / \mathbb{Q}$ split in $\mathbb{Q}(\sqrt{-d})$. For the remainder of this proof, we fix $n$ as in Theorem 3.3 so that $\operatorname{rk}_{p}\left(E / L_{n+1}\right)=\operatorname{rk}_{p}\left(E / L_{n}\right)$ and $\amalg\left(R / L_{n}\right)$ is finite. In view of Lemma 2.5(1)-(2), we deduce that $\left|\amalg\left(R / L_{n}\right)\right| \equiv\left|Ш_{0}\left(R / L_{n}\right)\left[p^{\infty}\right]\right|$. Combining this with Proposition 2.6(2) (applied with $K=K_{n}, F=K_{n+1}, L=L_{n}$ ) and Lemma 3.2, we get

$$
\left|Ш\left(R / L_{n}\right)\right| \equiv p^{\mathrm{rk} p\left(E / L_{n}\right)} \bmod \square .
$$

Since $E$ is defined over $\mathbb{Q}$, its global root number $\omega(E / \mathbb{Q}(\sqrt{-d}))=-1$. This is because the only contribution in the root number computation comes from the unique archimedean place of $\mathbb{Q}(\sqrt{-d})$. Since $\operatorname{Res}_{\mathbb{Q}}^{\mathbb{Q}(\sqrt{-d})} E$ is isogenous to $E \times E_{-d}$, we deduce that

$$
(-1)^{\mathrm{rk}_{p}(E / \mathbb{Q}(\sqrt{-d}))}=(-1)^{\mathrm{rk}_{p}(E / \mathbb{Q})}(-1)^{\mathrm{rk}_{p}\left(E_{-d} / \mathbb{Q}\right)} \stackrel{[3, \mathrm{Thm}}{=}{ }^{1.4]} w(E / \mathbb{Q}) w\left(E_{-d} / \mathbb{Q}\right) .
$$

In view of the isogeny, $w(E / \mathbb{Q}(\sqrt{-d}))=w(E / \mathbb{Q}) w\left(E_{-d} / \mathbb{Q}\right)$, from which we deduce that $\mathrm{rk}_{p}(E / \mathbb{Q}(\sqrt{-d})) \equiv 1 \bmod 2$. Since the parity of $p^{\infty}$-Selmer ranks remains unchanged in odd degree Galois extensions [3, Corollary 4.15], then $\operatorname{rk}_{p}\left(E / L_{n}\right) \equiv \operatorname{rk}_{p}(E / \mathbb{Q}(\sqrt{-d})) \equiv 1 \bmod 2$. Combining this with $(\dagger)$ gives the required result.

Theorem 3.5. Let $p$ be a rational prime. Then, there exists an abelian variety $R^{\prime} / \mathbb{Q}$ such that $\left|\amalg\left(R^{\prime} / \mathbb{Q}\right)\right|=p$. $\qquad$
Proof. For $p \geq 11$, we consider $R^{\prime}=\operatorname{Res}_{\mathbb{Q}}^{L} R$ where $R$ is the abelian variety from Theorem 3.4. Since $\amalg\left(R^{\prime} / \mathbb{Q}\right) \cong Ш(R / L)$ (combine Shapiro's lemma with [8, pp. 178(a)]), the result follows by Theorem 3.4. For $p \leq 7$, see [10] and [13].

Corollary 3.6. For every positive square-free integer $n$, there exists an abelian variety defined over $\mathbb{Q}$ with finite Tate-Shafarevich group of order $n$. $\square$.

Proof. Given abelian varieties $A_{1}, A_{2}, \amalg\left(A_{1} \times A_{2}\right) \cong \amalg\left(A_{1}\right) \times \amalg\left(A_{2}\right)$. The result follows from Theorem 3.5.
