# HAUSDORFF DIMENSION OF SOME EXCEPTIONAL SETS IN LÜROTH EXPANSIONS

ABSTRACT. In this paper, we study the metrical theory of the growth rate of digits in Lüroth expansions. More precisely, for  $x \in (0,1]$ , let  $[d_1(x), d_2(x), \cdots]$  denote the Lüroth expansion of x, we completely determine the Hausdorff dimension of the following sets

$$E_{\sup}\left(\psi\right) = \left\{x \in (0,1] : \limsup_{n \to \infty} \frac{\log d_n\left(x\right)}{\psi\left(n\right)} = 1\right\},\,$$

$$E\left(\psi\right) = \left\{x \in \left(0, 1\right] : \lim_{n \to \infty} \frac{\log d_n\left(x\right)}{\psi\left(n\right)} = 1\right\}$$

and

$$E_{\inf}\left(\psi\right)=\Big\{x\in\left(0,1\right]: \liminf_{n\rightarrow\infty}\frac{\log d_{n}\left(x\right)}{\psi\left(n\right)}=1\Big\},$$

where  $\psi: \mathbb{N} \to \mathbb{R}^+$  is an arbitrary function satisfying  $\psi(n) \to \infty$  as  $n \to \infty$ .

## 1. Introduction

In 1883, Lüroth [8] introduced the Lüroth expansion. The Lüroth transformation  $T:(0,1] \rightarrow (0,1]$  is defined as follows:

(1.1) 
$$T(x) := d_1(x) (d_1(x) - 1) \left( x - \frac{1}{d_1(x)} \right),$$

where  $d_1(x) = \lfloor \frac{1}{x} \rfloor + 1$  ( $\lfloor \cdot \rfloor$  denotes the largest integer not exceeding a real number). Through this algorithm very real number  $x \in (0,1]$  can be uniquely expanded into an infinite seris as

(1.2) 
$$x = \frac{1}{d_1(x)} + \frac{1}{d_1(x) (d_1(x) - 1) d_2(x)} + \cdots + \frac{1}{d_1(x) (d_1(x) - 1) \cdots d_{n-1}(x) (d_{n-1}(x) - 1) d_n(x)} + \cdots,$$

where  $d_n(x) = d_1(T^{n-1}(x))$   $(n \ge 2)$ . Such a series (1.2) is called the Lüroth expansion of x and written as

$$x = [d_1(x), d_2(x), \cdots],$$

where  $d_n(x)$   $(n \ge 1)$  are called the digits of the Lüroth expansion of x. Lüroth [8] showed that each rational number has an infinite periodic expansion of the form (1.2) and every irrational number has a unique infinite expansion. For any  $n \in \mathbb{N}$ , the n-th partial sum of (1.2)

$$\frac{p_n(x)}{q_n(x)} := \frac{1}{d_1(x)} + \frac{1}{d_1(x)(d_1(x) - 1)d_2(x)} + \cdots$$

$$+ \frac{1}{d_1(x) (d_1(x) - 1) \cdots d_{n-1}(x) (d_{n-1}(x) - 1) d_n(x)}$$

is called the n-th convergent of the Lüroth expansion of x.

The metrical theory of Lüroth expansions is one of the major subjects in the study of Lüroth expansions. It concerns the properties of the digits for almost all  $x \in (0,1]$ . For some certain sets defined in terms of the frequency of digits in Lüroth expansions, Barreira, Iommi [2] and Fan et al. [5] completely determined their Hausdorff dimension. In [13], Sun and Xu studied the asymptotic behaviour of the maximal run-length function in Lüroth expansions, and obtained its metrical property. The following Borel-Bernstein theorem is important for the study of the metrical theory of Lüroth expansions.

**Theorem 1.1** (Borel-Bernstein). Let  $\phi : \mathbb{N} \to \mathbb{R}^+$  be an arbitrary function and

$$F_{\phi} = \left\{ x \in (0,1] : d_n(x) \geqslant \phi(n) \text{ for infinitely many } n \in \mathbb{N} \right\},$$

then,  $F_{\phi}$  has Lerbesgue measure zero if  $\sum_{n=1}^{\infty} \frac{1}{\phi(n)}$  converges and has full Lebesgue measure otherwise.

The earliest research for exceptional sets of Borel-Bernstein Theorem in Lüroth expansions was considered by Šalát [9]. For any  $k \in \mathbb{N}$ , he obtained the Hausdorff dimension of the set

$$M_k = \left\{ x \in (0,1] : d_n(x) = k, n = 1, 2, \dots \right\}.$$

In [11], Shen and Fang investigated the Hausdorff dimension of the Cantor set

$$\left\{ x \in (0,1] : d_n(x) \geqslant \varphi(n) \text{ for any } n \geqslant 1 \right\},$$

where  $\varphi(n): \mathbb{N} \to \mathbb{R}^+$  satisfying  $\lim_{n \to \infty} \varphi(n) = \infty$ . Furthermore, Shen [10] studied the size of the set

$$\left\{ x\in\left(0,1\right]\,:\,d_{n}\left(x\right)\geqslant\varphi\left(n\right)\text{ for infinitely many }n\in\mathbb{N}\right\}$$

in the sense of the Hausdorff dimension.

The Lüroth expansion has a tight connection with classical Diophantine approximation, which focus on the question of how well a real number can be approximated by rational numbers. For instance, Cao, Wu, Zhang [3] proved that the Jarník-like set

$$\mathcal{J}(\beta) := \left\{ x \in (0,1] : \left| x - \frac{p_n(x)}{q_n(x)} \right| < \frac{1}{q_n(x)^{(\beta+1)}} \text{ for infintely many } n \in \mathbb{N} \right\}$$

and the set

$$\widetilde{\mathcal{J}}(\beta) := \left\{ x \in (0,1] : \limsup_{n \to \infty} \frac{\log d_n(x) d_{n+1}(x)}{\log q_n(x)} \ge \beta \right\}$$

share the Hausdorff dimension when  $\beta \geq 0$ . That is,  $\dim_H \mathcal{J}(\beta) = \dim_H \widetilde{\mathcal{J}}(\beta) = \frac{1}{\beta+1}$ , where  $\dim_H$  denotes the Hausdorff dimension. Furthermore, Tan and Zhou [14] studied the metircal properties of the sets

$$\mathcal{J}(\tau) := \left\{ x \in (0,1] : \left| x - \frac{p_n(x)}{q_n(x)} \right| < \frac{1}{q_n(x)^{(\beta+1)}} \text{ for } n \in \mathbb{N} \text{ ultimately} \right\}$$

and

$$\widetilde{\mathcal{J}}'(\tau) := \Big\{ x \in (0,1] : \lim_{n \to \infty} \frac{\log d_n(x) d_{n+1}(x)}{\log q_n(x)} = \tau \Big\}.$$

More precisely, they proved that  $\dim_H \mathcal{J}'(\tau) = \dim_H \widetilde{\mathcal{J}}'(\tau)$  when  $\tau \geq 0$ . And the dimension admits a dichotomy: it is either  $\frac{1}{\tau+2}$  or 1 according to  $\tau > 0$  or  $\tau = 0$ .

In this paper, we continue the study of exceptional sets of Borel-Bernstein Theorem in Lüroth expansions. Firstly, we investigate the Hausdorff dimension of the set

$$E_{\sup}(\psi) = \left\{ x \in (0,1] : \limsup_{n \to \infty} \frac{\log d_n(x)}{\psi(n)} = 1 \right\}.$$

**Theorem 1.2.** Let  $\psi: \mathbb{N} \to \mathbb{R}^+$  be an arbitrary function satisfying  $\lim_{n \to \infty} \psi(n) = \infty$ , we have

- (i) if  $\lim_{n\to\infty} \frac{\psi(n)}{n} = 0$ , then  $\dim_{\mathcal{H}} E_{\sup}(\psi) = 1$ .
- (ii) if  $\liminf_{n\to\infty} \frac{\psi(n)}{n} = \alpha (0 < \alpha < \infty)$ , then  $\dim_{\mathbf{H}} E_{\sup}(\psi) = H(\alpha)$ , where

$$H(\alpha) = \dim_{\mathbf{H}} \{ x \in (0,1] : d_n(x) \geqslant e^{\alpha n} \text{ for infinitely many } n \in \mathbb{N} \}.$$

(iii) if  $\lim_{n\to\infty} \frac{\psi(n)}{n} = \infty$ , then  $\dim_{\mathrm{H}} E_{\sup}(\psi) = \frac{1}{1+A}$ , where A is given by

$$\log A := \liminf_{n \to \infty} \frac{\log \psi(n)}{n}.$$

We also consider the Hausdorff demension of the sets

$$E(\psi) = \left\{ x \in (0,1] : \lim_{n \to \infty} \frac{\log d_n(x)}{\psi(n)} = 1 \right\}$$

and

$$E_{\inf}(\psi) = \left\{ x \in (0,1] : \liminf_{n \to \infty} \frac{\log d_n(x)}{\psi(n)} = 1 \right\}.$$

**Theorem 1.3.** Let  $\psi: \mathbb{N} \to \mathbb{R}^+$  be an arbitrary function satisfying  $\lim_{n \to \infty} \psi(n) = \infty$ , then

$$\dim_{\mathbf{H}} E\left(\psi\right) = \frac{1}{2+\eta},$$

where  $\eta$  is defined as

$$\eta := \limsup_{n \to \infty} \frac{\psi(n+1)}{\psi(1) + \dots + \psi(n)}.$$

**Theorem 1.4.** Let  $\psi: \mathbb{N} \to \mathbb{R}^+$  be an arbitrary function satisfying  $\lim_{n \to \infty} \psi(n) = \infty$ , then

$$\dim_{\mathbf{H}} E_{\inf}(\psi) = \frac{1}{1+V},$$

where V is given by

$$\log V := \limsup_{n \to \infty} \frac{\log \psi(n)}{n}.$$

The paper is organized as follows. In the next section, we present some elementary properties of Lüroth expansions and some auxiliary lemmas. Section 3 is devoted to showing the proof of Theorem 1.2. In Section 4, we prove Theorem 1.3 and Theorem 1.4.

### 2. Preliminaries

In this section, we racall some elementary properties of Lüroth expansions and some useful lemmas that will be used later.

**Definition 2.1.** A subsequence  $\{d_n\}_{n\geqslant 1}$  of  $\mathbb{N}$  is said to be admissible if there exists  $x\in (0,1]$  such that

$$d_n(x) = d_n \text{ for } n \geqslant 1.$$

**Lemma 2.2** (See [7]). A sequence  $\{d_n\}_{n\geqslant 1}$  of positive integers is admissible if and only if  $d_n\geqslant 2$  for  $n\geqslant 1$ .

For  $n \geq 1$ , we denote by  $\Sigma_n$  the collection of all admissible words of length n, i.e.,

$$\Sigma_n = \{ (d_1, \dots, d_n) : d_j \geqslant 2 \text{ for } 1 \leqslant j \leqslant n \}.$$

**Definition 2.3.** For any  $n \ge 1$  and  $(d_1, \dots, d_n) \in \Sigma_n$ , define

$$I(d_1, \dots, d_n) = \{x \in (0,1] : d_1(x) = d_1, \dots, d_n(x) = d_n\}$$

and call it a n-th order cylinder of Lüroth expansion.

**Proposition 2.4** (See [7]). The n-th order cylinder  $I(d_1, \dots, d_n)$  is the interval with the left endpoint

$$\frac{1}{d_1} + \frac{1}{d_1(d_1 - 1)d_2} + \dots + \prod_{k=1}^{n-1} \frac{1}{d_k(d_k - 1)} \frac{1}{d_n}$$

and right endpoint

$$\frac{1}{d_1} + \frac{1}{d_1(d_1 - 1)d_2} + \dots + \prod_{k=1}^{n-1} \frac{1}{d_k(d_k - 1)} \frac{1}{d_n} + \prod_{k=1}^n \frac{1}{d_k(d_k - 1)}.$$

Futhermore, one has

(2.1) 
$$|I(d_1, \dots, d_n)| = \prod_{k=1}^n \frac{1}{d_k(d_k - 1)}.$$

In this context, we use the symbol " $|\cdot|$ " to denote the length of an interval.

For convinience, we write

$$Q_n(x) := \prod_{k=1}^n d_k(x) (d_k(x) - 1).$$

**Lemma 2.5.** For any  $x \in (0,1]$ ,  $Q_n(x) \ge 2^n$ .

*Proof.* Since  $d_n(x) \ge 2$  for all  $n \ge 1$ , then

$$Q_n(x) = \prod_{k=1}^n d_k(x) (d_k(x) - 1) \geqslant \prod_{k=1}^n 2 \cdot (2 - 1) = 2^n.$$

For any integer  $M \geqslant 2$ , we set

$$E_{M} = \Big\{ x \in (0,1] : 2 \leqslant d_{n}\left(x\right) \leqslant M \text{ for any } n \in \mathbb{N} \Big\}.$$

The following lemma gives the Hausdorff dimension of  $E_M$ .

**Lemma 2.6** (See [12]). For the Lüroth expansion, let S(M) be the solution of the equation

$$\sum_{k=2}^{M} \left( \frac{1}{k(k-1)} \right)^{s} = 1,$$

then  $\dim_{\mathbf{H}} E_M = S(M)$ .

**Lemma 2.7.** For S(M) defined in Lemma 2.6, we have

$$0 \leqslant S(M) < 1$$
 and  $\lim_{M \to \infty} S(M) = 1$ .

Proof. Consider

$$\sum_{k=2}^{M} \frac{1}{k \left(k-1\right)} = 1 - \frac{1}{M} < 1 \text{ and } \sum_{k=2}^{M} \left(\frac{1}{k \left(k-1\right)}\right)^{0} = M - 1 \geqslant 1,$$

then

$$0 \leqslant S(M) < 1$$

since  $\left(\frac{1}{k(k-1)}\right)^s$  is decreasing with respect to  $s \in [0, \infty)$ .

For any  $\epsilon > 0$ , we set  $m = \lceil 1 + \frac{1}{2^{\epsilon} - 1} \rceil$ , where  $\lceil \cdot \rceil$  represents the samllest integer not less than a real number. Then for any M > m, we have

$$\begin{split} \sum_{k=2}^{M} \left(\frac{1}{k\left(k-1\right)}\right)^{1-\epsilon} &= \sum_{k=2}^{M} \left(\frac{1}{k\left(k-1\right)}\right) \left(k\left(k-1\right)\right)^{\epsilon} \\ &> 2^{\epsilon} \sum_{k=2}^{M} \frac{1}{k\left(k-1\right)} \\ &= 2^{\epsilon} \left(1 - \frac{1}{M}\right) \end{split}$$

Hence  $S(M) > 1 - \epsilon$ . Conbine this and S(M) < 1, we have  $\lim_{M \to \infty} S(M) = 1$ .

**Lemma 2.8.** For  $H(\alpha)$  defined in Theorem 1.2, let G(B) be the unique solution of the equation

$$\sum_{k=2}^{\infty} \left( \frac{1}{Bk(k-1)} \right)^s = 1,$$

then

$$H(\alpha) = G(e^{\alpha}).$$

Furthermore,  $H(\alpha)$  is continuous with respect to  $\alpha \in (0, \infty)$  and we have

$$\lim_{\alpha \to 0^{+}} H(\alpha) = 1, \lim_{\alpha \to \infty} H(\alpha) = \frac{1}{2}.$$

*Proof.* For any B>1, according to Lemma 2.3 of [10], G(B) is continuous with respect to  $B\in (1,\infty)$  and

$$\lim_{B \to 1^{+}} G(B) = 1 \text{ and } \lim_{B \to \infty} G(B) = \frac{1}{2}.$$

Put  $B = e^{\alpha} > 1$ , by Theorem 4.2 of [10], it follows that  $H(\alpha) = G(e^{\alpha})$ , then  $H(\alpha)$  is continuous with respect to  $\alpha \in (0, \infty)$ . Moreover, we have

$$\lim_{\alpha \to 0^{+}} H(\alpha) = 1 \text{ and } \lim_{\alpha \to \infty} H(\alpha) = \frac{1}{2}.$$

The following results is useful to estimate the lower bound of Hausdorff dimension for some sets.

**Lemma 2.9** (See [1]). Let  $\{u_n\}_{n\geqslant 1}$  be a subsequence of  $\mathbb{N}$  with  $u_n\geq 4$  for any  $n\geq 1$  and  $\lim_{n\to\infty}u_n=\infty$ , then for any integer  $N\geq 2$ , one has

$$\dim_{\mathbf{H}} \left\{ x \in (0,1] : u_n \leqslant d_n \left( x \right) \leqslant N u_n - 1 \text{ for any } n \in \mathbb{N} \right\} = u_0,$$

where

$$u_0 := \liminf_{n \to \infty} \frac{\log(u_1 \cdots u_n)}{2\log(u_1 \cdots u_n) + \log u_{n+1}}.$$

**Proposition 2.10** (See [4]). Let  $E \subseteq \mathbb{R}^n$ , suppose that  $f: E \to \mathbb{R}^m$  satisfies the Hölder condition  $|f(x) - f(y)| \le c|x - y|^{\alpha}$   $(x, y \in E)$ ,

where c is a constant. Then

$$\dim_{\mathrm{H}} f(E) \leq \frac{1}{\alpha} \dim_{\mathrm{H}} E.$$

## 3. PROOF OF THEOREM 1.2

Recall that

$$E_{\sup}(\psi) = \left\{ x \in (0,1] : \limsup_{n \to \infty} \frac{\log d_n(x)}{\psi(n)} = 1 \right\}.$$

We consider the following cases:

Case I:  $\lim_{n\to\infty} \frac{\psi(n)}{n} = 0.$ 

In this case, the upper bound follows trivially by noting that  $E_{\sup}(\psi) \subseteq (0,1]$ . We only focus on the lower bound of the Hausdorff dimension of  $E_{\sup}(\psi)$ . The lower bound is obtained by constructing a Cantor subset  $E_M(\psi)$  of  $E_{\sup}(\psi)$ .

Let  $\{m_k\}_{k\geqslant 1}$  be a subequence of  $\mathbb N$  with  $m_k=2^k$  for all  $k\geqslant 1$ , and for any integer  $M\geq 2$ , define

$$E_{M}\left(\psi\right)=\Big\{x\in\left(0,1\right]:d_{m_{k}}\left(x\right)=\left\lfloor \mathrm{e}^{\,\psi\left(m_{k}\right)}\,\right\rfloor+1\text{ and }2\leq d_{i}\left(x\right)\leq M\left(i\neq m_{k}\text{ for any }k\geq1\right)\Big\}.$$

It is clear that  $E_M(\psi) \subseteq E_{\sup}(\psi)$ .

Now, we estimate the lower bound of the Huasdorff dimension of  $E_M(\psi)$ . Firstly, we use the language of symbolic space to describe  $E_M(\psi)$ . For any integer  $n \ge 1$ , define

$$C_n = \left\{ (\sigma_1, \dots, \sigma_n) \in \Sigma_n : \sigma_{m_k} = \lfloor e^{\psi(m_k)} \rfloor + 1 \text{ and } 2 \le \sigma_i \le M, 1 \le i \ne m_k \le n \right\}.$$

For any integer  $n \ge 1$  and  $(\sigma_1, \dots, \sigma_n) \in C_n$ , the *n*-th basic interval is defined as follows:

(3.1) 
$$J_n(\sigma_1, \dots, \sigma_n) = \bigcup_{(\sigma_1, \dots, \sigma_n, \sigma_{n+1}) \in C_{n+1}} I_{n+1}(\sigma_1, \dots, \sigma_n, \sigma_{n+1}).$$

Obviously,

$$(3.2) E_M(\psi) = \bigcap_{n \ge 1} \bigcup_{(\sigma_1, \dots, \sigma_n) \in C_n} I_n(\sigma_1, \dots, \sigma_n) = \bigcap_{n \ge 1} \bigcup_{(\sigma_1, \dots, \sigma_n) \in C_n} J_n(\sigma_1, \dots, \sigma_n).$$

Let  $t(n) = \#\{k \in \mathbb{N} : 2^k \le n\}$ , where the symbol "#" denotes the cardinality of a set. It is easy to see that  $t(n) \le \lfloor \log_2 n \rfloor \le \log_2 n$ , then we have

$$\lim_{n \to \infty} \frac{t(n)}{n} = 0.$$

For any  $(\sigma_1, \dots, \sigma_n) \in C_n$ , let  $(\sigma_1, \dots, \sigma_n)^*$  be the block obtained by eliminating the terms  $\{\sigma_{m_k} : 1 \leq k \leq t (n)\}$  in  $(\sigma_1, \dots, \sigma_n)$ . Obviously,

$$(\sigma_1, \dots, \sigma_n)^* \in \{2, 3, \dots, M\}^{n-t(n)}$$
.

For simplicity, we write

$$(3.4) I_n^*(\sigma_1, \cdots, \sigma_n) := I_{n-t(n)}(\sigma_1, \cdots, \sigma_n)^*.$$

Since  $\lim_{n\to\infty} \frac{\psi(n)}{n} = 0$ , then

$$0 \leqslant \limsup_{n \to \infty} \frac{1}{n} \sum_{k=1}^{t(n)} \psi\left(m_k\right) \leqslant \limsup_{n \to \infty} \frac{1}{2^{t(n)}} \sum_{k=1}^{t(n)} \psi\left(2^k\right) \leqslant \limsup_{n \to \infty} \frac{1}{2^n} \sum_{k=1}^n \psi\left(2^k\right) = 0,$$

we have

(3.5) 
$$\lim_{n \to \infty} \frac{1}{n} \sum_{k=1}^{t(n)} \psi(m_k) = 0.$$

Now we compare the length of  $I_n(\sigma_1, \dots, \sigma_n)$  and the length of  $I_n^*(\sigma_1, \dots, \sigma_n)$ .

**Lemma 3.1.** For any  $0 < \epsilon < 1$ , there exists a positive integer  $N_1$  such that for any  $n \ge N_1$  and  $(\sigma_1, \dots, \sigma_n) \in C_n$ , we have

$$\left|I_n\left(\sigma_1,\cdots,\sigma_n\right)\right| \geq \left|I_n^*\left(\sigma_1,\cdots,\sigma_n\right)\right|^{1+\epsilon}$$
.

*Proof.* For any  $(\sigma_1, \dots, \sigma_n) \in C_n$ , set  $Q_0 := 1$ ,  $Q_n := \prod_{k=1}^n \sigma_k(\sigma_k - 1)$  and  $Q_n(\sigma_1, \dots, \sigma_n)^* := \prod_{k=1}^n \sigma_k(\sigma_k - 1)$ 

 $Q_n / \prod_{i=1}^{t(n)} \sigma_{m_i} (\sigma_{m_i} - 1)$ . According to Proposition 2.4, we have

$$|I_n(\sigma_1,\cdots,\sigma_n)|=\frac{1}{Q_n}$$

and

$$\left|I_n^*(\sigma_1,\cdots,\sigma_n)\right| = \frac{1}{Q_n(\sigma_1,\cdots,\sigma_n)^*}.$$

By the definition of  $C_n$ , one has

$$e^{\psi(m_k)} < \sigma_{m_k} \leqslant e^{\psi(m_k)} + 1$$
 for any  $k \geqslant 1$ ,

then

$$|I_n(\sigma_1, \dots, \sigma_n)| = \frac{1}{Q_n} = \frac{1}{Q_n (\sigma_1, \dots, \sigma_n)^* \cdot \prod_{i=1}^{t(n)} \sigma_{m_i} (\sigma_{m_i} - 1)}$$

$$\geqslant \frac{1}{Q_n (\sigma_1, \dots, \sigma_n)^*} \cdot \prod_{i=1}^{t(n)} \frac{1}{\left(e^{\psi(m_i)} + 1\right) \cdot e^{\psi(m_i)}}.$$
(3.6)

8

Set

$$b_n = \frac{t(n) - 1}{n} \cdot \log 2 + \frac{2}{n} \cdot \sum_{k=1}^{t(n)} \psi(m_k)$$

and

$$c_n = \frac{\log 2}{n} + \frac{t(n)}{n} \cdot \log 2,$$

then by (3.3) and (3.5), we have

$$\lim_{n \to \infty} b_n = \lim_{n \to \infty} \left( \frac{t(n) - 1}{n} \cdot \log 2 + \frac{2}{n} \cdot \sum_{k=1}^{t(n)} \psi(m_k) \right) = 0$$

and

$$\lim_{n \to \infty} c_n = \lim_{n \to \infty} \left( \frac{\log 2}{n} + \frac{t(n)}{n} \cdot \log 2 \right) = 0.$$

Hence for any  $0 < \epsilon < 1$ , there exists an integer  $N_1$  such that for any  $n \ge N_1$ , one has

$$(3.7) \qquad \frac{t(n)-1}{n} \cdot \log 2 + \frac{2}{n} \cdot \sum_{k=1}^{t(n)} \psi(m_k) < \epsilon \cdot \log a$$

and

$$(3.8) \qquad \qquad \frac{\log 2}{n} + \frac{t\left(n\right)}{n} \epsilon \cdot \log 2 < \frac{\log 2}{n} + \frac{t\left(n\right)}{n} \cdot \log 2 < \epsilon \left(\log 2 - \log a\right),$$

where a is a real number with 0 < a < 1. This shows that

(3.9) 
$$2^{t(n)} \cdot e^{2 \cdot \sum_{k=1}^{t(n)} \psi(m_k) \text{ by (3.7)}} < 2a^{n\epsilon} \stackrel{\text{by (3.8)}}{<} 2^{(n-t(n))\epsilon}.$$

Note that

(3.10) 
$$\prod_{i=1}^{t(n)} \left( e^{\psi(m_k)} + 1 \right) \cdot e^{\psi(m_k)} \leqslant \prod_{i=1}^{t(n)} 2 \cdot e^{2\psi(m_k)} = 2^{t(n)} \cdot e^{2 \cdot \sum_{k=1}^{t(n)} \psi(m_k)},$$

then by formula (3.6), (3.9), (3.10) and Lemma 2.5, when  $n \ge N_1$ ,

$$|I_{n}(\sigma_{1}, \dots, \sigma_{n})| \geqslant \frac{1}{Q_{n}(\sigma_{1}, \dots, \sigma_{n})^{*} \cdot \prod_{i=1}^{t(n)} \left(e^{\psi(m_{k})} + 1\right) \cdot e^{\psi(m_{k})}}$$

$$\geqslant \frac{1}{Q_{n}(\sigma_{1}, \dots, \sigma_{n})^{*} \cdot 2^{(n-t(n))\epsilon}}$$

$$\geqslant \frac{1}{Q_{n}(\sigma_{1}, \dots, \sigma_{n})^{*} \cdot \left(Q_{n}(\sigma_{1}, \dots, \sigma_{n})^{*}\right)^{\epsilon}}$$

$$= |I_{n}^{*}(\sigma_{1}, \dots, \sigma_{n})|^{1+\epsilon}.$$

In order to make use of Proposition 2.10 to estimate the Hausdorff dimension of  $E_M(\psi)$ , now we estimate |x-y|, where  $x \neq y \in E_M(\psi)$ .

**Lemma 3.2.** For any  $x \neq y \in E_M(\psi)$ , there exists  $(\sigma_1, \dots, \sigma_n) \in C_n$  and  $l_{n+1} \neq r_{n+1}$  satisfying  $(\sigma_1, \dots, \sigma_n, l_{n+1}) \in C_{n+1}$  and  $(\sigma_1, \dots, \sigma_n, r_{n+1}) \in C_{n+1}$  such that

$$x \in I_{n+1}(\sigma_1, \dots, \sigma_n, l_{n+1}), y \in I_{n+1}(\sigma_1, \dots, \sigma_n, r_{n+1})$$

and

$$|x-y| \geqslant \frac{1}{M^3} |I_n(\sigma_1, \cdots, \sigma_n)|.$$

Proof. For any  $x = [x_1, x_2, \cdots] \in E_M(\psi)$ ,  $y = [y_1, y_2, \cdots] \in E_M(\psi)$  and  $x \neq y$ , suppose that n is the greatest integer such that  $x_i = y_i$  for  $1 \leq i \leq n$ , then there exists  $(\sigma_1, \cdots, \sigma_n) \in C_n$  such that  $x, y \in I_n(\sigma_1, \cdots, \sigma_n)$ . If n = 0, set  $I_0 := (0, 1]$ , then  $x, y \in I_0$ . Otherwise, there exist  $l_{n+1} \neq r_{n+1}$  such that  $x \in I_{n+1}(\sigma_1, \cdots, \sigma_n, l_{n+1})$  and  $y \in I_{n+1}(\sigma_1, \cdots, \sigma_n, r_{n+1})$ , where  $(\sigma_1, \cdots, \sigma_n, l_{n+1}) \in C_{n+1}$  and  $(\sigma_1, \cdots, \sigma_n, r_{n+1}) \in C_{n+1}$ .

Without loss of generality, we assume x < y. then  $l_{n+1} > r_{n+1}$ , Note that for all  $k \in \mathbb{N}$ ,  $n+1 \neq m_k$ , otherwise  $l_{n+1} = r_{n+1} = \lfloor e^{\psi(m_k)} \rfloor + 1$ . Recall that  $x \in J_{n+1}(\sigma_1, \dots, \sigma_n, l_{n+1}) \cap E_M(\psi)$  and  $y \in J_{n+1}(\sigma_1, \dots, \sigma_n, r_{n+1}) \cap E_M(\psi)$ , then |x-y| is not less than the gaps between  $J_{n+1}(\sigma_1, \dots, \sigma_n, l_{n+1})$  and  $J_{n+1}(\sigma_1, \dots, \sigma_n, r_{n+1})$ .

We consider the following two cases:

(i) If  $n+2=m_k$  for some  $k \in \mathbb{N}$ .

In this case, y-x is greater than the distance between the left endpoint of the basic interval  $J_{n+1}(\sigma_1, \dots, \sigma_n, r_{n+1})$  and the right endpoint of the basic interval  $J_{n+1}(\sigma_1, \dots, \sigma_n, l_{n+1})$ . Let  $t = |e^{\psi(m_k)}| + 1 \ge 2$ , then

$$J_{n+1}(\sigma_1, \dots, \sigma_n, l_{n+1}) = I_{n+2}(\sigma_1, \dots, \sigma_n, l_{n+1}, t),$$
  
$$J_{n+1}(\sigma_1, \dots, \sigma_n, r_{n+1}) = I_{n+2}(\sigma_1, \dots, \sigma_n, r_{n+1}, t).$$

For simplicity, we write  $s_0 := 1$ ,  $s_k = \sigma_k (\sigma_k - 1)$  for  $1 \leq k \leq n$ , recall that  $Q_k = s_0 s_1 \cdots s_{k-1} s_k$  for  $1 \leq k \leq n$ , then by Proposition 2.4, we have

$$\begin{split} |y-x| \geqslant \left( \sum_{k=1}^{n} \frac{1}{Q_{k-1}} \cdot \frac{1}{\sigma_{k}} + \frac{1}{Q_{n}} \cdot \frac{1}{r_{n+1}} + \frac{1}{Q_{n}} \cdot \frac{1}{r_{n+1} (r_{n+1} - 1)} \cdot \frac{1}{t} \right) \\ - \left( \sum_{k=1}^{n} \frac{1}{Q_{k-1}} \cdot \frac{1}{\sigma_{k}} + \frac{1}{Q_{n}} \cdot \frac{1}{l_{n+1}} + \frac{1}{Q_{n}} \cdot \frac{1}{l_{n+1} (l_{n+1} - 1)} \cdot \frac{1}{t} + \frac{1}{q_{n}} \cdot \frac{1}{l_{n+1} (l_{n+1} - 1)} \cdot \frac{1}{t} + \frac{1}{q_{n}} \cdot \frac{1}{l_{n+1} (l_{n+1} - 1)} \cdot \frac{1}{t} - \frac{1}{l_{n+1} (l_{n+1} - 1)} \cdot \frac{1}{t-1} \right) \\ = \frac{1}{Q_{n}} \left( \frac{1}{r_{n+1}} - \frac{1}{l_{n+1}} + \frac{1}{l_{n+1} (l_{n+1} - 1)} \cdot \frac{1}{t} - \frac{1}{l_{n+1} (l_{n+1} - 1)} \cdot \frac{1}{t-1} \right) \\ \geqslant \frac{1}{Q_{n}} \left( \frac{1}{r_{n+1} l_{n+1}} - \frac{1}{l_{n+1} (l_{n+1} - 1)} \cdot \frac{1}{2} \right) \\ \geqslant \frac{1}{Q_{n}} \frac{1}{l_{n+1} (l_{n+1} - 1)} \cdot \frac{1}{2} \\ \geqslant \frac{1}{Q_{n}} \frac{1}{2M (M - 1)} \\ \geqslant \frac{1}{M^{3}} |I_{n}(\sigma_{1}, \dots, \sigma_{n})|. \end{split}$$

(ii) If  $n+2 \neq m_k$  for any  $k \in \mathbb{N}$ .

In this case, y-x is greater than the distance between the left endpoint of  $J_{n+1}(\sigma_1, \dots, \sigma_n, r_{n+1})$  and the right point of  $J_{n+1}(\sigma_1, \dots, \sigma_n, l_{n+1})$ . Note that  $n+2 \neq m_k$  for any  $k \geq 1$ , then the left endpoint of  $J_{n+1}(\sigma_1, \dots, \sigma_n, r_{n+1})$  is just the left endpoint of  $I_{n+2}(\sigma_1, \dots, \sigma_n, r_{n+1}, M)$  and the right point of  $J_{n+1}(\sigma_1, \dots, \sigma_n, l_{n+1})$  is the right point of  $I_{n+2}(\sigma_1, \dots, \sigma_n, l_{n+1}, 2)$ . Similar to case (i), we have

$$|y - x| \geqslant \frac{1}{Q_n} \left( \frac{1}{r_{n+1}} - \frac{1}{l_{n+1}} + \frac{1}{r_{n+1} (r_{n+1} - 1)} \cdot \frac{1}{M} - \frac{1}{l_{n+1} (l_{n+1} - 1)} \right)$$

$$\geqslant \frac{1}{Q_n} \frac{1}{l_{n+1} (l_{n+1} - 1)} \cdot \frac{1}{M}$$

$$\geqslant \frac{1}{Q_n} \frac{1}{M^2 (M - 1)}$$

$$\geqslant \frac{1}{M^3} |I_n(\sigma_1, \dots, \sigma_n)|.$$

Recall that

$$E_{M} = \left\{ x \in (0,1] : 2 \leqslant d_{n}(x) \leqslant M \text{ for any } n \in \mathbb{N} \right\}$$

and write

$$[d_1, d_2, \cdots d_n] = \frac{1}{d_1} + \frac{1}{d_1(d_1 - 1)d_2} + \dots + \frac{1}{d_1(d_1 - 1)\cdots d_{n-1}(d_{n-1} - 1)d_n}.$$

Define a map  $f: E_M(\psi) \to E_M$  as follows: for any  $x = [x_1, x_2, \cdots] \in E_M(\psi)$ , let

$$f\left(x\right) = \lim_{n \to \infty} \left[x_1, \cdots, x_n\right]^*,$$

where  $[x_1, \dots, x_n]^*$  is the real number obtained by eliminating the terms  $\{x_{m_k} : 1 \le k \le t(n)\}$  in  $[x_1, \dots, x_n]$ . For any  $x = [x_1, x_2, \dots] \in E_M(\psi)$ ,  $y = [y_1, y_2, \dots] \in E_M(\psi)$ , let m be the greatest integer such that  $x_i = y_i$  for  $1 \le i \le m$ , it is easy to see that for any  $0 < \epsilon < 1$ , if

$$|x - y| < \frac{1}{M^3} \min_{(\sigma_1, \dots, \sigma_{N_1}) \in C_{N_1}} \{ |I_{N_1}(\sigma_1, \dots, \sigma_{N_1})| \},$$

then  $m > N_1$ , where  $N_1$  is the same as  $N_1$  in Lemma 3.1. Otherwise, by Lemma 3.2, one has

$$|x-y| \geqslant \frac{1}{M^3} |I_m(\sigma_1, \cdots, \sigma_m)| \geqslant \frac{1}{M^3} \min_{(\sigma_1, \cdots, \sigma_{N_1}) \in C_{N_1}} \left\{ |I_{N_1}(\sigma_1, \cdots, \sigma_{N_1})| \right\},$$

which contradicts the hypothesis (3.11). Furthermore, according to Lemma 3.1 and Lemma 3.2, we have

$$(3.12) \left| f(x) - f(y) \right| \leqslant \left| I_m^*(\sigma_1, \cdots, \sigma_m) \right| \leqslant \left| I_m(\sigma_1, \cdots, \sigma_m) \right|^{\frac{1}{1+\epsilon}} \leqslant M^{\frac{3}{1+\epsilon}} \cdot \left| x - y \right|^{\frac{1}{1+\epsilon}}.$$

Take a sufficiently large k such that for any  $(\sigma_1, \dots, \sigma_k) \in C_k$ , one has

$$\left|I_k(\sigma_1,\cdots,\sigma_k)\right| < \frac{1}{M^3} \min_{(\sigma_1,\cdots,\sigma_{N_1})\in C_{N_1}} \left\{ \left|I_{N_1}(\sigma_1,\cdots,\sigma_{N_1})\right| \right\}.$$

It is clear that

$$E_{M}(\psi) = \bigsqcup_{(\sigma_{1}, \dots, \sigma_{k}) \in C_{k}} E_{M}(\psi) \cap I_{k}(\sigma_{1}, \dots, \sigma_{k}).$$

For simplicity, we write  $F(\sigma_1, \dots, \sigma_k) = E_M(\psi) \cap I_k(\sigma_1, \dots, \sigma_k)$ , then by the countable stability of Hausdorff dimension, we have

(3.13) 
$$\dim E_M(\psi) = \sup_{(\sigma_1, \dots, \sigma_k) \in C_k} \dim_{\mathbf{H}} F(\sigma_1, \dots, \sigma_k).$$

For any  $(\sigma_1, \dots, \sigma_k) \in C_k$ , by Proposition 2.10 and (3.12), we have

$$\dim_{\mathrm{H}} F(\sigma_{1}, \dots, \sigma_{k}) \geqslant \frac{1}{1+\epsilon} \dim_{\mathrm{H}} f(F(\sigma_{1}, \dots, \sigma_{k})).$$

Then by (3.13), one has

(3.14) 
$$\dim_{\mathbf{H}} E_{M}(\psi) \geqslant \sup_{(\sigma_{1}, \dots, \sigma_{k}) \in C_{k}} \frac{1}{1+\epsilon} \dim_{\mathbf{H}} f(F(\sigma_{1}, \dots, \sigma_{k})).$$

Note that

$$E_{M} = f\left(E_{M}\left(\psi\right)\right) = f\left(\bigsqcup_{\left(\sigma_{1}, \cdots, \sigma_{k}\right) \in C_{k}} F\left(\sigma_{1}, \cdots, \sigma_{k}\right)\right) \subseteq \bigsqcup_{\left(\sigma_{1}, \cdots, \sigma_{k}\right) \in C_{k}} f\left(F\left(\sigma_{1}, \cdots, \sigma_{k}\right)\right),$$

then

(3.15) 
$$\dim_{\mathrm{H}} E_{M} \leqslant \dim_{\mathrm{H}} \bigsqcup_{(\sigma_{1}, \cdots, \sigma_{k}) \in C_{k}} f\left(F\left(\sigma_{1}, \cdots, \sigma_{k}\right)\right) = \sup_{(\sigma_{1}, \cdots, \sigma_{k}) \in C_{k}} \dim_{\mathrm{H}} f\left(F\left(\sigma_{1}, \cdots, \sigma_{k}\right)\right).$$

Recall that  $E_M(\psi) \subseteq E_{\text{sup}}(\psi)$ , by combining (3.14), (3.15), we have

$$\dim_{\mathrm{H}} E_{\mathrm{sup}}(\psi) \geqslant \dim_{\mathrm{H}} E_{M}(\psi) \geqslant \frac{1}{1+\epsilon} \dim_{\mathrm{H}} E_{M}.$$

Let  $\epsilon \to 0^+$ , then

$$\dim_{\mathrm{H}} E_{\mathrm{sup}}(\psi) \geqslant \dim_{\mathrm{H}} E_{M}$$
.

Moreover, by Lemma 2.6 and Lemma 2.7 and let  $M \to \infty$ , we have

$$\dim_{\mathbf{H}} E_{\sup}(\psi) \geqslant \sup_{M \geqslant 2} \dim_{\mathbf{H}} E_M = 1.$$

Case II:  $\liminf_{n\to\infty} \frac{\psi(n)}{n} = \alpha \ (0 < \alpha < \infty)$ .

We split the proof into two parts.

**Upper bound** For any  $x \in E_{\sup}(\psi)$ , it holds that  $\limsup_{n \to \infty} \frac{\log d_n(x)}{\psi(n)} = 1$ , then for any  $0 < \epsilon < \min \{\alpha, 1\}$ , we have

$$d_n(x) \geqslant e^{\psi(n)(1-\epsilon)}$$

holds for infinitely many n. Since  $\liminf_{n\to\infty} \frac{\psi(n)}{n} = \alpha$ , then there exists a positive integer  $\widetilde{N}$  such that for any  $n \geqslant \widetilde{N}$ , one has

$$\psi(n) > n(\alpha - \epsilon)$$
,

thus,

$$d_n(x) \geqslant e^{\psi(n)(1-\epsilon)} \geqslant e^{n(\alpha-\epsilon)(1-\epsilon)}$$

holds for for infinitely many  $n \in \mathbb{N}$ . This show that

$$E_{\sup}(\psi) \subseteq \left\{ x \in (0,1] : d_n(x) \geqslant e^{n(\alpha - \epsilon)(1 - \epsilon)} \text{ for infinitely many } n \in \mathbb{N} \right\}$$

Recall that

$$H\left(\alpha\right)=\dim_{\mathcal{H}}\left\{ x\in\left(0,1\right]\ :d_{n}\left(x\right)\geqslant\mathrm{e}^{\alpha n}\ \mathrm{for\ infinitely\ many}\ n\in\mathbb{N}
ight\} ,$$

then

$$\dim_{\mathbf{H}} E_{\sup}(\psi) \leqslant H((\alpha - \epsilon)(1 - \epsilon)).$$

Let  $\epsilon \to 0^+$  and by Lemma 2.8, we have

$$\dim_{\mathbf{H}} E_{\sup}(\psi) \leqslant H(\alpha)$$
.

**Lower bound** Since  $\liminf_{n\to\infty} \frac{\psi(n)}{n} = \alpha$  and  $0 < \alpha < \infty$ , it is easy to see that

$$\liminf_{n\to\infty}\frac{\psi\left(n\right)}{n\alpha}=\frac{1}{\alpha}\liminf_{n\to\infty}\frac{\psi\left(n\right)}{n}=1.$$

Let  $\{n_k\}_{k\geqslant 1}$  be a subsequence of  $\mathbb{N}$  such that

$$\lim_{k \to \infty} \frac{\psi(n_k)}{n_k \alpha} = \liminf_{n \to \infty} \frac{\psi(n)}{n \alpha} = 1.$$

Choose a sufficiently sparse subsequence  $\{n_{k_i}\}_{i\geqslant 1}$  of  $\{n_k\}_{k\geqslant 1}$  (for simplicity, we still denote by  $\{n_k\}_{k\geqslant 1}$ ) such that

$$n_1 = 1$$
 and  $n_1 + n_2 + \dots + n_k \le \frac{1}{k+1} n_{k+1} \ (k \ge 2)$ .

Fix an integer  $M \geqslant 2$  and for any B > 1, define

$$F_{M}\left(B\right)=\left\{ x\in\left(0,1\right]:\left\lfloor B^{n_{k}}\right\rfloor +2\leqslant d_{n_{k}}\left(x\right)\leqslant2\left\lfloor B^{n_{k}}\right\rfloor +1\text{ for any }k\in\mathbb{N}\text{ and }$$
 
$$2\leqslant d_{j}\left(x\right)\leqslant M,\text{ if }j\neq n_{k}\text{ for any }k\in\mathbb{N}\right\}$$

and

$$F_{\alpha}\left(\psi\right) = \Big\{x \in (0,1]: \limsup_{n \to \infty} \frac{\log d_{n}\left(x\right)}{\psi\left(n\right)} \leqslant 1 \ \text{ and } \ \limsup_{k \to \infty} \frac{\log d_{n_{k}}\left(x\right)}{\psi\left(n_{k}\right)} \ = 1 \ \Big\}.$$

For any  $x \in F_M(e^{\alpha})$ , it is obvious that

$$\limsup_{n \to \infty} \frac{\log d_n\left(x\right)}{n\alpha} = 1 \text{ and } \lim_{k \to \infty} \frac{\log d_{n_k}\left(x\right)}{n_k \alpha} = 1.$$

Thus,

$$\limsup_{n \to \infty} \frac{\log d_n(x)}{\psi(n)} = \limsup_{n \to \infty} \frac{\log d_n(x)}{\psi(n)} \cdot \liminf_{n \to \infty} \frac{\psi(n)}{n\alpha}$$

$$\leq \limsup_{n \to \infty} \frac{\log d_n(x)}{n\alpha}$$

$$= 1$$

and

$$\lim \sup_{k \to \infty} \frac{\log d_{n_k}(x)}{\psi(n_k)} = \lim \sup_{k \to \infty} \frac{\log d_{n_k}(x)}{\psi(n_k)} \cdot \lim_{k \to \infty} \frac{\psi(n_k)}{n_k \alpha}$$
$$= \lim \sup_{k \to \infty} \frac{\log d_{n_k}(x)}{n_k \alpha}$$
$$= 1.$$

Hence

$$(3.16) F_M(e^{\alpha}) \subseteq F_{\alpha}(\psi).$$

Let  $G_M(B)$  be the unique solution of the equation

$$\sum_{k=2}^{M} \left( \frac{1}{Bk(k-1)} \right)^{s} = 1,$$

then according to the proof of Theorem 3.2 of [10], for any B > 1, it can be obtained that

(3.17) 
$$\dim_{\mathbf{H}} F_{M}\left(B\right) \geqslant G_{M}\left(B\right) \text{ and } \lim_{M \to \infty} G_{M}\left(B\right) = G\left(B\right),$$

where G(B) is defined in Lemma 2.8. It is easy to see that  $F_{\alpha}(\psi) \subseteq E_{\sup}(\psi)$ , then by (3.16), we have

$$\dim_{\mathrm{H}} E_{\mathrm{sup}}(\psi) \geqslant \dim_{\mathrm{H}} F_{\alpha}(\psi) \geqslant \dim_{\mathrm{H}} F_{M}(\mathrm{e}^{\alpha}) \geqslant G_{M}(\mathrm{e}^{\alpha}).$$

Let  $M \to \infty$ , it follows from (3.17) and Lemma 2.8 that

$$\dim_{\mathbf{H}} E_{\sup} (\psi) \geqslant \lim_{M \to \infty} G_M (\mathbf{e}^{\alpha}) = G (\mathbf{e}^{\alpha}) = H (\alpha).$$

Case III:  $\lim_{n\to\infty} \frac{\psi(n)}{n} = \infty$ . Upper bound For any  $0 < \epsilon < 1$ , define

$$\hat{E}\left(\psi,\epsilon\right) = \left\{ x \in (0,1] : d_n\left(x\right) \geqslant e^{\psi(n)(1-\epsilon)} \text{ for infinitely many } n \in \mathbb{N} \right\},\,$$

it is easy to see that

$$E_{\sup}(\psi) \subseteq \hat{E}(\psi, \epsilon)$$
.

Note that  $\lim_{n\to\infty}\frac{\psi(n)}{n}=\infty$ , we have

$$\lim_{n \to \infty} \frac{\log e^{\psi(n)(1-\epsilon)}}{n} = \lim_{n \to \infty} \frac{\psi(n)(1-\epsilon)}{n} = \infty$$

and

$$\liminf_{n \to \infty} \frac{\log \log e^{\psi(n)(1-\epsilon)}}{n} = \liminf_{n \to \infty} \frac{\log \psi(n)(1-\epsilon)}{n} = \liminf_{n \to \infty} \frac{\log \psi(n)}{n}.$$

Recall that

$$\log A = \liminf_{n \to \infty} \frac{\log \psi(n)}{n},$$

then it follows from Theorem 4.2 of [10] that

$$\dim_{\mathrm{H}} E_{\mathrm{sup}}(\psi) \leqslant \dim_{\mathrm{H}} \hat{E}(\psi, \epsilon) = \frac{1}{1+A}.$$

**Lower bound** We obtain the lower bound of the Hausdorff dimension of  $E_{\text{sup}}(\psi)$  by constructing a suitable Cantor subset of  $E_{\text{sup}}(\psi)$ .

Define  $\theta: \mathbb{N} \to \mathbb{R}^+$  as follows:

$$\theta\left(n\right) = \min_{k \geqslant n} \psi\left(k\right).$$

Since  $\lim_{n\to\infty} \psi(n) = \infty$ ,  $\theta(n)$  is well defined. Secondly, for any  $\epsilon > 0$ , define a sequence  $\{r_n\}_{n\geqslant 1}$  as follows:

(3.18) 
$$r_1 = e^{\theta(1)} \text{ and } r_n = \min \left\{ e^{\theta(n)}, \prod_{i=1}^{n-1} r_i^{A-1+\epsilon} \right\} \ (n \geqslant 2) \,.$$

It follows from the proof of Theorem 1.1 of [6] that

$$(3.19) \qquad \limsup_{n\to\infty}\frac{\log r_n}{\psi\left(n\right)}=1\ ,\ \lim_{n\to\infty}r_n=\infty\ \text{and}\ \limsup_{n\to\infty}\frac{\log r_{n+1}}{\log(r_1\cdots r_n)}\leqslant A-1+\epsilon.$$

We use the sequence  $\{r_n\}_{n\geqslant 1}$  to construct the Cantor subset of  $E_{\sup}(\psi)$ . By (3.19), there exsits a positive interger M such that  $M\lfloor r_n+1\rfloor\geqslant 4$  for all  $n\in\mathbb{N}$ . Define

$$E(\left\{r_{n}\right\}_{n\geqslant1}) = \left\{x \in (0,1]: M \lfloor r_{n}+1 \rfloor \leqslant d_{n}\left(x\right) \leqslant 2M \lfloor r_{n}+1 \rfloor - 1 \text{ for any } n \in \mathbb{N}\right\}.$$

For any  $x \in E(\{r_n\}_{n \ge 1})$ , by (3.19), one has

$$(3.20) 1 = \limsup_{n \to \infty} \frac{\log Mr_n}{\psi\left(n\right)} \leqslant \limsup_{n \to \infty} \frac{\log d_n\left(x\right)}{\psi\left(n\right)} \leqslant \limsup_{n \to \infty} \frac{\log 2M\left(r_n + 1\right)}{\psi\left(n\right)} = 1.$$

This shows that

$$E(\{r_n\}_{n\geq 1})\subseteq E_{\sup}(\psi)$$
.

Note that

$$\limsup_{n \to \infty} \frac{\log M \lfloor r_{n+1} + 1 \rfloor}{\log M^n \cdot \prod_{i=1}^n \lfloor r_i + 1 \rfloor} \leq \limsup_{n \to \infty} \frac{\log M (r_{n+1} + 1)}{\log M^n \cdot \prod_{i=1}^n r_i}$$

$$= \limsup_{n \to \infty} \frac{\log M + \log (r_{n+1} + 1)}{n \log M + \log r_1 \cdots r_n}$$

$$= \limsup_{n \to \infty} \frac{\log (r_{n+1} + 1)}{n \log M + \log r_1 \cdots r_n}$$

$$= \limsup_{n \to \infty} \frac{\log (r_{n+1} + 1)}{n \log M + \log r_1 \cdots r_n} \cdot \frac{1}{1 + \frac{n \log M}{\log r_1 \cdots r_n}}$$

$$= \limsup_{n \to \infty} \frac{\log (r_{n+1} + 1)}{\log r_1 \cdots r_n}$$

$$= \limsup_{n \to \infty} \frac{\log (r_{n+1} + 1)}{\log r_1 \cdots r_n}$$

$$\leq A - 1 + \epsilon.$$

Then by Lemma 2.9, we have

(3.21) 
$$\dim_{\mathbf{H}} E(\lbrace r_{n}\rbrace_{n\geqslant 1}) = \liminf_{n\to\infty} \frac{\log M^{n} \cdot \prod_{i=1}^{n} \lfloor r_{i} + 1 \rfloor}{2\log M^{n} \cdot \prod_{i=1}^{n} \lfloor r_{i} + 1 \rfloor + \log M \lfloor r_{n+1} + 1 \rfloor}$$
$$= \frac{1}{2 + \limsup_{n\to\infty} \frac{\log M \lfloor r_{n+1} + 1 \rfloor}{\log M^{n} \cdot \prod_{i=1}^{n} \lfloor r_{i} + 1 \rfloor}} \geqslant \frac{1}{1 + A + \epsilon}.$$

Thus,

$$\dim_{\mathrm{H}} E_{\mathrm{sup}}(\psi) \geqslant \dim_{\mathrm{H}} E(\{r_n\}_{n\geqslant 1}) \geqslant \frac{1}{1+A+\epsilon}$$

Let  $\epsilon \to 0^+$ , we have

$$\dim_{\mathbf{H}} E_{\sup} (\psi) \geqslant \frac{1}{1+A}.$$

## 4. PROOF OF THEOREM 1.3 AND THEOREM 1.4

In this section, we complete the proofs of Theorem 1.3 and Theorem 1.4.

# 4.1. **Proof of Theorem 1.3.** We split the proof into two parts.

**Lower bound** We construct a suitable Cantor subset of  $E\left(\psi\right)$  to get the lower bound of the Hausdorff dimension of  $E\left(\psi\right)$ . Since  $\lim_{n\to\infty}\psi\left(n\right)=\infty$  and  $\psi\left(n\right)>0$  for any  $n\in\mathbb{N}$ , there exsits an interger M such that  $M\lfloor \mathrm{e}^{\psi(n)}+1\rfloor\geqslant 4$  holds for any  $n\in\mathbb{N}$ . Define

$$W\left(\psi\right)=\left\{ x\in\left(0,1\right]:M\lfloor\mathrm{e}^{\psi\left(n\right)}+1\rfloor\leqslant d_{n}\left(x\right)\leqslant2M\lfloor\mathrm{e}^{\psi\left(n\right)}+1\rfloor-1\text{ for any }n\in\mathbb{N}\right\} .$$

Similar to (3.20), it is easy to see that

$$W(\psi) \subseteq E(\psi)$$
.

Therefore by Lemma 2.9, similar to (3.21), we have

$$\dim_{\mathbf{H}} W\left(\psi\right) \geqslant \frac{1}{2 + \limsup_{n \to \infty} \frac{\log(e^{\psi(n+1)} + 1)}{\log e^{\psi(1) + \dots + \psi(n)}}} = \frac{1}{2 + \limsup_{n \to \infty} \frac{\psi(n+1)}{\psi(1) + \dots + \psi(n)}}.$$

Recall that

$$\eta = \limsup_{n \to \infty} \frac{\psi(n+1)}{\psi(1) + \dots + \psi(n)},$$

hence

$$\dim_{\mathrm{H}} E(\psi) \geqslant \dim_{\mathrm{H}} W(\psi) \geqslant \frac{1}{2+\eta}.$$

**Upper bound** For any  $0 < \epsilon < 1$  and  $r \in \mathbb{N}$ , we define

$$E_{\psi}\left(r,\epsilon\right) = \left\{x \in (0,1] : e^{\psi(n)(1-\epsilon)} + 1 \leqslant d_n\left(x\right) \leqslant e^{\psi(n)(1+\epsilon)} + 1 \text{ for any } n \geqslant r\right\}.$$

It is easy to see that

$$E(\psi) \subseteq \bigcup_{r=1}^{\infty} E_{\psi}(r, \epsilon),$$

then we have

(4.1) 
$$\dim_{\mathbf{H}} E(\psi) \leqslant \dim_{\mathbf{H}} \bigcup_{r=1}^{\infty} E_{\psi}(r, \epsilon) = \sup_{r \geqslant 1} \dim_{\mathbf{H}} E_{\psi}(r, \epsilon).$$

Now we consider the Hausdorff dimension of  $E_{\psi}\left(r,\epsilon\right)$  for any  $r\in\mathbb{N}$ . Let  $M\geqslant 1$  be an integer, and define  $D_{n}\left(\epsilon,M,r\right)$  as the collection of sequence  $(d_{1},\cdots,d_{n})$  satisfying

$$\begin{cases} 2 \leqslant d_k \leqslant M + 1 & \text{if } 1 \leqslant k < r, \\ e^{\psi(k)(1-\epsilon)} + 1 \leqslant d_k \leqslant e^{\psi(k)(1+\epsilon)} + 1 & \text{if } r \leqslant k \leqslant n. \end{cases}$$

By the construction of  $D_n(\epsilon, M, r)$ , it is clear that

(4.2) 
$$\#D_n\left(\epsilon, M, r\right) \leqslant M^{r-1} \prod_{k=r}^n 2\epsilon \psi\left(k\right) \cdot e^{(1+\epsilon)\psi(k)}.$$

For any  $(\sigma_1, \dots, \sigma_n) \in D_n(\epsilon, M, r)$ , put

$$J_n(\sigma_1, \cdots, \sigma_n) = \bigcup_{(\sigma_1, \cdots, \sigma_n, \sigma_{n+1}) \in D_{n+1}(\epsilon, M, r)} I_{n+1}(\sigma_1, \cdots, \sigma_n, \sigma_{n+1}).$$

We define

$$\tilde{E}_{\psi,r,\epsilon}\left(M\right) = \left\{ x \in (0,1] : e^{\psi(k)(1-\epsilon)} + 1 \leqslant d_k\left(x\right) \leqslant e^{\psi(k)(1+\epsilon)} + 1 \text{ for any } k \geqslant r \right.$$

$$\text{and } 2 \leqslant d_k\left(x\right) \leqslant M + 1 \text{ for } 1 \leqslant k < r \right\}.$$

Clearly,

$$E_{\psi}(r,\epsilon) \subseteq \bigcup_{M=1}^{\infty} \tilde{E}_{\psi,r,\epsilon}(M),$$

then

(4.3) 
$$\dim_{\mathbf{H}} E_{\psi}(r, \epsilon) \leqslant \dim_{\mathbf{H}} \bigcup_{M=1}^{\infty} \tilde{E}_{\psi, r, \epsilon}(M) = \sup_{M \geqslant 1} \dim_{\mathbf{H}} \tilde{E}_{\psi, r, \epsilon}(M).$$

For any  $M \ge 1$ , now we estimate the Hausdorff dimension of  $\tilde{E}_{\psi,r,\epsilon}(M)$ . It is clear that for any  $n \ge r$ , one has

$$\tilde{E}_{\psi,r,\epsilon}(M) \subseteq \bigcup_{(\sigma_1,\cdots,\sigma_n)\in D_n(\epsilon,M,r)} J_n(\sigma_1,\cdots,\sigma_n).$$

By Proposition 2.4, we have

$$|I_{n+1}(\sigma_1, \cdots, \sigma_n, \sigma_{n+1})| = \frac{1}{Q_{n+1}(\sigma_1, \cdots, \sigma_n, \sigma_{n+1})} \leqslant \frac{1}{\prod_{i=1}^{n+1} (\sigma_i - 1)^2},$$

then

$$|J_{n}(\sigma_{1}, \dots, \sigma_{n})| \leq \sum_{\sigma_{n+1} \geq e^{\psi(n+1)(1-\epsilon)}+1} |I_{n+1}(\sigma_{1}, \dots, \sigma_{n}, \sigma_{n+1})|$$

$$\leq \sum_{\sigma_{n+1} \geq e^{\psi(n+1)(1-\epsilon)}+1} \prod_{i=1}^{n+1} \frac{1}{(\sigma_{i}-1)^{2}}$$

$$= \frac{1}{\prod_{i=1}^{n} (\sigma_{i}-1)^{2}} \sum_{\sigma_{n+1} \geq e^{\psi(n+1)(1-\epsilon)}+1} \frac{1}{(\sigma_{n+1}-1)^{2}}.$$

$$(4.4)$$

Since  $\lim_{n\to\infty}\psi\left(n\right)=\infty$ , there exists an integer  $\hat{N}\in\mathbb{N}$  such that for any  $n>\hat{N}$ , it holds that  $\mathrm{e}^{\psi(n)(1-\epsilon)}>3$ . Thus, for  $n>\hat{N}$ , one has

$$\sum_{\sigma_{n+1} \geqslant e^{\psi(n+1)(1-\epsilon)}+1} \frac{1}{(\sigma_{n+1}-1)^2} \leqslant \sum_{\sigma_{n+1}-1 \geqslant e^{\psi(n+1)(1-\epsilon)}} \frac{1}{(\sigma_{n+1}-1)(\sigma_{n+1}-2)}$$

$$= \sum_{\sigma_{n+1}-1 \geqslant e^{\psi(n+1)(1-\epsilon)}} \frac{1}{(\sigma_{n+1}-2)} - \frac{1}{(\sigma_{n+1}-1)}$$

$$\leqslant \frac{1}{e^{\psi(n+1)(1-\epsilon)}-1}.$$
(4.5)

For  $(\sigma_1, \dots, \sigma_n) \in D_n(\epsilon, M, r)$ , one has

$$\begin{cases} 2 \leqslant \sigma_i \leqslant M & \text{if } 1 \leqslant i \leqslant r, \\ \sigma_i - 1 \geqslant e^{\psi(i)(1 - \epsilon)} & \text{if } r \leqslant i \leqslant n. \end{cases}$$

Then, by the formula (4.4) and (4.5), when  $n > \hat{N}$ , we have

$$|J_{n}(\sigma_{1}, \cdots, \sigma_{n})| \leqslant \frac{1}{\prod_{i=r}^{n} e^{2\psi(i)(1-\epsilon)}} \cdot \sum_{\sigma_{n+1} \geqslant e^{\psi(n+1)(1-\epsilon)} + 1} \frac{1}{(\sigma_{n+1} - 1)^{2}}$$

$$\leqslant \frac{1}{e^{\psi(n+1)(1-\epsilon)} - 1} \cdot \prod_{i=r}^{n} e^{-2\psi(i)(1-\epsilon)}.$$
(4.6)

For convenience, we write

$$|J_n(\tilde{\sigma}_1, \cdots, \tilde{\sigma}_n)| := \max_{(\sigma_1, \cdots, \sigma_n) \in D_n(\epsilon, M, r)} |J_n(\sigma_1, \cdots, \sigma_n)|.$$

It follows from (4.6) and Proposition 4.1 of [4] that

$$\underline{\dim}_{B} \tilde{E}_{\psi,r,\epsilon} (M) \leqslant \liminf_{n \to \infty} \frac{\log \# D_{n} (\epsilon, M, r)}{-\log \left| J_{n} (\tilde{\sigma}_{1}, \cdots, \tilde{\sigma}_{n}) \right|}$$

$$\leqslant \liminf_{n \to \infty} \frac{(1+\epsilon) \sum_{k=r}^{n} \psi(k) + (r-1) \log M + \sum_{k=r}^{n} \log (2\epsilon \psi(k))}{2 (1-\epsilon) \sum_{k=r}^{n} \psi(k) + \log \left( e^{\psi(n+1)(1-\epsilon)} - 1 \right)}$$

$$= \liminf_{n \to \infty} \frac{1+\epsilon}{1-\epsilon} \cdot \frac{\sum_{k=r}^{n} \psi(k)}{2 \sum_{k=r}^{n} \psi(k) + \psi(n+1)}$$

$$= \frac{1+\epsilon}{1-\epsilon} \cdot \liminf_{n \to \infty} \frac{1}{2+\frac{\psi(n+1)}{\psi(r)+\cdots+\psi(n)}}$$

$$= \frac{1+\epsilon}{1-\epsilon} \cdot \frac{1}{2+\limsup_{n \to \infty} \frac{\psi(n+1)}{\psi(1)+\cdots+\psi(n)}}$$

$$= \frac{1+\epsilon}{1-\epsilon} \cdot \frac{1}{2+\limsup_{n \to \infty} \frac{\psi(n+1)}{\psi(1)+\cdots+\psi(n)}}$$

$$= \frac{1+\epsilon}{1-\epsilon} \cdot \frac{1}{2+\lim_{n \to \infty} \frac{\psi(n+1)}{\psi(1)+\cdots+\psi(n)}}$$

$$= \frac{1+\epsilon}{1-\epsilon} \cdot \frac{1}{2+n},$$

then

$$\dim_{\mathbf{H}} \tilde{E}_{\psi,r,\epsilon}(M) \leqslant \underline{\dim}_{B} \tilde{E}_{\psi,r,\epsilon}(M) \leqslant \frac{1+\epsilon}{1-\epsilon} \cdot \frac{1}{2+\eta}.$$

By (4.1) and (4.3), we have

$$\dim_{\mathbf{H}} E(\psi) \leqslant \frac{1+\epsilon}{1-\epsilon} \cdot \frac{1}{2+\eta}.$$

By letting  $\epsilon \to 0^+$ , we can obtain that

$$\dim_{\mathbf{H}} E\left(\psi\right) \leqslant \frac{1}{2+\eta}.$$

4.2. **Proof of Theorem 1.4.** Like before, we split the proof into two parts. **Lower bound** Recall that

$$\log V = \limsup_{n \to \infty} \frac{\log \psi(n)}{n}.$$

If  $V=\infty$ , then  $\dim_{\mathrm{H}} E_{\mathrm{inf}}(\psi)\geqslant \frac{1}{1+V}$  holds trivially. Now we assume  $1\leqslant V<\infty$ , the lower bound of the Hausdorff dimension of  $E_{\mathrm{inf}}(\psi)$  is yielded by constructing a suitable Cantor subset of  $E_{\mathrm{inf}}(\psi)$ .

For any  $0 < \epsilon < 1$ , define a sequence  $\{L_n(\epsilon)\}_{n>1}$  as follows:

$$L_n(\epsilon) = \sup_{j \geqslant n} \left\{ e^{\psi(j)(V+\epsilon)^{n-j}} \right\} \text{ for any } n \in \mathbb{N}.$$

It follows from the proof of Theorem 1.3 of [6] that

(4.7) 
$$\liminf_{n \to \infty} \frac{\log L_n(\epsilon)}{\psi(n)} = 1 \text{ and } \log L_{n+1}(\epsilon) - \log L_1(\epsilon) \leqslant (V + \epsilon - 1) \sum_{i=1}^n \log L_i(\epsilon).$$

Now, we use the sequence  $\{L_n(\epsilon)\}_{n\geq 1}$  to construct the Cantor subset of  $E_{\inf}(\psi)$ . Note that for any  $n\in\mathbb{N}$ ,  $L_n(\epsilon)\geqslant \mathrm{e}^{\psi(n)}$ , which implies  $\lim_{n\to\infty}L_n(\epsilon)=\infty$ , then there exsits a positive interger M such that  $M\lfloor L_n(\epsilon)+1\rfloor\geqslant 4$  holds for all  $n\in\mathbb{N}$ . Define

$$E\left(\left\{L_{n}\left(\epsilon\right)\right\}_{n\geqslant1}\right)=\left\{x\in\left(0,1\right]:M\lfloor L_{n}\left(\epsilon\right)+1\rfloor\leqslant d_{n}\left(x\right)\leqslant2M\lfloor L_{n}\left(\epsilon\right)+1\rfloor-1\text{ for any }n\in\mathbb{N}\right\}.$$

Similar to (3.20), it is easy to verify that

$$E\left(\left\{L_n\left(\epsilon\right)\right\}_{n\geqslant 1}\right)\subseteq E_{\mathrm{inf}}\left(\psi\right).$$

Therefore by Lemma 2.9 and formula (4.7), similar to (3.21), we have

$$\dim_{\mathbf{H}} E\left(\left\{L_{n}\left(\epsilon\right)\right\}_{n\geqslant1}\right)\geqslant\frac{1}{2+\limsup\sup_{n\to\infty}\frac{\log\left(L_{n+1}\left(\epsilon\right)+1\right)}{\log L_{1}\left(\epsilon\right)+\cdots+L_{n}\left(\epsilon\right)}}\geqslant\frac{1}{1+V+\epsilon}.$$

Hence

$$\dim_{\mathbf{H}} E_{\mathrm{inf}}(\psi) \geqslant \frac{1}{1 + V + \epsilon}.$$

Let  $\epsilon \to 0^+$ , this shows that

$$\dim_{\mathbf{H}} E_{\mathrm{inf}}(\psi) \geqslant \frac{1}{1+V}$$

**Upper bound** For any  $0 < \epsilon < 1$  and  $r \in \mathbb{N}$ , we define

$$F_{\psi}\left(r,\epsilon\right) = \left\{x \in \left(0,1\right] : d_{n}\left(x\right) \geqslant e^{\psi(n)(1-\epsilon)} \text{ for any } n \geqslant r\right\}.$$

It is easy to see that

$$E_{\inf}(\psi) \subseteq \bigcup_{r=1}^{\infty} F_{\psi}(r, \epsilon),$$

then

(4.8) 
$$\dim_{\mathbf{H}} E_{\inf} (\psi) \leqslant \dim_{\mathbf{H}} \bigcup_{r=1}^{\infty} F_{\psi} (r, \epsilon) = \sup_{r \geqslant 1} \dim_{\mathbf{H}} F_{\psi} (r, \epsilon).$$

For any  $r \in \mathbb{N}$ , now we estimate the Hausedorff dimension of  $F_{\psi}(r, \epsilon)$ , we consider the following cases.

(i) V = 1. Since  $\lim_{n \to \infty} \psi(n) = \infty$ , it is obvious that

$$F_{\psi}\left(r,\epsilon\right)\subseteq\left\{ x\in\left(0,1\right] :\lim_{n\to\infty}d_{n}\left(x\right)=\infty\right\} .$$

By Theorem 3.2 of [11], we have

$$\dim_{\mathcal{H}} F_{\psi}\left(r,\epsilon\right) \leqslant \dim_{\mathcal{H}} \left\{x \in (0,1]: \lim_{n \to \infty} d_{n}\left(x\right) = \infty\right\} = \frac{1}{2} = \frac{1}{1+V}.$$

(ii)  $1 < V < \infty$ . By the definition of V, one has

$$\psi(n) \geqslant (V - \epsilon)^n$$

holds for infinitely many  $n \in \mathbb{N}$ . We denote

$$U\left(\mathbf{e}^{(1-\epsilon)}, V - \epsilon\right) = \left\{x \in (0,1] : d_n\left(x\right) \geqslant \mathbf{e}^{(1-\epsilon)(V-\epsilon)^n} \text{ for infinitely many } n \in \mathbb{N}\right\},\,$$

then

$$F_{\psi}(r,\epsilon) \subseteq U(e^{(1-\epsilon)}, V - \epsilon).$$

Supposed that  $0 < \epsilon < \min \{V - 1, 1\}$ , then by Theorem 3.1 of [11], we have

$$\dim_{\mathbf{H}} F_{\psi}(r, \epsilon) \leqslant \dim_{\mathbf{H}} U(\mathbf{e}^{(1-\epsilon)}, V - \epsilon) = \frac{1}{1 + V - \epsilon}.$$

(iii)  $V = \infty$ . By the definition of V, for any M > 1, there exists infinitely many  $n \in \mathbb{N}$  such that

$$\psi(n) \geqslant M^n$$
,

then

$$F_{\psi}\left(r,\epsilon\right)\subseteq\left\{ x\in\left(0,1\right]:d_{n}\left(x\right)\geqslant\mathrm{e}^{\left(1-\epsilon\right)M^{n}}\text{ for infinitely many }n\in\mathbb{N}\right\} .$$

Similar to case (ii), we have

$$\dim_{\mathrm{H}} F_{\psi}(r, \epsilon) \leqslant \frac{1}{1+M}$$
.

By letting  $M \to \infty$ , one has

$$\dim_{\mathbf{H}} F_{\psi}\left(r,\epsilon\right) \leqslant \lim_{M \to \infty} \frac{1}{1+M} = 0 = \frac{1}{1+V}.$$

Combining (i) - (iii) and (4.8), it follows that

$$\dim_{\mathcal{H}} E_{\inf}\left(\psi\right) \leqslant \sup_{r \geqslant 1} \dim_{\mathcal{H}} F_{\psi}\left(r, \epsilon\right) \leqslant \begin{cases} \frac{1}{1+V} & \text{if } V = 1, \\ \frac{1}{1+V-\epsilon} & \text{if } 1 < V < \infty \text{ and } 0 < \epsilon < \min\left\{V-1, 1\right\}, \\ \frac{1}{1+V} & \text{if } V = \infty \text{ and } 0 < \epsilon < 1. \end{cases}$$

By letting  $\epsilon \to 0^+$ , we conclude that

$$\dim_{\mathbf{H}} E_{\inf} \left( \psi \right) \leqslant \frac{1}{1+V}.$$
