# OPTIMAL GRADIENT ESTIMATES FOR THE INSULATED CONDUCTIVITY PROBLEM WITH GENERAL CONVEX INCLUSIONS CASE

#### Abstract

In this paper we study the insulated conductivity problem involving two adjacent convex insulators embedded in a bounded domain. It is known that the gradient of solutions may blow up as the distance between two inclusions tends to zero. For general convex insulators, we establish a pointwise upper bound and a lower bound of the gradient with optimal blow up rates, which are associated with the first nonzero eigenvalue of an elliptic operator determined by the geometry of insulators. This extends the previous result for ball insulators in [12].


## 1. INTRODUCTION AND MAIN THEOREM

In this paper we establish the optimal gradient estimates for the insulated conductivity problem involving two adjacent general convex inclusions. The study of this area originated from [4], where the problem with inclusions closely located in a linear elastic background medium was studied numerically. We consider a bounded domain $D \subset \mathbb{R}^{n}(n \geq 2)$ with a $C^{2}$ boundary that contains two $C^{2, \gamma}$ convex open sets $D_{1}$ and $D_{2}$. We assume that they are located far away from the boundary $\partial D$, with $\operatorname{dist}\left(D_{1} \cup D_{2}, \partial D\right)>c>0$, and that the distance between two inclusions $\varepsilon=\operatorname{dist}\left(D_{1}, D_{2}\right)$ is small. Let $u$ be the solution to the insulated conductivity problem:

for a given function $\varphi \in C^{1, \alpha}(\partial D)$. Here $\partial_{\nu} u$ denotes the normal derivative on boundary $\partial D_{1} \cup \partial D_{2}$. It is well-known that there is a unique solution $u$ which is $C^{1, \alpha}$ on $\widetilde{\Omega}$. The solution $u$ represents the electric potential. There is interest from the perspective of engineering in estimating the magnitude of the electric field $\nabla u$ in the narrow region between $D_{1}$ and $D_{2}$. An open problem is to find the optimal upper bound on $|\nabla u|$ in terms of $\varepsilon$. We refer the reader to [1, 6, 8, 10, 11, 14, 16, 18, 21] and the references therein for background and related work on this problem.

In the case of $n=2$, Ammari, Kang, and Lim [3] demonstrated an upper bound for $|\nabla u|$ of order $\varepsilon^{-1 / 2}$ for circular inclusions by using the layer potential method. Ammari et al [2] further showed that this blow up rate, $\varepsilon^{-1 / 2}$, is sharp in dimension $n=2$. For insulated conductivity problem (1.1), Bao, Li and Yin [5] also obtained an upper bound of $|\nabla u|$ of order $\varepsilon^{-1 / 2}$ for all dimensions $n \geq 2$ for convex insulators
of arbitrary shape. However, the question of whether this upper bound is optimal in dimensions $n \geq 3$ remained open for about one decade. It was not until recently that Li and Yang [24] took advantage of a Harnack inequality to improve the upper bound in dimensions $n \geq 3$ to be on the order of $\varepsilon^{-1 / 2+\beta}$ for some $\beta>0$. Subsequently, Weinkove [26] employed a direct maximum principle argument and established an upper bound of order $\varepsilon^{-1 / 2+\beta(n)}$ with a specific constant $\beta(n)>0$ for $n \geq 4$ in the case where $D_{1}$ and $D_{2}$ are two balls. Later, Dong, Li, and Yang gave the optimal $\beta(n)$ for a certain class of inclusions, including two balls in all dimension $n \geq 3$, particularly with an explicit formula $\beta(n)=\left[-(n-1)+\sqrt{(n-1)^{2}+4(n-2)}\right] / 4$ when the insulators are balls in [12]. Dong, Yang and Zhu [15] further investigated the insulated conductivity problem with $p$-Laplacian, where the current-electric field relation follows the power law $J=|E|^{p-2} E$.

We use the notation $x=\left(x^{\prime}, x_{n}\right)$ to represent a point in $\mathbb{R}^{n}$, where $x^{\prime} \in \mathbb{R}^{n-1}$. After a possible translation and rotation of the coordinate if necessary, we assume that the origin $0 \in \partial D_{2}$ is one endpoint of the shortest line between $\partial D_{1}$ and $\partial D_{2}$, and there exists a universal constant $0<R_{0}<1$, such that near the origin, the parts of $\partial D_{1}$ and $\partial D_{2}$, denoted by $\Gamma_{+}$and $\Gamma_{-}$, can be represented by graphs of two functions in terms of $x^{\prime}$. That is,

where $f$ and $g$ are two $C^{2, \gamma}$ functions, $0<\gamma<1$, satisfying

For $0<r \leq 2 R_{0}$, we denote

Throughout this paper, we denote

a^{i j}=\frac{1}{2} \partial_{i j}(f-g)\left(0^{\prime}\right), \quad \text { and } a(\xi)=\sum_{i=1}^{n-1} \sum_{j=1}^{n-1} a^{i j} \frac{x_{i}}{\left|x^{\prime}\right|} \frac{x_{j}}{\left|x^{\prime}\right|}, \text { for } \xi \in \mathbb{S}^{n-2} \tag{1.4}
\end{equation*}

It is apparent that $a(\xi)>0$ a.e. and $\ln a(\xi) \in L^{\infty}\left(\mathbb{S}^{n-2}\right)$. Because $f$ and $g$ are in the class $C^{2, \gamma}$ and satisfy (1.2) and (1.3), we denote, for $\left|x^{\prime}\right|<2 R_{0}$,

It was proved in [13] that the optimal blow-up rate of the gradient for the insulated conductivity problem (1.1) is closely related to the first nonzero eigenvalue of of the following eigenvalue problem on $\mathbb{S}^{n-2}$ :

where $a(\xi)$ is defined by (1.4), determined by the Hessian $\partial_{i j}(f-g)\left(0^{\prime}\right)$. We define the inner product

From the classical theory, all eigenvalues of (1.6) are real, and the corresponding eigenfunctions can be normalized to form an orthonormal basis of $L^{2}\left(\mathbb{S}^{n-2}\right)$ under the inner-product defined by (1.7). The first nonzero eigenvalue $\lambda_{1}$ of problem (1.6) is given by the Rayleigh quotient:

Let $\alpha\left(\lambda_{1}\right)$ be the positive root of the quadratic polynomial $\alpha^{2}+(n-1) \alpha-\lambda_{1}$, that is,

According to Lemma 5.1 in [13], we conclude that $\lambda_{1} \leq n-2$ and hence $\alpha\left(\lambda_{1}\right) \in(0,1)$. In the case of circular inclusions, where $a(\xi) \equiv a$ is a positive constant and $\lambda_{1}=n-2$, Dong, Li, and Yang in [12] proved that the optimal blow-up rate of the gradient is $\varepsilon^{\frac{\alpha\left(\lambda_{1}\right)-1}{2}}$. In [13], they extended to study general convex inclusions case and proved that

|\nabla u(x)| \leq C\|u\|_{L^{\infty}\left(\Omega_{2 R_{0}}\right)}\left(\varepsilon+\left|x^{\prime}\right|^{2}\right)^{\frac{\alpha-1}{2}}, \quad \text { for } x \in \Omega_{R_{0}}, \quad 0 \leq \alpha<\alpha\left(\lambda_{1}\right) \tag{1.10}
\end{equation*}
$$

where $C$ is a constant depending on a lower bound of $\alpha\left(\lambda_{1}\right)-\alpha$. However, it is not clear whether $\varepsilon^{\frac{\alpha\left(\lambda_{1}\right)-1}{2}}$ is an optimal upper bound for general convex inclusions. In this paper, we show that $\varepsilon^{\frac{\alpha\left(\lambda_{1}\right)-1}{2}}$ indeed is an upper bound for $\nabla u$, with its sharpness proved in dimension $n=3$ and for a certain class of inclusions in dimensions $n \geq 4$.

By applying standard elliptic estimates, the solution $u \in H^{1}(\widetilde{\Omega})$ of (1.1) satisfies $\|u\|_{C^{1}\left(\widetilde{\Omega} \backslash \Omega_{R_{0} / 2}\right)} \leq C$. We only need to focus on the following problem near the origin:

Our main results of this paper are as follows.
Theorem 1.1. For $n \geq 3,0<\varepsilon \ll 1$, let $u \in H^{1}\left(\Omega_{2 R_{0}}\right)$ be a solution of (1.11) with $f$ and $g$ satisfying (1.2), (1.3) and (1.5). We have

\left|\nabla u\left(x^{\prime}\right)\right| \leq C\|u\|_{L^{\infty}\left(\Omega_{2 R_{0}}\right)}\left(\varepsilon+\left|x^{\prime}\right|^{2}\right)^{\frac{\alpha\left(\lambda_{1}\right)-1}{2}} \quad \forall x \in \Omega_{R_{0}} \tag{1.12}
\end{equation*}
$$

where $\lambda_{1}$ and $\alpha\left(\lambda_{1}\right)$ are given by (1.8) and (1.9), and $C$ is a positive constant depending only on $n, R_{0}, \gamma,\|f\|_{C^{2, \gamma}\left(\Gamma^{+}\right)},\|g\|_{C^{2, \gamma}\left(\Gamma^{-}\right)}$and $\|\ln a(\xi)\|_{L^{\infty}\left(\mathbb{S}^{n-2}\right)}$.
Remark 1.2. Estimate (1.12) improve the exponent from $\frac{\alpha-1}{2}$ in (1.10) to $\frac{\alpha\left(\lambda_{1}\right)-1}{2}$, which archives the optimality shown by Theorem 1.4 below.

Applying the maximum principle and Theorem 1.1, we have

Corollary 1.3. For $n \geq 3,0<\varepsilon \ll 1$, let $f$ and $g$ satisfy (1.2), (1.3) and (1.5). For any solution $u \in H^{1}(\widetilde{\Omega})$ of (1.1), we have

\|\nabla u\|_{L^{\infty}(\Omega)} \leq C\|\varphi\|_{C^{2}(\partial D)} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)-1}{2}} \tag{1.13}
\end{equation*}

where $\lambda_{1}$ and $\alpha\left(\lambda_{1}\right)$ are given by (1.8) and (1.9), and $C$ is a positive constant depending only on $n, R_{0}, \gamma,\left\|\partial D_{1}\right\|_{C^{2, \gamma}},\left\|\partial D_{2}\right\|_{C^{2, \gamma}},\|\partial \Omega\|_{C^{2}}$ and $\|\ln a(\xi)\|_{L^{\infty}\left(\mathbb{S}^{n-2}\right)}$.

The estimate (1.12) is shown to be optimal by the following lower bound estimates.
Theorem 1.4. For $n \geq 3$, let $D_{1}$ and $D_{2}$ be two strictly convex smooth domains in $B_{5}$, which are symmetric in $x_{j}$ for each $1 \leq j \leq n-1$, with $\lambda_{1}$ and $\alpha\left(\lambda_{1}\right)$ given by (1.8) and (1.9). Assume that the eigenspace corresponding to $\lambda_{1}$ contains a function which is odd in $x_{j}$ for some $1 \leq j \leq n-1$. Let $\varphi=x_{j}$ and $u \in H^{1}(\widetilde{\Omega})$ be the solution of (1.1). Then we have

\|\nabla u\|_{L^{\infty}(\tilde{\Omega})} \geq \frac{1}{C} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)-1}{2}} \tag{1.14}
\end{equation*}

where $C$ depends only on $\left\|\partial D_{1}\right\|_{C^{4}},\left\|\partial D_{2}\right\|_{C^{4}},\|\ln a(\xi)\|_{L^{\infty}\left(\mathbb{S}^{n-2}\right)}, \alpha\left(\lambda_{1}\right)$ and $n$.
By employing the property of the eigenspace associated with the first nonzero eigenvalue $\lambda_{1}$ of (1.6), as proved in [13](Theorem 5.2 and Corollary 5.7 in [13]), it can be inferred that the conditions outlined in Theorem 1.5 and 1.6 imply the conditions in Theorem 1.4, Consequently, the subsequent theorems follow directly.

Theorem 1.5. For $n=3$ and for any positive definite matrix $M$, there exist two smooth strictly convex inclusions $D_{1}, D_{2}$ inside $D=B_{5}$ with $D^{2}(f-g)\left(0^{\prime}\right)=M$, and a boundary data $\varphi \in C^{\infty}(\partial D)$ with $\|\varphi\|_{L^{\infty}(\partial D)}=1$, such that the solution $u \in H^{1}(\widetilde{\Omega})$ of (1.1) satisfies

\|\nabla u\|_{L^{\infty}(\tilde{\Omega})}>\frac{1}{C} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)-1}{2}}
$$

where $\lambda_{1}$ and $\alpha\left(\lambda_{1}\right)$ are given by (1.8) and (1.9) with $a(\xi)=\xi^{t} M \xi$, and $C$ depends only on $\left\|\partial D_{1}\right\|_{C^{4}},\left\|\partial D_{2}\right\|_{C^{4}},\|\ln a(\xi)\|_{L^{\infty}\left(\mathbb{S}^{n-2}\right)}, \alpha\left(\lambda_{1}\right)$ and $n$.

Theorem 1.6. For $n \geq 4$, there exists an $\varepsilon_{0}=\varepsilon_{0}(n) \in(0,1 / 2)$ such that for any positive definite matrix $M$ satisfying

there exist two smooth strictly convex inclusions $D_{1}, D_{2}$ inside $D=B_{5}$ with $D^{2}(f-$ $g)\left(0^{\prime}\right)=M$, and a boundary data $\varphi \in C^{\infty}(\partial D)$ with $\|\varphi\|_{L^{\infty}(\partial D)}=1$, such that the solution $u \in H^{1}(\widetilde{\Omega})$ of (1.1) satisfies

\|\nabla u\|_{L^{\infty}(\widetilde{\Omega})}>\frac{1}{C} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)-1}{2}}
$$

where $\lambda_{1}$ and $\alpha\left(\lambda_{1}\right)$ are given by (1.8) and (1.9) with $a(\xi)=\xi^{t} M \xi$, and $C$ is a positive constant depending only on $\left\|\partial D_{1}\right\|_{C^{4}},\left\|\partial D_{2}\right\|_{C^{4}},\|\ln a(\xi)\|_{L^{\infty}\left(\mathbb{S}^{n-2}\right)}, \alpha\left(\lambda_{1}\right)$ and $n$.

In the above, $\|M\|$ and $\|I\|$ denote the standard norm of the matrices.
The rest of this paper is organized as follows. In Section 2, we establish some estimates for the degenerate elliptic operator associated with the problem, which are crucial in the proof of Theorems 1.1 and 1.4. Theorems 1.1 and 1.4 are showed in Sections 3 and 4, respectively.

## 2. Estimates on degenerate elliptic operators

In this section, we establish some estimates for elliptic equations with degenerate coefficients, which are necessary for proving Theorem 1.1 and 1.4. Throughout this section, we work in the domain $B_{R} \subset \mathbb{R}^{n-1}$ for some $R>0$ and $n \geq 3$.

Let $a(\xi)$ be defined by (1.4). We introduce the following norms:

and

\|u\|_{C^{1}(D)}^{\prime}:=\|u\|_{L^{\infty}(D)}+d\|\nabla u\|_{L^{\infty}(D)},\|u\|_{C^{1, \mu}(D)}^{\prime}:=\|u\|_{C^{1}(D)}^{\prime}+d^{1+\mu}[\nabla u]_{C^{\mu}(D)},

where $d=\sup _{x, y \in D}|x-y|, D \subset \mathbb{R}^{n-1}$ or $\mathbb{R}^{n}$. For any bounded set $\Omega \subset \mathbb{R}^{n-1}$, we denote $H^{1}\left(\Omega,\left|x^{\prime}\right|^{2} d x^{\prime}\right)$ as the weighted $H^{1}$ norms given by:

For $\rho>0$, define the average

By using harmonic decomposition and the maximum principle, we can get following lemma from [13].

Lemma 2.1 ([13],Lemma 2.2). For $n \geq 3$, let $a(\xi)$ satisfy (1.4), $\lambda_{1}$ and $\alpha\left(\lambda_{1}\right)$ be given by (1.8) and (1.9), and $v_{1} \in H^{1}\left(B_{R_{0}},\left|x^{\prime}\right|^{2} d x^{\prime}\right)$ satisfy

Then $v_{1} \in C^{\beta}\left(B_{R_{0}}\right)$, for some $\beta>0$ depending only on $n$ and $\|\ln a(\xi)\|_{L^{\infty}\left(\mathbb{S}^{n-2}\right)}$. Moreover, for any $0<\rho<R \leq R_{0}$, we have $v_{1}\left(0^{\prime}\right)=\left(v_{1}\right)_{\partial B_{\rho}}^{a}$, and

\left(f_{\partial B_{\rho}} a(\xi)\left|v_{1}\left(x^{\prime}\right)-v_{1}\left(0^{\prime}\right)\right|^{2} d \sigma\right)^{1 / 2} \leq\left(\frac{\rho}{R}\right)^{\alpha\left(\lambda_{1}\right)}\left(f_{\partial B_{R}} a(\xi)\left|v_{1}\left(x^{\prime}\right)-v_{1}\left(0^{\prime}\right)\right|^{2} d \sigma\right)^{1 / 2} .

Lemma 2.2. For $n \geq 3$, let $a(\xi)$ satisfy (1.4), $\lambda_{1}$ and $\alpha\left(\lambda_{1}\right)$ be given by (1.8) and (1.9), and $v_{1} \in H^{1}\left(B_{R},\left|x^{\prime}\right|^{2} d x^{\prime}\right)$ satisfy

where $V_{1} \in C^{1, \mu}\left(\bar{B}_{R} \backslash B_{\frac{3}{4} R}\right)$ for some $\mu \in(0,1)$. Then for any $x^{\prime} \in \bar{B}_{R} \backslash\left\{0^{\prime}\right\}$,

where $C$ depends only on $n,\|\ln a\|_{L^{\infty}}$ and $\mu$.
Proof. For $\left|x_{0}^{\prime}\right| \in\left(0, \frac{7}{8} R\right]$, we take a change of variables by defining $y^{\prime}=\frac{x^{\prime}}{\left|x_{0}^{\prime}\right|}$ to map the region $B_{\left|x_{0}^{\prime}\right|+\frac{1}{8}\left|x_{0}^{\prime}\right|} \backslash B_{\left|x_{0}^{\prime}\right|-\frac{1}{8}\left|x_{0}^{\prime}\right|}$ to $B_{1+\frac{1}{8}} \backslash B_{1-\frac{1}{8}}$. Let $\tilde{v}_{1}\left(y^{\prime}\right)=v_{1}\left(\left|x_{0}^{\prime}\right| y^{\prime}\right)=v_{1}\left(x^{\prime}\right)$. Then $\tilde{v}_{1}\left(y^{\prime}\right)$ satisfies the equation

& \leq C\left(\frac{\left|x_{0}^{\prime}\right|}{R}\right)^{\alpha\left(\lambda_{1}\right)}\left(f_{\partial B_{R}}\left|v_{1}\left(x^{\prime}\right)-v_{1}\left(0^{\prime}\right)\right|^{2} d x^{\prime}\right)^{1 / 2} \\
& \leq C\left(\frac{\left|x_{0}^{\prime}\right|}{R}\right)^{\alpha\left(\lambda_{1}\right)}\left\|V_{1}-\left(V_{1}\right)_{\partial B_{R}}^{a}\right\|_{C^{1, \mu}\left(B_{R} \backslash B_{\frac{3}{4} R}\right)}^{\prime} .

For $\left|x_{0}^{\prime}\right| \in\left(\frac{7}{8} R, R\right]$, we choose a change of variables $y^{\prime}=\frac{x^{\prime}}{R}$ to map the domain $B_{R} \backslash B_{\frac{3}{4} R}$ to $B_{1} \backslash B_{\frac{3}{4}}$. Set $\tilde{v}_{1}\left(y^{\prime}\right)=v_{1}\left(R y^{\prime}\right)=v_{1}\left(x^{\prime}\right)$ and $\tilde{V}_{1}\left(y^{\prime}\right)=V_{1}\left(R y^{\prime}\right)=V_{1}\left(x^{\prime}\right)$. Then $\tilde{v}_{1}\left(y^{\prime}\right)$ satisfies

& \leq(2 \chi)^{\frac{C i}{\chi^{i}}}\left\|v_{3}\right\|_{L^{t_{i}\left(B_{1},\left|x^{\prime}\right|^{2} d x^{\prime}\right)}}+\frac{C}{\chi^{i}} \\
& \leq(2 \chi)^{\sum_{k=0}^{i} \frac{C k}{\chi^{k}}}\left\|v_{3}\right\|_{L^{t_{0}\left(B_{1},\left|x^{\prime}\right|^{2} d x^{\prime}\right)}}+\sum_{k=0}^{i} \frac{C}{\chi^{k}} \leq C .
\end{aligned}
$$

Letting $i \rightarrow \infty$, the case where $R=1$ is finished. For $R>0$, we set $y^{\prime}=\frac{x^{\prime}}{R}$. Let $\tilde{v}_{3}\left(y^{\prime}\right)=v_{3}\left(x^{\prime}\right)$ and $\tilde{F}\left(y^{\prime}\right)=\frac{F\left(x^{\prime}\right)}{R}$. Then $\tilde{v}_{3}$ satisfies

\end{aligned}\right.

where $\tilde{\varepsilon}=\frac{\varepsilon}{R^{2}}$. Therefore, we have

\left\|\tilde{v}_{3}\right\|_{L^{\infty}\left(B_{1}\right)} \leq C\|\tilde{F}\|_{\tilde{\varepsilon}, \sigma, 1,1} \tag{2.10}
\end{equation*}

Then, considering that $\left\|\tilde{v}_{3}\right\|_{L^{\infty}\left(B_{1}\right)}=\left\|v_{3}\right\|_{L^{\infty}\left(B_{R}\right)}$ and $\|\tilde{F}\|_{\tilde{\varepsilon}, \sigma, 1,1} \leq C\|F\|_{\varepsilon, \sigma, 1, R} R^{\sigma-1}$, we can complete the proof of (i).
(ii) We only prove the case that $R=1$ and $\left\|F_{\sqrt{\varepsilon}}\right\|_{\varepsilon, 1,1,1} \leq 1$, which means that $\left|F\left(x^{\prime}\right)\right| \leq \sqrt{\varepsilon}\left|x^{\prime}\right|$. By utilizing the inequalities $\sqrt{\varepsilon}\left|x^{\prime}\right| \leq C\left(\varepsilon+a(\xi)\left|x^{\prime}\right|^{2}\right)$ and $\left|F\left(x^{\prime}\right)\right| \leq$ $\sqrt{\varepsilon}\left|x^{\prime}\right|$, we can derive

By means of the Hölder inequality and the following version of the Caffarelli-KohnNirenberg inequality (see [9]) in $\mathbb{R}^{n-1}$ :

By employing an iteration argument again, we can obtain $\left\|v_{3}\right\|_{L^{\infty}\left(B_{1}\right)} \leq C$. The proof of (ii) is finished.
(iii) We only prove the case that $R=1$ and $\left\|F_{\varepsilon}\right\|_{\varepsilon, 1,1,1} \leq 1$, indicating that $\left|F\left(x^{\prime}\right)\right| \leq$ $\varepsilon\left|x^{\prime}\right|$. By using $\varepsilon \leq \varepsilon+a(\xi)\left|x^{\prime}\right|^{2}$ and $\left|F\left(x^{\prime}\right)\right| \leq \varepsilon\left|x^{\prime}\right|$, we have

## 3. Proof of Theorem 1.1

In this section, we are dedicated to proving Theorem 1.1. Following a similar argument as in Section 4 of [22], we define

and

\tilde{F}^{i}\left(x^{\prime}\right)=\int_{g\left(x^{\prime}\right)}^{\varepsilon+f\left(x^{\prime}\right)}\left(\frac{x_{n}-\varepsilon-f\left(x^{\prime}\right)}{\delta\left(x^{\prime}\right)} \partial_{i} g\left(x^{\prime}\right)-\frac{x_{n}-g\left(x^{\prime}\right)}{\delta\left(x^{\prime}\right)} \partial_{i} f\left(x^{\prime}\right)\right) \partial_{n} u(x) d x_{n} .
$$

Because $\delta\left(x^{\prime}\right)=\varepsilon+a(\xi)\left|x^{\prime}\right|^{2}+O\left(\left|x^{\prime}\right|^{2+\gamma}\right.$ ), we can rewrite (3.1) as

\end{equation*}
$$

and
$F_{2}^{i}\left(x^{\prime}\right):=\int_{g\left(x^{\prime}\right)}^{f\left(x^{\prime}\right)}\left(\frac{x_{n}-\varepsilon-f\left(x^{\prime}\right)}{\delta\left(x^{\prime}\right)} \partial_{i} g\left(x^{\prime}\right)-\frac{x_{n}-g\left(x^{\prime}\right)}{\delta\left(x^{\prime}\right)} \partial_{i} f\left(x^{\prime}\right)\right) \partial_{n} u(x) d x_{n}+O\left(\left|x^{\prime}\right|^{2+\gamma}\right) \partial_{i} \bar{u}\left(x^{\prime}\right)$.
By employing the "flipping argument" used in the proof of Theorem 1.2 in (5) or Theorem 1.1 in [12], we derive the following two lemmas. Since their proofs are quite similar, we will only present the proof of Lemma 3.2,

Lemma 3.1. For $n \geq 3, \varepsilon \in(0,1 / 4)$, let $u \in H^{1}\left(\Omega_{2 R_{0}}\right)$ be a solution of (1.11) with $f$ and $g$ satisfying (1.2), (1.3) and (1.5). We have

where $C$ depends only on $n$, $\gamma, R_{0},\|f\|_{C^{2, \gamma}\left(\Gamma^{+}\right)},\|g\|_{C^{2, \gamma}\left(\Gamma^{-}\right)}$and $\|\ln a(\xi)\|_{L^{\infty}\left(\mathbb{S}^{n-2}\right)}$.
Denote

Q_{t, s}(z):=\left\{y=\left(y^{\prime}, y_{n}\right) \in \mathbb{R}^{n}| | y^{\prime}-z^{\prime}\left|<s,\left|y_{n}\right|<t\right\}, \quad Q_{t, s}=Q_{t, s}(0) .\right. \tag{3.5}
\end{equation*}
$$

Lemma 3.2. For $n \geq 3,0<\varepsilon \ll 1$, let $f$ and $g$ satisfy (1.2), (1.3) and (1.5). For any solution $u \in H^{1}\left(\Omega_{2 R_{0}}\right)$ of (1.11) and $\sqrt{\varepsilon} \leq \rho \leq R_{0}$, we have

\left\|u-\bar{u}\left(0^{\prime}\right)\right\|_{C^{1}\left(\Omega_{\rho} \backslash \Omega_{\frac{3}{4} \rho}\right)}^{\prime}+\left\|\bar{u}-\bar{u}\left(0^{\prime}\right)\right\|_{C^{1, \mu}\left(B_{\rho}\left(0^{\prime}\right) \backslash B_{\frac{3}{4} \rho}\left(0^{\prime}\right)\right)}^{\prime} \leq C\left(f_{\Omega_{2 \rho} \backslash \Omega_{\rho / 2}}\left|u-\bar{u}\left(0^{\prime}\right)\right|^{2}\right)^{1 / 2}
$$

where $C$ depends only on $n, \gamma, R_{0},\|f\|_{C^{2, \gamma}\left(\Gamma^{+}\right)},\|g\|_{C^{2, \gamma}\left(\Gamma^{-}\right)}$and $\|\ln a(\xi)\|_{L^{\infty}\left(\mathbb{S}^{n-2}\right)}$.
Proof. For $\rho \geq \sqrt{\varepsilon}$, we make use of the following change of variables

to map the domain $\Omega_{2 \rho} \backslash \Omega_{\rho / 2}$ to $Q_{\rho^{2}, 2 \rho} \backslash Q_{\rho^{2}, \rho / 2}$, where $Q_{t, s}$ is defined by (3.5). Let $v(y)=u(x)$. Then $v(y)$ satisfies

where $\left(b^{i j}(y)\right)=\frac{\left(\partial_{x} y\right)\left(\partial_{x} y\right)^{t}}{\operatorname{det}\left(\partial_{x} y\right)}$. Then $\bar{v}\left(y^{\prime}\right)=f_{-\rho^{2}}^{\rho^{2}} v\left(y^{\prime}, y_{n}\right) d y_{n}=\bar{u}\left(x^{\prime}\right)$, and satisfies

\left.\left\|b^{i n}\right\|_{L^{\infty}\left(Q_{\rho^{2}, 2 \rho} \backslash Q_{\rho^{2}, \rho / 2}\right)} \leq C \rho, \quad\left[b^{i n}\right]_{C^{\mu}\left(Q_{\rho^{2}, 2 \rho}\right)} \leq Q_{\rho^{2}, \rho / 2}\right) \leq C \rho^{1-2 \mu}, \quad 1 \leq i \leq n-1  \tag{3.7}\\
\left\|\nabla b^{i j}\right\|_{L^{\infty}\left(Q_{\rho^{2}, 2 \rho} \backslash Q_{\rho^{2}, \rho / 2}\right)} \leq C \rho^{-1}, \quad 1 \leq i, j \leq n-1
\end{gather*}
$$

Let $\tilde{b}^{i j}(z)=b^{i j}(\rho z)$ and $\tilde{v}(z)=v(\rho z)$. Then $\tilde{v}(z)$ satisfies

\end{aligned}\right.

with $\frac{I}{C} \leq \tilde{b} \leq C I$ and $\|\tilde{b}\|_{C^{\mu}\left(Q_{\rho, 2} \backslash Q_{\rho, 1 / 2}\right)} \leq C$. We define

S_{l}:=\left\{z \in \mathbb{R}^{n}\left|1 / 2<\left|z^{\prime}\right|<2,(2 l-1) \rho<z_{n}<(2 l+1) \rho\right\}\right.

for any integer $l$, and $S_{s, t}^{m}:=\left\{z \in \mathbb{R}^{n}\left|s<\left|z^{\prime}\right|<t,\left|z_{n}\right|<m\right\}\right.$. Note that $Q_{\rho, 2} \backslash$ $Q_{\rho, 1 / 2}=S_{0}$. We take the even extension of $\tilde{v}$ with respect to $y_{n}=\rho$ and then take the periodic extension (so that the period is equal to $2 \rho$ ). More precisely, we define, for any $l \in \mathbb{Z}$, a new function $\hat{v}$ by setting

Then $\hat{v}$ and $\hat{b}^{i j}$ are defined in the infinite ring $Q_{2, \infty} \backslash Q_{1 / 2, \infty}$. In particular, $\hat{v}$ satisfies the equation

For $\frac{11}{16} \rho \leq\left|y^{\prime}\right| \leq \frac{3}{2} \rho$, let $\tilde{b}^{i j}(z)=b^{i j}\left(y^{\prime}+\rho^{2} z^{\prime}, \rho^{2} z_{n}\right)$ and $\tilde{v}(z)=v\left(y^{\prime}+\rho^{2} z^{\prime}, \rho^{2} z_{n}\right)$. Then $\tilde{v}$ satisfies

\end{aligned}\right.
$$

By the $W^{2, p}$ estimates, for $p>n$,

\|\nabla \tilde{v}\|_{C^{\mu}\left(Q_{\frac{1}{2}, 1}\right)} & \leq C\left\|\tilde{v}-(\tilde{v})_{Q_{1,1}}\right\|_{W^{2, p}\left(Q_{1,1}\right)} \leq C\left\|\tilde{v}-(\tilde{v})_{Q_{1,1}}\right\|_{L^{\infty}\left(Q_{1,1}\right)} \\
& \leq C\|\nabla \tilde{v}\|_{L^{\infty}\left(Q_{1,1}\right)} \leq C \rho^{2}\|\nabla v\|_{L^{\infty}\left(Q_{\rho^{2}, \rho^{2}}(y)\right)} \\
& \left.\leq C \rho^{2}\|\nabla v\|_{L^{\infty}\left(Q_{\rho^{2}, \frac{7}{4} \rho} \backslash Q_{\rho^{2}, \frac{5}{8} \rho}\right)} \leq C \rho\left\|u-\bar{u}\left(0^{\prime}\right)\right\|_{C^{1}\left(\Omega_{\frac{7}{4} \rho}, \Omega_{\frac{5}{8} \rho}\right.}^{\prime}\right)
\end{aligned}
$$

By rescaling, we obtain

\end{equation*}

Noting that $\bar{v}$ satisfies (3.6), and using the scaling technique, (3.7), (3.9) and (3.8), we have

Returning to $\bar{u}$, the proof is completed.
By Lemma 3.1 and 3.2, the following Corollary is immediate.
Corollary 3.3. For $n \geq 3, \varepsilon \in(0,1 / 4)$, let $f$ and $g$ satisfy (1.2), (1.3) and (1.5). For any solution $u \in H^{1}\left(\Omega_{2 R_{0}}\right)$ of (1.11) with $\|u\|_{L^{\infty}\left(\Omega_{2 R_{0}}\right)} \leq 1$, if $x \in \Omega_{R_{0}} \backslash \Omega_{\sqrt{\varepsilon}}$, we have

\end{equation*}
$$

if $x \in \Omega_{\sqrt{\varepsilon}}$, we have

where $C$ depends only on $n, \gamma, R_{0},\|f\|_{C^{2, \gamma}\left(\Gamma^{+}\right)},\|g\|_{C^{2, \gamma}\left(\Gamma^{-}\right)}$and $\|\ln a(\xi)\|_{L^{\infty}\left(\mathbb{S}^{n-2}\right)}$.

## 4. Proof of Theorem 1.4

In this section, the constants $C_{i}, i=1,2,3,4,5, C$ and $r_{0}$ depend only on the norms $\left\|\partial D_{1}\right\|_{C^{4}},\left\|\partial D_{2}\right\|_{C^{4}},\|\ln a(\xi)\|_{L^{\infty}\left(\mathbb{S}^{n-2}\right)}, \alpha\left(\lambda_{1}\right)$ and $n$, but are independent of $\varepsilon$.

Proof of Theorem 1.4. After a suitable rotation in $\mathbb{R}^{n-1}$, we can assume without loss of generality that

where $\left|E\left(x^{\prime}\right)\right| \leq C\left|x^{\prime}\right|^{4}$. Set

$$
\bar{u}\left(x^{\prime}\right)=f_{g\left(x^{\prime}\right)}^{\varepsilon+f\left(x^{\prime}\right)} u\left(x^{\prime}, x_{n}\right) d x_{n} .
$$

Then, similar to Section 3, we have

$$
\operatorname{div}\left[\left(\varepsilon+\sum_{i=1}^{n-1} a_{i} x_{i}^{2}\right) \nabla \bar{u}\right]=\partial_{i} F^{i}\left(x^{\prime}\right) \quad \text { in } B_{1} \in \mathbb{R}^{n-1}
$$

where $F^{i}\left(x^{\prime}\right)=\int_{g\left(x^{\prime}\right)}^{\varepsilon+f\left(x^{\prime}\right)}\left(\frac{x_{n}-\varepsilon-f\left(x^{\prime}\right)}{\delta\left(x^{\prime}\right)} \partial_{i} g\left(x^{\prime}\right)-\frac{x_{n}-g\left(x^{\prime}\right)}{\delta\left(x^{\prime}\right)} \partial_{i} f\left(x^{\prime}\right)\right) \partial_{n} u(x) d x_{n}+O\left(\left|x^{\prime}\right|^{4}\right) \partial_{i} \bar{u}\left(x^{\prime}\right)$.
Step 1. We write $\bar{u}=u_{1}+u_{2}$ in $B_{1}$, where $u_{1}$ satisfies

$$
\left\{\begin{array}{rlrl}
\operatorname{div}\left[\left(\sum_{i=1}^{n-1} a_{i} x_{i}^{2}\right) \nabla u_{1}\right] & =\partial_{i} F_{1}^{i}\left(x^{\prime}\right) & \text { in } B_{1} \subset R^{n-1} \\
u_{1} & =\bar{u} \quad \text { on } \partial B_{1}
\end{array}\right.
$$

where $F_{1}^{i}\left(x^{\prime}\right)=\int_{g\left(x^{\prime}\right)}^{f\left(x^{\prime}\right)}\left(\frac{x_{n}-\varepsilon-f\left(x^{\prime}\right)}{\delta\left(x^{\prime}\right)} \partial_{i} g\left(x^{\prime}\right)-\frac{x_{n}-g\left(x^{\prime}\right)}{\delta\left(x^{\prime}\right)} \partial_{i} f\left(x^{\prime}\right)\right) \partial_{n} u(x) d x_{n}+O\left(\left|x^{\prime}\right|^{4}\right) \partial_{i} \bar{u}\left(x^{\prime}\right)$, and $u_{2}$ satisfies

$$
\left\{\begin{array}{rlr}
\operatorname{div}\left[\left(\varepsilon+\sum_{i=1}^{n-1} a_{i} x_{i}^{2}\right) \nabla u_{2}\right] & =\partial_{i} F_{2}^{i}\left(x^{\prime}\right)-\varepsilon \Delta u_{1}\left(x^{\prime}\right) \quad \text { in } B_{1} \subset \mathbb{R}^{n-1} \\
u_{2} & =0 & \text { on } \partial B_{1}
\end{array}\right.
$$

where $F_{2}^{i}\left(x^{\prime}\right)=\int_{f\left(x^{\prime}\right)}^{\varepsilon+f\left(x^{\prime}\right)}\left(\frac{x_{n}-\varepsilon-f\left(x^{\prime}\right)}{\delta\left(x^{\prime}\right)} \partial_{i} g\left(x^{\prime}\right)-\frac{x_{n}-g\left(x^{\prime}\right)}{\delta\left(x^{\prime}\right)} \partial_{i} f\left(x^{\prime}\right)\right) \partial_{n} u(x) d x_{n}$.
By a direct calculation, we obtain

$$
\begin{equation*}
\left|F_{1}^{i}\left(x^{\prime}\right)\right| \leq C_{0}\left|x^{\prime}\right|^{\alpha\left(\lambda_{1}\right)+2} \tag{4.1}
\end{equation*}
$$

Using the standard regularity theory, we have $\|\bar{u}\|_{C^{2}\left(B_{1}\left(0^{\prime}\right) \backslash B_{3 / 4}\left(0^{\prime}\right)\right)} \leq C_{0}$. According to Proposition 2.1 in [13, we know

$$
\left|u_{1}\left(x^{\prime}\right)-u_{1}\left(0^{\prime}\right)\right| \leq C_{0}\left|x^{\prime}\right|^{\alpha\left(\lambda_{1}\right)}
$$

Then, by a similar argument as in Corollary 2.2, for $\left|x^{\prime}\right| \neq 0$, we have

$$
\left|u_{1}\left(x^{\prime}\right)-u_{1}\left(0^{\prime}\right)\right|+\left|x^{\prime}\right|\left|\nabla u_{1}\left(x^{\prime}\right)\right| \leq C_{0}\left|x^{\prime}\right|^{\alpha\left(\lambda_{1}\right)} .
$$

It is obvious that $\left|F_{2}^{i}\left(x^{\prime}\right)\right| \leq C_{0} \varepsilon\left|x^{\prime}\right|$. We further decompose $u_{2}=u_{21}+u_{22}$ in $B_{1}\left(0^{\prime}\right)$ such that $u_{21} \in H_{0}^{1}\left(B_{1}\left(0^{\prime}\right)\right)$ and satisfies

$$
\operatorname{div}\left[\left(\varepsilon+\sum_{i=1}^{n-1} a_{i} x_{i}^{2}\right) \nabla u_{21}\right]=\partial_{i} F_{2}^{i}\left(x^{\prime}\right) \quad \text { in } B_{1} \subset \mathbb{R}^{n-1}
$$

Since $\left|F_{2}^{i}\left(x^{\prime}\right)\right| \leq C_{0} \varepsilon\left|x^{\prime}\right|$, which implies $\left\|\frac{F_{2}}{\sqrt{\varepsilon}}\right\|_{\varepsilon, 1,1,1} \leq C_{0} \sqrt{\varepsilon}$, by Lemma [2.4, we have

$$
\left\|u_{21}\right\|_{L^{\infty}\left(B_{1}\left(0^{\prime}\right)\right)} \leq C_{0} \sqrt{\varepsilon}
$$

Then $u_{22} \in H_{0}^{1}\left(B_{1}\left(0^{\prime}\right)\right)$ is a solution to

$$
\operatorname{div}\left[\left(\varepsilon+\sum_{i=1}^{n-1} a_{i} x_{i}^{2}\right) \nabla u_{22}\right]=-\varepsilon \Delta u_{1}\left(x^{\prime}\right)
$$

By using a similar argument to derive (3.19), we obtain

$$
\left\|u_{22}\right\|_{L^{\infty}\left(B_{1}\left(0^{\prime}\right)\right)} \leq C_{0} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)}{2}}
$$

So that

$$
\begin{equation*}
\left\|u_{2}\right\|_{L^{\infty}\left(B_{1}\right)} \leq\left\|u_{21}\right\|_{L^{\infty}\left(B_{1}\right)}+\left\|u_{22}\right\|_{L^{\infty}\left(B_{1}\right)} \leq C_{0} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)}{2}} . \tag{4.2}
\end{equation*}
$$

We also have

$$
\left|f_{\mathbb{S}^{n}-2} a(\xi)\left(u_{2}(r, \xi)-u_{2}\left(0^{\prime}\right)\right) Y_{1, j}(\xi) d \xi\right| \leq C_{0} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)}{2}}
$$

and

$$
\left(f_{\partial B_{r}} a(\xi)\left(u_{2}(r, \xi)-u_{2}\left(0^{\prime}\right)\right)^{2} d \xi\right)^{1 / 2} \leq C_{0} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)}{2}} \quad \forall r \in(0,1)
$$

where $Y_{k, i}$ is the normalized eigenfunction corresponding to $k$-th nonzero eigenvalue $\lambda_{k}$ of the problem (1.6), and $\left\{Y_{k, i}\right\}_{k, i}$ forms an orthonormal basis of $L^{2}\left(\mathbb{S}^{1}\right)$ under the inner product (1.7). By assumption, we can use $Y_{1, j}$ to denote the eigenfunction which is odd in $x_{j}$. Therefore, $Y_{1, j}$ is the eigenfunction corresponding to the first nonzero eigenvalue of $\lambda_{1}$ of (1.6) in the half sphere $\mathbb{S}^{n-2} \cap\left\{x_{j}>0\right\}$ with zero Dirichlet boundary condition. This implies that $\lambda_{1}$ is simple and $Y_{1, j}$ does not change its sign in the half sphere. Without loss of generality, we assume $Y_{1, j}>0$ in $\left\{x_{j}>0\right\}$.
step 2. For $u_{1}$, we decompose it as follows:

$$
u_{1}\left(x^{\prime}\right)-u_{1}\left(0^{\prime}\right)=U_{0}(r) Y_{0}+\sum_{k=1}^{\infty} \sum_{i=1}^{N(k)} U_{k, i}(r) Y_{k, i}(\xi) \quad x^{\prime} \in B_{1} \backslash\{0\}
$$

where $U_{k, i}(r)=f_{\mathbb{S}^{1}} a(\xi)\left(u_{1}(r, \xi)-u_{1}\left(0^{\prime}\right)\right) Y_{k, i}(\xi) d \xi$ and $U_{k, i} \in C([0,1)) \cap C^{\infty}((0,1))$. Then $U_{1, j}$ satisfies $U_{1, j}(0)=0$ and

$$
L U_{1, j}:=r^{2} U_{1, j}^{\prime \prime}(r)+n r U_{1, j}^{\prime}(r)-\lambda_{1} U_{1, j}(r)=H(r), \quad 0<r<1,
$$

where

$$
\begin{aligned}
H(r) & =f_{\mathbb{S}^{n-2}} Y_{1, j}(\xi) \operatorname{div} F_{1} d \xi=f_{\mathbb{S}^{n-2}}\left(\partial_{r} F_{1}+\frac{1}{r} \operatorname{div}_{\xi} F_{1}\right) Y_{1, j}(\xi) d \xi \\
& =\partial_{r}\left(f_{\mathbb{S}^{n-2}} F_{1} Y_{1,1}(\xi) d \xi\right)-\frac{1}{r} f_{\mathbb{S}^{n-2}} F_{1} \operatorname{div}_{\xi} Y_{1, j}(\xi) d \xi \\
& =: A^{\prime}(r)+B(r), \quad 0<r<1
\end{aligned}
$$

and $A(r), B(r) \in C^{1}([0,1))$ satisfy, in view of (4.1), that

$$
\begin{equation*}
|A(r)| \leq C(n) r^{2+\alpha\left(\lambda_{1}\right)}, \quad|B(r)| \leq C(n) r^{1+\alpha\left(\lambda_{1}\right)}, \quad 0<r<1 \tag{4.3}
\end{equation*}
$$

step 3. We will show, for some constant $\tilde{C}_{1} \geq C_{1}>0$, that

$$
\begin{equation*}
U_{1, j}(r)=\tilde{C}_{1} r^{\alpha\left(\lambda_{1}\right)}+v(r), \quad 0<r<1 \tag{4.4}
\end{equation*}
$$

where $|v(r)| \leq C_{2} r^{1+\alpha\left(\lambda_{1}\right)}$. We use the method of reduction of order to find a bounded solution $v$ satisfying $L v=H$ in $(0,1)$, and then show that $|v(r)| \leq C_{2} r^{1+\alpha\left(\lambda_{1}\right)}$. Note that $h=r^{\alpha\left(\lambda_{1}\right)}$ is a solution of $L h=0$. Let $v=h w$ and

$$
w(r):=\int_{0}^{r} \frac{1}{s^{n+2 \alpha\left(\lambda_{1}\right)}} \int_{0}^{s} \tau^{n-2+\alpha\left(\lambda_{1}\right)} H(\tau) d \tau d s, \quad 0<r<1 .
$$

By a direct calculation,

$$
L v=L(h w)=h r^{2} w^{\prime \prime}+\left(2 r^{2} h^{\prime}+n r h\right) w^{\prime}=H
$$

By (4.3), we estimate $|w(r)| \leq C_{2} r$. Hence, $|v(r)| \leq C_{2} r^{1+\alpha\left(\lambda_{1}\right)}$. Since $U_{1, j}-v$ is bounded and satisfies $L\left(U_{1, j}-v\right)=0$ in $(0,1)$, we have $U_{1, j}=\tilde{C}_{1} h+v$ and (4.4) follows.

Next, we prove that $\tilde{C}_{1} \geq C_{1}>0$, where $C_{1}$ depends only on $n,\left\|\partial D_{1}\right\|_{C^{4}}$ and $\left\|\partial D_{2}\right\|_{C^{4}}$, not on $\varepsilon$. Since $D_{1}$ and $D_{2}$ are strictly convex and symmetric in $x_{1}, \ldots, x_{n-1}$, it is easy to show that $\partial_{\nu} x_{j} \geq 0$ in $\left\{x_{j} \geq 0\right\}$ and $\partial_{\nu} x_{j} \leq 0$ in $\left\{x_{j} \leq 0\right\}$. Therefore, under the assumptions of Theorem 1.4, $x_{j}$ is a subsolution of (1.1) in $\left\{x_{j} \geq 0\right\}$, and is a supersolution of (1.1) in $\left\{x_{j} \leq 0\right\}$. Hence, $u \geq x_{j}$ in $\left\{x_{j} \geq 0\right\}$ and $u \leq x_{j}$ in $\left\{x_{j} \leq 0\right\}$. Then, $u\left(0^{\prime}, x_{n}\right)=0$ and $\left|u\left(x^{\prime}, x_{n}\right)\right| \geq x_{j}$ for $\left(x^{\prime}, x_{n}\right) \in \Omega$. So, $\left|\bar{u}\left(x^{\prime}\right)\right| \geq\left|x_{j}\right|$ in $B_{1} \subset \mathbb{R}^{n-1}$ and $\bar{u}\left(0^{\prime}\right)=0$. Since $Y_{1, j}$ has the same sign as $x_{j}$, we have

$$
\begin{equation*}
f_{\mathbb{S}^{n-2}} a(\xi) \bar{u}(r, \xi) Y_{1, j}(\xi)=f_{\mathbb{S}^{n}-2} a(\xi)\left(\bar{u}(r, \xi)-\bar{u}\left(0^{\prime}\right)\right) Y_{1, j}(\xi) \geq C_{3} r \tag{4.5}
\end{equation*}
$$

where $C_{3} \geq 0$. Using (4.2) and (4.5), we have

$$
\begin{aligned}
U_{1, j}(r) & =f_{\mathbb{S}^{n-2}} a(\xi)\left(u_{1}(r, \xi)-u_{1}\left(0^{\prime}\right)\right) Y_{1, j}(\xi) d \xi \\
& =f_{\mathbb{S}^{n-2}} a(\xi)\left(\bar{u}(r, \xi)-\bar{u}\left(0^{\prime}\right)\right) Y_{1, j}(\xi) d \xi-f_{\mathbb{S}^{n-2}} a(\xi)\left(u_{2}(r, \xi)-u_{2}\left(0^{\prime}\right)\right) Y_{1, j}(\xi) d \xi \\
& \geq C_{3} r-C_{0} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)}{2}}
\end{aligned}
$$

By virtue of (4.4) and $|v(r)| \leq C_{2} r^{1+\alpha\left(\lambda_{1}\right)}$, we have

$$
\begin{equation*}
\tilde{C}_{1} r^{\alpha\left(\lambda_{1}\right)} \geq-C_{0} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)}{2}}-C_{2} r^{1+\alpha\left(\lambda_{1}\right)}+C_{3} r . \tag{4.6}
\end{equation*}
$$

We choose a small $r_{0}$ satisfying

$$
\begin{equation*}
-C_{0} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)}{2}}-C_{2} r_{0}^{1+\alpha\left(\lambda_{1}\right)}+C_{3} r_{0} \geq \frac{C_{3}}{2} r_{0} \tag{4.7}
\end{equation*}
$$

By (4.6) and (4.7), we obtain that $\tilde{C}_{1} \geq \frac{C_{3}}{2} r_{0}^{1-\alpha\left(\lambda_{1}\right)}$.
step 4. Firstly, we choose a positive constant $C_{4}$ such that $\frac{C_{1} C_{4}^{\alpha(\lambda)}}{4}>C_{0}$. Without loss of generality, we suppose that

$$
\begin{equation*}
C_{1}\left(C_{4} \sqrt{\varepsilon}\right)^{\alpha\left(\lambda_{1}\right)}-C_{2}\left(C_{4} \sqrt{\varepsilon}\right)^{1+\alpha\left(\lambda_{1}\right)} \geq \frac{C_{1}}{2}\left(C_{4} \sqrt{\varepsilon}\right)^{\alpha\left(\lambda_{1}\right)} \tag{4.8}
\end{equation*}
$$

We set $r_{\varepsilon}=C_{4} \sqrt{\varepsilon}$. (4.8) implies $U_{1, j}\left(r_{\varepsilon}\right) \geq \frac{C_{1}}{2} r_{\varepsilon}^{\alpha\left(\lambda_{1}\right)}$, so that

$$
\begin{aligned}
& \left(f_{\partial B_{r_{\varepsilon}}} a(\xi)\left|\bar{u}-\bar{u}\left(0^{\prime}\right)\right|^{2} d \sigma\right)^{1 / 2} \\
& \geq\left(f_{\partial B_{r_{\varepsilon}}} a(\xi)\left(u_{1}(r, \xi)-u_{1}\left(0^{\prime}\right)\right)^{2} d \sigma\right)^{1 / 2}-\left(f_{\partial B_{r_{\varepsilon}}} a(\xi)\left(u_{2}(r, \xi)-u_{2}\left(0^{\prime}\right)\right)^{2} d \sigma\right)^{1 / 2} \\
& \geq U_{1, j}\left(r_{\varepsilon}\right)-C_{0} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)}{2}} \\
& \geq \frac{C_{1}}{2} r_{\varepsilon}^{\alpha\left(\lambda_{1}\right)}-C_{0} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)}{2}}=\left(\frac{C_{1} C_{4}^{\alpha\left(\lambda_{1}\right)}}{2}-C_{0}\right) \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)}{2}} \geq \frac{C_{1} C_{4}^{\alpha\left(\lambda_{1}\right)}}{4} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)}{2}}
\end{aligned}
$$

Hence, there exists an $\xi_{0} \in \mathbb{S}^{n-2}$ such that $\left|\bar{u}\left(r_{\varepsilon}, \xi_{0}\right)\right| \geq \frac{1}{C} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)}{2}}$. Since $\bar{u}$ is the average of $u$ in the $x_{n}$ direction, there exists an $x_{n}$ such that

$$
\left|u\left(x_{\varepsilon}^{\prime}, x_{n}\right)\right| \geq \frac{1}{C} \varepsilon^{\frac{\alpha\left(\lambda_{1}\right)}{2}}, \quad x_{\varepsilon}^{\prime}=\left(r_{\varepsilon}, \xi_{0}\right)
$$

This, together with $u(0)=0$, implies that (1.14) holds.
