# Homogenization in 3D thin domains with oscillating boundaries of different orders

#### Abstract

This paper presents an extension of the unfolding operator technique, initially applied to twodimensional domains, to the realm of three-dimensional thin domains. The advancement of this methodology is pivotal, as it enhances our understanding and analysis of three-dimensional geometries, which are crucial in various practical fields such as engineering and physics. Our work delves into the asymptotic behavior of solutions to a reaction-diffusion equation with Neumann boundary conditions set within such a oscillatory 3-dimensional thin domain. The method introduced enables the deduction of effective problems across all scenarios, tackling the intrinsic complexity of these domains. This complexity is especially pronounced due to the possibility of diverse types of oscillations occurring along their boundaries.

## 1 Introduction

Thin domains with oscillating boundaries have garnered significant interest in the research community due to their natural appearance in modeling real-world phenomena. Most of the applications in reallife problems posses boundaries that are not perfectly smooth, presenting a lot of irregularities that affects significantly the effective behavior of the considered model, which, in general, involves a Partial Differential Equation (PDE) posed in thin domains with rough boundary. As researchers could see, such distortions on the boundary may have significantly influence on the effective behavior of the considered PDE. This has been motivating many investigations to develop and employ asymptotic analysis techniques to determine the effective behavior on a lower-dimensional domain.

For instance, thin structures with oscillating boundaries are prevalent in various scientific fields, such as fluid dynamics (lubrication), solid mechanics (thin rods, plates or shells) and even physiology (blood circulation), [14, 18, 19]. Refer to [1, 8, (9) for specific examples of applied problems.

In this work, we extend the unfolding operator introduced in [5] from two-dimensional to threedimensional thin domains. This extension is significant from both a practical and theoretical standpoint. Practically, three-dimensional domains have substantial applications across various fields such

[^0]as engineering and physics, making their comprehension vital for the progress in these disciplines. Theoretically, the analysis of these domains introduces additional complexity due to the potential for combining different types of oscillations at their boundaries. This enriches and complicates their study, presenting deeper and more varied mathematical challenges

Throughout this paper, we consider thin domains with different kind of oscillations at the top boundary, given by

R^{\varepsilon}=\left\{\left(x_{1}, x_{2}, x_{3}\right) \in \mathbb{R}^{3}:\left(x_{1}, x_{2}\right) \in \omega, \quad 0<x_{3}<\varepsilon^{\gamma} g\left(\frac{x_{1}}{\varepsilon^{\alpha}}, \frac{x_{2}}{\varepsilon^{\beta}}\right)\right\}, \quad 0<\varepsilon \ll 1
$$

where $0 \leq \alpha<\beta, 0<\gamma, \omega \subset \mathbb{R}^{2}$ is an open, bounded, connected and regular set and $g$ is a bounded periodic function not necessarily smooth. For an example of oscillatory boundary, see Figure 1 .

Without loss of generality, we can consider $\gamma=1$ since, if this is not the case, the thickness of the domain can be redefined as $\varepsilon=\varepsilon^{\gamma}$. Therefore, the thin domains considered are given by

R^{\varepsilon}=\left\{\left(x_{1}, x_{2}, x_{3}\right) \in \mathbb{R}^{3}:\left(x_{1}, x_{2}\right) \in \omega, \quad 0<x_{3}<\varepsilon g\left(\frac{x_{1}}{\varepsilon^{\alpha}}, \frac{x_{2}}{\varepsilon^{\beta}}\right)\right\}, \quad 0<\varepsilon \ll 1 \tag{D}
\end{equation*}
$$

Note that various values of $\alpha$ and $\beta$ greater than zero will result in distinct kinds of oscillatory patterns or roughness at the boundary. Much more complex behaviors appear than in two dimensions. In fact, it is possible to have oscillations of one type in the $x_{1}$-direction and oscillations of another type in $x_{2}$. Even in the simplest case, $\alpha$ or $\beta$ is zero, a locally periodic behavior is obtained.

Considering that the focus of this article lies in elaborating the technique of adapting the unfolding operator to a three-dimensional context, rather than on the specific problems it solves, we have chosen to illustrate this approach through a particular elliptic problem. This choice underscores our understanding that, while the method holds potential for broader application across more intricate equations, our emphasis remains on the nuances of the geometrical adaptation. Then, in the sequel, we address the following elliptic boundary-value problem.

where $\nu^{\varepsilon}$ is the normal unit outward vector to $\partial R^{\varepsilon}, f^{\varepsilon} \in L^{2}\left(R^{\varepsilon}\right)$.
The variational formulation of $(\bar{P})$ is

\int_{R^{\varepsilon}}\left(\nabla u^{\varepsilon} \nabla \varphi+u^{\varepsilon} \varphi\right) d x=\int_{R^{\varepsilon}} f^{\varepsilon} \varphi d x \tag{1.1}
\end{equation*}

for all $\varphi \in H^{1}\left(R^{\varepsilon}\right)$.
Lax-Milgram Theorem ensures the existence and uniqueness of solutions for problem (1.1) for any fixed $\varepsilon>0$. It is important to point out that the solutions' behavior is primarily determined by the value of the parameters $\alpha$ and $\beta$ respect to the thickness of the domain. Additionally, given that the thickness of the domain $R^{\varepsilon}$ is of order $\varepsilon$, it is anticipated that the sequence of solutions $u_{\varepsilon}$ will converge to a function with $n-1$ variables as $\varepsilon$ approaches zero.

Thus, the aim of this article is to present the unfolding method as a general approach that simplifies the process of obtaining the homogenized limit problem for problem $(\mathbb{P})$ considering all possible combinations of the values of $\alpha$ and $\beta$. Additionally, just like in the two-dimensional case, non-smooth periodic oscillatory boundaries may be considered.

As previously mentioned, depending on the value of the parameters $\alpha$ and $\beta$, we obtain distinct lower dimensional limit problems taking the general form

where $\eta$ denotes the unit outward normal vector to the boundary $\partial \omega$ and the homogenized coefficients $q_{i}, i=1,2$, varies as accordingly to the values of $\alpha$, and $\beta$. The function $\bar{f}$ is related to the function $f^{\varepsilon}$. We left the description of the coefficients of the different limitting problems for the next sections.

The key ingredient of the current work is the adaptation of the unfolding method introduced in [11] for a higher dimensional thin domain with rough boundary. First, the unfolding method was developed for problems with oscillating coefficients and perforated domains (see [12]) and then adapted for thin domains with oscillating boundary (see [4, 5, 17]). Besides defining the unfolding operator, which allows us to work within a fixed framework, one must address the challenge, common to all homogenization problems, of determining the limit of the partial derivatives. To achieve this, our primary innovation lies in constructing suitable operators that facilitate the determination of the limit of the unfolded gradients. Unlike in previous works, such as [12, 5, we encounter a unique complication: it is not possible to identify a single limit function whose gradient matches the limit of the unfolded gradients, owing to the differing scales in the $x_{1}$ and $x_{2}$ directions. Consequently, these differing scales lead us to identify various limit functions within distinct Lebesgue-Bochner spaces. The emergence of these diverse spaces necessitates a slightly modified corrector equation for the critical oscillations (i.e., of order $\varepsilon$ ) and also compels us to employ different test functions for each scenario, due to the interaction between the oscillation orders in each direction. Furthermore, it is pertinent to highlight that our ideas and techniques can be easily adapted to scenarios involving higher dimensions, though it must be noted that in such cases, the notation might become excessively cumbersome.

Now, we perform a brief overview on the literature. For pioneering works, we mention [1, 7, 13] where thin domains with or without oscillatory boundaries were studied. In [1], thin domains with oscillatory boundary were considered in context of $\Gamma$-convergence and in 7], where the Stokes system were studied. In [13], the authors studied a parabolic equation and its asymptotic dynamics in a standard thin domain (i.e. without oscillations).

More recently, the works [2, 3, 4, 5, 15, 16, 17] studied elliptic and parabolic problems on thin domains with rough boundary. These works used several techniques from the classical extension operator or asymptotic expansions to the most recent ones, using the unfolding operator method. It is important to emphasize that in [4, 5], the pioneering works with respect to the unfolding method in oscillating thin domains, a profound study of the method was performed for two-dimensional domains.

## 2 Notations and Preliminary Results

To study the convergence of the solutions of $(\mathrm{P})$, we fix some notations and recall results concerning the method of unfolding operator which will be essential trough the paper for our analysis.

We consider three-dimensional thin domains defined by (D). Observe that this domain have an oscillatory behavior at its top boundary. The parameters $\varepsilon, \alpha$ and $\beta$ are positive and the function $g$ is a periodic function. Firstly, we would like to clarify that, for the sake of simplicity in notation we say that a function in $\mathbb{R}^{2}$ is $L$-periodic if there exist two periods, $L_{1}$ and $L_{2}$, such that the function is $L_{1}$-periodic in the first variable and $L_{2}$-periodic in the second.

The function $g$ which defines the oscillatory boundary satisfies the following hypothesis:
$\left(\mathbf{H}_{\mathbf{g}}\right) g: \mathbb{R}^{2} \rightarrow \mathbb{R}$ is a strictly positive, bounded, lower semicontinuous, L-periodic function. Moreover, we define

g_{0}=\min _{\left(x_{1}, x_{2}\right) \in \mathbb{R}^{2}} g\left(x_{1}, x_{2}\right) \quad \text { and } \quad g_{1}=\max _{\left(x_{1}, x_{2}\right) \in \mathbb{R}^{2}} g\left(x_{1}, x_{2}\right)
$$

so that $0<g_{0} \leq g\left(x_{1}, x_{2}\right) \leq g_{1}$ for all $\left(x_{1}, x_{2}\right) \in \mathbb{R}^{2}$.
Recall that lower semicontinuous means that $g\left(x_{1}^{0}, x_{2}^{0}\right) \leq \liminf _{\left(x_{1}, x_{2}\right) \rightarrow\left(x_{1}^{0}, x_{2}^{0}\right)} g\left(x_{1}, x_{2}\right), \forall\left(x_{1}^{0}, x_{2}^{0}\right) \in \mathbb{R}^{2}$.
We will now establish the typical notation for the unfolding operator, adapted specifically to the case of a three-dimensional oscillating thin domain. This tailored notation is essential in ensuring clarity and precision in our definition of the unfolding operator, providing researchers with a standardized framework.

Let us consider a rectangular grid in $\mathbb{R}^{2}$ taking into account the periodicity of the problem, each rectangle $\omega_{i, j}$ has a width of $L_{1}$ and a height of $L_{2}$ :

\omega_{i, j}=\left[i L_{1},(i+1) L_{1}\right) \times\left[j L_{2},(j+1) L_{2}\right), \quad(i, j) \in \mathbb{Z}^{2}
$$

By analogy with the one dimensional case, for each $\left(x_{1}, x_{2}\right) \in \mathbb{R}^{2},\left[x_{1}, x_{2}\right]_{L}$ denotes the bottom left vertex of the rectangle where the point is. For instance, if $\left(x_{1}, x_{2}\right) \in \omega_{i, j}$ we have $\left[x_{1}, x_{2}\right]_{L}=\left(i L_{1}, j L_{2}\right)$. We also define $\left\{x_{1}, x_{2}\right\}_{L}=\left(x_{1}, x_{2}\right)-\left[\left(x_{1}, x_{2}\right)\right]_{L}$.

In particular, for each $\varepsilon>0$ we can write:

$$
\left(\frac{x_{1}}{\varepsilon^{\alpha}}, \frac{x_{2}}{\varepsilon^{\beta}}\right)=\left[\frac{x_{1}}{\varepsilon^{\alpha}}, \frac{x_{2}}{\varepsilon^{\beta}}\right]_{L}+\left\{\frac{x_{1}}{\varepsilon^{\alpha}}, \frac{x_{2}}{\varepsilon^{\beta}}\right\}_{L} .
$$

Notice that, if $\alpha=\beta$, as in classical periodic homogenization, it is straightforward to obtain the relationship between the macro and micro scales. In fact, the rescaled rectangles $\varepsilon^{\alpha} \omega_{i, j}$ represent the microscopic scale and we have

\left(x_{1}, x_{2}\right)=\varepsilon^{\alpha}\left(\left[\frac{x_{1}}{\varepsilon^{\alpha}}, \frac{x_{2}}{\varepsilon^{\alpha}}\right]_{L}+\left\{\frac{x_{1}}{\varepsilon^{\alpha}}, \frac{x_{2}}{\varepsilon^{\alpha}}\right\}_{L}\right) .
$$

However, when $\alpha \neq \beta$, the grid representing the microscopic scale is not formed by rectangles that are homothetic to $\omega_{i, j}$. In fact, we define the following family of rectangles

$$
\omega_{i, j}^{\varepsilon}=\left[i L_{1} \varepsilon^{\alpha},(i+1) L_{1} \varepsilon^{\alpha}\right) \times\left[j L_{2} \varepsilon^{\beta},(j+1) L_{2} \varepsilon^{\beta}\right), \quad(i, j) \in \mathbb{Z}^{2}
$$

which are obtained by shrinking by a factor $\varepsilon^{\alpha}$ in the $x$-direction and by a factor $\varepsilon^{\beta}$ in the $y$-direction. Consequently, we will use the following notation

$$
\left(x_{1}, x_{2}\right)=\left(\varepsilon^{\alpha}\left(\left[\frac{x_{1}}{\varepsilon^{\alpha}}\right]_{L_{1}} L_{1}+\left\{\frac{x_{1}}{\varepsilon^{\alpha}}\right\}_{L_{1}}\right), \varepsilon^{\beta}\left(\left[\frac{x_{2}}{\varepsilon^{\beta}}\right]_{L_{2}} L_{2}+\left\{\frac{x_{2}}{\varepsilon^{\beta}}\right\}_{L_{2}}\right)\right), \forall\left(x_{1}, x_{2}\right) \in \mathbb{R}^{2}
$$

Notice that, according to the previous notation we have

$$
\left[\frac{x_{1}}{\varepsilon^{\alpha}}, \frac{x_{2}}{\varepsilon^{\beta}}\right]_{L}=\left(\left[\frac{x_{1}}{\varepsilon^{\alpha}}\right]_{L_{1}} L_{1},\left[\frac{x_{2}}{\varepsilon^{\beta}}\right]_{L_{2}} L_{2}\right) \text { and }\left\{\frac{x_{1}}{\varepsilon^{\alpha}}, \frac{x_{2}}{\varepsilon^{\beta}}\right\}_{L}=\left(\left\{\frac{x_{1}}{\varepsilon^{\alpha}}\right\}_{L_{1}},\left\{\frac{x_{2}}{\varepsilon^{\beta}}\right\}_{L_{2}}\right) .
$$

Furthermore, given any domain $\omega \in \mathbb{R}^{2}$, we will distinguish between the rectangles $\omega_{i, j}^{\varepsilon}$ that are completely contained within $\omega$ and those that are not. Then, we denote by $\omega_{\varepsilon}$ and $\Lambda_{\varepsilon}$ the sets

\omega_{\varepsilon}=\bigcup_{(i, j) \in S_{\varepsilon}} \overline{\omega_{i, j}^{\varepsilon}} \quad \text { and } \quad \Lambda_{\varepsilon}=\omega \backslash \omega_{\varepsilon},
$$

where $S_{\varepsilon} \subset \mathbb{Z}^{2}$ is such that for each $(i, j) \in S_{\varepsilon}$, we have $\overline{\omega_{i, j}^{\varepsilon}} \subset \omega$.
Notice that $\omega_{\varepsilon} \subset \omega$ and $\Lambda_{\varepsilon} \xrightarrow{\varepsilon \rightarrow 0} 0$ in the sense of the measure. Both sets will play an important role in defining the unfolding operator, see Figure 1.

Then, we can split the thin domain $R_{\varepsilon}$ into two parts:

$$
R_{0}^{\varepsilon}=\left\{\left(x_{1}, x_{2}, x_{3}\right) \in \mathbb{R}^{3}:\left(x_{1}, x_{2}\right) \in \omega_{\varepsilon}, 0<x_{3}<\varepsilon g\left(\frac{x_{1}}{\varepsilon^{\alpha}}, \frac{x_{2}}{\varepsilon^{\beta}}\right)\right\}
$$

and

$$
R_{1}^{\varepsilon}=\left\{\left(x_{1}, x_{2}, x_{3}\right) \in \mathbb{R}^{3}:\left(x_{1}, x_{2}\right) \in \Lambda_{\varepsilon}, 0<x_{3}<\varepsilon g\left(\frac{x_{1}}{\varepsilon^{\alpha}}, \frac{x_{2}}{\varepsilon^{\beta}}\right)\right\} .
$$

We reserve the notation $Y^{*}$ for the reference cell which describes the oscillating domain

$$
Y^{*}=\left\{\left(y_{1}, y_{2}, y_{3}\right) \in \mathbb{R}^{3}: 0<y_{1}<L_{1}, 0<y_{2}<L_{2}, 0<y_{3}<g\left(y_{1}, y_{2}\right)\right\} .
$$

Moreover, since we have two different scales of oscillation for the variables $x$ or $y$, the following notation will be used:

$$
\begin{aligned}
Y^{*}\left(y_{1}\right)=\left\{\left(y_{2}, y_{3}\right) \in \mathbb{R}^{2}: 0<y_{2}<L_{2}, 0<y_{3}<g\left(y_{1}, y_{2}\right)\right\}, & y_{1} \in\left[0, L_{1}\right], \\
Y^{*}\left(y_{2}\right)=\left\{\left(y_{1}, y_{3}\right) \in \mathbb{R}^{2}: 0<y_{1}<L_{1}, 0<y_{3}<g\left(y_{1}, y_{2}\right)\right\}, & y_{2} \in\left[0, L_{2}\right], \\
Y^{*}\left(y_{1}, y_{2}\right)=\left\{y_{3} \in \mathbb{R}: 0<y_{3}<g\left(y_{1}, y_{2}\right)\right\}, & \left(y_{1}, y_{2}\right) \in L .
\end{aligned}
$$

To enhance readability, we will represent $x$ and $y$ as vectors $x=\left(x_{1}, x_{2}, x_{3}\right)$ and $y=\left(y_{1}, y_{2}, y_{3}\right)$, respectively.

Finally, recall some very commonly used notations in homogenization. The subindex $\sharp$ denotes periodicity. For instance, $\mathcal{C}_{\sharp i}^{\infty}\left(\omega \times Y^{*}\right)$ consists of all functions $\varphi$ wich are obtained as restrictions to $\omega \times Y^{*}$ of functions in $\mathbb{R}^{5}$ which are $L_{i}-$ periodic in the $y_{i}$-variable for $i=1,2,3$. For a measurable set $A \subset \mathbb{R}^{n}$, denote the average of a function $\varphi$ in $A$ as $\langle\varphi\rangle_{A}=\frac{1}{|A|} \int_{A} \varphi$.

### 2.1 The unfolding operator

In this section, we extend the definition of the unfolding operator that was originally given for 2dimensional thin domains in [5]. For the n-dimensional case, which exhibits the same type of oscillations in all directions, refer to [17. Additionally, we present its main properties.

Definition 2.1. Let $\varphi$ be a Lebesgue-measurable function defined in $R^{\varepsilon}$. The unfolding operator $\mathcal{T}_{\varepsilon}$ acting on $\varphi$ is defined as the following function defined in $\omega \times Y^{*}$

\mathcal{T}_{\varepsilon}(\varphi)\left(x_{1}, x_{2}, y\right)= \begin{cases}\varphi\left(\varepsilon^{\alpha}\left[\frac{x_{1}}{\varepsilon^{\alpha}}\right]_{L_{1}} L_{1}+\varepsilon^{\alpha} y_{1}, \varepsilon^{\beta}\left[\frac{x_{2}}{\varepsilon^{\beta}} L_{L_{2}} L_{2}+\varepsilon^{\beta} y_{2}, \varepsilon y_{3}\right),\right. & \left(x_{1}, x_{2}, y\right) \in \omega_{\varepsilon} \times Y^{*}, \\ 0, & \left(x_{1}, x_{2}, y\right) \in \Lambda_{\varepsilon} \times Y^{*} .\end{cases}
$$

Next, we establish some basic properties of $\mathcal{T}_{\varepsilon}$ that will play an essential role in the paper. These properties do not depend on the values of the parameters $\alpha$ and $\beta$.

Proposition 2.2. The unfolding operator has the following properties:
(a) $\mathcal{T}_{\varepsilon}$ is linear with respect to + and $\cdot$ operations.
(b) Let $\varphi$ be a Lebesgue function defined in $Y^{*}$ which is extended periodically in $\left(y_{1}, y_{2}\right)$. Then, $\varphi^{\varepsilon}\left(x_{1}, x_{2}, x_{3}\right)=\varphi\left(\frac{x_{1}}{\varepsilon^{\alpha}}, \frac{x_{2}}{\varepsilon^{\beta}}, \frac{x_{3}}{\varepsilon}\right)$ is mesurable in $R^{\varepsilon}$ and $\mathcal{T}_{\varepsilon}\left(\varphi^{\varepsilon}\right)\left(x_{1}, x_{2}, y_{1}, y_{2}, y_{3}\right)=\varphi\left(y_{1}, y_{2}, y_{3}\right)$. Moreover, if $\varphi \in L^{2}\left(Y^{*}\right)$, then $\varphi^{\varepsilon} \in L^{2}\left(R^{\varepsilon}\right)$;
(c) For all $\varphi \in L^{1}\left(R^{\varepsilon}\right)$, we have

\frac{1}{L_{1} L_{2}} \int_{\omega \times Y^{*}} \mathcal{T}_{\varepsilon}(\varphi)\left(x_{1}, x_{2}, y\right) d x_{1} d x_{2} d y=\frac{1}{\varepsilon} \int_{R_{0}^{\varepsilon}} \varphi\left(x_{1}, x_{2}, x_{3}\right) d x
$$

(d) $T_{\varepsilon}(\varphi) \in L^{p}\left(\omega \times Y^{*}\right)$ for all $\varphi \in L^{p}\left(R^{\varepsilon}\right)$ with

$$
\left\|\mathcal{T}_{\varepsilon}(\varphi)\right\|_{L^{p}\left(\omega \times Y^{*}\right)}=\left(\frac{L_{1} L_{2}}{\varepsilon}\right)^{\frac{1}{p}}\|\varphi\|_{L^{p}\left(R_{0}^{\varepsilon}\right)} \leq\left(\frac{L_{1} L_{2}}{\varepsilon}\right)^{\frac{1}{p}}\|\varphi\|_{L^{p}\left(R^{\varepsilon}\right)} .
$$

(e) $\partial_{y_{1}} \mathcal{T}_{\varepsilon}(\varphi)=\varepsilon^{\alpha} \mathcal{T}_{\varepsilon}\left(\partial_{x_{1}} \varphi\right), \partial_{y_{2}} \mathcal{T}_{\varepsilon}(\varphi)=\varepsilon^{\beta} \mathcal{T}_{\varepsilon}\left(\partial_{x_{2}} \varphi\right)$ and $\partial_{y_{3}} \mathcal{T}_{\varepsilon}(\varphi)=\varepsilon \mathcal{T}_{\varepsilon}\left(\partial_{x_{3}} \varphi\right)$ a.e. $\omega \times Y^{*}$ for all $\varphi \in W^{1, p}\left(R^{\varepsilon}\right)$.
(f) If $\varphi \in W^{1, p}\left(R^{\varepsilon}\right)$, then $\mathcal{T}_{\varepsilon}(\varphi) \in L^{p}\left(\omega ; W^{1, p}\left(Y^{*}\right)\right)$ with

Proof. The proof is very similar to [4, 55. Then, we just prove property c), which gives the relation
between the integrals in the thin domain and integrals in the new fixed domain in $\mathbb{R}^{5}$ :

& =\frac{1}{L_{1} L_{2}} \sum_{(i, j) \in S^{\varepsilon}} \int_{\omega_{i, j}^{\varepsilon}} \int_{Y^{*}} \varphi\left(\varepsilon^{\alpha}\left[\frac{x_{1}}{\varepsilon^{\alpha}}\right]_{L_{1}} L_{1}+\varepsilon^{\alpha} y_{1}, \varepsilon^{\beta}\left[\frac{x_{2}}{\varepsilon^{\beta}}\right]_{L_{2}} L_{2}+\varepsilon^{\beta} y_{2}, \varepsilon y_{3}\right) d x_{1} d x_{2} d y \\
& =\varepsilon^{\alpha} \varepsilon^{\beta} \sum_{(i, j) \in S^{\varepsilon}} \int_{Y^{*}} \varphi\left(\varepsilon^{\alpha} i L_{1}+\varepsilon^{\alpha} y_{1}, \varepsilon^{\beta} j L_{2}+\varepsilon^{\beta} y_{2}, \varepsilon y_{3}\right) d y \\
& =\frac{1}{\varepsilon} \sum_{(i, j) \in S^{\varepsilon}} \int_{\omega_{i, j}^{\varepsilon}} \int_{0}^{\varepsilon g\left(x_{1} / \varepsilon^{\alpha}, x_{2} / \varepsilon^{\beta}\right)} \varphi(x) d x \\
& =\frac{1}{\varepsilon} \int_{R_{0}^{\varepsilon}} \varphi(x) d x .

From now on, we will use the following notation for the rescaled norms in the thin domain $R^{\varepsilon}$

Notice that Proposition 2.2 is essential to pass to the limit since allows us to transform an integral over $R^{\varepsilon}$ into one over the fixed set $\omega \times Y^{*}$. Hence, the unfolding criterion for integrals (u.c.i.) plays an important role.

Definition 2.3. A sequence $\left(\varphi^{\varepsilon}\right)$ satisfies the unfolding criterion for integrals (u.c.i) if

The proofs of the next Propositions are analogous to [4, 5].

- if $\psi^{\varepsilon} \in L^{q}\left(R^{\varepsilon}\right), \frac{1}{p}+\frac{1}{q}=\frac{1}{r}, r>1$, then $\varphi^{\varepsilon} \psi^{\varepsilon}$ satisfies the u.c.i.
- if $\phi \in L^{q}(\omega), \frac{1}{p}+\frac{1}{q}=1$, then $\varphi^{\varepsilon} \phi$ satisfies u.c.i.
- If $\psi^{\varepsilon}\left(x_{1}, x_{2}, x_{3}\right)=\psi\left(\frac{x_{1}}{\varepsilon^{\alpha}}, \frac{x_{2}}{\varepsilon^{\beta}}, \frac{x_{3}}{\varepsilon}\right)$, where $\psi \in L^{q}\left(Y^{*}\right)$, then $\varphi^{\varepsilon} \psi^{\varepsilon}$ satisfies u.c.i.

Proposition 2.5. 1. Let $\varphi \in L^{p}(\omega)$. Then, $\mathcal{T}_{\varepsilon} \varphi \rightarrow \varphi$ strongly in $L^{p}\left(\omega \times Y^{*}\right)$.
2. Let $\left(\varphi^{\varepsilon}\right)$ be a sequence in $L^{p}(\omega)$ such that $\varphi^{\varepsilon} \rightarrow \varphi$ strongly in $L^{p}(\omega)$. Then,

Next, we recall a convergence result which does not depend on the value of the parameter $\alpha$ or $\beta$. To do that, we first introduce a suitable decomposition to functions $\varphi \in W^{1, p}\left(R^{\varepsilon}\right)$ where the geometry of the thin domains plays a crucial role. We write $\varphi\left(x_{1}, x_{2}, x_{3}\right)=V\left(x_{1}, x_{2}\right)+\varphi_{r}\left(x_{1}, x_{2}, x_{3}\right)$ where $V$ is defined as follows

Let $\left(\varphi^{\varepsilon}\right) \subset W^{1, p}\left(R^{\varepsilon}\right), 1<p<\infty$, with $\left\|\left|\varphi^{\varepsilon}\right|\right\|_{W^{1, p}\left(R^{\varepsilon}\right)}$ uniformly bounded and $V^{\varepsilon}\left(x_{1}, x_{2}\right)$ defined as in (2.1) for each $\varphi_{\varepsilon}$. Then, there exists a function $\varphi \in W^{1, p}(\omega)$ such that, up to subsequences

Proof. Let us prove that $V^{\varepsilon}$ is uniformly bounded:

Thus, there is $\varphi \in W^{1, p}(\omega)$ such that, up to subsequences,

\leq C(\varepsilon)^{p} \int_{0}^{\varepsilon g_{\varepsilon}\left(x_{1}, x_{2}\right)}\left|\partial_{x_{3}} \varphi^{\varepsilon}\left(x_{1}, x_{2}, x_{3}\right)\right|^{p} d x_{3} .
\end{gathered}

We integrate the inequality mentioned above in $\omega$ and divide it by $1 / \varepsilon$ to derive the following

we get

## 3 Oscillations just in one direction, $\alpha=0$

If $\alpha=0$, the thin domain only exhibits oscillations in one variable, thereby placing us in the scenario most akin to those studied in two dimensions. Before we state the result of this section we adapt some definitions and notations to this particular case. In this case the unfolding operator acts just in the second variable because the thin domains just present one scale of oscillation.

We consider

W_{\varepsilon}=\left\{\left(x_{1}, x_{2}, y_{2}, y_{3}\right) \in \mathbb{R}^{4}:\left(x_{1}, x_{2}\right) \in \omega_{\varepsilon}, \quad\left(y_{2}, y_{3}\right) \in Y^{*}\left(x_{1}\right)\right\}
$$

where $Y^{*}\left(x_{1}\right)=\left\{\left(y_{2}, y_{3}\right) \in \mathbb{R}^{2}: 0<y_{2}<L_{2}, 0<y_{3}<g\left(x_{1}, y_{2}\right)\right\}$.
Then, we define the unfolding operator as follows

\mathcal{T}_{\varepsilon}(\varphi)\left(x_{1}, x_{2}, y_{2}, y_{3}\right)= \begin{cases}\varphi\left(x_{1}, \varepsilon^{\beta}\left[\frac{x_{2}}{\varepsilon^{\beta}}\right]_{L_{2}} L_{2}+\varepsilon^{\beta} y_{2}, \varepsilon y_{3}\right), & \left(x_{1}, x_{2}, y_{2}, y_{3}\right) \in W_{\varepsilon} \\ 0, & \left(x_{1}, x_{2}\right) \in \Lambda_{\varepsilon}\end{cases}
$$

Note that all the properties outlined in the previous section can be easily adapted to this specific situation. Additionally, since for each fixed value of $x_{1}$ a two-dimensional thin domain with oscillating boundary similar to those studied in [5], it is possible to pass to the limit by replicating the results presented in that reference. By Proposition 2.2, one writes (1.1) as fixed domain problem as follows

=\int_{W} \mathcal{T}_{\varepsilon}\left(f^{\varepsilon}\right) \mathcal{T}_{\varepsilon}(\phi) d x_{1} d x_{2} d y+\frac{L_{2}}{\varepsilon} \int_{R_{1}^{\varepsilon}} f^{\varepsilon} \phi d x, \quad \forall \phi \in H^{1}(\omega)
\end{gathered}
$$

It is then observed that for all terms, the transition to the limit is immediate, except for the term of the derivative in the direction of the oscillations, $x_{2}$. However, for each $x_{1}$ fixed, two-dimensional thin domains with oscillations on the upper boundary are recovered, the limit of the unfolding of the derivative in $x_{2}$ is known from [5]. Therefore, based on the results obtained in the literature, we can state the following theorem.

Theorem $3.1(\alpha=0)$. Let $u^{\varepsilon}$ be the solution of ( $(\mathbb{P})$ with $f^{\varepsilon} \in L^{2}\left(R^{\varepsilon}\right)$ such that $\left\|\mid f^{\varepsilon}\right\| \|_{L^{2}\left(R^{\varepsilon}\right)} \leq c$ with c a positive constant independent of $\varepsilon$. Suppose that there is $f \in L^{2}(W)$ such that

- $0<\beta<1$. There exists $u_{1} \in L^{2}\left(\omega ; H_{\sharp 2}^{1}\left(Y^{*}\left(x_{1}\right)\right)\right)$ with $\frac{\partial u_{1}}{\partial y_{3}}=0$ such that

## 4 Weak and resonant oscillations, $0<\alpha<\beta \leq 1$

Now we present the central convergence result that will allow us to obtain the homogenized limit problem in all the situations of this section. Convergence of partial derivatives is achieved using auxiliary operators defined in appropriate function spaces, which enable us to separate different scales. In our exploration of oscillatory phenomena, it becomes evident that distinct cases emerge depending on the interplay between various orders of oscillation and the altitude order of the domain. This approach ensures a systematic and schematic representation, contributing to a more thorough understanding of the intricate dynamics inherent in the relationship between oscillation orders and thickness of the domains.

The first scenario considered in this section occurs if the frequency order of the oscillations is less than or equal to the order of the domain's height.

### 4.1 Resonant and Weak oscillations

In this subsection, we assume $0<\alpha<1$ and $\beta=1$. That is, the oscillations in the $x_{2}$-direction are of order $\varepsilon$ while the oscillations in the $x_{1}$-direction are much weaker, that is order $\varepsilon^{\alpha}$. In particular

=\int_{\omega \times Y^{*}} \mathcal{T}_{\varepsilon} f^{\varepsilon} \mathcal{T}_{\varepsilon} \varphi d x_{1} d x_{2} d y+\frac{L_{1} L_{2}}{\varepsilon} \int_{R_{1}^{\varepsilon}} f^{\varepsilon} \varphi d x
\end{gathered}
$$

Taking $\varphi \in H^{1}(\omega)$ as test functions, one passes to the limit in the above equation using 4.6). Then,

Notice that $C_{\# 2}^{1}\left(\left[0, L_{2}\right] \times\left[0, g_{1}\right]\right)$ is dense in $H^{1}\left(Y^{*}\left(y_{1}\right)\right)$. This means that we can rewrite the above equality for any $\psi \in H^{1}\left(Y^{*}\left(y_{1}\right)\right)$ and for a.e. point $\left(x_{1}, x_{2}, y_{1}\right) \in \omega \times\left(0, L_{1}\right)$. Moreover, for a.e. point $\left(x_{1}, x_{2}, y_{1}\right) \in \omega \times\left(0, L_{1}\right)$ it has a unique solution in $H^{1}\left(Y^{*}\left(y_{1}\right)\right) / \mathbb{R}$.

Recall that the uniquely solvable, for each $y_{1} \in\left(0, L_{1}\right)$, auxiliary problem is

### 4.2 Weak oscillations

In this subsection, we suppose oscillations of order $\varepsilon^{\alpha}$ and $\varepsilon^{\beta}$ with $0<\alpha<\beta<1$. Then, the thin domain is

Let $u^{\varepsilon}$ be the solution of (P) with $f^{\varepsilon} \in L^{2}\left(R^{\varepsilon}\right)$ such that $\left\|\left|f^{\varepsilon}\right|\right\|_{L^{2}\left(R^{\varepsilon}\right)} \leq c$ with $c$ a positive constant independent of $\varepsilon$. Suppose that there is $f \in L^{2}\left(\omega \times Y^{*}\right)$ such that

\mathcal{T}_{\varepsilon} \partial_{x_{1}} u^{\varepsilon} \rightharpoonup \partial_{x_{1}} u+\partial_{y_{1}} u^{1} \quad \text { weakly in } \quad L^{2}\left(\omega \times Y^{*}\right), \\
\mathcal{T}_{\varepsilon} \partial_{x_{2}} u^{\varepsilon} \rightharpoonup \partial_{x_{2}} u+\partial_{y_{2}} u^{2} \quad \text { weakly in } \quad L^{2}\left(\omega \times Y^{*}\right), \\

Let $\psi \in H^{1}\left(0, L_{1}\right)$ and $\phi_{1} \in \mathcal{D}(\omega)$ and $\phi_{2} \in \mathcal{D}\left(\omega \times\left(0, L_{1}\right)\right)$. Let $\Psi \in H_{\#}^{1}\left(0, L_{2}\right)$, the functions that are periodic in $y_{2}$. Define the sequences

\end{array}

strongly in $L^{2}\left(\omega \times Y^{*}\right)$.

Now, take $V_{1}^{\varepsilon}$ as a test function in PVU and pass to the limit. Therefore,

In order to identify $u^{2}$, take as a test function in PVU) $V_{2}^{\varepsilon}$. Then,

a.e. $\left(x_{1}, x_{2}, y_{1}, y_{2}\right) \in \omega \times\left(0, L_{1}\right) \times\left(0, L_{2}\right)$.

Joining together (4.11), (4.12) and (4.13) we have

which is equivalent to the weak formulation of the limit problem introduced in the theorem.

## 5 Strong oscillations $\beta>1$

In this section, we examine the behavior of solutions to the Neumann problem when at least one direction of oscillation exhibits highly oscillatory behavior First, we fix some notations. We divide the thin domain $R^{\varepsilon}$ into two parts: the oscillating and the non-oscillating.

Now we define a rescaling operator and we recall, without proofs, their basic results.

Definition 5.1. Let $\varphi$ be a measurable function in $R_{-}^{\varepsilon}=\omega \times\left(0, \varepsilon g_{0}\right)$. We define $\Pi_{\varepsilon}: \mathcal{M}\left(R_{-}^{\varepsilon}\right) \rightarrow$ $\mathcal{M}\left(R_{-}\right)$as follows

Moreover, in order to simplify the notation, we denote the restriction of the solution of $(\overline{\mathrm{P}})$ to $R_{+}^{\varepsilon}$ and $R_{-}^{\varepsilon}$ by $u_{+}^{\varepsilon}$ and $u_{-}^{\varepsilon}$ respectively.

Now, we prove the key compactness result that allows us to transition to the limit in the case where strong oscillations exist.

Taking $w^{\varepsilon}$ as a test function in (5.1). Then

and $X$ is the solution of the auxiliary problem

In this subsection, we suppose oscillations of order $\varepsilon^{\alpha}$ and $\varepsilon^{\beta}$ with $0<\alpha<1<\beta$.

The approach is very similar to the previous case.

\mathcal{T}_{\varepsilon} \partial_{x_{1}} u^{\varepsilon} \rightharpoonup \partial_{x_{1}} u+\partial_{y_{1}} u_{1} \quad \text { weakly in } L^{2}\left(\omega \times Y^{*}\right) . \\
\left\{\begin{array}{l}
-q_{1} u_{x_{1} x_{1}}-q_{2} u_{x_{2} x_{2}}+u=\bar{f} \text { in } \omega, \\
\left(q_{1} u_{x_{1}}, q_{2} u_{x_{2}}\right) \eta=0 \quad \text { on } \quad \partial \omega,
\end{array}\right.
\end{gathered}
$$

where

$$
\begin{array}{ll}
q_{1}=\frac{1}{\langle 1 / \bar{g}\rangle_{\left(0, L_{1}\right)}\langle g\rangle_{\left(0, L_{1}\right) \times\left(0, L_{2}\right)}}, & q_{2}=\frac{g_{0}}{\langle g\rangle_{\left(0, L_{1}\right) \times\left(0, L_{2}\right)}} \\
\bar{g}\left(y_{1}\right)=\int_{0}^{L_{2}} g\left(y_{1}, y_{2}\right) d y_{2} \quad \text { and } & \bar{f}=\langle f\rangle_{Y^{*} .}
\end{array}
$$

Proof. Since the solutions of (P) are uniformly bounded, we are in position to apply Theorem 5.6, which means that there are $u \in H^{1}(\omega), u_{1} \in L^{2}\left(\omega ; H_{\#}^{1}\left(Y^{*}\right)\right)$ and $u_{2} \in L^{2}\left(\omega \times Y^{*}\right)$ such that

$$
\begin{gathered}
\mathcal{T}_{\varepsilon} u^{\varepsilon} \rightarrow u \quad \text { strongly in } \quad L^{2}\left(\omega ; H_{\#}^{1}\left(Y^{*}\right)\right) \\
\mathcal{T}_{\varepsilon} \partial_{x_{1}} u^{\varepsilon} \rightharpoonup \partial_{x_{1}} u+\partial_{y_{1}} u^{1} \quad \text { weakly in } \quad L^{2}\left(\omega \times Y^{*}\right) .
\end{gathered}
$$

By Propositions 2.2 and 5.2 we get that

$$
\begin{gathered}
\frac{1}{L_{1} L_{2}} \int_{\omega \times Y^{*}}\left(\mathcal{T}_{\varepsilon} \partial_{x_{1}} u^{\varepsilon} \mathcal{T}_{\varepsilon} \partial_{x_{1}} \varphi+\mathcal{T}_{\varepsilon} \partial_{x_{3}} u^{\varepsilon} \mathcal{T}_{\varepsilon} \partial_{x_{3}} \varphi+\mathcal{T}_{\varepsilon} u^{\varepsilon} \mathcal{T}_{\varepsilon} \varphi\right) d x_{1} d x_{2} d y \\
+\frac{1}{\varepsilon} \int_{R_{1}^{\varepsilon}}\left(\partial_{x_{1}} u^{\varepsilon} \partial_{x_{1}} \varphi+\partial_{x_{3}} u^{\varepsilon} \partial_{x_{3}} \varphi+u^{\varepsilon} \varphi\right) d x \\
\frac{1}{L_{1} L_{2}} \int_{\omega \times Y_{+}^{*}} \mathcal{T}_{\varepsilon}^{+} \partial_{x_{2}} u_{+}^{\varepsilon} \mathcal{T}_{\varepsilon}^{+} \partial_{x_{2}} \varphi d x_{1} d x_{2} d y+\frac{1}{\varepsilon} \int_{R_{+1}^{\varepsilon}} \partial_{x_{2}} u_{+}^{\varepsilon} \partial_{x_{2}} \varphi d x \\
+\int_{R_{-}} \Pi_{\varepsilon} \partial_{x_{2}} u_{-}^{\varepsilon} \Pi_{\varepsilon} \partial_{x_{2}} \varphi d x=\frac{1}{L_{1} L_{2}} \int_{\omega \times Y^{*}} \mathcal{T}_{\varepsilon} f^{\varepsilon} \mathcal{T}_{\varepsilon} \varphi d x_{1} d x_{2} d y+\frac{1}{\varepsilon} \int_{R_{1}^{\varepsilon}} f^{\varepsilon} \varphi d x .
\end{gathered}
$$

We can pass to the limit the equation above taking test functions depending only on $\left(x_{1}, x_{2}\right)$ to find

$$
\begin{aligned}
& \frac{1}{L_{1} L_{2}} \int_{\omega \times Y^{*}}\left(\left(\partial_{x_{1}} u+\partial_{y_{1}} u_{1}\right) \partial_{x_{1}} \varphi+u \varphi\right) d x_{1} d x_{2} d y \\
& +\int_{R_{-}} \partial_{x_{2}} u_{-} \partial_{x_{2}} \varphi d x=\frac{1}{L_{1} L_{2}} \int_{\omega \times Y^{*}} \hat{f} \varphi d x_{1} d x_{2} d y
\end{aligned}
$$

To identify $u_{1}$, one can perform similar arguments as in previous sections:

$$
\partial_{y_{1}} u_{1}\left(x_{1}, x_{2}, y_{1}\right)=\left(\frac{1}{\langle 1 / \bar{g}\rangle_{\left(0, L_{1}\right)} \bar{g}\left(y_{1}\right)}-1\right) \partial_{x_{1}} u \quad \text { a.e. in } \omega \times\left(0, L_{1}\right),
$$

where

$$
\bar{g}\left(y_{1}\right)=\int_{0}^{L_{2}} g\left(y_{1}, y_{2}\right) d y_{2}
$$

This means that the resulting limit problem is

$$
\int_{\omega} q_{1} \partial_{x_{1}} u \partial_{x_{1}}+q_{2} \partial_{x_{2}} u \partial_{x_{2}}+\varphi+u \varphi d x_{1} d x_{2}=\int_{\omega} \bar{f} \varphi d x_{1} d x_{2}, \quad \forall \varphi \in H^{1}(\omega),
$$

where

$$
\begin{array}{ll}
q_{1}=\frac{1}{\langle 1 / \bar{g}\rangle_{\left(0, L_{1}\right)}\langle g\rangle_{\left(0, L_{1}\right) \times\left(0, L_{2}\right)}}, & q_{2}=\frac{g_{0}}{\langle g\rangle_{\left(0, L_{1}\right) \times\left(0, L_{2}\right)}} \\
\bar{g}\left(y_{1}\right)=\int_{0}^{L_{2}} g\left(y_{1}, y_{2}\right) d y_{2} \quad \text { and } & \bar{f}=\langle f\rangle_{Y^{*} .}
\end{array}
$$

### 5.3 Strong oscillations

In this subsection, we suppose oscillations of order $\varepsilon^{\alpha}$ and $\varepsilon^{\beta}$ with $0<1<\alpha<\beta$.

$$
R^{\varepsilon}=\left\{\left(x_{1}, x_{2}, x_{3}\right) \in \mathbb{R}^{3}:\left(x_{1}, x_{2}\right) \in \omega, 0<x_{3}<\varepsilon g\left(\frac{x_{1}}{\varepsilon^{\alpha}}, \frac{x_{2}}{\varepsilon^{\beta}}\right)\right\}
$$

Theorem 5.8. Let $u^{\varepsilon}$ be the solution of (P) with $f^{\varepsilon} \in L^{2}\left(R^{\varepsilon}\right)$ such that $\left\|\left\|f^{\varepsilon}\right\|\right\|_{L^{2}\left(R^{\varepsilon}\right)} \leq c$ with $c$ a positive constant independent of $\varepsilon$. Suppose that there is $f \in L^{2}(\omega)$ satifying

$$
\frac{1}{\varepsilon} \int_{0}^{\varepsilon g\left(\frac{x_{1}}{\varepsilon^{2}}, \frac{x_{2}}{\varepsilon^{\mathcal{B}}}\right)} f^{\varepsilon}\left(x_{1}, x_{2}, x_{3}\right) d x_{3} \rightharpoonup f \quad \text { in } \quad L^{2}(\omega)
$$

Then, there is $u \in H^{1}(\omega)$ such that

$$
\mathcal{T}_{\varepsilon} u^{\varepsilon} \rightarrow u \quad \text { in } \quad L^{2}\left(\omega ; H^{1}\left(Y^{*}\right)\right)
$$

and

$$
\left\{\begin{array}{l}
-q \Delta_{x_{1} x_{2}} u+u=\bar{f} \quad \text { in } \quad \omega, \\
\frac{\partial u}{\partial \eta}=0 \text { on } \quad \partial \omega
\end{array}\right.
$$

where

$$
q=\frac{g_{0}}{\langle g\rangle_{\left(0, L_{1}\right) \times\left(0, L_{2}\right)}} \quad \text { and } \quad \bar{f}=\frac{f}{\langle g\rangle_{\left(0, L_{1}\right) \times\left(0, L_{2}\right)}} .
$$

Proof. Due to the uniform bounds, we have that there are $u_{m} \in L^{2}\left(\omega \times Y_{+}^{*}\right), u \in H^{1}(\omega), m=1,2$, such that

$$
\begin{gathered}
\mathcal{T}_{\varepsilon} u^{\varepsilon} \rightarrow u \text { strongly in } L^{2}\left(\omega ; H^{1}\left(Y^{*}\right)\right) \\
\mathcal{T}_{\varepsilon} \partial_{x_{1}} u^{\varepsilon} \rightharpoonup u_{1} \quad \text { weakly in } L^{2}\left(\omega \times Y_{+}^{*}\right) \\
\mathcal{T}_{\varepsilon} \partial_{x_{2}} u^{\varepsilon} \rightharpoonup u_{2} \text { weakly in } L^{2}\left(\omega \times Y_{+}^{*}\right) \\
\Pi_{\varepsilon} \partial_{x_{1}} u^{\varepsilon} \rightharpoonup \partial_{x_{1}} u_{-} \text {weakly in } H^{1}\left(R_{-}\right) \\
\Pi_{\varepsilon} \partial_{x_{2}} u^{\varepsilon} \rightharpoonup \partial_{x_{2}} u_{-} \text {weakly in } H^{1}\left(R_{-}\right) \\
\Pi_{\varepsilon} u^{\varepsilon} \rightarrow u_{-} \text {strongly in } L^{2}\left(R_{-}\right) .
\end{gathered}
$$

Also, it is simple to see that

$$
u_{-}=u \quad \text { a.e. in } \omega .
$$

We rewrite the variational formulation of $(\mathrm{P})$ with test functions $\varphi \in H^{1}(\omega)$ as

$$
\begin{gathered}
\int_{R_{-}} \Pi_{\varepsilon} \nabla_{x_{1} x_{2}} u^{\varepsilon} \Pi_{\varepsilon} \nabla_{x_{1} x_{2}} \varphi d x+\frac{1}{L} \int_{\omega \times Y_{+}^{*}} \mathcal{T}_{\varepsilon}^{+} \nabla_{x_{1} x_{2}} u^{\varepsilon} \mathcal{T}_{\varepsilon}^{+} \nabla_{x_{1} x_{2}} \varphi d x_{1} d x_{2} d y \\
+\frac{1}{L} \int_{\omega \times Y^{*}} \mathcal{T}_{\varepsilon} u^{\varepsilon} \mathcal{T}_{\varepsilon} \varphi d x_{1} d x_{2} d y=\frac{1}{\varepsilon} \int_{R^{\varepsilon}} f^{\varepsilon} \varphi d x .
\end{gathered}
$$

We pass to the limit the equation above using Theorem 5.3 and get

$$
\begin{gather*}
\int_{R_{-}} \nabla_{x_{1} x_{2}} u \nabla_{x_{1} x_{2}} \varphi d x+\frac{1}{L_{1} L_{2}} \int_{\omega \times Y_{+}^{*}} u_{1} \varphi_{x} d x_{1} d x_{2} d y \\
\quad+\frac{1}{L_{1} L_{2}} \int_{\omega \times Y^{*}} u \varphi d x_{1} d x_{2} d y=\int_{\omega} f \varphi d x_{1} d x_{2} . \tag{5.4}
\end{gather*}
$$

To prove that $u_{1}=0$, we prove first that it independs on the $y_{2}$ variable. Indeed,

$$
\begin{gathered}
\int_{\omega \times Y_{+}^{*}} u_{1} \phi\left(x_{1}, x_{2}\right) \partial_{2} \psi(y) d x_{1} d x_{2} d y=\lim _{\varepsilon \rightarrow 0} \int_{\omega \times Y_{+}^{*}} \mathcal{T}_{\varepsilon}^{+} \partial_{x_{1}} u^{\varepsilon} \phi \partial_{y_{2}} \psi d x_{1} d x_{2} d y \\
=\lim _{\varepsilon \rightarrow 0} \int_{\omega \times Y_{+}^{*}} \varepsilon^{-\alpha} \partial_{y_{2}} \mathcal{T}_{\varepsilon}^{+} u^{\varepsilon} \phi \partial_{y_{1}} \psi d x_{1} d x_{2} d y=\lim _{\varepsilon \rightarrow 0} \int_{\omega \times Y_{+}^{*}} \varepsilon^{\beta-\alpha} \mathcal{T}_{\varepsilon}^{+} \partial_{x_{2}} u^{\varepsilon} \phi \partial_{y_{1}} \psi d x_{1} d x_{2} d y=0 .
\end{gathered}
$$

Next, we follow the steps of the previous sections and define

$$
\varphi^{\varepsilon}\left(x_{1}, x_{2}, x_{3}\right)=\varepsilon^{\alpha} \tilde{\phi}\left(x_{1}, x_{2}, \frac{x_{3}}{\varepsilon}\right) \psi\left(\left\{\frac{x_{1}}{\varepsilon^{\alpha}}\right\}_{L_{1}}\right) \quad \text { in } \quad R^{\varepsilon} .
$$

With this test function in hands, one can prove that

$$
\tilde{u}_{1}=0 \quad \text { a.e. in } \omega \times\left(0, L_{1}\right) \times\left(g_{0}, g_{1}\right) .
$$

Therefore, we rewrite (5.4) as follows

$$
\int_{\omega} g_{0} \nabla_{x_{1} x_{2}} u \nabla_{x_{1} x_{2}} \varphi d x_{1} d x_{2}+\frac{\left|Y^{*}\right|}{L_{1} L_{2}} \int_{\omega} u \varphi d x_{1} d x_{2}=\int_{\omega} f \varphi d x_{1} d x_{2},
$$

obtaining at the effective problem

$$
\left\{\begin{array}{l}
-\frac{g_{0}}{\langle g\rangle_{\left(0, L_{1}\right) \times\left(0, L_{2}\right)}} \Delta_{x_{1} x_{2}} u+u=\bar{f} \text { in } \omega, \\
\frac{\partial u}{\partial \eta}=0 \text { on } \partial \omega
\end{array}\right.
$$

with

$$
\bar{f}={\frac{f}{\langle g\rangle_{\left(0, L_{1}\right) \times\left(0, L_{2}\right)}}} .
$$
