ON THE CAUCHY-RASSIAS INEQUALITY AND LINEAR n-INNER PRODUCT PRESERVING MAPPINGS

ABSTRACT. We prove the Cauchy–Rassias stability of linear *n*-inner product preserving mappings in *n*-inner product Banach spaces. We apply the Cauchy-Rassias inequality that plays an influencial role in the subject of functional equations. The inequality was introduced for the first time by Th.M.Rassias in his paper entitled: On the stability of the linear mapping in Banach spaces, Proc. Amer. Math.Soc. 72(1978), 297–300.

1. Introduction

Let X and Y be Banach spaces with norms $||\cdot||$ and $||\cdot||$, respectively. Consider $f: X \to Y$ to be a mapping such that f(tx) is continuous in $t \in \mathbb{R}$ for each fixed $x \in X$. Th.M. Rassias [23] introduced the following inequality, that we call Cauchy-Rassias inequality: Assume that there exist constants $\theta \geq 0$ and $p \in [0,1)$ such that

(*)
$$||f(x+y) - f(x) - f(y)|| \le \theta(||x||^p + ||y||^p)$$

for all $x, y \in X$. Rassias [23] showed that there exists a unique \mathbb{R} -linear mapping $T: X \to Y$ such that

$$||f(x) - T(x)|| \le \frac{2\theta}{2 - 2^p} ||x||^p$$

for all $x \in X$. The inequality (*) has provided a lot of influence in the development of what we now call Hyers-Ulam-Rassias stability of functional equations. Beginning around the year 1980 the topic stability of linear functional equations has been studied by a number of mathematicians (see [7], [8] and [11]–[27]).

Jun and Lee [9] proved the following: Denote by $\varphi: X \setminus \{0\} \times X \setminus \{0\} \to [0, \infty)$ a function such that

$$\widetilde{\varphi}(x,y) = \sum_{j=0}^{\infty} \frac{1}{3^j} \varphi(3^j x, 3^j y) < \infty$$

for all $x, y \in X \setminus \{0\}$. Suppose that $f: X \to Y$ is a mapping satisfying

$$||2f(\frac{x+y}{2}) - f(x) - f(y)|| \le \varphi(x,y)$$

for all $x, y \in X \setminus \{0\}$. Then there exists a unique additive mapping $T: X \to Y$ such that

$$||f(x) - f(0) - T(x)|| \le \frac{1}{3} (\widetilde{\varphi}(x, -x) + \widetilde{\varphi}(-x, 3x))$$

for all $x \in X \setminus \{0\}$.

Let X and Y be complex Hilbert spaces. A mapping $f: X \to Y$ is called an inner product preserving mapping if f satisfies the orthogonality equation

$$\langle f(x), f(y) \rangle = \langle x, y \rangle$$

for all $x, y \in X$. The inner product preserving mapping problem has been investigated in several papers (see [2]–[4]).

In this paper, we prove the Cauchy–Rassias stability of inner product preserving mappings in Hilber spaces, introduce the concept of *n*-inner product Banach space and establish the Cauchy–Rassias stability of linear *n*-inner product preserving mappings in *n*-inner product Banach spaces.

2. Cauchy–Rassias stability of inner product preserving mappings in Hilbert spaces

In this section, assume that X is a complex Hilbert space with norm $||\cdot||$, and that Y is a complex Hilbert space with norm $||\cdot||$.

Theorem 2.1. Let $f: X \to Y$ be a mapping with f(0) = 0 for which there exists a function $\varphi: X \times X \to [0, \infty)$ such that

(2.i)
$$\widetilde{\varphi}(x,y) := \sum_{j=0}^{\infty} \frac{1}{2^j} \varphi(2^j x, 2^j y) < \infty,$$

(2.ii)
$$||f(\mu x + \mu y) - \mu f(x) - \mu f(y)|| \le \varphi(x, y),$$

(2.iii)
$$|\langle f(x), f(y) \rangle - \langle x, y \rangle| \le \varphi(x, y)$$

for all $\mu \in \mathbb{T}^1 := \{\lambda \in \mathbb{C} \mid |\lambda| = 1\}$ and all $x, y \in X$. Then there exists a unique inner product preserving mapping $U : X \to Y$ such that

(2.iv)
$$||f(x) - U(x)|| \le \frac{1}{2}\widetilde{\varphi}(x, x)$$

for all $x \in X$.

Proof. By the same reasoning as in the proof of [21, Theorem 2.1], it follows from (2.i) and (2.ii) that there exists a unique \mathbb{C} -linear mapping $U: X \to Y$ satisfying (2.iv). The \mathbb{C} -linear mapping $U: X \to Y$ is given by

(2.1)
$$U(x) = \lim_{l \to \infty} \frac{1}{2^l} f(2^l x)$$

for all $x \in X$.

It follows from (2.iii) that

$$|\langle \frac{1}{2^{l}} f(2^{l} x), \frac{1}{2^{l}} f(2^{l} y)\rangle - \langle x, y \rangle| = \frac{1}{2^{2l}} |\langle f(2^{l} x), f(2^{l} y)\rangle - \langle 2^{l} x, 2^{l} y \rangle|$$

$$\leq \frac{1}{2^{2l}} \varphi(2^{l} x, 2^{l} y) \leq \frac{1}{2^{l}} \varphi(2^{l} x, 2^{l} y),$$

which tends to zero as $l \to \infty$ for all $x, y \in X$ by (2.i). By (2.1),

$$\langle U(x), U(y) \rangle = \lim_{l \to \infty} \langle \frac{1}{2^l} f(2^l x), \frac{1}{2^l} f(2^l y) \rangle = \langle x, y \rangle$$

for all $x, y \in X$, as desired. \square

Corollary 2.2. Let $f: X \to Y$ be a mapping with f(0) = 0 for which there exist constants $\theta \geq 0$ and $p \in [0,1)$ such that

$$||f(\mu x + \mu y) - \mu f(x) - \mu f(y)|| \le \theta(||x||^p + ||y||^p),$$
$$|\langle f(x), f(y) \rangle - \langle x, y \rangle| \le \theta(||x||^p + ||y||^p)$$

for all $\mu \in \mathbb{T}^1$ and all $x, y \in X$. Then there exists a unique inner product preserving mapping $U: X \to Y$ such that

$$||f(x) - U(x)|| \le \frac{2\theta}{2 - 2p} ||x||^p$$

for all $x \in X$.

Proof. Define $\varphi(x,y) = \theta(||x||^p + ||y||^p)$ to be Th.M. Rassias upper bound in the Cauchy–Rassias inequality, and apply Theorem 2.1. \square

Theorem 2.3. Let $f: X \to Y$ be a mapping with f(0) = 0 for which there exists a function $\varphi: X \setminus \{0\} \times X \setminus \{0\} \to [0, \infty)$ such that

(2.v)
$$\widetilde{\varphi}(x,y) := \sum_{j=0}^{\infty} \frac{1}{3^j} \varphi(3^j x, 3^j y) < \infty,$$

(2.vi)
$$||2f(\frac{\mu x + \mu y}{2}) - \mu f(x) - \mu f(y)|| \le \varphi(x, y),$$

(2.vii)
$$|\langle f(x), f(y) \rangle - \langle x, y \rangle| \le \varphi(x, y)$$

for all $\mu \in \mathbb{T}^1$ and all $x, y \in X \setminus \{0\}$. Then there exists a unique inner product preserving mapping $U: X \to Y$ such that

(2.viii)
$$||f(x) - U(x)|| \le \frac{1}{3} (\widetilde{\varphi}(x, -x) + \widetilde{\varphi}(-x, 3x))$$

for all $x \in X \setminus \{0\}$.

Proof. By the same reasoning as in the proof of [11, Theorem 2.5], it follows from (2.v) and (2.vi) that there exists a unique \mathbb{C} -linear mapping $U: X \to Y$ satisfying (2.viii). The \mathbb{C} -linear mapping $U: X \to Y$ is given by

$$(2.2) U(x) = \lim_{l \to \infty} \frac{1}{3^l} f(3^l x)$$

for all $x \in X$.

It follows from (2.vii) that

$$|\langle \frac{1}{3^{l}} f(3^{l} x), \frac{1}{3^{l}} f(3^{l} y)\rangle - \langle x, y \rangle| = \frac{1}{3^{2l}} |\langle f(3^{l} x), f(3^{l} y)\rangle - \langle 3^{l} x, 3^{l} y \rangle|$$

$$\leq \frac{1}{3^{2l}} \varphi(3^{l} x, 3^{l} y) \leq \frac{1}{3^{l}} \varphi(3^{l} x, 3^{l} y),$$

which tends to zero as $l \to \infty$ for all $x, y \in X$ by (2.v). By (2.2),

$$\langle U(x), U(y) \rangle = \lim_{l \to \infty} \langle \frac{1}{3^l} f(3^l x), \frac{1}{3^l} f(3^l y) \rangle = \langle x, y \rangle$$

for all $x, y \in X$, as desired. \square

Corollary 2.4. Let $f: X \to Y$ be a mapping with f(0) = 0 for which there exist constants $\theta \ge 0$ and $p \in [0,1)$ such that

$$||2f(\frac{\mu x + \mu y}{2}) - \mu f(x) - \mu f(y)|| \le \theta(||x||^p + ||y||^p),$$
$$|\langle f(x), f(y)\rangle - \langle x, y\rangle| \le \theta(||x||^p + ||y||^p)$$

for all $\mu \in \mathbb{T}^1$ and all $x, y \in X \setminus \{0\}$. Then there exists a unique inner product preserving mapping $U: X \to Y$ such that

$$||f(x) - U(x)|| \le \frac{3+3^p}{3-3^p}\theta||x||^p$$

for all $x \in X \setminus \{0\}$.

Proof. Define $\varphi(x,y) = \theta(||x||^p + ||y||^p)$, and apply Theorem 2.3. \square

Theorem 2.5. Let $f: X \to Y$ be a mapping with f(0) = 0 for which there exists a function $\varphi: X \setminus \{0\} \times X \setminus \{0\} \to [0, \infty)$ such that

(2.ix)
$$\sum_{j=0}^{\infty} 3^{2j} \varphi(\frac{x}{3^j}, \frac{y}{3^j}) < \infty,$$

(2.x)
$$||2f(\frac{\mu x + \mu y}{2}) - \mu f(x) - \mu f(y)|| \le \varphi(x, y),$$

(2.xi)
$$|\langle f(x), f(y) \rangle - \langle x, y \rangle| \le \varphi(x, y)$$

for all $\mu \in \mathbb{T}^1$ and all $x, y \in X \setminus \{0\}$. Then there exists a unique inner product preserving mapping $U: X \to Y$ such that

(2.xii)
$$||f(x) - U(x)|| \le \widetilde{\varphi}(\frac{x}{3}, -\frac{x}{3}) + \widetilde{\varphi}(-\frac{x}{3}, x)$$

for all $x \in X \setminus \{0\}$, where

$$\widetilde{\varphi}(x,y) := \sum_{j=0}^{\infty} 3^j \varphi(\frac{x}{3^j}, \frac{y}{3^j})$$

for all $x, y \in X \setminus \{0\}$.

Proof. Note that

$$(2.3) 3^j \varphi(\frac{x}{3^j}, \frac{y}{3^j}) \le 3^{2j} \varphi(\frac{x}{3^j}, \frac{y}{3^j})$$

for all $x, y \in X$ and all positive integers j. By the Jun and Lee's theorem [9, Theorem 6], it follows from (2.ix), (2.3) and (2.x) that there exists a unique additive mapping $U: X \to Y$ satisfying (2.xii). The additive mapping $U: X \to Y$ is given by

(2.4)
$$U(x) = \lim_{l \to \infty} 3^l f(\frac{x}{3^l})$$

for all $x \in X$. By the same method as in the proof of [11, Theorem 2.5], one can show that the additive mapping $U: X \to Y$ is \mathbb{C} -linear.

It follows from (2.xi) that

$$\mid \langle 3^l f(\frac{x}{3^l}), 3^l f(\frac{y}{3^l}) \rangle - \langle x, y \rangle \mid = 3^{2l} \mid \langle f(\frac{x}{3^l}), f(\frac{y}{3^l}) \rangle - \langle \frac{x}{3^l}, \frac{y}{3^l} \rangle \mid \leq 3^{2l} \varphi(\frac{x}{3^l}, \frac{y}{3^l}),$$

which tends to zero as $l \to \infty$ for all $x, y \in X$ by (2.ix). By (2.4),

$$\langle U(x), U(y) \rangle = \lim_{l \to \infty} \langle 3^l f(\frac{x}{3^l}), 3^l f(\frac{y}{3^l}) \rangle = \langle x, y \rangle$$

for all $x, y \in X$, as desired. \square

Corollary 2.6. Let $f: X \to Y$ be a mapping with f(0) = 0 for which there exist constants $\theta \ge 0$ and $p \in (2, \infty)$ such that

$$||2f(\frac{\mu x + \mu y}{2}) - \mu f(x) - \mu f(y)|| \le \theta(||x||^p + ||y||^p),$$
$$|\langle f(x), f(y)\rangle - \langle x, y\rangle| \le \theta(||x||^p + ||y||^p)$$

for all $\mu \in \mathbb{T}^1$ and all $x, y \in X \setminus \{0\}$. Then there exists a unique inner product preserving mapping $U: X \to Y$ such that

$$||f(x) - U(x)|| \le \frac{3^p + 3}{3^p - 3}\theta||x||^p$$

for all $x \in X \setminus \{0\}$.

Proof. Define $\varphi(x,y) = \theta(||x||^p + ||y||^p)$, and apply Theorem 2.5. \square

3. Cauchy—Rassias stability of linear *n*-inner product preserving mappings in *n*-inner product Banach spaces

We first recall the notion of n-inner product space.

Definition 3.1 [5]. Let X be a complex linear space with dim $X \geq n \geq 2$ and $\langle \cdot, \cdot \mid \cdot, \cdots, \cdot \rangle : X^{n+1} \to \mathbb{C}$ be a function. Then $(X, \langle \cdot, \cdot \mid \cdot, \cdots, \cdot \rangle)$ is called an n-inner product space if

- $(\mathbf{n}\mathbf{I}_1) \ \langle x, x \mid x_2, \cdots, x_n \rangle \ge 0,$
- (nI₂) $\langle x, x \mid x_2, \cdots, x_n \rangle = 0$ if and only if x, x_2, \cdots, x_n are linearly dependent,
- $(nI_3) \langle x, y \mid x_2, \cdots, x_n \rangle = \overline{\langle y, x \mid x_2, \cdots, x_n \rangle},$
- (nI₄) $\langle x, y \mid x_2, \dots, x_n \rangle = \langle x, y \mid x_{j_2}, \dots, x_{j_n} \rangle$ for every permutation (j_2, \dots, j_n) of $(2, \dots, n)$,
- $(\mathbf{nI}_5) \langle x, x \mid x_2, x_3, \cdots, x_n \rangle = \langle x_2, x_2 \mid x, x_3, \cdots, x_n \rangle,$
- $(\mathbf{nI}_6) \langle \alpha x, y \mid x_2, \cdots, x_n \rangle = \alpha \langle x, y \mid x_2, \cdots, x_n \rangle,$
- $(\mathbf{nI_7}) \langle x+y,z \mid x_2,\cdots,x_n \rangle \leq \langle x,z \mid x_2,\cdots,x_n \rangle + \langle y,z \mid x_2,\cdots,x_n \rangle$

for all $\alpha \in \mathbb{C}$ and all $x, y, z, x_1, \dots, x_n \in X$. The function $\langle \cdot, \cdot | \cdot, \dots, \cdot \rangle$ is called an *n*-inner product on X.

The concept of *n*-inner product was introduced in [1] for n=2 and in [10] for $n \geq 2$.

For instance, on a given inner product space with inner product \langle , \rangle , one can put an *n*-inner product by defining $\langle x, y \mid x_2, \cdots, x_n \rangle$ to be

$$\det \begin{pmatrix} \langle x, y \rangle & \langle x, x_2 \rangle & \cdots & \langle x, x_n \rangle \\ \langle x_2, y \rangle & \langle x_2, x_2 \rangle & \cdots & \langle x_2, x_n \rangle \\ \vdots & \vdots & \cdots & \vdots \\ \langle x_n, y \rangle & \langle x_n, x_2 \rangle & \cdots & \langle x_n, x_n \rangle. \end{pmatrix}$$

Definition 3.2. An *n*-inner product and normed (respectively, Banach) space X with *n*-inner product $\langle \cdot, \cdot | \cdot, \cdots, \cdot \rangle_X$ and norm $\| \cdot \|$ is called an *n*-inner product normed (respectively, Banach) space.

For example, if $(X, \langle \cdot, \cdot \mid \cdot, \cdots, \cdot \rangle)$ is an n-inner product space, $\{a_1, \cdots, a_n\}$ is a fixed linearly independent set and k > 0 then $\langle x, y \rangle := k \sum_{\{i_2, \cdots, i_n\} \subseteq \{1, \cdots, n\}} \langle x, y \mid a_{i_2}, \cdots, a_{i_n} \rangle$ is an inner product on X (see [6]) and so X equipped with the norm induced by this inner product is an n-inner product normed space.

In the rest of this section, assume that X is an n-inner product Banach space with n-inner product $\langle \cdot, \cdot | \cdot, \cdots, \cdot \rangle_X$ and norm $|| \cdot ||$, and that Y is an n-inner product Banach space with n-inner product $\langle \cdot, \cdot | \cdot, \cdots, \cdot \rangle_Y$ and norm $|| \cdot ||$.

Theorem 3.1. Let $f: X \to Y$ be a mapping with f(0) = 0 for which there exists a function $\varphi: X^{n+1} \to [0, \infty)$ such that

(3.i)
$$\widetilde{\varphi}(x_0, \dots, x_n) := \sum_{j=0}^{\infty} \frac{1}{2^j} \varphi(2^j x_0, \dots, 2^j x_n) < \infty,$$

(3.ii)
$$||f(\mu x_0 + \mu x_1) - \mu f(x_0) - \mu f(x_1)|| \le \varphi(x_0, x_1, \underbrace{0, \dots, 0}_{n-1 \text{ times}}),$$

$$|\langle f(x_0), f(x_1) \mid f(x_2), \cdots, f(x_n) \rangle_Y - \langle x_0, x_1 \mid x_2, \cdots, x_n \rangle_X |$$

$$\leq \varphi(x_0, \cdots, x_n)$$
(3.iii)

for all $\mu \in \mathbb{T}^1$ and all $x_0, \dots, x_n \in X$. Then there exists a unique \mathbb{C} -linear n-inner product preserving mapping $U: X \to Y$ such that

(3.iv)
$$||f(x) - U(x)|| \le \frac{1}{2}\widetilde{\varphi}(x, x, \underbrace{0, \cdots, 0}_{n-1 \text{ times}})$$

for all $x \in X$.

Proof. By the same reasoning as in the proof of [20, Theorem 2.1], it follows from (3.i) and (3.ii) that there exists a unique \mathbb{C} -linear mapping $U: X \to Y$ satisfying (3.iv). The \mathbb{C} -linear mapping $U: X \to Y$ is given by

(3.1)
$$U(x) = \lim_{l \to \infty} \frac{1}{2^l} f(2^l x)$$

for all $x \in X$.

It follows from (3.iii) that

$$|\langle \frac{1}{2^{l}} f(2^{l} x_{0}), \frac{1}{2^{l}} f(2^{l} x_{1}) | \frac{1}{2^{l}} f(2^{l} x_{2}), \cdots, \frac{1}{2^{l}} f(2^{l} x_{n}) \rangle_{Y}$$

$$- \langle x_{0}, x_{1} | x_{2}, \cdots, x_{n} \rangle_{X} |$$

$$= \frac{1}{2^{2nl}} |\langle f(2^{l} x_{0}), f(2^{l} x_{1}) | f(2^{l} x_{2}), \cdots, f(2^{l} x_{n}) \rangle_{Y}$$

$$- \langle 2^{l} x_{0}, 2^{l} x_{1} | 2^{l} x_{2}, \cdots, 2^{l} x_{n} \rangle_{X} |$$

$$\leq \frac{1}{2^{2nl}} \varphi(2^{l} x_{0}, \cdots, 2^{l} x_{n}) \leq \frac{1}{2^{l}} \varphi(2^{l} x_{0}, \cdots, 2^{l} x_{n}),$$

which tends to zero as $l \to \infty$ for all $x_0, \dots, x_n \in X$ by (3.i). By (3.1),

$$\langle U(x_0), U(x_1) | U(x_2), \cdots, U(x_n) \rangle_Y$$

$$= \lim_{l \to \infty} \langle \frac{1}{2^l} f(2^l x_0), \frac{1}{2^l} f(2^l x_1) | \frac{1}{2^l} f(2^l x_2), \cdots, \frac{1}{2^l} f(2^l x_n) \rangle_Y$$

$$= \langle x_0, x_1 | x_2, \cdots, x_n \rangle_X$$

for all $x_0, \dots, x_n \in X$, as desired. \square

Corollary 3.2. Let $f: X \to Y$ be a mapping with f(0) = 0 for which there exist constants $\theta \geq 0$ and $p \in [0,1)$ such that

$$||f(\mu x_0 + \mu x_1) - \mu f(x_0) - \mu f(x_1)|| \le \theta(||x_0||^p + ||x_1||^p),$$

$$|\langle f(x_0), f(x_1) | f(x_2), \cdots, f(x_n) \rangle_Y - \langle x_0, x_1 | x_2, \cdots, x_n \rangle_X | \le \theta \sum_{j=0}^n ||x_j||^p$$

for all $\mu \in \mathbb{T}^1$ and all $x_0, \dots, x_n \in X$. Then there exists a unique \mathbb{C} -linear n-inner product preserving mapping $U: X \to Y$ such that

$$||f(x) - U(x)|| \le \frac{2\theta}{2 - 2^p} ||x||^p$$

for all $x \in X$.

Proof. Define $\varphi(x_0, \dots, x_n) = \theta \sum_{j=0}^n ||x_j||^p$ to be Th.M. Rassias upper bound in the Cauchy–Rassias inequality, and apply Theorem 3.1. \square

Theorem 3.3. Let $f: X \to Y$ be a mapping with f(0) = 0 for which there exists a function $\varphi: (X \setminus \{0\})^{n+1} \to [0, \infty)$ such that

(3.v)
$$\widetilde{\varphi}(x_0, \dots, x_n) := \sum_{j=0}^{\infty} \frac{1}{3^j} \varphi(3^j x_0, \dots, 3^j x_n) < \infty,$$

(3.vi)
$$||2f(\frac{\mu x_0 + \mu x_1}{2}) - \mu f(x_0) - \mu f(x_1)|| \le \varphi(x_0, x_1, \underbrace{0, \cdots, 0}_{n-1 \text{ times}}),$$

$$|\langle f(x_0), f(x_1) \mid f(x_2), \cdots, f(x_n) \rangle_Y - \langle x_0, x_1 \mid x_2, \cdots, x_n \rangle_X |$$

$$\leq \varphi(x_0, \cdots, x_n)$$
(3.vii)

for all $\mu \in \mathbb{T}^1$ and all $x_0, \dots, x_n \in X \setminus \{0\}$. Then there exists a unique \mathbb{C} -linear n-inner product preserving mapping $U: X \to Y$ such that

$$(3.\text{viii}) \qquad \|f(x) - U(x)\| \le \frac{1}{3} \left(\widetilde{\varphi}(x, -x, \underbrace{0, \cdots, 0}_{n-1 \text{ times}}) + \widetilde{\varphi}(-x, 3x, \underbrace{0, \cdots, 0}_{n-1 \text{ times}}) \right)$$

for all $x \in X \setminus \{0\}$.

Proof. By the same reasoning as in the proof of [20, Theorem 2.5], it follows from (3.v) and (3.vi) that there exists a unique \mathbb{C} -linear mapping $U: X \to Y$ satisfying (3.viii). The \mathbb{C} -linear mapping $U: X \to Y$ is given by

(3.2)
$$U(x) = \lim_{l \to \infty} \frac{1}{3^l} f(3^l x)$$

for all $x \in X$.

It follows from (3.vii) that

$$|\langle \frac{1}{3^{l}} f(3^{l} x_{0}), \frac{1}{3^{l}} f(3^{l} x_{1}) | \frac{1}{3^{l}} f(3^{l} x_{2}), \cdots, \frac{1}{3^{l}} f(3^{l} x_{n}) \rangle_{Y}$$

$$- \langle x_{0}, x_{1} | x_{2}, \cdots, x_{n} \rangle_{X} |$$

$$= \frac{1}{3^{2nl}} |\langle f(3^{l} x_{0}), f(3^{l} x_{1}) | f(3^{l} x_{2}), \cdots, f(3^{l} x_{n}) \rangle_{Y}$$

$$- \langle 3^{l} x_{0}, 3^{l} x_{1} | 3^{l} x_{2}, \cdots, 3^{l} x_{n} \rangle_{X} |$$

$$\leq \frac{1}{3^{2nl}} \varphi(3^{l} x_{0}, \cdots, 3^{l} x_{n}) \leq \frac{1}{3^{l}} \varphi(3^{l} x_{0}, \cdots, 3^{l} x_{n}),$$

which tends to zero as $l \to \infty$ for all $x_0, \dots, x_n \in X$ by (3.v). By (3.2),

$$\langle U(x_0), U(x_1) | U(x_2), \cdots, U(x_n) \rangle_Y$$

$$= \lim_{l \to \infty} \langle \frac{1}{3^l} f(3^l x_0), \frac{1}{3^l} f(3^l x_1) | \frac{1}{3^l} f(3^l x_2), \cdots, \frac{1}{3^l} f(3^l x_n) \rangle_Y$$

$$= \langle x_0, x_1 | x_2, \cdots, x_n \rangle_X$$

for all $x_0, \dots, x_n \in X$, as desired. \square

Corollary 3.4. Let $f: X \to Y$ be a mapping with f(0) = 0 for which there exist constants $\theta \ge 0$ and $p \in [0,1)$ such that

$$||2f(\frac{\mu x_0 + \mu x_1}{2}) - \mu f(x_0) - \mu f(x_1)|| \le \theta(||x_0||^p + ||x_1||^p),$$

$$|\langle f(x_0), f(x_1) | f(x_2), \cdots, f(x_n) \rangle_Y - \langle x_0, x_1 | x_2, \cdots, x_n \rangle_X | \le \theta \sum_{j=0}^n ||x_j||^p$$

for all $\mu \in \mathbb{T}^1$ and all $x_0, \dots, x_n \in X \setminus \{0\}$. Then there exists a unique \mathbb{C} -linear n-inner product preserving mapping $U: X \to Y$ such that

$$||f(x) - U(x)|| \le \frac{3+3^p}{3-3^p}\theta||x||^p$$

for all $x \in X$.

Proof. Define $\varphi(x_0,\dots,x_n)=\theta\sum_{j=0}^n||x_j||^p$, and apply Theorem 3.3. \square

Theorem 3.5. Let $f: X \to Y$ be a mapping with f(0) = 0 for which there exists a function $\varphi: (X \setminus \{0\})^{n+1} \to [0, \infty)$ such that

(3.ix)
$$\sum_{j=0}^{\infty} 3^{2nj} \varphi(\frac{x_0}{3^j}, \cdots, \frac{x_n}{3^j}) < \infty,$$

(3.x)
$$||2f(\frac{\mu x_0 + \mu x_1}{2}) - \mu f(x_0) - \mu f(x_1)|| \le \varphi(x_0, x_1, \underbrace{0, \cdots, 0}_{n-1 \text{ times}}),$$

$$|\langle f(x_0), f(x_1) | f(x_2), \cdots, f(x_n) \rangle_Y - \langle x_0, x_1 | x_2, \cdots, x_n \rangle_X |$$

$$\leq \varphi(x_0, \cdots, x_n)$$
(3.xi)

for all $\mu \in \mathbb{T}^1$ and all $x_0, \dots, x_n \in X \setminus \{0\}$. Then there exists a unique \mathbb{C} -linear n-inner product preserving mapping $U: X \to Y$ such that

$$(3.xii) ||f(x) - U(x)|| \le \widetilde{\varphi}(\frac{x}{3}, -\frac{x}{3}, \underbrace{0, \cdots, 0}_{n-1 \text{ times}}) + \widetilde{\varphi}(-\frac{x}{3}, x, \underbrace{0, \cdots, 0}_{n-1 \text{ times}})$$

for all $x \in X \setminus \{0\}$, where

$$\widetilde{\varphi}(x_0,\cdots,x_n) := \sum_{j=0}^{\infty} 3^j \varphi(\frac{x_0}{3^j},\cdots,\frac{x_n}{3^j})$$

for all $x_0, \dots, x_n \in X$.

Proof. Note that

$$(3.3) 3^j \varphi(\frac{x_0}{3^j}, \cdots, \frac{x_n}{3^j}) \le 3^{2nj} \varphi(\frac{x_0}{3^j}, \cdots, \frac{x_n}{3^j})$$

for all $x_0, \dots, x_n \in X$ and all positive integers j. By the same reasoning as in the proof of Theorem 2.5, it follows from (3.ix), (3.3) and (3.x) that there exists a unique \mathbb{C} -linear mapping $U: X \to Y$ satisfying (3.xii). The \mathbb{C} -linear mapping $U: X \to Y$ is given by

(3.4)
$$U(x) = \lim_{l \to \infty} 3^l f(\frac{x}{3^l})$$

for all $x \in X$.

It follows from (3.xi) that

$$|\langle 3^{l} f(\frac{x_{0}}{3^{l}}), 3^{l} f(\frac{x_{1}}{3^{l}}) | 3^{l} f(\frac{x_{2}}{3^{l}}), \cdots, 3^{l} f(\frac{x_{n}}{3^{l}}) \rangle_{Y}$$

$$- \langle x_{0}, x_{1} | x_{2}, \cdots, x_{n} \rangle_{X} |$$

$$= 3^{2nl} |\langle f(\frac{x_{0}}{3^{l}}), f(\frac{x_{1}}{3^{l}}) | f(\frac{x_{2}}{3^{l}}), \cdots, f(\frac{x_{n}}{3^{l}}) \rangle_{Y}$$

$$- \langle \frac{x_{0}}{3^{l}}, \frac{x_{1}}{3^{l}} | \frac{x_{2}}{3^{l}}, \cdots, \frac{x_{n}}{3^{l}} \rangle_{X} |$$

$$\leq 3^{2nl} \varphi(\frac{x_{0}}{3^{l}}, \cdots, \frac{x_{n}}{3^{l}}),$$

which tends to zero as $l \to \infty$ for all $x_0, \dots, x_n \in X$ by (3.ix). By (3.4),

$$\langle U(x_0), U(x_1) \mid U(x_2), \cdots, U(x_n) \rangle_Y$$

$$= \lim_{l \to \infty} \langle 3^l f(\frac{x_0}{3^l}), 3^l f(\frac{x_1}{3^l}) \mid 3^l f(\frac{x_2}{3^l}), \cdots, 3^l f(\frac{x_n}{3^l}) \rangle_Y$$

$$= \langle x_0, x_1 \mid x_2, \cdots, x_n \rangle_X$$

for all $x_0, \dots, x_n \in X$, as desired. \square

Corollary 3.6. Let $f: X \to Y$ be a mapping with f(0) = 0 for which there exist constants $\theta \geq 0$ and $p \in (2n, \infty)$ such that

$$||2f(\frac{\mu x_0 + \mu x_1}{2}) - \mu f(x_0) - \mu f(x_1)|| \le \theta(||x_0||^p + ||x_1||^p),$$

$$|\langle f(x_0), f(x_1) | f(x_2), \dots, f(x_n) \rangle_Y - \langle x_0, x_1 | x_2, \dots, x_n \rangle_X | \le \theta \sum_{j=0}^n ||x_j||^p$$

for all $\mu \in \mathbb{T}^1$ and all $x_0, \dots, x_n \in X \setminus \{0\}$. Then there exists a unique \mathbb{C} -linear n-inner product preserving mapping $U: X \to Y$ such that

$$||f(x) - U(x)|| \le \frac{3^p + 3}{3^p - 3}\theta||x||^p$$

for all $x \in X \setminus \{0\}$.

Proof. Define $\varphi(x_0,\dots,x_n)=\theta\sum_{j=0}^n||x_j||^p$, and apply Theorem 3.5. \square
