# SUBLATTICES OF LATTICES OF ORDER-CONVEX SETS, I. THE MAIN REPRESENTATION THEOREM

#### Abstract

For a partially ordered set $P$, we denote by $\mathbf{C o}(P)$ the lattice of order-convex subsets of $P$. We find three new lattice identities, (S), (U), and (B), such that the following result holds.

Theorem. Let $L$ be a lattice. Then $L$ embeds into some lattice of the form $\mathbf{C o}(P)$ iff $L$ satisfies $(\mathrm{S}),(\mathrm{U})$, and (B).

Furthermore, if $L$ has an embedding into some $\mathbf{C o}(P)$, then it has such an embedding that preserves the existing bounds. If $L$ is finite, then one can take $P$ finite, with $$
|P| \leq 2|\mathrm{~J}(L)|^{2}-5|\mathrm{~J}(L)|+4
$$ where $\mathrm{J}(L)$ denotes the set of all join-irreducible elements of $L$. On the other hand, the partially ordered set $P$ can be chosen in such a way that there are no infinite bounded chains in $P$ and the undirected graph of the predecessor relation of $P$ is a tree.


## 1. Introduction

For a partially ordered set (from now on poset) $\langle P, \unlhd\rangle$, a subset $X$ of $P$ is order-convex, if $x \unlhd z \unlhd y$ and $\{x, y\} \subseteq X$ implies that $z \in X$, for all $x, y$, $z \in P$. The set $\mathbf{C o}(P)$ of all order-convex subsets of $P$ forms a lattice under inclusion. This lattice is algebraic, atomistic, and join-semidistributive (see Section 2 for the definitions), thus it is a special example of a convex geometry, see P.H. Edelman 5], P. H. Edelman and R. Jamison [6], or K. V. Adaricheva, V. A. Gorbunov, and V.I. Tumanov [2]. Furthermore, it is 'biatomic' and satisfies the nonexistence of so-called 'zigzags' of odd length on its atoms. Is is proved in G. Birkhoff and M. K. Bennett [3] that these conditions characterize the lattices of the form $\mathbf{C o}(P)$.

One of the open problems of [2] is the characterization of all sublattices of the lattices of the form $\mathbf{C o}(P)$.

Problem 3 of [2] for $\mathbf{C o}(P)$. Describe the subclass of those lattices that are embeddable into finite lattices of the form $\mathbf{C o}(P)$.

[^0]In the present paper, we solve completely this problem, not only in the finite case but also for arbitrary lattices. Our main result (Theorem6.7) is that a lattice $L$ can be embedded into some lattice of the form $\mathbf{C o}(P)$ iff $L$ satisfies three completely new identities, that we denote by (S), (U), and (B). Furthermore, $P$ can be taken either finite in case $L$ is finite, or tree-like (see Theorem 7.7).

This result is quite surprising, as it yields the unexpected consequence (see Corollary (6.9) that the class of all lattices that can be embedded into some $\mathbf{C o}(P)$ is a variety, thus it is closed under homomorphic images. However, while it is fairly easy (though not completely trivial) to verify directly that the class is closed under reduced products and substructures (thus it is a quasivariety), we do not know any direct proof that it is closed under homomorphic images.

One of the difficulties of the present work is to guess, for a given $L$, which poset $P$ will solve the embedding problem for $L$ (i.e., $L$ embeds into $\mathbf{C o}(P)$ ). The first natural guess, that consists of using for $P$ the set of all join-irreducible elements of $L$, fails, as illustrated by the two examples of Section 8 We shall construct $P$ via sequences of join-irreducible elements of $L$. In fact, we are able to embed $L$ into $\mathbf{C o}(P)$ for two different sorts of posets $P$ :
(1) $P$ is finite in case $L$ is finite; this is the construction of Section 6
(2) $P$ is tree-like (as defined in Section 2]; this is the construction of Section 7

The two requirements (1) and (2) above can be simultaneously satisfied in case $L$ has no $D$-cycle, see Theorem 7.7(iii). However, the finite lattice $L$ of Example 8.2 can be embedded into some finite $\mathbf{C o}(Q)$, but into no $\mathbf{C o}(R)$, where $R$ is a finite tree-like poset, see Corollary 10.6 It is used to produce, in Section 10 a quasiidentity that holds in all $\mathbf{C o}(R)$, where $R$ is finite and tree-like (or even what we call 'crown-free'), but not in all finite $\mathbf{C o}(P)$.

We conclude the paper by a list of open problems.

## 2. BASIC CONCEPTS

A lattice $L$ is join-semidistributive, if it satisfies the axiom

$$
x \vee y=x \vee z \Rightarrow x \vee y=x \vee(y \wedge z), \quad \text { for all } x, y, z \in L
$$

We denote by $\mathrm{J}(L)$ the set of join-irreducible elements of $L$. We say that $L$ is finitely spatial (resp., spatial) if every element of $L$ is a join of join-irreducible (resp., completely join-irreducible) elements of $L$.

We say that $L$ is lower continuous, if the equality

$$
a \vee \bigwedge X=\bigwedge(a \vee X)
$$

holds, for all $a \in L$ and all downward directed $X \subseteq L$ such that $\bigwedge X$ exists (where $a \vee X=\{a \vee x \mid x \in X\}$ ). It is well known that every dually algebraic lattice is lower continuous - see Lemma 2.3 in P. Crawley and R. P. Dilworth 4], and spatial (thus finitely spatial)-see Theorem I.4.22 in G. Gierz et al. 9] or Lemma 1.3.2 in V. A. Gorbunov [10].

For every element $x$ in a lattice $L$, we put

$$
\downarrow x=\{y \in L \mid y \leq x\} ; \quad \uparrow x=\{y \in L \mid y \geq x\}
$$

If $a, b, c \in L$ such that $a \leq b \vee c$, we say that the (formal) inequality $a \leq b \vee c$ is a nontrivial join-cover, if $a \not \leq b, c$. We say that it is minimal in $b$, if $a \not \leq x \vee c$, for
all $x<b$, and we say that it is a minimal nontrivial join-cover, if it is a nontrivial join-cover and it is minimal in both $b$ and $c$.

The join-dependency relation $D=D_{L}$ (see R. Freese, J. Ježek, and J. B. Nation (7) is defined on the join-irreducible elements of $L$ by putting

$$
p D q \text {, if } p \neq q \text { and } \exists x \text { such that } p \leq q \vee x \text { holds and is minimal in } q \text {. }
$$

It is important to observe that $p D q$ implies that $p \not \leq q$, for all $p, q \in \mathrm{~J}(L)$.
For a poset $P$ endowed with a partial ordering $\unlhd$, we shall denote by $\triangleleft$ the corresponding strict ordering. The set of all order-convex subsets of $P$ forms a lattice under inclusion, that we shall denote by $\mathbf{C o}(P)$. The meet in $\mathbf{C o}(P)$ is the intersection, while the join is given by

$$
X \vee Y=X \cup Y \cup \bigcup\{z \in P \mid \exists\langle x, y\rangle \in(X \times Y) \cup(Y \times X) \text { such that } x \triangleleft z \triangleleft y\}
$$

for all $X, Y \in \mathbf{C o}(P)$. Let us denote by $\prec$ the predecessor relation of $P$. We say that a path of $P$ is a finite sequence $\mathbf{d}=\left\langle x_{0}, \ldots, x_{n-1}\right\rangle$ of distinct elements of $P$ such that either $x_{i} \prec x_{i+1}$ or $x_{i+1} \prec x_{i}$, for all $i$ with $0 \leq i \leq n-2$; if $n>0$, we say that $\mathbf{d}$ is a path from $x_{0}$ to $x_{n-1}$. We say that the path $\mathbf{d}$ is oriented, if $x_{i} \prec x_{i+1}$, for all $i$ with $0 \leq i \leq n-2$. We say that $P$ is tree-like, if the following properties hold:
(i) for all $a \unlhd b$ in $P$, there are $n<\omega$ and $x_{0}, \ldots, x_{n} \in P$ such that $a=x_{0} \prec x_{1} \prec \cdots \prec x_{n}=b$;
(ii) for all $a, b \in P$, there exists at most one path from $a$ to $b$.

## 3. Dually 2-distributive lattices

For a positive integer $n$, the identity of $n$-distributivity is introduced in A.P. Huhn [12. In this paper we shall only need the dual of 2-distributivity, which is the following identity:

$$
a \wedge(x \vee y \vee z)=(a \wedge(x \vee y)) \vee(a \wedge(x \vee z)) \vee(a \wedge(y \vee z)) .
$$

We omit the easy proof of the following lemma, that expresses how dual 2-distributivity can be read on the join-irreducible elements.
Lemma 3.1. Let $L$ be a dually 2 -distributive lattice. For all $p \in \mathrm{~J}(L)$ and all $a, b$, $c \in L$, if $p \leq a \vee b \vee c$, then either $p \leq a \vee b$ or $p \leq a \vee c$ or $p \leq b \vee c$.

We observe that for finitely spatial $L$, the converse of Lemma 3.1 holds.
The following lemma will be used repeatedly throughout the paper.
Lemma 3.2. Let $L$ be a dually 2 -distributive, complete, lower continuous lattice. Let $p \in \mathrm{~J}(L)$ and let $a, b \in L$ such that $p \leq a \vee b$ and $p \not \leq a, b$. Then the following assertions hold:
(i) There are minimal $x \leq a$ and $y \leq b$ such that $p \leq x \vee y$.
(ii) Any minimal $x \leq a$ and $y \leq b$ such that $p \leq x \vee y$ are join-irreducible.

Proof. (i) Let $X \subseteq \downarrow a$ and $Y \subseteq \downarrow b$ be chains such that $p \leq x \vee y$, for all $\langle x, y\rangle \in$ $X \times Y$. It follows from the lower continuity of $L$ that $p \leq(\bigwedge X) \vee(\bigwedge Y)$. The conclusion of (i) follows from a simple application of Zorn's Lemma.
(ii) From $p \not \leq a, b$ it follows that both $x$ and $y$ are nonzero. Suppose that $x=x_{0} \vee x_{1}$ for some $x_{0}, x_{1}<x$. It follows from the minimality assumption on $x$ that $p \not \leq x_{0} \vee y$ and $p \not \leq x_{1} \vee y$, whence, by Lemma 3.1$] \leq x_{0} \vee x_{1}$, thus $p \leq x \leq a$, a contradiction. Hence $x$ is join-irreducible.

For $p, a, b \in \mathrm{~J}(L)$, we say that $\langle a, b\rangle$ is a conjugate pair with respect to $p$, if $p \not \leq a, b$ and $a$ and $b$ are minimal such that $p \leq a \vee b$; we say then that $b$ is a conjugate of $a$ with respect to $p$. Observe that the latter relation is symmetric in $a$ and $b$, and that it implies that $p D a$ and $p D b$.

Notation 3.3. For a lattice $L$ and $p \in J(L)$, we put

$$
[p]^{D}=\{x \in \mathrm{~J}(L) \mid p D x\}
$$

Corollary 3.4. Let $L$ be a dually 2-distributive, complete, lower continuous lattice, and let $p \in \mathrm{~J}(L)$. Then every $a \in[p]^{D}$ has a conjugate with respect to $p$.

Proof. By the definition of join-dependency, there exists $c \in L$ such that $p \leq a \vee c$ and $p \not \leq x \vee c$, for all $x<a$. By Lemma 3.2] there are $a^{\prime} \leq a$ and $b \leq c$ minimal such that $p \leq a^{\prime} \vee b$, and both $a^{\prime}$ and $b$ are join-irreducible. It follows that $a^{\prime}=a$, whence $b$ is a conjugate of $a$ with respect to $p$.

## 4. Stirlitz, Udav, and Bond

4.1. The Stirlitz identity $(\mathbf{S})$ and the axiom $\left(\mathbf{S}_{\mathrm{j}}\right)$. Let $(\mathrm{S})$ be the following identity:

$$
a \wedge\left(b^{\prime} \vee c\right)=\left(a \wedge b^{\prime}\right) \vee \bigvee_{i<2}\left(a \wedge\left(b_{i} \vee c\right) \wedge\left(\left(b^{\prime} \wedge\left(a \vee b_{i}\right)\right) \vee c\right)\right)
$$

where we put $b^{\prime}=b \wedge\left(b_{0} \vee b_{1}\right)$.
Lemma 4.1. The Stirlitz identity (S) holds in $\mathbf{C o}(P)$, for any poset $\langle P, \unlhd\rangle$.
Proof. Let $A, B, B_{0}, B_{1}, C \in \mathbf{C o}(P)$ and $a \in A \cap\left(B^{\prime} \vee C\right)$, where we put $B^{\prime}=$ $B \cap\left(B_{0} \vee B_{1}\right)$. Denote by $D$ the right hand side of the Stirlitz identity calculated with these parameters. If $a \in B^{\prime}$ then $a \in A \cap B^{\prime} \subseteq D$. If $a \in C$ then $a \in A \cap C \subseteq D$.

Suppose that $a \notin B^{\prime} \cup C$. There exist $b \in B^{\prime}$ and $c \in C$ such that, say, $b \triangleleft a \triangleleft c$. Since $b \in B_{0} \vee B_{1}$, there are $i<2$ and $b^{\prime} \in B_{i}$ such that $b^{\prime} \unlhd b$, hence $a \in A \cap\left(B_{i} \vee C\right)$.
Furthermore, $b \in B^{\prime} \cap\left(A \vee B_{i}\right)$, thus $a \in\left(B^{\prime} \cap\left(A \vee B_{i}\right)\right) \vee C$, so $a \in D$.
Lemma 4.2. The Stirlitz identity (S) implies dual 2-distributivity.
Proof. Take $b_{0}=x, b_{1}=y, b=x \vee y$, and $c=z$.
Let $\left(\mathrm{SD}_{\vee}^{2}\right)$ be the following identity:

$$
\begin{equation*}
x \vee(y \wedge z)=x \vee(y \wedge(x \vee(z \wedge(x \vee y)))) \tag{V}
\end{equation*}
$$

It is well known that $\left(\mathrm{SD}_{\vee}^{2}\right)$ implies join-semidistributivity (that is, the axiom $\left.\left(\mathrm{SD}_{\vee}\right)\right)$, see, for example, P. Jipsen and H. Rose [13, page 81].

Lemma 4.3. The Stirlitz identity ( S ) implies $\left(\mathrm{SD}_{\vee}^{2}\right)$.
Proof. Let $L$ be a lattice satisfying (S), let $x, y, z \in L$. Set $y_{2}=y \wedge(x \vee(z \wedge(x \vee y)))$. Set $a=b_{1}=y, b=z, c=b_{0}=x$, and $b^{\prime}=b \wedge\left(b_{0} \vee b_{1}\right)=z \wedge(x \vee y)$. Then the
following inequalities hold:

$$
\begin{aligned}
y_{2} & =y \wedge(x \vee(z \wedge(x \vee y))) \\
& =a \wedge\left(\left(b \wedge\left(b_{0} \vee b_{1}\right)\right) \vee c\right) \\
& \leq\left(a \wedge b^{\prime}\right) \vee \bigvee_{i<2}\left(a \wedge\left(b_{i} \vee c\right) \wedge\left(\left(b^{\prime} \wedge\left(a \vee b_{i}\right)\right) \vee c\right)\right) \\
& =(y \wedge z) \vee(y \wedge x) \vee(y \wedge((z \wedge y) \vee x)) \\
& =(y \wedge z) \vee(y \wedge(x \vee(y \wedge z))) \\
& =y \wedge(x \vee(y \wedge z)) \\
& \leq x \vee(y \wedge z)
\end{aligned}
$$

This implies that $x \vee y_{2} \leq x \vee(y \wedge z)$. Since the converse inequality holds in any lattice, the conclusion follows.

We now introduce a lattice-theoretical axiom, the join-irreducible interpretation of $(\mathrm{S})$, that we will denote by $\left(\mathrm{S}_{\mathrm{j}}\right)$.

For all $a, b, b_{0}, b_{1}, c \in \mathrm{~J}(L)$, the inequalities $a \leq b \vee c, b \leq b_{0} \vee b_{1}$, and $a \neq b$ imply that either $a \leq \bar{b} \vee c$ for some $\bar{b}<b$ or $b \leq a \vee b_{i}$ and $a \leq b_{i} \vee c$ for some $i<2$.

Throughout the paper we shall make repeated use of the item (i) of the following statement. Item (ii) provides a convenient algorithm for verifying whether a finite lattice satisfies (S).

Proposition 4.4. Let $L$ be a lattice. Then the following assertions hold:
(i) If $L$ satisfies $(\mathrm{S})$, then $L$ satisfies $\left(\mathrm{S}_{\mathrm{j}}\right)$.
(ii) If $L$ is complete, lower continuous, finitely spatial, dually 2-distributive, and satisfies $\left(\mathrm{S}_{\mathrm{j}}\right)$, then $L$ satisfies $(\mathrm{S})$.

Proof. (i) Let $a \leq b \vee c, b \leq b_{0} \vee b_{1}$, and $a \neq b$ for some $a, b, b_{0}, b_{1}, c \in \mathrm{~J}(L)$. Then the element $b^{\prime}$ of the Stirlitz identity is $b^{\prime}=b \wedge\left(b_{0} \vee b_{1}\right)=b$; observe also that $a \wedge(b \vee c)=a$. Therefore, applying (S) yields

$$
\begin{aligned}
a & =a \wedge\left(b^{\prime} \vee c\right) \\
& =\left(a \wedge b^{\prime}\right) \vee \bigvee_{i<2}\left(a \wedge\left(b_{i} \vee c\right) \wedge\left(\left(b^{\prime} \wedge\left(a \vee b_{i}\right)\right) \vee c\right)\right) \\
& =(a \wedge b) \vee \bigvee_{i<2}\left(a \wedge\left(b_{i} \vee c\right) \wedge\left(\left(b \wedge\left(a \vee b_{i}\right)\right) \vee c\right)\right) .
\end{aligned}
$$

Since $a$ is join-irreducible, either $a \leq b$ or $a \leq\left(b_{i} \vee c\right) \wedge\left(\left(b \wedge\left(a \vee b_{i}\right)\right) \vee c\right)$ for some $i<2$. If $a \leq b$ then $a \leq a \vee c$ with $a<b$ (because $a \neq b$ ). Suppose that $a \not \leq b$. Then $a \leq\left(b_{i} \vee c\right) \wedge\left(\left(b \wedge\left(a \vee b_{i}\right)\right) \vee c\right) \leq b_{i} \vee c$ for some $i<2$. If $b \not \leq a \vee b_{i}$, then $a \leq \bar{b} \vee c$ for $\bar{b}=b \wedge\left(a \vee b_{i}\right)<b$.
(ii) Put $b^{\prime}=b \wedge\left(b_{0} \vee b_{1}\right)$, and let $d$ denote the right hand side of the identity (S). Since $d \leq a \wedge\left(b^{\prime} \vee c\right)$, we must prove the converse inequality only. Let $a_{1} \in \mathrm{~J}(L)$ with $a_{1} \leq a \wedge\left(b^{\prime} \vee c\right)$. Then $a_{1} \leq a$ and $a_{1} \leq b^{\prime} \vee c$. If $a_{1} \leq b^{\prime}$, then $a_{1} \leq a \wedge b^{\prime} \leq d$. If $a_{1} \leq c$, then $a_{1} \leq a \wedge c \leq d$.

Suppose now that $a_{1} \not \leq b^{\prime}, c$. Then, by using Lemma 3.2 we obtain that there are minimal $b_{1}^{\prime} \leq b^{\prime}$ and $c_{1} \leq c$ such that the following inequality holds,

$$
\begin{equation*}
a_{1} \leq b_{1}^{\prime} \vee c_{1} \tag{4.1}
\end{equation*}
$$

and both $b_{1}^{\prime}$ and $c_{1}$ are join-irreducible. From $a_{1} \not \leq b^{\prime}$ it follows that $a_{1} \not \leq b_{1}^{\prime}$. If $b_{1}^{\prime} \leq b_{i}$ for some $i<2$, then the inequalities $b_{1}^{\prime} \leq b^{\prime} \wedge b_{i} \leq b^{\prime} \wedge\left(a \vee b_{i}\right)$ and $a_{1} \leq b_{1}^{\prime} \vee c_{1} \leq\left(b^{\prime} \wedge\left(a \vee b_{i}\right)\right) \vee c$ hold; but in this case, we also have $a_{1} \leq a \wedge\left(b_{i} \vee c\right)$, whence $a_{1} \leq d$. Suppose that $b_{1}^{\prime} \not \leq b_{0}, b_{1}$. Then, by Lemma 3.2 there are join-irreducible elements $d_{i} \leq b_{i}, i<2$, such that the following inequality

$$
\begin{equation*}
b_{1}^{\prime} \leq d_{0} \vee d_{1} \tag{4.2}
\end{equation*}
$$

holds. It follows from (4.1), (4.2), $a_{1} \not \leq b_{1}^{\prime}$, the minimality of $b_{1}^{\prime}$ in (4.1), and $\left(\mathrm{S}_{\mathrm{j}}\right)$ that there exists $i<2$ such that $b_{1}^{\prime} \leq a_{1} \vee d_{i}$ and $a_{1} \leq d_{i} \vee c_{1}$. Then the following inequalities hold:

$$
a_{1} \leq a \wedge\left(d_{i} \vee c_{1}\right) \wedge\left(b_{1}^{\prime} \vee c_{1}\right) \leq a \wedge\left(b_{i} \vee c\right) \wedge\left(\left(b^{\prime} \wedge\left(a \vee b_{i}\right)\right) \vee c\right) \leq d
$$

In every case, $a_{1} \leq d$. Since $L$ is finitely spatial, it follows that $a \wedge\left(b^{\prime} \vee c\right) \leq d$.
4.2. The Bond identity (B) and the axiom ( $\mathbf{B}_{\mathrm{j}}$ ). Let (B) be the following identity:

$$
\begin{aligned}
x \wedge\left(a_{0} \vee a_{1}\right) \wedge\left(b_{0} \vee b_{1}\right)= & \bigvee_{i<2}\left(\left(x \wedge a_{i} \wedge\left(b_{0} \vee b_{1}\right)\right) \vee\left(x \wedge b_{i} \wedge\left(a_{0} \vee a_{1}\right)\right)\right) \\
& \vee \bigvee_{i<2}\left(x \wedge\left(a_{0} \vee a_{1}\right) \wedge\left(b_{0} \vee b_{1}\right) \wedge\left(a_{0} \vee b_{i}\right) \wedge\left(a_{1} \vee b_{1-i}\right)\right) .
\end{aligned}
$$

Lemma 4.5. The Bond identity (B) holds in $\mathbf{C o}(P)$, for any poset $\langle P, \unlhd\rangle$.
Proof. Let $X, A_{0}, A_{1}, B_{0}, B_{1}$ be elements of $\mathbf{C o}(P)$. Denote by $C$ the right hand side of the Bond identity formed from these elements. Let $x \in X \cap\left(A_{0} \vee A_{1}\right) \cap$ $\left(B_{0} \vee B_{1}\right)$, we prove that $x \in C$. The conclusion is obvious if $x \in A_{0} \cup A_{1} \cup B_{0} \cup B_{1}$, so suppose that $x \notin A_{0} \cup A_{1} \cup B_{0} \cup B_{1}$. Since $x \in\left(A_{0} \vee A_{1}\right) \backslash\left(A_{0} \cup A_{1}\right)$, there are $a_{0} \in A_{0}$ and $a_{1} \in A_{1}$ such that, say, $a_{0} \triangleleft x \triangleleft a_{1}$. Since $x \in\left(B_{0} \vee B_{1}\right) \backslash\left(B_{0} \cup B_{1}\right)$, there are $b_{0} \in B_{0}$ and $b_{1} \in B_{1}$ such that either $b_{0} \triangleleft x \triangleleft b_{1}$ or $b_{1} \triangleleft x \triangleleft b_{0}$. In the first case, $x$ belongs to $X \cap\left(A_{0} \vee A_{1}\right) \cap\left(B_{0} \vee B_{1}\right) \cap\left(A_{0} \vee B_{1}\right) \cap\left(A_{1} \vee B_{0}\right)$, thus to $C$. In the second case, $x$ belongs to $X \cap\left(A_{0} \vee A_{1}\right) \cap\left(B_{0} \vee B_{1}\right) \cap\left(A_{0} \vee B_{0}\right) \cap\left(A_{1} \vee B_{1}\right)$, thus again to $C$.

We now introduce a lattice-theoretical axiom, the join-irreducible interpretation of $(B)$, that we will denote by $\left(\mathrm{B}_{\mathrm{j}}\right)$.

For all $x, a_{0}, a_{1}, b_{0}, b_{1} \in \mathrm{~J}(L)$, the inequalities $x \leq a_{0} \vee a_{1}, b_{0} \vee b_{1}$
imply that either $x \leq a_{i}$ or $x \leq b_{i}$ for some $i<2$ or $x \leq a_{0} \vee b_{0}$, $a_{1} \vee b_{1}$ or $x \leq a_{0} \vee b_{1}, a_{1} \vee b_{0}$.
Throughout the paper we shall make repeated use of the item (i) of the following statement. Item (ii) provides a convenient algorithm for verifying whether a finite lattice satisfies (B).

Proposition 4.6. Let $L$ be a lattice. Then the following assertions hold:
(i) If $L$ satisfies $(B)$, then $L$ satisfies $\left(\mathrm{B}_{\mathrm{j}}\right)$.
(ii) If $L$ is complete, lower continuous, finitely spatial, dually 2-distributive, and satisfies $\left(\mathrm{B}_{\mathrm{j}}\right)$, then $L$ satisfies $(\mathrm{B})$.

Proof. Item (i) is easy to prove by using the (B) identity and the join-irreducibility of $x$.
(ii) Let $u$ (resp., $v$ ) denote the left (resp., right) hand side of the identity (B). It is obvious that $v \leq u$. Since $L$ is finitely spatial, in order to prove that $u \leq v$ it is sufficient to prove that for all $p \in \mathrm{~J}(L)$ such that $p \leq u$, the inequality $p \leq v$ holds. This is obvious if either $p \leq a_{i}$ or $p \leq b_{i}$ for some $i<2$, so suppose that $p \not \leq a_{i}, b_{i}$, for all $i<2$. Then, by Lemma3.2 there exist $x_{0}, x_{1}, y_{0}, y_{1} \in \mathrm{~J}(L)$ such that $x_{i} \leq a_{i}$ and $y_{i} \leq b_{i}$, for all $i<2$, while $p \leq x_{0} \vee x_{1}, y_{0} \vee y_{1}$. By assumption, we obtain that one of the following assertions holds:

$$
\begin{aligned}
& p \leq\left(x_{0} \vee y_{0}\right) \wedge\left(x_{1} \vee y_{1}\right) \leq\left(a_{0} \vee b_{0}\right) \wedge\left(a_{1} \vee b_{1}\right) ; \\
& p \leq\left(x_{0} \vee y_{1}\right) \wedge\left(x_{1} \vee y_{0}\right) \leq\left(a_{0} \vee b_{1}\right) \wedge\left(a_{1} \vee b_{0}\right) .
\end{aligned}
$$

In any case, $p \leq v$, which completes the proof.
4.3. The Udav identity ( $\mathbf{U}$ ) and the axiom $\left(\mathrm{U}_{\mathrm{j}}\right)$. Let $(\mathrm{U})$ be the following identity:

$$
\begin{aligned}
x \wedge\left(x_{0} \vee x_{1}\right) & \wedge\left(x_{1} \vee x_{2}\right) \wedge\left(x_{0} \vee x_{2}\right) \\
= & \left(x \wedge x_{0} \wedge\left(x_{1} \vee x_{2}\right)\right) \vee\left(x \wedge x_{1} \wedge\left(x_{0} \vee x_{2}\right)\right) \vee\left(x \wedge x_{2} \wedge\left(x_{0} \vee x_{1}\right)\right)
\end{aligned}
$$

Lemma 4.7. The Udav identity (U) holds in $\mathbf{C o}(P)$, for any poset $\langle P, \unlhd\rangle$.
Proof. Let $X, X_{0}, X_{1}, X_{2}$ be elements of $\mathbf{C o}(P)$. Denote by $U$ (resp., $V$ ) the left hand side (resp., right hand side) of the Udav identity formed from these elements. It is clear that $U$ contains $V$. Conversely, let $x \in U$, we prove that $x$ belongs to $V$. This is clear if $x \in X_{0} \cup X_{1} \cup X_{2}$, so suppose that $x \notin X_{0} \cup X_{1} \cup X_{2}$. Since $x \in\left(X_{0} \vee X_{1}\right) \backslash\left(X_{0} \cup X_{1}\right)$, there are $x_{0} \in X_{0}$ and $x_{1} \in X_{1}$ such that, say, $x_{0} \triangleleft x \triangleleft x_{1}$. Since $x \in\left(X_{1} \vee X_{2}\right) \backslash\left(X_{1} \cup X_{2}\right)$, there are $x_{1}^{\prime} \in X_{1}$ and $x_{2} \in X_{2}$ such that either $x_{1}^{\prime} \triangleleft x \triangleleft x_{2}$ or $x_{2} \triangleleft x \triangleleft x_{1}^{\prime}$. But since $x \triangleleft x_{1} \in X_{1}$ and $x \notin X_{1}$, the first possibility is ruled out, whence $x_{2} \triangleleft x \triangleleft x_{1}^{\prime}$. Since $x \in\left(X_{0} \vee X_{2}\right) \backslash\left(X_{0} \cup X_{2}\right)$, there are $x_{0}^{\prime} \in X_{0}$ and $x_{2}^{\prime} \in X_{2}$ such that either $x_{0}^{\prime} \triangleleft x \triangleleft x_{2}^{\prime}$ or $x_{2}^{\prime} \triangleleft x \triangleleft x_{0}^{\prime}$. The first possibility is ruled out by $x_{2} \triangleleft x$ and $x \notin X_{2}$, while the second possibility is ruled out by $x_{0} \triangleleft x$ and $x \notin X_{0}$. In any case, we obtain a contradiction.

As we already did for $(\mathrm{S})$ and (B), we now introduce a lattice-theoretical axiom, the join-irreducible interpretation of $(\mathrm{U})$, that we will denote by $\left(\mathrm{U}_{\mathrm{j}}\right)$.

For all $x, x_{0}, x_{1}, x_{2} \in \mathrm{~J}(L)$, the inequalities $x \leq x_{0} \vee x_{1}, x_{0} \vee x_{2}, x_{1} \vee x_{2}$ imply that either $x \leq x_{0}$ or $x \leq x_{1}$ or $x \leq x_{2}$.
Throughout the paper we shall make repeated use of the item (i) of the following statement. Item (ii) provides a convenient algorithm for verifying whether a finite lattice satisfies (U).

Proposition 4.8. Let $L$ be a lattice. Then the following assertions hold:
(i) If $L$ satisfies ( U$)$, then $L$ satisfies $\left(\mathrm{U}_{\mathrm{j}}\right)$.
(ii) If $L$ is complete, lower continuous, finitely spatial, dually 2-distributive, and satisfies both $\left(\mathrm{B}_{\mathrm{j}}\right)$ and $\left(\mathrm{U}_{\mathrm{j}}\right)$, then $L$ satisfies both $(\mathrm{B})$ and $(\mathrm{U})$.
Proof. Item (i) is easy to prove by using the (U) identity and the join-irreducibility of $x$.
(ii) We have already seen in Proposition 4.6 that $L$ satisfies (B).

Let $u$ (resp., $v$ ) be the left hand side (resp., right hand side) of the identity (U). It is clear that $v \leq u$. Let $p \in \mathrm{~J}(L)$ such that $p \leq u$, we prove that $p \leq v$. This is obvious if $p \leq x_{i}$ for some $i<3$, so suppose that $p \not \leq x_{i}$, for all $i<3$. Then, by using Lemma 3.2 we obtain that there are join-irreducible elements $p_{i}, p_{i}^{\prime} \leq x_{i}$ $(i<3)$ of $L$ such that the following inequalities hold:

$$
\begin{equation*}
p \leq p_{0} \vee p_{1}, p_{1}^{\prime} \vee p_{2}, p_{0}^{\prime} \vee p_{2}^{\prime} \tag{4.3}
\end{equation*}
$$

Since $p \not \leq x_{1}$ and $L$ satisfies $\left(\mathrm{B}_{\mathrm{j}}\right)$, it follows from the first two inequalities of (4.3) that $p \leq p_{0} \vee p_{1}^{\prime}, p_{1} \vee p_{2}$. Similarly, from $p \not \leq x_{2}$, the last two inequalities of (4.3), and $\left(\mathrm{B}_{\mathrm{j}}\right)$, we obtain the inequalities $p \leq p_{1}^{\prime} \vee p_{2}^{\prime}, p_{0}^{\prime} \vee p_{2}$, and from the first and the last inequality of (4.3), together with $p \not \leq x_{0}$ and $\left(\mathrm{B}_{\mathrm{j}}\right)$, we obtain the inequalities $p \leq p_{0} \vee p_{2}^{\prime}, p_{0}^{\prime} \vee p_{1}$. In particular, we have obtained the inequalities

$$
p \leq p_{0} \vee p_{1}^{\prime}, p_{1}^{\prime} \vee p_{2}^{\prime}, p_{0} \vee p_{2}^{\prime}
$$

whence, by the assumption $\left(\mathrm{U}_{\mathrm{j}}\right), p \leq x_{i}$ for some $i<3$, a contradiction.
5. First steps together of the identities (S), (U), and (B)
5.1. Udav-Bond partitions. The goal of this subsection is to prove the following partition result of the sets $[p]^{D}$ (see Notation [3.3).
Proposition 5.1. Let $L$ be a complete, lower continuous, dually 2-distributive lattice that satisfies $(\mathrm{U})$ and $(\mathrm{B})$. Then for every $p \in \mathrm{~J}(L)$, there are subsets $A$ and $B$ of $[p]^{D}$ that satisfy the following properties:
(i) $[p]^{D}=A \cup B$ and $A \cap B=\varnothing$.
(ii) For all $x, y \in[p]^{D}, p \leq x \vee y$ iff $\langle x, y\rangle \in(A \times B) \cup(B \times A)$.

Moreover, the set $\{A, B\}$ is uniquely determined by these properties.
The set $\{A, B\}$ will be called the Udav-Bond partition (of $[p]^{D}$ ) associated with $p$. We observe that every conjugate with respect to $p$ of an element of $A$ (resp., $B$ ) belongs to $B$ (resp., $A$ ).
Proof. If $[p]^{D}=\varnothing$ the result is obvious, so suppose that $[p]^{D} \neq \varnothing$. By Lemma 3.2 there are $a, b \in[p]^{D}$ minimal such that $p \leq a \vee b$. We define $A$ and $B$ by the formulas

$$
A=\left\{x \in[p]^{D} \mid p \leq x \vee b\right\}, \quad B=\left\{y \in[p]^{D} \mid p \leq a \vee y\right\}
$$

Let $x \in[p]^{D}$. By Corollary $3.4 x$ has a conjugate with respect to $p$, denote it by $y$. By Lemma 3.2 (ii), $y$ is join-irreducible, thus $y \in[p]^{D}$. By applying $\left(\mathrm{B}_{\mathrm{j}}\right)$ to the inequalities $p \leq a \vee b, x \vee y$, we obtain that either $p \leq a \vee x, b \vee y$ or $p \leq a \vee y$, $b \vee x$, thus either $p \leq a \vee x$ or $p \leq b \vee x$. If both inequalities hold simultaneously, then, since $p \leq a \vee b$ and by $\left(\mathrm{U}_{\mathrm{j}}\right)$, we obtain that $p$ lies below either $a$ or $b$ or $x$, a contradiction. Hence we have established (i).

Let $x, y \in[p]^{D}$, we shall establish in which case the inequality $p \leq x \vee y$ holds. Suppose first that $x \in A$ and $y \in B$. By applying $\left(\mathrm{B}_{\mathrm{j}}\right)$ to the inequalities $p \leq b \vee x, a \vee y$, we obtain that either $p \leq x \vee y$ or $p \leq b \vee y$. In the second case, $y \in B$, but $y \in A$, a contradiction by item (i); hence $p \leq x \vee y$.

Now suppose that $x, y \in A$. If $p \leq x \vee y$, then, by applying $\left(\mathrm{U}_{\mathrm{j}}\right)$ to the inequalities $p \leq x \vee y, b \vee x, b \vee y$, we obtain that $p$ lies below either $x$ or $y$ or $b$, a contradiction. Hence $p \not \leq x \vee y$. The conclusion is the same for $\langle x, y\rangle \in B \times B$. This concludes the proof of item (ii).

Finally, the uniqueness of $\{A, B\}$ follows easily from items (i) and (ii).
5.2. Choosing orientation with Stirlitz. In this subsection we shall investigate further the configuration on which $\left(\mathrm{S}_{\mathrm{j}}\right)$ is based. The following lemma suggests an 'orientation' of the join-irreducible elements in such a configuration. More specifically, we are trying to embed the given lattice into $\mathbf{C o}(P)$, for some poset $\langle P, \unlhd\rangle$. Attempting to define $P$ as $\mathrm{J}(L)$, this would suggest to order the elements $a, b, b_{0}$, and $b_{1}$ by $c \triangleleft a \triangleleft b$ and $b_{1-i} \triangleleft b \triangleleft b_{i}$. Although the elements of $P$ will be defined via finite sequences of elements of $\mathrm{J}(L)$, rather than just elements of $\mathrm{J}(L)$, this idea will be crucial in the construction of Section 7

Lemma 5.2. Let $L$ be a lattice satisfying $\left(\mathrm{S}_{\mathrm{j}}\right)$ and $\left(\mathrm{U}_{\mathrm{j}}\right)$. Let $a, b, b_{0}, b_{1}, c \in \mathrm{~J}(L)$ such that $a \neq b$ and satisfying the inequalities $a \leq b \vee c$ with $b$ minimal such, and $b \leq b_{0} \vee b_{1}$ with $b \not \leq b_{0}, b_{1}$. Then the following assertions hold:
(i) The inequalities $b \leq a \vee b_{i}$ and $a \leq b_{i} \vee c$ together are equivalent to the single inequality $b \leq b_{i} \vee c$, for all $i<2$.
(ii) There is exactly one $i<2$ such that $b \leq b_{i} \vee c$.

Proof. We first observe that $b \not \leq c$ (otherwise $a \leq c$ ). If $b \leq a \vee b_{i}$ and $a \leq b_{i} \vee c$, then obviously $b \leq b_{i} \vee c$. Suppose, conversely, that $b \leq b_{0} \vee c$. If $b \leq b_{1} \vee c$, then, by observing that $b \leq b_{0} \vee b_{1}$ and applying $\left(\mathrm{U}_{\mathbf{j}}\right)$, we obtain that either $b \leq b_{0}$ or $b \leq b_{1}$ or $b \leq c$, a contradiction. Hence $b \not \leq b_{1} \vee c$, the uniqueness statement of (ii) follows. Furthermore, by $\left(\mathrm{S}_{\mathrm{j}}\right)$, there exists $i<2$ such that $b \leq a \vee b_{i}$ and $a \leq b_{i} \vee c$, whence $b \leq b_{i} \vee c$, thus $i=0$. Therefore, $b \leq a \vee b_{0}$ and $a \leq b_{0} \vee c$.

Next, for a conjugate pair $\left\langle b, b^{\prime}\right\rangle$ of elements of $\mathrm{J}(L)$ with respect to some element $a$ of $\mathrm{J}(L)$, we define

$$
\begin{equation*}
C\left[b, b^{\prime}\right]=\left\{x \in \mathrm{~J}(L) \mid b D x \text { and } b \leq b^{\prime} \vee x\right\} \tag{5.1}
\end{equation*}
$$

Notation 5.3. Let SUB denote the class of all lattices that satisfy the identities (S), (U), and (B).

Hence SUB is a variety of lattices. It is finitely based, that is, it is defined by finitely many equations.
Lemma 5.4. Let $L$ be a complete, lower continuous, finitely spatial lattice in $\mathbf{S U B}$. Let $a, b \in \mathrm{~J}(L)$ such that $a D b$. Then the equality $C\left[b, b_{0}\right]=C\left[b, b_{1}\right]$ holds, for all conjugates $b_{0}$ and $b_{1}$ of $b$ with respect to $a$.

Proof. We prove, for example, that $C\left[b, b_{0}\right]$ is contained in $C\left[b, b_{1}\right]$. Let $x \in C\left[b, b_{0}\right]$ (so $b \leq b_{0} \vee x$ ), and suppose that $x \notin C\left[b, b_{1}\right]$ (so $b \not \leq b_{1} \vee x$ ). By Corollary 3.4 $x$ has a conjugate, say, $y$, with respect to $b$. Since both relations $a \leq b \vee b_{1}$ and $b \leq x \vee y$ are minimal nontrivial join-covers, it follows from Lemma 5.2 that either $b \leq b_{1} \vee x$ or $b \leq b_{1} \vee y$, but the first possibility does not hold. Hence the following inequalities hold:

$$
\begin{equation*}
b \leq b_{0} \vee x, b_{1} \vee y, x \vee y \tag{5.2}
\end{equation*}
$$

Furthermore, by the uniqueness statement of Lemma $5.2 b \not \leq b_{0} \vee y$. Thus, by $\left(\mathrm{B}_{\mathrm{j}}\right)$ and the first two inequalities in (5.2) (observe that $\left.b \not \leq b_{0}, b_{1}, x, y\right)$, we obtain that $b \leq b_{0} \vee b_{1}$. Hence $a \leq b \vee b_{0} \leq b_{0} \vee b_{1}$, whence $a \leq b \vee b_{0}, b \vee b_{1}, b_{0} \vee b_{1}$, a contradiction by $\left(\mathrm{U}_{\mathrm{j}}\right)$.

For all $a, b \in \mathrm{~J}(L)$ such that $a D b$, there exists, by Corollary 3.4 a conjugate $b^{\prime}$ of $b$ with respect to $a$. By Lemma 5.4. for fixed $a$, the value of $C\left[b ; b^{\prime}\right]$ does not
depend of $b^{\prime}$. This entitles us to define

$$
\begin{equation*}
C(a, b)=C\left[b, b^{\prime}\right], \text { for any conjugate } b^{\prime} \text { of } b \text { with respect to } a . \tag{5.3}
\end{equation*}
$$

Lemma 5.5. Let $a, b \in \mathrm{~J}(L)$ such that $a D b$. Then the set $\left\{C(a, b),[b]^{D} \backslash C(a, b)\right\}$ is the Udav-Bond partition of $[b]^{D}$ associated with $b$.

Proof. It suffices to prove that the assertions (i) and (ii) of Proposition 5.1 are satisfied by the set $\left\{C(a, b),[b]^{D} \backslash C(a, b)\right\}$. We first observe the following immediate consequence of Lemma 5.2

Claim. For any $x \in[b]^{D}$ and any conjugate $x^{\prime}$ of $x, x \notin C(a, b)$ iff $x^{\prime} \in C(a, b)$.
From now on we fix a conjugate $b^{\prime}$ of $b$ with respect to $a$. Let $x, y \in[b]^{D}$, let $x^{\prime}$ (resp., $y^{\prime}$ ) be a conjugate of $x$ (resp., $y$ ) with respect to $b$.

Suppose first that $x \in C(a, b)$ and $y \notin C(a, b)$, we prove that $b \leq x \vee y$. It follows from the Claim above that $y^{\prime} \in C(a, b)$, whence the inequalities $b \leq b^{\prime} \vee x, b^{\prime} \vee y^{\prime}$ hold, hence, by $\left(\mathrm{U}_{\mathrm{j}}\right), b \not \leq x \vee y^{\prime}$. But $b \leq x \vee x^{\prime}, y \vee y^{\prime}$, thus, since $b \not \leq x, x^{\prime}, y, y^{\prime}$ and by $\left(\mathrm{B}_{\mathrm{j}}\right)$, the inequality $b \leq x \vee y$ holds.

Suppose next that $x, y \in C(a, b)$. Since $b \leq b^{\prime} \vee x, b^{\prime} \vee y$, the inequality $b \leq x \vee y$ would yield, by $\left(\mathrm{U}_{\mathrm{j}}\right)$, a contradiction; whence $b \not \leq x \vee y$.

Suppose, finally, that $x, y \notin C(a, b)$. Thus, by the Claim, $y^{\prime} \in C(a, b)$, whence, by the above, $b \leq x \vee y^{\prime}, y \vee y^{\prime}$, whence, by $\left(\mathrm{U}_{\mathrm{j}}\right), b \not \leq x \vee y$.
5.3. Stirlitz tracks. Throughout this subsection, we shall fix a lattice $L$ satisfying the identities (S), (U), and (B). By Lemma 4.2 $L$ is dually 2-distributive as well. Furthermore, it follows from Propositions 4.4 4.6 and 4.8 that $L$ satisfies $\left(\mathrm{S}_{\mathrm{j}}\right)$, $\left(\mathrm{U}_{\mathrm{j}}\right)$, and $\left(\mathrm{B}_{\mathrm{j}}\right)$.

Definition 5.6. For a natural number $n$, a Stirlitz track of length $n$ is a pair $\sigma=\left\langle\left\langle a_{i} \mid 0 \leq i \leq n\right\rangle,\left\langle a_{i}^{\prime} \mid 1 \leq i \leq n\right\rangle\right\rangle$, where the elements $a_{i}$ for $0 \leq i \leq n$ and $a_{i}^{\prime}$ for $1 \leq i \leq n$ are join-irreducible and the following conditions are satisfied:
(i) the inequality $a_{i} \leq a_{i+1} \vee a_{i+1}^{\prime}$ holds, for all $i \in\{0, \ldots, n-1\}$, and it is a minimal nontrivial join-cover;
(ii) the inequality $a_{i} \leq a_{i}^{\prime} \vee a_{i+1}$ holds, for all $i \in\{1, \ldots, n-1\}$.

We shall call $a_{0}$ the base of $\sigma$. Observe that $a_{i} D a_{i+1}$, for all $i \in\{0, \ldots, n-1\}$.
Observe that if $\sigma$ is a Stirlitz track as above, then, by Lemma 5.2 the following inequalities also hold:

$$
\begin{align*}
a_{i+1} & \leq a_{i} \vee a_{i+2} ;  \tag{5.4}\\
a_{i} & \leq a_{i+1}^{\prime} \vee a_{i+2}, \tag{5.5}
\end{align*}
$$

for all $i \in\{0, \ldots, n-2\}$.
The main property that we will need about Stirlitz tracks is the following.
Lemma 5.7. For a positive integer $n$, let $\sigma=\left\langle\left\langle a_{i} \mid 0 \leq i \leq n\right\rangle,\left\langle a_{i}^{\prime} \mid 1 \leq i \leq n\right\rangle\right\rangle$ be a Stirlitz track of length $n$. Then the inequalities $a_{i} \leq a_{0} \vee a_{n}$ and $a_{i} \leq a_{1}^{\prime} \vee a_{n}$ hold, for all $i \in\{0, \ldots, n\}$. Furthermore, $0 \leq k<l \leq n$ implies that $a_{k} \not \leq a_{l}$; in particular, the elements $a_{i}$, for $0 \leq i \leq n$, are distinct.

Proof. We argue by induction on $n$. The result is trivial for $n=1$, and it follows from (5.4) and (5.5) for $n=2$. Suppose that the result holds for $n \geq 2$, and let $\sigma=\left\langle\left\langle a_{i} \mid 0 \leq i \leq n+1\right\rangle,\left\langle a_{i}^{\prime} \mid 1 \leq i \leq n+1\right\rangle\right\rangle$ be a Stirlitz track of length $n+1$. We
observe that $\sigma_{*}=\left\langle\left\langle a_{i} \mid 0 \leq i \leq n\right\rangle,\left\langle a_{i}^{\prime} \mid 1 \leq i \leq n\right\rangle\right\rangle$ is a Stirlitz track of length $n$, whence, by the induction hypothesis, the following inequalities hold:

$$
\begin{align*}
& a_{n-1} \leq a_{0} \vee a_{n}  \tag{5.6}\\
& a_{n-1} \leq a_{1}^{\prime} \vee a_{n} \tag{5.7}
\end{align*}
$$

We first prove that $a_{n-1} \leq a_{0} \vee a_{n+1}$. Indeed, suppose that this does not hold. Hence, a fortiori $a_{n-1} \not \leq a_{0}, a_{n+1}$. Hence, by applying $\left(\mathrm{B}_{\mathrm{j}}\right)$ to (5.5) (for $i=n-1$ ) and (5.6) and observing that $a_{n-1} \not \leq a_{n}, a_{n}^{\prime}$, we obtain that $a_{n-1} \leq a_{n} \vee a_{n+1}$. Therefore, $a_{n-1} \leq a_{n} \vee a_{n+1}, a_{n} \vee a_{n}^{\prime}, a_{n}^{\prime} \vee a_{n+1}$, a contradiction by $\left(\mathrm{U}_{\mathrm{j}}\right)$. Hence, indeed, $a_{n-1} \leq a_{0} \vee a_{n+1}$. Consequently, by (5.4), $a_{n} \leq a_{n-1} \vee a_{n+1} \leq a_{0} \vee a_{n+1}$. Hence, for $i \in\{0, \ldots, n\}$, it follows from the induction hypothesis (applied to $\sigma_{*}$ ) that $a_{i} \leq a_{0} \vee a_{n} \leq a_{0} \vee a_{n+1}$.

The proof of the inequalities $a_{i} \leq a_{1}^{\prime} \vee a_{n+1}$, for $i \in\{0, \ldots, n\}$, is similar, with $a_{0}$ replaced by $a_{1}^{\prime}$ and (5.6) replaced by (5.7).

Finally, let $0 \leq k<l \leq n$, and suppose that $a_{k} \leq a_{l}$. By applying the previous result to the Stirlitz track $\left\langle\left\langle a_{k+i} \mid 0 \leq i \leq l-k\right\rangle,\left\langle a_{k+i}^{\prime} \mid 1 \leq i \leq l-k\right\rangle\right\rangle$, we obtain that $a_{l-1} \leq a_{k} \vee a_{l}=a_{l}$, a contradiction. Hence $a_{k} \not \leq a_{l}$, in particular, $a_{k} \neq a_{l}$.

Lemma 5.8. For positive integers $m, n>0$, let

$$
\sigma=\left\langle\left\langle a_{i} \mid 0 \leq i \leq m\right\rangle,\left\langle a_{i}^{\prime} \mid 1 \leq i \leq m\right\rangle\right\rangle, \quad \tau=\left\langle\left\langle b_{j} \mid 0 \leq j \leq n\right\rangle,\left\langle b_{j}^{\prime} \mid 1 \leq j \leq n\right\rangle\right\rangle
$$

be Stirlitz tracks with the same base $p=a_{0}=b_{0}$ and $p \leq a_{1} \vee b_{1}$. Then $a_{i}, b_{j} \leq$ $a_{m} \vee b_{n}$, for all $i \in\{0, \ldots, m\}$ and $j \in\{0, \ldots, n\}$.

Proof. Suppose first that the inequality $p \leq a_{1} \vee b_{1}^{\prime}$ holds. Then $p \leq a_{1} \vee b_{1}^{\prime}, b_{1}^{\prime} \vee$ $b_{1}, b_{1} \vee a_{1}$, a contradiction by $\left(\mathrm{U}_{\mathrm{j}}\right)$. Hence $p \not \leq a_{1} \vee b_{1}^{\prime}$, thus, by applying $\left(\mathrm{B}_{\mathrm{j}}\right)$ to the inequalities $p \leq a_{1} \vee a_{1}^{\prime}, b_{1} \vee b_{1}^{\prime}$, we obtain that $p \leq a_{1}^{\prime} \vee b_{1}^{\prime}$.

Furthermore, from Lemma 5.7 it follows that $a_{i} \leq p \vee a_{m}$, for all $i \in\{0, \ldots, m\}$, and $b_{j} \leq p \vee b_{n}$, for all $j \in\{0, \ldots, n\}$, thus it suffices to prove that $p \leq a_{m} \vee b_{n}$. Again, from Lemma 5.7 it follows that $p \leq a_{1}^{\prime} \vee a_{m}, b_{1}^{\prime} \vee b_{n}$. Suppose that $p \not \leq a_{m} \vee b_{n}$. Then $p \not \leq a_{1}^{\prime}, a_{m}, b_{1}^{\prime}, b_{n}$, thus, by $\left(\mathrm{B}_{\mathrm{j}}\right), p \leq a_{1}^{\prime} \vee b_{n}$. Furthermore, we have seen that $p \leq b_{1}^{\prime} \vee b_{n}$ and $p \leq a_{1}^{\prime} \vee b_{1}^{\prime}$. Hence, by $\left(\mathrm{U}_{\mathrm{j}}\right), p$ lies below either $a_{1}^{\prime}$ or $b_{1}^{\prime}$ or $b_{n}$, a contradiction.

## 6. The small poset associated with a lattice in SUB

Everywhere in this section before Theorem 6.7 we shall fix a complete, lower continuous, finitely spatial lattice $L$ in SUB. For every element $p \in \mathrm{~J}(L)$, we denote by $\left\{A_{p}, B_{p}\right\}$ the Udav-Bond partition of $[p]^{D}$ associated with $p$ (see Subsection 5.1). We let + and - be distinct symbols, and we put $R=R_{0} \cup R_{-} \cup R_{+}$, where $R_{0}$, $R_{-}$, and $R_{+}$are the sets defined as follows.

$$
\begin{aligned}
R_{0} & =\{\langle p\rangle \mid p \in \mathrm{~J}(L)\} \\
R_{+} & =\{\langle a, b,+\rangle \mid a, b \in \mathrm{~J}(L), a D b\} \\
R_{-} & =\{\langle a, b,-\rangle \mid a, b \in \mathrm{~J}(L), a D b\}
\end{aligned}
$$

We define a map $e: R \rightarrow \mathrm{~J}(L)$ by putting $e(\langle p\rangle)=p$, for all $p \in \mathrm{~J}(L)$, while $e(\langle a, b,+\rangle)=e(\langle a, b,-\rangle)=b$, for all $a, b \in \mathrm{~J}(L)$ with $a D b$.

Let $\prec$ be the binary relation on $R$ that consists of the following pairs:

$$
\begin{array}{lll}
\langle p, a,-\rangle \prec\langle p\rangle \prec\langle p, b,+\rangle & & \text { whenever } a \in A_{p} \text { and } b \in B_{p}, \\
\langle b, c,-\rangle \prec\langle a, b,+\rangle \prec\langle b, d,+\rangle & & \text { and } \\
\langle b, d,-\rangle \prec\langle a, b,-\rangle \prec\langle b, c,+\rangle, & & \text { whenever } c \in[b]^{D} \backslash C(a, b) \text { and } d \in C(a, b) . \tag{6.3}
\end{array}
$$

Lemma 6.1. Let $\varepsilon \in\{+,-\}$, let $n<\omega$, and let $a_{0}, \ldots, a_{n}, b_{0}, \ldots, b_{n} \in \mathrm{~J}(L)$ such that $a_{i} D b_{i}$, for all $i \in\{0, \ldots, n\}$ and $\left\langle a_{0}, b_{0}, \varepsilon\right\rangle \prec \cdots \prec\left\langle a_{n}, b_{n}, \varepsilon\right\rangle$. Then exactly one of the following cases occurs:
(i) $\varepsilon=+$ and, putting $a_{n+1}=b_{n}$, the equality $a_{i+1}=b_{i}$ holds, for all $i \in$ $\{0, \ldots, n\}$, while there are join-irreducible elements $a_{1}^{\prime}, \ldots, a_{n+1}^{\prime}$ of $L$ such that $\left\langle\left\langle a_{i} \mid 0 \leq i \leq n+1\right\rangle,\left\langle a_{i}^{\prime} \mid 1 \leq i \leq n+1\right\rangle\right\rangle$ is a Stirlitz track.
(ii) $\varepsilon=-$ and, putting $a_{-1}=b_{0}$, the equality $a_{i-1}=b_{i}$ holds, for all $i \in$ $\{0, \ldots, n\}$, while there are join-irreducible elements $a_{-1}^{\prime}, \ldots, a_{n-1}^{\prime}$ of $L$ such that $\left\langle\left\langle a_{n-i} \mid 0 \leq i \leq n+1\right\rangle,\left\langle a_{n-i}^{\prime} \mid 1 \leq i \leq n+1\right\rangle\right\rangle$ is a Stirlitz track.

Proof. Suppose that $\varepsilon=+$ (the proof for $\varepsilon=-$ is similar). We argue by induction on $n$. If $n=0$, then, from the assumption that $a_{0} D b_{0}$ and by using Corollary 3.4 we obtain a conjugate $a_{1}^{\prime}$ of $b_{0}$ with respect to $a_{0}$, and $\left\langle\left\langle a_{0}, a_{1}\right\rangle,\left\langle a_{1}^{\prime}\right\rangle\right\rangle$ is obviously a Stirlitz track.

Suppose that $n>0$. From the assumption that $\left\langle a_{n-1}, b_{n-1},+\right\rangle \prec\left\langle a_{n}, b_{n},+\right\rangle$ and the definition of $\prec$, we obtain that $a_{n}=b_{n-1}$. Furthermore, from the induction hypothesis it follows that there exists a Stirlitz track of the form

$$
\left\langle\left\langle a_{i} \mid 0 \leq i \leq n\right\rangle,\left\langle a_{i}^{\prime} \mid 1 \leq i \leq n\right\rangle\right\rangle .
$$

Put $a_{n+1}=b_{n}$, and let $a_{n+1}^{\prime}$ be a conjugate of $a_{n+1}$ with respect to $a_{n}$. Using again the assumption that $\left\langle a_{n-1}, b_{n-1},+\right\rangle \prec\left\langle a_{n}, b_{n},+\right\rangle$, we obtain the inequality $a_{n} \leq a_{n}^{\prime} \vee a_{n+1}$. Therefore, $\left\langle\left\langle a_{i} \mid 0 \leq i \leq n+1\right\rangle,\left\langle a_{i}^{\prime} \mid 1 \leq i \leq n+1\right\rangle\right\rangle$ is a Stirlitz track.

Let $\unlhd$ denote the reflexive and transitive closure of $\prec$.
Lemma 6.2. The relation $\unlhd$ is a partial ordering on $R$, and $\prec$ is the predecessor relation of $\unlhd$.

Proof. We need to prove that for any $n>0$, if $r_{0} \prec \cdots \prec r_{n}$ in $R$, then $r_{0} \neq r_{n}$. We have three cases to consider.
Case 1. $r_{0} \in R_{+}$. In this case, $r_{i}=\left\langle a_{i}, b_{i},+\right\rangle \in R_{+}$, for all $i \in\{1, \ldots, n\}$. By Lemma 6.1] if we put $a_{n+1}=b_{n}$, then $a_{i+1}=b_{i}$, for all $i \in\{0, \ldots, n\}$, and there are join-irreducible elements $a_{1}^{\prime}, \ldots, a_{n+1}^{\prime}$ of $L$ such that

$$
\left\langle\left\langle a_{i} \mid 0 \leq i \leq n+1\right\rangle,\left\langle a_{i}^{\prime} \mid 1 \leq i \leq n+1\right\rangle\right\rangle
$$

is a Stirlitz track. In particular, by Lemma 5.7 $a_{0} \neq a_{n}$, whence $r_{0} \neq r_{n}$.
Case 2. $r_{0} \in R_{0}$. Then $r_{i} \in R_{+}$, for all $i \in\{1, \ldots, n\}$, thus $r_{0} \neq r_{n}$.
Case 3. $r_{0} \in R_{-}$. If $r_{n} \notin R_{-}$, then $r_{0} \neq r_{n}$. Suppose that $r_{n} \in R_{-}$. Then $r_{i}=$ $\left\langle a_{i}, b_{i},-\right\rangle$ belongs to $R_{-}$, for all $i \in\{0, \ldots, n\}$. By Lemma 6.1 if we put $a_{-1}=b_{0}$, then $a_{i-1}=b_{i}$, for all $i \in\{0, \ldots, n\}$, and there are join-irreducible elements $a_{-1}^{\prime}$, $\ldots, a_{n-1}^{\prime}$ of $L$ such that $\left\langle\left\langle a_{n-i} \mid 0 \leq i \leq n+1\right\rangle,\left\langle a_{n-i}^{\prime} \mid 1 \leq i \leq n+1\right\rangle\right\rangle$ is a Stirlitz track. In particular, by Lemma 5.7 $a_{0} \neq a_{n}$, whence $r_{0} \neq r_{n}$.

## Definition 6.3.

(i) Two finite sequences $\mathbf{r}=\left\langle r_{0}, \ldots, r_{n-1}\right\rangle$ and $\mathbf{s}=\left\langle s_{0}, \ldots, s_{n-1}\right\rangle$ of same length of $R$ are isotype, if either $e\left(r_{i}\right)=e\left(s_{i}\right)$, for all $i \in\{0, \ldots, n-1\}$, or $e\left(r_{i}\right)=e\left(s_{n-1-i}\right)$, for all $i \in\{0, \ldots, n-1\}$.
(ii) An oriented path (see Section 2) $\mathbf{r}=\left\langle r_{0}, \ldots, r_{n-1}\right\rangle$ of elements of $R$ is

- positive (resp., negative), if there are elements $a_{i}$, $b_{i}$ (for $0 \leq i<n$ ) of $\mathrm{J}(L)$ such that $r_{i}=\left\langle a_{i}, b_{i},+\right\rangle$ (resp., $r_{i}=\left\langle a_{i}, b_{i},-\right\rangle$ ), for all $i \in$ $\{0, \ldots, n-1\}$.
- reduced, if either it is positive or is has the form

$$
\left\langle u_{0}, \ldots, u_{k-1},\langle p\rangle, v_{0}, \ldots, v_{l-1}\right\rangle
$$

where $p \in \mathrm{~J}(L),\left\langle u_{0}, \ldots, u_{k-1}\right\rangle$ is negative, and $\left\langle v_{0}, \ldots, v_{l-1}\right\rangle$ is positive.

Lemma 6.4. Every oriented path of $R$ is isotype to a reduced oriented path.
Proof. Let $\mathbf{r}$ be an oriented path of $R$, we prove that $\mathbf{r}$ is isotype to a reduced oriented path. If $\mathbf{r}$ is either positive or reduced there is nothing to do. Suppose that $\mathbf{r}$ is neither positive nor reduced. Then $\mathbf{r}$ has the form

$$
\left\langle\left\langle a_{k-1}, a_{k},-\right\rangle, \ldots,\left\langle a_{0}, a_{1},-\right\rangle,\left\langle b_{0}, b_{1},+\right\rangle, \ldots,\left\langle b_{l-1}, b_{l},+\right\rangle\right\rangle
$$

for some integers $k>0$ and $l \geq 0$. If $l=0$, then $\mathbf{r}$ is isotype to the positive path

$$
\left\langle\left\langle a_{0}, a_{1},+\right\rangle, \ldots,\left\langle a_{k-1}, a_{k},+\right\rangle\right\rangle .
$$

Suppose now that $l>0$. Since $\left\langle a_{0}, a_{1},-\right\rangle \prec\left\langle b_{0}, b_{1},+\right\rangle$, two cases can occur.
Case 1. $a_{0}=b_{1}$ and $a_{1} \notin C\left(b_{0}, b_{1}\right)$ (see (6.2)). Observe that $\left\langle a_{0}, a_{1},-\right\rangle \prec\left\langle a_{0}\right\rangle$ if $a_{1} \in A_{a_{0}}$ while $\left\langle a_{0}\right\rangle \prec\left\langle a_{0}, a_{1},+\right\rangle$ if $a_{1} \in B_{a_{0}}$ (see (6.1)). In the first case, it follows from Lemma 5.5 (applied to $C\left(a_{0}, a_{1}\right)$ ) that the sequence

$$
\left\langle\left\langle a_{k-1}, a_{k},-\right\rangle, \ldots,\left\langle a_{0}, a_{1},-\right\rangle,\left\langle a_{0}\right\rangle,\left\langle b_{1}, b_{2},+\right\rangle, \ldots,\left\langle b_{l-1}, b_{l},+\right\rangle\right\rangle
$$

is an oriented path, isotype to r. Similarly, in the second case, the oriented path

$$
\left\langle\left\langle b_{l-1}, b_{l},-\right\rangle, \ldots,\left\langle b_{1}, b_{2},-\right\rangle,\left\langle a_{0}\right\rangle,\left\langle a_{0}, a_{1},+\right\rangle, \ldots,\left\langle a_{k-1}, a_{k},+\right\rangle\right\rangle
$$

is isotype to $\mathbf{r}$.
Case 2. $a_{1}=b_{0}$ and $b_{1} \notin C\left(a_{0}, a_{1}\right)$ (see (6.3). Observe that $\left\langle b_{0}\right\rangle \prec\left\langle b_{0}, b_{1},+\right\rangle$ if $b_{1} \in B_{b_{0}}$ while $\left\langle b_{0}, b_{1},-\right\rangle \prec\left\langle b_{0}\right\rangle$ if $b_{1} \in A_{b_{0}}$ (see (6.1)). In the first case, the oriented path

$$
\left\langle\left\langle a_{k-1}, a_{k},-\right\rangle, \ldots,\left\langle a_{1}, a_{2},-\right\rangle,\left\langle b_{0}\right\rangle,\left\langle b_{0}, b_{1},+\right\rangle, \ldots,\left\langle b_{l-1}, b_{l},+\right\rangle\right\rangle
$$

is isotype to $\mathbf{r}$. Similarly, in the second case, the oriented path

$$
\left\langle\left\langle b_{l-1}, b_{l},-\right\rangle, \ldots,\left\langle b_{0}, b_{1},-\right\rangle,\left\langle b_{0}\right\rangle,\left\langle a_{1}, a_{2},+\right\rangle, \ldots,\left\langle a_{k-1}, a_{k},+\right\rangle\right\rangle
$$

is isotype to $\mathbf{r}$.
This concludes the proof.
We define a map $\varphi$ from $L$ into the powerset of $R$ as follows:

$$
\begin{equation*}
\varphi(x)=\{r \in R \mid e(r) \leq x\}, \text { for all } x \in L \tag{6.4}
\end{equation*}
$$

Lemma 6.5. The set $\varphi(x)$ belongs to $\mathbf{C o}(R, \unlhd)$, for all $x \in L$.

Proof. It is sufficient to prove that if $r_{0} \prec \cdots \prec r_{n}$ in $R$ such that $e\left(r_{0}\right), e\left(r_{n}\right) \leq x$, the relation $e\left(r_{k}\right) \leq x$ holds whenever $0<k<n$. By Lemma 6.4 it is sufficient to consider the case where the oriented path $\mathbf{r}=\left\langle r_{0}, \ldots, r_{n}\right\rangle$ is reduced. If it is positive, then, by Lemma 6.1 there exists a Stirlitz track of the form

$$
\left\langle\left\langle a_{i} \mid 0 \leq i \leq n+1\right\rangle,\left\langle a_{i}^{\prime} \mid 1 \leq i \leq n+1\right\rangle\right\rangle
$$

for join-irreducible elements $a_{i}, a_{i}^{\prime}$ of $L$ with $r_{i}=\left\langle a_{i}, a_{i+1},+\right\rangle$, for all $i \in\{0, \ldots, n\}$. But then, by Lemma 5.7 applied to the Stirlitz track

$$
\left\langle\left\langle a_{i+1} \mid 0 \leq i \leq n\right\rangle,\left\langle a_{i+1}^{\prime} \mid 1 \leq i \leq n\right\rangle\right\rangle,
$$

$e\left(r_{k}\right)=a_{k+1} \leq a_{1} \vee a_{n+1} \leq x$. Suppose from now on that $\mathbf{r}$ is not positive. Then three cases can occur.
Case 1. $\mathbf{r}=\left\langle\left\langle a_{0}\right\rangle,\left\langle a_{0}, a_{1},+\right\rangle, \ldots,\left\langle a_{n-1}, a_{n},+\right\rangle\right\rangle$ for some $a_{0}, \ldots, a_{n} \in \mathrm{~J}(L)$. It follows from Lemma 6.1] that there exists a Stirlitz track of the form

$$
\left\langle\left\langle a_{i} \mid 0 \leq i \leq n\right\rangle,\left\langle a_{i}^{\prime} \mid 1 \leq i \leq n\right\rangle\right\rangle
$$

hence, by Lemma 5.7 $e\left(r_{k}\right)=a_{k} \leq a_{0} \vee a_{n} \leq x$.
Case 2. $\mathbf{r}=\left\langle\left\langle a_{n-1}, a_{n},-\right\rangle, \ldots,\left\langle a_{0}, a_{1},-\right\rangle,\left\langle a_{0}\right\rangle\right\rangle$ for some $a_{0}, \ldots, a_{n} \in \mathrm{~J}(L)$. The argument is similar to the one for Case 1.
Case 3. $\mathbf{r}=\left\langle\left\langle a_{n^{\prime}-1}, a_{n^{\prime}},-\right\rangle, \ldots,\left\langle a_{0}, a_{1},-\right\rangle,\left\langle a_{0}\right\rangle,\left\langle b_{0}, b_{1},+\right\rangle, \ldots,\left\langle b_{n^{\prime \prime}-1}, b_{n^{\prime \prime}},+\right\rangle\right\rangle$ for some positive integers $n^{\prime}$ and $n^{\prime \prime}$ and join-irreducible $a_{0}=b_{0}, a_{1}, \ldots$, $a_{n^{\prime}}, b_{1}, \ldots, b_{n^{\prime \prime}}$. From $\left\langle a_{0}, a_{1},-\right\rangle \prec\left\langle a_{0}\right\rangle \prec\left\langle b_{0}, b_{1},+\right\rangle$ it follows that $a_{0}=b_{0} \leq a_{1} \vee b_{1}$. From Lemma 6.1 it follows that there are Stirlitz tracks of the form

$$
\begin{aligned}
\sigma & =\left\langle\left\langle a_{i} \mid 0 \leq i \leq n^{\prime}\right\rangle,\left\langle a_{i}^{\prime} \mid 1 \leq i \leq n^{\prime}\right\rangle\right\rangle \\
\tau & =\left\langle\left\langle b_{j} \mid 0 \leq j \leq n^{\prime \prime}\right\rangle,\left\langle b_{j}^{\prime} \mid 1 \leq j \leq n^{\prime \prime}\right\rangle\right\rangle
\end{aligned}
$$

with the same base $a_{0}=b_{0} \leq a_{1} \vee b_{1}$. Since $e\left(r_{k}\right)$ has either the form $a_{i}$, where $0 \leq i<n^{\prime}$, or $b_{j}$, where $0 \leq j<n^{\prime \prime}$, it follows from Lemma 5.8 that $e\left(r_{k}\right) \leq a_{n^{\prime}} \vee b_{n^{\prime \prime}} \leq x$.
This concludes the proof.
Lemma 6.6. The map $\varphi$ is a $\langle 0,1\rangle$-lattice embedding from $L$ into $\mathbf{C o}(R)$.
Proof. It is obvious that $\varphi$ is a $\langle\wedge, 0,1\rangle$-homomorphism. Let $x, y \in L$ such that $x \not \leq y$. Since $L$ is finitely spatial, there exists $p \in J(L)$ such that $p \leq x$ and $p \not \leq y$. Hence, $\langle p\rangle \in \varphi(x) \backslash \varphi(y)$, so $\varphi(x) \not \leq \varphi(y)$. Therefore, $\varphi$ is a $\langle\wedge, 0,1\rangle$-embedding.

Now let $x, y \in L$ and let $r \in \varphi(x \vee y)$, we prove that $r \in \varphi(x) \vee \varphi(y)$. The conclusion is trivial if $r \in \varphi(x) \cup \varphi(y)$, so suppose that $r \notin \varphi(x) \cup \varphi(y)$. We need to consider two cases:
Case 1. $r=\langle p\rangle$, for some $p \in \mathrm{~J}(L)$. So $p \leq x \vee y$ while $p \not \leq x, y$. By Lemma 3.2 there are minimal $u \leq x$ and $v \leq y$ such that $p \leq u \vee v$, hence $u$ and $v$ are join-irreducible and they do not belong to the same side of the Udav-Bond partition of $[p]^{D}$ associated with $p$ (see Proposition 5.11). Hence, by the definition of $\prec$, either $\langle p, u,-\rangle \prec\langle p\rangle \prec\langle p, v,+\rangle$ or $\langle p, v,-\rangle \prec\langle p\rangle \prec\langle p, u,+\rangle$. Since $\langle p, u, \varepsilon\rangle \in \varphi(x)$ and $\langle p, v, \varepsilon\rangle \in \varphi(y)$, for all $\varepsilon \in\{+,-\}$, it follows from this that $\langle p\rangle \in \varphi(x) \vee \varphi(y)$.
Case 2. $r=\langle a, b,+\rangle$ for some $a, b \in \mathrm{~J}(L)$ such that $a D b$. So $b \leq x \vee y$ while $b \not \leq x, y$. By Lemma 3.2 there are minimal $u \leq x$ and $v \leq y$ such that $b \leq u \vee v$, hence $u$ and $v$ are join-irreducible and they do not belong to the same side of
the Udav-Bond partition of $[b]^{D}$ associated with $b$ (see Proposition 5.1). Hence, it follows from Lemma 5.5 that either $u \notin C(a, b)$ and $v \in C(a, b)$ or $u \in C(a, b)$ and $v \notin C(a, b)$. In the first case,

$$
\langle b, u,-\rangle \prec\langle a, b,+\rangle \prec\langle b, v,+\rangle,
$$

while in the second case,

$$
\langle b, v,-\rangle \prec\langle a, b,+\rangle \prec\langle b, u,+\rangle .
$$

Since $\langle b, u, \varepsilon\rangle \in \varphi(x)$ and $\langle b, v, \varepsilon\rangle \in \varphi(y)$, for all $\varepsilon \in\{+,-\}$, it follows from this that $r \in \varphi(x) \vee \varphi(y)$.
Case 3. $r=\langle a, b,-\rangle$ for some $a, b \in \mathrm{~J}(L)$ such that $a D b$. The proof is similar to the proof of Case 2.

We can now formulate the main theorem of this paper.
Theorem 6.7. Let $L$ be a lattice. Then the following are equivalent:
(i) L embeds into a lattice of the form $\mathbf{C o}(P)$, for some poset $P$;
(ii) L satisfies the identities (S), (U), and (B) (i.e., it belongs to the class SUB);
(iii) L has a lattice embedding into a lattice of the form $\mathbf{C o}(R)$, for some poset $R$, that preserves the existing bounds. Furthermore, if $L$ is finite, then $R$ is finite, with

$$
|R| \leq 2|\mathrm{~J}(L)|^{2}-5|\mathrm{~J}(L)|+4
$$

Proof. (i) $\Rightarrow$ (ii) follows immediately from Lemmas 4.14 .5 and 4.7
$(\mathrm{ii}) \Rightarrow$ (iii) Denote by Fil $L$ the lattice of all dual ideals (= filters) of $L$, ordered by reverse inclusion; if $L$ has no unit element, then we allow the empty set in Fil $L$, otherwise we require filters to be nonempty. This way, Fil $L$ is complete and the canonical lattice embedding $x \mapsto \uparrow x$ from $L$ into Fil $L$ preserves the existing bounds. It is well known that Fil $L$ is a dually algebraic lattice that extends $L$ and that satisfies the same identities as $L$ (see, for example, G. Grätzer [11]), in particular, it belongs to SUB. Furthermore, Fil $L$ is dually algebraic, thus lower continuous and spatial, thus it is a fortiori finitely spatial. We consider the poset $\langle R, \unlhd\rangle$ constructed above from Fil $L$. By Lemmas 6.5 and 6.6 the canonical map $\varphi$ defines a $\langle 0,1\rangle$-embedding from Fil $L$ into $\mathbf{C o}(R)$.
$($ iii $) \Rightarrow(\mathrm{i})$ is trivial.
In case $L$ is finite, put $n=|\mathrm{J}(L)|$, we verify that $|R| \leq 2 n^{2}-5 n+4$ for the poset $\langle R, \unlhd\rangle$ constructed above, in the case where $n \geq 2$ (for $n \leq 1$ then one can take for $P$ a singleton). Indeed, it follows from the join-semidistributivity of $L$ (that itself follows from Lemma 4.3) that $L$ has at least two $D$-maximal ( = join-prime) elements, hence the number of pairs $\langle a, b\rangle$ of elements of $\mathrm{J}(L)$ such that $a D b$ is at most $(n-1)(n-2)$, whence

$$
|R| \leq 2(n-1)(n-2)+n=2 n^{2}-5 n+4
$$

Remark 6.8. The upper bound $2|\mathrm{~J}(L)|^{2}-5|\mathrm{~J}(L)|+4$ of Theorem 6.7(iii), obtained for the particular poset $R$ constructed above, is reached for $L$ defined as the lattice of all order-convex subsets of a finite chain.

Corollary 6.9. The class of all lattices that can be embedded into some $\mathbf{C o}(P)$ coincides with $\mathbf{S U B}$; it is a finitely based variety. In particular, it is closed under homomorphic images.

Of course, we proved more, for example, the class of all lattices that can be embedded into some finite $\mathbf{C o}(P)$ forms a pseudovariety (see [10]), thus it is closed under homomorphic images.

## 7. The tree-Like poset associated with a lattice in SUB

Everywhere in this section before Theorem 7.7 we shall fix a complete, lower continuous, finitely spatial lattice $L$ in $\mathbf{S U B}$. The goal of the present section is to define a tree-like poset $\Gamma$ and a lattice embedding from $L$ into $\mathbf{C o}(\Gamma)$ that preserves the existing bounds, see Theorem 7.7

The idea to use $D$-increasing finite sequences of join-irreducible elements is introduced in K. V. Adaricheva [1], where it is proved that every finite lattice without $D$-cycle can be embedded into the lattice of subsemilattices of some finite meetsemilattice; see also [2].

We denote by $\Gamma$ the set of all finite, nonempty sequences $\alpha=\langle\alpha(0), \ldots, \alpha(n)\rangle$ of elements of $\mathrm{J}(L)$ such that $\alpha(i) D \alpha(i+1)$, for all $i<n$. We put $|\alpha|=n$ (the length of $\alpha$ ), and we extend this definition by putting $|\varnothing|=-1$. We further put $\bar{\alpha}=\langle\alpha(0), \ldots, \alpha(n-1)\rangle($ the truncation of $\alpha$ ) and $e(\alpha)=\alpha(n)$ (the extremity of $\alpha$ ). If $\alpha=\bar{\beta}$, we say that $\beta$ is a one-step extension of $\alpha$. Furthermore, for all $n \geq 0$, we put

$$
\Gamma_{n}=\{\alpha \in \Gamma| | \alpha \mid \leq n\}, \quad \text { and } \quad E_{n}=\Gamma_{n} \backslash \Gamma_{n-1} \text { for } n>0
$$

For $\alpha \in \Gamma \backslash \Gamma_{0}$, we say that a conjugate of $\alpha$ is an element $\beta$ of $\Gamma$ such that $\bar{\alpha}=\bar{\beta}$ and $e(\alpha)$ and $e(\beta)$ are conjugate with respect to $e(\bar{\alpha})$. It follows from Corollary 3.4 that every element of $\Gamma \backslash \Gamma_{0}$ has a conjugate. Furthermore, for $\alpha, \beta \in \Gamma$, we write $\alpha \sim \beta$, if either $\alpha=\bar{\beta}$ or $\beta=\bar{\alpha}$.

For all $n>0$, we define inductively a binary relation $\prec_{n}$ on $\Gamma_{n}$, together with subsets $A_{\alpha}$ and $B_{\alpha}$ of $[e(\alpha)]^{D}$ for $\alpha \in \Gamma_{n-1}$.

The induction hypothesis to be satisfied consists of the following two assertions:
(S1) $\prec_{n}$ is acyclic.
(S2) For all $\alpha, \beta \in \Gamma_{n}, \alpha \sim \beta$ iff either $\alpha \prec_{n} \beta$ or $\beta \prec_{n} \alpha$.
For $n=0$, let $\prec_{n}$ be empty.
The case $n=1$ is the only place where we have some freedom in the choice of $\prec_{n}$. We suppose that we have already used this freedom for the construction of the poset $\langle R, \unlhd\rangle$ of Section 6] that is, for each $p \in \mathrm{~J}(L)$, let $A_{p}, B_{p}$ such that $\left\{A_{p}, B_{p}\right\}$ is the Udav-Bond partition of $[p]^{D}$ associated with $p$ (see Subsection 5.1), and we let $R$ be the poset associated with this choice that we constructed in Section Then we put $A_{\langle p\rangle}=A_{p}$ and $B_{\langle p\rangle}=B_{p}$, and we define

$$
\prec_{1}=\left\{\langle\langle p, a\rangle,\langle p\rangle\rangle \mid p \in \mathrm{~J}(L), a \in A_{\langle p\rangle}\right\} \cup\left\{\langle\langle p\rangle,\langle p, b\rangle\rangle \mid p \in \mathrm{~J}(L), b \in B_{\langle p\rangle}\right\} .
$$

It is obvious that $\prec_{1}$ satisfies both (S1) and (S2).
Now suppose having defined $\prec_{n}$, for $n \geq 1$, that satisfies both (S1) and (S2). For all $\alpha \in E_{n}$, we define subsets $A_{\alpha}$ and $B_{\alpha}$ of $[e(\alpha)]^{D}$ as follows:
Case 1. $\bar{\alpha} \prec_{n} \alpha$. Then we put $A_{\alpha}=[e(\alpha)]^{D} \backslash C(e(\bar{\alpha}), e(\alpha))$ and $B_{\alpha}=C(e(\bar{\alpha}), e(\alpha))$.
Case 2. $\alpha \prec_{n} \bar{\alpha}$. Then we put $A_{\alpha}=C(e(\bar{\alpha}), e(\alpha))$ and $B_{\alpha}=[e(\alpha)]^{D} \backslash C(e(\bar{\alpha}), e(\alpha))$.
Then we define $\prec_{n+1}$ as
$\prec_{n+1}=\prec_{n} \cup\left\{\langle\alpha \frown\langle x\rangle, \alpha\rangle \mid \alpha \in E_{n}\right.$ and $\left.x \in A_{\alpha}\right\} \cup\left\{\langle\alpha, \alpha \frown\langle y\rangle\rangle \mid \alpha \in E_{n}\right.$ and $\left.y \in B_{\alpha}\right\}$,
where $\langle\alpha, \beta\rangle \mapsto \alpha \frown \beta$ denotes concatenation of finite sequences.
Lemma 7.1. The relation $\prec_{n+1}$ satisfies both (S1) and (S2).
Proof. It is obvious that $\prec_{n+1}$ satisfies (S2). Now let us prove (S1), and suppose that $\prec_{n+1}$ has a cycle, say, $\alpha_{0} \prec_{n+1} \alpha_{1} \prec_{n+1} \cdots \prec_{n+1} \alpha_{k}=\alpha_{0}$, where $k \geq 2$. We pick $k$ minimal with this property. As $A_{\alpha} \cap B_{\alpha}=\varnothing$, for all $\alpha$, we cannot have $k=2$ as well, so $k \geq 3$.

By the induction hypothesis, one of the elements of the cycle belongs to $E_{n+1}$, without loss of generality we may assume that it is the case for $\alpha_{0}$. Hence, by (7.1), $\alpha_{1}=\overline{\alpha_{0}}$ belongs to $\Gamma_{n}$. Let $l$ be the smallest element of $\{1, \ldots, k-1\}$ such that $\alpha_{l+1} \notin \Gamma_{n}$ (it exists since $\alpha_{k}=\alpha_{0} \notin \Gamma_{n}$ ). Suppose that $l<k-1$. By (S2) for $\prec_{n+1}, \alpha_{l+2}=\overline{\alpha_{l+1}}=\alpha_{l}$, a contradiction by the minimality of $k$. Hence $l=k-1$, which means that $\alpha_{1}, \ldots, \alpha_{k-1} \in \Gamma_{n}$. Hence, since $k-1 \geq 2$, we obtain that $\alpha_{1} \prec_{n} \cdots \prec_{n} \alpha_{k-1}=\alpha_{1}$ is a $\prec_{n}$-cycle, a contradiction.

Lemma 7.1 completes the definition of $\prec_{n}$, for all $n>0$. We define $\prec$ as the union over all $n<\omega$ of $\prec_{n}$. Hence $\prec$ is an acyclic binary relation on $\Gamma$ such that $\alpha \sim \beta$ iff either $\alpha \prec \beta$ or $\beta \prec \alpha$, for all $\alpha, \beta \in \Gamma$. Since $\prec$ is acyclic, the reflexive and transitive closure $\unlhd$ of $\prec$ is a partial ordering on $\Gamma$, for which $\prec$ is exactly the predecessor relation. For the sake of clarity, we rewrite below the inductive definition of $\prec$ and the sets $A_{\alpha}$ and $B_{\alpha}$ for $\alpha \in \Gamma$.
(a) For $|\alpha|=0, A_{\alpha}$ and $B_{\alpha}$ are chosen such that $\left\{A_{\alpha}, B_{\alpha}\right\}$ is the Udav-Bond partition of $[e(\alpha)]^{D}$ associated with $e(\alpha)$.
(b) Suppose that $|\alpha| \geq 1$. Then we define $A_{\alpha}$ and $B_{\alpha}$ by

$$
\left\langle A_{\alpha}, B_{\alpha}\right\rangle= \begin{cases}\left([e(\alpha)]^{D} \backslash C(e(\bar{\alpha}), e(\alpha)), C(e(\bar{\alpha}), e(\alpha))\right) & \text { if } \bar{\alpha} \prec \alpha, \\ \left(C(e(\bar{\alpha}), e(\alpha)),[e(\alpha)]^{D} \backslash C(e(\bar{\alpha}), e(\alpha))\right) & \text { if } \alpha \prec \bar{\alpha} .\end{cases}
$$

(c) $\alpha \prec \beta$ implies that $\alpha \sim \beta$.
(d) $\alpha \frown\langle x\rangle \prec \alpha$ iff $x \in A_{\alpha}$ and $\alpha \prec \alpha \frown\langle x\rangle$ iff $x \in B_{\alpha}$, for all $\alpha \in \Gamma$ and all $x \in[e(\alpha)]^{D}$.
By Lemma 5.5 the set $\left\{A_{\alpha}, B_{\alpha}\right\}$ is the Udav-Bond partition of $[e(\alpha)]^{D}$ associated with $\alpha$, for all $\alpha \in \Gamma$. Therefore, by Proposition 5.1 and the definition of $\prec$, we obtain immediately the following consequence.

Corollary 7.2. For all $\alpha \in \Gamma$ and all $x, y \in[e(\alpha)]^{D}, e(\alpha) \leq x \vee y$ iff either $\alpha \frown\langle x\rangle \prec \alpha \prec \alpha \frown\langle y\rangle$ or $\alpha \frown\langle y\rangle \prec \alpha \prec \alpha \frown\langle x\rangle$.

For $\alpha, \beta \in \Gamma$, we denote by $\alpha * \beta$ the largest common initial segment of $\alpha$ and $\beta$. Observe that $\alpha * \beta$ belongs to $\Gamma \cup\{\varnothing\}$ and that $\alpha * \beta=\beta * \alpha$. Put $m=|\alpha|-|\alpha * \beta|$ and $n=|\beta|-|\alpha * \beta|$. We let $P(\alpha, \beta)$ be the finite sequence $\left\langle\gamma_{0}, \gamma_{1}, \ldots, \gamma_{m+n}\right\rangle$, where the $\gamma_{i}$, for $0 \leq i \leq m+n$, are defined by $\gamma_{0}=\alpha, \gamma_{i+1}=\overline{\gamma_{i}}$, for all $i<m$, $\gamma_{m+n}=\beta$, and $\gamma_{m+n-j-1}=\overline{\gamma_{m+n-j}}$, for all $j<n$. Hence the $\gamma_{i}$-s first decrease from $\gamma_{0}=\alpha$ to $\gamma_{m}=\alpha * \beta$ by successive truncations, then they increase again from $\gamma_{m}$ to $\gamma_{m+n}=\beta$ by successive one-step extensions.

For $\alpha, \beta \in \Gamma$, we observe that a path (see Section [2) from $\alpha$ to $\beta$ is a finite sequence $\mathbf{c}=\left\langle\gamma_{0}, \gamma_{1}, \ldots, \gamma_{k}\right\rangle$ of distinct elements of $\Gamma$ such that $\gamma_{0}=\alpha$, $\gamma_{k}=\beta$, and $\gamma_{i} \sim \gamma_{i+1}$, for all $i<k$.
Proposition 7.3. For all $\alpha, \beta \in \Gamma$, there exists at most one path from $\alpha$ to $\beta$, and then this path is $P(\alpha, \beta)$. Furthermore, such a path exists iff $\alpha(0)=\beta(0)$.

Hence, by using the terminology of Section 2 the poset $\langle\Gamma, \unlhd\rangle$ is tree-like.
Proof. Put again $m=|\alpha|-|\alpha * \beta|$ and $n=|\beta|-|\alpha * \beta|$, and $P(\alpha, \beta)=\left\langle\gamma_{0}, \ldots, \gamma_{m+n}\right\rangle$. Let $\mathbf{d}=\left\langle\delta_{0}, \ldots, \delta_{k}\right\rangle$ (for $\left.k<\omega\right)$ be a path from $\alpha$ to $\beta$. We begin with the following essential observation.

Claim. The path $\mathbf{d}$ consists of a sequence of truncations followed by a sequence of one-step extensions.

Proof of Claim. Suppose that there exists an index $i \in\{1, \ldots, k-1\}$ such that $\delta_{i}$ extends both $\delta_{i-1}$ and $\delta_{i+1}$. Then $\delta_{i-1}=\overline{\delta_{i}}=\delta_{i+1}$, which contradicts the fact that all entries of $\mathbf{d}$ are distinct.

Hence, either d consists of a sequence of truncations, or there exists a least index $l \in\{0, \ldots, k-1\}$ such that $\delta_{l+1}$ is an extension of $\delta_{l}$. If $\delta_{i+1}$ is not an extension of $\delta_{i}$ for some $i \in\{l, \ldots, k-1\}$, then, taking the least such $i$, we obtain that $\delta_{i}$ extends both $\delta_{i-1}$ and $\delta_{i+1}$, a contradiction by the first paragraph of the present proof. Hence $\delta_{i+1}$ is a one-step extension of $\delta_{i}$, for all $i \in\{l, \ldots, k-1\}$. $\square$ Claim.

Let $l$ denote the least element of $\{0, \ldots, k\}$ such that $l<k$ implies that $\delta_{l+1}$ extends $\delta_{l}$. In particular, $\delta_{l}$ is a common initial segment of both $\alpha$ and $\beta$, thus of $\alpha * \beta$. Furthermore,

$$
|\alpha|-l=\left|\delta_{0}\right|-l=\left|\delta_{l}\right| \leq|\alpha * \beta|=|\alpha|-m,
$$

thus $l \geq m$. Similarly,

$$
|\beta|-(k-l)=\left|\delta_{l}\right| \leq|\alpha * \beta|=|\beta|-n,
$$

thus $k-l \geq n$. In addition, both $\alpha * \beta$ and $\delta_{m}$ are initial segments of $\alpha$ of the same length $|\alpha|-m$, thus $\alpha * \beta=\delta_{m}$. Similarly, both $\alpha * \beta$ and $\delta_{k-n}$ are initial segments of $\beta$ of the same length $|\beta|-n$, whence $\alpha * \beta=\delta_{k-n}$. Therefore, $\delta_{m}=\delta_{k-n}$, whence, since all entries of $\mathbf{d}$ are distinct, $m=k-n$, so $k=m+n$, whence $l=m$ since $m \leq l \leq k-n$. It follows then from the claim that $\mathbf{d}=P(\alpha, \beta)$.

Furthermore, from $\alpha \sim \beta$ it follows that $\alpha(0)=\beta(0)$, thus the same conclusion follows from the assumption that there exists a path from $\alpha$ to $\beta$. Conversely, if $\alpha(0)=\beta(0)$, then $\alpha * \beta$ is nonempty, thus so are all entries of $P(\alpha, \beta)$. Hence $P(\alpha, \beta)$ is a path from $\alpha$ to $\beta$.

Now we define a map $\pi: \Gamma \rightarrow R$ by the following rule:

$$
\pi(\alpha)=\left\{\begin{array}{ll}
\alpha & \text { if }|\alpha|=0, \\
\langle e(\bar{\alpha}), e(\alpha),+\rangle & \text { if } \bar{\alpha} \prec \alpha, \\
\langle e(\bar{\alpha}), e(\alpha),-\rangle & \text { if } \alpha \prec \bar{\alpha},
\end{array} \quad \text { for all } \alpha \in \Gamma .\right.
$$

Lemma 7.4. $\alpha \prec \beta$ in $\Gamma$ implies that $\pi(\alpha) \prec \pi(\beta)$ in $R$, for all $\alpha, \beta \in \Gamma$. In particular, $\pi$ is order-preserving

Proof. We argue by induction on the least integer $n$ such that $\alpha, \beta \in \Gamma_{n}$. We need to consider first the case where $p, a, b \in \mathrm{~J}(L), a \in A_{p}, b \in B_{p}$ (so that $\langle p, a\rangle \prec\langle p\rangle \prec\langle p, b\rangle$ in $\Gamma)$, and prove that $\pi(\langle p, a\rangle) \prec \pi(\langle p\rangle) \prec \pi(\langle p, b\rangle)$ in $R$. But by the definition of $\pi$, the following equalities hold,

$$
\pi(\langle p, a\rangle)=\langle p, a,-\rangle, \quad \pi(\langle p\rangle)=\langle p\rangle, \quad \text { and } \pi(\langle p, b\rangle)=\langle p, b,+\rangle,
$$

while, by the definition of $\prec$ on $R$,

$$
\langle p, a,-\rangle \prec\langle p\rangle \prec\langle p, b,+\rangle,
$$

which solves the case where $n=1$.
The remaining case to consider is where $\alpha \frown\langle x\rangle \prec \alpha \prec \alpha^{\frown}\langle y\rangle$ in $\Gamma$, for $|\alpha|>0$. Thus $x \in A_{\alpha}$ and $y \in B_{\alpha}$, whence

$$
\begin{aligned}
& \pi(\alpha \frown\langle x\rangle)=\langle e(\alpha), x,-\rangle, \\
& \pi(\alpha \frown\langle y\rangle)=\langle e(\alpha), y,+\rangle .
\end{aligned}
$$

Suppose first that $\bar{\alpha} \prec \alpha$. Then

$$
A_{\alpha}=[e(\alpha)]^{D} \backslash C(e(\bar{\alpha}), e(\alpha)) \text { while } B_{\alpha}=C(e(\bar{\alpha}), e(\alpha))
$$

Furthermore, $\pi(\alpha)=\langle e(\bar{\alpha}), e(\alpha),+\rangle$, while, by the definition of $\prec$ on $R$,

$$
\langle e(\alpha), x,-\rangle \prec\langle e(\bar{\alpha}), e(\alpha),+\rangle \prec\langle e(\alpha), y,+\rangle,
$$

in other words,

$$
\pi\left(\alpha^{\frown}\langle x\rangle\right) \prec \pi(\alpha) \prec \pi\left(\alpha^{\frown}\langle y\rangle\right) .
$$

Suppose now that $\alpha \prec \bar{\alpha}$. Then

$$
A_{\alpha}=C(e(\bar{\alpha}), e(\alpha)) \text { while } B_{\alpha}=[e(\alpha)]^{D} \backslash C(e(\bar{\alpha}), e(\alpha))
$$

Furthermore, $\pi(\alpha)=\langle e(\bar{\alpha}), e(\alpha),-\rangle$, while, by the definition of $\prec$ on $R$,

$$
\langle e(\alpha), x,-\rangle \prec\langle e(\bar{\alpha}), e(\alpha),-\rangle \prec\langle e(\alpha), y,+\rangle,
$$

in other words,

$$
\pi\left(\alpha^{\frown}\langle x\rangle\right) \prec \pi(\alpha) \prec \pi\left(\alpha^{\frown}\langle y\rangle\right),
$$

which completes the proof.
We observe the following immediate consequence of Lemma 7.4
Corollary 7.5. One can define a zero-preserving complete meet homomorphism $\pi^{*}: \mathbf{C o}(R) \rightarrow \mathbf{C o}(\Gamma)$ by the rule

$$
\pi^{*}(X)=\pi^{-1}[X], \text { for all } X \in \mathbf{C o}(R)
$$

We put $\psi=\pi^{*} \circ \varphi$, where $\varphi: L \hookrightarrow \mathbf{C o}(R)$ is the canonical map defined in Section 6 Hence $\psi$ is a zero-preserving meet homomorphism from $L$ into $\mathbf{C o}(\Gamma)$. For any $x \in L$, the value $\psi(x)$ is calculated by the same rule as $\varphi(x)$, see (6.4):

$$
\psi(x)=\{\alpha \in \Gamma \mid e(\alpha) \leq x\}
$$

Lemma 7.6. The map $\psi$ is a lattice embedding from $L$ into $\mathbf{C o}(\Gamma)$. Moreover, $\psi$ preserves the existing bounds.

Proof. The statement about preservation of bounds is obvious. We have already seen (and it is obvious) that $\psi$ is a meet homomorphism. Let $x, y \in L$ such that $x \not \leq y$. Since $L$ is finitely spatial, there exists $p \in J(L)$ such that $p \leq x$ and $p \not \leq y ;$ whence $\langle p\rangle \in \psi(x) \backslash \psi(y)$. Hence $\psi$ is a meet embedding from $L$ into $\mathbf{C o}(\Gamma)$.

Let $x, y \in L$, let $\alpha \in \psi(x \vee y)$, we prove that $\alpha \in \psi(x) \vee \psi(y)$. This is obvious if $\alpha \in \psi(x) \cup \psi(y)$, so suppose that $\alpha \notin \psi(x) \cup \psi(y)$. Hence $e(\alpha) \leq x \vee y$ while $e(\alpha) \not \leq x, y$, thus, by Lemma 3.2 there are minimal $u \leq x$ and $v \leq y$ such that $e(\alpha) \leq u \vee v$, and both $u$ and $v$ belong to $[e(\alpha)]^{D}$. Therefore, by Corollary 7.2 either $\alpha \frown\langle u\rangle \prec \alpha \prec \alpha \frown\langle v\rangle$ or $\alpha \frown\langle v\rangle \prec \alpha \prec \alpha \frown\langle u\rangle$. In both cases, since $\alpha \frown\langle u\rangle \in$ $\psi(x)$ and $\alpha \frown\langle v\rangle \in \psi(y)$, we obtain that $\alpha \in \psi(x) \vee \psi(y)$. Therefore, $\psi$ is a join homomorphism.

Now we can state the main embedding theorem of the present section.

Theorem 7.7. Let $L$ be a lattice. Then the following assertions are equivalent:
(i) there exists a poset $P$ such that $L$ embeds into $\mathbf{C o}(P)$;
(ii) L satisfies the identities (S), (U), and (B) (i.e., it belongs to the class SUB);
(iii) there exists a tree-like (see Section (2) poset $\Gamma$ such that $L$ has an embedding into $\mathbf{C o}(\Gamma)$ that preserves the existing bounds. Furthermore, if $L$ is finite without $D$-cycle, then $\Gamma$ is finite.
Proof. (i) $\Rightarrow$ (ii) has already been established, see Theorem 6.7
$($ ii $) \Rightarrow$ (iii) As in the proof of Theorem 6.7] we denote by Fil $L$ the lattice of all filters of $L$, ordered by reverse inclusion; if $L$ has no unit element, then we allow the empty set in Fil $L$, otherwise we require filters to be nonempty. We consider the poset $\Gamma$ constructed from Fil $L$ as in Section 7 By Lemma 7.6 $L$ embeds into $\mathbf{C o}(\Gamma)$. The finiteness statement of (iii) is obvious.
(iii) $\Rightarrow$ (i) is trivial.

Even in case $L=\mathbf{C o}(P)$, for a finite totally ordered set $P$, the poset $\Gamma$ constructed in Theorem 7.7 is not isomorphic to $P$ as a rule. As it is constructed from finite sequences of elements of $P$, it does not lend itself to easy graphic representation. However, many of its properties can be seen on the simpler poset represented on Figure 5, which is tree-like.

As we shall see in Sections 9 and 10 the assumption in Theorem 7.7(iii) that $L$ be without $D$-cycle cannot be removed.

## 8. Non-Preservation of atoms

The posets $R$ and $\Gamma$ that we constructed in Sections 6 and 7 are defined via sequences of join-irreducible elements of $L$. This is to be put in contrast with the main result of O. Frink [8] (see also [11]), that embeds any complemented modular lattice into a geometric lattice: namely, this construction preserves atoms. Hence the question of the necessity of the complication of the present paper, that is, using sequences of join-irreducible elements rather than just join-irreducible elements, is natural. In the present section we study two examples that show that this complication is, indeed, necessary.
Example 8.1. A finite, atomistic lattice in SUB without $D$-cycle that cannot be embedded atom-preservingly into any $\mathbf{C o}(T)$.
Proof. Let $P$ be the nine-element poset represented on the left hand side of Figure 1, together with order-convex subsets $P_{0}, P_{1}, P_{2}, Q_{0}, Q_{1}, Q_{2}$.

We let $\boldsymbol{K}$ be the set of all elements $X$ of $\mathbf{C o}(P)$ such that $p_{i} \in X \Leftrightarrow p_{i}^{\prime} \in X$, for all $i<3$. It is obvious that $\boldsymbol{K}$ is a meet-subsemilattice of $\mathbf{C o}(P)$ which contains $\{\varnothing, P\} \cup \Omega$, where $\Omega=\left\{P_{0}, P_{1}, P_{2}, Q_{0}, Q_{1}, Q_{2}\right\}$. We prove that $\boldsymbol{K}$ is a joinsubsemilattice of $\mathbf{C o}(P)$. Indeed, for all $i<3$, both $p_{i}$ and $p_{i}^{\prime}$ are either maximal or minimal in $P$, hence, for all $X, Y \in \mathbf{C o}(P), p_{i} \in X \vee Y$ iff $p_{i} \in X \cup Y$, and, similarly, $p_{i}^{\prime} \in X \vee Y$ iff $p_{i}^{\prime} \in X \cup Y$. Hence $X, Y \in \boldsymbol{K}$ implies that $X \vee Y \in \boldsymbol{K}$.

Therefore, $\boldsymbol{K}$ is a sublattice of $\mathbf{C o}(P)$. It follows immediately that the atoms of $\boldsymbol{K}$ are the elements of $\Omega$, that $\boldsymbol{K}$ is atomistic, and the atoms of $\boldsymbol{K}$ satisfy the following relations (see the right half of Figure 1):

$$
\begin{array}{lll}
Q_{0} \leq P_{1} \vee P_{2} ; & Q_{1} \leq P_{0} \vee P_{2} ; & Q_{2} \leq P_{0} \vee P_{1} ; \\
P_{0} \not \leq P_{1} \vee P_{2} ; & P_{1} \not \leq P_{0} \vee P_{2} ; & P_{2} \not \leq P_{0} \vee P_{1} .
\end{array}
$$



Figure 1. The poset $P$ and the geometry of $\boldsymbol{K}$.

Hence, the sequence $P_{0} P_{1} P_{2} P_{0} P_{1}$ is a zigzag of length 5 (in the sense of 3]). It follows from this and the easy direction of the main theorem of [3] that $\boldsymbol{K}$ cannot be embedded atom-preservingly into any $\mathbf{C o}(T)$.

By contrast, our second example is subdirectly irreducible, but it has $D$-cycles. We shall see in a subsequent paper [15] that the latter condition is unavoidable, that is, any finite, subdirectly irreducible atomistic lattice without $D$-cycle that can be embedded into some $\mathbf{C o}(P)$ can be embedded atom-preservingly into some finite $\mathbf{C o}(P)$ without $D$-cycle.
Example 8.2. A finite, atomistic, subdirectly irreducible lattice in SUB that cannot be embedded into $\mathbf{C o}(T)$, for any poset $T$, in an atom-preserving way.
Proof. Let $Q$ be the 12-element poset represented on the left hand side of Figure 2, together with order-convex subsets $A, B, C, A^{\prime}, B^{\prime}, C^{\prime}$.


Figure 2. The poset $Q$ and the geometry of $\boldsymbol{L}$.

We let $\sigma$ be the anti-automorphism of $Q$ defined by $\sigma\left(a_{i}\right)=a_{1-i}, \sigma\left(a_{i}^{\prime}\right)=a_{1-i}^{\prime}$, $\sigma\left(b_{i}\right)=b_{1-i}, \sigma\left(b_{i}^{\prime}\right)=b_{1-i}^{\prime}, \sigma\left(c_{i}\right)=c_{1-i}, \sigma\left(c_{i}^{\prime}\right)=c_{1-i}^{\prime}$, for all $i<2$, and we let $\boldsymbol{L}$ be the set of all elements $X$ of $\mathbf{C o}(Q)$ such that $\sigma X=X$. It is obvious that $\boldsymbol{L}$ is a meetsubsemilattice of $\mathbf{C o}(Q)$ which contains $\{\varnothing, Q\} \cup \Omega$, where $\Omega=\left\{A, B, C, A^{\prime}, B^{\prime}, C^{\prime}\right\}$. We prove that $\boldsymbol{L}$ is a join-subsemilattice of $\mathbf{C o}(Q)$. Let $X, Y \in \boldsymbol{L}$, we prove that $X \vee Y \in \boldsymbol{L}$.

Since both $a_{0}^{\prime}$ and $a_{1}^{\prime}$ are either maximal or minimal in $Q$, the equivalence $a_{i}^{\prime} \in$ $X \vee Y \Leftrightarrow a_{i}^{\prime} \in X \cup Y$ holds, for all $i<2$, whence $a_{0}^{\prime} \in X \vee Y \Leftrightarrow a_{1}^{\prime} \in X \vee Y$. Similarly, $b_{0}^{\prime} \in X \vee Y \Leftrightarrow b_{1}^{\prime} \in X \vee Y$ and $c_{0}^{\prime} \in X \vee Y \Leftrightarrow c_{1}^{\prime} \in X \vee Y$.

Suppose now that $a_{0} \in X \vee Y$, we prove that $a_{1} \in X \vee Y$. If $a_{0} \in X \cup Y$ this is obvious, so suppose that $a_{0} \notin X \cup Y$. Without loss of generality, there are $x \in X$ and $y \in Y$ such that $x \triangleleft a_{0} \triangleleft y$, whence $x \in\left\{b_{1}^{\prime}, b_{1}, c_{1}^{\prime}, c_{1}\right\}$ and $y=a_{0}^{\prime}$. From $Y \in \boldsymbol{L}$ it follows that $a_{1}^{\prime} \in Y$, thus $A^{\prime} \subseteq Y$. Similarly, from $X \in \boldsymbol{L}$ it follows that either $B \subseteq X$ or $C \subseteq X$ or $B^{\prime} \subseteq X$ or $C^{\prime} \subseteq X$. If $B \subseteq X$, then $b_{0} \in X$, thus, since $a_{1}^{\prime} \triangleleft a_{1} \triangleleft b_{0}$ and $a_{1}^{\prime} \in Y$, we obtain that $a_{1} \in X \vee Y$. If $B^{\prime} \subseteq X$, then $b_{0}^{\prime} \in X$, thus, since $a_{1}^{\prime} \triangleleft a_{1} \triangleleft b_{0}^{\prime}$ and $a_{1}^{\prime} \in Y$, we obtain again that $a_{1} \in X \vee Y$. Similar results hold for either $C \subseteq X$ or $C^{\prime} \subseteq X$. Therefore, $a_{0} \in X \vee Y$ implies that $a_{1} \in X \vee Y$. By symmetry, we obtain the converse. Similarly, $b_{0} \in X \vee Y \Leftrightarrow b_{1} \in X \vee Y$ and $c_{0} \in X \vee Y \Leftrightarrow c_{1} \in X \vee Y$. Therefore, $X \vee Y$ belongs to $L$, which completes the proof that $\boldsymbol{L}$ is a sublattice of $\mathbf{C o}(Q)$.

It follows immediately that the atoms of $\boldsymbol{L}$ are the elements of $\Omega$, that $\boldsymbol{L}$ is atomistic, and the atoms of $\boldsymbol{L}$ satisfy the following relations:

$$
\begin{array}{lll}
A, B \leq A^{\prime} \vee B^{\prime} ; & A \leq A^{\prime} \vee B ; & B \leq A \vee B^{\prime} \\
B, C \leq B^{\prime} \vee C^{\prime} ; & B \leq B^{\prime} \vee C ; & C \leq B \vee C^{\prime} \\
A, C \leq A^{\prime} \vee C^{\prime} ; & A \leq A^{\prime} \vee C ; & C \leq A \vee C^{\prime}
\end{array}
$$

Hence, $\boldsymbol{L}$ is subdirectly irreducible, with monolith (i.e., smallest nonzero congruence) the smallest congruence $\Theta(\varnothing, A)$ identifying $\varnothing$ and $A$, also equal to $\Theta(\varnothing, B)$ and to $\Theta(\varnothing, C)$. Furthermore, the sequence $A^{\prime} B^{\prime} C^{\prime} A^{\prime} B^{\prime}$ is a zigzag of length 5 (in the sense of [3]). It follows from this and the easy direction of the main theorem of [3] that $\boldsymbol{L}$ cannot be embedded atom-preservingly into any $\mathbf{C o}(T)$.

## 9. Crowns in posets

We first recall the following classical definition.
Definition 9.1. For an integer $n \geq 2$, we denote by $\mathbb{Z} / n \mathbb{Z}$ the set of integers modulo $n$. The $n$-crown $C_{n}$ is the poset with underlying set $(\mathbb{Z} / n \mathbb{Z}) \times\{0,1\}$ and ordering defined by $(i, 0),(i+1,0)<(i, 1)$, for all $i \in \mathbb{Z} / n \mathbb{Z}$.

The crown $C_{n}$ is illustrated on Figure 3.
We shall mostly deal with sub-crowns of posets.
Definition 9.2. For $n \geq 2$ and a poset $(T, \unlhd)$, a $n$-crown of $T$ is a finite sequence $\left\langle\left\langle a_{i}, b_{i}\right\rangle \mid i \in \mathbb{Z} / n \mathbb{Z}\right\rangle$ of elements of $T \times T$ such that there exists an order-embedding $f: C_{n} \hookrightarrow T$ with $f(i, 0)=a_{i}$ and $f(i, 1)=b_{i}$, for all $i \in \mathbb{Z} / n \mathbb{Z}$.

We shall sometimes identify an integer modulo $n$ with its unique representative in $\{0,1, \ldots, n-1\}$ and a $n$-crown $\left\langle\left\langle a_{i}, b_{i}\right\rangle \mid i \in \mathbb{Z} / n \mathbb{Z}\right\rangle$ with the finite sequence

$$
\left\langle\left\langle a_{0}, b_{0}\right\rangle,\left\langle a_{1}, b_{1}\right\rangle, \ldots,\left\langle a_{n-1}, b_{n-1}\right\rangle\right\rangle .
$$

The following lemma makes it possible to identify crowns within posets.


Figure 3. The crown $C_{n}$.

Lemma 9.3. Let $(T, \unlhd)$ be a poset, let $n \geq 3$, and let $a_{i}, b_{i}(i \in \mathbb{Z} / n \mathbb{Z})$ be elements of $T$. Then the following are equivalent:
(i) $\left\langle\left\langle a_{i}, b_{i}\right\rangle \mid i \in \mathbb{Z} / n \mathbb{Z}\right\rangle$ is a n-crown.
(ii) $a_{i} \unlhd b_{j}$ iff $i \in\{j, j+1\}$, for all $i, j \in \mathbb{Z} / n \mathbb{Z}$.

Proof. (i) $\Rightarrow$ (ii) is trivial. Conversely, suppose (ii) satisfied, we prove that $f: C_{n} \hookrightarrow T$ defined by $f(i, 0)=a_{i}$ and $f(i, 1)=b_{i}$, for all $i \in \mathbb{Z} / n \mathbb{Z}$, is an order-embedding. We need to prove the following assertions:
(i) $a_{i} \unlhd a_{j}$ implies that $i=j$, for all $i, j \in \mathbb{Z} / n \mathbb{Z}$. Indeed, if $a_{i} \unlhd a_{j}$, then $a_{i} \unlhd b_{j}, b_{j-1}$ (because $a_{j} \unlhd b_{j}, b_{j-1}$ ), thus, by assumption, $i \in\{j, j+1\} \cap$ $\{j, j-1\}=\{j\}$ (we use here the inequality $n \geq 3$ ), that is, $i=j$.
(ii) $b_{i} \unlhd b_{j}$ implies that $i=j$, for all $i, j \in \mathbb{Z} / n \mathbb{Z}$. The proof is similar to the one of (i).
(iii) $b_{j} \unlhd a_{i}$ occurs for no $i, j \in \mathbb{Z} / n \mathbb{Z}$. Indeed, suppose that $b_{j} \unlhd a_{i}$. Then $b_{j} \unlhd$ $b_{i}, b_{i-1}$ (because $a_{i} \unlhd b_{i}, b_{i-1}$ ), thus, by (ii), $j=i=i-1$, a contradiction.
This concludes the proof.
Definition 9.4. A poset $T$ is crown-free, if it has no $n$-crown for any $n \geq 3$.
Strictly speaking, the 2-crown $C_{2}$ is crown-free since we are requiring $n \geq 3$ in the definition above. The motivation why we are putting this slight restriction on $n$ lies in the following observation. First, the poset of Figure 4(i) is tree-like, but it contains the 2 -crown represented on Figure 4(ii); observe also that the $n$-crown, for any $n \geq 2$, is never tree-like.

On the other hand, we shall now prove the following result.
Proposition 9.5. Every tree-like poset is crown-free.
As witnessed by the square $\mathbf{2}^{2}$, the converse of Proposition 9.5 does not hold.


Figure 4. A tree-like poset which contains the crown $C_{2}$.
Proof. Let $(T, \unlhd)$ be a tree-like poset. For $x, y \in T$, we denote by $d(x, y)$ the length of the unique path from $x$ to $y$ if there is such a path, $\infty$ otherwise. Observe that $x \unlhd y$ implies that $d(x, y)<\infty$ (but the converse does not hold as a rule), and then the unique path from $x$ to $y$ is oriented (see Section [2).

For a $n$-crown $\gamma=\left\langle\left\langle a_{i}, b_{i}\right\rangle \mid i \in \mathbb{Z} / n \mathbb{Z}\right\rangle$ in $T$, we put

$$
\ell(\gamma)=\sum_{i \in \mathbb{Z} / n \mathbb{Z}} d\left(a_{i}, b_{i}\right) .
$$

Suppose that $T$ has a $n$-crown, for some integer $n \geq 3$. We pick such a crown $\gamma=\left\langle\left\langle a_{i}, b_{i}\right\rangle \mid i \in \mathbb{Z} / n \mathbb{Z}\right\rangle$ with $\ell(\gamma)$ minimum. For all $i \in \mathbb{Z} / n \mathbb{Z}$, we let

$$
\begin{gathered}
a_{i}=x_{i, 0} \prec x_{i, 1} \prec \cdots \prec x_{i, p_{i}}=b_{i}, \\
a_{i+1}=y_{i, 0} \prec y_{i, 1} \prec \cdots \prec y_{i, q_{i}}=b_{i}
\end{gathered}
$$

be the paths from $a_{i}$ (resp., $a_{i+1}$ ) to $b_{i}$, where $\prec$ denotes the predecessor relation of $T$.
Claim 1. $\left\{x_{i, p} \mid 0 \leq p<p_{i}\right\} \cap\left\{y_{i, q} \mid 0 \leq q<q_{i}\right\}=\varnothing$, for all $i \in \mathbb{Z} / n \mathbb{Z}$.
Proof of Claim. Suppose, to the contrary, that $x_{i, p}=y_{i, q}$ for some $p \in\left\{0, \ldots, p_{i}-1\right\}$ and $q \in\left\{0, \ldots, q_{i}-1\right\}$. We put $b_{j}^{\prime}=b_{j}$, for all $j \neq i$ in $\mathbb{Z} / n \mathbb{Z}$, while $b_{i}^{\prime}=x_{i, p}$. Since $a_{i}, a_{i+1} \unlhd b_{i}^{\prime}$, the condition $k \in\{l, l+1\}$ implies that $a_{k} \unlhd b_{l}^{\prime}$, for all $k, l \in \mathbb{Z} / n \mathbb{Z}$. Conversely, let $k, l \in \mathbb{Z} / n \mathbb{Z}$ such that $a_{k} \unlhd b_{l}^{\prime}$. From $b_{l}^{\prime} \unlhd b_{l}$ it follows that $a_{k} \unlhd b_{l}$, whence $k \in\{l, l+1\}$. By Lemma 9.3 the family $\gamma^{\prime}=\left\langle\left\langle a_{k}, b_{k}^{\prime}\right\rangle \mid k \in \mathbb{Z} / n \mathbb{Z}\right\rangle$ is a $n$-crown. However,

$$
\ell\left(\gamma^{\prime}\right) \leq \ell(\gamma)-\left(p_{i}-p\right)<\ell(\gamma),
$$

which contradicts the minimality of $\ell(\gamma)$.
The proof of the following claim is symmetric.
Claim 2. $\left\{y_{i, q} \mid 0<q \leq q_{i}\right\} \cap\left\{x_{i+1, p} \mid 0<p \leq p_{i+1}\right\}=\varnothing$, for all $i \in \mathbb{Z} / n \mathbb{Z}$.
We define a walk of $T$ to be a finite sequence $\mathbf{c}=\left\langle c_{0}, c_{1}, \cdots, c_{m}\right\rangle$ of elements of $T$ such that either $c_{i} \prec c_{i+1}$ or $c_{i+1} \prec c_{i}$, for all $i<m$, we say then that $\mathbf{c}$ is a walk from $c_{0}$ to $c_{m}$. Hence, a nonempty path of $T$ is a walk with all distinct entries.

Now we let $\mathbf{d}$ be the finite sequence defined by

$$
\begin{aligned}
& \mathbf{d}=\left\langle x_{0, k} \mid 0 \leq k \leq p_{0}\right\rangle \frown\left\langle y_{0, q_{0}-l} \mid 0<l<q_{0}\right\rangle \frown\left\langle x_{1, k} \mid 0 \leq k \leq p_{1}\right\rangle \frown \ldots \\
& \cdots \frown\left\langle x_{n-1, k} \mid 0 \leq k \leq p_{n-1}\right\rangle .
\end{aligned}
$$

It is obvious that $\mathbf{d}$ is a walk from $x_{0,0}=a_{0}$ to $x_{n-1, p_{n-1}}=b_{n-1}$. We shall now prove that $\mathbf{d}$ is a path.

Suppose, indeed, that dis not a path. Then one of the following cases occurs.

Case 1. There are distinct $i, j \in \mathbb{Z} / n \mathbb{Z}$, together with $k \in\left\{0, \ldots, p_{i}\right\}$ and $l \in$ $\left\{0, \ldots, p_{j}\right\}$, such that $x_{i, k}=x_{j, l}$. Then $a_{i} \unlhd x_{i, k}=x_{j, l} \unlhd b_{j}$, thus $i \in\{j, j+1\}$, while $a_{j} \unlhd x_{j, l}=x_{i, k} \unlhd b_{i}$, thus $j \in\{i, i+1\}$. Since $n \geq 3$, we obtain that $i=j$, a contradiction.
Case 2. There are distinct $i, j \in(\mathbb{Z} / n \mathbb{Z}) \backslash\{n-1\}$, together with $k \in\left\{1, \ldots, q_{i}-1\right\}$ and $l \in\left\{1, \ldots, q_{j}-1\right\}$, such that $y_{i, k}=y_{j, l}$. Then $a_{i+1} \unlhd y_{i, k}=y_{j, l} \unlhd b_{j}$, thus $i \in\{j, j-1\}$, while $a_{j+1} \unlhd y_{j, l}=y_{i, k} \unlhd b_{i}$, thus $j \in\{i, i-1\}$, whence, since $n \geq 3, i=j$, a contradiction.
Case 3. There are $i \in \mathbb{Z} / n \mathbb{Z}$ and $j \in(\mathbb{Z} / n \mathbb{Z}) \backslash\{n-1\}$, together with $k \in\left\{0, \ldots, p_{i}\right\}$ and $l \in\left\{1, \ldots, q_{j}-1\right\}$, such that $x_{i, k}=y_{j, l}$. Then from Claim it follows that $i \neq j$, while from Claim 2 it follows that $i \neq j+1$. On the other hand, $a_{i} \unlhd x_{i, k}=y_{j, l} \unlhd b_{j}$, thus $i \in\{j, j+1\}$, a contradiction.
Therefore, we have proved that $\mathbf{d}$ is, indeed, a path from $a_{0}$ to $b_{n-1}$. However, the finite sequence

$$
\mathbf{d}^{\prime}=\left\langle y_{n-1, l} \mid 0 \leq l \leq q_{n-1}\right\rangle
$$

is a path from $y_{n-1,0}=a_{n}=a_{0}$ (the indices are modulo $n$ ) to $y_{n-1, q_{n-1}}=b_{n-1}$, thus, by the uniqueness of the path from $a_{0}$ to $b_{n-1}, \mathbf{d}=\mathbf{d}^{\prime}$. Thus every entry $x$ of $\mathbf{d}$ satisfies that $x \unlhd b_{n-1}$, in particular, $b_{0}=x_{0, p_{0}} \unlhd b_{n-1}$, a contradiction since $n \neq 1$.

## 10. A quasi-IDEntity for $\mathbf{C o}(T)$, for finite and crown-free $T$

Let $(\theta)$ be the following lattice-theoretical quasi-identity:

$$
\begin{aligned}
& {\left[a \leq\left(a^{\prime} \vee b\right) \wedge\left(a^{\prime} \vee c\right) \& b \leq\left(b^{\prime} \vee a\right) \wedge\left(b^{\prime} \vee c\right) \& c \leq\left(c^{\prime} \vee a\right) \wedge\left(c^{\prime} \vee b\right) \&\right.} \\
& \left.\quad \&\left(a^{\prime} \wedge a\right) \vee\left(b^{\prime} \wedge b\right) \vee\left(c^{\prime} \wedge c\right) \vee(a \wedge b) \vee(a \wedge c) \vee(b \wedge c) \leq a^{\prime} \wedge b^{\prime} \wedge c^{\prime}\right] \\
& \Longrightarrow a \leq a^{\prime}
\end{aligned}
$$

It is inspired by Example 8.2 (see Corollary 10.6). The main result of Section 10 is the following.

Theorem 10.1. Let $(T, \unlhd)$ be a finite crown-free poset. Then $\mathbf{C o}(T)$ satisfies $(\theta)$.
Let us begin with an arbitrary (not necessarily finite, not necessarily crown-free) poset $(T, \unlhd)$ and convex subsets $A, B, C, A^{\prime}, B^{\prime}, C^{\prime}$ of $T$ that satisfy the premise of $(\theta)$, that is,

$$
\begin{aligned}
& A \subseteq A^{\prime} \vee B ; \quad A \subseteq A^{\prime} \vee C ; \\
& B \subseteq B^{\prime} \vee A ; \quad B \subseteq B^{\prime} \vee C ; \\
& C \subseteq C^{\prime} \vee A ; \quad C \subseteq C^{\prime} \vee B ; \\
& A \cap A^{\prime} \subseteq B^{\prime} \cap C^{\prime} ; \quad B \cap B^{\prime} \subseteq A^{\prime} \cap C^{\prime} ; \quad C \cap C^{\prime} \subseteq A^{\prime} \cap B^{\prime} ; \\
& A \cap B \subseteq A^{\prime} \cap B^{\prime} ; \quad B \cap C \subseteq B^{\prime} \cap C^{\prime} ; \quad A \cap C \subseteq A^{\prime} \cap C^{\prime} .
\end{aligned}
$$

We shall put $\widehat{A}=A \backslash A^{\prime}, \widehat{B}=B \backslash B^{\prime}$, and $\widehat{C}=C \backslash C^{\prime}$. Observe that

$$
\begin{gathered}
\widehat{A} \cap(B \cup C)=\widehat{B} \cap(A \cup C)=\widehat{C} \cap(A \cup B)=\varnothing \\
\widehat{A} \cap \widehat{B}=\widehat{A} \cap \widehat{C}=\widehat{B} \cap \widehat{C}=\varnothing
\end{gathered}
$$

We shall later perform a construction whose key argument is provided by the following lemma.

Lemma 10.2. Let $a \in \widehat{A}$ and let $a^{\prime} \in A^{\prime}$ with $a \triangleleft a^{\prime}$. Then there exists $\left\langle b, b^{\prime}\right\rangle \in$ $\widehat{B} \times B^{\prime}$ such that $b^{\prime} \triangleleft b \triangleleft a$.

Proof. Observe first that $a \in A \subseteq A^{\prime} \vee B$. Since $a \notin A^{\prime} \cup B$, there exists $\left(\bar{a}^{\prime}, b\right) \in$ $A^{\prime} \times B$ such that either $\bar{a}^{\prime} \triangleleft a \triangleleft b$ or $b \triangleleft a \triangleleft \bar{a}^{\prime}$. In the first case, $\bar{a}^{\prime} \triangleleft a \triangleleft a^{\prime}$, thus, by the convexity of $A^{\prime}, a \in A^{\prime}$, a contradiction; whence $b \triangleleft a$. If $b \in B^{\prime}$, then $b \in B \cap B^{\prime} \subseteq A^{\prime}$, but $b \triangleleft a \triangleleft a^{\prime}$, thus $a \in A^{\prime}$, a contradiction; whence $b \in \widehat{B}$. If there exists $x \in A$ with $x \unlhd b$, then, since $b \triangleleft a$, we obtain that $b \in A \cap B \subseteq A^{\prime}$, a contradiction again. But $b \in B \subseteq A \vee B^{\prime}$ and $b \notin B^{\prime}$, thus there exists $b^{\prime} \in B^{\prime}$ such that $b^{\prime} \triangleleft b$.

In particular, we observe the following corollary.
Corollary 10.3. The sets $\widehat{A}, \widehat{B}$, and $\widehat{C}$ are either simultaneously empty or simultaneously nonempty.

Proof. If $\widehat{A}$ is nonempty, we pick $a \in \widehat{A}$. So $a \in A^{\prime} \vee B$ while $a \notin A^{\prime} \cup B$, thus there is $\left(a^{\prime}, b\right) \in A^{\prime} \times B$ such that either $b \triangleleft a \triangleleft a^{\prime}$ or $a^{\prime} \triangleleft a \triangleleft b$. In the first case, we apply Lemma 10.2 to deduce that $\widehat{B} \neq \varnothing$. In the second case, we apply the dual of Lemma 10.2 to reach the same conclusion.

Now we suppose that $\widehat{A}$ is nonempty, and we pick $a_{0} \in \widehat{A}$. As in the proof of Corollary 10.3 there exists $a_{0}^{\prime} \in A^{\prime}$ such that either $a_{0} \triangleleft a_{0}^{\prime}$ or $a_{0}^{\prime} \triangleleft a_{0}$; by replacing $\unlhd$ with its dual if needed, we may assume without loss of generality that $a_{0} \triangleleft a_{0}^{\prime}$.

By Lemma 10.2 there are $\left\langle b_{0}, b_{0}^{\prime}\right\rangle \in \widehat{B} \times B^{\prime}$ and $\left\langle c_{1}, c_{1}^{\prime}\right\rangle \in \widehat{C} \times C^{\prime}$ such that $b_{0}^{\prime} \triangleleft b_{0} \triangleleft a_{0}$ and $c_{1}^{\prime} \triangleleft c_{1} \triangleleft a_{0}$. By applying the dual of Lemma 10.2 to $c_{1}^{\prime} \triangleleft c_{1}$, we obtain $\left\langle b_{1}, b_{1}^{\prime}\right\rangle \in \widehat{B} \times B^{\prime}$ such that $c_{1} \triangleleft b_{1} \triangleleft b_{1}^{\prime}$. By applying Lemma 10.2 to $b_{1} \triangleleft b_{1}^{\prime}$, we obtain $\left\langle a_{2}, a_{2}^{\prime}\right\rangle \in \widehat{A} \times A^{\prime}$ such that $a_{2}^{\prime} \triangleleft a_{2} \triangleleft b_{1}$. By applying in the same fashion Lemma 10.2 and its dual, we obtain $\left\langle c_{2}, c_{2}^{\prime}\right\rangle \in \widehat{C} \times C^{\prime},\left\langle b_{3}, b_{3}^{\prime}\right\rangle \in \widehat{B} \times B^{\prime}$, and $\left\langle a_{3}, a_{3}^{\prime}\right\rangle \in \widehat{A} \times A^{\prime}$ such that $a_{2} \triangleleft c_{2} \triangleleft c_{2}^{\prime}, b_{3}^{\prime} \triangleleft b_{3} \triangleleft c_{2}$, and $b_{3} \triangleleft a_{3} \triangleleft a_{3}^{\prime}$.

Now we observe that $b_{0}^{\prime} \triangleleft b_{0} \triangleleft a_{0} \triangleleft a_{0}^{\prime}$ and $b_{3}^{\prime} \triangleleft b_{3} \triangleleft a_{3} \triangleleft a_{3}^{\prime}$, that is, we can start the process again. Arguing by induction, we obtain elements $\left\langle a_{i}, a_{i}^{\prime}\right\rangle \in \widehat{A} \times A^{\prime}$ for $i \not \equiv 1(\bmod 3)$, elements $\left\langle b_{i}, b_{i}^{\prime}\right\rangle \in \widehat{B} \times B^{\prime}$ for $i \not \equiv 2(\bmod 3)$, and elements $\left\langle c_{i}, c_{i}^{\prime}\right\rangle \in \widehat{C} \times C^{\prime}$ for $i \not \equiv 0(\bmod 3)$ such that the following relations hold, for all $i<\omega$ :

$$
\begin{gather*}
b_{3 i}^{\prime} \triangleleft b_{3 i} \triangleleft a_{3 i} \triangleleft a_{3 i}^{\prime} ;  \tag{10.1}\\
c_{3 i+1}^{\prime} \triangleleft c_{3 i+1} \triangleleft b_{3 i+1} \triangleleft b_{3 i+1}^{\prime} ;  \tag{10.2}\\
a_{3 i+2}^{\prime} \triangleleft a_{3 i+2} \triangleleft c_{3 i+2} \triangleleft c_{3 i+2}^{\prime} . \tag{10.3}
\end{gather*}
$$

This can be illustrated by Figure 5.
Now we define subsets of $T$ as follows:

$$
\begin{aligned}
\Omega^{+} & =\left\{a_{3 i} \mid i<\omega\right\} \cup\left\{b_{3 i+1} \mid i<\omega\right\} \cup\left\{c_{3 i+2} \mid i<\omega\right\} ; \\
\Omega^{-} & =\left\{a_{3 i+2} \mid i<\omega\right\} \cup\left\{b_{3 i} \mid i<\omega\right\} \cup\left\{c_{3 i+1} \mid i<\omega\right\} ; \\
\Omega & =\Omega^{+} \cup \Omega^{-} .
\end{aligned}
$$



Figure 5. A pattern in $T$.
Since $\widehat{A}, \widehat{B}$, and $\widehat{C}$ are mutually disjoint and their union contains $\Omega$, we can define a map $\chi: \Omega \rightarrow 3$ by the rule

$$
\chi(x)=\left\{\begin{array}{ll}
0 & (x \in \widehat{A}), \\
1 & (x \in \widehat{B}), \\
2 & (x \in \widehat{C}),
\end{array} \quad \text { for all } x \in \Omega\right.
$$

Lemma 10.4. For all $\langle x, y\rangle \in \Omega^{-} \times \Omega^{+}, \chi(x)=\chi(y)$ implies that $x \notin y$. In particular, $\Omega^{-} \cap \Omega^{+}=\varnothing$.

Proof. We need to prove that for all natural numbers $i$ and $j$, the following inequalities hold:

- $a_{3 i+2} \nsubseteq a_{3 j}$. Otherwise, by (10.1) and (10.3), $a_{3 i+2}^{\prime} \triangleleft a_{3 i+2} \triangleleft a_{3 j}^{\prime}$, thus $a_{3 i+2} \in A^{\prime}$, a contradiction.
- $b_{3 i} \nsubseteq b_{3 j+1}$. Otherwise, by (10.1) and (10.2), $b_{3 i}^{\prime} \triangleleft b_{3 i} \triangleleft b_{3 j+1}^{\prime}$, thus $b_{3 i} \in B^{\prime}$, a contradiction.
- $c_{3 i+1} \not \ddagger c_{3 j+2}$. Otherwise, by (10.2) and (10.3), $c_{3 i+1}^{\prime} \triangleleft c_{3 i+1} \triangleleft c_{3 j+2}^{\prime}$, thus $c_{3 i+1} \in C^{\prime}$, a contradiction.
This concludes the proof.
For an integer $m \geq 2$, we define a $m$-pre-crown to be a finite sequence $\left\langle\left\langle x_{i}, y_{i}\right\rangle\right|$ $i \in \mathbb{Z} / m \mathbb{Z}\rangle$ of elements of $\Omega^{-} \times \Omega^{+}$such that the following conditions hold, for all $i \in \mathbb{Z} / m \mathbb{Z}$ :
(C1) $x_{i}, x_{i+1} \triangleleft y_{i}$;
(C2) $\chi\left(x_{i}\right) \neq \chi\left(x_{i+1}\right)$ and $\chi\left(y_{i}\right) \neq \chi\left(y_{i+1}\right)$ if $i \neq m-1$.
If $m=2$, then, by (C1), $x_{0}, x_{1} \triangleleft y_{0}, y_{1}$. Furthermore, by (C2), $\chi\left(x_{0}\right) \neq \chi\left(x_{1}\right)$, thus it follows from $x_{0}, x_{1} \triangleleft y_{0}$ and Lemma 10.4 that $\chi\left(y_{0}\right)$ is the unique element of $3 \backslash\left\{\chi\left(x_{0}\right), \chi\left(x_{1}\right)\right\}$. The same holds for $\chi\left(y_{1}\right)$, whence $\chi\left(y_{0}\right)=\chi\left(y_{1}\right)$, which contradicts (C2). Therefore, if there exists a $m$-pre-crown, then $m \geq 3$.

We can now prove the main lemma of this section.
Lemma 10.5. Suppose that $T$ is crown-free. Then there are no pre-crowns in $T$.
Proof. Otherwise, let $m$ be the least positive integer such that there exists a $m$-precrown, and let $\mathbf{c}=\left\langle\left\langle x_{i}, y_{i}\right\rangle \mid i \in \mathbb{Z} / m \mathbb{Z}\right\rangle$ be such a pre-crown. As observed before, $m \geq 3$. By assumption on $T$, in order to get a contradiction, it suffices to prove that $\mathbf{c}$ is a crown of $T$. By (C1) and Lemma 9.3 it suffices to prove that for all $i$, $j \in \mathbb{Z} / m \mathbb{Z}$ such that $i \notin\{j, j+1\}$, the inequality $x_{i} \unlhd y_{j}$ does not hold. Suppose otherwise; by Lemma $10.4 x_{i} \triangleleft y_{j}$. Two cases can occur.

Case 1. $i<j$. Then the finite sequence

$$
\left\langle\left\langle x_{i}, y_{i}\right\rangle,\left\langle x_{i+1}, y_{i+1}\right\rangle, \ldots,\left\langle x_{j}, y_{j}\right\rangle\right\rangle
$$

is a $(j-i+1)$-pre-crown (see Figure $6(\mathrm{i})$ ), with $1 \leq j-i \leq m-1$. By the minimality assumption on $m$, this cannot happen unless $i=0$ and $j=m-1$, in which case $i=j+1$ (modulo $m$ as usual), a contradiction.

Case 2. $j<i$. Then the finite sequence

$$
\left\langle\left\langle x_{i}, y_{i-1}\right\rangle, \ldots,\left\langle x_{j+2}, y_{j+1}\right\rangle,\left\langle x_{j+1}, y_{j}\right\rangle\right\rangle
$$

is a $(i-j)$-pre-crown (see Figure $6(\mathrm{ii})$ ), with $2 \leq i-j<m$, which contradicts again the minimality of $m$.
Hence $\mathbf{c}$ is a $m$-crown of $T$, a contradiction.
Now we have all the necessary tools to conclude the proof of Theorem 10.1
Proof of Theorem 10.1. Suppose that $T$ is finite and crown-free. There are $i<j$ such that $b_{3 i}=b_{3 j}$. Then the finite sequence

$$
\left\langle\left\langle b_{3 i}, a_{3 i}\right\rangle,\left\langle c_{3 i+1}, b_{3 i+1}\right\rangle, \ldots,\left\langle a_{3 j-1}, c_{3 j-1}\right\rangle\right\rangle
$$

is a $(3 j-3 i)$-pre-crown in $T$ (see Figure 7 ), a contradiction.


Figure 7. A pre-crown in $T$.
Hence we have proved that $\widehat{A}=\varnothing$, that is, $A \subseteq A^{\prime}$. Therefore, $\mathbf{C o}(T)$ satisfies $(\theta)$.

Corollary 10.6. Let $Q$ be the finite poset and $\boldsymbol{L}$ the finite lattice of Example 8.2 , Then, although $\boldsymbol{L}$ embeds into $\mathbf{C o}(Q)$, there is no finite, tree-like poset $R$ such that $\boldsymbol{L}$ embeds into $\mathbf{C o}(R)$.

Proof. It follows from Proposition 9.5 that $R$ is crown-free, thus, by Theorem 10.1 $\mathbf{C o}(R)$ satisfies $(\theta)$. On the other hand, the lattice $\boldsymbol{L}$ of Example 8.2 does not satisfy $(\theta)$ (consider the atoms $A, B, C, A^{\prime}, B^{\prime}, C^{\prime}$ of $\boldsymbol{L}$ ), therefore it cannot be embedded into $\mathbf{C o}(R)$.

On the other hand, it follows from Theorem 7.7(iii) that if a finite lattice $L$ without $D$-cycle embeds into some $\mathbf{C o}(P)$, then it embeds into $\mathbf{C o}(R)$ for some finite, tree-like poset $R$. In the presence of $D$-cycles anything can happen, for example, take $L=\mathbf{C o}(4)$, the lattice of all order-convex subsets of a four-element chain; it embeds into $\mathbf{C o}(4)$ for the finite, tree-like poset 4 , however it has $D$-cycles.

## 11. Finite generation and word problem in SUB

For a lattice term $\mathbf{s}\left(\mathrm{x}_{1}, \ldots, \mathrm{x}_{n}\right)$, a poset $P$, and convex subsets $X_{1}, \ldots, X_{n}$ of $P$, we denote by $\mathbf{s}^{P}\left(X_{1}, \ldots, X_{n}\right)$ the evaluation of the term $\mathbf{s}\left(\mathrm{x}_{1}, \ldots, \mathrm{x}_{n}\right)$ at $\left\langle X_{1}, \ldots, X_{n}\right\rangle$ in the lattice $\mathbf{C o}(P)$.

The present section rests on the following lemma. Its proof is an easy induction argument on the length of $\mathbf{s}$, that we leave to the reader.

Lemma 11.1. Let $n$ be a positive integer, let $\mathbf{s}\left(\mathrm{x}_{1}, \ldots, \mathrm{x}_{n}\right)$ be a lattice term, and let $X_{1}, \ldots, X_{n}$ be convex subsets of a poset $P$. Then $\mathbf{s}^{P}\left(X_{1}, \ldots, X_{n}\right)$ is the directed union of all subsets of the form $\mathbf{s}^{Q}\left(X_{1} \cap Q, \ldots, X_{n} \cap Q\right)$, for $Q \subseteq P$ finite.

As immediate corollaries, we get the following.
Corollary 11.2. Let $P$ be a poset. Any lattice-theoretical identity valid in all $\mathbf{C o}(Q)$, for $Q$ a finite subset of $P$, is also valid in $\mathbf{C o}(P)$.

Corollary 11.3. A lattice-theoretical identity is valid in SUB iff it holds in $\mathbf{C o}(P)$ for every finite poset $P$.

Consequently, the variety SUB is generated by its finite members. By using the results of J. C. C. McKinsey [14], we obtain the following consequence.

Corollary 11.4. The word problem in the variety SUB is decidable.
This means that it is decidable whether a given lattice identity $\mathbf{s}\left(\mathrm{x}_{1}, \ldots, \mathrm{x}_{m}\right)=$ $\mathbf{t}\left(\mathrm{x}_{1}, \ldots, \mathrm{x}_{m}\right)$ holds in all lattices of the form $\mathbf{C o}(P)$. A closer look at the proof of Lemma 11.1 shows that it is sufficient to verify whether the given identity holds in all $\mathbf{C o}(P)$ for $|P| \leq n$, where $n$ is the supremum of the lengths of the terms $\mathbf{s}$ and $\mathbf{t}$.

## 12. Open problems

We know that the class SUB is generated, as a variety, by its finite members (see Corollary 11.31). We also know that any finite lattice in SUB can be embedded into some finite $\mathbf{C o}(P)$ (see Theorem 6.7). Nevertheless we do not know whether the latter generate the whole quasivariety.

Problem 1. Is the class SUB generated, as a quasivariety, by its finite members?

Equivalently, does there exist a lattice quasi-identity that holds in all finite $\mathbf{C o}(P)$-s but not in all $\mathbf{C o}(P)$-s?
Problem 2. Is the universal theory of all lattices of the form $\mathbf{C o}(P)$ decidable?
A positive answer to Problem 1 would yield a positive answer to Problem 2
Problem 3. Is the class $\mathbf{C}$ of all lattices that can be embedded into a product of the form $\prod_{i \in I} \mathbf{C o}\left(C_{i}\right)$, where the $C_{i}$ are chains, a variety?

Problem 3 is solved by the authors in [16].
Problem 4. Can the embedding problem of a lattice in $\mathbf{S U B}$ into some $\mathbf{C o}(P)$ be solved by a functor (that, say, sends any $L$ to some $\mathbf{C o}(P))$ ? Can such a functor be idempotent?

Our next problem has a more computational nature.
Problem 5. For each positive integer $n$, denote by $\xi(n)$ the least positive integer such that every finite lattice $L$ in $\mathbf{S U B}$ with $n$ join-irreducible elements embeds into some $\mathbf{C o}(P)$, where $|P| \leq \xi(n)$. Compute $\xi(n)$, for all $n>0$. Does $\xi(n)=O(n)$ as $n$ goes to infinity?

For a sublattice $K$ of a finite lattice $L$, the inequality $|\mathrm{J}(K)| \leq|\mathrm{J}(L)|$ holds, see [1. Lemma 2]. In particular, if a finite lattice $L$ embeds into $\mathbf{C o}(P)$ for some finite poset $P$, then $|\mathrm{J}(L)| \leq|P|$. By combining this with the result of Theorem6.7 we obtain the inequalities

$$
n \leq \xi(n) \leq 2 n^{2}-5 n+4
$$
